J&K HC Sets Aside 13-Year-Old Judgment In Corruption Case, Sentences Accused To 6 Months In Jail

JAMMU, JUL 13: The law finally caught up with a former government official facing corruption charges after 26 years with the Jammu and Kashmir High Court setting aside his 2010 acquittal by a trial court.

Justice MA Chowdhary convicted the accused, sentenced him to six months in jail and slapped a fine of Rs 20,000 on him, agreeing with Senior Additional Advocate General Monika Kohli.

The high court was hearing the acquittal appeal filed by the appellant — the Union Territory administration – against the January 29, 2010,

border, the Minister held close interaction with the local villagers and also administrative officials.

Accompanied by a team of officials and local representatives, Minister Thakur interacted with local villagers in Kharnak and Samad among others and listened to their concerns and aspirations. At Kharnak, he inaugurated the PMGSY road connecting the highway of Dadh Khar-

The Minister discussed issues related to solar power, drinking water, housing for 32 households, cycling track, artificial lake, and tourism subsidy. The Home Minister also specified the need to think coherently to crack down on the use of various virtual assets.

Speaking at the G20 Conference on Crime and Security in the age of the Non-Fungible Token (NFT), Artificial Intelligence (Al) and Metaverse', Shah further said "The Metaverse, once a science fiction idea, has now stepped into the real world.'

He said the metaverse may create new opportunities for terrorist organizations primarily for propaganda, recruitment, and training.

"This will make it easier for terrorist organizations to select and target vulnerable people and prepare material according to their vulnerabilities."

"The metaverse also creates opportunities for true imitation of a user's identity, known as "deep-fakes". Using better biometric information about individuals, criminals will be able to impersonate users and steal their identities," Shah

The minister also pointed out that incidents ranging from ransomware attacks, the sale of critical personal data, online harassment, and child abuse to fake news and misinformation campaigns with 'toolkits' are being carried out by cybercriminals.

At the same time, Shah said, there is also a growing tendency to strategically target critical information and financial systems.

"Such activities are a matter of national concern, as their activities have a direct impact on national security, law and order, and the economy. If such crimes and criminals have to be stopped, then we have to think and also act by rising above the conventional geographic boundaries," said Shah.

"The targets in digital warfare are not our physical resources, but our ability to act online. Disruption of the online network even for 10 minutes can be

Noting that all the governments of the world are promoting digital means in governance and public welfare today, Shah said it is necessary in this direction that citizens have faith in digital plat-

Insecurity in the digital space also raises questions about the "legitimacy and sovereignty" of the nation-state, Shah said while advising "Our internet vision should neither be one of excessive freedom threatening the very existence of our nations nor one of isolationist structures such as digital firewalls."

Stating on cyber-attack threat hovering over all the major economies of the world, Shah cited World Bank estimate that "cyber-attacks could have caused losses of around \$5.2 trillion to the world during the years 2019-2023.

He also said the use of cryptocurrency by malicious threat actors further complicates its detection and prevention.

"The government of India under the leadership of Prime Minister Modi has worked towards outlining a uniform cyber strategy, real-time reporting of cyber-crimes, capacity building of LEAs, designing analytical tools and setting up a national network of forensic laboratories, ensuring cyber hygiene, and spreading cyber awareness to every citizen. The Crime and Criminal Tracking Network and System (CCTNS) has been implemented in all the police stations of the country," Shah said.

He also said the Government of India has established the Indian Cyber-Crime Coordination Center (14C) to ensure a comprehensive response against cyber-

24/7, 365 days (a year), whether there is yatra or not. There is an increase in the (number of) forces in view of the yatra, and more focus is given," Deputy Inspector General of CRPF Alok Avasthy said.

Avasthy said the CRPF was using with modern gadgets and weapons to maintain a hawk-like vigil on its area of operation in south Kashmir.

"We are using the most modern technology which is available in the world. I will not reveal the details here, but, yes, we are using that," he added.

Asked if there was a specific threat to the ongoing pilgrimage to the holy cave shrine of Amarnath, the officer said the CRPF was focussed on ensuring round the year peace.

"There is no specific threat, but, yatra or no yatra, our priority is the security of the people, and our jawans do not rest. They work 24/7. They are on duty 365 days. I assure you that we are at your service," Avasthy said.

Asked about special drills along the highway, he said there is an increase in the traffic and the CRPF personnel are also engaged in traffic control to ensure smooth movement of the yatra convoy.

Avasthy lauded the local population's support to the pilgrimage.

"We have full cooperation of the local people. There are no problems, local population provides water to yatris, bless them," he added. (Agencies)

the respondent had been acquitted in a corruption case registered in 1998.

Yaar Mohammad, a resident of Surankote in Poonch district, had moved a written complaint on October 24, 1997, alleging that Abdul Aziz Mirza, the then tehsil supply officer, swindled Rs 22,000 from him by promising a job in the Food and Supplies Department.

The accused, who was charge-sheeted on August 26, 2000, was acquitted by the trial court, mainly on the ground that the complainant was a "bribe giver" and, as

such, no credence could be given to his statement in the absence of any supportive corroborative evidence.

The trial court also rejected the main prosecution witnesses, saying both of them being from the "same brotherhood" as the complainant were not competent witnesses to credibly believe them.

"...the appeal of the appellant-state is allowed and the impugned judgment passed by the trial court is set aside. As a result, the respondent/accused is convicted for the commission of offences punishable under Section 5(2) of the PC (Prevention of Corruption) Act and Section 161 of the RPC (Ranbir Penal Code)," Justice Chowdhary said in his 16-page order on Tuesday.

The order said since the accused was alleged to have committed the offence in 1997, now, at this stage of the case, while the appeal is being decided in 2023, it is recorded that for this inordinate delay in its disposal by the trial court in 2010 and by the high court now, a lenient view has to be taken while imposing the sentence of punishment.

"Though the offences of which the respondent has been convicted are punishable with a minimum punishment of one year imprisonment and fine, but for special reasons to be recorded, punishment of imprisonment can be further lowered to six months," Justice Chowdhary said.

"...the respondent/convict is sentenced to an imprisonment of six months and fine of Rs 20,000 for the commission of offences punishable under P C Act and RPC each. In default of payment of fine, he shall undergo further simple imprisonment of one month," the order read. (Agencies)

Kashmir in a militant conspiracy case. NIA said raids were conducted today at five locations in the three districts of Shopian, Awantipora and Pulwama in south Kashmir.

The NIA also raided the premises of sympathisers and cadres of the newly floated outfits, namely The Resistance Front (TRF), United Liberation Front Jammu & Kashmir (ULFJ&K), Mujahideen Gazwat-ul-Hind (MGH), Jammu & Kashmir Freedom Fighters (JKFF), Kashmir Tigers, PAAF and others. These outfits are affiliated to various banned Pak-backed organisations like Laskhar-e-Toiba (LeT), Jaish-e-Mohammed (JeM), Hizb-ul-Mujahideen (HM), Al-Badr and Al-Qaeda, the NIA said

"Several digital devices containing large volumes of incriminating data were recovered by NIA during today's searches, which have once again put the spotlight on OGWs as an important part of the terror ecosystem in the Valley, which is being dismantled on a continuous basis. Also known as hybrid terrorists, they provide support to militants and terrorists based in Pakistan," the NIA spokesperson said.

They said some of these newly-floated outfits, The Resistance Front (TRF), a shadow organisation of Lashkar-e-Taiba, have been found issuing threats of carrying out attacks in J&K over the social

The NIA had registered a suo moto case on June 21, 2022 to investigate the involvement of the cadres and OGWs of the various outfits in spreading activities relating to terror, violence and subversion in J&K. These cadres and workers have been involved in the collection and distribution of sticky bombs/magnetic bombs, IEDs, funds, narcotic substances and arms/ammunitions.

NIA investigations have revealed that Pak-based operatives were using social media platforms to promote terror. Drones were being used by them to deliver arms/ammunition, explosives, narcotics etc. to their operatives and cadres in the Kashmir valley.

The terror conspiracy relates to plotting by the banned outfits in both physical and cyber space to unleash violent terrorist attacks in J&K with sticky bombs, IEDs and small arms etc. The organisations, supported by their masters in Pakistan, have been conspiring to commit acts of terror and violence, by radicalizing local youth and mobilizing overground workers, to disturb peace and communal harmony in J&K.

Braving the hot and humid weather conditions, devotees including women are patiently waiting in long queues to get a registration token.

"We have been waiting in long queues since morning for the registration. We will first get a token and then have to get a health checkup done, only after which we can proceed with the registration process," Kapil Dev Pandey, a Maharashtra resident who came here for the pilgrimage, said.

Pandey, however, pointed out that there should be more counters to attend to the huge number of people.

Over 1,500 unregistered pilgrims, including women, who have arrived in Jammu city, have been registered so far for the Yatra to the 3,880-metre-high cave shrine in south Kashmir Himalayas.

Five counters have been set up for Tatkal registration of the devotees. While three counters have been put up at Vaishnavi Dham, Mahajan Sabha, and Panchayat Ghar for registration of the general public, two have been set up at Geeta Bhawan and Ram Mandir for the registration of 'sadhus', the officials said. Dharminder Bhargava, a pilgrim from Madhya Pradesh, standing in the queue for three hours, said he arrived here a week ago and has been waiting for the Amarnath Yatra registration to resume.

"We visited the Mata Vaishnodevi cave shrine during the suspension of Yatra last week. There should have been more counters so that registrations could have been conducted faster," Bhargava said.

Pilgrims waiting in the queues said the shelter and drinking water facilities at the registration spots were inadequate.

According to official horticulture records, a staggering 26,000 hectares of land are dedicated to apple cultivation in this region. The fertile lands of Shopian nurture a diverse range of apple varieties, including the Red Delicious, Golden, American, White Dotted Red, and Gala, among others.

Shopian witnessed a remarkable apple production of 3.6 lakh metric tonnes (MTs) in the previous year - 2022. However, the current year's forecast predicts a tentative production of 3 million metric tones—(KNO)

The importance of Guidance and Counselling in adolescents' life

GUIDANCE AND

COUNSELO



Guidance is a broader term which includes counselling as one of its services. It means help or advice to deal with the complex problems linked with your work, education, personal relationship and making into easier ones. Guidance is regarded as a conceptualized programme of activities that offers a gateway out to the existing problems in the present era of complex scientific and technological developments. The aim of guidance and counselling is to assist behaviour change, enhance coping skills, promote decision making, improve the relationship and to facilitate users' potential.

Guidance and counselling help to recognize and understand about one's talents and abilities, help to develop an optimistic outlook for removal of undesirable traits, it aids to develop resourcefulness and self-direction in adapting to changes in society. Guidance and counselling earn recognition through their services rendered in enhancing human happiness by being healthier, more productive, attain valuable lesson and also eliminate later stage problems. The major aim of guidance and counselling services is to encourage students' academic, social, emotional and personal development. These are thus, an integral component of education as well. Guidance and counselling have become very imperative for young children and schools have a massive role in fetching out the best in children, as at today's time young minds need guidance to polish their personality and also help to attend to the physical, social, psychological, educational and vocational needs of the school students who go a long way to remove impediments of learning.

Adolescence is generally considered as a turbulent period and is often portrayed as a negative phase of life-a phase of storm and stress to be survived or endured. This stage is best defined as a critical period in relation to puberty and also considered as a revolution of a person's life which starts with biological transformation and finished in adjusting with those challenges in the society. Adolescence means 'to emerge' to attain 'identity' and this way of attaining identity has to go long facing up with challenges as well as changes. During this period a variety of physiological, cognitive, emotional and social changes take place. Adolescence emerges from later childhood and merges into adulthood with sexual maturity, increased hormone levels, desire for more independence, the capacity to think abstractly, escalating interest in peers, distancing from parents due to relationship with peers or outside and the inauguration of a romantic relationship are characteristics

of adolescence. These characteristics are like shifting from a child like to be adult-like. The tendency to make innovative discoveries is more frequent in adolescence as compare to childhood because in childhood scope of activity is restricted as a child has fear of guardians or afraid of going far whereas in adolescence they discover superior freedom. Additionally, there is a diverse number of conflicts that adolescents are faced with, such as making decisions about future adult role, identity formation and separating themselves from caregivers.

Adolescents require explicit attention. Today, millions of children are addicted to drugs, engaged in various crimes, school dropout, delinquency, attempt suicide, suffer from anxieties and depressions. In spite of rising in literacy rates, the trend of opting the wrong decision or confusing is continuously increasing in children because of the lack of guidance services. At this stage of life, adolescents are packed with multifarious challenges and if these challenges are not resolved, they may go on to become a social misfit in later life. An adolescent on his own may also make use of trial-and-error approach and master the developmental tasks vital for the switch to ideal adulthood but in the practice, they used to waste their precious time that they might spend in learning and knowing further constructive activities and also it would deteriorate their self-confidence and motivation to acquire up tasks that have proved to be hard in doing it. They are not mature enough to critically evaluate baffling situation arising due to these changes around them. Many of these problems not only require remedial treatment but also prominently help from guidance and counselling profession to take preventive efforts. Thus, adolescence becomes challenging as well as a puzzling chapter of lifespan development for those who are facing and also for the parents and adults who are raising and nurturing their children. So to survive this period and get the direction of fulfilling their potential, adolescents require guidance and honest support.

Adolescents confront problems which they cannot readily cope with the absence of assistance from their parents, teachers or professionals such as school counsellors. The academic achievement may be one of the determinants of adolescent mental health and as a result, can be associated with the adolescents' need for guidance and counselling. A school counsellor's role also becomes sensitive when the ultimate aim is students academic achievement.

COUNSELING

Teenagers have an important role in society. Today's young people are the hope, future citizens and leaders of tomorrow; therefore it is necessary to develop aptitude, behaviour and action according to democratic ideals. In India adolescence has a good hold on the population. They will be controlling and running the world someday. Clearly, we need to better understand these challenges and find appropriate solutions. The principle of guidance and counselling in schools is to make progress in academic achievement, increase acquisitions and application of conflict resolution, promote affirmative study attitudes and behaviour and reduce school dropouts of the children. Even at institutions, adolescents have the stress of academic performance, selecting fields of specialization and career as well. Teachers as well as parents choose academic achievement as sole criteria to judge students' performance. However, it can be a very hard period during which a great deal of understanding, patience and support is required. Modernization has given many positive effects as it is providing so many opportunities, but at the same time, it has remitted into multiple stressors in adolescents' life. This stress leads to massive mental health problems. It is, therefore, very pertinent that students' guidance and counselling needs must be known, so that, steps can be taken to make available required support services in this regard to them at an adequate level.

Hadith of Nabi sallallahu 'alayhi wa sal-

Ibn Abid Dunyaa has narrated a Hadith to the effect that once the earth began to

tremble in the time of Nabi sallallahu 'alayhi wa sallam. Nabi sallallahu 'alayhi wa sallam

placed his blessed hand on the earth and instructed it to stop shaking, because the time had not yet arrived.

This instruction to the earth to be still was because the time for the occurrence of Qiyaamah had not yet arrived (when the earth will shake violently).

Nabi sallallahu 'alayhi wa sallam then turned towards his companions and said: Your sustainer wants you to turn to him, so turn to him in repentance.

Beneficial lesson

From this Hadith, the cause of earthquakes becomes apparent, which is 'the sins of man'. The underlying wisdom also becomes known, and that is 'to draw man's attention and motivate him to turn to Allah Ta'ala in repentance'.

 $Sayings of the Sahabah \, radiyallahu\, `anhu$ The following completes and corroborates the Hadith mentioned above.

During the time of Hadhrat Umar radiyallahu 'anhu, the earth began to tremble

Hazrat Umar radiyallahu 'anhu addressed the people as follows: O people! The earth is shaking because of a new sin being com-

I state upon oath that if this (earthquake) happens again, I will not stay with you any longer ie. I will go and live elsewhere.

Beneficial lessons

Imam Ahmed rahimahullah has narrated the same subject matter with variations in the wording from Hazrat Safiyyah radiyallahu 'anha and added that this took place in Madeenah Shareef.

Ibn Abid Dunyaa narrates from Hazrat Anas radiyallahu 'anha that he once accompanied another person to visit Hazrat Ayesha radiyallahu 'anha. The person said: O mother of the believers! Tell us something pertaining to earthquakes.

Hazrat Ayesha radiyallahu 'anha replied: When people commit adultery and fornication as though it's permissible, consume intoxicants and play with flutes and musical instruments, at such a time the sense of honor of Allah Ta'ala comes to the fore and the earth is commanded to shake a little. If they repent and desist (from their evil habits), well and good, otherwise (the demand of such open transgression and rebellion) is that buildings be crushed upon

Upon this, the person asked: Is this done as a form of punishment and chastisement

Hazrat Ayesha radiyallahu 'anha replied: No, actually it is a mercy and a form of goodness for the believers. As for the disbelievers, it is a punishment, chastisement and unleashing of divine wrath upon them.

Hazrat Anas radiyallahu 'anhu says that never have I experienced such joy from any Hadith of Nabi sallallahu 'alayhi wa sallam thereafter, as I experienced upon hearing this particular Hadith.

In this Hadith too, the same cause is mentioned ie. 'the sins of man', and the same underlying wisdom ie. 'to motivate man to turn in repentance to Allah Ta'ala'.

It is an accepted fact amongst the scholars of Hadith, that if a Sahaabi says anything which is beyond the scope of logic and reason, then it will necessarily be understood that he had heard it from Nabi sallallahu 'alayhi wa sallam.

Such a Hadith is termed as 'Marfoo e Hukmi' (Though the wording is that of the Sahaabi, the subject matter contained therein will be regarded to have been taken from Nabi (saw)

The subject matter of this Hadith too is such (ie. it is beyond the scope of logic and reason), therefore the subject matter and meaning of this Hadith will be taken to be from Nabi sallallahu 'alayhi wa sallam.

Sayings of the Taab'ieen (Those who saw Sahabah radiyallahu 'anhu

Muhaddith Ibnul Qayyim rahimahullah narrates in his treatise entitled 'Al Jawaabul Kaafi' that Hadhrat Umar bin Abdul Aziz rahimahullah (The Khalifah of the time) wrote the following and sent it to various towns and cities:

After praising Allah Ta'ala and sending salutations, it should be known and understood that these earthquakes are a manifestation of Allah Ta'ala's retaliation unleashed by him upon his slaves so that they turn in repentance to him.

The Muhaddith has also narrated the following from Hazrat Ka'b Ahbaar, who was a great scholar of the people of the book and was blessed with Imaan during the khilaafat of Hadhrat Umar radiyallahu

WHAT IS THE UNDERLYING CAUSE BEHIND THE OCCURRENCE OF EARTHQUAKES?

What benefit and favorable outcome results from the occurrence of earthquakes?

Earthquakes occur due to excessive sinning which takes place on the earth. Out of fear caused by the fact that Allah Ta'ala is watching, the earth begins to

From this statement too, the same cause and same underlying wisdom come to the

This humble servant has seen the following narration in a reliable source (which has slipped the mind currently as has the name of the narrator) that Allah Ta'ala has placed certain plates or cords inside the earth which are in the hands of Angels. When sins occur in abundance on earth, Allah Ta'ala instructs the Angels to pull the cords at a specific location, which causes

Removal of a misconception

At this juncture, clarification is needed regarding the doubt that could occur, because the philosophers and intelligentsia mention that there are vapors and steam trapped in the earth, and due to pressure they try to exit. When the pressure builds up and the earth cannot contain them, this causes the plates in the earth to move which in turn causes earthquakes or trem-

From what is witnessed too, this can be correctly assumed to be the apparent cause of earthquakes. This apparent contradiction is removed by understanding that any one occurrence can have multiple underlying causes. Some are primary causes whilst others are secondary causes. The secondary causes are triggered off by the pri-

Understand it from the example of a person whose anger is incited due to some provocative words told to him. He becomes overheated with rage and due to immense fury he totally loses his composure until he eventually snaps, has a mental break-

down and lands up in the mental hospital. The cause of him going to the mental hospital can be attributed to his mental breakdown, or to his getting overheated, or to his anger and rage, or to the provocative words uttered to him.

The provocative words can be said to be the primary cause, whilst the others can be called the secondary causes. There is

no contradiction between these causes. A person who is totally unaware of the human psychology will, upon hearing that the provocative words caused someone to land up in the mental hospital, immediately deny it, no matter how truthful and honest the one conveying the message may be. He will object and consider the news relayed to him to be irrational and utter nonsense.

This is his condition, despite the fact that every person with a reasonable amount of knowledge will know that his objection is totally unfounded, and that what was related to him is one hundred percent correct.

Similarly there are people who are unaware of spiritual medicine, the rights due to Allah Ta'ala and his workings in the creation, the effects and harms of sins, and the link between hidden causes and their


Upon hearing this subject matter described in the Hadith, they flatly deny it without any basis or proof, relying solely upon their deficient opinions and defective understanding.

They fall under the category of:

"Rather, they deny that which they encompass not in knowledge, and whose interpretation has not yet come to them." Surah Yunus verse 39.

Understand the matter from the following explanation:

It can be said that Allah Ta'ala is displeased with excessive sinning and wishes to shake the earth. For this, he has created molten lava and high-pressure steam by means of which earthquakes occur. The

command is issued for the hidden cords to be pulled, which cannot be detected with the naked eyes, like electricity.

By denying this, the philosophers are placing themselves in the category of ignorant laymen (of those times) who deny the great wonders performed by means of electricity. So the actual (hidden) and primary cause of earthquakes is the excessive sinning, and the steam and pressure

etc. are the secondary and apparent cause. I say, what prevents one from accepting the above explanation? Or is it impossible

and contrary to logic? It is the height of injustice and irrationality to deny it by saying that it cannot be understood. What will you say about a person who has never seen a train before, and denies it when you tell him that there is a conveyance that moves speedily without the need for animals to pull or push it, $and \, is \, able \, to \, easily \, transport \, large \, numbers \,$ of people and huge quantities of goods from place to place?

Will you not regard him to be a stubborn ignoramus?

So such a stance should not be taken in these matters (of the reasons explained in the Hadith) because we will not tolerate such an approach in worldly matters. To digest this more easily, understand that at times earthquakes are due to natural causes, and at times due to Shar'i causes. On the basis of justice, when Shari'at does not deny the natural causes, then is there any justice in the stance of the philosopherswho deny the Shar'i causes without any valid basis?

As far as the statement of Hadhrat Umar radiyallahu 'anhu which conveys the impression that this is the sole cause of the earthquake, it will be taken to apply to that specific earthquake, and not to all earth-

It thus becomes evident that there is no contradiction between the Shari'at and philosophy with regards to the cause. Philosophy does not delve into underlying points of wisdom; therefore no contradiction can be found in this matter.

NB. There is no concrete evidence for the famous belief that earthquakes are to do with the shedding of bulls' horns, therefore such a baseless belief should be discarded (common belief in India at the time of Hadhrat Thanwi-translator).

Several Past Nations were punished by earthquakes due to sin

Regarding the people of Thamud and

the inhabitants of Madyan, it is mentioned:

So, the earthquake seized them, and they were (found dead) in their homes, fallen on their faces. In several places mention is made of the overturning of the towns of the people of Nabi Lut Alaihis Salaam. It is obvious that before being overturned, the towns would have been moved and

Regarding the people of the Bani Israil who accompanied Nabi Moosa Alaihis Salaam to the mount Toor and uttered disrespectful words, it is also mentioned:

And M sa selected seventy men from his people for Our appointment. Later when the earthquake seized them, he said, "My Lord, had it been Your will, You could have destroyed them earlier, and me too. Would You destroy us for what the foolish among them have done? It is nothing but a trial from You, wherewith you let go astray whom You will, and give guidance to whom You will. You are our protector, so forgive us, and have mercy on us, and You are the best among those who forgive.

The incident of the sinking of Qarun into the earth is mentioned in the Quraan Shareef. Here too it is apparent that there has to be movement for sinking to take place. It is established that the above mentioned people were punished by means of earthquakes.

The occurrence of abundant of earthquakes are a sign of the Day of Qiyamah In 'Mishkaat Shareef - 'The chapter con-

cerning the signs of Qiyaamah', a lengthy Hadith is narrated by Hadhrat Abdullah bin Hawaalah radiyallahu 'anhu in which Rasulullah sallallahu 'alayhi wa sallam is reported to have said:

When the Islamic Khilaafat will come to the land of Shaam, it will be very close to the occurrence of earthquakes, trials and colossal events. These will occur in close proximity to Qiyaamah.

Narrated by Abu Dawood and Haakim. It is narrated in the same chapter from Hazrat Abu Hurairah radiyallahu 'anhu that Nabi sallallahu 'alayhi wa sallam said: When such and such actions will take place...(amongst them Nabi sallallahu 'alayhi wa sallam also mentioned) when a trust will be taken like booty, zakaat will be taken as a penalty, knowledge of Deen will be acquired for worldly motives, wives will be obeyed and mothers disobeyed, relationships with friends will be enhanced, and reduced with fathers, unproductive discussions will take place in the Masaajid,

leadership positions will be given to sinners and transgressors, there will be an abundance of music, intoxicants will be consumed in profusion, when the pious predecessors will be insulted, then at such a time anticipate and expect red winds, earthquakes and sinkings into the earth, and other dreadful calamities.

Narrated by Tirmizi

This Hadith corroborates the subject under discussion in the first chapter with regards to identifying the cause of earth-

NB. The tremendous earthquake that will occur specifically on the day of Qiyaamah has been mentioned in numerous places in the Quraan Shareef.

Course of action

It has been established from several narrations of chapter one that the first and most important recourse is to make Taubah (turn in repentance to Allah Ta'ala). In the same chapter, mention was made of the letter of Hadhrat Umar bin Abdul Aziz rahimahullah, which ends with the fol-

On a certain (specific) date and month, everyone should gather out in the open. Whoever is able to, should also give out charity. The aforementioned (Taubah and Sadagah) should be carried out because Allah Ta'ala states:

Success is surely achieved by him who purifies himself, and pronounces the name of his Lord, then offers prayer.

(The word 'Tazakkaa' is derived from 'Zakaah' which means to purify oneself, or one's wealth by giving charity)

Make the following du'as:

The Du'a of Nabi Adam Alaihis Salaam Our Sustainer! We have wronged ourselves - If you do not forgive us and have mercy on us, we will surely be amongst the losers.

The Du'a of Nabi Nuh Alaihis Salaam

"y Lord, I seek refuge with You that I should ask You something of which I have no knowledge. If You do not forgive me and do not show mercy to me, I shall be among the losers.'

The Du'a of Nabi Yunus Alaihis Salaam There is none worthy of worship except you, you are free of faults, most certainly I was of the oppressors.

In 'Durre Mukhtaar - Kitaabul Kusoof' it is mentioned:

The gist of the above is that at the time of intimidating occurrences, each one should read Nafl Salaah individually at home or in the Masjid (Unless it is a Makrooh time).

Examples of the above are the times of lunar eclipse, severe winds, sudden intense darkness during the day, sudden intense brightness during the night, earthquakes, lightning and thunder, heavy rains or hail, outbreaks of sicknesses... NB Du'a for the removal of plagues is included in the cat-

The following appears in Raddul Muhta-

Du'a alone is sufficient, but it is preferable to perform Salaah as well.

This is taken from the Hadith which mentions that:

When any disturbing event took place, Nabi sallallahu 'alayhi wa sallam would hasten with urgency to perform Salaah.

With the exclusion of Salaah at the occasions of a solar eclipse (Kusoof) and when seeking rain (Istisqaa), which are performed in Jamaat (congregation), the rest are performed individually.

From all these narrations, the following course of action and ettiquettes are derived:

- 1. 1.To make Taubah (turn in repentance to Allah Ta'ala). It is advisable to also recite the verses quoted earlier on by Hadhrat Umar bin Abdul Aziz rahimahullah.
- 2. To perform nafl Salaah
- 3. To make Du'a
- 4. To give Sadaqah (charity)

5. If one wishes, one may go to an outlying open area and express one's humbleness before Allah Ta'ala

The customary practice of the masses of calling out the Azaan on such occasions, is not established from Shar'i proofs. This innovation should be given up.

Adopting measures to protect oneself during an earthquake

The following is recorded in Durre Mukhtaar before Kitaabul Faraa-idh:

It is not only permissible, but better and meritorious to leave one's house and go to the outskirts in the open, due to the fact that Nabi sallallahu 'alayhi wa sallam himself once shifted away from a wall that was about to collapse. This humble one recalls that in all probability he saw this Hadith in Al-Adabul Mufrad of Imam Bukhaari rahimahullah.

I now conclude this writing with the Du'a that Allah Ta'ala grant us the ability to obey him and the courage to stay away from all sins. May he forgive all of our sins and protect us from all types of disasters and misfortunes.

approved the proposal for procurement of 26 Rafale Marine aircraft and three additional Scorpene submarines from France. The project was cleared by the Defence Acquisition Council (DAC) headed by Defence Minister Rajnath Singh, when Prime Minister Narendra Modi embarked on a twoday visit to France today (July13).

The Defence Ministry in a statement said it will boost Indian Navy's operational capabilities.

"The DAC granted Acceptance of Necessity (AoN) for procurement of 26 Rafale Marine aircraft along with associated ancillary equipment, Governmental Agreement (IGA)" said the Ministry in a Statement.

India has already procured 36 Rafale jets from France for the Indian Air Force. The DAC's approval to the projects came around a week after they were cleared by the Defence Procurement Board (DPB).

Over the price and other terms of purchase, the Ministry said, "They will be negotiated with the French Government after taking into account all relevant aspects, including comparative procurement price of similar aircraft by other countries".

"Further, integration of Indian

designed equipment and establishment of Maintenance, Repair & Operations (MRO) Hub for various systems will be incorporated into the contract documents after due negotiations" it

The three additional Scorpene submarines under Buy (Indian) category, will be constructed by Mazagon Dock Shipbuilders Limited (MDL).

The Ministry said it will also help the MDL in further enhancing its capability and expertise in submarine construction.

"The procurement of additional submarines, with higher indigenous content, will not only help in maintaining required force level and operational readiness of the Indian Navy, but also create significant employment opportunities in the domestic sector", the statement said.

In addition, the DAC approved the proposal to lay down guidelines for achieving the desired indigenous content in all categories of capital acquisition cases.

Bombay HC rejects Nawab Malik's bail plea on medical grounds

Mumbai, July 13 (UNI) The Bombay High Court on Thursday rejected the interim bail plea filed by former minister and NCP leader Nawab Malik on medical grounds in an alleged money laundering case registered by the Directorate of Enforcement (ED) related to underworld fugitive Dawood Ibrahim. Justice Anuja Prabhudessai, while rejecting the plea, said she will hear the NCP leader's bail plea on merits in two weeks. Jailed NCP leader Nawab Malik had moved for bail on medical grounds, stating that he could be considered a sick person as defined under the provisions of the Prevention of Money Laundering Act (PMLA) and hence entitled to be released on bail. Malik was arrested by the Enforcement Directorate (ED) on February 23, 2022, in an alleged money laundering case involving fugitive gangster Dawood Ibrahim for usurping land at a price much below the market rate.

Delhi Roads Underwater, Massive Jams, **Metro Hit, Schools And Colleges Shut**

New Delhi: The water level in the swollen Yamuna in Delhi rose further during the night, flooding homes, affecting public transport and prompting emergency mea-

The water level in Yamuna was 208.62 metres at 1 pm today as Hathnikund barrage in Haryana continues to release water into the river. The current water level is three metres above the danger mark.

The Arvind Kejriwal government had urged the centre to step in and stop the water discharge, but the centre replied that excess water from the barrage had to be released. The water discharge is expected to reduce later in the day.

The Haryana barrage has filled up due to very heavy rain further north in Himachal Pradesh. The monsoon has brought large-scale destruction in the hill state, bringing down homes and sweeping away

In the national capital, the posh Civil Lines area was waterlogged as river water entered nearby localities. The waters are barely 350 metres from the residence of Chief Minister Arvind Kejriwal and Delhi Assembly.Waterlogging has disrupted traf-



fic movement on several roads, including in parts of the arterial Outer Ring Road. Traffic has been diverted to alternate routes, leading to massive traffic jams.

Compounding challenges for those taking public transport, Metro services have also been affected. The Yamuna Bank Metro station on Blue Line has been shut owing to waterlogging on the approach road. Although operations on all lines remain normal, trains are running at a restricted speed on Metro bridges.

Following a meeting of the Delhi Disaster Management Authority, the Chief Minister ordered closure of all schools and colleges till Sunday. Government employees, except those in emergency services, have been asked to work from home. Private offices have also been advised to move to the WFH option.

West offers security assurances to frustrated Ukraine

VILNIUS: The United States and global allies unveiled new security assurances for Ukraine at a Nato summit on Wednesday, designed to bolster the country's defences against Russia over the long haul while Kyiv strives for membership in the alliance.

Members of the world's most powerful military bloc offered the prospect of longterm protection a day after Ukrainian President Volodymyr Zelensky decried as "absurd" a refusal to offer an invitation or timetable for Ukraine's entry into Nato.

Instead, a declaration by the G7 group of the world's most industrialised countries launched a framework for bilateral negotiations to provide military and financial support, intelligence sharing and a promise of immediate steps if Russia should

"Our support will last long into the future. It's a powerful statement of our commitment to Ukraine," President Joe Biden said alongside Zelensky and leaders of the G7, which is made up of the US, Britain, Canada, France, Germany, Italy and Japan. "We're going to be there as long as that takes."

Swallowing his disappointment over the lack of a membership timetable, Zelensky called the outcome a "meaningful success" following a flurry of announcements of military aid for Kyiv.

"Today there are security guarantees for Ukraine on the way to Nato," he said. "The



Ukraine delegation is bringing home a significant security victory for Ukraine."

Zelensky said he would raise Ukraine's need for long-range weapons at a meeting with Biden at the summit.

At a bilateral meeting, Biden promised Zelensky the US was doing everything it could to meet Ukraine's needs and acknowledged Zelensky's frustration about the scale and speed at which he was receiving

'Your resilience and your resolve has been a model for the whole world to see," Biden said.

ing laughter from Zelensky. Asked by a reporter how soon after the war he would like Ukraine to join Nato, Biden responded "an hour and 20 minutes". US national security adviser Jake Sullivan said Biden would offer Zelensky long-range missiles when they met.

British Defence Secretary Ben Wallace said he had told Ukraine that its international allies were "not Amazon" and Kyiv needed to show gratitude for weapons donations to persuade Western politicians to give more.

Zelensky said: "We were always grateful to the UK, prime ministers and the minister of defence because the people are always

200 patients forced to evacuate over fire at Daegu hospital in S Korea

Seoul, July 13 (UNI) About 200 patients were forced to evacuate from a hospital in the South Korean city of Daegu early on Thursday due to a fire, the Yonhap news agency reports, citing South Korea's fire officials.

The fire of unknown origin broke out at 3 a.m. local time (18:00 GMT on Wednesday) at the hospital parking tower in Daegu's Dalseo district, the report said. Some 170 firefighters and 65 fire engines managed to extinguish the fire approximately two hours later.

A woman in her 70s, one of the patients evacuated from the hospital, said she was having difficulty in breathing and was taken to a nearby hospital, the

Daegu fire authorities and police will investigate the incident to determine the exact cause of the blaze, the agency reported.

Armenian DM reports another firing by Azerbaijani troops in border area

Yerevan, July 13 (UNI) The Armenian Defense Ministry on Thursday reported the second in 48 hours shooting by Azerbaijani troops in a border area.

"Between 9 p.m. [17:00 GMT] on July 12 and 1 a.m. on July 13, the units of the Azerbaijani armed forces fired from different caliber small arms against the Armenian combat positions near Verin Shorzha," the ministry said in a statement.

On Wednesday, the defense ministry said that an Armenian soldier had been wounded after Azerbaijani troops fired toward Armenian combat outposts on bilateral border.

Armenia and Azerbaijan have fought two wars over disputed Nagorny-Karabakh, an Armenian-majority mountainous region wedged in between the two nations where both have a military presence. The decades-long conflict reignited in fall 2020, marking the worst escalation since the 1990s. Hostilities ended in a Russia-brokered ceasefire and deployment of Russian peacekeepers to the region.

In September 2022, a new outbreak of hostilities between Yerevan and Baku was reported in an area unrelated to Nagorno-Karabakh, marking the most serious escalation since 2020

Musk, Twitter sued for \$500mln over severance payments

Washington, July 13 (UNI) Former Twitter employees have filed a lawsuit against the company and its owner, Elon Musk, over denial to pay them at least \$500 million in severance packages, a lawsuit read.

"An Order compelling Defendants to provide the full terms of severance according to the Plan to all terminated employees from the date of Mr. Musk's takeover of the company to one year from the date of judgment, an amount that is no less than \$500 million, plus pre-judgment and post-judgment interest at the maximum legal rate," the lawsuit said.

The complaint was filed on Wednesday in the US District Court for the Northern District of California with Courtney McMillian, who was an employee in Twitter's HR department, as the lead plaintiff in the

In late October 2022, Musk finalized the \$44 billion acquisition of Twitter, a US company founded in 2006, and headquartered in San Francisco, California. Following the takeover, Musk changed the company's day-to-day operations, including the termination of Twitter executives who were responsible for the platform's privacy, cybersecurity and censorship, as well as about two-thirds of Twitter's employees.

1 killed, 2 injured after multi-vehicle crash in **Australia's Sydney**

Sydney, July 13 (UNI) Police in the Australian state of New South Wales (NSW) on Thursday appealed for dashcam footage after a six-vehicle crash killed one and critically injured two in Sydney's northwest.

At about 1:30 p.m. local time on Wednesday, emergency services were called to a multi-vehicle pile-up at the intersection of Blaxland Road and First Avenue, Eastwood, which involved a Mitsubishi SUV, a Holden Commodore, a Kia SUV, a Toyota sedan, an Audi hatchback, and a van. A 61-year-old female passenger of the Holden died at the scene, while out of the same car, a 67-year-old female driver and a 63-year-old female passenger were sent to hospitals with critical injuries.

A 31-year-old man behind the wheel of the Mitsubishi was treated for a head injury and in stable condition, with other drivers uninjured. Both Mitsubishi and Holden cars have been seized to undergo forensic examination."Police established a crime scene which was examined by specialist officers from the Metropolitan Crash Investigation Unit," said NSW Police Force, adding that an investigation is underway into the circumstances surrounding the crash. Abbas vows to rebuild Jenin camp after deadly Israeli raid

JENIN: Palestinian president Mahmud Abbas vowed $to \, rebuild \, the \, Jenin \, refugee$ camp during a rare and brief visit on Wednesday, a week after a deadly Israeli raid destroyed much of the camp in the occupied West

Abbas, 87, hailed the Jenin camp as an "icon of struggle" during his first trip to the area in more than a decade, a period during which fighters have gained popular support at the expense of his Palestinian

The two-day Israeli raid last week — the largest such operation in years, involving hundreds of troops, drone strikes and armoured bulldozers – killed 12 Palestinians and one Israeli soldier.

Israel views the denselypopulated urban area, a stronghold of fighter groups including Islamic Jihad and Hamas, as a "terrorism hub" and has launched frequent armed raids there since early last year.



Popular discontent with the PA, which cooperates with Israel on security, has been simmering in Jenin, and crowds last week heckled several visiting top officials of Abbas's Fatah party, including deputy chairman Mahmoud Aloul.

On Wednesday, Abbas expressed determination to back Jenin's reconstruction and security, describing the camp as an "icon of steadfastness and struggle" in a short address to cheer-

ing supporters. 'We have come to say that we are one authority, one state, one law," Abbas said, warning against anyone who "tampers with the unity and security of our people". He vowed to oversee the reconstruction of the camp and the wider city to restore it "to what it was, or even better".

As he concluded his visit, Abbas laid a wreath on the graves of Palestinians who lost their lives in recent Israeli raids.

A number of Arab countries have announced aid for the camp after last week's offensive.

Ahead of Abbas's arrival, hundreds of soldiers from the presidential guard patrolled the streets of the camp, an AFP journalist said, and snipers were positioned on rooftops.

WHO worried bird flu might adapt to humans 'more easily'

GENEVA: The World Health Organisation warned on Wednesday that the surge in bird flu outbreaks among mammals could help the virus spread more easily among humans.

Since late 2021, Europe

has been gripped by its worst-ever outbreak of bird flu, while North and South America have also experienced severe outbreaks. This has led to the culling of tens of millions of poultry worldwide, many with the H5N1 strain of the virus, which first emerged in 1996. "Avian influenza viruses normally spread among birds, but the increasing number of H5N1 avian influenza detections among mammals — which are biologically closer to humans than birds are raises concern that the virus might adapt to infect humans more easily," the WHO said in a statement.

"In addition, some mammals may act as mixing vessels for influenza viruses, leading to the emergence of new viruses that could be more harmful to animals and humans."The current



outbreaks pose ongoing risks to humans," it said. More than 64,000 people enter Ethiopia from Sudan: UN

Addis Ababa, July 13 (UNI) The number of people entering Ethiopia from Sudan has surpassed 64,000, the International Organization for Migration (IOM) said Wednesday. The IOM, a UN migration agency, in its latest situation update issued Wednesday, said the ongoing armed conflict in Sudan has forced hundreds of thousands of people to flee to neighbouring countries.It said as of Tuesday, more than 64,000 people had arrived in Ethiopia through multiple border crossing points in the country's Amhara, Benishangul Gumz and Gambella regions.

Amid the increasing number of people crossing into Ethiopia, the IOM said heavy rains have made the conditions and terrains very difficult for aid workers to provide timely support.

The IOM said it has scaled up its presence at border crossing points and its migration response center in



Metema, the major crossing point, providing multi-sectoral assistance to arriving people, including health, water and sanitation, mental health and psychosocial support, onward transportation, as well as tailored

protection assistance. Brutal fighting erupted in Khartoum, the Sudanese capital, on April 15 and swiftly escalated in different parts of the country. The ongoing fighting is pitting the Sudanese Armed Forces (SAF) against the Rapid Support Forces (RSF), the paramilitary group.

Both sides have accused each other of initiating the conflict. Deep differences had emerged between the SAF and the RSF, particularly regarding the latter's integration into the army as stipulated in a framework agreement signed between military and civilian leaders on Dec 5, 2022.

US, S Korea allegedly planning to discuss use of nukes against N Korea

Seoul, July 13 (UNI) The United States and South Korea are allegedly planning to discuss the use of nuclear weapons against North Korea during the inaugural meeting of the new Nuclear Consultative Group in Seoul, Pyongyang's state-run Korean Central News Agency (KCNA) reported Thursday. The US prepared the Washington Declaration in April during the meeting between US President Joe Biden and South Korean President Yoon Suk-yeol in Washington, which the state media called "a programme for nuclear confrontation" with North Korea. The Nuclear Consultative Group would allegedly be the parent body of a "tripartite nuclear alliance" among South Korea, the US and Japan, which would further drive the regional situation to the brink of an unprecedented nuclear war, the report said.KCNA also confirmed that Pyongyang test-fired the new-type Hwasong-18 intercontinental ballistic missile on Wednesday, which reached the maximum altitude of 6,648.4 kilometers (4,131 miles) and flew a distance of 1,001.2 kilometers for 4,491 seconds. North Korean leader Kim Jong Un personally guided the test launch of the missile, aimed at confirming the technical credibility and operational reliability of the weapon system. The Yonhap news agency has cited Yoon's office as saying that the first meeting of the Nuclear Consultative Group would be held on July 18 in Seoul.



astroenteritis is a medical condition characterised by inflammation of the gastroin $testinal\, tract, specifically\, the\, stomach\, and$ the small intestines. It is commonly caused by viral or bacterial infections, although it can also result from parasitic infections, food poisoning, or reactions to certain medications.

1. Abdominal pain and cramping

One of the most common and prominent symptoms of gastroenteritis is abdominal pain. The pain is typically crampy in nature and may vary in intensity. This can be caused by increased contractions of the intestinal muscles due to the inflammation.

Gastroenteritis often presents with diarrhoea, which is characterised by loose and watery stools. This occurs because the infection affects the normal function of the intestines, leading to increased fluid secretion or decreased absorption. Diarrhoea can range in severity and duration, depending on the causative agent and individual factors.

3. Nausea and vomiting

Another hallmark symptom of gastroenteritis is nausea followed by vomiting. The inflammation of the gastrointestinal tract can trigger the body's protective mechanism to expel harmful substances. Vomiting may also occur due to the irritation of the stomach lining.

In many cases, gastroenteritis is accompanied by a fever. The body raises its temperature as a defence mechanism to fight off infections. It is important to note that not all cases of gastroenteritis will lead to a fever, and the severity of the fever may vary.

5. Loss of appetite

Gastroenteritis can cause a significant loss of appetite. The inflammation and irritation of the gastrointestinal tract can lead to a decreased desire to eat, as it may be associated with discomfort or pain. This loss of appetite can contribute to dehydration and weakness if not properly managed.

6. Dehydration

Due to the increased fluid loss through diarrhoea and vomiting, gastroenteritis can often lead to dehydration. Signs of dehydration include dry mouth, decreased urination, dark-coloured urine, fatigue, and dizziness. It is crucial to replenish fluids and electrolytes to prevent complications caused by dehydration.

7. Muscle aches

Some individuals with gastroenteritis may experience muscle aches or body pain. This can be associated with the viral infection itself or the body's response to the infection. Muscle aches can be generalised or localised to specific areas, such as the

Why not mix cooked and uncooked foods?

strongly believe that there ■ is science behind not mixing cooked and uncooked foods, said registered dietitian Garima Goval. Giving an example of having fruits a food is improperly chewed, it causes with main meals, Goyal mentioned that have them at

least 30 minutes before a meal or two hours later. "This will help to avoid the gas formation in the stomach and prevents bloating," said Goyal.

*It complicates the digestion process - Mixing raw and cooked foods complicates the process of digestion. "When talking about cooked foods, it is very easier for our digestive tract or gut to digest them as they are already cooked and body will easily digest such foods by activation of the body enzymes upon consumption. But the rate of consumption of raw foods is slower," mentioned Goyal.

*It causes digestive troubles -When we mix raw and cooked foods in a meal, it leads to digestive issues and discomfort such as belching, gas,

ealth and gut practitioners indigestion etc. This is because it needs significantly high energy and effort of our body to digest raw foods than cooked ones. Chewing the food is the first step of digestion and when digestive discomfort.



said Goyal. *It affects the food's digestibility - Any food that you consume is healthy if you are able to receive all of its health benefits and absorb its nutrients well. This is known as food digestibility. Whenever the food you consume is in cooked form rather than raw form. it's more digestible as well as lacks anti-nutrients. Anti-nutrients are compounds that inhibit the body's ability to absorb nutrients in plant foods. They even are responsible for the gas formation in the gut, said

Clarifying that the emphasis is not on the consumption of cooked foods over raw ones, Goyal said that the idea is to make a meal pattern wherein you don't consume them together for a healthy gut. "Both raw and cooked foods have their own sets of advantages and limitations too. So the inclusion of both is crucial for our health, but not together!" Dr Dimple

Dr Dimple Jangda, an ayurveda and gut health coach too shared an informative post on the subject on Instagram. "Remember bloating is not a disease – it is a direct consequence of the foods you have eaten, the combinations of wrong food items, undigested foods, and waste that has not been eliminated from the previous day," she added. Sharing that cooked foods like grains, vegetables, lentils, pulses, and beans are cooked with cooking oil, spices, salt, and herbs ready for consumption, Dr Jangda said that they can be easily digested, absorbed, and assimilated by the body. Also, the process of cooking changes the chemical complement of these food groups. On the other hand - raw foods like fruits and vegetables salads have active fruit acids, fruit and vegetable enzymes which are alive! There are live bacteria in these foods," said Dr Jangda.

pregnancy and maternal health ickle cell disease is widely prevalent in certain parts of India and

while this health condition can cause a wide spectrum of symptoms, innovations in management have transformed this condition. For the uninitiated, Sickle Cell Disease (SCD) is a genetic condition where the red blood cells become shaped like crescents or sickles, which can cause various health complications. In an interview with HTLifestyle, Dr Santanu Sen, Consultant, Paediatric Hematology, Oncology and Stem Cell Transplantation at Kokilaben Dhirubhai Ambani Hospital Mumbai, talked about what is the Impact of Sickle Cell Disease on Pregnancy and Maternal Health and shared, "For pregnant women with SCD, the condition adds an extra layer of complexity to the pregnancy. These mothersto-be may experience increased pain episodes, infections, and high blood pressure. The irregular shape of the red blood cells can obstruct blood flow,

potentially leading to complications such as preterm birth and low birth weight in newborns, miscarriages and even spontaneous

abortions." She added, "SCD poses risks to the mother's health; there can be severe anaemia leading to fatigue, shortness of breath and even fetal anaemia. In addition, there is an elevated risk of blood clots and pulmonary issues, such as acute chest syndrome as well as increased incidence of strokes. Chances of preeclampsia due to high blood presseure is also very high. It is essential for pregnant women with SCD to be under the care of health-

knowledgeable about the condition. Through vigilant monitoring and proper management, both the mother and baby can be

safeguarded during this critical period. If a patient has severe sickle cell disease, a stem cell transplant can be curative." According to Dr Amita Mahajan, Senior Consultant, Paediatrics Oncology and Hematology at Indraprastha Apollo Hospital in New Delhi, pregnancy can pose few challenges to patients with sickle cell disease like

Increased Risk of Complications: Pregnant women with SCD face a higher

risk of complications compared to the general population. The abnormal sickle-shaped red blood cells can obstruct blood vessels, leading to vaso-occlusive crises, which can occur during pregnancy. These crises can manifest as severe pain, organ damage, and even life-threatening conditions, such as acute chest syndrome. Furthermore, pregnant women with SCD are more susceptible to infections, anemia, and pre-eclampsia, which can complicate their pregnancies and endanger maternal and fetal wellbeing.

Maternal Mortality and Morbidity: Women with SCD have an increased risk of maternal mortality compared to women without the condition. The combination of pre-existing complications and the physiological changes that occur during pregnancy can exacerbate the health risks. Anemia, which is common in SCD, can worsen during pregnancy due to increased blood volume require-



Alyssa Healy admits: 'The Ashes are on the line, proper' after **Bristol cliffhanger**

Moment of 'pure joy' for Knight, Cross as England stay in the series in epic fashion

LONDON: Alyssa Healy, Australia's captain, has challenged her side to throw out the excuses and galvanise for a response, after conceding that England's third consecutive victory in the white-ball leg of the Women's Ashes has left the series "on the line now, proper". After slipping to a 6-0 deficit following defeat in the one-off Test in Trent Bridge and the first T20I at Edgbaston, England have now roared back to contention, squaring the rubber at six points all with a nailbiting twowicket win in Bristol, with two final ODIs to come at Southampton and Taunton.


And while Australia need only to take victory in either match to retain the trophy that they have held since 2015, the fearlessness of England's fightback - led on this occasion by Heather Knight's superb captain's innings of 75 not out but epitomised by an astonishing penultimate-over ramp for four from Kate Cross - has put real belief into their team's challenge.

Fittingly, it was left to Knight to seal the chase with an emphatic slap for four through point off Jess Jonassen, after which she flung away her bat and let her emotions pour out as she leapt into Cross's arms and soaked up the acclaim of another packed house, with 5,731 fans in Bristol's County Ground.

"It was just pure relief and ecstasy," Knight said at the post-match presentation. "I thought it was slipping away there when we were eight-down, we kept losing wickets at regular intervals and kept making it hard for ourselves, but I was just trying to stay in my little bubble and keep really calm."

At 235 for 8, England still needed 29 to save the series, with only Lauren Bell to come, but Cross settled quickly into her work with back-to-back fours off Jonassen, before Knight climbed into the spin of Ashleigh Gardner with a huge six over cow corner. And then, with the requirement into single figures, Cross unfurled the stroke that telegraphed the extent of England's resolve.

"Kate Cross, what a hero," Knight said. "She was quite nervous when she came in, but we just broke it down, trying to get it in tens. And when fine leg came up, I just had a chat with her, 'paddle's on, I back you to do it'. I thought she might go pace off, but Crossy executed it brilliantly, and took all the pressure off." Cross finished unbeaten on 19 from 20 balls from No.10, a priceless contribution that showcased all of her experience, and more than made up for a tricky day with the es out there. So it's up to us to turn it around



ball, with her six overs in Australia's innings going for 42. What's more, after being laid low by a tropical disease in March that disrupted Cross's preparation for this series, it was further proof of the fighting qualities that had got her back to full fitness for this campaign. "I kept saying to her, 'Lauren Bell's in next, so keep going, keep getting it down," Knight joked. "Poor Lauren was a bit nervous, but I'm really pleased for Kate. She's probably not had the best day but she's one of the most resilient people that I know, so to see her do that was outstanding.'

For Healy and Australia, however, it was a deeply chastening loss. Last week, their 2-1 defeat in the T20Is was their first loss in any series since 2017-18; now they have lost their first ODI in 16 attempts - and only their third in 46 - and have lost three matches in a row for the first time since February 2017.

"I mean, the Ashes is on the line now proper, isn't it?" Healy said. "So if that doesn't galvanise the group, I don't know what it does. We obviously haven't been in this position a lot. And you know, we either see it as an opportunity to learn and grow, or we see it as an opportunity to throw excusfor the next two games, [because] that Ashes trophy is well and truly on the line."

Defending 264, Australia were rattled early on by a brilliant Powerplay onslaught from Tammy Beaumont and Alice Capsey, whose fast-paced 40s helped lift England to 84 for 1, their highest 10-over score in ODI history. And though their spinners in particular helped to stem the tide, the run-rate remained below five an over for the bulk of the remaining chase.

And despite a scruffy display that contained 23 extras, the multiple World Champions refused to give up without a fight - a trait that gave Healy some comfort as she prepared for what will doubtless be a difficult post-match debrief.

"It ended up going right down to the wire," she said. "Look, we just got outplayed a little bit at the end but thought we fought really well to keep ourselves in the fixture. It was a good game of cricket all round.


"We were probably 20 runs short with a bat, and then we bowled 20-odd extras so I mean, that's 40 runs in the game, so it's probably what's done us at the end of the day. "We've been showing it in patches," she added. "The way we took it as deep as what we did, shows it's still there. We've just got to be better, got to be sharper in different certain areas to get ourselves over the line. And that's what we're going to have to find over the next few days.'


England, however, also have room for improvement even after this thrilling win, in particular their own fielding display which was marked by six dropped catches and a missed stumping. Knight, however, credited the Bristol crowd for playing their part in keeping the team's spirits high throughout, and carrying them over the line.

"We can be a lot better as well," Knight said. "It was definitely not our best day. But the fight in the side is remarkable and we showed that again today." "I found it a really tricky wicket, I don't think I middled one until I was on about 30," Knight added. "It was quite hard to feel fluent and to rotate the ball around but the crowd kept us in it.

"We know Australia are a brilliant team and we're going to have to go again in Southampton, but the support from the crowd was unreal. I had to not get too high when everyone was singing Hey Jude at the end, and try not to sing along in my head, but it's been awesome.
