

# Over 1.40 Lakh Kg **Drugs Destroyed, Amit Shah Says Aim Is To Ensure No Youth Under Influence Of Narcotics**

**NEW DELHI, JUL 17:** Union Home Minister Amit Shah on Monday said the fight against drugs is to ensure that no youth is under the influence of narcotics and the country is safe and free from illegal substances.

Shah said this at a conference on "Drugs Smuggling and National Security" during which he watched through video conferencing destruction of more than 1.40 lakh kg drugs worth Rs 2,381 crore in various parts of the country. "Our aim is to ensure that no youth is under the influence



of drugs.... Our aim is to make the country drugs free and secure. I appeal to all chief ministers and LGs (lieutenant governors) to extend all possible cooperation for it," he said.

The home minister said that in the last one year 10 lakh kg drugs worth Rs 12,000 crore were destroyed and it is a very significant achievement.

"Many congratulations to all the people involved in fulfilling such a big goal in the Azadi ki Amrit Mahotsav,"

He said when the state and central governments along withall the agencies come together on a single platform then only "we will be able to make the country free from drugs".

# **Gurez Village Lacks Basic Amenities, Say Locals**

Urge admin to address their grievances on priority

BANDIPORA, JUL 17: Shikari village in Tulail area of Gurez is without basic facilities causing immense hardships

Residents told the news agency-Kashmir News Observer (KNO), that the village lacks proper road connectivity, healthcare facility, electricity, mobile connectivity and potable water

According to the locals, the village health centre has been closed for years now and the staff rarely shows up.

"Also, the situation is no different at the local school where irregular attendance of teachers is negatively impacting students," they said.

Similarly, locals complained about lack of piped water saying they have to collect water in buckets from a distance.

'We have to go to far-off places to fetch water because we don't have access to a drinking water facility nearby," Bashir Ahmad a local resident said, adding that their village is

"We will be able to succeed in this campaign against drugs by following 'whole of government approach' with cooperation, coordination, collaboration,"

Shah said till the financial chain of drug smugglers are not broken, the fight against drugs is not completed.

He said that earlier the main area of drug smuggling was called 'Golden Triangle' and 'Golden Crescent' but the Government of India has proposed internationally that it should be named as 'Death Triangle' and 'Death Crescent'. "This approach shows the direction and intensity of our fight against drugs," he

The home minister said there is no question of a single destination for elimination of drugs or a single target for

"It is an act of constant vigilance. A moment's laxity can spoil the entire movement," he said.

The destruction of the narcotics, the bulk of it from Madhya Pradesh, was carried out in different cities as Shah watched through video conferencing from New Delhi.

The drugs destroyed include 6,590 kg seized by the Narcotics Control Bureau's (NCB) Hyderabad unit, 822 kg seized by the Indore unit and 356 kg by the Jammu unit, officials said.

Besides, various law enforcement agencies from different states also destroyed drugs - 1,03,884 (1.03 lakh) kg in Madhya Pradesh, 1,486 kg in Assam, 229 kg in Chandigarh, 25 kg in Goa, 4,277 kg in Gujarat, 2,458 kg in Haryana, 4,069 kg in Jammu and Kashmir, 159 kg in Maharashtra, 1,803 kg in Tripura and 4,049 kg in Uttar Pradesh.

With the destruction of drugs on Monday, the total quantity of drugs destroyed in just one year has reached around 10 lakh kilogram with a value of Rs 12,000 crore. From June 1, 2022 to July 15, 2023, regional units of the NCB and anti narcotics task forces of the states collectively destroyed around 8,76,554 (8.76 lakh) kg seized drugs worth around Rs 9,580 crore which is more than 11 times the target. investigation clearly established that the trio were "acting on behalf of Paki-

stan ISI and the terror outfits." "The trio were terminated from the service for actively working with Pakistani terror outfits, providing logistics to terrorists, propagating terrorists ideology, raising terror finances and furthering secessionist agenda. The government has invoked 311 (2) (c) of the Constitution of India to sack the three government employees after painstaking investigation clearly established that they were acting on behalf of Pakistan ISI and the terror outfits," officials said

The respective orders for the dismissal of the three employees were issued by the General Administration read that the Lieutenant Governor is "satisfied after considering the facts and circumstances of the case and on the basis of the information available, that the activities of the trio are such as to warrant his dismissal from service".

Under Article 311(2)(c) of the Constitution a government employee can be dismissed when the President or the Governor is satisfied that in the "interest of the security of state it is not expedient to hold such an inquiry."

According to officials, Aslam is a "diehard secessionist" who not only "subscribes to and endorses the secessionist ideology, but has been a key propagandist for terrorists and terror outfits in Kashmir Valley."

They said Aslam's social media posts depict beyond doubt that he is a hardcore Pak Embedded High Value Asset (PEHVA) of Terror Outfits, responsible for promoting and glamorising terrorism.

Officials said constable Thokar was a highly effective overground worker (OGW) of banned Jaish-e-Mohammad and on account of being a policeman, as he "took undue and criminal advantage" of his uniform and his credentials.

..Instead of helping the department in fighting terror which he (Arshid) was mandated for, he chose to be a mole and a collaborator and betrayed his oath and uniform," they said.

Former chief minister and PDP chief Mehbooba Mufti said the LG administration is "institutionalising a permanent state of disintegration in J-K"

Pradesh, Madhya Pradesh and Rajasthan. Two of the pilgrims died of cardiac arrest, while the cause of the death of the third was being ascertained, the officials added.

While two people died on the Pahalgam route of the yatra, one death occurred on the Baltal route, they said.

These three deaths have taken the toll during the yatra so far this year to 30.

Among the victims are an Indo-Tibetan Border Police (ITBP) officer posted on yatra duty, a sadhu and a sevadar, according to the officials.

Cardiac arrest triggered by low oxygen concentration at high altitude is one of the most common causes of fatalities among Amarnath pilgrims and security forces posted there.

So far, over 2.30 lakh pilgrims have visited the cave shrine to glimpse the natural ice lingam formation.

The 62-day annual pilgrimage to the 3,888-metre-high cave shrine in the south Kashmir Himalayas commenced from the twin tracks of Pahalgam in Anantnag district and Baltal in Ganderbal district on July 1. The yatra is scheduled to conclude on August 31. (Agencies)

"For the past 20 years, the villagers have been demanding a replacement for the damaged bridge which caters to over 2,000 population, many of whom use the bridge daily to reach their destinations and bring essentials like ration from the town," Joginder Kumar (70), a resident of Rainda village, said.

Villagers said they have pleaded before the authorities several times to either replace the 61-year-old damaged bridge with the steel plated one, or at least repair it for the safety of the school going

"Roads and Buildings Department officials have carried out surveys of the bridge more than 50 times in the past two decades, rekindling hope every time that we will get a safe bridge but unfortunately nothing happened on the ground," Shri Krishan Sharma (68) said.

Amit Kuma Sharma said they are fed up with false promises.

"It's really painful to being in a state of fear all the time, especially during rains when the water level in Neeru almost touches the surface of the bridge. We have no other option but to cross the worn out bridge to reach the other side of the river," he said.

Assistant Executive Engineer, Roads and Buildings, Bhaderwah, Mushtaq Ahmed Sheikh admitted that the old foot bridge is in a "very bad condition" and said they have already sent a detailed project report to NABARD worth Rs 2.15 crore for construction of a motorable bridge on the river.

"The district administration has taken up the issue on top priority considering the safety of the people. As of now, we will send a team of engineers for safety checks and, if necessary, the bridge will be closed for people. The people are requested to avoid crossing the bridge and instead use Sarolbagh bridge," the officer said.

Sarolbagh bridge is three kilometres away from Rainda bridge. (Agencies)

situated on a hill, and rains trigger landslides causing damage to their houses.

"The absence of electricity persists and the government is not concerned about our plight," he added.

Noor Mohammad, another local resident, said they travel to a nearby village to make a call as the village lacks mobile network connectivity.

#### **Tourist footfall.....**

February 2021, halting the bloodshed and firefight. Since then, the erstwhile no-go zones have been opened up for visitors and paving way for night camping, bonfires, trekking, and other related activities.

Talking to news agency-Kashmir News Observer (KNO), officials said that the footfall of both international and domestic tourists has shown an increase compared to previous years.

They said that the facilities have been enhanced and everything required for visitors is being facilitated.

A senior administrative official privy to the tourism activities in the district said that the figures compared to previous years are close to double now. "Kupwara is witnessing an ever-increasing footfall of tourists. They include both international and domestic arrivals. All previous records have been broken in terms of tourist arrival," the official said.

Faroog Ahmad, Executive officer of Lolab Bungus Drangyari Development Authority (LBDDA) said that the tourist footfall is increasing too much. "Since April this year, Kupwara has recorded about 1.40 lakh visitors, both international and domestic.'

He said that last year until July, 67,000 tourists arrived in the district. "This year, the number has already gone past 1.27

lakh visitors," he added. The executive officer said that everything required has been enhanced for a better experience. "About 76 homestay facilities have been readied and are registered with the department. They are providing both accommodation and food to visitors," he said. "Besides, 150 homestays are providing facilities in the district but are not registered with us."

Eco Parks, he said developed by the forest department, are acting as premier tourist attractions. "Waterfronts have been developed. Children's parks are maintained. Tourist huts have been repaired," he said.

#### Two IEDs.....

Operation (SADO) in Wodhpura Forest in the wee hours of Monday.

The operation resulted in the recovery of two sophisticated IEDs weighing approximately 5 and 7 kg, concealed in the jungle area. The team immediately cordoned off the area with adequate

security measures. The positive identification of an IED was carried out by the Indian Army's highly trained Explosive detection team, equipped with explosive detectors and an army dog.

The Bomb Disposal team executed a controlled detonation of IEDs, rendering them safe.

A thorough search operation was resumed by personnel of the Indian Army and Handwara Police in the general area of Wodhpura Forest for any more IEDs or hiding militants. No loss to life and property was reported.

The prompt action by the joint team of security forces averted major incidents in the area, police said.

of the Indian Army and Jammu and Kashmir Police established an anti-infiltration posture in multiple tiers to prevent any terrorist from escaping," said the spokesman.

He stated that in the early hours of the morning, contact was established, which led to a heavy volume of fire being exchanged.

In the ensuing firefight, two terrorists were hit. One of the terrorists fell on the spot, while the other terrorist was observed falling in the Poonch River," he added.

Lt Col. Bartwal said that in a deliberate and massive search operation, the body of one terrorist has been recovered from the site.

Major warlike stores were recovered, including one AK-74 rifle with magazine, eleven rounds, and other stores for sustenance, he added.

He further said, "By their quick action, alert troops of the Indian Army and Jammu Kashmir Police have eliminated a major infiltration bid, which was aimed at disturbing the peace in Poonch District."

"The Security Forces continue to remain alert on the Line of Control and are fully prepared to thwart such attempts in future too," said the PRO.

when she was eight years old and has never got connected with them

"Then I was brought to the valley by a Kashmiri family from Bangalore. They took care of me like their own child and I spent around 19 years with them. Later, I got very ill due to

rheumatoid arthritis and continued living with them for a few more years," she said.

They even took care of my treatment; bore the expenses of my operation which, however, didn't show any positive result. "I became so weak that I wasn't able to hold anything in my hand. I had to undergo hip replacement surgery as well. Then, I decided to part from them as I didn't want to put further burden on them," Noor said.

Saima said that in Srinagar, she admitted herself in SMHS for treatment and was there for some time. "However, I suffered panic attacks due to the continuous noise in the hospital. Then, after the intervention of a woman working in the Social Welfare Department, the then DC Srinagar ordered the hospital authorities to provide me a room," she said.

She is now living a wheelchairbound life in SMHS where she has been encountering the harsh realities of hunger and loneliness, and transforming the adversity into artistic mastery.

I started painting at Ward 6 of the hospital to divert attention from noise, loneliness, hunger and other issues and have made hundreds of paintings so far. I even sold a few to manage my expenses, she said, adding, "Sometimes, some friends also help".

"I haven't even eaten anything for weeks together as nothing was available but still I think I am alive only because of Kashmiri people," Saima said. "Had I been living anywhere else, I would have been in the grave.'

Saima, however, refuses to succumb to despair and dependency; instead, she embarked on a creative journey using her artistic talents.

"One shouldn't succumb to despair but try to work whatever he/she can so as to remain independent," she said, adding that she has been given a space in Kashmir Haat Srinagar to sell her art pieces.

My message to the other speciallyabled persons will be that your disability isn't the end of life, rather you need to be courageous to fight all odds and overcome challenges, Saima said. "If your one organ isn't functioning, your brain is working and that is enough to work on your dreams to make them come true."

At the outset, the Deputy Commissioner took a detailed review and progress of all Tehsils of the District on various Revenue matters including progress on digitization of Jamabandis/Girdawari, Reconstruction of damaged Massavies, Status of Migrant offline/ online grievances, updation of cases on Revenue Court Cases



Monitoring System (RCCMS), Online services delivery system, digitization of legacy mutations.

While reviewing progress with regard to authentication process of digitised Jamabandies and scanning of revenue records as per the targets, the DC asked all the Tehsildars to clear pendencies under set timelines. The DC asked the concerned Revenue Officers to

reconcile the updated/corrected copies of the Jamaban dies with therespective Tehsil Offices to ensure presence of up-to-date records. He sets Tehsil wise deadlines for completing the process of Authentication of Jamabandies.

should be regularly uploaded, so

that functioning of the Revenue

Courts is effectively monitored. With regard to disposal mech-

anism of grievances related to Migrant properties filed by the Kashmiri migrants in different categories offline/online, the DC was informed that till date 1929 grievances have been received by the District Administration, out of which 1733 grievances of different nature have been resolved by the Office of District Magistrate Srinagar with quality disposal while disposal of remaining grievances is being carried on fast track basis.

On the Deputy Commissioner instructed all the Tehsildars to pay special thrust on ensuring efficient and prompt delivery of public services to their best satisfaction as envisaged under Public Services Guarantee Act (PSGA). The ignorance of public issues and growing unemployment in J&K has led to the feeling of despair among the people that needs to be addressed by holding assembly elections because an elected Govt is answerable to people," he further stated.

# 59 Posts of Teaching, Non-Teaching Staff Lying Vacant in NIT Srinagar; Reveals RTI

SRINAGAR, JUL 17: Fifty Nine positions of teaching and non-teaching staff are lying vacant in National Institute of Technology(NIT) Srinagar which is one of premier education institution of north India, information in this regard has been shared by the Central Public Information Officer of the institute in response to an RTI application by a Jammu based RTI activist Raman Sharma.

In official letter dated 19/06/2023 signed by Registrar & Central Public Information Officer of the institution, the Reply informs that NIT Srinagar has 4-Tier Flexible faculty cadre structure and the total sanctioned strength of permanent faculty staff is 198 and posted strength is 162. It further states that there are 36 vacant faculty posts.

The reply served by the institute also discloses that there are 13 temporary faculty members also, including 03 posted in Electrical Engineering department, 03 in I.T department, 2 in Metallurgical & Materials Engineering, 02 in Humanities and Social sciences and Management, 01 each in Computer Science & Engineering, Electronics & Communication Engineering and department of Physics.

The information provided by the CPIO to RTI activist Raman Sharma also reveals that 23 posts of perma-



nent non-teaching staff are also lying vacant there in NIT, Srinagar.

While giving detail about the intake capacity and as on date enrolled strength of the students there in the institute, the documents provided by the CPIO disclose that intake capacity for undergraduate courses is 952 (including 53 for DASA, Direct Admission for Students Abroad) and for Post graduate courses it is 439(including 23 for DASA). As on date total enrolled strength of students in Undergraduate courses is 3175 and those pursu-

ing PG Courses is 428.

Category wise detail of Students reveals that 269 students under EWS quota are pursuing Under graduate courses and 7 are admitted for PG courses, 1606 students under open merit category out of which 1406 are pursuing UG courses and 200 undergoing PG programs. In the reply it has also been informed that there are 501(SC), 256(ST), 56(PWD), 742(OBC-NCL), 3(DASA) 163(Self Sponsored) students enrolled in the NIT Srinagar and pursuing different courses.

#### **Crime Branch, NCB, District Police Pulwama and Samba destroys seized** contrabands worth crores

**SRINAGAR, JULY 17:** Jammu and Kashmir Police in collaboration with Narcotics Control Bureau (NCB) has carried out destruction of large scale seized narcotic drugs in Samba and Pulwama today.

Under the Union Governments programme, Nasha Mukht Bharat Abhiyan, Crime Branch J&K as (Nodal agency) in collaboration with NCB, District Police & Judiciary took a major leap forward and destroyed 7798 Kgs seized contraband, 8545 /106730/51 Psychotropic substance at M/S Anmol Healthcare Samba & M/S Kashmir Healthcare IGC Lasipora, Pulwama. The contrabands were seized in 670 different NDPS cases of UT JK and were valuing approximately Rs.17 Crores.

The destruction was carried out by incineration in a controlled manner as provided under rules to avoid any harm to the environment. This was just a start of the process and in the coming day all the drugs lying in different Police, Court and ANTF Godowns are being destroyed as per the laid down guidelines. It is pertinent to mention here that the destruction of seized contraband initiative has been taken by Hon'ble Union Home Minister Shri Amit Shah under Nasha Mukht Bharat Abhiyan throughout the country.

# J&K BJP chief serves legal notice to former MLC; seeks apology for false allegations of corruption

JAMMU, JUL 17: Jammu and Kashmir BJP president Ravinder Raina on Monday served a legal defamation notice to former MLC Surinder Choudhary who recently joined National Conference here after ending his over yearlong association with the national party.

Raina sought an unconditional apology from Choudhary within a week for his attempts to damage his reputation among the masses and the party ranks, warning of a defamation suit worth Rs five crore against the politician after the expiry of the deadline.

Choudhary quit Peoples Demo-

cratic Party on March 30, last year before joining BJP within a week. However, he left the BJP and joined National Conference Vice President Omar Abdullah on July 7. Choudhary announced his decision to quit BJP on his twitter handle and accused Raina of encouraging "familism and corruption".

"I have served a legal notice to Choudhary through my lawyer from J&K High Court (Navyug Sethi) for leveling baseless allegations against me with the sole aim to defame my reputation within the party and the masses. He should apologize within one week or prepare for legal action,"



Raina said.

In the legal notice, Sethi said the intentional defamation of his client was a designed move coinciding with the joining of Choudhary in National Conference and

his client has suffered serious damage to his name, reputation and goodwill besides suffering from mental trauma.

"You may choose any political party that suits your ambition, yet the choice of words in the tweeton July 11 are purely inappropriate, rather defamatory to my clients and the BJP, despite you knowing well that my client was not involved in any of the alleged acts," the legal notice read.

Sethi said it was clear that in order to damage his client reputation and years of goodwill as an honest upright politician, the allegations have tarnished his reputation amongst the general public as also in his party circles and relatives. He said his client is well within his legal rights to invoke remedies both under civil and criminal law against Choudhary.

Additional Deputy Commissioner Baramulla/ Sopore, Principal Government Medical College Baramulla, Programme Officer ICDS, SDM's and other functionaries of concerned departments were present in the meeting.

Every day the police bulletins are a buzz with news of Notorious drug peddlers being nabbed and huge hauls of drugs being recovered from their possession. Although the majority of drug users are male and drug stores are the major suppliers to addicts, however the alarming trends surfacing are that a good number of female folk has been dragged into this menace through a well knit conspiracy. Experts have taken serious note and warn disaster if society doesn't act now.

In Kashmir Valley alone the aftermath the of conflict is depressing as well as dangerous for the society. Mass destruction of life and property, and overwhelming fear and uncertainty during the past many years of disturbance has taken heavy psychological toll-being manifested in terms of rampant drug abuse among youth.

A recent study conducted by a local NGO in Srinagar revealed substantial increase in the number of patients diagnosed as drug abusers during last 10 years. Valley's leading psychiatrists giving the background of the menace are of the opinion that over the past decade Kashmiri youth are highly traumatised and to relieve of the stress they often take drugs . Psychological problems are in the back ground. The use of various drugs has increased tremendously during these years of traumatic violence. The Study shows that the society at large is in deep slumber and needs to wake up and every member has a role to play to put this mess in order otherwise it is bound to spell the disaster.


Sociologists warn that the abuse has assumed a kind of epidemic and it's consequences would be disastrous on the society. The problem needs to be handled immediately, otherwise it would be too late to act. Nobody as a member of society can be exempted from the responsibility. # Crucibles: Must-haves in leadership development



There is great value in moving across functions, geographies, work relationships, and domains-what I term as talent portability and adaptation. A questioner may rightly ask why this is so: where does the value accrue? The answer lies in the idea of a 'crucible'.

A crucible is a vessel in alchemy where the nature and character of the contents change and become quite different from the original ingredients. The change may be for the better or for the worse. In chemistry, it is a fairly severe trial in which different elements interact, creating something

Essentially, when an individual undergoes a life experience, they are modified by that experience-like, for example, when Gandhiji was thrown out of a first-class compartment in South Africa despite possessing a valid ticket, or when school-pass Srinivasa Ramanujan left for Cambridge, England, to do high research in mathematics with Professor G H Hardy.

A crucible experience may arise due to an incident (what happens), due to the context (how, where, and when), or both. For example, Indians who went to the USA in the 1960s, when immigration rules in that country were liberalised, were impacted—many favourably, but some unfavourably—by what happened to

them as well as the new context. If you imagine an x-axis titled 'incident impact' and a y-axis titled 'context impact', you can construct a matrix: from low impact/context to high impact/context with combinations in between.

When Nandan Nilekani moved from his post as CEO of Infosys to a government job as head of UIDAI (Unique Identity Development Authority of India), aka Aadhaar, it was a high-impact/context transition. When a young Deepak Parekh quit his multinational bank job in 1977 to join a startup called HDFC, it was a crucible experience for him. When I moved from the post of vice-chairman of HUL to director of Tata Sons, it was a high-impact/context situation. On the other hand, when I was moved from being a regional sales manager in the west to the north, it was a lowimpact/context situation. All had developmental implications (crucible effects), but some were more impactful than others.

Such a logic drives the idea of talent portability and adaptation, which means that every few years, a high-potential executive should experience work change along one or more of the four vectors of talent portability—function, geography, relationships, and domain. In great talent companies, crucible effects are designed, but they may also occur unplanned. The following anecdote illustrates the point about unplanned crucible events.

A Hungarian lieutenant took part in a leadership development program. On his first leadership assignment, he led his small team on the required

On the evening of the third day, the team camped to rest for the final assault the next day. Since the weather was clear, several soldiers in the team volunteered to do an advance recce of the assault area so that the probability of success on the next day would increase. The leader agreed. The soldiers left but without their equipment or instruments.

An unexpected blizzard arose that night. None of the men returned throughout the long night. The lieutenant was rightly distraught at letting his men go on an unplanned recce sans instruments and equipment. When the blizzard miraculously abated the next morning, the men straggled back, much to the amazement of the leader. What happened, he enquired. "We had given up," said a young soldier,
"When suddenly Pietr here pulled out a map. The map helped us to find our way back." Upon seeing the map, the lieutenant was astonished that it was a map of the Pyrenees, whereas their action had occurred in the Swiss Alps. It is the equivalent of a team finding their way back from Kedarnath with a map of the Nilgiris!

The story is used in leadership training to illustrate that managers find their way out of troublesome and unexpected situations through 'sensemaking', not precise maps. Such sensemaking has a tremendous impact on how a leader develops.

Crucible training has existed in one form or another for many years. Vanavasa for Sri Rama was a crucible training as it was also for the Pandavas.

Without calling their training programs by that name, great talent companies design their crucible programs, improving and tweaking these continuously. McKinsey makes associates work on unfamiliar domains,

and Hindustan Unilever sends its future leaders on rural development stints. Indian defence and administrative officers change the station and role for upcoming officers every few years. Portability and adaptation are also techniques people of other professions resorted to voluntarily. Dr John Goodenough, who died recently at age 101, won the Nobel Prize at age 97! His scientific work on lithium batteries has

day marvels in the form of cell phones and other hand-held instruments. In short, crucibles and adaptation are the antitheses of stagnation. They hold the key to human neoteny, which means rejuvenation and youthfulness. Leaders who cling on to positions of responsibility—CEOs of companies, heads of State, leaders of political parties—fail their stakeholders by throttling the

# **BJP Says 38 Parties Support** NDA As 26 Opposition Parties **Meet In Bengaluru**

New Delhi: The BJP's mega show of strength in Delhi -- to be conducted parallelly with the Opposition's unity meet in Bengaluru -- will be attended by 38 parties, party chief JP Nadda announced today. Though most of the 38 are smaller allies with pockets of influence and a few or no MPs, the figure far outstrips the 26-party tally announced earlier by the Congress -- a psychological advantage the ruling party hopes to deploy in the runup to next year's general elections.Addressing the media this evening, BJP chief JP Nadda said the NDA's reach and scope has increased over the years."The growing desire of the people to push the agenda of development has led to the expansion of the NDA... Good governance given in the last nine years under the leadership of Modi-ji... It is a continuous

process," he told reporters. The BJP's outreach to allies had come late in the



day -- weeks after the opposition held its first unity meet in Patna in June. The opposition has jeered that its unity move -- modelled after the JP movement of 1970s -- has had the BJP jarred.The BJP, though, has been moving in a planned manner. Most of its push has been in Bihar, where Nitish Kumar had mopped up the board when he parted company with the NDA, leaving only the fractured Lok Janshakti Party to the BJP. The BJP is now attempting to effect a reconciliation between Chirag Paswan and its uncle, which will give it access to the six per

cent Paswan votes.

Three more parties from Bihar -- Upendra Singh Kushwaha of the Rashtriya Lok Samta Party, and Mukesh Sahani of the Vikassheel Insaan Party and Jitan Ram Manjhi of Hindustani Awam Morcha -- are expected to join the NDA.

While the key allies -AIADMK and Tamil Manila Congress in Tamil Nadu and Shiv Sena (Eknath Shinde faction) and Ajit Pawar faction of the NCP in Maharashtra --are expected to keep the seat count up in the two major states, the BJP has also kept close its allies in the northeast.

Seven parties that helps the BJP govern the seven

northeastern states -- NPP (National People's Party Meghalaya), NDPP (Nationalist Democratic Progressive Party), SKM (Sikkim Krantikari Morcha), MNF (Mizo National Front), ITFT (Tripura), BPP (Bodo People's party) and AGP (Asom Gana Parishad) -- are on the list.There are a few new entrants also. Besides the ones in Bihar and Uttar Pradesh, the BJP has drawn actor Pawan Kalyan's Jansena and the faction of Kerala Congress led by Kerala Congress (Thomas). The latter had quit the NDA in 2021 alleging trouble in seat sharing, but has since refreshed the alliance. Post a commentThe list

overall makes clear the party's trajectory. Already strong in most northern states, the BJP has been sticking to its plan of beefing up in the south, west and northeast. In crucial states like Uttar Pradesh and Bihar, it is only seeking to extend its footprint by patching in parties that have influence among Scheduled Castes.

# Assets Of Those Involved In Drug Trade Should Be Confiscated: Amit Shah

New Delhi: Union Home Minister Amit Shah on Monday pitched for harsher punishments such as confiscation of assets of those involved in the drug trade and their public shaming, saying such action will act as strong deterrence.

Mr Shah addressed a conference on "Drugs Smuggling and National Security" during which he also watched through video conferencing the destruction of more than 1.40 lakh kg of drugs worth 2,378 crore in various parts of the country.

He said it is the aim of the Modi government to create such an India where not even a single youth is addicted to drugs and to achieve this it is necessary for both the states and the Centre to work together.

Harsher punishment will act as a stronger deterrent as it will send a stronger message, he said, adding confiscation of assets of those involved in the illicit drug trade should be increased.

He emphasised that public shaming or boycotting



of such individuals will discourage others from joining the drug trade. "We need to move ruthlessly towards the confiscation of assets."

The home minister said states should collaborate with the Enforcement Directorate (ED) on financial investigations and refer the cases to the ED.

"Until we conduct financial investigations of drug traffickers and break their interest chain, our campaign will not be successful. Our approach should be such that those who consume drugs should be considered as victims, while those who engage in the trade should be marked as culprits," he said.

Mr Shah said those who use drugs are victims and everyone should make efforts to bring them back to the right path rather than leaving them to become

addicts permanently.

"The fight against drugs is to ensure that no youth is under the influence of narcotics and the country is safe and free from illegal substances. Our aim is to make the country's drugs free and secure. I appeal to all chief ministers and LGs (lieutenant governors) to extend all possible coop-

The home minister said that in the last one year, 10 lakh kg of drugs worth 12,000 crore were destroyed and it is a very

eration for it," he said.

significant achievement.

He said when the state and central governments along with all the agencies come together on a single platform then only "we will be able to make the country free from drugs".

"We will be able to succeed in this campaign against drugs by following 'whole of government approach' with cooperation, coordination, collaboration," he said.

He said that earlier the main area of drug smuggling was called 'Golden Triangle' and 'Golden Crescent' but the government of India has proposed internationally that it should be named as 'Death Triangle' and 'Death Crescent'.

"This approach shows the direction and intensity of our fight against drugs," he said.The destruction of the narcotics, the bulk of it from Madhya Pradesh, was carried out in different cities as Mr Shah watched through video conferencing from New Delhi.The drugs destroyed include 6,590 kg seized by the Narcotics Control Bureau's (NCB) Hyderabad unit, 822 kg seized by the Indore unit and 356 kg by the Jammu unit, officials.

# 13.5 Crore Indians Escaped **Poverty In 5 Years: Niti Aayog**

New Delhi: As many as 13.5 crore people in five years ended March 2021 moved out of multidimensional poverty, measured by improvement in health, education and standard of living, with Uttar Pradesh, Bihar and Madhya Pradesh registering the fastest reduction, said a Niti Aayog report on Mon-

India has registered a significant decline of 9.89 percentage points in the number of India's multidimensionally poor from 24.85 per cent in 2015-16 to 14.96 per cent in 2019-2021, according to the second edition of the National Multidimensional Poverty Index (MPI)

While rural areas witnessed the fastest decline in poverty from 32.59 per cent to 19.28 per cent, urban areas saw a reduction in poverty from 8.65 per cent to 5.27 per

"A record 13.5 crore people moved out of multidimensional poverty between 2015-16 and 2019-21," said the report 'National Multidimensional Poverty Index: A Progress Review 2023' released by Suman Bery, Vice-Chairman, Niti Aayog.

The National MPI measures simultaneous deprivations across three equally weight-



ed dimensions of health, education, and standard of living that are represented by 12 SDG-aligned indicators.

These include nutrition, child and adolescent mortality, maternal health, years of schooling, school attendance, cooking fuel, sanitation, drinking water, electricity, housing, assets, and bank accounts.

Marked improvement is witnessed across

all the 12 indicators, Niti Aayog said, adding the report follows the Alkire-Foster methodology developed by its technical partners -- the Oxford Poverty and Human Development Initiative (OPHI) and United Nations

Development Programme (UNDP). According to the latest update of the global MPI released by UNDP and OPHI at the University of Oxford, a total of 415 million people moved out of poverty in India within just 15 years from 2005/2006 to 2019/2021.

The Niti report attributes the decline in poverty to the government's dedicated focus on improving access to sanitation, nutrition, cooking fuel, financial inclusion, drinking water, and electricity. All 12 parameters of the MPI have shown marked improvements.

The report states that the fastest reduction in the proportion of multidimensional poor was observed in Uttar Pradesh, Bihar, Madhya Pradesh, Odisha, and Rajas-

Between 2015-16 and 2019-21, the MPI value nearly halved from 0.117 to 0.066 and the intensity of poverty reduced from 47 per cent to 44 per cent.

India is on the path of achieving the SDG Target 1.2 (of reducing multidimensional poverty by at least half) much ahead of the stipulated timeline of 2030, said Niti Aayog CEO B V R Subrahmanyam.

The report said schemes like Poshan Abhiyan and Anaemia Mukt Bharat have contributed to reduced deprivations in

Initiatives such as Swachh Bharat Mission and Jal Jeevan Mission have improved sanitation across the country.

South Korea's president vowed on Monday to "completely overhaul" the country's approach to extreme weather from climate change after at least 39 people were killed by recent flooding and landslides during monsoon rains.

Rescue workers waded through thick mud as they drained a flooded underpass in central Cheongju, searching for more victims after vehicles were trapped in the tunnel by flash floods, the interior ministry said, with nine people still missing

 $South\,Korea\,is\,at\,the\,peak\,of\,its\,summer$ monsoon season and days of torrential rain have caused widespread flooding and landslides, with rivers bursting their banks and reservoirs and dams overflowing – and there is more rain forecast this week.

"This kind of extreme weather event will become commonplace – we must accept climate change is happening, and deal with it," President Yoon Suk Yeol said on Monday, ahead of a visit to flood-hit North Gyeongsang province.

The idea that extreme weather linked to climate change "is an anomaly and can't be helped needs to be completely overhauled", he said, calling for "extraordinary determination" to improve the country's preparedness and response.

South Korea will "mobilise all available resources" including the military and police to help with rescue efforts, he said.



"The rainy season is not over yet, and the forecast is now that there will be torrential rain again tomorrow," he added.

The majority of the casualties — including 19 of the dead and eight of the missing – were from North Gyeongsang province and were largely due to massive landslides in the mountainous area that engulfed houses with people inside.

Some of the people who have been reported missing were swept away when a river overflowed in the province, the interior ministry said.

Stay inside South Korean police said they would launch an investigation into the fatal flooding of the underpass in Cheongju, some 112km south of Seoul, Yonhap reported.

The underpass flooded early on Saturday when a nearby river overflowed and an embankment collapsed, leaving 16 vehicles, including a bus, trapped inside, with at least 12 people killed and rescue workers warning the toll could rise as they searched

The Korea Meteorological Administration forecast more heavy rain through Wednesday and urged the public to "refrain from going outside".

South Korea is regularly hit by flooding during the summer monsoon period, but the country is typically well-prepared and the death toll is usually relatively low.

Scientists say climate change has made weather events around the world more extreme and more frequent.

South Korea endured record-breaking rains and flooding last year, which left more than 11 people dead.

They included three people who died trapped in a Seoul basement apartment of the kind that became internationally known because of the Oscar-winning Korean film "Parasite".

The government said at the time that the 2022 flooding was the heaviest rainfall since Seoul weather records began 115 years ago, blaming climate change for the extreme weather. Yoon, just back from an overseas trip, on Monday convened a disaster response meeting and conceded the situation was made worse because of poor management of vulnerable areas.

"We've repeatedly emphasised access control over dangerous areas and preemptive evacuation since last year, but if basic principles of disaster response are not kept on the spot, it is difficult to ensure public safety," Yoon told the meeting. ### 1,500 flights canceled as storms hit NE US

New York, July 17 (UNI) Over 1,500 flights in and out of the United States have been canceled as of Sunday evening as storms battered the country's northeast over the weekend.

Thunderstorms and heavy rain have caused massive flight disruptions and ground stops at major airports in New York and New Jersey, according to the Federal Aviation Administration.

Newark Liberty International Airport in New Jersey has experienced the most significant cancellations, with 362 flights canceled and 337 delayed as of Sunday evening, according to the flight-tracking site FlightA-

In New York, John F. Kennedy International Airport has seen 318 canceled flights and 426 delayed flights. At LaGuardia Airport, another airport in the city, the number of canceled flights has reached 270.

Boston Logan International Airport also experienced a ground stop due to thunderstorms on Sunday evening. Flight Aware data showed that nearly 260 flights were canceled.

In the U.S. Northeast, over 56 million people were under a flood watch, as heavy rain moved through on Sunday, causing flash flooding and power outage in parts of New York, New Jersey, Pennsylvania, Delaware and Maryland.

### **Hong Kong issues No. 8** typhoon signal as Typhoon **Talim draws near**

Hong Kong, July 17 (UNI) The Hong Kong Observatory issued the No. 8 Southeast Gale or Storm Signal on Monday morning, which will remain in effect until 4 p.m. local time under the effect of Typhoon Talim.

The No.8 signal is the third-highest warning under Hong Kong's weather system. Winds with mean speeds of 63 km per hour or more are expected from the southeast quarter.

The Hong Kong Stock Exchange has suspended trading, multiple flights have been canceled at Hong Kong International Airport, several piers have been suspended, and attractions such as Hong Kong Disneyland have been temporarily closed.

At 1 p.m. on Monday, Typhoon Talim was centered about 270 km southwest of Hong Kong and is forecast to move west-northwest at about 18 km per hour in the general direction of Leizhou Peninsula, Guangdong

#### Norway temporarily bans Facebook, Instagram from tracking users for ads

Oslo, July 17 (UNI) Norwegian authorities have imposed a three-month ban on Instagram and Facebook from showing users in the country personalized advertisements, based on information not expressly authorized by the user for such purposes, the Politico news agency reported on Monday, citing an official

The Norwegian Data Protection Authority ordered US company Meta (banned in Russia as an extremist organization), the owner of Facebook and Instagram, to cease showing Norwegian users personalized ads based on any personal data, except for data given by users in the "about" section of their profiles, Politico

The ban starts from August 4 and will last for three months, and Meta will have to pay a fine of 1 million Norwegian Krone (\$99,504) for each day it does not comply with the order, the news outlet reported.

At the moment, Meta uses several controversial advertising practices that involve showing its users personalized ads based on personal data, which a person did not provide willingly, such as online activity and estimated locations.

### Iran relaunches police patrols against veil violations

Iranian police on Sunday relaunched patrols to catch the increasing number of women leaving their hair uncovered in public in defiance of a strict dress code, state media reported. The report comes exactly 10 months after the September 16 death in custody of Mahsa Amini, 22, triggered nationwide protests and saw morality police largely disappear from the strees, while more and more women flouted the law.

Amini, an Iranian-Kurd, had been arrested by morality police for allegedly violating the dress code, which requires women to cover their head and neck in public. While the morality police withdrew, authorities have taken other measures to enforce the law. These included the closure of businesses whose staff do not conform to the rules, and installing cameras in public places to track down offenders. But beginning on Sunday, the traditional approach is being tried again, state media said. "The police will launch car and foot patrols to warn, take legal measures, and refer to the judiciary those who disobey police orders and disregard consequences of dressing against the norms," the official IRNA news agency quoted police spokesman Saeed Montazer Almehdi as saying. Online images have shown female police officers, clad in all-black chadors, berating and arresting women whose heads were uncovered. AFP could not independently verify the authenticity of the images.

# Hamas unable to pay salaries in Gaza after Qatari aid delay

GAZA: The Gaza Strip's Hamas rulers have been unable to pay salaries for 50,000 public sector workers, with officials in part blaming a delay in a monthly payroll grant from Qatar, a crucial aid donor to the impoverished Palestinian enclave.

The salary crisis has sparked an unusual amount of criticism on social media in Gaza, including by some of Hamas' own employees. A drop in tax revenue and a jump in spending has made the situation even more difficult.

Most of Gaza's 2.3 million residents live in poverty, and the economy is dependent on foreign aid. Qatar



has paid hundreds of millions of dollars since 2014 for construction projects. It currently pays \$30m per month in stipends for families, fuel for electricity, and to help pay public sector wages.Hamas officials say no salary aid has been received since just over half of a \$5m grant to support the May payroll. The reason

for the delay was not clear.

"The government is going through a stifling and escalating financial crisis, with a continuous increase in the deficit month after month, which led to the delay of salaries this month," Awni Al-Basha, the Hamasappointed deputy minister,

cant efforts to pay the salaries, and we hope to do so at the end of this week," he said.Monthly payroll costs Hamas 125m shekels (\$34.5m) per month, said Basha.On Sunday, Salama Marouf, chairman of the Hamas government media office, said there has also been an increase in spending, particularly for the ministry of health and repayment of bank debts. He called on Qatar to increase the salary grant to \$7m.Gaza has been under an Israel-Egyptian blockade since 2007 when Hamas, which opposes peace with Israel, took control. Public sector employees have not received full salaries since 2013.

### Nato's partnership with **Pakistan to continue:** ambassador

ISLAMABAD: The North Atlantic Treaty Organisation's (Nato) partnership with Pakistan would continue in the days to come as both had a cooperation programme that included research and development.

Talking to Dawn, Belgian Ambassador to Pakistan Delogne Charles, who is also the point ambassador of Nato to Pakistan, however, candidly stated that the level of cooperation had diminished following the withdrawal of Nato troops from Afghanistan.He further said frequent talks at the military level did take place between Nato and Pakistan. Sharing details of the decisions and deliberations at the recently-held two-day Nato summit at Vinius, the Lithuanian capital, Delogne Charles said China was not an enemy but a challenge for Nato. Says China seen as a challenge not enemy "Chinese policies affect our economy and security. This is something we have to deal with," he said, without elaborating on it further.He also said China did not respect some key rules of the international order.

"It continues to expand its military arsenal and there is no transparency in its nuclear stockpile," he added.

The ambassador also accused China of seeking to invest in Nato countries to gain control on key technological and industrial sectors, critical infrastructure, strategic materials and supply chains and create strategic dependencies.

# Antibiotics, Antacids Linked to Obesity Risk in Kids

lan antibiotics and antacids given to kids at a young age increase their risk for childhood obesity? That's what a new study, recently published in the British Medical Journal Gut, suggests. The research, a collaboration between the Uniformed Services University of the Health Sciences (USU) and Walter Reed National Military Medical Center, found that children who were given antibiotics and antacids in the first two years of life were more likely to develop obesity.

The researchers looked at the Military Health System records of 333,353 children born between October 2006 and Septem-

They found that 72.4 percent were prescribed an antibiotic and 11.8 percent were given antacids before they turned two. There was a correlation between the prescription of antibiotics and those who had childhood obesity.

Those who had antacids, such as those given to control acid reflux, were also associated with increased risk for obesity

Lead researcher and Air Force Lt. Col. Dr. Cade Nylund, an associate professor of pediatrics at USU, said that it seems the impact these prescriptions have on the human gut microbiome might be the cause.

"Antibiotics directly kill portions of the healthy gut microbiome; antacids alter the gut microbiome by decreasing acidity in the gut," Nylund told Healthline. "Both antibiotics and antacids have been shown to decrease the bacterial diversity in the gut. Certain changes in bacteria have an effect on both how we digest nutrients and our metabolism.'

Nylund said it was somewhat surprising to see that these kinds of medications might bear some "significant negative effects" on a child's overall health.

"Antibiotics will always play a role in treating bacterial infections and we do not wish to discourage treating bacterial infections with antibiotics," Nylund stressed. "However, many illnesses in children are viruses like the common cold. Viral infections do not need to be treated with antibiotics. Likewise, the vast majority of gastroesophageal reflux in early infancy is normal, it resolves in time and antacid medications have been shown to not decrease symptoms like infant fussiness.'

Gail Cresci, PhD, RD, a researcher in the department of pediatric gastroenterology at Cleveland Clinic Children's, echoed the idea that these medications could be community of helpful microorganisms that live in your gut.

"Antacids take away the first line of the body's defense against ingested pathogens by decreasing gastric acidity which can destroy many of these pathogens," Cresci told Healthline. "Obesity is known to be



associated with 'low grade' inflammation. This then may allow the pathogens to reach the distal intestine and then alter micro-

 $Cresci\,pointed\,out\,that\,antibiotics\,target$ a variety of gut microbes which decreases gut bacterial numbers and diversity.

"This overall may decrease intestinal immunity and ability to fight infections

and regulate inflammation," Cresci said. Cresci added that the microbes that live in your gut produce various "metabolic byproducts" that help regulate a person's inflammation and immunity. Altering the number of microbes could impact the regulation of inflammation tied to something like obesity.

#### The factors that lead to obesity

That being said, there are some limits to this observational study. It doesn't take into account other environmental factors in these children's lives or family health histories that could increase risk for obe-

Cresci explained that "obesity is multifactorial," so, when coming across studies like this, consider that a lot more contributes to whether a child is at risk for obesity than just being prescribed antibiotics at a young age.

For instance, she said we know diet and exercise are important in regulating a person's body weight, which means making sure these two things are a key part of you and your child's daily lives is important to regulate and prevent obesity.

"Consuming a diet rich in fruits and vegetables loaded with antioxidants and fibers may assist with keeping the gut microbiota's abundance and diversity as well as provide support to immune function and could be anti-inflammatory," she

#### What parents should know

So, what should you be concerned about when it comes to giving a child an antacid



or antibiotic medication at a young age? If your child is on an antibiotic, should you consider also giving him or her some kind of probiotic, live bacteria and yeasts – think yogurt — that could be good for digestion and protect those helpful microbes that live in the gut?

"Only consume antibiotics or antacids if absolutely necessary. Consider taking a probiotic along with – and up to two weeks after - an antibiotic to prevent gut dysbiosis, or microbial imbalance," Cresci said.

She added that not all probiotics are created equally. Some available on the market have been studied regarding their protection against antibiotics, so be sure to take a probiotic that's beneficial against antibiotics, she stressed. As always, consult your doctor or your child's pediatrician if

you're concerned about your best option. Moving forward, what is next for Nylund's research?

"I have an interest in whether these findings translate over to other complications of obesity, like heart disease, liver disease, diabetes, et cetera," he added. "We will need to follow the established cohort over a longer time to establish any associations with these conditions."

# 'End of AIDS' still possible by 2030, hopes UN

GENEVA: "The end of AIDS" is still possible by 2030, the United Nations insisted on Thursday, but cautioned that the world's deadliest pandemic could only be halted if leaders grasped the opportunity.

"AIDS can be ended" as a public health threat, the UNAIDS agency said, as it outlined a roadmap of investment, evidence-based prevention and treatment, empowering civil society and tackling the inequalities holding back progress.

UNAIDS said ending the pandemic was, above all, a political and financial choice.

"We are not yet on the path that ends AIDS," the agency's executive director Winnie Byanyima said, but 'we can choose to get on that path".

The UN first set out in 2015 the target of ending AIDS as a public health threat by 2030.

Byanyima said the greatest progress on HIV — the virus that causes AIDS — was being made in the countries and regions that have invested strongly.

She cited eastern and southern Africa, where new HIV infections have dropped by 57 per cent since

Botswana, Eswatini, Rwanda, Tanzania and Zimbabwe have already achieved what are called the 95-95-95 targets.



This means that 95pc of those living with HIV know their status; 95pc of those who know they have HIV are on life-saving anti-retroviral treatment; and 95pc of people on treatment to achieve viral suppression and therefore highly unlikely to infect others.

At least 16 other countries are close to achieving the target.

They include eight in sub-Saharan Africa — the region where 65pc of HIV-positive people live - and Denmark, Kuwait and Thailand.

39 million living with HIV In a report, UNAIDS said that two decades ago the AIDS pandemic seemed unstoppable, with more than 2.5 million people acquiring HIV each year and AIDS claiming 2m lives annually.

But the picture is now dramatically different.

UNAIDS said that in 2022, 39m people globally were living with HIV, of whom 29.8m were accessing antiretroviral therapy. Those missing out include 660,000 children. The numbers on anti-retroviral treatment have near-quadrupled from 7.7m in 2010.

Furthermore, 82pc of pregnant and breastfeeding women living with HIV had access to anti-retroviral treatment in 2022, compared to 46pc in 2010 - which has led to a 58pc drop in new infections in children.

Around 1.3m people became newly infected with HIV last year – down 59pc from the peak in 1995.

Meanwhile, 630,000 died from AIDS-related illnesses, and it is still the "number one killer" in countries including Mozambique, said Byany-

"Overall, numbers of AIDS-related deaths have been reduced by 69 percent since the peak in 2004," the report said.

'Dependent on action'

"The end of AIDS is an opportunity" for today's leaders to be remembered as "those who put a stop to the world's deadliest pandemic", said Byanyima.

"We are hopeful, but it is not the relaxed optimism that might come if all was heading as it should be. It is, instead, a hope rooted in seeing the opportunity."

# **James Anderson back in England XI for Old Trafford Test**

Veteran seamer replaces Ollie Robinson while Moeen Ali carded at No. 3

James Anderson has been recalled to the England team for the fourth men's Ashes Test, which starts on Wednesday at his home ground, Emirates Old Trafford.

Anderson was rested for England's victory in the third Test at Headingley after taking three wickets at 75.33 in the first two Tests of the series, but will return in place of Ollie Robinson in England's only personnel change. Robinson declared himself "100 percent fit" to play last week but looked short of his best in Leeds even before suffering a back spasm.

But there is another significant change from the team that started the Headingley Test, with Moeen Ali carded to bat at No. 3. Moeen batted at No. 7 in the first innings in Leeds, but asked to be pushed up the order in the second, thereby enabling Harry Brook to return to his favoured No. 5 spot.

Moeen made only 5 in his new role, but the change was vindicated by Brook's 75 in a more familiar position. England have retained the same batting order, with Ben Stokes due to come in at No. 6 and Jonny Bairstow keeping wicket and batting at No. 7. Stokes, England's captain, hinted at Anderson's inclusion in Manchester before the Headingley Test, saying Anderson would have the opportunity to get some rest and prepare "to charge in from the James Anderson End at Old Trafford next week".

Anderson returned from a groin injury, sustained playing for Lancashire, at the start of the series and was some way short of his best. But Stuart Broad, his long-time new-ball partner, believes that Anderson was "unlucky" with both the timing of his injury and the pitches.

"At Lord's, we had six of the best bowlers in the world bowling cross-seam bouncers, which tells you all you need to know about what the pitch was offering from a good length," Broad wrote in his Mail on Sunday

"But Jimmy has been one of the world's best bowlers for a long time and he can put those issues behind him. He's bowled goodness knows how many overs at Old Trafford and I'm expecting a big performance from him in a high-pressure game."

Anderson himself acknowledged in his Telegraph column last week that his selection for the Old Trafford Test could not be governed by "nostalgia", even though he conceded that, with his 41st birthday approaching this month, it might be his final opportunity to play on his Lancashire home ground.

His record there, however, is excellent - 37 wickets at 22.02 in ten previous Tests, including a vital role in last year's series-



levelling win against South Africa.

Moeen himself was unequivocal: "There's no doubt England are a better team with James Anderson in it," he said. "Even in the first two games, I actually thought he bowled really well. When he feels like, or people say, that he doesn't bowl well, he doesn't go for any runs... he's been a bit unfortunate with catches and things not going his way.

'[For] anybody that plays at their home ground for England, it's amazing, but especially for him having his own end here," Moeen added. "Being the best bowler England have ever had, being a legend of a player and a great guy as well, it's great to see him have the opportunity to play what could be his last one. Hopefully he bowls well and gets us the win.'

Moeen's own promotion to No. 3 came about when, on the third evening of the third Test, he approached Brendon McCullum and suggested a reshuffle. "We thought that him coming in at No. 3, he was able to impact the game more than he would be at No. 7," Stokes explained.


Stokes said that the move epitomised the


"selfless" approach he looked for from his team. "I just love the fact that Mo is willing to put himself in those situations; that he wants to get out there and help the team in a positive way... Mo going to Baz and saying, 'I want the opportunity' is everything that we're about as a team."

Moeen said that he felt as though shuffling up the order was the best thing for the team as a whole, if not necessarily for him. "Brooky is a great player and will be a great player," he said. "I just personally feel No. 5 is great for him: the impact he can have there is much more than he probably can at No. 3 at the moment. I'm not saying he won't be a great No. 3, I just feel right now, for the team, it's probably best I go No. 3."

He has scored 92 runs in his seven Test innings at No. 3, but has nine first-class hundreds in the role, having frequently batted there for Worcestershire in county cricket. "It's obviously going to be challenging batting No. 3 vs Australia, the best bowling attack in the world... but it's not totally alien. If I'm seeing the ball well, I might be aggressive. If they're bowling well... I'll try and bat as properly as I can.'
