



incidents carried out by them had emboldened them to carry out such nefarious activities. With the elimination of these four militants, prosperity and progress have been given a new lease of life," he said while being flanked by the SSP Poonch.

Giving details of the operation, the Commander said that the Indian Army has been continuing relentless operation in the past three months as part of "Op Trinetra".

"As part of the same on July 16 input was received about movement of unidentified persons in Sindhrah - Bachianwali and Maidana. Accordingly the area was cordoned," he said. adding, "On July 17 specific intelligence regarding presence of armed (militants) near villages Sindarah and Maidana which are part of Surankote Tehsil, District Poonch was received." Based on the intelligence, he said, Army and Special Operations Group of Police further launched a specific cordon and search operation of the area.

"After establishing an effective cordon the troops commenced their search operations and approached Village Sindrah. Four (militants) who had taken shelter in the forest near the village on noticing the troops opened indiscriminate fire on the approaching troops," he said, adding, "Their fire was promptly retali-

ated and the (militants) were pinned down in the area. The cordon was then readjusted to deny any escape to them."

The militants making use of the terrain, forest foliage and inclement weather kept opening fire onto the troops in a desperate attempt to break the cordon, he said.

"In a display of excellent leadership and coordination between Indian Army and Jammu Kashmir Police own troops displayed superior tactical acumen in retaliating the (militants) fire in a controlled manner while pinning them down in the given area."

The intermittent fire between militants and troops continued till about 0530 hours after which there was no fire from the side of the militants. However, he said, the troops continued to be on the highest alert to prevent the trapped militants from escaping.

"At the first light a detailed search of the area was carried out. The search resulted in the recovery of a large quantity of arms and ammunition comprising of four AK 47 Rifles with Magazines and rounds. Two 9 mm Pistols with magazines and rounds were also recovered." He said the bodies of the four militants were also found in the area. "I also wish to bring out the AKs are Chinese built and Pistols are made in Pak."

He said that the presence of such heavily armed militants in the hinterland is indicative of attempts to "destabilise" the region. "If not neutralised in time these (militants) could have carried out major incidents in coming days". He said the joint action by Indian army and police has resulted in saving the lives and contributed towards maintaining peace in the region. "The relentless efforts by Security forces in past few months have started to give

He said the neighbour is leaving no stone unturned to disturb this region. "Pak residents along with Pak arms & ammunition have been infiltrating and creating hindrance in the peaceful existence of the locals," he said as per GNS, adding, "Recent contacts on the line of control bears testimony of their intentions. The foiled infiltration bid in Sarla and Noushera Sector are part of his game plan to spread instability in the region".

He said four militant attacks since 1 January this year in which 9 civilians and 10 soldiers were killed at Dhangri, Bhata-Dhurian, and Kandi forest, and "now executing infiltration bids clearly indicate that Pakistan is trying its best to revive (militancy) and disturb peace in the Rajouri-Poonch border districts of Jammu province."

Amit Shah.....

On this occasion, Union Minister of State for Ministry of Cooperation Shri B.L. Verma, Justice R. Subhash Reddy, Former Judge of Supreme Court and Secretary, Ministry of Cooperation, Shri Gyanesh Kumar along with the depositors of the four cooperative societies of Sahara Group were also present.

In his address Shri Amit Shah said that this programme is important because the concerns of people whose hard earned money is stuck in these 4 co-operative societies were not paid attention. In such cases, generally multiagency seizure often happens but no agency thinks about the investor. He added that this leads to feeling of great insecurity and mistrust towards cooperative societies. Shri Shah said that crores of people of the country do not have capital but they want to contribute in the development of the country and there is no other way than cooperative movement. In this direction, Prime Minister Shri Narendra Modi took a decision to form a separate Ministry of Cooperation. He said that co-operative is the only movement in which big works can be done by combining small capital to create big capital.

Shri Amit Shah said that many times allegations of scams are made and those who invest, their capital gets stuck like Sahara whose example is in front of everyone. He said that the case went on in the Supreme Court for many years, the agencies sealed their properties and accounts, and with this, the credibility of the cooperative societies also get lost. Shri Shah said that the Prime Minister Shri Narendra Modi formed a separate Ministry of Cooperation and taking initiative in this matter discussions were held with all the stakeholders. He said that it was considered whether a system can be made in which everyone rises above their claims and thinks about small investors. Shri Shah said that all the agencies together filed a petition in the Supreme Court and the Supreme Court gave a historic decision to form a committee under the chairmanship of a former Supreme Court judge to start the payment process in a transparent manner. He said that the process of returning the amount of Rs. 5,000 crore to the investors is starting today in a transparent manner on a trial basis. He said that after the completion of Rs. 5,000 crore payment, another appeal will be made in the Supreme Court to return the amount to the remaining investors.

Union Home Minister and Minister of Cooperation said that through this portal, first payment up to Rs.10,000 will be made to one crore investors who had deposited Rs. 10,000 or more. He said that complete data of all the four societies is available online for applying on this portal. He said that all necessary provisions have been made in this process so that there is no scope for any kind of manipulation or injustice to any genuine investor.

Shri Amit Shah said that people who have not made any investments cannot receive any refund in any way from this portal, but those who have invested will receive the refunds for sure. Minister of Cooperation instructed that arrangements should be made to file applications through Common Service Center (CSC). He requested all the investors to register online through the facility of CSC. Shri Shah said that there are two main conditions related to the process: first, the investor's Aadhaar card must be linked to their mobile number, and second, the Aadhaar card must be linked to their bank account. He assured the investors, that the money will be deposited into their bank accounts within 45 days.

Union Minister of Cooperation said that a significant beginning has been made today. He said that under the leadership of Prime Minister Shri Narendra Modi, for the first time the investors are receiving their money which was stuck due to scam, in a transparent manner, and it is a very big achievement. He added that now, crores of people are going to receive their hard-earned money, which was stuck due to scams. Shri Shah said that approximately 1.78 crore small investors, whose money up to Rs. 30,000 stuck, will get their money back and it is a great achievement.

Hon'ble Supreme Court vide its order dated 29th March 2023 directed that Rs. 5000 Crores be transferred out of the "Sahara-SEBI Refund Account", to the Central Registrar of Cooperative Societies (CRCS) for disbursement against the legitimate dues of the genuine depositors of the Sahara Group of Cooperative Societies. The whole process of disbursement is being supervised and monitored by Justice R. Subhash Reddy, Former Judge of Hon'ble Supreme Court with the assistance of Shri Gaurav Agrawal, learned Advocate, Amicus Curiae as per directions of Hon'ble Supreme Court. Four senior Officers on Special Duty (OSDs) have been appointed for each of the above Societies for assisting in the refund process.

The online Portal developed for submission of claims is user friendly, efficient and transparent. The entire process is digital. Necessary checks and balances have been incorporated in the Portal to ensure that only the legitimate deposits of the genuine depositors are refunded. The portal can also be accessed through Ministry of Cooperation website. The genuine depositors of these Societies have to submit their claims by filling online application form available on the portal and upload requisite documents. The depositors will be verified through Aadhaar card to ensure their identity. After the verification of their claims and uploaded documents by the appointed Societies, Auditors, and OSDs, the payment to the genuine depositors will be credited in their Bank account within 45 days after filing their online claims. subject to fund availability and they will be intimated the status through SMS/Portal. The genuine depositors of the Societies are requested to ensure that they have Aadhar linked mobile number and Bank Account along with requisite documents as proof of their claim and deposits.

Rotational....

Kashmir Government has asked the departments to submit details of officers working on such posts beyond three years for submitting them to the Union Home Ministry.

In a communique, accessed by news agency— Kashmir News Observer (KNO), the General Administration Department (GAD) has written to the administrative secretaries to submit complete details of all employees posted/ deputed/attached who are occupying sensitive posts beyond three years so that the same is furnished to the Government of India for further action in the matter.

As per desired format, the government has to submit details of all such officers along with its remarks on them.

The details are being collected to identify sensitive posts and ensure the rotation of officers manning them within the prescribed time

limit. "Identification of sensitive posts and rotational transfer of officials holding sensitive posts is one of the tools for effective implementation of preventive vigilance mechanism." the Central

Vigilance Commission had said in its 2022 order. The rotational transfers are being done to avoid developing vested interest by staffers holding sensitive posts. The overstay and continuous posting afford scope for indulging in corrupt practices, developing vested interest etc. which may not be in the interest of a depart-

Pulwama district on February 26. The case of killing of Sharma was initially investigated by Pulwama Police and subsequently it was transferred to the SIA Kashmir.

This was the third round of searches carried by the SIA during the investigation of the case. SIA said today they conducted searches at five locations in Anantnag, one in Kulgam and

four in Shopian districts of south Kashmir. "These ten target premises also included residential houses of three active terrorists of LeT namely Danish Hamid Thoker alias Khalid, Ubaid Padder both from Chakoora Shopian and Abrar Farooq Wani of Heff Shirmal by the first light today," they said.

The searches were conducted by ten special teams of SIA in pursuance of search warrants issued by the Special UAPA Court, Pulwama to collect evidence relevant to ongoing investiga-

tion necessary to unearth conspiracy of minority killings in south Kashmir.

"While launching specific hunt for substantial evidences, SIA searched various structures and house keeping records at target places and questioned many individuals for ascertaining circumstances and evidences in the case," the agency said.

The investigation agency has been narrowing down efforts to attain specifications and evidentiary data for the logical conclusion of the case for judicial determination, it added.

Reaping peace.....

India and Pakistan has transformed remote and out of bound villages and mountains into tourism destinations.

Talking to the news agency-Kashmir News Observer (KNO), a senior officer in Kupwara said that 70 homestay facilities have been registered with the authorities and they offer food and accommodation to tourists.

"All their details and tourist arrival figures are available with the authorities. They also maintain the arrival details of tourists," the official said.

The official said that homestays are pivotal in the promotion of tourism activities in the district. "There is no infrastructure other than what locals have already constructed. Major hotels and restaurants aren't there in any part of the remote areas,' the official stated.

The official also said that tourism-related activities have begun just a couple of years ago only.

"No big night accommodation is available there. Tourism has just begun and almost all of these places were out of bonds for the general public other than locals. Homestays are proving to be a game changer in attracting more tourists," the official said while assuring more facilities will be enhanced with time.

Another senior official said that although 70 homestays are registered with the concerned authorities, their number has increased. "As per our reports, about 150 homestay facilities as of now are offering their services to tourists across the Kupwara district."

The officials said these facilities are in Keran, Karnah (Teethwal), Machil and the rest of the tourist destinations in the district.

The official said that people are now able to eke out their livelihood from the tourism activities.

Locals are happy that tourism activities are picking up saying it has helped them earn their livelihood.

Azhar Peer, a local associated with tourism activities said two years ago it was not possible to even think of suggesting a tourist to visit border areas. "But now, last year people in the border areas have opened their homes for homestays which make the job much easier. We are now inviting tourists to visit the border areas of Kupwara," he said.

He said that he always follows the prescribed guidelines and proper permission of visitors so they don't have to face any problem at any level.

Azhar also said that in September this year, about 25 couples from outside Jammu and Kashmir will be visiting these border villages.

"We have already started our preparations. We have made room bookings and arrangements for food for them. About 30 homestay rooms will come under use," he said.

He said the homestay initiative is helping a huge number of families and individuals to earn a good amount for their livelihood. "Border villages are gradually turning into tourist destinations," he added.

Amid this, locals pray the peace along borders stays forever.

Militant attack: JK police attaches shopian SHO to **Anantnag's RPHQ**

SRINAGAR, JUL 18: Days after a militant attack, which left three migrant workers from Bihar wounded in south Kashmir's Shopian district, Jammu and Kashmir Police has attached Shopian Station House Officer (SHO) Ghulam Jeelani Bhat to Range Police Headquarter (RPHQ) Anantnag, pending an inquiry.

"In view of the incident occurred on 13-7-2023 at about 2030 hours at Gagren Shopian, Inspector Gh Jeelani Bhat (AWP) (SHO P/S Shopian) PID No ARP-109258, is attached to RPHQ Anantnag pending inquiry," read an order issued by the Deputy Inspector General (DIG) of police south Kashmir range, Rayees Mohammad Bhat on Monday.

This order shall have immediate effect," the order added.

On July 13 evening, three migrant labourers identified as Anmol Kumar, Pintu Kumar Thakur and Heralal Yadav, all residents of Supaul, Bihar were shot at and injured in a militant attack in Shopian

This was the third attack on non-locals and minorities in Kashmir this year.

On February 26, a Kashmiri Pandit working as a security guard at a bank was shot dead by militants at Achen in south Kashmir's Pulwama district.

Over three months later on May 29, Deepu, a resident of Udhampur, who was working at a private circus mela at an amusement park, was shot dead near Jagland Mandi in Anantnag town.

Since the abrogation of Jammu and Kashmir's special status in 2019, there have been a series of attacks on minority community members and non locals in the Valley.

Districts, Municipalities, Panchayats with exemplary performance in tackling drug menace to be suitably rewarded: Dr Mehta

SRINAGAR, JUL 18: Chief Secretary, Dr Arun Kumar Mehta remarked that the Districts, Municipalities and Panchayats registering outstanding performance in dealing with narcotics would be suitably rewarded by the UT

The Chief Secretary made these remarks while chairing the 6th UT Level NCORD meeting attended by ACS, Home; Special DG, CID; Special DG, Crime; Principal Secretary, Forest; Principal Secretary, Education; ADGP, Kashmir/Jammu, Commissioner Secretary, RDD; Divisional Commissioner Kashmir/Jammu; DG Prosecution, Deputy Commissioners, District SPs besides other officers of the concerned departments.

During the meeting, Dr Mehta impressed upon the officers to take all the measures to eradicate the evil in its entirety. He asked them to put a fool proof system in place to convert most of the arrests into convictions. He told them to gradually increase the sanitized areas free from drugs and declare them as 'Drug Free' after due

He directed for framing well thought out guidelines for declaring the Panchavats as 'Drug Free' in consultation with different agencies like PRI members, Police, Health, Education, RDD, Revenue and Social Welfare Departments. He also took note of the pharmacy shops with functional CCTVs and maintenance of registers showing sale of scheduled drugs. He asked for fixing the timeframe to complete the process of having these installed at each chemist shop across the UT.

In order to ensure that the illicit trade of drug trafficking is curbed effectively the Chief Secretary asked the Police and District administration to attach the properties of drug dealers as provided under the relevant rules governing it. He observed that the wrongdoers needs to be dealt with iron hand to save our youth from becoming prey to their nefarious designs.

He made out that the 'Nasha Mukht J&K' is not a mere slogan but a goal to be achieved collectively. He called for practising social boycott against the drug peddlers or those engaged in this trade. He called upon the educational institutions to be vigilant and report any suspicious activity there to local police for investigation so that our Schools/ Colleges do not become victims of such immorality.

While speaking in the meeting the ACS Home, RK Goyal advised the police administration to hold capacity building workshops for their officers dealing with PITNDPS Act so that they are sensitized about the nuances of handling such cases in a more professional manner. He said that each Panchayat should be declared 'Drug free' only when it is certified by the concerned institutions that there is no drug dealer, cultivator and consumer in the village.

While giving details of the performance registered by the Department in rooting out this menace the Special DGP, Crime, A.K Chaudhary gave out that a total of 1850 cases were registered in 2022 arresting 2756 involved persons and registration of 1410 cases till June this year thereby arresting 2068 persons named in the FIRs.

It was further given out that this year 251.42 Kgs of Charas, 124.47 Kgs of Heroin/Brown Sugar, 92.24 Kgs of Ganja, 3374.69 Kgs of Fuki/Poppy straw, 105588 Caps/ Tabs/Injections/Bottles of contraband substances were seized under the NDPS Act up to June, 2023.

Moreover it was revealed that in order to plug any loopholes on part of administration action has been taken against IOs/prosecution in NDPS cases which have been dismissed by the trial courts for any shortcomings /discrepancies during investigation. A Total of 95 cases from UT have been identified so far out of which 74 have been referred to ADGP Jammu and 21 were referred to ADGP Kashmir for taking action against erring officials.

DC Srinagar Chairs NCORD meeting

Emphasises on strengthening intelligence network to crack hotspots of drugs, obstructing drug-peddling

SRINAGAR, JUL 18: A meeting of District Level Committee of Narco Coordination Centre (NCORD) was today held under the Chairmanship of Deputy Commissioner(DC) Srinagar, Mohammad Aijaz Asad at Conference Hall of DC Office Complex in order to discuss the comprehensive strategy to counter the menace of drug abuse in Srinagar.

The DC reviewed the implementation of the measures taken and progress achieved to eliminate drug abuse and its peddling from the Srinagar District particularly during the last two months.

The meeting among others was attended by Additional Deputy Commissioner, Syed Shabir Ahmad, Additional Deputy Commissioner, Syed Ahmad Kataria, Superintendent of Police, Arif Amin Shah, Assistant Commissioner Revenue, SDM East, Chief Education Officer, District Social Welfare Officer, DDMO Srinagar, besides Nodal Officer Colleges, representative from Private Schools Association, Incharge Drug De-addiction Centre SMHS Hospital, Incharge ATF, SKIMS Bemina and other concerned.

At the outset, the DC took a detailed appraisal from concerned members of NCORD Committee regarding the present scenario of drug related occurrences, areas of concern, age group of addicts, hot spots of drug abuse in the District.

The DC took feedback from the members of the Committee including SP Headquarter, Incharge Drug Deaddiction Centre SMHS Hospital and Incharge ATF, SKIMS Bemina who presented the latest report related to action taken against drug addiction and drug trafficking in the last 2 months in the District.

On the occasion, the DC stressed upon the Officers of all the line Departments to further intensify IEC

activities, connecting communities aged from tempting towards drugs. including religious influencers and The DC stressed on adopting zero

ing capacity building programmes for Heads of Educational Institutions. The DC also emphasised the Offi-

cers including Enforcement agencies for strengthening intelligence network to crack hotspots of drug abuse, obstruct drug-peddling, besides creating greater deterrence to combat dangerous trade of drug-trafficking.

The DC also called for attacking the problem of drugs from both supply and demand sides vital to contain the drug peddling and break the supply chain. He also called for stringent action against the culprits involved in the hazardous trade of drugs.

The DC asked the Revenue and Police authorities to pace up the process of the hotspots of the drugs

SIMILARLY, the DC also laid thrust on further intensifying IEC campaigns at Schools and Colleges levels to sensitize students and common masses about ill effects of drugs as well as encouraging healthy activities and hobbies to discourage drug abuse.

The DC asked the Chief Education Officer and Nodal Officer Colleges to conduct seminars, rallies and other programmes on the harmful effects of drug menace in all Government and Private Educational Institutions of the District so that youth is discour-

The DC laid stress on identification of drug hotspots in the District and asked the enforcement agencies to conduct raids on such identified hotspots to nab the drug peddlers.

During the meeting, the DC also asked the RTO and Health Departments to constitute a special Joint team to conduct random testing of vulnerable groups including drivers of commercial vehicles.

The DC also emphasised on effective functioning of Addiction Treatment Facility Centres(ATFCs) to fight against drug addiction and mitigate the sufferings of the drugs affected persons. He also laid trust on ensuring proper counselling and rehabilitation for individuals struggling with

SP Headquarter, Arif Amin Shah apprised the meeting that as many as 13 new drug peddlers have been detained under Narco PSA since May, 2023, besides 9 accused detained under PIT NDPS. In addition, 60gms of heroin, Charas, 348.28 gm, 9.5 kgs of Bung Poppy, 800 psychotropic syrup bottles, 24860 capsules/tablets of psychotropic substances were recovered.

Two Labourers Killed As Landslide Hits Construction Site In Udhampur

UDHAMPUR, JUL 18: Two labourers were killed and six others injured after a landslide hit an under-construction building in Jammu and Kashmir's Udhampur district on Tuesday, officials said.

A group of labourers were busy in construction work at Kallar near vegetable market in Udhampur town when they came under the landslide around 11.45 am, a police

He said a rescue operation was launched immediately and six labourers were rescued in an injured condition and shifted to hospital.

Bodies of two labourers were recovered by a joint rescue team of police, the National Disaster Response Force(NDRF) and the State Disaster Response Force(SDRF) after several hours of search, the official said while iden-



tifying one of the deceased as Anirudh Kumar, a resident of Madhya Pradesh.

The identity of the other deceased is being ascertained, the official said.

Earlier, Additional Deputy Commissioner, Udhampur Joginder Singh Jasrotia who inspected the scene said nine labourers were at the scene when the landslide struck.

Meanwhile, a three-member inquiry committee has been set up by ADC Jasrotia to ascertain the facts related to the incident.

He asked the committee members to submit a comprehensive report with specific recommendations for lapses, if any, within a week. (Agencies)

Curbed drug menace to large extent in border areas: SSP B'la

Seeks people's active cooperation to make Baramulla a drug-free district

BARAMULLA, JUL 18: Senior Superintendent of Police (SSP) Baramulla, Amod Ashok Nagpure on Tuesday said drug peddling and smuggling was a major challenge in the border areas but J&K Police with a sustained campaign has been able to curb the menace to a large extent.

Addressing the media persons on the sidelines of a free medical camp organised in Silikote village of Uri border town, the SSP, according to the news agency—Kashmir News Observer (KNO) said, "The progress made in curbing drug peddling and smuggling in this north Kashmir district over the last six months would serve as a clear message to all people involved in drug menace to stop their illegal activities as they would soon face the consequences if they hadn't already." He warned that police would not tolerate drugrelated offenses and advised those involved in illegal activities to abstain fromit.He expressed optimism that

through the active cooperation of the people, the police would soon succeed in making Baramulla a drugfree district. The SSP said that in the past six months, they have filed 187 FIRs under the NDPS Act, leading to the arrest of 318 drug peddlers. "Among those arrested, 34 peddlers who are considered hardcore and repeat offenders have been charged under the NDPS Public Safety Act (PSA)," he said. Describing the strategies implemented to combat drug

abuse, SSPBaramulla said, "First, we focused on cracking down on the suppliers, considering it the initial part of their strategy. Also, to tackle the demand side, the police initiated an ongoing awareness program to combat the drug menace."

The presence of a drug de-addiction center in Baramulla, along with centers in Srinagar and Anantnag, further supports our goal of addressing the demand side while concurrently reducing the drug supply, he added. He said Baramulla Police, led bv DIG Vivek Gupta, conducted a freemedical camp for the residents of Silikote village as part of the Government of India's border outreach program."This initiative aims to address the concerns and issues of the locals by facilitating interaction between officials from different government departments and the community. The medical camp organized on this day falls within the framework of this program," he added—(KNO)





Racism In Britain Is Not A Black And White Issue. It's Far More Complicated

comething was amiss but I couldn't say why. I was a sixth-form student and talking to a girl who told me with utter confidence that "white people can't be victims of racism". Racism is about power and privilege. White people have power and privilege. Black people and Asians don't. This means that only the latter group can be victims of racism; racism is the exercise of power and privilege against people of co-

I nodded at the time - she almost convinced me. Almost. I admired her clarity but felt her account was too neat. I liked her passion but thought it was painfully misguided.

It has only been over the past few years that I have been able to say exactly why she is wrong; why her account of racism is provincial rather than progressive; why combating material inequalities should be based on truth rather than distorted narratives.

The year 2021 was a strange time to be alive. The interregnum between lockdown and "back to normal". The last full year of Boris Johnson's slipshod government. The terrifying wildfires in Australia. Amid the chaos and change, though, something else seismic occurred that year. More than 14,000 people took part in the Evidence for Equality National Survey between February and October. They came from 21 ethnic backgrounds and all parts of the country. The survey report was released last week, and it claims to be the most comprehensive account of racial inequality in Britain for more than 25 years.

The research was carried out by academics from the universities of St Andrews, Manchester and King's College London, and published in a book called Racism and Ethnic Inequality in a Time of Crisis.

Nissa Finney is a professor of human geography at St Andrews and led the report. She argues that the "UK is immeasurably far from being a racially just society. The kinds of inequality we see in our study would not be there if we had a really just society."

The figure from the report that has most grabbed the headlines is this: more than a



third of ethnic minority people in Britain have experienced some form of racist abuse.

The two groups most likely to say they have experienced racist abuse are Traveller communities and Jewish people

The standard progressive response would be that this is awful but not surprising. We all know we live in a racist society; anyone who denies this is deluded and complicit with racism. Any racial abuse against any individual is morally abhorrent, and civil society has a moral duty to oppose prejudice. We should try to get the number of people who experience racism as close to zero as we possibly can. But something again nagged at me in the way many have presented the evidence from this survey. Because the corollary of one third of ethnic minority people

reporting that they have experienced racist assault is that two thirds of ethnic minority people have not.

This does not mean that there is no racism in Britain. The recent Casey report, for instance, affirmed the existence of institutional racism in the Metropolitan police. But the Evidence for Equality National Survey report complicates some of the underlying assumptions that many ostensibly progressive people espouse on racial inequality in Britain. One is a narrow idea of what consti-

Anyone who is white is privileged, we are told, and racism only affects people of colour. The problem with this view is that there are certain minorities who are seen as white and yet experience prejudice. In fact,

the two groups most likely to say they have experienced racist abuse, according to the survey, are Gypsy, Traveller and Roma communities and Jewish people.

More than 60% of Gypsy and Traveller people reported that they had experienced some form of racist assault. More than 55% of Jewish people report the same.

But we also find striking differences within groups we often unthinkingly group

White Irish people are more likely to say they have experienced prejudice in Britain than black African people

Black Caribbean people, for instance, are more likely than black African people to say they have experienced racism - nearly 50% for black Caribbean people and more than

30% for black African people. Which also means that more than half of black Caribbean people and two thirds of black African people say they experienced no racist assault. All of this from a survey many have used to conclude that Britain is far from being a racially just society.

Remarkably, the survey found that 40% of white Irish people reported experiencing some form of racist assault in their lives. This means that white Irish people are more likely to say they have experienced prejudice in Britain than black African people and all Asian ethnic groups: Indian, Pakistani, Bangladeshi, Chinese and other Asian

One response to this is obvious. Some minority groups might under-report their experience of racist abuse, others might over-report. We shouldn't take the survey as an objective account of racism in Britain. But the problem with this point of view is that the report has already been used to advance the claim that Britain is still plagued by racism – and the very same people who make this claim also emphasise only one kind of racial inequality, one that puts black and Asian people at the very bottom of society, and "white" people at the top.

If the latter is true, then we need to discard the report as useless. If the report is useful, we need to recalibrate how we think about racism. We can't think both that the report is helpful and still cling to that narrow account of racism.

There are racial inequalities in our society. This much is true. But this should be approached with subtlety rather than simplicity. This is because ethnic minority people in this country have diverse experiences and any commitment to fighting racial disadvantage needs to incorporate this complex truth if it wants to be truly effective.

Morally speaking, racism is a black and white issue. But when it comes to how it manifests itself, it is multidimensional. The most comprehensive survey on racial inequality for nearly 30 years needs to be examined comprehensively.

In the gracefully presented lyrical and insightful collection of poems befittingly titled 'The Rhythm of Pain'. The poet has effusively professes and honours her deep understanding of liberation for women and rebellion and thought-provoking ideology in the male-dominated society when she has ecstatically felt herself in numerous cases. Readers are enticed to explore through her vast experiences, deep knowledge, rich descriptions, unique perspectives, and ingenious prowess of imagination and the bewitching exquisiteness of an assortment of delectable about women's empowerment equally calls for the necessity to acknowledge women's power and dimensions of colours to drive the profound society that they impart and the unwaver-

ing love and hope they robustly stand for. Ranajan's poems sincerely try to dig out the holistic approach, ranging from the

perspective of biology, psychology, anthropology, sociology, and history amongst others like the French writer Simone de Beavoir's book "The Second Sex " which still stands supreme for its highly comprehensive work on gender. She initiates the book by explaining how women are not allowed to exist in their genuine sense. What becomes of a woman is a social construct. The woman is what man will enable her to be. Human Society is antiphysics in a sense, it is against nature; it does not passively submit to the presence of life but instead takes over the control of the environment on its behalf. This arrogation is not an inward, subjective operation; it is accomplished objectively in practical action. She tries to explain gender discrimination in the human mind through this viewpoint. Is it in human nature to restrict the world? And the other? Or for Us? The poetess raised the voice of such melancholic sentiments through each poem about how women are oppressed by putting off opportunities to foster their inborn talent and differentia to be selfreliant in this contemporary society.

This is a book that alarms the charismatic power and complexity of women who are misunderstood and hailed as subordinate ones. Her poetry sharply points out the harsh reality of the contemporary situation of Nepali Women's position despite being educated and self-reliant in particular areas still they are prolonged to tackle gender discrimination.

Another notable poem is 'Life! A Celebration of Words explores the idea of life and how far we can get a form of transformation and renewal during our living after being free from conventional belief. There are some more poems which render in mind and heart after reading twice and thrice like 'Gautama, Why did you curse me?,' I am the Lord of Myself', 'Another Morning',' The request of a fetus', 'Slaughter House of Dependence ''Tears Plead', 'Earth - wom-

The poem entitled 'Slaughter House of Dependence ' is one of the best satirical pieces that set numerous questions about the women's prime responsibility and duties in daily lifestyle that they had to perform like a machine who is even tamed and treated as an animal in carnage to

fulfil men's desired. It is a very ironic verse about being a derailed daughter-in-law in their husband's house how a woman is tamed with many chores and how she retains to be a machine in twenty-four hours despite having many own dreams and passions to live independently. This poem marks the sense of equality and liberation and feminine ideology. Similarly 'Testimony of a sex worker' poem is a total description of a prostitute woman who how had to quench s thrust of sex of a male for her survival after being released from the brothel and how she is viewed with such an ill ideology in society.

Ranjan's poems constitute the pain and agony that females are carrying for ages which deprived the power of being independent and free to make their sky. India, France Agree To "Co-Develop Next **Generation Military Equipment"**

New Delhi: India and France agreed to develop new generation military equipment as part of a longterm roadmap during Prime Minister Narendra Modi's visit to Paris, French **Ambassador Emmanuel** Lenain said on Tuesday.

The envoy also said that there is "real" political consensus in France on enhancing ties with India as he cited Modi's meetings with President of the French Senate Gerard Larcher, President of French National Assembly Yael Braun-Pivet and Prime Minister Elisabeth Borne.

"It shows that when it comes to India in France, there is real consensus. There is no difference. Everybody is so supportive and that is one of the trademarks of this partnership," Lenain said at a media brief-

Prime Minister Modi visited Paris on July 13 and 14 during which both sides reaffirmed their commitment to expand overall strategic cooperation including in defence.

"Defence cooperation has always been very important for the two countries as we

feel that in order to be independent, we have to be secure. And in order to be secure, we need good equipment and technologies," Lenain said.

The Defence Acquisition Council, headed by Defence Minister Rajnath Singh, on July 13 accorded the approval for the purchase of 26 Rafale-M (naval variant) and the three-Scorpene submarine from France.

The envoy said the two countries are working on a roadmap to produce nextgeneration military equipment and technologies.

"We have decided to work and co-develop the next generation of equipment. And we are working on a roadmap in the defence field," he said without elaborating. At the same time, Lenain said the defence cooperation between the two sides was much beyond one or two platforms as both sides are looking at expanding it significantly.

Ambassador Lenain described Modi's visit to Paris as a reflection of "trust and strong partnership" between the two countries. "It was a very good and

significant visit to send a strong message of trust and friendship," he added. On the 1650 MW nucle-

ar power project in Jaitapur in Maharashtra, the envoy said there has been some progress on it.

Both sides are engaged in talks to resolve all issues including those relating to civil nuclear liability, cost and techno-commercial matters.During Modi's visit, both sides agreed to adopt a 25-year roadmap to set the course for the bilateral relationship up to 2047 to celebrate the centenary of India's independence and the centenary of the diplomatic relations between the two countries.

"The roadmap for the next 25 years will mean one century of bilateral relations. The roadmap is very very ambitious," Lenain

He said the two sides are committed to expanding cooperation in the Indo-Pacific as well.

Following talks between Prime Minister Modi and French President Emmanuel Macron, the two sides unveiled an India-France Indo-Pacific roadmap for boosting cooperation in the region.

'Our two countries believe in a free, open, inclusive, secure and peaceful Indo-Pacific region," the roadmap noted. "We believe that the India-France partnership will be a crucial pillar of the interconnected and intersecting arrangements in the Indo-Pacific region and indispensable for a peaceful and prosperous future for the Indo-Pacific region," it said.

As per the FIR filed by Noida police, Seema told them that she couldn't get a visa to India so she travelled to Nepal from where she took a bus to New Delhi. "I reached the Yamuna Expressway with my four children on May 13 from where Sachin took us to a rented house in Greater Noida's Mohalla Ambedkar Nagar," she said.

"Fight Between PM Modi And I.N.D.I.A": **Opposition Coalition Has A New Name**

New Delhi: I-N-D-I-A -- the Indian National Developmental Inclusive Alliance -- is what the united opposition front will be known as, 26 parties participating at the crucial meet in Bengaluru decided today, setting what Congress's Rahul Gandhi called a "Modi versus I.N.D.I.A" battle for the 2024 general elections.

"We are defending the Constitution, voice of Indians and the idea of India. You know what happens to anyone who wants to fight the idea of India... The fight is between NDA and I.N.D.I.A, Narendra Modi and I.N.D.I.A, his ideology and I.N.D.I.A. India always wins all fights," said Mr Gandhi. "The fight is about two different ideas of India... The voice of the country is being stifled. The fight is for the voice of the country. So this name was chosen --I.N.D.I.A," he added.

The BJP – which is gathering its allies together in Delhi -- scoffed. Drawing a parallel with the banned organization SIMI, the BJP's Amit Malviya said changing the UPA is just regrouping under another name.

"In 2024, country will elect Prime Minister Modi, the leader... The future of our country is too precious to be risked with one of the self serving, corrupt, dynastic



together to save their shrinking turfs, not serve the people," read his tweet.

The name for the united opposition was arrived at after much deliberation on Day 2 of the mega meeting.

Sources said the Left parties wanted the word 'Alliance' to be changed to 'Front' while some parties were not too keen on 'NDA' in the name. Shiv Sena UBT chief Uddhav Thackeray pushed for a name that would not have any mention of opposition.

It was Mr Gandhi who finally came up with the acronym, tweeted Jitendra Ahwad of the Nationalist Congress Party. "His creativity was greatly appreciated," his tweet read..

"Chak de India," read a gleeful tweet from Trinamool Congress's Derek O'Brien soon after the name was decided on. "NDA can you challenge INDIA? BJP can you challenge INDIA?" questioned his boss, Bengal Chief Minister Mamata Banerjee.

Addressing the media after the meet, Congress chief Mallikarjun Kharge said, "The BIP wants to destroy democracy, Constitution, using autonomous bodies like CBI, ED, vigilance all such institutions against opposition party leaders and workers. This is a grave situation. We have come

together to save this situation. How to save the country and the people of the country -- this is the issue before us".

Asked who will lead the alliance, Mr Kharge said, "We are making a coordination committee of 11. At that meeting in Mumbai, we will decide on who the 11 will be, who the Convenor will be, etc. These are

small things". In her remarks at the press conference, Mamata Banerjee, while acknowledging all leaders present, referred to Rahul Gandhi as "our favourite". Today's meeting, she said, was "very good, constructive, fruitful". The next meeting in Mumbai will also focus on a Common Minimum Programme, she added. The opposition meeting coincided with the NDA meeting in Delhi, where the BJP, in a grand show of strength, has gath-

ered together 38 parties. Refering to the Delhi meet, Mr Kharge claimed the BJP is running scared. "Earlier, they (the BJP) never cared. They never spoke... Tukde tukde ho gaya tha (the NDA was in pieces)... Now PM trying to put them together. It shows he is afraid of the Opposition," Mr Kharge said. About the parties attending the NDA meet, he added, "Don't know who they are. If they are registered parties, I have not heard that there are so many parties in India".

Kerry seeks 'urgent action' as China, US revive climate talks

BEIJING: US climate envoy John Kerry held four hours of talks with his Chinese counterpart in Beijing on Monday, calling for "urgent action" as the two countries revived stalled diplomacy on reducing planet-warming emissions.

Climate talks between the two biggest greenhouse gas emitters came to a halt last year after Nancy Pelosi, then-speaker of the US House of Representatives, enraged Beijing by visiting self-ruled Taiwan, which China considers to be part of its territory.

Kerry, a former secretary of state, has enjoyed comparatively cordial and consistent relations with China despite Washington and Beijing locking horns over Taiwan and other issues.

Kerry met his Chinese counterpart Xie Zhenhua in Beijing, with the two men speaking for around four hours, state broadcaster CCTV said. Both countries "must take urgent action on a number of fronts, especially the challenges of coal and methane pollution," Kerry wrote in a tweet after

"The climate crisis demands that the world's two largest economies work together to limit the Earth's warming," Kerry tweeted. Beijing said after the talks that "climate change is a common challenge faced by all mankind".

"Every country, including China, has a responsibility to reduce emissions," Sullivan said. "And the world, I do believe, should step up and encourage — indeed, pressure - China to take far more dra-

China has long used its official status as a developing nation to justify its high emissions, with Sullivan saying "there is more work for them to do on that front". "Secretary Kerry will make that point when he's in Beijing," he said.Kerry's trip follows two other high-profile visits by US officials -Secretary of State Antony Blinken and Treasury Secretary Janet Yellen — that were

aimed at stabilising US-China ties. His visit to China came as the Northern Hemisphere endured record-setting summer heat waves, which scientists have said are being exacerbated by climate change.

"The Kerry visit and the resumption of climate interaction underscores the critical importance of coordinated efforts to address the climate crisis," Chunping Xie, Senior Policy Fellow at the Grantham Research Institute on Climate Change and the Environment, said in written com-

Japan, France to conduct joint air force training from **July 26-29**

Conduct bilateral training with the French Air and Space Force (FASF) to improve JASDF tactical skills and promote mutual understanding, and further deepen defense cooperation to realize a 'Free and Open Indo-Pacific.'," the air force said in a statement.

The training will be conducted at the Nyutabaru air base in the Japanese southern prefecture of Miyazaki and in the airspace around the Kanto region, the statement read.

Japan will provide seven aircraft for the military drills, including three F-15s fighter jets, and France will send two Dassault Rafale jets, a tanker aircraft and one Airbus A400M Atlas cargo plane, the document added.

The incident fuelled questions over South Korea's efforts to prevent and respond to flood damage.

Israel recognises Western Sahara as Moroccan territory

RABAT: Israel has recognised Morocco's sovereignty over the disputed territory of Western Sahara and is mulling opening a consulate there, a statement from the Israeli prime minister's office said on Monday.

The announcement confirmed a statement earlier from Morocco's royal palace, which said Israel's position had been expressed in a letter to King Mohammed VI from Israeli Prime Minister Benjamin Netanyahu.Israel was considering opening a consulate in Dakhla, the statement said.Morocco considers Western Sahara its own territory, but the Algerian-backed Polisario Front wants an independent state there. In 2020, then-US president Donald Trump recognised Morocco's claim to the territory in return for Morocco's resumption of diplomatic ties with Israel. The Israeli position "will be sent to the United Nations, regional and international organisations", the statement from Morocco's royal palace quoted the letter as saying.

Twenty-eight other countries — mostly African and Arab – have opened consulates in Dakhla, in what Moroc-

co sees as tangible support for its Western Saharan rule. Israel's position on Western Sahara was "clear-cut" and adds to the momentum in Morocco's favour, after Washington and Madrid, in addition to other European capitals, supported its plan for the territory, a senior Moroccan government official said.

ne of the most interesting aspects about being a doctor is the wide variety of people one meets every day. It enables us to observe how the same condition can elicit divergent responses from different people. This week I saw two patients who had just been detected to be "prediabetic" while undergoing a routine health check-up. Patient 1 was a 25-year-old man working in Gurgaon in a large firm. His reaction? "It's prediabetes, not $diabetes. It \verb|'s just some | jargon that|$ doctors make up. I don't believe there is anything wrong with me and came to you because it was part of my corporate package." Patient 2, a jittery, 35-year-old woman said, "I am doomed. Everyone in my family has diabetes. I don't want to get diabetes, doctor, please do something about

So, who was right in their approach? Let us first understand what prediabetes is. This means that your blood sugar is higher than usual but not high enough for you to be diagnosed with Type 2 diabetes. Prediabetes is also sometimes called borderline diabetes that most people tend to take casually.

The diagnosis of prediabetes is made by blood tests.

- 1. Fasting blood glucose 100 -125 mg/dl (impaired fasting glucose, IFG)
- 2. Two hours after taking 75-gram glucose dissolved in water - blood glucose value between 140 and 199 mg/dl (impaired glucose tolerance, IGT) 3. HbA1c value between 5.7 to

The risks of prediabetes are not limited to the development of diabetes. Recent data suggests that prediabetes may increase the risk of vascular disease —

heart attack and stroke — by 20 per cent. Some studies suggest that microvascular complications like neuropathy and retinopathy may also start increasing in the prediabetes stage.

Is diabetes inevitable if you have prediabetes?

The answer is NO. Prediabetes can also be interpreted as "prevent diabetes." It comes down to your choice. With lifestyle measures like diet and exercise, you can lose excess body weight and reverse prediabetes to normal, or at least remain in the prediabetes range for a prolonged period of time without converting to diabetes. If you choose to ignore and look the other way, you can go down the steep slope of diabetes and attendant complications.

Prediabetes truly offers a window of opportunity. Intervention at this stage can reduce the risk of not just conversion to diabetes, but also vascular complications. Intensive lifestyle interventions were able to reduce the risk of developing diabetes by 29 to 67 per cent in different populations. As a rule of the thumb, up to 50 per cent cases of Type 2 diabetes can be prevented or delayed if intervention is introduced at the right time.

Who should get tested for prediabetes?

Since prediabetes produces no symptoms, testing is the only way to diagnose the condition. Otherwise it can easily remain under the radar without being diagnosed. In India, everybody should test their blood sugar annually starting at the age of 25. Others who should test early and regularly are those who are overweight, sedentary or have a first degree relative with diabetes. Overweight children with a family history should be first tested during puberty itself. Women with a history of diabetes during pregnancy, large sized babies, or polycystic ovarian disease are particularly at risk.

What can you do if diagnosed with prediabetes?

In case lifestyle measures fail to stop the progress of prediabetes over three to six months, oral medication like Metformin or Acarbose can be used.

Black men are at an increased risk for melanoma, study finds While gender and race ogy at the University of treatment," she added.

lack men are at a higher risk of death from melanoma than other racial groups, according to a study published Tuesday in the Journal of the American Academy of Dermatology (JAAD).

Across 205,125 cases of male patients diagnosed with cutaneous invasive melanoma from 2004 to 2018 tracked by the National Cancer Database, the five-year survival rate was the lowest for Black men at 51.7%. The rate of survival was the highest for white men, at 75.1%, compared to the other racial groups in the study.

White men are more likely to get melanoma, according to the CDC, the study found that Black people have a 26% higher risk of death from melanoma than the white population.

Cutaneous melanoma a form of cancer that begins in pigment-producing cells — is the most aggressive and fatal form of skin cancer, according to the National Library of Medicine.

JAAD's study also found that melanoma-related disparities also exist among Black women, who had the highest percentage of tumors in the lowerextremity, which include legs, ankles and feet.

Wysong recommends that people go to a boardcertified dermatologist if they notice any lesions on the skin that are new, bleeding or not healing.

"We hope our research can lay the foundation for future studies to determine why there's such a gap in survival rates, and to make headway to reduce these survival rate gaps," she said.

Cummins backs 'good signs' from Warner as **Australia look to** avoid Ashes decider

LONDON: Pat Cummins expects David Warner to retain his place at the top of the order at Old Trafford as Australia look for the victory that will secure the Ashes and avoid the series from going to a decider.

Warner's position has come under scrutiny after his double failure against Stuart Broad at Headingley - making it 17 times he has fallen to Broad - with Australia needing to work out if there is a way of getting Cameron Green back into the XI.

Since 2021, Warner has averaged 28.17 in 23 Tests, and that includes his double hundred against South Africa during the Boxing Day Test at the MCG last year. In a clear sign that he remained in Australia's plans, he was part of the slip cordon during practice on Monday and Cummins, although saying the selectors had not yet met, endorsed Warner's contributions in the series where he has put on opening stands of 61, 73 and 63 with Usman Khawaja. "We'll chat about it, but I imagine it will stay the same," Cummins said of the opening pairing. "I think [Warner] has been going really well. I thought at Lord's, he was really impressive. Last week, like many of us, he probably didn't contribute as much as he would have liked with the bat.

"He's been out there over the last couple of days putting in a lot of work, but I think this tour he has shown a lot of good signs and hasn't quite kicked on to make that big score. Some of those innings he's played under really tough circumstances has made it easy for [Steven] Smith to come in and score runs, or the like." If, as expected, Warner is retained, the only other way for Green to return would appear to be in place of Todd Murphy leaving Australia with an all-pace attack supplemented by Travis Head, who did have an extensive bowl in the nets on Monday. Murphy was lightly used at Headingley and Cummins appeared to hedge his bets slightly on what the decision could be.

One byproduct of the aggressive way England play is that their innings last fewer overs (they have batted more than 80 just once so far in the series, and that was by nine balls in

the second innings at Lord's) so there is less opportunity for a spinner to make an impact, particularly if conditions favour the quicks, although there's no doubt that if Nathan Lyon was fit, he would be locked in the side.

"Every situation is different," Cummins said. "We've played games with one quick; we've played some games with heaps of quicks. It's all really conditions based. As I said last week about Toddy, I would have loved to bowl him a bit more but there wasn't a heap of overs in the game, the ball seemed to swing and seam a little bit, so that's certainly something to weigh up this week."


Selection issues aside, Australia are entering a two-week period that will define how this tour - and this team - are remembered. If they can win at Old Trafford, the job will be complete before The Oval with a first series win in England since 2001. Fail from 2-0 up and the missed opportunity of 2019 will pale by comparison.

So much of Australia's planning for this tour has been based around them still being able to peak towards the end of the trip if needed, which is how things are playing out after they slipped up at Headingley.

The squad only came back together in Manchester on Sunday as most players took the best part of a week off. Some have questioned if that has been the best use of time with the series on a knife-edge.
