meeting held on June 09, 2023 to discuss the project proposals of bridges for PMGSY-111 submitted by the UT Government of Jammu & Kashmir.

The meeting chaired by additional secretary (Rural Development) and Director General, National Rural Infrastructure Development Agency (NRIDA) was attended by senior officials of Centre and J&K government.

According to minutes of the meeting, Jammu & Kashmir Government was asked if the works would be completed by the extended timeline i.e. March 2024.

However, J&K Government informed the Centre that, under PMGSY-1, 80-85 kilometer roads and six bridges may not get completed due to non-issuance of forest clearance.

"Other works will be completed by November 2023," the record note quotes J&K government's representative saying. In the meeting, the Jammu & Kashmir Government was also told to increase the pace so as to achieve the target of 2023-24.

There could be some additional features for the army-spec model, but certain details are not yet known.

Army's Northern Command confirmed the development and shared a post on tweet.

"The Hilux, known for its toughness, durability, reliability, and offroading capabilities with its powerful engine and 4×4 drive coupled with enhanced safety features will boost the operational readiness and modernise the fleet of the Indian Army," the Northern Command said in a tweet.

Meanwhile, as per spokesperson of Toyata, the army specific Hilux features four-wheel drive as well as a low-range transmission with front and rear electronic differential locks for increased offroad capability. It has a 29° approach angle and a 26° departure angle. The Hilux also features a 700 mm water-wading capacity. Sharing his views, Mr. V. Wiseline Sigamani, General Manager – Strategic Business Unit (North), said "We are thrilled to deliver the Hilux, marking a significant milestone, fulfilling our first-ever Hilux order to the Indian Army. We are truly honoured and proud with this opportunity. The Hilux that offers unique off-roading characteristics, coupled with enhanced safety features, makes it the most ideal vehicle for the army purposes and cater to their special purposes. The senior leadership and users of Hilux said, "We are happy to receive the first fleet of Toyota Hilux, which measures up to the requirements of the Indian Army. We acknowledge TKM's support to customise the Hilux, passing through our stringent road tests with its strong off-roading strengths and extreme performance under stringent weather, difficult terrain conditions, which is key to our requirements. We look forward to utilising these fleet of Hilux for the purposes meant." In the past, the Indian Army has procured the Tata Xenon pick up, the Tata Safari Storme and the Maruti Suzuki Gypsy - the latter being the favourite of the armed forces for almost two decades. In May 2018, Tata Motors had showcased the army-spec three-door Tata Safari Storme with a soft top. However, the vehicle could not enter service in the armed forces. In March 2022, we had reported that the Indian Army was looking to replace 35,000 units of the Gypsy SUV in a phased manner, and the Scorpio was also considered.

Nine years on.....

He said many bridges which were approved after 2014 have been completed but this bridge has been left incomplete due to unknown reasons. According to Nadeem Ahmad,

another local, the bridge is funded by the World Bank and was taken up by the Jammu And Kashmir Projects Construction Corporation (JKPCC) nine years ago. The work was started; however, the department is yet to complete it, he said, adding that the work on the bridge is no way near completion.

The locals said whenever they take up the issue with higher-ups or highlight it through media; the work is started for a few days, and then again put to a halt.

The work on the bridge should be speeded up and completed at the earliest, they said, adding that they have knocked on the doors of every authority but received only assurances.

The bridge is being constructed at an estimated cost of Rs 21.5 crore. An official said the release of funds from the World Bank was delayed due to which it took time to complete. "The work has been allotted again and the bridge will be completed soon," he said.

Jammu Crime.....

Singh, Jamil Hussain, Attamjeet Singh, Raghubir Chander, Neelam Kumari Sharma and agent Mohd Shabir, all residents of district Rajouri.

The spokesman added that the case owes its origin to a written complaint lodged by the unemployed Physical Trained Youth of District Rajouri which inter-alia alleged that during the year 2010 about 130 appointments were made in District Rajouri by Secretary SSRB Srinagar and most of the candidates were having C.P.ED i.e. Certificate in Physical Education.

Likewise there are many other physical education teachers who managed BP.Ed degrees, through Agents and produced the same before **District Youth Services and Sports** Officer at the time joining their duties and succeeded in getting grade pay of Rs. 2800 instead of Rs 2400 grade pay," said the spokesman. He stated that during the course of Investigation, statements of complainants were recorded, obtained from the concerned Department, Fake BP. Ed Degrees were seized in the case and it is found that the accused candidates were appointed as Physical Education Teachers in Rajouri District on the CP. Ed basis, however they later produced BP. Ed Certificates before the competent authority and succeeded in getting the higher grade pay of Rs 2800 to which they were not entitled to.

about 1.9 lakh houses under PMAY and these are enough to saturate the housing needs of all the houseless persons. Criminal culpability of the accused individuals for the commission of offences punishable under Sections 420, 447-A & 120-B RPC has been proved.

The charge report (challan) of the instant case has accordingly been presented in the Court for judicial determination, the statement said.



The Real Story Of Rising Tomato Price And Plight Of Small Farmers

LOWER SUPPLY AND MARKET IMPERFECTIONS MAKE THE VEGETABLE DEARER



In 2009, the Swedish car company Volkswagen ran a unique ad campaign to promote its newly launched fuel-efficient car. They hired the ad agency DDB Stockholm and transformed the standard staircase of the Stockholm metro station into a 'piano staircase' which produced musical sounds when stepped in. People responded to this environmentally friendly energy-saving 'fun' signal, although it meant more hard work. They started avoiding using the escalator adjacent to the piano stairway.

adjacent to the piano stairway. In India, the farmers are no different. During November 2022, the price of tomato in the retail market was hovering around Rs 20 a kilo. This meant that the small and marginal farmers who are the actual growers were not able to recoup the farming cost. As per an estimate by the Reserve Bank of India, the farmers in India do not even realize 50% of the retail price for major traded crops such as tomatoes. The bulk of what the final consumer pays is apportioned by the middleman and traders. The margin between what the farmers get and the consumers pay are hosts of other charges such as commissions, mandi (market) charges, Agricultural Produce Market Committee (APMC) memberships fees, weighing and assaying charges, loading and unloading charges, and transport charges. And all of these jack up the final price.

In 2021, the Central government responded to this cascading impact of the price rise by trying to repeal the farm law. The argument was if there are more markets where farmers can buy and sell their produce, it will lead to price discovery for the small and marginal farmers, and at the same time, the retail price will come down. India has around 260 million people living in poverty and 83% of them fall in the category of small and marginal farmers (with less than 2 hectares of landholding size).

If farmers are to sell their produce, they had two options. The first is to sell directly to the government. The Central government procures 23 essential food items from the farmers through its agencies such as the National Agricultural Cooperative Marketing Federation of India Limited (NAFED) at minimum support price (MSP) which is usually higher than the market price. From the perspective of tomato growers, this should sound like a good option. However, for a perishable non-standardized crop like tomatoes, it is difficult to administer MSP. Unlike rice and wheat which can be stored naturally, tomatoes need cold storage.

Even if the government agrees to procure tomatoes at the MSP, these government-procuring outlets are not uniformly distributed with almost 70% to 80% procurement of rice and wheat procurement done



from Punjab, Haryana, Uttar Pradesh, and Andhra Pradesh. Interestingly, these are states where most of the cold storage units in India are concentrated.

The second option for the farmer is to take their produce to the nearby government-designated mandi where in front of state officers they can auction produce to the middlemen.

To do that they need to store their perishable stocks in cold storage. The predominantly tomato growing states such as Karnataka, Gujarat, Madhya Pradesh, etc., have relatively much less cold storage units.Even if the farmer is lucky to get access to cold storage, he needs to book a minimum quantity of 50,000 quintals for their produce, something not possible for a marginal farmer. Nearly 20% of India's tomatoes are wasted because of storage problems.

The third option for the farmers is to directly take the produce to the local mandi. But given that there are only 7700 mandis as against 6,60,000 villages, means a farmer has to arrange for transport, which again may not be a feasible option given the distance and booking a 400 quintals capacity truck all for himself. In India, the average agriculture yield is 2070 kg/hectare, and the marginal farmers given their land holding size can at the most produce 24 quintals, and therefore booking a truck is not cost-efficient.

An easier way out is to sell to village-level aggregators. In fact, in most instances, these marginal farmers are so debt-ridden they are obliged to sell their produce to the village moneylenders. In India, only 15% of the marginal farmers get access to formal credit, and most of the time they depend upon informal sources, for buying seeds, fertilizers, and other farming requirements. The cost difference for loan rates between the formal and informal sectors varies between 30-45%, annually.

Finally, in the best possible scenario if the farmer is able to take his produce to the mandis, then also it does not help. The bargaining power of the farmer is low. Under APMC Act, state government officers are meant to oversee activities related to auctioning such as the commodities traded are homogenous in quality, and the markets are equipped with basic infrastructure for taking correct weights and for making payments. In reality, however, these middlemen form a cartel and at the time of auction offer a substantially lower price to the farmers.

The argument behind repealing the farm law was that the reform in the APMC Act will allow farmers and middlemen to trade in markets, in addition to the already existing mandis. So long it was the state governments that were in the business of regulating the mandis. If additional markets for trading are created the bargaining power of the middlemen is likely to fall and the farmers will benefit. It is to be noted, it was because of the pressure from the middleman and big traders (some of whom are also statelevel party workers and politicians), the central government could not repeal the farm law.

The present rise in tomato prices is purely how the marginal farmers reacted to the not so 'fun' price 'signal' they faced during last November. When the realized price is abysmally low and with the risk of pre-monsoon rainfall playing a spoilsport, it is quite natural for them to grow some other weather-resistant crops such as millets, jowar, soyabean, something they did. The cause of the price rise in tomatoes can be attributed to a lower supply and market imperfection.

Robust Growth Forecast For Indian Economy In 2023-24 Is Risk Ridden

Normal Weather Conditions And No Geopolitical Shocks Are Prequisites



Asian Development Outlook of July 2023 maintains India's economic growth forecast at 6.4 per cent for the FY 2023, the same level of its earlier forecast made three months ago in April. However, it is risk ridden, since it assumes normal weather conditions and no geopolitical shocks, which is surprising. India has already suffered heat wave conditions during the summer, and heavy monsoon rains causing floods during the monsoon that has damaged its crops.

Asian Development Bank has said in its outlook that South Asia is on course to achieve the April growth forecasts. However, it has made downward revisions for Nepal and Pakistan in 2023. It reflects chiefly tighter monetary and fiscal policies and are offset by an upward revision for Bangladesh as net exports performed better than expected. Growth projections elsewhere in South Asia are largely maintained.

The Indian economy, supported by upbeat domestic demand, is set to meet earlier projections, the outlook says. In fiscal year 2023(FY2023, ending 31 March 2024), consumption demand in India is expected to recover with improvement in both rural and urban demand as reflected in such indicators as consumer confidence, urban unemployment, and motorbike sales.

Investment growth in India will remain robust, underpinned by strong bank credit growth and demand for housing, and supported by fewer interest rate hikes by the central bank. However, the global economic slowdown has suppressed merchandise trade, which will be a drag on growth, ADO July 2023 said.

On the supply side, growth will be buoyed by manufacturing as input prices cool. The service PMI has remained above 60, indicating resilient growth in the sector. Assuming normal rainfall and other weather factors, and no further geopolitical shocks, India is expected to grow by 6.4% in FY2023 and 6.7% in FY2024, as projected in ADO April 2023.

One of the bases of ADO July 20, 2023 forecast is the indicator emanating from seasonally adjusted Manufacturing Purchasing Mangers' Indexes, according to which India's position had improved from 55.4 in January 2023 to 58.7 in May. However, it has suffered in June to 57.8. Improvement has been seen in every month from January to May.

Growth in GDP in South Asia was estimated at 6.7 per cent in 2022, while India's GDP grew by 7.2 per cent. Economic growth in the region then declined to 5.5 per cent as per the April assessment and remained at this level in July also. Deceleration was also witnessed in India which declined to 6.4 per cent by April but maintained this level of growth as per the assessment of the second quarter in July 20, 2023.

As for inflation in South Asia is concerned, there is likely to be only a little relief in 2023, since it was forecast at 8.1 per cent for 2023 only a little less than 8.2 per cent in 2022. For India, ADO estimated a considerable relief, which was estimated at 6.7 per cent in 2022, but has declined to 5 per cent in April and 4.9 per cent in July.

As food and oil prices moderated, inflation eased below the 6.0% upper bound of the monetary policy target of RBI. Expected softening of Brent crude prices in 2023 should lower headline inflation, but core inflation, which excludes food and fuel, is expected to be stubbornly high in India.

Risk factors for Indian economy are obvious for other reasons too, which included economic activity in major advanced economies that remained weak as monetary tightening took hold. GDP growth in the United has slowed from 2022, while the euro area contracted for a second consecutive quarter and thus entered a technical recession, with leading economic activity indicators suggesting continued weakness. Further, the exports and industrial activities in developing Asia continue to decelerate as global demand slows.

One of the risks is interest rate hikes as part of taming inflation. However, it has now begun to slow the global economy. Investment is likely to weaken further, as suggested by continued contraction in the manufacturing PMI. Retail sales have remained relatively steady since the beginning of the year, but some signs of weaker consumer confidence materialized in quarter 2, which is likely to slow consumption growth.

There are many domestic and external risks to India economy, which include food inflation, unstable rupee, large current account deficit, and uncertain economic and political developments globally. The world economy is projected to slow down due to three major factors -Russia Ukraine War, economic slowdown in China and monetary tightening in the US - through which India needs to navigate with great caution. Within the country, India needs to effectively manage the climate challenges to agricultural production, along with supply of money in the market to boost consumption. Labour market, with unprecedented unemployment rate, need urgent attention to deal with cost of living crisis that has of late taken the country in its grip.

Tahawism: Imam Tahawi's Life and Works

Abu Ja'far Ahmad Bin. Muhammad Bin. Salamah al-Azdi, al-Hajri, al-Tahawi, was born at Taha, a village in Upper Egypt. His forefathers came from the Yemen to Egypt and settled there after it had come under the

Muslim rule. There is a considerable difference of opinion as to the year of his birth. The years 229/843, 230/ 844, 238/852 and 239/853 are mentioned by different biographers. Al-Sam'ani asserts that he was born in 229/843 and this is correct. He died in Egypt in 321/933.

Al-Tahawi was mainly interested in Hadith and Fiqh, and was regarded as one of the greatest Muhaddithin and fuqaha' of his time. According to Abu Ishaq al-Shirazi, he was the last leader of Hanafi Fiqh in Egypt.

He began to study Shafi'i Law under his maternal uncle abu Ibrahim Ismail al-Muzani (d. 264/878), the most celebrated pupil of Imam al-Shafi'i, and then leaving his school he took up the study of Hanafi Law

under al-Shaikh abu Jafar Ahmad b. abi , Imran (d. 285/898), who became the Chief Qadi of Egypt in 270/883. Different versions are given by his biographers of his conversion to Hanafi school, but the most probable reason seems to be that the system of Imam abu Hanifah appealed to his critical insight more than that of Imam Shafi`i. Al-Tahawi went to Syria in 268/882 for further studies in Hanafi Law and became a pupil of Qadi abu Khazim `Abd al-Hamid b. Ja'far, the then Chief Justice of Syria.3 He learnt hadith from a large number of Shaikhs especially from those who visited Egypt at his time, and had also many pupils of distinction.4

He is a distinguished author of many important works of which the following may be mentioned here:

His original contribution to Hadith literature, so far as we can estimate is that he introduced a new system of collecting legal traditions, developed a new method of interpreting and harmonizing the conflicting traditions, and adopted a new criterion for criticizing them. His predecessors and conwell-known view of Imam Abu Hanifah, consists of

three elements: knowledge, belief, and confession; knowledge alone or confession alone is not faith.7 Al-Maturidi holds the same view and lays emphasis on knowledge (ma'rifah) and belief (tasdiq). But, according to his

explanation, knowledge is the basis of faith and confession is not in reality an integral part of faith but only an indication (`alamah) of faith, a condition for enforcement of Islamic laws and enjoyment of the rights and privileges of the Muslim community. So the belief based on the knowledge of God is the basis of faith.8 Al-Tahawi excludes knowledge from his definition of faith and holds that it consists in believing by heart and confessing by tongue.9 As

regards the relation between faith and action Imam Abu Hanifah maintains that Islam demands from its followers two things: belief and practice, and both are essential for a perfect Muslim. The two are very closely related like back and belly, but they are not identical. Practice is distinct from faith and faith is distinct from practice, but both are essential elements of Islam. "Allah has ordained practice for the faithful, faith for the infidel, and sincerity for the hypocrite

be termed as dogmatic, while that of al-Maturidi as critical. The critical method followed by al-Tahawi in Hadith is quite lacking in theology. Thus, though both of them belong to the same school and uphold faithfully the doctrines of their master, they differ from each other in temperament, attitude, and trends of thought. In order to indicate the characteristics of the system of al-Tahawi

that Islam demands from its followers two things: belief and practice, and both are essential for a perfect Muslim. The two are very closely related like back and belly, but they are not identical. Practice is distinct from faith and faith is distinct from practice, but both are essential elements of Islam. "Allah has ordained practice for the faithful, faith for the infidel, and sincerity for the hypocrite." The term al-din (religion) includes both faith and action.10 Faith, according to him, is a living conviction of the heart - an absolute and indelible entity having its own existence independent of action. From this definition of faith he arrived at the following conclusions: (a) Faith is not liable to increase or decrease.11 (b) Faith is impaired by doubt.12 (c) The faithful are equal in faith but different in degree of superiority regarding practice.13 (d) No Muslim should be declared devoid of faith on account of any sin, if he does not declare it to be lawful. One may be a man of faith with bad behaviour, but not an infidel.14 (e) A believer who dies unrepentant, even though guilty of mortal sins, will not remain in hell for ever. Allah may grant him forgiveness or punish him in accordance with his sins.15 Pointing out the differences between himself and the Murji'ites, Imam Abu Hanifah says: "We do not say that sins do not harm the faithful, nor do we say that he will not enter hell, nor do we say that he will remain there for ever, although he should be a man of evil practice (fasiq), after having departed from this world as a man of faith. And we do not say that our good actions are accepted and our sins are forgiven, as the Murji'ites say. But we say that no one who performs a good action, fulfilling all its conditions and keeping it free of all defects, without nullifying it by infidelity, apostasy, or bad conduct during any part of his life, shall be neglected by God. God may punish in hell or grant complete forgiveness to a person who commits an evil deed (polytheism and infidelity excluded) and dies without repenting.16 The Kharijites and Mu'tazilites laid so much emphasis on the doctrine of threats (wa`id) that they led the believers to despair and take a depressing view of life; while the Murji'tes emphasized the doctrine of promise (wa'd) so much that they quite endangered the ethical basis of Islam. Imam Abu Hanifah endeavoured to strike a middle course between these two extremes. Sins, according to him, are not without consequences; a sinner is always liable to blame or punishment, but to drive him out from the fold of Islam, to declare him an infidel, or to condemn him to eternal

punishment is quite inconsistent with divine justice. His broad outlook and tolerant attitude were

consistently continued by al-Maturidi and al-Tahawi. The latter has summarized the views of his master on these questions in the following words:

"We do not declare anyone of the people of qiblah an infidel on account of a sin, so long as he does not deem it lawful. And we do not say that sin with faith does no harm to him who commits it. We entertain hope for the righteous among the faithful, but we have no certainty about them, and we do not certify that they will be in paradise. We ask forgiveness for their evil actions and we have fear for them, but we do not drive them into despair. Sense of security and despair both turn a man away from religion. The true way for the people of qiblah lies midway between these two. A faithful servant does not go out of the field of faith except by renouncing what had brought him into it."17

Al-Tahawi substituted the phrase ahl al-qiblah for mu'min and Muslim, evidently to avoid the theological controversies regarding their identification, and to make the circle of the believers wider and at the same

tune to give the question a practical bias. He also avoided the theoretical definition of a Muslim or mu'min, and instead described how one could be regarded as such. He says:

"We give those who follow our qiblah the name Muslim or mu'min, so long as they acknowledge what the Prophet brought with him and believe in what he said and what he narrated."18

Knowledge of God and belief in Him may save those who are guilty of mortal sins from eternal punishment, and they may entertain hope of deliverance from hell through divine mercy and the intercession of the righteous. "Those who are guilty of grievous sins will not remain eternally in hell, if they died as unitarians, even if they were not repentant. They are left to God's will and judgment; if He wills He will forgive them out of His other gods with Himself; other sins He may forgive if He pleases;' 19 and if He wills He will punish them in hell in proportion to their sins as demanded by His justice. Then He will bring them out of it through His mercy and the intercession of His obedient people, and finally He will send them to paradise. This is because Allah is the Lord of those who know Him well, and He has not destined them in either world to be like those who denied Him, went astray from His guidance, and did not obtain His help and favour."20 It may be noticed here that, although al-Tahawi did not include knowledge in his definition of faith, he was fully conscious of the cognitive aspect of it. As regards intercession, Imam Abu Hanifah seems to restrict it to the prophets in general and particularly to Prophet Muhammad,21 but al-Tahawi extends this privilege to the righteous and the pious among the faithful. As regards the independent character of faith and equality of the faithful, al-Tahawi says: "Faith is one and the faithful are equal; their comparative eminence lies in fear22 (of Allah), in righteousness, in disobeying lust, and in pursuing what is best. All the believers are friends of the Merciful. The most honourable among them before God are those who are the most obedient and the best followers of the Holy Qur'an."23 On the question whether it is obligatory for a man to know God before the advent of His messenger, and whether to follow precedence (taqlid)24 is allowed in matters of faith, al-Tahawi does not express his opinion explicitly, though his master was quite outspoken on these questions. These questions pertain to the Mu'tazilites doctrine of promise and threat (al-wa'd w'al-wa'id), which gave rise to the discussion of the nature and value of reason and revelation. They held that as God has endowed men with reason and they can easily perceive by proper use of this faculty that the world has a creator, it is obligatory on their part to know God even if the call of the Prophet does not reach them. But they were divided as to whether knowledge of God is acquired and a posteriori (kasabi) or necessary and a priori (daruri).25 Imam Abu Hanifah agreed with the Mu'tazilites on the original question and maintained that "no one can have any excuse for ignorance about his creator, as he sees the creation of the heaven and the earth of his own as well as of others. So even if Allah should not have sent any messenger to the people, it was obligatory on them to know Him by means of their intellect." Remaining views of Tahawism on attributes of God, beatific vision, divine decree, and human freedom will be discussed on next Friday.

temporaries, the authors of al-Sihah al-Sittah (the Six Canonical Compilations) collecting traditions according to their own standards and principles, left out a large number of genuine traditions.

Al-Tahawi made a strenuous effort to collect all the genuine legal traditions of the Prophet, narrated by different authorities on a particular subject, together with the opinions of the Companions of the Prophet, their-Successors and the distinguished jurisprudents. He then scrutinized traditions (ahadith) and showed by evidence which of them were authentic, strong, weak, unknown, or such as might be supposed to have been

repealed. Thus, his collection provided for the scholars an unprecedented opportunity to judge for themselves the merits or demerits of a particular tradition. The criterion for judging the genuineness of a tradition, according to the Traditionists in general, was the isnad (chain of the narrators), and so they paid greater attention to the scrutiny of the isnad than to the scrutiny of the text (matn) of a tradition. But al-Tahawi, while scrutinizing a tradition, took into consideration the matn as well as the isnad of the tradition. He also aimed at a harmonizing interpretation in case of conflicting traditions.

Al-Tahawi, like al-Maturidi, was a follower of Imam Abu Hanifah (d.150/ 767) in jurisprudence as well as in theology. He wrote a little treatise on theology named Bayan al-Sunnah w-al-Jama'ah, generally known as

al`Aqidat al-Tahawiyyah.5

In the introduction to this treatise he says he will give therein an account of the beliefs of the Ahl al-sunnah w'al-jama'ah according to the views of Imam Abu Hanifah, Abu Yusuf, and Muhammad al-Shaibani - the wellknown jurisprudents of the community. So the importance of his creed lies in the fact that it corroborates the views of Imam Abu Hanifah, the founder of the school, that have come down to us from different sources. Al-Tahawi made no attempt to explain the views of the Imam or to solve the old theological problems by advancing any new arguments. His sole aim was to give a summary of the views of the Imam and to show indirectly that they were in conformity with the traditional views the orthodox school.

The difference between him and al-Maturidi the two celebrated authorities on the views of the Imam is quite evident. Al-Maturidi was a thorough dialectician and his main endeavour was to find out a philosophical basis for the views of the leader and to support these views by scholastic reasoning, and thereby bring them closer to the views of the rational-

Al-Tahawi, as a true traditionist, did not favour, as will be seen, any rational discussion or speculative thinking on the articles of faith, but preferred to believe and accept them without questioning. There is no

reference in his creed to the critical examination of the method, sources, and means of knowledge, or the foundation on which his theological system is built. So his system may and to make an estimate of his contributions to theology, we propose to give in the

following pages an outline of the views of Imam Abu Hanifah along with the views of both al-Tahawi and al-Maturidi on some of the most important theological problems that arose in Muslim theology. Imam Abu Hanifah directed his movement against the Kharijites, Qadarites, Mu'tazilites, Shiites, Jabrites, the extreme Murji'ites, and the Hashwiyyah, the last being a group of the orthodox people who under the influence of the converted Jews, Christians, and Magians fell into gross anthropomorphism, and ascribed to God all the characteristics of a created being.6 He was the first theologian among the fuqaha' who adopted the principles

and method of reasoning and applied them to a critical examination of the articles of faith and the laws of the Shariah. That is why he and his followers were called by the Traditionists the People of Reason and Opinion

(ashab al-ra'i w-al-qiyas). This rational spirit and philosophical attitude were more consistently maintained

by al-Maturidi than by al-Tahawi. Their views on the nature of faith, attributes of God, beatific vision, divine

decree, and human freedom may be mentioned here to indicate the distinctive features of their methods.

In a written reply in Rajya Sabha, Law Minister Arjun Ram Meghwal said the 21st Law Commission had issued a consultation paper on "Reform of Family Law" on August 31, 2018."Since more than four years have lapsed from the date of issuance of the said consultation paper, the 22nd Law Commission (the present panel) decided to solicit views and ideas of the public at large and religious organisations on June 14, 2023, bearing in mind the relevance and importance of the subject matter and also various court orders on the subject of uniform civil code," he said.Responding to another question on modalities of the UCC, Mr Meghwal said since the law panel is in process of holding consultations at this stage, "the question of modalities does not accrue at this stage". Last week, the law panel had extended the deadline for the public to send their views on uniform civil code till July 28, saying the decision was taken following



an overwhelming response and numerous requests seeking more time for submitting suggestions.On June 14, the Law Commission initiated a fresh consultation process on the UCC by seeking views from stakeholders, including public and recognised religious organisations, on the politically sensitive issue. Earlier, the 21st Law Commission, the term of which ended in August 2018, examined the issue and solicited the views of all stakeholders on two occasions. Subsequently, a consultation paper on "Reforms of Family Law" was issued in August 2018. Meta Platforms said it had restored WhatsApp connectivity issues after thousands of users globally reported problems accessing the messaging app on Wednesday, according to outage tracking website Downdetector.com.We're back, happy chatting!" the Whatsapp Twitter account posted in a tweet.

The company had earlier said it was experiencing disruptions "receiving incoming messages and message delivery on Whatsapp," according to Meta's status dashboard. At one point, there were more than 37,000 incidents of people in the United States reporting issues with the messaging service, according to Downdetector, which tracks outages by collating status reports from a number of sources including user-submitted errors on its platform.

Meanwhile, more than 177,000 users reported issues with WhatsApp in the United Kingdom and nearly 15,000 said they faced trouble while using the messaging app in India.

Pakistan passport ranked 4th worst in world

Islamabad, July 20 (UNI) The Pakistani passport has been ranked the 'fourth worst' by this year's Henley Passport Index, a ranking of the world's 199 passports according to the number of destinations their owners can access without a prior visa.

In the latest ranking, Pakistan's travel document is only ranked higher than those of Syria, Iraq and Afghanistan, Dawn news reports.

Pakistan's passport permits visa-free access to 33 states, Syria's gives access to 30 destinations, Iraq's allows travel to 29 and Afghanistan's travel document only affords the bearer access to 29 destinations.

The top spot belongs to Singapore, as its passport provides citizens visa-free access to 192 destinations.

Germany, Italy and Spain tied for 2nd place, with each passport allowing access to 190 destinations.

Of the countries in the top 10, the US has seen the biggest fall in its ranking over the past decade, plummeting from 2nd place to 8th.

8 killed, 4 missing as wall collapses in rain in Pakistan

Moscow, July 20 (UNI) The Australian authorities have imposed new sanctions against 10 citizens from Russia and Belarus and 35 Russian entities in defense, technology and energy sectors, Australian Foreign Minister Penny Wong said on Thursday.

"Today Australia has imposed targeted sanctions on 35 entities in Russia's defence, technology and energy sectors, and 10 individuals, including Russian Ministers and senior officials, and senior military personnel in Belarus," Wong said in a statement.Sanctions are designed to "have maximum impact on those individuals and entities who play a role in directly or indirectly supporting" Russia's special military operation in Ukraine, the statement read.

The restrictions have been introduced, in particular, against Russian First Deputy Prime Minister Andrey Belousov and Deputy Prime Minister Dmitry Chernyshenko, as well as senior Belarusian military officials.

The sanctions list also includes major Russian defense companies, the country's largest military helicopter manufacturer and its chief, Wong said.

Moreover, the new restrictions target Russian entities involved in nuclear energy and the extraction of Arctic resources, the top Australian diplomat said.

Jamieson back in New Zealand squad for UAE and England T20Is



DUBAI: Dean Foxcroft and Adithya Ashok have earned their maiden call-ups to the senior New Zealand men's squad for the upcoming three-match T20I series against UAE, which is scheduled to be played in Dubai from August 17 to 20. The squad is also notable for the return of Kyle Jamieson, who has been out of action since undergoing back surgery in February.

New Zealand are travelling to the UAE with a somewhat second-string squad, which is without regulars Finn Allen, Devon Conway, Matt Henry, Adam Milne, Daryl Mitchell, Glenn Phillips and Ish Sodhi.

Those players, however, will return to the squad when New Zealand move to England for a four-match T20I series (August 30 to September 5) that immediately follows the UAE tour. Foxcroft, Ashok and five other players - Chad Bowes, Dane Cleaver, Cole McConchie, Henry Shipley and Will Young - will also travel to England, where they won't be part of the T20I squad but will be in contention for the two warm-up T20 games against Worcestershire and Gloucestershire.

According to the NZC release announcing the squads, allrounders James Neesham and Mitchell Santner, who have been picked on both tours, have secured short-term contracts that will allow them to play the closing stages of The Hundred in the UK between the UAE and the England T20Is.

Kane Williamson (knee) and Michael Bracewell (achilles), who are recovering from injuries, were not available for selection.

Foxcroft, a 25-year-old batting allrounder who bowls offspin, was named domestic player of the year at the NZC awards in March. T20 competition, scoring 424 runs for Otago at an average of 47.11 and a strike rate of 131.26, and also took nine wickets in the tournament with an economy rate of 7.15. Foxcroft also performed strongly in the Plunket Shield first-class competition, in which he was Otago's top run-getter with 631 at 45.07 while also picking up seven wickets at 29.71.

Ashok is a 20-year-old legspinner who was part of New Zealand's squad at the Under-19 World Cup. He made his first-class debut in the 2022-23 season and made a significant impact, picking up 19 wickets for Auckland in the Plunket Shield at an average of 27.84. Both Foxcroft and Ashok were part of the New Zealand A squad that played two first-class matches against Australia A in Lincoln in April. "It's always exciting to introduce new play-

ers to the BlackCaps environment and especially so when they're on the younger side, as Adi and Dean are," New Zealand coach Gary Stead said. "Dean's been a really consistent performer domestically and that was acknowledged by the awards he picked up in March.
