

Security Experts Attribute Surge In Infiltration To Pakistan's **Frustration Over G20 Success In Kashmir**

JAMMU, JUL 24: As Jammu and Kashmir recently witnessed a surge in infiltration attempts from across the border with over 20 terrorists being eliminated by Army personnel in two months, security experts point to Pakistan's frustration with the successful G20 meeting in Kashmir.

The surge in the infiltration from

across the LoC gained momentum in May, around the time of the G20 event, and it continued into June and July.

Former J-K director general of police Kuldeep Khoda stressed that Pakistan has renewed its efforts to increase terrorism in the Union territory but the security forces and police have effectively countered

Centre likely to reserve 3 seats for Kashmiri migrants, PoJK refugees in J&K Assembly

SRINAGAR, JUL 24: The Central government is mulling to amend the Jammu & Kashmir Reorganisation Act to reserve three seats in the Jammu & Kashmir Legislative Assembly for Kashmiri migrants and refugees from the Pakistan occupied Jammu & Kashmir (PoJK).

Sources told news agency—Kashmir News Observer (KNO) that the Centre is planning to bring "The Jammu and Kashmir Reorganisation (Amendment) Bill, 2023, in Parliament to reserve two seats for Kashmiri migrants and one for refu-

gees from PoJK. These members will be nominated by the Lieutenant Governor of Jammu and Kashmir Union Territory, they said. According to sources, the bill states that Jammu & Kashmir's Lieutenant Governor may nominate not more than two members, one of whom shall be a woman, from the community of Kashmiri migrants, to the Jammu and Kashmir Legislative Assembly.

The Lt Governor directed the Deputy Commissioners to ensure improved connectivity to Imambaras, power supply, availability of extra ration, water and basic amenities, regular market inspection, cleanliness, traffic management, best possible medical facilities to the people.

He also sought valuable inputs from the eminent representatives of Shia Community on the Muharram arrangements. The Lt Governor assured prompt and appropriate steps to address the issues and demands raised during the interaction.

Deputy Commissioners briefed the meeting on the preparations and arrangements made in their respective districts for Muharram.

Singh said conspiracies are being hatched against the J&K youth from across as consignments of drugs continue to infiltrate into this side.

He said last year, J&K police destroyed 8000 kgs of drugs and registered 2000 cases. "Some 3000 people were arrested and many of them under Narcotic Drugs and Psychotropic Substances (NDPS) act,"

Militancy is on its deathbed in Jammu and Kashmir but efforts from across are on to hook youth towards drugs, he said.

"Terrorism is elusive like a Jinn in Jammu and Kashmir. Sometimes appearing here and sometimes there", DGP said and added "that peace is moving forward ahead of terrorism".

Singh said a peaceful environment is prevailing in J&K at present as stones lying on the roads are being used for the construction of buildings and streets. "Stones are no longer used to bruise or hurt anyone," he said.

Replying to a query about Amarnath Yatra, the DGP said that pilgrimage is going on smoothly and so far more than 3 lakh pilgrims have performed darshan. "The pilgrims are coming to Srinagar as well and visiting other places of Kashmir to enjoy the beauty of the Valley," he said.

The J&K police Chief said that they have made elaborate arrangements to facilitate the Muharram procession of the Shia community.

"There shouldn't be any sectarian rift as all festivals and religious obligations are equally important and sacred. We are cooperating with the Shia community and will ensure peaceful Muharram processions," he said.

He said that almost 46 teams will participate in the J&K police martyrs football tournament. "For the first time, four women teams will participate in the tournament. These events help display the skills and also help teams exchange their culture and thoughts," the DGP added.

in incidents of militancy and depletion of over-ground support.

"For the past 10 to 12 years, the level of militancy has gone down in the Jammu region, prompting authorities to dilute the security grid due to betterment in the security situation. Taking benefit of the same, they (Pakistani terror setup) have tried to infiltrate more terrorists in Poonch region," he alleged.

"There have been some incidents in which there was a loss to security forces," Khoda said.

He emphasized that despite a low level of militancy in the Jammu region for the past decade, the security grid remains vigilant and continues to strengthen to combat infiltrations.

Overall, the security forces are determined to prevent any attempt at disturbing the peace and tranquillity in the region, and they remain on high alert to counter any mischief orchestrated from across the border, the former DGP said.

The surge in infiltration attempts gained momentum after the successful conclusion of the G20 events in the Kashmir valley which took place from May 22 to 24.

The event was attended by representatives from G20 member countries, international organisations, and industry

Security expert Captain Anil Gaur highlighted that Pakistan's inability to disrupt the G20 conclave in Kashmir led to their escalated efforts to engineer

infiltrations along the LoC, aiming to disturb the region.

"After the abrogation of Article 370, the terror infrastructure was eliminated by the security forces. It restored the environment of peace and normalcy in Kashmir and India conducted a G20 meeting in Kashmir.

"Due to its success, Pakistan got very frustrated as they never wanted the G20 conclave to be organised in Kashmir. That is why they increased the level of infiltrations into J&K," Gaur said.

Since the G20 event, there have been approximately 14 to 15 infiltration attempts along the LoC and the International Border (IB) in Jammu and Kashmir, as per statistics.

The security forces have successfully neutralised 23 armed terrorists and intruders during this period. Additionally, seven suspects have been arrested and 16 weapons, along with ammunition and explosive materials, recovered, it showed.

Around 15 infiltration bids were thwarted in areas like Poonch, Balakote, Machail, Nowshera, Rajouri and Uri along the LoC in Jammu and Kashmir.

The seized cache of arms and ammunition includes assault rifles, pistols, improvised explosive devices (IEDs), and narcotics, according to the data. (Agen-

Legislative Assembly. The bill is aimed at "preserving political rights of the migrants and refugee communities as well as for their social and economic development".

It is worthwhile to mention that the delimitation commission headed by former Supreme Court judge Justice (retd.) Ranjana Desai had recommended to the Government of India to make a legal provision for nomination of at least two members (one of them must be female) from the community of Kashmiri Migrants in the Legislative Assembly.

It had also recommended that the Government may consider giving some representation to refugees from PoJK in the Jammu and Kashmir Legislative Assembly, by way of nomination of representatives of the displaced persons from PoJK. Later JK LG to nominate three members for KPs and PoJK people in the Parliament. Indeed a great gesture by PM Modi led government.".

Pakhtoon said the last few years have been "positively on the good side" as far as hosting of tourists in houseboats is concerned. However, the stay pattern is not the same as it used to be, he said, adding that the persistence in business

has led to an improvement in livelihood. "The booking pattern is now for a very short phase, but the consistency in the business has made us in a position to generate more employment to offer more and better services to our clients," he

President of Shikara Association, Wali Mohammad, told KNO that the past few years have been better than the previous

"There is no denial that the tourism activities have increased in the valley and it has surely had a positive impact on our work due to which our earnings have increased to a certain level," he said.

Secretary KHBOA, Abdul Rashid, however, said more needs to be done in order to ensure the sustainability of their business. "There is a marginal improvement in livelihood, but it can become good if the visitors stay for a longer time,"

According to the KHBOA, the houseboats have scaled down from thousands to a few hundred only, while many more hundreds are offering to surrender their registrations and seeking "rehabilitation" as they cannot continue with their maintenance due to "inflation".

According to the Shikara Association, more than 3,000 Shikaras are registered with them which are currently in service at Dal, Nageen, Manasbal, and Hazratbal. However, J&K Tourism Department has mentioned the Shikara numbers as above

15 cloudburst.....

News Observer (KNO), Jammu and Kashmir has received excess rainfall of 27 per cent since June 01, 2023 to July 19, 2023 as the frequent rainfall has been reported in the Union Territory from last month.

Deputy Director MeT, Dr Mukhtar Ahmad told KNO that although the complete data has not been prepared but so far in this month, a total of 15 cloudburst incidents have been reported in July alone.

"It will be premature to speak whether such incidents have witnessed an upward trend as the data has not been finalized yet, which would help in comparing the figures of this year with previous years," he said.

Several areas of J&K a few days ago were hit by flash floods triggered by the cloudburst incidents, which led to the damage of roads, some walls of the Government run schools in Kulgam and minor damage to the roads in Zirhama village in Kupwara.

A few cloudburst incidents were also reported in Katra recently leading to the cloudburst.

Moreover, the weatherman has predicted more rains in J&K till July 28, saying that the weather would remain partly to generally cloudy from July 25-July 28.

On July 25, MeT Deputy Director said that there is a possibility of light rain, thunderstorm during late night and early morning.

He added that from July 26-July 28, the weather would remain partly to generally cloudy during daytime while there is a possibility of light to moderate thunderstorm at many places with isolated heavy rainfall especially during late night and early morning.

In an advisory, the MeT has predicted risk of flash flood, mudslide, landslide during the period and advise people to remain cautious and stay away from Streams, Rivers and other vulnerable spots during the period.

The successful implementation of the National Food Security Act (NFSA) has played a crucial role in reaching out to the most vulnerable sections of society. By achieving 100% Ration Card Level under the NFSA, the government has ensured that no eligible household is left out from the PDS net.

To streamline the distribution process and bring in more accountability, the administration converted 6,413 out of 6,735 Point-of-Sale (PoS) machines to online status. Additionally, 322 PoS machines were put in offline mode, primarily to cater to areas with limited internet connectivity. This tech-driven approach has not only expedited the distribution process but also reduced the scope for malpractices and ensured real-time

monitoring. With over 93% of PDS transactions being conducted online, the beneficiaries now draw their ration through Aadhaar authentication. This has not only minimized human intervention but also empowered the beneficiaries with a convenient and hassle-free process. The authentication system has also made it easier to track the movement of food grains, thus

ensuring efficient stock management. By implementing One Nation One Ration Card (ONRC), the government has facilitated seamless portability, enabling beneficiaries to avail their entitled ration from any PDS outlet across the country. This has been of immense help to transient populations and has further strengthened the food security network.

The government's meticulous de-duplication exercise led to the deletion of one million ineligible beneficiaries from the PDS system. This exercise not only ensured that the

benefits reached the truly deserving ones but also saved substantial resources and reduced the burden on the exchequer.

The combined impact of technology integration, Aadhaar authentication, and de-duplication has resulted in substantial financial savings. The streamlined PDS has saved over Rs 230 crores and efficiently distributed 1.6 Lakh MTs of food grains to the needy population.

By leveraging technology, embracing Aadhaar authentication, and implementing innovative schemes like ONORC, the administration has set an exemplary precedent for other states to follow. The elimination of leakages, improved efficiency, and significant cost savings are clear indicators of the successful implementation of these reforms. The reformed PDS system stands as a shining example of how good governance can positively impact the lives of the most vulnerable and marginalized sections of society.

Meanwhile, some of the parents of those wards studying in private crèches said that the lackadaisical approach of the government is giving a freehand to the owners of these preparatory schools to mint hefty

amounts from the parents. One of the parents said, "With no regulatory authority to monitor and keep a check and balance on the functioning of these pre-schools, a hefty amount is being minted from the parents in the name of admission and tuition charges."

Another parent said, "Either these crèches should not be allowed to function or there should be a proper check on it."

"Irony is that as to who is keeping an eye as to how the kids are being treated and what kind of treatment and food is being given to them," he



Meeras Mahal goes online to preserve **Kashmir history**

SOPORE, JUL 24: Meeras Mahal, the valley's first and biggest private museum and home to more than 7,000 artefacts, has gone online, providing an ethnographic lens into the rich cultural heritage of

The museum in the Sopore area of north Kashmir's Baramulla district houses ancient ornaments, coins, traditional dresses and utensils, which could now be accessed through the website www.meerasmahalmuseum.com.

It was set up in the year 2002 by renowned educationist Aatiqa Bano who worked hard to preserve Kashmir's identity and depict its rich history.

Talking to the news agency—Kashmir News Observer (KNO), Muzzamil Bashir, President Meeras Mahal, said, "Initially, the museum was started with a Kashmiri firepot (Kondal) which was kept in a small room, and the additions keep going with gradual collections. The people mostly come here to donate things with an aim to preserve them."

Though this was just like a store room and was not fulfilling the requirements which a museum must possess, Aatikaa ma'am approached the government several times for its support but always returned disappointed, Muzzamil, who is Aatiqa Bano's nephew, said. "We are pinning hopes on the present government for its support to preserve the heritage."

He said the Indian National Trust for Art and $Cultural\,Heritage\,(INTACH), Kashmir-an\,organiza$ tion involved in mapping, documenting and preserving the cultural heritage of Kashmir – is supporting the museum. We are currently shifting the items to the newly-constructed structure, which is a gallery type and fulfilling all the needs of a museum, he

Most of the artefacts, Bashir said, are items of daily use that were a common sight in Kashmir until the end of the 20th century. The Meeras Mahal museum collections are classified into terracotta, woodwork, wicker and grass-ware, metal (including jewellery), stone, textiles and manuscripts, he said, adding that new addition to this Meeras is Ladakh's heritage items including

The museum's website was inaugurated by Deputy Commissioner Baramulla Syed Sehrish Asgar last week.

The president of the museum said that putting it online was due to the efforts of Musarat Kar, President Municipal Council Sopore, who is acting as a volunteer and is deeply passionate about preserving the rich cultural heritage of her homeland. This is going to help people across the globe to know about Kashmir's rich past, he added.

During the peak season of tourism, heritage lovers, both locals including college and school students, and outsiders (foreigners) prefer to visit the Meeras Mahal to gain knowledge about the valley's rich

"Objects have a huge cultural and heritage value as they depict a lifestyle and living pattern of a region," the DC Baramulla said while inaugurating the website.

"The museum has been used by the local population to get an understanding of the life and times of their immediate ancestors. It gives people firsthand information of their vernacular past," she said.

With exemplary innovations, Bandipora's 'Newton' changes stereotype perceptions of rural life

BANDIPORA, JUL 24: A septuagenarian innovator from the Bandipora district of North Kashmir has been subverting conventional conceptions of rural existence by his outstanding

in its way. "It is very important

to make our languages relevant

Muhammad Ismail Mir aka "Newton" from Watapora town of the district, has been innovating since he was young and has succeeded in his mission.

Talking to news agency—Kashmir News Observer (KNO), Ismail said that he attended classes until 12th grade, but had to stop due to fiscal struggles at home. However, he has always cherished an enthusiasm for technological inventions. Ismail said he then joined the ITI after quitting school to gain technical education, but he had to discontinue since he would constantly challenge his professor and the issue might have reached the authorities, leading him to abandon his ITI studies prematurely.

"In 2019, he created an automated respirator that provides immense aid to critically sick patients. It enables the patient to undertake treatment without needing the assistance of a healthcare worker or anybody to continuously pump the air device in order to sustain," he said.

Ismail declared that the automated respirator was accepted by the Harvard Medical School in Boston, USA. "I acquired a recognition certificate from Harvard Medical School and a money prize of Rs. 5,000 for



constructing this automated respirator model," he said.

Ismail said that when the second wave of COVID was at its peak and everybody was yearning for oxygen, he crafted a blueprint of an oxygen concentrator. "I established an oxygen concentrator as there was tremendous demand for it due to the COVID pandemic. Thus, I imagined if some company started manufacturing it here, I made a plan".

Ismail has generated a diversity of electronic prototypes previously as well. His undertakings have been extensively valued, by the public and by healthcare professionals.

Ismail experienced the death of his eldest son Dr Jamsheed to Cancer in 2019, however that didn't stop his inventive nature. Now several friends of his late son have decided to set up an in situ 'fab lab' worth 5 lac at his residence in Bandipora.

Ismail uttered that he crafted his

first invention in 2008 when he fashioned a lantern with a motion sensor with a fire alarm installation.

Ismail recently modified Kashmir traditional winter heating gadget kangri and augmented its productivity, making it appropriate for use in any kind of weather which he claims will not merely be limited to winter use, but could also be utilized as a cooling system in the summer season.

Ismail is also functioning on a variety of recent inventions. "I am trying my part to benefit the society with whatever is practicable. Imagination and creativity are two abilities that are highly esteemed in today's society and should be admired more.", he declared

"We have an atmosphere that names invention as madness, but our victory would be in recognizing additional outrageous individuals and their outrageousness so that the creativity rebellion can disperse across our nation." he said.

100 e-buses for **Srinagar: SSCL set** to start trial run in next 2 days

SRINAGAR, JUL 24: The Srinagar Smart City Limited (SSCL) is all set to start trial run of e-buses in Srinagar in next two days while over a dozen such vehicles are expected to ply on the roads here after 15 days.

Mysterious blast creates panic in city heart

JAMMU, JUL 24: A low-intensity mysterious explosion triggered panic in the old city area of Jammu while police has started investigation

 $Eyewitness told news agency-\bar{K}ashmir News Observ-\\$ er (KNO), the blast took place at around 10 -10.30 pm late Sunday night in city's Kachi Chawani area, which is part of city heart and just few meters away from several vital installation including civil secretariat, rare side Raj Bhawan, All India Radio and Inspector General of Police office. The blast took place outside the residence of political activist associated with right wing Shiv Sena Pandit Rajesh Kesari. He informed that soon after the blast, everyone in the locality came out and police were called in to investigate the matter.

"The cops reached the spot within 10 minutes and $carried \, out \, a \, massive \, search. \, Multiple \, police \, teams \, have \,$ been here since last night along with the Bomb Disposal Squad. They have collected the evidence, mostly iron nails, with them", Kesri said. Sources confirmed that the explosion has been recorded in the multiple CCTV's that were installed in a nearby building.

The explosion took place at around 10.51 PM late last night and Police were informed 7 minutes after the blast. Teams of Police reached the spot in 10 minutes after being informed about the incident. However, Senior Superintendent of Police (SSP), Jammu, Chandan Kohli in a statement said, "In Jammu, an incident came to fore wherein blast like sound was reportedly heard from Kachi Chawni area. Police and forensics alongwith technical experts visited the place. Matter being probed.".

Global Initiative Is Needed To Stop Immediately Russia-Ukraine War

Spending On Nuclear As Also Other Dangerous Weapons Is On The Rise

The recent report on the state of annual assessment of the state of armaments, disarmament and international security released by the Stockholm International Peace Research Institute (SIPRI) on 12th June 2023 is startling. The report highlights that the 'number of operational nuclear weapons has increased because several countries have expanded their long-term force modernization plans'. At present it is estimated that there were 12 512 warheads in January 2023. Out of this about 9576 were in military stockpiles for potential use which is 86 more than in January 2022.

Of those, an estimated 3844 warheads were deployed with missiles and aircraft, and around 2000-nearly all of which belonged to Russia or the USAwere kept in a state of high operational alert, meaning that they were fitted to missiles or held at airbases hosting nuclear bombers. The report further elaborates that Russia and the USA together possess almost 90 per cent of all nuclear weapons.

The International Campaign to Abol $ish \, Nuclear \, We apons (ICAN) \, in \, its \, fourth$ annual report on nuclear weapon spending today: "Wasted: 2022 Global Nuclear Weapons Spending" has come out with the data of country wise spending on nuclear weapons in 2022. The United States: \$43.7 billion, \$83,143/minute; China: \$11.7 billion, \$22,219/ minute; Russia: \$9.6 billion, \$18,228/ minute; The United Kingdom: \$6.8 billion, \$12,975/ minute; France: \$5.6 billion, \$10,603/ minute; India: \$2.7 billion, \$5,181/ minute; Israel: \$1.2 billion, \$2,226/ minute; Pakistan: \$1 billion, \$1,967/minute; North Korea: \$589 million, \$1,221/ minute.



Comparing it with social needs the report says that the year 2022 Nuclear weapons spending for the entire year could have Covered 37% of climate change adaptation costs for developing countries or Set up 16 million homes with solar power or Paid the annual salary of 740 thousand nurses. Nuclear weapons spending per minute in 2022 could have Provided clean water sanitation for 2.4 thousand people or Paid for 3.9 thousand COVID vaccines or Hired three high-school science teachers or Paid for 20 U.S. public housing units.

These reports point out the danger of existence to the mankind in case of their use. They also caution us about the resource crunch which is created as a result of wasteful expenditure on the arms race.

The arms race is increasing at a time when the world has just come out of the pandemic. The global capacity to deal with the pandemic stands exposed. In the present world of science and technology we witnessed 6,943,390 deaths globally as per the WHO till 14th June 2023. Unofficial figures could be even higher. The problem of unavailability of drugs, equipment and vaccines has been very acute. Smaller countries which lacked resources and knowhow to make vaccines or drugs suffered the most. Vaccine producing companies made huge profits during this period. There are reports of black mail of the small countries by these companies.

These countries had to accept several clauses which would favour only the vaccine manufacturer. Chinese Youth Losing Interest In Marriage Will Hit The Country's Demographic Advantage

Globally, Marriages Number Is Shrinking In A Large Number Of Countries



China could just as well be contesting with the United States as the new super power, however internally it is facing serious problems with its younger generations turning away from traditional social

China has just witnessed fewest marriages in decades. The Chinese state has an elaborate machinery for gathering information on its citizens. The latest marriage registration figures reveal fewest nuptials. This is having its impact on the Chinese

China is already witnessing a shrinking population. The overall fertility rate has dropped to 1.3 per woman. Replacement of the existing population level calls for more than two children for every woman.

What is happening in China is indicative of a complete social transformation and changes in preferences of its younger generations. This is end result of a complex interplay of economic, social and cultural developments in the country in the last fifty years.

The latest figure indicates 6.83 million couples married in 2022, down from 7.63 million in the previous year. Besides, the average age for marriage is also rising. A 10% drop in the number of marriages over a year is a matter of concern and cannot happen without deep underlying causes.

Some are ascribing this to the trauma from the experience of common people during the Covid period. The state had come down so heavily that it has created a social trauma and altogether throttled individual freedom, even as much of it as was still left. People were even debarred from leaving their apartments for months.

In one horrific incident, residents of a high rise block were left to die as a fire broke out as covid restrictions made it impossible for fire tenders to come in and douse the fire. The incident got wide coverage in Chinese media. There were wide spread protests.



As a backlash, young people are known to say "theirs was the last generation." That is, unable to really live in a free society, these younger people are loathe to bring their children in a society which is severely constricted. There are of course more secular long playing socio-economic dynamics which are discouraging increasing number of marriages.

With the rise in women empowerment and their freedom from Homs, what is being seen widely is the aversion of young women to get married. In a traditional society, the Chinese women are still expected to fulfil their role as the submissive wife, which the younger women of present day are unwilling to bear. They rather opt for career and wider opportunities from being unmarried.

The Chinese economic development has made possible for women to pursue attractive career options. Lucrative professional careers are available, as the economy was expanding and demanding new skill sets. Such jobs are giving them comfortable incomes to afford lives uncluttered by family demands.

The gender transformation in Chinese society is

having a multifarious impact as younger women feel increasingly empowered to take their own decisions about their lives rather than be dictated by the traditional social mores.

These socio-economic changes apart, there is no denying that the rising graph of youth unemployment is at the heart of many of these changes.

The primary reason for the drop is the extent of youth unemployment in China, running upto 20%. The jobs available and expectations are also showing an increasing divide. The huge youth unemployment has shown itself in various ways including, not unexpectedly, a tendency to religiosity.

There are reports that more and more younger people are visiting the Buddhist and Tao temples. They are praying for their career and their prospects.

Indeed, China is no outlier. Across the world, population numbers are falling. In China's neighbouring South Korea, birth rates are reaching rock bottom and the country's population will halve by another fifty years. Here in India, population growth rate is plummeting. (IPA Service)

Official Data On The Decline In Poverty In India Highly Questionable

IMF STAFF PAPER DOUBTS 'SIGNIFICANT PROGRESS IN REDUCING POVERTY'



Several recent studies have claimed that India has made significant progress in reducing poverty during the decades leading up to the pandemic in 2020, however, a recent Staff Paper prepared in the International Monetary Fund (IMF) says that the magnitude of the decline in poverty over the past decade is highly uncertain given the lack of official household expenditure date after 2011. It means, for the entire period under PM Narendra Modi's regime, there are only government's claims of reduction of poverty but no government data to substantiate such claims.

While India's robust growth over the past decade likely contributed to such a reduction, the authorities have also expanded social assistance programs, most notably through the 2013National Food Security Act, whereby the government provided enhanced rations of food to thebottom 50 and 75 percent of the urban and rural populations, respectively.

Broader measures of poverty likely declined as well, reflecting thegovernment's development interventions in health andeducation—for example, a saturation of village electrification and toilets, which was achieved in 2018.

Similarly, the Multidimensional PovertyIndicator(MPI)showsalargereduction in poverty in India, where about 275 million people moved out ofmultidimensional poverty between 2005-06 and 2015-16 and about 140 million people between 2015-16 and 2019-21.

Notwithstanding this considerable improvement in poverty, the large impact of the pandemic shockon economic activity has raised concerns about poverty and inequality, the report emphasized. According to the nowcasting analysis by the World Bank (2022), the global poverty rate increased by 11 percent or 70 million-



people, and the global Gini coefficient increased by over 0.5 points in 2020. As with other countries, India's economy was adversely affected by the pandemic and the associated containment measures. GDP and consumption per capita declined sharply during the first and second wavesofthe pandemic. Following the first wave, the employment to population ratio decreased by

7.3 percentage points, and unemployment rate spiked to above 20 percent in urban areas. Although both GDP and labor market indicators recovered quickly, the distributional impact of the pandemic could be significant given the heterogenous shocks of the pandemic.

Though the paper used unit-level data from two nationally representative surveys for analysis of the three specific issues – to investigate the evolution of poverty and inequality in India during COVID; the factors that are associated with the impact of the pandemic on income and consumption; and the impact of the government's food subsidy scheme – it has cast serious doubts about the quality data and therefore readjusted them to match the present ground reality as far as the authors of the study could see.

The two data set the study uses are – the Consumer Pyramids Household Survey (CPHS) collected by a private agency called the Centre for Monitoring the Indian Economy (CMIE) and the Periodic Labour Force Survey (PLFS) conducted by the Ministry of Statistics and Programme Implementation.

It is already known that the present ruling establishment has been repeatedly warning against the private data, but they themselves are not providing realtime data. Perhaps it is in this context the study has taken note of the 'concerns', of course without saying anything about the government about the private data regarding CPHS's representativeness. "We adjusted the sampling weights of CPHS," the paper says, while mentioning that the definition

of consumption and income as captured by the CPHS do not necessarily match the relevant variables in India's official household survey.

It is therefore, the paper says, out main emphasis is on capturing the changes and drivers of poverty and inequality during the pandemic, as opposed to estimates of the level of poverty and inequality consistent with official measures or surveys, ie, the last official survey from 2011-12. The paper also developed their analysis of labour income dynamics through the government PLFS data.

The IMF paper has concluded, first, that the economic downturn associated with the COVID-19 pandemic have increased poverty and inequality, but the impact has been temporary with both poverty and inequality returning to their pre-pandemic levels by the end of 2021.

 $Secondly, demographic and labour \, mar-\\$ ket characteristics were the key factors associated with poverty, income, and consumption changes. The analysis broadly suggests that low skill (low education) workers and those working in informal sector with no formal employment protection were more negatively impacted during the pandemic.

Lastly, the government's expansion of food subsidies has likely provided significant mitigation to the rise in poverty during the pandemic. Going forward, ongoing improvements in targeting and portability are critical to improve outcomes with limited fiscal space. It means, all will depend on the level of performance of the government in reduction of poverty and inequality, that have been suggested by several other studies as rising in the last

However, the present IMF paper does not say it, but casts only doubts. While analyzing the impact of social assistance schemes on poverty and inequality, it says that there was large leakage in such programmes and only a part of subsidy reaches the intended recipients. "Prior to the Food Security Act 2013 data showed that leakage has improved to about 45%. As we do not have any data to estimate the recent leakage, we consider two scenarios. For, scenario 1, leakage is assumed to decline from about 45 per cent in 2015 to 14 per cent in early 2020, as in Bhalla et al. (2022). For scenario 2, we use a more conservative assumption where leakage declines by 0.2% each month and reaches about 30% at the end of 2021," the paper says.

In both cases, what is significant is, IMF does not rule out leakage of subsidies, such as food subsidies to poor households that are reaching to the persons for which these are not intended. We have examples, of large food subsidy diversion to industrial $houses for ethanol \, production \, who \, are \, being \,$ supplied rice at subsidized rate of Rs20 per kg while poor people of Karnataka were $refused \, rice \, from \, FCI \, even \, at \, the \, market \, rate$ of Rs34 per kg. There can be many other examples that perhaps did not reach the researchers of the present IMF study.

On "Merciless" Loan Recovery, Finance Minister's Instructions To Banks

Nirmala Sitharaman said banks should approach the matter with humanity and sensitivity in mind.

New Delhi: Union Finance Minister Nirmala Sitharaman today said the government has instructed both public and private banks that harsh steps should not be taken when it comes to the process of loan repayment and that they should handle such cases with humanity and sensitivity.

Ms Sitharaman said this while making an intervention during the Question Hour in the Lok Sabha on a question related to repayment of loans taken by small borrowers.

"I have heard complaints about how mercilessly loan repayments have been followed up by some banks. The government has instructed all banks, both public and private, that harsh steps should not be taken when it comes to the process of loan repayment, and they should approach the matter with humanity and sensitivity in mind," she said. The Madras High Court had last month observed If banks have to recover outstanding loan amount, the same has to be recovered in accordance with the procedure established by law. "Coercive method of recovery by private agents, if appointed by banks, is not permissible. The banks certainly cannot use muscle power to recover the loan amount," it said, while disposing of a public interest litigation petition alleging coercive methods being used against farmers.

The Reserve Bank of India had in a 2008 circular warned banks that it might consider imposing a ban on a bank from engaging recovery agents



if it receives complaints about the agents. Further, the banks had been asked to periodically review their recovery mechanism and give their feedback/ suggestions for improvement in the guidelines.

The central bank has since regularly issued circulars aimed at curbing harassment by recovery agents hired by banks and Non-Banking Financial Companies.

The RBI had in March this year fined RBL Bank Ltd 2.27 crore for not complying with certain directives on loan recovery agents. The RBI noticed "deficiencies in regulatory compliance" after it examined complaints received against the Mumbai-based lender's recovery agents during the financial years 2018-19 to 2021-22, the central bank had said in a statement. The central bank has also imposed penalties on several coop-

India Rejects \$1 Billion Bid By Chinese Carmaker To Set Up EV Factory: Report

India rejected Chinese carmaker BYD Co.'s proposal to build a \$1 billion electricvehicle plant in partnership with a local company, according to people with knowledge of the matter.

The government dismissed the plan from BYD and Hyderabad-based Megha Engineering and Infrastructures Ltd. on national security concerns, the people said, asking not to be identified as the decision is not yet public. The use of Chinese homegrown technology is a concern, one of the people said. Foreign direct investment in India's automobile sector doesn't typically require approval. Investment proposals from countries that share a border with India, however, need political and security clearance from the ministries of external and home affairs. BYD declined to comment. Representatives for Megha, which was established in 1989 and has infrastructure $projects\,in\,sectors\,from\,power\,to\,transport,$ didn't return phone calls or an email seeking comment.

Spokespeople for the Finance Ministry, the Heavy Industries Ministry and the Ministry of Home Affairs, which were all assessing BYD's proposal and vet invest-



ment coming into the country, didn't respond to requests for comment.

India is restricting Chinese investment following a number of deadly clashes along the disputed border between the two nations, which have strained relations. Great Wall Motor Co. failed in an attempt to buy a mothballed General Motors Co. plant after it couldn't get approval to close the deal. The Economic Times reported the government's rejection of BYD's investment plan on Saturday.

The government was probing SAIC Motor Corp.'s local unit MG Motor India Pvt over alleged financial irregularities, Bloomberg News reported last year. MG Motor has since announced plans to dilute its 100% share of the business, and aims to have it majority-owned by an Indian firm in two

Russian Missile Strikes On Ukraine Destroys Historic Orthodox Church: Report

Kyiv, Ukraine: The Russian missile strikes that killed at least one and injured many have destroyed a famous Orthodox cathedral in the southern Ukrainian port city of Odesa, reported CNN.

In the latest wave of attacks on Odesa, several other historic buildings have also been destroyed.

The largest church structure in Odesa is the Transfiguration Cathedral. It was consecrated in 1809 and later demolished in 1936 during the Sovietera. However, when Ukraine became an independent nation, the structure underwent a reconstruction. Videos circulating on social media revealed the cathedral's interior was filled with debris. According to Ukrainian officials, the patroness of the city's icon had been rescued from the ruins, CNN reported.

The cathedral is located in Odesa's city



centre, which UNESCO designated a World Heritage Site in response to the invasion

threat from Russia.

The Russian missiles have damaged as many as twenty-five architectural monuments in Odesa, the Ukrainian port city, alleged a Ukrainian local official, reported

Russia "deliberately aimed their missiles at the historic city centre of Odesa" which is protected by the United Nations Educational, Scientific and Cultural Organisation (UNESCO), said Oleh Kiper, the head of the region's military administration.

"Everything that was built with hard work by great architects is now being destroyed by cynical inhumans," said Mr Kiper. Odesa is a significant cultural hub with long ties to Russia. Earlier this week, Russia launched a barrage of drones and missiles overnight at the Ukrainian port city of Odesa, CNN reported. Russia had cited Ukraine's attack on the Crimea bridge for launching a strike on Odesa.

Twitter website replaces bird logo with X

Twitter launched its new logo on Monday, replacing the blue bird with a white X on a black background as the company moves toward rebranding as X.

The social media network's website showed the company's new logo, but its URL was still showing as twitter.com and the blue "Tweet" button was visible. Some users saw a blue version of the X logo, suggesting the rollout was not yet finalised.

Owner Elon Musk and the company's CEO had revealed the new logo on Sunday, saying the company would be renamed X and move later into payments, banking and commerce.

Founded in 2006, Twitter takes its name from the sound of birds chattering, and it has used avian branding since its early days, when the company bought a stock symbol of a light blue bird for \$15, according to the design website Creative Bloq.

Tweeting a picture of the company's new logo Sunday night, Twitter chief executive Linda Yaccarino said "X is here! Let's do this."

Flash floods claim 31 lives in **Afghanistan**

KABUL: Flash floods caused by torrential rain have so far killed 31 people since Friday, with more than 40 people missing. Shafiullah Rahimi, spokesman for the disaster management ministry, said extensive damage had been caused to property and farmland.

Twenty-six of the deaths occurred in Jalrez district of Maidan Wardak province, 46 kilometres east of Kabul, after the rain washed away hundreds of houses, most of them built of earth.

Four more people died in Kabul, and a total of over 70 were injured in both the districts.

Government spokesman Zabihullah Mujahid said urgent aid was being rushed to the main disaster zone in Jalrez district.

Mujahid issued a condolence message, calling on aid groups and the Kabul administration to help the bereaved families.

Although Afghanistan lies on the western edge of the monsoon footprint, flash floods happen regularly during the wet season as heavy rain courses down dry

Rahimi, the disaster ministry spokesman, told a presser that 604 houses had been fully or partially damaged and hundreds of acres of agricultural land and orchards destroyed in Jalrez since Friday.

Netanyahu says 'doing great' after surgery ahead of key judicial vote

Trump's deputy terms his **conduct during Capitol** attack reckless

WASHINGTON: Former US vice president and Republican presidential candidate Mike Pence said on Sunday he felt former President Donald Trump's words and actions leading up to the Capitol attacks on Jan 6, 2021, were reckless though not likely criminal.

"While his words were reckless, based on what I know, I am not yet convinced that they were criminal," Pence told CNN's State of the Union show. Trump said on Tuesday he had received a letter saying he is a target of a grand jury investigation into efforts to overturn his 2020 presidential election defeat.

The letter represented the clearest sign to date that Trump, the front-runner for the 2024 Republican presidential nomination, may face federal criminal charges around his efforts to remain in power after losing the election to Democrat Joe Biden."I hope it does not come to that," Pence said on a potential Trump indictment over efforts to overturn the 2020 election. He said it should be left to the American public to determine whether Trump was responsible. "His actions were reckless," Pence said. He added: "I don't honestly know what his intention was" on Jan 6, 2021. Ahead of the 2021 Capitol attacks by Trump supporters, the then-president repeatedly lambasted Pence for refusing to try to prevent Congress from certifying Biden's win in the 2020 election.

Pence said on Sunday that Trump was wrong in thinking the former vice president could overturn the outcome of the election. Some rioters chanted "hang Mike Pence" during the Capitol riots.

Biden Urges Israeli Leaders Not To Rush "Divisive" Judicial Reforms

Washington: President Joe Biden urged Israel in a statement Sunday not to rush increasingly "divisive" judicial reforms, given the other challenges facing the US ally.

In a statement first published by news site Axios and later shared with AFP by the White House, Biden said, "It doesn't make sense for Israeli leaders to rush this - the focus should be on pulling people together and finding consensus.""From the perspective of Israel's friends in the United States, it looks like the current judicial reform proposal is becoming more divisive, not less," he said. Prime Minister Benjamin Netanyahu seeks to bring his controversial proposal to curb the power of judges to a vote in the Knesset as soon as Monday. The proposal triggered dueling protests over the weekend between supporters of the proposal and those who fear it will undermine Israel's democracy. The driving force behind the reforms, Justice Minister Yariv Levin, said the bill being put to lawmakers on Monday had undergone changes to accommodate critics, but added that the coalition was still open to "understandings." Netanyahu faced other

challenges over the weekend, not the least of which was a trip to the hospital to have a pacemaker fitted after he was hospitalized for a reported spell of dizziness.

Taiwan Holds Annual Air-Raid **Drill Amid Tensions With China**

Taipei, Taiwan: Cities across northern Taiwan ordered cars off roads and people to stay indoors on Monday for an annual airraid exercise as the island $steps\,up\,preparations\,in\,the$ event of a Chinese attack amid rising military threats from Beijing.

Sirens sounded at 1:30 p.m. (0530 GMT) for the mandatory street evacuation drills, which effectively shut towns and cities including its capital Taipei for 30 minutes.

An "air raid alert", asking people to evacuate to safety immediately, was sent via text message.

"When you receive the text message, please be aware of the wordings such as 'test' and 'drill' and stay calm,"Taiwan President Tsai Ing-wen said in a reminder to the public on Facebook about an hour before the exercise named Wan An, which means everlasting peace.

China, which views democratically governed Taiwan as its territory, has been staging regular exercises around the island for the past three years, to pressure Taipei to accept Beijing's claim of sovereignty despite the island's strong rejec-

In the bustling shopping district of Ximending in Taipei, some shops pulled down their shutters and police directed passersby and vehicles including food delivery drivers on motorcycles to move to the side of the road and seek shelter.

Tourists with luggage were seen taking shelter in a subway station, some shocked and not sure what had happened.

"I heard the siren and I was worried, not knowing what happened especially we are foreigners in a foreign country," said Lee Jang Ho, a tourist from South Korea.

Among the various drills

carried out by authorities in Taipei, some citizens were instructed to seek shelter in basement parking lots with their hands covering their eyes and ears while keeping their mouths open -to minimise the impact of

blast waves from missiles. Sirens sounded 30 minutes later to give the allclear. Other parts of Taiwan, where periodic air-raid drills are required by law, will carry out street evacuation drills this week.

Beijing has stepped up its warnings against a trip to the United States by Taiwan vice president and presidential frontrunner William Lai next month, while the top U.S. diplomat in Taipei urged China not to take "provocative" action in response to the brief transits.

For the First Time, We May Have Multiple **Drugs That Can Slow Alzheimer's Disease**

n experimental Alzheimer's disease drug, donanemab, slowed the progression of symptoms in people with early forms

Both drugs are monoclonal antibodies that target the beta-amyloid protein that is involved in Alzheimer's disease.

Another drug capable of slowing the progression of Alzheimer's disease may soon be available in the United States.

An experimental drug, donanemab, slowed the progression of symptoms in people with early forms of the disease, according to results of a phase 3 clinical

However, side effects included potentially life-threatening swelling and bleeding in the brain.

Representatives of drugmaker Eli Lilly presented the results at the Alzheimer's Association International Conference in Amsterdam on July 17. The research was published the same day in JAMATrusted

This follows the Food and Drug Administration's full approvalTrusted Source earlier this month of a similar drug, lecanemab (brand name Leqembi), from Japanese drugmaker Eisai and Massachusetts-based drugmaker Biogen.

Lecanemab received accelerated FDA approvalTrusted Source in January 2023 based on earlier clinical trial results. The approval was upgradedTrusted Source when phase 3 results confirmed the clinical benefits of the drug.

Both drugs are monoclonal antibodies that target the beta-amyloid proteinTrusted Source that is involved in Alzheimer's disease. Abnormal levels of the protein clump together to cause plaques in the brain that disrupt the function of neurons.

Scientists think that reducing the level of beta-amyloid may slow the progression of the disease.

Healthline spoke to three experts about what these drugs may mean for the treatment of Alzheimer's disease, which currently affects an estimated 6.7 million American adults ages 65 and older, according to the Alzheimer's Association.

Drug slowed the progression of dementia

The phase 3 clinical trial for donanemab included 1,736 people with mild cognitive impairment (MCI) or mild dementia due to Alzheimer's disease.

MCI is an early form of memory loss or loss of other cognitive functions, such as language or visual/spatial perception. It can be a precursor to Alzheimer's disease, although some people with MCI see improvement in their symptoms.

Brain scans confirmed that all participants in the clinical trial had brain deposits of beta-amyloid and tau — another protein involved in Alzheimer's disease.



Participants were randomly assigned to receive either donanemab or an inactive placebo. These were given every four weeks by intravenous infusion for about 18

The results showed that cognitive function and daily functioning continued to decline in all participants throughout the

However, those receiving donanemab saw a delay in that decline of about 4 months, researchers found.

When researchers looked only at people with low or medium levels of tau, those taking donanemab saw a delay in that decline of about 8 months.

Participants with high levels of tau had little to no benefit from the drug, the study

In addition, people who took donanemab were less likely to progress from MCI to mild dementia – which means moving from being fully independent during daily activities to requiring some assistance, the authors of a related editorialTrusted Source wrote.

They were also less likely to move from mild dementia to moderate dementia needing some assistance with basic self-

care, according to the editorial's authors. The results of the trial also showed that there were some potentially life-threatening side effects of the drug.

Almost 37% of people who received donanemab developed swelling or bleeding in the brain, compared to 15% of those who received the placebo. Most cases in the donanemab group were mild to moderate, although three participants died as

Eli Lilly said it has filed for FDA approval of donanemab, and hopes to hear from

the agency by the end of the year. The phase 3 clinical trial for lecanemab showed similar benefits for people with MCI or mild dementia, with a slowing of the decline in cognition and daily function-

This drug was also associated with potentially life-threatening swelling and bleeding in the brain. As a result, the FDA required the prescribing information for Leqembi to include a boxed warning about

Longer time with better quality of life

Dr. Doug Scharre, director of the division of Cognitive Neurology at the Ohio State University's Wexner Medical Center's Neurological Institute, said the "big news" about lecanemab and donanemab is that they not only improve people's symptoms, but they also alter the course of the disease.

However, he emphasized that the clinical benefits seen during the first year-anda-half of treatment — the length of the phase 3 trials for these drugs — were "mod-

"It is possible that benefits may persist for longer periods," he told Healthline, "but we will have to wait and see."

With both drugs, though, there was a significant delay in declines of cognition and daily functioning, compared to the placebo group, said Dr. Christian Camargo, an assistant professor at the University of Miami Miller School of Medicine and a neurologist at UHealth - University of Miami Health System.

For patients, this translates to "time saved," he told Healthline, meaning additional time with better functioning.

"If you need less assistance with day-today activities and you can still enjoy conversations and activities, that likely reflects

on quality of life," said Scharre. Dr. Manisha Parulekar, co-director of Hackensack University Medical Center's Center for Memory Loss & Brain Health,

With these drugs, "you are able to maintain your functioning for an additional six adults continue to work to help support months without needing help from your family or any other people," she told Healthline. "This helps you live independently

for that extended period of time." While the results of the trials for these treatments are promising, Camargo pointed out that Alzheimer's disease is very complex.

"People often have multiple pathologies

present, and the proteins that accumulate and damage the brain as a result of Alzheimer's disease tend to re-accumulate," he

Given the complexity of the disease, Parulekar thinks anti-amyloid drugs are unlikely to be the only treatment needed for Alzheimer's disease.

Still, "this group of medications has given us that next step," she said, "but we have to keep building on these develop-

Benefits only for a subset of people

The modest benefits and the potential risk of serious side effects mean that decisions about using these drugs will remain a "highly personalized and individual decision," said Camargo, requiring discussions between patients and their doctor.

This, he said, will need to take into account the person's genetic profile and other risk factors.

Parulekar said use of these drugs will also require careful patient selection, and ongoing monitoring for possible side effects such as swelling or bleeding in the brain.

In addition, these treatments work best in the early stages of the disease, she pointed. They are not designed for people with late-stage mild, moderate or severe

Unfortunately, "a lot of times people may not go to the doctor earlier on," she said. "So by the time they seek a diagnosis, they may very well be into the later mild or moderate stage of dementia."

Scharre said to improve treatment outcomes, health care providers need to be knowledgeable about how to diagnose Alzheimer's disease in the early stages.

Also, "if you or a loved one has noticed a change in your thinking or memory over the last year, you should get to your primary care provider for evaluation," he said.

Ohio State University has developed a self-administered test designed to detect early signs of cognitive, memory or thinking impairments. This is free of charge and can be taken at home or in your provider's

Health disparities limit reach of drugs Camargo, who provides specialized dementia care to a socioeconomically and racially diverse community, said ensuring access to new treatments for Alzheimer's disease is of particular concern to him.

But many factors may limit the reach of these drugs.

For example, in some multi-generation households in certain communities, older their family, he said. As a result, it may be difficult for them to go to the clinic regularly for infusions — monthly for donanemab and twice a month for Legembi.

They also may face other barriers to treatment, such as a lack of a driver's license or access to a vehicle or public transporta-

Harmanpreet Likely To Be Penalised Four Demerit Points For Her Outburst

NEW DELHI: India captain Harmanpreet Kaur is likely to be penalised four demerit points for her reaction after being given out and criticising the umpiring during the third and final ODI against Bangladesh, which ended in a tie. While the ICC is yet to send out a media release on the exact penalty, Harmanpreet is in danger of becoming the first woman cricketer to be found guilty of a Level 2 breach of the ICC's code of conduct, which covers player behaviour.

After being given out caught at slip for 14, Harmanpreet smashed the stumps with her bat, and later, at the post-match presentation, called the standard of umpiring "pathetic" throughout the game.

ESPNcricinfo has learned that the match referee recommended three demerit points for equipment damage and one demerit point for criticising the match officials in public. The final decision will be taken by the ICC. It is understood that the BCCI has been talking to the ICC.

As per the ICC rules, when a player reaches four or more demerit points within a 24-month period, they are converted into suspension points and a player is banned. Two suspension points equate to a ban from one Test, or two ODIs, or two T20Is, whatever comes first for the

There are 29 women's players who have been found guilty of breaching the code of conduct in the ICC's latest list - that goes back to 2016 - released on June 7. Apart from Harmanpreet, Veda Krish-



namurthy is the other Indian player to have been found guilty twice.

The last time Harmanpreet got a demerit point was during the semi-final of the Women's World Cup 2017 against Australia. After working legspinner Kristen Beams through midwicket, she was involved in a mix-up with Deepti Sharma, before they completed the double that brought Harmanpreet's century. Instead of celebrating the milestone, Harmanpreet flung her helmet onto the ground and fired verbal volleys at Deepti. Harmanpreet was found guilty of a Level 1 offence, which she had accepted.

Players breaking the stumps - either with the bat or kicking - while reacting to umpiring decisions is a rare occurrence in cricket. Ironically the most recent case also happened in Bangladesh. In 2021, Bangladesh allrounder Shakib Al Hasan was suspended for three matches and fined USD 5800 approx during a Dhaka Premier League T20 match between Abahani Limited and Mohammedan Sporting

Shakib, who was leading Mohammedan, kicked the stumps immediately after umpire Imran Parvez turned down his lbw appeal against Mushfiqur Rahim. An over later, he ripped up all three stumps and threw them on the ground after umpire Mahfuzur Rahman called for the covers as it started to rain.


