

The DGP said the police have taken stringent action against the narco-terrorism trade in Jammu and Kashmir and have registered 2,000 cases under the Narcotic Drugs and Psychotropic Substances (NDPS) Act and arrested more than 3,000 persons involved in these

"We have got successes against the narco-terror and weapon trade that is being run from Pakistan. We have intensified our operations. For the first time, such a large number of arrests have been made under the NDPS Act, people involved in this are detained under the Public Safety Act (PSA), and the properties accumulated through narco-terror trade are being targeted," Singh said. He said the civil administration and police were making efforts to help rehabilitate the youth who have fallen victim to drug abuse.

"I want to appeal to the children to stay very far from this menace as it is deadly and harmful to society. The ill effects will be felt for a long time," he added.

Asked about the presence of foreign militants in Kashmir, Singh said they have been neutralised to a large extent. "Last year, 40 of them were killed and the remaining will also be dealt with. A large number of terrorists killed at the border while infiltrating into Kashmir were foreigners of Pakistani origin," he said.

Meanwhile, Jammu and Kashmir's top cop said the police and security forces have got clues about the missing Army jawan in Kulgam district and expressed confidence that the soldier will be located.

"Few days back, an army jawan, who was on leave, has been reported missing. Police and security forces are carrying out operations and, in view of the clues that are with us, we will be able to locate him," DGP Dilbag Singh told reporters here. (Agencies)

The minister said the measures taken by the government to curb terrorist violence include proactive counter-insurgency operations against terrorists, identification and arrest of over-ground supporters of terrorists, deployment of police, Army, Central Armed Police Forces (CAPFs) and night patrolling and area

Attachment of properties belonging to terrorists and their associates under relevant sections of the law, sharing of intelligence inputs amongst all security forces on a real-time basis and intensified Cordon and Search Operations (CASO) are undertaken to thwart any terrorist incidents in Jammu and Kashmir, he said in a written reply to a question.

Further, Rai said, the government has adopted a well-coordinated and multi-pronged strategy to tackle cross-border infiltration. This includes the tactical deployment of forces at the International Border (IB)/ Line of Control (LoC), and the use of technology like surveillance cameras, night vision cameras, heat sens-

ing gadgets, etc. Multi-tiered deployment along IB/LoC, border fencing, deployment of intelligence personnel to collect advance and target-oriented inputs on infiltration. ambushes and foot patrolling by Army and Border Security Force have also been undertaken.

The establishment of border police posts for generating local intelligence and taking pro-active action against infiltrators are other actions taken by the government, he said. (Agencies)

and 3 Marla belonging to Abdul Rashid Qureshi alias Farooq Qureshi, a resident of Kachama, Kralpora Kupwara who is operating from Pakistan was attached by the SIU Kupwara following investigation of an FIR.

He exfiltrated to Pakistan in early 1990s and is presently the launching commander of Al-Barq outfit in Pakistan Occupied Kashmir.

"Following extensive intelligence gathering and meticulous investigations in case FIR No.276/2022 of Police Station Kupwara registered under sections 120-B, 121, 121-A, 122, 123 IPC & 17, 18, 18-A, 18-B, 20, 38, 39, 40 of UA(P)A, the team of SIU Kupwara Police led to the identification and subsequent attachment of the terrorist's property located at multiple locations within the district at village Kachama," police said.

This measure taken by the Police aims to disrupt his illicit network and restrict his ability to carry out further acts of terror. Police also said Qureshi has been a persistent threat to peace and security of the Union Territory of Jammu and Kashmir since the time he exfiltrated to Pakistan in early 1990s.

"He is a member of Al-Barq terror outfit and presently operating from PoJK as launching commander. Farooq's strategic involvement in numerous acts of terror has caused immense suffering and loss of innocent lives in the valley in the past. Jammu and Kashmir Police has been actively pursuing his acts to bring an end to his destructive activities," police said.

Police said the attachment of the property serves as a strong message to terrorists and their supporters that their actions will not go unnoticed or unpunished.

#### Srinagar airport.....

(KNO) reveal that Srinagar airport is the third highest profit-making airport for the AAI after Netaji Subash Chandra Bose Airport, Kolkata and Pune airport.

Srinagar airport generated profit of Rs 20.16 crore for AAI while Kolkata and Pune airports generated profit of Rs 145.28 crore and Rs 39.13 crore, respectively.

These details have been laid bare in the departmentrelated parliament standing committee on Transport,

According to the report, the Ministry of Civil Aviation told the parliamentary committee that there are only profit-making airports with AAI.

"As regards profitability of airports, the Ministry highlighted that there are 133 airports with AAI including JVC and PPP Airports. Out of 130 AAI airports (excluding 3 JVC airports), 9 airports operated by AAI are profit-making airports," reads the report.

As per report, the profit-making airports include Behala, Jammu, Jamnagar, Kanpur Chakeri Flying Club, NSCBI Airport, Kolkata, Leh, Pune, Srinagar and Darb-

Jammu and Leh airports have respectively generated profit of Rs 0.09 crore and Rs 2.82 crore.

After enquiring about reasons about less number of airports making profits, the parliamentary panel said that it agrees with the fact that an airport in general becomes profitable when adequate traffic flows from the airport.

"The committee feels that the Ministry should work towards increasing the share of air transport for cargo movement as the same would help generate revenue for the airports. AAI should also work with airlines to attract new routes and increase frequency on existing routes to attract maximum passengers," the commit-

#### NIA conducts.....

Kupwara and Pulwama districts, at the premises of Trusts and individuals associated with Jammu Kashmir Coalition of Civil Societies (JKCCS), an NGO involved in raising funds for banned terrorist organisations.

"Raids were also conducted at locations associated with the NGO Programme Coordinator Khurram Parvej and his associate, Irfan Mehraj," the spokesman said.

Both Parvez and Mehraj were arrested by the NIA in March this year after investigations revealed their role in raising funds for the JKCCS from various charities based abroad, and utilising these funds to foment trouble and terror in Jammu and Kashmir, the spokesman added.

"Subsequent investigations revealed that the JKCCS NGO and the two arrested accused were actively involved in instigating and funding stone-pelting in and organised manner in the Valley.

They had been working with various banned terrorist organisations operating in Jammu & Kashmir,"

It added that several digital devices and incriminating documents related to financial transactions were seized in today's searches in the case registered suo moto by the NIA in Delhi on October 8, 2020.

NIA said the case relates to activities of certain NGOs, trusts, societies and organisations involved in collecting funds domestically and abroad, and transferring the same to separatist and terrorist organisations to sustain terrorist and secessionist activities in Kashmir.

NIA had earlier conducted searches at 23 locations in this case in Jammu and Kashmir, Delhi and Bangalore.

He advised that the officers visiting these villages should thoroughly inspect these works and seek feedback from PRIs and public regarding each scheme.

He made out that each scheme should have a perennial source to ensure its sustainability. Besides, it should suffice the drinking water needs of the population of these villages for at least few decades to come. He also underscored the need of training both men and women of these villages in handling of water testing kits as they are most concerned about their domestic

needs. The Chief Secretary further stressed on running of informative campaigns to create due awareness among public about the goals and objectives of the Mission. He asked for roping in civil society members and school children in such campaigns in order to penetrate the message to each house in the village. While giving insights about the this fortnight long campaign, the Principal Secretary, Jal Shakti Department, ShaleenKabra informed the meeting that the officers on visit would carry out inspection of on-going JJM works

to ensure their quality. He also revealed that it would be obligatory for these officers to give their reports about 100% FHTC villages for declaring them as 'HarGhar Jal Villages'. He made out that the certification of HarGhar Jal reported villages should be done through calling of special Gram Sabhas and the local PRI's and people should approve of the same

on their part as well. It was informed that J&K is well on track to achieve the target of 100% Functional Household Tap Connections (FHTCs) by tge end of this year. It was added that during this campaign enough number of Field Testing Kits (FTKs) would be made available in all the villages. Signages would be installed on all water supply schemes OHTs, besides identification of Nodal Persons for each village to oversee the running of these schemes. It was said that achievement of 100% progress under pre-monsoon water quality testing is one of the prime objectives of this campaign.

During this 'JJM Fortnight', which would culminate on 15th of this month Special Gram Sabhas would be called to hold threadbare discussion on JJM works and people sensitized about manning those assets successfully. Moreover debates, painting competitions, rallies, street plays in schools would be conducted to make it the campaign of all age groups and the whole

The meeting was apprised that district level Pani Samiti Conventions would be conducted all across the UT. Senior most officers of the UT like that of Principal Secretary, Jal Shakti Department, other Administrative Secretaries incharge of the districts, District Development Commissioners, Mission Director, JJM, other District Level officers/ Engineers of Hydraulic side upto AEE level/Prabhari Officers of the Panchayats are going to participate in this Fortnight long campaign launched today.

On the occasion, Chief Secretary also e-inaugurated Water Supply Scheme Heing Keshmatipora in District Baramulla. The scheme was completed under the ongoing Jal Jeevan Mission at an estimated cost of Rs 9.35 Cr.

SRINAGAR, AUG 01: The Deputy Commissioner, Srinagar, Mohammad Aijaz Asad, who is also the District Election Officer (DEO) Monday chaired a meeting at Meeting Hall of DC Office Complex, here to review preparations for Special Summary Revision (SSR) of Urban Local Bodies (ULBs)/Srinagar Municipal Corporation electoral roll and finalise the action plan for smooth conduct of SSR in the district.

Besides, Additional Deputy Commissioner(ERO), Syed Shabir Ahmad; Additional Deputy Commissioner(ERO), Syed Ahmad Kataria; Joint Commissioner SMC (ERO), Syed Abul Qasim; Joint Commissioner SMC (ERO), Riyaz Ahmad and Deputy District Election Officer (DDEO) Srinagar, Shakeel Hussain, the meeting was attended by Election Registration Officers(EROs), Assistant Electoral Registration Officers (AEROs), Nodal Officer Colleges, Nodal Officer, SVEEP, Official from District Election Office Srinagar and ERONET Operators of all 8 Assembly Constituencies of Srinagar District.

of Srinagar District.
At the outset, the DEO took a detailed review of the Action Plan for smooth and successful conduct of the Electoral Roll Revision of the Urban Local Body (ULB) to register all eligible electorates in all 08 Assembly segments of the Srinagar District. He also discussed the steps required to

update and finalise the Municipal Electoral Rolls in the district.

Speaking on the occasion, the DEO emphasized the EROs, AEROs and other officials of District Election Authority to put in coordinated efforts to ensure the exercise for Electoral Roll Revision regarding ULB is conducted in all the eight Assembly Constituencies of the district as per laid guidelines of Election Authority.

The DEO directed the Officers to conduct revision strictly in accordance with the ECI guidelines as per schedule and complete the process within the given timeline. He exhorted upon the concerned Officers to take extra care while making the addition of new voters, left out voters, deletion of absent/shifted/deceased electors and modification in the particulars of already registered voters to improve the health of Electoral Rolls and making it error free.

The DEO also asked the EROs and AEROs, Nodal Officer SVEEP and other concerned to remain proactive during conduct of Special Summary Revision to build awareness and activate all their resources for successful conduct of all SVEEP programmes/ activities regarding ongoing Revision of Municipal Electoral Rolls across all Assembly segments of the Srinagar district.

He also asked them to create momentum regarding the exercise



from the day first and supervise the process with focused attention to ensure 100% registration of all eligible and ensure no elector is left unregistered keeping in view the limited time period to conduct the exercise.

On the occasion, the DEO was given a detailed overview about the exercise and it was given out in the meeting that the Electoral Roll Revision with July 01, 2023 as the qualifying date is commencing from August 01 with the publication of Draft Electoral Rolls.

Giving activity wise details, the DEO was informed that the period of filing claims and objections for Additions,

Deletions, Corrections and Transpositions is from 01-08-2023 to 11-08-2023. It was also informed that 2 Special Camps for Electoral Registration will be organised at all the Polling Stations of the District on August 6, 2023 (Sunday) and August 10, 2023 (Thursday).

Similarly, the DEO was informed that the disposal of claims and objections shall be made by August 16, 2023 (Wednesday) and date for updation of Electoral Rolls is fixed on August 21, 2023 (Monday). While final publication of Electoral Roll is scheduled for August 25, 2023.

In order to have focused outreach to enroll all eligible electors and con-

cerned Booth Level Officers (BLOs) shall remain available at respective booths with requisite Forms and Draft Electoral Rolls for the assistance of the Electors.

The Nodal Officers from Colleges and Schools of District for SVEEP were asked to conduct special awareness programmes in their respective Educational Institutions so that all eligible young voters are made aware to acquire the power to vote during the ongoing revision of rolls.

During the meeting, it was also informed that the Ward Officers as per the instructions of the Election Department have to depute Polling

Station Level Officers (PSLOs) in respect of all 74 Electoral Wards who will be assisted by Assembly Level BLOs. Each Ward Officer shall ensure distribution of Electoral Rolls and all relevant forms to PSLOs/BLOs falling within their administrative jurisdiction. The Ward Officers shall monitor the daily progress of claims and objections received by each PSLOs/BLOs and shall update the office of District Election Officer, Srinagar as well as Commissioner of the Corporation.

Likewise, all the concerned EROs shall ensure the publication of Draft Electoral Rolls on 01.08.2023 at all the 840 Polling Stations of 74 Electoral Wards of Municipal Corporation of District Srinagar. The Polling Station Level Officers (PSLOs)/BLOs shall remain present in their respective polling areas.

In addition, each ERO has to issue Notice of publication on Form-2 and the notice has to be published across all the 74 Electoral Wards of the Corporation. ERO/AEROs/Ward Officers/PSLOs/BLOs shall ensure availability of sufficient numbers of the copies of draft rolls, forms of claims and other relevant material during the revision period.

Earlier, the DEO was informed that as many as 748081 voters are already registered in all 8 Assembly segments of the District and a total 840 number of polling stations have been designated in Srinagar.

# Poor air quality is behind for rise in lung cancer cases among non-smokers: DAK

**SRINAGAR, AUG 1:** Doctors Association Kashmir (DAK) on Tuesday put responsible the increasing exposure to toxic air for rise in lung cancer cases among the non-smokers.

On world lung cancer day, DAK President Dr Nisar ul Hassan said that "Poor air quality is behind the spike in lung cancer cases among non-smokers.".

Dr Hassan said evidence has shown that polluted air is associated with increased risk of lung cancer which is the most prominent cancer in

A new ground breaking study conducted at Francis Crick Institute and University College London has revealed that poor air quality can



increase the odds of lung cancer in individuals who do not smoke.

"Researchers have found that increased exposure to fine particles - typically seen in vehicle exhaust and smoke from fossil fuels trigger inflammation which causes cancerous state in lung cells,"

he said.

The DAK President said the air quality in Kashmir has been constantly deteriorating for the past few years due to the increasing number of vehicles, constructions, brick klins, cement and other factories which emit pollutants and significantly pollute the air.

"And this is contributing to the enormous burden of lung cancer in the valley," Dr Hassan said

Dr Nisar said while smoking continues to be an important risk for lung cancer, in Kashmir many people who have never smoked are diagnosed with lung cancer and air pollution is a big factor.

"It is a wakeup call about the damaging impact of air pollution on human health. We cannot ignore climate health. If we want to address human health, we have to address climate health, he said.

"There is an urgent need to control air pollution to reduce the burden of lung cancer in the community and save precious human lives," he added.

# Demand for NEET-SS exam centre in Kashmir grows shriller

#### Now National Medicos Organisation writes to NBE for intervention

Srinagar, Aug 01: The demand for the National Eligibility Cum Entrance Test for Super Specialty (NEET-SS) has grown shriller as the National Medicos Organisation J&K has written to the governing body of the National Board of Examination (NBE) for intervention.

The NEÉT-SS exam is slated to take place on September 9–10, 2023, putting the students with the burden of travelling to Jammu or other states to sit the significant test. On September 4, admit cards are anticipated to be released and around 500 aspirants from Kashmir are scheduled to appear in the examination.

"NBE is conducting an entrance examination for admission in DM/MCH courses, which is scheduled to be held on the 9th and 10th of September this year. Candidates of the Jammu and Kashmir region are distressed due to the absence of an examination centre in Srinagar. The aspirants are in a quandary, stated by incharge of the resident doctors

association of Skims Institute Srinagar Dr Rubeena and other aspirants. Many candidates were unable to appear in the examination last year owning to no NBE centre in Srinagar," the medicos' organisation has written to NBE, a copy of which lies with the news agency—Kashmir News Observer (KNO).

It said that both travelling via aerial routes or roads connecting the valley to other states may cause hardship due to unpredictable weather or landslides on national highways in J&K. "This obstacle may avert aspirants during their journey. You are being appealed to assign an examination centre in Srinagar for DM/MCH candidates," the letter mentions.

Several candidates who have to appear in the examination told KNO that they will have to spend more than Rs 20,000 per head and at least three to four days of travel to other states to appear in the

examination.

"We aren't against setting up examination centre in Jammu but there is a need for such centres in Kashmir as well, where there are hundreds of candidates," they said. "In case no examination centre was being established in Kashmir, we will have to bear the financial strain of flight tickets, and hotel accommodations besides uncertainty due to the frequent closures on the highway."

The upset candidates have already written to LG Manoj Sinha to intervene at the earliest so that they won't have to suffer.

Various associations including RDA SKIMS and others have also shot letters to the LG seeking his intervention.

Meanwhile, top health officials already informed KNO that they have taken up the issue with the concerned authorities and are hopeful that a centre will be allotted in Srinagar

Addressing the root causes of air pollution is a complex challenge that requires a multi-faceted approach. Governments at all levels must implement stringent environmental policies to reduce emissions from industries, transportation, and other sources. Investing in renewable energy sources and promoting sustainable practices can also contribute significantly to curbing pollution.

Individual responsibility is equally crucial. We must recognize the collective impact of our daily choices, from using public transportation to reducing energy consumption and opting for cleaner alternatives. # Defying Economic Sanctions, Russian Economy Set To Grow In 2023

Big Increase In Indian And Chinese Oil Imports Helps Moscow's Recovery



Arguments, debates and surprises spun on Russia circumventing the fall out of US led western sanctions and hoping for a bounce back in the economy. About 37 countries have imposed sanctions on Russia since the invasion of Ukraine in February 2022.

Russian economy shrank by 2.1 percent in 2022, but was positive for bounce back in growth in 2023. According to latest IMF outlook, GDP of Russia is expected to inch up by 0.7 percent in 2023. These demonstrate that Russian economy avoided recession, unlike Japan and Germany, which are more damaging to the economy in the longer term.

Russia is the 8th largest economy by nominal GDP and 6th largest economy by PPP. Oil and gas accounted for about 40 percent of Russia's federal Budget


Revenue and 60 percent of exports in 2019. The underlying factors leveraging Russian resilience to economic distress were energy trade. Buoyancy in trade with India and China played a key role in  $boosting \, Russian \, resilience. \, Surging \, imports \, by \, India \,$ and China from Russia triggered revenue exchequer

to save the Russian economy from the distress. In 2022-23, India's imports from Russia spurred by 368.2 percent. It is a consequential leap over and above the spur in imports in the preceding year. India's imports from Russia increased by 79.9 percent

So did the China's bubbling growth in imports from Russia. In 2022, China's imports from Russia leaped by 43.4 percent. For the first time, Russia became one of the top ten trade partners of China. Much to the surprise and which is unusual, China borne the trade deficit with Russia. In 2022, China's import from Russia was US \$ 114.5 billion, against export of US\$ 76.1 billion, leaving much cushion to Russia to earn revenue to tide over the war and sanc-

In both the cases, energy was the primary reason for surge in imports from Russia. During 2 years period preceding Ukraine invasion (2020 and 2021), annual average of oil export by Russia to the world was about 261.5 million tonne. Assuming the same amount of export was generated in 2022, India and China accounted for nearly 50.5 percent of Russia's total oil export, against 39.1 percent in 2021. Of these, China accounted for 32.9 percent and India 17.6

Even though China accounted for more share in



import of crude oil from Russia in 2022, in terms of growth, India excelled China. In 2022, China imported 86.3 million tonne, as compared to 79.6 million tonne in 2021, showing a growth by 8.4 percent in 2022. In contrast, India's import of crude oil from Russia made an whopping jump by 2,605.9 percent in 2022- from 1.7 million tonne in 2021 to 46.0 million tonne in 2022. These demonstrate that India has played more active role in revving up Russia's revenue budget, despite the war and sanctions.

Conversely, Russian oil made a predominant entry in Indian oil basket. From merely 4 percent in the oil basket, Russian share in the Indian oil basket leapfrogged 20 percent in 2022-23. This manifests a new era with a major shift to Russia, leaving OPEC in the back bench for import of oil.

To tide over the sanctions, India and Russia have set up alternative arrangements. Indian refineries have accepted Russian insurance. Russian oil suppliers are trying to handle Urals oil transport to India themselves, using their own vessels and shipping

Besides oil, India's large imports of fertilizer kept Russian coffers supplemented by enhancing revenue. India's import of fertilizer from Russia increased by 293.9 percent in 2022-23, in value term. Oil and fertilizer accounted for 73.7 percent of total import of India from Russia in 2022-23, as compared to 32.9 percent in 2021-22. This manifests that it is not only in energy, but in agricultural development also, Russian cooperation has become imperative.

De-dollarization has become a timely support to Russia to fight sanctions. The fall out led to global partisan trade, leading shadow on the prominence of dollar based trade. Nearly 75 percent of China's import from Russia in 2022 was settled in Chinese

Following suit, India revived its Rupee trade arrangement with Russia. Indian government permitted nine Indian banks to open vostro accounts with Russian banks. This will facilitate to deal with Russian oil in rupee trade in currency swapping deal. Indian UCO bank has opened the vostro accounts with Russian Gazprombank and VTB banks.

In sum,, Russian vulnerability as a trade partner of India has no basis rather there are more benefits. India saved US \$ 3.6 billion by importing oil from Russia in the first ten months of 2022-23, according to the statement by the Minister. India has been benefited through energy and fertilizer ties with Russia, same is the benefits to Russia at this time of sanctions.

# Chicago's Newly Elected Socialist **Mayor Brandon Johnson Is A Big Hope For American Left**

A Protege Of Bernie Sanders, He Has Big Potential To Take Pro-People Measures

Johnson, who was recently inaugurated after beating conservative Democrat Paul Vallas by a four-point margin to become Chicago's newest mayor. But it also would have been an apt characterization of Burlington, Vermont, in 1980, when a young Bernie Sanders had just squeaked out a victory in his first mayoral campaign.

There are also, of course, many differences. Chicago in 2023, with a racially diverse population of 2.75 million, is a very different city, facing different opportunities and challenges, than the 38,000-person Burlington of the early 1980s. Johnson certainly has a much bigger and tougher task governing his city than Sanders did. Still, some of what Sanders was up against as mayor of Burlington — and what he did to overcome fierce opposition — will be relevant to Johnson's mayoralty. Here are a few lessons Johnson might take from Sanders's "outsider" approach to governing as mayor.

Johnson's campaign platform included support for "Treatment, Not Trauma," which would reopen health clinics closed by former mayor Rahm Emanuel and send social workers and

four-way race against long time incumbent Gordon Paquette. (The original vote count had Sanders winning by twenty-twovotes; a recount reduced that margin to ten.)

Paquette, a Democrat, had been in the mayor's office since 1971; he largely deferred to business interests. "The urban renewal projects Paquette ended up supporting displaced communities and, combined with the county's exploding population, raised rents and shrank the pool of available housing," Branko Marcetic wrote of his tenure as mayor. "Meanwhile, as the city's finances grew tighter, Paquette opted to cut services and fight demands for better pay and benefits from city employees."

Sanders, like Johnson, had run a progressive campaign, with a platform of reducing property taxes, which he regarded as "regressive and unfair," and shifting the tax burden to businesses and wealthier residents. (Johnson also pledged not to raise property taxes.) He additionally campaigned on rent control, opposing new developments that would displacelow-income residents, and raising salaries for city workers.

mayoralty on more favorable terrain than Sanders. Johnson's agenda will likely have the support of much of Chicago's city council members backed by the Chicago Teachers Union (CTU), which totals about two-fifths of aldermanic seats, including the six occupied by Democratic Socialists of America (DSA)-backed council members.

Johnson himself is a product of the militant CTU. For the past decade, the CTU has been building an independent, member-based political organization, United Working Families (UWF), that backs defenders of public education and otherworking-class causes. (In addition to Johnson, UWF has elected a number of aldermen, county commissioners, and Illinois state legislators, as well as one member of Congress, Representative Delia Ramirez.)

Along with other growing left groups like DSA, UWF has the potential to be the beginning of a party-like alternative to the neoliberal Democratic Party establishment in Chicago. If and when Johnson does face opposition to his platform on the city council, whether he succeeds will depend on his ability to maintain and expand the legislative coalition around these groups, including by primarying his neoliberal opponents and empowering allies.

These popular initiatives no doubt aided Sanders and the Progressive Coalition in boosting turnout and shifting Burlington's balance of power in subsequent elections, first in the city council race and then in the 1982 mayoral campaign. Sanders boasts that, between the mayoral election in 1979 preceding his first campaign and his first reelection campaign, turnout nearly doubled, from seven thousand to 13,320. Support for Sanders and the Progressives was concentrated in lower-income and working-class wards, where he won nearly 70 percent of the vote in 1983.

Brandon Johnson can also build popular support for his agenda and the coalition behind him by creatively using executive action and promoting government participation. Johnson issued a handful of executive orders immediately upon being sworn in, including one that "instructs the Office of Budget and Management to prepare an analysis of all resources in the City's FY2023 budget that are available to fund youth employment and enrichment programs" and  $another \, establishing \, a \, deputy \, mayor \, of labor \, relations, tasked \,$ with "improving working conditions, advancing new job opportunities for employment, and protecting workers' rights," among other responsibilities. The executive orders also created similar positions for immigrant rights and community safety. Hopefully, Johnson will continue using his mayor's pen to expand the remit of city government and fulfill his campaign promises wherever possible. Doing so may be necessary to get around potential intransigence on the city council, as it was for Sanders, and help Johnson rally and energize his supporters.

The opposition to Johnson will not just come from the city council, of course. Immediately after he won, Bloomberg ran a report quoting financial and business executives voicing serious concerns about the incoming mayor's plans to impose new taxes; these executives are more or less threatening a capital strike. Meanwhile, John Catanzara, president of Chicago's Lodge 7 of the Fraternal Order of Police, said before Johnson's victory that there would be "blood in the

How Johnson ultimately governs will in part be a function of what kind of public pressure he faces from CTU and other activists and social movements. Even Sanders was not immuneto compromising in the face of business's power. In his first year, he angered environmentalists by greenlighting a woodchip burning plant that later caused "long-term environmental issues for the city," according to Marcetic. And activists claim that the city's large public waterfront beautification project, for which Sanders has long taken credit, would have been blighted by high-rise condos and a hotel if not for public opposition. It was only because activists helped kill Sanders's original, more business-friendly proposal, they say, that much of the waterfront has been reserved for public use.

# Centre Must Take Up Action Plan Rather Denying Heatwave Deaths

REPRIMANDING DOCTOR ADMITTING LINKED DEATHS IN U.P. UNFORTUNATE



Deaths linked to heatwave conditions or exacerbated by it causing about 100 deaths within a span of few days in Uttar Pradesh and Bihar must be taken as wake-up call for India, for it requires urgently putting in place the heat action plan for health to save human lives, rather than denying by government as it has unfortunately happened in Uttar Pradesh, where the government reprimanded and even replaced the doctor who said that the patients died of heatstroke.

Dr. Diwakar Singh, who was chief medical superintended of Ballia district, had told media persons of Friday that 34 people had died of heatstroke at the main hospital under his oversight. The Uttar Pradesh government on Saturday took action against the doctor, reprimanded and replaced him for prematurely drawing that conclusion. A scientific team was formed at the state capital Lucknow and then sent to investigate the causes of death of at least 54 people in Ballia district, who were brought to the government hospital having complaint and symptoms of heatstroke. Dozens of them were brought at hospitals in the last three days between June 15 and June 17.

It was not only the conclusion of Dr Diwakar Singh. Another doctor, chief medical officer of Ballia District, Dr Jayant Kumar has further said that 23 people died of heatstroke in the district on Thursday, and 11 more on Friday, while adding that the "number of deaths has been more than normal." He had even told the media that most of the dead being elderly people suffering from different ailments like diabetes.

Though the government officials are on denial mode, perhaps due to failure of not



properly putting the heat action plan for health in place and a wish not to be exposed in the eyes of the people, pushing back against linking the deaths to heatstroke.

However, Dr SK Yadav who has taken charge in place of the removed Dr Singh, has said, "Elderly patients with comorbidities like hypertension and diabetes are expiring because of heat." He even told media that the deaths were more than normal, and the excessive heat was to blame for the high death toll, whatever the exact

After about 100 deaths in India, including 54 in Ballia and 42 deaths in Bihar in two days, the government officials have advised

the people in the country especially the elders to remain in their home during peak heat times in the day. Out of 42 deaths in Bihar 35 had occurred at two hospitals in the state capital Patna.

The state capital authorities in Lucknow in Uttar Pradesh have said that most of the patients died were over 60 years of ae with pre-existing health conditions, which may have been exacerbated by the severe heatwave. Dr Yadav in Ballia has said on Sunday that some 300 patients had been admitted to district hospitals in the last three days for various ailments aggravated by heat, while in Patna, authorities said that over 200 patients have been brought in hospitals

with complaints linked to heatwave, diarrhoea and vomiting.

Heatwave must be taken seriously in these circumstances, since India has been heading towards an unprecedented temperature rise, as it has been warned by Indian and international meteorological organisations. El Nino conditions are likely to bring hotter days ahead impacting even monsoon and winter.

It also must be noted that heatwave condition prevailed this year in February, ie one month ahead of last year, and had broke the record since 2019. Even last year, in March and April, India suffered brutal heatwave conditions. March 2022 was the hottest and

driest in 120 years, with temperature soaring to 8 degree above normal, and in the entire year the country underwent 200 days of heatwave conditions, which was five times of the 2021. India saw a 55 per cent increase in deaths due to extreme heat between 2000-04 to 2017-21, and according to Indian Meteorological Department (IMD), 10,545 people lost their lives to hat waves. However, NCRB of India, cites only about half of the figure.

IMD has issued a heatwave warning for about 10 states and UTs - which included certain areas of Chandigarh, Jharkhand, Maharashtra, Odisha, Telangana, Andhra Pradesh, Bihar, West Bengal, Madhya Pradesh, and Uttar Pradesh. Though, IMD has said that heatwave conditions are expected to gradually abate from these regions within few days from now, it should not be taken as alibi for not implementing the heat action plan of the country in the right earnest. Certain actions were taken as extension of closure of schools for summer vacations, issuing certain health advisories for people, and for workers 75 per cent of whom are exposed to heat, but these are too little to deal with the heatwave conditions with the emerging climate crisis.

IMD declares a heatwave conditions when either maximum atmospheric temperature exceeds 40 degree Celsius or 4.5 degree above normal, and severe heatwave condition when maximum temperature remains above 40 degree Celsius or 6.4 degree higher than the normal. Then there is the dangerous Wet Bulb Temperature (WBT), of which even 31 degree Celsius is exceedingly harmful to humans, while a temperature of 35 degree Celsius is considered unsurvivable if continues for more than 6 hours. We cool ourselves by evaporation, and hence WBT is measured by wrapping a piece of wet cloth around the end of the thermometer.

# **Absolute Breakdown Of Constitutional Machinery In Manipur: Supreme Court**

New Delhi: In scathing remarks against the government over the ethnic violence in Manipur, the Supreme Court said today that there has been an absolute breakdown of constitutional machinery in the state for the past two months.

Terming the investigation "tardy" and "lethargic", Chief Justice of India DY Chandrachud, who is heading the bench, said there has been a delay in FIRs being registered and statements being recorded. The court has also demanded the personal presence of the Manipur Director General of Police during the next hearing on Monday.

The Supreme Court's comments are likely to give further ammunition to the Opposition, which has been demanding the removal of Manipur Chief Minister N Biren Singh and the imposition of President's Rule in the state.

When the hearing began this afternoon, Solicitor General Tushar Mehta informed the court that 6,523 FIRs related to the violence have been registered, and 11 of these per-

Mr Mehta told the bench that seven people, including a juvenile, have been arrested in the case related to the horrific video of the women who were paraded naked and allegedly gangraped. The CJI then sought details of another incident in which two women were gang-raped and murdered.

The Solicitor General informed the court that 252 people had been arrested so far in connection with the 6,523 FIRs. He assured the CJI that there won't be any lethargy on the part of the government and said that the centre was open to transferring all 11 FIRs to

"There are about 6,500 cases. We want to see the serious cases. You can't transfer everything to the CBI. We have to put a mechanism in place," the CJI said.

Noting that there have been 150 deaths in Manipur since the violence broke out on May 3, Justice Chandrachud said that the material provided to the court was inadequate. "State must carry out the exercise of break up of FIRs, how many FIRs concern murder, rape, arson, looting, outraging modesty, destruction of places of religious worship and grievous hurt," he said

# Haryana On Alert After Communal Clashes Leave 4 Dead, 30 Injured

Gurugram/New Delhi: Four people, including two Home Guards, were killed, and at least 30 others injured in clashes that broke out between two groups in Haryana yesterday. The clash started during a religious procession in Haryana's Nuh, adjoining Gurugram.

Police said the Home Guards were shot dead as a mob tried to stop the religious procession in Nuh's Khedla Mod, throwing stones and setting cars on fire. A 26-year-old man was killed late last night after a mob attacked a mosque in Gurugram as the violence spread to the neighbouring district, while the identity of the fourth man who died in the violence is yet to be

ascertained. The Brij Mandal Jalabhishek Yatra, organised by the Vishwa Hindu Parishad (VHP), was stopped by a group of young men on the Gurugram-Alwar National Highway.

As the violence escalated, government and private vehicles were targeted by the mob. Towards evening, violence spread to the Gurugram-Sohnahighway, where several cars were torched and stones were



thrown at the police, sourc-

es said. About 2,500 people, who had come to Nuh to take part in the procession, were stranded in a temple due to the violence outside. They were rescued by police later in the evening.

Incidents of stonethrowing and arson were reported from parts of Palwal and Gurugram as well. Curfew has been imposed in Nuh to prevent further escalation of violence in the district. Prohibitory orders banning large gatherings have been put in place in Gurugram, Palwal, and

Faridabad as well. Police have registered about 20 cases and detained more than 20 people in connection with the communal violence. They are scanning footage from the security cameras to identify the rioters.

Internet services have been suspended in Nuh till tomorrow to contain the "intense communal tension" and stop the spread of misinformation and rumours. The situation in the town continues to be tense. However, there were no reports of any fresh violence today.

Reports say the clash was triggered by an objectionable video posted on social media by a Bajrang Dal activist. Sources said Bajrang Dal member Monu Manesar and his associates had circulated the video a few days ago.

Haryana Chief Minister Manohar Lal Khattar and other leaders have appealed to people to maintain peace and harmony. "Today's incident is unfortunate. I appeal to all the people to maintain peace in the state The guilty will not be spared at any cost, and strictest action will be taken against them," the Chief Minister said

Security around religious places in the violence-hit districts has been strengthened. Both the police and administration are holding meetings with prominent members of both communities to ensure peace. About 2,500 people, who had come to Nuh to take part in the procession, were stranded in a temple due to the violence outside. They were rescued by police later in the evening.

Incidents of stonethrowing and arson were reported from parts of Palwal and Gurugram as well. Curfew has been imposed in Nuh to prevent further escalation of violence in the district. Prohibitory orders banning large gatherings have been put in place in Gurugram, Palwal, and Faridabad as well.

Police have registered about 20 cases and detained more than 20 people in connection with the communal violence. They are scanning footage from the security cameras to identify the rioters.

#### **Mob Burns Restaurant, Shop In Gurugram Day After Communal Clashes**

The ripples from yesterday's communal clash in Haryana's Nuh -- which claimed five lives and left at least 70 people injured -- has reached Badshahpur, 40 km away. Restaurants and shops were vandalised and torched by a mob this evening amid religious chants. A row of shops and shanties have been reduced to cinders.

Violence broke out during a religious procession yesterday in Nuh, following what many say is an objectionable video that went viral. As a mob attacked the procession with stones, the 2,500-plus participants rushed into a temple to take shelter. The violence escalated as the evening progressed -- a mosque was torched post midnight, scores of vehicles torched and vandalised as mobs went on rampage in Nuh and neighbouring Gurugram. The dead include two security personnel and two civilians, one of them a cleric of the mosque. The people who had taken shelter in the temple were rescued close to midnight.

# Families flee as gunfire rocks Palestinian camp; toll rises to 11

SIDON: Three days of fighting in south Lebanon's Ain al-Helweh Palestinian refugee camp have left at least 11 dead and dozens wounded, the UN agency for Palestinian refugees said on Monday.

Clashes broke out over the weekend between members of Palestinian president Mahmud Abbas's secular Fatah movement and Islamist fighter based in the camp, Lebanon's largest located in the coastal city

Renewed gunfire and shelling on Monday shook the camp, said a correspondent in Sidon, sending frightened residents

"According to reports, 11 were killed and another 40 were injured, including one staff member" of UNRWA, said Dorothee Klaus, the UN agency's director in Lebanon. Fatah and Islamist group say they have

agreed on a truce in Sidon She added in a statement that UNRWA has "temporarily suspended" operations in the camp due to the fighting.

Palestinian factions said they had agreed on a truce on Sunday but it did not hold, with fighting continuing with automatic weapons and rocket fire.

Officials said five Fatah members and one Islamist fighters had been killed in the initial violence over the weekend.

There was no immediate word on the



identities of the other fatalities.

"UNRWA urgently calls on all parties to immediately return to calm and take all measures necessary to protect civilians, including children," Klaus said.

The statement noted that "two UNRWA schools have sustained damaged" and more than 2,000 Ain al-Helweh residents had been forced to flee.

A correspondent on Monday morning saw dozens of people, mostly women and children, leaving the camp carrying light luggage, while others took refuge in a nearby mosque.

### **Only four nations doing** enough to stub out smoking, says WHO

GENEVA: Only four countries — Brazil, Mauritius, the Netherlands and Turkiye — have adopted all the anti-tobacco measures recommended in the fight against the "deadly scourge" of smoking, the World Health Organisation said on Monday.

In a fresh report, the UN health agency urged countries to scale up their use of recognised measures to reduce tobacco use, including enforcing advertising bans, plastering health warnings on cigarette packages, raising tobacco taxes and providing assistance to those who want to quit.

It said Mauritius and the Netherlands had now joined Brazil and Turkiye in implementing all of its recommended measures.WHO said 5.6 billion people, or 71 per cent of the world's population, were now protected by at least one tobacco control measure - five times more than in 2007.

Brazil, Mauritius, the Netherlands and Turkiye implementing anti-tobacco measures

The health agency said the global rate of the prevalence of smoking had dropped from 22.8 per cent in 2007 to 17pc in 2021.

Without this decline, there would have been 300 million additional smokers now, the WHO said.

"Slowly but surely, more and more people are being protected from the harms of tobacco," WHO chief Tedros Adhanom Ghebreyesus said, adding that his organisation was eager to support national efforts to "protect their people from this deadly scourge".

Smoking remains the leading cause of preventable death, killing 8.7 million people each year, including 1.3m who die from inhaling second-hand smoke.

According to the organisation, eight countries are one policy step away from joining the leaders in tobacco control: Ethiopia, Iran, Ireland, Jordan, Madagascar, Mexico, New Zealand and Spain.

#### **Xi Jinping Calls Project Through PoK "Testament Of** Friendship" With Pakistan

Beijing: China will continue to work with its allweather ally Pakistan to take their strategic ties to new heights, Chinese President Xi Jinping has said as the two countries celebrated the 10th anniversary of the launch of the ambitious so-called "CPEC" infrastructure projects in the South Asian country for regional connectivity.

In his congratulatory message to the 'Decade of China-Pakistan Economic Corridor' (CPEC) celebration event held in Islamabad on Monday, Xi said the USD 60 billion CPEC infrastructure programme is an "important pioneering project" of the Belt and Road Initiative (BRI). The so-called "CPEC", which connects Gwadar Port in Pakistan's Balochistan with China's Xinjiang province, is opposed by India as it is being laid through Pakistan-occupied Kashmir.

The event was attended by Chinese Vice Premier He Lifeng, who is on a three-day visit to Pakistan.

"China will work with Pakistan to aim for highstandard, sustainable and livelihood-enhancing outcomes and further build the CPEC into an exemplary project of high-quality Belt and Road cooperation," Xi

#### Saudi Arabia Plans To **Give Yemen Economic Aid** Worth \$1.2 billion

#### **Myanmar's Aung Suu Kyi Pardoned In 5 Cases By Military Junta: Report**

Yangon: Jailed Myanmar civilian leader Aung San Suu Kyi has been pardoned in five criminal cases, though she still faces 14 others, state media said Tues-

The announcement was part of an amnesty of more than 7,000 prisoners to mark Buddhist Lent.

"Chairman of State Administration Council pardons Daw Aung San Suu Kyi, who was sentenced by the relevant courts," the broadcast said.

Suu Kyi, who has been in detention since she was ousted in a 2021 military coup, has been sentenced to 33 years in jail for a clutch of charges, including corruption, possession of illegal walkie talkies and flouting coronavirus restrictions.

The broadcast said she had been pardoned in five cases but faces 14 others.

"She couldn't be freed completely although some sentences against her were pardoned. She still has to face 14 cases. Only five cases out of 19 were pardoned," a legal source said.

Suu Kyi has only been seen once since she was held after the February 1, 2021 putsch -- in grainy state media photos from a bare courtroom in the military-

built capital Naypyidaw. The coup plunged the Southeast Asian nation into a conflict that has displaced more than one million people, according to the United Nations.

# At least 11 killed, 27 missing in Beijing rainstorms

At least 11 people are dead and 27 missing after heavy rains lashed Beijing, state media said on Tuesday, in downpours that have submerged roads and deluged neighbourhoods with

Storm Doksuri, a former super typhoon, had swept northwards through China since hitting southern Fujian province on Friday after first scything through the Philippines.

Heavy rains began pumrounding areas on Saturday, with nearly the average rainfall for the entire month of July dumped on the capital in just 40 hours.

Swathes of suburban Beijing remain badly hit by the rains — some of the city's heaviest in years.

On Tuesday, state broadcaster CCTV reported the rains had killed at least 11 people and that 27 were missing. Among the dead were two workers "killed on duty during rescue and relief" efforts, it said.



More than 100,000 people across the city deemed at risk had been evacuated, state-owned tabloid The Global Times reported.

On the banks of the Mentougou river, one of the flooding, AFP reporters saw muddy debris strewn across the road.

One local elderly man told AFP he had not seen flooding this bad since July 2012, when 79 people were killed and tens of thousands evacuated."This time it's much bigger than that," he said, declining to give his

"It's a natural disaster, there's nothing you can do," a man in his 20s surnamed Qi told AFP as he waited for a taxi outside a hospital

with his grandmother. "(We) still have to work

hard and rebuild," he added. About a dozen emergency vehicles, including trucks with water tanks and bulldozers, were spot-Shijingshan and Mentougou districts.

# US, Afghan Taliban officials hold rare talks in Doha

WASHINGTON: US officials held their first wide-ranging talks, since the 2021 pullout from Kabul, with representatives of the Afghan Taliban in Doha, Qatar, to discuss economic issues, security, and women's rights, both sides confirmed on Monday.

The talks also focused on returning assets of the Afghan central bank that were frozen in the United States after the Taliban takeover of Kabul in Aug

"On July 30 and 31, met senior Taliban representatives and technocratic professionals in Doha, Qatar ... to continue discussions regarding critical interests," US State spokesperson Matthew Miller said in a statement issued in Washington.

The US delegation was led by Thomas West, Special Representative for Afghanistan, and included Rina Amiri, Special Envoy for Afghan Women,



Girls, and Human Rights, and Karen Decker, chief of the US mission to Afghanistan.

Zabiullah Mujahid, the chief spokesman for Taliban, confirmed the meeting in a tweet, saying that an Afghan delegation, led by Foreign Affairs Minister Mawlavi Amir Khan Muttaqi, met Mr West and his team in Doha to discuss key issues.

Representatives of Afghanistan' finance ministry, the Bank of Afghanistan, and officials of Taliban's political office in Qatar attended the meeting, he added.

Mr Miller said US officials urged the Taliban to "reverse policies responsible for the deteriorating human rights situation in Afghanistan, particularly for women, girls, and vulnerable communities".

US officials also expressed grave concern regarding detentions, media crackdowns, and limits on religious practice. They also expressed support for the Afghan people's "demands for their rights to be respected and for their voices to shape the future of the country", the spokesperson added.

### **US** general says allies key to countering China in Pacific

SYDNEY: The United States will rely on allies rather than a major expansion of its own forces to counter any Chinese military risk in the Pacific, a US general has said. Beijing enjoys "very clear" advantages in the region, said Major General Joseph Ryan, commander of the

12,000-strong 25th Infantry Division on Oahu, Hawaii. He cited China's expanding military defences, its longrange rocket missile capability and the ease with which it can position forces and equipment in the Pacific.

By contrast, in the event of conflict, the United States and its allies would have to traverse international waters or the territories of multiple nations, requiring their permission as well as the mobilisation of air, land and sea

"I don't see a major expansion of US military presence in the region," Ryan said while in Darwin at the weekend for multinational military exercise Talisman Sabre. "What I do see is increased partnership, opportunities

for partnership and perhaps some increased growth in the region," he said.

Tensions between Beijing and Washington have flared in recent years over self-ruled Taiwan, China's disputed claims over a swathe of the South China Sea and a tug-ofwar for influence in the South Pacific.

It's easy to get caught up in counting calories and grams of added sugars, fats, proteins, and carbs when you're trying to eat well. But there's one nutrient that too often gets thrown to the wayside: dietary

Scientists have long known that eating fiber is good for health. This nutrient has been linked to fending off disease and reducing the risk of a range of conditions, including type 2 diabetes-Trusted Source, food allergiesTrusted Source, and even knee arthritis.

Star-studded endorsements aside, it's not about eating a "high-fiber" diet as much as it's simply this: Eat more fiber. Fiber does more than contributing to weight loss and reducing the risk of disease.

Losing out on those recommended fiber grams per day may significantly change the way your gut functions. It could even make a difference between weight loss or none, and longer life or not.

#### What we know about fiber today

Many studies have strongly linked highfiber diets with longer and healthier lives. For example, Dr. Burkitt, as mentioned above, found in the 1960sTrusted Source that Ugandans who ate high-fiber vegetable diets avoided many of the common diseases of Europeans and Americans. 

# Kane Williamson begins batting again

New Zealand captain posts video of him in the nets on social media

**GUJARAT:** Kane Williamson has begun facing throwdowns in the nets once again as he continues his recovery after undergoing surgery for a ruptured anterior  $cruciate\ ligament\ (ACL)\ in\ his\ right$ knee. Williamson posted a short clip of him batting on Instagram on August 1 with the caption "Nice to be back in the nets with the bat in hand for a few throws.'

Williamson had ruptured his ACL while playing for Gujarat  $Titans\,in\,the\,opening\,match\,of\,IPL$ 2023 on March 31. He had jumped up on the deep square leg boundary to intercept a shot from Chennai Super Kings opener Ruturaj Gaikwad, and though he saved the six he landed awkwardly on his right leg and went down immediately. He had to be carried off the field and was subsequently ruled out of the IPL and possibly even the 2023 ODI World Cup at the time.

Williamson returned to New Zealand and had surgery in April, and it was later reported that if he wasn't fit to play the World Cup in India, he might still travel with the team as a mentor.

# Verstappen's dominance makes a third straight F1 title look like a formality

PARIS: Max Verstappen's dominance is so total that it already feels like he's won his third straight Formula One title, even with 10 rac $es\,remaining\,following\,the\,mid-season\,break.$ 

With a lead of 125 points over his nearest rival, the Red Bull driver is already in a position to watch a highlights reel of his season and list his favourite wins. There have been 10 out of 12 races so far, plus a further two victories when including sprint races. After winning the Belgian Grand Prix with another emphatic drive on Sunday, Verstappen was asked which of the victories he likes the most. "It's difficult to choose. There have been a lot of nice ones," he said. "I think the one actually which I really enjoyed was like back in

May 7, to be precise, although it may seem long ago in Verstappen's world considering he has won every race since. At that point in the season, however, his Red Bull teammate Sergio Perez was a self-declared title contender and still actually looking like one.

The Mexican driver had just done the main race-sprint race double at Azerbaijan, and his


