SRINAGAR, AUG 08: Dengue is making its way again in Jammu Division as fresh cases have been reported in the region with officials terming it an emerging threat in the coming months. However, the government said it is adopting a three-pronged strategy for the control and management of the infection.

A top health official told the news agency—Kashmir News Observer (KNO) that this year, 25 cases of dengue have been reported in Jammu Division, with most of them in Jammu district only.

As of now, no patient suffering from dengue was hospitalized as they are having mild symptoms which are

MUMBAI/SRINAGAR, AUG 8: After a fresh probe was initiated into the 1989 murder case of Kashmiri Pandit judge Neelkanth Ganjoo, his family has said that it is "a little too late" and they don't want "wounds to be scraped

On Monday, the State Investigation Agency (SIA) in Jammu and Kashmir initiated a fresh investigation into the 1989 murder of retired judge Neelkanth Ganjoo, marking a significant step towards seeking justice for the longstanding case.

"It's too little too late after 34 years of the incident. Now we don't want our wounds to be scraped again," SK Ganjoo, the son of the slain former judge said.

Meanwhile, former Jammu and Kashmir Deputy Chief Minister, Kavinder Gupta, has welcomed the probe, stating,



"As co-chairs of the Congressional Caucus on India and Indian Americans, we are proud to lead a bipartisan delegation to India. We will be there to discuss how to strengthen economic and defense ties between our two counties, the oldest and largest democracies," Khanna said.

"Both of us believe that the US-India relationship will be a defining one of the 21st century. India is a key partner in ensuring multipolarity in Asia and the denial of China as a hegemon," he said.

"We must continue to strive to make progress and build our partnership based on our shared founding values of democracy, freedom of the press and assembly, and human rights. This delegation is a historic opportunity to drive further collaboration and advance shared aims,"

Earlier this year, Khanna and Waltz hosted a historic US-India Summit on the Hill featuring panels and remarks from government leaders, experts, and Indian-American leaders from across the country. (Agencies)

Reacting to the reopening of the probe into the over three-decades case, Kashmiri Pandit writer and political activist Agnishekar said, "Genocide has happened to Kashmiri Pandits. This is one big thing, justice should be done for Neelkanth Ganjoo, who was reportedly killed by Yasin Malik, leader of Jammu Kashmir Liberation Front (JKLF).

"For 34 years, we have been talking about investigation a probe a SIT. 1500 Kashmiri Pandits have been killed. Now we welcome this news of investigation after 34 years."

"It was a selective killing, kill one and scare ten. Neelkanth Ganjoo was a reputed personality," Agnishekhar said.

The SIT of Jammu and Kashmir Police has appealed to the public to come forward and share accounts of events to unearth the larger conspiracy behind the murder.

The incident occurred over 30 years ago, when Ganjoo, a Sessions and District Court udge, was shot dead by militants in Srinagar on November 4, 1989.

Three militants surrounded Ganjoo as he was in the Hari Singh Street market and shot him dead near the Srinagar High Court. (Agen-

Chikri is a pale, honey colored, fine grained soft wood found in hill ranges of Rajouri district of Jammu province. The Chikri woodcraft of Rajouri is characterized by intricate carving and detailing.

Similarly, Mushqbudji Rice is a premium variety of short bold aromatic rice grown in higher reaches of the Kashmir valley especially in Anantnag district. The cooked Mushqbudji Rice is unique and possesses a harmonious blend of taste, aroma and rich organoleptic properties.

Geographical Indications (GI) is a form of Intellectual Property right that identifies goods originating from a specific geographical location and having distinct nature, quality and characteristics linked to that location.

After GI tagging only an authorized user has the exclusive rights to use the Geographical Indication in relation to these products. Due to this, no person can copy it from beyond their geographical areas. This will prevent unauthorized use of these registered Geographical Indication goods by third parties, will boost exports and promote their brands at international level, thereby promoting economic prosperity of producers and related stakeholders including contribution to GDP of the country.

While speaking on the development, Chief  $General\,Manager, NABARD, Bhallamudi\,Sridhar,$ thanked the concerned departments of the UT government and congratulated all the GI applicant organizations. He further informed that earlier this year in March Basohli Painting of Kathua and Ladakh Wood Carving of Ladakh got GI tag through NABARD support. He added that five more products of J&K are in the final stages of getting GI Tag.

reported in the valley since January 2023 to date, leading to 135 fatalities.

Srinagar district emerged as one of the most accident-prone areas, recording 225 accidents that claimed the lives of 28 people. Srinagar is followed by South Kashmir's Anantnag that saw 147 accidents and 25 deaths.

"Budgam reported 80 accidents, resulting in eight fatalities. In Kulgam, 74 accidents were reported, leading to the loss of 11 lives. Ganderbal district witnessed 83 accidents, with a  $death \, toll \, of \, 2 \, people. \, A \, total \, of \, 38 \, road \, accidents$ were recorded in Bandipora, resulting in three deaths. Pulwama experienced 59 accidents and four fatalities. Shopian saw 20 accidents and three tragic deaths," the official data reveals, adding that "Awantipora police district in south Kashmir reported 50 accidents, with 13 lives lost. Baramulla district reported 126 accidents, leading to 12 fatalities. Kupwara witnessed 57 accidents, resulting in seven deaths. Handwara reported 58 accidents, with a death toll of nine people. Sopore saw 47 accidents and the loss of 10 lives.

Expressing concern over the distressing statistics, Superintendent of Traffic Police for Rural Kashmir, Ravindar Pal Singh, emphasized the efforts undertaken to address this alarming issue. "Special drives against traffic violations  $have \, \dot{been} \, carried \, out \, rigorously, and \, awareness$ programs targeting drivers, students, and local communities have been conducted to encourage adherence to traffic rules and regulations," he said.

To enhance enforcement measures, he said several initiatives have been implemented, including the use of E-Challaning for streamlined penalties, breath analyzers to detect intoxication, and the installation of trash barricades. "Over-speeding is being tackled through a state-of-the-art speed radar system, and violators are being promptly booked in accordance with provisions of the Motor Vehicles Act. Special attention is being devoted to combat non-compliance with helmet-wearing, overloading, and reckless driving practices," he

"Efforts are also being focused on taking strict actions against habitual violators, including the cancellation of driving licenses, vehicle registrations, and permits for those involved in accidents resulting in fatalities," he said.

Singh urges drivers to follow traffic rules strictly: no speeding, wear helmets, avoid overloading, refrain from mobile use while driving, no stunts on bikes, and stay on the correct side of the road, ensure regular vehicle check-ups, drive sober, and possess a valid license and fitness certification.

### Machail Mata.....

Paddar valley of Kishtwar commenced on July 25 and is scheduled to conclude on September 5.

The footfall at the temple is likely to witness manifold increase with the arrival of holy "Charri Yatra" from Jammu to Machail on August

"The yatra has been transformed into a more comfortable, enjoyable and safe journey for on-foot pilgrims with the opening of the PMG-SY road by district administration Kishtwar on August 5," an official said.

This year, the district administration led by Deputy Commissioner Devansh Yadav has taken far reaching measures to facilitate the devotees to make their yatra a lifetime memo-

rable experience, he said. These include the installation of a first-ofits-kind 30 KW hybrid solar power plant, a 4G Airtel tower, and electricity to Machail Village, easing the arduous spiritual journey of the devotees, the official said.

Additionally, facilities such as tent city at Machail, Yatri Bhawan, Sapphire guest house and luxury mushroom tents at base camp Gulabgarh have been arranged to accommodate and host the devotees during their pilgrimage, he said.

He said the Machail Mata yatra holds immense spiritual and cultural significance and remains a cherished place of pilgrimage for devotees across the country.

Describing the construction of PMGSY road as a "major milestone", the official said the department concerned successfully cleared the challenging rocky stretch on Machail road in a short span of time.

"Road cutting in a crucial rocky stretch has resulted in achieving significant progress on this road which is now being used by pilgrims up to Hamouri village for on foot journey," he said.

The pilgrims had to foot a distance of about 22 kilometres to reach the shrine but after the construction of the road, the travel time was shortened from 1.5 to 2 hours, the official said.

Additionally, the officials said the installation of railings by the Army on the Mov bridge has significantly enhanced the safety of pilgrims during their journey. (Agencies)

The official said that on the direction of

Administrative Secretary to Government, Health and Medical Education, the authorities are going to adopt a three-pronged strategy for the control and management of dengue.

An aggressive IEC/BCC campaign will be carried out through local radio, television and Jammu Municipal Corporation's garbage collection vans, he said, adding that surveillance activities are being enhanced for vector-borne diseases in districts. Besides, for identification and prioritisation of high-risk areas, a comprehensive strategy is being charted out for integrated vector management (IVM),

The health official said that domestic breeding checkers are being hired for source reduction activities of vectors.

He said the principals of Government Medical Colleges, Chief Medical Officers and Medical Superintendents have been directed to have earmark separate dengue wards along with blood component facilities in all GMCs and district hospitals. The concerned authorities have been directed to immediately impart training to the staff to start diagnostic facilities for dengue at district hospitals in Ramban and Reasi, he

"The chief medical officers have been directed to ensure that all private laboratories and nursing homes must upload the data on the integrated Health Information Platform (IHIP) while CMOs and BMOs have been directed to enhance surveillance activities of Vector Borne Diseases, and identify high-risk areas strategies so that the integrated vector management may be worked out," he informed.

MD JKMPCL and State Malariologist have been directed to ensure the availability of diagnostic kits, drugs, insecticides and other logistics.

Pertinently, 18 people died of dengue while over 8,000 were found positive in J&K last year.

Dengue viruses spread to people through the bite of an infected Aedes species (Ae. aegypti or Ae. albopictus) mosquito. Almost half of the world's population - about 4 billion people - live in areas with a risk of dengue. It is often a leading cause of illness

# In SC, Sibal says will of the people of J&K not considered at all

'J&K cannot be converted into a UT'

Srinagar, Aug 08: Questioning the abrogation of Article 370 by Union Government, senior Supreme Court lawyer Kapil Sibal on Tuesday said that that will of the people of Jammu & Kashmir was not consid-

ered at all. Appearing before the five judge constitution bench hearing petitions challenging abrogation of the Article 370, Sibal said that people of J&K gave themselves Constitution like the people of India gave Constitution of India to themselves.

As per news agency— Kashmir News Observer (KNO), referring to three presidential orders issued on December 19, 2018, August 05, 2019 and August 6,2019, Sibal said these are all executive acts and the will of the people is not considered at all.

"Can you delete provi- obtaining concurrence of executive act? Can you Malik. decimate the constitution by an executive act? Can through this order states you change the constitution by an executive act?" he asked. On December 19, 2018,

the President of India while imposing the President's rule in Jammu & Kashmir had also suspended proviso to Article 3 of the Constitution of India. The proviso makes it compulsory for the president to refer the Bill con-

taining the proposal for re-organisation of a state to the legislature of that state for obtaining its views thereon. On August 5, 2019, the President of India had issued "The Constitution (Application to Jammu &

### **CS launches 'Aspirational Panchayat' dashboard** for monitoring rankings of 4291 Panchayats

SRINAGAR, AUG 8: Chief Secretary, Dr Arun Kumar Mehta today launched the Planning, Development and Monitoring Department dashboard for monitoring the progress of panchayats of J&K under 'Aspirational Panchayat Development Programme

Those who were present included Commissioner Secretary, RDD; Commissioner Secretary, IT; Secretary, PD&MD; DG, Planning; CEO, JaKeGA besides other concerned officers.

During the launch ceremony, the Chief Secretary felicitated the Planning Department for coming up with the monitoring mechanism for keeping track of the development of Panchayats. He observed that tools like these are the sure way of bringing efficiency in the governance and advised the developers to programme other such tools in future.

The Chief Secretary called this dashboard a mirror to find out the areas of concern for each panchayat. He remarked that it would make the interventions more directional with requisite outcomes to be monitored in real time. He exhorted upon all to carry forward this exercise of updating this portal periodically and not to turn such efforts into ritualistic

Dr Mehta made out that the data available over this dashboard together with the plans of each panchayat available over the 'Janbhagadari' portal can be used to develop separate

portals for each panchayat. He further added that the statistics relating to population and institutions present there should also be captured to make these portals informative for gen-

The Chief Secretary also enjoined upon the officers to ensure that the 'Prabhari Officers' of each panchayat go through the reports about their concerned Panchayats each month in order to have fair idea about the status of development there. He directed for making it one of the benchmarks to assess their performance annually.

Dr Mehta also asked the officers to work in coordination with each other to realize the goal of 'Zero Poverty' in J&K by 2024. He asked them to study the panchayat models adopted by the states like Kerala, Telangana, Karnataka, Madhya Pradesh and Uttar Pradesh to adopt best practices implemented there. He directed formulating a plan that is more suitable and realistic for meeting our targets and expectations at large.

On the occasion the Secretary, PD&MD, Raghav Langar informed the participants about the unique features of the dashboard. He made out that each of the Panchayat is evaluated across 9 sectors having 100 indicators. He informed that the dashboard has a feature to filter top and bottom Panchayats in each district across different sectors.

It was also brought out that the life of rural population.

data entry for each month has to be done at the Panchayat level which has to be validated at Block and authenticated at District level. It was revealed that for the capacity building of the staff, a training module has been conceived for them to make this exercise efficient.

Aspirational Panchayat Development Programme (APDP) has been conceived on the analogy of "Aspirational Block Development Programme" of UT of J&K. It has been conceived for holistic development of Aspirational Panchayats over a period of time. The process included rating all the 4291 Panchayats spread over 285 Blocks in 20 Districts of Jammu and Kashmir on defined socioeconomic indicators.

Pertinently, the 100 measurable indicators (KPIs) across 9 Sectors include Agriculture & allied Activities (6 indicators), Health & Nutrition (11 indicators), Education (13 indicators), Rural Development & Sanitation (7 indicators), Individual Beneficiary Oriented Schemes (4 indicators), Skill Development (4 indicators), Basic Infrastructure (17 indicators), Environment (5 indicators), & Good Governance (33 indicators). These provide insight into existing status and will also capture incremental progress over a period of time. On the basis of importance of these sectors, weights had been assigned to each sector and sub-indicators as per relevance in the

### **School building constructed** years back allegedly turned into cowshed in Budgam

BUDGAM, AUG 8: A school building that was intended for educational purposes in Rakhi Aarath Bemina has unfortunately been left unfinished for the past eight years, and it has now been repurposed as a cowshed.

This alarming development has led to a situation where numerous cows have taken up residence within the building, displacing the potential learning environment for students. Sources have informed Kashmir News Service (KNS) that the under-construction school, part of the SSA scheme, situated in Rakhi Aarath Bemina, has shockingly transformed into a cowshed. This grave issue has resulted in a substantial number of cows inhabiting the premises meant for students' education.

The current SSA school operations are being con-

ducted within a privately-owned building, which is proving to be inadequate in terms of space. This inadequacy is causing significant disruptions to students' ability to receive a

quality education. Concerned locals in the area have raised their voices,

expressing their distress over the situation. Due to the administration's inability to provide appropriate facilities, children are being forced to study in rented private rooms. This unfortunate circumstance has prompted a demand from the

a more suitable and conducive learning environment. An official from the Education Department, who chose to remain anonymous, disclosed that the teachers of the affected school had even contributed their personal funds to secure the rented building for educational purposes.

Several students who were interviewed shared their dissatisfaction with the current condition of the rented building. They earnestly appealed to the authorities to expedite the process of relocating them to a new, dedicated school building, which would enable them to pursue their studies without hindrance.

Despite numerous attempts to contact the CEO of Budgam, there has been no response to our inquiries at the time of reporting.

rience, Personality and Leadership Development, Career Progression, and Placement, Objective Score, and Perception



The campaign was launched at an event organized with regard to the J&K Transport Subsidy scheme to provide a subsidy of Rs. 5.0 Lac for replacing vehicles older than 15 to 20 years of age with new commercial passenger vehicles. He exhorted Transport Unions,

Drivers and other stakeholders to participate in ongoing campaign of "Meri Mitti Mera Desh" to remember the great sacrifices of martyrs, who laid down their lives for the nation.

Meanwhile, intensifying enforcement activities against the instances of overloading of vehicles and other violations, the teams of Motor Vehicles Department have launched special enforcement drives in the Month of August. 2023.

The Department has decided to continue such drives and warned of strict & punitive action if any violation is committed on roads.



The warnings were issued by the different enforcement Teams of Motor Vehicle department during ongoing enforcement drives conducted at different locations of NH44. The teams are conducting surprise checking on the special directions of RTO Jammu Pankaj Bhagotra under the overall directions of Transport Commissioner I&K Rahul Sharma.

While interacting with drivers, teams emphasized that MVD is determined to bring violations on the roads to zero level and asked them to be disciplined while driving their vehicles on Road.

"Any deviation/violation on your part will attract strict penalty as per MVA and Rules made there under, which may even lead to cancellation/suspension of the RCs/RPs of their vehicles and DLs of the drivers committing the offences" they were told. As per the Regional Transport Office Jammuduring the current month, the department checked as many as 350 vehicles, out of which 95 vehicles were challaned/compounded for various violations under MV Act and Rules framed there under. An amount of Rs 2.35 Lac has been realized from violators on spot against the

disposed challans, while as an amount of Rs. 8.35 Lac is expected from remaining challans.Moreover 5 Driving Licenses, 3 Route Permits and 2 Registration Certificates were also recommended for suspension by the enforcement wing for involvement in violations of serious nature. 

efforts women do to look beautiful for others more appealing than Allah's rewards? They should fear Him and know that modesty is the best jewel of women which is a part of their faith.


"Do not they know that it is Allah who accepts the repentance of his servants". (Surah Tawba, Verse 104)

# In order to Create a Better Future, We have to develop Interest in Reading **Books among Children**



Wealthy candidates have an advantage in gaining a foothold. Parties also seek selffinanced candidates who tend to be more competitive during elections.

Running for office can be expensive. Unfortunately, a candidate's wealth determines their likelihood of winning.

Will Indian democracy be affected by a Parliament made up mostly of wealthy representatives in a mainly impoverished coun-

Over 80% of Parliament members are millionaires. As a result, many qualified and knowledgeable people in India do not view politics as a career choice.

It's the same analogy in the US. It is possible to contest and win elections if you are a multi-millionaire or supported by wealthy

Coming back to India, although she had a questionable track record, the former chief minister of Tamil Nadu, J. Jayalalitha, even after conviction, has succeeded in winning multiple elections. Other notable politicians include BJP leader Y.S. Yediyurappa and the late Gujarat Chief Minister Chiman Bhai

Establishing a transparent and honest method of fighting elections is crucial to promote democracy and fairness in countries like the US and India. It will pave the way for a more equal and just society.

### **United Arab Emirates: The** 'Teflon' Nation In The Middle East

The United Arab Emirates resembles US 'Teflon President' Ronald Reagan.

Congresswoman Pat Schroeder awarded Reagan the label because nothing stuck to him while he was president in the 1980s - not the recession, not his interventions in Lebanon that cost the lives of 241 US Marines, not his plunging job approval rating.

UAE President Mohammed bin Zayed doesn't need  $to worry\,about\,performance\,ratings.\,His\,Teflon\,quality$ is the lack of pushback he encounters as he charts an independent course that sometimes puts him at odds with the United States, the UAE's long-standing ally and security guarantor.

The UAE's Teflon coating has long dampened the effect of allegations of loose money laundering and sanction compliance controls and human rights abuses, and repeated revelations about covert surveillance and monitoring operations beyond the country's borders.

However, the Teflon shield, the product of one of the Middle East's most successful nation branding campaigns, may be fraying at the edges.

Recent leaks involving a cache of 78,000 internal documents illustrated how a Swiss company operated by a former intelligence agent sought to destroy the reputations of some 1,000 people, including activists, journalists, and politicians, and 400 organisations in 18 European countries.

The targets were accused, often based on flimsy evidence, of being Islamists or critics of the UAE.

In June, British parliamentarians launched a bipartisan inquiry into the UAE's treatment of foreign business executives accused of breaking the law. The deputies took the UAE to task for the lack of an independent judiciary and due process.

"There are shortcomings on many of those fronts in the UAE," said Baroness Helena Kennedy, a prominent barrister and Labour Party member of the House of Lords, who chaired the inquiry.

In testimony, Meridith Morisson, head of business intelligence at the Risk Advisory Group, described the UAE as "the biggest latent business risk in the Middle East – because it's the one that goes below the radar."

In an echo of a 2006 debacle, when Dubai-owned DP World sought to acquire Peninsular and Oriental Steam Navigation Company (P&O), US national security officials are scrutinising UAE sovereign investor Mubadala's US\$3 billion takeover of New York-based Fortress Investment Group.

Concerned about handing management of six US ports to an Arab company, DP World was forced to exclude the facilities from the acquisition.

US intelligence has since reported a resumption of construction at a suspected Chinese military facility in Abu Dhabi's Khalifa Port, a year after the UAE said it had halted the project because of US concerns.

 $Mubadala\,agreed\,in\,May\,to\,acquire\,a\,70\,per\,cent\,stake$ in Fortress, a private equity and distressed debt investor, from Japan's SoftBank Group.

Fortress' investment portfolio consists of financial services, transportation, healthcare, energy, and infrastructure companies.

Mubadala hopes to salvage the deal by attracting American investors, including pension funds, who would reduce its stake in Fortress.

The Fortress deal scrutiny does not mean the UAE's Teflon is irreparably damaged. On the contrary.

The UAE accounted in 2020 for about US\$45 billion of foreign direct investment flows to the United States. much of that from its sovereign wealth funds, including Mubadala.

The United States, alongside Germany, Italy, and Greece, have recently pressured the Financial Action Task Force (FATF), an international anti-money laundering and terrorism finance watchdog, to remove the UAE from its watchlist despite persistent indications that the country is a hub for illicit transactions, involving, among others, Russia's Wagner group and African gold smugglers.

The United States has sanctioned several Emirati companies because of links to Wagner or circumventing sanctions against Russia related to the Ukraine war.

In March, the UAE's central bank cancelled a license granted to Russia's MTS Bank after the bank was sanctioned by the United States and Britain. The UAE has also targeted Iranian entities for evading Ukrainerelated sanctions against Russia.

The FATF grey listing dented the UAE's reputation as the Middle East's foremost financial hub. Members of the committee monitoring Emirati progress in addressing FATF concerns questioned the reliability of UAE submissions on steps it has taken to address deficiencies in its measures to prevent sanctions evasion, smuggling, money laundering, and terror finance.

Even so, a recent FATF progress report on the UAE's adoption of the watchdog's recommended fixes said the UAE was "now 'compliant' with 15 of the 40 FATF Recommendations, 'largely compliant' with 24 Recommendations and 'partially compliant' with one Recom-

US support for giving the UAE a clean bill came as Emirati National Security Advisor Tahnoun bin Zayed Al Nahyan, a brother of President Mohammed bin Zayed, visited Washington in early June for the first time in

Bin Zayed's visit was intended to improve strained relations over Emirati complaints that the United States had failed to respond forcefully to a 2022 attack on Abu Dhabi by Yemen's Houthi rebels and UAE dealings with China and Russia. A statement by Bin Zayed and Jake Sullivan, his US

counterpart, said the two men had discussed "the importance of building trusted technology ecosystems." Officials said Bin Zayed and Sullivan had agreed on ways to address US concerns about the UAE's engagement with China. However, they provided no details.

### **Niger Coup Risks Opening Another** Front In The West's War With Russia

On July 26, a splinter faction of the Niger military overthrew President Mohamed Bazoum, confining him to the presidential palace. While telecommunications infrastructure was still intact, a tweet from the premier's office claimed Bazoum and family were in good health but were prepared to call upon the National Guard to attack if the rebelling soldiers did not back down.

Within forty-eight hours, Colonel Amadou Abdramane, surrounded by nine other officers, took control of national airwaves, declaring he had "put an end to the regime that you know due to the deteriorating security situation and bad governance." The African Union and the Economic Community of West African States (ECOWAS) condemned the effort to unseat Bazoum, who was elected president two years ago in the nation's first peaceful, democratic transfer of power since its independence from France in 1960.

European leaders, along with United Nations chief António Guterres, condemned "any effort to seize power by force" and urged respect for Niger's constitution, while the United States expressed deep concern and called for Bazoum to be released from captivity. Even Ethiopia's government, which human rights organizations accused of war crimes throughout the Tigray War, said putschists were "acting in total betrayal of their republican duty." How regional powers would respond to this crisis was, according to Nigeria's recently elected president, Bola Tinubu, a "litmus test for West Africa's democracy."

This coup is the seventh to take place in Africa's Sahel region, which stretches from Mauritia in the west to Eritrea in the east, since 2020; most recently, Mali and Burkina Faso have suffered three coups in as many years. This political tumult threatens to open fissures across the region. Mali and Burkina Faso, both states currently held by putschists, have stated that they will respond to any attempt by ECOWAS, a political and economic bloc made up of largely Western-allied West African nations or outside military forces, to restore Bazoum with a full-scale invasion. Whilst Niger's beleaguered premier has called for US intervention, the juntas in neighboring Mali and Burkina Faso have aligned with Russia since taking charge.

Niger was a strategic outlier for Western powers combatting growing jihadist movements in the Sahel. After military takeovers in Chad, Mali, and Burkina Faso in 2020, the West and its allies saw Niger as an integral part of its attempt to maintain power in a region in which pro-Russian sentiment is growing and Islamist groups hold sway.

On July 28, Russian foreign minister Sergei Lavrov stated that constitutional order should be restored while at the same time, Wagner Group's Yevgeny Prigozhin released a voice message on the Telegram app denying any involvement in the coup. According to Reuters he did, however, describe the developments as "a moment of long overdue liberation from Western colonizers and made what looked like a pitch for his fighters to help keep order."

Niger is home to twenty-seven million people, 40 percent of whom live in extreme poverty and 50 percent on \$2.15 a day. At \$15 billion, its GDP is less than onetenth of that of Washington, DC, whose population numbers just over seven hundred thousand. The state imports nearly one-third of its food and is ranked 189th out of 191 in the United Nations Development Program (UNDP) Human Development Index, with a per capita GDP of US\$594.90, one of the lowest in Africa. In the global community of states, it suffers the most from economic inequality. As a result, the average life expectancy in Niger is sixty, and its median age is fifteen, making it the youngest country in the world.

Since 1945, and well after France's African colonies gained independence in the 1960s, France instituted or imposed the West African franc (CFA) as the currency of its West African colonies. The currency is backed by the French treasury and pegged to the Euro, and it's accepted in fourteen member countries, including the last three countries that underwent a coup: Mali, Burkina Faso, and Niger.

While the CFA franc provides some economic order and interstate financial convenience, its value, inflationrate, and volatility are determined by the behavior of people playing in markets on a completely different continent. The absence of monetary sovereignty within the region puts constraints on the kinds of domestic policies that local governments can pursue. In 2019, the Brookings Institution, a conservative think tank, conceded that although the CFA franc ensured currency stability, it limited intra-regional trade, encouraging the emergence of economies reliant on the export of primary commodities, and made more difficult the development of an independent industrial policy.

Niger provides 5 percent of the world's uranium and has helped to sustain France's nuclear energy sector. Reports have suggested that the West African nation's new government plans to ban exports of the mineral to France, a move whose significance is easy to overstate amidst the ensuing chaos. However, in the short or medium term, this shift, were it to take place, would not put significant constraints on France's access to uranium. Australia, Canada, and Kazakhstan are three of the four largest producers of the mineral and each of these countries plans to increase its output to global markets. France and the West's concerns over the fall of Niger cannot, therefore, be easily attributed to anxieties about resource scarcity.

More significant in understanding the geopolitics of the region is the role that the West has played in guaranteeing the security of nations in the Sahel without the state capacity to do so themselves. Governments in the Sahel have often invited France in to assist or bolster security measures in vast swaths of the country where the growing presence of jihadist movements threaten the stability of the central government. French security in exchange for CFA loyalty is the tacit geopolitical agreement here, but the former colonial power has long failed to uphold its side of the bargain and quell the unrest in the remote regions of the Sahel. As a result,  $governments\,fall\,to\,coups, and\,French\,troops\,are\,forced$ to withdraw, as they did in Mali and Burkina Faso.

New DelhiThe third and final meeting of G20 Anti-Corruption Working Group (ACWG) under India's Presidency will be held from 9 to 11 August 2023 in Kolkata. Over 154 delegates from G20 Members, 10 invitee countries, and various international organizations will be attending the meeting. It will be followed by the G20 Anti-Corruption Ministerial Meeting on 12th August 2023, which will be chaired by Dr. Jitendra Singh, Minister of State (Independent charge) for Ministry of Science and Technology, Minister of State for the Prime Minister's Office, the Ministry of Personnel, Public Grievances and Pensions, the Department of Atomic Energy and the Department of Space of Government of India. This will be the second ever Ministerial meeting of G20 ACWG and the first in-person ACWG Ministerial meeting. The deliberations at the level of Ministers will impart a further political impetus to combatting corruption as ACWG plays a crucial role in leading international efforts to combat corruption.

Under India's G20 presidency, ACWG has been able to achieve significant progress on anti-corruption cooperation regarding action against fugitive economic offenders and return of assets, guided by the Nine Point Agenda for Action Against Fugitive Economic Offences and Asset Recovery, presented by Honourable Prime Minister



Shri Narendra Modi to G20 nations in 2018. During the 1st and 2nd ACWG meetings held in Gurugram and Rishikesh respectively, India was able to forge a consensus in G20 to advance international anti-corruption agenda by finalizing three outcome documents (High Level Principles) on important and sensitive issues.

These pragmatic and action-oriented highest-level commitments will contribute towards prevention, detection, investigation, and prosecution of corruption offences, strengthening domestic anti-corruptioninstitutional frameworks, extradition of fugitive economic offenders and recovery of assets of such offenders from foreign jurisdictions.The High-Level Principles on Promoting Integrity and Effectiveness of

Public Bodies and Authorities Responsible for Preventing and Combatting Corruption will provide a guiding framework for strengthening the independence, transparency, and accountability of anti-corruption institutions. It will help in addressing root cause of corruption including institutional weakness and lack of accountability.

The High-Level Principles on Strengthening Asset Recovery Mechanisms for  $combatting \, Corruption \, are \, a \, set \, of \, guiding \,$ principles to support establishment of a robust and effective framework for the expeditious recovery of proceeds of crime. These principles will deter economic offenders who seek refuge in foreign jurisdictions.The High-Level Principles on Strengthening Law Enforcement related

International Cooperation and Information Sharing for Combatting Corruption is a 6-point plan to enhance inter-agency cooperation and international cooperation through information sharing amongst law enforcement agencies and countries. It will ensure timely and effective action against corruption offences, prosecution of offenders and recovery of proceeds of crimes.

ACWG is also focusing on the role of audit institutions in tackling corruption. Earlier, in the year, side events were also organized to highlight the use of Information and Communication Technologies (ICT) in reducing corruption in public administration and delivery of public services and gender related issues of corruption. The discussion on impact of corruption on women initiated under India's presidency will generate further concrete action towards collective initiatives for adopting gender-sensitive and gender-responsive approaches in anti-corruption strategies.

The 3rd ACWG meeting in Kolkata will give direction to the future work of ACWG and further the commitments made on law enforcement cooperation, strengthening asset recovery mechanisms, and enhancing integrity and effectiveness of anti-corruption authorities during India's G20 presidency. The meeting will also enable exchange of valuable insights and best practices related to combating corruption across different sectors by G20 members, invitee countries and international organizations (IOs).

# Heat threatens millions of children across South Asia: Unicef

ISLAMABAD: South Asia has the highest percentage of children exposed to extreme high temperatures, compared to all other regions, according to a Unicef analysis released on Monday.

Unicef estimates that 76 per cent of children under-18 in South Asia – 460 million – are exposed to extreme high temperatures where 83 or more days in a year exceed 35 degree celsius. This means that 3 in 4 children in South Asia are already exposed to extreme high temperature compared to only 1 in 3 children (32pc) globally. The analysis is of 2020 data, the latest available.

In addition, the data also show that 28 pc of children across South Asia are exposed to 4.5 or more heatwaves per year, compared to 24pc globally. In parts of Pakistan's southern Sindh province, including Jacobabad, the world's hottest city in 2022, temperatures were in their 40s in June, exposing 1.8 million people to severe shortand long-term health risks. The scorching heat came less than one year after the devastating floods which left most parts of southern Sindh underwater in August 2022. More than 800,000 children in floodaffected areas were at risk of severe heat stress in June 2023.

July was the hottest month ever recorded globally, raising further concerns about a future where children, including those living in South Asia, are expected to face



more frequent and severe heatwaves, largely due to climate change.

"With the world at global boiling, the data clearly show that the lives and wellbeing of millions of children across South Asia are increasingly threatened by heatwaves and high temperatures. Countries in the region are not the hottest in the world right now, but the heat here brings lifethreatening risks for millions of vulnerable children," said Sanjay Wijesekera, Unicef Regional Director for South Asia.

"We are particularly concerned about babies, toddlers, malnourished children and pregnant women as they are most vulnerable to heat strokes and other serious effects." According to Unicef's 2021 Children's Climate Risk Index (CCRI), children in Afghanistan, Bangladesh, India, Maldives, and Pakistan are at 'extremely high risk' of the impacts of climate change.

Heat threatens children

Even in the rainy season, the heat can exacerbate the situation for children. Since children cannot adapt quickly to temperature changes, they are not able to remove excess heat from their bodies.

This can cause symptoms and illnesses such as higher body temperature, rapid heartbeat, cramps, severe headache, confusion, organ failure, dehydration, fainting, and coma, in young children; poor mental development in infants; and developmental setbacks such as neurological dysfunction and cardiovascular diseases.

Early contractions, hypertension, seizures, high blood pressure, preterm births, and stillbirths are risks for pregnant women, who are particularly susceptible to heat. For young children, ice packs, fans, or misting with water can help lower their body temperature, while cold water immersion can help older children.

Front-line workers, families, and caregivers should recognise the symptoms of heat stress symptoms immediately, especially signs of heat stroke, and help take affected people to a health facility.

Ultimately, the most vulnerable children, adolescents, and women are the ones that pay the highest price for extreme weather

'Young children simply cannot handle the heat," added Mr. Wijesekera. "Unless we act now, these children will continue to bear the brunt of more frequent and more severe heatwaves in the coming years, for no fault of theirs." In Rakhine State's Mrauk U township, some 1,209 people have been evacuated to safe places such as monasteries and relatives' houses due to heavy rainfall between Aug 1 and Aug 7, the department said on Monday, adding in Mrauk U township, flood victims included 596 males and 613 females from 246 house-

Buthidaung town and Minbya township of Rakhine State also evacuated the residents from flood-hit areas, the state-run television channel MRTV reported on Monday.

On Monday, The Myanmar's Meteorology and Hydrology Department warned of flood risks, saying that river levels in several townships are approaching or already exceeding their danger marks.

### Over half million houses left without power due to bad weather on US East Coast

Washington, Aug 8 (UNI) Over 500,000 homes across the east of the United States have been left without power due to bad weather, according to data from PowerOutage.us monitoring service.

### NZ, BlackRock join hands to back 100 pc renewable electricity

Wellington, Aug 8 (UNI) The New Zealand government and BlackRock announced on Tuesday to work together on the first of its kind climate infrastructure fund to make the country one of the first in the world to reach 100 percent renewable electricity.

The 2 billion NZ dollar (1.22 billion U.S. dollar) fund will accelerate green energy options like solar, wind, green hydrogen and battery storage to fuel a low emissions economy, New Zealand Prime Minister Chris Hipkins said in Auckland.

The net zero fund will provide access to greater pools of capital for New Zealand businesses, supporting the creation of highly skilled local jobs, Hipkins said.

"This fund is a massive opportunity for New Zealand innovators to develop and grow companies," he said.

The government has worked with BlackRock, one of the world's largest investors in climate infrastructure and clean technology, to deliver a fully renewable electricity system, the prime minster said.

Energy and Resources Minister Megan Woods cited Cyclone Gabrielle and the Auckland floods earlier this year as reminders for the urgency to speed up climate actions, saying the fund will super charge investments in clean technology.

"With countries around the world experiencing the impacts of climate change on a daily basis, it's never been more urgent to invest in technology that will help address the climate crisis," Woods said.

Investors in the green economy can see New Zealand's potential and recognize its climate commitments and goals, such as the banning of further offshore oil and gas exploration, she said. ### Israeli finance minister suspends funds to Arab towns, East Jerusalem

Israeli Finance Minister Bezalel Smotrich has frozen funds for Arab towns and Palestinian education programmes in East Jerusalem, citing crime and safety fears and prompting accusations of racism.

Smotrich, a key member of Prime Minister Benjamin Netanyahu's nationalistreligious government, said on Monday some of the budget funds meant for Arab local councils were a political pay-off by the previous cabinet that could end up in the hands of "criminals and terrorists".

"The priorities of our national government ... are different from those of the previous leftist government and we should not apologise for that," said Smotrich, head of the pro-settler Religious Zionism party whose past comments about the Palestinians have drawn international condemna-

Israel's public broadcaster Kan first reported the freeze on Sunday when it published a letter from Interior Minister Moshe Arbel



to Smotrich, urging him to release 200 million shekels (\$54m) of the funds at stake that are intended for administration and another 100m for economic development.

Lawmaker Mansour Abbas, who heads the United Arab List, accused Smotrich of racism.

"Arab citizens are entitled to those funds, which were meant to close the gaps between Arab and Jewish communities," he told Reuters.

Arab citizens, most of whom are descendants of Palestinians who stayed in the new Israeli state after the 1948 war surrounding its creation, make up about a fifth of Israel's population.

Netanyahu's office did

not respond to a request for comment, while opposition leader and former prime minister Yair Lapid also accused Smotrich of racism, "abusing Arab citizens simply because they are Arab".

Israel's Arab minority has for decades faced social and economic disparities compared with Jewish citizens, including high poverty rates, overcrowded towns lacking in infrastructure and poorly-funded schools.

# Russian strikes on east Ukraine residential building kill at least 7

Rescue workers combed through the rubble of damaged buildings in the city of Pokrovsk in eastern Ukraine on Tuesday, the day after Russian strikes killed at least seven people.

Pokrovsk sits just 50 kilometres from the eastern frontline, where Moscow says it is gaining ground and repelling Ukrainian attacks.

Two missiles — launched 40 minutes apart - damaged residential buildings, a hotel, catering establishments, shops and administrative buildings on Monday, Pavlo Kyrylenko, head of the Donetsk region's military administration

AFP correspondents on the ground saw rescuers



evacuating survivors from the rubble of a five-storey building, and carrying the wounded into ambulances.

Seven people died and 67 were wounded, including two children, according to Igor Klymenko, Ukraine's minister of internal affairs.

Those killed included a high-ranking emergency official of the Donetsk region, Klymenko said.

"We are resuming the demolition of rubble," he said on early Tuesday after the rescuers "were forced to suspend work for the night due to the high threat

of repeated shelling". President Volodymyr Zelensky said on Monday that Moscow had struck a residential building, and shared a video on social media of civilians helping

wounded people and rescuers clearing rubble from a building that had lost its top

The footage also showed a second building that appeared heavily damaged. The city had a pre-war population of around 60,000 people.

Also on Monday, Russia said it had recently advanced three kilometres towards Kupiansk in northeastern Ukraine around 150km north of Pokrovsk and a few dozen kilometres from the Russian border.

### Two more US warships enter Red Sea

DUBAI: More than 3,000 United States military personnel have arrived in the Red Sea aboard two warships as part of a 'beefed up response' from Washington after tanker seizures by Iran, the US Navy said on Monday.

The deployment adds to a growing US military buildup in tense Gulf waterways vital to the global oil trade and led Tehran on Monday to accuse the US of 'inflaming regional instability'.

The US sailors and Marines entered the Red Sea on Sunday after transiting through the Suez Canal in a preannounced deployment, the US Navy's Fifth Fleet said.

They arrived on board the USS Bataan — an amphibious assault ship which can carry fixed-wing and rotary aircraft as well as landing craft — and USS Carter Hall warships — a dock landing ship, transports Marines, their gear, and lands them ashore - providing "greater flexibility and maritime capability" to the Fifth Fleet.

Tehran accuses Washington of fuelling instability in

However, Iran's foreign ministry spokesman Nasser Kanani told a presser on Monday that US deployments were only serving Washington's interests.

# Is it safe to store food in plastic containers?

You must avoid using plastic containers that are old, scratched, or damaged as they may have a higher risk of leaching chemicals into food, according to Dr Praveen Jha, gastroenterologist at Lucknow's Regency Superspeciality Hospital

ur mothers love their stash of plastic dibbas (boxes). God, forbid you lose even a single of them, nobody would be able to save you from their wrath. But as much as they love them, is it even safe to consume the food stored in these plastic containers?

According to Dr Praveen Jha, gastroenterologist at Lucknow's Regency Superspeciality Hospital, the safety of storing food in plastic containers depends on the type of plastic and its intended use. "Some plastics may release harmful chemicals when they come into contact with food, especially if they are heated or used for acidic or fatty foods," he explains.

#### What are plastic food containers made of?

A common type of plastic that is used in plastic containers is PETE, fully known as polyethylene terephthalate, which is generally considered safe for single-use applications but not suitable for repeated use or heating.

Dr Jha recommends checking if the plastic is labeled as food-safe before using it.



#### What kind of plastic containers should be avoided? What are their alternatives?

While storing food in plastic containers may be common, the major issue against using them is the leaching of substances from the plastic into the food. Hence, foods

that are hot, oily and acidic in nature must never be stored in plastic containers as they will encourage the migration of chemicals into them. You must avoid using plastic containers that are old, scratched, or damaged as they may have a higher risk of leaching chemicals into food, according to Dr Jha. Some alternatives that can instead be used in storing food are containers made

of glass, stainless steel, silicone, beeswax, and bamboo, among others, as they're all made of non-toxic materials best for the storage of food.

#### What are some tips to keep in mind while storing food in plastic containers?

\*Look for plastic containers labeled as "food-grade" or "BPA-free." BPA (bisphenol A) is a chemical that has been linked to potential health risks.

\*Avoid microwaving plastic containers as heat can accelerate the release of chemicals from plastic.

\*Inspect plastic containers for cracks, scratches, or warping. Damaged containers are more prone to leaching chemicals and should be replaced.

\*Follow manufacturer instructions as different plastic containers have varying guidelines for safe use, including temperature limits and dishwasher compat-

\*Use plastic containers for short-term storage, such as leftovers that will be consumed within a day or two.

### Women Over 70 Are Commonly Overdiagnosed with Breast Cancer

new report indicates that the overdiagnosis of breast cancer in older women is quite common. Overdiagnosed cancers are those that will not cause a problem during the patient's lifetime.

Overdiagnosis is a problem because it leads to unneeded treatments. It also creates unnecessary psychological distress for women. It is important for women to discuss the pros and cons of screening with their doctor.

A new study published in the Annals of Internal Medicine reports that the overdiagnosis of breast cancer in older women is quite common among those who are diagnosed. According to Cancer Research UK, the term "overdiagnosis" refers to cancer that would most likely not have caused any symptoms during the remainder of the person's lifetime; and, if that person had never been screened, they would never have become aware that they

Overdiagnosis is a problem, the organization explains, because it causes people to go through arduous treatments and the accompanying emotional distress unnecessarily.In fact, the study found that among a population of over 50,000 women, continued breast cancer screening after the age of 70 was linked to a greater incidence of cancer that would not have caused symptoms in the person's/patient's lifetime.

False positives, in contrast with overdiagnosis, occur when people are thought to be at higher risk for cancer when actually their risk is normal.

#### **Breast cancer overdiagnosis is common** for women over 70

The researchers studied a group including 54,635 women who were aged 70 and older. All participants had been screened for breast cancer in the recent past.



Upon analysis of the data, they found that the risk for overdiagnosis grew as women got older.

Among women aged 70 to 74, they estimated that 31% of breast cancer was overdiagnosed.

Between the ages of 74 to 84, this figure rose to 47%. And, in those aged 85 and older, it rose even further to 54%. However, the researchers said, they did not see meaningful reductions in deaths from breast cancer as a result of these screenings.

They state that the possibility of overdiagnosis should be factored in when deciding whether to screen older women and balanced with any potential benefits to be

Dr. Ilana Richman, the lead author of the study, noted, however, that only about 2% of older women who continued to receive screening for breast cancer will be overdiagnosed.

"So if women continue screening, overdiagnosis is actually not incredibly common overall," she stated.

However, among those who do end up being diagnosed, between 31% and 63% may be overdiagnosed, depending on their age and how long they live.

"So among women who are screened and diagnosed with breast cancer, overdiagnosis is pretty common," said

#### What are the risks associated with overdiagnosis?

Christine Kingsley, an Advanced Practice Registered Nurse (APRN) and the Health and Wellness Director of the Lung Institute, said that overdiagnosis is "incredibly harmful to a patient."

She noted that there are behavioral and psychological

impacts for the person receiving this label. Additionally, it leads to all of the burdens of overtreat-

ment, she said. "Exposing a patient to unnecessary treatments and therapies is often dangerous and there's no benefit to it. In the case of breast cancer overdiagnosis, the benefits don't necessarily outweigh the risks, as the treatment

will always be tailored to the intensity of the cancer." Kingsley explained that when a tumor is found that appears to be high risk, this triggers a particular path of treatment, including biopsies, surgeries, chemotherapy,

and radiation. "These things can be especially harmful if said tumor isn't supposed to be deadly and progressive," said King-

"Invasive treatments, especially, can be risky and can lead to financial and psychological distress," she concluded.

Telephone-based CBT **Appears Promising** Mental health, psychiatric disorders, and obesity are all closely intertwined. Doctors have, therefore, taken the prudent step of researching how counsel-

ing can improve quality of life, mental health, and eating disorders for those who have undergone bariatric surgery. In a new study, published

August 3 in JAMATrusted Source, researchers looked at how effective CBT administered by telephone one year after bariatric weight loss surgery was on weight loss, disordered eating, and psychological distress. The researcher's primary objective was to identify if CBT was associated with a higher percentage of total weight loss compared to a control group.

The researchers found that the CBT group did not see a high percentage of weight loss.

But they did find positive benefits of getting the therapy.

The study found that CBT was helpful in improving two other outcomes: disordered eating and mental distress. There's also an additional silver lining to the study: highlighting the effectiveness of telephonebased counseling.

"This study is significant as it is the largest randomized controlled trial examining the effectiveness of CBT on disordered eating, psychological distress and weight loss after bariatric surgery. The results showed significant improvements in eating behaviors and reductions in anxiety and depressive symptoms after bariatric surgery," Dr. Sanjeev Sockalingam, a Professor of Psychiatry at the University of Toronto, Director of Obesity Canada,

found that how people feel about their sleep has a greater impact on their well-being than what sleep-tracking technology says about their sleep qual-

Over two weeks, 100 participants aged 18 to 22 years kept a sleep diary, documenting what time they went to bed and got ready to fall asleep, how long it took them to fall asleep, what time they woke up, what time they got out of bed, and how satisfied they were with their sleep in general.

Participants were also asked to rate their positive and negative emotions and how satisfied they were with their lives the following day. Throughout the study, they also wore an actigraph on their wrist to measure their movement, sleep patterns, and rest cycles.

Researchers compared the actigraph data with the participant's perceptions of their sleep to find out how their sleep quality related to their mood and life satisfaction the next

Commenting on the findings, lead author Dr. Anita Lenneis, from the University of Warwick's Department of Psychology said, "Our results found that how young people evaluated their own sleep was con-

sistently linked with how they felt about their wellbeing and life satisfaction.

When participants reported that they slept better than they normally did, they experienced more positive emotions and had a higher sense of life satisfaction the following day.

"However, the actigraphy-derived measure of sleep quality, which is called sleep efficiency, was not associated with next day's well-being at all," Lenneis explains.

In short, the study shows that your perception of sleep quality matters more for mood and well-being than what your sleep devices sav.

# Harmanpreet Kaur calls for more women's Tests

India's captain also wants red-ball matches to return to domestic cricket

NEW DELHI: India captain Harmanpreet Kaur has called for more women's Tests as well as a resumption of long-duration domestic cricket in India. Harmanpreet, 34, is broadly representative of the top-level women's cricketer of her time in how many games she's played in each of the three formats: only three Test matches to go with 127 ODIs and 154 T20Is.

India are scheduled to play only two Test matches in the 2022-25 women's Future Tours Programme (FTP) cycle, both at home in the 2023-24 season, against England and Australia. Only four teams will play Test cricket during this cycle, with India playing the fewest behind England (five), Australia (four) and South Africa (three).

"As a player, I definitely want more Tests because as a growing kid, we saw more Tests on TV than T20s," Harmanpreet said while interviewed on the Sky Sports Cricket Podcast. "Nowadays it's a lot of fun playing T20s but Test cricket is something every cricketer wants to play.

"This year we have two Tests one against England and one against Australia - and I hope those games can make a huge impact on women's cricket and hopefully in the future we will keep getting more Test matches. We have to bring back Test matches in women's cricket because it's very important for



women's cricket."

The last time there was multiday domestic women's cricket in India was in 2017-18, when the BCCI conducted an inter-zonal three-day tournament as well as an inter-zonal Under-19 two-day tournament. While Harmanpreet is happy with how far domestic women's cricket has come since her early years, particularly with the start of the Women's Premier League (WPL), she hopes longduration cricket will resume soon.

"Trust me, [domestic cricket] has improved a lot," she said. "Initially when I started playing, we hardly got domestic games but for the last couple of years, domestic level has improved a lot. We are getting more games and some domestic games are live also,

people can watch on TV. "It is improving day by day but in my early days we used to play two- and three-day games which we are really missing, and I'm sure after these two Test matches

hopefully we'll get two-day matches back. The more cricket we get, the more improvement we'll see in women's cricket.

"Definitely it's improving day by day and [I] hope to see some more talent in the Indian side. As you mentioned WPL was a gamechanging moment for us, the tournament was so good, everyone loved it back home, we had a great experience and hopefully next year we'll get some more young talent who can take this cricket higher."

After years of players voicing their desire for a women's franchise T20 tournament along the lines of the IPL, the WPL got underway in 2023, with the Harmanpreet-led Mumbai Indians winning the title.

"Yes definitely it's a little late, to be honest, but something is better than nothing," Harmanpreet said, when asked if it had taken too long for the WPL to get off the ground. "At least it started and started in such a way that everyone liked it. Maybe we were a little scared, [wondering] what if people won't like it, but the response we got for WPL, some of the audience, they were more interested in women's IPL than men's because it was something new to watch and they really liked it. Hopefully, after some years, we'll add more teams, more players."

Crawley's opportunities in white-ball cricket have been sporadic since his Test call-up in 2019. His three England ODI caps to date came two years ago, as part of the




second-string team that whitewashed Pakistan, and he is yet to make an appear-
