# Drug Menace A Major Challenge Ahead: DGP Dilbagh Singh

**SRINAGAR, AUG 11:** Director General of Police, I&K, Dilbag Singh Friday remarked the militancy was at its last stage as there is lowest number of militants as of now even as the drug menace remained a challenge for the law-enforcement agencies to tackle. The top cop made the remarks on his visit to frontier north Kashmir's Kupwara district.

Talking to media on the sidelines of 'Meri Matti Mera Desh' event, DGP Dilbag Singh said that Jammu and Kashmir is moving towards peace and

# For First Time, Marrying A Woman **After Concealing Identity To Be Crime Under Proposed Law: Amit Shah**



NEW DELHI, AUG 11: Marrying a woman by concealing identity or having intercourse under false promise of marriage, promotion and employment will be treated as crime for the first time under the proposed law that will replace the colonial-era Indian Penal Code, Home Minister Amit Shah said

Introducing the Bharatiya Nyaya Sanhita (BNS) Bill, which will replace the IPC of 1860, Shah said a special focus has been given to provisions related to crimes against women.

"Crime against women and many social problems faced by them have been addressed in this bill. For the first time, intercourse with women under the false promise of marriage, employment, promotion and false identity will amount to a crime," he said.

While courts have dealt with cases of women claiming rape on the basis of breach of promise of marriage, there is no specific provision for this in the IPC.



The bill, which will now be examined by a Standing Committee, states: "Whoever, by deceitful means or making by promise to marry to a woman without

any intention of fulfilling the same, and has sexual intercourse with her, such sexual intercourse not amounting to the offence of rape, shall be punished with

**NEW DELHI. AUG 11:** India and China are likely to hold the 19th round of Corps Commander Level talks on Monday at the Chushul-Moldo meeting point in the Eastern Ladakh sector to resolve the ongoing military standoff between the two countries for over three years.

imprisonment of either description for a term which may extend to ten years and shall also be liable to fine."

It further states that "deceitful means" shall include the false promise of employment or promotion, inducement or "marrying after suppressing iden-

Senior criminal lawyer Shilpi Jain said this provision was long overdue and due to the absence of such a provision, cases were not regarded as a crime and

were open to a lot of interpretation from both sides. While some saw the specific provision about "marrying after suppressing identity" being targeted at cases of interfaith marriages under false

names, Jain said that would be open to interpretation. The key point here is that consent of the victim taken under false pretence cannot be termed voluntary, she said.

"Women are being exploited in our country by men who have sex with them after promising them marriage and it's an offence if men at the time of making the promise had no intention to marry," she

Jain, however, said that clubbing false promise of marriage with promise of employment or promotion in this provision may not be the right way to go

"Promise to marry cannot be equated with promise of employment/promotion because promise of marriage is based on love, trust, while promise of employment/promotion are benefits which women are accepting in return for sex. It's a relationship of mutual benefit.

"When a woman knows what she is getting into – that is sex for employment or promotion – then it is not under deceitful or false promise," she says.

The proposed bill has also made the crime of voyeurism gender neutral with a punishment of three to seven years.

Shah also said the changes were brought in to provide speedy justice and create a legal system that keeps contemporary needs and aspirations of the people.

 $\hbox{``In all cases of gang rape, there will be punishment}\\$ of 20 years to life imprisonment. In case of rape of girls less than 18 years of age, the punishment will be death," he said.

The bill states that the crime of murder will invite death sentence or life imprisonment, crime of rape shall be punished with minimum 10 years of jail or imprisonment for life and gang rape will invite at least 20 years of imprisonment or imprisonment for the remainder of the convicted person's natural life. this time has woven a map of India with tricolour inscribed on a 2 x 2 cotton carpet that took him two months to complete, The wonderful creation is to be represented on the occasion of Independence Day under the "Mere Maati Mere Desh" (My Mother, My Country) initiative.

He believes that the traditional Kashmiri Carpet industry would get a boost from this patriotic gesture towards the country.

Talking to UNI Dar said, "I used to weave something unique on this occasion for the past some years to express my patriotism and love towards the country and I believe this gesture would definitely further explore the carpet industry of Kashmir valley".

The carpet is fast blue in the background and deep saffron (Kesari) at the top, white in the middle there is a navy blue wheel. The lower part is dark green. All three parts are of equal proportion, making the map of India eye-catching.

Dar has a big team of educated girls who are also working with him weaving carpets of different sizes and hues for the past many years.

Dar said that he gave the idea to the Indian Institution of Carpet Technology (IICT), Srinagar, who provided him with the computerised "Talim" of weaving the Map with the tricolour on carpet with a printout of the subject.,

Dar, who also runs "Delight Carpet Weavers" society in the area, is associated with carpet weav-

ing for the past 22 years and had 20 looms in north Kashmir's Bandipora district where about 50 young and educated girls from downtrodden families are weaving different wall hangs with zeal and zest to earn their livelihood.

Dar said he has been invited by Deputy Commissioner, Bandipore, Owais Ahmad to the Independence

Day function where this map would be showcased. Dar had previously stunned onlookers by weaving a mesmerising Kashmiri cultural painting, that earned him a huge amount after its presentation in

the "Srinagar Hunar Haat" 2021. Dar appealed to the authorities to provide special incentives to the carpet weavers especially the young poor girls for their economic uplift in the society and to give life to the age-old traditional art in Kashmir Valley.

The quote "In love of home, the love of country has its rise" appeared in Dickens's widely read novel The Old Curiosity Shop which he had serialised between 1840 and 1841. It is said it was so popular that New York readers rushed in huge numbers when the ship carrying the final instalment arrived at the port. Dar is hoping that his latest creation would do an encore.

#### BJP all set.....

#### Unable To.....

The border villager used to work as a tailor and received most of the work from security camps. The trouble started when his wife Veena Devi fell seriously ill in 2018. And when she recovered after several months of treatment in Jammu, Chand himself suffered a paralytic attack which left him bedridden.

The couple's son, their only child, works at a private factory and gets a meagre salary. With the family struggling to make ends meet, rebuilding their crumbled house is the last thing on their minds.

"We are living on the Zero Line (India-Pakistan border) and the government constructed this bunker for our safety during (cross-border) firing. Since we are going through a difficult phase, we are using it

as our home," Chand said. In December 2017, the centre sanctioned the construction of 14,460 individual and community bunkers for the border residents in the five districts of Jammu, Kathua and Samba covering the villages located along the IB and Poonch and Rajouri villages on the Line of Control (LoC).

Later, the government sanctioned over 4,000 bunkers to cover more vulnerable people.

On February 25, 2021, India and Pakistan announced the implementation of renewed ceasefire along the borders in Jammu and Kashmir, which came as a major relief to the people living along the International border and the LoC.

"We are highly distressed and need help," he said, demanding the construction of individual household toilets under the Swachh Bharat Mission and the extension of benefits under Prime Minister Awas Yojna (PMAY).

He said the elected panchayat members have forwarded their papers many times in the last four years but every time their names could not find a place in the beneficiary list.

"The government has built toilets in the homes of many people but we did not even get the benefit of this scheme. We are facing a lot of problems," he

Veena Devi said the family moved into the bunker in May 2019 otherwise they would have been on the road or living in a tent.

"Rains damaged our house as we could not repair it due to our poor financial condition. No government

scheme has reached us so far," she said. Tarsem Lal, a neighbour of Chand, said the family is the "most deserving" to get benefits of government schemes. "They can hardly afford two meals a day and cannot construct a toilet or a house. The government should come forward and help the

family," Lal, whose wife is a panch, said. Referring to the Lt Governor Manoj Sinha-led administration's approval of a proposal to allot 5 marla land each to landless families for the construction of houses under PMAY, he said they should also look into the cases of people like Chand.

When contacted, Deputy Commissioner, Samba Abhishek Sharma said he will look into the matter of why government schemes were not implemented for the benefit of the family so far.

"A team of officers will be deputed to know the status of the case. If eligible, the family will be provided with all benefits under central and UT level schemes in accordance with the laid down norms," he said. (Agencies)

This is the biggest order Umar has received in recent vears.

"My family has been doing pottery for generations and I have been doing it since childhood.

"Ahead of Independence Day, we received a bulk order for earthen lamps. I am very delighted to have received this order as it has generated a huge income for us." Umar said.

Initially, the administration had placed an order for 5,000 oil lamps but then it doubled it, he said.

"We have made more than 8,000 lamps and hopefully all lamps will be ready in the next couple of days," he added.

This "unexpected order" is what is keeping Umar's seven-member team busy these days.

Umar said pottery art is on the decline but when the oil lamps will be lit in front of the Tricolour, it will help create awareness about it and generate a demand for earthen products.

"A potter makes gold out of clay and now authorities are working to revive this craft by launching a number of schemes. In Kashmir, we do not get such big orders except for Diwali," he added.

The oil lamps will be lit on the evening of August 13 at Zabarwan Park along the banks of the famous Dal Lake here.

Showkat Ahmad Kumar, who works with Umar, said he is very happy with the order as it will lead to

more earning opportunities for them.  $Handicrafts\, Department\, Director\, Mahmood\, Shah$ said it is very important that the government extend

support to artisans. "The order given to the potters is not a one-time order. We are trying to promote local souvenirs in government events and we also want that every office should proudly display the art forms of Jammu and Kashmir. Such orders are very encouraging for the artisan community," Shah said. (Agencies)

On the occasion, Dr Mehta enjoined upon the officers to make it a practice to conduct a 'Quality Check (QC)' before declaring the villages as Model category ODF+ under SBM (G).

He called upon them to take recommendations of the concerned 'Prabhari Officers' and local Sarpanchs to declare any village as ODF+ category. He asked them that all the requisite facilities mandatory for this exercise like collection of waste, treatment of liquid waste, removing legacy waste, availability of segregation sheds besides the visual cleanliness of surroundings should be cross-checked before making this declaration.

The Chief Secretary also observed that the cleanliness is not a single day affair but demands a permanent change in the attitude of people. He made out that people should demand cleanliness and the efforts should not drop going forward even in the winter months here.

Dr Mehta appreciated the role of the Rural Sanitation Department for making it happen in a short timeframe. He said that there were times when it looked difficult to achieve this uphill task in this

timeframe but the collective efforts have made it happen which is quite admirable. He told them to sensitize people by taking

out 'Swachhta Rallies' in these concerned Panchayats this Independence Day and involve the youth and women also in these rallies. On the occasion the Commissioner Secretary,

RDD, Mandeep Kaur made out that the Department is making every effort to sustain this campaign in each village. She said that the day to day collection of waste has already been started besides the household latrines and soak pits/composit pits have been provided in each of these villages. She said that by effective enforcement the sanitation of each village is not a distant dream now.

In his presentation, the Director, Rural Sanitation, Charandeep Singh informed the meeting that with a percentage of more than 96% J&K is currently among the top three States/ UTs in the country in ODF Model rankings. He gave out that out of 6650 villages, 6399 have already achieved the status of Model category and the rest are going to achieve this status before 15th of this month as assured by each of the Deputy Commissioners of the UT.

#### National Highway.....

National Highway, particularly those carrying perishable fruit consignments.

In addition to the Principal Secretary, PWD, the meeting was attended by Principal Secretary, Forest; Principal Secretary, PDD; Divisional Commissioners; concerned Deputy Commissioners; representatives from NHAI, NHIDCL, BRO, and many other concerned officers. Speaking on the occasion, the Chief Secretary stressed upon the executing agencies to complete all these road projects providing interconnectivity to different regions in the stipulated timeframe. He enjoined upon them that the significance of these roads is very high as the UT, due to its hilly terrain, has hardly any alternative roads to link various parts.

He directed the concerned authorities to strictly stick to the timeline of completing these road projects. He made out that these projects make significant contribution towards the economic upliftment of various parts. All the officers including the Deputy Commissioners should take keen interest in seeing them completed on time.

Regarding the Jammu Ring Road project he asked the concerned Divisional Administration to take early measures for dedicating to public the completed portion of the road from Raya Morh (Samba) to Nagrota (Jammu). He also asked them to renovate the significant Tarnah Bridge at Kathua in shortest timeframe.

Regarding the Ring Road Srinagar the Chief Secretary asked the authorities to ensure that the 20 kms stretch under phase-I is dedicated to public by November this year. He told the concerned Deputy Commissioners of Pulwama and Budgam to look into the aspect of Ribbon development of this road in their areas for generating economic activities optimally.

As far as the Jammu-Akhnoor Road is concerned the Chief Secretary asked for completing it in all aspects and dedicating it for the use of general public. He made out that this road is going to play a vital role in bringing this circuit on the tourism map of J&K and increase the footfall to this location.

Dr Mehta while taking review of the Srinagar-Jammu National Highway stressed on the executing agencies to work for completing all the tunnels especially T3, T5 and other viaducts on time. He observed that the travel time has got considerably reduced on this road yet the remaining projects between the Ramban-Banihal stretch needs to be made more reliable.

The Chief Secretary reviewed the progress of the construction of four-lanning of Ramban flyover and completion of Banihal Bypass. He also took stock of the under-construction bridge at Qazigund, Railway Over-Bridge at Anantnag and Lasjan flyover. He fixed the timelines for completion of each of these Road projects and directed for not to extend these beyond the agreed timelines.

Regarding the Delhi-Katra Expressway the Chief Secretary directed for continuing the momentum of work besides meeting timelines set for completing different sub-projects. He asked them that this Road project is of national importance as it leads to the holy shrine of Shri Mata Vaishno Devi visited by millions of pilgrims every year. He said that the work on such a prestigious project should be given due priority for completing it at the earliest.

Dr Mehta also sensitized the executing agencies about the significance of Uri-Poonch Highway. He told them that the work on this project should be taken in hand at the earliest so that it is also completed on time bringing respite to people besides providing alternate route between the two divisions of the UT.

The Chief Secretary also took note of the work done on the Srinagar-Pulwama-Shopian-Kulgam Highway (NH-444). He stressed on completing the bypasses for the towns of Shopian, Kulgam and Pulwama so that the road is complete before the onset of winter. The highway is going to drastically reduce the time taken for traveling to and fro and to reach to Srinagar. City from these districts. He also took stock of the progress made in execution of Srinagar-Baramulla-Uri Highway, Chenani-Sudhmahadev-Goha- Khellani, Akhnoor-Poonch, Singhpora-Vailoo and Chatroo-Khanabal Highways and stressed on their early completion.

Dr Mehta enquired from the executing agencies about the bottlenecks affecting the pace of their work. He passed directions to the concerned government departments for taking measures to address the bottlenecks. He said

that both the executing agencies and different government departments should work in coordination with each other and hold regular deliberations for resolving issues without wasting time.

On the occasion, the Chief Secretary enjoined upon the Divisional Administration Kashmir to ensure that there are no unnecessary halts on the highways in the valley during convoy movement.

#### Hot, dry weather.....

during the next 9 days as there is no possibility of any precipitation during the period as per the forecast.

Deputy Director, MeT said that the maximum temperature would settle in between 31 and 32 degree Celsius during the period, however, thunder showers at a few places during the period cannot be ruled out.

Pertinently, J&K witnessed hot and dry weather conditions since the inception of August month.

Nonetheless, during the ongoing season from June 01-2023 to August 09, 2023, J&K has recorded a precipitation of 336.6 mm against the average rainfall of 337.3 mm.

Srinagar, the summer capital of J&K has recorded a large excess rainfall of 268.4 mm against an average precipitation of 148.9 mm, which is 80 per cent above normal.

Kishtwar is the only station where large deficient rainfall has been recorded in the ongoing season as against the normal precipitation of 265.5 mm, it has received 90.7 mm rainfall, which is 66 per cent deficient than normal.

Moreover, Shopian in Kashmir and Reasi & Poonch in Jammu division have recorded deficient rainfall of 39 per cent and 22 per cent each respectively in the ongoing season.

under the control of the Directorate. Spokesperson of the Directorate of Health Services Kashmir Dr Mir Mushtaq said that so far, 5,320 cases of 'Eye Flu' have been reported in the hospitals in the Kashmir division coming

under the DHSK's control. Giving details of the cases, he said 781 were reported from Anantnag, 15 from Bandipora, 999 from Baramulla, 351 from Budgam, 287 from Ganderbal, 164 from Kulgam, 412 from Kupwara, 924 from Pulwama, 601 from Shopian and 786 from Srinagar.

The officials said that cases are more, as the data doesn't include the cases reported in Government Medical Colleges of both divisions. Almost in every hospital, every day around 20 to 30 cases of 'Eye Flu' are being seen in OPDs.

The DHSK recently issued an advisory to control the spread of the condition where they put emphasis on maintaining optimal hygiene and frequent hand washing with soap and water for at least 20 seconds, particularly after touching the face or contaminated surfaces.

In situations where soap and water aren't available, opt for hand sanitiser containing at

least 60 percent alcohol, the advisory states. The advisory mentions, "Avoid touching the eyes to prevent germ transfer. Steer clear of infected individuals as conjunctivitis is highly contagious, refrain from sharing personal items and ensure surfaces prone to virus contact are regularly disinfected, consider wearing eye protection when in close proximity to infected individuals, employ respiratory etiquette by covering the mouth and nose when coughing

or sneezing, and dispose of tissues properly." It called for preventing eye rubbing to curb the spread of the virus. "Stay home if infected and seek guidance from a healthcare professional before resuming activities. Adhere to contact lens guidelines, replace lenses and cases regularly, and maintain cleanliness in shared environments, and avoid swimming pools to prevent further transmission," the

advisory stated. The doctors said it is a "self-limiting infection" and each individual's immunity will have a role to play in the course of the disease.

The monsoon's humid and damp conditions provide an ideal breeding ground for viruses or bacteria responsible for these infections to spread rapidly, they said. "This flu can infect any person of any age group and to stop the spread of the infection; touching of eyes should be avoided, especially unwashed hands," they added. They said that symptoms of this flu are watery discharge in the eyes, redness, congestion, photophobia and hemorrhages in the

superficial layer of the eye. In most cases, eye flu is not dangerous and can be easily treated with proper care, the doctors said, adding that there are over-thecounter available eye drops and anti-bacterial medications that can be taken with appropri-

ate dosage for eye flu treatment. However, if left untreated, severe cases of bacterial conjunctivitis may lead to complica-

Aspirants urges LG Sinha to intervene

**SRINAGAR**, **AUG 11**: The to be held on 9th and 10th Sep-National Board of Examinations in Medical Sciences has said required standards of security aren't being met at Srinagar to hold NEET-SS examination.

The National Medical organisation (NMO) had written to NBE demanding NEET-SS examination centre in Kashmir.

While responding to the letter of NMO, the National Board of Examinations (NBE) has said that the required standards of security aren't being met at the centres available in Srinagar to hold examinations.

"I have got the matter examined with the concerned department. It is for your kind information that NEET Super Specialty Entrance Examination is a highstake examination conducted by the National Board of Examinations in Medical Sciences on a pan India basis. For the examination

tember 2023, NBEMS has identified examination centers in 36 cities across the country.

"Consideration of a test city for holding an examination depends upon a multitude of factors including but not limited to the availability of secure test centres to hold a particular examination. The audit of available test centers in the city of Srinagar has revealed that the required standards of security are not met at the centres available to hold the examination as on date. Accordingly, Srinagar has not been considered as a test city for conduct of the said examination." read the letter of NBE to NMO, a copy of which lies with news agency-Kashmir News Observer (KNO).

The NEET-SS 2023 will be conducted in Jammu city and candidates of J&K can write their exams



"It is not feasible to conduct the examination compromising any standards of security applicable. No test centre was offered in the city of Srinagar in the last NEET-

SS as well, held on 1st and 2nd

September 2022," it added. Aspirants have questioned that if required standards of security are being met for conducting NEET-PG and UPSC examinations then why not for NEET-SS.

Dr Rubeena Bhat incharge of the resident doctors association of SKIMS Srinagar told KNO that National Board of Examination (NBE) authorities are saying that due to security reasons they are not keeping the centre at Srinagar.

"If the standard for UPSC cen-

tre at Srinagar is acceptable then why not for NEET-SS," she asked.

Several candidates who have to appear in the examination told KNO that they will have to spend more than Rs 20,000 per head and at least three to four days of travel to other states to appear in the examination.

"We aren't against setting up examination centre in Jammu but there is a need for such centres in Kashmir as well where there are hundreds of candidates," they

"In case no examination centre was being established in Kashmir, we will have to bear the financial strain of flight tickets, and hotel accommodations besides uncertainty due to the frequent closures on the highway."

The upset candidates have already written to LG Manoj Sinha to intervene at the earliest so that they won't have to suffer.

## Lack of basic facilities hampers tourism potential of Yousmarg

Work underway for installation of mobile tower, says CEO

**SRINAGAR, AUG 11:** At a time when the Jammu and Kashmir government's tourism department is putting emphasis on the promotion of tourism destinations in Kashmir, locals, and tourists have rued lack of basic facilities at Yousmarg in Budgam.

Locals and tourists told news agency-Kashmir News Observer (KNO) that there is no immediate health facility, ATM service and mobile connectivity in at the place.

"The place often remains cut off from the rest of the valley as the area witnesses heavy snowfall during the winters. But with the arrival of summers visitors start thronging the place but due to the least minimum facilities majority of the people prefer not to come to this place", said Rayees Ahmad, local.

A visitor who had come from Maharashtra said that although they were fascinated by the beauty, they could not go horse riding because they were not carrying cash.

"We prefer online payment but upon reaching here we found that there was no mobile connectivity and no ATM where we could withdraw money. One remains cut off from the rest of the world", he

Another local Abdul Gani said that the place lacks health facilities causing immense hardships to both locals as well as visitors in case of medical emergency.

Chief Executive Officer (CEO) of Yousmarg Development Authority Bilal Khursheed told KNO that they have already taken up these issues with the district administration and that the work on the installation of the mobile tower by BSNL is going on.

With mobile network connectivity, ATM facilities too will come up in the area, he added.

"The developmental part is an ongoing process, and we are hopeful of witnessing these facilities soon," he said.

# Walking 4,000 steps a day lowers your risk of dying: DAK

**SRINAGAR, AUG 11:** Doctors Association Kashmir (DAK) on Friday said walking fewer steps a day significantly reduces a person's risk of early death.

"If you walk just 4,000 steps a day, you can substantially lower your risk of dying," said DAK President Dr Nisar ul Hassan in a statement issued to the news agency— Kashmir News Observer (KNO).

Dr Hassan said according to a large study published in European Journal of Preventive Cardiology on Wednesday walking

3,967 steps a day reduces the risk of death from any cause, while taking 2,337 steps a day can significantly decrease the risk of dying from cardiovascular disease.

For every additional 1000 steps a day, the risk of dying from any cause falls by 15%, while a 500 extra steps leads to a 7 per cent drop in the risk of death from cardiovascular disease.

"That shows the more you walk, the greater the health benefits," he said.

Dr Hassan said researchers of the study found that adults 60 and older who walked between 6,000 and 10,000 steps a day saw a 42% reduction in risk of early

death, while people under 60 who walked between 7,000 and 13,000 steps a day had a 49% reduction in risk.

"This gives us to understand that health benefits are more if we start early," he said. The DAK President said for years, it has been unclear how many minimum steps

we should thrive for to start seeing health

"Studies on walking are many, but this one for the first time sets a prescription dose for lifestyle correction," he said.

Dr Nisar said the study recommendation suits our population. Most Kashmiris are not up to extreme physical exercises. These fewer steps are doable for all.

He said the message of the study is loud and clear. Walk more and sit less. Physical activity is good for health and



a sedentary lifestyle invites a huge lot of

health issues.

"As per World Health Organization (WHO)data, insufficient physical activity is the fourth most frequent cause of death in the world, with 3.2 million deaths a year related to physical inactivity," he added.

# Family accuses Bandipora DH of negligence, say pregnant woman asked to wait for 10 days

BANDIPORA, AUG 11: Accusing Bandipora District Hospital, a family from the remote village of Chandeji in north Kashmir's Bandipora district Friday claimed that after being told her delivery was ten days away by a doctor, a pregnant woman returned home only to give birth to her baby at home soon after.

"My wife endured excruciating labor pain yesterday, and we rushed her to the hospital. However, a female doc-

tor, after a brief examination, recommended that we return home, suggesting that her delivery was scheduled for ten days later," Afraaz Ahmad Khan, the husband of the woman told the news agency-Kashmir News Observer (KNO).

He further said that despite his wife's intense suffering, they remained at the hospital, but the doctor became agitated and instructed them to depart.

"After making transportation arrangements, we headed home

amidst a state of confusion, given my wife's intense suffering," he recounted. He added that while en route, his wife unexpectedly gave birth late last night, leaving all of them utterly stunned.

"Thankfully my wife and child are safe. However, we believe the doctor at the hospital was in a rush and didn't thoroughly examine my wife. If anything unfortunate had occurred, we would have held the same lady doctor responsible,"

Continuing, he mentioned another unfortunate incident from this morning when we went to the hospital for the baby's vaccination, where, upon informing the doctor about my wife's unexpected delivery, she became angry, shredded the documents, and accused us of leaving the hospital without her consent, which was quite absurd.

The family called for decisive action



against the said doctor, stating that her behavior towards them was entirely unacceptable. They also expressed concerns that if such treatment of patients persists, it won't be long before a tragedy occurs.

Meanwhile, an official stated that the hospital administration has received a formal complaint from her husband, prompting the formation of an inquiry committee to establish the truth, and those found responsible will face strin-

Women's participation has substantially gone down in single digit in central government and CPSE jobs.

Centre has not been providing latest data on women employed in central government jobs is therefore understandable. The latest Census of Central Government Employees was brought out in April 2014 for the year ending March 31, 2011. Narendra Modi, as prime ministerial candidate had been promising 'jobs with dignity for all' which meant 2 crore jobs every year, but after he became prime minister of the country, even central government jobs started declining.


About 30.87 lakh employees were there in 2011 in the Central government, as per the Census of Central Government Employees, said the Minister of State in the Ministry of Labour and Employment in the year 2020 in Rajya Sabha, out of that as low as 10.93 per cent were women. It showed how the government was afraid of providing the latest number.

Just before general election 2019, Modi government had tabled interim budget 2019-20 in which it said that the estimated number for central government employees was over 36.15 lakh as on March 1,2019, and showed a 12 per cent increase over March, 2017. Then the BJP came with a manifesto to formulate roadmap to increase women employees in government.

However, the total number of employees had declined as of March 1, 2022 to 31.69 lakh as per the budget papers of 2023-24 under heading "Estimated Strength of Establishment and Provisions". It has however estimated that central government employment was expected to rise over 34.45 lakh as of March 1, 2023 and then to 35.55 lakh as of March, 2024. Between the general election of 2019 and 2024, central government employees would be declining by at least 60,000. Share of women in central government would also decline with it even at faster rate.

It would be despite the fact that there were 40.35 lakh sanctioned posts but only 30.55 lakhs persons were in position as on March 1, 2021, according to Expenditure Department's Annual Report on Pay & Allowanced of Central Government Civilian Employees. Over 9.79 lakhs posts were vacant, implying one in every 4 posts were vacant. Now when elections are coming to close, PM Modi has been distributing jobs in employment fairs, to appear to be concerned for increasing employment, just contrary to the real

employment situation in the central government. Employment fairs are being held across the coun-



try, and the new appointees are being not only inducted into the central ministries, departments, autonomous bodies, but also in Central Public Sector Undertakings. The target announced is that the government intends to provide 10 lakh jobs over a year. It means that all the new appointments are not being done for the central government where the vacancies were 9.79 lakhs.

Many of the appointees are being sent to CPSEs, but employment in CPSEs have also been declining in the last decade. On March 31, 2013, there were 17.3 lakh employees in CPSEs, but on March 31, 2022, only 14.6 lakhs employees were there. It means, 2.7 lakh employments were just vanished. The quality of employment has also substantially declined in the meantime. The share of casual and contract workers has more than doubled and rose from 19 per cent in 2013 to 42.5 per cent in 2022. In the meantime, the number of casual and daily workers rose from 40,000 to 1 lakh, and contract workers from 2.9 lakh to 5.2 lakhs.

Women's employment position is far worse. In 2021-22, women constituted 9.1 per cent of total employees in CPSEs. The number decreased to 76,678 in 2021-22 from 80,525 in 2020-21.

The Seventh Central Pay Commission report was accepted by the Central government in 2016, and the Centre had said that the recommendation would apply to 33 lakh central government employees. The number of central government employees were estimated to

only 8.5 per cent of the organised workforce of the country providing quality decent jobs with social secu $rity\,provision.\,It\,means\,within\,six\,years\,by\,2021, central$ government shed about 3 lakh jobs.

All these show the huge gender gap in the central government and CPSE jobs, where women's share in employment is less even less than 10 per cent. However, in the entire labour market the Labour Force Participation Rate (LFPR) for women in urban areas in Current Weekly Status (CWS) was 18 per cent in the last quarter of 2022-23 that ended on March 31, 2023. Worker Population Ratio (WPR) for women was just 16.4 per cent. It is against LFPR of 47 per cent globally. LFPR as per PLFS for July 2021 – June 2022 was 27.2 per cent and WPR at 25.6 per cent.

Female labour force participation has been declining since 1999-2000 in India, when it was 34.1 per cent which came down to 27.2 per cent in 2011-12, and worsened to 18 per cent in during January – March 2023.

These show that the promises made by the PM Modi and his party for women empowerment and increasing their share in employment are just hollow. Majority of women workforce are in low quality private jobs. If the Centre can't give women their share in central government and CPSEs jobs, how can it expect the labour market to increase women's

# **Smriti Ravindra's First Novel Is A Gripping Account Of Churning In A Nepali Society**

The Author Tells A Personal Story Covering Both India And Kathmundu

he woman who climbed trees opens with a wedding. Meena 14, stands on a terrace in Dharbhanga eating roasted peanuts when she is told about 21-year-old Manmohan, her future husband. He is first in his family from Nepal to study in India. Her mother, Keveri, claims he is a "prize" and a "project Man-

But Manmohan is no Manju: instead, he dreams of finding his place in Kathmandu and leaves his wife with her dour mother-in-law Sawari Devi in Sabaila.

Manmohan had studied at the Banaras Hindu University and dreams of democracy. It is through his eyes that readers see the politics of Nepal and India.

At the beginning of the novel, as the barber's wife applies mehendi on Meena's hands, she talks about marriages, mothers and motherland. "The mother and motherland are not like arms or legs of a body, which once decayed can be amputated", she says. "The mother and motherland are the heart and liver of the body. They cannot be removed. The mother remains, and the motherland too, in daylight and in darkness.... What is mother and motherland to a woman. They are impermanent dreams." This loss lies likes at the heart of the book, one that is carried through generations and remembered.

The story is personal, fuelled by the memory of her mother's longing for her home in Nepal. It is addictive, evocative and hunting.

The novel, Smriti Ravindra's first, traces Meena's journey to Sabaila from Dharbhanga as he tries to build her life in a country that is not hers. Ravindra brings alive the squelch of Sabaila mud, the mountains of Kathmandu and green of her garden as she writes with longing of the Maddesh experience in Nepal. The politics may be familiar, but Ravindra makes it palpable and real. It is not institutional history that she weaves -- the linking of Nepal with India -- but one that is remembered and felt. She blends folklore and myths to create a world that is dazzling, populated by women and brought alive with their

And these characters—whether it is Sukumariya, the old babysitter of Sabaila who carries the memory of the struggle of the first Indians who came to Nepal: Keveri, Meena's mother who lives fiercely when her husband dies: Kumud, Meena's sisterin-law trying to keep up with the tasks and her twins; Meena, fragile and strong at the same time; or Preeti, who watched her mother unspool—no one is forgettable. The heart beats with these stories, stories that resonate even when you finish reading.

# **CONCEPTS** AND TECHNIQUES IN **NEUROSCIENCE**

Neuroscience is the scientific study of the nervous system. It is a multidisciplinary science that combines physiology, anatomy, molecular biology, developmental biology, cytology, mathematical modeling, and psychology to understand the fundamental and emergent properties of neurons and neural circuit. Neuroscience is the empirical study of the brain and connected nervous system, and contemporary neuroscience seeks to explain how human behaviour arises from brain activity. This is not an easy task. The human brain contains around one hundred billion (1011) nerve cells or neurons and one hundred trillion (1014) synapses or connections between nerve cells. But, over the past thirty years, neuroscientists have made remarkable progress. Neuroscience has shed light on how the brain and certain mental processes can work, and research is showing just how complex the links between brain activity, mental processes and behaviour really are. For example, neuroscience has shown correlations between patterns of activity in the human brain, mental functions (such as thinking, feeling, sensing, attention, memory and consciousness) and particular In the United States, the MacArthur Foundation has funded a major programme of work on neuroscience and the law, and at least one university now runs a graduate seminar course on 'Neurolaw'. The French government has also been funding a programme on 'Neuroscience and Public Policy' since 2009, and the European Science Foundation funds a European Neuroscience and Society Network. types of behaviour. Research has shown that both genes and the environment can affect mental functions, patterns of brain activity and behaviour. It is known that interactions between genes and environment affect changes in the brain and that the brain continues to develop beyond adolescence and into adulthood. But it is also important to recognise that there is no direct mapping of mental function to specific areas of the brain, and that there are huge differences between individuals. The application of findings such as these

remit of this report is to discuss the relevance and utility of these findings from neuroscience to the law. In what follows, a relatively broad view of 'neuroscience' is taken, to include some discussion of behavioural genetics and psychology. At present there may be relatively little neuroscience that can be directly applied to the law, but this will surely change over the next ten to twenty years. This report also takes a broad view of 'the law' (although perhaps with more emphasis on criminal than civil law), and has attempted to consider not only what happens in court trials, but also, for instance, what happens in sentencing and probation. It has not been possible within the scope of this report to discuss every possible interaction of neuroscience and law. Instead, some key areas of debate are highlighted, with examples that refer to the legal system of England and Wales, except where stated where stated otherwise. As investigation of the relationship between brain and mind has developed, researchers have been able to describe mental processes that relate nerve cells or neural circuits to the behaviour of individuals. Many of these mental processes such as thinking, feeling, sensing, attention, memory, and consciousness are regularly used in common language. But although mental processes are helpful in explaining the relationship between brain and mind, the mappings from brain activity to mental process and from mental process to bahaviour, remain complex and poorly understood. Moreover most experiments that investigate the relationship between brain activity and behaviour necessarily use simplified laboratory situations. Generalising findings from these experiments to complex 'real world' situations is difficult and  $uncertain.\,An\,appreciation\,of\,the\,limits$ of neuroscientific techniques can inform the assessment of how useful these findings can be, and importantly, highlight areas for productive research. Indeed, everyday experience shows that individuals respond very differently to specific situations. Why is that? unique, individual, lifelong experiences, play a role in modulating behaviour. However genetic influences on the brain are not yet well understood. Genetic predispositions may have an effect on behaviour, but examples where a simple genetic defect alone can act to affect behaviour are rare. An example from the fi eld of health would be the gene mutation for Huntington's disease. In the majority of cases, multiple genes affect behaviour, and their individual effects would be very small. In addition, the physical and behavioural attributes linked to specific genes are affected by a range of environmental factors, including diet, exposure to toxins and social interactions. One of the most important discoveries about the human brain has been that there is a systematic relationship between particular brain areas and particular functions. For example, the brain areas associated with vision are located in the occipital lobe at the back of the brain. However, it is now clear that such consistent relationships between a brain structure and a mental process are not straightforward 'one-to-one' links. Instead, a particular brain structure may be involved in many (but not all) mental processes; and a particular mental process will often involve several (but not all) brain areas. This 'many-to-many' mapping of mental processes onto brain areas or structures makes it difficult if not impossible to infer particular mental processes from the observation of activity in a particular area. The presence of brain activity in a particular area may result from several different mental processes for example those of pain perception, arousal and affect. The 'fallacy of reverse inference refers to the misguided and incorrect attempt to conclude from observation of activity in an area that a particular mental process was taking place. This is rarely possible. Neuroscience may also help to provide an understanding of how early adversity alters brain development. Adults who have suffered from adverse early experiences are more likely to demonstrate elevated levels of risk taking behaviours, akin to the behavioural characteristic of adolescence. Studies have revealed that these adults also show heightened neural response in subcortical limbic brain regions during reward



# Villages moving towards digital India



Our writers, thinkers and politicians have always spoken about two Indias— one that lives in our cities and the other in our villages. Both are integral to the nation yet are deeply divided in culture, income, technology, and access to resources. The technological gap, however, is gradually fading thanks to a digital revolution bubbling at the heart of our nation. According to a 2022 study by Nielsen, rural India's internet presence is 20 percent higher than urban India.

The penetration of smartphones, UPI [Unified Payments Interface], and government schemes such as the Pradhan Mantri Gramin Digital Saksharta Abhiyan, have enabled Internet access in remote parts of our country. As a result, untapped human potential is finding space to realise itself. Numerous corporates, nonprofits, and educational startups are reaching rural India with skill training, health and nutrition awareness, self-help group (SHG) empowerment programs, and more, by leveraging video conferencing and other technological platforms.

I share a few key sectors that are enabling rural populations with opportunities for a better tomorrow.

#### 1) EDUCATION

The Indian edtech market is gaining a strong foothold. The heartwarming story of Ranjitsinh Disale, a government schoolteacher in Maharashtra and winner of the \$1 million Global Teacher Prize, is particularly poignant. Disale revolutionised the use of QR codes in textbooks by embedding them with audio poems, video lectures, assignments, and more, allowing students to access an interactive school environment, especially for girls, on days they missed school. As a result, the Ministry of Education soon announced that all NCERT textbooks would embed QR codes. Similarly, the Indian government has also introduced free digital e-learning platforms such as Diksha and E-Pathshala. Diksha offers engaging learning material, relevant to the prescribed school curriculum, to teachers, students and parents. Similarly, E-Pathshala, developed by NCERT hosts educational e-resources including textbooks, audio, video, periodicals and a variety of print and non-print materials through website and mobile app. Collectively the available apps offer host explanation videos, e-books, interactive lessons, in 12 to 15 Indian languages. This is a significant step towards better and more inclusive education.

#### 2) HEALTH

The healthtech market will likely be worth \$50 billion by 2033 (RBSA Advisors Report). It is a sector that uses the agency of NGOs, the private



sector and government initiatives through a competent network of ASHA workers. The eSanjeevani app (a national browser-based application facilitating doctor-to-doctor and patient-to-doctortele-consultations) has facilitated over five million teleconsultations and was a boon during the pandemic, especially in rural areas. Through eSanjeevani OPD, one can seek medical advice as well as medication through audio and video. The Since the pandemic, a few NGOs have built effective virtual clinics to cater to antenatal and pediatric care after hospitals were converted to Covid-19 care centers. In addition, startups' digitisation of single medical stores enables patients in remote areas to access medicines outside their village limits.

3) AGRICULTURE Around 70 percent of India's rural households depend on agriculture according to the Food and Agriculture Organization (FAO). Therefore, agritech is naturally drawing interest from farmers, governments, and private startups. One such is the Karnataka government's e-Sahamathi app. The e-governance department has developed the e-Sahamati app with the help of National Informatics Centre (NIC). Under this app, farmers must agree to share their crop information with the aggregator which will in turn share details such as a farmer's name, his crop, landholding etc. with the retailer. In essence, allowing the farmers to list their produce and directly sell it to retail

chains—giving them the power to negotiate a fair price for their harvest. Multiple startups have created similar marketplaces. Bain & Company's research shows that the Indian agritech sector got \$1 billion in funding from 2017 to 2020. Many startups are developing AI-enabled technology and apps to provide end-to-end solutions, which include soil testing, microfinance, weather updates, and more.

#### 4) ECONOMIC EMPOWERMENT

The Ministry of Labor and Employment's e-Shram portal, a digital database of unorganised workers, is a fine example of a digital upgrade. For the first time e-Shram allows construction and migrant workers to access job opportunities in an organised fashion. Additionally, as per the ministry, it is to provide social security to workers, offering a pension after the age of 60 Years if you have a Shramik Card along with insurance benefits. The Union Labour Minister has shared that the portal has received registrations for over 400 occupations. Given the unregulated nature of these markets, this is a great way to ease the process of seeking and employing skilled labor. Besides employment creation, the digital revolution has created opportunities for economic activities in rural India by making them an integral part of the market value chain for products and services—both as suppliers and consumers. This was further aided by the Jan Dhan Account-Aadhaar-mobile connectivity or JAM trinity as it is popularly called, which brought crores

of people into the banking system and transparency in transactions.

### 5) WOMEN EMPOWERMENT

My experience with rural communities has convinced me that our women are a formidable force and can uplift their communities if given an opportunity. For example, Angrekond, a village in Raigad, has raised self-help groups comprising 30 women thanks to digital and financial literacy programs. Once homemakers, they are now self-made entrepreneurs. Many non-profits are partnering with tech companies to empower rural communities, especially women. These networks are introducing communities to online skill training via YouTube and social messaging apps, leading them to become entrepreneurs and manage small businesses.

According to a survey by McKinsey, the digital economy could create 60 million jobs by 2025, and many of these would require functional digital skills. Technology is key to making a level playing field for the two Indias and opening a treasure trove of opportunities for rural communities. As we walk from 75 years, towards our next milestone as a nation—100 years of independence, I hope to see a digitally forward, enabled, and inclusive India—where the rural communities retain their distinct identities and are deeply connected with urban centers and the world.

# **Capital Punishment For Mob Lynching: Big Revamp Of Indian Criminal Laws**

New Delhi: The government today announced a complete overhaul of colonial-era criminal laws to include maximum punishment for crimes like mob lynching and rape of minors and a new offence of "endangering unity" instead of sedition.

The Indian Penal Code of 1860 will be replaced by the Bharatiya Nyaya Sanhita, said Union Home Minister Amit Shah, introducing three bills. The Bharatiya Nagarik Suraksha Sanhita will replace the Code of Criminal Procedure and the Bharatiya Sakshya will replace Indian Evidence Act.

All three were referred to a Standing Committee for review. A new offence on acts of secession, armed rebellion, subversive activities, separatist activities or endangering sovereignty or unity and integrity of India has been added in the revised laws.

The sedition law has been repealed, said the Home Minister. It has been replaced by Section 150 for acts endangering sovereignty, unity and integrity

All the communities are responsible. The problem of hate speech is not good and nobody can accept it," the Supreme Court said.

The court told Additional Solicitor General KM Nataraj, appearing for the Centre, to seek instructions and reply about the committee by August 18.

The bench also told the petitioner to collate all the material, including videos, and give them to nodal officers.



In the petition, Mr Abdullah said, "We hope and trust that the state governments and police will ensure that no hate speeches irrespective of the identity are made against any community and there is no physical violence or damage to the properties."Justice Khanna said the Supreme Court will tell the police chief to form a committee, which will look into hate speech complaints received by police stations in different areas.

The next hearing in on August 18. A mahapanchayat in Haryana's Gurugram was held on August 7 amid tensions six days after communal violence broke out in Nuh district and spilled over to Gurugram city. The gathering organised by the Hindu Samaj Mahapanchayat did not have the police's permission.

# **Doctors Can Now Refuse To Treat** "Abusive, Violent" Patients: Medical Body

New Delhi: Doctors can now refuse to treat "abusive, unruly, and violent patients or relatives", the National Medical Commission Registered Medical Practioner said. taking a major step toward curbing the ongoing instances of violence against medical practitioners.

"The RMP who attends to the patient will be fully accountable for his actions and entitled to the appropriate fees. In case of abusive, unruly, and violent patients or relatives, the RMP can document and report the behavior and refuse to treat the patient. Such patients should be referred for further treatment elsewhere," the notification mentioned under the duties of RMPs towards their patients said.

These new regulations will replace the Medical Council of India's (MCI) Code of Medical Ethics 2002. This is for the first time that doctors will have the right to refusal of patient treatment to unruly and violent patients. The move is aimed at discouraging violence against doctors.

"RMP is free to choose whom he will serve, except in case of a life-threatening emergency. Having accepted a case, the RMP should neither neglect the patient nor withdraw from the case without giving adequate notice to the patient and his family. If a change of RMP is needed (for



example, the patient needs a procedure done by another RMP), consent should be obtained from the patient himself or the guardian. The RMP who attends to the patient will be fully accountable for his actions and entitled to the appropriate

It's also mentioned in the notification under duties of RMPs towards the public and allied healthcare professionals that doctors can't receive any gifts, travel facilities etc from pharmaceutical companies.

"RMPs and their families must not receive

or monetary grants, consultancy fee or honorariums, or access to entertainment or recreation from pharmaceutical companies or their representatives, commercial fees," the notification stated.

healthcare establishments, medical device companies, or corporate hospitals under any pretext," it said. However, this does not include salaries

and benefits that RMPs may receive as employees of these organisations, the regulations stated.

Further, the regulations said, RMPs

# With No End In Sight, Sudan's Civil War Enters 4th Month

Wad Madani: Four months into a battle both believed they would win, Sudan's army has lost its grip on Khartoum to paramilitaries, who are unable to declare victory and instead are accused of waging war on civilians.

When fighting began on April 15, Sudan's army chief Abdel Fattah al-Burhan was certain it would be over "within two weeks".

His former deputy, turned enemy, Mohamed Hamdan Daglo, has sworn his Rapid Support Forces will achieve "victory".

Yet neither has been able to gain a decisive advantage, while fighting has killed at least 3,900 people, uprooted more than four million, worsened food shortages and sparked war crimes allegations.

"The army thought it knew the exact military capacity of the RSF," said military expert Mohammed Abdelkarim.

But the RSF realised "they could be in for a long war" and immediately "seized the entry points to Khartoum and secured their supply lines", a former army officer said, requesting anonymity for security reasons.

The army in July announced the closure of the highway linking Khartoum and Darfur -- a paramilitary stronghold -- but that did little to stem their flow of troops and weaponry, residents and analysts said.

Sanctions by the United States and Britain on companies linked to both sides also seem to have done little to slow the fight-



ing.While the armed forces try to hold key Khartoum bases, they dominate the skies,

raining regular air strikes on the capital. But they lack the RSF's infantry power, which is "essential given the urban nature

of the war", Abdelkarim told AFP. Sudan's army has all but ceded the streets

- 'Appalling abuses' -

"The army has for years neglected its infantry," the former officer said, choosing to instead contract out its many wars -including, ironically, to the RSF which  $previously fought in the \, Darfur \, region \, and \,$ South Kordofan state.

Sudan's army long relied on the Popular

Defence Forces Islamist militia, and in Darfur, where a rebellion began in 2003, then-president Omar al-Bashir unleashed the Janjaweed militia, which later evolved into the RSF.Their campaign led to war crimes charges against Bashir and others by the International Criminal Court.

Bashir's overthrow in 2019 ushered in a transition to civilian rule but that was derailed when Burhan, the country's de facto leader, carried out a coup with Daglo in 2021.

Through its inability to control Khartoum, the army's "claim to represent the government was in question", said Sudan expert Alex de Waal.

But "what it gained on the battlefield, the RSF lost in the political arena", he said, decisively eliminating any sympathies among city dwellers "through the appalling abuses" its fighters committed.

The US-supported Sudan Conflict Observatory said the RSF's positions in civilianoccupied neighbourhoods and buildings are "a potential violation of the Geneva

A separate Observatory report issued August 2 found that, in Darfur, RSF and "aligned forces" had destroyed at least 27

And on August 4, Britain, Norway and the United States condemned "reports of killings based on ethnicity and widespread sexual violence" in Darfur by the RSF and allied militias.

The army has also been accused of abuses, including a July 8 air strike that killed around two dozen civilians.

Burhan retains "the political upper hand" but only "by default", de Waal said.

De Waal said Burhan had "shown neither political profile nor leadership, and it is unclear if he can manage his cabal of quarrelsome lieutenants".What initially appeared as a fight between two generals has since threatened to broaden into "fullscale civil war", the United Nations has warned.On the army side, "it has opened the door to the Islamists, because they're the most prepared, but that would prolong the war and complicate Sudan's diplomatic relations", the former officer said.

## Six foreigners arrested in killing of Ecuadorian presidential candidate

Quito, Aug 11 (UNI) Six suspects arrested in connection with the assassination of Ecuadorian presidential candidate Fernando Villavicencio and another suspect who was shot dead are all foreigners, said authorities on Thursday.

the six weaponized suspects, all members of organized crime groups, were captured hiding in a house in Quito, the country's capital, said a police report. Describing the killing as "a political crime of a terrorist nature," Ecuadorian Interior Minister Juan Zapata confirmed all suspects are foreigners without revealing their nationalities. The minister noted that the police will continue investigating and seeking a motive for the crime. Fernando Villavicencio, Ecuador's candidate for the presidential election later this month, was killed on Wednesday in an armed attack following a political rally in Quito.

## Hawaii wildfire death toll rises to 53, expected to grow higher

Los Angeles, Aug 11 (UNI) At least 53 people have been confirmed dead in the devastating hurricanedriven wildfires in Hawaii's Maui Island, authorities said on Thursday.

"As firefighting efforts continue, 17 additional fatalities have been confirmed today amid the active Lahaina fire. This brings the death toll to 53 people," Maui County wrote on the county's official website. The death toll was 36 earlier in the day. Strong winds from Hurricane Dora were to blame for the deadly wildfires, destroying parts of Lahaina, a tourist spot on Maui Island.Officials warned the death toll could grow even higher. The wildfire that caused widespread damage in Lahaina town was reported to be 80 percent contained this morning after the fire department reported making progress in fighting the Lahaina fire and fires in Pulehu and Upcountry Maui, said county officials in an earlier press release.

Officials said that the status of all three fires remained unchanged as of Thursday afternoon.

U.S. President Joe Biden on Thursday morning approved a major disaster declaration for Hawaii in the wake of the devastating hurricane-driven wildfires. Hawaii Governor Josh Green is on Maui to survey the damage. In a video speech at the scene in Lahaina, Green said that "over a thousand buildings" have likely been destroyed.

"This is a tragic day for everyone in Hawaii and the nation. Our hearts go out to the families of the victims and the survivors suffering through the deadliest natural disaster the state has seen in generations," he said in an earlier statement.

# 5.9-magnitude quake jolts Japan's Aomori: JMA

According to the Japan Meteorological Agency (JMA), the temblor occurred at 09:14 a.m. local time (0014 GMT) at a depth of 20 km, measuring level 4 on Japan's seismic intensity scale which peaks at 7.The temblor's epicenter was located off Aomori at a latitude of 41.2 degrees north and a longitude of 142.9 degrees east. No tsunami warning has been issued.

## Three French police charged over man's death during riots

MARSEILLE: Three French police were charged on Thursday over a 27-year-old man's death during nationwide rioting earlier this summer, prosecutors said, an uncommon instance of officers facing a criminal case over on-duty violence.

An autopsy of the man who died in Marseille during the riots showed marks on his chest consistent with the impact of a shot from a blast ball commonly used by police, prosecutors said.

The officers were arrested on Tuesday over the incident – the only known death at or on the margins of the unrest that gripped France in late June and early July over killing of a teenager by a policeman during a traffic check outside Paris on June 27.

The riots were met by a forceful police response. The man, Mohamed Bendriss – a married father of one whose widow is expecting a second child – died after feeling unwell while riding a scooter.

# West African bloc activates force for possible Niger intervention



ABUJA: The West African bloc ECOWAS on Thursday ordered the activation of a standby force for possible use against the junta that took power in Niger in July, saying it wanted a peaceful restoration of democracy but all options including force were on the table.

After a summit of its heads of state in the Nigerian capital Abuja, the bloc pledged to enforce sanctions, travel bans and asset freezes on those preventing the return to power of democratically elected President Mohamed "No option is taken off

the table, including the use of force as a last resort," said Nigerian President Bola Tinubu, the ECOWAS chair.

"I hope that through our collective effort we can bring about a peaceful resolution as a roadmap to restoring stability and democracy in Niger," he said. "All is not lost yet." After Tinubu spoke, an official communique was read out which included a reso-



lution asking the bloc's defence chiefs to "activate the ECOWAS Standby Force with all its elements immediately". Another resolution spoke of ordering "the deployment of the **ECOWAS Standby Force** to restore constitutional order in the Republic of Niger", immediately followed by another that spoke of restoring such order "through peaceful means". Security analysts say a regional force could take weeks or longer to assemble, potentially leaving room for negotiations.The ECOW-AS statement did not spell out how the force

would be funded, which countries would participate or how many troops and what hardware they could contrib-

The junta in Niamey had defied an Aug 6 deadline to stand down set by ECOWAS, instead closing Niger's airspace and vowing to defend the country against any foreign attack.

ECOWAS accused the generals in charge in Niamey of "defiantly repelling" all the bloc's attempts at diplomatic engagement and sought to project an image of resolution and

# Iran, US to free prisoners under swap deal

DUBAI: Iran agreed to release four American-Iranian dual nationals from Tehran's Evin prison under a prisoner exchange deal between Tehran and Washington, its mission to the United Nations said on Thursday.

"Under the deal mediated by a third country, five Iranians jailed in the United States will be released and Iran's frozen funds in South Korea will be unblocked and transferred to Qatar," it said, according to state news agency IRNA.

Five Iranian nationals will be released from US prisons as well.

Earlier, Iran moved five Americans from jail to house arrest, officials and family members said on Thursday, in the first step of a delicate deal.

The next step would be transfer of Iran's \$6bn frozen in South Korea to a special account administered in Qatar

The progress on the prisoners — one of them detained for nearly eight years comes after quiet, exhaustive diplomacy between the longtime adversaries whose separate talks on restoring a nuclear deal broke down.

Sources familiar with the negotiations said that the next step would be the transfer of \$6 billion frozen in South Korea to a special account administered in Qatar which Iran could use for humanitarian purchases such as food and medicine. If all goes as planned, the prisoners could leave Iran sometime in September, one source



Four of the prisoners — Siamak Namazi, Emad Sharqi and Morad Tahbaz, and another who preferred to remain anonymous - were taken on Thursday out of Tehran's notorious Evin prison, a day after President Joe Biden's administration informed their families of a breakthrough in talks.

The four were escorted to a hotel where they will remain held under guard by Iranian officials, a lawyer for one of the prisoners said. Sources said that a fifth American, a woman, was also part of the discussions and had already been moved in recent weeks to house arrest.

"While this is a positive change, we will not rest until Siamak and others are back home; we continue to count the days until this can happen," Babak Namazi, Siamak's brother, said in a statement.

A spokeswoman for the US National Security Council called the release to house arrest "an encouraging step" but said Iran should never have arrested the five Americans. "Of course, we will not rest until they are all back home in the United States," said the spokeswoman, Adrienne Watson. "Negotiations for their eventual release remain ongoing and are delicate," she said.

## **Bangladesh records** highest daily spike of nearly 3,000 dengue cases, death toll rises to 364

Dhaka, Aug 11 (UNI) In a grim landmark, a total of 2,959 people were diagnosed with dengue fever in Bangladesh in the past 24 hours on Thursday, the highest number in a single day so far this year, said the Directorate General of Health Services (DGHS) under the Ministry of Health.

Also in the same period, 12 people died due to the mosquito-borne disease. According to figures reported by the DGHS, 1,097 people were diagnosed with dengue in Dhaka alone Thursday. With the fresh infections reported as of 8:00 a.m. local time Thursday, the number of dengue cases has surged to 78,028 in Bangladesh so far

this year, the DGHS said. So far in August, 26,196 dengue cases were recorded after 43,854 people were infected with the disease in July, according to the DGHS, which confirmed 364 dengue deaths so far this year. While 113 deaths were reported so far in August, there were 204 deaths in July and 34 in June,

the DGHS said. In order to fight the rising number of dengue cases, Bangladeshi health authorities have strengthened measures to check the breeding of mosquitoes and conduct anti-larval operations.

# Colorism: How Skin Color, Race Create a Toxic Mix for Health

cross the globe, darker skin puts millions of people at a disadvan-Ltage. Within communities of color, lighter skin often bestows better access, privilege -- and better mental and physical health.

Nov. 3, 2022 - In Asian, Black, and Latino communities, colorism is the elephant in the room, sitting at the family dinner table, the group photoshoot, meeting strangers for the first time, or even playing in your kindergarten classroom. This phenomenon is so deeply rooted within communities of color that it is almost taboo to talk about. Or maybe it hurts too deeply to call out by name. But, if you're not a person of color, this concept might sound completely foreign; but that's OK, keep reading. To boil colorism down to a simple explanation, it is discrimination, prejudice, and bigotry, based on skin tone and color.

"The similarities in colorism across [Asian, Black, and Latino] communities are specifically related to the adoration and glorification of whiteness and the perception that anything that's European and of lighter skin is better," says Nayeli Y. Chavez-Dueñas, PhD, a licensed clinical psychologist and professor at the Chicago School of Professional Psychology.

This includes thoughts like, "white people – followed by people of color with lighter skin - are smarter and more capable and deserving of societal privileges, like access to better jobs, wealth," she says.

In our new docu-series, "Color by Web-MD: WebMD's Exploration of Race and Mental Health," we'll start by addressing colorism and the costly mental health effects of this phenomenon. We'll also look at ways to break these multi-generational thought patterns that prevent some people of color from truly recognizing and appreciating the beauty of varying skin

#### Colorism vs. Racism

Differentiating colorism from racism can be tricky because one bleeds into the other, according to Radhika Parameswaran, PhD, an associate dean of The Media School at Indiana University in Bloomington.



Racism pertains to attitudes, behaviors, and treatment from one racial group to another. For example, the way a white community treats an Asian community. Colorism, on the other hand, looks at how members of a community of color treat

"So, in some ways, colorism is also about internalized racism," says Parameswaran. Where Does Colorism Come From?

While colorism is rooted inside certain racial groups, we can trace its origins back to European colonialism, says Vanessa Gonlin, PhD, an assistant sociology professor at the University of Georgia. For African American communities in the U.S., colorism stems from chattel slavery. Colonizers created a skin-tone hierarchy where lighter-skinned slaves were more likely to be "put in the house" and tasked with cooking, cleaning, and other duties often deemed as "easier," Gonlin explains. Darker-skinned slaves often worked it the fields. "This led to literal divisions among enslaved people," she says. "You're less likely to band together for a slave revolt if you have these perceived differences that actually are enacted based on your occupation."

Even after emancipation, some African

Americans kept colorist ideas going within their communities. Gonlin gives the example of the notorious "brown paper bag test," particularly among certain Greek fraternities and sororities throughout the

20th century. "If your skin was lighter than a brown paper bag, you were allowed entry into certain spaces," Gonlin says.

#### **Colorism in Asian and Latin American Communities**

When Spaniards began to colonize Latin America in the late 15th century, they created a ranking system. People with lighter skin were at the top and those with darker skin and non-European facial features (for example, a narrow nose or thin lips) were at the bottom of the ranking order, according to Chavez-Dueñas.

"They used this [ranking order] to dehumanize and exclude people who were indigenous people or of Afro descent," she says. "That system has been at work for centuries throughout Latin America."

And in many Asian cultures, colorism began long before Europeans arrived. Rather, skin tone bias was connected to

"If you were lighter-skinned, that means

that you're not toiling outside in the field," Gonlin says. "It was this idea of having the luxury or the means to be able to stay inside. If you were darker-skinned, then you were a laborer."

#### It Starts at Hom

Perhaps the ugliest reality across cultures is that colorism usually starts at home. Ideas of self-doubt can be introduced very early and can be hard to shake, says Chavez-Dueñas. In fact, colorism often begins before birth. Comments like, "I hope your child turns out white" or "I hope they have good hair" can be commonplace for pregnant women, she says.

In some families, there will often be praise heaped upon siblings who have a lighter skin tones, Parameswaran says.

'They will be sought out for presentation to the public."

This may sound horrendous, but it's important to keep in mind that many families just want the best for their children, Parameswaran says. The idea that lighter skin provides children less social stigma and more career opportunities, romantic partners, and an overall "easier life" fuels colorist narratives.

The Harsh Reality for Darker-Skin Chil-

Colorist comments are usually uttered during casual conversation and often become normalized. Darker-skin children can develop feelings of exclusion and low self-esteem, even to the point where they believe their parents "don't love them as much as, perhaps, a sibling who's lighterskinned," says Parameswaran.

"The child ends up carrying a lot of stigma and shame – it's like a heavy backpack," Parameswaran says. "Sometimes they don't have that vocabulary to articulate those feelings. So, they hold it within themselves, and it can be very damaging over the long run."

Some children carry this shame into adulthood, which can make it hard to sustain romantic relationships and simply "be themselves to the fullest extent possible," she says

# **Yoga And Breathing Techniques May Help Asthmatic People Breathe Better: Study**

**Y**oga and breathing techniques combined with aerobic training are particularly important exercises for asthmatic people looking to improve their lung function, according to a study. The study, which was released today in the Annals of Medicine journal, emphasises the significance of including the right type of exercise training in asthma management strategies. According to lead author Shuang-

tao Xing, an Associate Professor at the School of Physical Education at Henan Normal University, the results show just how effective particular types of exercise training can be to improve lung function for those adults. "Breathing training combined with aerobic training, and yoga training, appear to be particularly advantageous – offering potential avenues for effective treatment approaches," he stated. "Larger, well-designed randomized controlled trials are now needed to more accurately estimate the benefits of exercise training for individuals with asthma." Asthma, a chronic lung condition that affects around 339 million people worldwide, causes symptoms such as coughing, wheezing, shortness of breath and chest tightness. In the past, exercise was considered a potential risk factor for individuals with asthma, as it was believed to trigger or worsen acute asthma attacks. However, recent studies have revealed



that exercise training can actually enhance respiratory function and exercise capacity in adult patients. However, variations in the specific exercise interventions in existing randomized controlled trials (RCTs) have made it challenging to compare the effectiveness of different rehabilitation programs.

To address this issue, the current study conducts a network metaanalysis, which enables a simultaneous comparison of results from multiple treatments in a single analysis, to compare the effects of multiple types of exercise training on lung function in adults with asthma.

The analysis included a total of 28 RCTs involving 2,155 people with asthma and examined the effects of breathing training, aerobic training, relaxation training, yoga training, and breathing combined with aerobic

training, on lung function.

Furthermore, the researchers applied a statistical technique to rank the effects of different exercise treatments against each other. Relaxation training showed the most significant effect on improving FEV1 levels, breathing combined with aerobic exercise had the most significant effect on improving FVC levels, and yoga training had the most significant effect on improving PEF levels. "These findings should provide valuable insight for healthcare professionals prescribing exercise training for the management of adult asthma patients. However, it is essential to consider individual factors, such as family history, duration of the condition, and environmental influences, when designing exercise rehabilitation programs.

# Kane Williamson confronts World Cup prospects amid recovery progress

TAURANGA, AUG 11: As the road to recovery continues, Kane Williamson discussed the possibility of representing New Zealand at the ICC Men's Cricket World Cup in India.

În April, Kane Williamson underwent surgery to address a ruptured ACL suffered during the Indian PremierLeague(IPL), raising doubts about his participation in the ICC Men's Cricket World Cup.

However, encouraging developments followed, as Williamson  $resumed \, practice \, earlier \, this \, month$ and was also part of New Zealand's training camp held in Mount Maunganui, an ICC report said.

Speaking to the reporters at the Bay Oval, Williamson said the possibility of playing in the World Cup has been a huge motivating factor. "To be at the World Cup is always special. It's still just guesswork at the moment in terms of when the day is or how it's tracking at the time," Williamson said.

"There's a lot of work to do. I am just really following the programme, with the professionals for physio, the support staff and New Zealand Cricket. And it's

# **Shakib Al** Hasan to lead Bangladesh in Asia Cup & **Cricket World Cup**


