SRINAGAR, AUG 17: The cases of HIV AIDS are increasing with each passing year in Jammu & Kashmir as 6,158 patients have tested positive in the union territory till June 2023.

An official told the news agency—Kashmir News Observer (KNO) that so far 1,400 HIV-positive patients have died while 3,478 patients are living on Anti-Retroviral Therapy (ART). He said 547 patients have left follow-up.

He said that 5,060 cases of HIV have been reported at GMC Jammu and among them, 1,228 have died, 503

"The Artificial Intelligence based voice cloning is the new cyber crime in news. Apple Ios7 and various apps and sites like Heyge, Murf and Resemble Al etc. are being used for voice cloning," Jammu Cyber Police Station spokesman said.

He said that the criminals are using computer generated voice sound to act as friends and relatives and in the process, money can be lost.

Sharing the modus operandi, the spokesman said that the Ai-ml (artificial intelligence/machine learning) model learns the patterns and characteristics from the person's voice recordings. (speech patterns, accents, voice inflection and even breathing). 




## Chandryaaan-3: Lander Module successfully separated from Propulsion Module

CHENNAI, AUG 17: Marking yet another milestone, the Lander Module (LM) was on Thursday successfully separated from the Propulsion Module (M) in the Chandrayaan-3 spacecraft and it will be deboosted for descend to a slightly lower Orbit tomorrow ahead of soft landing on the South Polar region of the moon on August 23.

ISRO tweeted "Thanks for the ride, mate! said the Lander Module (LM)." "LM is successfully separated from the Propulsion Module (PM)...LM is set to descend to a slightly lower orbit upon a deboosting planned for tomorrow around 1600 Hrs., IST", it said. Meanwhile, the Propulsion Module continues its journey in the



current orbit for months/years.

The SHAPE payload onboard in PM would perform spectroscopic study of the Earth's atmosphere and measure the variations in polarization from the clouds on Earth – to accumulate signatures of Exoplanets that TURN ON.....PAGE 02

The decision comes after months of protests by JKSSB candidates against Aptech, the former exam-conducting agency appointed by the Jammu and Kashmir administration to fill vacancies in government departments.

The move to replace Aptech was prompted by concerns about the security of their network, raised by law enforcement and technical experts during the early stages of the examination process.

These concerns led to the cancellation of exams, including those for Sub Inspector and Junior Assistant posts, by the High Court in December 2022 due to allegations of paper leak and fraud.

The shift to TCS aims to ensure a more secure and fair exam process for JKSSB candidates.

order of August 9 which directed the NC to approach the office of the Election Department of the Administration of Union Territory of Ladakh for notifying the reserved symbol (Plough) already allotted to for the polls.

In their plea, the admin contended that even if the NC is entitled to be allowed to use the symbol, the authority to give such concession is the Election Commission of India and not the Election Authority of UT of Ladakh In their order on August 14, a division bench of the High Court comprising Chief Justice N Kotiswar Singh and Justice M A Chowdhary said, "Since the election pertains to the LAHDC, Kargil, the Election Commission of India is not the authority to conduct the elections and it would be the UT Authority which will be primarily responsible for the conduct of the elections for the Ladakh Autonomous Hill Development Councils.

... It has been provided under Section 59 of the Ladakh Autonomous Hill Development Councils Act, 1997 that the Government may make rules to regulate all or any of the matters mentioned therein for the purpose of holding of elections of members under this Act," the 10-page order said.

It also added that there is hardly any scope for examining the same in view of the admitted position regarding the allotment of the symbol of "Plough" to the National Conference as a recognised State Party in the UT of Jammu and Kashmir, the court said.

The present appeal stands dismissed, it said.

According to a notification issued by the election department on August 5, the election to 26 seats of the 30-member Ladakh Autonomous Hill Development Council (LAHDC), Kargil, is scheduled for September 10 and the counting of votes will take place four days later. "Keeping in view that the upcoming general election of LAHDC (Kargil) stands announced, the petitioner-party (National Conference) is directed to approach the office of the respondents (Ladakh Election department), for notifying the reserved symbol (Plough) already allotted to it...," Justice Sindhu Sharma had said in her five-page order last week. The National Conference had submitted that being the recognised state political party under section 29 of the Representation of the People Act, 1951 read with the election symbols (Reservation and allotment) order 1968, it is entitled to contest the upcoming general election of LAHDC, Kargil on allotted election symbol. The counsel for the NC, Shariq Reyaz, had submitted that the National Conference was recognised as a state political party in the erstwhile State of Jammu and Kashmir, which included the Union Territory of Ladakh also. of acid), 201 (destroying evidence) and 120-B (criminal conspiracy). The court passed the 312-page verdict after considering the arguments by Special Public Prosecutor AA Teli and the defence council.

"I find that the prosecution has been able to establish the charges against the accused persons beyond any reasonable shadow of doubt. As such, this charge-sheet is accepted and the accused persons namely Irshad Amin Wani and Mohammed Umer Noor (Accused No.2), are held guilty for the offences punishable under Sections 326-A, 201 &120- B RPC," the court said in thje verdict, a copy of which lies with GNS.

The court said that it find "absolutely no material from the defence side to suggest any probable reason for falsely implicating the accused persons in this case.'

"The established facts, circumstances and the chain of evidence taken cumulatively are so complete and consistent that in all human probabilities the only hypothesis is that the horrendous act of throwing acid on the victim has been committed by the accused No.2 in furtherance of the conspiracy hatched by accused No.1 with accused No.2," the court said, adding, "The established facts and circumstances do not leave any reasonable ground for the conclusion consistent with the innocence of the accused persons."

The court is likely to announce the quantum of punishment on Saturday.

Notably, on 11 December 2014, a young law student was grievously injured in the acid attack near Nowshera on the city outskirts while she was on way to her college.

Given the gravity of the offence which sent shock waves across the Valley, a Special Investigation Team, constituted by the then IGP Kashmir A.G. Mir under supervision of then SSP Srinagar Amit Kumar with then SP Rayees Mohammad Bhat (presently DIG South Kashmir) as incharge of SIT, arrested the two persons accused within a fortnight.

He said the international standard of the best quality grapes is to have a berry size of 4-5 gm and Repora grapes have a size of 12.5 gm exceeding the international standards.

"Grapes are cultivated on around 202 hectares of land in Ganderbal, and in Repora, these are grown on 80-90 hectares which provides livelihood to hundreds of people, especially during harvesting season which begins these days," the farmer said.

Abdul Rehman, who cultivates grapes on several kanals of his land, told KNO that Kashmiri grapes are known for their sweetness not only in the valley but throughout the country.

Rehman said he works very hard but sometimes they suffer huge loss due to on August 23.

Now that the LM got separated from the PM, ISRO would be executing a series of complex braking maneuvers to facilitate a soft landing in the hitherto unexplored South Polar region of the Moon on August 23. The Space Agency said the health of Chandrayaan-3 is normal. "Through-

out the mission, the health of the spacecraft is being continuously monitored from the Mission Operations Complex (MOX) at ISRO Telemetry, Tracking, and Command Network (ISTRAC), the Indian Deep Space Network (IDSN) antenna at Byalalu, near Bengaluru, with the support from European Space Agency (ESA) and JPL Deep space antenna.

ISRO had on August five said the Chandrayaan-3 mission achieved a crucial milestone with the successful completion of the Lunar Orbit Insertion (LOI).

After it entered the Moon's Orbit, ISRO said "MOX, ISTRAC, this is Chandrayaan-3, I am feeling lunar gravity." "A retro-burning at the Perilune was commanded from the Mission Operations Complex (MOX), ISTRAC, Bengaluru", it said. This is the third time in succession that ISRO has successfully inserted its spacecraft into the lunar orbit, apart from doing so into the Martian orbit.

The highly anticipated soft landing is planned for August 23, during which the lander attempt a gentle touchdown near the southern polar region of the Moon.

This maneuvre required precise braking techniques to ensure a safe landing.

Prior to the landing attempt, ISRO will conduct thorough imaging of the landing site region to identify safe zones, free of hazards and potential obstacles.

The success of the soft landing would propel India to join a select group of space faring nations to achieve this historic milestone. Only US, the then Soviet Union and China have achieved this feat so far.

India too nearly achieved it in its maiden attempt when it had launched Chandrayaan-2 in July 2019, before the lander crash landed very close to the landing spot, making the mission about 99.99 per cent success.

The Chandrayaan-3 spacecraft was successfully launched by ISRO's heaviest launch vehicle LVM3-M4 from the spaceport of Sriharikota on July 14.

After a flight duration of about 16 minutes, it was precisely placed in an elliptic parking orbit of 36,500 km x 170 km. The injection of Chandrayaan-3 in the orbit marked its 42-day

closer to the lunar surface with each orbit.

The Chandrayaan-3 consists of an indigenous Lander Module (LM), propulsion module (PM), and a rover with the objective of developing and demonstrating new technologies required for future inter-planetary missions.

The success of Chandrayaan-3 will make it the surface mission closest to the lunar south pole to date, a region of the moon that has been found to be geologically unique and host to spots in permanent shadow.

Through the Chandrayaan-3 mission, ISRO is crossing new frontiers by demonstrating soft landing on the lunar surface by its lunar module and demonstrate roving on the lunar terrain.

It is expected to be supportive to ISRO's future interplanetary missions. ISRO said Chandrayaan-3 is a followon mission to Chandrayaan-2 to demonstrate end-to-end capability in safe landing and roving on the lunar surface. (UNI)

also been reported in China, Europe and Japan.

"The new variant was first detected in India in May 2023 and the fact is that there has been no significant increase in the incidence of the new strain since its detection 3 months ago shows that it is not something to be bothered about." he said.

The DAK President the new variant is basically a sub-lineage of omicron which most of us have gone through and our population has enough immunity against omicron and its sub-variants.

"With high vaccination rates and natural immunity, the possibility of a new wave in our population due to the variant is unlikely," he said.

Dr Nisar said new variants will keep coming as frequent changes in the genomic structure are part of the natural course of the virus.

"We are going to see the new variant Eris for some time before it is replaced by yet another variant. That is the nature of the virus," he said.

"World Health Organisation (WHO) has added the new variant EG.5 to the list of monitored variants and classified it as a variant of interest and not a variant of concern as it does not pose a threat to public health," he added. (UNI)

Around 203 hectares of land is under grapes production in this yard with an annual production of 1336 metric tonnes, farmers said.

ISRO had on Wednesday completed the Lunar bound maneuvres of India's third moon Mission Chandrayaan-3 by reducing its orbit for the fourth time setting the stage for separation of LM from the PM, which was successfully done today.

The separation of PM and LM marked the commencement of their separate journeys.

After entering the Lunar Orbit on August five, the Chandrayaan-3 spacecraft underwent four orbit reduction maneuvres till date and moved very closer to the moon's surface.

The earlier three orbit reduction maneuvres were performed on August 6, 9 and 14, gradually moving the 3 spacecraft closest to the moon's surface ahead of soft landing

journey towards the Moon traversing more than 3.80 lakh kms that would culminate in the soft landing on August 23, ISRO Chairman S.Somanath said.

After five Orbit raising maneuvres since the July 14 launch, the spacecraft moved out of the earth's orbit and sent to the Trans Lunar Orbit by successfully completing the Lunar Orbit Injection (LOI) on August one.

In a key manoeuvre – a slingshot move – the spacecraft was sent successfully towards the Moon from Earth's orbit. The soft landing on the moon is planned at 5.47 p.m on August 23.

After injection into the Lunar orbit, the spacecraft's orbit was further manoeuvred for the planned soft landing on August 23 evening to explore the hitherto unexplored south polar region of the moon.

The LOI marked the beginning of the lunar-centric phase during which the spacecraft will orbit the Moon four times, getting progressively further

## Will Take A Year To Rebuild, Says **Himachal Chief Minister On Rain Damage**

Shimla: At least 71 people have died in the past three days and 13 are still missing in Himachal Pradesh after devastating rains pounded the state, with Chief Minister Sukhvinder Singh Sukhu terming the work of rebuilding infrastructure a "mountain-like challenge".

The death count from landslides and flashfloods jumped on Wednesday as rescuers pulled out more bodies from the rubble of collapsed buildings, officials said.

Heavy rains have battered the hill state since Sunday, triggering landslides in several districts including Shimla where three areas -- Summer Hill, Fagli and Krishna Nagar -- are badly hit by landslips. "At least 71 people have died in the past three days and 13 are still missing. As

many as 57 bodies have been recovered since Sunday night," Principal Secretary (Revenue) Onkar Chand Sharma said.

Earlier, Chief Minister Sukhu said that about 60 people have died since Sunday night. In an interview with PTI,



Mr Sukhu said his state will take a year to rebuild the infrastructure wrecked by the heavy rains this monsoon and claimed that the estimated loss in the two devastating spells of heavy rains-this week and in July - is about 10,000 crore.

The chief minister said it takes time to rebuild roads and water projects. But the government is speeding up the process. "We have to get the infrastructure fully restored within a year. I am working with this in mind." "It's a big challenge, a mountainlike challenge," he said.

According to the state emergency operation centre, in total 214 people have died in the rain-related incidents in the state since the onset of monsoon on June 24 while 38 are still in the state on Wednesday due to inclement weather and the Himachal Pradesh University has suspended teaching activities till August 19.

About 800 roads are blocked in the state and the losses suffered by the state since the onset of monsoon on June 24 have crossed 7,480 crore, officials said, adding as many as 10,714 houses have been completely or partially damaged so far.

Deputy Chief Minister Mukesh Agnihotri has urged the Centre to declare national calamity in Himachal Pradesh and release

2,000 crore for restoration works. Meanwhile, 1,731 people have been rescued from flood-affected areas of Indora and Fatehpur sub-divisions of Kangra district in the last 24 hours, said Deputy Commissioner Nipun Jindal on Wednesday.

Specifically, 1,344 people were rescued from Indora and 387 from Fatehpur.

The operation to evacuate people from floodaffected areas is going on with the assistance of Air Force helicopters, Army personnel, and NDRF, Mr Jindal said.

## **Two Indian Pilots Die In** 2 Days, 1 At Airport, **Another On Flight**

New Delhi: India has seen the deaths of two pilots in two days. While an IndiGo captain fell unconscious at a boarding gate in Nagpur today, a Qatar Airways pilot suffered a heart attack onboard a flight yesterday.

The IndiGo captain was supposed to operate a flight from Nagpur to Pune and had reached the boarding gate when he lost consciousness. He was taken to a hospital where he was declared dead.

Sources said the pilot had operated two sectors, from Trivandrum To Nagpur Via Pune, between 3 am and 7 am yesterday. He had 27 hours of rest and was supposed to fly four sectors today. He had reported for his first departure of the day, which was scheduled for 1 pm, when he fell unconscious.

## **Candidates, A First Before Poll Dates**

New Delhi: The BJP today announced first lists of candidates for Assembly polls in Madhya Pradesh and Chhattisgarh due later this year. This is the first time the BJP has announced names of candidates even before the Election Commission of India announces the poll dates. The party has announced 21 candidates for the 90-member Chhattisgarh Assembly and 39 for the 230-member Madhya Pradesh House. The announcement comes a day after Prime Minister Narendra Modi chaired a meeting of the BJP's central election committee, the party's decision-making body for selection of candidates and preparation of poll strategies. The BJP leadership's unprecedented decision to announce candidates' names well in advance appears to be aimed at identifying friction within the ranks so that issues can be resolved well in advance. Following the poll setback in Karnataka earlier this year, the party is in no mood for another debacle. Chhattisgarh and Madhya Pradesh are among five states going to polls later this year, along with Rajasthan, Telangana and Mizoram. Out of these, Chhattisgarh, Rajasthan and Telangana are ruled by Opposition forces. In Mizoram,



BJP's ties with ally and ruling party Mizo National Front are strained in the wake of the Manipur unrest. And in Madhya Pradesh, a neck-to-neck fight is expected between the BJP and the Congress.

The names of former Chief Minister Raman Singh and other senior party leaders are missing from the first list.In Madhya Pradesh, the names of Chief Minister Shivraj Singh Chouhan and prominent ministers are not on the first list of candidates.The BJP's Chhattisgarh list comprises five women, 10 candidates from Scheduled Tribes and one from the Scheduled Castes category. ## **HP Jal Shakti Dept suffers** Rs 2,000cr loss due to rains: Mukesh Agnihotri

Una (HP), Aug 17 (UNI) HP Deputy Chief Minister Mukesh Agnihotri said Jal Shakti Department in Himachal Pradesh has suffered a loss of 2,000 crore rupees due to rains in the last month, during a state level review meeting of the department here last night. The meeting, held through video conference, was presided over by Deputy Chief Minister, Himachal Pradesh, Mukesh Agnihotri. He called for efforts to restore services and address the situation. Chief Engineers, Chief Engineers, Superintending Engineers, and many other officers of the Jal Shakti Department also participated in the meeting and gave detailed information to the Deputy Chief Minister about the damaged and affected drinking water schemes in their respective areas due to rains in the second phase.

"The Prime Minister of India should have gone to Manipur but he didn't do that. He spoke about Manipur for 3 minutes before the session and only for 5 minutes during No-Confidence Motion," he said, speaking at a rally in Maharashtra's Beed.

"The Prime Minister didn't understand the pain of the women in Manipur," added Mr Pawar, whose faction of Nationalist Congress Party was among those which northeastern state on May 3.

During his response to the No-Confidence Motion in Lok Sabha last week, he referred to the issue after nearly 90 minutes, once the opposition members walked out.

# **Climate Change May Turn Thar Desert Green By Century's End: Study**

New Delhi: India's Thar Desert, known for its arid expanse, could undergo a transformative shift due to the effects of climate change, a study suggests.

While many deserts across the globe are predicted to expand with rising temperatures, the Thar Desert might defy this trend and actually turn green within the next century, the researchers said.

The Thar Desert is located partly in Rajasthan, and partly in the Punjab and Sindh provinces of Pakistan, covering over 200,000 square kilometres of territory. It is the world's 20th-largest desert and the world's 9th-largest hot subtropical desert.

Several studies have projected the growth of Earth's deserts under the influence of global warming. For instance, experts have estimated that the Sahara Desert could increase in size by over 6,000 square kilometres annually by 2050. However, the newly published study,

published recently in the journal Earth's Future, offers an unexpected perspective on the Thar Desert.

By employing a combination of observations and climate model simulations, the research team found that the mean rainfall over the semi-arid northwest regions of India and Pakistan witnessed an increase



of 10–50 percent between 1901 and 2015. Under moderate greenhouse gas scenarios, this rainfall is anticipated to surge by 50-200 percent, they said.

Remarkably, the study indicates that an eastward shift of the Indian monsoon has been a pivotal factor contributing to the arid conditions in the west and northwest regions of India. Historically, these areas were thriving during the monsoon season, supporting the Indus Valley civilizations. The researchers propose that a reversal of this trend, coupled with a westward expansion of the present-day Indian monsoon, could radically transform the west and northwest regions of India into a humid "monsoonal" climate.

This transformation, in turn, might enhance food security for the nation's burgeoning population.

According to the study's corresponding author, B. N. Goswami, from the Department of Physics at Cotton University in Guwahati, understanding the dynamics

of the Indian summer monsoon is key to comprehending how the climate could green the Thar Desert. "This happens due to the seasonal migration of the rainband or the active Inter-Tropical Convergence Zone (ITCZ) from south of the equator over the Indian Ocean in winter to about 25 degrees North in summer over the Indian continent," Goswami told PTI.

The expansion of the warm water pool in the equatorial Indian Ocean, brought about by climate change, has led to a westward shift of the ITCZ. This, in turn, drives rain further westward over the land during the summer months.

Goswami notes that this phenomenon is unique to the Indian monsoon and is crucial for the potential greening of semiarid regions in northwest India.

The study emphasizes that this trend could lead to significant agricultural and socio-economic changes in the region.

The research team, including P.V. Rajesh from the Indian Institute of Tropical Meteorology in Pune, compiled weather data from South Asia over the past 50 years.

By analysing changes in monsoon duration and concentration, they fed historical weather and sea surface temperature data into a climate model to predict future changes under various greenhouse gas scenarios.

Kashmir being a geographical wonder is blessed with immense natural beauty and is known for its breathtaking landscapes, snowy mountains, meadows, gardens, orchards, lakes, high mountain passes, Hill stations and religious sites . There is too much of diversity that Kashmir offers in culture, nature and climate. Apart from this Kashmir valley offers various categories of tourism, like water sports, rafting, skiing, tracking, Shikara ride and iconic house boats. There is an immense potential of winter games, snow parking, spiritual tourism and border tourism. Tourism has become a very fast growing industry in the current period and is considered an economic bonanza for union territory, since industrial development is very limited and youth unemployment is one of the major challenges faced by union territory of J&K. Tourism has contributed much to the local economy over the years. Tourists provide direct and indirect income to innumerable locals by spending money on taxi, hotel, shopping, travel agency etc. Tourism industry has the potential to uplift the local economy of kashmir and create job opportunities for the unemployed youth. Tourism sector is the main driver of the economy. This sector has a capacity to create large scale employment and has given jobs to a large number of people espicially in tertiary sector. Its impact is visible in services rendered by people directly or indirectly, including hotel staff, tour operators, taxi drivers, tour guides, souvenir vendors etc. The industry provides employment to around 70,000 people. It is holding strategic importance in the development and expansion of other industries, such as agriculture, horticulture, handicrafts, sports, construction, banking, insurance and transportation. People get engaged in related services for several socio- economic benefits which in turn get good quality of life, high standard of living and increase in the wealth. Tourism is a game changer for this ailing econmy .Today over 70 percent of J&K's papulation is estimated to be around 35 years. If this huge demographic potential is properly canalized, it could prove a great source of human asset. This human asset could be utilized in the unique type of highly labour-intensive industry and which does not require vast patches of land like in agriculture and horticulture. Presently both skilled and unskilled youth render services to earn money spent by tourists in the places they visit. Tourism sector starts paying off immediately as it has no gestation period like other sectors. According to tourism department the region witnessed increasing foot fall of domestic and foreign visitors. Kashmir is scaling new heights in tourist count. Tourism in Jammu and Kashmir has seen a remarkable boom after the turmoil, violence and unrest the region



has witnessed over the years. The record breaking arrival of tourists thronging the valley has been bringing smiles on the otherwise gloomy faces of educated youth.The surge in tourism is evident among foriegn visitors with a staggering 1.27 crore tourists visiting upto july 2023. The target is much more as the union territory is set to break last years record of 1.89 crore tourist arrivals, more than 15,000 foriegners visiting upto june 2023 a significant increase compared to the first half of 2022 when only 4028 foreign tourists arrived. It is predicted that the total number of tourist arrivals will surpass 2 crores. Tourism industry in the state of j&k generates around ₹8000 crores contributing to nearly 7% of the UT's GDP. The GDP figure would have been different if the violence had not hit hard the tourism sector. The usual shutdown in valley due to the armed conflict and resurgence that erupted in the valley in early 1990s compelled tourists to switchover to other places, causing the loss of tourist appetite for this particular destination.

In 1987, the last big season before the conflict started, tourism accounted for approximately 10% of state's income . During the next 23 years of unrest, tourism contributed virtually nothing to state's economy. As a result of the unfavourable circumstances, the negative travel advisories to visit Kashmir were issued by various foriegn countries. This negative approach adversely affected the tourist revenue generated by foreign visitors. The impact of conflict in the valley that its main city Srinagar was once declared as the most threatened site in India by the World Monument Fund (WMF), placing it on the 2008 list of Most Endangered sites (Winter and Punjab, 2010).Now again this tourism industry healing the wounds of unemployed youth who have miseries and nothing else to invest in capital based ventures.

Agrarian sector particularly horticulture and agriculture mostly plays a vital role in shaping J&k's economy but it is still lacking the marketing concept due to which false representation that the produce is of a particular standard quality, quantity or gradecomposition. Our horticulture industry needs professional consultants and only then it would be the real backbone of J& K's economy. The increased tourist numbers are exposing local industries to the world and creates new business opportunities.

The spritual tourism is another allied source of income over 58 lakh pilgrims visiting the famous Vaishno Devi shrine in Jammu region until July. Jammu is famous for its temples, palaces, forts and forests. The Amarnath Yatra has also seen a tremendous response with over 4 lakh pilgrims in the first 32 days of Yatra, both Vaishno Devi shrine and Amarnath Yatra surpassing the pilgrimage percentage from the previous year.

The border tourism has a huge potential to provide diverse opportunities to the youth of J&k. Social media is exploring the tourist visiting sites, like Bangus valley, Keran, Lolab valley, Machil, Teetwal, Tangdhar , Reshwari, Gurez etc which bear the potential to provide jobs to the unemployed youth of entire North Kashmir . Economic growth has been of late and heavily demands reformation and renovation.The lower middle class and lower class of people are still at the back end. These people have fewer opportunities to get educated, enhance their skills and to stand as entrepreneur. These classes consume higher fraction of their earning than the rich with the result they fail to survive in any business. If more money flows to these segments then the lower middle class and lower classes are key engines of growth but with inequality on rise these engines are stalling. The tourism policy of 2020 should be fully implemented. All it needs are the serious steps to provide the required reformation. Another challenge for Government is that the Tourist land is shrinking and authorities should ensure sustainable utilization of natural resources. The lakes, wetlands, rivers and streams of J&k have become garbage-dumping sites and huge influx of tourists is adding fuel to the fire. The need of the hour is setting up modern sanitary landfill sites.

The key to unlock the potential of this sector is through government support, infrastructure development, skill enhancement ,quality of service, safety, good travel facilities, proper tour guide and hospitality. These services should refrain from any unfare trade practices for purpose of promoting sale and supply and consumption or adopt any unfair or deceptive trade practices. The tourism industry could have been converted into a big income earning industry but it stands neglected despite the provision of funds in 2023-24 Amritkaal Budget . This industry should be developed as per the vision of sustainable development goals and the new preparations should be made to promote eco-friendly tourism so that it will be a new ray of hope for the people of the region.

Although this particular job is being performed from time immemorial i.e from the times of Raja's and Maharajas or even before that from the time's of Lord Rama's and Lord Krishna's when they used to send their Duta's to the other kingdoms like Angad was sent to Ravana by Rama to bring peace by releasing Sita without any fight etc.

With the time and materialization of everything and anything, the role of Duta's and PRO's of the present day has changed to a greater extent. PROs ensure internal cohesion in the company by maintaining a clear communications network between the management and employees. Its first objective is to improve channels of communication and to establish new ways of setting up a two-way flow of information and understanding.

Public relations as a career option has come into existence when lots of private or government companies and institution felt the need to market their product, service and facilities. In the times of cut-throat competition and similar products and services to sell, it is the Public image that has become important to all organisations and prominent personalities. As a legatee of Indian reform, I am grateful to the laws of the land and to the enlightened Indian fathers who let their girls out of the box over the last 100 years, to study, work, travel, and marryor not marry-as they chose. However, it is still a heavily patriarchal society with sky-high expectations of a wife. In Tulsidas' Ramcharitmanas from the 16th century, Aranya Kand, Verse Four, Rishi Atri's wife Anasuya gives this advice to Sita: "Devotion of body, speech and mind to the feet of her lord, the husband, is the only duty, sacred vow and penance for a woman."

This job description was detailed in South India in the 13th century in a popular verse by Telugu poet Bhadra Bhupala or 'Baddena':

"Karyeshu dasi, karaneshu mantri,bhojeshumata,shayaneshu Rambha, roopeshu Lakshmi, kshamayeshu Dharitri, shath dharmayuktakuladharmapatni."

It means, "Like a servant doing the chores, like a minister giving her husband intelligent advice, serving him food as a mother feeds her child, like the apsara Rambha in bed, as beautiful as Lakshmi, and as forbearing as Mother Earth: the woman who has these six qualities is the ideal wife."

However, a well-known Sanskrit scholar in Kumbakonam could not tell me of any corresponding scriptural virtues and qualities required of a husband, when I asked him back in 2008. To his credit, he admitted it with unsparing honesty after spending a sleepless night trying to find an instance.

So, I was intrigued some years later to discover a forgotten story in the Markandeya Purana, said to date back to around 250 CE. The purana is a collection of storiesin-a-story comprising 9,000 verses. It is best-known for the section called 'Devi Mahatmyaham', recited every year at Durga Puja. But in this story that I would like to retell, Rishi Markandeya acquaints his disciple Kraustuki with the complex give-and-take between husbands and wives.

There was once a king called Uttama who was happily married to a beautiful queen named Vahula. Though shy by nature, she was a practical person. She knew she had a public role to play and took part with composure in all her queenly duties, be it in court or at the sacrificial fires. She ran the women's quarters with utmost sense, discouraged petty behavior, and gave her household a good tone. The maids adored her and the public respected her.

But a star-crossed phase befell Vahula. She felt neglected by her husband and no longer found him interesting or attractive. She began to withdraw subtly from him and soon, more openly. The three pains according to Samkhya philosophy are Adhyatmika, born of the mind and body; Adhidaivika or supernatural; and Adhibhoutika,



because of an incident or calamity. All three were to fall on the royal couple's heads.

The tension between Uttama and Vahula grew and grew without a single conversation about it. One evening at a public dinner with rich merchants and foreign diplomats present, Uttama had a bit too much wine. He thrust his goblet at Vahula, who pointedly turned away. Uttama lost his temper and ordered the guards to take Vahula to the forest and abandon her there. Vahula swept off silently with a proud smile.

Soon after this catastrophe, a poor priest appeared in court to demand the king's help. Someone had stolen his wife from their hut in the middle of the night. "Describe her, we'll send out search parties," said Uttama.

"She's not very pretty and she has a foul temper," disclosed the priest. "What?" exclaimed Uttama.

"It would be easier to find you a new wife, you know." "King," said the priest reproachfully, "My wife is my wife. It is my duty to protect her from

the rest of the world, from my ownfamily, and even from myself." "But where can we look without more information?" countered

Uttama. "Lord of the Earth, you take a sixth of our produce as your due. Your subjects are supposed to sleep peacefully because you uphold the law," said the priest unyieldingly.

Abashed, Uttama assembled a hunting party and soon found the priest's wife unharmed in the forest, placidly eating plums. It was the neighbourhood rakshasa who had kidnapped her just to disturb the priest's pujas, which required his wife's presence. The priest and his wife then cheerfully went their way while the rebuked rakshasa, already berated soundly by the hot-tempered lady, promised to behave itself in future.

This incident left Uttama deeply ashamed of the way he had treated Vahula, making no attempt to understand her but treating her like a well-oiled machine at his beckand call. Further, he discovered through a rishi with a supernatural

sight that Vahula had been kidnapped by the serpent king Karpotaka and was hidden away in a cave by the serpent princess Nanda. Uttama made his way with great difficulty to the serpent kingdom and challenged Karpotaka to single combat. It was a close, fierce fight but the determined king had the best of it. When he found his wife, led by the serpent princess, he gathered Vahula lovingly to him with concerned, affectionate words, and manfully asked her to forgive him. At this, the queen found herself unable to hold a grudge and spoke to him with renewed love.

Nanda could not speak because she had been cursed by her angry father for hiding Vahula, and the queen wanted to performa Saraswati Pujatobeg the Goddess of Knowledge to restore Nanda's speech.

"We can do that better at home, let's take Nanda back with us," urged Uttama, and all was made well for the principled and upright serpent princess. In due course, she was even able to go back home to her now-repentant father.

As for Uttama and Vahula, they lived in great harmony after these harrowing events brought them back together, and the king never took his queen for granted again... "Know therefore, Kraustuki," said Rishi Markandeya, "A husband has many duties, but chiefly, moral gallantry."

# China's Consumer Demand Decine Helping India In Getting More Foreign Investment

It Is Now Certain India Will Be Third Largest Economy In The World In 2027

Consumer demand in China plunged into deflation, reflecting onslaught on consumer price. Its consumer price index



In 2022-23. India's GDP soared by 7.2 percent - one of the fastest growth in economy - in the world. Inflation hovered in the comfortable zone at 6.7 percent and robust growth was achieved in capital expenditure by 39 percent, reflecting a strong platform for investment. Export boomed nearly by 7 percent in 2022-23. It was over a strong base of 45 percent growth in 2021-22, reflecting a combined impact of nearly 50 percent growth in export during the past two years

fell by 0.3 percent in July, 2023, year -onyear basis, demonstrating failure of Xi Jinping's new policy to retrieve the economy, which was dented by zero -COVID policy and domestic oriented demand.

Global analysts asserted that Chinese recession is akin to Japanese style stagnation, which let it deepened in the "Lost decade" - 1991-2000. A new term churned out for Chinese recession, renaming "Japanification". It equated to Japanese style asset price bubble burst, low demand and downsizing of population, threatening an aging society similar on the line of Japan. According to latest estimates by the Chinese Government, more than 30 percent of the population in China would be over 60 years, by around 2035. Global Times, a Chinese media, acknowledged that there were certain similarities between Japan of 1980 and 1990's and China today,

Expectation for growth in the Chinese economy declined significantly. It faltered twice in its target of growth. In 2021, the target was 5.5 percent. But it fell to 3 percent. In 2022, the target was set at around 5 percent. It was lower than 3 percent.

In contrast, India pitched for a strong macroeconomic stability in the post COV-ID. It poses a big challenge to Chinese hegemony in the growth. Trajectory of growth ensures Prime Minister Narendra Modi to predict India to be the 3rd biggest economy. This means India will surpass Germany and Japan in growth. Currently, India is the 5th largest economy, according to Forbes.

According to State Bank of India research report, India was forecasted to be the 3rd biggest economy by 2030. Global S&P was upbeat to project India's annual growth by over 6 percent annually till 2030. Morgan Stanley, in its last November report, projected India to be 3rd biggest economy by 2027.

Demographic and digital dividends are the key factors, attributed to India shining in growth amidst the slower growth in the world. It is supported by nearly 900 million working age population, with 759 million "active internet users" and 650 million smartphone users in 2022, the second biggest after China. India ranked 2nd biggest manufacturer of mobile phones and



3rdbiggest in the world for start-ups and Unicorn.

In 2022-23, India's GDP soared by 7.2 percent – one of the fastest growth in economy - in the world. Inflation hovered in the comfortable zone at 6.7 percent and robust growth was achieved in capital expenditure by 39 percent, reflecting a strong platform for investment. Export boomed nearly by 7 percent in 2022-23. It was over a strong base of 45 percentgrowth in 2021-22, reflecting a combined impact of nearly 50 percent growth in export during the past two years.

India's reinvigorate Make in India – the flagship of Indian manufacturing policy lost the steam. Manufacturing made a stupendous growth, after deceleration consecutively for 2 years in post COVID period. It surged by 11.8 percent in 2021-22, in contrast to fall by 9.6 percent and 1.4 percent in 2020-21 and 2019-20 respectively.

A series of policy measures were introduced to reboot the growth. It introduced "Atmanirbhar Package (self-reliant)", which included PLI scheme (Productivity Linked Incentive), investment opportunities under National Infrastructure Pipeline (NIP), Indian Industrial Land Bank (IILB), National Single Window system and others PLI Scheme has been a big success for attracting FDI in the country. While the world FDI inflow registered a downtrend, India pinned a marked growth. In 2022, Global FDI inflow declined by 12.5percent , in contrast to spurring growth in India , by 10.3 percent.

With the outbreak of COVID 19, supply chain disruption jolted global growth and eventually FDI inflow. Ironically, global supply chain disruption turned boon to India instead. It gave a new lease of life to "Make in India", which was losing stream.

Arguments were made and doubts were raised against India's potential for the ambitious vision for a new hub for global supply chain. According to Hu Shisheng, Director, South Asia Institute, China -Institute for Contemporary Industrial Relation, expressed concerns on India emerging as substitute for the China supply chain. There are three major challenges of Modi government policy, according to him. First, introduction of PLI scheme (Production Linked Incentive), second, the global search for China alternatives and third, enhancing free trade agreement routes to topple the burgeoning imports from China ". The decision of Apple of USA, decoupling from China and shifting to India, is a case in point.

Vietnam has emerged a potential challenge to India in supply chain. As a result, it became a big bet for the foreign investors. But, what goes in favour of India is its big domestic demand, in contrast to Vietnam, engulfed by low domestic demand. FDI flow in India was three times more than Vietnam in 2022.

The recent visit of Indian Prime Minister to USA made a major turnaround in the inter-dependency of the two nations. Global viewers hyped India, saying "USA needs India more than India needs". USA has been the biggest foreign investor in India.

US tilt to India for supply chain was reflected, with USA acknowledging India's leadership in Indo-Pacific region. In 2nd IPEF (Indo-Pacific Economic Framework) for Prosperity Ministerial Meeting at Detroitin May 2023, agreement was signed for supply chain resilience. It provides several benefits to India, including potential shift of production centres, from the 14 member nations.

In summing up, Modi's chanting of India to be the 3rd biggest economy by 2030is likely to pitch a potential destination for doing business.

## 17 soldiers killed in Niger **border attack**

NIAMEY: At least 17 troops were killed in an ambush in Niger in a reminder of the nation's deep security crisis as its military rulers face off against neighbours determined to reverse last month's coup.

An army detachment was "the victim of a terrorist ambush near the town of Koutougou" in the Tillaberi region near Burkina Faso on Tuesday, said a defence ministry statement published later that day. It added that another 20 soldiers had been wounded, six seriously, with all the casualties evacuated to the capital Niamey.More than 100 assailants, who were travelling on motorbikes, were "neutralised" during their retreat, the army said. An insurgency has plagued Africa's Sahel region for more than a decade, breaking out in northern Mali in 2012 before spreading to neighbouring Niger and Burkina Faso in 2015. The so-called "three borders" area between the three countries is regularly the scene of attacks by rebels affiliated with the Islamic State group and Al-Qaeda. The unrest across the region has killed thousands of troops, police officers and civilians and forced millions to flee their homes. Anger at the bloodshed has fuelled military coups in all three countries since 2020. Alarmed by the cascade of takeovers, the West African bloc ECOW-AS has warned of possible military intervention to reinstall Bazoum, who is being detained in the presidential compound in Niamey.

## Taliban 'ban' political parties in Afghanistan

PESHAWAR: The Afghan Taliban on Wednesday said there was a complete ban on activities of political parties in Afghanistan.

"Political parties' activities have been completely stopped in the country because neither do these parties have any standing in Sharia, any place in Sharia nor are any national interests attached to these parties or the nation liked them," Interim Minister for Justice, Shaikh Maulavi Abdul Hakeem Sharae said while presenting annual report of his ministry in Kabul, according to a statement issued by the Afghan Taliban's media outlet.

The statement demonstrates that the Afghan Taliban may continue to monopolise power as a movement and have no intention of allowing political plurality in the country.

It wasn't clear when the ban was imposed, but the Afghan Taliban have been resisting international pressure to form a more inclusive government, saying their 'interim government' had representatives from all ethnicities and tribes and was broad-based.

The Afghan Taliban have been opposed to including what they call "discredited and puppet politicians" from the previous dispensation, saying their participation would be a betrayal of their long struggle against foreign occupation forces and their "puppets" and "stooges."

While the Taliban government has generally disallowed political activities from the get-go, this is widely being seen as the first official statement in this regard.

# Militia fighting leaves 55 dead, 146 wounded in Libya populated neighbourhood's unlit streets,

TRIPOLI: Tripoli's worst armed clashes in a year have killed 55 people and wounded 146, Libyan media reported on Wednesday, before a truce took hold in the capital and air traffic was restored.

Fighting between the influential 444 Brigade and the Al-Radaa, or Special Deterrence Force, two of the myriad of militias that have vied for power since the 2011 overthrow of Muammar Qadhafi, erupted on Monday night and raged through Tuesday.

The clashes with rocket launchers and machine-guns followed the detention of the 444 Brigade head, Colonel Mahmud Hamza, by the rival Al-Radaa Force on Monday, an interior ministry official said.

Al-Ahrar TV updated the death toll to 55, citing Malek Mersit, spokesman for the emergency medical centre that handles emergency response in the country's west. In August last year, 32 people were killed and 159 wounded in Tripoli during battles between divided Libya's two rival administrations. The country has seen more than a decade of stop-start conflict since the Nato-backed revolt that toppled Qadhafi. Truce takes hold after deal for release of

444 Brigade chief to a 'neutral party'

A period of relative stability had led the United Nations to express hope for delayed



elections to take place this year, and the latest fighting triggered international calls for calm.

The social council in the southeastern suburb of Soug el-Joumaa, a stronghold of Al-Radaa, announced that an agreement had been reached with Prime Minister Abdelhamid Dbeibah, head of the UNrecognised government in Tripoli, for Hamza to be handed over to a "neutral party".

In a televised announcement, the council said a ceasefire would follow the transfer of the force's commander, and late on Tuesday the fighting abated.

Both armed groups are aligned with Dbeibah's government.

A total of 234 families were evacuated from frontline areas in the capital's southern suburbs, along with dozens of doctors and paramedics trapped by the fighting while caring for the wounded, the Emergency Medical Centre said.

Overnight Tuesday-Wednesday, Dbeibah visited the southeastern suburb of Ain Zara, which saw some of the heaviest fighting on Tuesday, accompanied by Interior Minister Imed Trabelsi.

Dbeibah "saw for himself the severity of the damage" as he toured the densely

## **Imran Khan Interrogated In Attock Jail Over Missing Cipher Copy: Report**

Islamabad: A joint investigation team (JIT) of the Federal Investigation Agency (FIA) interrogated former Pakistan Prime Minister Imran Khan inside the Attock jail, in a case related to the cable gate saga, ARY News reported on Wednesday.

The matter pertains to March last year when the Pakistan Tehreek-e-Insaaf (PTI) Chairman brandished a letter claiming that it was evidence of an "international conspiracy" backed by the US to topple his government.Last month, the probe agency had grilled the deposed prime minister - who was removed from office via a noconfidence motion in April last year - for nearly two hours in the case after the Lahore High Court (LHC) withdrew a stay order against the call-up notice to Khan by the



ing the conclusion of its findings but the latest publication of alleged content of the secret cable document in an online American news organisation has forced it to expand its investigation to cover the aspect of the leak to the media.

ARY News reported citing sources said the JIT was keen to see how and who had leaked the document's content to the media and whether the content of the cipher, as shared by The Intercept, is original or exag

news agency IRNA said.

The visit "is focusing on bilateral ties, regional and international issues", according to IRIB state broadcaster.

IRNA said Amir-Abdollahian was due to meet with his Saudi counterpart and other officials in the kingdom.

The minister was accompanied by the new Iranian ambassador to Saudi Arabia, the report added.

State media reported in May Tehran had named Alireza Enayati, a former ambassador to Kuwait, as the Islamic Republic's Saudi envoy.

In June, Prince Faisal bin Farhan became the first Saudi foreign minister to travel to Iran since 2006.Earlier that month Iran had reopened its embassy in Riyadh with a

On August 9, Iran said the Saudi embassy in Tehran had begun operations but Riyadh has yet to confirm.

Iran and Saudi Arabia have backed opposing sides in conflicts across the Middle East for years.

Iran has in recent months been at odds with Saudi Arabia and Kuwait over a disputed gas field.Saudi Arabia and Kuwait claim "sole ownership" to the field – known as Arash in Iran and Dorra in Kuwait and Saudi Arabia – with Tehran warning it would "pursue its right" to the offshore zone if negotiations fail. Iran has intensified its diplomatic activity in recent months and pushed for closer ties with other Arab countries in a bid to reduce its isolation and improve its economy.

Imran, while making the claims did not reveal the contents of the letter nor mention the name of the nation that had sent it. But a few days later, he named the United States and said that "Assistant Secretary of State for South and Central Asia Affairs Donald Lu had sought his removal".

## "Playing With Fire On Taiwan **Question": China Warns US**

Beijing: Days after Beijing condemned Taiwan's Vice President William Lai for making stopovers in the United States calling him a "troublemaker", China's Defence Minister Li Shangfu on Tuesday cautioned against "playing with fire" when it comes to Taiwan, Chinese Defence Ministry reported.

In an apparent attack at the US, Li cautioned any attempts to "use Taiwan to contain China," and said it would "surely end in failure," China's defence Ministry said in a statement and Xinhua news Agency quoted.

## **US beefs up Gulf** deployment over Iran oil tanker threat

MANAMA: As Iranian seizures threaten oil tankers plying the Gulf, the United States is raising its military presence – a move long demanded by Gulf Arab states who accused Washington of retreating from the region.

Three thousand additional US personnel on trooplanding warships have already passed through the Red Sea, and US-led maritime forces are warning ships against approaching Iranian waters.

The moves follow a spate of capture and attempted capture of ships in and around the Strait of Hormuz, the U-shaped gateway to the Gulf of Oman and Arabian Sea that carries a fifth of world oil output.

"There is a heightened threat, a heightened risk to regional mariners in terms of seizures" by Iran in the strait, said Commander Tim Hawkins, spokesman for the US Navy's Fifth Fleet.

"Right now, our focus is on ... increasing our presence in and near the Strait of Hormuz to ensure security and stability in a very critical waterway," Hawkins said at the US Naval base in Bahrain.

The attacks on tankers came at a time of troubled relations between Washington and its wealthy Gulf allies, who have long relied on US protection for their oil assets and chafed at a perceived military drawdown.

## **Muscovites** fight in **Ukraine: mayor**

MOSCOW: Tens of thousands of Muscovites are taking part in combat operations in Ukraine, the Russian capital's mayor Sergei Sobyanin said on Wednesday, giving a rare estimate of the forces deployed.

Russia and Ukraine rarely communicate on the total number of troops involved in the conflict, or on their respective losses.

"Forty-five thousand Muscovites are fighting in the area of the special military operation," Sobyanin was cited as saying by Russian news agency Interfax.

The mayor added they represented a "considerable part" of the fighters there. Among them, "at least 5,000 people are professional soldiers," he also said.

Beginning in August, Deputy Security Council Chairman Dmitry Medvedev said Russia had enlisted over 230,000 additional personnel into the army since the start of the year.

Last September, President Vladimir Putin announced a "partial" military mobilisation of 300,000 men to replenish the troops.

The announcement – Russia's first such mobilisation since World War II – sent a shock through the country as thousands of men were drafted into the army.

### Hawaii officials say 'no regrets' about lack of wildfire sirens

Embattled officials in Hawaii who have been criticised for the lack of warnings as a deadly wildfire ripped through a town insisted on Wednesday that sounding emergency sirens would not have saved lives. At least 110 people died when the inferno levelled Lahaina last week on the island of Maui, with some residents not aware their town was at risk until they saw flames for themselves.But the head of Maui's Emergency Management Agency, which operates a network of 80 sirens, on Wednesday defended the decision not to sound them as fire bore down on Lahaina's more than 12,000 people."The sirens are used primarily for tsunamis. The public is trained to seek higher ground in the event.



## UGC To Grant Foreign Degree Equivalence; Restricts Online, **Distance Mode And Franchise Agreement Degrees**

NEW DELHI. Aug 17: The University Grants Commission (UGC) has drafted guidelines for granting equivalence and for recognition of degrees obtained from foreign universities, restricting degrees obtained through distance and online mode as well as through any franchise agreement. The commission has also drafted norms for recognising qualifications obtained from schools affiliated to foreign boards as well as from offshore campuses of a foreign higher educational institution.

The norms come at a time foreign universities are in the advanced stages of setting up campuses in India's GIFT city and Indian universities are collaborating with institutions

abroad to offer dual or joint degrees.

The higher education regulator in its draft Recognition and Grant of Equivalence to Qualifications obtained from Foreign Educational Institutions) Regulations, 2023, has covered internationally relevant curricula, academic and research collaboration with foreign universities and credit recognition under twinning arrangements.

"Oualification obtained from a foreign higher educational institution shall be recognized and granted equivalence provided the qualification has been awarded by a foreign higher education institution that is duly recognized in its home country. "The student should have

pursued the programme through regular, in-person instruction (and not through



online or distance learning). The entry-level requirements for admission to the programme should be similar to that of a corresponding programme in India," it said.

The commission has noted that "similarity" of entry criteria will be determined through due process by the Standing Committee set up for the pur-

pose based on similarity of minimum duration of the programme in India and the foreign country; minimum credit requirements and evaluation processes.

"Credits in different categories of courses may be examined and similarity established (such as basic background courses. disciplinary core courses, disci-

plinary elective courses, crossdisciplinary courses, laboratory courses etc), so that the equivalence also reflects the similarity in 'flavour' of the offerings in India and abroad," it said.

While the guidelines state that the minimum duration of the programme should be similar to that of a corresponding programme in India, in case the duration varies, the UGC will consider minimum credit requirements that should be the same in both institutions.

"In considering this, the commission will examine and grant equivalence to the definition of credit(number of contact hours per week. number of self-study hours, the quantum of experiential learning, etc) first, before the equivalence between the programmes is established. Up to 10 per cent variation of total

normalised credit requirements may be given equivalence," the guidelines said.

In order to facilitate the mobility of students in a seamless manner, the UGC will maintain a dedicated online portal to receive applications to grant equivalence to qualifications obtained from foreign educational institutions.

This equivalence certificate will certify the "parity of a qualification" between a foreign qualification and the qualification awarded by an Indian Board or university at the same level. According to the UGC regulations, the equivalence certificate will also be accepted by the universities in India for the purposes of admission or employment.Currently, the evaluation division of the All India Universities (AIU) – an apex interuniversity organisation - issues an "equivalence certificate" to students with foreign qualifications to facilitate their admission in Indian Universities. With the guidelines coming into effect. the UGC will also assume the responsibility of granting equivalence to foreign degrees.

Qualification obtained from off-shore campuses, according to the UGC, under dual degree or joint degree programmes will only be recognised if the academic programmes satisfy the accreditation requirements in the country where the offshore campus is located and in the country of origin."Qualification obtained in the offshore campus of a foreign higher educational institution shall be recognised provided the campus is duly approved by the competent authorities in India as well.

## SC asks Centre, Gujarat govt why selective remission only to Bilkis Bano convicts

New Delhi, Aug 17 (UNI) The Supreme Court on Thursday questioned the policy of the Gujarat and Union governments about selective application for remission (pre-mature release) of Bilkis Bano's 11 convicts serving jail sentence for gang-rape and murder.The Apex Court was hearing a batch of pleas, including certain pleas filed by third parties, challenging the decision of the Gujarat

government to grant remission to 11 convicts who had gang-raped Bilkis Bano and murdered her family members during the 2002 Gujarat riots.

## **Jofra Archer** unlikely to be part of England's World **Cup plans**

Cricbuzz Staff | Jofra Archer's exclusion from England's squad for the New Zealand series at home-also the provisional shortlist for the upcoming ODI World Cup in India - is down to the fact that the ace seamer has "run out of time" to prove his fitness following the stress fracture of the elbow earlier this year. England selector Luke Wright has confirmed that Archer will only be flying to India as a "travelling reserve" with the team.

"There has got to be a duty of care with Jof," Wright said. "We know how desperate we all are to have him - there's no doubt about that - but we've also got to get it right for him. He's been very unfortunate with these injuries.. regarding the World Cup, unfortunately, we're just running out of time."

"He's not going to come round quite quick enough, especially for the first part of the World Cup. There is a duty of care with him. We have to make sure that long-term, we get it right because we see him as a huge asset for a long time. As much as the temptation is to try and rush him in and get him in for the start of this World Cup, unfortunately, we're just going to run out of time." Archer was England's leading wicket-taker in the 2019 World Cup that the hosts won, but has been out of action since picking up the elbow injury midway through IPL 2023. In his absence, England have picked six frontline seamers in their provisional World Cup squad, the final deadline for which is September 28. However, given the recent injury record of most of the English seamers, the team is hoping Archer could potentially be ready towards the later half of the tournament to fill in as a replacement, if needed. "Idon't think we can, unfortunately, have him in the squad to start with," Wright said. "Bestcase scenario for Jof really at the moment would probably be [that he is] available for the back-end of the tournament. That's bestcase scenario, which obviously, in a squad of 15, is going to leave us quite light. "The last thing we want to do is really to put a massive time [limit] on him and try to push him and force him into playing before he does [feel ready]. We've got to get him right, first and foremost.

While England boast the pedigree as twice World Cup semi-finalists and winners of the European title last year, Australia's plucky Matildas have captured the hearts of a nation usually invested in other sports.

Australian rules and rugby league fans may be sketchy on the finer details of the round-ball game but they know 'Aussie grit' when they see it, and last Saturday's dra-



matic penalty shootout win over France certainly fit the bill.

Sports fans around the country celebrated goalkeeper Mackenzie Arnold's saves and Cortnee Vine's winning

penalty as if the tournament was won, and there has since been blanket media coverage of a sport often disparaged Down Under.

Sydney's next two biggest stadiums will open their doors to allow ticketless fans to watch Wednesday's match on big screens and the prime minister has all but promised a public holiday if the co-hosts lift the trophy after Sunday's final.

Before they start thinking about taking on Spain, however, they must get past an England side who know all about the pressure of performing on home soil after similarly being embraced by their compatriots during last year's Euros triumph.

In Dutchwoman Sarina Wiegman, they have one of the best coaches in the game and most of their players play for top clubs in highly competitive European leagues.

## **Russians might opt** out of Olympics: Ukraine's **Sports Minister**

This resulted in Ukraine barring their athletes from competing at events where Russians and Belarusians were - tennis being the exception as it has been since the invasion as they compete as individuals. However, last month there was a dramatic change of tack from the Ukrainian government permitting their athletes to take part in events where the Russians and Belarusians were competing as 'neutral athletes'.

The 38-year-old left-armer, who last represented Pakistan in December 2020, has played in three ODI World Cups (2011, 2015 and 2019) and finished with 237 international wickets across 27 Tests, 91 ODIs and 36 T20Is.

"It has been an honor and a privilege to represent Pakistan on the interna-

tional stage. As I bid farewell to this chapter, I am thrilled to embark on a new adventure in franchise cricket, where I hope to entertain and inspire audienceswhilecompetingagainst some of the best talents in the world," said Wahab in a media release.

Wahab made his international debut for Pakistan in an ODI against Zimbabwe back in February 2008. His memorable performances include a fivewicket haul in the 2011 World Cup semifinal against India in Mohali and a fiery spell of fast bowling against Shane Watson, coming against Australia in the 2015 World Cup quarter final match in Adelaide.

Wahab took an indefinite break from red-ball cricket in 2019 to focus on limited-overs cricket and now finally bids goodbye to the international arena.

"I have been speaking about my retirement plans for the past two years, that 2023 is my target to retire from International cricket, and I feel comfortable now more than ever that I have served my country and National team to the best I could have.

## Carmona fires Spain into maiden Women's World Cup final

AUCKLAND: Olga Carmona struck late to lift Spain to a thrilling 2-1 semifinal win over Sweden on Tuesday and send the Iberians into a first Women's World Cup decider as the tournament left New Zealand with a flurry of goals. Wearing the captain's armband, Carmona's 90th-minute strike from the edge of the area pinged off the crossbar and into the net two minutes after Rebecka Blomqvist had levelled the match for Sweden in front of a baying crowd of 43,217 at Eden Park.

Teenager Salma Paralluelo, Spain's quarter-final hero against the Netherlands, produced magic off the bench again, putting her side in front in the 81st minute and breathing life into what had been a slow-burning, cagey affair.

Less than a year after a player revolt tore the squad apart, 'La Roja' will have the chance to lift the trophy on Sunday when they face co-hosts Australia or England in the decider. "We knew it would be a really demanding game mentally," Spain coach Jorge



Vilda said.

"But they showed they were prepared because in the last minute Olga appeared to produce the work of art she did to take us through."

Peter Gerhardsson's Sweden bow out after another defeat at the penultimate hurdle, having made the semi-finals in France four years ago and at last year's European Championship.

"It felt like a punch in the stomach when they managed to take the lead again straight away. There are no words," Sweden defender Magdalena

Eriksson told Swedish radio. Sweden playmaker Kosovare Asllani said she was sick of crying tears of championship failure.

It is caused by overproduction of melanin, the pigment that gives you your natural skin tone. When this pigment forms a deposit in the skin, it causes brown or tan spots on the skin which is called pigmentation

In nut shell any discoloration of the skin is known as pigmentation which is completely harmless and faced by both men and women. Pigmentation can occur to anyone on face, hands or any other body part regardless of one's gender, race, age or geographical locations.

The use of scrubs and masks also help to remove dead skin cells and their contained pigment. This helps the dark patches to gradually become lighter. External care, itself, can remove pigmentation permanently, provided protective care is followed afterwards. Even when the pigmented patches disappear, one should



The first aspect of the treatment is protection from the sun. Actually, as part of the treatment, one should try to avoid sun-exposure as far as possible. Physical protection is the only answer by applying a sunscreen before going out in the sun. Select a sunscreen with SPF of at least 20. The sunscreen should be applied 20 minutes before sun-exposure, to allow it time to be absorbed by the skin. It should be reapplied if you are in the sun for longer than an hour. The effects of the sun increase near water bodies and snow, as they reflect the sun's radiation. Therefore, it becomes all the more important to protect the skin and re-apply the sun screen after 20 to 30 minutes.

If the skin is dry, it should be kept moisturized at all times. At night, after cleansing, apply a nourishing cream and massage it on the skin with a few drops of water. continue to use a sunscreen. In fact, the use of a sunscreen has become an important part of modern cosmetic-care, to protect the skin from problems and premature ageing.

Give the skin some nourishment. As a home remedy, you can try applying a little sesame seed (til) oil and pat the skin with a hot moist towel. Or, apply a little milk, with a few drops of honey, leave it on for 10 to 15 minutes and wash off with water. If you wish to make a cleanser at home, add 5 drops of oil to one tablespoon cold milk. Mix it well. Using cotton wool, use this mixture to wipe the skin. You will find that milk is very soothing to dry skin.

Here are some home remedies for pigmentation (dark patches):

Mix one part honey with two parts lemon juice and apply. Wash off after 20 minutes.

Mix ground almonds with curd and apply. Rub the mixture gently over the skin. Leave on for 5-10 minutes and wash off with water.

Mix rose water and lemon juice in equal quantities and apply on the dark areas. Wash off after 10 minutes, or once it dries.

Mix besan (gram flour) and curd, with a little turmeric and apply on the dark areas.

Take some rice flour, add a little curd and use it as a scrub on pigmented skin

Scrub: Mix 3 tablespoons almond meal (ground almonds) with half cup yogurt (curd). Apply on the face and neck. Rub gently, especially on the dark patches and wash off. It also helps to remove tan. Scrubs should not be applied on dry or sensitive skin. For dry skin, add half teaspoon til oil to a little milk and apply on the face. Wipe off with moist cotton wool after 15 minutes.

For sunburn: Actually, cold milk applied daily, using cotton wool, not only helps to soothe the skin, but also keeps it soft. It also makes the skin colour lighter over a period of time, if used daily.

For dark patches: Mix together a big pinch of coarse salt with a cream. Apply only on the areas with the dark patches or spots and rub gently. Wash off. Then apply cold milk and wash off after 15 minutes. Do this twice a week.

For dark spots: Add a pinch of turmeric (haldi) to curd and apply daily on the entire face. Wash it off after 20 to 30 minutes.

Mask: Mix 3 teaspoons oatmeal with ripe papaya pulp and one teaspoon curd into a thick paste. Apply and wash off after 20 minutes. This mask suits both dry and oily skin.

## ealth and financial **I** influencers now need to disclose qualifications under new **ASCI** guidelines



he Advertising Standards Council of India (ASCI) said medical practitioners, health and

fitness, and finance experts holding certifications from recognised institutions are required to "disclose" that they are certified experts and practitioners while sharing information or promoting products or services or making any healthrelated claims. All advertisements published by social media influencers "must carry a disclosure label that clearly identifies it as an advertisement", the ASCI said as it issued fresh guidelines on August 17. "Influencers providing advice and/or promoting and/or commenting on merits or demerits on aspects related to commercial goods and services, in the fields of Banking, financial services and insurance (BFSI) and Health & Nutrition, must have the necessary qualifications and certifications in order to provide such information and advice to consumers," ASCI said in a press release.

#### **Qualifications mandatory**

Under the new guidelines, finance influencers also known as 'finfluencers', if advising about stock or investments, must have been registered with SEBI and their SEBI registration number should be stated with their name and qualifications. For other financial advice, the influencer must have suitable qualifications such as an IRDAI insurance license, CA, CS etc. "In addition, they must abide by all disclosure requirements as mandated by financial sector regulators from time to time," the regulatory body said.Meanwhile, for posts related to health and nutrition, the influencer must have relevant qualifications such as a medical degree, or be a certified nurse, nutritionist, dietician, physiotherapist, or psychologist depending on the specific advice being given. The ASCI said influencers must disclose their qualifications and registration or certification details prominently and in the case of promotional content, advised them to review and satisfy themselves that the advertiser is in a position to substantiate the claims made in the advertisement. These additional guidelines for celebrities, influencers, and virtual influencers in the field of health and wellness were earlier released by the nodal Consumer Affairs Ministry. The Department of Consumer Affairs will actively monitor and enforce these guidelines. Violations may lead to penalties under the Consumer Protection Act 2019 and other

ndia in collaboration with the World Health Organization (WHO) will launch the Global Initiative on Digital Health on August 19 as part of the on going G-20 summit in Gandhinagar, Gujarat.

The first-of-it's-kind global initiate is aimed at data converge, interface of health platforms and investments in the digital health space around the globe.

The summit is also working on bringing in the crucial interim MedicalCountermeasure(MCM)-"which is a 'network of networks approach' before the next health emergency hits us and India in collaboration with WHO is leading the advocacy," said Lav Agarwal, additional secretary, Health Ministry on Wednesday.

He added that the global digital platform will include an investment tracker, an ask tracker (to understand who needs what kind of products and services) and a library of existing digital health platforms.

He further explained that digital health innovations and solutions will aid universal health convergence and improve healthcare service delivery. The initiative has also found funding from global partners.

Speaking about data security associated with the initiative, Mr. Agarwal said that India has always followed the policy of having data owned by the citizens.



"This is not the practice that we find across the world. India has spoken to its partners about the India format which has been endorsed by partners," he explained.

The global platform for data sharing will offer no data about its users but will share analyses and work at inter operational ability of data.

The summit is also working at garnering support for setting up a Climate and Health Initiative (CHI) in India, in collaboration with the Asian Development Bank and the launch of patient and healthcare workforce mobility portal.

Meanwhile at the summit, WHO is also convening the traditional medicine global summit on August 17 and 18 which is co-hosted by the Ministry of Ayush. It will explore the role of traditional complimentary and integrative medicine in addressing pressing health challenges and driving progress in global health and sustainable development.

# **Relaxed Jasprit Bumrah** all set for India comeback: 'I'm not holding back'

Jasprit Bumrah isn't expecting too much from himself. He's simply happy to be back in international cricket and going through the processes he missed dearly over the past year. Ahead of the Ireland T20I series opener in Dublin on Friday, Bumrah, on return from a back injury that sidelined him for a year, and standing in as India's captain no less, appeared relaxed as he fielded questions on his time away and the work he's had to put in postsurgery to get to this point.

"I was bowling normally," Bumrah said of his first net session with the Indian team in a year. "It's not like I'm holding back. I'm enjoying it. I've done a lot of net sessions. When my rehab finished and I went home [to Ahmedabad], I practised with Gujarat [his state team] as well.

"I've had a lot of sessions and practice matches. It's not like there are any restrictions or I'm holding back. Obviously, when you come with the Indian team - and the weather here [in Dublin] is great - you enjoy bowling that much more. I'm not holding back. The body feels good and I'm looking forward to the games coming up."

Over the past month or so, Bumrah has slowly worked his way up at the National Cricket Academy in Bengaluru in terms of bowling workloads. This has included exhaustive match simulations and a number of practice games to test his match readiness. Bumrah shrugged off any concerns when asked if the bowling demands of a 50-over game, which he could soon face at the Asia Cup and World Cup, would be so much more taxing for someone just returning compared to what was required in this T20I series.

"We were mindful that there's not a lot of Test cricket in this cycle till the World Cup ends [in November], so even in my rehab, we were never preparing for a T20 game, I was preparing to bowl 10-overs for the World Cup," Bumrah said. "I have been bowling 10, 12, even 15 overs. I've bowled more overs, so it becomes easier when you bowl lesser than what is required."

How does Bumrah view the expectations on his shoulders to lead India's attack at the World Cup? Could such thoughts get overwhelming, especially to someone coming back from injury?

"Whoever's opinion [that Bumrah is India's bowling trump card] it is, obviously I respect it but whether it's good or bad, I don't take it seriously," he said with a laugh. "I don't want to carry any baggage or pressure of expectation. I also haven't set unrealistic expectations

takes longer than usual to heal, it can get frustrating. But instead of having self-doubt as to whether I won't become alright, my thought process was how I can be fine and how quickly I can come back. You need to give the body as much time as it needs.

"I never thought of it like those were dark days or I wouldn't be able to come back. I was never looking too far ahead. I was only looking at finding a solution to the issue at hand. Once I found the solution, it felt good that I'd be able to work my way up.

"For the first time in summer in 10-11 years I was at home. So I looked at it as an off-season. I got a lot of time to spend with my family, so I was looking at the positives. Yes, it was disappointing I as away [from cricket for so long], but that's okay, that's something you can't control, so you can't be frustrated about it. I spent time with my family. I'm happy with that and once I
