### Price Pressure In Food Items To Be Transitory; Global Uncertainty, **Domestic Disruption To Keep Inflation Elevated: FinMin**

**NEW DELHI, AUG 22:** The finance ministry of Tuesday said the inflation in food items is likely to be transitory as preemptive measures by the government and arrival of fresh crops will cool prices, even though global uncertainty and domestic disruptions may keep inflationary pressures elevated for the coming months.

The Lt Governor took a detailed review of various infrastructure projects including construction of Transit Accommodations for Kashmiri Migrant Employees and directed the concerned departments to expedite the implementation at the earliest.

District Administration was directed to set up a help desk to facilitate establishment of Industrial units in the district.

The Lt Governor asked the officials to hold regular meetings with banks and financial institutions for timely provision of credit under different government schemes.

He further emphasized on promoting selfemployment and extending support to aspiring youth of the district under the dedicated schemes of Mission Youth.

The meeting also discussed the utilisation of vacant Government buildings and encouraging youth to join NCC and Red Cross initiatives.

as to save themselves from mosquito bites, which they said choose to breed in stagnant water accumulated by water logging mainly during monsoon.

They said the mosquitoes that spread dengue are active during the day. "Cover as much of your body as possible and use mosquito nets if sleeping during the day and spray the nets with insect repellents," they said.

The most common symptoms, as per doctors, are fever and headache, eye pain (typically behind the eyes), muscle, joint or bone pain, rash, nausea and vomiting.

If anyone has stomach or belly pain, tenderness, vomiting (at least 3 times in 24 hours), bleeding from the nose or gums, vomiting blood, or blood in the stool and feeling tired, restless, or irritable, you must consult a doctor, the advisory mentions.

The mosquito remains active mostly at dusk and dawn and people must wear clothes that minimise skin exposure to these mosquitoes, they said.

Meanwhile, the officials said that 8,269 dengue cases (the highest number) and 18 deaths were reported in J&K last year.

They said two cases were in 2009, none in 2010, three in 2011, and 16 in 2012. However, 1,837 cases were reported in 2013.

In 2014, four cases were reported, 153 in 2015, 79 in 2016, 488 in 2017, 214 in 2018, 439 in 2019, 53 in 2020, and 1,709 in 2021, they said.

### **Visitors freely.....**

He said besides waste being thrown in the open there is horse manure everywhere. "In the absence of a pony track, the horse dung is everywhere especially the road leading to the Thajwas Glacier."

In the absence of a proper mechanism plastic bottles and polythene end up in limpid water bodies and forest areas.

Another visitor Bilal Ahmed questioned the authorities asking why no serious measures are being taken to add to the beauty of Sonamarg. He alleged that the work on some hutments which had come up illegally in the past has been going on. "It's an irony that this natural wealth has been tampered with" he added.

An official from Sonamarg Development Authority said that visitors must act as responsible fellows. "We have installed the dust bins and yet some visitors pollute the environment. We don't want to be strict with tourists," he said adding that a pony track will come up at the

tourist destination.

#### 2 convicts.....

Amin Wani alias Sunny, a resident of Wazirbagh, Srinagar and Mohammed Umar Noor, a resident of Bemina who were found guilty for the offences punishable under Section 326-A (voluntarily causing grievous hurt by use of acid, etc.), Section 120-B (Punishment for criminal conspiracy) and Section 201 (causing disappearance of evidence of offence, or giving false evidence to screen offender) of the Ranbir Penal Code.

The two were convicted of throwing acid on an eighth-semester law student in Srinagar on December 11, 2014, just outside the Kashmir Law College in Srinagar.

Principal Sessions Judge at Srinagar, Jawad Ahmed on Tuesday observed the convicts do not deserve leniency and no other punishment except the maximum punishment of life imprisonment prescribed under law for their act can do the real and complete justice to the victim.

"The convicts are hereby sentenced to 10 years of imprisonment and fine of Rs 25,000 each for the offence punishable under Section 120-B RPC, in default of payment of fine they shall undergo further imprisonment for one year.

The convicts are sentenced to suffer imprisonment for life and fine of Rs 5 lakhs each for commission of offence punishable under Section 326-A RPC read with Section 120-B RPC," the court order said.

'The fine, when recovered, shall be paid to the victim in terms of proviso 1 and 2 of Section 326-A RPC. In default of payment of fine, the convicts shall undergo rigorous imprisonment for three years.

The convicts are also sentenced to imprisonment for 3 years for offence punishable under Section 201 RPC read with 120-B RPC with fine of Rs 10,000 each and in default of such fine they shall undergo further imprisonment for six

The sentence awarded to the convicts for different offences shall run concurrently," the order

The court also recommended the case of the victim to the Member Secretary, J&K Legal Service Authority for compensation to the victim.

"In view of the huge amount, the victim has incurred on her treatment and the amount which is required for her further treatment, I deem it appropriate to recommend the case of the victim to the Member Secretary, J&K Legal Service Authority to award the maximum compensation to the victim in terms of the J&K Victim Compensation Scheme, 2019, of course subject to the adjustment of the interim compensation already paid to her under the scheme," the court said.

At the time of arguments on the quantum of punishment, the victim, with permission of the court, narrated the struggles and hardships of the trauma which she has undergone ever since the convicts had thrown acid on her.

She stated that she was a bright student, topper in the class and had chosen her career in the field of law but the horrific act of the convicts shattered all her hopes and dreams. She said this lifelong trauma is not only for her but, even for her parents.

She stated that she has undergone 28 surgeries and the duration of every surgery was ranging between 9 hours to 72 hours.

The victim said as on date her father has spent Rs 37,16,508 on her treatment and does not know how much they need for her further treatment.

She stated before the court that though, nothing can bring the glory of her physique back but, if the convicts, responsible for making her life a living hell, are given the maximum punishment prescribed under law, she would feel that justice has been done with her, otherwise apart from living the life with the miseries, she would feel that even the court has not done the complete justice with her.

"It is further ordered that during the period of suspension, they shall remain attached in the Directorate of Health Services, Kashmir and he shall submit their bio-metric attendance to the Health and Medical Education Department on monthly basis," the order read.

Besides, Mudasir DEIC Manager (on contractual basis), District Hospital, Kulgam is, hereby, attached in the office of the Mission Director. National Health Mission, J&K with immediate effect, the order reads.

"Sanction is, hereby, accorded to the constitution of two-member enquiry committee, comprising of the following Officers to enquire into the embezzlement of hospital Development funds of District Hospital, Kulgam while taking into account, the preliminary enquiry as conducted by the Directorate of Health Services, Kashmir as well as all other connected docu-

ments/evidence," reads a seperate order. The members of the committee as per order are Dr. Yash Pal Sharma, Director Coordination, New Government Medical Colleges, J&K and Muzaffar Ahmad Rather, Chief Account Officer,

Government Medical College, Anantnag. "The inquiry committee shall submit its report alongwith explicit recommendations to the Health and Medical Education Department within a period of fifteen (15) days from the date of issuance of this order," the order reads.

Notably, a few days ago, a private security guard of district hospital Kulgam was arrested on the charges of withdrawing Rs 33 lakhs from the official account of the Medical Superintendent district hospital Kulgam.

the government in the current fiscal is now leading to crowding in of private investment.

The consumer price index based retail inflation spiked to a 15-month high of 7.44 per cent in Iuly 2023, with specific food commodities mainly driving the increase. Core inflation, however,

stayed at a 39-month low of 4.9 per cent. Cereals, pulses and vegetables exhibited double-digit growth in July compared to the corresponding period last year. Disruption in domestic production also aggravated the inflationary pressures. Interruption in the supply chain of tomatoes due to white fly disease in Kolar district, Karnataka and the swift arrival of monsoon in northern India caused a surge in tomato prices. Tur dal price also inflated due to

deficient production in kharif season 2022-23, the ministry said.

"The government has already taken preemptive measures to restrain food inflation which, along with the arrival of fresh stock, is likely to subside price pressure in the market soon... The price pressure in food items is expected to be transitory," the report said, adding, global uncertainty and domestic disruptions may keep inflationary pressures elevated for the coming months, warranting greater vigilance by the government and the RBI.

Though food inflation in July is perhaps the third highest since the new CPI series began in 2014, only 48 per cent of food items have inflation of above 6 per cent, and this includes 14 food items with inflation in double digits.

Items like tomato, green chilli, ginger and garlic witnessed inflation of more than 50 per cent. Hence, the abnormal increase in prices of certain specific items led to high food inflation in July 2023.

"Tomato prices are likely to decline with the arrival of fresh stocks by the end of August or early September. Further, enhanced imports of tur dal are expected to moderate pulses inflation. These factors, along with the recent government efforts, can soon materialise moderation in food inflation in the coming months," the Ministry said.

Russia's decision to terminate the Black Sea Grain deal, along with dry conditions in major wheat-growing areas, caused the price spike in cereals. While domestic factors like white fly disease and uneven monsoon distribution exerted pressure on vegetable prices in India, it added.

The RBI's interest rate setting committee had earlier this month decided to keep policy rates unchanged and remained focused on the withdrawal of accommodation to ensure that inflation progressively aligns with the target while supporting growth.

The Monetary Policy Committee (MPC) expected vegetable prices to correct in the coming months, but flagged the presence of uncertainties on the domestic food price outlook due to sudden weather events, possible El Nino conditions in August and beyond, and the firming up of global food prices. In this context, the MPC revised its inflation projection for current fiscal from 5.1 per cent to 5.4 per cent.

Cumulative rainfall during this year's southwest monsoon season till August 18, 2023 has been deficient by about 6 per cent compared to long period average. As on August 18, 2023, farmers have sown 102.3 million hectares, which is similar to the corresponding period last year's level and 1.1 per cent higher than the average of the last five years.

The monthly report from the finance ministry's Department of Economic Affairs further said that the agricultural sector is picking up momentum with significant advancement in monsoon and kharif sowing. The procurement of wheat and rice has been progressing well, increasing the buffer stock levels of food grains to ensure food security in the country.

With regard to investment, the report said the government's continued emphasis on capital expenditure is expected to drive growth in the coming years. The Union government in FY24 budget increased the capital outlay by 33.3 per cent, raising the share of capital expenditure in total expenditure from 12.3 per cent in 2017-18 to 22.4 per cent in 2023-24 (BE).

Measures implemented by the Union government have also incentivised states to increase their capex spending. States capital expenditure increased by 74.3 per cent YoY in Q1 of FY24 to complement Centre's capex increase of 59.1 per cent in the same quarter.

"Enhanced provision for capital expenditure by the government is now leading to crowding in of private investment, as evident in the performance of various highfrequency indicators and industry reports which highlight the emergence of the green shoots of a private capex upcycle," the report said.

The monthly review further said that the external sector requires monitoring for further strengthening the prospects in the face of active pursuit of industrial policies globally. Services exports continue to do well and are likely to continue doing so as the preference for remote working remains unabated, typically manifested in the proliferation of global capability centres.

At the same time, from a medium-term perspective, it is important to monitor the impact of new technologies, such as Artificial Intelligence, on the external demand for Indian services exports and the consequent impact on employment, it added.

### **Baramulla: Nowpora residents protest** against Jal Shakhti Dept over water crisis

BARAMULLA, AUG 22: Amid scorching heat, Nowpora Jagir village in north Kashmir's Baramulla district continues to grapple with a severe water crisis, with locals accusing the Jal Shakhti Department of negligence, saying the situation is worsening with each passing day.

The aggrieved residents while protesting over the issue told the news agency—Kashmir News Observer (KNO) that they are without drinking water supply for more than a month and alleged that the department hardly bothered to redress their genuine demands despite taking the matter several times into their consideration.

There is not a single day we approach the Jal Shakti Department. We are oftentimes assured of early redressal but nothing is being done," they said, adding that the most affected areas are Bedenhar, Mirangund and others.

Mohammad Rafiq, a protester, said, "We are facing an acute shortage of drinking water supply. The authorities have turned a deaf ear to our repeated pleas. They are making no effort to ease our difficulties."

The authorities are facilitating water supply to Sopore town and have forgotten the villages which are nearer to the plant, he said.

The residents also accused the Jal Shakti Department of providing them with "raw water". We have been left with no other option but to block roads, they said.

### Court Rejects Bail Of Person Allegedly Involved In Killing Of Six In 1996 For Voting For A Party

SRINAGAR, AUG 22: A court in Jammu and Kashmir's Bandipora district on Tuesday rejected the bail plea of a man accused of killing seven persons in 1996 for casting their votes in favour of a particular political party.

The accused, Muhammad Ayoub Dar, was absconding since the commission of the offence and was arrested in 2021. He also served in the Territorial Army before he was dismissed.

The court of principal sessions judge, Bandipora, rejected the bail application of Dar, a resident of the Hakabara area of Hajin in the north Kashmir district, citing the gravity of the charges against him.

Dar is accused of involvement in the killing of seven persons at the Saderkoot Bala area of Bandipora in the year 1996 when he along with others opened indiscriminate firing on a truck.

The court said that from the mate-votes in the favour of National Confer-



rial evidence on record, it is crystal clear that the accused was very much present on the date of occurrence in Saderkoot Bala.

"That due to this indiscriminate firing by these accused persons, seven persons were killed for only a single fault that they had cast their

ence," it added.

The court said it has arrived at the conclusion that in the given facts and circumstances, the personal liberty of the accused can be curtailed in the interest of society at large as well as taking into consideration the gravity of the charge against him.

"In view of the aforesaid discussion as well as the evidence produced during the trial before this court, the grounds stated by the learned counsel of the applicants are having no significance in the consideration of the bail application of the accused within the contours of Section 439 of CrPC," the court said.

 $\hbox{``Hence, the bail application moved'}\\$ by the accused person is rejected and be made part of the main file. The case law submitted by the learned counsel of the applicant is not applicable in the given facts and circumstances of the case," it said. (Agencies)

### **India To Be 150 Billion Bio-Economy By 2025: Dr Jitendra**

NEW DELHI, AUG 22: Union Minister of State (Independent Charge) Science & Technology; MoS PMO, Personnel, Public Grievances, Pensions, Atomic Energy and Space, Dr Jitendra Singh today said, India is set to achieve \$150 billion Bio-Economy by 2025, which stood at over \$100 billion in 2022.

The Minister was speaking, while overseeing the signing up of the 'Implementation Arrangement' between the Department of Biotechnology (DBT) and the United States-National Science Foundation (US-NSF) today in New Delhi. This was a follow-up of the discussion meeting held between Dr. Rajesh S. Gokhale. Secretary, DBT and Dr Sethuraman Panchanathan. Director, NSF in June. 2023 to discuss opportunities for developing 'Strategic Partnership' between DBT and US-NSF.

Dr Jitendra Singh recalled that during the recent visit of Prime Minister Narendra Modi to the US in June 2023, the leaderships of the both the countries called on their administrations to extend the existing partnerships to advanced biotechnology and biomanufacturing, and enhance biosafety and biosecurity innovation, practices, and norms.

Dr Jitendra Singh said, India's ever-growing Bio-Economy graph is going to contribute significantly to India's Overall Economy. He said, India has a 3-5% market share in the global biotechnology industry and it ranks 12th in the world in biotech and 3rd in Asia-pacific.

The Minister said, India has the 3rd largest Startups ecosystem globally; and the largest vaccine manufacturer. Moreover, India's ranking in global science and technology indices continues to rise and India has been ranked 40th among the innovative economies as per Global Innovation Index, 2022.

Dr Jitendra Singh pointed out that the Department of Biotechnology has created and nurtured a strong foundation in biotechnology innovation, research and manufacturing across segments such as bio-pharma, bio-services, agri biotech, industrial biotech, and bioinformatics through public-private partnership, Make-in-India and Atma Nirbhar Bharat initiatives of the Government.

Dr Jitendra Singh said, Indian Government has always supported technology-driven innovation towards the creation of a 'future-ready' technology platform in line with the Prime Minister Modi's vision of Aatmanirbharta and he congratulated DBT and NSF for building on the bilateral collaborations between India and USA through this Implementation Arrangement.

Dr Jitendra Singh said, the climate change, inadequate resource utilization, an unsustainable pattern of material consumption and waste generation are global threats and require concerted sustainable interventions and therefore called for futuristic research and innovation strategies for accelerating Biomanufacturing are essential to address global sustainable goals.

### Supreme Court Terms As "Unacceptable" Contention That Article 370 Ceased To Operate After 1957

**NEW DELHI, AUG 22:** The look at the Indian constituent which Article 370 was framed." Supreme Court Tuesday termed as "unacceptable" the submission that Article 370 of the Constitution ceased to operate once the term of the constituent assembly of Jammu and Kashmir ended in 1957 after drafting the state's Constitution. The remark by a five-judge bench headed by Chief Justice DY Chandrachud came when senior advocate Dinesh Dwivedi, appearing for intervenor Prem Shankar Jha, argued that nothing of Article 370, which accorded special status to the erstwhile state, survived once the Constitution of J-K was enacted on January 26, 1957 and the term of the state's constituent assembly ended.

Jha, who has challenged the August 5, 2019 decision of the Centre to abrogate Article 370, raised the legal question about whether Article 370 ceased to operate or exist after the enactment of the Constitution of J&K and the dissolution of the constituent assem-

This led the bench to raise queries on the legality of the submis-

The bench, also comprising Justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant told Dwivedi that the court has to

assembly debates and the intent of the makers of the Indian Constitution in a manner in which the Article 370 was framed.

"I am arguing somewhat differently from what my friends have argued. They want some part of Article 370 to survive. My argument is that nothing survives. All the powers conferred under Article 370, I would show, cease to operate once the Constitution of Jammuand Kashmir was enacted," Dwivedi said.

The CJI said the consequence of the argument will be that the Constitution of India and its application to Jammu and Kashmir would "stand frozen as of January 26,

"Therefore, no further development in Indian constitutional law can at all apply, according to you,  $to the state of Jammu \, and \, Kashmir$ after 1957. How can that be acceptable?" he said.

The bench told Dwivedi, "You are asking us to read what is not there in Article 370. Your submission is that it will be frozen after the constituent assembly of J-K frames the Constitution but that does not appear to be following. We have to look at the constituent assembly debates in a manner in Dwivedi said when the Article

was framed, Jammu and Kashmir was in turmoil and the only legal entity was the state government and, therefore, the provision said there should be "consultation and concurrence" on the matters related to Union and concurrent list and those which do not fall under the Instrument of Accession.

"The constituent assembly was about to be set up. Hence, all the decisions which were taken in consultation and concurrence with the state government were to be placed before the constituent assembly of J-K. Therefore, Article 370 was a temporary provision," he contended.

The senior lawyer said looking at the provision and the constituent assembly debates, it can be clearly inferred that Article 370 was temporary and ceased to exist after January, 1957.

The bench said what was being submitted was contrary to arguments advanced by others opposed to the abrogation as they said that the provision had acquired permanent status after the term of the state's constituent assembly ended.

"This is what is creating a problem. Perhaps our thinking in the manner which we have been tuned to think for the past 70 years is that there should be One Nation-One Constitution. But where is that prescribed? It should be prescribed in the Constitution which does not say so," the senior lawyer said.

CII Chandrachud then asked can the court say that a speech made by a member of the constituent assembly, however weighty, represented the commitment of India to Jammu and Kashmir.

"This will have a bearing on the interpretation of the Constitution", the CJI said.

Justice Kaul also questioned Dwivedi on his line of argument and said according to him, Article 370 was a defunct provision and no purpose was served having it.

"Yet the provision continued to bethereintheIndianConstitution. Constitution Orders (orders applying provisions of Indian Constitution to J-K) have been issued pre-1957 and post 1957. Yet nobody thought about removing it. The association of people with Article 370 was negatory and hence nothing survives. This is your argument?" Justice Kaul summed up Dwivedi's contentions.

Dwiveditold the bench that past practices would not justify the invalidity of a provision and this is a settled law.

"The law, as I understand, is that however long a past practice is if it is constitutionally illegal, it cannot be justified. What I am trying to show is the intent of our Constitution framers. We cannot read Article 370 dehors (other than) the intent is my question," he said.

Justice Kaul said it is difficult to accept that the constituent assembly debates amount to an assurance that Article 370 would dissolve itself after the Constitution of Jammu and Kashmir has been enacted and term of the state's constituent assembly comes to an

Senior advocate CU Singh, appearing for Mohammed Yousuf Tarigami and others challenged the enactment of the Jammu and Kashmir Reorganisation Act, 2019 and said the erstwhile state could not be divided into two union territories.

The hearing remained in conclusive and will continue on Wednesday. Several petitions challenging the abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh - were referred to a Constitution bench in 2019. ## Where have all the 'smart' cities gone?

AS MANY AS 1,100 SMART MOBILITY PROJECTS WORTH RS 22,785 CRORE HAVE BEEN COMPLETED, AND 984 PUBLIC SPACES DEVELOPED AT A COST OF RS 5,861 CRORE.

Remember the scramble 7-8 years ago after Prime Minister Modi announced the Smart Cities Mission (SCM) in June 2015. More than 18 months were spent in selecting the 100 cities that would make it to the list. City bureaucrats competed with pitches and ministers pulled strings in the Ministry of Urban Affairs. It seemed transformation of the blighted urban landscape was around the corner.

Eightyears down the line, the Smart Cities euphoria has waned. It is absent from election promises and in the bragging of ministers. The project was supposed to be completed by June 2021. After two extensions – the last one made in May this year - most of the 'smart' cities look much the same.

The report card submitted to Parliament in February this year however shows a pretty picture. As many as 7,804 projects worth over Rs 1.8 lakh crore have been sanctioned in 100 cities. Of these, 72 per cent of the projects worth Rs 1,07,000 crore were to be completed by April 30, 2023.

Around 232 projects worth Rs 15,000 crore relate to infrastructure development such as multi-modal transport hubs, multi-level car parking, and bike sharing. As many as 1,100 smart mobility projects worth Rs 22,785 crore have been completed, and 984 public spaces developed at a cost of Rs 5,861 crore.


### **Tardy completion**

On the other hand, Parliament's Standing Committee on Housing and Urban Affairs by April this year conceded as many as 68 'smart cities' had failed to achieve their targets by January 2023. The figures put out by the ministry are also misleading as 32 of the cities had completed more than their original quota of projects; and if one takes those away, the actual performance is even more dismal, the Committee noted.

So while Varanasi, Agra, and Udaipur had touched near 90% completion, many like Silvasa, Gangtok, Faridabad, and Shillong were struggling at less than 10% completion. "There have been astute attempts to manufacture a high project completion rate by completing small/lessvalued projects, which take lesser time," the parliamentary committee noted.

The revised report card in April 2023, as per the Parliamentary Standing Committee is: Against an allocation of a little over Rs 2 lakh crore to develop smart cities, as many as 5,343 projects worth over Rs 1 lakh crore have not yet been completed.

The Smart Cities Mission was doomed from the start as none of our astute planners ever chose to define what a 'smart city' is. The projects chosen were a mishmash of technology upgradation, mass, rapid transportation and building infrastructure. There were as many definitions



of a 'smart city' as there were planners.

A 'Smart City' in international parlance is all about improving cities through technology. It was initially coined by Scandinavian and West European city planners to refer to a new level of tech modernization – from well-synchronized traffic lights and intelligent homes to driverless transportation, all aimed at making cities more livable and efficient.

### 'Smart' technology

The best 'smart cities' of the world chosen by Earth.org this year include Singapore - which has excelled in evolving a digital health care system including video conferencing for the aged. Another city Zurich was selected for among other things its streetlights that adapted to traffic levels, and which increased brightness or dimmed using sensors. The project enabled an energy saving of up to 70%.

But India's Smart Cities Mission has been firing in a different direction – it includes technology but it also supports a fullspectrum city modernization programme. That is why it falters. It is neither strictly a tech ramp-up; nor is it focused on building basic civic infrastructure. India's erratic and unplanned growth of cities need holistic goals that include providing affordable housing, efficient public transportation and civic infrastructure. Building technology to create smart cities is only an adjunct to these more basic civic goals.

An old McKinsey & Company report on India's urban landscape predicts that 40% of the country's population or 590 million people will be residing in cities by 2030. Moreover, with the shift from agriculture to services, 70% of the new jobs being created would be in urban areas.

To make cities livable, McKinsey had estimated a massive \$ 1.2 trillion by 2030 in capital expenditure. The outlay of Rs 2 lakh crore or approximately \$25 billion on the Smart cities Mission is a small speck of what is required. At the micro level, sample this: Chandigarh in the first phase was allocated Rs 196 crore to fund smart water meters, a Wi-Fi zone and modern solid waste management. And it was all ploughed into one pocket - Sector 43.

"Today, in per capita terms, India's annual capital spending of \$17 is only 14% of China's \$116 and less than 6% of New York's \$292," reminds the McKinsey report. Indian cities today are hell-holes crushing the poor in hovel-like housing and long commutes that suck the life out of the bread earner. To transform these cities multiple and focused agencies have to work in tandem tackling infrastructure, education, housing and so on. The Smart Cities Mission in its present avatar is at best tinkering around.

### PM In South Africa For BRICS Summit, **Buzz Over Possible Xi Jinping Meet**

New Delhi: Prime Minister Narendra Modi landed in South Africa on Tuesday evening to take part in the three-day BRICS summit that begins from today. The visit comes amid buzz over a possible bilateral meet with China's Xi Jinping, which has yet to be confirmed.

Prime Minister Modi - who was warmly welcomed at the airport by Deputy President Paul Shipokosa Mashatile-will join China, Russia and hosts South Africa for the first inperson BRICS summit since 2019; the last three were held online because of the COVID pandemic.

Asked about a possible meeting with President Jinping on the summit's sidelines, India said yesterday the Prime Minister's schedule is 'still being developed'."We have a positive intent and an open mind when it comes to BRICS expansion," Foreign Secretary Vinay Kwatra said.

PM Modi's first official engagement will be at 4 pm local time (7.30 pm IST)-the BRICS' Business Forum Leaders' Dialogue. The Prime Minister is slotted to address the gathering for 10 minutes at 4.30 pm; President Jinping's 10-minute address is slotted for immediately afterwards. He will then attend the BRICS Leaders Retreat that will see Russian President Vladimir Putin participate via a video link. Possible topics for discussion at this event will be global developments and the BRICS membership expansion



issue.

Last month a senior South African diplomat said over 40 nations had expressed interest in joining the BRICS grouping, which represents around 40 per cent of the world's population. Argentina, Iran, Saudi Arabia, the United Arab Emirates, Cuba, the Democratic Republic of Congo, Comoros, Gabon, and Kazakhstan have all expressed interest, officials

As PM Modi left for the summit, he said he hoped the meeting would provide a useful opportunity for all members to 'identify future areas of cooperation'. "... BRICS has become a platform for discussing and deliberating on issues of concern for the Glob-

al South." Buzz about a possible Modi-Jinping bilateral meeting Xi Jinping on the summit's sidelines come as Indian and Chinese troops remain locked in

confrontation in parts of eastern Ladakh despite disengagement at some others following extensive diplomatic and military talks.

Last month, National Security Advisor Ajit Doval met Chinese Foreign Minister Wang Yi on the sidelines of a meeting of BRICS nations in Johannesburg and emphasised the importance of continuing efforts to fully resolve the situation and restore peace in the border areas.

India-China ties deteriorated following a fierce clash in Ladakh's Galwan Valley in June 2020 that marked the most serious military conflict between the two countries in decades.

After a series of military and diplomatic-level talks, the two sides completed the disengagement process in 2021. However, India maintains that ties with China cannot be normal unless there is peace in the border

### **Union Minister Raises Concerns Over Preserving Manuscripts In Northeast**

New Delhi: Union Minister Rajkumar Ranjan Singh has asked Culture Minister G Kishan Reddy to explore the possibility of setting up a record centre of the National Archives for northeast states.

Mr Singh, the Minister of State for External Affairs and one of the two MPs from Manipur, in a letter to the Culture Minister said researchers in the northeast often face problems in collecting primary sources from the states' archives, and they have to eventually travel to Delhi to access the National Archives."This involves abundant cost, ample time required and enormous effort, which many of the scholars can ill afford," Mr Singh said in the letter to Mr Reddy, who is also the Minister of Development of North Eastern Region (DoNER)."It is high time and genuinely felt need that a record centre of the National Archives of India for the northeast states be ordered to be established at a convenient site in Imphal, Manipur. There was an initiative to set up such a record centre in the northeast in the year 2000, but the demand has remained unfulfilled," said Mr Singh, whose house in Manipur's capital Imphal was set on fire and vandalised by a mob on June 15



amid the Meitei-Kuki ethnic clashes.

Mr Singh raised concerns about losing precious ancient manuscripts of the northeast due to mishandling or lack of infrastructure for safekeeping.

"... There are numerous collections of Puya text (old manuscripts) written in archaic Manipuri language as well as religious scriptures written in Sanskrit and Buranjis of Assam requiring serious attention towards their scientific preservation," Mr Singh said in the letter.

### India's "Biggest Asset" In Pakistan Is Congress's Mani Shankar Aiyar

New Delhi: Batting for resumption of dialogue with Pakistan, diplomatturned-politician Mani Shankar Aiyar says India won't be able to take its due place in the world as long as its western neighbour is an "albatross around our necks".

The Congress leader, who served as India's consul general in Karachi from December 1978-January 1982, has dedicated a full chapter to his Pakistan stint in his autobiography "Memoirs of a Maverick -- The First Fifty Years (1941-1991)" that hit the stands on Monday.

In an interview with Press Trust of India on his new book, published by Juggernaut Books, Mr Aiyar said the high point of his bureaucratic career was undoubtedly his stint as consul general in Pakistan and he has dwelt at very great length on his three



years in Karachi in the first volume out now.

India's "biggest asset" in Pakistan were the people there who did not consider it an enemy country, he said.

"We were coming back from a dinner one day, within the first two-three weeks of the posting, when my wife Suneet asked me a question that reverberated in my mind in my stay in Karachi - 'This is an enemy country, right'?" Mr Aiyar said he asked himself the question through his three years there and for the last 40 years since he came back from Pakistan.

"I have come to the conclusion that whatever may be the view of the sections of the army, or sections of polity, as far as the people of Pakistan are concerned, they are neither an enemy country nor do they regard India as an enemy country," he claimed in his interview

to Press Trust of India. "Every time we want to display our disapproval of the(Pakistani)government, visas are stopped, films are stopped, TV exchanges are stopped, books are stopped, travel is stopped, so I don't see why we do not know how to leverage the goodwill of the people of Pakistan as an integral part of our diplomatic approach," Mr Aiyar added.

For the last nine years all dialogue between India and Pakistan has been frozen, he noted.

"Until Mr (Narendra) Modi became prime minister of India, almost every prime minister, if he had the time, was attempting some kind of a dialogue with the Pakistanis but now we are in a freeze and the victims of this freeze are not the army of Pakistan which is still swigging its scotch, it is the people of Pakistan whose relatives in large numbers live in India and many of whom have a desire to visit our country," he said.Mr Aiyar said that during his diplomatic stint in Karachi, he issued three lakh visas and did not get a single complaint of misuse.

"So why are we targeting the Pakistani people? You can target the Pakistani establishment if you want to, but as far as the people.

### **Delhi Officer Drugged** Friend's Teen Daughter, **Raped Her: Police Sources**

New Delhi: The teen girl raped multiple times by suspended senior Delhi government official Premoday Khakha was drugged before each act of sexual abuse and, on one instance, woke up to injuries on her body, police sources said Tuesday as more details emerge of this shocking crime. Police sources also said the young girl - then 14 years old - was depressed after her father died in 2020. The father died at the height of the pandemic but not due to Covid, the sources added.

According to the police, the first rape occurred on October 31, 2020. This was likely just days after the young girl - traumatised by her father's death - was packed off to Khakha's home in Burari in northeast Delhi by her mother - less than two weeks later. The mother said the

official had convinced her she would be safe in his care. Police sources have said the teen was raped at least once more during her five-month stay in Burari - in February 2021. A month later she went to Jharkhand for a family

function and did not return to Khakha's home. In her statement to the police, the girl said Khakha used

to molest her in church as well as his home. The police say the teen girl - now a Class XII student suffered frequent panic attacks after her father died, forcing her to drop out of school after Class IX and enroll in an open learning institution. It is likely, police sources say, the twin trauma - the father's death and the rapes left her unable to alert authorities to the sexual abuse

### **Erdogan blames UN** peacekeepers after Cyprus assault HT News Network

ANKARA: Turkish President Recep Tayyip Erdogan on Monday accused United Nations peacekeepers of instigating violence in which several members of the agency's mission were assaulted on Cyprus.

The United Nations said Turkish Cypriot forces on Friday attacked peacekeepers who were attempting to block construction of a road in the buffer zone separating the divided east Mediterranean island.

The confrontation occurred in an ethnically mixed village in the UN-patrolled area between the internationally recognised Republic of Cyprus in the south and the breakaway Turkish Cypriot statelet in the

The breakaway government is recognised internationally only by Turkiye. Erdogan accused the UN force of illegally moving into Turkish Cypriot territory to halt the construction of the road. "The physical intervention of the UN forces on the territory of [northern Cyprus] last Friday is unacceptable," Erdogan said in his first public remarks about one of the most serious incidents of its kind on the island in years.

### Firefighters in Greece battle blazes fanned by gale force winds

ATHENS: Hundreds of firefighters struggled to contain wildfires fanned by gale force winds in several parts of Greece on Monday as authorities warned most regions faced a high risk of new blazes.

More than 200 firefighters backed by 17 aircraft were battling a wildfire burning for the third day near the northern port city of Alexandroupolis, where 13 communities were evacuated as a precaution since the fire broke out on Saturday, the fire brigade said.

Cyprus said it was sending two firefighting aircraft. "We are in a state of alert, as we will be tomorrow, due to very high temperatures and gale force winds," fire brigade spokesperson Yannis Artopios said.

"We are facing extreme phenomena," he said. A man was found dead in a wildfire raging north of the Greek capital Athens on Monday, firefighters said. "An old shepherd ran to his sheepfold to save the animals and was retrieved dead," a spokesman from the fire brigade said in Boeotia, about 100 kilometres

The three leaders said in a joint statement on Friday they opposed the "dangerous and aggressive behaviour" of China in maritime disputes in the East and South China Sea. Beijing hit back on Monday, saying the leaders had "smeared and attacked China on Taiwanrelated and maritime issues, grossly interfered in China's internal affairs and deliberately sowed discord between China and its neighbours". Beijing says leaders interfered in internal affairs and deliberately sowed discord between its neighbours

It also expressed "strong dissatisfaction and firm opposition and has lodged solemn representations with relevant parties", foreign ministry spokesperson Wang Wenbin said at a regular news briefing.

# Russian strikes kill eight 'fighters' in Syria

BEIRUT: Eight fighters died on Monday in Russian air strikes targeting a rebel base in Syria's northwest, the last major bastion of armed opposition to President Bashar al Assad's rule, a war monitor said.

Moscow's intervention since 2015 has helped Damascus claw back much of the territory it had lost to rebel forces early in the 12-year civil war, and Russian forces have repeatedly struck the Idlib area.

Early on Monday, "Russian warplanes carried out air strikes on the western outskirts of Idlib city, targeting a military base belonging to Hayat Tahrir al-Sham (HTS)... killing at least eight fighters," said Rami Abdel Rahman, head of the Syrian Observatory for Human Rights.

Several other fighters were wounded in the strikes, with some in critical condition. said the Britain-based monitor which relies on a wide network of sources inside Syria. Demonstrators take to the streets again

### West Africa bloc rejects Niger's three-year transition plan

NIAMEY: West African nations have rejected a call by Niger's coup leaders for a three-year transition back to democracy, as the crisishit country's neighbours weigh whether to take military action.

General Abdourahamane Tiani has declared he will hold off a return to civilian rule after army officers toppled President Mohamed Bazoum last

His announcement came after a delegation from the West African regional bloc ECOWAS, which has threatened to use force to reinstate Bazoum, visited Niger in a final diplomatic push.

"The three-year transition is unacceptable," Abdel-Fatau Musah, ECOW-AS commissioner for politics and security, told Al Jazeera in an interview broadcast on Monday. "We want constitutional order to be restored as soon as possible.'

In a televised address on Saturday, Tiani accused ECOWAS of preparing to

attack Niger by setting up an occupying force in collaboration with a foreign army, without referencing

### Trump will skip Republican presidential debates

WASHINGTON: Donald Trump said on Sunday he will skip this week's first Republican presidential debate, arguing that Americans know him well so there's no need for a public showdown with his rivals for the White House.

In a message on his platform Truth Social, Trump touted what he called a hugely successful record as president and what he described as his popularity among the American people.

"I will therefore not be doing the debates!" he said. The first debate in the race for the 2024 Republican presidential nomination is scheduled for Wednesday in Milwaukee,

In his post, Trump noted the latest in a wave of polls showing him far, far out ahead of the Republican field, this one by CBS News published on Sunday.

It said 62 per cent of those polled for the survey would vote for him even though he has been indicted four times this year, including on charges he tried to subvert US democracy by scheming to overturn the 2020 election and stay in power despite his loss to Joe Biden.

Trump's closest contender in the CBS poll was Florida Governor Ron DeSantis at 16pc. The rest of those in the field are polling in the single digits. Trump wrote that DeSantis is "crashing like an ailing bird." "The public knows who I am & what a successful Presidency I had," Trump said, citing issues including energy, border security and the military, and the economy. The 77-year-old



former president, who is rarely out of the headlines, had been vocal about possibly skipping the debate in the midwestern city of Milwaukee, wary of sharing the limelight with lower-polling rivals.

The New York Times reported on Friday that Trump had told aides he was planning to upstage his rivals by skipping the event, organised by Fox News, and instead sit for an online interview with one of Fox's former hosts, Tucker Carlson.

Even in his absence, Trump will be ripe for broadsides from opponents over the four criminal and three civil trials he faces involving allegations before, during, and after his scandal-plagued presidency.

"Obviously, his legal issues are affecting this race," Fox News host Bret Baier, who will be moderating the debate, told the Milwaukee Journal Sentinel.

"All these candidates have been asked non-stop about what's happening in courtrooms around the country. So he'll be a part of this debate whether he's there or not." Seven other candidates have qualified for the debate, including state governors DeSantis and Doug Burgum, former vice president Mike Pence.

# High heat can serve up food insecurity within days, says study

PARIS: Amid record-high temperatures globally, a study on Monday reveals that a few days of searing heat can be enough to prevent billions of people already living hand-tomouth on daily wages from putting food on the table.

A week of extreme temperatures in India, for example, means an additional eight million people will likely experience serious food insecurity, according to findings published in the journal NatureHuman Behaviour.

Spread across 150 countries examined - especially in tropical and subtropical zones — that same heatwave translates into millions of men, women and



children at risk of hunger, even if overall food precar $ity \, is \, increased \, by \, less \, than \,$ one per cent, they found.

The World Bank estimates that nearly 30pc of the global population suffered moderate or severe food insecurity in 2022.

World Bank estimated last year nearly 30pc people globally suffered food insecurityAnalysis of heat impact on food availability is usually limited to decreases in crop yields, with the effects felt over months or years. The new study, however, reveals that the impact can be immediate when it is tied to income."If it gets hot today, there might be food insecurity within just a few days because people can't work, which means they can't earn income and afford to

buy food," lead author Car-

olin Kroeger of Oxford Uni-

versity.Such outcomes are

typically greatest in jobs where pay is closely tied to productivity, such as for agricultural harvests or piece-rate work. Female brick carriers in

West Bengal, for example, are paid by the number of bricks they carry a day. ### Hitler's birth house to be redesigned

VIENNA: The redesign of Adolf Hitler's birth house will go ahead as planned, starting on October 2, Austria's interior ministry said on Monday, after a documentary aired new claims about the late Nazi dictator's wishes for it. Following years of legal wrangling, the government decided to turn the house in the northern Austrian town of Braunau, where Hitler was born in 1889, into a police station with a human rights training centre.

In a bid to prevent the building on the border with Germany from becoming a neo-Nazi shrine, the government took control of the dilapidated building in 2016. The expropriation ended a bitter saga between the state

and the former owner. "The construction (to convert the house) is scheduled to start on 2 October 2023," an interior ministry spokes-

man confirmed. "Everything will go ahead as planned," he added. But Austrian director Guenter Schwaiger, who is due to release a documentary about the house in late August, said the ministry's plans for the house's future use will

"always be suspected" of being "in line with the dictator's

wishes". As evidence Schwaiger cited the discovery of a local newspaper article from 10 May 1939, which states that it was Hitler's wish to have his birth house converted into offices for the district authorities.

ew research found an association between a daily serving of nuts and reduced depression

The researchers say they aren't sure why the connection exists. Experts speculate that nuts

contain specific nutrients that

may support mental health. A serving of nuts a day could help keep depression at bay.

According to new research, a serving of nuts (30 grams) per day is associated with a 17%

reduced risk of depression. A small handful of nuts, or 30 grams of nuts, equals about:

The findings of the study were published July 26 in the journal

Clinical Nutrition, How does nut consumption affect mental health?

For the study, researchers xamined data from the UK Biobank cohort, an online database of medical and lifestyle records.

From this database, over 13,500 Britons without self-reported depression or antidepressant use aged 37-73 between 2007 to 2020 were included in a comparison



analysis People in the study who consumed a serving of nuts daily were less likely at follow-up roughly five years later to have

developed depression. The findings do not clearly indicate why nuts were associated with this reduced risk.

However, researchers and experts speculate protective nutrients in nuts play a role.

Their results also suggest the likelihood of developing depression is also lower among adults in the United Kingdom with healthy weight, healthy lifestyle, and overall general health.

Nut consumption linked to

healthy lifestyle behaviors "Emerging research is uncovering the profound influence of our dietary habits on our mental health, particularly pointing to a strong gut-brain connection," said Kelsey Costa, a registered dietitian and nutrition consultant for the National Coalition on Healthcare.

"These findings underscore the potential of our dietary choices in steering our mental health, highlighting nutrition's pivotal role in our psychological well-

ness," she tells Healthline. However, it is important to

highlight that this is a prospective study that watches for outcomes over a certain period of time.

"As such, results can only establish a correlation (not causation) between factor and outcome," said Dr. Gabrielle Lyon, a functional medicine practitioner, founder of Muscle Centric Medicine, and author of the forthcoming book, "Forever Strong: A New, Science-Based Strategy for Aging Well."The cause or etiology of mood disorders is multifactorial and can rarely be reduced to a single factor, she adds.

For example, Dr. Lyon says those individuals who eat more nuts may also engage in other health-promoting behaviors like exercise and good sleep hygiene, which will also decrease their risk for mood disorders.

Which types of nuts help educe depression risk?

"While the study does not explore the reasons for the correlation between nut consumption and lower risk for depression, nuts' anti-inflammatory and antioxidant properties may contribute to the observed benefits,"

Costa said.

"The substances in nuts can help our body better manage stress, improve our gut health and promote brain health," she explained. "Hence, eating nuts could be a helpful dietary strategy for preventing and managing depression."Walnuts are known for their high omega-3 content and are of notable interest when studying depression.

"Omega-3s, integral to brain function and development, exert anti-inflammatory and antioxi dant effects, potentially alleviating depression risk," Costa said.

"By influencing the creation and performance of mood-regulating neurotransmitters, such as serotonin and dopamine, regular consumption of omega-3-rich walnuts may aid in mood improvement and decrease depression symptoms," she add ed.One observational 2023 sudy-Trusted Source found that omega-3 supplementation was associated with significant improvement in symptoms of depression in people with mild to moderate depression.

### **How Getting the Right Treatment Helped** Danielle Jonas Manage Painful Eczema

hile pregnant with her second child with musician Kevin Jonas of the acclaimed Jonas Brothers, Danielle Jonas started experiencing symptoms of eczema.

"I started feeling things and thought it was just pregnancy...and had the baby and then [the symptoms] never stopped," she told Healthline.

When Danielle's itchiness, redness, and discomfort didn't go away, she decided to seek out help from her doctor, who diagnosed her with moderate eczema, a chronic skin condition characterized by intense, persistent itching and burning, itchy rashes that can crack, crust, or ooze and cause

discoloration. "I had an underlying condition that brought out my moderate eczema," said Danielle. "I just felt it all the time... it made me feel not myself at all and so I just stayed home with the kids," she said.

The emotional effects of eczema can be profound

Kevin witnessed how eczema added stress and anxiety to his wife's already busy life which was packed with mothering their two daughters, running a jewelry line, writing children's books, and managing the scrutiny of being in the public eye.

[Dealing] with moderate eczema and having to feel all those things and not feel yourself. She would stop going to shows with me. We would stop



doing events certain ways and I'd just do what I had to do, and this was my teammate," said Kevin.

The emotional and mental effects of eczema can be profound, said Dr. Michele Green, cosmetic dermatologist at Northwell Lenox Hill Hospital.

"Uncontrollable itchiness can disrupt sleep, leading to moodiness and irritability," she told Healthline. "Individuals with eczema are more likely to isolate themselves from social interactions and activities to hide their appearance or itching behav-

Many people spend a lot of time coping with persistent and often debilitating symptoms, added Dr. Annabelle Garcia, a dermatologist at Sonterra Dermatology.

"Everyday tasks can be difficult for people with the disease, and sometimes activities that many of us take for granted, like brushing hair, going out with friends, or taking a shower, can be tough," she told Healthline.

Around the time Danielle began having symptoms, she also began experiencing hair loss. However, she said it is unclear if losing her hair was directly a result of having eczema.

"Every time I took a shower it was clumps [coming out] and...I would get more stressed out seeing that and then the symptom got worse," she

The connection between eczema and hair loss

While eczema does not directly cause hair loss, Green said seborrheic dermatitis, a chronic form of eczema, which often develops on the scalp, can present as dandruff or a rash, leaving the scalp flaky, red, and

"The excess sebum produced can trigger an overproduction of Malassezia, a yeast that naturally develops on the skin. Although seborrheic dermatitis does not directly cause hair loss, if left untreated, excessively high levels of Malassezia can further inflame the skin, resulting in hair follicles being unable to push new hair through," she said.

Additionally, excessive itching on the scalp can lead to hair follicle damage and hair strands accidentally being ripped out, she said.

Any kind of inflammation on the scalp can impact the hair follicles, which can result in hair shedding or hair loss, Garcia added.


