

Jammu SIA nabs another key accused in Narco terror case

JAMMU, AUG 25: The sleuths of State Investigation Agency on Friday claimed to have arrested another key accused wanted in a Narco terror case in Poonch district of Jammu and Kashmir.

The sources in the SIA here said that on May 30, 2023, an attempt was made by four associates in a narco terror module to smuggle drugs and explosives into India from across the border fence in Poonch district of Jammu and

The accused persons were intercepted by the Army and apprehended with arms, ammunition, IEDs and Heroin, they said.

Sources added that upon investigation it was revealed that the group of four persons (of which one had absconded from the spot) were being supervised by key accused Mohammad Javed who was recently arrested by SIA in Delhi.

"Upon technical surveillance and human intelligence, it was ascertained that Liyagat had played an important role in planning the entire conspiracy with Mohammad Javed and other accused persons," sources said.

Need To Find Feasible Ways To Boost Adoption Of Modern Technologies In Construction: Puri

NEW DELHI, AUG 25: Housing and Urban Affairs Minister Hardeep Singh Puri on Friday said more than 60 crore people are estimated to reside in cities by 2030 because of rapid urbanisation and stressed the need to increase adoption of new technologies in the construction industry.

The minister was addressing a conference on 'Adoption of New and Emerging Building Materials and Technologies in Construction Industry', being organised by realtors' apex body CREDAI, which represents more than 13,000 developer members.

"It is imperative we find feasible ways to increase the adoption of emerging materials



and technologies in the construction industry," Puri said.

Meanwhile, he instructed District Administrations to take up beautification works of towns for aesthetic upgradation. He emphasised that most of the beautification works do not require much funds and small interventions can uplift the face of towns. He further asked them to take on other developmental projects to enhance the infrastructure development.

Moreover, he also reviewed various issues pertaining to PM Package employees.

Navyug and Chenani-Nashri Tunnels for a period of 15 days was considered.

While making his observations regarding remedial measures for smooth flow of traffic on the road, the Chief Secretary said that HMVs lower than 3-axles should not be halted anywhere during its travel on the road. He asked for keeping an eye on chronically slow moving vehicles and enquire from each of them about the reasons behind the same. He also advised for penalizing those erratically moving vehicles under law caus-

ing inconvenience to others traveling on this road. Dr Mehta impressed upon the concerned highway authorities along with the Deputy Commissioners to designate no halt zones in their respective jurisdictions and strictly adhere to same under all circumstances. He asked them to take measures for improvement of the road surface near the slide-prone stretches at Dalwas, Mehad, Cafeteria Morh and Sher-Bibi. He further instructed for designating the halting areas for trucks especially in the Ramban District where the widening of road is still in progress.

The Chief Secretary insisted on having better coordination between the traffic and District police. He told them to provide the best gear to the traffic personnel manning the traffic on these stretches where work is going on. He asked for putting extra men into service for effective monitoring and management of the traffic plying on

Regarding the movement of fruit trucks from valley the Chief Secretary stressed on taking onboard the Fruit Associations while devising the traffic plan. He asked for marking the fruit laden trucks with specially designed stickers for their identification and giving unhindered access to reach the Mandis outside. He directed the Deputy Commissioners of valley to establish District Control Rooms in their offices for giving real time updates to the fruit growers about the road and other issues.

While making his remarks the ACS, Home, RK Goyal stressed on finding out ground realities which are hindering the movement of HMVs in certain portions. He also told them to utilize the alternate assets like Mughal Road and Jawahar tunnel optimally to reduce congestion of traffic on NH-44. He also asked for enhancing the level of enforcement especially on the critical stretch-

 $The {\it Principal Secretary}, PWD, Shailendra Kumar$ observed that efforts should be made by the con-

cerned to reduce the gap between minimum and maximum time taken by the vehicles to cross the Chenani-Banihal stretch. He also advised for making vehicles to move continuously without any halts and use of lean window (between 1:00 am to 5:00 am) optimally by diverting most of the heavy vehicles to cross the 2-lane stretch during the underutilized time period.

In his presentation the IG Traffic, Bhim Sen Tuti highlighted the pattern of traffic on the highway through various studies and algorithms. He presented the day wise and seasonal behavior of traffic along with the analysis of time taken by each class and size of vehicle. He also dwelt upon the causal analysis of each aspect of this traffic behavior and put forth certain remedial measures

The meeting discussed about Passenger Car Unit (PCU) analysis of traffic on this road besides hourly and daily rush of traffic using google data of previous years also. The meeting also took note of the data of vehicles traversing the Navyug and Chenani-Nashri Tunnels besides examining speed of vehicles throughout their journey between them.

It was inferred that by taking measures like enhancing the time window for plying of heavy vehicles (above 4-axle) during night and letting the rest of the traffic to move continuously would greatly reduce their travel time. It was also enjoined that by dedicating the infrastructure projects like 2nd tubes of Kunfer tunnel, Chanderkot tunnel and Ramban flyover by the month of September would bring huge respite to all the travelers in the davs to come.

addiction, anxiety-related issues as it has received more than 23,000 calls since its inception in Jammu and Kashmir nine months ago.

The first-of-its-kind mental health helpline, launched on November 4, 2022, is a three-tier system that has mental health counselors, clinical psychologists and psychiatrists available for patients' calls.

Talking to the news agency—Kashmir News Observer (KNO), Dr Qazi Haroon, State Program Manager Mental Health J&K said that till date over 23,200 calls including those related to stress, drug addiction, suicidal tendencies and anxiety have been received.

Among these, around 600 were very distressing calls having suicidal tendencies who were counselled on time, he added.

"Tele-MANAS helped us to reach so extensively to common people in such a short period of time. In the near future, more and more people suffering from mental health will find refuge in it." Dr Haroon said.

He said India's first Tele-MANAS chatbot, designed to engage with people in distress, that was launched in Jammu & Kashmir last month has managed to provide assistance to around 150 youngsters so far.

"The Chatbot provides round-the-clock access to health counsellors, clinical psychologists, and consultants." he added.

The doctor said that Chatbot encourages individuals to avail the benefits of this service from the comfort of their homes, addressing privacy concerns and promoting accessibility.

Meanwhile, officials said that due to stigma, people are not seeking psychiatric help. They, however, said that Tele-MANAS has reduced the stigma attached to mental health issues as callers don't need to reveal their identities.

"Such facilities are being enhanced with an aim to reach to more and more people as around 11 percent of the adult population suffers from mental illness in J&K," the officials said.

The toll-free number of Tele MANAS Cell I&K is 14416/1-800-891-4416 and for Tele MANAS Chatbot is 9797600601. The cell is open to the general public for providing mental health services and drug de-addiction services 24x7.

While briefing the media, the Divisional Commissioner said that these installations are not unique to Jammu and Kashmir but are being carried out across the nation. He explained that Smart Meters offer connectivity and are designed to empower end consumers by curbing power loss.

The Div Com informed that a meeting with Civil society was held in which it was decided to install check meters (old digital meters in parallel to Smart meters) to verify the readings. "The Meters have been installed in a warehouse area where it was found that readings are the same. The same practice would be replicated in other areas for the satisfaction of consumers" he added.

With over 80% of the installation work already completed in Jammu, the Div Com emphasized the progress made by Techno and Envil, the two certified companies responsible for the installa-

Clarifying the reasons for occasional high bills, he clarified that any discrepancies in bills were due to past pending amounts and he assured the public that the new system's bill cycle has been rectified.

"A dedicated grievance redressal cell has also been established, with an impressive 90% complaint resolution rate. Additionally, flexibility has been introduced in Smart Meter installation heights. making it possible to install them on the wall of consumers if suitable conditions are met", he explained.

It was informed that a committee headed by Additional Deputy Commissioner Jammu consisting of Officials from Revenue Department, volunteers from Red Cross Society, Civil Society has also been constituted to receive grievances and redress the same at the earliest.

Responding to the issue of prepaid meters, the Div Com clarified that in the phase 1st only Smart meters would install. Prepaid meters are not yet

"To facilitate a seamless and transparent installation process, the JPDCL officials will accompany the vendors at the time of meter installation to dispel doubts of consumers", Div Com said.

Managing Director JPDCL, Shivanant tayal, also cleared the queries raised by the media persons.

The ADGP briefed the media about the concerns related to Toll Plaza. "PM Modi opened the Space sector just over 3 years back and today there are more than 150 private Startups," he said.

Dwelling on Administrative Reforms, Dr. Jitendra Singh said many reforms have been initiated by PM Modi in the last nine years.

"During the Covid period, life came to a standstill, but there was no delay in the Government of India's administrative machinery, because we had already gone digital while others were just preparing for it," he said, referring to transfer of benefits to the common man through DBT.

Dr Jitendra Singh said the Prime Minister gave us the mantra of 'Minimum Government - Maximum Governance'. The DARPG took initiatives such as the practice of Attestation by Gazetted officers was done away with, Interviews were scrapped abolishing malpractices. Most of the functioning was converted online and in order to bring in transparency, accountability and citizen participation, the human interface was reduced to the bare minimum.

The Minister said, DoPPW introduced Digital Life Certificate (DLC) and later the Aadhar based scheme for online submission of DLC. Initially submission of DLCs was through biometric devices and now the Face-Authentication Technologybased system based on UIDAI Aadhaar software has been introduced.

Speaking about the transparency and accountability in the governance, the Minister said that

the benchmark for clean and effective government is the robust grievance redressal mechanism. The CPGRAMS receives about 20 lakh grievances every year in comparison to just 2 lakhs annually earlier because this government followed a policy of time bound redressal and gained the confidence of the people.

Dr Jitendra Singh listed DigiLocker and SVAMITVA scheme bringing transparency in land registry, among technology driven reforms towards Ease of Living.

"Our goal is to gear up and work towards making India a developed nation by 2047, and we will accomplish this with speed and scale, leveraging the potential of digital transformations in e-governance," he said.

"J&K Waqf Board has decided to recruit people who holds degree in Islamic Studies and can lead Islamic prayers and congregations well. We want to revive this culture in Kashmir onwards. We will invite applications and interviews in this regard will be conducted soon," she said.

She said Waqf will also replace elders from young ones. "It is a prime demand from public. We will look into the matter and situation will be addressed on priority basis. We respect our Imam's and Preacher's but there should an age limit to serve the community. Those who will lead prayers and congregations should be under age and degree holders," she added.

older technologies into new cutting-edge technologies in the construction industry. On its part, the ministry has short-listed 54 innovative construction technologies from all over the world under the Global Housing Technology Challenge and six light house projects were selected in Chennai, Rajkot, Indore, Lucknow, Ranchi and Agartala under

innovative construction technologies. "With these light house projects, I believe that the Modi government has laid down the roadmap for the construction industry to reorient itself and support the vision of the Prime Minister in achieving net zero emission by 2030," Puri said.

He cited various benefits of the use of new technologies in these six projects — 50 per cent reduction in construction time, 15-20 per cent saving of cement, 20 per cent reduction in construction waste, 10-20 per cent reduction in cost of construction, 20-25 per cent enhanced thermal comfort, 4-Star green GRIHA rating, low lifecycle cost, 20 per cent reduction in energy and 35 per cent reduction in GHG emissions, among others.

The project in Chennai, comprising 1,152 houses, was completed in a record 12 months. The project in Rajkot, consisting of 1,144 houses, has also been delivered and the remaining four projects will also be completed shortly, he said.

"India in 2030 will have an urban population of over 600 million. Cities, as the hub of economic activity, will be responsible for more than 70 per cent of the country's GDP by 2030," Puri said. With rapid urbanisation and faster economic growth, the minister said there will be a lot of business potential for the construction and real estate industries in the next two decades or so. He asked the industry players to gear up to encash this growth opportunity.

At the same time, Puri said cities are also major contributors to climate change.

The United Nations Environment Programme (UNEP) estimates that cities emit up to 75 per cent of the global CO2-equivalent emissions globally. Buildings and urban transport are amongst the largest contributors. He expressed confidence that India will

be second globally in the metro network. "We are slowly but surely on the way to establishing the world's second largest metro system. That's going to happen before too long," he said, adding that much of the acceleration in building metros has happened in the last nine years.

"The Modi government has viewed urbanisation as an opportunity for multifaceted growth. India boasts to have one of the most comprehensive programmes for planned urbanisation," he said.

On the Pradhan Mantri Awas Yojana-Urban (PMAY-U), Puri said this mission has not only addressed the issue of affordable housing for India's urban poor but has also created sustainable and green infrastructure.

The PMAY-U has emerged as one of the largest affordable housing schemes in the world by sanctioning more than 1.18 crore houses. Out of these, work has started for 1.13 crore houses and more than 76 lakh

houses have been delivered to beneficiaries.

"About 43.3 lakh houses under the mission are being constructed using sustainable building materials such as fly ash bricks/ blocks and AAC blocks. These houses will contribute to a reduction of 9 million tonnes of CO2 emissions by the end of December 2024," Puri said.

Housing and Urban Affairs Secretary Manoj Joshi said there is a need to take new technologies to smaller cities.

Joshi said state-owned NBCC and CPWD (Central Public Works Department) will use new technologies for the construction of government buildings.

CREDAI Chairman Manoj Gaur and CREDAI President Boman Irani also spoke about the initiatives taken by the association to promote green buildings. (Agencies)

rates. These people living in the upper villages of the Budgam said they have taken it upon themselves to maintain the traditional practice of brick-making. But for that to happen, the government needs to provide the necessary firewood resources, which are necessary for the revival of these kilns on a larger scale, they said.

"The huge increase in brick prices has impacted the construction projects, housing and infrastructure development," said Ghulam Hassan, a resident of Neegu, Budgam.

He said the local residents are struggling to afford the materials required for building their houses. "The revival of traditional brick kilns provides a chance for skill survival and local entrepreneurship in addition to providing a cost-effective alternative to the inflated brick costs," he said.

In these uncertain economic times, the trade of brick-making, which has been passed down through the years, may prove to be quite useful, Hassan added.

Another local, Bilal Ahmad, however, said the availability of firewood, an essential component in the brick-making process for curing bricks in fire, is critical to the success of this grassroots task.

He appealed to the government to provide them with the required supplies of firewood. This support would enable local communities to take control of their own economic wellbeing in addition to assisting in the revival of traditional brick kilns, he said.

Bilal said these bricks are not only inexpensive but also durable as bricks cured in kilns. "If this culture could receive more attention, a large quantity of pollution could be eliminated, and these bricks could cost only half as much as bricks baked in kilns," he said. The government can help revive the traditional practice since it has the potential to reduce the financial burdens of the people of the village and give them more control over their own economic future.

Leaking pipes, lack of smart classroom and hostel facility at Tribal school in Kulgam

KULGAM, AUG 25: The Eklavya Model Residential School at Tangmarg area of Dambal Hanjipora in

Kulgam, which was inaugurated by Lieutenant Governor Manoj Sinha last year is facing multiple issues, leaving the students with a multitude of challenges.

The school set up at an estimated cost of Rs 17 crore was aimed at providing quality education to the tribal students of the area. But the several problems plaguing the school is affecting education and safety of students.

A teacher pleading anonymity told news agency—Kashmir News Observer (KNO) that one of the major problems is leaking water pipes inside the building. "This has caused inconvenience to the students as they have to constantly deal with wet floors and walls," the teacher added.

He said the female students in the school do not have a female warden, undermining their privacy, safety and well-being.

"The school is located in a forested area and there is a risk of wild animal attacks because of absence of a boundary wall for the school. "We are always in fear of some wild animal coming into the school especially at night," the teacher said.

The lack of staff also hampers the educational experience in the school as only four teachers are available for about 100 students, he added.

Bilal Ahmad Chauhan, a student said there is also an absence of a designated playground for the students in the school. "The students have to play on the stones lying in front of the school. This is not only unsafe, but it is also not conducive to physical activity," he said.

He said that there is no smart classroom as well hostel facilities available in the school.

This reporter found the school washrooms in a dilapidated condition, with water leaking from pipes.

The parents of the students have also expressed concern about the situation. "The government has spent crores of rupees on building the school, it has failed to provide the basic facilities that the students need. This is a clear case of discrimination against the tribal communities," said one of the parent.

Students as well as parents requested higher authorities look into the matter.

Repeated attempts to contact Chief Education Officer (CEO) Kulgam Mushtaq Qadri could not materialize.

Meet Sahrose Wani, who is set to become first commercial pilot from Anantnag

ANANTNAG, AUG 25: A 23-year-old youth from Verinag area is set to become the first commercial pilot of south Kashmir's Anantnag district. Sahrose Ahmad Wani, son of Mehraj-Ud-din Wani, completed the commercial pilot training and received a CPL (Commercial Pilot License) a month ago. He is undergoing a two-month course for advanced jet training in Germany known as Type Rating.

In an exclusive chat with the news agency—Kashmir News Observer (KNO) from Berlin, Germany, Sahrose said he started his aviation career in the year 2019 and passed six DGCA and other exams as well. His goal is to join Air India.

"I did my schooling from SSMEI Dooru Shahabad up to 10th and passed my 12th from Higher Secondary School Brakpora Anantnag in 2017," he said.

Istarted from Carver Aviation Academy,

Pioneer Flying Academy and Redbird Flight Training Pune, Baramati, Wani said, adding that the journey was filled with a lot of flying lessons and tons of skill tests and came to an end by passing IRT (Instrument Rating Test) at Redbird Flight Training Academy earlier this year.

"My parents and my sister always supported me in choosing this completely different path and special thanks to Captain Haroon Amin Lone (Examiner Captain Indigo) who guided me all throughout the journey," Sahrose said. He said Kashmiri youth can do anything provided they work hard consistently. "I want to tell my Kashmiri brothers and sisters that do what you are passionate about and work hard on it, be consistent and things will happen. We have the huge potential to achieve anything but all we need is some guidance and persistence towards our goals."

Shortage of teachers among other issues hit Bandipora's AMT

Students urge authorities to address their problems

BANDIPORA, AUG 25: The Ancillary Medical Training (AMT) institute in north Kashmir's Bandipora district is grappling with shortage of teaching faculty and a lack of basic facilities, affecting students.

Data collected by the news agency— Kashmir News Observer (KNO) showed the institute offers four courses—FMPHW with 20 students, Lab Technician with 10 students, Medical Assistant with 10 students, and ISM with 10 students.

The details stated that the ISM course currently lacks a teacher and a similar shortage is observed for the Medical Assistant program. Also, the Lab Technician course, spanning sixteen subjects across the first and second semesters, has only one available teacher to cover all eight

subjects per semester.

A group of students said the school is currently riddled with a state of complete mismanagement, and higher authorities have seemingly turned a blind eye to their issues. "For several months, we have been pleading for additional staff but our pleas have fallen on deaf ears," they said. "Basic facilities are absent within this institution. The building lacks proper fencing and the road leading to it is in a deplorable state"

They alleged that there is no regularity in class work from 10 pm to 4pm and the administration declares 'holiday' on its

A senior health official said they will take up the issue with the Principal AMT and the grievances if any will be addressed.

J&K govt imposes penalty on officer after inquiry finds negligence in distribution of national flags

SRINAGAR, AUG25: The administration of J&K has decided to withhold two increments of an official in Kashmir Valley after a probe found him guilty of negligence in discharge of his official duty concerning the upkeep and distribution of national flags during the last year's "Har Ghar Tiranga" programme.

The Housing & Urban Development Department has ordered withholding of two increments of the then executive officer municipal committee, Magam, Syed Aijaz Manzoor, who was put under suspension after it was found that national flags were being distributed in garbage hoppers in Magam, Budgam.

In an order, a copy of which is in possession of news agency—Kashmir News Observer (KNO), the Housing & Urban Development Department said after a news regarding alleged insult of national flags at Municipal Com-

mittee Magam, went viral on social media on August 13, 2022, deputy director (admin), urban local bodies, Kashmirvisited municipal committee Magam to enquire into the matter. The deputy director, ULB found that two hoppers parked in premises of Municipal Committee Magam were carrying national flags for distribution inconnection with "Har Ghar Tiranga" programme. According to the order, the sub-divisional magistrate Beer-

wah Budgam immediately placed the officer under suspension and ordered an enquiry into the matter.

Subsequently, the Housing & Urban Development Department examined the case and served a memorandum, article of charges and statement of imputation to the officer. After the officer submitted the statement of defence, the government appointed vice-chairman, Srinagar Development Authority as inquiry officer in the

matter. In his report submitted to the H&UDD, the inquiry officer clearly stated the negligence on the part of Syed Aijaz Manzoor, the then executive officer, municipal committee Magamin discharge of his official duty concerning the upkeep/distribution/hoisting of national flags at municipal committee Magam. The discharge of the duty was held in violation of the provisions of the Flag Code of India, 2002, the order states.

YRS members 'breached peace' in Jammu, to be released after getting guarantee from 'prominent person', says ADGP Jammu

JAMMU, AUG 25: Police said that activists of Yuva Rajput Sabha (YRS) arrested in Jammu for "breach of peace" will be released if any "prominent person" guarantees on their behalf that they would not repeat the offense.

"The YRS members breached the peace. They gave assurance of peaceful protest but ended up blocking the highway, which is not acceptable in any condition. Moreover, the protest turned violent with activists hurling stones at Toll Booth," said Additional Director General of Police Mukesh Singh.

As per the news agency—Kashmir News Observer (KNO), the YRS members were detained on Monday from Sarore toll plaza when they were protesting to press for its removal. At least 27 YRS activists were detained for violating restrictions around the toll plaza. Authorities had imposed Section 144 of the Criminal Procedure Code (CrPC), which forbids the gathering of four or more people at a particular place.

people at a particular place. The YRS has demanded the removal of the toll plaza on the Jammu-Pathankot national highway in the Samba district, claiming that it was illegally set up to collect tolls from people. The Jammu ADGP said that a high-level meeting was conducted over the issue of the toll

"All grievances which came up with LG were taken with the Centre for resolution. A team of NHAI will come here and a ground visit will be conducted to examine all the issues", he

The ADGP said that the protesters would be released once any prominent person comes forward to provide a guarantee on their behalf. "They will be



released the moment someone takes the guarantee," he said.

The Chamber of Commerce and Industries, Jammu (CCIJ) on Thursday gave a call for a bandh on August 26 to protest against the installation of smart meters in the city.

Regarding Saturday's strike, Singh said all issues have been addressed. "We will request them to call off the bandh as all issues have been resolved", he said.

Meanwhile, Jammu Divisional Commissioner Ramesh Kumar Friday said that the installation of over 1.46 lakh smartelectricity meters, around 80 percent of the target, has been completed in Jammu.

He said that a grievance cell has been set up to address complaints related to the meters.

A grievance cell has been set up to address complaints of hefty bills from smart meters, if any, within two days, Kumar said.

"Over 200 complaints have been received and 180 complaints have been addressed," he said.

Kumar said the installation of smart electricity meters will provide consumers with "better facilities" and "empower" them.



New study reveals grape consumption may protect skin against UV damage

WASHINGTON: A recent human study published in the Journal of the American Academy of Dermatology found that the consumption of grapes protected against ultraviolet (UV) skin damage.

Study subjects showed increased resistance to sunburn and reduction in markers of UV damage at the cellular level. Natural components found in grapes known as polyphenols are thought to be responsible for these beneficial effects.

The study, conducted at the University of Alabama, Birmingham and led by principal investigator Craig Elmets, M.D., investigated the impact of consuming whole grape powder, equivalent to 2.25 cups of grapes per day, for 14 days against photodamage from UV


Subjects' skin response to UV light was measured before and after consuming grapes for two weeks by determining the threshold dose of UV radiation that induced visible reddening after 24 hours, the Minimal Erythema Dose (MED). Grape consumption was protective and more UV exposure was required to cause sunburn following grape consumption, with MED increasing on average by 74.8 per cent.

Analysis of skin biopsies showed that the grape diet was associated with decreased DNA damage, fewer deaths of skin cells, and reduction in inflammatory markers that if left unchecked, together can impair skin function and can potentially lead to skin cancer.

It is estimated that 1 in 5 Americans will develop skin cancer by the age of 70. Most skin cancer cases are associated with exposure to UV radiation from the sun, about 90 percent of nonmelanoma skin cancers and 86 percent of melanomas, respectively. Additionally, an estimated 90 percent of skin ageing is caused by the sun.

We saw a significant photoprotective effect with grape consumption and we were able to identify molecular pathways by which that benefit occurs through the repair of DNA damage and downregulation of proinflammatory pathways," said Dr. Elmets.

"Grapes may act as an edible sunscreen, offering an additional layer of protection in addition to topical

* Keep a check on acidic food and drinks as they might wear down the teeth enamel. Limit the consumption of these foods and drinks, and try to brush about 20 minutes after eating them (not earlier, or the brushing may hurt your enamel further)

Teeth whitening treatments or alcohol-based mouthwash can make things even worse, so steer clear of them.

Scientists identify the root of nicotine addiction, may lead to new treatments

Scientists have identified specific chemical changes deep in the brain that help drive nicotine addiction, an advance that may lead to new treatments for the condition.

In the research published in the journal PNAS, scientists were able to halt these changes in mice and discover potential targets for drugs to treat tobacco dependence.

Nicotine is a stimulant that works by binding to receptors widely distributed throughout the brain, causing neurons to release a variety of neurotransmitters including dopamine, which triggers feelings of pleasure.

In a search for the brain cells that transmit this response, researchers at the Rockefeller University in the US investigated how nicotine affects two midbrain structures, the interpeduncular nucleus (IPN) and the medial habenula (MHb).

While these brain regions are ancient in evolutionary terms and are found in all vertebrates, including humans, they have not received much attention from scientists until recently,

researchers said. Working with mice, Jessica LAbles,



first author of the study, found that chronic nicotine consumption alters the functions of a particular population of neurons inside the IPN.

These altered brain cells, which she dubbed Amigo1, appear to promote nicotine addiction by disrupting the communication between the habenula and the IPN.

Normally, these brain structures have a system in place to curtail nicotine

The habenula responds to a given dose of nicotine by sending an aversion signal to the IPN that decreases the reward of the drug, an effect that ultimately limits the urge to consume nicotine.

After chronic exposure to nicotine, however - the mice used in the study dranknicotine-laced water for six weeks - the Amigo1 cells compromise this "braking effect" by releasing two chemicals that reduce the response of

the IPN to the aversion signal from the

In other words, the stop-smoking message does not get delivered.

The result is a "pro-addiction" response to nicotine, which the mice displayed in a behavioural test designed to measure the motivational properties of the drug.

In the test, called conditioned place preference, the mice chose to spend time in a chamber where they had previously received nicotine.

"If you are exposed to nicotine over a long period you produce more of the signal-disrupting chemicals and this desensitises you. That is why smokers keep smoking," said Ines Ibanez-Tallon, a scientists in the lab of Nathaniel Heintz, a professor at the Rockefeller University.

In other experiments, her group was able to confirm that these mices response to chronic nicotine was indeed influenced by Amigo1 neurons

When the researchers silenced these neurons using a genetic engineering technique, this eliminated the "nicotine preference" of the mice, strongly suggesting that those neurons play a role in the addictive behaviour.

Adding VITAMIN C

in diet can help cure bleeding gums, finds study

newstudyexploresaddedadvantages of Vitamin C consumption and **L**advocates that adding it to our daily diet could work wonders in healing bleeding gums. If your gums bleed, make sure you are brushing and flossing twice a day because it could be a sign of gingivitis, an early stage of periodontal disease.

However, you should also check your intake of vitamin C, as per the study. The findings of the study led by the University of Washington, were published in the journal 'Nutrition Reviews'.

"When you see your gums bleed, the first thing you should think about is not, I should brush more. You should try to figure out why your gums are bleeding. And vitamin C deficiency is one possible reason," said the study's lead author Philippe Hujoel, a practicing dentist and professor of oral health sciences in the UW School of Dentistry.

Hujoel's study analysed published studies of 15 clinical trials in six countries, involving 1,140 predominantly healthy participants, and data from 8,210 U.S. residents surveyed in the Centers for Disease Control and Prevention's Health and Nutrition Examination


The results showed that bleeding of the gums on gentle probing, or gingival bleeding tendency, and also bleeding in the eye, or retinal hemorrhaging, were associated with

low vitamin Clevels in the bloodstream. And, the researchers found that increasing the daily intake of vitamin C in those people with low vitamin C plasma levels helped to reverse these bleeding issues.

Of potential relevance, said Hujoel, who is also an adjunct professor of epidemiology in the UW School of Public Health, both a gum bleeding tendency and retinal bleeding could be a sign of general trouble in one's microvascular system, of a microvascular bleeding tendency in the brain, heart, and

The study does not imply that successful reversing of an increased gingival bleeding tendency with vitamin C will prevent strokes or other serious health outcomes, Hujoel stresses. However, the results do suggest that vitamin C recommendations designed primarily to protect against scurvy, a deadly disease caused by extremely low vitamin C levels, are too low and that such a low vitamin C intake can lead to a bleeding tendency, which should not be treated with dental

Consequently, Hujoel does recommend people attempt to keep an eye on their vitamin C intake through the incorporation of nonprocessed foods such as kale, peppers, or kiwis into your diet, and if you can't find palatable foods rich in vitamin C to consider a supplement of about 100 to 200 milligrams



If someone is on a specialised diet, such as a paleo diet, it's important that they take a look at their vitamin Cintake, Hujoel said. "Vitamin C-rich fruits such as kiwis or oranges are rich in sugar and thus typically eliminated from a low-carb diet."

This avoidance may lead to a vitamin C intake that is too low and is associated with an increased bleeding tendency. People who exclusively eat lean meats and avoid offal, the vitamin-rich organ meats, may be at particularly high risk for a low vitamin C

intake. The association between gumbleeding and vitamin C levels was recognized more than 30 years ago. In fact, two studies coauthored by the former dean of the UW School of Dentistry Paul Robertson (published in 1986 and 1991) identified gum bleeding as a biological marker for vitamin C levels. However, this connection somehow got lost in dental conversations around bleeding

"There was a time in the past when gingival bleeding was more generally considered to be a potential marker for a lack of vitamin

C. But over time, that's been drowned out or marginalized by this over-attention to treating the symptom of bleeding with brushing or flossing, rather than treating the cause," Hujoel said.

Hujoel's literature review also determined that "retinal hemorrhaging and cerebral strokes are associated with increased gingival bleeding tendency, and that (vitamin C) supplementation reverses the retinal bleeding associated with low (vitamin C) plasma levels."

So, missing the possible connection between gum bleeding and low levels of vitamin C has the potential to have serious health consequences. The study authors wrote, "A default prescription of oral hygiene and other periodontal interventions to 'treat' microvascular pathologies, even if partially effective in reversing gingival bleeding as suggested in this meta-analysis. So, missing the possible connection between gumbleeding and low levels of vitamin C has the potential

"A default prescription of oral hygiene and other periodontal interventions to `treat` microvascular pathologies, even if partially effective in reversing gingival bleeding as suggested in this meta-analysis, is risky because it does not address any potential morbidity and mortality associated with the systemic microvascular-related pathologies," they added.


Apart from Al Hilal, Mumbai City FC also drew Iran's FC Nassaji Mazandaran and Uzbekistan's PFC Navbahor Namangan in the 2023-24 AFC Champions League draw held on Thursday. But even before the ceremony, all the chatter was about whether Mumbai would come up against one of the four Saudi teams in fray – the others included Cristiano Ronaldo's Al Nassr and Karim Benzema's Al Ittihad. "It's an exciting draw, and a very difficult one," said Mumbai City coach Des Buckingham. "It would have been difficult regardless of who we pulled out of the draw. Our target would be to go and play the kind of football that we want to play, that we can play, that we did last year. We got three results in six games. We'll be representing our club and our region but more importantly, we'll be representing Indian foot-

While the mass exodus of stars from European top-flight to Saudi Arabia's oil-money-fueled clubs have been subject to much criticism from Western media, it nevertheless brings a great deal of spotlight on Asian football. 
