Meanwhile, TRI J&K has been asked to notify and publicise helpline numbers on radio and all media for wider circulation, to be made available for real time grievance redress.

with the restoration of peace in Jammu and Kashmir, Northern Command Army Commander, Lieutenant General, Upendra Dwivedi on Monday said that this year so far 46 terrorists have been neutralised out of which 37 were foreigners.

'This is for the first time, the terrorists killed in various operations across the region this year, the number of foreign terrorists was four times higher than locals," the Army Commander said speaking to media after the inauguration of three-day North Tech Symposium at IIT Jammu.

"Attempts are being made from across the border to disrupt peace in Jammu and Kashmir but we will never allow it to happen," he said.

Lt Gen Dwivedi added that the number of terrorists killed in the last nine months is 46 and out of these, nine were locals and 37 were foreigners.

"Moreover. 29 of these terrorists have been killed in the South of Pir Panchal," he added.

He said that the Northern Command is not only guarding the Line of Control (LOC) but also the Line of Actual Control (LAC), adding, "induction of upgraded technology will benefit the Indian Army and further augment the Armed Forces.'

As far as the situation along the border is concerned, the Northern Command is always ready operationally, adding he said, "India Army is maintaining vigil 24x7 along the LAC and the

the North Tech is being attended by the battery of officers from various commands so that they get learned and get aware of the latest technology for adopting it into the Armed Forces.

Lt Gen Dwivedi said that the equipment on display in the North Tech is completely focussed on the 'Atmanirbharta', adding, "so far 256 equipments are inducted into the Army from the last North Tech held in May 2022 in Northern Command after successful trials."

On drone challenges, the Army Commander said, "counter drone equipment's are also inducted and they are being upgraded time to time," adding he said, "along the Line of Control (LoC), we need intelligence, surveillance and reconnaissance and moreover lot of equipment is inducted, which is used in the warfare."

The Army Commander however, also said that with each passing day, technology along the Line of Actual Control (LAC) is improving. UNI

say what is fact because I have seen myself on the ground that not even one square inch of land which the Chinese have occupied." "Whatsoever happened in 1962 that is immaterial. But today we are in occupation of our land to the last inch," he said. Mishra, a retired Brigadier, was here to attend the three-day North Tech Symposium being organised by the Army.

Responding to reporters' queries on the sidelines of the event, he said, "Our armed forces are prepared for any eventuality, and God forbid if the balloon goes up, people will get a bloody nose from us." He said the morale of troops is very very high. "Their intent is to defend every square inch of land. Nobody can dare to come towards India with any design to have a foothold here. I think all the credit goes to great leadership under Prime Minister Narendra Modi," he said.

Asked whether weapons have been identified and procured to be deployed along the Line of Control (LoC) to boost security, he said it is being done.

Monday. The decision was taken after the improvement in the road conditions along the highway.

"The traffic on Srinagar-Jammu national highway including fruit laden trucks will now ply from both the ways after improvement in road conditions", Divisional Commissioner Vijay Kumar Bidhuri told media persons in Srinagar.

Earlier the traffic on Srinagar-Jammu highway was plying on a schedule of even odd type and one day the up convoy was being allowed to ply on the road and next day the down convoy was being allowed to move on the highway, he said.

Bidhuri said after a visit by the Chief Secretary and other officials on the highway after road condition considerably improved, they decided that the restrictions on the movement of vehicles including fruit laden trucks have been lifted.

"It is good news for fruit growers as trucks now can ply on the road without any restrictions on a daily basis", he added.

He said following the attack on the CRPF Convoy at Lethpora on highway in 2019, a standard operating procedure (SOP) was designed for the movement of traffic along the highway.

He said the traffic in the other tube of the highway was stopped when a convoy of security was moving on the road. It was also implemented due to non-availability of a divider in the middle of the road, he added.

"Now, the security situation has significantly improved and security agencies will soon make a decision of allowing the civilian traffic during the forces movement after considering all aspects," Bidhuri added.

Singh will also carry out e-shilanyas of Nyoma Airfield to be constructed in Ladakh, he added and said that in the last two years BRO has dedicated a record 205 Infrastructure projects to the Nation at a cost of Rs 5100 crore.

"These Infrastructure Projects have been constructed under challenging weather conditions, at most inhospitable terrain locations," he added. The highlight of the event will be the inauguration of state of the art "422.9 meter long, Class 70 RCC Devak Bridge on Bishnah-Kaulpur-Phulpur Road in Jammu and Kashmir" from the site and this bridge is of strategic importance to Defence Forces and will facilitate speedy induction of troops, heavy equipment and mechanised vehicles to forward areas and will also boost socioeconomic development of the region, he added. "Under the leadership of Hon'ble Prime Minister Shri Narendra Modi Ji, the country has witnessed major push for Aatmanirbharta in Defence. We are a responsible space power and have shown our strategic strength," the Lt Governor said.

During the meeting the Chief Secretary maintained that the administration is pro-poor and has their welfare on top of its agenda. He underscored the need of reaching to these needy people as it is the primary objective of the Department.

He mentioned that during his interactions with the people he came across demands regarding the issuance of pension from the Department. He stated that it is the right of these eligible old aged people to claim their rights and the administration is duty bound to provide them same in a time bound manner.

He directed them to collaborate with the Revenue Department and complete verification of all the pending cases within a week's time. He told them to declare a time table in a day or two for such camps and widely publish it for information of all the concerned. He urged them that no eligible person should be left out and those cases verified should be provided pension forthwith.

He told them to settle the pension cases of at least 1 lakh beneficiaries by next two weeks and complete all the pendencies by the end of month. He also asked them to work for release of their accumulated arrears therefrom in a phased manner

Dr Mehta further stressed on distribution of benefits among the deserving population only. He asked for providing of PHH ration cards among the most deserving population as per the criteria laid down. He made out that no complaints should be there regarding exclusion of eligible beneficiaries. He urged them that merit should be the only criteria to categorize people in these hierarchies.

The Commissioner Secretary, Social Welfare, Sheetal Nanda gave out during this meeting that the DSWOs/TSWOs have already been sensitized by her that no pendencies beyond 2 working days shall be acceptable at their end. She further said that the verifications pending for want of reports from the revenue officials would also be taken in a mission mode.

She reiterated that camps as directed by the chair would be organized as per the schedule to be laid down and cases settled on merits as per the set timelines given in the meeting.

On increasing terrorist incidents in Rajouri and Poonch districts, he said, "wherever peace returns, Pakistan is trying to disturb it."

"Despite Pakistan's worsening situation internally, foreign terrorists are being pushed to the Indian Territory because local terrorists and support to the neighbour is almost zero in Jammu and Kashmir and the citizens of this region are up against terrorism and instead standing by the security forces," he stated.

"As the deployment and technology has changed to a larger extent, the terrorists trying to infiltrate are being neutralised on the border only and the attempts are being foiled successfully," the Army Commander said and added that all the top commanders of various terror outfits are eliminated in Jammu and Kashmir, which has frustrated the Pakistan. 'Atmanirbharta'.....

Command Army Commander Lieutenant General Upendra Dwivedi on Monday said that 'Atmanirbharta' is a first step for India to get global leadership.

"Atmanirbharta is a first step for India to get global leadership and to boost Atmanirbharta, industry, military and academia have come together and we will march forward so that the technology we already had, which we are importing, we will find an alternate solution to it," Lt Gen Dwivedi told media while inspecting stalls on the first of the three days North Tech Symposium being hosted at IIT Jammu.

"And the latest technology coming ahead, how we jointly have to work upon so that the cumulative effect should be so good that we move ahead of other countries," he added.

Elaborating on the symposium, the Army Commander said that the equipment is divided into five parts.

"Survivability of protection, mobility, surveillance and communication, infrastructural development and fire power are the key areas focussed in the North Tech," said the Army Commander. He stated that one-third of the equipment is already inducted into the Army, which needs improvement and the two-third developed by the industry after they understood our requirement and if the need arises and it meets our expectation, shall also be inducted after trials. He said that the technology must be known to everyone irrespective of any age group and

Intelligence (AI), Internet of Things (IOT), cloud, internet and normal smartphone will be employed.

The meeting was attended by Deputy Commissioner Baramulla, Deputy Commissioner Kupwara, Director Health Services Kashmir, and other officers.

Besides, representatives of PSU who attended virtually included Director (S&T), North Eastern Council, DIC, UIET, Punjab University, Chandigarh, HoD, Community Medicine Dept, Safdarjung Hospital, New Delhi and CEO, Inca Synergies.

At the outset, a presentation was given which focused on intervention of 5G and allied technologies of IoT (Internet of Things), Artificial Intelligence, Big Data in Health Sector to improve the quality of healthcare screening nearest to home and reduce out of pocket expenses as per the vision of NITI Aayog.

4th meeting of UTLLACPC convened in Srinagar

Rs 5000 Cr earmarked for upgrading infrastructure, setting up Public Libraries in Gram Panchayats: DG RRRLF

SRINAGAR, SEP 11: The Government of India has earmarked whopping Rs 5000 crores for the year 2023-24 for upgrading infrastructure in Public Libraries and extending Library facilities to the Gram Panchayat level across the country.

This was announced by Prof Ajay Pratap Singh, Director General, National Library of India (NLI) and Raja Rammohun Roy Library Foundation(RRRLF)in his opening remarks at the two-day meeting of J&K UT-Level Library Advisory-cum-Purchase Committee(UTLLACPC)whichbeganatSPS Library Complex here on Sunday.

Prof Singh said, it is for the first time, that such a huge amount has been earmarked, in one go, by the Government of India for upgrading library infrastructure in the States & UTs. He said extension of library facilities and taking the library movement to the grassroots level is aimed at facilitating improved access of the children and adolescents in the rural and semi-urban areas to the latest books and e-connecting them to the vast learning resources available through National Digital Library of India (NDLI).

He said the Union Ministry of Finance has already sought proposals from all the States and Union Territories under the scheme as the funding for upgrading infrastructure in Public Libraries and providing Library facilities at the Gram Panchayat level would be available on "First-ComeFirst-Serve" basis. "A communication in this regard has been sent by the Department of Expenditure, Union Ministry of Finance to the Chief Secretaries of all the States & UTs in May 2023," he said.

Enumerating the broader contours of the scheme, Prof Singh said that funding under the scheme would be available to the states and UTs for construction of new library buildings; renovation of existing libraries; purchase of library furniture; purchase of IT equipment including computers, printers, networking etc and purchase of books. He said financial assistance under the scheme would be limited to one Library in each Municipal Ward and one Library in each Gram Panchayat. Prof Singh said J&K's Libraries Department should also explore the possibility of establishing decent reading spaces, in convergence with related departments, at the Public Parks, Gardens, along Jhelum River bank and around Dal Lake for tourists and morning walkers.

Earlier, welcoming the participants at the meeting, the Director, Libraries & Research, Mr Mohammad Rafigave an overview of the initiatives taken by the Department to upgrade the infrastructure in Public Libraries and provide best possible facilities to the library users. He said the huge increase in footfall in the Public Libraries has put immense pressure on library resources and there is a pressing need for upgrading the infrastruc-



ture especially the library furniture.

The Director Libraries sought the intervention of Director General RRRLF to facilitate early release of funds under National Mission on Libraries (NML) from RRRLF for construction of buildings for Gani Memorial UT Central Library at Rajouri Kadal Srinagar and District Library Samba. He also pressed for release of RRRLF financial assistance under Matching Grant Scheme for upgrading furniture in Public Libraries.

UT-Level Library Advisory-cum-Purchase Committee discussed and approved various proposals put forth by the Director, Libraries and Research for upgradation and expansion of PublicLibrary facilities in J&K. These include, Digitization of Libraries; establishment of theme-based Libraries-cum-Reading Centres at tourist resorts, setting up of dedicated Reading Areas for travellers at Srinagar & Jammu Airports, collaboration with School Education Department to organize free coaching of students for various competitive exams, organizing Book Fair at Srinagar and Jammu in collaboration with National Book Trust (NBT), setting up of "Book Village" at Aragam in District Bandipora as a joint initiative of the Department of Libraries & Research; District Administration Bandipora and

Pune-based NGO "Sarhad", setting up of Public Library-cum-Reading Room at Gandtal, Harwan under Aspirational Blocks Development Program (ABDP) in convergence with the Department of Rural Development & Panchayati Raj, extension of Internet facility to the PublicLibrariesatTehsil&Blocklevels, weeding out of obsolete books & reference material for Competitive Examinations, write off the damaged/lost books, conservation of books & manuscripts, procurement of e-Books and making available more Online Services to the Library Users.

UTLLACPC approved the list of books under various categories to be

purchased by the Department of Libraries & Research for its Libraries during the year 2023-24.

The meeting was informed that J&K has the distinction of having the oldest libraries in the country including SRS Library Jammu established in 1879 and SPS Library Srinagar established in 1898.

UTLLACPC members who attended the 4th meeting of the forum included Dr Arif, Dy Director, J&K Board of School Education; Mr Saleem Pandit, Journalist; Mr Satish Vimal, expert Hindi language; Mr Liaqat Jafri, expert Urdu language; Mr Ghulam Nabi Haleem, expert Kashmiri Language; Ms Surinder Neer, expert Punjabi Language; Prof Parvez Majeed, Media Studies and Mr Kulbushan Malhotra.

Over 12,000 Devotees Leave For 3-Day Kailash Yatra In Doda

JAMMU, SEP 11: The three-day Kailash Yatra commenced in Jammu and Kashmir's Doda district on Monday as over 12,000 devotees left for the annual pilgrimage from the ancient Vasuki Nag temple here, officials said.

The pilgrimage to the 14,700-foot-high Kailash Kund, depicting ancient 'Nag' culture, was seen off by Doda Deputy Commissioner Vishesh Paul Mahajan along with Senior Superintendent of Police Abdul Qayoom and Additional Deputy Commissioner Dilmir Chowdhary.

The Yatra is considered one of the toughest as pilgrims have to trek the 18-km-steep Kailash mountain range to pay their obeisance at the high-altitude temple, where they take a dip in the ice-cold 'Kund' (lake) and take the blessings of their deities Vasuki Nag and Lord Shiva.

"Last year, over 35,000 devotees paid obeisance at the holy Kailash Kund and this year we are expecting manifold increase in the turnout as we have promoted this ancient and unique pilgrimage at the Union Territory and national level simultaneously," Mahajan said.

The 'Charri Mubarak' (holy mace) was taken out from Vasuki Nag Temple at Gatha around 9 am and was joined by another mace from Vasuki Nag Temple at Vasik Dhera in Bhaderwah town, marking the commencement of the pilgrimage.



The fading colours of watchdogs

The same is the case with regulatory agencies as well as tribunals, the watchdogs of markets

The Digital Personal Data Protection Act, notified on August 11, 2023, has been a long-awaited legal shield for the people of India in these difficult times of the rapidly increasing misuse of personal information. It is a neatly drafted legislation, mainly following a principle-based approach (hence durable) backed by several illustrations, with only 44 Sections and one Schedule—it is altogether a crisp 21-page document.

Several expert commentaries, fine-combing some Sections and provisions of the law, are already available in the public domain. One major limitation of the law, according to most critics, is the amendment to the RTI Act, 2005, removing the obligation to disclose personal information. According to them, this amendment dilutes the RTI Act, an important tool in the hands of the citizens to make governance of public authorities transparent and accountable. A big battle won by people in 2005 is lost!

The RTI Act has travelled a distance of 18 years. Though still a teenager, it has had an initial active phase, which, by many yardsticks, has not been that pleasant for many stakeholders. There have been reports of some using the tool for unintended purposes and some others getting harassed for using it. Several issues, including primacy of the security of personal information, may be contributing to the alleged dilution of the RTI watchdog.

Most agencies of public governance or watchdogs are created by the legislature. All of them are established by the executive. Then, why are some of them not on the 'right' side of the governments of any day, and why are some others always on the right side of every government? The simple answer is that watchdogs in general are not that high in priority for the executive at all times, for multiple reasons.

Watchdogs are constituted for improving the governance of other agencies. They do not aid the agencies/their officials, but only question them on their alleged 'failure'. No one likes criticism, even constructive criticism. The bureaucracy is least known for appreciating criticism. Therefore, the assumption that asking tough questions or imposing small fines would improve governance is misplaced, particularly when ground-level governance is trapped in low-level equilibrium.



A hierarchical approach, even amongst equals, is ingrained in India's administrative philosophy and practice. No two ministries/departments are equal, and hence their ministers and secretaries, too, are 'unequal'. There are super-ministries and departments. It got officially legitimised about two decades ago when four secretaries to the Government of India were given fixed two-year tenures even if they crossed the normal retirement age of 60. Appointment of these 'super' secretaries would never get delayed. So is the case with heads of investigative agencies, though technically they are only equivalent to secretaries to the Government.

The same is the case with regulatory agencies as well as tribunals, the watchdogs of markets. Some of them do not take off while others fly high. Some remain headless for years, while for others, appointments could be done overnight. The resources made available to them, including infra-facilities, speak much about their relative status. It is comical that the office building of one such regulator has been overshadowed by a public restroom for more than a decade now. Many others functioned/function in the premises rented out by their regulated entities.

Frictions and inter-institutional bargaining are part of all large systems. State/government apparatus, historically being the largest, had always been in the throes of such internal 'power struggles'. Stories of how great rulers managed such 'palace intrigues' are still being told/sold by writers and moviemakers with great élan. Great administrators of modern times also try to balance the inter-institutional power equation, but mainly based on their direct usefulness to the system. That explains why administrative organisations usually get priority over advisory structures or revenue-generating ones over spending ones. Interestingly, an agency is considered more useful if it has powers over others, which often gets reflected in its office ambience.

Soon after the RTI Act was passed, the Central Information Commission was established and commissioners were appointed, there were high expectations. Still, there were Doubting Thomases' on the efficacy of having such legal-centric umbrella structures as watchdogs for promoting transparency when it is the ground-level agencies that needed to be efficient, empowering citizens as the first step. Transplanting the experiment in Scandinavia, where administrative efficiency is at its peak, to a situation of serious governance issues, was not considered a panacea at least by some who thought such moves would create more white elephants.

That is exactly what happened to the CIC/SICs, the Lokpal/Lokayuktas, NHRC/SHRCs, and the like. Currently, the Central information Commission has five members out of the sanctioned 11. It rarely makes any headlines, unlike in its initial years. The RTI twin, Lokpal, is no better. Though the Lokpal Act is only 10 years old and the Lokpal was set up initially with the maximum permissible strength of nine (Chair plus eight), it now comprises an Acting Chair and four members. The conditions of the SICs and Lokayuktas are no better, with many of them hardly functional. Thus, the issue is not about the political party in power or even the individual heading the watchdog. It is a systemic bias against watchdogs.

Socio-political pressures may succeed in getting legal-centric watchdogs set up, but given their roles/ functions, their survival needs lots of luck. Ironically, greater efficiency of the ground-level organisations may improve the acceptability of such watchdogs like in well-governed countries, where complaints are few and far between.

Adoption, Inheritance Rights Of Transgender Persons In India: An Uphill Battle

Ranjita Sinha, a transwoman and transgender rights activist, has been fighting to get the family pension ofher deceased father from the West Bengal government for over six years now. Family pension is allowed to the dependent unmarried or widow daughter. Sinha has been claiming the right as a transgender daughter but the state police department, where her father was an officer, did not agree to her claims. She has finally decided to approach the court. The legal battle may not be easy. The Supreme Court of India in its famous 2014 judgement (National Legal Services Authority vs Union of India) held that a person has the right to identify their gender as male, female or transgender but the Transgender Persons Protection of Rights Act (TPPRA) of 2019 reduced the scope of the rights.

"Each person's self-defined sexual orientation and gender identity is integral to their personality," said the apex court and ruled that no one should be forced to undergo medical procedures, including Sex Reassignment Surgery (SRS), sterilisation or hormonal therapy as a requirement for legal recognition of their gender identity.

The TPPRA defines transgender persons as "whose gender does not match with the gender assigned to that person at birth and includes transman or transwoman (whether or not such person has undergone SRS or hormone therapy or laser therapy or such other therapy), person with intersex variations, genderqueer and person having such socio-cultural identities as kinner, hijra, aravani and jogta."

While section 4 of the law gives the right to selfidentification only as 'transgender', and not as male or female, section 7 of the same law implies that a transgender person's choice of gender identity as male or female can be recognised only after the person has provided a medical certificate in support of having undergone medical treatment.

Sinha has not undergone the SRS, just like the majority of the transgender community. "My fight is not only about my claim to family pension. It's a fight for the rights of the community. The majority of transgender people do not have the financial capacity to undergo SRS," says Sinha, a former member of the West Bengal Transgender Persons Development Board.

Sinha highlighted how different governments prioritise the empowerment of women, treating them as the marginalised sex, and cited the examples of the West Bengal government's Kanyashree scheme for girl children and the Laxmir Bhandar monthly assistance to women and the Karnataka and Delhi government's free bus ride schemes.

"These are welcome policy interventions. At the same time, it is disheartening to see there is nothing on offer to the people from the third gender, who are far more marginalised than women," says Sinha, who heads the Association of Transgender/Hijra Bengal (ATHB) and the non-profit Gokhale Road Bandhan. The latter also runs a shelter home for transgender persons.

In a 2020 article, Jayna Kothari, a Supreme Court advocate and executive director, the Centre for Law and Policy Research, wrote that section 7 of the TPPRA negated the apex court's core principle that a person has the right to self-determination of their gender identity and that their self-identified gender can be either male, female or a third gender. "Even with the NALSA judgment in place, the response of the State has been to defeat the right to self-determination of gender and to insist on a medical model for legal recognition of one's gender identity. The TPPRA 2019 and all government welfare schemes still require medical proof of reassignment to be provided by transpersons in order to get benefits," Kothari wrote. Most transgender rights activists agree with Kothari's summation of the government's attitude, which they cite as one of the main reasons why transgender people have to approach the judiciary to remove the hurdles in their way.

For example, a transperson from a northern West Bengal town has recently decided to move to the High Court after the police asked for the job application to be either as male or female. In Uttar Pradesh, a transperson employed with the state police had to approach the High Court as the police were not giving permission for SRS for transition from woman to man.

In August, an Indian resident currently in Chicago approached the Delhi High Court after failing to get a new passport with a new gender identity. The person, born a male, transitioned into a woman by 2022 by underground SRS in the US and got new legal documents accordingly from the courts there. However, the Indian passport authorities had not issued her a new passport in six months. While hearing the petition, the Delhi High Court said that it was necessary to 'streamline the process' of renewing passports with one's new identity and appearance. These are a few among the many hurdles that India's transgender people face, as most legislations and government orders are written in a language of heteronormative binary and transgender people must fall in either the male or the female category to claim their rights. In a society habituated to gender binaries, every policy excludes the third gender.

Take the case of Prithika Yashini, a sub-inspector of police who had to win a legal battle in the Madras High Court to get appointed to the state police as a transgender woman in 2017. In June this year, she had to approach the court again after her application for adopting a child was rejected on the grounds that she was transgender.

The legal developments in this case will be keenly followed by the transgender community, as adoption has been a major obstacle they face. In a 2021 report by the National Institute of Public Finance and Policy, authors Karan Gulati and Tushar Anand showed how India's adoption laws differ in the treatment of male and female persons and the exclusion of gender-neutral terms and provisions create gray areas for transpersons as prospective parents or adopted children.

The Hindu Adoptions and Maintenance Act provides that a single male person can only adopt a female if he is at least 21 years older than the adoptee, while there needs to be a 21-year gap between a single adoptive mother and a male child. Adoption Regulations passed under the Juvenile Justice Act disallows a single male to adopt a female child but there is no such restriction on a female adopting a male child. "Both Acts (and regulations) also have repeated usage of gendered sections. There are 36 and 37 instances of the terms male and female in the Adoption Regulations, respectively," the paper said, adding that the absence of gender-neutral or third-gender-specific terms creates ambiguity for transgender people. The question of determination of gender, either of the prospecting transgender parent or the child to be adopted or both, can spoil the scope for adoption.

Adoption restrictions also impact inheritance and succession, as transgender persons cannot prove legal adoption. Besides, inheritance as a spouse becomes impossible because transgender marriage is not legally accepted. The Succession Acts based on religion-specific personal laws make no provision for transgender persons. A section of the transgender community has pinned their hopes on the pending Supreme Court judgement on the case seeking legal recognition of same-sex marriage, a demand that the government of India has opposed citing various reasons, including the impact on other laws. However, even if a favourable order comes from the apex court, the community will still be left with many legal hassles, as bringing gender neutrality to a list of laws is not going to be an easy task.

'Achievement is not linked to marks': IIT Madras Director on his journey

from scoring poorly in his entrance test to becoming JEE chairperson

There is nothing called "failure". Wise people through the ages have said so. The honourable former President of India, Bharat Ratna Dr APJ Abdul Kalam said, "FAIL = First Attempt In Learning."

No individual can embody Dr Kalam's definition more aptly than myself. As a young JEE aspirant in 1985, I scored a singledigit mark out of 100 in Chemistry. That particular day of the examination was unfavourable to me. And yet, decades later, I became the JEE Chairman, thereby proving that achievement is not linked to scores, marks and grades.

For a youngster faced with the frustration of unexpected or unfavourable results, failure may appear real and larger than life. This frustration often arises because of unrealistic expectations and the mismatch between their capabilities or aptitudes and the field they are thrust into. Dealing with this frustration requires a drastic change in perspective, both by the student and by us, their caretakers.

How "failure" is perceived by us is shaped by what the activity means to us. If we are engaged in something we enjoy and encounter a roadblock, we perceive it as an opportunity to improve. I love music. When I play the violin in front of an audience and miss a note, I diligently work towards perfecting my fingering and bowing. However, when we are forced to do something that we do not enjoy and perform sub-par, the perceived failure becomes a burden, amplifying our frustration and negativity towards the experience.

It is important for us as parents to understand this. Our children can handle adversities better if they are interested in and excited about their activities. Oftentimes, parents have a vision for their children, well-meant no doubt, but visions that may not align with the interests of the children



themselves. Enrolling children in rigorous coaching centres comes to mind. For children with personal ambitions and aspirations to get into premier institutions, these coaching centres can be of tremendous value. But is the parent sending the child to these institutes because it is their vision for their children and not the aptitude of the children themselves?

I'm not suggesting that parents should not guide their children. Our culture is built on the hierarchy of Mata-Pita-Guru-Deivam – the mother, the father, the teacher and then God, and parental support is pivotal in helping children navigate the complexities of growing up. The most valuable lesson we can teach our children is that success and significance are possible in all walks of life through passion, perseverance and the will to see things through. Any other guidance we provide to our children must necessarily take into account the child's ambitions, aptitudes, and abilities.

As parents, we must realise that life is not all about engineering and medicine. The modern world offers abundant opportunities across various domains for our children and youth. Yes, the IITs are exceptional education institutions, but they are not the only educational institutions that provide quality education to the Indian youth. I recently had the privilege of attending the 'Champions of Chennai' awards event, where the awardees, intelligent and hardworking youngsters, were not all IITians.

Another aspect that warrants introspection is this. No good can result from comparing children. Each child is unique, and such comparisons can have detrimental effects, particularly at an age in which children seek parental approval and encouragement. It is important for both parents and children to understand that marks, ranks and scores in any exam are numerical representations and do not reflect the overall intelligence of the student. While diligent effort is undoubtedly necessary for success, fixating on numbers can lead to undue stress. There have been cases where students' emotions shift unexpectedly and suddenly from happiness to sadness due to excessive pressure, sometimes resulting in unfortunate and tragic outcomes.

There is also much pressure on children to pursue certain fields such as computer science, and yet, no discipline is inferior to another. Remarkable contributions to society have been made by people from all disciplines. The largest revenue-earning department through Industry Consultancy and Sponsored Research at IIT Madras is Ocean Engineering. As we become the first country to land on the South Pole of the Moon, can we ignore the contributions of aerospace engineers? Could the world have survived COVID-19 without the vaccines developed by biological scientists?

The challenges that the child faces may not always be due to academic reasons. No family is without problems, and the child may be affected by issues within the family, like conflicts and financial issues. It is the responsibility of the adults to manage issues in a way that does not seriously damage the child's emotional state. Interpersonal relationships can also be difficult to manage at that age. Being there for children during tough times is crucial. When schools and colleges express concerns about a student's well-being, parents should respond immediately. Staying connected and offering unwavering emotional support can help children overcome academic and personal challenges.

My personal observation over more than two decades as a teacher is that a kid who is raised in a joint family is more emotionally stable than one who has been isolated from the extended family. The support and affection of grandparents and extended relatives can foster positivity in children. Although nuclear families have become the norm in recent times, children must be encouraged to communicate actively with grandparents and other relatives.

Life extends beyond academics. Just realising this can help us guide our children to be emotionally strong and positive. Strength and positivity are essential for our country if we are to stop our valuable children from falling prey to disappointments caused by perceived failures.

Happiness is a collective responsibility.

New Delhi, Sep 11 (UNI) Prime Minister Narendra Modi on Monday said that India and Saudi Arabia's cooperation is vital for the peace and stability of the entire region.

In a bilateral meeting with the Crown Prince of Saudi Arabia, Mohammed bin Salman bin Abdulaziz Al Saud, in New Delhi, Modi said, "We are adding a new dimension to our ties in tune with changing times. For India, Saudi Arabia is one of our most important strategic partners."

During the meeting, both leaders reviewed the various facets of bilateral ties and discussed ways to further unlock the potential of the strategic partnership.

"As the world's two largest and fastest-growing economies, our mutual cooperation is vital for the peace and stability of the entire region," he added.

The PM said, "Saudi Arabia is important for India. I once again thank His Royal Highness for his contribution to the success of the G20 Summit.

Calling the decision to build the economic corridor between India, West Asia, and Europe as "historic", the Prime Minister said. "This corridor will not only connect two countries, but also help in providing economic growth and digital connectivity between Asia, West Asia and Europe.

Speaking at the meeting, Salman bin Abdulaziz Al Saud said, "There was no disagreement at all during the history of India-Saudi Arabia relation-



ship, but there is cooperation to build the future of our country and create opportunities".

"Today we are working on future opportunities... I congratulate you (Modi) on the management of the G20 Summit and the initiatives achieved, including the Economic Corridor linking the Middle East, India, and Europe, which requires that we work diligently in order to make it a reality,' Saud added.

Both leaders also co-chaired the first meeting of the India-Saudi Arabia Strategic Partnership Council (SPC).

At the meeting, the Prime Minister said that during the talks, both nations had identified several initiatives to take the partnership to the next level.

"Today's talks will provide new

energy and direction to the relations. This will provide us inspiration to work together for the welfare of humanity," he added.

After the meeting, Prime Minister Narendra Modi and the Crown Prince signed the minutes of the first meeting of the India-Saudi Strategic Partnership Council.

The Crown Prince is on a three-day state visit to India. He arrived in New Delhi on Saturday to attend the 18th G20 summit.

Earlier this morning, Prince Mohammed Bin Salman Bin Abdulaziz Al-Saud was accorded a ceremonial welcome at the forecourt of Rashtrapati Bhavan.

President Droupadi Murmu and Prime Minister Narendra Modi welcomed the Crown Prince of Saudi Arabia.

"Nothing To Do With Hinduism", Rahul Gandhi Hits Out At BJP At Paris Event

New Delhi: Congress MP Rahul Gandhi hit out at the Bharatiya Janata Party and its ideological mentor, the Rashtriya Swayamsevak Sangh on Sunday, declaring neither "have nothing to do with Hinduism" and that "there is nothing Hindu about what the BJP does ... ". Mr Gandhi was at an event in France on Sunday, when he said, "I have read the Gita, a number of the Upanishads and many Hindu

books... absolutely nothing Hindu about it (the BJP)... "I have not read anywhere in any Hindu book, or heard from any learned Hindu person, that you should terrorise or harm

people weaker than you. This idea... this word - 'Hindu nationalist' - this is a wrong word. They are not 'Hindu nationalists'... they have nothing to do with Hinduism," Mr Gandhi emphasised. Interacting with students at Paris' Sciences PO University, he ripped into the government, which has been widely criticised for suppressing opposition leaders' voices within the country,

accusing them of being "out

to gain power at any cost".



"They(BJP and RSS) have nothing to do with Hinduism. They are out to gain power at any cost... and will do anything to ensure the caste structure and social structure of my country is not threatened," he said. "They seek the dominance of a few... that is what they are about." Mr Gandhi's comments

came after a question about the "scary radicalisation of youth by Hindutva forces". This is not the first time he has attacked the BJP on this topic. In 2021, he called them "fake Hindus" who "use" religion for their benefit.

The jabs invited a predictably furious response with BJP Lok Sabha MP Tejasvi Surya taunting his rival for "crying... while ment about 'Sanatan Bharat achieves global conright-wing commentators have claimed is a "call for the genocide of people with Sanatan thoughts".

Earlier this month Mr Stalin said, "Sanatana (Dharma) ought to be eradicated like malaria, dengue and mosquito ... "

An apoplectic BJP hit back, with Prime Minister Narendra Modi and several members of his cabinet and party targeting him. Mr Stalin was even the target of a 10 crore bounty allegedly issued by a temple priest in Uttar Pradesh's Ayodhya. Mr Gandhi has not, so far, responded directly to this controversy, although his party has, flipflopping between support and criticism. Karnataka minister Priyank Kharge disavowed any religion that does not treat all people as equals. However, Congress boss Mallikarjun Kharge, his father, seemed to want distance, declaring "there is no need to mix religion, politics".Mr Gandhi's jabs also come amid a fight over Tamil Nadu minister Udhayanidhi Stalin's comment about 'Sanatan Dharm', which the BJP and right-wing commentators have claimed is a "call for the genocide of people.

Kolkata, Sep 11 (UNI) Over 50 percent of suicide cases are reported from five major states: Maharashtra, Tamil Nadu, Madhya Pradesh, West Bengal, and Karnataka, in India's total figures that stood at 1,64,033 selfkillings in 2021, according to the National Crime Records Bureau (NCRB).

Meta to develop new high-powered AI model

Washington, Sep 11 (UNI) Meta Platforms, Inc. is developing a new, more powerful model of artificial intelligence (AI), The Wall Street Journal newspaper reported on Monday, citing sources.

The new system is expected to be as powerful as the most advanced ChatGPT AI model developed by OpenAI, the newspaper said.

The new AI model is aimed at helping other companies to create networks that perform complicated text and analytic tasks. Meta is currently constructing new centers for data processing to maintain the new AI, as well as purchases more H100, the advanced Nvidia chip, used for such operations.

The new AI is expected to be ready by the next year and to be many times more powerful than previous Meta's AI model, Llama 2.

Facebook Inc. rebranded itself as Meta in October 2021 during its push into the so-called metaverse, which augments reality with its vision of work and play in a virtual world. Meta products include social media platforms Facebook and Instagram (banned in Russia), as well as messaging app WhatsApp.

Mogadishu, Sep 11 (UNI) Somali National Army's elite force, Gorgor, killed more than 20 al-Shabab militants and wounded others early Sunday in heavy fighting between the army and militants at a military base in Awdheegle district in southern Somalia, officials said.

Abdirahman Yusuf Al-adala, deputy minister of Information, Culture and Tourism, told the national news agency that the brave troops responded swiftly and foiled the attack by al-Shabab fighters at the military base. "Our SNA forces took swift action against al-Shabab terrorists who attempted to attack an army base in Awdheegle district in Lower Shabelle region on Sunday morning. The terrorists left over 20 dead bodies at the scene. Our forces also recovered weapons during the operation," Al-adala said.

He did not confirm if there were casualties on the SNA side during the fierce fighting. Al-Shabab militants claimed responsibility for the latest attack, saying its fighters killed 59 soldiers including commanders and ran over the base.

The al-Qaida allied terror group normally inflates casualty figures during their battle with the government's security forces. The attacks continue across Somalia despite the security forces backed by allied forces having stepped up operations against the militants in the country.

G20 declaration on health: Mention of India's 3 priorities, digital push

ll three health priorities of India's G20 presidency found a mention in the G20 New Delhi Leaders' Declaration released on Saturday.

The declaration spoke of strengthening primary healthcare, health workforce, and essential health services to better-thanpre-pandemic levels, ideally within the next two to three years. In addition to focusing on epidemics such as tuberculosis and AIDS, the G20 recognised the importance of research on long COVID. The declaration also stressed the importance of one health approach – where diseases in animals, plants, and humans are tracked by the same mechanism - with focus on tackling antimicrobial resistance. The G20 health track that concluded last month was one of the most successful under India's presidency: not only did India manage to build consensus on all three of its priority areas, it also managed to launch a proposed repository of scalable digital health platforms.

What were the three priorities?

The three priorities kept in mind the economic and social disruption caused by Covid-19, and what could be done to prevent such losses in the future.

The priorities included:

* Building resilient systems for health emergency prevention, preparedness, and response.

^{*}Strengthening cooperation in the pharmaceutical sector with focus on ensuring equitable availability and access to vaccines, diagnostics, and therapeutics during a pandemic.

* Creating a platform for sharing digital health innovations and solutions to ensure better and universal health coverage, like CoWIN and e-Sanjeevani.

The consensus was reached with some compromises – India did not insist on countries contributing towards a \$200-million fund for a digital health programme, or on a permanent platform for sharing knowledge, intellectual property rights, and resources for developing vaccines, diagnostics, and therapeutics.



What is this digital health programme? With the pandemic highlighting the importance of digital health innovation, India committed to developing a platform for sharing scalable solutions under the World Health Organisation (WHO) that can be utilised by its member states. This culminated in the launch of Global Initiative on Digital Health (GIDH), with four main pillars – an investment tracker, a repository of existing digital health solutions, knowledge sharing for implementation and country-specific adaptation of these solutions, and an ask tracker to monitor the needs of different countries.

While a \$200-million fund proposed by India did not find consensus among countries, several non-profits have committed to the fund.

India has committed to offering its vaccine management platform CoWIN, its tele-medicine platform e-Sanjeevani, and its Ayushman Bharat Digital Mission platform as digital public goods to others.

This initiative, delegates present on the negotiating table said, may help in ending the "epidemic of pilots" where several

similar initiatives are launched in different countries but aren't scaled up.

A World Bank report released on the sidelines of the health ministers' meeting took a look at the Ayushman Bharat Digital Mission, and said it was "an example of a concerted effort to fill in the health information gaps and connect health information dots." Around 44.2 crore unique IDs have been created and 110 digital health services integrated into the mission as of August 2023, the report said. However, it went on to add that there are concerns regarding data protection and privacy.

What is the interim medical countermeasure platform?While there was no consensus on creating a permanent platform for ensuring equitable access to medical countermeasures during a pandemic, the committees agreed to develop an interim platform to promote an endto-end network for research and manufacturing them till a legally binding pandemic treaty can be agreed upon The outcome document said that the interim platform should be led by an inclusive decision-making arrangement, including

effective representation of low- and middle-income countries, and convened by the WHO.

Although there is an in-principle agreement by the G20 member countries on the need for such a platform, there is no clarity yet on how soon the platform can be developed.

Why have some opposed this interim platform?

Delegates present at the negotiating table said the push for this interim platform has come from G7 countries, which currently hold the majority of the patents for drugs, diagnostics, and vaccines. Even though the outcome document specifically mentions lower- and middle-income countries having a voice in the platform, many said it is likely to replicate the failures of the ACT accelerator – a similar platform developed to share medical countermeasures during Covid-19 – by giving more say to the G7 countries.

One of the senior delegates present at all the negotiations said, "This will replicate what the ACT did. Even the people who were on the table are not clear about the negotiations that happened during the pandemic. Also, now that Covid-19 is no longer a public health emergency of international concern, those agreements no longer stand, and poorer countries have to keep paying high prices to maintain the level of vaccination." Another said that an interim measure would be used as an excuse by the G7 countries to keep delaying a legally binding pandemic treaty.

What is the role proposed for traditional medicine?India's G20 presidency also pushed for integration of evidencebased traditional medicine practices with modern medicine. A global summit on traditional medicine was hosted on the sidelines of the health ministers' meeting last month. The outcome document said: "We acknowledge the potential of evidence-based traditional and complementary medicine practices in public health delivery systems, provided they are rigorously and scientifically validated."

Hepatitis C Patients Should Consider Re-Vaccination For Hepatitis B Virus: Study

patients should consider re-vaccination for hepatitis B virus, suggests a study after a previous research showed low response among patients with hepatitis C, finds study. Hepatitis C is caused by a blood-borne virus that leads to inflammation of the liver. Currently, there is no effective vaccine for Hepatitis C. Globally, about 58 mil-

epatitis C lion people have Hepatitis C, with 1.5 million new infections each year. Hepatitis B is a liver infection that can be prevented with the HBV vaccine. The new study, published in the Journal of Infectious Diseases conducted on 34



now is that after treating is present, they should be hepatitis C the hepatitis B vaccine seems to be more effective in this population. This is important as many of these individuals are still at risk for hepatitis B infection," Debes added.

Having both hepatitis B

offered a vaccine after treating hepatitis C, the researchers said. They also suggested research in a larger group to assess optimaltime for re-vaccination
