### **Doctor, cop among** 4 employees sacked by J&K govt over alleged terror links

SRINAGAR, NOV 22: Jammu & Kashmir government has sacked four employees, including a doctor and police constable, for their alleged anti-national activities and terror links.

The employees were sacked by invoking Article 311 (2)(c) of the Constitution of India, which allows the government to terminate employees without seeking an explanation from them or ordering an inquiry into their

The government, however, did not reveal specific details of their alleged terror or anti-national activities in which they were

The employees sacked on Tuesday included Assistant Professor in one of the largest tertiary care Hospitals of Kashmir, Dr. Nissarul-Hassan, police constable Abdul Majeed Bhat, school teacher Farooq Ahmed Mir and laboratory bearer in Higher Education department Abdul Salam Rather.

Dr. Nissar, a resident of Sopore in Baramulla district of Jammu and Kashmir was also the president of Doctors Association of Kashmir (DAK). He was also promoted as an Associate Professor a few days ago

## Kashmir Valley shivers, Srinagar, Pahalgam continue to experience coldest nights

**SRINAGAR, NOV 22:** Kashmir valley shivers as Srinagar and Pahalgam continue to experience the coldest nights with temperatures dipping to -1.8°C and -3.3°C, respectively, on Wednesday, officials said.

Srinagar experienced consecutive coldest nights, with temperatures further dipping from -1.2°C to -1.8°C on Wednesday, and it was -1.9°C below normal for this period of the season, the

MeT office said.

Similarly, Pahalgam also recorded the lowest temperature of the season on Wednesday at -3.3°C against -2.9°C the previous night. It was -0.9°C below normal for the tourist hot spot in south Kashmir.

Meanwhile, Qazigund, on the Srinagar-Jammu national highway, recorded a minimum of -1.0°C against -0.8°C the previous night, and it was -1.1°C below normal for the gateway to Kashmir.

has been constituted on the directions of Lieutenant Governor which will give its decision very soon. "Within a weeks' time the power generation will

increase and the situation will improve", the Divisional Commissioner added. He admitted that the unscheduled power cuts remain very painful for the people and we are look-

ing at it. The Divisional Commissioner said that "there were two issues that reduced the electricity supply to the consumers.. firstly the onset of early severe winter which was not expected and secondly there

were some issues with the generation capacity of electricity due to no rains". He said as the authorities had issued a power cut schedule for 4.30 hours to 6 hours in the metered areas and 8 to 10 hours for the non- metered areas and that could not be followed due to excessive

demand due to onset of severe winter. Bidhuri said in the flat rate areas the demand of power supply increased by five to ten times in different natures which need at times to apply distress cuts to save the transmission lines.

He urged those who are using electricity on flat rates and others to use less electricity gadgets to save energy. (UNI)

#### **KPDCL** accelerates.....

KPDCL also warned that legal action shall be taken against offenders who are found involved in rampant hooking and connecting electricity lines of their own.

While incidents of hooking in metered areas on bare conductor has witnessed a steep rise over the last one month, consumption of energy by consumers in unmetered areas over and above their agreed load has also sharply grown, putting huge strain on the power curtailment schedule.

In unmetered areas, the usage of power by consumers is three to four times their registered load, leading to frequent DT damages, low voltage condition thereby resulting in distress cuts.

Giving details in a statement released today, an official spokesperson stated that extensive inspection drives have been conducted by KPDCL in the first seven months of the current financial year.

"About 53,016 inspections have been conducted till October 31 this year, which includes 2370 by the Central Squad targeting high-end commercial and industrial consumers," he said, adding "that a penalty of Rs.12.68 crore has been imposed for unauthorized power use in terms of Section 126 of the Elec-

The spokesperson stated that special teams have been constituted across all 6 Circles of KPDCL for late night inspections to book those resorting to illegal hooking and using crude heating gadgets including banned nichrome-based, in a bid to reduce soaring energy demand in winter.

On a tip off through social media, inspection teams from Electric Division II, Srinagar, conducted surprise inspections in Ikhrajpora, KP Bagh and Sadaat Colony areas of ESD Chanapora and booked many offenders for illegal hooking. Fines in terms of Section 126 of the Electricity Act for unauthorised use of power have been imposed on such consumers.

The KPDCL spokesperson also attributed damage to Distribution Transformers (DTs), LT AB cables and Distribution Boxes to illegal hooking by consumers and use of crude heating gadgets.

He said that 64 DTs were damaged on Tuesday alone, a direct outcome of heavy loading of the electric transformers, over and above their approved capacity. "While 64 DTs were reported damaged on November 21,67 DTs were also repaired and replaced by the Central Workshop at Pampore and Workshops across all 19 Electric Divisions in Kashmir Valley, he added.

KPDCL assured the consumers that all DTs are serviced and maintained to provide smooth power supply, provided they are not overloaded due to power pilferage and illegal hooking.

The spokesman further assured the registered consumers of improvement in power situation if they use power judiciously as per agreed load, especially during peak time, in the mornings and evenings.

"Cases of power theft increase in winter months, which leads to severe overloading of the distribution system at certain places, resulting in unscheduled power cuts", he added.

In a bid to improve revenue realization, Circle I, Srinagar, disconnected 448 commercial and 147 industrial units on Tuesday for having failed to pay energy dues for the last three months amounting to Rs. 13.50 crore.

The commercial and industrial units whose power connections were disconnected are situated in Sheikhbagh, Dalgate, Habbakadal, Nishat, Khunmoh in Electric Division I and Khanyar, Hawal, KK Moulla, Rainawari and Zakura in ED IV.

The spokesperson further stated that KPDCL is targeting improvement in billing and collection efficiency to improve revenue realization and bring down AT&C losses to the levels fixed by the Government under RDSS norms. (UNI)

till a formal announcement is made but we are seriously considering it (winter vacations). A proposal has been submitted in this regard (to the administration)," Divisional Commissioner, Kashmir, V K Bhiduri told reporters here.

Bhiduri said while it is easy for the administration to announce winter vacations, it also has to ensure that the students do not suffer academically.

"We have to balance both things. The academic session of schools is planned and we have to figure in several things, including board examinations. The way the weather has changed, the government is considering this issue (winter vacation). A formal announcement will be made in a day or two," he

The officials said schools are likely to be closed in a phased manner according to past practice.

"We may not close all the classes in one go. Maybe primary classes will be closed in the beginning, then middle level and later senior secondary classes. In all likelihood, the primary classes will continue only till the end of this week," he said.

The minimum temperature in Kashmir valley has fallen significantly since Sunday night with the mercury in a freefall in Srinagar where the minimum temperature last night was minus 1.8 degrees Celsius two degrees below normal for this time of the year.

Over the last three days, dense fog has been witnessed early morning when children go to school.

Asked if the government has directed educational institutions to make heating arrangements, Bhiduri said the schools have been sensitized about this need.

"We cannot issue general instructions as some schools have good heating arrangements and some don't. However, we have sensitised the schools about the issue," he said.

Private Schools Association of Jammu and Kashmir has asked the government to consider announcing winter vacations for lower classes because of the cold wave conditions in the valley. (Agencies)

#### Doctor, cop.....

The order issued by the General Administration Department said the Lieutenant Governor is satisfied after considering the facts and circumstances of the case and on the basis of the information available, that the activities of Dr. Nisar-Ul-Hassan, Assistant Professor (Medicine), SMHS Hospital, Srinagar are such as to warrant his dismissal from service.

"And whereas, the Lieutenant Governor is satisfied under sub-clause (c) of the proviso to clause (2) of Article 311 of the Constitution of India that in the interest of the security of the State, it is not expedient to hold an enquiry in the case of Dr. Nisar-Ul-Hassan.... Accordingly, the Lieutenant Governor hereby dismisses Dr. Nisar-Ul-Hassan from service, with immediate effect," the order said.

Similar dismissal orders were issued to constable Abdul Majeed Bhat a resident of Kupwara, teacher Farooq Ahmed Mir of Kupwara and laboratory

bearer Abdul Salam of Kulgam.  $Two former Chief Mministers Omar Abdullah \, and \,$ 

Mehbooba Mufti have hit out at the sacking. National Conference Vice President Omar Abdullah said all these orders will be revisited once there

is a change in government. "...Everyone has a right to explain his position. Law says the same thing you are innocent till proven guilty . .. Unfortunately this has been happening and people are sacked like this. Let the regime change this matter will be revisited," Abdullah told report-

ers in central Kashmir. Mufti described the sacking as "humiliation of Kashmiris on a daily basis". "J&K admin has created an abysmal record of sorts by dismissing more employees than recruiting new ones. Snatching the livelihood of Kashmiris on false trivial grounds isn't just collective punishment. But also signifies the manner in which all Kashmiris are mistrusted &

humiliated on a daily basis," she said on X. Over the last two years, the I&K government has terminated the services of over 50 employees for being a "threat" to the security of the state.

The sacking of employees started in April 2021 and the government terms it a part of its effort to counter the terrorist ecosystem in J&K. (UNI)

#### Dismissed J&K.....

Mir, who has been sacked under the provisions of Article 311 of the Constitution, is a resident of Kupwara in north Kashmir and had exfiltrated in 1990 and received arms training at ISI-operated camps before infiltrating back after a year.

He was a top commander of the Hizbul Mujahideen terror outfit before being arrested in 1991, the offi-

He was arrested by security forces and remained under detention for two years to be subsequently released in 1993, they said, adding immediately after his release, Mir made good use of his affiliation and influence within the secessionist-terrorist ecosystem to get himself appointed as a Class-IV employee in the education department.

Jammu and Kashmir was under Governor's rule t that time.

Mir, a resident of north Kashmir's Kupwara district, was initially appointed to the education department in 1994 and was later promoted to the post of a teacher in 2007, a time when the PDP-Congress government was in power. "Propriety and sanity would expect that after joining the government, Mir would refrain from indulging in anti-national activities. But he openly began preaching and practising secessionist ideology and emerged as the most active and remarkably senior functionary of secessionist organisation Tehreek-e-Hurriyat (TeH) led by hardline Hurriyat Conference leader Syed Ali Shah Geelani." the official said.

The charge sheet showed that Mir had gained prominence in Kupwara as a staunch supporter and

sympathiser of the banned Jamaat-e-Islami (JeI).

'Being a Pakistan-trained terrorist and having a significant position in the secessionist camp, bestowed him with huge powers. Like many such other entities, his name would instil fear and awe in common people and local administration," an official said.

Continuing his secessionist and terrorist incitation, the officials said Mir played a major role in the 2008 Amarnath land row agitation and was openly propagating 'Jihad' against India and exhorting the youth to join terrorism.

A case under relevant sections of the law, including the Unlawful Activities (Prevention) Act, was registered against him at Kupwara police station on November 13, 2009.

In this particular incident, he not only incited and provoked youth to join terrorist ranks but also hatched a criminal conspiracy with other secessionist elements to orchestrate large-scale violence in Kupwara.

On July 23, 2010, the officials said he instigated, incited and provoked an unruly mob to commit violence and leading the violent mob he made forcible entry in the police guard room at Kupwara district hospital and set the guard room on fire.

In this connection, another criminal case was registered against him and others in police station Kupwara, they said, adding for his incorrigible unlawful behaviour, he was finally detained under the provisions of the Public Safety Act (PSA) in 2010 and lodged in Central Jail Kot Balwal, Jammu for a period

"The strange and sad state of affairs is that despite being detained under PSA and arrested many times, no disciplinary action was taken against him by the department. He paradoxically was never marked absent despite being in jail for six months for one occasion and was shown on duty and paid full salary," the official said, adding this evidence shows the "influence and penetration of adversary" within the government system.

Not mending his ways, they said, Mir played a major role in the 2016 violent agitation that erupted after the killing of poster boy of Hizbul terrorist Burhan Wani and was at the forefront of mobilising

mobs and instigating violence in Kupwara town. "The actions of Mir were at a huge cost to human lives and property. Many young people were killed and many more got injured due to his incitation. Public and private property worth scores of crores got destroyed," the charge sheet reasoned.

"It is not a hidden fact that thousands of unscrupulous people, having affiliation with the secessionist-terrorist ecosystem and even the Pakistan-trained terrorists were appointed in government services blatantly throwing all norms to the winds.

Mir was dismissed along with an assistant professor (medicine) at SMHS Hospital, Srinagar, Nisar-ul-Hassan, constable Abdul Majeed Bhat and laboratory bearer in the Higher Education Department Abdul Salam Rather in terms of Article 311 of the Constitution of India, they said. (Agencies)

#### J&K's Unemployment.....

Speaking on the occasion, Secretary (Labour and Employment), Rehana Batul called upon all stakeholders to work towards further bringing down the unemployment rate of the UT and said that more than a dozen departments are working for employment generation and were going to implement many more schemes in this pursuit.

Batul maintained that all departments should learn from each others' best practices for replicating

them in the implementation of their schemes. "Our sole motive should be to contribute towards providing ample opportunities to the aspiring youths," she said. She asked them to be ready to sit with the financial institutions to iron out any differ-

The annual meeting served as a unique platform for collaborative discussions on various issues, including follow-up actions on the Secretary-General's response to the Panel Letter and addressing critical concerns related to financial management, climate change, and digital matters.

In the meeting, Murmu led the discussion on critical financial and management issues affecting UN organisations.

In a separate meeting, Murmu and panel members met with UN Secretary-General Antonio Guterres, exchanging views in the areas of risk management, the challenging financial environment, and the imperative for well-structured funding strategies.

The panel members emphasised the pivotal role of the UN system in guiding and managing climate finance issues, along with expressing concerns about digital transformation. (Agencies)

The official also said that the winter vacations for other classes will likely commence after the first week of December for Middle classes and second week of December for high and secondary level classes respectively.

Meanwhile, Divisional Commissioner, Kashmir, Vijay Kumar Bidhuri said that the winter vacation for schools in Kashmir will be announced in a day or two as they are seriously considering the issue. While speaking with reporters, Bidhuri said that the decision to announce the vacation will be made after considering various factors, including the impact of vacation on the academic calendar of students.

He said that the vacations will be announced in a phased manner, with primary schools being the first to close, followed by middle and higher schools.

"The exact dates for the vacation will be announced in a day or two," he said. The Divisional Commissioner also assured that the government is committed to ensuring that the academic calendar of students does not suffer as a result of the vacation.

In the meantime, advisor to Lieutenant Governor. Rajiv Rai Bhatnagar told KNO that the concerned authorities will take a call soon in this regard.

"The matter of winter vacation is being highly considered and we are also keeping tabs on the syllable and other important factors before announcing early winter vacation," he said.

HANDWARA, NOV 22: Unscheduled power cuts for long hours have irked the residents of both rural and urban areas of Langate and Handwara constituency. Metered, as well as non-metered area consumers alleged that the Power Development Department(PDD)division Handwara is not following its reduction schedule and subjecting them to long hours of unscheduled power cuts during day and night hours.Local residents of Handawara told



HEADLINES TODAY, We are witnessing frequent power cuts opposing our locality being full metered, adding that unscheduled power cuts have grown severe from past twenty days giving a hard time to people', especially in evening hours. It is a very tough time to survive without electricity in these harsh winters, said Mustafa Manzoor resident of Handwara. Residents of different villages like Kultoora, Guloora, Phauropeth, Khuroo, Hanjishat, Gund Kharou, Chotipora, Gund Chogal and Chogal said, despite paying electric bills, the unscheduled power cuts have thrown people in darkness. We hardly receive power supply for three to four hours a day, peole added."We have been paying bills in time and still not getting electricity on time. The department forces us to suffer in these cold days by frequent power cuts. In 24 hours the electricity remains hardly for Three to Four hours they said unscheduled and expanded power cuts have also distressed the business units in Handwara and other Langate,,"Trade president Handwara Sofi Ajaz said.(HT) A group of students from different institutions especially from GMC Handwara said due to unscheduled and prolonged power cuts, they could not study after every 20 minutes. "The light goes off forcing them to wait for hours and after that, the hardships continue till night," said a student Akther Azad from Handwara.We are facing acute power crisis in our locality. Unscheduled power cuts are causing us a lot of miseries. Our children aren't able to give their 100% to their studies as they need", local villagers said.(HT)A resident of Kultoora Bashir Ah said, "Frequent power cuts are evident here. We do not receive proper power supply as per schedule, which have become a daily affair now since last 20-days". The residents have sought an intervention of concerned authorities to look out the grievance so that the residents have a sigh of relief.PDD department on the other hand claims there is no power shortage and no cuts are being imposed. It says "technical faults" might be leading to interruption in supply.(HT)

## Amid tourism boom, Kashmir's border residents hope uninterrupted connectivity this winter

'We would remain cut-off for months together, tourism activities must continue without halt'

BARAMULLA, NOV 22: Kashmir's border residents have pinned hopes on the thriving tourism this winter stating that they hope to stay connected in the upcoming harsh winter days given the huge winter tourism

potential of border areas.  $As \, per \, the \, news \, agency-Kash$ mir News Observer (KNO), as the clamour for stocking of essential services in border areas grows louder, there is an increasing demand for necessities such as helicopter services for students appearing for exams, people requiring medical attention, and others, especially when road connectivity is disrupted by heavy

While undoubtedly these places are a tourist heaven in the summer, locals of Gurez, Tangdhar, Karnah and Tulail hope that they stay connected amid thriving tourism in winters this season.

"During heavy snowfall, winter becomes an intensely chilling ordeal for the residents of the border areas and at such times, it becomes challenging for others to comprehend the magnitude of our struggles," the residents said.

While authorities may make efforts to keep these routes accessible, the increasing snowfall is likely to result in complete closures throughout the winter, leaving places such as Gurez, Tanghdar, Karnah, and Tulail entirely isolated.

Protesting for the past 30 years, the residents of Karnah are steadfast in their demand for the construction of a tunnel at the SadhnaPass on the Kupwara-Tangdhar road, which has become perilous over time, often deemed a 'death trap.' They express their annual yearning for improved road connectivity during the winter season. Every winter, the stretches,



including Gurez and Karnah, witness closures due to heavy snowfall, causing increasing concern for the thousands of people residing in these areas with each passing day.

"When the roads close due to snowfall, the immediate concern is how to manage if someone falls ill; it's easy to talk about, but the actual pain we endure is incomprehensible," said Gulam Ahmad, a local of Karnah, while highlighting the hardships faced in these

situations.

Manzoor Ahmad, another resident of Gurez, urges the administration to take into account the challenges experienced by the people last winter and actively address them to provide relief.

He said that there is a need for an examination of the health sector and advocates for an assessment of staffing shortages and the prompt fulfilment of vacant positions. He also said that the

importance of inspecting generator sets to ensure uninterrupted electricity supply during the upcoming winter is must.

"We shouldn't have to long for basic healthcare and other facilities here during heavy snowfall; the government should proactively address the issues of border residents beforehand," said Mohammad Ayaz, another resi-

dent of Tulail. Meanwhile, a senior official stated that the government is actively addressing essential services and other facilities for border residents. During heavy snowfall in these areas, road clearance operations will be expedited. "However, in cases of road closures, helicopter services are promptly deployed," he said, adding that the main roads will be promptly cleared off the snow to ensure tourism remains abuzz in border areas.

#### NHAI to undertake safety audit of 6 under-construction tunnels in J&K

SRINAGAR, NOV 22: The National Highways Authority of India (NHAI) will undertake a safety audit of six under-construction tunnels in Jammu & Kashmir after one such tunnel collapsed in Uttarakhand, trapping 41 construction workers.

Talking to news agency—Kashmir News Observer (KNO), Regional Officer, NHAI, J&K, P Siva Shankar said that they are undertaking a safety audit of the tunnels being constructed at Maroge, Digdol and Panthyal. "We are undertak-

ing a safety audit of both tubes of these tunnels," he said. The announcement of the safety audit of tunnels being constructed by the NHAI in different states and UTs was made by the Centre today.

In total, NHAI will undertake a safe audit of 29 tunnels. Of these tunnels, 12 are in Himachal Pradesh, six in Iammu & Kashmir, two each in Maharashtra, Odisha, Rajasthan and one each in the states of Madhya Pradesh, Karnataka, Chhattisgarh, Uttarakhand and Delhi respectively. According to an official handout, NHAI officials along with a team of experts from Delhi Metro Rail Corporation (DMRC) as well as other tunnel experts will inspect the ongoing tunnel projects and will submit a report within seven days.

# India Emerging As Top Source Market For Leisure Travel To Global Destinations

Economic Prosperity, Youthful Population Add To Propensity For Foreign Trips

Boosted by rising economic prosperity and a fast-growing economy, India is set to be an important global source market for leisure travel and the world could see a wave of Indian travellers as destinations try to delight and attract them, global consulting agency McKinsey says in a special report on Indian tourists.

India is now the fifth-largest economy, and the population has surpassed China's to become the largest in the world, at over 1.4 billion people, the report pointed out. Another significant aspect is the population is young, with the median age being 27.6, more than ten years younger than that of most major economies. It also cites the fact that consumption of goods and services, including leisure and recreation, is forecast to double by 2030. Adding a strong post-pandemic travel recovery, and a growing appetite for international travel, these factors point to India's significant potential for outbound tourism, McKinsey says.

McKinseysees a wave of Indian travellers setting out to see the world, spurred by the country's forecast growthin GDP percapita, accompanied by a growing propensity for international travel. If India follows China's outbound travel trajectory, then Indian tourists could make 80 million to 90 million trips a year by 2040.

India is already one of Asia's key outbound tourist markets. Prior to the Covid-19 pandemic, India's outbound tourist market was among the fastest-growing markets in Asia. India has already recovered 61 percent of its pre-pandemic market, with 13 million outbound tourists in 2022. This represents a much quicker recovery than most Asian countries.

There are a few steady favourite destinations for Indian tourists, the top pick being the United Arab Emirates. The report attributes this preference to proximity. In fact, around 70 percent of travellers choose nearby destinations. With a travel time of less than four hours, and a large Indian diaspora, the Middle East is a destination of choice for around one-third of Indian travellers, closely followed by South Asian destinations. For long-haul trips, North America and Western Europe stand out as preferred choices. While the top destinations have remained fairly consistent over the past decade,



others are shaking up the rankings, the report notes.

In 2022, India was the largest source market for leisure travellers to Dubai. The city is known for its luxury offerings and, perhaps surprisingly, also offers a wide range of accommodations, such as 3-star options. And flights from India are affordable when compared with flights of similar distances. Taken together, these factors make the luxury of Dubai accessible to Indian travellers, the report points out.

An important finding of the report is that destination preferences vary across regions. For example, travellers from North India constitute a large share of travel to the United States and Canada, while two-thirds of travellers from Kerala prefer destinations in the Middle East. Purpose of travel, distribution of the diaspora, and cultural linkages play a role in destination choice. The US and Canada attracts a large number of travellers from North India, particularly centres such as Delhi, Chandigarh, Amritsar, Jaipur, Lucknow, Varanasi and Srinagar. Two-thirds of travellers from Kerala visit the Middle East, which is the only region with traffic from non-international airports, indicating connectivity with smaller airports. Compared with other destinations, the UAE attracts a more balanced range of Indian travellers.

Indian market. These could include accessibility, connectivity, affordability and travel experience. The report points out how over the past decade, Thailand has been carrying on marketing campaigns specifically for Indian consumers, travel agents, and niche businesses. For example, marketing campaigns directed at Indian wedding planners and couples positioned Thai-

most Asian countries

land as a top choice for weddings and honeymoons. Campaigns for travel agents showcased Thai culture and tourist attractions, catering to budget travellers and high-spending groups alike.

The report cites the case of Azerbaijan to show how easy visa process greatly helps in boosting leisure travel. Complicated visa application processes, or long waiting periods, can influence decisions around vacation destinations. Leisure travellers can be swayed by how difficult or easy it may be to obtain a visa. In 2017, Azerbaijan introduced the ASAN system that processes electronic visas within three working days of application. Popularity with Indian tourists skyrocketed thereafter, with annual arrivals increasing five-fold by 2019. Combined with direct flights from India, and restaurantand accommodation options suitable  $for Indian \, tour ists, the \, country \, became$ increasingly attractive for Indian travellers, the report points out.

While only 9 percent of Indian travellers focus on long-haul destinations in Western Europe, Switzerland has been an Indian top-20 destination for over a decade. The report attributes the Bollywood connection to Switzerland for this popularity. Many Bollywood hits feature Swiss attractions, there are plenty of Indian restaurants and cultural festivals, and English is widely spoken there.

## It Is Time To Take Note Of The Leading Israeli Intellectual's Lessons On Terrorism

Yuval Noah Harari has emerged as one of 21st century's most recognised public intellectuals. In the midst of the Israel—Palestine war in Gaza, it is useful to revisit his 21 Lessons for the 21st Century, published in 2018.

He writes that "terrorism" is a "strategy almost always adopted by very weak parties who cannot inflict much material damage on their enemies". They resort to terror because spreading "fear is their main story." Most important of all, "There is an astounding disproportion between the actual strength of the terrorists and the fear they manage to inspire." He goes on to say that terrorists calculate that when the "enraged enemy uses his massive strength against them, he will, raise a much more violent military and political than the terrorists themselves could ever create". He further underlines, "provoking the enemy to action without eliminating any of his weapons or options is an act of desperation taken only when there is no

Although in 2018, when the book was published, Harari like more Israelis, took virtually no note of Hamas as like most Israelis, was totally complacent that Israel's military and intelligence had the Palestinians completely cowed, his extraordinary accurate of "desperation" leaving the oppressed with little "choice" but resort to foredoomed violence is that "since they are very weak and have no military option,



they have nothing to lose and everything to gain." That is why Hamas unleashed its limited stock of missiles in virtually one go, then broke through the Israel barricades to capture about 200 hostages to bargain for release of their own men and women—

some 2000 of them locked in Israeli jails. They knew, of course, that Israeli would retaliate—and retaliate inhumanly, viciously and disparately. As Harari has predicted, "Fear and confusion will cause the enemy to misuse his intact strength and overreach". So that, "Mistakes are made, atrocities are committed, public wavers, neutrals change their stance and balance of power changes". For again as Harari says, "Terrorism is a military strategy that hopes to change the political situation by spreading

## RBI must see crypto as assets, not currencies. No one's using it to buy grocery

India is seeing the second-highest levels of crypto transaction volumes after the US. A missing regulatory environment would leave Indians to the sharks.

The Ministry of Finance and the Reserve Bank of India are running out of reasons not to implement consolidated cryptocurrency regulation in India. It's time for them to finally bite this bullet. Their hesitance made some sense initially, nascent as the crypto industry was at the time. But it's now clear that India is a major crypto market—one of the largest in the world—and the crypto craze is thriving, regardless of how hostile policymakers make it for traders.

Yet, even the latest statements by RBI Governor Shaktikanta Das make it seem as if policymakers either don't understand or are deliberately ignoring the reality of what's happening in the crypto market. Most of the concern seems to be about the ramifications of widespread use of cryptocurrencies as a currency, with close to none being about their use as assets.

This selective blindness is strange, especially considering how proactive the RBI has been about Central Bank Digital Currencies (CBDCs) and the fact that the government itself refers to cryptocurrencies as virtual digital assets (VDAs).

The thing is, people don't buy private cryptocurrencies—such as Bitcoin, Ethereum, Dogecoin, and the like—so they can use them to buy bread. That kind of role as a medium of exchange may have been part of the original idea of cryptocurrencies, but the thinking has since evolved. People buy cryptocurrencies with the hope of achieving the super-normal profits that many have seen from such investments in recent

 $Cryptocurrencies have \ resurrected \ and \ democratised$ the possibility of becoming fabulously wealthy overnight, and this is the idea that is finding increasing appeal in economies where income inequality is widening-not the notion of using cryptocurrencies at the grocery store.

The 2023 edition of the 'Geography of Cryptocurrency Report' by the crypto analytics firm Chainalysis, released earlier this month, has pegged India at the top of the crypto adoption index, which basically means that India is experiencing the highest levels of crypto adoption at the grassroots level.

The report also says that India has the secondhighest levels of crypto transaction volumes, second only to the US, and beating out wealthier nations like the UK, Canada, and Germany.

The report made it a point to mention that India's emergence as a top crypto market is happening despite a tax and regulatory environment that "can be challenging for the industry to navigate". In other words, even though policymakers have made it tough to operate in this space, crypto adoption and usage are still surging in India.



It's not hard to understand why this is happening in developing countries such as India, Vietnam, the Philippines, Indonesia, Pakistan, and Thailand—all of which feature in the top-10 countries in crypto  $adoption. High \, rates \, of \, economic \, growth \, and \, distress$ are typically accompanied by rising inequality levels. Those at the bottom increasingly look for unconventional ways to augment their subdued incomes.

Enter cryptocurrencies offering the allure of overnight millions.

The missing touch

Now, it's not as if the finance ministry or the RBI have been blind to this growing interest in cryptocurrencies in India. Over the years, both bodies have made it clear that investing in cryptocurrencies is akin to falling for a Ponzi scheme. The RBI has consistently and vocally advocated for banning

cryptocurrencies.

The finance ministry has somewhat softened its stance, changing the nomenclature of its proposed legislation to remove the word 'banning' from the title and instead focusing on regulation. However, despite being finalised back in 2021, the crypto bill is no closer to being considered and passed by

Instead, the government has taken a more piecemeal approach to regulation. In Budget 2022, it announced a 30 percent tax on profits arising from crypto transactions and a 1 percent tax deducted at source (TDS) on all crypto transactions. In March of this year, it said that the Prevention of Money Laundering Act (PMLA) would apply to crypto transactions as

However, these are all high-level regulations,

whereas what's needed are the nuts and bolts of the rules. India's stubbornly growing crypto industry needs clear regulations covering aspects such as know-your-customer norms (currently based on the PMLA), explicit specifications on whether cryptocurrencies can or cannot be used as mediums of exchange, and rules for fraud prevention and resolution, among other aspects.

In fact, the Chainalysis report has highlighted that an uneven implementation of the TDS regulation has led many Indian users to flock to international crypto exchanges that don't collect TDS as effectively, to the detriment of homegrown exchanges.

The finance ministry has been saying that it will finalise its own crypto regulations once there is international consensus on what shape such regulations should take. That consensus is now in place, thanks in large part to India's efforts during its recently concluded presidency of the G20. With a draft bill already in place, it should be relatively easy to tweak it and introduce it during the upcoming winter session

RBI Governor Shaktikanta Das recently revealed quite a bit about how the government and RBI are thinking about the crypto issue. Speaking during a one-on-one chat with an International Monetary Fund official during a G20 meeting in Marrakech, he highlighted the risks associated with cryptocurrencies as currencies.

According to him, these risks included threats to domestic financial stability, global financial stability, domestic monetary system, global monetary order, and problems of terror financing and money laundering. "The central bank itself will lose control over the monetary system," he lamented.

As the governor of India's central bank, he would, of course, be well aware of these risks, but noticeably absent in his reply was any mention of cryptocurrencies

Sure, dealing with assets might have been outside his jurisdiction as a central banker, but a mention of that manner of usage of cryptos would have shown that the regulators were cognisant of how cryptos were actually being used in the country. The fear might be of cryptos as currencies, but the reality is cryptos as assets.

The governor, in Marrakech, evocatively said, "We need to know, before entering the water, how many sharks are there inside the water". The thing is, it's the regulators that can and should dispel the sharks. Leaving Indian crypto enthusiasts to the mercy of these 'sharks' for too long isn't prudent regulation; it's irresponsible.

## More Floods Mean Worse Soil

Data from research initiatives and modelling studies should be widely disseminated and communicated with governments and humanitarian agencies

Across the world, the intensity and frequency of flooding events has escalated. In the last few months alone, record-breaking floods have pummelled New Jersey and New York, Libya, and Greece, killing thousands of people and causing widespread damage to infrastructure, farmland, and livestock. This, in turn, puts pressure on agriculture, which can drive food insecurity.

Compared to the visible devastation caused by flooding, the impact on soil is subtler but no less important. Floods can harm soil biology and health, as well as the beneficial microorganisms and larger organisms like insect larvae, nematodes, springtails, and earthworms that live in the soil and perform fundamental functions such as breaking down crop residues, recycling nutrients, stimulating plant growth, and fending off stressors, including insects. Damage to this symbiotic ecosystem has far-reaching implications for crop production.

New research from my lab at the University of Illinois, which is investigating the impact of flooding on soil-microbial communities and agricultural staples such as maize and tomatoes, and from other scholars, shows that extreme wet conditions can cause severe crop losses, including from reduced plant growth and

unplanted farmland.

Despite being relatively limited so far, research has also demonstrated that flooding can negatively affect soil functioning and soil-microbial communities. One experiment using spring wheat found that floods depleted beneficial microbes and increased those that were detrimental to plants. Another experiment showed that these extreme events reduced microbial biomass and soil-fungi content.

Moreover, once the water recedes, surviving microbes are left with a fundamentally different habitat; depending on the conditions, they can bounce back quickly or die off slowly. Without a healthy and functional soil microbiome, nutrients are not recycled, and plants are weakened, paving the way for invaders – such as insects and pathogens - to

This is bad for plants, but also for humans. Healthy soils are the basis for healthy food production: we depend on them to grow crops that have high nutritional value. Research on different farming methods has highlighted the important – and often underappreciated – role that soil health plays in determining the nutrient density of foods grown. This implies that we need more research aimed at understanding the impact of flooding on crops that are relevant for food security,



including research on how floods affect soil biology, quality, and health, including the consequences for beneficial soil microbes.

More importantly, researchers must work to identify the interventions that, in the wake of a flood, can help support plant health, restore soil fertility, and facilitate the recovery of soildwelling microorganisms and larger organisms. For example, applying nitrogen fertilizer

immediately after flooding has been proposed as one of the mitigation strategies that could nurse water-logged plants back

Unfortunately, soil-dwelling microbes and larger organisms may take longer than actively growing plants to recover. Their rehabilitation could last anywhere from a year to multiple years, depending on several factors, including the duration and severity of the flooding, and the soil's condition prior to the extreme wet conditions. Making use of cover crops is among the recommended measures to restore these organisms.

Modelling studies, which could help determine where future flooding events may occur and how long they may last, should complement these research efforts. It is not feasible to conduct experiments in all environmental

conditions, some of which have yet to be created. Flood modeling is thus a crucial tool for testing hypotheses and analyzing various scenarios, especially regarding soil quality, microbial communities, and plant health.

Data from research initiatives and modelling studies should be widely disseminated and communicated with governments and humanitarian agencies. That way, policymakers and civilsociety leaders can formulate strategies and interventions to prevent flood-induced soil degradation.

Countries around the world must connect the dots between flooding, soil quality, plant health, and food insecurity. Only when we care for the invisible world of microscopic life that underpins our agriculture can we create a comprehensive preparedness strategy and design sciencebacked interventions to minimise flooding's harmful impact on crop production. As extreme weather events become more common and more intense, it is time to stop treating our soil like dirt.

## "12 Metres Left" In Race To Save 41 **Workers Trapped In Uttarakhand Tunnel** ■ HT News Network

New Delhi: Only 12 metres of rock and debris separate 41 workers trapped in the collapsed tunnel in Uttarakhand's Silkyara and rescue officials racing to save them, and "big news" is expected by 11.30 pm, officials said Wednesday, after the American-made drill bored another six metres into the hillside.

"I am happy to announce we have been able to move forward by another six meters. It is expected that in the next two hours, when we prepare for the next phase, we will be able to (finish) remaining work," Bhaskar Khulbe, the Special Officer deputed to the Uttarakhand Tourism Department, told reporters.

Mr Khulbe said about 67 per cent of drilling had been completed. Earlier today Mahmood Ahmed, a senior official with Uttarakhand's Road and Transport Department, said the auger (or earth drilling machine) that was switched on at 12.45 am had drilled 18 metres so far.

"I am very happy to share that drilling for 39 metres



has been completed. Estimates indicate the workers are trapped 57 metres underground, so only 18 metres is left," he explained.

Mr Ahmed also said the most time-consuming process - in a rescue attempt that is now in its 11th day - is the welding of pipes to be pushed into the drilled holes to provide workers' an escape route. "Welding is most important... this takes time. It does not take much time to drill... due to this it has taken almost 15 hours, from late night, to send 18 metres of pipes, i.e., three sections," he added. "An additional 800mm pipe has also been pushed 21 metres inside the tunnel."

"If there are no obstacles, some big news may be received tonight or tomorrow morning. An iron rod has also come with the debris. We are happy this (rod) did not create any problems for us..."

"This is very happy news for us, that we are moving forward at a fast pace," he added. However, Mr Ahmed also issued a word of warning - that the remaining section is the most critical.

Rescue efforts have been slow, complicated by falling debris as well as repeated breakdowns of heavy-drilling machines. One machine last week ran into boulders, causing drilling to be suspended for over three days after the tunnel's roof seemed to crack.

Both the state and the central governments have promised to do all they can to bring the 41 workers back up safely, but they have refused to give a definitive timeline for their rescue, noting these are "subject to change due to technical glitches, challenging terrain, and unforeseen emergencies".

Officials have said the workers could be rescued any time between 60 hours and 15 days. Five government agencies, including the Oil and Natural Gas Corporation - have been roped in to this massive effort, and given specific goals, including drilling vertically for an alternative escae route.

In case the route through the main entrance does not work, blasting and drilling have also begun from the far end of the unfinished tunnel, which is nearly half a kilometre long.

Preparations have also been made for a risky vertical shaft directly above.

Rescuers have already drilled smaller holes to reach the tunnel in which the workers have been trapped since November 12, and have used these to supply them with food, water and medicines.

One of these holes was used to insert a smaller pipe and then to push an endoscopy camera nearly 60 metres down to capture the first images of the trapped workers. The blurry images showed over a dozen men, wearing white and yellow hardhats, standing in a large cavernous area.

### **Amid Myanmar Clashes, India Asks Its Nationals To Register At Embassy**

New Delhi: Amid mounting hostilities between Myanmar's anti-junta groups and government forces, India on Tuesday asked its citizens to avoid non-essential travel to the neighbouring country and advised Indians living there to register with the embassy in

Since the current conflict in Myanmar started in 2021, a large number of citizens from the neighbouring country have taken refuge in India. According to the UN, the intensified fighting in Myanmar since last month has displaced about 90,000 people.

"In view of the evolving security situation in Myanmar, all Indian nationals are advised to avoid non-essential travel. Those already living in Myanmar are advised to take precautions and avoid travel to the regions affected by violence. Inter-state travel by road should also be avoided," the advisory said.

### BSF seize 5.3kg of heroin from Punjab border

Patna: The Nitish Kumar government in Bihar upped the ante on the Chief Minister's long-standing demand for grant of special status to the state with a resolution to the effect on Wednesday being passed by the cabinet.

Mr Kumar broke the news himself, announcing the development on social media, shortly after the cabinet meeting he chaired here was over.

"The cabinet has passed a resolution (prastaav) requesting the Centre for grant of special category status to Bihar", Mr Kumar wrote in a lengthy post in which he also said that the fresh demand was necessitated by findings of the caste survey his government carried out in the state. Mr Kumar said that while the rise in percentage of population of the deprived castes has led to increase in the quotas for SCs, STs and OBCs from 50 to 65 per cent, his govern-

"The implementation of all such measures will incur an expenditure of 2.50 lakh crore. Because of the huge sum involved, we have set a deadline of five years from now for the completion of the schemes. But if we get special category status, we will be able to accomplish the task in a much shorter time", said Mr

Kumar. The JD(U) leader, who is

the state's longest-serving chief minister, also recounted that he had been raising the demand for special status "since 2010" and rallies to press the demand were addressed by him here in 2012 and a year later at the Ram Lila Maidan in Delhi. "To look into our demand, the government at the Centre had set up a committee headed by (former RBI governor) Raghuram Rajan which submitted its report but nothing came of it. In May 2017, we again wrote to the Centre requesting special status..... it is my request that the Centre agree to the demand keeping in view the interests of the people of Bihar", said Mr Kumar.

Notably, Mr Kumar, who had dumped the BJP last year and has emerged as a key figure of the opposition coalition INDIA, has been asserting that if the new formation formed the next government at the Centre, he would press for "special status to all backward states".

## "Pitch Good, Hopefully Will Win": Congress' Azharuddin On Telangana Polls

Hyderabad: Congress leader and ex-Lok Sabha MP Mohammad Azharuddin is taking guard for the next innings in his political career - the former India cricket captain is his party's candidate for the Jubilee Hills seat in Hyderabad in this month's Telangana election. Azharuddin, who led India in 47 Tests and 174 One Day Internationals, faces a strong challenge from the incumbent lawmaker - the ruling BRS' Maganti Gopinath - but told NDTV he is confident of a good result after the state votes on November 30."The pitch is very good. I'm working hard and, inshallah, hopefully will prevail," he said, swatting away the challenge of his rival, whom he accused of encouraging "goondaism"."In last nine years, no work has been done here and people are fed up, and are living in fear. He (Maganti Gopinath) only promotes 'goondaism'! Even now, his men are scaring away people working for me... they are putting fake cases with help from the police."

"This is not the way a MLA should be. The other day he was standing next to KT Rama Rao (a Telangana minister and Chief Minister K Chandrasekhar Rao's son) and saying, 'I will remove 'rowdyism". But he himself is a rowdy... so how will he do anything?" The Jubilee Hills seat - one of the poshest areas in Hyderabad - is home to over one lakh Muslim voters. For the Congress, fielding Azharuddin from here was an obvious option. That said, his Muslim identity wasn't the only reason the Congress picked Azhar, party sources had told NDTV, pointing to the emotional connection between him and the city. The large number of Muslim voters is also why Asaduddin Owaisi's AIMIM has fielded its candidate - Mohammed Rashed Farazuddin, a municipal corporator with influence over voters in the Shaikpet area.

## Israel and Hamas agree on 4-day truce upon exchange of hostages, Palestinian prisoners

Israel's government and Hamas agreed on Wednesday to a four-day truce to allow the release of some hostages held in Gaza in exchange for Palestinians imprisoned in Israel, and the entry of humanitarian aid into the besieged enclave.

The official start time for the truce is expected to be announced within 24 hours, with the first hostages to go free on Thurs-

In a statement, mediator Qatar called the agreement a "humanitarian pause".

A statement by Israeli Prime Minister Benjamin Netanyahu's office said 50 women and children will be released over four days, during which there will be a pause in fighting.

For every additional 10 hostages released, the pause would be extended by another day, it said, without mentioning the release of Palestinian prisoners in exchange. However, Israel's justice ministry published a list of 300 names of Palestinian prisoners who could be freed.

"Israel's government is committed to returning all the hostages home. Tonight, it approved the proposed deal as a first stage to achieving this goal," said the statement, released after hours of deliberation that were closed to the press.

Hamas said the initial 50 hostages would



be released in exchange for 150 Palestinian women and children held in Israeli jails. Hundreds of trucks of humanitarian, medical and fuel supplies would enter Gaza, while Israel would halt all air sorties over southern Gaza and maintain a daily sixhour daytime no-fly window in the north,

Israel had committed not to attack or arrest anyone in all parts of Gaza during the truce period, it added.

US President Joe Biden said he welcomed the deal. "Today's deal should bring home additional American hostages, and I will not stop until they are all released," he said in a statement.

The accord is the first truce of a conflict

in which Israeli bombardments have flattened swathes of Gaza, killed 13,300 civilians in the tiny densely populated enclave and left about two-thirds of its 2.3 million people homeless.

Pending the start of the truce there was no let-up in fighting. As morning broke, smoke from explosions could be seen rising above northern Gaza in live Reuters video from across the fence.

Israel's military released footage of soldiers shooting in narrow alleyways and said it had carried out airstrikes. Its "forces continue to operate within the Strip's territory to destroy terrorist infrastructure, eliminate terrorists and locate weaponry", it said. 'What truce can there be?'

"What truce can there be after what happened to us? We are all are dead people," said Mona, a woman in Gaza whose nieces and nephews were among those killed by an Israeli air strike that hit the home of the Seyam family.

"This will not bring back what we lost, will not heal our hearts or make up for the tears we shed.'

Kamelia Hoter Ishay, whose 13-year-old granddaughter Gali Tarashansky is believed held in Gaza, said she would not believe reports of a deal until she got a call that the girl was freed.

"And then I'll know that it's really over and I can breathe a sigh of relief and say that's it, it's over," she said.

"We hope the truce will happen and there will be good solutions, and we hope people will live peacefully, return to their nomes and workplaces with stability," said Abu Jihad Shameya, a displaced man from north Gaza who had taken refuge in the main southern city Khan Younis.

"May God not prolong this hardship." Qatar's chief negotiator in ceasefire talks, Minister of State at the Foreign Ministry  $Mohammed\,Al\text{-}Khulaifi, told\,\bar{R}euters\,that$ the International Committee of the Red Cross would be working inside Gaza to facilitate the hostages' release.

He said that the truce means there would be "no attack whatsoever. No military movements, no expansion, nothing."

Al-Khulaifi added that Qatar hopes the deal "will be a seed to a bigger agreement and a permanent cease of fire. And that's

3 dead, 3 missing in U.S.

A female was found dead Monday night during initial search efforts, said Alaska Department of Public Safety spokesman Austin McDaniel.

On Tuesday afternoon, the bodies of two adults were found in the slide area, while two juveniles and an adult remained unaccounted for, said Alaska State Troopers.

The landslide occurred after a combination of rain and high winds buffeted the community. The slide is estimated to be 450 feet wide where it crossed the road, with a significant debris field, according to state transportation officials.

### 1 killed as 6.6-magnitude earthquake jolts E. Indonesia

 $Jakarta, Nov\,22\,(UNI)\,A\,6.6-magnitude\,earth quake$ rocked off Indonesia's eastern province of North Maluku on Wednesday, leaving one person dead, local disaster official said.

The tremor, which hit the hardest at III to IV MMI (Modified Mercalli Intensity) in Ternate city, caused the collapse of a telecommunication tower and killing of a worker, said Fehby Alting, head of the provincial disaster management and mitigation agency.

The quake happened when a worker was working to demolish the Telkomsel-operated tower whose lifetime had expired, whereas the tower collapsed and killed the worker, Alting told Xinhua via phone.

The official added that other buildings or houses in the city and other parts of the province were not damaged, while the risk assessments of the impact of the tremors have yet to be completed. The earthquake occurred at 09:48 a.m. Jakarta time (0248 GMT) with its epicenter situated at 68 km northwest of Halmahera Barat (West Halmahera) district and a depth of 109 km under the seabed, the country's meteorology and geophysics agency said.

The quake was also felt in districts of West Halmahera and North Halmahera of North Maluku province, as well as Manado city, Bitung city, Minahasa district and Sitaro district of North Sulawesi province, the agency said.

### WHO plans to evacuate patients from three hospitals

GENEVA: The World Health Organisation said on Tuesday three hospitals in Israeli-besieged northern Gaza had requested help with evacuating patients and that planning for that was under way, expressing regret that doing so would rob people of a lifeline.

Hospitals have come under Israeli relentless bombardment and all hospitals in the northern part of the enclave have effectively ceased functioning normally, although they continue to house some patients that could not flee and displyaced Gazans.

"Were looking at three hospitals right now in the north that asked to be evacuated but the important point is where to? There is no safe space," WHO spokesperson Christian Lindmeier told a Geneva press briefing, saying that southern hospitals were already full and suffering shortages.

### **North Korea fires 'spy** satellite', stokes panic in Japan

SEOUL: North Korea has fired what it claims is a military spy satellite, the South's armed forces said on Tuesday, hours after Japan confirmed that Pyongyang had warned it of an imminent launch.

North Korea's previous efforts to put a spy satellite into orbit in May and August both failed, and Seoul, Tokyo and Washington had repeatedly warned Pyongvang not to proceed with another launch, which would violate successive rounds of UN resolutions.

Seoul's military "detected at 10:43pm one alleged military surveillance satellite launched from the Tongchang-ri area in North Pyongan province," South Korea's Joint Chiefs of Staff said. The rocket and its purported satellite payload "flew to the west of Baengnyeong island", it said, referring to an island near the maritime border between the two Koreas in the Yellow Sea. The JCS did not give any details on whether the launch appeared to have succeeded or failed.Japan also confirmed the launch, with Prime Minister Fumio Kishida's office posting on X: "North Korea has launched a suspected ballistic missile". Space launch rockets and ballistic missiles have significant technological overlap, experts say, but different payloads, and Pyongyang is barred by UN resolutions from any tests involving ballistic technology. Tokyo warned residents in the southern region of Okinawa to take shelter, but soon lifted the alert, saying the projectile had "passed into the Pacific". Kishida said he condemned North Korea's missile launch in the "strongest possible terms". Seoul has been saying for weeks that Pyongyang was in the final stages of preparation for another spy satellite launch, warning it would take "necessary measures" if it went ahead. The office of South Korean President Yoon Suk Yeol — who is in London for a state visit hinted earlier on Tuesday that it would consider suspending the Sept 19 military agreement.

## Xi Jinping Calls For "Immediate Ceasefire" In Israel-Hamas War


Beijing: Xi Jinping on Tuesday called for the release of civilian detainees and an immediate ceasefire in the war between Israel and Hamas, state media said, as the Chinese President addressed a virtual summit of fellow BRICS leaders.

"All parties in the conflicts should immediately cease fire and hostilities, stop all violence and attacks targeting civilians, and release civilian detainees to avoid more loss of lives and suffering," Xi said, according to Beijing's state news agency Xinhua.

He did not make specific reference to the estimated 240 hostages abducted from Israel by Hamas last month, nor to Palestinian prisoners being held by Israel. Xi also called for an "international peace conference" to resolve the conflict between Israel and Hamas."There can be no sustainable peace and security in the Middle East without a just solution to the question of Palestine," Xi said, speaking through an interpreter."China calls for an early convening of an international peace conference that is more authoritative to build international consensus for peace," he said.

Such a conference would, Xi added, "work toward an early solution to the question of Palestine that is comprehensive, just and sustainable". "Since the outbreak of the latest Palestinian-Israeli conflict, China has been working actively to promote peace talks and a ceasefire," he said.

Beijing, he said, "has provided humanitarian assistance to help ease the humanitarian plight in Gaza" and would continue



to do so. Pretoria is hosting a virtual meeting of BRICS -- a group of major emerging economies that includes Brazil, Russia, India, China and South Africa -- aimed at drawing up a common response to the Israel-Hamas conflict. Fighting has raged in Gaza after Hamas gunmen killed around 1,200 people, mostly civilians, during crossborder raids on October 7 -- the deadliest attack in Israel's history. In retaliation, Israel launched a relentless bombing campaign and ground offensive in Gaza, which is ruled by Hamas. According to Hamas, the war has killed more than 13,300 people, thousands of them children. China has historically been sympathetic to the Palestinians and supportive of a two-state solution to the Israeli-Palestinian conflict.

## **Worst Dengue Outbreak In Bangladesh As Cases Cross 3,00,000** Mark: Report

Dhaka, Bangladesh: Dengue cases in Bangladesh have crossed the 300,000 mark as the nation grapples with its worst outbreak of the vector-borne disease, media reports said on Mon-

Bangladesh's overall tally of dengue infections stood at 301,255, with the country logging 1,549 deaths by the viral disease this year, the bdnews24. com news portal reported, citing data from the Directorate General of Health Services.

On Sunday alone, 1,291 new cases of the viral fever were reported, according to the report.

A total of 4,949 patients, including 1,127 in Dhaka, are receiving treatment at hospitals across the country.

After August saw 71,976 cases and 342 deaths, a record 79,598 dengue cases and 396 deaths were recorded in September amid the worst outbreak of



the disease, while 67,769 cases and 359 deaths were reported in October.

The death count in the first 19 days of November was 201, while 30,080 new dengue cases were recorded during this period.

According to the report, experts blamed a prolonged monsoon, rising temperatures, and a lack of effective measures to kill the Aedes aegypti mosquito, the known carrier of the dengue virus, for the outbreak.

It said an alarming surge of the Aedes aegypti mosquito was recorded in a government-funded premonsoon survey of Dhaka,

fuelling the worst spread of the disease over the past five years.

Last year, hospitals in Bangladesh reported 62,382 patients who took medical care for the disease, and the death count stood at 281, the previous highest since the record-keeping began for dengue hospitalisations in the 1960s, the news portal said.

Dengue can be controlled in many ways, including vector management and reducing the Aedes breeding sources, said former chief entomologist at DHGS, Mohammad Khalilur Rahman.

## Indonesia gives hundreds of Rohingya temporary stay

LHOKSEUMAWE: Hundreds of Rohingya refugees were on Tuesday given shelter for three months in western Indonesia, the country's immigration office said, after locals threatened to turn them back to sea for a third time.

The group of 256 from the persecuted Myanmar minority were turned back twice last week by locals and, after they made land successfully at the third attempt on Sunday, residents protested their presence and threatened to put them back to sea again.

But local authorities ordered a hold on them for two days while they waited in a temporary shelter in



Bireuen district, Aceh Province.On Tuesday, national officials ordered their relocation to a new shelter in Lhokseumawe, one of Aceh's biggest cities.

"The security of the refugees during temporary stay is the government's responsibility by coordinating with the local police," the national immigration office said in a statement.

"The aforementioned building will be undergoing major renovations in 2024... therefore the temporary permit to accommodate Rohingya ethnic refugees is a maximum of three months." Authorities gave no details about what would happen to the refugees after their three-month stay expires.The refugees were being moved on Tuesday

evening and a journalist saw trucks packed full of Rohingya men, women and children setting off for the new shelter. Ann Maymann, representative of the UN refugee agency in Indonesia, said the decision was "better... than having the refugees stay at a beach" with no security."There are many vulnerable people like women and children among the group," she said. The group of 256 were part of more than 800 who arrived in Aceh in the past week as conditions eased on the long sea journey from Bangladesh, Many Acehnese, who themselves have memories of decades of bloody conflict, have long been sympathetic to the plight of their fellow Muslims.

## **UNHCR** raises alarm over Afghans' exit order

ISLAMABAD: The UN Refugee Agency, has raised concerns over Pakistan's announcement for undocumented foreigners to leave, as the orders have adversely affected Afghan nationals including registered refugees and others with valid documents.UNHCR Representative in Pakistan Philippa Candler told a press briefing at UN European headquarters in Geneva on Tuesday that mass arrivals back to Afghanistan were adding to the ongoing humanitarian crisis, as winter temperatures in some locations dip to as low as -4°C. Since Pakistan's announcement of the repatriation plan on October 3, an estimated 374,000 people have returned to Afghanistan. "We are witnessing an exponential increase in arrests, detentions and deportations of Afghans in Pakistan. Many Afghan returnees are vulnerable, including women and children who could lose their lives in a harsh winter if left without adequate shelter," the official said. He explained that the Afghans interviewed in Khyber Pakhtunkhwa and Balochistan said they were leaving in a rush, fearing arrest and detention. All registered Afghan refugees are exempt from the government's orders, but the announcement and follow-up actions created a sense of panic.

"We have been reiterating our call that any return to Afghanistan should be voluntary, safe and dignified, irrespective of legal status in Pakistan. We have urged the Government of Pakistan to put in place a screening.



## Unscheduled power cuts fume Langate and Handwara resident's, seek redressal before snowfall: People

Handwara, Nov, 22: Unscheduled power cuts for long hours have irked the residents of both rural and urban areas of Langate and Handwara constituency. Metered, as well as nonmetered area consumers alleged that the Power Development Department(PDD)division Handwara is not following its reduction schedule and subjecting them to long hours of unscheduled power cuts during day and night hours.Local residents of Handawara told HEADLINES TODAY ,We are witnessing frequent power cuts opposing our locality being full metered, adding that unscheduled power cuts have grown severe from past twenty days giving a hard time to people', especially in evening hours. It is a very tough time to survive without electricity in these harsh winters, said Mustafa Manzoor resident of Handwara. Residents of different villages like Kultoora, Guloora, Phauropeth, Khuroo, Hanjishat, Gund Kharou, Chotipora, Gund Chogal and Chogal said, despite paying electric bills, the unscheduled power cuts have thrown people in darkness. We hardly receive power supply for three to four hours a day, peole added."We



have been paying bills in time and still not getting electricity on time. The department forces us to suffer in these cold days by frequent power cuts. In 24 hours the electricity remains hardly for Three to Four hours they said unscheduled and expanded power cuts have also distressed the business units in Handwara and other Langate,," Trade president Handwara Sofi Ajaz said.(HT) A group of students from different institutions especially from GMC Handwara said due to unscheduled and prolonged power cuts, they could not study after every 20 minutes. "The light goes off forcing them to wait for hours and after that, the hardships continue till night," said a student Akther Azad from Handwara.We are facing acute power crisis in our locality. Unsched-

uled power cuts are causing us a lot of miseries. # Pollution affects Beauty

f the views from your large office windows seem more hazy and compromised than usual, and a wave of colds and coughs have held your coworkers hostage, you have the increasing pollution to blame

The rising air Pollution has become a buzzword nowadays and is affecting the normal functioning of life due to toxic air and a heavy blanket of smog.

Pollution breaks down collagen and oxidizes the lipid layer in the skin, which impairs skin-barrier function. Smog particles are generally too large to penetrate the skin, but they can disturb the barrier, resulting in dehydration, sensitivity, uneven skin tone, dullness, acne, and premature aging.

Skin of women living in a city is more likely to age 10 per cent faster than those living in rural areas.

Airborne pollutants on human skin can contribute to skin aging, atopic dermatitis, skin discoloration, eczema, psoriasis, and acne and can be absorbed through the skin into the body, causing a wide range of diseases. While pollution takes a toll on the environment and health but it also affects natural beauty very adversely. Pollution breaks down collagen and oxidizes the lipid layer in the skin, which impairs skin barrier function.

Highly toxic air containing smoke, soot, acid, and other pollutants severely affects the skin by draining away skin moisture which leads to allergies and pigmentation spots on the forehead and cheeks on dry and rough skin.

The toxic haze hanging in the sky cause uneven skin tone, accelerated ageing, wrinkles, and black spot on the face

For many living in big cities like in Metropolitian cities it is completely unavoidable so it is matter of reducing exposure, repairing the damage and protecting it as much as possible

Among the other organs of the body, the skin is also one of the first to bear the brunt of air pollutants, which not only attack the skin's surface but also lead to an accumulation of toxins. In fact, they are potent skin irritants. There are both long and shortterm effects of pollutants. Chemical pollutants cause oxidation damage and this can lead to the manifestation of premature ageing signs on the skin, like wrinkles, loss of elasticity, dark patches, spots, etc. Chemical pollutants also disrupt the normal balance of the skin and scalp, leading to



problems like dryness, sensitivity, rashes, acne, irritation or allergic reactions, dandruff, and related conditions. They also make the skin and hair dull, lacking vitality. All of us who live and work in urban areas need protective beauty care, whether we are housewives or working women. Of course, for working women, the job may involve traveling long distances to work. The skin is thus more exposed to the pollutants in the air.

Cleansing of the skin assumes more importance in order to get rid of the impurities and pollutants that are deposited on the skin. If you have dry skin, use a cleansing cream or gel. Deep clean the skin at night, neutralize it with antioxidants and create a barrier with sunscreen. Include antioxidants in your diet and skincare regime. Citrus fruits contain Vitamin C, E, and limonene which lower the risk of cancer and protect your skin from damage. Avoid cleansers containing Sodium lauryl sulphate and sodium laureth sulphates or denatured alcohols as they dry out the skin and can damage our skin barrier over time.

Use skincare rich in antioxidants. Pamper your skin with sheet masks or hydrating overnight masks to repair the damage.

For oily skin, cleansing milk or face wash may be used. For oily skin, also use a facial scrub after cleansing. Look out for products with ingredients like sandalwood, eucalyptus, mint, neem, tulsi, aloe vera, etc., when you buy cleansers. The antitoxic and tonic properties of such ingredients have helped in clearing the skin congestion and eruptions that result from exposure to chemical pollutants. Aloe vera, for example, is also a powerful moisturizer and an anti-oxidant. So are ingredients like apricot kernel oil, carrot seed, wheatgerm oil, etc. the skin needs to be protected. If the skin is prone to eruptive conditions like acne, pimples, or rash, it should be protected with specialized creams that not only protect but also reduce oiliness and deal with the problem.

After cleansing, wipe the skin with a rose-based skin tonic or rose water, to complete the cleansing process and refresh the skin. Soak cotton wool in chilled rose water and tone the skin with it, patting briskly. It also improves blood circulation to the skin's surface and adds a glow. Green tea also makes a good skin toner. If there is a rash or eruptions, add a little rose water to the sandalwood paste and apply it to the face. Wash off with plain water after

- Anti-pollution cosmetics help to provide protection and reduce the damage caused by environmental effects. These are basically "cover creams" that form a barrier between the skin and pollutants. sandalwood protective cream is very useful to protect the skin from environmental effects. It forms a transparent protective cover. Sandalwood soothes the skin and protects it from irritative reactions and eruptive condi-tions. It suits all skin types and increases the skin's moisture retention ability too.
- The hair also needs frequent washing if one regularly travels long distances for their work. Pollutants also collect on the scalp. Shampoo, hair rinses, serums, and conditioners help to restore normal balance if they contain ingredients like amla, Brahmi, Triphala, bhringaraj, and henna. They also coat the hair and form a protective cover. Mix one teaspoon each of

vinegar and honey with one egg. Massage the mixture lightly into the scalp. Leave on for half an hour and then wash the hair. Rinse well with water.

**HT - HEALTH** 

My advice is while rely on healthy eating, drinking water, and regular exercise to keep your skin healthy. Making the right choices about our skincare regimen is an equally or even more important part of a successful beauty routine.

Or, give the hair hot oil therapy. Heat pure coconut oil and apply it to the hair. Then dip a towel in hot water, squeeze out the water and wrap the hot towel around the head, like a turban. Keep it on for 5 minutes. Repeat the hot towel wrap 3 or 4 times. This helps the hair and scalp absorb the oil better. Leave the oil on overnight and wash your hair the next day.

The impurities and pollutants can also affect the eyes, causing burning or redness. The eyes should be washed with plain water several times. Soak cotton wool pads in chilled rose water and use them over the eyes as eye pads. Lie down and relax for fifteen minutes. This really helps to remove fatigue and brightens the eyes.

if one is also exposed to cold weather, poor diet, a lack of sleep, or simply stress, as many of us are. In the presence of any of these factors along with pollution, the quality of the skin can become further diminished.

To brighten the skin and even skin tone, I recommend products containing Vitamin C to be used in conjunction with richer creams. Deeply moisturizing creams can truly help repair and hydrate the skin. Use an air purifier with a humidifier at home and the workplace to lessen the effects of pollution. Humidifiers make the air breathable and maintain the room's humidity.

Eat your greens, Vitamin C rich foods, jaggery and drink loads of fluids rich in antioxidants. Antioxidants can neutralize the effects of pollutants. Lemon, orange, amla, green vegetables, grapefruit, tomatoes and potatoes are some examples of Vitamin C rich foods.

## 'Silent Atherosclerosis' **Can Be Especially Deadly for Young People, Study Finds**



therosclerosis is a hardening of the arteries due to plaque buildup from calcium, fats, and cholesterol that can lead to blood clots, stroke, and heart attack or heart failure. It has commonly been associated with older adults

But a new study published Monday outlines an increased risk to younger adults for so-called "silent atherosclerosis," suggesting that risk factors like high cholesterol and hypertension should be addressed earlier in life to prevent the disease from developing further.

The study, carried out at Spain's Centro Nacional de Investigaciones Cardiovasculares (CNIC) and published in the Journal of the American College of Cardiology, analyzed the key arteries including the carotid, femoral, and coronary arteries and aortas of more than 4,000 healthy middle-aged employees of a bank in Madrid.

The researchers found that even moderate increases in blood pressure and cholesterol were shown to significantly impact the risk of atherosclerosis in younger adults.

At what age should blood pressure and choles-

Risk factors like high cholesterol and hypertension can affect younger adults' chances of atherosclerosis later in life more than previously known.

Testing earlier in life (between the ages of 20 and 25) and aggressively mitigating risk is beneficial, Dr. Borja Ibáñez, the scientific director of CNIC and one of the authors of the study, told Heathline.

"Given these findings, it would be worthwhile for healthcare professionals to start assessing cardiovascular risk earlier on, including during check-ups in early adulthood," Dr. Rigved Tadwalkar, a cardiologist at Providence Saint John's Health Center in Santa Monica, Calif., told Heathline. "This approach is consistent with the idea of early intervention and aggressive control of cardiovascular risk factors as a means for reducing cardiovascular disease burden."

What age groups are most at risk for atheroscle-

Given the physiological changes that come with aging, older adults are still at the highest risk, Tad-

"This includes arterial stiffening, atherosclerosis progression, and increased vulnerability to oxidative stresses and inflammation. The cumulative exposure to risk factors, such as high blood pressure and cholesterol, further amplifies cardiovascular risk as people age," Tadwalkar noted.

But the study suggests that even seemingly healthy younger adults should be monitored for risks associated with cardiovascular disease, Tadwalkar said, adding that genetic traits can play a role.

## **Statins Can Help Women With Breast Cancer, Study Finds**

tatins may reduce the risk of mortality among women with breast cancer, new research has found.

The studyTrusted Source, published in JAMA Network Open this month, found that the risk of dying was substantially lower in women with breast cancer whose cholesterol levels dropped after starting statins, which are commonly prescribed lipid-lowering medications.

Past researchTrusted Source suggests high cholesterol may be associated with a greater risk of breast cancer. It's possible that statin use interrupts cancer cell signaling and tumor development.

The new findings suggest statins may be beneficial for people with breast cancer, which is the most common cause of cancer death Trusted Sourceamong women across the world, the researchers say.

"This suggests a potentially beneficial role for statins in breast cancer treatment, highlighting the importance of cholesterol management in cancer prognosis," Dr. Wael Harb, board-certified hematologist and medical oncologist at MemorialCare Cancer Institute at Orange Coast and Saddleback Medical Centers in Orange County, CA, told Healthline.

Harb was not involved in the study. Statins linked to lower risk of death from breast cancer



The researchers evaluated statins in 13,378 females with breast cancer. They followed up, on average, for

4.5 years after breast cancer diagnosis, during which time 16.4% of patients died and 7% died from breast cancer.The researchers found the risk of death dropped among those who started taking statins after diagnosis and experienced a reduction in cholesterol levels.

The team found that 7.6% of the participants who did not take statins died of breast cancer compared to 6.1% who took statins.

"In a retrospective study, this is a very small difference and not definitive," Dr. Parvin Peddi, the director of Breast Medical Oncology for the Margie Petersen Breast Center at Providence Saint John's Health Center and Associate Professor of Medical Oncology at Saint John's Cancer Institute, said. Peddi was not involved in the study.

The reduced risk of death was also observed among women with estrogen receptor-positive tumors.

The risk further declined with increasing intensity of statin use, the study found.

The risk of death didn't drop in women whose cholesterol levels did not substantially decrease after starting statins. In addition, the decreased risk was only apparent in people with localized disease.The researchers suspect statins may not improve survival rates among those with metastatic disease."The main takeaway is that post-diagnostic use of statins in breast cancer patients is associated with a reduced risk of death from the disease, especially when statin use leads to decreased cholesterol levels," Harb said.

Statins may interrupt tumor growthIn studies conducted in mice, a metabolite of cholesterol -27-hydroxycholesterol - appeared to promote tumor growth and metastases.In the current study, the researchers note that statins may be beneficial for breast cancer because they lower serum lipoproteins or interrupt cancer cell signaling pathways.Laboratory studies have found that statins have anti-invasive and antiangiogenic effects, meaning they inhibit tumor growth.

## Harmanpreet 'really excited' for Test homecoming despite limited preparation time

**NEW DELHI, NOV 22:** That is the big challenge facing Harmanpreet Kaur. India's captain has had a glittering international career, playing in 285 internationals, and has become a globetrotting superstar in leagues across the world - she is currently the only Indian player playing in the WBBL in Australia.

Extraordinarily, though, Harmanpreet will play more home Tests in two weeks in December, against England and Australia in Mumbai, than she has in her previous 14 years at international level. The only home Test in her career came back in 2014 against South Africa where she took nine wickets in a huge innings victory. She has only played one Test match since then, full stop, in 2021 against England, and three Tests in her career overall.

Making the task harder is the preparation. She won't leave Australia until after Melbourne Renegades' final game at the MCG against Melbourne Stars on Saturday night. She will then have just ten days to prepare for the start of the three-match T20I series against England that precedes the Test that starts on December 14.

"The Test series is something which we are really looking forward to because I haven't played in front of a home crowd [since 2014], so I'm really excited for that," Harmanpreet told ESPNcricinfo. "The challenge for us is that we haven't played with the red ball. We have been play-



ing with the white ball for so many years, even in domestic cricket also we don't have red-ball cricket back home. So the challenge for us is to make yourself ready in such a short time."

Harmanpreet's Renegades team-mates are facing the same preparation pressures with England's Tammy Beaumont and Australia's Georgia Wareham both aiming to play in the respective Test matches against India with similarly compromised preparations. Although they have more recent Test experience, with Beaumont making a stunning double-century in the Ashes this year.

There had been hopes from Australia's standpoint that their bowlers would get some Testmatch practice in during the WBBL in order to increase their loads. They actually trained with pink balls during the October ODI series against West Indies in anticipation of a day-night Test in India, but that was subsequently changed to a red-ball game.

"I had that thought if I can simultaneously do some red-ball practice also, but because it's such a packed schedule you can't mix things'

But the WBBL schedule is so tightly packed with 14 games in six weeks and a huge travel burden, that it has been difficult to find time. Harmanpreet had grand designs on getting some red-ball practice in while in Australia, but the weekly grind of play, travel, play, travel with very little training in between has made that impossible to implement.

"I had that thought if I can simultaneously do some red-ball practice also, but because it's such a packed schedule you can't mix things,"Harmanpreetsaid."We're playing T20 cricket and the Test game is a totally different kind of game, so I didn't want to mix it. When I'm going back, I have ten days to prepare myself."

Harmanpreet missed India's last Test against Australia on the Gold Coast in late 2021 because of a thumb injury. But she said she spent a lot of that match observing how the game unfolded to try and get a sense of how to play long-form cricket and how to lead her side tactically.

But in the short term, her focus is on finishing the season well with Renegades. It has been a disastrous tournament for a team that had high expectations coming into the WBBL off the back of recruiting three of the world's most in-form players in Harmanpreet, Beaumont and Hayley Matthews. Renegades are anchored to the bottom of the table with just two wins from 12 games.

However, they have a chance to finish the season well. Firstly, against Hobart Hurricanes at Bellerive Oval on Thursday, before finishing with the Melbourne Derby at the MCG on Saturday, which will be part of the WBBL's stadium series. It is the first time the WBBL has held a standalone fixture at the MCG. There have been games there in the past, but they have been part of doubleheaders with men's BBL matches.

The Melbourne derby will be the first women's game at the MCG since the historic 2020 T20 World Cup final, where Harmanpreet captained India against Australia. She said she was thrilled to get the chance to return to the venue and play there again.

"It's always an honour to play here at one of the best stadiums to play," Harmanpreet said. "When we played the T20 World Cup final here, and before that in some games against Australia, it's been always amazing. And now again this season we are getting the opportunity to play here and I'm really looking forward to that."

## **Royals trade Padikkal for Super Giants' Avesh in** straight swap

MUMBAI. NOV 22: Fast bowler Avesh Khan is set to make a move to Rajasthan Royals from Lucknow Super Giants, who will acquire top-order batter Devdutt Padikkal in a straight trade swap ahead of IPL 2024. ESPNcricinfo has learned that the franchises and players agreed on the trade in the past week with the BCCI set to put a stamp on the swap

Avesh, who is part of the India squad for the T20I series against Australia starting Thursday, was bought by Super Giants in the mega auction in 2022 for INR 10 crore (US\$ 1.2 million approx.). Royals, meanwhile paid INR 7.75 crore (US\$ 945,000 approx.) for Padikkal. Both the players were retained by the respective franchises this year.

It was especially disappointing for Padikkal, who, despite playing every match for his team in 2022 (17) and 11 games in 2023, struggled to fulfil the top-order role Royals had assigned to him. In 28 matches in these two seasons, Padikkal scored 637  $runs\,at\,an\,average\,of\,23.59\,and\,a\,strike\,rate\,of\,125.88$ with just three half-centuries. Overall, Padikkal has scored 2768 runs in 92 IPL games at 33.34 with 17 fifties and three centuries striking at 133.52.

Super Giants will be the third franchise for Padikkal, who started his IPL journey with his hometown franchise Royal Challengers Bangalore where he spent two seasons (2020 and 21).

For Avesh, too, Royals will be the third franchise after he debuted at Delhi Capitals: in 2021, he was the second-highest wicket-taker in the tournament with 24 wickets at 18.75. After Capitals released him ahead of the mega auction, Super Giants bid fiercely to buy Avesh in a four-way bidding war. He finished the 2022 season as Super Giants' highest wickettaker, helping them make the playoffs in their inaugural IPL season.

However, on the slow and underprepared pitches in Lucknow, Avesh struggled in 2023. Failing to finish his full quota of four overs in five of the nine games he played, Avesh finished the 2023 season with just eight wickets at 35.37, going at an economy of 9.75.

#### **Danielle McGahey acknowledges** her international career 'is over' after ICC transgender ruling

**NEW DELHI, NOV 22:** After a key change to ICC's gender eligibility requirements that banned transgenders from participating in women's internationals, Danielle McGahey, the first transgender to play internationals, has acknowledged "with a very heavy heart" that her international career for Canada "is over".

"Following the ICC's decision this morning, it is with a very heavy heart that I must say that my international cricketing career is over," McGahey posted on Instagram. "As quickly as it began, it must now end." The ICC board on Tuesday approved the new rules by which any player who has transitioned from male to female and has been through any form of male puberty will not be allowed to participate



in women's international cricket, regardless of any surgery or gender reassignment treatment they may have undertaken.

"It is based on the following principles (in order of priority), protection of the integrity of the women's game, safety, fairness and inclusion," the ICC said in a statement. "The regulations will be reviewed within two years." ICC CEO Geoff Allardice added: "Inclusivity is incredibly important to us as a sport, but our priority was to protect the integrity of the international women's game and the safety of players."

Originally from Australia, McGahey, 29, moved to Canada in 2020 and underwent a male-to-female medical transition in 2021. In September this year, she played for Canada in the Women's T20 World Cup Americas Qualifier that acts as the pathway for the Women's T20 World Cup 2024.

"While I hold my opinions on the ICC's decision, they are irrelevant," McGahey wrote. "What matters is the message being sent to millions of trans women today, a message saying that we don't belong. I promise I will not stop fighting for equality for us in our sport, we deserve the right to play cricket at the highest level, we are not a threat to the integrity or safety of the sport."

McGahey played six T20Is and scored 118 runs at an average of 19.66 and a strike rate of 95.93.

Sri Lanka stalwart Athapaththu is playing in the WBBL for Sydney Thunder, and is currently the second-highest run-scorer in the tournament across teams with a tally of 451 runs from 12 innings at an average of 45.10 and strike rate of 134.62, behind only Perth Scorchers' Beth Mooney, who has 535 runs from 12 innings.

In a statement released by Northern Districts, she said she was "super excited" at the opportunity. Athapaththu will join the Northern Brave camp in late

Åthapaththu, the ninth-highest run-getter in women's T20Is with 2651 runs from 120 innings, has had a sensational 2023. In ODIs, there were the two centuries - 108 not out and 140 not out - against New Zealand at home in Galle in June, which gave Sri Lanka a famous 2-1 series win, while she has hit three half-centuries in 16 T20I innings this year too. Overall, she has 3255 ODI runs at an average of 34.26 with eight centuries, and 2651 T20I runs at a strike rate of 106.20 with one century.

A more than handy offspinner, Athapaththu also has 68 wickets in international cricket.

Easily the most popular Sri Lankan woman cricketer, Athapaththu has played in the Women's CPL, for Guyana Amazon Warriors, as well as in the FairBreak Invita $tional T20 \, tournament \, and \, in \, the \, Women's \, T20 \, Challenge$ At the WBBL, Thunder is her third team, after she turned out for Melbourne Renegades and Scorchers in previous
