Kashmir Valley Continues To Reel Under Severe Cold

SRINAGAR, JAN 3: Kashmir Valley continues to reel under severe cold, with Srinagar recording a low of -4.8°C and Pahalgam -6.6°C on Wednesday.

The Meteorological Centre Srinagar said the minimum temperature in Srinagar settled at -4.8°C for the second consecutive day on Wednesday. It was -2.7°C below normal for the summer capital of Jammu and Kashmir during this period of the season.

Parts of Dal Lake and other water bodies froze due to



the impact of the temperature in Srinagar and other parts of the valley.

The maximum temperature was 4.3°C above the normal of 6.9°C, against 11.2°C in Srinagar the previous day amid sun appearing during the day. The other stations in the valley also witnessed 4-5°C above-normal day temperatures.

Gross death rate shows slight decline at SMHS

SRINAGAR, JAN 3: The gross death rate has shown a slight decline in Kashmir's one of the largest tertiary care hospitals, Shri Maharaja Hari Singh (SMHS).

The Health and Medical Education Department (H&MED) said a total of 72,795 patients were admitted as inpatients in the hospital in the year 2023-24 until November 30, 2023, and the total deaths during the period were 2095.

Out of these total deaths, 295 patients were brought to death, and 838 deaths were reported in the hospital.





SRINAGAR, JAN 03: Once renowned for its fish, Nadru, and lush vegetable gardens, Anchar Lake in the Soura area of Central Kashmir's Srinagar district is now struggling for survival as it has become a victim of illegal dumping sites being made on its shores.

The lake, linked to Dal Lake through the Nallah Amir Khan water channel, has faced a drastic reduction in size, nearly half of its original area, over the past few decades due to administrative neglect, rampant pollution, siltation, and encroachment.

Since 2015, detailed follow-up of recommendations of past conferences has become the norm and is the topic of the first business session, attended by the prime minister and the home minister, the official said.

Recommendations are tracked closely by the conference secretariat, led by the Intelligence Bureau, with the help of nodal officers in the states.

About 250 officers in the rank of Directors General of Police (DGPs) and Inspectors General of Police (IGPs) will physically attend the conference while more than 200 others are likely to attend virtually.

Many officers have been tasked with delivering presentations on specific subjects such as counterterrorism, online fraud, cross-border terrorism in Jammu and Kashmir, activities of pro-Khalistani groups and Left Wing Extremism, among others, the official said.

Till 2013, the annual meet had been held in New Delhi.

The following year, after the Modigovernment came to power, it was decided to hold the event, organised by the Union Ministry of Home Affairs and the Intelligence Bureau, outside the national capital. Accordingly, it was first held in Guwahati in 2014, Rann of Kutch in 2015, the National Police Academy in Hyderabad in 2016, the BSF Academy at Tekanpur in 2017, Pune in 2019.

In 2020, the meet was held virtually during the Covid pandemic and in hybrid mode in Lucknow in 2021. The conference was held in New Delhi in January 2023.

The number of business sessions and topics have increased significantly, with a focus on improving policing in the service of the people.

Before 2014, the deliberations largely focused on national security matters. Since 2014, these conferences have a twin focus on national security as well as core policing issues, including prevention and detection of crime, community policing, law and order and improving the police's image, among others, another official said.

Earlier, the conference was Delhi-centric with officers coming together only for the meet. Residing on the same premises over two to three days has served to build a heightened sense of unity among officers of all cadres and organisations since 2014, the official added.

Direct interaction of the police's top brass with the head of government has resulted in a convergence of views on crucial challenges faced by the country and the emergence of doable recommendations, the official further said.

In the past few years, the topics have been selected after detailed discussions with the highest echelons of the police service.

On December 6 last year, the Northern Railwayssuccessfully conducted the first trial run of an electric train from the Banihal railway station to the Khari railway station, bringing cheer on the faces of the local population residing in the remote picturesque area. The officials said the second round of statutory inspection by CRS Dinesh Chand Deshwal for the opening of Banihal-Khari track was conducted, brightening the chances for commission of this section to link Khari with Kashmir valley by train.

During the inspection, the officials said the chief administrative officer of the USBRL, the construction officers and other concerned officials accompanied the CRS, who first led trolley inspection of the work from Banihal to Khari and later returned from Khari to Banihal by special train.

The train schedule will be released after the submission of the report by the CRS, the officials said, adding the track between Banihal and Khari passes mostly through tunnels and has four minor and major bridges as well.

Deshwal said the infrastructure is ready for commissioning and the inspection was imperative before extending the train service to Khari.

"Though I am skilled in making both houseboats and Shikaras, government regulations have limited me to crafting Shikaras only. I seek to expand my work by building more Shikaras, and houseboats but my heart aches for the declining houseboat industry. Therefore, I urge the government to reconsider the ban and allow responsible construction of houseboats to revive this vibrant tradition," said Ghulam Nabi.

As already reported by KNO, the iconic houseboats are declining, with a recorded number decrease from 2000 to just 750, courtesy of a blanket ban on construction and non-availability of master craftsmen.

President Houseboat Owners Association (HBOA), Manzoor Pakhtoon, said till early 1980s, there were almost 2000 houseboats in Dal Lake, Nigeen Lake, and river Jehlum. "But today, the number of houseboats in Dal Lake, Nigeen Lake, Chinar Bagh, and river Jhelum is just 750," he said while

He expressing serious concern over the fast-fading houseboats, once known as the "Crown of Kashmir."

"Moreover, as a houseboat is usually made out of Cedar wood, which can withstand damage from being in water for long periods, the houseboats usually have a corridor, drawing room, dining room, pantry, two to four bedrooms with attached bathrooms with hot and cold water," he added.

Suhail Yaseen, who owns a houseboat at Dal Lake, said, the number of houseboats is fast shrinking, and they can't construct new houseboats as there are hardly any master craftsmen left now. "Those who are present, the government should activate support for them," he added.

Meanwhile, President of Private Schools Association of Jammu and Kashmir (PSAJK) G N Var said that the association is supporting the protest call of Jammu private schools association. "We extend our support to the **JKPSA.**"

Pertinently, JKBOSE earlier this week has given a nod to enrol secondary and senior secondary level students of sixty private schools to nearby government institutions in view of 'land and affiliation expiry issues'.

In this regard JKBOSE Deputy Secretary General for Kashmir division said that the directives have been issued for tagging of on-roll students of sixty private academic institutions of Kashmir Division running their affairs on proprietary land, having their period of affiliation expired and also failed to furnish their extension case files.

"In order to safeguard the academic career, sanction is accorded to tagging of on-roll students of sixty private schools of classes 10th to 12th with the nearby government high or higher secondary schools or cluster head schools, as the case may be in respect of schools of Kashmir division with immediate effect," it reads.

The officer said that the sanction was accorded consequent upon the expiration of affiliation of such private academic institutions of Kashmir division in October 2021-2022, coupled with the failure of the concerned managements to submit requisite case files for further extension with necessary certificates and safety documents.

"The concerned principals or cluster heads after securing necessary discharge certificates of the concerned students shall authenticate and submit the Permission-Cum-Admission (PCA) forms of classes 10th to 12th and renewal registration returns, as the case may be, with normal prescribed fee, as per the notifications issued by the IKBOSE Director Academic," it reads.

The board authority has also said that the concerned private schools shall remit a tagging fee equivalent to periodical inspection fee for the current academic session viz. 2023-2024, as prescribed by the JKBOSE.

The board authorities said that the orders shall be subject to the outcome of writ petitions, if any, pending before the competent courts of law.

Earlier the top official has told KNO that "Under Statutory Order (SO) 177, in the case of those private schools who are running their institutions from the state land and are defaulters, their number is around 200."

The official said that those private schools will have to get their title cleared from the revenue department. "We only need a NOC from them."

Pertinently, in April-2022, the government had notified conditions under SO-177 for private schools for their registration, recognition, and affiliation.

Handmade chain stitch craft struggles to survive amid diminishing demand

SRINAGAR, JAN 03: The intricate artistry of handmade chain stitch work is witnessing a decline, posing challenges for artisans who have mastered this meticu-

lous craft through generations. The demand for such traditional craftsmanship is diminishing, overshadowed by the allure of massproduced alternatives. Artisans, who have inherited the legacy of handmade chain stitch work, express concern over the various challenges that threaten the continuity of this unique craft.

Speaking with the news agency-KashmirNewsObserver(KNO),AbdulRasheed Bhat, a 60-year-old chain stitch master from Tengpora Nawa Kadal, lamented the

decline of this art form despite his family running a Kashmir Crewel Chain stitch factory in the area for the past century.

"I have been associated with this craft for the last 40 years. Earlier, there were good returns but a person who works dawn to dusk on a handmade chain stitch doesn't even earn Rs 100 per day and sustaining a livelihood on such earnings is impossible in today's era," he said.

With each passing day, this craft is sinking towards decline, Bhat said, adding that the shift towards mass production and the prevalence of mechanised alternatives led to the dwindling demand for handmade chain stitch work.

Common Curriculum And Common Textbooks

The recent move of the Jammu and Kashmir Board of School Education to prescribe one type of textbooks for both private and public schools from classes 1st- 12th has recieved a mixed response from stakeholders and general public.

Earlier private schools of the region would teach board prescribed textbooks from classes six onwards, but the fresh orders of the board makes it mandatory for both private and government schools to adopt board prescribed textbooks from classes 1-12 leaving no room for any kind of laxity or deviation from the strict orders. For a long time, various sections of the society have been demanding same type of syllabus and textbooks for the students enrolled both in private as well as government schools. However this all of a sudden move though displeasing to a minor group, has been widely hailed by majority of the people and has succeeded in garnering widespread praise and admiration.

Board prescribed textbooks are not authored by a single author instead a team of academic experts after thorough deliberations for months together come up with their product. They not only keep in mind the academic needs of the child but keep into consideration the overall personality development of the child also. Education is a fundamental right that empowers children and shapes their future.

Governments bear the responsibility of providing accessible and inclusive education free from discrimination. Education equips children with the knowledge and skills needed to participate actively in society fostering a culture of learning and understanding. Thus it makes no sense that children of same region enrolled in two different kinds of schools are taught different set of textbooks. It develops inferiority complex among those learning in public schools besides failing to provide equal competitive opportuni-



equal opportunities for the upcoming competitive events and demand common methodologies to acquire the set academic goals. Strong foundations of an effective education system are laid at primary level, so both government agencies and other stakeholders must be focused on improving the academic standard of primary education.

Various NGO's and parents associations have previously appealed to the people at helm about the burning issue of minimising the weight of school bags of little chaps who find it difficult to carry on their shoulders. Upto class 5th, only five textbooks including Kashmiri is taught in government run schools while their counterparts in private schools are forced to carry a heavy load of more than a dozen books which is obviously an injustice to them.

Teaching computer, fat grammar books, Islamic studies, General Knowledge etc to children at tender age is beyond every one's understanding. It brings no good results instead dips our future progeny in a well of melancholy because a heavy load of textbooks and extended syllabi can only push them to mental trauma. Teaching computer books to students of primary standard can hardly yield any desired result as these are laden with bulk of information, tough concepts and terms alongside difficult wordings which they seldom comprehend. Instead of teaching computer books, it is far better to

eral knowledge of higher standard to primary level children who hardly remember onerous and burdensome concepts. Similarly teaching Islamic studies at this stage can no longer make them religious scholars instead overburden them with an extra textbook. If we are truly sincere to our upcoming generation, then instead of teaching a dozen of separate textbooks it is imperative to impart education through a minimum number of textbooks with the incorporation of contents from all the sections.

It will unconsciously and playfully equip them with required informative content rather coercing them to learn the same through a dozen books. The sweet fruits of this board order can be reaped by taking into confidence the publishers and private school managements also who through unanimous deliberations and discussions can choose best and qualitative content material out of a big choice, which can satisfy both academic and developmental needs of a child. Decades ago there were least number of private schools and students learned from the books which board had prescribed.

Products of such institutions are presently holding highest ranks in every field of life, so we must have full faith in board prescription which from time to time takes stock of quality of the books as well as their necessary amendments in quality and contents. would surely get them at reasonable rates who earlier would raise hue and cry over their exorbitant prices.

After the declaration of NEET, JEE and other state and national level civil services results, candidates who top the results or qualify with flying colours attribute their successes to NCERT and other board textbooks. According to them, these books not only help them in full comprehension of the terms and concepts but also pave the way for their success in future.

Moreover our proud son of soil, Dr Shah Faisal who topped the prestigious Civil service exam in 2009, averred in an interview that any candidate aspiring to sit in the civil services exam must collect the board textbooks of all subjects from classes 6th-12th, read them thoroughly and then stride ahead with new choice of books. In order to overcome the social and academic disparities among our children, it is crucial to frame a common curriculum and prescribe same set of textbooks but every attempt must be made to update and review the quality and content material of the books.

Academic experts and publishers of high repute must be consulted from time to time in giving the material a final shape. Moreover the availability of textbooks in required quantity must be ensured both in market and schools before the commencement of the academic session to

Exhorting common syllabus and textbooks can develop a sense of uniformity among children of same region, take them in computer labs so that they get acquainted about the computer hardware and basic parts.

DECARBONISING FOOD IS ESSENTIAL TO MEETING OUR CLIMATE GOALS

TRANSFORMING FOOD SYSTEMS IS A POWERFUL WAY TO **REDUCE GLOBAL DEPENDENCY ON FOSSIL FUELS**

When political leaders, policymakers, environmental advocates, and philanthropists gather for this year's United Nations Climate Change Conference in Dubai (COP28), food systems will be high on the agenda for the first time. Given that the food sector accounts for one-third of all greenhouse-gas emissions, its inclusion is long overdue.

Fortunately, this challenge need not compete for our attention, because transforming food systems is also a powerful way to reduce our global dependency on fossil fuels. As our organisation shows in a new report, Power Shift: Why We Need to Wean Our Industrial Food Systems Off Fossil Fuels, food systems, from farm to plate to landfill, account for at least 15 per cent of annual global fossilfuel use - equal to that of the European Union and Russia combined. And if the current approach to industrial food production continues, that figure is expected to increase significantly.

Today's industrial food system is increasingly fossil fuel-intensive. Fossil fuels go into synthetic fertilisers and pesticides, as well as the plastics that are used in everything from the coatings for those pesticides and fertilisers to most food packaging. Moreover, most packaging is needed to store ultra-processed foods - from meat and dairy to sweets and sugary drinks - all of which require highly energy-intensive manufacturing and petrochemicals in the form of plastics.

Worryingly, the energy sector views the food system as a promising growth market. Food-related plastics and synthetic fertilisers account for approximately 40 per cent of all petrochemical products, and the International Energy Association predicts that petrochemicals will drive nearly half the growth in oil demand by 2050, outstripping sectors like aviation and shipping. Similarly, research from the Center for International Environmental Law has shown that fossil-fuel companies are banking on the expansion of these markets. The industry "is eyeing the food

system", CIEL's Lisa Tostado told us, "from inputs like pesticides and fertilisers to production and processing, as a dangerous escape hatch".

Finally, we're also seeing a push to use more agricultural land for incredibly inefficient energy production. The United States already dedicates about 40 per cent of its corn harvest to ethanol fuels, which are estimated to be "at least 24 per cent more carbon-intensive than petrol."

Given increased marketing of and demand for energy-intensive food, decoupling food production from fossil fuels is essential to meet our climate goals. Even if all governments delivered on their 2030 climate pledges, fossil-fuel use in the food system alone would consume our remaining 1.5° Celsius carbon budget by 2037.

Fortunately, there are many ways to

phase out fossil fuels in food systems. These include strategies to end the use of fossil-fuel-based fertilisers and pesticides, and to move away from inputdependent crop-based energy systems like corn ethanol; shifting to renewable energy for processing, cooling, and drying food; supporting minimally processed, less energy-intensive foods and encouraging plant-rich diets; and encouraging the uptake of seasonal, locally grown food.

Shifting away from industrial methods toward more sustainable ways of farming not only would protect the planet. It also would create jobs, improve health, protect biodiversity, and help address the roots of hunger. Evidence from around the world shows that approaches like agroecology and regenerative agriculture are effective in driving a shift away from fossil-fuel

dependency. With these strategies, yields remain steady or improve, while emissions fall, farmworkers' health improves, and biodiversity is protected.

There is no technical barrier to shifting from dependence on synthetic inputs toward agroecological and regenerative food production, or to replacing fossil-fuel energy with renewable sources. But many governments offer very few subsidies to support these transitions, and many more incentivise business as usual. According to the OECD, every year between 2019 and 2021, public funds totalling \$528 billion were channelled to agricultural and food-production practices that are generally bad for the climate, the environment, and human health.

Now that we have come to understand just how endemic fossil-fuel usage is across our economies, we must take pains to ensure that all sectors are included in the transition to a fossil-fuel-free future.We are pleased to see food finally taking centre stage at COP28. But that discussion must not be isolated from the one about ending the use of fossil fuels as fast as possible. There will be no food-systems transformation without phasing out fossil fuels, and there will be no phasing out fossil fuels without food-systems transformation.



In A 1st, India To Launch Its Big Communications Satellite On SpaceX Rocket

New Delhi: The Indian space agency will rely on SpaceX to launch its next generation heavy communications satellite named GSAT-20. This is the first time the Department of Space and Indian Space Research Organization (ISRO) will use the Falcon-9 heavy lift launcher which may liftoff from Florida on a dedicated Indian mission.

The deal also exposes the weak underbelly of ISRO which still lacks a rocket which has

the capacity to lift big communication satellites. ISRO Chairman S Somanath says India had to go to SpaceX since 'no other rocket was available in time.'The commercial arm of ISRO, New Space India Limited has signed a contract with SpaceX for a possible liftoff in the second quarter of this year. The SpaceX deal also signifies a significant shift since till now India relied heavily on the France led Arianespace consortium to launch the heavy satellites. India's own rockets lack the capacity for launching very heavy satellites to the geostationary



orbit beyond 4 ton class. According to NSIL, GSAT-20 offers Ka-Ka band high through put (HTS) capacity with 32 beams having Pan-India coverage including Andaman & Nicobar, Jammu&Kashmir and Lakshadweep islands. NSIL is realizing GSAT-20 satellite through ISRO. The satellite weighs 4700 kg, offers HTS capacity of nearly 48Gpbs. The satellite has been specifically designed to meet the demanding service needs of remote/ unconnected regions. Dr Radhakrishnan Durairaj, CMD, NSIL says this is the second demand driven communication satellite mission being undertaken by NSIL after the GSAT-24 mission whose full capacity was leased out to Tata Play. Durairaj says this new satellite deal only confirms that the reform process undertaken by the government is yielding results. NSIL has not revealed who has bought the capacity of the satellite.

While France and Arianespace was indeed a trusted all weather partner all along and India launched 23 of its heavy duty communications satellites on this rocket owned by the European Space Agency.

Notice To Centre, 11 **States On Plea Claiming Caste Discrimination In** Jails

New Delhi: The Supreme Court today sought responses from the Centre and 11 states, including Uttar Pradesh and West Bengal, on a PIL alleging that the prison manuals of these states encourage caste-based discrimination in jails. A bench comprising Chief Justice DY Chandrachud and Justices JB Pardiwala and Manoj Misra took note of senior advocate S Muralidhar's submissions that the jail manuals of these 11 states discriminate in allocation of work inside their prisons and caste determines the places where inmates are lodged.

Certain de-notified tribes and habitual offenders are treated differently and discriminated against, the senior lawyer said. The court asked Muralidhar to compile jail manuals from the states and listed the plea for hearing

511 Cases Of COVID-19 Sub-Variant **JN.1 Detected In India: Report**

New Delhi: A total of 511 cases of COV-ID-19 sub-variant JN.1 have been reported in the country so far with the maximum recorded in Karnataka, official sources said today.

The sources told Press Trust of India that 199 cases have been reported from Karnataka, 148 from Kerala, 47 from Goa, 36 from Gujarat, 32 from Maharashtra, 26 from Tamil Nadu, 15 from Delhi, four from Rajasthan, two from Telangana and one each from Odisha and Harvana.

The WHO has classified JN.1 as a separate "variant of interest" given its rapidlyincreasing spread, but said it poses a "low" global public health risk.

The IN.1 sub-variant of the coronavirus was previously classified as a variant of interest (VOI) as part of the BA.2.86 sublineages, the parent lineage that is classified as a VOI, the world body said. The Centre has asked states and Union territories to maintain a constant vigil amid an uptick in the number of Covid cases and the detection of the JN.1 sub-variant in the country.

"Arvind Kejriwal Shaking In Fear": **BJP On Chief Minister Evading Summons**

New Delhi: Delhi Chief Minister Arvind Kejriwal is "shaking in fear" and not appearing before the Enforcement Directorate because he knows that he is the "kingpin" of the alleged liquor policy scam, the BJP

The BJP's reaction came after Mr Kejriwal skipped the third summons issued by the Enforcement Directorate (ED) in the Delhi excise policy case and sent a written reply calling the notice "illegal".

Reacting sharply, BJP national spokesperson Gaurav Bhatia said, "Outright dishonest and sinister Arvind Keiriwal is shaking in fear and making one after another lame excuse to skip ED summons."

"It won't be wrong to say that (Arvind)



"But a corrupt and sinister Arvind Kejriwal tells ED to withdraw its summons. Mr Arvind Kejriwal, you are not above the law," he charged, saying it is the right of the probe agencies to take action against corruption



after four weeks. Issuing notices to the Union Ministry of Home Affairs and others, the bench asked Solicitor General Tushar Mehta to assist the court in dealing with the issues raised in the PIL filed by Sukanya Shantha, a native of Kalyan in Maharashtra.

"The petitioner states that caste-based discrimination is there in barracks to the manual labour which is allotted and such discrimination among de-notified tribes and habitual offenders. The plea seeks repeal of offending provisions in state prison manuals. Issue notice to the Union and the state government...," the court ordered.

"I have not heard of discrimination on caste... the segregation is usually based on undertrial prisoners and the convicts," the solicitor general said.

Besides Uttar Pradesh and West Bengal, the other states are Madhya Pradesh, Andhra Pradesh, Telangana, Punjab, Odisha, Jharkhand, Kerala, Tamil Nadu, Maharashtra.

Mahua Moitra Gets No Supreme Court Relief, Next **Hearing In March**

New Delhi: The Supreme Court today declined to look into the expulsion of Trinamool Congress leader Mahua Moitra from the Lok Sabha, in a setback to the leader who faces cash-for-query allegations linked to businessman Darshan Hiranandani. Though the Supreme Court did not dismiss Ms Moitra's challenge against her expulsion from parliament, the court said it will first determine whether it has jurisdiction to hear the matter.

Solicitor General Tushar Mehta, appearing for the Lok Sabha Secretary General, said the Supreme Court should not interfere in decisions taken inside parliament, since parliament has its own sovereignty and is one of the three organs under the Constitution, and parliament can internally manage disciplinary issues of its members through its in-house procedure which is not amenable to judicial review."If we have the power of judicial review, we will investigate," the Supreme Court said.

Ms Moitra will also get three weeks to reply. The hearing will begin from March 11 in the Supreme Court again. At the moment, Ms Moitra remains expelled from the Lok Sabha and can't participate in the proceedings.

The Supreme Court said for now it won't comment on the merits of the issues raised by Ms Moitra in the challenge to her expulsion, but has kept the case open.

Archaeological Body Seeks 4 Weeks To Make Gyanvapi Survey Report Public

New Delhi: The Archaeological Survey of India (ASI) has requested a court in Varanasi to give four weeks to make the 'scientific survey' report public in the Gyanvapi case. On December 18, 2023, the ASI submitted a sealed report to the district judge in Varanasi and it was unclear whether to make the report public.

The survey of the mosque premises, excluding the 'wazukhana' sealed by the Supreme Court, was ordered by the Varanasi court to check if the late 17th-century mosque was built over a Hindu temple.

The Muslim side is opposed to a public report, while the Hindu side is demanding that the report should be made public.

The ASI, in its application, said if the survey report is unsealed and disclosed in public before the submission of the copy in the survey report of the suit filed in 1991 seeking the "restoration" of a temple where the Gyanvapi mosque now stands in Varanasi was dismissed by Allahabad High Court, there is more chance of rumours being spread, which may affect the work of ASI.

The Allahabad High Court had on December 19 dismissed several pleas

from Muslim sides challenging the maintainability of a suit seeking restoration of the temple where the Gyanvapi mosque now stands in Varanasi.

In its observation, Justice Rohit Ranjan Agarwal had said the Places of Worship (Special Provisions) Act, 1991 did not define religious character and this can only be determined through evidence presented in the court by opposing parties.

Right-wing groups claim a temple was demolished, by order of Mughal emperor Aurangzeb, to make room for the mosque, which is adjacent to the Kashi Vishwanath Temple.

The survey started after the Allahabad High Court upheld the Varanasi court order. The High Court said the survey was "necessary in the interest of justice" and would benefit both sides in the dispute.

The Gyanvapi mosque committee then moved the Supreme Court against the High Court's order but, on August 4 last year, refused a stay; a bench led by Chief Justice DY Chandrachud, however, directed the ASI to not carry out invasive acts, which ruled out excavations the Varanasi court had cleared.

The top court ordered non-invasive methods of survey and said certain areas - including a structure found in a video survey in April last year and claimed by petitioners as a 'shivling' - were off-limits.

Chandigarh Withdraws Order To Cap Sale Of Fuel As Truckers' Strike Ends

Chandigarh: As the truckers called off their strike against stricter punishments in the new law on hit-and-run cases, Chandigarh on Wednesday withdrew the order on restriction on the sale of petrol and diesel.

On Tuesday, long queues were witnessed at many fuel stations over fears that stocks would run dry soon in the wake of the truckers' strike, following which the Chandigarh administration put a cap on the sale of fuel.

Two-wheelers in Chandigarh were limited to 2 litres or a maximum value of 200 of fuel, while four-wheelers were limited to 5 litres or a maximum value of 500.

"The District Magistrate Chandigarh, who had earlier issued directions for capping fuel transactions, hereby withdraws the aforementioned restrictions with immediate effect. This development comes as efforts to resume the supply of fuel to Chandigarh have been successful, thanks to coordinated efforts with Oil Marketing Companies and the states of Punjab and Haryana," the Chandigarh Administration said in a statement.

"Fuel station operators are encouraged to resume normal operations, and consumers are no longer subject to the previously imposed restrictions," it added.

Truckers End Protest After Centre Says 'Hit-And-Run Law Decision After Talks'

The countrywide truckers' stir was on Tuesday late evening called off as the Centre assured that it would consult stakeholders before implementing a contentious law against hit-and-run cases.

After long talks with the government, the All-India Motor Transport Congress called off the agitation.

"We had a discussion with All India Motor Transport Congress representatives... the government wants to say that the new rule has not been implemented yet.



He said to think of cancer screening as part of your preventive health plan, meaning you should always be current for the cancer screening that is recommended for your gender and age group.

As the medical field continues to understand the importance of screening in regards to improving health, impacting survival, and reducing the number of people who develop late-stage cancer, it will be able to help more people obtain screening earlier, which may impact curative potential of many diseases, said Dr. Ajaz M. Khan chair in the department of medical oncology at City of Hope Atlanta, Chicago and Phoenix.

As certain cancers like breast, colon and lung continue to increase, screening becomes more and more critical, he added.

"More importantly, they establish criteria and guidelines that can help determine patients that are at higher risk based upon their age, gender, family, and social history. Early detection of cancers may also help improve survival and offer cura-



tive options for treatment," Khan told Healthline.

The top five cancer screenings to consider in 2024

Health experts say that the top five cancer screenings that should be on your radar in the new year include the following: Mammogram

A mammogram takes an X-ray picture of the breast, so doctors can analyze the breast for early signs of breast cancer. Getting regular mammograms allows doctors to compare changes in breasts over time, and allows them to find breast cancer early, sometimes up to three yearsTrusted Source before the cancer can be felt.

The American Cancer Society (ACS) recommends the following guidelines-Trusted Source for women at average risk for breast cancer, meaning they don't have a personal history of breast cancer, a strong family history of breast cancer, or a genetic mutation known to increase risk of breast cancer (such as in a BRCA gene), and have not had chest radiation therapy before the age of 30.

Women 40 to 44 can start getting annual mammograms.

Women 45 to 54 should get mammograms every year.

Women 55 and older can get annual mammograms or choose to get them every other year if they are in good health and expected to live at least 10 more years.

"[In] patients with higher risk, which is dependent upon familial or individual risk, screening may also include [ultrasound and] MRI evaluations," said Khan. Cervical cancer screening

The following two tests can help detect cervical cancer early or prevent it. Your doctor can do both tests in the office by collecting cells and mucus from the cervix and the area around it. The sample is then sent to a lab for testing.

HPV test, which detects the human papillomavirus that can cause cell changes on the cervix. If HPV does not clear on its own, it can cause genital warts and cancer.

HT - HEALTH

Pap smear looks for cell changes on the cervix that could turn into cervical cancer if left untreated.

"Cervical cancer screening usually begins after the age of 18 and women can obtain a Pap smear evaluation along with testing for HPV DNA in order to assess for higher risk of development of cervical cancer," said Khan.

Depending on your age, your doctor will determine how often you need these tests.

Colorectal screenings

The U.S. Preventive Services Task Force (USPSTF) recommends that both men and women age 45 to 75 be screened for colorectal cancer. Those older than 75 and those at increased risk for colorectal cancer should talk to their doctor regarding screening.

While there are several screening tests that can detect polyps or colorectal cancer, such as flexible sigmoidoscopy and stool tests, colonoscopy is often used for preventive screening.

During a colonoscopy, a doctor checks the rectum and colon for polyps or cancer by using a flexible, lighted tube. If polyps and cancer are found, the doctor can sometimes remove them during the procedure.

If everything looks normal, your doctor will recommend getting another colonoscopy in 10 yearsTrusted Source, "but the interval of screening will be dependent upon both individual and familial risk," said Khan.

Prostate cancer screening

A prostate-specific antigen (PSA) blood test detects PSA, which is a protein made by cells in the prostate gland (both normal cells and cancer cells).

Enhancing health systems capacities in the WHO European Region

Empowering public health leaders Countries in the WHO European



Region are facing unprecedented challenges: climate change, urbanization, socioeconomic turbulence, noncommunicable diseases, mental and behavioural health risks, misinformation, inequalities, and an exhausted health and care workforce. To tackle these, countries need to identify their underlying causes and invest in informed public health leadership.

The second WHO European Public Health Leadership Course, developed with the University of Bordeaux, brought together public health professionals from over 30 countries. For 2 weeks, participants immersed themselves in real-world or hypothetical scenarios presented by facilitators to enhance their leadership skills, including sessions focusing on innovation, governance, selfmanagement, professional growth, and problem-solving.

"In addition to the practical skills

we developed during those weeks, the network we created and the conversations we had with other trainees are exceptional opportunities to understand global health dynamics," shared Delphine Rahib, Research Manager at Santé publique France, who attended the course.

Strengthening health workforce management

Understanding the intricate dynamics of health systems is crucial for shaping effective health policies, and a key component of this understanding lies in grasping the complexities of the health workforce.

As part of the comprehensive support to countries in the WHO European Region to advance their health workforce policies, the WHO Regional Office for Europe hosted the second round of its executive course on health workforce leadership and management in Copenhagen - this time for representatives of the Small Countries Initiative (SCI).

Twenty participants from 9 SCI countries and representatives from Greenland and Ukraine explored ways to make sustainable plans on numbers and skills of health workers, as well as the importance of selfsufficiency, intersectoral collaboration, and the role of human-centred design. This was an important opportunity for small countries working towards achieving the 2025.

Australia Prime Minister praises Khawaja's courage amid ICC saga

ustralia Prime Minister Anthony Albanese has praised Usman Khawaja's courage in fighting to show solidarity with victims of warfare during the Test series with Pakistan.

Since the days before last month's series opener, Khawaja has been lobbying to voice his support for those affected by ongoing conflict in the Middle East, first by writing "all lives are equal" and "freedom is a human right" on his shoes.

The International Cricket Council (ICC) barred Knawaja from displaying the phrases during the Perth Test on the grounds that international players are prohibited from wearing personal messages on their uniforms.

The veteran opening batter eventually taped over the messages, but the ICC charged him for breaching clothing and equipment regulations with the black armband he wore instead.

Khawaja did not wear the armband in the second Test at the MCG from Boxing Day and had hoped to display a dove holding an olive branch on his bat, but this too was banned by the ICC.

Khawaja, who has received widespread support from current and former Test players, wrote the names of his daughters on his shoes in the MCG Test in place of the original messages.

Mr Albanese made mention of Khawaja on Monday as he addressed the Australian and Pakistani teams at Kirribilli House during his annual New Year's Day reception before the SCG Test.

"I'd like to congratulate [Khawaja] for the courage he has shown standing up for human values," Mr Albanese said. "He has shown courage, and the fact that the team has backed him in is a great thing."

This week's Test match will be Khawaja's last batting with opening partner David warner, who is hanging up his baggy green at the conclusion of the match, which begins on Wednesday.

Khawaja did not wear the armband in the second Test at the MCG from Boxing Day and had hoped to display a dove holding an olive branch on his bat. but this too was banned by the ICC.

"When Ussie and Dave go out, it will be a very special moment, when you walk on to the SCG," Mr Albanese said.

The pair of childhood friends have formed a formidable duo at the top of the order since Khawaja's recall to the Test team during the home Ashes series two summers ago

Warner became emotional speaking about Khawaja in his pre-match press conference on Monday.

"Just to see him come back the way he has the last two years has been absolutely amazing," Warner said. "I know his family are really, really proud of him. I'm really, really proud of him as a mate.

Ayub to debut

rested for

SCG Test;

akistan vice-captain Shaheen Shah Afridi has been rested for the third and final Test against Australia at the SCG to manage his workload. Saim Ayub will make his Test debut in place of opener Imam-ul-Haq, who struggled in the second Test at the MCG despite scoring a half-century in Perth.

The decision that has been enforced upon the visitors is the continued unavailability of Abrar Ahmed. He bowled in the nets on Monday, but there are lingering doubts about his ability to remain fit over the course of five days, as well as concerns around how his body responds to being Pakistan's lead spinner and potentially bowling over 50 overs across the Test. Having pulled up with discomfort in his right leg during the Prime Minister's XI game in Canberra, Pakistan are aware that risking playing him means

potentially going down to ten players early into the Test match.

> Abrar was subsequently ruled out of each of the Tests, and Sajid Khan, the man flown in as his replacement in Perth, will play his first game of the series. It is the first Test Sajid will play since Australia's tour of Pakistan in 2022. He fell down the pecking order behind Abrar and Noman Ali since, but injuries to both, as well as Pakistan's eagerness to play a spinner at the SCG, has seen him return to the side.

> Afridi's absence is the big surprise, with captain Shan Masood praising him for being the leader of the attack just hours earlier. But his lack of pace since his return from injury last year has been the most talked-about aspect of his bowling, his pace rarely rising above the low 130s. In addition, he has had to shoulder greater responsibility in the absence of key frontline

bowling partner Naseem Shah, with the absence of Pakistan's first-choice spinner and an inexperienced fast bowling attack throwing an even greater burden his way. Consequently, he has bowled - by far - more deliveries than any other player across both sides this series, sending down four balls shy of 100 overs. The man in second place on that list is offspinner Nathan Lyon at 69.5 overs.

Imam being dropped to the bench is less of a surprise, not so much for his struggles in Melbourne but how out of touch he looked while at the crease. Masood also stressed the importance of playing attacking cricket, with Imam's strike rate of 31.22 not quite conducive to that philosophy. While Ayub has limited red-ball experience - the 21-year old has only played 14 first class games - his aggressive disposition is more likely to fall in tune with that brand of cricket.
