Kashmir Awaits Snow, Rain

SRINAGAR, JAN 10: Dry spell prevailed in Kashmir valley even as the minimum temperature fell by several degrees, intensifying bone chilling conditions, officials said on Wednesday.

The dry weather has resulted in freezing nights and warmer than usual days as Srinagar on Tuesday recorded a maximum temperature of 14.2 degrees Celsius which was 8.1 degrees higher than usual for this time of the year.

Jammu, the winter capital of the union territory, was



colder than Srinagar on Tuesday recording a high of 11.6 degrees Celsius, which was 6.5 degrees below the normal. Jammu is currently under a cover of dense fog which has resulted in colder days.

Srinagar city recorded a minimum temperature of minus 5 degrees Celsius on Tuesday night, down from minus 2.4 degrees Celsius recorded on the previous night, the officials said.

They said Qazigund recorded a low of minus 4.4 degrees against minus 2.6 degrees Celsius, while in the ski resort of Gulmarg in north Kashmir it was minus 5 degrees Celsius

Pahalgam in south Kashmir's Anantnag district, which serves as one of the base camps for the annual Amarnath Yatra, recorded a minimum temperature of minus 6.3 degrees Celsius, up from the previous night's minus 4.4 degrees Celsius, they said. The minimum temperature in Kokernag town settled at minus 2.4 degrees Celsius and in

Kupwara at minus 4.7 degrees Celsius. Kashmir is currently under the grip of "Chillai-Kalan", a 40-day harsh winter period, when a cold wave sweeps the region and temperatures drop considerably leading to the freezing of water bodies as well as water in pipes.

The chances of snowfall are the highest during this period and most areas, particularly the higher reaches, receive heavy snowfall.

Kashmir has been going through a prolonged dry spell and a 79 per cent deficit in rainfall was recorded for December while there has been no precipitation in the first week of January.

There has been no snowfall in most plain areas of Kashmir, while the upper reaches of the valley have received lesser than usual amount of snow. The meteorological department has forecast mainly dry weather till January 12.

'Chilla-i-Kalan' will end on January 31. However, the cold conditions will continue after that with a 20-day 'Chilla-i-Khurd' (small cold) and a 10-day 'Chilla-i-Bachha' (baby cold). (Agencies)

accelerate its disconnection drives as warranted under Section 56 of the Electricity Act.

He further stated that smart meter consumers with arrears are being automatically disconnected if they do not pay their pending power bills.

Expressing serious concern over huge default figures in domestic, commercial and industrial categories, the MD stated that revenue realized on account of clearance of pending bills shall enable KPDCL to have enough resource availability for power purchase which will be critical for providng reliable supply.

The MD also said that huge default figures are taking a toll on the financial health of the Corporation as it would impact the fund flow under Revamped Distribution Sector Scheme (RDSS), which is aimed at transforming the LTD istribution Network in Kashmir Division.

Seeking cooperation of all consumers in clearing dues, the MD further stated that keeping in view the compulsion for realization of arrears, KPDCL has passed directions to all 19 Electric Divisions to further accelerate disconnection drives of defaulter consumers who are reluctant to pay their energy dues on time.

Limited (KPDCL), Mussarat Islam, today inspected Divisional Workshop of Electric Division (ED) II, Srinagar at Huzuribagh and obtained a firsthand appraisal about replacement of damaged trans-

Executive Engineer, ED II, Srinagar, Er. Rauf Bhat, AEE, Er. Dara Singh and other engineering and technical staff of Sub Division Huzuribagh were also present on the occasion.

While inspecting the buffer stock of DTs, the MD was informed by EE ED II that no Distribution Transformer(DT) is presently damaged in Electric Division II and all damaged DTs have been repaired at the workshop.

He was further informed that only 34 DTs were damaged in the month of December 2023, down from 62 in the corresponding period in 2022. In January so far, only 5 DTs have been reported damaged and all have been replaced within the stipulated timeline fixed by the Government.

While visiting 3x6.3 MVA Receiving Station and $Billing \, Centre \, of \, \widetilde{S}/D \, Huzuri bagh, the \, MD \, appreci$ ated the KPDCL staff and urged upon them to increase the billing and collection efficiency and maintaining the momentum of inspection and disconnection drives in the Electric Division.

The MD also appreciated the improvement in revenue realisation in Electric Division II and hoped that targets fixed by the Government will be achieved.

the Centre will have to either pass an ordinance or bring a bill in Parliament for it.

"It is extremely unlikely that the panchayat polls will be held before the Lok Sabha elections in Jammu and Kashmir. Besides amending the act, the quantum of reservation has also to be decided." State Election Commissioner BR Sharma said.

Lok Sabha elections are due in April-May. Sharma said the commission was performing its statutory duty of revising and updating the

electoral rolls in the Union territory. According to officials, besides the issues related to OBC reservation, the commission will have

to wait till the wards to be reserved are identified. The other major task likely to be carried out before holding the panchayat and municipal polls will be delimitation of the wards to address the

skewed distribution of electors. The housing and urban development department is actively pursuing a communication from the office of the chief electoral officer, which, among other things, suggested transfer of mandate to conduct the municipal electoral processes to the State Election Commission (SEC) in accordance

with constitutional provisions. In Jammu and Kashmir, the chief electoral officer (CEO) is the authority to hold urban local body (ULB) elections in addition to Lok Sabha and assembly polls, while the SEC – headed by a state election commissioner — is mandated to conduct elections to Panchayati Raj Institutions (PRI).

In a letter to the housing and urban development department last month, the CEO's office said consequent to the appointment of a full-time state election commissioner, the mandate to conduct the municipal electoral processes needs to be transferred from the CEO to the SEC.

"For this, the election authority under the municipal acts needs to be changed from chief electoral officer to the state election commissioner. The constitutional provisions also mandate

this," the letter read. The five-year term of most of the municipalities, including the Jammu Municipal Corporation (JMC) and the Srinagar Municipal Corporation (SMC), ended in November last year, while the term of panchayats expired on Tuesday.

The term of the SMC ended on November 5 andthe JMC's ended on November 14.

The tenure of block development councils (BDCs)and district development councils (DDCs) is ending in October 2024 and January 2026, respectively. The last ULB and panchayat elections were held between October and December 2018 after a long delay. The CEO's office, in its letter, also referred to various petitioners who have objected to the large-scale difference in the electoral base of each seat of the two municipal corporations and demanded a fresh delimitation of all bodies.

"...there is a large difference in the elector bases of different wards wherein there are wards with elector bases in the range of 2,000 to 3,000 on one side and 12,000 to 15,000 on the other extreme. Similar variance is there in most of the municipal councils and committees also. This skew in the representation strength of each ward can be addressed by a fresh delimitation exercise," the

letter stated. (Agencies)

administrator(s) for running the affairs of Halqa Panchayats for a period of six months, saying that it is satisfied that Halqa Panchayat(s) cannot be constituted immediately.

"The term of Halga Panchayat(s) has expired on 09.01.2024 and the Government is satisfied that Halqa Panchayat(s) cannot be constituted immediately," reads a notification issued by Department of Rural Development and Panchayati Raj.

"Now therefore in exercise of powers conferred by section 9 of Jammu & Kashmir Panchayati Raj Act, 1989, the Government hereby appoints Block Development Officers (BDOs) as administrator(s) for running the affairs of the Panchayat Halqa(s) under their jurisdiction for a period of six months w.e.f 10.01.2024 or till further orders, whichever is earlier," it further states.

KNO had already reported that government is appointing administrator(s) for running the affairs of Panchayats.

The government had already made similar arrangements urban local bodies after their fiveyear term came to end in October-November last year. It had empowered deputy commissioners and additional district development commissioners as administrator(s) of municipal bodies.

The elections for Urban Local Bodies and Panchayats were expected in October-November last year, but couldn't take place due to a host of reasons.

The local bodies polls in J&K are unlikely to be held before the 2024 parliament polls which would take place in April -May.

In December 2023, the administrative council headed by LG Manoj Sinha proposed amendments in Jammu & Kashmir's Panchayati Raj Act to grant reservation to Other Backward Classes(OBCs) in these institutions.

located in remote and hilly terrain." The Planning Department and Monitoring Department in the proposed vision has further revealed, "Considerable chunk of human resource is not skilled in the art of teaching, Over 36000 ReTs or RReTs are not possessing desired level of qualification have

been regularised." Stating the further weaknesses, the department has said, "Development works get delayed due to hilly terrain and Climatic Conditions-snow bound areas."

The documents also reveal that at least 1,67,106 teachers for 27.18 lakh students, i.e. one teacher for 16 students on an average are available in the region.

Seven out of eight seats of JKPSC members lying vacant

COMMISSION WITHOUT CHAIRMAN SINCE NOV 2023; 800 GAZETTED **POSTS AWAITING** RECRUITMENT

SRINAGAR, JAN 10: With the retirement of Jammu and Kashmir Public Service Commission (JKPSC) member Zubair Ahmed Raza, seven out of eight seats in the JKPSC are now vacant.

According to the news agency— Kashmir News Observer (KNO), Tariq Ahmad Khan, a former Director General of Planning, remains the sole active member and is also due to retire soon. The commission, operating without a chairman since November last year, has halted the recruitment process.

Since the abrogation of Article 370 in 2019 and the bifurcation of the state into two Union Territories, JKPSC Chairman Satish Chandra took on the role of the reconstituted PSC's first Chairman in June 2020. However, several members, including the Chairman. have retired since then, leaving only Tariq Khan as the single active member.

The members who retired from the reconstituted Commission include former judge Syed Iqbal Aga on January 15, 2022; Samir Bharti, a retired Indian Forest Service officer, on January 28, 2022; Subhash Gupta on March 28, 2022; Prof Showkat Ahmad Zargar on April 3, 2022; retired IAS officer and incharge Chairman Dr Farooq Ahmad Lone on June 1, 2022; engineer Desraj on December 15, 2022; retired IGP Syed Ahfadul Mujtaba on February 11, 2023; and Chairman Satish Chandra on November 19, 2023.

Officials said the vacancies have not only impacted the recruitment process for hundreds of gazetted posts but have also caused concerns among students. They said the absence of a chairman and members has delayed the forwarding of selected candidates' lists to respective departments.

"The Chairman has the authority to make decisions related to conducting examination but the absence of the chairman is not putting an impact on the functioning of the commission but it is also causing concerns among students," they said.

According to officials, the absence of the chairman and its members has put the recruitment process of around 800 gazetted posts on halt. "More than 200 assistant professors were selected in October and November 2023 in the Health and Medical Education and Higher Education Department, but the lists are yet to be forwarded due to the absence of the chairman and members," they said, adding that the examinations for hundreds of posts scheduled for December 2023 and January 2024 have been postponed, and DPCs of various departments are pending.

Candidates, speaking to KNO, have expressed frustration, saying the issue was brought to the notice of higherups several times but no positive steps have been taken as of now.

They have urged Lieutenant Governor Manoj Sinha and Chief Secretary Atal Dullo to intervene and expedite the appointment of a new chairman and members to ensure the swift functioning of the commission.

Properties worth Rs 3 cr consumed by fire in Gbl last year: Official data

Ganderbal, Jan 10: The Central Kashmir's Ganderbal district has witnessed 149 fire incidents last year, causing losses worth Rs 3 crore. The alarming figures highlight the urgent need for enhanced fire safety measures in the district. Besides, data obtained by the news agency—Kashmir News Observer (KNO) showed the fires devoured the lives of 24 people.

The affected properties included residential houses, a mosque, a Dar-ul-Awam, commercial centers, government buildings, tin sheds, cowsheds, poplar trees, electricity transformers, vehicles, poultry farms, adairy farm, and gas cylinders. The estimated cost of the damaged assets surpasses 3 crores, leaving a trail of devastation.

Electric short circuit has been found to be responsible for 80 percent fire incidents.

Amid the losses, the district is equipped with only five fire stations across 139 revenue areas, raising concerns among the local population. An official from the Fire Service Department acknowledged the severity of the situation and revealed that the department witnessed a 25% reduction in fire incidents compared to the previous year.

He attributed the decline to proactive measures, including public awareness campaigns and enhanced fire protection procedures implemented by the department.

Tragically, the year 2023 also saw seven individuals, including two firefighters from the Fire and Emergency Department, sustain injuries while battling the blazes.

This underscores the challenges faced by emergency responders and emphasizes the need for a comprehensive approach to fire safety in Ganderbal.

The district is now at a crossroads, with residents and business owners urging the establishment of additional fire stations in prominent tourist spots like Sonmarg and Manasbal as well as other areas including Tulmulla.

In light of the call for a global framework for responsible development of Artificial Intelligence (AI), it is important to understand what this amazing transformative and fast evolving technology is. Among the many disruptive technologies AI occupies an important place. Like a knife in the kitchen it can do good as well as harm. Therefore, Prime Minister Narendra Modi, in his speech at the recent Global Partnership on Artificial Intelligence Summit, among other things said, "making it transparent and free from bias would be a good start. We must convince people across the world that AI is for their benefit and for their future, and that no one will be left

We must not lose a single second... We must complete the global framework within this year... we must all work together." A number of multinational corporations have invested heavily in the promotion of AI for financial gains impelling governments around the world to debate on what legislations should be made for formulating evidence-based policies to ensure that AI is all-inclusive and to understand the risks as well as the harm it could do in the absence

of government regulations. The unethical dimension of our scientific and technological advancement is that poorer sections of populations, particularly in developing countries, are still deprived of most benefits of scientific progress. National and international means for a better distribution and application of new knowledge are essential. It has become clear, however, that even in the most developed countries that material progress has become unsustainable and a society driven by fossil fuel-based growth has plunged the entire planet into dire peril.

And even more important, are moral crises for if material gains outrun the social and spiritual progress of man, as evident today, it will threaten the very survival of the human race. Sadly, many developing countries and emerging economies are hell-bent on aping the Western model of growth. It is not surprising, therefore, that permanent solutions to global problems, including the negative impact of disruptive technologies such as AI, 3D printing, augmented reality, blockchain and streaming media, appear to be elusive and distant. AI and ChatGPT have the potential of overtaking human intelligence and seizing control over all affairs

The primary reason for such a situation is the unethical proliferation of newer technologies. The economic development process should accordingly employ science and technology to reflect fully the fundamental organic oneness of the human race, by helping to abolish all prejudice and divisiveness, whether of class, creed, caste, sex, race, or nationality. While new technologies may appear uncontrollable and unpredictable, ethics research at Simon Fraser



University in British Columbia believes that "they are not unguided" and work according to the instructions and choices made by people.

Mario Rosetti, Professor Emeritus of Theoretical Physics at the Politecnico di Torino, noted that the human brain cannot be compared to artificial intellect due to the brain's magnificent structure and function. If the human brain is far more powerful than Artificial Intelligence, there is hope that the technology could be controlled by people. All previous studies accentuate an argument that Artificial Intelligence must not be worshipped. However, since machines are constantly being improved upon, it is vital for religious and technology leaders to discuss the ethical issues that surround Artificial Intelligence and help innovators minimize their risks. We know that if ethically employed science and technology can lead to the betterment of the human race, to the development of the qualities of humanity, and to an understanding of the mysteries of the universe. They have the potential to eradicate poverty, enrich humanity, and free it from the struggle for existence. The Internet is one of this age's most transformative technological developments. It appears to be playing a catalytic role in breaking down long standing geographical, cultural and institutional barriers while facilitating the formation of new communities of interaction that are increasingly global in nature.

All would agree that finite material resources of the planet are for the benefit of all human beings; it is through science that we can understand the potential of existing resources and learn to develop this natural heritage for ourselves and future generations. Science should, therefore, be pursued to improve human life, and have as its conscious and ultimate goal the establishment of world peace and the unification of the human race.

Yet, for many of the multinational and transnational

corporations, profit-maximization appears to be the first priority. Oftentimes technology providers, those toiling in laboratories or research institutions, do not know if their inventions or innovations are benefiting society. A range of ethical questions have been posed such as how Artificial Intelligence can address the needs of diverse local communities, and how innovation and regulation can work hand in hand to advance the common good. ChatGPT, the chatbot launched by "Open AI", a company that develops Artificial Intelligence products is already causing disruptions in the society. While the storm unleashed by ChatGPT is still not fully understood, its impact in daily transactions and educational institutions has become a matter of concern for all sections of society.

These have brought fresh interest in Artificial Intelligence, as well as optimism and fear. There is no doubt that with ChatGPT, Artificial Intelligence has turned a corner. From the perspective of ethics, all must endeavour to become agents of positive change. Followers of the Bahá'i Faith believe that moral principles derived from the best there is in every religion when instilled in individual scientists and technocrats can be a most effective way to eliminate obstacles to the application of science and technology to development. They will immediately see the need for betterment of society and will want to apply their knowledge in service of their fellow

So motivated, they will encourage the appropriate transfer of technology that can address the needs of diverse local communities, and show how innovation and regulation can work hand in hand to advance the common good. Religions are the source of ethics and moral imperatives and traditionally provided standards and goals for the individual and society, but misunderstandings and distortion of fundamental

teachings have brought prejudice, dogmatism, superstition and fanaticism, all major hindrances to human development. On the other hand, scientific progress, without the religious values brought by the founders of the world's revealed religions, has spawned materialism, greed, selfishness, distrust and injustice.

On January 10, 2023, "AI Ethics: An Abrahamic Commitment to the Rome Call" gathered the three Abrahamic religions – Judaism, Christianity, Islam - and different corporate leaders at the Vatican for the purpose of discussing ethics in navigating this technology. The common agreement was that algorithms should improve the world but not be the ultimate decision-maker. At a time when humans are being defined as biochemical Algorithms, it is interesting to note that Brad Smith, Microsoft representative at this gathering, underlined the importance of considering the religious take on ethics as a moral compass in determining the rules and regulations around Artificial Intelligence. Following the conference, the leaders of Abrahamic religions signed a joint declaration.

It urged the developers of AI to follow six principles: AI must be transparent, inclusive, accountable, impartial, reliable, secure, and respectful of the users' privacy. It is necessary to analyze relevant studies on the positive and negative aspects of AI in order to better understand the rising concerns that surround it. The initiative taken by the Abrahamic Faiths could be expanded to include all other religious/dharmic communities. Dangers emanating from emerging technologies must impel all sections of society to re-think the role of both religious institutions and scientific progress. The spirit of altruism and human goodness must keep pace with the speed of technological advances that seem to have outpaced the human capacity to reflect on consequences. The need for greater participation of the human family in critical questions concerning humanity's future, such as how Artificial Intelligence and other digital technologies are developed is very urgent. Inclusivity is a must in designing any software or any new piece of

The risk of Artificial Intelligence being designed only to serve a certain part of the world or part of society is real. It was highlighted at the recent Summit meeting against the criteria that places human progress at the centre of all our goals. Recognizing the urgency of the situation, it is hoped that a global framework for AI would be enacted and adopted by all countries. When graphed into the future, such changes can accelerate the progress of science and technology. From the perspective of ethics, all must endeavour to become agents of positive change.

How to Prevent Anger's Damage to Your Brain

When I was in college and proudly showed my mother my new Volkswagen, she tearfully said, "How could you? The Germans murdered 33 of our relatives."

I wanted to say, "Mom, the people who built my car weren't born then; they aren't responsible for the sins of their fathers."

But her anger was so immediate and intense that I knew nothing would reduce her hostility toward anything German, from riding in a Volkswagen to eating schnitzel. I didn't realize the neurological effects of her anger.

Anger and the Aggressive Amygdala Anger is the brain's reaction to events, ranging from my mother's response to the horrific deaths of family members to a partner's fury when not remembering a 25th wedding anniversary. This reaction, and others on the "offense" continuum, start in the amygdala, an almond-shaped bundle of neurons in the brain no bigger than a shelled peanut.

Five million years ago, the amygdala's "fight or flight" response was essential for survival when velociraptors lurked in the forest, hoping our ancestors would be on the menu for lunch.

You can think of the amygdala as a sentry that acts when it senses danger. If it snoozes, people die, or on a personal level, your ancestor becomes an appetizer.

Hardwired into the amygdala is the motto, "Better safe than sorry," a reaction that caused our ancestors to flee at the sound of rustling in the forest rather than hoping to get close enough to pet the toothy monster lurking behind a tree.

Unfortunately, many of our hardwired traits linger thousands or even millions of years after their survival value has diminished. Anger appears to be one such



Instead of anger becoming a little-used reaction with limited value, the amygdala remains on high alert, responding to words with the same ferociousness as if a passing insult was life-threatening rather than unskillful. This inappropriate reaction often results in unintended and hurtful consequences.

Anger's Consequences

Tibetans have a saying, "You can throw hot coals at the enemy, but you'll burn your hands in so doing." The effects of

anger have been well-documented, ranging from the destruction of interpersonal relationships to the impaired mental health of those who are consumed by it. On balance, the survival value of anger does not seem to justify the damage it does to the initiator or the recipient of the emotion.

Your anger can rarely be contained, like spilled water on a countertop. Think about how your furious response affected interactions with everyone that day. An explanation of why you cannot isolate your anger about a specific event may come from neurological research.

Negative emotions—including anger trigger other negative feelings that often result in depression or a prevailing sense of gloom. Think of a row of dominos where the tripping of one sets off a reaction that doesn't stop until the last one falls.

Shakespeare got it right in The Merchant of Venice when Portia pleads for mercy. The quality of mercy is not strained; It droppeth as the gentle rain from

It blesseth him that gives and him that

Upon the place beneath. It is twice

Mercy and forgiveness, precursors for bridling anger, can reduce or eliminate the damage the amygdala's prehistoric reaction causes to both the thrower of hot coals and the person struck by them. But what happens when you can't forgive? When an offense is so horrific that you believe even God could not forgive what the person did. The answer lies in understanding.

Try to Understand When You Can't

Forgive Understanding is often mistaken for forgiveness. It is not. There are important distinctions between the two that involve both the heart and the head.[viii] I can't for give what the Nazis did to my relatives, but I can understand the dynamics that explain why they blindly followed a

We routinely encounter situations in which a choice is necessary. We can become angry, forgive, or understand. Even when the response is justified, anger does nothing to render justice. Although forgiveness is healing, the greater the magnitude of the offense, the less likely it will occur. Sometimes, the only thing left is understanding.

Is understanding as comforting as forgiving? Absolutely not, but understanding won't burn your hands as much.

During the Awareness Camps organized at Chief Animal Husbandry Officer (CAHO), office Kowbagh, village Gaam and Chamalwas, where a team led by CAHO, Dr. Suhail Jan Kawoosa comprising Dr. Nadeem Ahmed, Extension Officer, Extension & Publicity Wing, Directorate of Animal Husbandry, Jammu and, Managing Director, JK Milk Producers' Cooperative Ltd. DODA, JANUARY 10: District Development Commissioner(DDC)Doda, who is also District Panchayat Election officer, chaired a meeting in the conference hall of DC office complex, to review preparedness for the Summary revision of the Panchayat electoral roll, with January 1, 2024 as the qualifying date.

The DDC directed the Block Development Officers (AEROs) to actively enroll voters during this revision and ensure the presence of the Assured minimum facility (AMF) at each polling station. The Jammu and Kashmir State Election Commission, as the Election Authority, has issued comprehensive directions for the annual revision of the Panchayat Electoral Rolls. This process is in accordance with Section 38 of the J&K Panchayati Raj Act, 1989, and Rule 4 of J&K Panchayati Raj Rules, 1996. The revision will be effective as of January 1, 2024, and will involve four Special Camps organized at all polling station locations on specific dates.The Special Camps scheduled for January



27-28, 2024, and February 3-4, 2024, aim to facilitate the revision process.

During these camps, Panchayat Election Booth Officials (PEBOs) will be present at respective polling stations, equipped with necessary forms to guide electors and receive claims or objections. Assembly Booth Level Officers (BLOs) will also assist PEBOs dur-

ing these special camps. The Block Development Officers (AEROS) will play a crucial role in collecting details of claims and objections received during the Special Camps, following a prescribed format. This information will then be submitted to the Electoral Registration Officer (ERO), who, in turn, will submit it to the District Panchayat Election Officer (DDC). A consolidated report of the district will be submitted to the State Election Commission for appraisal on the day following the special camp.The schedule of the revision process includes the publication of the integrated draft Electoral Roll on January 15, 2024, followed by a period for filing claims and objections until February 5, 2024. The disposal of claims and objections by the ERO is expected to be completed by February 16, 2024, with the final publication of the Electoral Roll slated for February 26, 2024. This announcement signifies the commitment of the J&K State Election Commission to maintain an accurate and up-to-date electoral roll, ensuring a fair and transparent electoral process for the Panchayat elections in 2024.The meeting was attended by the deputy district election officer Doda Om Prakash, BDOs (AEROs) election Naib Teshildar Doda Angrez Singh Jasrotia and concerned representative of concerned

Dr Ritika Sachdev, Additional Director of Medical Services & Ophthalmologist, Center For Sight Eye Hospital, says, "As an ophthalmologist, it is crucial to shed light on the different types of glaucoma, the associated risk factors, common symptoms, and available treatment options." 1.

Primary Open-Angle Glaucoma (POAG): This is the most common type, often developing gradually and without noticeable symptoms until later stages.

2. Angle-Closure Glaucoma: This occurs when the drainage angle of the eye narrows, leading to a sudden increase in eye pressure. It can manifest with rapid symptoms like severe eye pain and blurred vision.

3. Normal-Tension Glaucoma: In this type, optic nerve damage occurs despite normal eye pressure. The reasons behind this phenomenon are still being researched.

like PCBs, pharmaceuticals, and pathogens (Funded by the Hudson River Foundation)," Beizhan Yan, study author and Associate Research Professor at Columbia Climate School Lamont-Doherty Earth Observatory, told Healthline. "In comparison, nanoplastics are expected to have an even greater ecological and health impact due to their higher partitioning rate and associated nanotoxicity."

Large amounts of nanoplastics in bottled water

For the new study, Yan and fellow researchers looked for seven types of plastic, which only made up approximately 10% of the nanoparticles in the water samples.

This suggests determining particle composition is quite complex.

Theresearchers estimated thatan average liter of bottled water contained 240,000 identifiable plastic

Further research is necessary to determine if drinking bottled water containing nanoplastics could lead to adverse health effects. "If people are concerned about

nanoplastics in bottled water, it's reasonable to consider alternatives like tap water," said Yan. "However, it's important to emphasize that staying hydrated is crucial for health. Therefore, we do not advise against drinking bottled water when necessary, as the risk of dehydration can outweigh the potential impacts.

Plant-Based Diet, Less Dairy, And Meat To Cut Covid-19 Risk: Study

ating a predominantly plant-based or vegetarian diet high in vegetables, ✓ legumes, nuts, is linked to 39 per cent lower odds of Covid-19 infection, claims a research. Researchers from the Universidade de Sao Paulo in Brazil also claimed that a diet low in dairy products and meat may help to ward off the infection.

"Plant-based dietary patterns are rich in antioxidants, phytosterols and polyphenols, which positively affect several cell types implicated in the immune function and exhibit direct antiviral properties," the team wrote in the study, published in the open access journal BMJ Nutrition Prevention & Health. In the study, the team set out to evaluate the potential impact of dietary patterns on the incidence, severity, and duration of Covid-19 infection among 702 adult volunteers all of whom were recruited between March and July 2022. They were divided into either omnivorous (424) or predominantly plantbased (278) dietary groups. The plantbased food group was further divided into flexitarians/semi-vegetarians who ate meat three or fewer times a week (87); and vegetarians and vegans (191).

The omnivores reported a higher rate of medical conditions and lower rates of physical activity. And the prevalence of overweight and obesity was significantly higher among



the omnivores -- all factors associated with higher Covid-19 infection risk and more severe symptoms/ complications.

In all, 330 people (47 per cent) said that they had had Covid-19 infection. Of these, 224 (32 per cent) said they had mild symptoms and 106 (15 per cent) had moderate to severe symptoms. The omnivores had a significantly higher reported incidence of Covid-19 than the plant-based dietary groups: 52 per cent vs 40 per cent. And they were more likely to have had moderate to severe infection:18 per cent vs just over 11 per cent.

There was no difference, however, in how long symptoms lasted, the researchers said.


But those following a predominantly plant-based or vegetarian/ vegan diet were 39 per cent less likely to become infected than the


omnivores.

It may be that predominantly plantbased diets provide more nutrients that boost the immune system and help to fight viral infections, they suggest, by way of an explanation for their findings. The team noted that "this is an observational study, however, and as such, can't establish causal factors". The researchers also acknowledge that the study relied on personal recall and subjective assessment, both of which are prone to error.

Nevertheless, "in light of these findings and the findings of other studies, and because of the importance of identifying factors that can influence the incidence of Covid-19, we recommend the practice of following plant-based diets or vegetarian dietary patterns," they said.











Afghanistan's Rashid Khan to miss all three T20 matches aginst India

MOHALI: Afghanistan spinner Rashid Khan will miss the three-match Twenty20 series against India due to injury, but the team has plenty of experience in reserve, skipper Ibrahim Zadran said Wednesday. Rashid, a leg-spinner with 347 international wickets across formats, underwent lower-back surgery in November but remains part of the

opener on Thursday in Mohali.

"He is not totally fit (but) he is travelling with the team. We hope he gets fit soon," Zadran told reporters. "Without Rashid, we will struggle but not that much. His experience is important for us but this is cricket, you should be ready for any kind of situation."

Rashid, 25, is a pillar of a world-class travelling squad which will play the Afghan spin attack that also includes

Mujeeb Ur Rahman, Noor Ahmad and Mohammad Nabi.

The three matches are a tune-up for this year's T20 World Cup in June and Afghanistan will be up against a formidable home side, with skipper Rohit Sharma and star batsman Virat Kohli both back in the short-format team.

"Playing against India on their home soil is a difficult task, but we came here

to play well against them and show our skills," said Zadran.

"We have lots of good T20 players, all our boys are playing good cricket, so I am sure they will play well."

The cricketing minnows put up an impressive show in last year's ODI World Cup in India with victories over England, Pakistan, Sri Lanka and the Netherlands.

Zadran, a 22-year-old opening bats-

man, said fans' raised expectations will motivate the team to elevate their per-

"Not only Afghanistan people are expecting lots of things, but all around the people are expecting (a) lot of things from us nowadays because we played a wonderful World Cup," he said. Zadran said the team hoped to "play positive cricket and show our skills on the field".

As Nigerian supporters flocked to the national stadium expectations were high that the home team would use that advantage to good effect and secure a place at the finals in Qatar.

But those dreams were shattered as Ghana drew 1-1 to qualify on away goals and deprive Osimhen and his teammates of a place on the global stage.

ICC rates South Africa's Newlands pitch as unsatisfactory after shortest-ever Test in history

DUBAI: The International Cricket Council (ICC) on Tuesday rated the Newlands pitch for the second Test between India and South Africa as

"unsatisfactory" after it ended inside five sessions.

India defeated the hosts by seven wickets in the match, which turned out to be the shortest-ever in the history of Test cricket.

The victory allowed India to draw the two-match series 1-1. The decision was made under the ICC Pitch and Outfield Monitoring Process.

Only 642 balls could be bowled in the

"The pitch in Newlands was very difficult to bat on. The ball bounced quickly and sometimes alarmingly throughout the match, making it difficult to play shots," said Chris Broad, the match referee for the Test, in his report submit-

"Several batters were hit on the gloves and many wickets also fell due to the awkward bounce," Broad further wrote. Subsequently, the Newlands was awarded one demerit point. One demerit point is awarded to venues whose pitches and outfields are rated by the match referee as unsatisfactory.

Cricket South Africa has 14 days to appeal against the sanction. If a venue reaches six demerit points, it is suspended from hosting any international cricket for 12 months. The penalty is 24 months in case of 12 demerit points. These points remain active for a rolling five-year period.

Indian skipper Rohit Sharma was

exceptionally vocal in his criticism of the Newlands surface.

"We saw what happened in this match, how the pitch played. I don't mind playing on pitches like this. As long as everyone keeps their mouth shut in India and don't talk too much about Indian pitches," Rohit had told reporters in his post-match press meet.

"Because you come to Test cricket to challenge yourself. Yes, it is dangerous. It is challenging. So, and when people come to India, it is again pretty challenging as well. If the pitch starts turning (in India), people start talking about 'Puff of dust! Puff of dust!' There's so much crack here (Newlands) on the pitch," he added.
