### 6.0 magnitude earthquake hits Afghanistan, tremors felt in J&K

SRINAGAR, JAN 11: Earthquake of magnitude 6.0 hit Hindu Kush region of Afghanistan on Thursday with tremors felt across Jammu and Kashmir.

According details available with the news agency-Kashmir News Observer (KNO), the quake occurred at 02:50 pm. However, there were no immediate reports of any damage or loss of life reported anywhere. As per initial estimates the epicentre was recorded in Hindu Kush Region of Afghanistan.

### Youth killed in Kulgam road accident

KULGAM, JAN 11: A 30-year-old youth was killed in a road accident in South Kashmir's Kulgam on Thursday, an official said.

An official told the news agency— Kashmir News Observer (KNO), Javid Gulzar, a 30-year-old motorcyclist hailing from Sehpora Kulgam, lost his life in a road accident near PHC Katrasoo Kulgam.

He said the motorcyclist lost his control when a dog unexpectedly darted across his path, leading to the bike skidding off the road.

The official said the impact resulted in critical injuries to him, and he was immediately evacuated to the district hospital in Kulgam for emergency medical care but succumbed to his injuries.

### Amid No Snow.....

Kashmir is reeling under an intense cold and temperatures continue to be below freezing point during the night. However, days are relatively warmer.

Srinagar- the summer capital of J&Krecorded a minimum temperature of minus 5.0 degrees Celsius on Wednesday night, same as the previous night, MeT said.

Pulwama in south Kashmir was the coldest place as it recorded a minimum temperature of minus 6.6 degrees Celsius.

The tourist resorts of Pahalgam in south Kashmir and Gulmarg in Baramulla district recorded minus 6.3 degrees Celsius and minus 3.5 respectively.

Kashmir's harshest 40 days winter period, "Chilla-i-Kalan", began on December 21 and despite that is almost halfway through, Kashmir has witnessed no snow. Even the ski resort of Gulmarg is bereft of any snow, leaving the tourists upset.

Scientists say the dry winters would mean higher mass loss of glaciers in this hydrological year, if the weather conditions do not improve and might impact hydropower generation, irrigation agriculture and dependent sectors. (UNI)

for better research and innovations. Speaking to the news agency—Kashmir News Observer (KNO), Singla said, "In School Education sector, there are many areas to focus on but primarily the department will be focusing on improving the access and quality of education."

Singla further said that it will be also focusing on the welfare of human resources of the department and all other stakeholders.

"Besides our special focus would be on the quality of education in all rural and far flung areas," he said.

During the session, officers from the School Education Department presented a detailed overview of various aspects of the department to the newly appointed administrative secretary.

He was informed about the department's overall functioning of centrally sponsored schemes, the physical and financial progress achieved under UT Capex, human resource management (HRM) challenges, and the department's best practices and initiatives.

Singla on the occasion emphasized the importance of timely completion of Departmental Promotion Committees (DPCs), finalization of seniority lists, and the provision of quality infrastructure for students.

### Situation In....

Gen Manoj Pande said on Thursday. At a press conference, he also said he has conveyed an unambiguous message to the soldiers and commanders that there will be "zero tolerance" to human rights violations and they must operate in a professional manner.

Three civilians were killed in Poonch last month allegedly during questioning by the Army in connection with an ambush of Army personnel by militants. Four Army soldiers were killed in the ambush.

"The situation in Poonch-Rajouri has been an issue of concern to us," Gen Pande said.

It is learnt that the terrorists operating in the Rajouri-Poonch area are very welltrained in carrying out terror attacks and ambushes.

The Army Chief said his force is focusing on strengthening the human intelligence which includes synergising the Army's efforts with other agencies, adding having support of the locals is also "extremely crucial" in anti-terror operations.

"We have already taken follow up action,"

he said.

The Chief of Army Staff said the Army is also looking at strengthening the ability to use technology to gather intelligence.

"We have enhanced our deployment and also reoriented some of the units," he said. At the same time he said the troops have been told to operate professionally.

"My guidance to soldiers and commanders is unambiguous — in terms of respect for human rights, there will be zero tolerance for any actions on that account," he said.

"We have clearly laid out guidelines spelling out what you (Army personnel) must do and what you must not do in those areas and for the soldiers to be able to (operate)in a professional manner," Gen Pande said.

He said there has been an increase in terrorist activities in Rajouri-Poonch region in the last five-six months.

"In the last five to six months, in Rajouri and Poonch, there has been an increase in terrorism. Terrorism in that area was eradicated in 2003 and peace was there till 2017-18," he said. "Because of the situation in the valley

getting normal, this is one area, our adversaries have been active in, in terms of abetting terrorism, encouraging proxy tanzeems in operating in this area," he said.

The Army Chief said 45 terrorists were killed in Jammu and Kashmir in the last three years. (Agencies)

ISRO Chairman S. Somnath and Project Director of Chandrayaan 3, Dr P.Veeramuthuvel, at a glittering ceremony here.

The award recognised the remarkable contribution made by ISRO in pushing the boundaries of Space exploration, read the award citation.

"The year 2023 will undoubtedly be etched in the books of history as a period when India's Space agency demonstrated unparalleled prowess and resilience in the face of challenges. The pinnacle of ISRO's achievements in 2023 was the successful first-ever soft landing of Chandrayaan-3 on the Moon's uncharted South Polar region

In his brief remarks, Dr Jitendra Singh said the Chandrayaan-3 was not only indigenous but also a very cost-effective mission, with a budget of about Rs. 600 Crore. Even though talent was never lacking in the country, the missing link of enabling milieu was created under the leadership of Prime Minister Shri Narendra Modi, he said.

"With the "unlocking" of Space Technology, Dr Jitendra Singh said, the common masses of the country have been able to witness the launch of the mega Space events like Chandrayaan-3 or Aditya. Over 10,000 spectators, over 1,000 media persons and a large number of common people had come to see the Aditya launch and an equal number were there during the Chandrayaan-3 landing on the moon," he said.

Dr Jitendra Singh said, for the first time the whole of nation got involved when Chandrayaan-3 made a historic landing on the lunar south polar region.

"In a way, that has given the nation a sense of belonging, - owning these space missions," he said.

Dr Jitendra Singh said, four-five years back, we had just one Startup in the Space sector, today we have 190 private Space Startups after opening up of the sector and the earlier ones of them have even turned entrepreneurs. There has been an investment of over Rs.1,000 crore by private Space Startups in the current financial year from April to December 2023, he said.

"So, there's huge pooling of both the financial resources as well as the knowledge resources happening. And that is what has now placed India as the frontline nation... I think these three successive success stories. which I would say is a trilogy of ISRO's success, are the first of their kind in one way or the other," he said.

Dr Jitendra Singh said, when Prime Minister Modi talks of Amritkaal and India's ascent to that pedestal, that ascent has already begun via Space technology.

ancestral profession especially after the government started taking measures to check manufacturing of machine-made copper utensils in the vallev.

"Designing copperware is my ancestral profession. I was hopeful that the government will take some measures to promote the art. I am now thinking of starting my work of making and designing copperware again," he told the news agency—Kashmir News Observer (KNO).

Taking strict measures against machine made copper, the Director of Handicrafts and Handloom (H&H) Kashmir has been appointed by the Government of Jammu and Kashmir as the person in charge of implementing the J&K Prohibition of Manufacture of Specified Copper Utensils (by machine) Act.

The step is aimed to combat the introduction of machines in crafting copper utensils which has resulted in marginalization of traditional artisans, and has allowed individuals without specific copper working skills to enter the industry, adversely affecting traditional craftsmen.

"This move has given us hope for the future of our craft. We have seen a decline in demand for our handmade products, but

with the ban on machine-made copperware, we believe our unique craftsmanship will be valued once again," said Nazir Ahmad Wani, a coppersmith, who has been associated with the art for over 40 years.

Pertinently the handicrafts department has recently included copperware, along with 20 other crafts, in the category of 'Notified Crafts' to support local artisans. This inclusion facilitated the registration of copperware artisans, granting them access to various government support programs. Director of Handicrafts and Hand-

loom Kashmir Mahmood Ahmad Shah said the identification of deceptive artisans and manufacturers of copperware by the Quality Control Division will be given top priority.

He urged the public to purchase copper items labelled with QR codes, as this supports authentic artisans.

outfit on December 27, 2023 under the Unlawful Activities (Prevention) Act, 1967 and the Tehreek-e-Hurriyat, Jammu and Kashmir (TeH) was banned on December 31, 2023 under the same law.

"Now, therefore, in exercise of the powers conferred by section 42 of the Unlawful Activities (Prevention) Act, 1967, the central government hereby directs that all powers exercisable by it under section 7 and section 8 of the said Act shall be exercised also by the state governments and the Union Territory administration in relation to the above said unlawful association," the notification read.

The Section 7 of the UAPA is related to power to prohibit the use of funds of an unlawful association and the Section 8 is related to power to notify places used for the purpose of an unlawful association.

While declaring the TeH outlawed for five years, the home ministry had said it was fomenting terrorism and spreading anti-India propaganda in the Union Territory

The objective of the TeH is to separate Jammu and Kashmir from India and establish Islamic rule in Jammu and Kashmir, it said.

The group was founded by Geelani, who was succeeded by Masarat Alam Bhat. Bhat is also known for his anti-India and pro-Pakistan propaganda. Bhat is currently in jail.

Bhat's outfit Muslim League Jammu Kashmir, which he heads, was also declared a banned organisation by the government for its involvement in anti-national and secessionist activities in Jammu and Kashmir.

The home ministry had said the outfit and its members are involved in antinational activities in Jammu and Kashmir, supporting terrorist activities. (Agencies)

SRINAGARJAN 11: In connection with celebrations of forthcoming Republic-Day-2024, a meeting was held under the Chairmanship of Deputy Commissioner(DC), Srinagar, Dr. Bilal Mohi-Ud Din Bhat here today at Meeting Hall of DC Office Complex to ensure smooth and flawless conduct of the national

Senior Superintendent of Police (SSP) Srinagar, Ashish Mishra was also present in the meeting.

At the outset, the Deputy Commissioner took a Department wise review about the arrangements to be put in place by the respective Departments.

## Locals say filtration plant awaits completion


**GANDERBAL, JAN 11:** People in Bonizil and other areas in Ganderbal district have complained about lack of drinking water due to non-completion of work at the filtration plant.

The work on the filtration plant was started some four years ago at the cost of Rs 5 crore and was stopped a few months ago due to unknown reasons, the locals told news agency—Kashmir News Observer (KNO).

They said that to overcome the severe shortage of water in

several areas, it was planned to bring water supply for this filtration plant from the upper region of Chattergul.

"An underground water pipe was laid from the Chattergul area to Bonizal, while other buildings including water reservoirs were also constructed. However, after spending more than 4 crore rupees, the construction work on the filtration plant was suddenly stopped a few months ago, and nobody knows the reason," the



Since then, the people living in Bonizal, Mochan, Haripora, Reshipora, and other adjoining areas have been suffering a lot due to an acute shortage of potable drinking water.

An official Told KNO "there were some technical problems in the filtration plant due to which the work was stopped."

'The problem is being gradually resolved. It will take some time and the work on Bonizal Filtration Plant will be started

## **Sopore Fruit Mandi president announces** Rs 50,000 cash reward for information on spurious fertilizers

**SOPORE, JAN 11:** President, Sopore Fruit Mandi – Asia's second-largest fruit market - has announced a cash reward of Rs 50,000 for those providing crucial information about the sale of counterfeit fertilizers in the market. This comes in the wake of growing concerns about the rise of spurious fertilizers affecting crop yields in the valley.

Speaking with the news agency—Kashmir News Observer (KNO), Fayaz Ahmed Malik, also known as Kaka Ji, expressed dismay at unscrupulous dealers compromising the integrity of the agriculture industry by selling fake fertilizers. "Farmers are the backbone of our community and it is our collective responsibility to safeguard their interests," he said.

 $Malik said the {\it cash} \, reward \, initiative \, aims$ to encourage locals to come forward with information that can assist authorities in identifying and curbing the circulation of duplicate fertilizers.

Expressing deep concern for the welfare of farmers and the agriculture industry, he said such actions not only jeopardize the

livelihoods of hardworking farmers but also pose a threat to the overall economic stabil-

"The generous cash reward is intended to motivate individuals to play an active role in maintaining the integrity of agricultural practices in the region. People are encouraged to provide details about suppliers or dealers suspected of dealing in duplicate or spurious fertilizers. Confidentiality will be maintained to ensure the safety of those reporting," Fayaz added.

Calling for immediate and decisive action, including the implementation of the Public Safety Act (PSA) against those found guilty of distributing counterfeit fertilizers, Malik reiterated his commitment to eradicating this issue.

The Department of Agriculture, Kashmir, recently seized around 620 bags of duplicate spurious fertilizers in Sopore and Kulgam districts during raids. The director warned of stringent action against those selling counterfeit fertilizers in the valley and urged people to report any such activities.

## **Committees constituted to probe pregnant** woman's death at SDH Banihal, non-availability of medicines at DH Ramban

**SRINAGAR, JAN 11:** The Jammu and Kashmir government on Thursday established two distinct committees to investigate allegations of negligence which resulted in the death of a pregnant woman at Sub DistrictHospital(SDH)Banihal and complaints of inadequate medicine supplies at the District Hospital Ramban. According to an official order accessed by the news agency-Kashmir News Observer (KNO), the inquiry into alleged medical negligence will be led by the District Programme Officer, Poshan Ramban. The investigation into reports of medicine unavailability at DH Ramban will be spearheaded by the Assistant Commissioner Revenue (ACR) Ramban.

The order stated, "Sanction is hereby accorded to the constitution of a committeeto conduct an in-depth inquiry into the death of a lady, namely Afroza Begum, Wife of Zakir Hussain, Resident of Neel, due to the alleged negligence of Doctors and Hospital StaffatSubDistrictHospital(SDH)Banihal."

The committee, chaired by Jahangir Hashmi, JKAS District Programme Officer, Ramban Poshan, will include Zaheer Abass Bhat, JKAS Sub Divisional Magistrate, Banihal, Dr Kamal Jee Zadoo, Chief Medical Officer, Ramban, Nasir Javeed, Tehsildar, Pogal Paristan, and Dr G L Manhas as its members. The committee has been mandated to submit a comprehensive report along with recommendations within four days of its formation. The move follows the circulation of a viral video on social media in which an individual claimed that his wife experienced pain while travelling from Srinagar to Jammu and was admitted to the District Hospital Ramban. The complainantalleged that he had to procure medicines outside the hospital due to the unavailability of drugs within the facility.

Aseparate committee has been instituted to investigate these claims, as per the order. Giasul Haq, JKAS Assistant Commissioner, Revenue, Ramban, will serve as the committee's Chairman, with Dr Kamal Jee Zadoo, ChiefMedical Officer, Ramban, Deepak Kumar, District Treasury Officer, Ramban, and Dr Varinder Trisal, MSDHRamban, as members.

The DMO informed that while seizing the vehicles including JCBs, measurement of excavated area was recorded on the spot by officials of department and the penalty was imposed on the perpetrators as per extant rules and regulations. It was

also found that the machinery was illegally deployed by a contractor for extracting material from a location in the Bhini River which is almost three km away from a sanctioned minor mineral block only to evade the royalty.Strictinstructions were issued to the contractor and other construction agencies for transporting minor minerals only from allotted sites and not to indulge in illegal mining which results in heavy loss to the natural resources and government exchequer.DeputyCommissioner Kathua, Rakesh Minhas has already directed the mining department to keep regular check on the mining activities and initiate stern action against those involved in illegal mining business. # Voice Of Voiceless Rehbai Khail Teachers

A country that aspires to be a fully developed nation, global power and the strongest economy by 2047 cannot exploit its youth by giving a salary of 100 /day. Yes, I am talking about the scheme in vogue, namely the REK scheme. The biggest tragedy is that PHD NET SET & JRF qualifiers have been engaged under this scheme. These prestigious national level exams make one eligible to teach at university level but here the fate is reversed. Isn't it a

Keeping in view the growing career options in the field of sports and the momentum the sports field was gaining, a new hope rejuvenated and thousands of students from Jammu and Kashmir switched to higher studies in the physical education subject during the last one decade. But in reality only hopelessness is reigning and the colossal statements about the sports culture look contrast to the tall claims about the sports ecosystem of the country. The sports teachers, who encourage, trains and teach the students in hundreds of institutions across the country are hopeless about their future.

Observing that the unemployed youth with the degrees in physical education are mounting in alarming numbers. The then Govt in the year 2018, decided to absorb these degree holders in youth services and **Voiced Consonants Voiceless Consonants** ng

sports department. A scheme namely Rehbari-Khail was introduced, and consequently almost three thousand degree holders were engaged across the length and breadth of Jammu and Kashmir. Most of the engaged candidates are postgraduates, and there are a considerable number of NET, SET, M.Phl and PhD pass out as well . I being a PHD with JRF, NET, SET feel dejected and disappointed choosing it as as a career option because the terms and conditions laid down in the scheme are two harsh, cruel, inhuman and unjust. According to the scheme, a Rehbari-Khail teacher is given a stipend of rupees three

thousand per month that too for seven long years.

What could be more bizarre and cruel than this! Besides adding insult to injury, there is no service inclusion of these seven years for these unfortunate and unprivileged teachers. It is more like forced labour than a profession. We have been knocking different corridors of power since 5 year so as to get the scheme modified. From protests to meetings, we did everything in a democratic manner but in response we got assurances from the higher authorities only. Our applications are biting dust in the official shelves of the secretariat.

Very recently, some Rehbari-Khail teachers with extraordinary sports achievements staged a unique way of protest in Jammu. These teachers put their national and international medallions and certificates on sale. It was an attempt to mock and ridicule the official insensitivity towards the teachers who have glorious sports and academic backgrounds to their credit. When a labourer, a carpenter or a mason is paid rupees seven to eight hundred a day, isn't it shocking that an REk teacher is being paid only one hundred rupees a day. Is it possible to manage our

families on this amount with old parents at home.

We don't have money to buy even life saving medicines for them. Majority of the teachers are married and facing depression. They are hardly able to meet their personal demands and their families are craving for pennies because of this official apathy and discrimination.

The well-being of every individual in the state is the moral responsibility of a government, but if the government is exploiting its workforce, then who will come to their rescue? Handsome salary is a great motivation for a person to give his/her best.

The Rehbari-Khail teachers are dejected and sad. . People at the helm of affairs should take a Humanitarian look at the matter, and the Rehbari-Khail scheme must be modified to benefit thousands of poor Rehbari-Khail teachers. The monthly stipend should be increased to a handsome level which would uphold labour laws of our erstwhile state and the country. The quantum of our unrecognized service should either be changed or at least reduced to two years.

We deserve compassion and mercy. The recent cabinet decision to cancel the SRO 202 have sent waves of optimism among the physical education teachers and their families. It has rather paved the way for the resolution of their genuine demands. When the government has delivered justice to SRO 202 appointees, why can't it resolve the issue of these poor teachers? The way developmental works are prioritised and getting a new impetus under the present regime, we hope that the Lieutenant Governor will listen to our plight and announce some relief for this unfortunate lot.

# WHAT HAPPENED IN 2023? A TIMELINE OF KEY EVENTS IN INDIA

India had a lot to celebrate this year - a new Parliament, two successful space missions and an effective rescue mission to drill out people stuck inside a collapsed tunnel. But the ethnic violence in the Northeast that led to hundreds of people losing their lives, multiple natural disasters and accidents killing scores and reputed women wrestlers of the country fighting against sexual harassment also dominated the headlines this year.

Here, we look at some of the key stories that shaped the country this year:

#### **January**

2023 kicked off on a rocky start as the country was hit by several Indian wrestlers levelling allegations of sexual misconduct against BJP MP and Wrestling Federation of India chief Brij Bhushan Sharan Singh. Led by Vinesh Phogat, Sakshi Malik, and Bajrang Punia, several wrestlers staged a dharna at Jantar Mantar in New Delhi, demanding that WFI be disbanded, its president be sacked, and a probe be conducted into the matter.

### **February**

Delhi's Deputy Chief Minister Manish Sisodia was arrested after around eight hours of interrogation by the Central Bureau of Investigation (CBI) regarding the alleged irregularities in the nowscrapped Delhi excise policy. The chain of events culminating in Sisodia's arrest by the CBI began in July 2022, when Delhi Chief Secretary Naresh Kumar submitted areport to Lt Governor Vinai Kumar Saxena, accusing Sisodia of providing undue benefits to liquor vend licensees in lieu of "kickbacks" and "commissions", which were allegedly used by the Aam Aadmi Party (AAP) in the Punjab Assembly elections in February that year.

Elections in the Northeast and senior Congress leader Rahul Gandhi's disqualification from the Lok Sabha is what grabbed the headlines throughout March.

The BJP emphatically won the Tripura Assembly elections and returned to power in Meghalaya and Nagaland as a junior partner in ruling coalitions. The party overcame a Left-Congress alliance and the TIPRA Motha, which had emerged as a force to reckon with in tribal seats, to bag 32 seats in Tripura, one more than the majority mark. It retained power in Nagaland along with senior alliance partner Nationalist Democratic Progressive Party. In Meghalaya,

the National People's Party emerged as the single-largest party. The NPP and the BJP ruled the state together for five years but contested the elections separately. However, they decided to tie up again to form the government in the state.

Later in the month, the Congress party was dealt a severe setback as Rahul Gandhi was disqualified from the Lok Sabha, a day after he was convicted in a defamation case by a Surat court. A notice issued by the Lok Sabha Secretariat said he stood disqualified from the House from March 23, the day of his conviction.

### **April**

**Srinagar, Friday** 

India officially surpassed China to become the most populous country in the world, estimating to touch 142.86 crore by the middle of this year, marginally ahead of China at 142.57 crore. According to projections by the United Nations, India's population is expected to grow for the next three decades after which it will begin declining.

In April, the country also saw the encounter of a gangster-turned-politician in Uttar Pradesh and the arrest of a Khalistani separatist. While Atiq Ahmed and his brother Ashraf were shot dead in the presence of police personnel and media persons on April 15 in Prayagraj, Uttar Pradesh, a few days later, radical Sikh self-styled preacher and Waris Punjab De chief Amritpal Singh was arrested by the Punjab police from the Moga district after a month-long chase.

The month started off with violent clashes breaking out at various places in Manipur during the course of a 'Tribal Solidarity March' called on May 3 by the All Tribal Students' Union. The development reopened an old ethnic faultline in the state between the plain-dwelling Meitei

community and the hill tribes. However, later in the month, India got a new Parliament building, 'embodying the culture, pride and spirit of the entire nation'. Prime Minister Narendra Modi's speech, the centre-piece and concluding note of the inauguration of the new Parliament building on May 28, sought to place this moment in a longer and wider national imagination. Built at an estimated cost of Rs 971 crore, sitting adjacent to the existing Parliament House, the building can accommodate 888 parliamentarians in the Lok Sabha and 300 in the Rajya Sabha,

up from the existing 543 and 250, respectively. June

## Over 280 people killed, more than 850 injured - India was mourning after a horrific collision involving the Chennaibound Coromandel Express, the SMVT

Bengaluru-Howrah Express and a goods train took place near Bahanaga Bazar station on June 2. The Coromandel, instead of going past the goods train on the main line, entered the loop and smashed into the goods train from the rear. Pictures from the spot show the Coromandel's locomotive perched atop the goods train.

Tragedy continued into the next month for India as a video showing two women from the Kuki-Zomi community being paraded naked by a mob of men and being sexually assaulted began doing the rounds, bringing to light an incident which took place in Manipur more than two months ago, when violence first started. Barely two days before a police complaint was filed in connection with incident, another zero FIR in another case was registered at the same police station — in connection with the alleged abduction, rape and murder of two Kuki-Zomi women.

Added to this was Himachal Pradesh enduring a tumultuous period battling extreme weather situations leading to devastating landslides, widespread damage and collapse of several buildings. Three spells of excessive rain wreaked havoc in Himachal. Extreme events such as flash floods, cloudbursts, landslides, subsidence, and sinking of land devastated lives and property especially in Mandi, Kullu, Manali, Shimla and in some parts of Kangra. According to the government's assessment, the state suffered a loss of Rs 12,000 crore.

However, a silver lining to the tumultuous month was the launch of India's moon mission — Chandrayaan-3 — on July 14.

### August

India was celebrating this month as its Moon mission Chandrayaan-3 scripted history by successfully landing on the lunar surface on August 23. With the Lander accomplishing a 'soft landing' on the Moon's south pole, India became the only country to have ever done so.

On the political front, the Congress breathed a sigh of relief as their senior leader Rahul Gandhi returned to Parliament after the Supreme Court stayed his conviction in a 2019 criminal defamation

case over his remarks on the 'Modi' surname. The Lok Sabha Secretariat notified the restoration of Rahul's membership, about four months after it was revoked.

#### September

This month was all about the G20 Summit in New Delhi as leaders from the most powerful nations in the world flocked to the capital. The culmination of India's year-long presidency of the G20, the summit concluded with the adoption of a G20 Leaders' Declaration. India's presidency came at a time when the world was undergoing a geo-political churn. The Russia-Ukraine war had impacted the global economy after two years of the Covid-19 pandemic. The economic shock of these twin events had a deep impact on developing and under-developed countries – the war came at a time when these countries were just trying to get back on their feet with the post-pandemic economic recovery.

It had been nearly five months since the first clashes broke out in Manipur during a tribal solidarity march but the situation continued to remain tense. Intermittent violence — emerging from an ethnic conflict between Meitei and Kuki communities - has continued to keep the state on the boil, claiming over 175 lives and injuring more than 1,000.

### October

Over 70 people were killed, including Army personnel, in Sikkim after the South Lhonak Lake — a glacial lake situated in the state's northwest at 17,000 ft – burst due to incessant rains, leading to the release of water in downstream areas. This caused the rise of water levels in Teesta river that flooded at least four districts, including Mangan, Gangtok, Pakyong and Namchi on October 4.

Later in the month, the Supreme Court unanimously declined to recognise samesex marriages, saying it can only be done by the legislature and that any attempt by the court to do so would amount to encroaching upon the field set for the legislature. The month also saw a series of blasts at a Sunday prayer convention of the Christian denomination Jehovah's Witnesses near Kochi in Kerala. At least 7 people died and over 30 were injured.

The election fever returned to the country as Madhya Pradesh, Rajasthan, Chhattisgarh, Telangana and Mizoram went to the polls this month. From highoctane campaigning to poll promises, parties went all out to set the tone ahead of the big 2024 Lok Sabha polls.

1.4 billion people across the country suffered a heartbreak this month as India fell short of winning the ODI World Cup after a terrific campaign. For 40 nights since their first win against Australia in Chennai, India strode like the invincibles, but would stumble on the 41st night to a tame defeat.

The highlight this month, however, was the mammoth rescue operation to drill out 41 workers who were trapped following a tunnel collapse in Uttarakhand. A collective sigh of relief coursed across a nation after rescuers reached the 41 workers trapped, capping an operation that lasted over 400 hours. It was a test of resolve, grit and perseverance – for those on both sides of the 57 metres of debris – as the rescue operation suffered one setback after another. In the final lap over the weekend, the drilling machine gave way, and, in the end, it was 14 "rathole miners" who dug through the last 12 metres and reached the trapped men.

#### **December**

The month kicked off with Madhva Pradesh, Rajasthan, Chhattisgarh, Telangana and Mizoram getting new governments as the results of the Assembly polls were announced on December 3 and 4. With its landslide win in Madhya Pradesh, and having overturned Congress governments in Rajasthan and Chhattisgarh, the BJP-led National Democratic Alliance is now in power in 17 states and Union Territories.

For the Congress, after a disappointing counting day, its win in Telangana was just a consolation prize. The Congress's strong performance, with 64 seats and 39.4% of the vote share, however, solidifies its presence in the South.

On the 22nd anniversary of the Parliament attacks, in a major security breach, two men jumped into the Lok Sabha chamber from the visitors' gallery on December 13, raised slogans and opened canisters that emitted yellow smoke, triggering panic among those present and raising questions of what if. The two men held in Lok Sabha were seated in the visitors' gallery and took out canisters from their shoes. Television footage showed them jumping from desk to desk, and they appeared to be headed towards the Well of the House.

# **2024 WILL WITNESS MASSIVE SPACE LAUNCH** PROGRAMMES BY INDIA, CHINA AND JAPAN

Japan Is Following India's Chandrayaan-3 Success Soon Through Its Landing On Moon

In 2024, the global space launch landscape is expected to see increased activity from both public and private sectors in countries like China, India, and Japan, following a year dominated by SpaceX.

Chinese startup Land Space Technology is set to introduce reusable rockets by 2025, following a strategy similar to SpaceX. Meanwhile, India is preparing for a sequence of flight tests leading to a manned space mission, also targeted

Japan is striving to become the fifth country to successfully land a spacecraft on the Moon this month. This follows India's achievement with Chandrayaan-3, which landed on the lunar surface on August 23, 2023. India has reportedly returned the propulsion module used for Chandrayaan-3 to Earth's orbit, potentially setting the stage for a future mission to bring back lunar samples.

Japan's involvement in space exploration dates back to 1970 when it became the fourth nation to launch a satellite into orbit, following the Soviet Union, the United States, and France. In recent times, China and India have emerged as significant players in space exploration. China announced its goal to send astronauts to the Moon by 2030. Meanwhile, India has ambitious plans for establishing a space station by 2035 and aims to send its first astronaut to the Moon by 2040.

Shogo Yakame, a business consultant at Nomura Research Institute, expressed to the Financial Times his belief that India is likely to become a more formidable competitor in space to Japan than China. He pointed out the dynamic nature of India's commercial space sector as the basis for his opinion.

Japan is set to demonstrate its advanced space technology with a groundbreaking lunar mission scheduled for January 20. The mission involves the Smart Lander for Investigating the Moon (SLIM), which aims to achieve the world's first "pinpoint" lunar landing. SLIM is expected to land within 100 meters of a designated target, located near the Shioli Crater by the Sea of Nectar, just south of the Moon's equator.

To achieve a precise lunar landing, Japan's SLIM spacecraft employs a combination of a radar altimeter and a vision-based navigation system. This system identifies crater patterns and compares them with existing map data in real-time, aiding in obstacle avoidance and locating a smooth landing area. The 2.4-meter lander is uniquely designed to fall onto its side if it lands on a slope, a feature intended to stabilize its position upon touchdown.

The precision landing ability of Japan's SLIM and the surface data it gathers will play a crucial role in future lunar missions. This includes a collaborative mission between India and Japan in 2025, aimed at exploring water resources in the Moon's polar regions. Additionally, Toyota Motor and Mitsubishi Heavy Industries are developing a pressurized rover for astronaut use on the lunar surface. The development of this rover is set to begin in 2024, with a planned launch in 2029.

The escalating rivalry in the space sector is underscored by SpaceX's impressive achievement of launching nearly 100 rockets in 2023, propelling commercial space endeavours to unprecedented levels. On November 2, CEO Elon Musk announced on platform X that Starlink, the company's satellite phone service, had reached cash flow break-even. This service, relying on a network of over 5,500 satellites, offers global broadband connectivity. It garnered widespread attention for its role in assisting Ukrainian forces during the conflict with Russia.

Yakame remarked on the onceunthinkable feasibility of a service like Starlink, highlighting the immense challenges and costs associated with constructing, launching, operating, and maintaining a large number of satellites, as well as the complexity of establishing connections with rapidly orbiting satellites in low Earth orbit. He mentioned the attempt by Iridium, a company based in the United States, to offer a comparable service in the 1990s, which ultimately did not succeed.

Space activities have evolved through various phases, beginning with the creation of launch vehicles, followed by the deployment and use of satellites, and then the exploitation of space environments, for instance in space stations. Seiji Izumisawa, CEO of Mitsubishi Heavy, conveyed to the Financial Times , that the forthcoming phase would be centred on commercialization.

On February 15, Japan is set to launch the H3, its next-generation rocket, aspiring to rival SpaceX's Falcon 9. This launch comes after an initial attempt on March 7 was unsuccessful due to an electronics problem. Mitsubishi Heavy, the company behind the H3, aims for the rocket to be competitive with the Falcon 9 in cost, even if not in launch frequency, and plans to achieve up to six launches annually.

Since Russia's Soyuz rocket became unavailable due to the country's invasion of Ukraine, businesses seeking satellite launches have increasingly turned to SpaceX as their preferred provider.

In 2023, the United States led in space launches with a total of 103, while China followed with 61, and Russia with 18, as per Space-Track.org data, a satellite data platform run by the US Department of Defense. Atsushi Murakami, president of Satellite Business Network, a consultancy firm, noted that the United States and China are prevailing forces in the space sector and are further extending their lead, raising the question of whether Japan can make a significant entry into this competitive arena.

Japan, in contrast to countries like the US, India, or China, lacks the financial capacity to independently execute largescale space missions. Therefore, its primary strategy is to focus on technology development and become a crucial partner

in the space sector. In the realm of space launches, a key emphasis is on reusability, a concept spearheaded by SpaceX. The company achieved a milestone by successfully landing a rocket booster post-launch in 2015, and later, in 2017, it launched a reused booster. Currently, SpaceX is working on the large-scale Starship cruise ship, which is intended for human missions to the Moon and Mars. The Starship is designed to be refuelled and relaunched after returning from space.

SpaceX continues to be the sole commercial company with reusable rockets in operation. However, China's LandSpace, which successfully completed its initial satellite launch in December, has announced plans to launch a reusable rocket by 2025.

LandSpace's rocket, similar to SpaceX's Starship, will utilize methane as its fuel source. This choice is gaining interest due to the possibility of producing methane-based fuel on Mars using local resources like carbon dioxide and water from ice, which could make return missions from Mars more practical. Additionally, the Japan Aerospace Exploration Agency and Mitsubishi Heavy are working on a methane-powered rocket, aiming for a potential launch around 2030. (IPA Service)

# **Heart-Related Deaths Involving Substance** Use, Especially Alcohol, on the Rise

lardiovascular disease deaths involving substance use increased from 1999 to 2019, even as overall cardiovascular disease deaths fell during that time.

Alcohol was involved in 65% of cardiovascular disease deaths related to substance use, but death rates for cannabis and psychostimulants increased more

Women, American Indian and Alaskan adults, younger adults, and rural residents also saw larger increases in cardiovascular disease deaths related to substance use.

Deaths due to cardiovascular disease that involved substance use increased an average of 4% per year from 1999 to 2019, even as overall cardiovascular disease deaths decreasedTrusted Source during that time, a new study shows.

"The results are concerning, as they mark a significant upward trend in cardiovascular deaths where substance abuse was noted," said Dr. Sameer Amin, cardiologist and chief medical officer at L.A. Care Health Plan, who was not involved with the new research.

"Considering this is in the midst of an overall decrease in cardiovascular death during that time period, this appears to be an exception to our progress in treating cardiac disease," he told Healthline.

Dr. Cheng-Han Chen, interventional cardiologist and medical director of the Structural Heart Program at Memorial Care Saddleback Medical Center in Laguna Hills, Calif., pointed out that the data in the study only goes through 2019, just before the start of the COVID-19 pandemic.

'There have been data pointing out that substance use and abuse have worsened starting in 2020 with the pandemic," said Chen, who was not involved in the new study. So "it's concerning to think that this



trend may be getting worse in more recent

vears." The study was published Jan. 10 in the Journal of the American Heart AssociationTrusted Source.

Many substances linked to cardiovascular disease

In the study, researchers used publicly available data from the Centers for Disease Control and Prevention's Wide-Ranging Online Data for Epidemiologic Research (WONDER) database to examine cardiovascular disease death trends from 1999

The rate of cardiovascular deaths related to substance use increased from 9.9 per 100,000 population in 1999 to 21.4 per 100,000 population in 2019, researchers found – an average increase of 4% per year.  $From 2012 to 2019, the death \, rate \, increased$ even more rapidly: 6.2%.

In comparison, the overall rate of cardiovascular disease deaths decreased Trusted Source an average of 1.5% per year, researchers found.

Several substances, such as alcohol, opioids, stimulants, sedatives and cannabis increase the risk of cardiovascular disease, including coronary heart disease, heart failure and irregular heart rhythms, the researchers point out.

Overall, 65% of the cardiovascular disease deaths related to substance use were linked to alcohol, followed by opioids (13.7%), cocaine (9.8%), stimulants (6.5%), sedatives (4.1%) and cannabis (0.5%).

However, people who used cannabis (12.7%) and psychostimulants such as amphetamines (16.8%) had higher increases in the average annual percent change in cardiovascular disease deaths related

"It's troubling to see that there have been increases in cardiovascular disease mortality with all different types of substances, not only the most commonly used substance, alcohol," Chen told Healthline.

The study did not include smoking/ tobacco use as a form of substance use. Smoking is linkedTrusted Source to heart disease, stroke and other chronic diseases, as well as lung and other cancers.

While the findings highlight long-term trends in cardiovascular disease deaths related to substance use, researchers did not have information about other risk factors for cardiovascular disease, such as a condition such as type 2 diabetes or high blood pressure or whether people had a family history of cardiovascular disease.

Who is most impacted by cardiac deaths The new study's findings show that certain groups were impacted more by cardiovascular disease deaths related to substance use.

For example, increases in the average annual percent change for death rates were higher for American Indian or Alaskan individuals (5.4%); people ages 25 to 59 years (5.3%); people living in rural areas (5.0%); adults ages 55 to 69 years (4.9%); and women (4.8%).

"I am particularly concerned at the disparities in outcomes for women, American Indian/Alaskan individuals and rural area residents," said Amin. This "could represent healthcare inequities in our system."

The death rate was higher for people living in rural areas (15.2 per 100,000) than urban areas (14.1 per 100,000). It was also higher for men (22.5 per 100,000) than women (6.8 per 100,000).

Although death rates were higher in men than in women, women saw larger increases during the study period, researchers

## **New Vaccine May Help Stop Recurrence** of Certain Pancreatic, Colorectal Cancers

esearchers are investigating a potential vaccine that could help prevent certain cancers from returning.

The vaccine, labeled the ELI-002 vaccine, appeared to reduce the risk of relapse in some people with pancreatic and colorectal can-

All of the patients had a specific tumor mutation called mKRAS mutation, which is one of the more common gene mutations linked to cancer.

Scientists have developed a vaccine that could potentially help prevent some types of pancreatic and colorectal cancers from recurring.

The shot was put to the test in a Phase I trial led by researchers at The University of Texas MD Anderson Cancer Center.

The vaccine, labeled the ELI-002 vaccine, appeared to reduce the risk of relapse in people with pancreatic and colorectal cancers who'd previously had surgery and chemotherapy, according to the study-Trusted Source, which pub-



lished Tuesday in Nature Medicine.

People who've undergone surgery for pancreatic and colorectal cancer

have a high risk of relapsing.

Having an effective vaccine that can attack any remaining cancer cells in the body could lower the risk of relapse and, ultimately, boost chances of survival.

"These findings are very exciting because this is one of the first studies to show that a vaccine may reduce the chance of a very aggressive cancer (pancreas) from returning," said Dr. Anton Bilchik, MD, PhD, a surgical oncologist and chief of medicine and director of

the Gastrointestinal and Hepatobiliary Program at Saint John's Cancer Institute in Santa Monica, CA. Bilchik was not involved

in the study. The vaccine triggered a strong anti-cancer immune response

The trial recruited 25 individuals with pancreatic or colorectal cancer who had previously had surgery, chemotherapy, and, in some cases, another procedure like radiation

therapy. All of the patients had a m K R A S tumor mutation,Trusted Source which is one of the more common gene mutations linked to cancer.

The patients received a maximum of 10 doses of the vaccine, which is specifically designed to target KRAS mutations, at various

The researchers investigated how people's immune system's produced T cell responses after receiving the vaccine.

"T cells are an essential component of the immune system that have a profound impact on how cells function and also build a defense against diseases like cancer from occurring or relapsing," Bilchik explained.

The team found that 84% of all patients developed a Tcell response and 100% of patients who received the two highest vaccine doses developed a T cell response.

T cell responses were linked to reductions in tumor biomarkers and clearance of ctDNA, which is a type of DNA that comes from cancerous cells and

In addition, the T cell responses produced by the vaccine were associated with an 86% reduced risk of relapse or death.
