



"The condition of Jammu and Kashmir has changed a lot in the past four years. The New Industrial Scheme which the government of India has made for investment in J&K, so I would like to say that today the highest incentive is being generated from here (because of this scheme). Poverty is also less in J&K," Sinha said.

Ever since the abrogation of Article 370 from Jammu and Kashmir, the central government has been looking at bringing in big-ticket investments in the region which has seen decades-long militancy.

Coming back to Amit Shah, he contended that the Vibrant Gujarat model has been replicated and accepted by

various States across the country. "Many states have followed Gujarat's industrial model," Shah said.

"India has become the best place to invest at a global level. And in India, the best destination to invest is our Gujarat," he said. "Gujarat is the gateway to Viksit Bharat (a developed India by 2047). It is our duty to keep the trust intact."

Speaking of Gujarat, he made particular mention of Gift City and Dholera Smart City, which have emerged as the two prominent growth engines of the state's industrialisation over the two decades.

"The way Modi ji has made Gujarat a policy-driven state, and Bhupendra bhai has taken it forward, I believe investors from across the globe will like to invest in

Police are meant for public service and it will not run away from its responsibilities. He said that J&K Police have taken a gigantic step of listening to people's grievances and and resolve them for their welfare and well-being.

"We have started to listen people's grievances. Many sittings have been conducted both in Jammu and Kashmir regions. People throng such durbars with hope that their issues will get resolved, and we too are committed to provide them respite," the DGP said.

He appealed to visitors to come up with those grievances linked to police department only. "On many occasion we have seen visitors put forth those issues which do not belong to the police. I request my people to come up with those issues only which belong to police only," DGP said.

### Feeble WD.....

generally cloudy in Jammu and Kashmir with the possibility of light snow over isolated higher reaches.

Due to prolonged dry spells, the maximum temperature at many stations recorded 6 to 8°C above normal with the highest maximum temperature recorded over Banihal station (23.4°C) on January 11. The previous all-time record was 22.6°C on

January 18, 2003, the MeT office said. It said contrary to this, the places engulfed with dense fog recorded 9 to 10°C below normal. Jammu, Samba and Kathua Friday recorded 8.6, 8.8 and 8.9 °C maximum temperature on January 11.

Years with prolonged dry spells also showed similar trends of maximum temperature in the past. (2018, 2016, 2015)

The dry weather is likely to continue till January 20 with feeble WDs approaching on January 12 & 17 evening.

The weather will remain generally dry from January 18-20, It said.

An independent observer, Kashmir weather said as a result of weak Western Disturbance, light snowfall is possible at Sonamarg, other higher reaches of Ganderbal district, Drass 40% chance, Gurez, higher reaches of Kupwara and Bandipora, Pahalgam, Kargil 25 - 30% chance towards late night today or tomorrow morning. There are 15-20% chances of snowfall at Gulmarg and other higher reaches of Anantnag, Leh 15 - 20% chance during the

period, he said. There is no letup in freezing cold weather conditions in Kashmir valley as Srinagar recorded a low of -4.0°C on Friday against the -5.0°C on Thursday. It was 1.9°C below normal for the summer capital of

Jammu and Kashmir during this period of

There was a slight improvement in night temperature at Pahalgam, recording a low of-5.3°C against the -6.0°C recorded the previous night. It was 1.8°C above normal for the tourist spot of south Kashmir.

Qazigund on Srinagar-Jammu National highway had a low of -4.2°C against the -4.6°C recorded a day ago while mercury at Kokernag settled at -2.4°C for the third consecutive day on Friday.

Gulmarg showed further improvement in minimum temperature on Friday and recorded at -3.2°C against the -3.5°C recorded on Thursday. It was 4.74°C above normal for the famous ski resort of north

Kupwara recorded a low of -4.4°C against the -5.3°C recorded the previous day. It was 1.5°C below normal for the frontier Kashmir district during this period of the season, the MeT office said. (UNI)

In the wake of the continued dry spell in Kashmir Valley, Muttahida Majlis-e-Ulema (MMU) Jammu and Kashmir, a conglomerate of religious bodies in Kashmir representing different schools of thought, had appealed to mosque Imams to offer "Namaz-e-Istisqa" after Friday prayers.

The special prayers for the rain and snowfall were held on Friday in the historic Jamia mosque in Srinagar and other parts of Kashmir.

The managing body of Jamia mosque, Anjuman Auqaf, has termed the droughtlike situation in the valley "extremely alarming," saying the lack of rain and snow in this season is a matter of concern not only for those associated with the agriculture sector but also for the common man.

It said there are even fears of the spreading of various diseases due to the drought, the Auqaf said in a statement.

"We must seek forgiveness from Allah for our sins and organise meetings of repentance so that the Almighty will save us from this difficult situation," they said.

At the time of such trials, we should turn to Allah, seek his help through supplications, and ask him to make us steadfast on the path of Islam so that he delivers us from this difficult time, as Augaf's statement said.

The Anjuman Auqaf has also urged the people to seek forgiveness collectively as well as individually for their sins before Allah.

Kashmir is witnessing a snowless winter even as Kashmir's harshest 40-day winter period, "Chilla-i-Kalan," that began on December 21, is almost halfway through.

Scientists say the dry winters would mean higher mass loss of glaciers in this hydrological year if the weather conditions did not improve and might impact hydropower generation, irrigation agriculture, and dependent sectors. (UNI)

# In Kashmir, PDD mulls to install smart meters in over 40,000 **Distribution Transformers**

Dept to replace nearly 9,000 DTs that have turned obsolete or are out-aged: Pr Sec PDD

Srinagar, Jan 12: In addition to consumer smart metering, Jammu and Kashmir Power Development Department (JKPDD) is mulling to install smart meters in over 40,000 Distribution Transformers (DTs) of Kashmir region

Speaking to the news agency—Kashmir News Observer (KNO), PDD Principal Secretary H Rajesh Prasad said, "JKPDD is all

set to replace nearly 9,000 DTs that have turned obsolete or are out-aged."

Prasad said: "Besides the department is going to install smart meters in all 40,000 plus DTs functioning in the Kashmir region so that we have a complete chain from feeder meter to DT meter to consumer meter.'

He said that the department aims to

measure the energy right from the source to make it more accountable.

In the meanwhile, the official documents in this regard accessed by KNO reads, "KPD-CL currently operates approximately 40,000 Distribution Transformers (DTs)."

"Additionally, there are proposed plans to add 9,000 DTs under the RDSS. Among these DTs, 10,000 are to have smart meters installed under the PMDP, while the remaining DTs covered under RDSS," it

It also states that the primary objective of implementing smart meters at the DT level is to enable accurate energy account-



ing and monitoring.

The Principal Secretary said, "The 10,000 DTs under PMDP have not been started yet because it is being covered under RDSS of which tendering has been done and installation have been initiated."

The diaspora has occasionally raised its voice for or against decisions of the Indian government, whether it be abrogation of article 370, the farmers' bill or the Citizenship Amendment Act. Indian origin members of parliament have flagged issues concerning India in their political forums as these impact families of their constituents in India.

Thus, whatever happens in India has global ramifications due to the presence of the Indian diaspora. All major Indian political parties have their connectivity with the diaspora hoping for their support in domestic politics. Some political parties have received funding from the diaspora based on their agenda.

The Indian diaspora, apart from projecting India's soft power, also influences Indian politics. A miniscule number of supporters of a utopian Khalistan, residents of different countries with religion as their sole link to India, remain a blot on the country's largely peaceful diaspora. Their demands for splitting the country, joining hands with Pakistan to incite violence, targeting Indian origin Hindus and their places of worship in their countries of residence, solely as vengeance, while funding anti-India activities has gone against the ethos of an otherwise soft powerexpanding diaspora.

They gain confidence when their country of residence turns a blind eye. There have been occasions when activities of these elements have raised diplomatic tensions between India and their nation of residence, but nothing can match the current Indo-Canadian spat. India has, whenever their activities cross a threshold, protested to the concerned country requesting them to curb these illegal activities. While their protests as also failed referendums have had almost no impact on India, it is the violence they generate against other Indians or the nation's diplomatic property which raises hackles in Delhi.

Since the movement for Khalistan poses no local threat, as compared to Islamic groups, the response of their home country is generally lukewarm. In response to Indian requests, countries enhance security for its diplomatic establishments, act against select perpetrators of violence but fail to curb ringleaders, nor are they willing to extradite them, despite India declaring them as terrorists and obtaining Interpol's Red notice.

Intelligence provided by India is either ignored or rejected as being insufficient as evidence. In some cases, the movement is even exploited as a means to gain leverage over India. This was evident when the Indian NSA, Ajit Doval, mentioned to his US counterpart, Jake Sullivan, that India has not acted against Sikhs for Justice leader, Gurpatwant Singh Pannun, because it is aware that he is a CIA agent. The Khalistan movement had been ongoing for some time with little to show, but gained global attention after Justin Trudeau accused India of having a hand in the killing of known terrorist Hardeep Singh Nijjar.

Since then, diplomats have been expelled and accusations exchanged between the two nations. India has stopped issuance of visas as the relationship slips downhill. A small group, with no legal sanctity, funded by an inimical Pakistan, has managed to mar the positive image of the Indian diaspora.

This could not have happened in isolation. Nations where such elements reside must understand that the diaspora has a lot to offer and by acting against a few troublemakers, they have much to gain from a growing and powerful India.

Whenever the PM travels abroad, one of his major events is an address to the diaspora.

Other global addresses with a similar electrifying atmosphere include the one at Wembley stadium in London with over 60,000 attending, Shanghai and Singapore. Many more watch the events telecast live. The impact of the Indian diaspora and their feelings for the home country were prominent in the US when Donald Trump joined Mr. Modi on a common platform to address American-Indians. The 'Howdy Modi' event in Houston in Sept 2019 drew over 50,000 attendees. Indians in the US have crossed the 4.5 million mark and play a major role in binding the two nations.

Globally, Indians have made a mark due to their hard work and sincerity. Most are performers and well educated. The Economist mentions that the 'median annual income of the Indian diaspora in the US is \$150,000, which is double the national average.' The Indian diaspora



# Bouncing Back: 7 Ways to Get Up When You Fall Down

Life is filled with more fistpumping triumphs than souldestroying setbacks. Yet it's the latter that disproportionately dominates our minds and our moods.

When you mess up or get something badly wrong, it's hard to get back on the horse. It can feel crushing, especially if the error was caused by your own hand. Whether it's a relationship breakdown, career setback, psychological trauma, or sports defeat, it's important to know how to rebound quickly.

No one appreciates this more than Nelson Mandela, who said, "Do not judge me by my success, judge me by how many times I fell down and got back up again."

The speed with which you bounce back is based not just on the inner voices you tune into but also on the scornful voices you tune out.

### **Tuning in to the Right Voices**

Behavioral science can help with seven simple strategies and some advice from those who have bounced back.

#### Acknowledge **Embarrassment**

The only way to deal with feelings istoactuallyfeelthem.Acknowledging and processing embarrassment or disappointment is a crucial step in boosting well-being. We tend to catastrophize events when we can't see how the future will unfold—it's the uncertainty effect. "What do I do now?" What doesn't help is social media which amplifies and sensationalises error. Or when others seem to relish our mistakes!

Adding further to our agony is the delusion that others are watching us. It's the spotlight effect. "What will colleagues or neighbors think?" Of course, others are so busy selfobsessing that they don't care—and even fewer have noticed. Our anxiety is often less about coping with our disappointment than coping with the compounding factor of what we think others think. We get stuck in our own spotlight misery.

## 2. Gain Relative Perspective

The most obvious response is to try to gain immediate perspective and reduce the perceived consequentiality of the error. I find it helpful to look at more highconsequence impact and ask three things: (i) Will you struggle to eat? (ii) Will you lose your bed? (iii) Has this damaged lives? If the answer is most likely "No" to any of these questions, then the issue may not be quite so dramatic. Note the echo of Maslow's survival needs. Compare yourself to those who lose loved ones, face terminal illnesses, have missing children, and struggle to pay bills or feed families. It's the contrast effect that minimizes potential overreaction to what is usually a minor event, albeit one that feels disproportionately large in the moment.

## 3. Adopt a Positive Mindset

Businesses adapt after a setback or market shift which often signifies a turning point. Equally, individuals can regard change as an opportunity



for new beginnings. "Change is the law of life. And those who look only to the past or present are certain to miss the future," opined John F. Kennedy. Winners appreciate that time lost in self-recrimination means squandered money, reputation, and opportunity. They know a positive mindset increases the probability of achieving the desired result. Stephen Spielberg was rejected three times from the University of Southern California film school. Similarly, JK Rowling was rejected 15 times by publishers. What voices did they entertain? Self-belief is the essence of getting back up.

## 4. Forgive Yourself

Some disappointment, selfloathing, and self-lashing is inevitable—at least temporarily. It doesn't feel much better if others are responsible and you've been fired, ghosted, or dumped. The response is different—rejection and ridicule—

but no less intense or debilitating. Part of a positive mindset involves self-compassion and forgiving yourself. Aspiring comedians and actors suffer rejection and humiliation all the time. Just as you would to a friend, treating yourself with kindness improves resilience. Accept that you're doing the best you can. For some, self-esteem can be strengthened through meditation and mindfulness. Others prefer collective optimism. Massachusetts citizens gained solidarity after the 2013 marathon bombings with the unifying phrase "Boston Strong." There is no universal panacea.

### 5. When It's Gone, Move On

When Novak Djokovic won the French Open and became the highestachieving male tennis player, he shared his winning formula that is as useful on as off the court. He urged us to "live in the present, forget the past as the future will just happen."

When he misses a tie-breaker, game, or match point, the moment is gone. There's no time for negative narratives, dwelling on mistakes and what should have been. Psychological distance is immediately placed between the error and the next move. The mind is at the baseline, preparing to receive the next opportunity.

Iconic tennis player McEnroe understands the danger of an allconsuming win/lose mentality: "Measure your success by how much you evolve, not necessarily how much you win." The ability to compartmentalize loss reduces severe side effects.

### 6. Reflect, Relearn, and Reset

Companies conduct post-mortems to identify sources of error and prevent similar mistakes. It's a crucial step toward growth and recovery. "Failure is the opportunity to begin again more intelligently," said Henry Ford. Otto von Bismarck agreed, espousing that only a fool learns from his own mistakes. In the 1990s, Apple faced bankruptcy until Steve Jobs strategically narrowed its products to the iMac, iPod, iPhone, and MacBook. The rest is history. Similarly, Netflix started as a DVD rental-bymail service and leaders faced a crisis as the market declined; they transitioned into a streaming service. Individuals can learn from this in any situation and redefine the meaning of success.

Resetting goals is a powerful way to refocus energy and motivation. "The secret to change is to focus all of your energy not on fighting the old, but on building the new," said Socrates.

### 7. Recalibrate Expectations

Mistakes hurt as we worry about social, political, religious, and career repercussions. When we're preoccupied with smashing the competition, winning a medal, or securing a promotion, excessive tunnel vision sets in. You need a pressure valve or method of release to regulate anxiety in these scenarios. Wharton professor Adam Grant advocates a "challenge network" to provide a buffer zone that insulates against poor decisions.

Losing face is an inevitable part of life, whether in business, sports, or relationships. It's how you respond to challenges that define your character and success. Avoid those who seem to enjoy your dilemma. It can be tough to reach out to empathetic others for guidance. Oprah Winfrey got it right when she said, "Surround yourself with those who only lift you higher." It's too easy to criticize and condemn, usually serving the critic more than the criticized.

Armed with these behavioral strategies, you can reframe losses more easily as opportunities for growth—and in time, even stories to tell others. This is merely a stepping stone toward a better, smarter, and more robust you.

# **Depression Amid Pregnancy** Linked to Years of Suicide Risk

pair of new studies of women living in Sweden suggests that any woman who has depression during or after pregnancy has a higher and longer risk of suicide, regardless of psychiatric history.

Women who are diagnosed with depression during pregnancy or treated for depression within a year of giving birth are three times more likely to have suicidal behavior than pregnant women not affected by depression during those periods, according to findings published Tuesday in JAMA Network Open.

Perinatal depression affects up to 1 in 5 pregnant women in the U.S., and in 2021 there were nearly 3.7 million live births nationwide, pointing toward an increased suicide risk among hundreds of thousands of women each year.

The researchers analyzed the likelihood of suicidal behavior among women with perinatal depression, compared to pregnant women of the same age with similar due dates who did not have depression. Suicidal behavior included attempting or completing suicide. The study followed 925,061 pregnant women living in Sweden for up to 18 years after delivery, and also included an analysis that compared the women with perinatal depression to their sisters who did not have perinatal depres-

For the study, researchers defined perinatal depression as having a first depression diagnosis documented during pregnancy, or having an antidepressant medication prescription filled within a year of giving birth. A total of 86,551 women in the study met the depression criteria, and all gave birth between 2001 and 2017.

The highest risk of an unnatural death occurred during the year after diagnosis,



but stayed higher for as long as 18 years, which was the duration of the study.

The researchers said in a news release that psychiatric treatment should not be discontinued during pregnancy and emphasized the importance of screening for depression before and after birth.

A second study that also looked at many of the same data about women with perinatal depression in Sweden was published Wednesday in BMJ, the journal of the British Medical Association. It showed that the increased risk of suicide among women with perinatal depression could not entirely be explained by family factors (many psychiatric illnesses have familial links), and having a preexisting psychiatric condition before pregnancy also didn't

explain the increased risk of suicide. The second study showed that women with perinatal depression were almost twice as likely to die of natural or unnatural causes, compared to pregnant women

who did not have the condition.

A news release summarizing the findings called the incidence of suicide "rare, but women with perinatal depression were more than six times as likely to die from suicide, and three times as likely to die from an accident, than women who did not have perinatal depression," according to the summary from the BMJ press

"This finding was not surprising because depression is one of the most common psychiatric disorders in the postpartum

period," the BMJ study authors wrote. They said "early detection and treatment are needed for groups at high risk of perinatal depression to prevent the fatal outcomes." A range of known risk factors for both depression and premature death were taken into account, including socioeconomic status, pre-existing psychiatric disorders, adverse birth outcomes, and death of a child within the first year after

During the 18-year study follow-up period, 522 deaths (0.82 per 1000 person years) were reported among women with perinatal depression diagnosed at an average age of 31 years and 1,568 deaths (0.26 per 1000 person years) among unaffected

The results show that women with perinatal depression were more than twice as likely to die than women who did not have perinatal depression. Results were similar when comparing deaths between sisters and among women who did and did not have a pre-existing psychiatric disorder.

The increased risk associated with perinatal depression was most pronounced in the first year after diagnosis, and although it gradually reduced over time, it remained higher throughout the 18 years of study follow up. Overall, the increased risk associated with perinatal depression was greater for death caused by unnatural causes (0.46 per 1000 person years) than by natural causes (0.36 per 1000 person years). Although suicide was rare (0.23 per 1000 person years), women with perinatal depression were more than six times as likely to die from suicide, and three times as likely to die from an accident, than women who did not have perinatal depression. These are observational findings and the researchers point to several limitations.





Kohli missed the lung-opener in Mohali due to personal reasons. There is a raging debate on whether the duo should play or

"You want to pick your best team, you can't just fill the team with youthful players. You need experience," the two-time World Cup winning captain said in a media interaction here.

The 79-year-old was the chief guest at the 75th foundation day ceremony of the Satgachia High School, about three hours from Kolkata. "Kohli is still one of the best players around. Rohit is quite good as captain. So you pick your best team. You will have some young players too, because you have so many cricketers here, and they are pushing the older players... and that's how it should be. But I'm sure that you will have a very formidable side."

Talking about his favourite Team India batters, Lloyd picked Shubman Gill and Shreyas Iyer.

"I liked this fellow Gill, he looks a good cricketer, and (Shreyas) Iyer," he said. "India have a lot of good cricketers at the moment, I must say. And I think what I like about it is they have a much more balanced side," he added. The should be "paid well". legendary West Indian, however, is of the view that the Indians are playing too much cricket that may make the sport itself "stale".

"Yes, I think they're a very good side, and they will do well for quite a while if they continue in this manner. But my problem is that they might be playing too much cricket, and then, you know, you can get stale," he said, voicing a general concerninthecricketcommunityabout tight international schedules. Blaming the advent of T20 franchise leagues for decline of West Indies cricket, Lloyd said Test cricketers

West Indies failed to qualify for the ODI World Cup last year, while in the 2022 T20 World Cup, they failed to reach the tournament proper, crashing out of the group stage. Lloyd was bitter with his country's players for putting T20 above other formats.

"I don't mind T20. It's excellent. It's good entertainment. But I think too much of it might be hampering cricket throughout the world. It's hampered us in the West Indies. We only have five million people, 14 islands..." he pointed out. "And we are losing a lot of our players to

the shorter formats, and they're refusing to play for their country, I find that very disturbing."

Lloyd said countries like India don't face this situation because of their huge talent pools.

"Other countries like India, Pakistan, England and Australia have a lot of people. So they can afford to lose one or two players because they can replenish those people," he said. "If you're saying that Test cricket is the highest cricket, then they should be paid much better. You're paying the guys who are playing the shorter game, so it doesn't make sense," he said.

# **Coco Gauff enters Australian Open as** teenage Grand Slam champion, the pressure is off

to win a Grand Slam singles title as a teenager is over, Coco Gauff feels liberated enough to discuss her next target: a career tally in double digits.

Could be 10, 11 or more ... no limits. Plus, an Olympic medal in Paris this year. Preferably gold, but silver or bronze would do – in singles, doubles or mixed.

She's entering the Australian Open as a reigning Grand Slam champion, new territory for the 19-year-old American. Had she not fulfilled those expectations at last year's US Open, this would have been her last shot at being

a teenage major winner. Gauff, who turns 20 in March, believes she can play with more freedom now in pursuit of a second major title as the No. 4 seeded player at Melbourne Park.

The tournament starts on Sunday, a day earlier than usual.

Defending champion Novak Djokovic, aiming for a recordingextending 11th Australian title and 25th overall, announced ahead of the schedule's release that he'd

be playing Sunday night.

**MELBOURNE:** Now that the pressure Djokovic opens against 18-year-old qualifier Dino Prizmic of Croatia.

Gauff's first-round match is against Anna Karolina Schmeiedlova, a 29-yearold from Slovakia who has only been past the third round once in 35 majors.

Having rebounded from a shocking first-round exit at Wimbledon to winning a breakthrough major title at the very next major in New York has helped with a shift in mindset.

"I think I put too much pressure on winning a Slam. I think I was feeling like I have to do it," Gauff said. "When

I went on the scene at 15, I felt like I had to win a Slam as a teenager because that's what everybody thought.

"Honestly, going into U.S. Open, I didn't expect it. I felt like I was having a bad season, and

my focus was just get through the season and focus on the Australian Open this year."

It was the loss at Wimbledon that helped her take pause, relax and think about all those rounds before the final, one-byone. She'd thought losing in the first round would have been the worst thing to happen to her.

# New Zealand beats Pakistan by 46 runs in first T20; leads five-match series 1-0

AUCKLAND: Daryl Mitchell and Kane Williamson made brisk half centuries to propel New Zealand to a 46-run win over Pakistan Saturday in the first of five Twenty20 internationals.

Mitchell blasted 61 from 27 balls. following Williamson who scored 57 from 42 as New Zealand made 226-8 after being sent in, the highest-ever total against Pakistan in a T20 international.

Pakistan was in with a chance as long as Babar Azam was at the crease. But when he was out for 57 in the 16th over, the size of the run chase became insurmountable. The tourists finally were all out for 180 in 18 overs.

Tim Southee took 4-25 for New Zealand to become the first bowler from any nation to claim 150 wickets in T20 internationals.

Williamson's 18th half century in T20s came in difficult circumstances. Batting first drop, he came to the crease on only the third ball of the New Zealand innings after Devon Conway was out for a first

ball duck. He also lacked recent time in the middle after missing New Zealand's recent T20 series against Bangladesh as he continues a controlled return from the serious kneeinjury he suffered while playing in the Indian Premier League in April.

Williamson also was in the shadow early of Finn Allen who



smashed 35 from 15 balls at the top of the order, including 24 runs, 6, 4, 4, 4, 6, from the second over bowled by Pakistan captain Shaheen Shah Afridi.

He batted watchfully at first but when Allen was out, Williamson steadily gained momentum to reach his half century from 40 balls with eight boundaries. He was twice dropped, on nine by Babar from the bowling of Abbas Afridi and on 39 by Iftikhar Ahmed off Usama Mir.

Just as Williamson took up where Allen left off, Mitchell stepped up the pace of the New Zealand innings after Williamson and reached his half century from 22 balls. His score of 61 included four

powerful sixes down the ground. "I thought the partnerships we

built throughout the middle with Kane and (Glenn Phillips) as well allowed us to build a platform to put the bowlers under some pressure which you always try to do at Eden Park," Mitchell said. "Also the way the boys bowled at the end there was superb.

New Zealand piled on runs through the middle of its innings -80 between the eighth and 14th overs — but didn't finish quite as strongly at it would have hoped. Glenn Phillips made 19 runs from 11 balls and Mark Chapman 26 from 11 at the death. But New Zealand may have been a batter short in the absence of Mitch Santner

who was ruled out of the match at the last moment after testing positive positive for the coronavirus.

Saim Ayub gave Pakistan an explosive start to its innings when he hit 27 from eight balls with three sixes and two fours. But he was immensely unlucky to be run out backing up too far. Mohammad Rizwan had to parry a delivery from Adam Milne who picked up the ball on his follow through and threw out Ayub at the non-striker's

New Zealand would have been concerned when Pakistan was 62-1 after five overs with Mohammad Rizwan and Babar at the crease. Rizwan fell before the end of the power play, top edging a ball from Tim Southee which hung for a long time in the night sky before being caught by Conway, the New Zea-

land wicketkeeper. Ish Sodhi pulled off a brilliant one-handed catch off his own bowling to dismiss Fakhar Zaman but Pakistan was 109-3 after 10 overs, still in the race.

Babar and Iftikhar added 40 for the fourth wicket but the Pakistan run rate began to dip below New Zealand's.

As Pakistan's set batsman, Babar was crucial but New Zealand did well to limit him by bowling shorter to restrict his access to the shorter straight boundaries at Eden Park.
