

As per news agency—Kashmir News Observer (KNO), gold has seen unprecedented price hikes in recent months, reaching once unimaginable levels.


The price of 24-carat gold rose Rs 170 in early trade on Tuesday, with ten grams of the precious metal selling at Rs 63,270.

society to ensure that no beneficiary is left behind. He also inaugurated and laid foundation stone for development projects worth Rs 38 crore.

He said the impressive participation of the citizens during Viksit Bharat Sankalp Yatra across the UT is a reflection of the transformation that happened in J&K, under the leadership of Hon'ble Prime Minister Shri Narendra Modi, over the past few years.

GST, Simplified.....

"We gave the country a modern system in the form of GST and simplified income tax and introduced faceless assessment. All these reforms have resulted in record tax collection", Modi said.

"We are returning people's money through various schemes', " he added, stating that the IT exemption limit was raised from the income of Rs 2 lakh to Rs 7 lakh. Tax reforms after 2014 have resulted in tax savings of about 2.5 lakh crore rupees for the citizens," the PM said.

"The number of taxpayers is consistently increasing in the country as they feel happy that their tax money is put to good use," he stated.

Modi also highlighted the special attention paid to the optimum utilization of resources, pointing out to the past UPA government which tended to stall, shelve and divert projects causing huge losses to the nation.

He said that in the last 10 years, 10 crore fake names have been weeded out of the documents. "Today, every paisa reaches the bank account of the beneficiary who is entitled to it. Fight against corruption and action against corrupt people has been the priority of the government", the Prime Minister said.

He underlined that the positive results of this belief can be witnessed in the development works carried out in the country as he apprised the nation about the latest report released by NITI Aayog yesterday which states that almost 25 crore people have been lifted out of poverty in the last 9 years by the efforts of the present BJP government.

Modi expressed the belief that the poor of this country have the potential to defeat poverty if they are given the means and resources. "We can see this becoming a reality today", he added, stating that the government spent on health, education, employment and self-employment, and increasing the facilities for the poor.

"Poverty can be reduced in India, this is going to fill everyone with a new belief and will increase the confidence of the country", he remarked.

Registration on the portal facilitates delivery of Social Security and welfare Schemes to the workers.

The Labour Commissioner called for sustained efforts by the officers in generating awareness among the workers regarding registration on the e-shram Portal and benefits associated with it and to ensure that no workers are left out. 'Registration on the e-shram Portal will facilitate seamless delivery of benefits under the PM Vishwakarma Scheme, Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Shram Yogi Man Dhan Pension Scheme (PM-SYM) and other UT and Central Government schemes to the workers".

Charandeep Singh also reviewed the status of online services of the Labour Department wherein it was informed that the Department has fully switched to delivery of services through online mode and now these are being delivered via the J&K Single Window System. He underscored the need to ensure that the delivery of online services is seamless and timely.

He emphasised on taking all stakeholders on board and urged officers to work earnestly for Labour Welfare to improve their working conditions, provide them social security benefits and raise their standard of living.

The arid weather conditions have taken a toll on various crops, including carrots, radishes, turnips and collard greens. Farmers across different parts of Srinagar are reporting financial losses and damage to their agricultural produce.

"Vegetables like carrots, radishes, turnips and collard greens have either dried or turned red due to the lack of rain or snow. All this is causing financial losses to us," a group of farmers, working in the fields, lamented.

Bulk vegetable buyers, who had entered into early purchase agreements with the farmers, are also counting losses due to the unexpected weather challenges.

This unforeseen challenge has disrupted the agricultural rhythm, leaving farmers grappling with emerging consequences.

With fields experiencing reduced yields and crop failure, farmers have expressed concerns about their livelihoods and are worried about how to sustain their families in the absence of regular precipitation.

"We are witnessing withering fields, reduced yields, and there is an imminent threat to our livelihoods. What will we feed our families when there is no crop?" the distressed farmers asked.

Director of Agriculture, Kashmir, Choudhary Mohammad Igbal told KNO that the department is closely monitoring the situation. He said an advisory will be issued soon to guide farmers through the ongoing dry spell.

All the officers/officials of the Government Departments stationed at Jammu are directed to attend the Beating Retreat Ceremony. It is also

"We are monitoring the situation; this particular crop damage can be an isolated one. There is no denial that dry weather conditions won't be affecting the vegetable crops, but as I am talking to you, a meeting is underway, and an advisory will be issued," he said,

Aside from crop damage, the dry spell has resulted in a decline in water levels in rivers and reservoirs. This scarcity of water for irrigation further aggravates the challenges faced by farmers.

been a staple in Kashmir's vibrant economy, are feeling the pinch as customers turn away from gold due to its exorbitant prices.

"There is a fall of almost 95 percent in the demand for gold currently. A 24-carat gold sells at Rs 6300 per gram in Kashmir. which is almost Rs 200 less than the cost of per gram of gold in the country. Still, we don't get customers now," said Bashir Ahmad Rather, the President of the All Kashmir Valley Gold Dealers and Workers Union.

Rather said the instability in the gold prices has compelled people not to invest in gold and silver.

"We have been witnessing that the gold prices have not been stable for a couple of weeks. It had led to a recession among gold dealers countrywide. We would often make good sales even during winters which is off-season for gold dealers in Kashmir. This winter we are facing immense losses," he said.

The soaring prices have led to a sharp decline in the purchasing power of consumers, with many finding it difficult to afford gold for traditional occasions such as engagements and weddings. The economic downturn has created a ripple effect across various sectors, impacting the livelihoods of those dependent on the gold industry.

"Kashmiris mostly prefer to buy gold when its rates come down. For the last few months, the gold rates have been touching the sky. As such people have deferred functions like engagements, which mostly do happen during winter," said Noor Mohammad Zargar, a gold dealer.



Severe Combined Immunodeficiency Disease

SCID is a rare disease that appears in infancy. It causes affected children to have a very weak immune system. There are now tests and treatments for this severe, inherited condition.

evere combined immunodeficiency disease (SCID) is a very rare genetic disorder that affects about 1 in every 100,000 births in the United States. This condition causes an incredibly weak immune system.

Until very recently, SCID was nearly always fatal. Children with SCID typically died in early childhood after repeated and frequent infections. It was common for SCID to be undiagnosed until a child was about 6 months old and already seriously

Today, thanks to newborn screening, early interventions, and advances in treatments, children with SCID can be successfully treated.

Options such as bone marrow transplants can repair a child's immune system, and treatments such as immunoglobulin and enzyme replacement therapy help keep children healthy while they wait for bone marrow transplants.

Children who are treated in the first few months of life have high odds of a good treatment outcome.

How many types of SCID are there? There are a few different types of SCID caused by different inherited abnormalities. Knowing the exact type can help doctors determine the best treatment plan. However, all types of SCID share a weak immune system as their primary symptom.

What is 'boy in the bubble' syndrome? SCID is sometimes called "boy in the bubble" syndrome, due to a highly publicized case in the 1970s of a boy named David Vetter who had SCID and lived his life in a sterile plastic chamber.

Treatment of SCID has improved significantly since then. Children today have much better options and a much better outlook.

SCID is genetic. Several genetic abnormalities can lead to SCID. The condition can be inherited as either an autosomal



recessive trait or as an X-linked trait:

Recessive genetic traits: These traits are passed on when each parent carries the trait and the child inherits two copies of the trait. Generally, someone with one copy of the genetic trait for a disorder or condition will be a carrier but won't have that condition. Two carrier parents have a 25% chance of having a child with the condition.

X-linked conditions: These conditions are passed down on the X chromosome and occur more often in men. This is because women normally only have the trait on one X chromosome, making them unaffected carriers.

There are no known environmental risk factors for SCID.

Symptoms of severe combined immunodeficiencyThe most common symptom of SCID is frequent respiratory infections. Often, these respiratory infections are severe enough that hospital treatment is needed. Additional symptoms include:



- chronic diarrhea
- frequent eczema-like rashes
- skin infections
- oral thrush
 - diaper rashes
- yeast infections
- delayed growth
- frequent ear infections
- infections that don't respond well to antibiotics
- rare infections such as pneumocystis pneumonia

Today, SCID is primarily detected through newborn screenings. This is often done as part of the same screening as the heel prick blood test that screens for:

Depending on the results of the screening, further blood tests might be done. These tests can look at immune system function and genetic markers of SCID.

Additionally, if you know you have a family history of SCID, there are in-utero tests that can be done.

Early treatment is very important for

children with SCID. The exact treatment plan will depend on your child's exact needs. Common treatments include:

Antibiotics: Antibiotics treat and prevent infections.Immunoglobulin replacement: Immunoglobulin replacement is a shortterm therapy that uses donated plasma to provide antibodies to a child with SCID.

Enzyme replacement therapy: Enzyme replacement therapy repairs defective proteins in the body so that the immune system can gain function.

Bone marrow transplant: At this time, a bone marrow transplant is the only cure for SCID. Bone marrow transplants have the highest success rates when they're performed in the first 3 months of a child's life and when the donor is a healthy relative.Gene therapy for sevee combined immunodeficiencyGene therapy is an emerging option for SCID. It could be a breakthrough for children who are unable to receive a bone marrow transplant or for whom bone marrow transplants don't work. Gene therapy has been shown to successfully restore immune cell function in children. However, this treatment is still experimental. In the United States, it's only available through clinical trials. Gene therapy is currently available in Europe, and clinical trials are being conducted by the United States National Institute of Health and multiple children's hospitals.

If you want to get involved in a clinical trial, you can check out what's available at ClinicalTrials.gov. Always make sure to discuss any trial with your child's doctor before signing up, especially if it would involve any change to their treatment plan.

Can severe combined immunodeficiency be cured?SCID can be cured with early treatment. Children who are treated in the first 3 months of life and who receive a bone marrow transplant from a donormatched sibling have the best odds of a successful treatment outcome.

Tendulkar who spotted the manipulation took to X cautioning his fans and the public that that the video was fake and asked people to report such applications, videos and advertisements.

He also tagged the Maharashtra Cyber Police, Union Electronics and Information Technology Ministry and Union Minister of State for Electronics and IT Rajeev Chandrashekar. in his tweet.

"These videos are fake. It is disturbing to see rampant misuse oftechnology. Request everyone

to report videos, ads & apps like these in large numbers. Social media platforms need to be alert and responsive to complaints. Swift action from their end is crucial to stopping the spread of misinformation and fake news. @GoI_MeitY, @Rajeev_GoI and @ MahaCyber1," tweeted Sachin. Notably, on November 6 last

year, a modified video of actor Rashmika Mandanna appeared online sparking discussions of digital safety. In the viral video, it can be seen that a woman resembling the actress Rashmika was entering a lift wearing a black swimsuit.

The video quickly went viral and several social media users came forward to confirm that it was a deep fake. It was later identified that the video was of a British actress, Zara Patel. The actor strongly reacted to

the alleged deep fake video and said, "I feel really hurt to share this and have to talk about the deep fake video of me being spread online. Something like this is honestly, extremely scary not only for me but also for each one

of us who today is vulnerable to so much harm because of how technology is being misused."

The social media platforms have responded. They are taking action. We have told them to be more aggressive in this work."

"Also, we must notice that the 'Safe Harbour' Clause that most of the social media platforms have been enjoying, doesn't apply if the Tendulkar speaks at an event in platforms do not take adequate steps to remove the deepfakes from their platforms," he added.

Andy Murray Says 'Definite Possibility' He Has Played Final Australian Open

MELBOURNE: Five-time finalist Andy Murray said Monday there was a "definite possibility" that he has played his final Australian Open after slumping out at the first hurdle.

The 36-year-old put up stiff resistance in a 61-minute first set against Argentine Tomas Martin Etcheverry, but the 30th seed slowly ground him down to win 6-4, 6-2, 6-2.

Murray had a frustrating end to 2023, winning just one match in his last four tournaments, and said previously that unless his form picked up the curtain could be coming down on his career.

"Yeah, it's a definite possibility that will be the last time I play here," he said.

"In comparison to the matches that I played here last year, it's the complete opposite feeling walking off the court. Wish I involved the crowd more. Just disappointed with the way I played. Tough, tough way to finish."

The British player, who won Wimbledon in 2013 and 2016 and also took the US Open title in 2012, is part of a golden generation coming towards the end of trophy-laden careers.

Sixers will face table-toppers Brisbane Heat in Friday's Qualifier on the Gold Coast with both teams having the safety net of a double chance. It was a costly defeat for Scorchers, who will host an elimination final against surging Adelaide Strikers on Saturday.
