



foundation stone of 8 AMRUT (Atal Mission for Rejuvenation and Urban Transformation) projects worth around Rs 2,000 crore in the state.

He also dedicated more than 90,000 houses completed under PMAY-Urban in Maharashtra.

In a choked voice, the Prime Minister said he wished he had had the opportunity to stay in such houses when he was young.

Urging people, who got the houses, to light Ram Jyoti on January 22, when the consecration of the Ayodhya Ram temple will be held, Modi said it will be an inspiration to eradicate poverty from their lives.

"Lord Ram did the work that made his people happy. My Government is dedicated to the welfare and empowerment of the poor. We launched schemes to mitigate their hardships," he said, adding that the role of middlemen has been completely eradicated in his Government's welfare schemes.

Modi said homes and toilets have been constructed in ten years as the lack of these amenities was insulting to the poor, especially women.

'We have constructed more than 10 crore toilets which is Modi's 'izzat ki guarantee' for women and provided more than four crore pucca houses so far," he said.

Welfare of the poor and dignity of labour has been his Government's focus, the PM said.

Making India 'Atmanirbhar' (self-reliant) is crucial for turning it into 'Viksit Bharat' (developed India), he said, appealing to people to dream big. "Your dream is my pledge and this is Modi's guarantee," he said.

Modi said 'Garibi Hatao' was just a slogan earlier because schemes did not reach beneficiaries.

Recalling the slogan "aadhi roti khayenge..." from the past, the PM said that under "Modi guarantee, you will eat full roti".

The Kashmir Valley is currently grappling with an alarming situation due to prolonged dry spell and the absence of rainfall and snowfall has triggered alarm bells among the residents and the government in the region.

The 40-day long period of harsh winter cold known as the 'Chillai Kalan' is ending on January 30 and so far, there has been no major snowfall anywhere in the Kashmir Valley.

Meanwhile, the minimum temperatures dropped further last night.

The MeT official said Srinagar recorded a minimum temperature of minus 4.9 degrees Celsius as against minus 4.6 degrees Celsius during the previous night.

Pulwama at minus 6.9 degrees Celsius was the coldest place in Kashmir

The tourist resort of Pahalgam in south Kashmir recorded a minimum temperature of minus 6.3 degrees, while Kokernag recorded a minimum of minus 1.4 degrees Celsius. Qazigund, in south Kashmir recorded a minimum of minus 5 degrees Celsius

in Meghalaya, Shah said, "In these 10 years under the leadership of Prime Minister Narendra Modi, the distance from North East to Delhi and the rest of India has reduced due to the creation of infrastructure."

He said the Northeast, which was struggling with various ethnic, linguistic, border and extremist groups related problems, has also got the beginning of a fresh and durable era of peace in these 10 years.

The Home Minister told Governors and Chief Ministers of the eight North Eastern States present at the meeting that "If these 10 years for the Northeast are compared with the 75 years after the country's independence, then this decade will definitely be considered as the Golden period of the Northeast.

We have always considered the Northeast as an important part of India," he said.

"During the time of Atalji, by giving it priority, a separate ministry was created for the Northeast and today under the leadership of Prime Minister Modi, the three mantras of 'Act East', 'Act Fast' and 'Act First' are being implemented. Along with this, impetus is being given to the Northeast by giving priority to it in all the ministries of the Government of India," Shah said.

Highlighting some of the achievements of the central government in the past decade, the Minister said, 11,121 violent incidents took place in the northeast from 2004 to 2014 when the Congress was in power. Such incidents have declined by 73 per cent to 3,114 from 2014 to 2023.

Deaths among security forces dropped by 71 percent from 458 to 132, while civilian deaths declined by 86 percent in the past 10 years, he said.

Shah said that the insurgency-related incidents have also come down significantly because in the last 5 years more than 8,900 rebels of various militant groups have surrendered and have joined the mainstream.

Further, the Home Minister also informed that 75 percent of the areas in the region which were covered under Armed Forces Special Powers Act (AFSPA) have been removed from the ambit of AFSPA from 2018, barring a few areas of Assam and Manipur.

Shah said this has sent a strong message across the country that "peace and prosperity are interconnected" and without it the states or a region cannot develop.

The Home Minister, who is also chairman of the NEC, the regional planning body of the North Eastern States, said that in the 50 years of its establishment, the NEC has increased the pace of development in the region by providing a policy-related platform to all the states and simplifying the solutions to their problems.

The impact of DGP's public interaction program has frustrated many fraudulent persons who have started to return money to their genuine owners.

The fresh three families have simply asked the fraudulent persons that they will approach Director General of Police (DGP) for resolution of their issues if they won't pay their amount back. The fraudulent persons while sensing the behavior have instantly returned their money without any further delay, just to save themselves from legal action.

A women (name withheld) from Hanjibug Magam village of central Kashmir's Budgam district as per reports was duped by a travel agent of Kupwara in pretext of giving discount rate tickets but when I demanded air ticket he played dilly dallying tactics and duped me.

Another women (name withheld) of Bemina Srinagar had also gave a money to a person for providing employment at Srinagar International Airport. "Neither I was given employment nor the person returned my money back," she told KNS. A man from Shalteng locality of Srinagar

district had sold bricks to a government servant who had digested his two lakh rupees while misusing his official position. The trio approached the respective indi-

viduals and clarified them if they do not return their money they will file a complaint at DGP Office Srinagar and will seek legal action in the matter.

All three victims received their money back without any further delay after fraudulent persons heard about DGP's Public Grievance Redressal Program.

New initiative of linkage of minimum reserve bid price with sale potential of each vend has been approved. Lower cap of 15% of MSP of liquor for on premises consumption has been fixed. As notified in Excise Policy for the year 2023-24, Excise Duty on CSD/ PAMF shall continue to be 25% less than that on civil for all types of liquor manufactured in the UT of J&K and the import duty shall continue to be 15% less than that on civil for all brands of liquor. Existing licensees having License of Beer Bar with Microbrewery License shall be given License within same premises on remittance of requisite license fee and other duties.

There will be complete digitalization in liquor manufacturing, distribution and sale from proparts of Punjab, Haryana, north Rajasthan, and west Uttar Pradesh starting at 8 pm on Thursday.

An official at the India Meteorological Department (IMD) said dense to very dense fog blanketed parts of Punjab, Rajasthan, Haryana, Delhi, and Tripura. Moderate fog prevailed in parts of Uttarakhand, east Uttar Pradesh, Bihar. Jharkhand, and Odisha.

Early morning foggy weather in north and northeast India has heavily impacted road, rail, and air traffic since the end of December.

IMD scientists say the absence of active western disturbances – weather systems originating in the Mediterranean region and bringing unseasonal rainfall to northwest India – is the reason behind the blinding layer of fog persisting over the plains in northwest India since December 25

The circular addressed a noticeable lack of awareness among individuals and organizations regarding laws, practices, and conventions related to the display of the National Flag.

The circular emphasizes that these paper flags should not be discarded or thrown on the ground after the event. Instead, individuals are urged to dispose of them privately, ensuring the continued dignity of the flag.

"As per clause (x) of Paragraph 2.2 of Part-II of the Flag Code of India, the National Flag made of paper may be waved by the public on occasions of important national, cultural and sports events," it stated. "You are requested to ensure that on the occasions of important national, cultural and sports events, Flags used by the public, made of paper are not discarded or thrown on the ground after the event. Such Flags are to be disposed of, in private, consistent with the dignity of the Hag," it further stated.

The MHA has further requested states and Union territories to conduct mass awareness programs to educate the public on the proper handling of the National Flag made of paper.

"You are also requested to undertake a mass awareness programme in this regard and also to give it wide publicity through advertisements in the electronic and print media," the circular mentioned. (Agencies)

DC Srinagar finalises Snow Clearance Plan; gears up Admin for dealing with winter challenges

Asks Officers to ensure swift action to avoid any interruption in public service delivery

SRINAGAR, JAN 19: In order to gear up the District Administration and machinery to deal winter challenges particularly with regard to current weather advisory, a meeting of all District/Sectoral Officers was today held under the chairmanship of the Deputy Commissioner(DC)Srinagar, Dr. Bilal Mohi-Ud-Din Bhat at Meeting Hall of DC Office Complex, here.

The DC took a detailed review of overall winter preparedness in the district including, health care facilities, power and water supply position, availability of ration, fuel, LPG and other essentials, besides arrangements put in place for timely snow clearance across the district to ensure smooth movement of vehicles, ambulances etc.

At the outset, the DC stressed on taking preventive and precautionary measures well in advance so that routine functioning at all essential installations, besides trade, transport, essential supplies and other routine works are not affected.

He also stressed the Officers on readying men and machinery to ensure timely redressal of weather vagaries and subsequent interruptions of supply of water, electricity and road closure due to snowfall.

During the meeting, the DC directed for setting up of a special Joint Control Room in the district to redress the winter-related complaints of the general public on a fast track basis. He stressed the concerned to ensure a prompt response system is placed to ensure hassle-free supply of essential services to the people and instructed that response time should be minimized while facing any emergency like situations.

The DC also took first hand



appraisal of the preparations made with regard to clearance of Snow.

The meeting was apprised that adequate number of hi-tech Snow clearance machines have been kept ready by the R&B, SMC and Mechanical Engineering Department in Srinagar out of which various machines have been deployed at important installations and vital sites across the district, while few machines are kept in standby mode to meet any exigency during heavy snowfall.

In addition, permanent and mobile dewatering stations are run by SMC in the district to tackle any water logging caused due to rains or snowfall. Besides, dewatering pumps of UEED are also operational to deal with any water logging

The DC asked the SMC authorities to keep men and machinery ready to clear snow from inner lanes and by-lanes of the City.

Similarly, the DC directed the Chief Medical Officer to ensure availability of staff, medicine and sufficient stock of drugs, emergency medicine, ambulance services in all tertiary care hospitals in the City, besides making proper functioning of the central heating system in all hospitals during the winter season.

Reviewing the status of the power supply scenario in the district, the DC asked the Engineers of KPDCL to take all required measures in order to ensure that power supply is not affected during snowfall particularly at essential installations. He asked the Officers to keep men and machinery ready for early restoration of the power supply in case of disruption due to snowfall.

The DC stressed on time bond replacement of damaged transformers in all the areas of the district so that people do not face any

inconvenience.

It was informed that proper backup has been kept for ensuring supply of water in the district and all PHE schemes are running properly and supplying water smoothly to all the areas.

The Assistant Director FCS&CA informed that sufficient stock of Ration is available to cater the demands, while Petrol and Diesel supply is also in buffer stock besides LPG stock for minimum 20 days in the district.

Besides, Additional District Development Commissioner, Zahoor Ahmad Mir, the meeting was attended by Superintendent Engineers of R&B, MED, PDD, SMC, Chief Planning Officers, Chief Medical Officer, Assistant Commissioner Revenue, SDM East, SDM West, All Tehsildars, and AD FCS&CA, besides other senior Officers fromTraffic Police and Civil Administration.

JAMMU, JAN 19: The government suspended Medical Superintendent district hospital Kishtwar for unauthorized absence on Friday. As per anorderissued by Deputy Commissioner Kishtwar, ADC Kishtwar has been directed to conduct an enquiry into the matter.

"It has come to the notice of undersigned during field visit to District Hospital Kishtwar that Dr Yudvir Singh Kotwal, Medical Superintendent District Hospital Kishtwar is unauthorized absent from legitimate duties, which invites action under article 128

of JK CSR 1956. Therefore, he is

hereby placed under suspension in terms of Rule 31 of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956," said an order.

It said that Dr Kotwal will remain attached in Chief Medical office Kishtwarduring his period of suspension and BMO Kishtwar has been given the charge of Medical Superintendent District Hospital Kishtwar in addition to his own duties.

"The ADC Kishtwar shall conduct the discreet enquiry into the matter and shall submit the detailed report to this office along



with his recommendation for further action within a period of 07 days positively," it added.

Soon after the suspension order was issued, Dr Kotwal managed to sanction five day casual leave with effect from January 15-19.

"During his leave period Dr Sajjid Hussain Butt, Consultant

Surgeon, DH Kishtwar will look after the routine and emergency work of the hospital," said the order.

Official sources told news agency KNO that taking serious notice of the issue of how casual leave was sanctioned after the Medical Superintendent was suspended clearly indicated that DHSJ is involved in it.

They said that higher ups including the Chief Secretary and Secretary Health and Medical Education intervened in it following which the casual leave order was rescinded by DHSJ with immediate effect.

"In reference to the subject and reference cited above, 05 days of Casual Leave sanctioned in favour of Dr Yudvir Singh, Medical Superintendent District Hospital Kishtwar vide this office order No. ES-3/4156-58 dated 19.01.2024, is hereby rescinded with immediate effect," said the order.

As per news agency-Kashmir News Observer (KNO), Kashmir's winter charm, characterized by its pristine snow-covered landscapes, has long been a sought-after setting for Bollywood and pre-wedding shoots. Majority of the films for the last few years have been shot during winter in Kashmir given the charm of the valley that doubles after snowfall.

However, this winter has witnessed a departure from the norm, as the region grapples with a surprising lack of snowfall.

It has led to the deferment of scores of the shoots, which mostly include Bollywood, prewedding and promotional films.

Danish Khan, a line producer for Bollywood films in Kashmir, said that many of his scheduled shoots have been postponed due to the snowless winter. "We are getting a number of queries from Bollywood about the weather situation in Kashmir. Many Bollywood shoots are scheduled for Kashmirduring winterespecially for snow. Since, it is a dry weather here without any traces of snow, shoots get either cancelled or deferred," he said. Khan, who has a production company named as 'Hamiasto Productions' said he had three projects in the pipeline for winters out of which two shifted to other locations.

"Winter beauty has helped a lot in film revival in Kashmir. Now, we wait for snowfall so that shooting doesn't get impacted," he said.

Peer Idrees, production manager of 'Hamiasto Productions' said the dry rivers too contribute to the postponement of film shooting in Kashmir.

"Some film procurements have now shifted to Russia to shoot snow sequences. Flowing rivers with snow capped mountains in the background provide an apt setting for Bollywood movies," he said. Local film makers, who usually plan their schedules around the enchanting snow-covered scenery, are facing an unprecedented dilemma. "I had three music videos and two pre-wedding shoots scheduled, which got cancelled. The ongoing dry spell has impacted the work of local filmmakers to a great extent," said Mian Imad, a filmmaker and photographers who is famous as Imad Clicks.

Soaring Prices Amidst Smooth Highways

As winter descends upon Kashmir, the region is grappling with an unexpected conundrum - an unjustified surge in market prices despite the absence of snowfall.

Traditionally, the onset of winter in the valley is accompanied by a dip in temperature and the arrival of snow, influencing the prices of essential commodities. However, this year has defied expectations, with no snowfall yet observed with smooth highway traffic movement, yet the market prices have been on an unwarranted ascent.

The impact of this anomaly is felt keenly by the local populace. Prices of winter staples such as firewood, warm clothing, and heating fuels have skyrocketed, placing an undue burden on the residents who are accustomed to adjusting their lifestyles in response to the harsh winter conditions. The lack of a meteorological explanation for this price surge raises questions about the ethics of certain market practices and the need for regulatory scrutiny.

Contrastingly, the Srinagar-Jammu National Highway, a lifeline for the region's connectivity, is experiencing smooth traffic flow. Are these price hikes a result of artificial scarcity or speculative trading? Or is there a deeper economic undercurrent at play that demands immediate attention?

As we navigate through this enigma, it is imperative for local authorities to intervene, investigate, and rectify the unjustified price hikes. Transparency in the supply chain, strict enforcement of regulations, and public awareness campaigns are essential components of addressing this issue.

This government initiative to make generic and affordable drugs widely available could substantially reduce healthcare expenses borne by the underprivileged. Presently, 264 Jan

Aushadhi Kendras, including 188 in the government sector and 76 in the private sector, are operational in J&K, according to the State Drugs Controller's recent update.

A significant stride in making healthcare accessible to all is the proliferation of medical colleges and associated hospitals across remote regions of the UT. These medical colleges not only extend specialized services but also provide medical education. Currently, five new medical colleges are fully operational in J&K, with two more in the process of expanding their services.



Face Scrubs for Glowing Skin

ull, dry, lusterless skin is result of regular exposure to dirt, dust and pollution in environment which accumulates toxins in deep pores. While washing and cleasing help get rid of superficial build up on face but misses out dead skin cells, blackheads and whiteheads. Face scrubs are must to clear dead cells and remove toxins from deep within pores for radiant, clear and flawless skin.

Packed with the goodness of natural ingredients and essential oils, face scrubs can provide your skin with deep exfoliation to give you smooth and clear skin .Scrubs not only improves skin texture, but also stimulates circulation and encourages toxins to escape through the unclogged pores. When skin is clean and exfoliated, it can absorb the beneficial ingredients in treatment and moisturizing products much more effectively.

Scrubs play an important role by keeping the pores free of clogged oil, thus preventing blackheads and pimples. Some scrub ingredients, like lemon juice, lemon peels, curd, milk, turmeric, ground



almonds, help to brighten the skin and lighten skin colour over a period of time. Natural cooling ingredients can be used to make scrubs, like multani mitti, rose water, sandalwood, fruits, cucumber, aloe vera, while natural antiseptics helps to prevent rashes. These are neem, tulsi, pudina. Other home ingredients for scrubs are ground almonds, oats, rice flour, wheat bran(choker), cucumber or pumpkin seeds, dried orange and lemon peels and eggs. For dry skin, use a scrub only once a week. If the skin is sensitive, with reddish patches or rash, avoid scrubs. For normal to oily skin, scrubs may be used more often. For oily skin with enlarged pores: Mix

oatmeal with egg white and apply on the areas. When it dries, dampen with water and rub gently with circular movements, washing off with water. Both egg white and oatmeal also help to reduce oiliness.

Mix 3 parts rice powder with 2 parts gram flour. Add curd and a little turmeric to mix into a paste. Apply on exposed areas of the body. Leave on for 10 minutes. Rub gently on the skin and wash off with water.

Ripe papaya has a cleansing action and contains an enzyme called papain, which helps to remove dead skin cells and brighten the skin. Add oats and curd to papaya. Apply on the face and rub gently on the skin, washing off with water.

Take 2 parts coarsely ground almonds and one part yogurt. Add a little turmeric. Mix together and apply on the body. After 5 minutes, rub gently and then wash off

with water.

Take sesame seeds (til), dried mint (pudina) leaves and honey. Crush the sesame seeds coarsely and powder the dried mint leaves. Mix them with a little honey and apply on the skin. Leave on for 5 minutes. Rub gently and wash off with water. Sesame seeds actually have sun protective properties and also soothe sun-damaged skin. Or, mix ground almonds with yogurt. Apply on the face. Leave on for 15 minutes. Then moisten with water and rub gently. Wash off with plenty of water.

HT - HEALTH

Dried and powdered lemon and orange peels, along with dried and powdered mint (pudina) leaves can be added to facial scrubs to help add a glow. In fact, mint also helps to keep the skin clear and prevent eruptions. Apply the mixture on the face and leave on for a few minutes. Then, rub gently, with small circular movements, washing off with water.

For all skin types, make a powder of green tea leaves and mix it with curd and aloe vera gel in equal quantities. Apply on face leave on for a few minutes. Rub gently and wash off with water.

harity Watkins sensed something was deeply wrong when she experienced exhaustion after her daughter was born. At times, Watkins, then 30, had to stop on the stairway to catch her breath. Her obstetrician said postpartum depression likely caused the weakness and fatigue. When Watkins, who is Black, complained of a cough, her doctor blamed the flu.

About eight weeks after delivery, Watkins thought she was having a heart attack, and her husband took her to the emergency room. After a 5½-hour wait in a North Carolina hospital, she returned home to nurse her baby without seeing a doctor.

When a physician finally examined Watkins three days later, he immediately noticed her legs and stomach were swollen, a sign that her body was retaining fluid. After a chest X-ray, the doctor diagnosed her with heart failure, a serious condition in which the heart becomes too weak to adequately pump oxygen-rich blood to organs throughout the body. Watkins spent two weeks in intensive care. She said a cardiologist later told her, "We almost lost you."

As the new Covid variant surges in the U.S., what to know about testing and accuracy

In a study published Jan. 8 in JAMA Internal Medicine, researchers found that nearly 1 in 4 hospital patients who died or were transferred to intensive care had experienced a diagnostic error. Nearly 18% of misdiagnosed patients were harmed or died.

In all, an estimated 795,000 patients a year die or are permanently disabled because of misdiagnosis, according to a study published in July in the BMJ Quality & Safety periodical.

Women and racial and ethnic minorities are 20% to 30% more likely than white men to experience a misdiagnosis, said Dr. David Newman-Toker, a professor of neurology at Johns Hopkins School of Medicine and the lead author of the BMJ study. That's significant and inexcusable," he said.

Researchers call misdiagnosis an urgent public health problem. The study found that rates of misdiagnosis range from 1.5% of heart attacks to 17.5% of strokes and 22.5% of lung cancers.

Weakening of the heart muscle – which led to Watkins' heart failure – is the most common cause of maternal death one week to one year after delivery, and is more common among Black women.

Heart failure "should have been No. 1 on the list of possible causes" for Watkins' symptoms, said Dr. Ronald Wyatt, chief science and chief medical officer at the Society to Improve Diagnosis in Medicine, a nonprofit research and advocacy group.

Maternal mortality for Black mothers has increased dramatically in recent years. The United States has the highest maternal mortality rate among developed countries. According to the Centers for Disease

All you need to know about stomach cancer treatment

orldwide about 1 million people are diagnosed with gastric cancer. It is ranked as the 5th most common cancer. In India it accounts for about 60,000 new cancer cases (6th most common) and about 53,000 deaths.

How is this diagnosed?

This is diagnosed after endoscopic biopsy.

What is the treatment for stomach cancer?

Stomach cancer treatment depends upon the stage of the disease. For early or locally advanced disease this is surgery, chemotherapy with or without radiotherapy. For stage 4 disease this is chemotherapy with or without targeted therapy. Sometimes immunotherapy is also used with or without chemotherapy. This is based on various factors.

How is the choice of treatment determined for stomach cancer patients?

Treatment decisions are based on factors like the cancer stage, tumor location, patient's overall health, and the presence of specific genetic mutations.

Is surgery the primary treatment for stomach cancer? Surgery is often the main treatment for stomach can-



(removal of lymph nodes), and palliative surgery for symptom relief.

Can stomach cancer be treated with chemotherapy? Yes, chemotherapy is often used to shrink tumors before surgery, kill cancer cells, or manage advanced cases of stomach cancer.

Is radiation therapy effective for stomach cancer treatment?

Radiation therapy can be used to target and destroy cancer cells, either alone (to prevent bleeding) or in

Immunotherapy drugs like checkpoint inhibitors can stimulate the immune system to recognize and attack cancer cells.

What is neoadjuvant therapy in stomach cancer treatment?

Neoadjuvant therapy refers to treatment administered before surgery to shrink tumors or improve surgical outcomes.

Can stomach cancer spread to other organs, and how is metastatic cancer treated?

Stomach cancer can metastasize to other organs. Treatment for metastatic stomach cancer may involve chemotherapy, targeted therapy, and immunotherapy.

What is adjuvant therapy in stomach cancer treatment? Adjuvant therapy is given after surgery to kill any

Thyroid Issues And Women's Health:

hyroid Awareness Month, observed every January, serves as a crucial initiative to educate and inform about thyroid disorders. From hypothyroidism to hyperthyroidism, raising awareness fosters early detection and proper management. The thyroid gland is an endocrine gland which is easily visible and felt. It produces 2 hormonesT4 and T3 which are important in regulating our daily activity and metabolism. Thyroid gland dysfunction can lead to problems such as goitre, hypothyroidism or hyperthyroidism.

In an interaction with Zee News English, Dr Shrinath P Shetty, Consultant Endocrinology, KMC Hospital, Mangalore shares how thyroid issues affect women's health and some everyday tips on nutrition, exercise, and stress management to maintain a healthy thyroid.

Dr Shrinath says, "Goitre is more of a structural problem in the thyroid gland which leads to enlargement of the gland. Hypothyroidism and hyperthyroidism are caused by reduced levels of thyroid hormones (T4 and T3) and increased levels of thyroid hormones (T4 and T3) respectively."

Thyroid illness can present in different ways. According to Dr Shrinath, "Patients can present with goitre, hypothyroidism and hyperthyroidism. Although thyroid illness can affect both genders, women tend to present more often to the doctor. This is mainly because women tend to



have more problems like menstrual problems, infertility issues, PCOS (Polycystic ovary syndrome) and pregnancy-related thyroid disturbance. This is compounded by the fact that autoimmune thyroid issues are more common in women compared to men.'

Among the many effects thyroid has on women's health following are some ways as shared by Dr Shrinath:

Infertility: Hypothyroidism can lead to delays in conceiving a child and having a family. Treatment with thyroxine can help these couples in completing their family.

Pregnancy

a) Hypothyroidism - Patients with mild hypothyroidism who do not treatment otherwise need thyroxine supplementation during pregnancy. This is because the growing fetus (baby) is dependent on the mother's thyroid hormones in the initial part of the pregnancy. Thyroid supplementation during pregnancy has shown better outcomes.

b) Hyperthyroidism - It is not so uncommon to see pregnant women with low TSH during the 1st 3 months of pregnancy. This is mainly due to increased HCG levels during pregnancy. It is usually self-resolving, but some of the patients may have underlying hyperthyroidism due to Graves' disease-which needs accurate diagnosis and treatment.

c) Goitre - pregnancy may be complicated with goitre due to increased demand or due to tumours; which need proper evaluation and management. Patients who need thyroid surgery are usually operated on during mid-pregnancy.

Menstrual Irregularities: Hypothyroidism is known to cause irregular menstrual cycles, sometimes increasing bleeding and leading to anaemia (low haemoglobin). Recognition of hypothyroidism and treatment improves the condition. Sometimes women presenting with PCOS may also have hypothyroidism as an underlying cause which needs to be recognized at the right time for better outcomes. Hyperthyroidism can also lead to irregular cycles which improves with thyroid treatment.

Puberty: Undiagnosed hypothyroidism in young adults can lead to early menarche (periods) and short stature. Mildly elevated TSH is commonly seen in the elderly population. Not everyone needs thyroxine supplements. The decision has to be taken based on the underlying aetiology and severity of hypothyroidism.

Intermittent Fasting Can Help Slow Brain Ageing, Boost Longevity: Study


f you want to help slow down your brain from ageing and increase your lifespan then follow diet patterns like intermittent fasting or restrict your calorie intake, suggests a study. A team of scientists at the Buck Institute for 'Research on Ageing' in California have found a role for a gene called OXR1 that is necessary for the lifespan extension seen with dietary restriction and is essential for healthy brain ageing. OXR1 gene is an important brain resilience factor protecting against ageing and neurological diseases, said the researchers in the study, published in the journal Nature Communications.

"When people restrict the amount of food that they eat, they typically think it might affect their digestive tract or fat buildup, but not necessarily about how it affects the brain," said Kenneth Wilson, a postdoctoral student at the Institute. "As it turns out, this is a gene that is important in the brain." The team additionally demonstrated a detailed cellular mechanism of how dietary restriction can delay ageing and slow the progression of neurodegenerative diseases. The study, done in fruit flies and human cells, also identifies potential therapeutic targets to slow ageing and age-related neurodegenerative diseases."We found a neuronspecific response that mediates the neuroprotection of dietary restric-



tion," said Professor Pankaj Kapahi from Buck Institute. "Strategies such as intermittent fasting or caloric restriction, which limit nutrients, may enhance levels of this gene to mediate its protective effects," he added. The team began by scanning about 200 strains of flies with different genetic backgrounds. The flies were raised with two different diets, either with a normal diet or with dietary restriction, which was only 10 per cent of normal nutrition. They found the loss of OXR1 in humans results in severe neurological defects and premature death. In mice, extra OXR1 improves survival in a model of amyotrophic lateral sclerosis (ALS). Further, a series of in-depth tests found that OXR1 affects a complex called the retromer, which is a set of proteins necessary for recycling cellular proteins and lipids. Retromer dysfunction has been associated with age-related neurodegenerative diseases that are protected by dietary restriction, specifically Alzheimer's and Parkinson's diseases. The team found that OXR1 preserves retromer function and is necessary for neuronal function, healthy brain ageing, and lifespan extension seen with dietary restriction. "Diet is influencing this gene. By eating less, you are enhancing this mechanism of proteins being sorted properly in your cells, because your cells are enhancing the expression of OXR1," said Wilson.
