Addressing a programme in India's largest and first-of-its-kind mobility exhibition "Bharat Mobility Global Expo 2024" at Bharat Mandapam here, Modi said "Today, India's economy is expanding fast, and in our third term, our country is bound to become the third biggest economy in the world."

Talking about the automobile industry and its expansion, PM Modi said, "In 10 years before 2014, around 12 crore vehicles were sold in the country. However, since 2014 more than 21 crore vehicles have been sold in the country"

temperature recorded at Gulmarg during February in the past 2 years. On February 12, 2023, the minimum temperature at Gulmarg was recorded at -13.5°C.

Gulmargalso received 10.8 mm of rainfall and 1.2 cm of snowfall during the past 24 hours

Similarly, the tourist hotspot of Pahalgam in South Kashmir witnessed a record low of below 5.8°C against the normal of -6.1°C on Friday. The earlier minimum temperature recorded at Pahalgam was -10.3 °C on February 13, 2023.

It also received 12.2mm of rainfall and 8.5cm of snowfall during the past 24 hours.

Kashmir weather, an independent forecaster, said that Larnoo recorded a low of -17.7°C, Shopian -10.7°C, Kulgam -9.3°C, and Anantnag -8.5°C in south Kashmir. and Sonamarg in Ganderbal district had a low of -15.1°C on Friday.

Qazigund on Srinagar-Jammu National High also witnessed the lowest temperature in the last 16 years at -9.4°C on Friday. The earlier lowest temperature was recorded at -12.2°C on February 13, 2008.

Qazigund also received 17.8 mm of rainfall and 14.0cm of snowfall during the past 24 hours.

Kokernag in south Kashmir also witnessed a record low of -9.4°C on Friday. The earlier lowest minimum temperature at the picnic spot was recorded at -4.6°C on February 13, 2023. It also received 17.1mm of rainfall and 12.2cm of snowfall during the past 24 hours.

Kupwara had a low of -4.4°C, and it was -2.1°C below normal for the frontier Kashmir district on Friday. It also received 0.6mm of rainfall during the past 24 hours.

Srinagar recorded a low of -0.3°C, and it was 0.4°C above normal for the summer capital of Jammu and Kashmir during this period of the season. Srinagar also received 0.4mm of rainfall during the past 24 hours, the MeT office said.

The MeT forecast weather will generally remain dry with the possibility of very light snow at isolated higher reaches today, while from February 3–4, there is a possibility of light to moderate snow or rain (Jammu) at many places in J&K, while the weather will generally remain dry from February 5 to 12. (UNI)

extremely dangerous, as it not only destroys the younger generation but also being used to generate funds to support terrorist activities," Swain said, addressing a monthly crime review meeting here on Thursday. He directed the officers to take strict and well-planned action against the criminals involved in the drug trade.

The DGP also directed them to maintain the record of drug peddlers as well as of drug consumers so that action is initiated in a more comprehensive manner, a police

spokesperson said. Swain impressed upon the officers to make a 'master list' of repeatedly offending vehicles and also directed for indexing of drivers and vehicles found involved in transportation of drugs.

He stressed on the classification of victims, peddlers and dealers and impressed upon the officers to look forward and background linkages benefiting from the past experiences.

During the meeting, the spokesperson said several crucial aspects of improving the investigation and disposal of crime cases particularly drugs and bovine smuggling were deliberated upon.

"The crime picture of a district or zone should highlight the rate of disposal and quality of disposal of the crime cases registered, and to improve the efficiency of crime disposal, we must create a comprehensive, up-to-date and accurate database of the criminals," the DGP

"A robust crime case database will help in utilising the data for investigations," Swain said.

The DGP directed the officers to take strict action against bovine smugglers, as the trade is often associated with various other unlawful activities including transportation of criminals and unlawful material.

"Strict action must be initiated against the vehicle owners whose vehicles are repeatedly used for the trade," he said.

As an added incentive to motivate the officers, the DGP announced that those who demonstrate exceptional performance in the investigations would be rewarded as best district and best police station. (Agencies)

worries of fruit growers and farmers. They said the prolonged dry spell leads to a lack of soil moisture which can badly impact both the quality and yield of fruits, including apples, in the next season.

Ali Mohammad, a fruit trader and expert, said this year January witnessed good temperatures and if the same had continued, there could have been sprouting of buds and flowers very early. "Now the temperature has dropped with the arrival of snow, it will help in better pollination along with fruit set and production,"

Ali said most orchards are rain threads; however, due to prolonged dryness, there would have been no water available for irrigating orchards. Now, there won't be such issues, he said, adding that the dry spell could have also led to pest attacks as lack of moisture and dryness make the fruit trees vulnerable.

Mohammad Ashraf a farmer from Pulwama said that snowfall in winter has a direct connection with the availability of water for irrigation purposes for paddy plantation.

Dr Suhaib A. Bandh, Assistant Professor, Environmental Science at SP College, Srinagar, said prolonged dry weather significantly impacts orchards and fruit crops, posing substantial challenges to the region's agricultural productivity.

The extended dry spells disrupt the natural irrigation patterns essential for fruit cultivation. which leads to diminished water availability for crops, he said, adding that this scarcity hampers the growth and development of fruit trees, reducing their yield and quality.

The dry spell had also raised concerns for mustard crops, with farmers reporting deficiency symptoms due to insufficient rainfall or snowfall.

#### SEC Reviews.....

Kumar, Joint Director Information (HQ) Vevaik Puri, Joint Director RDD Avleen Kour, Assistant Commissioner Relief (Migrant) Riyaz Ahmad, besides senior officers from concerned departments were present in the meeting where as Deputy Commissioners joined the meeting via video conference.

At the outset, the SEC reviewed the district wise status of progress in updating the Panchayat Electoral Roll-2024 and discussed about the issue/difficulties in updating the same.

The SEC extended the period for filing claims, objections, additions, deletions, corrections, and transpositions to 12th February 2024 and asked to organise additional special camps at the polling booth locations on 10th and 11th of this month. He said that Electoral Registration Officers (EROs) will address claims and objections by 23rd February 2024, and the final publication of the Panchayats Electoral Roll 2024 shall be scheduled for 3rd of March 2024.

SEC emphasized upon the concerned officials to gear up their men and machinery to expedite the process of updating the Electoral Roll and achieve the target well in time.

He added that Panchayat Election Booth Officials (PEBOs), including Village Level Workers (VLWs), Multi-Purpose Workers (MPWs). and Gram Rozgar Sevak (GRS), along with Assembly Booth Level Officers shall be available to guide electors with requisite forms and Panchayat Rolls.

measures taken so far for the cleaning, beautification and conservation of this fresh water body. He observed that the lake has the significance of an insignia in terms of the tourism value of Srinagar city and needs our prior attention and focus for development.

He also emphasized upon taking effective measures to control the encroachment in the restricted area. He asked them to enhance the enforcement mechanism and ensure that no illegal structures are raised in the lake area. He called for showing zero tolerance towards any of the unlawful activity deemed detrimental for the health of the lake.

Dulloo called for preserving the environment of the lake besides taking other scientific measures for its conservation. He asked for making concerted efforts to remove the weeds and lily pads from the water surface. He stressed on restricting the untreated waste water into from going into the lake and optimal use of the STPs developed

for preserving the lake from pollution. Regarding the beautification of the lake the Chief Secretary asked for completing all the ongoing projects like installation of aerators and fountain clusters at different spots in the lake. He even asked for making a breakthrough in installation of the musical and high jet fountain in the lake as per the proposal. The Chief Secretary also took note of the implementation of Rs 273 Cr Dal Lake conservation plan which includes components like dredging, catchment area management, development of sewerage network, Eco-parks, Viewing decks/jetties/ghats besides completion of other conservation works.

He even advised for exploring the possibility of the construction of 'Ferris Wheel' in PPP mode inside the lake area. He asked for seeking the consultancy services regarding the best possible mechanism of getting it installed here. He also asked for looking into the establishment of STP at Gupta Ganga as requested by the conservation authority.

In his presentation the Vice Chairperson LCMA, Bashir Ahmad threw light on different measures taken by them to conserve this water body. He also provided details of the projects completed so far and the physical progress of those under execution.

It was given out that the lake area has not decreased as per the earliest possible available records (1985 settlement by Sir Walter L). It was revealed that the area is almost same as per the ETS survey carried out in 2009 and satellite imagery.

Moreover the authority had carried out delineation of Lake boundary for the first time, lbesides carrying out drone survey done through SOI in the years 2020 and 2023.

Regarding taking of other steps it was said that the Bathymetric Survey for scientific deweeding /dredging has been done, plantation of 160000 plants for treatment of catchment area has also been completed.

In the last two years one third of the lake has been rejuvenated, 6.5 Sqkm has been cleared off lily and the open expanse of the Dal Lake has been increased for the first time to more than 20.3 sq

# Women in Kashmir's border district of Kupwara brave all odds to beat winter challenges

KUPWARA, FEB 02: In the border villages of Kashmir's northern district of Kupwara, winter arrives not merely as a season but as a formidable adversary, testing the mettle of the residents, especially women folk.

The snow clad villages in Kupwara become isolated heavens, amidst the biting cold and challenging conditions. But the women here demonstrate a remarkable spirit as they navigate through the winter months.

As the first snowflakes descend, transforming the landscape into a pristine white canvas, the women take on the mantle of ensuring their families endure the winter. With temperatures plummeting to sub-zero levels, their daily routines become a testament to courage and determination.

Halima, 45, a housewife, Pushwari Machil village, told news agency-Kashmir News Observer (KNO) that women wake up before the first light of dawn, to lit wood-fired stoves to warm their homes and prepare for the day ahead. "It's really challenging, but we are used to it now," she beams. She is not alone in this battle against cold as many other women in her community do the same.

The crackling sound of burning wood accompanies the morning ritual, a melody that signifies not just the battle against the winter chill but also defines the borderland communities.

The border women embark on the various tasks that winter demands. One of the most demanding tasks faced by these women is securing water, as freezing temperatures turn local water sources into icy reservoirs.

"One of the biggest challenges for us is to embark on a treacherous journey to fetch water in heavy containers on our heads and shoulders. Walking through snowcovered paths is difficult," said Shaheena Begum

Tabasum, a resident of Badwan Tangdar, the mother of two children, holding a cup of tea in her hand, having students of different classes from her neighbourhood, around her and a heating stove at the corner of the room narrates a tale of courage. "Teaching students is one of the toughest jobs during winter months. Children wither in cold but we ensure heating arrangements for them as they are our future," she said.

She said that schools are often inaccessible during the winter months, so she has taken the responsibility of educating them at home. The living rooms transform into impromptu classrooms, where women become educators, ensuring that the flame of knowledge continues to burn amid the chilling breeze of snow.

"Despite the harsh conditions, the women of Kupwara remain the backbone of their communities, shouldering responsibilities with a quiet strength that resonates through the snowy landscape. Community bonds are further strengthened during the winter months, as women gather in shared spaces to engage in collective

As the snow begins to recede and the promise of spring looms on the horizon, the heroines of Kupwara stand as living testimonials to the strength found within the hearts of those who brave the winter in these borderlands.

# Several migratory bird species of global conservation in Wular Lake at brink of extinction

SRINAGAR, FEB 02: Known for its avian genus, several species of global conservation in Wular Lake are at the brink of extinction.

According to the official documents accessed by the news agency-Kashmir News Observer(KNO) five migratory bird species of global conservation in Wular Lake have been categorized as critically endangered.

These species include Whitebellied Heron, Pink-headed Duck, Baer's Pochard and Kashmir Cat-

Located in the foothills of Harmukh Mountain, Wular Lake is Asia's second-biggest freshwater

The Lake has a total area of 200 square kilometers, with a length of about 24 kilometers and a width of 10 kilometers.

The official documents further reveal that the species like Oriental Stork, White-headed Duck,



White-winged Duck and Blackbellied Tern have been categorized as in endangered category.

Besides, species like Blacknecked Crane, Indian Skimmer, Marbled Teal, Asla and Common

Carp have been seen as vulner-

The documents, while mentioning the species richness, said that in Wular Lake there are 56 types of birds, 39 types of fishes

and twenty plus different types

Stating the threats to the Lake, it reads that the construction of embankments, siltation, pollution and encroachment of Willow

plantation are some of the major threats to the Lake.

Meanwhile, the latest data maintained by the Wetlands of India Portal of the Ministry of Environment, forest and climate change of Government of India, there are two lakes and a wetland in Jammu and Kashmir that have been listed under the threat cat-

The data reveals that the Hokera wetland also known as Hokersar is reeling under the threats of encroachment, invasive species proliferation, pollution and siltation. "Potential threats include recent housing facilities, littered garbage, and demand for increasing tourist facilities."

Similarly, the Wular Lake has also been listed in the threat category wherein the threats like encroachment, hydrological regime alteration, pollution and siltation has been mentioned.

# Dry spell jolts Srinagar's famous floating market, but Srinagar siblings encourage growers continue to feed City with Veg varieties

**SRINAGAR, FEB 02:** A narrow wooden pathway starting from the Chowdary Bagh area of Rainawari leads to a renowned floating market nestled within the heart of Dal Lake in Srinagar. Every morning, prior to the sunrise, hundreds of people from different parts of the capital city visit the market to purchase different kinds of fresh vegetables cultivated in the wet or floating fields within

The farmers offer a variety of vegetables to their customers, who arrive in empty boats, to purchase vegetables like turnips, tomatoes, cucumbers, lotus stems [locally known as Nardoo] among others. These vegetables are later sold at various locations across the city.

"We sell around 200 to 300 kilograms of vegetables to customers every day," Mehraj Ud Din, a farmer who cultivates lotus stems in the famous market, told news agency-Kashmir News Observer (KNO). "This year the production was lower com-city in at least 300 to 400 boats," said

dry spell during the peak winter," he added.

Fifty percent of the crops, Din said, were damaged due to the dry spell. He added that scarcity of snowfall  $and \, rainfall \, had \, a \, financial \, impact \, on \,$ farmers like him making it difficult to earn the amount they deserve.

"We prefer not to use water from the lake due to pollution concerns because contaminated water affects our produce," Din said. "Over last half a decade the situation has worsened to the extent that using this water results in our crops burning due to the presence of harmful chemicals spilled through drains," he added.

Shabir Ahmad Sheikh, a vegetable seller within the floating market of the Dal Lake, told KNO that during the summer over 300 boats belonging to retailers visit the market.

"June-July is our peak season and we supply vegetables to the entire

pared to previous years due to the Sheikh. "During the winter season we hardly find 60 to 70 boats," he said, adding not everyone can make it there due to the intense cold.

"This vegetable market is not merely a place of commerce but a symbol of resilience," Sheikh said. "Farmers as well as our customers face different challenges such as weather uncertainties to ensure regular food supply for the people of Kashmir especially living in Srinagar," he added.

Meanwhile, Din, the grower, revealed to KNO that retailers buy vegetables at one-fourth of the market price.

"We farmers desire to sell our vegetables independently but we lack space for it," Din said. "I as a farmer urge the Government to designate a spot for us where we can directly sell our produce," he said, adding, the initiative would "benefit all parties involved including the general public who would purchase vegetables at a low cost.".

# Draining out water to top dressing, Agri deptt issues advisory to framers post-snowfall

**SRINAGAR, FEB 02:** After fresh agency—Kashmir News Observsnowfall, the Department of Agriculture Kashmir has issued an advisory to the farmers, asking them for necessary maintenance of the fields for better health of crops. A vast area in Kashmir currently is under mustard cultivation, which largely depends on the precipitation during the winter months.

As the valley received a fresh snowfall on Wednesday, the agriculture department has advised the farmers to take various protective measures for protecting crops from diseases.

While talking to the news

er (KNO), Director agriculture Choudhary Mohammad Iqbal said the farmers should essentially drain out the water from the fields. "After snowfall, there is much possibility that water may accumulate in the fields. Stagnation of water leads to various problems in crops. So, the farmers should essentially drain out the water from the fields so that crops, especially mustard, are protected from diseases," he said.

In addition to the draining out of water, the director agriculture said that top dressing should be also done for nutrient require-



ments of crops. "With the top dressing, the crops get abundant nitrogen for normal growth. Farmers should ensure top dressing as soon as possible so that our crops get ample nutrients from the fertilizers," he said.

Iqbal said the rabi crops were in dire need of a wet spell, saying the prolonged dry spell affects its normal growth.

"Snowfall proves a blessing for our rabbi as well as kharif crops. Our soil gets ample moisture during winter months with spells of snowfall and rains. Our glaciers are the source of water, which is used for drinking as well as for

irrigating our crops," he said. Growers are also rejoicing as the valley receives a fresh blanket of snow, providing much-needed relief to the farming community. Farmers had been concerned about the water levels required for their crops, especially in the absence of substantial precipitation from the last two months.

They said the snowfall is a promising sign for a fruitful harvest in the upcoming season.

"This snowfall is like a lifeline for our crops. The moisture from the snow will seep into the soil, replenishing it and providing a much-needed boost for our crops and orchards. We are hopeful for a few more spells of snowfall," said Mohammad Akbar Dar, a grower from Baramulla.

# Where students of South India give priority to science subjects

Some time ago, a study revealed that while students of South India give priority to science subjects, students of North India take more interest in arts subjects. According to the study conducted by the Union Ministry of Education, the data received from various state education boards of class 11-12 in the year 2022 shows that in Tamil Nadu, Telangana and Andhra Pradesh, 1.53,2.01 and 2.19 percent students gave importance to arts subjects. Whereas in West Bengal, Punjab, Haryana, Gujarat and Jharkhand, science subject was the first choice of 13.42, 13.71, 15.63, 18.33 and 22.9 percent students respectively. On the contrary, arts were given priority by 81.5 percent students in Gujarat, 78.94 percent in Bengal, 72.89 percent in Punjab, 76.76 percent in Haryana and 71.23 percent in Rajasthan. This discrepancy also reflects the fact that what is the root cause of shortage of scientists in India and why the pace of increase in the number of patents in the field of original invention has been slow, encourage the field of scienceDespite many efforts of the government, there is a shortage of scientists in almost all the top institutions of the country. At present, the posts of 3200 scientists are vacant in seventy major research institutes of the country. The maximum number of 177 posts are vacant in the institutes associated with the Council of Scientific and Industrial Research (CSIR) in Bengaluru. The posts of 123 scientists are vacant in the National Chemical Laboratory of Pune. This is the situation in these institutions of the country when the government has started many attractive schemes to fill the posts. For research in theseThere is also provision of facilities. Besides, scientists working abroad are being given attractive salary and allowances offers upon returning home. Despite this, neither the students are developing interest in becoming scientists nor has the process of return of scientists from abroad started. In the background of this, on the one hand, there is no confidence among the scientists that the proposals being made will be sustained; second, the tendency of the bureaucracy to create obstructions in the functioning is also becoming an obstacle in creating confidence.Is. In the current scenario, any country can

become strong and capable only through scientific achievements. These achievements also keep human life pleasant and prosperous. India is full of young talents or educated unemployed, yet the number of youth becoming scientists or taking interest in fundamental research is less. One of the main reasons for this is that we are not able to make scientists ideal like players, actors, bureaucrats and politicians. At many levels, sports are given more importance than science. not getting atten $tion This \, is \, a \, major \, reason \, for \, the \, migration \,$ of scientific talents. Obviously, we need to create such an environment which becomes synonymous with fundamental research and research culture. For this, we will have to give importance to those people who are engaged in inventions on the basis of their indigenous knowledge, but due to lack of academic knowledge, their inventions do not get scientific recognition. In fact, here we have the government dominating the field of science and technology, hence it lacks the will to take risks. Whereas, scientific researchThe foundation rests on imagination and transparency, which cannot be achieved without taking risks. Today, in the era of globalization, research and development in the field of science  $and\, technology\, is\, very\, important.\, But\, the$ other sad aspect of the liberal economy is that our high-class science education institutions are not able to attract talent. Most of our talents either migrate abroad. Or join private banks, insurance companies or other management institutions by doing MBA with engineering. Are. That is, talented people who have acquired basic education are forced to work in the opposite work culture. Isn't this contradictory

work culture a betrayal of talent? There was a time when there was shortage of funds in science institutions. But now these institutions are no longer short of funds and resources. Despite this, if the youth are shying away from science, then there may be something lacking in our scientific work culture. The research being done today has a tendency to repeat the work done in the past. The trend seems to be increasing, which is really worrying. Indian institutions are still searching for a place among the top two hundred universities of the world. It is noteworthy here that in the year 1930, when there was foreign rule in India, there was no scientific research in the country. The infrastructure was non-existent. The literature that gave creativity to thoughts was also inadequate. English education was also in its initial stages, despite this, CV Raman worked with the help of simple indigenous equipment on the basis of indigenous knowledge and language and won the Nobel Prize in Physics for the country. SatyendRa Nath Basu worked with Einstein. Meghnad Saha, Ramanujan, PC Ray and Homi Jahangir Bhabha achieved many achievements. APJ Abdul Kalam and K. Scientists like Shivam have also become great scientists by taking primary education in their mother tongue. Jagadishchandra Basu had surprised the world by discovering life in trees with the equipment made by himself, but now despite all the quality improvements in higher education, it is not possible to achieve such new achievements. We are ahead of the West in the field of science and technology.Can't get rid of dominance. However, India's space missions have

emerged as an exception in this direction, in which indigenous technology is being used. In fact, in the last 75 years, our education system has become a victim of such concepts in which understanding and reasoning are not possible. Instead, the method of cramming has developed. Secondly, instead of making the entire education oriented towards ideas and knowledge, it has been made job or career oriented. In our education system, the teacher's skill of cultivating imaginative ideological sources is also more or lessSh is missing. The pressure of English is also frustrating the natural talents. Is. We need to take a lesson from the countries like America, Russia, China and Japan, from which we are lagging behind in the field of scientific research, that their mother tongues are the medium of science and technical education. There, research and invention work starts at the university level itself. If a person with non-academic education materializes an invention, his achievement is immediately taken over by science research institutions. Whereas here we have There is a lack of work culture to encourage or recognize the work. Unless an environment suitable for scientific work culture is created in the country, it is difficult to get ahead in competition with other countries. Besides, our young talents will also not be able to move forward in the direction of becoming scientists. Studies showing disinterest in science subjects are proof of this



# Draining out water to top dressing, Agri deptt issues advisory to framers post-snowfall

Srinagar, Feb 02 (KNO): After fresh snowfall, the Department of Agriculture Kashmir has issued an advisory to the farmers, asking them for necessary maintenance of the fields for better health of crops.

A vast area in Kashmir currently is under mustard cultivation, which largely depends on the precipitation during the winter months.

As the valley received a fresh snowfall on Wednesday, the agriculture department has advised the farmerstotakevarious protective measures for protecting crops from diseases.

While talking to the news agency-Kashmir News Observer (KNO), Director agriculture Choudhary Mohammad Iqbal said the farmers should essentially drain out the water from the fields."After snowfall, there is much possibility that water may accumulate in the fields. Stagnation of water leads to various problems in crops. So, the farmers should essentially drain out the water from the fields so that crops, especially mustard, are protected from diseases," he said.

In addition to the draining out of water, the director agriculture said that top dressing should be also done for nutrient requirements of crops.

"With the top dressing, the crops get abundant nitrogen for normal growth. Farmers should ensure top dressing as soon as possible so that our crops get ample nutrients from the fertilizers," he said.

Iqbal said the rabi crops were in dire need of a wet spell, saying the prolonged dry spell affects its normal

# Rs 86.28 cr earmarked under RDSS to augment Power distribution in Doda District New 132KV transmission line to enhance power supply by 33%: Harvinder Singh

DODA, FEBRUARY 02: Residents of District Doda can anticipate a significant improvement in the power supply as the Revamped/Reformed Distribution Sector Scheme (RDSS) shall replace 719Km barbed/damaged wire, poles, and other equipments/ machinery with the latest and improved infrastructure.

The information was given by District Development Commissioner Harvinder Singh while discussing the rollout of RDSS in the District. It was also informed that a new 132KV Ramban-Khellani-Kishtwar transmission line, slated to be commissioned shortly by the government, promises to alleviate the strain on existing infrastructure and enhance overall reliability. It was estimated that a 33% augmentation is expected in the capacity of overall power supply to the district by the new transmission line. Currently, the region relies heavily on the 132KV Single



DHP line from the Udhampur Grid station for power supply, with the 132/33KV Grid Substation Khellani serving as a critical node. However, with the impending commissioning of the Ramban-Khellani-Kishtwar line, an additional source of power will become available, complementing the existing Dul Hasti Transmission line.

The introduction of this new transmission line is poised

to augment the capacity, providing much-needed relief to the District. This expansion in capacity is expected to mitigate longstanding issues related to power shortage and ensure more stable electricity access for residents and businesses alike.

Rupees 86.28 crores have been earmarked by the government to augment the power distribution system of the district under RDSS, for which a detailed project, after thorough deliberations, has been submitted to the con-

cerned authorities for early approval. Moreover, the completion of the Ramban-Khellani-Kishtwar line signifies a proactive approach to address challenges such as right-of-way (ROW) issues raised by the Power Grid Corporation Ltd.

By rerouting certain lines and resolving logistical hurdles, authorities are demonstrating a commitment towards improving infrastructure and meeting the growing energy demands of the region.

# tudy Reveals How Sleeping Habits **Impact Brain Health, Raise Stroke Risk**



etting either too much or too little sleep is associated with changes in the brain that have been shown to increase the risk of stroke and dementia later in life, according to a study.

The research, published in the Journal of the American Heart Association, focused on two measures of brain health: Matter hyper intensities (WMH), which are lesions on the brain indicating brain ageing, and fractional anisotropy, which measures the uniformity of water diffusion along nerve axons. More WMH, larger WMH, and lower fractional anisotropy are associated with increased risk of stroke and dementia. "Conditions like stroke or dementia are the end-stage result of a long process that ends tragically," said Santiago Clocchiatti-Tuozzo, post-doctoral Fellow at Yale University's School of Medicine, in the US. We want to learn how to prevent these processes before they happen." In one of the largest neuroimaging studies of its kind to date, the team examined brain images of close to 40,000 healthy, middle-aged participants to evaluate how sleeping habits might impact two measures of brain health.Researchers found that compared with optimal sleep (7-9 hours per night), participants with short sleep had higher risk of WMH presence, larger WMH volume where WMH was present, and lower fractional anisotropy. Long sleep (averaging more than 9 hours per night) was associated with lower fractional anisotropy and with larger WMH volume, but not with risk of WMH presence.

"These findings add to the mounting evidence that sleep is a prime pillar of brain health," Clocchiatti-Tuozzo said. "It also provides evidence toward helping us understand how sleep and sleep duration can be a modifiable risk factor for brain health later in life."Researchers said the study highlights middle age as an important time to adjust our sleeping habits to support brain health. They aim to serve our people through improved healthcare services. Our government plans to set up more medical colleges by utilising the existing hospital infrastructure under various departments. A committee for this purpose will be set up to examine the issues and make relevant recommendations," Sitharaman added.

According to the World Health Organization (WHO), "Cervical cancer is the fourth most common cancer in women. Effective primary (HPV vaccination) and secondary prevention approaches (screening for, and treating precancerous lesions) will prevent most cervical cancer cases."

When it comes to treatment, the WHO says that "when diagnosed, cervical cancer is one of the most successfully treatable forms of cancer, as long as it is detected early and managed effectively. Cancers diagnosed in late stages can also be controlled with appropriate treatment and palliative care."In her Interim Budget speech, Nirmala Sitharaman said "our government will encourage vaccination for girls in the age group of 9-14 years to prevent cervical cancer".

Experts recommend limiting time spent on social media to preserve your mental health.

Advertising on social media has become increasingly popular across all industries, including food brands.

However, there is growing evidence to show that some food-related content is having harmful effects on users' mental health.

According to a new study, young adults who were exposed to junk food content on Instagram experienced cravings for unhealthy foods and negative mental health effects. The findings were recently published online in the journal Appetite.

Researchers observed 63 participants ages 18 to 24 years old who were separated into two groups. One group looked at a standard Instagram feed and the other looked at a feed



with junk food images for 15 minutes. Next, participants answered a survey, which included questions about body image perception, mood, and food cravings. Then 7 days later, they looked at the other Instagram feed and answered the survey questions again.Results showed participants who were exposed to junk food content had increased cravings for salty and fatty foods. They also experienced increased feelings of stress, sadness, exhaustion, and hunger.

Neither Instagram feed affected body image perception, the study

"Constant exposure to food advertisements on social media certainly can impact our perception and relationship with food," said Dr. Nicole Avena, nutrition consultant, assistant professor of neuroscience at Mount Sinai School of Medicine, visiting professor of health psychology at Princeton University, and author of "Sugarless."

"Seeing your favorite celebrity enjoying a specific junk food through a paid advertisement may incline you to choose similar food options. Similarly, seeing your favorite influencer enjoying healthy and nutritious foods may influence you to choose healthier options," Avena added.

Social media may also impact our relationship with food through com-

"Social media typically focuses on highlights and near-perfect content and advertisements; however, this is not an accurate representation of real life," Avena explained.

# Women With PCOS More Likely To **Have Memory Problems: Study**

from polycystic ovary syndrome may be more likely to have memory and thinking problems in middle age, according to new research. The study, published in the online issue of Neurology, does not prove that polycystic ovary syndrome causes cognitive decline. It only shows an association.

Polycystic ovary syndrome is a hormonal disorder that is defined by irregular menstruation and elevated levels of a hormone called Androgen. Other symptoms may include excess hair growth, acne, infertility and poor metabolic health. It is a common reproductive disorder that impacts up to 10 per cent of women. While it has been linked to metabolic diseases like obesity and diabetes that can lead to heart problems, less is known about how this condition affects brain health. "Our results suggest that people with this condition have lower memory and thinking skills and subtle brain changes at midlife.



This could impact a person on many levels, including quality of life, career success and financial security," said Heather G. Huddleston, from the University of California, San Francisco.

The study involved 907 female participants who were 18 to 30 years old at the start of the study. They were followed for 30 years, at which time they completed tests to measure memory, verbal abilities, processing speed and attention.

At the time of testing, 66 participants had polycystic ovary syndrome. The

# BARTLETT MAKES A MASSIVE IMPACT ON 'ALMOST NOT REAL' AUSTRALIA DEBUT

# "HE LOOKED LIKE HE BELONGED," SHAI HOPE SAYS OF XAVIER BARTLETT

**LONDON:** No one predicted Xavier Bartlett would be playing for Australia this summer. Not even Xavier Bartlett.

The fact that he made his debut in an ODI, having not played a 50-over List Agame for Queensland since September 2022, makes it even more remarkable. Before the BBL, where he dominated the tournament taking 20 wickets in Brisbane Heat's title win, Bartlett did not play a single game for Queensland in any format as he was coming off a back injury.

But, at the MCG on Friday, he looked like he had been playing international cricket for years as he scythed through West Indies' top order to claim 4 for 17, the second-best figures by an Australian man on ODI debut.

He admitted he had no thought at the start of the summer, or even during the early part of the BBL, that he was even close to Australia selection.

"Oh, definitely not," Bartlett said. "We've got so many great fast bowl-

ers at the moment. Obviously, [Mitchell|Starc,[Josh]Hazlewoodand[Pat] Cummins are probably the top three to ever do it for Australia or in that conversation. And then I only really got my chance through Jhye Richardson's injury and Nathan Ellis was injured as well.

"There's definitely a long list of people in front of me. But I've just got to keep trying to do my best for Queensland, and if I get an opportunity at the higher level, just

try and take it and just sort of almost learn as much as I can as well along the way."

Despite his BBL success, the thought had dawned on him that he had not played any 50-over cricket since September 2022, which added to his pre-game nerves.

"Yeah it did," Bartlett said. "I spoke to someone on the phone and I was like 'I haven't played a 50-over game in like 15 or 16 months'. Yeah, I mean ... I don't know. It just sort of happened so fast. "I was injured at the start of this year and didn't have a chance to play any domestic cricket, which was a frustrating time. But you can kind of see the light at the end of the tunnel and you've just got to keep trying to work hard because these days don't happen very often in the game of cricket."

It was serendipitous that Australia's selector on duty, Tony Dodemaide, had been the one to tell Bartlett he would make his international debut. Dodemaide's 5 for 21 against Sri Lanka in 1988 remains the best figures on ODI debut by an Australian, but Bartlett was happy to slot in behind him in second spot.

"We were sitting in there watching the boys bat and it floated up on the screen," Bartlett said. "Some of those names, to just be alongside them, it's pretty cool. [Dodemaide] didn't say anything. I just had a little picture with him just then."

West Indies captain Shai Hope was one of Bartlett's four victims, having nicked a good length outswinger to first slip during the powerplay. He had watched footage of Bartlett in the lead-up but was very impressed by the real thing.

"He's shown that he's got the ability to perform at this level," Hope said after the match. "Not the quickest, but as we see you don't need pace to be disruptive. He was very, very consistent. He bowled really well, especially for his first game. He looked like he belonged. We know as a West Indies group we have to find a way to not allow him to settle for the next game."
