DUBAI, FEB 14: Prime MinisterNarendraModionWednesday emphasised that his biggest principle has been "minimum government, maximum governance" and noted that it is the government's job to ensure minimal government interference in people's lives.

Addressing the World Governments Summit 2024 in Dubai, PM Modi called for reform in the Global Governance Institutions and said there is a need to promote the concerns of the developing world and the participation of the Global South in global decision-making.

"My biggest principle has



been 'Minimum government, maximum governance'. I have always emphasised creating an environment in which a sense of enterprise and energy in citizens grows. I believe that it is the job of the government to ensure that government interference in people's lives is minimal," he said.

PM Modi also referred to challenges which were posed by COVID-19.



IIT Jammu Develops Anti-Drone System

JAMMU, FEB 14: Dr Karan Nathwani, professor in the Electrical Engineering department of IIT Jammu, has constructed an anti-drone system that works mainly on sound technology.

"It is the first of its kind, and we have developed an entirely new technology called sound-based detection. This system detects the sound emitted by drones, producing a unique signature that helps in their identification. We compare this signature with the system's database, and if a match is found, the drone is detected. The cost of this system is about Rs 4 lakh," he said.

"Not only is it cost-effective, but it is also user-friendly, making it accessible to the general public. It is easy to operate, and there are no issues with cameras or radar. The system TURN ON PAGE 02



February 14, 2019 marks five years since the Pulwama terror attack, when 40 valiant Indian soldiers were killed after a suicide bomber rammed an IED-laden vehicle into the security convoy carrying them.

Days after the attack, the Indian Air Force carried out multiple aerial strikes on February 26, 2019, at JeM terror camps in Pakistan's Balakot, killing a "large number" of terrorists and destroying their infrastructure.

The air strike was launched in the early hours of February 26 and Pakistan's efforts to launch an offensive the next day to target Indian military installations in Jammu and Kashmir were thwarted by an alert IAF.

In the dogfight, Wing Commander Abhinandan Varthaman, flying a MiG-21 Bison fighter plane and chasing Pakistani jets, crossed over to PoJK, where his aircraft was shot down. He was taken into custody by Pakistan. India also shot down a Pakistani fighter jet.

External Affairs Minister S Jaishankar also paid tributes to the brave soldiers "Pay homage to our brave jawans who laid down their lives this day in Pulwama in 2019. Their courage motivates us to keep up our vigil against cross-border terrorism."

Union Minister Rajeev Chandrasekhar recalled the valiant sacrifice of the soldiers "Today, we pause to remember and salute the brave CRPF soldiers who made the ultimate sacrifice in the Pulwama Terrorist attack while in service to the nation. It was then, one of his relatives informed him about the State Marriage Assistance Scheme (SMAS) being implemented in Jammu and Kashmir to financially help the underprivileged women.

"The amount disbursed by the social welfare department helped us a lot. My daughter got married last year and we managed to buy essential items required for the wedding rituals." he said.

In Jammu and Kashmir, scores of the financially underprivileged families avail the benefits of the SMAS to get their daughters married.

As per the figures accessed by KNO, a total of 18976 under privileged women from Kashmir have availed the benefits of the scheme since its inception in 2015.

Data reveals that 1220 beneficiaries have availed the benefits of the scheme in Srinagar. From Baramulla, the social welfare department sanctioned 3306 cases under the scheme.

In Bandipora and Kupwara, as many as 2456 and 1857 women, respectively, have availel benefits under the scheme.

Social welfare department has sanctioned 1118 cases in Ganderbal. In southern Kashmir's Pulwama, Anantnag, Shopian and Kulgam, 1593, 2370, 894 and 2084 women, respectively have availed benefits under the scheme.

SMAS is a Social Assistance Scheme implemented by the Social Welfare Department to financially assist un-married identified women in Jammu and Kashmir who belong to the below poverty line category.

Jammu and Kashmir Administrative Council headed by Lt Governor Manoj Sinha earlier in 2022 restructured the State Marriage Assistance Scheme to provide benefits to all AAY and PHH families.

As per the restructured scheme, any girl of legally marriageable age belonging to the families of Antyodaya Anna Yojana (AAY), or Priority Household (PHH) ration card holders, will be eligible for one-time financial assistance of Rs 50.000.

An official said the number of beneficiaries under the scheme has been increasing every year.

"Throughout Jammu and Kashmir, scores of underprivileged women apply for the scheme and their cases are being speedily approved. The department after official verifications disburse the amount to the beneficiaries," he said.

Bhat was a top commander of militant outfit Hizbul Mujahideen when the group declared a ceasefire in July 2000, which was reciprocated by the Centre.

In May 2022, the court of Special Judge designated under NIA Act Srinagar framed changes against the separatist leader and seven others for allegedly procuring medical seats in Pakistan for Kashmiri students in lieu of money which was "partly used" to "support and fund terrorism and separatism in different ways".

A spokesman of the ED on Wednesday said the three were arrested in connection with money laundering case wherein accused persons involved in terror financing were handin-glove with Pakistani handlers Manzoor Ahmad Shah and Altaf Ahmad Bhat, who arranged admissions in MBBS & other courses in the colleges of Pakistan for students from Jammu & Kashmir.

The trio have been remanded to ED custody till February 20.

The ED initiated money laundering investigation on the basis of FIR registered by J&K Police for offences under various sections of Unlawful Activity (Prevention) Act and IPC, 1860 against Mohammad Akbar Bhat, Fatima Shah, Altaf Ahmad Bhat, Qazi Yasir, Syed Khalid Geelani alias Khalid Andrabi & others involved in terrorist activity in Jammu & Kashmir.

The ED investigation revealed that the arrested accused persons were hand in glove with Pakistani handlers in the guise of admissions in MBBS & other courses in the colleges of Pakistan for students from Jammu & Kashmir.

"They had received money in their personal accounts and in the bank accounts of Al-Jabar Trust which was a charitable trust," the ED said. " But it was being used for the purpose of receiving funds from students, which were further being ploughed into the terrorist activity in India in various ways such as given money to stone pelters, providing money to the persons/terrorist based in Jammu & Kashmir as per instructions of Pakistan handlers such as Manzoor Ahmad Shah, Altaf Ahmad Bhat etc.'

He further said that our security forces need a foolproof anti-drone Grid system on IB and LOC and many anti-drone technologies have already been installed and are being developed.

"We can provide this system to the army only when they provide us with data from similar environments, allowing our AI technology to incorporate and adapt," Dr Nathwani said.

With the help of this sound-based drone detection system, this device will be able to easily detect drones, aircraft, multiple drones or birds flying up to 300 meters by their sound. The cost of making this drone ranges from Rs 25 to 40 thousand. (Agencies)

Action against recently appointed MTS staff possessing higher qualification

SRINAGAR, FEB 14: The Jammu and Kashmir government has sought details from its offices across the Union Territory about the reported higher qualification being possessed by the Multi Tasking Staff appointed in the year 2022. Reports inform that it has come to the notice of the LG administration that several complaints have been received wherein it has been alleged that a portion of selected/ appointed candidates were in possession of qualification higher than the prescribed one as on the relevant cut-off date. The government has asked the Departments to initiate urgent appropriate action in all such cases and also act against the delinquent candidates under norms.

As per the news agency-Kashmir News Observer (KNO), the Minimum and Maximum qualification prescribed for appointment to Class-IV/MTS posts, as per the Jammu and Kashmir

Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020, is "Matric and 10+2" respectively. Pursuant to the indent placed by the General Administration Department on 22.06.2020, the J&K Service Selection Board (JKSSB) advertised 8575 Class-IV/MTS posts vide Notification No. 01 of 2020 dated 26.06.2020 and prescribed 28.08.2020 as the last date for applying in online mode for the posts advertised.

According to the JKSSB, candidates, while filling the application forms, submitted "Self-Declaration" that they are in possession of the prescribed qualification as per the advertisement/ notification issued by the Board and also submitted an "Affidavit" to the Board at the time of verification of documents, affirming therein, that they were not in possession of qualification higher than the one prescribed

for the post as on cut-off date of 28.08.2020 i.e. the last date for applying in online mode for the posts advertised by the Board.

The J&K SSB, while forwarding the recommendations of the selected candidates, also advised the concerned appointing authorities that they shall satisfy themselves about the fact that the candidates are in possession of the 'prescribed minimum(10th) and maximum qualification (12th) as on the said cut-off date before issuing the appointment orders and in case it is found that any candidate is possessing qualification higher than the prescribed one as on the said cut-off date, the Board may be intimated so that criminal proceedings against such . candidate(s) can be initiated by the Board. However, reads an official communication in this regard, several complaints have been received wherein it has been alleged that a few selected/appointed candidates were in

possession of qualification higher than the prescribed one as on the relevant cut-off date.

"In view of the above, it is enjoined upon all the concerned Administrative Departments to immediately examine all such cases to ensure that the candidates appointed as Class-IV (MTS) on the recommendations of the J&K Service Selection Board (JKSSB) were not in possession of qualification higher than the one prescribed in the relevant rules as on the above cut-off date as prescribed by the Board while advertising the Class-IV(MTS) vacancies vide Notification No. 01 of 2020 dated 26.06.2020 and, if there are cases in which appointment orders have been issued in violation of the relevant rules, the Departments shall initiate urgent appropriate action in all such cases and also act against the delinguent candidates under norms," reads an official order

SMART CITY'S E-BUS TRAVEL: PASSENGERS CAUGHT WITHOUT TICKET TO BE PENALIZED

SRINAGAR, FEB 14: Srinagar City's e-bus transportation system has announced measures to curb fare evasion and ensure a fair system for commuters, saying that those travelling without a ticket or pass will now incur a penalty ten times the legal fare or a flat fine of Rs 500, officials said on Wednesday.

The penalty clauses, according to the news agency–Kashmir News Observer (KNO), outlined by the smart city authorities,

specify that under Penal Action 178, passengers found travelling without a valid ticket or pass can face fines up to Rs 500.

Additionally, penal action 178/1 addresses misbehaviour, obstruction to checking officers in the discharge of their duties, and refusal to provide information also carry fines up to Rs 500.

Emphasizing the importance of adherence to fare regulations, officials clarified that the legal fare would be calculated from the



originating point to the destination of the commuter's trip. As per the Srinagar Smart lished as Up to 0–3 Km: Rs 10,

03-05 Km: Rs 15, 05-10 Km: Rs 20, 10-15 Km: Rs 25, 15-20 Km: Rs 30, 20-25 Km: Rs 35 and 25-30 Km: Rs 40.

The official said that these measures aim to ensure fair payment for transportation services and discourage fare evasion. "Commuters are urged to comply with these regulations to avoid penalties and support the city's efforts toward a reliable and equitable transportation system", said an official.

Confronting the Epidemic of Sexual Assault on Minors

The recent conviction of a man for sexual assault in Handwara, with a sentence of 10 years imprisonment and a fine of fifty thousand rupees, casts a glaring spotlight on the escalating crisis of sexual violence against minors in Kashmir. This verdict serves as a stark reminder of the urgent need for comprehensive societal, legal, and educational reforms to safeguard the most vulnerable among us.

Sexual assault on minors is not just a crime, it is a heinous violation of trust, innocence, and basic human rights. Each reported case reflects countless others shrouded in silence, underscoring the pervasive nature of this grave issue. The trauma inflicted upon the victims resonates far beyond the confines of individual incidents, leaving lasting scars on their physical, emotional, and psychological well-being.

The Handwara verdict must catalyze proactive measures aimed at prevention, prosecution, and rehabilitation. Strengthening legal frameworks to ensure swift and stringent punishment for perpetrators is imperative. However, legal recourse alone is insufficient without parallel efforts to address root causes.

Prevention is equally crucial in combating this epidemic. Comprehensive sex education programs must be integrated into school curricula to empower children with knowledge about consent, boundaries, and safe practices. Parents, educators, and community leaders must engage in open dialogue to dismantle the culture of silence and stigma surrounding sexual violence, creating an environment where survivors feel empowered to speak out and seek help without fear of judgment or reprisal.

Moreover, it is incumbent upon every member of society to actively challenge and confront attitudes and behaviors that perpetuate gender-based violence and exploitation. By fostering a culture of respect, empathy, and accountability, we can create a safer and more equitable future for our children.

The conviction in Handwara serves as a stark reminder of the urgent need for collective action to combat the scourge of sexual assault on minors. The Himalayas are identified as one of the global biodiversity hotspots, with high species richness due to ecological, phytogeographic, and evolutionary factors. For populations living in mountainous locations, collecting and, more lately, marketing MAPs has offered a significant source of income. The long-term viability of such plants is inextricably linked to future Himalayan potential. Plants are still used for primary healthcare in many cultures around the world, and medicinal herbs have long been used in traditional healthcare systems. With recent developments in plant sciences, the usage of plant-based health products has increased dramatically in both developing and industrialized countries. Around the world, 70–80% of people use medicinal plants as their primary health care. Kashmir Himalayas has a diverse range of medicinal plants due to topographical diversity.Jammu and Kashmir (J&K), an Indian Himalayan state, is rich in biodiversity with a rich medicinal flora. The Kashmir valley referred to as Terrestrial Paradise has abundant biodiversity that adorns Kashmir's beauty. The region is endowed with a rich diversity of medicinal plants due to its phyto-geographical location within the North-Western Himalayas. The scientific documentation of medicinal flora diversity, distribution, and traditional usage could be crucial in the conservation and long-term utilization of these valuable plant resources in this Himalayan state. Some of the medicinal plants that are widely found in Jammu and Kashmir include Aconitum heterophyllum, Berberis aristata, Artemesia absinthium, Atropa acuminata, Trillium govanianum, Saussurea costus, Picrorhiza kurroa, Withania somnifera, Acorus calamus; among the most significant

aromatic herbs are Levandula officinalis, Rosmarinus officinalis, Organium vulgare, Podophyllum hexandrum, Hippophae rhamnoides, Dactylorhiza hatagirea, and Arnebia benthamii. Medicinal and aromatic plants (MAP) conservation and production are becoming increasingly important. In India, MAPs are collected/cultivated in a variety of climate and soil conditions, ranging from the seacoast to the high Himalayas. The preservation and development of medicinal and aromatic plants is a top priority in Jammu, Kashmir, and Ladakh, which represent temperate, alpine, and cold dry region zones.The medicinal plant market is still developing and is largely unregulated. Local residents in the region collect and trade medicinal herbs in order to meet their basic requirements for livelihood. According to local medicinal plant collectors and traders, demand for particular species such as Aconitum heterophyllum, Angelica glauca, Podophyllum hexandrum, Ephedra gerardiana, and Saussurea costus is quite high, but supply is low due to rare populations and lack of cultivation. Medicinal plants are rapidly becoming valuable bio-resource. Without a doubt, their effectiveness

in managing human ailments while causing no negative effects has earned a widespread reputation for these useful species. Given the high cost and side effects of modern medicine, traditional knowledge and practices of medicinal plants against various diseases, such as asthma, diarrhoea, throat infections, rheumatism, ulcer, poliomyelitis, abdominal pain, body swellings, cough, burns, wounds, allergies, general weakness, etc., are extremely important. Some of the medicinal plants, including Rheum species, Artemisia species, Ephedra species, and Salvia species, have been demonstrated in recent scientific studies to be useful in treating COVID-19. The growth of sustainable medicinal herbs offers a great chance to capitalize on the growing market while guaranteeing a consistent supply for local communities. Industry growth strategy for herbal medicine over 100 million hectares of wastelands are currently idle, depriving the income generating options while also posing a major threat to the ecosystem and environment. These kinds of lands can be used to grow medicinal herbs, which are in high demand. Establishing contact with bulk consumers can help to boost commercial medical herb cultivation. The following actions are recommended for a successful promotion of the herbal medicine business in Jammu & Kashmir.

Plant species with therapeutic characteristics need to be identified and herbariums should be established.

Assessment of demand & supply status relating to medicinal plants.

Standardization of propagation and cultivation procedures in order to produce superior grade herbal materials.

Validation for the use of numerous medicinal herbs in the treatment of various ailments, as well as standardization of protocols and documentation.

Assisting collectors and growers to store, transport and market their herbal products.

Research to develop effective herbal medications to treat diverse ailments, particularly newly emerging diseases, should be strengthened.

Herbal medicine should be taught as a core subject in medical schools that deal with various systems.

Popularization of diverse herbal medications through workshops, training, social marketing, and public awareness. Establishing primary processing, grading, marketing, and other facilities in coordination with local stakeholders and organizations.

Traditional healers and Ayurveda practitioners should be supported through knowledge sharing, networking, the provision of superior quality germplasm, and connections with farmers for raw material supply.

The demand for medicinal herbs has risen dramatically in recent years on both national and international markets. Traditional medicines have seen a return in popularity in recent decades, both as alternative cures and in the pharmaceutical industry. There seems to be a lack of attention in current research to maintain the sustainable use of these valuable plant species. Plant species that only grow in the wild and are not cultivated, need to be conserved. The long-term protection and sustainable use of their source species must be prioritised if plant elements to promote human health are to be made available in the future.



BJP Renominates Only 4 of 28 Outgoing Rajya Sabha MPs

New Delhi: Many senior BJP leaders and outgoing Rajya Sabha MPs, including seven Union ministers such as Dharmendra Pradhan and Bhupender Yadav, have not been renominated by the party for the biennial Rajya Sabha polls amid strong indications that several of them may contest the upcoming Lok Sabha elections.

With the ruling party naming 28 candidates for the elections to 56 seats, their profiles underscore the BJP's determination to recognise its grassroots organisation workers, who might not be much known in outside political circles, while factoring in social equations as well.

Three of the new names -Dharmshila Gupta of Bihar, Medha Kulkarni of Maharashtra and Maya Naroliya of Madhya Pradesh - are associated with the party's 'Mahila Morcha' (women's wing), in keeping with Prime Minister Nar-

No outgoing Rajya Sabha member of the BJP who has served two or more terms has been repeated, except Mr Nadda, who is set for a third term.

Notably, none of the party's national office-bearers figure among the 28 soon-to-be Rajya Sabha MPs, even though many of

their lower-profile state organisation leaders have made the cut.

"I will call it decentralisation and democratisation of the selection process. The visibility that comes with moving around in political circles in Delhi or comments to the media makes no difference to the current national leadership," a senior party leader

Rajeev Chandrasekhar, Mansukh Mandaviya, Parshottam Rupala, Narayan Rane and V Muraleedharan are five other ministers whose term is ending in the Upper House and who have not been renominated by the BJP.

Other senior leaders who have not been repeated are the party's chief spokesperson and its media head Anil Baluni, former Union minister Prakash Javadekar and former Bihar deputy chief minister Sushil Kumar Modi.

Several of them are being talked about within the party's circles as probable candidates for the Lok Sabha elections expected to be held in April-May.

Ms Gandhi, 77, will not, however, withdraw from public life just yet; this is not a retirement but a repositioning, of sorts. She will move to the Rajya Sabha.

She filed her nomination papers from Jaipur in Rajasthan today and will take over - the Congress has the numbers to guarantee her election - the seat now held by former Prime Minister and party stalwart Manmohan Singh, who may retire

Modi Govt trying to suppress voice of farmers: Rattan Lal Gupta

Arvind Kejriwal Summoned By Probe Agency For 6th Time In Liquor Policy Case

New Delhi: Delhi Chief Minister Arvind Kejriwal has received a sixth summons from the Enforcement Directorate, sources told NDTV Wednesday evening. Mr Kejriwal has been asked to appear on Monday for questioning in connection with the liquor excise policy case in the national capital.Mr Kejriwal has skipped the five earlier summons, setting up a court battle with the probe agency and raising the prospect of the Aam Aadmi Party boss being the first sitting chief minister to be arrested. The sixth summons by the ED - investigating money laundering charges - comes a week after a Delhi court



directed Mr Kejriwal to appear on Saturday, and explain why he has skipped summons so far. The AAP, which claims Mr Kejriwal is being targeted by the BJP ahead of the 2024 Lok Sabha election - welcomed the order; party sources told NDTV "we will tell the

court how the summons are illegal".Mr Kejriwal snubbed the fifth summons on February 2. He skipped another on January 31, and three others - on January 19, December 21, and November 2. The AAP leader cited various reasons, apart from the illegality of the ED's notices, including campaigning for the Madhya Pradesh election.Mr Kejriwal has been questioned by the Central Bureau of Investigation; this was in April. He is not an accused so far. "CBI asked 56 questions (but) everything is fake. Am convinced they don't have a single piece of evidence," he had said. However, two senior AAP members, including ex-Deputy Chief Minister Manish Sisodia, have been arrested. Mr Sisodia was arrested in February last year and Rajya Sabha MP Sanjay Singh.

ROHIT SHARMA TO CAPTAIN INDIA IN THIS YEAR'S T20 WORLD CUP

RAJKOT: India will be playing the T20 World Cup 2024, to be organised in the Caribbean and the USA, under the captaincy of Rohit Sharma, said BCCI secretary Jay Shah at an event here on Wednesday.

India have had Hardik Pandya as their full-time skipper in the shortest format but the heartbreaking loss in the final of the 2023 World Cup to Australia have reignited the murmurs of senior batters Virat Kohli and Rohit returning for the

T20 showpiece in June.

"In 2023 (final) at Ahmedabad, even though we did not win the World Cup after 10 straight wins, we won hearts. I want to promise you that in 2024 (T20 World Cup) in Barbados (venue for the final), under Rohit Sharma's captaincy, ham Bharat ka jhanda gaadenge (we will hoist the Indian flag)," Shah said at the end of his speech.

Shah was present at the Saurashtra Cricket Association Stadium in Khanderi,

which was renamed after veteran cricket administrator Niranjan Shah, as the chief guest.

Shah made a speech in front of a gathering of several dignitaries including former India captains Sunil Gavaskar and Anil Kumble and IPL chairman Arun Dhumal.

The event also featured current chief selector Ajit Agarkar, incumbent head coach Rahul Dravid, Rohit, Mohammed Siraj, Ravindra Jadeja, Axar Patel and a

few members of the Indian team support staff.

Rohit Sharma is the third-highest run-getter among Test openers since he started on the job against South Africa five years ago. He has 2242 runs in 49 innings just below Dimuth Karunaratne (2358 in 48 innings) and David Warner (2328 in 58). His average, 48.73, is third among openers with more than 2000 runs in the period.

Rohit has been among the consistent

run-getters since becoming an opener. At home, he averages a tinge above 52 and has five centuries, the last one being against Australia in Nagpur. Which is why, there have been questions about his on-field tactics against England in the first two Tests and red-ball captaincy in general, but not about the fact that Rohit has not crossed the 40-run mark in eight innings (13, 14, 39, 24, 16*, 39, 0, 5). Or about how he hasn't scored a fifty in the last five Tests he played.
