



Sources in the BJP said that the Prime Minister will be addressing a mega public rally on February 20 at Jammu's M A Stadium having a seating capacity of around 25,000 spectators.

Sources revealed that the Modi will also be inaugurating a series of development projects including All India Institute of Medical Sciences (AIIMS) at Vijaypur in Samba, the highest Railway Bridge, linking Kashmir with rest of the country this year, in Reasi district, Devika Rejuvenation project at Udhampur, IIM Jammu and Shahpur Kandi Redevelopment Plan in Kathua.

'The Prime Minister will be e-inaugurating these projects," adding party sources said that e-foundation stones of various other development works in Jammu and Kashmir will also be laid by the Prime Minister.

They said that before his scheduled Jammu rally and other programmes, Modi is also expected to meet the party's I&K cadre at New Delhi on February 17-18

during a two-day Working Group meeting. "A Two-day national convention is to be convened in Bharat Mandapam on February 17-18, coinciding with the upcoming Lok Sabha election which will be inaugurated by BJP National President J P Nadda and concludes with Prime Minister Narendra Modi's closing address," they

The sources said that Modi's visit to Jammu and Kashmir could boost BJP's prospects in the Union Territory ahead of Lok Sabha election as the party is eyeing three seats.

BJP for two consecutive terms in 2014 and 2019 won two Lok Sabha seats from

Union Minister of State in the Prime Minister's Office (PMO) Dr Jitendra Singh won the Udhampur-Kathua seat and Jugal Kishore Sharma won Jammu-Poonch seat in the last two Lok Sabha polls.

"The party this time is eyeing third seat Anantnag-Poonch-Rajouri which has a large number of Pahari votes to whom the Government accorded ST status in the just concluded Parliament session," said a BJP

Meanwhile tight security is in place for the smooth conduct of the Prime Minister's

All vehicles passing nearby the venue located in the heart of Jammu city--are being frisked and special check posts are installed along the River Tawi bank-adjacent to the M A Stadium.

"Security forces are on alert and are

The meeting was attended by CEO, Smart City Limited/VC SDA/ Commissioner SMC, Dr Owais Ahmad; MD SRTC; RTO Kashmir; SSP Traffic City; SSP Rural and Representatives of various Transport Associations.

Speaking on the occasion, Div Com asked transporters to upgrade their services and coordinate with the officers of Smart City, SRTC & RTO Kashmir and ensure their vehicles ply till late in evening on all

The transporters apprised the meeting about different grievances and issues faced by them. They demanded a comprehensive Transport Policy for UT and regulation of unregistered service providers and a policy for E-Rickshaw Autos.

On the occasion, Div Com enjoined RTO Kashmir to take lead to frame a detailed plan and a timetable in consultation with other stakeholders. He said that passengers should be aware about the time of arrival and departure of buses at any stop in City.

He emphasized on private transporters to come forward and take part in water transportation which shall help in minimizing traffic congestion.

Meteorological Centre Srinagar said under the influence of WD, an extended wet spell from February 17 night onwards till February 21 afternoon is most likely to cause moderate rain and snow at many places over J&K and adjoining areas.

The main activity of the WD is likely to occur on February 19–20.

During this period, there is a possibility of light to moderate rain or snow at most places, including plains and lower reaches, with the possibility of heavy snowfall over the middle and higher reaches of Kupwara, Baramulla, Bandipora, Ganderbal, Badgam, Shopian, and Kulgam districts, the MeT office said.

It said that there is a possibility of light to moderate snow at many places till the afternoon or late afternoon and gradual

improvement thereafter on February 21. A significant drop in daytime temperature is also expected during the peri-

An independent weather observer, Faizan Arif, said a strong WD is going to affect Iammu and Kashmir from the night or morning of Sunday onwards, and under its influence, moderate to heavy rain and snow are expected in the region.

Initially, there can be rain only on the plains, which can transform into snow later on February 18 or 19.

"There is uncertainty about whether it will continuously snow in the plains as temperatures may again rise on February 19 afternoon. However, for higher reaches, it is going to dump heavy to very heavy snowfall till February 20," he said, adding that "over 5 feet of snow accumulations can also happen in a few areas."

He predicted the total amount of snow accumulation at Sadhna Top in north Kashmir's Kupwara district may be 10–12 feet and is likely to get closed for a long time now. A similar situation is expected for Razdan Pass in Bandipora district and Sinthan Pass in Kishtwar district of Jammu

For plains, if snow occurs and accumulates, it will be slightly denser and have the potential to cause damage.

The wet weather may cause landslides and shooting stones over the Jammu-Srinagar National Highway between February 18-21.

Meanwhile, the MeT office said the minimum temperature during the intervening nights of Wednesday and Thursday in Srinagar settled at -3.0°C for the second consecutive day. It was 4.0°C below normal for the summer capital of Jammu and

Qazigund on Srinagar-Jammu National Highway had a low of -2.0°C, while the picnic spot of Kokernag in south Kashmir recorded a low of -0.2°C for the second consecutive day on Thursday.

The night temperature at Pahalgam dropped by a few notches and recorded a low of -5.4°C against -5.2°C. It was 1.0°C below normal for the tourist hot spot in south Kashmir.

Kupwara recorded a low of -3.3°C against -3.4°C, and it was 3.1°C below normal for the frontier north Kashmir district.

The minimum temperature at Gulmarg further improved and settled at -3,2°C against the -4.2°C recorded on Wednesday, and it was 3.6°C above normal for the famous ski resort of north Kashmir. (UNI)

During the operation, incriminating material and documents such as identity cards, bank documents, identity cards, and registers besides digital devices like mobile phones and computers were seized from various HR consultancies, a statement from SIA said.

It added that this nefarious scheme is part of a broader conspiracy hatched by international terrorist organizations, in connivance with notorious trans-border human traffickers.

"These groups facilitate the infiltration of foreign nationals across international borders, concealing their original identities with forged Indian documents with an ultimate aim is to establish sleeper cells to aid, execute, or facilitate terrorist acts in the UT of J&K," the statement

The SIA said the seized material will be meticulously examined so that all the accused persons are identified and brought to book.

"Today's search operation marks the continuous pursuit of SIA in dismantling the terror ecosystem in Jammu and Kashmir and unfurling the sinister agendas of international terrorist organizations operating in the region," the statement added. (UNI)

Police had said a pistol that was used by him to commit the crime was also recovered.

However, during further questioning, Aadil revealed to the investigators that he had thrown his cellphone and other incriminating materials into a water body at two places along the Ali Jan Road in Srinagar after the attack, official

"It was on this revelation that the searches were launched by Police and MARCOS in the water body to trace his mobile and other incriminating materials," the sources said, adding. that "this material was important for further investigation in the case."

After the arrest, Additional Director General of Police, Vijay Kumar had said Aadil had been radicalised online by Pakistan-based

"If you dig Aadil Manzoor's background, neither he nor his family has no previous background (of militancy),. He was motivated and radicalised through social media by Pakistani handlers," Kumar told reporters in Srinagar on

Kumar claimed Aadil used to regularly pray at the mosque and had leanings towards the Ahli Hadees sect of Islam. (UNI)

Monitor progress on River Morphology studies on daily basis: CEO ERA asks officers

SRINAGAR: Chief Executive Officer, Jammu and Kashmir Economic Reconstruction Agency (ERA), Dr. Syed Sehrish Asgar, today asked the officers to effectively monitor progress on Jhelum and Tawi river basin morphological studies being undertaken as part of World Bank funded Jhelum Tawi Flood Recovery Project on daily basis to ensure earliest completion of critical studies.

Dr Syed Sehrish Asgar said this while chairing a meeting held to review progress on ongoing World Bank funded JTFRP at Civil Secretariat, Srinagar here today

She gave instructions for close monitoring of progress of work on all the remaining under execution sub-projects under JTFRP particularly the flagship sub-projects of construction of Emergency Operations Centre at Ompura, Budgam, construction of Additional Hospital block at Bone and Joints Hospital, Barzulla and construction of extension block at Lal Ded Hospital, Srinagar. Director, Technical, JTFRP, Gurcharan Singh, while giving details regarding preparation of feasibility and detailed project report for flood mitigation and comprehensive river management measures for Jhelum river basin, informed that the concerned stakeholders had asked for some clarifications which have been incorporated in the model and final observations from Central Water Commission are awaited. With regard to preparation of feasibility and detailed project report for flood mitigation and comprehensive river management of Tawi basin, he said that some clarifications have been raised by the concerned stakeholders which have been incorporated and further a joint site visit was conducted with the I&FC Jammu for on spot inspection.

The CEO asked the Director Technical, JTFRP, to closely follow up both the studies with the I&FC Department so that both the studies are finalised and completed at earliest.

Dr Sehrish was informed that progress of work on upgradation of 47 dewatering stations in Srinagar city is in progress with work already

completed on 40 stations while as work on remaining stations is underway. She asked the Director, Technical, JTFRP to follow-up all impediments hindering progress of work on the sub-project and concerned PIU be asked to give firm date for the completion of the sub-project.

Nodal officer for construction of additional hospital building at Bone and Joints hospital, Barzulla informed that work on the sub-project is at the advanced stage. He said that estimates for construction of corridor from existing hospital to new block and other additional works has been submitted to World Bank for approval.

Nodal officer for various subprojects being executed by J&KERA as PIU (project implementation unit) in Kashmir Division informed that work on Hamray-Sultanpora road sub-project has been completed and project handed over to R&B. Besides, work on the construction of Waghama-Bijbehara road subproject is underway with excavation and construction of diversion in progress. The CEO directed the concerned nodal officer to ensure that work on the said sub-project is completed by June, 2024. With regard to progress on various bridge subprojects being executed by J&KERA in Kashmir division, it was informed by the concerned nodal officer that work on construction of Rohmoo bridge in Pulwama, is in full swing with one deck slab already laid and preparation for laying of 2nd deck slab presently underway alongwith the construction of approaches. Further, work on construction of approaches and pedestal for the bearings on Trenz bridge is in progress.





Custodian General inspects evacuee properties in Kashmir division; Asks officers to act swiftly against encroachments

SRINAGAR, FEB 15: Custodian General J&K, Rishpal Singh, conducted extensive tour of evacuee property assets and land situated at Peerbagh, Hyderpora, Sanath Nagar, Panthachowk, Boulevard, Kathidarwaza Rainawari and other places of Kashmir division.

Deputy Custodian (HQ), Custodian Evacuee Property Kashmir, Assistant Engineer E P Department Kashmir along with field staff accompanied the Custodian General J&K.

During the visit of Evacuee property flats, Convention Centres and marriage halls and shopping complex Hyderpora Srinagar, various delegations of tenants met the Custodian General with their demands and issues. The Custodian General redressed some of the issues on the spot while directing the Custodian Kashmir for redressal

of other genuine demands of the tenants within shortest possible time.

The Custodian General also convened a review meeting with officers of Evacuee Property Department Kashmir.

The Custodian General assessed different aspects of functioning of Evacuee Property Department Kashmir besides reviewing the action taken on decisions taken in the previous meetings. He expressed satisfaction over remarkable achievements including reconciliation of figures of notified evacuee land in due consultation with Revenue Department in Kashmir division and retrieval of big chunk of evacuee land. He asked the officers and officials to act swiftly on receiving reports of encroachment of evacuee land in collaboration with Revenue and Police depart-



The Custodian General also asked the Deputy Custodians to liaise up with district administration for proper management and safeguarding of the evacuee property. He asked for identifying the evacuee land which is potentially viable for commercial purposes including other lands which can be fenced with installation of sign boards to avoid any further encroachment. He said that the land not viable for departmental use should put to e-auction for which the department has already developed e-auction portal and subsequent constitution of auction committee by the government for auction of Evacuee Property.

Meanwhile, a group of employees met the Custodian General and demanded conduct of Departmental Promotion

Committee meeting which has not been conducted since 2017.

The Custodian General assured them that he will take up the matter with the administrative department for early finalization of recruitment rules of the department, so that the genuine demands of the employees for promotion to the next higher grade are acceded to keeping in view their seniority, integrity and performance.

Later, the Custodian General emphasized the need of scanning of all records pertaining to the department up to ending February 2024 besides asking for completion of geo tagging of all the Evacuee Property within 15 days. He also emphasized skill development of the employees on priority through skill enhancement sessions and other orientation

Among them education department has 14000 buildings followed by Rural Development Department, Home, Health & Medical Education, PDD Jal Shakti, Social Welfare Tourism and Higher

Addressing the nodal officers of the respective departments, the Commissioner Secretary said that they should frame a clear roadmap and action plan regarding adoption of the system to ensure implementation of the scheme as per its guidelines. He asked each of the department to provide the information like list of their buildings along with sanctioned connected load, shadow free rooftop space, geo-coordinates and other relevant details about such structures here.

The Commissioner Secretary said that all the newly constructed government buildings should have mandatory solar rooftops and the same should reflect in the DPRs.

Jammu and Kashmir BJP president Ravinder Raina, along with other party leaders, welcomed Bukhari and hundreds of his supporters, including former bureaucrat G M Khuwaja and retired senior superintendent of police Shabir Geelani, into the party fold at the party headquarters here.

"I have kept my promise of joining a party which fulfils our long-pending demand of ST status. I am thankful to Prime Minister Narendra Modi, Home Minister Amit Shah and Raina for doing justice with Paharis who have struggled for 40 long years for the ST status," Bukhari told reporters.

The BJP-led central government recently added four communities - Gadda Brahmin, Koli, Paddari Tribe and Pahari Ethnic group — to the list of Scheduled Tribes in Jammu and Kashmir.

After resigning from the NC, the former minister had said his statement at a function that "we will not hesitate in supporting any party which will help the community in achieving its demand of ST status did not go down well with the NC leadership and I was asked for an explanation." He claimed that he had a "heated argument" with Abdullah over the issue and submitted his resignation from the basic membership of the party after walking out of the meeting.

Raina said, "Bukhari is not only a political stalwart but a spiritual personality having a lot of influence on people (of his community) in both Jammu and Kashmir. His joining BJP will further strengthen the party at the grassroots level." He claimed a wave in Jammu and Kashmir in favour of the BJP and the prime minister who had provided justice to all sections of society who were deprived of their rights

"In the coming days, you will see more political stalwarts joining BJP and there will be only one party left in Jammu and Kashmir," he said, adding that the lotus — the BJP's poll symbol — will bloom not only in Dal Lake but in the entire landscape in Kashmir.

Empowering Women in Jammu & Kashmir: A Transformative Journey

Recognizing Women's Crucial Role in Development, Peace and Stability

As India strides towards progress and development, acknowledging the vital role women play becomes imperative. In the intricate tapestry of Kashmir, the empowerment of women emerges as a pivotal force for positive change. Women constitute 47% of the total population in J&K. This significant portion of the population must contribute to development, becoming professionals in various fields and contributing significantly to the nationbuilding process.

The Effect of Conflict

The journey of women in regions like Jammu and Kashmir has been marred by the long-standing conflict, significantly affecting their lives. Kashmiri society has traditionally placed women in important roles in the societal hierarchy The advent of fundamentalism, militancy and terrorism brought about severe challenges, including limited access to education, healthcare, and economic opportunities. Women faced discrimination, violence, and harassment, creating a dire situation.

Kashmir has a history of protest politics, wherein women have been prominently involved. Over time, women in Kashmir have been misled and subjected to mistreatment on the streets. Certain opportunistic factions manipulated them into taking to the roads and staging sit-ins as part of a calculated strategy. Despite their genuine intention to promote stability and advocate for it within their communities, they have been led astray to support secessionist ideologies. According to Swati Parashar, women have played a pivotal role as a support network for militants. She asserts that they provided care and protection to militants, conveying messages and transporting arms. Despite a society traditionally characterized by Sufi values, younger women, influenced by fundamentalists, romanticized the rebellious "angry young man" in pseudo-military attire. The acceptance of armed masculinity became ingrained in a society historically associated with peaceful Sufi principles (Source: "Gender, Jihad, and Jingoism," Swati Parashar, 2011, p. 438).

Despite these challenges, the resilience and courage of women in Jammu and Kashmir have been remarkable, with a notable increase in women's participation in various fields.



A Shift Towards Peace and Stabil-

Post the decline of terrorism and abrogation of Article 370, the region has witnessed a significant shift. The focus on peace and stability, coupled with various initiatives, has fostered an environment conducive to the resurgence of women to their rightful place. The government, under the leadership of Manoj Sinha, the Lieutenant Governor of Jammu and Kashmir, has taken deliberate and positive steps to address the issues faced by women.

In the complex terrain of Jammu & Kashmir, the government has implemented measures to improve the security situation for women, strengthening law-and-order machinery and increasing police patrolling in vulnerable areas. Skill development training and initiatives to promote women's entrepreneurship have been rolled out, aiming to bridge the gender gap and create a more inclusive society.



The Education system was a couple of books and little home work. Students were a good time to play and cheer happily. There was no competition at all and students were careless both about careers and their course. Still they moved and we got the great personalities like Albert Einstein, Isaac Newton, Stephen

Hawking, Some socio-political giants like Ali Mohammed Jinnah, Mahatma Gandhi, Dr Sir Mohammad Iqbal(R.A.) and others.

Our Jammu and Kashmir in much of turmoil and conflict had given eminent religious souls to world in form of Sheikhul-Alam, LalDed, BulBul shah Kashmiri, Mufti Molvi Ameen shopyani and many others, courtesy to Education.

Things have changed now. Children are loaded with responsibilities and put to forceful activity from day ist. They are deprived of their babyhood and minor age.

I have now been in service of Higher School Education for ten year now and both an sensible witness and social human, I experienced that majority, even greater majority of Students have now started ignoring and bunking classes because of this unpleasant new education system. A roll of 250 to 300 student classroom is $marking with \ daily \ 7 to \ 8 students. Despite$ counseling of experts and mentors, the curse on our little student generation is their heavy school bags with much of overweight books that is a definite cruelty causing them severe heath problems day by day. Weight of school bags is increasing and not decreasing at any rate, our school children have turned slaves of educational system where commission of booksellers and teachers making their bags heavier and heavier.

There is no scope of creativity, imagination, ingenuity, inspiration and critical analysis. These children got no time to think except rote learning and homework. The system emboldens and promotes them with memorization and rote

learning concept. The little children didn't get any time to ponder freely or think openly. This is an open oppression on them. We have kept them on method of cramming and memorizing selection of books is totally a hallucination and horror. Many companies are producing stuff in name of books and their is no to ask them the level against the children, Schools and teachers get their commissions

to choose the book publishing companies. It is a large misconception we are doing for our younger generation. In fact it has became a disastrous disease among people that much difficult books mean informative and higher standard of learning.

It is a delusion that burdensome and difficult books are prescribed. Children's of today are more sensitive than those a few decades before (unconscious children). The extra burden and deprivation of liberty builds pressure on them. Then the children feel their life in despondency, desolation, loneliness, failure and deprivation. Then what we can get are suicidal

cases and drug addicts cum chain and there should be no doubt but we should be

ready and obvious for such disas-Parents and guardians are

aware of this kind of bad **Education sys**tem, but feel helpless and they have ceded

to it. No parent feels a need to go against the school system as political potential of schools will send his/her ward back to home with called off admission, with the school's fame unharmed. The alternative of Government schools is not a good approach as they are completely at lack of proper facilitated functionary. It is a desperate situation for everyone for every member of the society. We are not establishing a good and adequate system for our next generations which they shall have to face individually and unintentionally.

One more night mare is we have put our children on continuous coaching system. It is a chief troublesome now a days in our society. It becomes important for a student to attend the coaching classes even at the rate of her or his school. It has turned a fashion for Kashmiri students to attend tuition classes than Schools. By this A student looses his or her much precious time, playing time and school life thus fails to overlook the challenges of life as all-round development is possible only in school life. Also tuition concept has made Student's mind such that he or she feels it unable to clear their examinations without coaching classes

Luckily, we are not incapable, the things are in our hands, they have not yet uncontrolled. Stress upon them for grades for social status is a kind of suppression on them, which need to be think of. All these developments should be thoroughly applied like a necessity.

2 Key Issues Took Centre Stage As Court Struck Down Electoral Bonds Scheme

New Delhi: The Supreme Court has declared the Electoral bond Scheme – launched in 2018 with much fanfare – as unconstitutional on several counts. They violate people's right to information and Article 14 of the Constitution guaranteeing equality. They also infringe on the principle of free and fair elections as stipulated in the constitution, the court argued.

The Electoral Bond Scheme was launched in 2018 after a series of amendments to financial rules in 2016 and 2017. The petitioners had argued that their effect was to enable political parties to not disclose the contributions received through electoral bonds, allow companies to make unlimited funding and not disclose the details of contributions made in any form.

The petitions filed on the matter had asked the court to resolve two issues: -- Whether amendments violate the Right to Information under Article 19(1)(a) and whether unlimited corporate funding violates principles of free and fair elections. Answering in the affirmative, Chief Justice of India DY Chandrachud said two judgments -- one by him and one by Justice Sanjeev Khanna, who was part of the fivejudge constitution bench -- had



arrived the same conclusion, though their reasonings were slightly different.

While Indian election system

involves secret ballot, the cloak of anonymity cannot be extended to political donations above the 2000 threshold, the court said. This is because for voters, information about funding of political parties is essential for making electoral choices."Political contributors get access... this access leads to policy making... because of the nexus between money and voting. Financial supports to political parties can lead to quid pro quo arrangement," Justice Chandrachud said, meaning corporate funding of political parties can include quid pro quo in terms of policy making -- so policies can be tweaked to favour the donors."Courts have maintained that the citizens have right to hold the government to account. Crucial aspect of expansion of right to information is that it is not confined to state affairs but also includes information necessary for participatory democracy," the Chief Justice added.The lack of information also violates the rights of shareholders

of a donor company. The field is further skewed as only the voters are left in the dark about the donors, since there is no rule that stops the donor from informing the party about the donations.The curbing of the right to information cannot be defended in the name of public interest -- weeding out black money as the Centre

had argued -- the court said, pointing out that "public interest' is not among the very few instances the Constitution has allowed such a

That short list includes a threat to the sovereignty and integrity of India; the security of the State; friendly relations with foreign states; public order; decency or morality; contempt of court; defamation and incitement to an offence.

There are other methods of curbing black money, the court said.

The top court also criticised the legal provision that allowed unlimited political contribution, saying it allowed companies with deep pockets to influence policy. It also encouraged loss-making companies to throw their hat in the ring by contributing through shell companies.On the whole, "The deletion of the proviso to Section 182(1) of the Companies Act permitting unlimited corporate contributions to political parties is arbitrary and violative of Article 14 (pf the Constitution that guarantees the Right to Equality),' the judgment read.

The court also pointed out that the while Article 324 of the Constitution puts the Election Commission in charge of the entire electoral process, it is not the sole duty of the election body to secure the "purity and integrity of the electoral process".

PM Modi Concludes Visit To Qatar **After Meeting Top Leadership**



Ajit Pawar's Faction Real NCP, Can't Disqualify Its MLAs: Maharashtra Speaker

Mumbai: Maharashtra Speaker Rahul Narwekar on Thursday referred to last week's Election Commission order - recognising Ajit Pawar as the leader of the 'real Nationalist Congress Party'-and rejected petitions seeking disqualification of MLAs who rebelled against Sharad Pawar last year, triggering a split and a battle for control of the NCP.

Mr Narwekar said the MLAs who joined Ajit Pawar in rebelling against his uncle - and allied with the BJP and a similar breakaway faction of the Shiv Sena - to form a new government, could not be disqualified simply because they had questioned the latter. This, he said, was only "internal dissent" and could not amount to



defection, which would have invited disqualification.

"Party leadership cannot use (the) Tenth Schedule of the Constitution (which deals with anti-defection provisions) to stifle dissent of large numbers of members by threatening to disqualify them," he said.

The sequence of events preceding the split were due to dissent within the undivided NCP, he added.

Mr Narwekar also took note of the "overwhelming" support Ajit Pawar's camp had at the time of the division, and said, "I hold, therefore, that (the) Ajit Pawar-led NCP is the real political party... has the legislative majority (and) this is undisputed," he said, "All petitions seeking disqualification are rejected."Also therefore, decisions of the Aiit Pawar faction are the "will of the NCP", he ruled. The Supreme Court last month gave Mr Narwekar till February 15 to decide on disqualification petitions against MLAs affiliated to Ajit Pawar's group.

Before the split the NCP had 53 MLAs. After the dust settled, 41 sided with Ajit Pawar, leaving 12 with Sharad Pawar as he tried to re-assert control over the party he helped found in 1999, and has since led.

Mahua Moitra Summoned By Probe Agency In Foreign Exchange Violation Case

New Delhi: In fresh trouble for Trinamool Congress leader and expelled Lok Sabha MP Mahua Moitra, the Enforcement Directorate has summoned her for questioning in an alleged foreign exchange violation

The summons have been issued in connection with violations of the Foreign Exchange Management Act and Ms Moitra has been asked to appear at the agency's office in New Delhi on Monday.


"We Have Objection To Farmers' Method", Says Haryana Chief Minister

Unregulated, soaring prices of mutton, fruits, vegetables leave consumers struggling CAPD says it has no authority to fix rates

Srinagar, Feb 15: Unregulated mutton and poultry prices have emerged as a pressing issue in Kashmir, causing immense concern among the local population. Following the government's decision to end price control last year, the absence of a regulatory body has led to soaring prices, leaving consumers struggling.

According to the news agency—Kashmir News Observer (KNO), the Union Ministry's notification last year advised the Food Civil

Supplies & Consumer Affairs Department of Jammu and Kashmir to refrain from enforcing price control. It cited orders under S.O. 145(E) dated 15.02.1990 which effectively removed the region's ability to regulate mutton and chicken prices.People are expressing anger and are worried over the steep increase in mutton prices, which now range from 700 to 750 rupees, making it challenging for households. The absence of a regulatory authority has left consumers vulnerable to exploitation by retailers

Abdul Rashid War, Director of Food, Civil Supplies and Consumer Affairs, Kashmir told KNO that before the implementation of the National Food Security Act (NFSA), their department was fixing the rates, but currently they don't have any authority to do it."We don't have any authority to fix the rates of mutton, chicken, fruits or vegetables; however, if there is a complaint, people can approach consumer commission. Our mandate is for the supply of food grains," he said. A locally established mutton retail-

Rohit, Jadeja and Sarfaraz make it India's day

RAJKOT: Rohit Sharma and Ravindra Jadeja made classical Test match hundreds while debutant Sarfaraz Khan announced his arrival on the big stage with a fluent half-century as India reached 326 for five at stumps on day one of the third Test against England here

With India reduced to 33 for three inside the first hour of play, Rohit (131 off 196) and Jadeja (110 batting off 212) steered the ship through choppy waters with a 204-run partnership.

After the pair was separated, Sarfaraz (62 off 66) scored the joint fastest fifty by an Indian on debut to push India past the 300-run mark.

Jadeja was batting with nightwatchman Kuldeep Yadav (1 batting) at close

In batting friendly conditions, the home team will be looking get near the

500-run mark on day two. For England, fast bowler Mark Wood (3/69) vindicated his selection as England's second pacer with a two-wicket burst in the morning, accounting for Yashasvi Jaiswal (10) and Shubman Gill (0), while spinner Tom Hartley (1/81) got the better of Rajat Patidar (5) to leave

India tottering.

Jaiswal was caught in the slips by Joe Root while Gill looked susceptible against the moving ball.

After beating Gill on the inside edge,

Wood found an outside edge to send back India's No. 3 for a nine-ball duck. Patidar was outdone by a ball from

Hartley that neither spun sharply nor bounced unevenly but seemed to have slowed off the surface.

Patidar was unable to control his shot as the ball simply ballooned towards short cover for a regulation catch.

The pressure on the Indian camp was

palpable and the team management opted for a safer route by holding Sarfaraz back and promote Jadeja at No.5 a spot where he has batted at in only five out of his 70 Tests yet.

What transpired after the first hour calmed all the nerves in the dressing room as senior pros Rohit and Jadeja recorded only the third double-century partnership for India against England in

With 204 runs for the fourth wicket, Rohit and Jadeja joined the esteemed company of Sachin Tendulkar and Sourav Ganguly (249 vs England at Leeds in August 2002) and Vijay Hazare and Vijay Manjrekar (222 vs England at Leeds in June 1952) for having put on more than 200 against the Englishmen.

It was also the highest partnership between Rohit and Jadeja in an undertransition Indian side as well as their second in triple figures, having put on 100 for the sixth wicket against New Zealand at Kanpur in September 2016.

As if he had saved his best in the series for this day, Rohit was unhurried and completely assured in the middle, producing a knock that was in complete contrast of his recent approach.

Healy's 99 and Brown's five wickets headline Australia's dominance

SYDNEY: Australia's quicks defied searing heat at the WACA to tear through an inexperienced South Africa badly missing Marizanne Kapp before captain Alyssa Healy fell agonisingly short of a maiden Test century late on day one.

A tiring Healy, who had been on the field for almost the entire day, was dismissed for 99 when she succumbed to the offspin of debutant Delmi Tucker and was caught and bowled.

But Australia are well on top in the historic first Test between the countries and lead by 175 runs at stumps.

South Africa were routed for just 76 in their lowest ever Test score after being bowled out in 31.2 overs. But they hit back when quick Masabata Klaas produced a spectacular new-ball spell to leave Australia reeling at 12 for 3 in reply.

South Africa's attack were unable to keep up the pressure in 42-degree heat as Healy combined with Beth Mooney in a 155-run partnership to regain Australia's ascendency.

Healy combined with Annabel Sutherland, who took advantage of a wilting South Africa with an unbeaten half-century as the shadows creeped onto the ground.

South Africa's bid for an upset victory to square the multi-format series appears for lorn after a disastrous start to the four-day match.

Playing only their second Test match in a decade, fielding four debutants, South Africa were rocked when Kapp was ruled out due to illness.

A rattled South Africa were unable to cope with the discipline of Australia's quicks, who targeted a dangerous back of a length to devastating effect. South Africa's inexperience against the red-ball, with their XI combining for just seven Tests, was apparent as they fell tamely to loose strokes. Their



batters were undone by minimal foot work and too often slashed at deliveries outside the off-stump.

Vindicating Healy's bold decision to bowl first amid fierce heat, speedster Darcie Brown claimed her first Test five-wicket haul while Sutherland and Tahlia McGrath also starred on a green-tinged surface offering movement and bounce. The dominance of the quicks meant that Healy did not have to call upon Australia's trio of frontline spinners, including Sophie Molineux playing in her first international match in more than two years.

There had been intrigue over the surface, used for the first time this season, but fittingly, in the first men's or women's Test match played at the WACA since December 2017, pacebowling dominated.

Having won back her spot after missing Australia's last Test in India, Brown steamed in and created a chance almost immediately when opener Anneke Bosch was dropped at third slip by Mooney.

But she was worked over by a fiery Brown as a Kapp-less South Africa desperately needed captain Laura Wolvaardt to overcome her sluggish form on the tour. She was unable to capital is eon a drop from a diving Healyto fall on the next delivery to Brown, who finished a spectacular opening spell with 2 for 5 from five overs.

South Africa appeared to be rallying when Sune Luus and Tazmin Brits dug in to defy Australia for 12 overs. Brits, however, was unable to turn over $the \, strike \, and \, crawled \, to \, 5 \, off \, 48 \, balls$ before succumbing lbw to Sutherland in a decision that was overturned on DRS.
