
# **Committed to fulfill all promises made** with people of J&K: CM Omar Abdullah

Announces constitution of CS-led panel to workout roadmap for daily-wagers

JAMMU, MARCH 11: Chief Minister Omar Abdullah today announced to constitute a committee under the chairmanship of Chief Secretary Atal Dulloo to devise a roadmap for the regularization of daily-rated wagers.

Replying to the discussion on Budget 2025, the Chief Minister said, "Through this House, I am announcing the formation of a committee under the Chief Secretary, with the Additional Chief Secretary to the CM, Commissioner Secretary GAD, Planning Secretary, and Law Secretary. Within six months, we will finalize a framework, determine the



exact number of daily wagers, and legally and financially assess how they can be regularized. Then, the policy will be discussed here in the next budget."

Speaking about the plight of daily wagers, the Chief Minister emphasized that this is not merely a financial issue but a humanitarian and social concern. Referring to the use of force against protesting daily wagers in Srinagar and Jammu, he remarked, "What happened to them yesterday, I do not want to repeat. But I must ask—why did the situation reach this stage?"

He recalled that during his previous tenure as Chief Minister, his government

The boys had gone for cattle grazing near Bhamberwan Goat Farm but never returned home. Their worried families reported the matter to Police Station Raj Bagh, submitting a written complaint. Acting on the report, police registered a formal case and started an investigation.

# Each MLA to get Rs 3 crore as Constituency Development Fund

### Post creations excluded, Rs 20 lakh set aside for supporting Tribal, BPL communities

Srinagar, Mar 11:: The Jammu and Kashmir Government has decided to allocate Rs 3 crore annually for each Member of the Legislative Assembly (MLA) under the Constituency Development Fund (CDF) scheme.

This decision, according to the news agency-will enable MLAs to recommend and oversee the implementation of key develop-

ment projects in their constituencies. The funds will be used to support infrastructure development, public welfare projects, and essential services, with a clear focus



on ensuring the timely completion of all approved works.

The Finance Department has issued a detailed circular outlining the guidelines for the implementation of the CDF scheme. Under these guidelines, each MLA can propose development works worth up to 3 crore ( 300 lakh) annually to the District Development Commissioner (DDC) for execution in their constituency. Additionally, nominated MLAs have the flexibility to recommend projects in any part of the Union Territory.

The allocated funds are specifically designed for capital expenditure and cannot be used TURN ON.....PAGE 02

The notifications further alleged that AAC and JKIM have encouraged the use of arms to destabilize law and order, while also engaging in efforts to fuel discontent among the people of Jammu and Kashmir. The Centre warned that if the group's activities were not immediately curbed, it would continue its anti-national agenda, including challenging Jammu and Kashmir's accession to India and disrupting public order.

Citing these concerns, the government exercised its powers under Section 3(1) of the UAPA to officially ban these organizations. The order will remain in effect for five years from the date of publication in the Official Gazette, unless revoked or modified under Section 4 of the Act.

The move is part of the Centre's continued efforts to crack down on organizations it deems a threat to national security and territorial integrity. [KNT]

initiated a framework for regularizing daily wagers. However, he noted that the 2014 elections and the devastating floods had disrupted these plans. Taking a dig at the opposition, he questioned their inaction, stating, "What did you (the opposition) do? I reviewed past budget speeches from your tenure and found no mention of daily wagers except in the fourth budget speech, where you vaguely spoke about 'sustainable livelihood'." He further pointed out that even after the issuance of SRO-520, only 577 daily wagers

were regularized. Challenges in Regularization

The Chief Minister highlighted that, over the past decade, opposition which were in power then failed to address the issue, despite having both state and central authority. He accused them of prioritizing the 7th Pay Commission over the regularization of daily wagers, making the situation more complicated.

"Then came the J&K Reorganization Act, which effectively shut the door on their regularization. Now, we must reopen this issue. But in these years, their numbers have changed, making it difficult to determine an accurate count," he said. The government must start from the scratch to resolve their concerns, he said.

Budget 2025: A Realistic approach, not pessimistic

Addressing criticism that his budget speech was pessimistic, the Chief Minister clarified that it was, in fact, realistic. "Some members termed the beginning of my budget speech as pessimistic. I believe it was not pessimistic; it was realistic.

I told the truth—I said my whole body has wounds. Pessimism would have been if I had said, 'The body has so many wounds, death would be inevitable." Instead, he explained, "I said, 'The body has so many wounds, and Idon't even have enough balm for them.' This is not pessimism; this is our reality."

He stressed the financial constraints facing the Union Territory, adding, "Do I have enough money to take all the power projects into my hands and start working on them? No. Can I provide free electricity to all the people? No. In today's age, we don't even have the budget to ensure 24-hour electricity for Jammu and Kashmir. We are forced to buy electricity. We have worked on increasing social benefits for the poor. But is this truly enough to meet their needs? No."

Fiscal responsibility and future growth Quoting an English saying, "Cut your coat according to your cloth," the C

hief Minister explained the necessity of managing within available resources. "My words were not pessimistic; they were realistic. I presented the truth. We don't have enough money, but we have prioritized welfare measures that will have a meaningful impact on the people."

He acknowledged that the budget would not yield instant results but assured that long-term growth had been set in motion. "This budget serves as our foundation. Over the next five years, we will build a strong and prosperous Jammu and Kashmir."

Opposition's response and criticism Responding to the opposition, particularly BIP members, the Chief Minister remarked that instead of focusing on the budget, their speeches were centered around Article 370, Maharaja Ji, and July 13.

"Initially, I thought his speech had substance, but in reality, there was nothing related to the budget," he said, referring to a BJP legislator's remarks.

A 'Love Letter' to the People of J&K

Addressing the interpretation of his budget speech, Omar Abdullah reiterated, "My budget speech is a love letter—to the BJP, to the PC, to the PDP, to the AIP, to Congress, to the CPI(M), to independent MLAs, and, above all, to the people of Jammu and Kashmir. Why do we write love letters? To express love. And dowe not love those who are in need? Through this budget, we have tried to extend that love by addressing their challenges and aspirations."

"I am not ashamed to call it a love letter. In fact, for the next five years, we will continue writing such love letters—letters of commitment, of progress and of transformation for the people of Jammu and Kashmir."

Responding to criticism about acknowledging financial support from the Centre, the Chief Minister stated, "The central government has extended financial support to us. Should I be ashamed to admit it? No, I will not. The reality is that we are not yet selfsufficient. We are not financially independent. That is our challenge. And that is precisely what we must work toward." He stressed that Jammu and Kashmir had always relied on central funds, but the goal was to achieve financial self-reliance in the long run. Projects under the CDF must be completed within one year. In areas with limited working seasons, such as high-altitude regions, the DDC, with the MLA's approval, may extend the timeline, allowing work to be completed within two working seasons, but not exceeding two years.

The scheme encourages MLAs to recommend projects with costs not exceeding 10 lakh per work, although higher-value projects may be considered for certain infrastructure investments, provided they are completed within the specified time.

A wide range of development activities will be supported, including the construction and upgradation of government buildings such as schools, hostels, libraries, and sanitation facilities, as well as the provision of computers for educational institutions. The fund will also support the construction of roads, irrigation facilities, power infrastructure, and housing upgrades for the underprivileged.

The government aims to make a significant impact on the local infrastructure by allowing projects such as: Construction and upgradation of roads, including approach roads and link roads, with funding upto Rs 15 lakh. Projects for water table recharging, irrigation, and drainage, with support up to Rs 20 lakh.

Strengthening power infrastructure with a budget of up to Rs 50 lakh.

Assistance for housing upgrades for tribal and BPL populations, with funding of up to Rs 20 lakh for each project. This initiative also focuses on improving

rural areas by allowing the creation of kachha roads where local needs dictate. To ensure proper utilization of funds, the

scheme, as per KNO, includes provisions for strict oversight. Payments for completed works will be made only after the necessary verification and the successful completion of a Defect Liability Period (DLP), if applicable.

The scheme, according to KNO, also emphasizes the importance of efficiency, requiring that at least 80% of the allocated funds be utilized within the financial year.

In cases where the prescribed threshold is not met, funds will be withheld until the target is achieved, and future allocations will be contingent upon meeting these goals.

Certain projects will not be eligible for funding under the CDF, including office or residential buildings for government departments, memorials, creation of posts, or any kind of revenue expenditure. The funds will not be used for works related to places of worship either.

By giving MLAs the autonomy to choose projects and ensuring proper monitoring, the CDF scheme aims to foster a more localized and responsive approach to development. This initiative represents a significant step forward in empowering elected representatives to directly contribute to the growth and well-being of their constituencies—(KNO)

### Rs 143 cr Tawi River Front Project to be completed by April 2025: Javed Rana

He said that CHC Sumbal is well equipped in terms of manpower, machinery, equipment, infrastructure, dialysis unit, medical and emergency equipment serving as a critical healthcare hub in Bandipora district.

He informed that WSS Zaingeer, WSS Shiva (proposed) and WSS Saidpora (proposed) are partly dependent on Zanageer canal as the source, WSSs Mazbugh, Checkpora Nowpora, Nowpora Kalan, Bohripora Sheeraz Colony, Bohripora Hamdanabad and Sidiq Colony and Model Town, Wadoora and Nathipora are dependent on Pohru Nallah as the source while WSSs Takiybal Wagub (under execution) and Sharkwara Rural are dependent on Ningli Nallah as the source. He said that the DPRs are based on a detailed survey that included assessment of quantum and quality of the source. He said that in these schemes, provision of rapid sand filtration plants has been kept to meet the BIS 10500 quality parameters. Besides, surface water has been taken as a source that has sufficient discharge capacity thus ensuring sustainability.

# NC's flip-flop over distribution of 200 units of free electricity

he National Conference in its election manifesto for the 2024 union territory assembly elections had promised that once the party comes into power 200 units of free electricity would be given to the people. In the manifesto it was nowhere written that this facility would be provided to the people belonging to the lower strata of the society alone. Five months down the line the party has changed its stance on the issue and the same has not gone well with the people.

Immediately after forming the government in October last year the party leaders and the ministers in the cabinet maintained that all the promises mentioned in the manifesto would be fulfilled. Addressing his maiden press conference in Srinagar in January chief minister Omar Abdullah had said that the government will provide 200 units of free electricity to the people who deserve it. He had also said that the same is possible only to the areas where the meters have been installed.

In the 2025-26 union territory budget it has been envisaged that 200 units of free electricity would be provided to the people belonging to Antodaya Anna Yojna (AAY). It seems that people belonging to the AAY category are only the deserving ones and the rest of the people are well off at least economically. Since the chief minister has said that it is imperative to have meters first for the calculation of free units of electricity it remains to be seen how the government responds since the AAY people are primarily living in nonmetered areas.

It would be a herculean task for the officials of the Kashmir Power Distribution Corporation Limited (KPDCL) to identify the AAY families and then calculate their monthly power bill as most of them come under the non-metered category. In the past the genuineness of many of the AAY families has been questioned by the common masses and it would be unfair if free units of electricity is provided to the people who don't deserve the same.

Across the Kashmir valley complaints of bogus AAY ration cards have been doing rounds for the past many years now. In such a scenario there are maximum chances that deserving people will be left out of the government scheme of providing free units of electricity to them. This whole process needs to be taken up in a meticulous manner and the government needs to extend the benefits to the other sections of the society.

# Ramadan: A Spiritual Journey of **Fasting and Self-Discovery**

he Arabic term Ramadan connotes intense heat. It indicates that in pre-Islamic Arabia, Ramadan was the name of a scorching hot summer month. In the Islamic calendar, however, the timing of Ramadan varies from year

Ramadan not only teaches us perseverance but has numerous benefits for our spiritual being. The Quran states that fasting was prescribed for believers so that they may be conscious of God (Allah). Ramadan is a period of fasting and spiritual growth and is one of the five "pillars of Islam" - the others being the declaration of faith, daily prayer, alms-giving and the pilgrimage to Mecca. Ablebodied Muslims are expected to abstain from eating, drinking and sexual relations from dawn to sunset each day of the month. Many practising Muslims also perform additional prayers like Taraweeh, especially at night, and attempt to recite the entire Quran. Besides some believers observe Atikafa meritorious voluntary act to stay in the mosque, especially on the last ten days of Ramadan and engage in God's worship and win His blessings.

Ramadan is having a profound impact on our spirituality, particularly given the physical hardships that it entails. The most distinct feature of Ramadan is that it requires the able Muslims to fast the entire month. The fact that this distinct feature correlates with the auspiciousness of the month is perhaps a testament to how important and beneficial fasting is. Indeed, the activity entails immense spiritual benefits that lay the foundations for the spiritual uplift we witness during the month. Since we are often unaware of these bene-



fits, this article aims to briefly introduce how, ironically, fasting is food for the soul.

#### It weakens your NAFS (SELF)

According to the Sufi philosophies, the "NAFS" in its unrefined state is "the ego", which they consider to be the lowest dimension of a person's inward existence-his animal and satanic nature.

The "NAFS" is the component of an individual that compels them towards their animalistic desires. Each individual is responsible for controlling and overcoming these desires. Imam Ghazali writes that physical easements are the source of strength for the Nafs,

including food and drink. The logical conclusion, therefore, is that depriving the physical body of food and drink would weaken the Nafs, and hence its ability to invite the individual towards evil and sin.

Since good deeds enhance one's spirituality and bring them closer to Allah (SWT), it is quite understandable that fasting entails a great degree of spiritual benefit, particularly with regards to weakening your ability to sin.

#### It strengthens your "SOUL"

Keeping up with the first point, weakening the Nafs would naturally mean strengthening the soul, since it is the

vehicle through which an individual is inclined towards good deeds and hence towards developing a stronger relationship with Allah (SWT). This is why you feel that heightened sense of closeness to Allah (SWT) during Ramadan; your soul no longer has to battle your nafs in the desire to do good, and it is empowered by the fast, hence the increased willingness to do good.

#### It brings you closer to your "THOUGHTS" and "EMOTIONS"

You have probably felt an overarching sense of calm and serenity during Ramadan. Quite often, even though the raging hunger of a long fast

bothers us, we are calmed down by an overbearing sense of peace. These emotions are the direct impact of a closer connection to Allah (SWT). This calmness also allows us to be better attuned to our own thoughts and emotions, since we slowly drift away from the hurry and fuzz of worldly

#### It relieves you of worldly "DESIRES"

It is quite often the case that individuals refrain from all things that invite them towards sin during their fast. The natural response is that if one is making an effort to please Allah (SWT), one best not infect that effort by engaging in activities that breed evil and sin. We try to refrain from anger and from expressing our base instincts during Ramadan for this very reason, the natural result of which is a sort of deviation from the traditional chase of our worldly desires and aspirations. Fasting allows us to be more cognizant of ourselves and our actions, which in turn makes us more aware of the unnecessary pursuit of mate-

rial and inconsequential gains. In conclusion, while there are immense, visible physical benefits of fasting, the spiritual side of the activity often goes unnoticed. Imam Ghazali and others have spent a great deal of time and effort in outlining these benefits for the Ummah, which just goes on to show how the soul is often neglected in our conception of the world. Let this Ramadan be a portal for a great cognizance of the soul and its role in developing our connection with the Almighty.

# 'Supporting Jammu and Kashmir's Artists with Fair Compensation and Recognition'

**¬**he Jammu and Kashmir Academy of Art, Culture, and Languages (JKAACL) holds a distinguished position in the region, revered for its pivotal role in preserving and promoting the cultural and artistic traditions of Jammu and Kashmir. It serves as a platform for artists, writers, musicians, and performers, ensuring that the region's rich and diverse heritage continues to thrive. The Jammu and Kashmir Academy of Art, Culture, and Languages is instrumental in supporting artists, offering them opportunities to showcase their work, fostering creativity, and maintaining the region's

However, despite its invaluable contributions, there remains a pressing issue that cannot be ignoredthe inadequate financial compensation provided to those who dedicate their lives to the arts. Artists, writers, and cultural workers associated with the academy continue to grapple with meager remuneration that does not reflect the value of their work or their contribution to society.

The artist fee, at a mere

Rs.1,350 per performance or contribution, stands as a glaring reflection of the disparity between the cultural and artistic value of work and its financial recognition. In the current economic climate, where the cost of living is rising steadily, this fee is simply insufficient to sustain an artist's livelihood. Basic necessities, including food, housing, and healthcare, have seen significant price hikes, making it increasingly difficult for many artists to make ends meet. The fee of Rs. 1,350 might have been more acceptable in the past, but it is no longer in tune with the economic realities of the present. This problem is symptomatic of a broader trend-artist and cultural workers are often overlooked and undervalued, despite their crucial role in shaping the intellectual and creative fabric of society.

The disparity between the remuneration of artists and that of salaried professionals is particularly striking. While employees in the government and corporate sectors benefit from regular pay raises and other financial perks, artists, who are vital to the preservation and promotion of cultural heritage, do not receive the same treatment. Government employees, politicians, and bureaucrats regularly see their salaries adjusted to keep pace with inflation, while the artists who breathe life into the art and culture of the region remain stagnant in their financial struggles. Similarly, employees in the private sector are granted

annual appraisals and bonuses as a way to reward their performance and to adjust their earnings to reflect the realities of the economy. However, artists are left without a structured framework for ensuring fair and consistent compensation.

The profession of an artist is inherently unstable, with many facing uncertainty in terms of income and opportunities. Most artists dedicate years, if not decades, to mastering their craft, but financial security often remains elusive. The nature of artistic work means that it is projectbased, with performances, exhibitions, and contributions occurring sporadically rather than regularly. This unpredictability makes it difficult for many artists to plan for their future, pay their bills, or support their families. The fee of Rs. 1,350 per performance is grossly inadequate in such an environment. Even with a substantial number of performances, an artist would find it challenging to generate a sustainable income. This constant financial insecurity leads to a range of unfortunate consequences: artists are forced to take on secondary jobs unrelated to their passion or creative practice, hindering their ability to fully invest time and energy into their art.

The economic strain also has wider implications for the cultural landscape. When artists are financially stressed, their ability to create, innovate, and contribute to the arts is compromised. Creativity flourishes in an environ-

ment of stability and security. Yet, when basic financial needs are not met, artists are left unable to dedicate themselves fully to their craft. This not only harms the individual artist but also affects the cultural output of the region as a whole. A lack of financial support stifles the potential for growth and innovation within the artistic community, limiting the richness of cultural experiences that can be shared with the wider public.

It is time for a structured revision of artist fees. Artists, like other professionals, must be able to rely on periodic fee increments that reflect changes in the economic environment. Just as government employees and corporate workers receive pay raises to match inflation, artists should be granted the same privilege. A reasonable starting point would be to institute a minimum 10% fee increase every year. This would provide artists with a basic level of financial security and enable them to focus on their creative endeavours without the constant worry of financial instability. The value of an artist's work should be reflected in their compensation, and this adjustment would be a step in the right direction toward ensuring that artists can maintain their livelihoods while continuing to contribute to the cultural and intellectual life of the

Additionally, the Jammu and Kashmir Academy of Art, Culture, and Languages (JKAACL) may look to the fee structures of National Academies as a reference point for their own fee structure. By considering the fee models and financial frameworks of established cultural institutions, the JKAACL can ease the process of implementing fee hikes, aligning them with broader national standards. This approach would not only ensure that artist remuneration keeps pace with the growing cost of living but also allow JKAACL to be more in tune with the needs and expectations of the artistic community.

In addition to increasing the artist fees, there are other ways the Jammu and Kashmir Academy of Art, Culture, and Languages can provide financial support to artists. The creation of grants and fellowships specifically designed for artists in need would be a significant step in this direction. Such funding could be awarded to individual artists or collectives to help them pursue specific projects or cover their living expenses while they focus on their work. Fellowships could also provide opportunities for artists to collaborate with national and international institutions, fostering cross-cultural exchange and expanding the reach of Jammu and Kashmir's cultural heritage beyond regional boundaries.

Furthermore, the Jammu and Kashmir Academy of Art. Culture, and Languages could explore the introduction of a pension system for senior artists. Many veteran artists, who have dedicated their

lives to preserving and promoting the cultural traditions of Jammu and Kashmir, face financial hardship in their later years. A pension system would offer them the support and dignity they deserve after decades of service to the arts. Such initiatives would not only help senior artists but also demonstrate a broader commitment to the wellbeing of the entire artistic community.

Finally, exploring alternative revenue sources could provide the academy with additional funds that could be used to support artists financially. The Jammu and Kashmir Academy of Art, Culture, and Languages could consider organizing ticketed cultural events, paid workshops, and other cultural activities that generate income. Collaborations with national and international cultural institutions could also serve as a means of bringing in additional revenue while simultaneously increasing the visibility of Jammu and Kashmir's artistic traditions on the global stage. These initiatives would not only provide much-needed financial support but would also help to expand the reach of the region's cultural offerings, allowing for greater recognition and appreciation of the rich heritage of Jammu and Kashmir.

Investing in the arts is not just an investment in individual artists; it is an investment in the cultural and intellectual growth of society. The preservation and promotion of cultural heritage are fundamental to a society's identity and well-being. If the Jammu and Kashmir Academy of Art, Culture, and Languages is to continue its vital role in safeguarding the region's artistic traditions, it must address the financial insecurity that too many artists face. Providing fair compensation, introducing support mechanisms such as grants and fellowships, and exploring alternative revenue streams are all steps that can help ensure the survival and thriving of Jammu and Kashmir's vibrant artistic commu-

Creativity cannot thrive when its practitioners are burdened by financial distress. The survival of cultural traditions depends on the well-being of the artists who bring them to life. The time has come for the Jammu and Kashmir Academy of Art, Culture, and Languages to recognize the importance of ensuring fair compensation for the region's artists. Only through such recognition will the academy truly fulfill its mission of promoting and preserving the rich cultural heritage of the region. 

# **Automatic Mutation Of Land Records: A Necessity** Of The Present Era

The Karnataka government has resolved to implement automatic mutation of land records from Wednesday, March 13, 2024, with the primary objective of eliminating the role of intermediaries and sparing landowners the ordeal of frequenting the offices of tehsildars.

#### **Revolutionizing Land Record Management**

Experts from the IT sector have divulged that automatic mutation shall be effectuated in cases pertaining to land mortgages for bank loans, property division, land acquisition, and court-mandated direc-

Approximately 72% of alterations in land records, particularly in Pahani/RTC (Record of Rights, Tenancy, and Crops), will transpire autonomously, devoid of human intervention. Under the prevailing system, modifications in Pahani necessitate the biometric authentication of revenue inspectors. The advent of automated mutation will obliterate such procedural impediments, ensuring that all modifications in RTCs are meticulously documented on the designated digital portal.

#### **Limitations of Automatic Mutation**

Scrutinizing the modifications executed in RTCs over the past six months, experts have observed that while 72% of changes are seamlessly automated, the remaining 28% necessitate manual intervention. Certain transactions—sale deeds, partition deeds, inheritance matters, guardianship of minors, and disputed land cases-remain beyond the ambit of automation. In such instances, applicants are accorded a 15-day notice period for requisite processing.

#### **Mitigating Bureaucratic Redundancies**

The introduction of automated land record mutation is poised to eradicate the protracted bureaucratic formalities, alleviate the workload of officials, and dismantle

the entrenched network of intermediaries. This progressive initiative will substantially curtail the necessity of physical visits to tahsildar offices, thereby enhancing administrative efficacy.

#### **Mandatory Functioning of Sub-Registrar**

Offices on Sundays In a parallel development, the government has mandated the operation of subregistrar offices within urban municipal jurisdictions on Sundays. In each city corporation, one sub-registrar office will function on a rotational basis, catering to the exigencies of both public and private

sector employees. Given that numerous employees grapple with weekday constraints, this initiative shall facilitate their ability to undertake property registrations and other official procedures on Sundays. However, only individuals with prior appointments shall be granted access to these offices.

Karnataka boasts ten city corporations. Bengaluru has already witnessed Sunday operations in sub-registrar offices. Nevertheless, public response has been tepid, largely attributable to inadequate dissemination of information. To ameliorate employee welfare, those assigned Sunday duty shall be compensated with a weekday off, preferably on Tuesdays, given that property registrations are relatively sparse on that day.

A Paradigm Shift in Land Governance: Need for Nationwide Adoption

While Karnataka spearheads the transition toward technologically driven land governance, our revenue department has also witnessed commendable advancements. 

#### **Gunmen attack Jaffer** express in Balochistan

ISLAMABAD, MAR 11 (UNI)

Gunmen attacked the Jaffer Express passenger train in Kachhi district of Pakistan's Balochistan province on Tuesday, injuring several people and prompting a security operation in the area, media reports said.

The assault occurred near Ab-e-Gum area of Mach Town, where around six armed men opened fire on the train, spreading panic among passengers, the Express Tribune

Meanwhile, the Baloch Liberation Army claimed responsibility for carrying out what it called a "strategic operation" and claimed that its activists have seized control of the Jaffar Express by derailing it. During the resistance, six military personnel were killed, while over 100 passengers have been taken into BLA custody.

Among the hostages are active-duty personnel from the Pakistani military, police, Anti-Terrorism Force (ATF), and Inter-Services Intelligence (ISI)-all of whom were traveling to Punjab on leave, the BLA claimed and warned that if the any military tried to intervene, all hostages will be executed.

Pakistani officials said rescue teams and security forces have reached the scene, and an operation is underway to track down the assailants.

Railway officials confirmed that the train's driver sustained serious injuries, and an emergency relief train has been dispatched

Following the attack, authorities halted Karachi-bound Bolan Mail at Sibi, along with the Peshawar-Quetta Jaffer Express, as a precautionary measure. The Sibi hospital has declared an emergency, anticipating further casualties. UNI XC GNK SSP

#### **Immigration bill** introduced in LS, Opposition claims legislation violates fundamental rights

NEW DELHI, MAR 11 (UNI)

Minister of State for Home Affairs Nityanand Rai introduced The Immigration and Foreigners Bill, 2025 in the Lok Sabha on Tuesday amid demands from the Congress and other Opposition parties that the legislation be withdrawn as it violated fundamental

The opposition also demanded the bill be referred to a Joint Parliamentary Committee

Congress member Manish Tewari said the bill "is a violation of our fundamental rights on many counts".

"Either this bill should be withdrawn or should be referred to a Joint Parliamentary Committee (JPC) for very careful consideration, because it violates multiple articles of the fundamental rights under the Constitution of India," he said.

He said the provisions of the bill can be potentially misused by any government of the day if it feels that the political views or the ideological beliefs of any individual or conscientious dissenter do not conform to the views of the incumbent establishment.

TMC member Saugata Roy also criticised the bill, arguing that its provisions are too stringent for foreigners. He further pointed out the absence of Union Home Minister Amit Shah in the House.

In response, Rai stated that concerns had been raised regarding the legislative competence of the bill. However, he asserted that the bill aligns with the legislative authority and falls within the provisions of the Indian

He said the bill is not intended to bar any foreigner but rather to ensure adherence to the country's laws. He emphasised that it is the government's duty to safeguard the nation's security, progress, sovereignty and overall safety.

Lok Sabha Speaker Om Birla later sought the House's opinion on the proposal to introduce the bill, which was approved by a voice

The WFI had been suspended on December 24, 2023, due to governance lapses, including violations of the National Sports Development Code of India, 2011, and a lack of transparency in operations. In response, an Ad-hoc Committee appointed by the Indian Olympic Association (IOA) had taken over the federation's responsibilities.

#### **EC** invites party presidents, senior leaders for interaction to strengthen electoral processes

NEW DELHI, MAR 11 (UNI)

The Elections Commission of India (ECI) has invited suggestions from all national and state political parties by April 30 to strengthen the election process.

As per the notification, the Commission has called for an interaction with the party presidents and seniors to further strengthen the electoral processes in accordance with the established law.

This comes after the opposition parties raised questions over the duplicity in some electors' photo identity cards after the Maharashtra polls.

Earlier, during an ECI conference last week, Chief Election Commissioner Gyanesh Kumar had instructed CEOs, DEOs and EROs of all states and UTs to hold regular interactions with political parties, resolve any suggestions received in such meetings strictly within the legal framework.

The Commission has also urged political parties to proactively use this mechanism of decentralised engagement.

# Sleep debt, night shifts can raise risk of infections: Study

NEW DELHI

Sleep debt and night shifts increase the risk of several common infections, according to a study on Monday.

According to researchers from Norway, sleep debt, defined as the gap between sleep need and actual sleep duration, increased infection risk in a dose-dependent manner.

# Study explains why firefighters may face a higher brain cancer risk

Firefighters with increased exposure to certain chemical compounds are more likely to develop gliomas -the most common type of malignant brain tumour -than individuals with other occupations, according to a study on Monday.

The study, published in the peer-reviewed journal CANCER, suggests a greater likelihood of haloalkane-associated mutations in firefighters with gliomas than in other patients with this type of brain cancer.

# Indian pharma market to grow 8-9 per cent in FY26: Report

Indian pharmaceuticals market is expected to grow 8-9 per cent year-onyear in FY26, according to a report on Monday.

The report by India Ratings and Research (Ind-Ra) said the growth in the sector will be at 7.5-8.0 per cent year on year for FY25. This is "against 6.5

per cent year-on-year in FY24 and 9.9 per cent YoY growth in FY23," said Krishnanath Munde, associate director at India Ratings and Research.

In February, the pharma market delivered revenue of 7.5 per cent year on year. This growth was driven by growth in price (5.2 per cent YoY) and new launches (2.4 per cent YoY), while (YTD) in FY25. 
