Changing weather patterns a challenge: CM Omar Says artificial snow will be generated to ensure early skiing at Gulmarg

GULMARG, MARCH 12: Chief Minister Omar Abdullah today said that he was delighted to see the 5th Edition of Khelo India Winter Games (KIWG) in Gulmarg held successfully.

Union Sports Minister Mansukh Mandaviya, who was the chief guest on the occasion, also addressed the concluding function of the Khelo India Winter Games 2025 held in Gulmarg. "Finally, the 5th Khelo India Winter Games were held smoothly," he remarked at the outset of his address while addressing a large gathering of athletes, officials and guests.

Reflecting on the challenges leading up to the event, the CM noted that persistent dry



weather in January and February had raised concerns about whether the games would take place this year.

"Over the past four years, KIWG have been conducted with great enthusiasm. However, this year, we faced an unprecedented challenge as there was very little snow accumulation."

He shared that a thorough assessment of the snow conditions was conducted by technical staff, leading to extensive discussions on whether the games should be held, postponed or cancelled. Eventually, he decided to postpone the event, hoping for snowfall.

"Then, by the grace of the Almighty, we received enough snow, and the 5th Edition of KIWG was officially announced," he said.

When asked whether there had been a reduction in central assistance, the minister clarified that overall assistance has remained steady. TURN ON.....PAGE 02


J&K LG Orders Remission of Life Sentence for Three Jammu Convicts

Srinagar, Mar 12, :: Jammu and Kashmir Lieutenant Governor Manoj Sinha has ordered the remission of life imprisonment for three convicts previously sentenced under Sections 302, 34, and 201 of the Ranbir Penal Code.

A notification issued by the J&K Home Department states that the remission has been granted under Section 473 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, in accordance with Ministry of Home Affairs directives. The order takes immediate effect,

subject to strict conditions. As per the notification, the released individuals must maintain peace, avoid unlawful activities, and refrain from intimidating the victims' families. They are also required to report to the



police every six months and complete all legal formalities before their release. Authorities have instructed local police to monitor their activities, warning that any violation will lead to the cancellation of their remission.

The convicts, Anil Singh of Jammu's Shastri Nagar, Dev Raj of Chak Jaffray, Kana Chak, and Girdhari Lal of Mangnar, Poonch, had served over 14 to 16 years of their life sentences before being granted remission.

"The general public/ motorists are hereby informed that on 16.03.2025 (Sunday) at 06:30 AM "Run for Fun Jammu Marathon" will be organized by J&K Police. In this connection diversions will be applicable on the day from 0500 Hours to till conclusion of Marathon (11:00 AM expectedly)" a public notice issued today stated.

The Marathon will start from Gulshan Ground (Starting/Finishing Point) and pass through PHQ Main Gate - P/S Bagh-e-Bahu Crossing -Qasim Nagar – NH-44 – Forest Check Post – Environment Park – Hill View

As per diversion plan, All kind of traffic movement shall remain restricted on the marathon route during the movement of Marathon participants.

To ensure the success of the festivals, the Deputy Commissioner issued directives to the heads of different departments, emphasiz-



ing meticulous planning and execution in their respective areas of responsibility. Particular attention was given to security to mitigate any potential untoward incidents during the festive

The Jal Shakti department was entrusted with ensuring a consistent supply of potable water, while the Power Development

Department (PDD) was directed to ensure uninterrupted electricity supply throughout the festival duration.

Civil society's cooperation was encouraged to uphold cleanliness standards in the town.

To prevent profiteering and black marketing, the Food Safety department was directed to conduct market checks across all markets of the district to ensure essential commodities are sold at government-approved rates and meet quality standards.

He then traced the evolution of Gulmarg's sports infrastructure, mentioning the development of chairlifts and the Gondola Phase 2

"The initial infrastructure at Gulmarg dates back to the British era, but what we have today is still not sufficient to meet the growing demands of winter sports and tourism," he

The CM underscored the need to upgrade Gulmarg's sports facilities, citing examples of Central Asian countries like Uzbekistan, which have developed world-class skiing infrastructure that now attracts international skiers—including those who previously visited Gulmarg.

"If we wish to position ourselves as a global winter sports destination, we must invest in infrastructure enhancement," he stressed. Speaking about the recent inauguration of the Sonamarg Tunnel by Prime Minister Narendra Modi. CM Omar Abdullah described it as a game-changer for tourism and sports in the region. "Sonmarg is now another glorious tourism and sports destination. We also plan to develop skiing facilities there," he announced.

Looking ahead, the CM envisioned using eco-friendly artificial snow technology to ensure that the Khelo India Winter Games can be held as early as December and January, thereby expanding the winter sports season.

Referring to the assurance given by Union Sports Minister Mansukh Mandaviya to J&K Sports Minister Satish Sharma, CM Omar Abdullah expressed gratitude for any assistance the Ministry of Youth Affairs and Sports could

He also emphasized that sports infrastructure should not be limited to mainstream games like cricket and football, which require spacious

"Emerging sports like Pickleball are attracting young players, and these require minimal space. We must diversify our sports infrastructure," he suggested.

He said that such a show should not be held at any time of the year and not to talk of the holy month of

Omar said that the event was a private event and the union territory government had no knowledge about the same. The people as a whole welcomed the statement of the chief minister and termed it in tune with the aspirations and emotions of the valley residents. A section of the people is not ready to buy the chief minister's statement that the government was having no knowledge about the fashion show. These people say that mere condemnation would not work and the government must act.

Since Omar heads the tourism department some heads must roll following the controversy over the holding of the show. Jammu, March 12: Minister for Jal Shakti, Javed Ahmad Rana, today informed the House that several measures are being taken up to address the pollution and other environmental concerns affecting the Chenab and Ravi rivers in Jammu

The Minister was replying to a question raised by Davinder Kumar

Manyal in the Legislative Assembly. The Minister informed that 11 Decentralized Waste Water Treatment Systems (DEWATS) have been

proposed for various districts of Jammu Division through Rural Development Department to tackle river pollution caused by grey water discharge from the households.

He stated that, of these, 04 works have already been commenced and these systems are specifically designed to effectively mitigate pollution concerns and improve the environmental health of rivers in

The Minister informed that a DPR for "Improvement and Strengthening of Main Ravi Canal and its distribution network" amounting Rs. 571.83 crore has been framed for



better management of irrigation and water resources in Ramgarh Constituency, which also includes the canal network of Ramgarh Constituency. The said DPR stands submitted to CWC for appraisal.

He also provided details about the steps being taken up for improvement/rejuvenation of canals (Jammu Chenab) in the Ramgarh Constituency. He informed that the stretch of D-9 canal from RD 32000 m to 36600 m falls under the territorial jurisdiction of Ramgarh Constitu-

He said that the stretch of 4.50 Km cater to 1259 acre of land for Irrigation and the overall condition of the canal is good, however, the stretch of about 1 Km at spots requires improvement and same shall be part of the project shelf of UT Capex 2025-

The Minister said that timeline for the project "Improvement of Ravi Canal and its distributaries" shall be two years from the date of sanction of the project. After implementation of the project, a potential of 8861 Ha shall be increased in Ramgarh Constituency. Further, other improvement works are being executed under UT Capex Budget as per availability of funds, he added.



Childhood abuse may double risk 25 mn young people in US now living of poor health later: Study

Children who experience physical and sexual abuse are twice as likely to suffer from physical and mental health conditions. including angina, arthritis, asthma, COPD, heart attack, depression, and disability in adulthood, according to a study.

The study, published in the journal Child Maltreatment, found that children with sexual abuse were 55 per cent to 90 per cent more likely to experience these health outcomes compared to their peers who had not experienced any abuse.

Facing only physical abuse also had significantly elevated odds of these health outcomes from 20 per cent to 50 per cent.



The prevalence of chronic conditions such as attention deficit hyperactivity disorder (ADHD), autism, asthma, prediabetes, and depression or anxiety, has risen to unprecedented levels -- 30 per cent -- over the past twenty years in the US, according to a study. The study showed that nearly one-in-three young people or about 25 million young people ages 5 to 25 are estimated to now be living with these conditions that began in childhood. It is significantly affecting and limiting their lives.

"The prevalence of childhood conditions is currently higher than previous estimates suggest, said lead author Lauren Wisk, an assistant profesversity of California-Los Angeles, US.

They found that the frequency among children ages 5 to 17 years rose from about 23 per cent in 1999/2000 to more than 30 per cent by 2017/2018. This amounts to an estimated 130,000 additional children per year.

Among young adults ages 18 to 25 years, the prevalence increased from 18.5 per cent to 29 per cent over the same period. for about an additional 80,000 young adults each

Nearly all of the conditions are treatable with access to high-quality healthcare, Wisk said.




