

Those who attended the meeting included Principal Secretary, Finance; Director, IIM Jammu; Commissioner Secretary, GAD; Secretary, Planning; Secretary, Law besides other concerned officers from IIM, CITaG and government departments.

During the meeting, Dulloo highlighted CITaG as a crucial platform for fostering coordination among the premier institutions such as IIT, IIM and AIIMS with the government. He emphasized the need for developing governance models aligned with future

demands, ensuring that J&K remains at the forefront of technological advancements.

Expressing urgency, he stated that rapid developments in Artificial Intelligence, Bioengineering, Climate Change and Quantum Computing necessitate immediate action. "If we fail to adapt to these transformations, we will be left behind with none to blame," he remarked.

He further stressed that solutions are available for addressing the physiological, biological and environmental concerns, but the key lies in adopting relevant technologies. He urged the Planning, Development & Monitoring Department (PD&MD) to explore technological solutions for bridging the governance gaps.

been achieved on this road and remaining work is in progress on war footing.

He said that three routes lead from NH44 to the Shrine of Baba Chambyal in Ramgarh constituency and the first road starts from Vijaypur NH to Chambyal via Ramgarh and SM Pura having length of 16.70 Km. He added that the second road starts from Swankha Morh NH to Chambyal via Swankha having length of 16.50 Km, 4 Km is being maintained by BRO and remaining 12.50 Km is with the PWD. "PWD has completed upgradation/ improvement of 12.50 Km road in 2023-24 under CRIF having intermediate lane of width 5.5 m. This road merges with the above mentioned first road 2 Km ahead of the Shrine", he informed.

in Jhelum basin and 500 MW in Ravi basin. He said that out of the identified potential, 3540.15 MW (23.81%) has been harnessed till date including 1197.4 MW in UT sector (JKSP-DC), 2250 MW in Central sector (NHPC) and 92.75 MW in IPP mode under 31 projects.

Regarding the Solar Power Projects, the Minister said that solar power plants with capacity of 41367 and 34300 have been installed in a total of 4648 government buildings and 5463 residential households respec-

tively. The Minister said that UT of J&K has an estimated solar potential of 111 GW, most of which is restricted to the UT of Ladakh. He added that the mega size solar power projects have not been developed in I&K till date as identification of feasible land banks (500 acres for 100 MW solar park) at a single location for its development is difficult because of the topography of the UT.

The Minister informed that, however, a cumulative capacity of 75 MW of Rooftop Solar Power Plants has been installed in the UT of J&K across all sectors under various schemes and projects mostly sponsored by the Ministry of New and Renewable Energy (MNRE), GoI.

He added that, presently, the Rooftop Solar Power plants are being installed on residential households by DISCOMS under PM Surya Ghar Muft Bijli Yojna in which 1 kWp Rs 55,000 with subsidy of Rs 36,000, 2 kWp Rs 1,10,000 with subsidy of Rs 72,000 and 3 kWp Rs 1,59,500 with subsidy of Rs 94,800 have been finalized.

The Minister also informed that Purchase of electric/utility poles, HT/LT wires and transformers is being made through the

shops, and programs are regularly undertaken in schools, colleges, and universities, in collaboration with district administration, NGOs, volunteers, and other allied agencies, to address the menace and ill effects of drug and substance abuse," Itoo said. "We have collaborated with J&K Bank under the project Najjath, which focuses on drug abuse prevention and treatment. This initiative was successfully launched on November 10, 2023, covering the Jammu and Pulwama districts.'

She said the project aims to raise awareness among individuals, families, and communities about the harmful effects of tobacco and drug addiction, as well as the available resources for prevention, treatment, and support.

To further facilitate treatment for drug victims, the government has established a call centre known as Tele Manas, which provides counselling, helps with stress management, and motivates drug users to

When responding to a similar question from MLA Banihal Sajad Shaheen, Itoo acknowledged that there had previously been an increase in drug addiction among the youth of Jammu and Kashmir. However, she said that since the initiation of the Nasha Mukt Abhiyan in September 2022, there has been a slight decrease in the registration of new cases, according to available records.

"As per available data, there has been no increase in newly registered drug addiction cases in Jammu and Kashmir. A comparison of three years of data shows no rise in the number of registered cases," she clarified.

The health minister highlighted the steps taken to combat this issue, including the adoption of a drug re-addiction policy, the constitution of a State Level Policy Implementation Monitoring Committee, and the launch of a massive campaign—Nasha Mukt J&K Abhiyan. She said the Health Department has established standard operating procedures, divisional-level monitoring committees, and district-level monitoring committees for effective oversight and functioning of drug de-addiction centres.

Currently, there are 20 addiction treatment facilities (ATFs) operational in Jammu and Kashmir, with 11 in the Kashmir Division and 9 in the Jammu Division. Outpatient department (OPD) services are functional in all 20 districts, while inpatient department (IPD) services are available in all 9 Government Medical Colleges (GMCs), catering to both male and female patients, with psychiatrists available in all GMCs throughout the UT.

"Twenty-five medical officers, with 12 from Jammu and 13 from Kashmir, have been trained by NIMHANS, Bengaluru, and were deployed to their respective districts to strengthen de-addiction centres. They are also responsible for enhancing surveillance and data collection on a daily basis through Google Sheets for real-time reporting to monitor trends and measure the impact of interventions," the minister added.

Responding to a similar inquiry from MLA Khanyar Ali Mohammad Sagar, Minister Itoo said the Health Department's role is limited to managing medicinal preparations that fall under their purview, while the enforcement staff regulates the sale of habit-forming drugs governed under Schedule H1 and X of the Drugs and Cosmetics Act of 1940.

"The subject of narcotic drugs, as well as violations under the Narcotic Drugs and Psychotropic Substances (NDPS) Act of 1985, is primarily regulated by the Narcotics Control Bureau, Excise, Police, and the Revenue Department of the UT. Sale statements for habit-forming drugs are obtained from depots and C&F of various pharmaceutical manufacturers operating in the UT," she said, adding, "The supply chain of such drugs is monitored regularly up to the end-user level. We are continuously persuading state drug controllers in neighbouring states and UTs to exercise strict regulation regarding the sale of such medicinal preparations to restrict interstate smuggling."

The minister added that the Drug and Food Control Organisation conducts awareness programmes at the district level to educate the public about the ill effects of habit-forming drugs. Special drives, in addition to routine inspections, are being conducted to curb the menace of these drugs, including prosecutions and administrative actions such as the suspension of drug sale licenses under the Drugs and Cosmetics Act of 1940.

She said the department has also successfully implemented directives from various NCORD meetings regarding the installation of CCTV cameras and the adoption of computerized billing systems in drug sale establishments.

"This proactive approach has resulted in increased transparency, accountability, and responsibility in the drug regulatory mechanism," Itoo said-

accurately and empower the teachers to provide personalized learning interventions. To enhance CITaG's effectiveness, Dulloo directed the officials to make its verticals fully operational and strengthen the capacity of government officers to function optimally under this framework.

About the key achievements and progress made, so far, Commissioner Secretary, PD&MD, Talat Parvez Rohella made out that a dedicated CITaG Cell, led by the Director General of PD&MD, has been established to oversee Public Private Partnerships (PPP) and state transformation initiatives. He added that the government has allocated 2.18 crore for CITaG's initiatives, with a proposed annual budget of 7.61 crore for the next

Regarding the capacity building, he informed the meeting that training sessions  $have\,been\,conducted, equipping\,197\,officials$ with skills in governance transformation. An additional 200 officials are set to undergo the training in the coming months, he concluded.

Director IIM Jammu, Professor B.S Sahay besides giving the suggestions for prioritized uptake also informed about the plan for further streamlining the working of this centre. He gave out that it is being planned to initiate the recruitment drive completing the hiring process for CITaG, including the selection of a Chief Executive Officer (CEO) and domain experts.

He revealed the training modules for future ready governance covering the key areas such as AI and digital governance, Blockchain Applications in public services, Big data for policy development, cybersecurity and risk management, leadership and digital transformation in governance.

It was also informed that the State Instituteof Transformation (SIT) concentrating on advancements in tourism, education, agriculture and urban planning is also going to be a reality soon.

Regarding implementation of PPP projects, the meeting was apprised that the bidding process for two Public-Private Partnership (PPP) projects had been concluded.

Moreover, it was added that Detailed Project Reports (DPRs) for four initiatives stands finalized besides completing feasibility studies for eight projects. It was also suggested that in order to overcome the shortage of professionals in the centre it is being planned that a student internship program offering a monthly stipend to the students involved in governance research projects.

Pertinent to mention here that the CITaG, a pioneering initiative under the Planning **Development & Monitoring Department** (PD&MD) in collaboration with the Indian Institute of Management (IIM) Jammu was established with the support of NITI Aayog, the Department of Economic Affairs (Ministry of Finance, GoI) and the UT government. It aims to drive the governance reforms through research, policy development and capacity building thereby building a conducive environment for investments and publicprivate partnerships (PPP) while strengthening future-ready governance structures here in the UT.

truth-tellers languishing in Indian jails. His remarks have once again brought focus to the issue of political detentions in Kashmir, a subject that has frequently drawn criticism from human rights organizations. Civil society groups have repeatedly demanded the release of political prisoners, citing concerns over their health and prolonged legal battles.

To address this, steps are being taken to Improve healthcare facilities, Including infrastructure, medical staff, besides providing necessary medical equipment to enhance patient care and meet the rising demand for healthcare services," she added.

"SDH Pampore, PHC Khrew and PHC Pampore are functional and well equipped in terms of infrastructure, manpower and Medical equipment," Sakina said—(KNO)

The chief minister revealed that a list of 52 ropeway projects for J&K had been proposed, with bidding currently underway for a 1.05 km ropeway to the Shankaracharya temple in Srinagar. However, bids for a 2.12 km ropeway from Darshan Deopdi to Shivkhori temple in Reasi were annulled due to an ongoing court case.

As per the latest tender issued on January 25, 2025, the NHLML has invited bids for DPRs of the Baltal-Amarnath ropeway. an 8.80 km Bhaderwah-Seojhdar ropeway in Doda, and a 1.60 km Sonamarg-Thajiwas Glacier ropeway. These projects are expected to enhance accessibility for both pilgrims and tourists.

Additionally, DPR bids are being sought for the Parihas-Diskhal ropeway at Doodhpathri, Sutharan-Tosamaidan ropeway in Budgam, and Nashri Tunnel-Sanasar lake ropeway in Ramban. Meanwhile, a prefeasibility study is underway for the Karchiall-Wasamarg ropeway in Ramban. [KNT]

He informed the House that the intends have also been placed for 9661.05 kanal of land and 5000.13 kanal for establishment of Industrial Estates in Jammu and Kashmir respectively.He said that among others, Education and Skill Development, figures in the Focus Sector List of J&K Industrial policy 2021-30 which is also part of Service Sector Positive List of New Central Sector Scheme (NCSS) 2021, issued by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India.

He added that 596 applicants have been registered under the Jammu and Kashmir Start-Up Policy notified vide Government Order No. 29-JK(IND) of 2024 dated 23.02.2024,, of which, 436 applicants have been recognized as Startups. Besides, 26 of these applicants are in the Skill Development and Education Sector. The Minister asserted that the Industrial Estates have been designated as Sector Specific Industrial Estates in sectors like Education and Skill Development, Health and Medical education in Jammu division and H&ME, Technical Education and Information Technology and Information Technology in Service (IT/ITeS) sectors comprising more than 3628 kanal of land in both the divisions.

Srinagar, Mar 22, KNT: The lapse of Rs 90 crore in capital expenditure funds over the past three years at the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) has raised serious concerns about financial management at the premier healthcare institution. However, for the first time since 2021, all allocated funds have been fully utilized this year, including Rs 50 crore in central funding.

The issue was brought to light in the Legislative Assembly when MLA Tangmarg, Farooq Ahmad Shah, sought details on fund utilization at SKIMS. In response, Minister for Health and Medical Education, Sakina Masood



Ittoo, informed the House that a total of Rs 90 crore remained unutilized over the past three financial years. She provided a breakdown of the lapses, stating that Rs 34.16 crore went unused in 2021-22, Rs 21.72 crore in News Trust. [KNT]

2022-23, and Rs 34.22 crore in 2023-24. The revelation has sparked discussions over budgetary inefficiencies during the tenure of former SKIMS Director, Dr. Parvaiz Koul, under whom the lapses occurred. Sources said the inability to utilize allocated funds had hindered infrastructure development and procurement of essential medical equipment at the institute. However, the current administration at SKIMS has ensured the  $complete\,utilization\,of\,funds\,this\,year.$ "For the first time in years, we have successfully utilized the entire budget, including Rs 50 crore received from the central government," SKIMS Director, Prof. Muhammad Ashraf Ganaie told the news agency Kashmir


SMC urged all citizens to adopt simple water-saving measures, such as fixing leaks, reducing wastage, and using water efficiently in daily activities.

## Health institution Batamaloo upgraded to PHC: Sakeena Itoo

Jammu March 22, Minister for Health and Medical Education, Sakeena Itoo, today informed the House that Health institution Batamaloo has been upgraded to PHC and is functional with sufficient infrastructure.

The Minister said this while replying to a question by Tariq Hameed Karra.

The Minister said that the PHC Batamaloo is functioning with 12 sanctioned posts. She added that out of 12, 9 are in-position including two Medical Officers and two Dental Surgeons from the regular side, besides 16 sanctioned posts from NHM side are also in place.

The Minister further informed that PHC Batamaloo has sufficient infrastructure as a four storied structure required for smooth functioning of a UPHC and its bed strength had been raised to 56 during Covid time.

The Minister further said that the catchment area of PHC Batamaloo is approximately 50,000 as reported by the Director Health Services Kashmir. She added that PHC Batamaloo does not qualify for up-gradation to the level of Sub District Hospital

She also informed that PHC Batamaloo is being served by the higher and tertiary level health institutions like GMCSrinagar, Super Specialty Hospital Srinagar, SKIMS Srinagar, SKIMS (JVC) Medical College, SMHS Hospital Srinagar, LD Hospital Srinagar, NTPHC Lachmanpora Batmaloo and UPHC Bemina.

## Govt completes all development works on Abhinav Theatre, makes it fully functional: Dy CM

Jammu, Mar 22, : Deputy Chief Minister, Surinder Choudhary, today said that all development works on Abhinav Theatre, Jammu have been completed and the theatre is fully functional.

### Two Killed as Pickup-Truck Plunges into Gorge on Srinagar-Jammu Highway

SRINAGAR, Mar 22,: Two people lost their lives in a road accident at Battery Chashma along the Srinagar-Jammu Highway after a pick-up truck veered off the road and plunged into a deep gorge on Saturday. Police sources told the news agency Kashmir News Trust that the vehicle, a Tata Yodha (JK14H-2006), was carrying vegetables from Jammu to Srinagar when the driver lost control, leading to the fatal crash. The driver, identified as Seva Singh, and another occupant, Irshad Rashid, a resident of Ukhral, Banihal, died on the spot. The impact of the accident left the vehicle completely damaged. Rescue teams, along with police, rushed to the scene and retrieved the bodies. Authorities have urged drivers to exercise caution while navigating the treacherous stretches of the highway. especially during adverse weather conditions. [KNT]

## **GOI's decision to** reduce import duty on foreign apples pushes local apple growers to wall

The decision of the Government of India to reduce the import duty on the apples imported from the United States of America has led to heartburn among the fruit growers of the Kashmir valley. The apple growers of the valley have already voiced their concern over this development and have urged the union territory government to intervene in the matter. They have demanded that the step should be rolled back so that the fruit industry is saved from further losses.

Since Kashmir's economy is predominantly dependent on the horticulture sector the government move to reduce duty on imported apples is bound to cause disaster to the sector. Over the years the fruit industry of the valley faced serious challenges and the people involved in this sector at times feel that they have been pushed to the wall. This time around too the government decision to cut down duty on imported apples has not gone well with the apple growers and they want immediate rollback.

There is a trend in Kashmir that people tend to follow others as and when the other person tries to do something new. Same has been witnessed in the high density apple project launched some years back by the government. Many people converted their paddy fields into apple orchards and as such there is a food grain crisis in many areas of the valley. People randomly converted their paddy fields into apple orchards without looking into the repercussions of the same.

It is a well established fact that apple orchards cannot be set up in a random manner and there are many factors that determine the same. The soil and climate are the important factors in this regard and these need to be properly assessed before taking any decision to convert any type of land into apple orchards. The hush-hush manner in which the people took the decision and converted their fields into apple orchards speaks volumes about their lack of knowledge about the

Most of the people in order to earn quick bucks converted their fields into apple orchards without caring for the consequences thereof. This resulted in a food grain crisis and due to the availability of more apples the apple growers and traders were forced to cut down the rates of their produce. Given this fact the apple growers and traders sold their stock at much cheaper price and at the end of the day these people suffered huge losses.

## The begging mentality in Kashmir: Towards a culture of empowerment and self-sufficiency

Need to confront dependency and promote dignity through responsible charity and community support

n Kashmir, a growing "begging mentality' threatens to shape the moral and economic fabric of society. This is not just a practice of charity but an ingrained habit that needs deeper reflection. Workforce participation of women above 30 years of age in India is only 18%, while this number is 78% for men.

Inspiring Case Studies

Indra Noovi managed to maintain her career despite being married. In her book "My Life in Full," she has explained how she balanced her family and career and how companies need to create supportive workplaces for women. Kiran Mazumdar Shaw (founder of Biocon) built her biotech company despite marriage and society's expectations. According to her, women can successfully pursue their careers even after marriage if they get support from their family. Tennis star Serena Williams returned to the game even after motherhood and won many titles. She broke the myth that the only option after becoming a mother is to quit a career.

So what is the solution? Families need to understand that marriage does not mean the end of women's careers. Men should play an equal role in the responsibilities of the home and children. Companies should provide more flexible job options for women. Instead of looking at career and marriage as opposing poles, they need to be taken together. Men should also be equal partners in the responsibilities of the home and children. Companies should provide flexible working options so that women can easily play both roles.

Marriage can be a new chapter, not "the end"!

Marriage should not mean "the end" of any woman's career. Rather, it should be a stage from where she can move forward in a balanced way in her personal and professional life. 

He said that the agenda for promotion of Finance Assistants to the level of Assistant Accounts Officer (AAO) was considered in the DPC meeting held on 5th/9th August, 2024, but because of mismatch between the Finance Department rules adopted by the JKSPDC for such promotions and eligibility of the candidates, it was deemed appropriate to seek Board of Directors (BoDs) approval to dispense with the requirement of passing SAC-I and SAC-II exams stipulated in the Finance Depart-

ment rules for their promotion. The Minister said that the matter



is being placed before the BoDs for appropriate decisions facilitating

their promotion. The Minister said that in case of Computer Operators (currently at Pay level L-4), there is no higher post available in consecutive pay level of L-5 in the sanctioned strength issued by the Government of Jammu & Kashmir vide Government Order No: 56- JK(PDD) of 2023 dated

The Minister said that having regard to the fact that the functioning of the Corporation, a distinct corporate entity under Companies law, does not conform to the functioning of a government department and requires different skill sets, job profiles and hierarchical pattern, the Corporation is in the advanced stage of finalizing stage recruitment rules.

These recruitment rules once notified shall provide a clear career progression for all those cadres includ $ing\,computer\,operators.\,Promotions$ for other cadres including Junior Assistants and Senior Assistants, will however, be initiated shortly against vacant promotion quota posts after following relevant recruitment rules currently in vogue i.e. J&K Subordinate Service Recruitment Rules, SRO-381 of 1981 Dated. 26.08.1981.

The Minister said that as it is evident from this information that no discrimination with non-gazetted employees has ever been made in past nor shall be made in future while as promotions against vacant promotion quota posts of all cadres, where the employees are eligible under relevant Government recruitment rules in vogue, shall be initiated and concluded shortly.

## **Sopore Town receives 24x7** power supply under PMDP, **RDSS schemes: Javed Rana**

Jammu, Mar 22; Minister for Jal Shakti, Javed Ahmad Rana, today said that Watlab Receiving Station has been upgraded from 1x6.3 MVA to 2x6.3 MVA under PMDP and completed in 2019. The Minister was replying on behalf of Chief Minister, Omar Abdullah, to a question raised by Irshad Rasool Kar.He said that the upgraded Watlab Receiving Station has been supplying power to the Warpora area through the 11KV Warpora feeder, however, with increasing load demand, the feeder load reaches 460 Amps during the peak hours. He added that to address this, the department has initiated a fresh technical feasibility survey to assess the need for a new  $Receiving\,Station\,at\,Warpora\,and\,a\,decision\,on\,the\,new$ Receiving Station will be taken based on the survey

He said that the 10MVA 33/11KV Receiving Station at Warpora was initially proposed as part of a prospective plan. The Minister said that Electrical infrastructure development is underway under various centrally sponsored schemes like PMDP/RDSS. He said that some areas of Sopore Town (Model Town, Court Road, Galabad) havebeen completed and 24x7 power supply is being provided there. He said that there has been an appreciable improvement in power supply hours, quality of supply in completed areas and work is in progress for the remaining feeders and planned shutdowns are being availed for execution of works safely, with prior informa-

He said that once the project works are completed and the loss level of feeders decreases to the desired level, the feeders will qualify for 24x7 power supply.

The Minister said that the work on shifting/re-aligning the entire 33 KV line is not being covered under any existing projects. However, a separate tap line was taken up from Substation Sopore-1 to River crossing under the Centrally Sponsored Scheme R-APDRP Part-B to partly shift the line.

The financial assistance covers multiple components, including death and funeral assistance, as well as educational support. The initiative aims to provide financial stability and social security to construction workers and their families.



## DC reviews TB Cases, treatment protocols in Poonch Calls for timely diagnosis, providing nutritional support to patients

POONCH, MARCH 22: Deputy Commissioner Vikas Kundal today convened a meeting to review the current status of TB cases and the implementation of treatment protocols under the National Tuberculosis Elimination Program (NTEP) in Poonch District.

The meeting revealed critical insights into the number of reported TB cases, Human Resources (HR) status, condition of advanced testing laboratories, sputum examination results, treatment statuses, and overall incidence rates. The review underscored the urgency of timely diagnosis and strict adherence to treatment protocols to effectively manage and reduce the spread of this contagious

During the discussions, the Deputy Commissioner stressed the necessity of organizing awareness IEC (Information, Education, and Communication) activities on Tuberculosis. He urged the Chief Medical Officer (CMO) to ensure effective case



detection and engage community support in the fight against TB.

Additionally, the need for involving Nikshay Mitras to provide nutritional support to all TB patients during their treatment was highlighted as a key initiative to enhance patient care.

To further strengthen the TB management strategy, the Deputy Commissioner directed the PPM to conduct regular

visits to all blocks once every 15 days. These visits will facilitate meetings with doctors to ensure proper notification and testing of TB cases.

This installation aims to simplify and expedite TB testing for the local population. ## Study links childhood obesity with chronic lung disease later

Children overweight or obese may be at an increased risk of chronic obstructive pulmonary disease (COPD) in adulthood, according to a study.

COPD is a progressive lung disease that makes it hard to breathe and worsens over time.

While smoking is a major risk factor for COPD, other risk factors like environmental, occupational, and even early life factors are increasingly being recognised.

The study led by researchers from Copenhagen University in Denmark focuses on examining the link between a high body mass index (BMI) in childhood and COPD.

The team found that compared to women with an average childhood BMI, risks of chronic COPD were 10 per cent higher for sity BMI trajectory the risk above-average trajectory. those who had an aboveaverage BMI trajectory.

In contrast, a lower risk of future COPD was observed only for women with a below-average childhood BMI trajectory -- 9 per cent lower compared to women with an average childhood BMI trajectory.

"Having a BMI trajectory above average in childhood may increase the risk of subsequent COPD. Thus, our results suggest that being overweight during this early period of life is an indicator of risk for the development of COPD," said Frida Richter, from the Center for Clinical Research and Prevention, at the varsity.

The study included data from 276,747 Danish children (137,493 girls) born from 1930-1982, who had between 2 and 12 weight and height measurements between ages 6-15 years.

They were then examined for a diagnosis of COPD from age 40 years onwards. The research will be presented at this year's European Congress on Obesity (ECO 2025) to be held in Malaga, Spain in May

## Antibody-based therapy shows promise against lethal mucormycosis

An antibody-based therapy has shown promise to treat lethal mucormycosis -- a fungal infection that caused serious infection among Covid-19 patients.

Mucormycosis is caused by fungi Mucorales and has high mortality rates in people with weakened immune systems. The disease caused serious infection among Covid-19 patients treated with high doses of corticosteroids with mortality rates close to 60 per cent.

While vaccines and immunotherapies are available for viruses and bacteria, effective antifungal immunotherapies for mucormycosis, specifically, are lacking.
