The approved grants included Rs. 258369.98 Lakh for Agriculture Production Department, Rs. 122899.58 Lakh for Animal & Sheep Husbandry Department, Rs. 22524.86 Lakh for Fisheries Department, Rs. 475485.95 Lakh for Rural

Development Department, Rs. 70429.33 lakh for Horticulture Department, Rs. 35960.43 lakh for Election Department, and Rs. 9642.4 Lakh for the Co-operatives Department.

Winding up the discussion on Demands for Grants, Minister for Agriculture Production, RDD, Cooperative and Election, Departments, Javid Ahmad Dar, said that agriculture and allied sectors are indeed the backbone of Jammu & Kashmir's economy, contributing a staggering Rs 37,559 crore, which accounts for 18 percent of the State's Gross Domestic Product (SGDP). The Horticulture sector takes the lead, accounting for a whopping 41 percent of this contribution, reaffirming J&K's dominance in high value fruit production. ## Invest in horticulture sector to curb unemployment: Sajad Lone to Govt

Calls for opening doors for corporate investment, increasing budget allocation

SRINAGAR, MAR 24: Peoples Conference Chairman and MLA Handwara Sajad Lone on Monday raised concerns over the low budget allocation for the horticulture sector in Jammu and Kashmir.

There is a lot of scope in this industry to generate employment, but the budget allocation remains low. Day by day, job opportunities are shrinking, and this sector has the potential to grow," Lone



said while speaking in the assembly. Highlighting the financial

struggles of farmers, he stated that those engaged in tradi-

tional paddy farming barely manage to allocate Rs 2,500 after covering expenses, whereas high-gain industries offer significantly higher incomes. "If farmers earn well, they will continue agricultural activities. Otherwise, why would they grow rice just for the sake of tradition, even when it is not profitable?" he

Lone warned that agricul-

The Chief Minister, while intervening during the Question Hour in the Legislative Assembly, stated that funds are being disbursed efficiently. Out of the Rs 155 crore received, Rs 144 crore have already been distributed among the landowners, leaving only Rs 11 crore to be released soon. While individual concerns may persist, the government is committed towards expediting the fund disbursement as efficiently as possible.

He said that the concerned department will be urged to expedite the process in this regard. "However, as one of the members pointed out, this is not merely an issue of relief but it's a humanitarian concern. Beyond this relief, there are so many other pressing concerns affecting the people in these areas that demand our attention," he asserted.

"I urge the members to allow the session to conclude at the earliest. Once the session ends in the first week of April, I will convene a meeting with all the members representing the border and LoC areas," maintained the Chief Minister. We will engage in comprehensive discussions and promptly implement the necessary government actions, he added.

 $Earlier, replying to the \, main \, question \, raised$ by Vijay Kumar, Minister for Health and Medical Education, Sakeena Itoo, on behalf of Chief Minister, said that land measuring 13415 Kanal in 113 villages of Jammu, Samba and Kathua districts in Jammu division has been acquired by the BSF for Border fencing.

The Minister informed that an amount of Rs. 155.08 crore, as compensation, has been received by the concerned Collectors, out of which, Rs. 144.12 crore have been disbursed among the landowners and remaining amount is under process of title verification.

The elections for J&K Assembly were held in three phases during September and October last year. In the polls, National Conference emerged as the single largest party, securing 42 seats, while its ally Congress won six seats. The BJP claimed 29 seats, and the Peoples Democratic Party secured three.

People's Conference (PC), Communist Party of India (Marxist) (CPI(M)) and Aam Aadmi Party (AAP) each won one seat, while

"Even with a 50% subsidy, many farmers struggle to afford the remaining costs. There is resistance to modernising agriculture because of financial constraints." he said.

Lone urged the government to open doors for corporate investment or directly inject funds into the horticulture sector to support farmers. "Without this transition, a significant portion of agricultural land will be lost to non-agricultural purposes," he said—

perception. However, the court declined the transfer request, instead directing the Srinagar Wing to facilitate virtual hearings.

As per the news agency—the case revolves around a 17-kanal land dispute in Shopian, initially ruled in favor of respondents 4 to 7 through an allegedly fraudulent compromise decree in the Munsiff Court, Pulwama.

The decree was later set aside, and the case was transferred to the Jammu court due to the security concerns of the petitioners, who had migrated from Kashmir.

After nearly two decades of litigation, the suit was dismissed on November 16, 2023, and possession of the land was handed back to the petitioners on February 14, 2024.

Following this, the respondents challenged the dismissal order in the Srinagar Wing of the High Court, prompting the petitioners to seek a transfer back to Jammu, citing the same security concerns that had initially led to the case's relocation.

Chief Justice Tashi Rabstan acknowledged the threat perception that the petitioners face, stating that the security situation in Kashmir had previously justified transferring the case. However, he said that modern virtual hearing facilities now allow litigants to attend proceedings remotely.

Two decades ago, there was a significant security risk due to militancy, making it impossible for the petitioners to pursue their case in Srinagar. However, with virtual proceedings now available in both Wings of the High Court, the petitioners can attend hearings from Jammu itself," the Chief Justice said.

Instead of transferring the case, the court directed the Registrar (Judicial) of the Srinagar Wing to ensure that the petitioners and their counsel are provided virtual hearing links in advance. This arrangement allows them to argue their case without physically appearing in Srinagar, mitigating their security concerns—(KNO)

an important part of Ramadan. The large-scale gathering at Dar-ul-Uloom Raheemiya is not just about worship but also about community participation, with volunteers playing a crucial role in supporting those observing Itikaf.

Many locals, known as Khadims (helpers), dedicate themselves to ensuring that the participants, or Itikafis, have everything they need. From preparing meals for Sehri (predawn meal) and Iftar (evening meal) to maintaining cleanliness in the seminary, the vol-

unteers work tirelessly behind the scenes. Shahid Ahmad, a local volunteer, has been assisting in Itikaf arrangements for the past five years. "Serving those in Itikafis a blessing for us," he said. "We wake up before Sehri to prepare food and ensure that everything is ready on time. It is tiring, but the satisfaction we get from serving others makes it worthwhile."The seminary sees a structured daily routine during these ten days, with prayers, Quranic recitations, and religious discussions filling the schedule. Volunteers like Muneeb Hussain, a 30-year-old from Bandipora, said the sense of brotherhood during this time is unparalleled.

"People from different places come here, but we all work together as one family. During Iftar, we ensure everyone gets their meal in time, and seeing them break their fast peacefully makes all our efforts worth it," he said—(KNO)

He said that the government is complementing its ongoing investments in infrastructure with a stronger emphasis on beneficiary-oriented schemes, ensuring that the farmers directly benefit from targeted interventions. One such initiative is the High-Density Plantation (HD) Scheme, which has already brought 836 hectare under highdensity orchards, including 174 hectare covered in the current financial year. With Rs 30 crore budget allocation during 2024-25, this initiative is driving higher productivity, increased farmer income and long-term sustainability in the horticulture sector, he added.

The Minister said that the government is also driving transformational growth in the livestock sector through targeted interventions that enhance productivity, employment and income generation for farmers. He said 3,220 dairy units were established in 2024-25 under Integrated Dairy Development Scheme, generating employment for nearly 5,000 people. Similarly, 2,170 units were set up in 2024-25 under the Integrated Sheep Development Scheme.

Jammu and Kashmir's agriculture sector is experiencing a remarkable transformation under the Holistic Agriculture Development Program (HADP), delivering tangible results, said the Minister. He extolled that agriculture in the UT is undergoing a transformative shift, from a focus solely on produce to a producercentric approach. This evolution is driving higher returns for the farmers, nurturing entrepreneurship and creating a more sustainable and commercially viable agricultural ecosystem, he added.

He said that there are 29 projects under HADP, spanning across all sectors within the Agriculture Production Department (APD), driving a fundamental transformation in Jammu & Kashmir's agri-economy.

The Minister highlighted significant strides in horticulture, particularly in the expansion of High-Density (HD) Plantations. The government is developing rootstock banks and mother orchards to support growth of HD plantations across 5,500 hectare under Project 21 of HADP. During 2024-25, the government promoted protected cultivation with 9,083 square meters already developed for rootstock production besides establishment of 45 hectares as mother orchards and cultivating 18.6 hectare for rootstock production, he maintained. He said that assistance will now be disbursed in three phases, 50 percent after plantation, 30 percent upon sprouting and the final 20 percent after one year, if survival reaches 90 percent, to address setbacks in traditional orchards due to reduced farmer engagement post-financial support.

The Minister said that the government is also launching scientific measures to improve livestock breeding besides implementing Embryo Transfer Technology (ETT) and Artificial Insemination (AI) to enhance the genetic potential in cattle, sheep and goats. He said that 191 satellite heifer rearing units had been established in 2024-25 to reduce dependence on animal imports and improve the quality of dairy animals in J&K. Additionally, 19 milk value-addition SHGs were supported with Rs 25 lakh each, equipping 88 SHGs with automatic milk collection units linked to bulk milk coolers. Regarding the mutton sector, he informed that four breed-based farms (each housing 500 sheep) and 673 commercial sheep farms had been established during 2024–25 said. Besides, the government is importing 900 high quality Texel and Dorper sheep from Australia to enhance the meat production. The Minister said that 210 trout units, 6 Recirculating Aquaculture System (RAS) units and 8 biofloc units had been established in 2024-25, to boost fish production, improve livelihoods and promote sustainable aquaculture in J&K. He added that the government is focusing on improving irrigation coverage, promoting climate-resilient cropping and ensuring judicious use of water resources for expanding irrigation infrastructure and enhancing water efficiency in rainfed areas.

He informed that the District Irrigation Plan aims to cover 415,000 hectare of Culturable Command Area (CCA). So far, 191,000 hectare has been covered and efforts are underway to bring an additional 33,000 hectare under irrigation. He said that, to bridge this gap, 18 projects are in progress under UT Capex and 14 new projects worth Rs 48.83 crore have been sanctioned. Also, 20,102 hectare has been brought under irrigation during 2024-25. Over the next three years, an allocation of Rs 116.86 crore will be utilized on establishment of 200 community borewells, integrated with drip and sprinkler irrigation systems to significantly enhance water use efficiency and boost agricultural productivity across 2,000 hectare.

The Minister said that, simultaneously, the Rainfed Area Development (RAD) Project 16 is focused on making rainfed farming more sustainable and climate resilient under HADP. He said that the department through its project on "Promotion of Vegetables and Exotic Vegetables under Open and Hi-Tech Protected Cultivation" is expanding both open-field vegetable cultivation and hi-tech protected farming, ensuring higher yields, better quality and greater market competitiveness. The Minister revealed that 21 lakh soil health cards have been issued to farmers

under the Soil Health Card (SHC) Scheme.

He said that currently there are 37 mandis with 24 fully operational and the remaining 13 in various stages of development. Significantly, out of the 19 wholesale mandis, 17 have already been integrated with the e-NAM platform, while the integration of the remaining two is underway. In 2024-25 alone, 54,975 stakeholders were registered on the platform, including 3,634 growers, 72 traders and 108 Farmer Producer Organizations (FPOs). In 2024-25, a total of 9.44 lakh quintal of agricultural and horticultural produce worth Rs 594 crore, was traded through e-NAM, as compared to 6.55 lakh quintal worth Rs 416 crore in 2023-24, he said.

The Minister said that introduction of the rail network in Kashmir will be a gamechanger for the apple growers, significantly reducing freight costs and ensuring better profitability.

"Jammu & Kashmir Competitiveness Improvement Project (JKCIP) is a forwardlooking initiative being launched with support from the International Fund for Agricultural Development (IFAD)" the Minister said.

Javid Dar said that in J&K, there are 10.82 lakh active KCC accounts, 8.49 lakh for crops and 2.33 lakh for animal husbandry. This year alone, 61,316 new KCCs were issued. The total sanctioned limit stands at 9,726 crore with an outstanding credit of Rs 7,393 crore. The NPA ratios remain low at 4.7% for crops and 2.1% for animal husbandry, reflecting strong credit discipline. In FY 2025–26, we aim to add 1 lakh new KCCs in the crop sector and 2 lakh in Animal Husbandry, he added.

He said that the Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) scheme is also being implemented to promote small food processors, improve value addition and enhance market access. Based on a One District One Product (ODOP) strategy, it offers a 35% credit-linked subsidy up to 10 lakh, and support to SHGs and FPOs. He said upto 2024-25, 1743 applications were cleared by District Committees, with 1,326 sanctioned, 927 disbursed and 1,000 new units targeted for establishment in 2025-

In 2024-25, the Pradhan Mantri Fasal Bima Yojana (PMFBY) provided insurance coverage to 1.48 lakh farmers during Rabi, covering 60,556 hectare and 60,178 farmers in Kharif with 20,561 hectares insured. To further enhance climate risk coverage, the Restructured Weather-Based Crop Insurance Scheme (RWBCIS) is being implemented for the first time in J&K during 2025-26. He said that for the first time, apple, saffron, mango and litchi will be covered under the Restructured Weather-Based Crop Insurance Scheme (RWBCIS), the Minister emphasised.

He said that seven unique agricultural products from J&K have been granted the prestigious Geographical Indication (GI) Tag by the Government of India, reinforcing their authenticity, heritage and market value. These included Saffron, Basmati, Baderwah Rajmash. Mushkbudji Rice, Udhampur Kaladi, Ramban Sulai Honey and Ramban Anardana. In continuation, GI tagging for 17 more crops shall be processed during 2025-26.

# DC Srinagar finalizes arrangements for Shab-e-Qadr, Jumat ul vida, Eid-ul-Fitr

# 243 Doctors, Paramedics deployed in Ramnagar Constituency: Sakeena Itoo Selection process for 181 Medical Officer underway with JKPSC

Jammu Mar 24, Minister for Health and Medical Education, Sakeena Itoo, today said that out of 252 sanctioned posts of Doctors, Paramedics, Non-Gazetted, 142 have been filled up and an additional staff of 101 Doctors and Paramedics have been deployed under the National Health Mission to improve healthcare in remote areas of Ramnagar Constituency.

The Minister was replying to a question raised by Dr. Sunil Bhardwaj in the Legislative Assembly.

The Minister informed the House that, out of 365 newly appointed Medical Officers, 17 have been posted in Udhampur while selection process for 181 Medical Officer posts is still underway with the Jammu and Kashmir Public Service Commission (JKPSC). "Once the selections are received, the appointed doctors will be assigned to health institutions experiencing severe staff shortages" she added.

The Minister informed that in addition to this, the department is also in the process of operating the waitlist for



91 selected Medical Officers. She said that, additionally, 292 vacancies in non-gazetted, paramedical categories from the Directorate of Family Welfare and 290 from the Directorate of Health Services have been referred for recruitment to the Jammu and Kashmir Services Selection Board to strengthen the healthcare in the region.

Regarding Ramnagar Constituency, the Minister informed that 51 health institutions have been sanctioned with 19 in government buildings, 29 in rented buildings and 3 in other departmental buildings

departmental buildings. The Minister said that construction and repair work on nine institutes was initiated, out of which, six have been completed and three are under execution. Additionally, initiatives like e-Sanjeevni, Tele-radiology, Tele-Manas and implementation of National Health Mission schemes, Pradhan Mantri ABHIM and PMJAY-SEHAT are strengthening the healthcare services immensely for the UT populace, the Minister informed.

The Minister said that Jammu and Kashmir, with 554 NTPHCs as of now, is among the top in health institution density in the country, according to the Ministry of Health and Family Welfare's 2023 report. The region is working on consolidation of existing health facilities with over 4,200 health institutions across primary, secondary and tertiary levels. The creation and upgradation of health institutions will follow the IPHS-2022 guidelines, which serve as the benchmarks for developing or upgrading the existing healthcare facilities.



Jammu:-,Minister for Agriculture, Javed Ahmad Dar, today said that the government is focused on revolutionizing agriculture in Jammu and Kashmir with emphasis on enhancing farmer's income, productivity and sustainability. The Minister was replying to a question raised by Ranbir Singh. He informed the House regarding key initiatives being undertaken to transform the agriculture sector in J&K. These included introduction of advanced technology, crop diversification, soil health management, Integrated Pest Management (IPM), financial support and subsidies, Research and Development, Training and Capacity Building, Infrastructure Development, Market Linkages and Promotion of Agro-based Industries. The Minister further said that various schemes have been initiated by the government to extend financial assistance to unemployed youth in the agriculture sector under Interest Subvention and Credit Linked

Schemes including KCC, AIF, AHIDF, PMFME and NLM.He added that several initiatives have been undertaken to promote agricultural growth and sustainability in the UT, as part of Holistic Agriculture Development Programme (HADP). These included Custom Hiring Centres, Hi-Tech Polygreen Houses, Controlled Cropping Mushroom Unit, Establishment of Pasteurized Compost Unit, Apiculture, KKG, Millet Restaurants, Establishment of Millet Mills, Establishment of Mini Soil Testing Labs, Establishment of Seed Processing Units, Dairy development projects, Self Sufficiency in Mutton Production, Poultry Development Project, Fish Seed and Trout Production besides Fodder production.The Minister said that, similarly, many other schemes have been initiated under the Agriculture Sector Centrally Sponsored Schemes. These included Rashtriya Krishi Vikas Yoja-na (RKVY), Soil Health Card, Sub-Mission on Agriculture Mechanization (SMAM), Per Drop More Crop scheme,



Rainfed Area Development (RAD), Paramparagat Krishi Vikas Yojana (PKVY), Sub Mission on Agroforestry (SMAF), Sub-Mission on Agriculture Extension (SMAE), National Food Security Mission (NFSM), National Mission on Edible Oils (NMEO) besides Sub- Mission on Seeds and Planting Material (SMSP).The Minister informed that 4.14 lakh hectare of total land has been brought under Culturable Command Area (CCA), of which, 1.91 lakh hectare has already been covered. Besides, 0.33 lakh hectare is being covered under new projects to facilitate the farmers to overcome irrigation challenges.He said that 18 irrigation projects are currently being implemented with financial assistance from NABARD while 14 additional projects have been sanctioned under RĬDF with an outlay of Rs 4883.54 lakh to cater 11678 Hectare of land in J&K. He added that 200 community bore wells are under construction under the Per Drop More Crop scheme.

## **Government** hospitals all set to witness extra patient rush

At a time when the government hospitals are already over burdened with patient rush the rush is all set to increase as the government has decided to absolve the private hospitals from some of the surgeries and procedures under the golden card health scheme. These surgeries and procedures will be carried out in the government sector and the patients have been asked not to visit the private hospitals in this regard while having a golden health card.

It would be in place to mention here that there is a dearth of staff in most of the government hospitals and other health institutions. Given this scenario it would be a herculean task for the doctors, para-medical staff and theatre staff to carry out surgeries and procedures that have been assigned to the government sector exclusively. The dearth of staff in the government sector has been ackneowledged by the government itself during the ongoing budget session of the Jammu & Kashmir legislative assembly.

Ever since the golden card scheme was introduced by the central government the government hospitals in the union territory have been keeping the patients waiting for months together even for simple procedures and surgeries. In such a situation the problems for the patients are going to increase since some surgeries and procedures have been kept as exclusive for the government hospitals. There would be endless queues of patients at the government hospitals in order to get the surgeries and procedures there.

Since most of the patients want their surgeries and procedures to be carried out in a timely manner these people can go to any extent in this regard. Such patients are ready to shell out money in the private sector so that the surgery or procedure is carried out in a quick manner and they are absolved of the tension. In such a manner the purpose and aim of the golden card would be defeated and people would be forced to go for expensive treatment in the private sector.

As the government has decided to keep some of the surgeries and procedures exclusive for the government sector it is important that the dearth of staff in the hospitals is overcome. The posts of specialists need to be filled at the earliest and at the same time steps should also be taken to fill the various posts associated with the operation theatres of the government hospitals. There should not be any compromise in this regard and people would be benefitted.

# From Vision to Victory: How India is Reshaping Its Fight Against TB



n this World Tuberculosis (TB) Day, I reflect with immense pride on how India is rewriting the playbook in the fight against TB. The recently concluded 100-day Intensified TB-Mukt Bharat Abhiyaan has not only demonstrated the power of innovation but has also shown that mobilizing communities is just as crucial as transforming the programmatic approach. The campaign was launched on 7th, December 2024 with the objectives to Accelerate TB case detection, Reduce mortality and

The 100-day Intensified TB-Mukt Bharat Abhiyaan introduced cuttingedge strategies to detect TB early, ensuring that even those without symptoms - who would have otherwise gone undiagnosed - were identified and treated. Portable X-ray machines were taken directly to high-risk individuals, including people with diabetes, smokers, alcohol consumers, those living with HIV, the elderly, those with low BMI and household contacts of TB patients. Artificial intelligence-powered X-rays flagged suspected TB cases instantly, and confirmation was done using gold-standard Nucleic Acid Amplification Tests (NAAT). These efforts ensured that contagious cases were identified and treated quickly, curbing transmission and saving lives.

The campaign reached every corner of the country, screening 12.97 crore people belonging to vulnerable populations. This intensive effort led to the notification of 7.19 lakh TB patients, out of which 2.85 lakh cases were asymptomatic and would have otherwise been missed but for this innovative approach, thus breaking the chain of TB infection. This is more than just a milestone it's a turning point.



#### TB- Mukt Bharat Abhiyaan: A people's movement

But the real game-changer wasn't just the technology - it was the unprecedented mobilization of communities. TB elimination is now a mass movement powered by Jan Bhagidari (people's participation). Across India, over 13.46 lakh Nikshay Shivirs were held, where more than 30,000 elected representatives, including Hon'ble MPs, MLAs, and representatives of PRIs and ULBs stepped up to support the 100 day TB Mukt Bharat Abhiyaan. Corporate partners and ordinary citizens joined the campaign, reinforcing the idea that TB elimination is not just a government responsibility but a collective mission. And in this mission Jan Bhagidari was exemplified across the States /UTs where in more than 35000 activities like TB awareness, nutrition kit distribution, undertaking pledge for TB free India etc was carried out across 22 line ministries. Similarly more than 21000 activities were held with PSUs, Trade associations, Business associations, voluntary organisations and more than 7.7 lakh students across 78000 educational institutions participated in TB awareness and sensitisation activities. Screening and testing of more than 4.17 lakhs vulnerable population was undertaken in congregate settings like prisons, mines, tea gardens, construction sites and work places. More than 21000 TB awareness activities were held on festivals during the campaign duration involving faith based leaders and community influencers.

The vision of our honorable PM, which laid the foundation stone of Jan-Bhagidari, mobilized extensive social support for adoption of patients not only for nutrition but also psychosocial and vocational support. Support for TB patients is no longer limited to hospitals - it is happening at homes, in villages, and at workplaces. Through the Ni-kshay Mitra initiative, individuals and organizations are providing nutritional support to TB-affected families, with thousands of food baskets already delivered. In just 100 days, 1,05,181 new Ni-kshay Mitras were enrolled. Recognizing the critical link between nutrition and TB recovery, the government has doubled financial assistance under the Nikshay Poshan Yojana from Rs 500 to Rs 1,000 per month, ensuring that no TB patient fights this battle alone.

The Ministry of Health and Family Welfare is also providing tailored

and personalised treatment for TB patients under the Differentiated TB care program. For instance, if a TB patient is found to be underweight (with a BMI < 18.5 kg/m2), their healthcare providerswill chart out a tailored nutrition and treatment plan and monitor their progress each month during treatment.

#### Building on the momentum of the 100day campaign

The momentum of this campaign has also demonstrated how a wholeof-society and whole-of-government approach can drive transformative change. 22 ministries joined forces to integrate TB awareness and services into everyday life. TB awareness floats became a highlight of the Goa Carnival parades. In schools across the country, TB awareness messages were incorporated into morning assemblies. The Ministry of Small and Medium Enterprises leveraged its network of cluster offices to offer free TB screenings to thousands of visitors. These diverse efforts shattered stigma, corrected misinformation and put TB elimination at the centre of public consciousness.

The 100-day campaign is just the beginning. India is all set to scale up these efforts nationwide, ensuring that every citizen - regardless of where they live - has access to modern diagnostics, quality treatment, and unwavering community support. Just as India rapidly scaled up COVID-19 testing, the Ministry of Health and Family Welfare is investing in next-generation TB diagnostics to bring faster and more accurate testing to the last mile.

India has witnessed the power of community-driven action before whether through Swachh Bharat Mission or our Polio eradication drive. Similarly, TB-Mukt Bharat Abhiyan is now becoming another people led movement. When innovation meets access, and when governments, communities & individuals unite the impossible becomes reality.

These values, while perhaps less formally documented, contributed significantly to creating humble, God-fearing individuals who prioritized community over self-interest.

In contrast,the current generation, despite its impressive academic credentials, often seems to lack these fundamental human virtues.Growing selfishness,rampant materialism, and a disregard for environmental stewardship are increasingly evident in everyday life.The careless disposal of waste in public spaces and the neglect of natural resources signal a broader shift from a value system grounded in ethical and spiritual awareness to one dominated by materialistic pursuits. This divergence between knowledge and wisdom risks undermining the very fabric of society.

If this moral decline is not addressed, the future may bring a society where intellectual achievements are undermined by ethical decay, leading to chaos and social disintegration.True education,after all,transcends the mere acquisition of knowledge-it involves the cultivation of wisdom, ethical decisionmaking, and a deep respect for life. Without a balanced approach that integrates moral teachings into academic curricula, we risk raising a generation that excels professionally but falls short in character.

To reverse this worrisome trend, moral education must become a cornerstone of both government and private schooling. Alongside core subjects such as science, mathematics, and social studies, curricula should include dedicated programs for ethical, moral, and spiritual learning. Children should be taught the importance of honoring their families, engaging in acts of kindness, preserving the environment, and upholding truthfulness in all aspects of life. Lessons in patience, humility, and self-restraint are equally critical, as they help young people navigate life's challenges with inner peace and gratitude.

The National Education Policy (NEP) 2020 emphasizes innovation and modern pedagogy in science and technology, yet it is equally important to focus on nurturing responsible citizens. # Hill Kaka's Struggle for Basic Facilities: A Call for Immediate Action

The Hill Kaka, a remote and isolated village in Surankote area of Poonch district of Jammu and Kashmir, UT is grappling with severe challenges due to its lack of basic infrastructure and government support. The people of Hill Kaka are forced to carry pregnant women on a cot (charpai) for over 40 kilometers to reach the nearest hospital in Surankote, as the village has no road connectivity or transportation facilities. The villagers live without electricity, potable water, or Anganwadi services, and reaching Surankote takes an entire day on foot. Even basic healthcare is out of reach, as medical staff rarely reports for duty, leaving the residents to suffer in silence.


Education in Hill Kaka is another pressing issue. Although a government school has been established, the state authorities have shown little interest in ensuring its proper functioning. While a room was constructed for the school and teachers were assigned, they are often absent, leaving the children of Hill Kaka eager to learn but without a teacher to guide them. The Education Department of Jammu and Kashmir needs to intervene and provide these children with the education they deserve. Until then,

the people of Hill Kaka continue to be deprived of opportunities for a better future.

Despite being part of the Mora Panchayat, which is about 40 kilometers away, Hill Kaka's residents are unable to benefit from government schemes due to the lack of connectivity and basic services. The local people are largely illiterate and impoverished, yet they remain fiercely patriotic. In 2003, they fought alongside the Indian Army to clear the area of militants in the historic Operation 'Sarp Vinash.' Many locals lost their lives in this operation, and Hill Kaka remains the only village in Jammu and Kashmir where women members of the Village Defense Committee (VDC) participated in the fight against terrorism. The bravery of these martyrs will never be forgotten, yet their families continue to face hardships, with little support from the government.

The road connectivity issue has seen some progress with the construction of a 14-kilometer road from Bafliaz to Hill Kaka. However, only half of the road has been completed, and it remains in poor condition. The completion of this road is crucial for the overall development of the area and would help alleviate many of the difficulties faced by the residents.

The government's promises to



improve the lives of the people of Hill Kaka remain unfulfilled. While there has been some improvement since 2004, the lack of attention and proper governance continues to hinder the community's progress. Residents question why the promises of development, education, and healthcare remain unmet, leaving them to wonder if the government is truly committed to their welfare.

The extension of the Forest Rights Act (FRA) of 2006 to Jammu and Kashmir in 2019 was intended to ensure the land tenure, food security, and livelihood of traditional forest dwellers, including communities like the Gujjars and Bakerwals. However, these communities, including Hill Kaka's residents, have found that the implementation of the FRA has made their lives even more difficult. The Forest Department's response has been to restrict their rights, adding to their struggles.

The people of Hill Kaka need urgent intervention. Despite their history of sacrifice and patriotism, their needs remain largely ignored. The road to Hill Kaka needs to be completed, medical staff should be posted to the local aid center, and children should be admitted to schools to ensure their future. A fair price shop should be opened, especially during the summer months, and the residents should be provided with compensation for their sacrifices during Operation 'Sarp Vinash.' Additionally, the government must ensure that the village has access to clean drinking water, electricity, and basic sanitation services. Solar energy systems could provide a sustainable solution to their power needs.

His intervention can help uplift the village and ensure that the people's needs are addressed. Hill Kaka's bravery in the face of terrorism is a testament to its people's resilience and patriotism. However, despite their sacrifices, they continue to face neglect from the government. It is time for the authorities to recognize their struggles and take meaningful action to improve their lives, so that the martyrs of Hill Kaka, who gave their lives for the nation, are honored with the basic rights and services they have long been denied.



## **Stray Dogs Kill 40 Sheep, Injure Several in Kralgund Villages**

Handwara, Mar, 24: A surge in stray dog attacks has caused panic among livestock owners in Gundkamal-Rangpath and neighboring villages of Kralgund in north Kashmir's Kupwara district. Over the past three months, at least 40 sheep have been killed, and several other livestock injured, triggering concerns among locals.

According to residents, the attacks began on January 1 in Gujjarnor village, where two sheep belonging to Mohd Rafiq Cheche and Shams-u-Din were killed. Subsequent incidents saw multiple livestock losses, including:

January 20: Four sheep killed, three injured (Gh Hassan Cheche). February 12: Two sheep injured (Rayees Ahmad



Khan). February 20: Four sheep injured (Jahangir Ahmad Malla. Pakribal).March 17: Four sheep injured (Ab Raheem Khan, Moshnor). March 21: Two sheep and one goat killed, three sheep injured (Mohd Shafi Cheche, Mohd Yasir). Residents report that stray dogs have been freely roaming in the

cially among children. Many villagers are now hesitant to let their livestock graze, fearing further attacks. Despite growing concerns, local authorities have yet to take concrete action. A police official confirmed the incidents, stating that officers visited the affected areas to assess the situation. However, the Tehsildar of the region mentioned that no formal complaints had been received so far but assured that necessary steps would be taken once the revenue department conducts a ground review.The villagers have urged authorities, particularly the Animal Husbandry Department and Municipal bodies, to intervene immediately and address the stray dog menace before the situation worsens.




## **Residual cancer may hide behind clear** scans, linked to worse outcomes: Study

Love to sip that freshly brewed coffee at work? Beware, your coffee brewing machine at the office may raise your cholesterol levels, claims a study.

## Researchers find mechanisms that may lead to inflammatory bowel disease

A team of scientists has discovered mechanisms of abnormal immune cell function that may lead to Crohn's disease, an inflammatory bowel disease

Crohn's disease causes chronic inflammation of the gastrointestinal (GI) tract, and symptoms can include abdominal pain, diarrhoea, weight loss, anaemia, and fatigue.

White blood cells in the GI tract known as intraepithelial lymphocytes express the gamma delta T cell receptor (gamma delta IELs), which prevent infection and provide surveillance for the intestinal barrier. These gamma delta IELs are often reduced in patients with active Crohn's disease.

The findings, published in Science Immunology, now show that gamma delta IELs are substantially decreased weeks before clinical or histological evidence of disease in a mouse model of Crohn's disease-like ileitis.

Furthermore, "we were able to generate a timeline of events leading to the dysregulation of gamma delta IELs that mirrored findings from prior studies in patients with IBD," Edelblum said.

The researchers said loss of gamma delta IELs could be used as a predictive biomarker for disease relapse or patient responsiveness to treatment.

Additionally, development of future therapies that boost the function of gamma delta IELs may provide a new way to maintain remission in IBD patients or prevent disease development in susceptible individuals.

## Waist circumference stronger risk marker than BMI for obesity-related cancer in men

Waist circumference (WC) is a stronger risk marker than BMI for developing obesity-related cancers in men, but not women, says a new study.

BMI is a measure of body size, but does not provide information on fat distribution, whereas waist circumference is a proxy more closely related to abdominal adiposity.

"This distinction is crucial because visceral fat, which accumulates around the abdominal organs, is more metabolically active and has been implicated in adverse health outcomes, including insulin resistance, inflammation, and abnormal blood fat levels," said the study conducted by Dr Ming Sun, Dr Josef Fritz and Dr Tanja Stocks.

After accounting for BMI, high WC still remained a risk factor for obesity-related cancer in men. This suggests that the elevated risk associated with abdominal adiposity is specific, and not explained by high body size alone, as measured by BMI.

Among women, the associations were weaker and similar for both WC and BMI.

"A plausible explanation is that men are more likely to store fat viscerally, while women generally accumulate more subcutaneous and peripheral fat," said authors in Journal of the National Cancer Insti-

Including hip circumference into risk models may provide further insights into this sex difference and enhance the association between WC and cancer, particularly for women, they added.

### **Tamim Iqbal** suffers heart attack mid-match
