"No one Shall be allowed to Spread Terror in J&K Anymore"

SRINAGAR, APR10: Union Home Minister Amit Shah has said that no one will be allowed to conspire to spread terror in Jammu and Kashmir.

In a conversation with a national news channel, Shah, according to the news agency—said, "We will not let anyone conspire to spread terror in J&K.

If anyone tries such things, they will be punished."The Union Home Minister maintained that national security is a top priority for the Centre and its stand on security and separatism is firm. "We will not compromise, nor will we allow anyone else to do it," he added.Referring to his recent visit to Jammu and Kashmir, Shah said, "Meeting with Chief Minister Omar Abdullah was cordial and focused on development and governance. We have

always supported regional governments equally, without any bias."He reiterated that the Centre is committed to working with J&K's elected leadership.

Asked whether a recent terror incident in Kathua was caused by Pakistan-backed infiltration, Shah said, "Infiltration is, of course, backed by Pakistan and not someone else like Russia. And this has been happening for years. But our soldiers and the

NIA arrests Mumbai terror attacks accused, Rana after extradition from US

ICJ Prez welcomes Trump Govt's decision to facilitate extradition

NEW DELHI/SRINAGAR, Apr 10: The National Investigation Agency on Thursday said it has "successfully secured the extradition" of Tahawwur Hussain Rana, a key accused in the 26/11 Mumbai terror attacks, and has arrested him.

In a statement to the news agency—NIA spokesman said that Rana was arrested formally immediately after his arrival at Indira Gandhi International Airport in New Delhi, following his successful extradition from the United States.

"NIA secured Rana's extradition following years of sustained and concerted efforts, and after the terror mas-



termind's last-ditch efforts to get a stay on his extradition from the US failed," the statement added.

It said that Rana was escorted to New Delhi by teams of NSG and NIA, comprising senior officials, on a special plane from Los Angeles, US. The NIA investigation team at the airport arrested Rana, a Canadian national of Pakistani origin living primarily in Chicago (US), soon after he emerged from the airplane, after completing all the necessary legal formalities.

"With the coordinated efforts of India's Ministry of External Affairs and Ministry of Home Affairs, along with the relevant authorities in the United States, NIA has worked closely with other Indian intelligence agencies through the entire extradition process, which marked a major step in India's efforts to bring individuals involved in terrorism to justice, irrespective of

Agriculture, allied sectors power over 78% of J&K's GDP: Govt

Over 13 lakh families depend on sector; saffron revival gains pace with 2,598.75 hectares rejuvenated under Rs 400 cr mission

SRINAGAR, APR 10: The Jammu and Kashmir government on Monday said that agriculture and allied sectors account for more than 78 percent of the Union Territory's Gross Domestic Product (GDP), providing livelihood to over 13 lakh families.

According to the news agency—the statement was made in response to a question raised in the Legislative Assembly by MLA Ali Sagar, who sought information regarding the potential of the agriculture and horticulture sectors in Jammu and Kashmir.

In its reply, the government affirmed that agriculture and horticulture continue to be the backbone of the Union Territory's economy. To unlock the full potential of these sectors, it said, multiple centrally sponsored schemes are currently being implemented across the region. These



include Rashtriya Krishi Vikas Yojana (RKVY), the Soil Health Card Scheme, the Sub-Mission on Agricultural Mechanization (SMAM), Per Drop More Crop, Rainfed Area Development (RAD), Paramparagat Krishi Vikas Yojana (PKVY), and the Sub-Mission on Agroforestry (SMAF).

The government added that under the flagship Holistic Agriculture Development Programme (HADP), several transformative initiatives have been introduced to boost productivity, enhance infrastructure, and improve market linkages for farmers and growers.

One such initiative is the Production of Designer Plants, which aims to promote hybrid varieties and rejuvenate orchards across 5,500 hectares over a five-year period. This project is expected to reduce dependence on imported planting material and improve the quality and yield of horticultural produce.

Another significant component of HADP, the government said, is the Strengthening of the Agro-Marketing System, which focuses on developing key infrastructure like Controlled Atmosphere (CA) stores, modern grading lines,

Moreover, in connection with a case under FIR number 06/2024 under UAPA Act of PS Hajin, two persons were arrested, who have been identified as Ab Majeed Gojri S/o Gh Mohd Gojri of R/o Vigpara and Ab Majeed lone S/o Mohd Maqbool Lone of Vigpara Hajin, both members of Tehreek-e-Hurriyat JK.

Some objectionable material, pamphlets and electronic devices including mobile phones were seized from the arrested persons, the spokesman said, adding that the investi $gations\,have\,revealed\,that\,the\,members\,have$ continued to promote terrorist and secessionist activities in J&K even after the outfits of which they had affiliation were banned under Unlawful Activities (Prevention) Act.

The arrested members were engaged in motivating impressionable youth and recruiting new members (Rukuns) in J&K to further their nefarious and secessionist activities.

"The arrests serve as a stark reminder of police in its ongoing crackdown against extremism and the imperative of collective vigilance in J&K. Bandipora police remain committed to maintaining peace and security in the district. A total of 166 persons were killed and over 238 injured in the deadly attacks.

Both LeT and HUJI have been declared as terrorist organisations by the Government of India under the Unlawful Activities (Prevention) Act, 1967, the statement said

ICJ PREZ WELCOMES TRUMP GOVT'S **DECISION TO ALLOW EXTRADITION**

Meanwhile, International Council of Jurists (ICJ) President, Senior Advocate Dr Adish C Aggarwal on Thursday welcomed the decision of Donald Trump administration to extradite 26/11 Mumbai attacks accused Tahawwur

Aggarwal while talking to the reporters in Srinagar, according to KNO said, "Trump government took special interest and allowed Tahawwur Rana's extradition to India. Donald Trump himself making a statement on this as soon as his government came into power shows that he is against terrorism."

Asked would this move pave the way for extradition of the Mumbai attacks mastermind Hafiz Sayed also, Agarwal said, "Everything will happen. Our forces are doing a good job. I assure you that whether economic offender or terrorist offender, everyone will have to come here."

Pertinently, soon after taking over as the President of United States for second time, Donald Trump in February this year had confirmed 26/11 Mumbai terror attack accused Tahawwur Rana's extradition to India and said that he was pleased to announce

that Rana is "going back to India to face justice". During the joint press meet with Prime Minister Narendra Modi after their bilateral meeting, Trump had said. "I am pleased to announce that my administration has approved the extradition of one of the plotters (Tahawwur Rana) and one of the very evil people of the world, having to do with the horrific 2008 Mumbai terrorist attack to face justice in India."

Th Dy CM also asked the executive agencies working on various packages to deposit the penalties first imposed on them by the department to get the incessant supply of material. He assured full cooperation to NHAI from the Government prior to clearance of penalties imposed on executive agencies.

On February 13, Pakistani troops violated the ceasefire by resorting to unprovoked firing on Indian posts along the LoC in Poonch district of Jammu and Kashmir, prompting a befitting response by the Indian Army, security officials said.

The ceasefire violation by Pakistan in the Krishna Ghati sector came a day after two Indian Army personnel, including a captain, were killed in an improvised explosive device (IED) explosion triggered by suspected terrorists near the LoC in the Akhnoor sector of Jammu district on February 11.

Ceasefire violations along the LoC have been very rare ever since India and Pakistan renewed the ceasefire agreement on February 25, 2021. (Agencies)

More than 300 central government officials set for retirement by March 31, 2026, attended the workshop, aimed at providing comprehensive support and guidance for a smooth transition into retirement, an official statement said.

Abanks' exhibition for showcasing various services provided by the banks to pensions was also organised simultaneously, it added.

refrigerated vans, and new mandis to minimize post-harvest losses and improve the market value of produce.

In parallel, the Food Processing Clusters project is developing seven product-specific clusters across the UT, providing end-to-end solutions in food processing—from production and processing to packaging and marketing. These initiatives are aimed at expanding the reach of J&K's produce in domestic and international markets.

The government also highlighted the provision of a top-up subsidy to encourage investment in CA storage, crucial for preserving produce and regulating market supply. Presently, the UT has a CA storage capacity of 2.11 lakh metric tonnes, and an additional 37,250 metric tonnes is expected to be added during the financial year 2024–25.

Efforts under the High-Density Plantation Scheme have already brought 836 hectares under cultivation by January 2025, out of the targeted 5,500 hectares. The government also noted ongoing upgrades to fruits and vegetable markets across the Union Territory, with support from NABARD. A total of 17 mandis have been integrated with the National Agriculture Market (e-NAM) platform. As of January 2025, 3,816 farmers and Farmer Producer Organizations (FPOs) had registered on the platform, trading approximately 9.37 lakh quintals of produce worth around Rs 592 crore. Since 2020-21, e-NAM has facilitated the trade of 16.87 lakh quintals, with a cumulative transaction value of Rs 1,041.96 crore.

The government also reported progress on the Mission for Economic Revival of Saffron, which was launched in 2010-11 to rejuvenate saffron cultivation across the region. Developed by the Sher-e-Kashmir University of Agricultural Sciences and Technology, Kashmir (SKUAST-K), and implemented under the Ministry of Agriculture and Farmers' Welfare, the mission set a target to revive saffron farming across 3,715 hect-

To date, 2,598.75 hectares have been successfully rejuvenated. The project is being implemented in the key saffron-growing districts of Pulwama, Budgam, Srinagar, and Kishtwar.

Pulwama district, with the highest target area of 3,200 hectares, has seen rejuvenation on 2,055.75 hectares. Budgam exceeded its target of 300 hectares by achieving 328 hectares of revival, while Srinagar and Kishtwar achieved their respective targets of 165 and

The total cost of the project stands at Rs 400.11 crore, with Rs 315.99 crore contributed by the Government of India and Rs 84.12 crore as the farmers' share. Out of Rs 269.91 crore released so far, Rs 259.68 crore has already been utilized across various components of the project.

The government concluded by reaffirming its commitment to transforming Jammu and Kashmir's agricultural economy into a sustainable and resilient model. "These reforms are designed not only to modernize the sector but also to improve the livelihoods of farming communities across the Union Territory," it said-

Omar-Rijiju meeting creates ripples in political circles in J&K

he Jammu & Kashmir chief minister Omar Abdullah might have given the explanation that his meeting with the union minority affairs minister Kiren Rijiju few days back at the tulip garden in Srinagar was just a chance encounter but there are very few people who are ready to buy this statement from Omar. The issue has snowballed into a major controversy with the Kashmir based politicians aiming barbs at the chief minister and the National Conference.

Most of the people including the political analysts believe that the visit of a high profile personality to any garden or any place in Srinagar is not a normal thing and the administration especially the security brass is aware about any such visit. Given this situation the visit of the union minister and the chief minister was not wrapped and the people were aware about the same. In this scenario, since Rijiju went to the tulip garden first the chief minister would have been informed by the security agencies about the visit of the union

Since the Waqf bill was introduced by the minority affairs in both houses of the parliament he came in for sharp criticism from the politicians belonging to the different political parties including the National Conference. As such the meeting of Omar with Rijiju was bound to create ripples among the political circles of the union territory. Peoples Conference legislator from Handwara Sajad Lone was seen yelling tulip tulip at the NC legislators while they were holding a protest in the legislative assembly while demanding a discussion on the Waqf bill.

The Omar-Rijiju meeting gave ammunition to the Kashmir based law-makers and they accused the National Conference of deceiving the people of Jammu & Kashmir especially, the Kashmir valley. These legislators said that the NC law-makers are resorting to theatrics by demanding discussion on Waqf one side while hobnobbing with the Bharatiya Janta Party (BJP) government at the centre on the contentious issue of Waqf bill. Some events that unfolded after the meeting gave more firepower to the opposition legislators.

Along with the explanation given by Omar some of the photos and a video released on the occasion gave an impression that the meeting was not a chance encounter but the same was fixed in advance. The union minister also came out with an explanation and asked the people not to attach political connotation with his meeting with the Jammu & Kashmir chief minister. This too made the situation somewhat precarious for Omar Abdullah.

Jabir Ibn Hayyan: An Intellectual Odyssey From Baghdad To Europe

That if the genesis of modern chemistry-the periodic table, laboratory apparatus, and scientific methodologyoriginated not in Europe but in the intellect of an 8th-century polymath in Baghdad? Abu Musa Jabir Ibn Hayyan Al-Azdi, an innovative alchemist, philosopher, and scientist, transmuted alchemy into a structured empirical discipline, his legacy permeating laboratories, industries, and academia worldwide. Yet, his name remains obscured within dominant historical narratives, an unacknowledged architect of scientific progress.

There was an era when Muslim scholars, driven by epistemic rigor, forged an intellectual framework that became the substratum of scientific inquiry. Meticulously interwoven with empirical precision, systematic reasoning, and scholastic depth, this legacy transcended doctrinal and cultural boundaries, flourishing through institutions like the House of Wisdom and vast madrasa networks. Even today, its universality commands recognition, with scholars across disciplines and geographies affirming its enduring imprint.

Jabir ibn Hayyan, an erudite polymath, remains profoundly integral to modern chemistry, his seminal contributions serving as a critical juncture between arcane alchemical traditions and empirically grounded scientific inquiry. Through methodical experimentation and the discovery of fundamental chemical compounds-many of which retain contemporary utilityhe engendered a paradigm shift in the discipline.

His scrupulous systematization of experimental methodologies and fastidious documentation established the epistemological substratum upon which the edifice of modern experimental chemistry was meticulously constructed.

Laboratory Innovations

He designed and refined apparatuses such as the alembic for distillation, which remains a prototype for modern distillation equipment. His development of techniques like crystallization, calcination, sublimation, purification, amalgamation, oxidation, evaporation, and filtration processes, significantly impacted the development of chemistry all over the world. are still integral to chemical processes.

Discovery and Use of Acids

Jabir is credited with preparing hydrochloric acid nitric acid, and aqua regia acids critical in industrial and laboratory applications today. His work with these substances advanced early chemical synthesis and metallurgy.

Classification of Substances

He categorized materials into "spirits" (volatile substances), metals, and nonmalleable compounds, foreshadowing modern chemical taxonomy. This organizational approach influenced later systematic classifications, including the periodic table.

Emphasis on Experimentation and Documentation

Jabir's insistence on systematic experimentation, reproducibility, and recordkeeping established principles later formalized as the scientific method.

Empirical approach

He shifted focus from alchemical mysticism to evidence-based inquiry, paving the way for modern chemis-

Jabir engineered an exceptionally precise scale capable of measuring weights up to 6,480 times smaller than a ratl 2.2 lbs. (no textual proof)

Applied Chemistry

He developed early pharmaceuticals and chemical remedies, linking chemistry to healthcare—a precursor to modern pharmacology.

Industrial applications

Techniques like dye-making, glass production, and metal extraction were refined

in his work, influencing early industrial chemistry.

In an age of clay crucibles and flickering flames, Jabir ibn Hayyan forged the tools of modern chemistry-distilling truth from mystery with crude alembics, scarce resources, and relentless curiosity. His legacy? Proof that genius thrives not in ease, but in the alchemy of perseverance. Jabir turned medieval limits into chemical revolutions. Imagine what you could transform.?

A Literary Corpus Blending Empirical Science with Philosophical Inquiry

Jabir ibn Hayyan's intellectual corpus, an intricate amalgamation of practical experimentation and philosophical reflection, profoundly shaped the trajectory of scientific thought. His seminal works-Kitab al-Kimya (The Book of Chemistry/Alchemy), Kitab al-Sab'een (The Book of Seventy), Kitab al-Mawazin (The Book of Balances), Kitab al-Asrar (The Book of Secrets), and Kitab al-Rahma (The Book of Mercy)-laid the epistemological foundations of chemistry, pioneering an empirical methodology that would resonate across centuries.

Enduring Scholarly Recognition in Medieval and Modern **Perspectives**

Jabir's profound influence has been acknowledged by both medieval and modern scholars, transcending geographical and cultural boundaries.

Medieval Acknowledgment

Albertus Magnus, the eminent medieval scholar, extolled Jabir's contributions, asserting that alchemists such as Jabir had uncovered knowledge of immense prac-

Roger Bacon, a pivotal advocate of experimental science in the 13th century, directly attributed the advancement of the sciences, inherited from the Arabs, with Jabir as a central figure.

Paracelsus, the 16th-century Swiss physician-alchemist and progenitor of modern medicine, revered Jabir's medicinal chemistry, affirming that "the true secrets of chemistry were first taught by the Arabs," with Jabir as its preeminent luminary.

Modern Historical Recognition

E.J. Holmyard, in Alchemy (1957), underscored Jabir's revolutionary contributions to chemical sciences.

George Sarton, in Introduction to the History of Science (1927), hailed Jabir as an unparalleled genius whose work underpinned the evolution of experimental chemistry.

William Newman, in The Summa Perfectionis of Pseudo-Geber (1991), elucidated the extensive European assimilation of Jabir's methodologies, particularly his emphasis on quantification and laboratory precision.

Eric John Holmyard, in Makers of Chemistry (1931), contended that without Jabir's foundational discoveries, the chemical revolution spearheaded by Lavoisier and Boyle might never have materialized.

Lawrence Principe, in The Secrets of Alchemy (2013), accentuated Jabir's practical ingenuity, noting that his work on distillation and acids was not merely theoretical but applied science, with his alembic serving as the precursor to modern distillation apparatus.

Jim Al-Khalili, in The Golden Age of Arabic Science (2010), highlighted the enduring relevance of Jabir's discoveries, particularly his synthesis of nitric and hydrochloric acids, which remain indispensable to contemporary chemical laboratories.

Nobel Laureate Ahmed Zewail lauded Jabir's visionary integration of theoretical and experimental science, asserting that his method-

ologies laid the foundational bedrock for modern experimental chemistry.

Syed Nomanul Haq, in Names, Natures, and Things (1994), repositioned Jabir as a polymath whose intellectual breadth extended beyond chemistry into philosophy and epistemology.

Bill Bryson, in A Short History of Nearly Everything (2003), contrasted Europe's intellectual stagnation during the Dark Ages with the scientific advancements of figures like Jabir ibn Hayyan, whose work in Baghdad ignited the embers of the Renaissance.

A Legacy Etched in Scientific History

Jabir ibn Hayyan, venerated by historians and scientists alike, stands as an indelible figure in the annals of chemistry. His profound impact was recognized by Ibn Khaldun, who positioned him as a seminal architect. and polymath, and his stature remains unequivocal in contemporary discourse, as attested by The Enduring Legacy of Muslim Civilization (4th Edition, UK, 2017).

Be next jabir who interrogate phenomena with ontological audacity, experiment through dauntless empiricism, and architect an epistemic future where scientific praxis synthesizes rather than bifurcates. Let the hermeneutic alembic of cognition catalyze chaos into epistemic lucidity-interrogate the occluded noumenal, metricize stochastic uncertainties, and transmogrify heuristic postulates into positivist certitude. Chains of Caste: Mental Slavery Even After Independence

India, which is called a country of spirituality and diversity, hides within itself a world of contradictions that sometimes surprises. On the one hand, we talk of science, technology, space,, and artificial intelligence, while on the other hand, medieval thinking is still deeply rooted in the social and cultural layers. In the same society, such scenes are seen where people drink the charanamrit of some Baba,, considering it as 'amrit,' and and even consume cow urine and cow dung,, calling it medicine; and in the same society, drinking water from the hands of a Dalit person is considered a 'sin.' This is the irony that has been exposed with full force by this sharp sentence: "Aastha tak pee paani pila deti hai, caste tak paani nahi peena deti." This line is not just a satire ut is the identification of two major diseases deeply rooted in Indian society-e is faith drowned in superstition,, and the other is caste discrimination. Both challenge the basic principles of humanity, reasoning,, and equality to some extent.

Faith: The thin line between belief and stupidity

Faith is the spiritual and cultural backbone of any society. It gives a purpose to a person, gives him morality and selfconfidence. But when this faith crosses the limits of logic, science,, and human rights and turns into blind faith, it takes a dangerous form. There are many examples in India where religious leaders made their followers do acts like drinking cow urine, consuming feces or declaring themselves as 'God,,' and people followed them blindly. News of a baba making people drink his urine in the name of 'miraculous water' has also been coming out from time to time. Devotees drink it,, considering ia 'blessing,' and when the media raises questions on these incidents, it is accused of insulting religion. What kind of faith is this that forces a person to completely abandon his thinking and conscience? What kind of faith is this that turns those who raise questions into criminals?

Caste: Medieval Thinking in a **Modern Society**

Now let us talk about the

second big social diseasecasteism. In India, caste is a structure that determines a person's social status, occupation, rights,, and even lifedeath chances on the basis of birth. The Indian Constitution may have outlawed casteism, but its roots are still as deep in the social psyche. Even today, in many parts of the country, Dalits are not allowed to enter temples, there are separate wells or taps for them, their children are made to sit separately in schools, and objects are considered 'impure' by their mere touch. Inhuman practices like manual scavenging have not ended even today. There are daily instances when a Dalit youth is killed for loving an upper-caste girl r when their houses are set on fire in a village just because they crossed the 'limit.' How tragic it is that the same society that can consider cow urine as medicine considers water impure by the mere touch of a human being.

The roots of the paradox

The roots of this contradiction are hidden nowhere else but in our social, religious, and political structure. In the name of religion, people's thinking was controlled by using faith as a weapon. Through arbitrary interpretations of religious texts, one class was proved to be 'superior' and the other 'lowly.' Those who raised questions were declared 'anti-religion.'

Politics also nourished this system a lot. Castes were converted into vote banks. Hatred was spread in the name of reservation, but no concrete efforts were made to end caste atrocities, nor was any willpower shown. The public was emotionally bound in the name of faith, and scientific thinking was rejected by calling it 'Western ideology.'

Lack of education and wisdom

Education is the tool that makes society rational and just. But in India's education system, the education of logic and human rights is very limited. We teach science to children but do not inculcate a scientific approach in their thinking. We give them moral education but remain silent on questions of casteism and social justice. When a child sees in school that his classmate is being called 'Chamar' or 'Bhangi,' when the

teacher himself asks the caste of the students, then this thinking gets deeply embedded in his consciousness. This same child grows up and discriminates in the same way, and once again the vicious cycle begins.

The hypocrisy of media and

Media is called the fourth pillar of democracy, but when it comes to casteism or superstition, its attitude is either very superficial or it remains completely silent. It shows the miracles of babas in the name of 'entertainment' but ends the matter by running a two-minute report on the murder of a Dalit. It deliberately avoids issues that may anger any 'particular class.'

The society also chooses sensitivity as per its convenience. The seller of cow urine is called a 'modern sage,' but no voice is raised on the death of a laborer cleaning a manhole.

What is the solution?

Expansion of rational education: Schools should include a curriculum based on scientific outlook and social justice. It is important to teach children from childhood that faith does

human being is equal. Strict laws and their implementation: Laws made against caste-based discrimination have to be implemented not just on paper, but also on the ground. Change in society is possible only when the culprits are punished. Responsibility of the media: The media should start honest discussions on this subject. Strong reporting is necessary against Dalit issues, caste injustice, and superstition. Reforms in religious institutions: Religious leaders should give the message of science and social equality to their followers. If there is no change in religion, then there will be no change in society either. Participation of civil society and youth: Social organizations, students, and aware citizens will have to raise their voices together against this system. A movement can be started against casteism and superstition by making social media a powerful medium.

Have we really become modern?

While India is celebrating its achievement of reaching the moon, a Dalit is beaten to death in a village for entering a

government campaign gives the slogan of 'Clean India,' on the other hand thousands of sanitation workers die by entering the gutter without protection. And while on one hand people drink Baba's urine, considering it as 'prasad,' at the same time water touched by a Dalit is considered 'dirty.' This contradiction forces us to think whether development is limited only to buildings, mmetros and mobile networks, or does it also include thinking, equality, and humanity? The place of faith is important, but if it crushes humanity, then it is of no use. If the caste structure does not give anyone his human rights, then it must be broken. Therefore, the biggest need today is that we recognize this hypocrisy and speak against it. If faith can even make someone drink urine, then the society will have to be made so sensitive and rational that water is not denied in the name of caste. A person should be identified not by his caste but by his deeds and character-this is the real religion, this is the true

Key Urban Projects For Revitalising Srinagar City

The city of Srinagar stands at a crucial crossroads, with numerous projects and initiatives poised to enhance its infrastructure and quality of life. There is a need to address several key issues that have been sidelined over the years. From the revitalisation of water transport on the Jhelum River to the completion of vital infrastructure like the New Ganderbal Hydroelectric Project, these initiatives hold the potential to transform Srinagar into a more efficient, sustainable and vibrant

The current government must revive these proposals and prioritise citizen-centric solutions that not only preserve the city's rich heritage but also enhance the overall well-being of its residents. This article outlines eight pressing projects and initiatives that require immediate attention:

Inland Water Transport Project from Pampore to Chattabal

This project was conceived by the Srinagar Development Authority (SDA) during 1997-99 under my tenure as Project Director. A comprehensive Detailed Project Report (DPR) was prepared by internationally acclaimed consultants, M/s RITES. The project was aimed at decongesting Srinagar's roads and reviving water-based transport that historically thrived on the Jhelum

The plan envisaged 50-seater motorboats for passengers and 25-seater boats for tourists, offering scenic rides past Srinagar's heritage sites. It was also expected to boost riverside tourism and rejuvenate the arts and crafts market along the riverbanks. Unfortunately, despite initial enthusiasm, the project was reduced to symbolic efforts - a few signboards and a couple of expensive boats at Zero Bridge.

The DPR continues to gather dust in the I&FC Department. Reviving this project could serve as a signature initiative for the current administration, combining heritage conservation, tourism, and urban mobility.

Skew Bridge near Presentation Convent School

A motorable skew bridge on the Jhelum near the Presentation Convent was constructed up to the deck level in 2017 at a cost of Rs 12 crore. Strangely, despite the original design, a pedestrian footbridge was constructed on flimsy grounds using steel girders, nullifying the investment and the objective of decongesting city roads.

A PIL filed in the Hon'ble High Court supported the restoration of the motorable bridge, but the case file was reportedly misplaced. There is still an opportunity to replace the footbridge decking with the originally designed RCC deck, thereby restoring the utility of the project and easing central Srinagar's traffic woes.

New Ganderbal Hydroelectric Project

Initiated in 1992 with a DPR prepared by M/s Thapar Consultants, NGHEP is strategically located near Srinagar, offering minimal transmission losses. Infrastructure and



land acquisition were largely completed early on, and the project was expected to augment not only power supply but also water availability through the Rangil Water Supply portal.

Despite its technical viability and infrastructural readiness, the project remains stalled-likely due to past political disturbances. The current government, known for decisive action, must prioritize this ready-to-execute project for energy sufficiency and public utility enhancement.

Solid Waste Disposal Scheme -**Greater Srinagar**

In the 1980s, the Urban Environmental Engineering Department

(UEED), with M/s Universal Enviroscience as consultants, prepared a DPR proposing a mechanical compost plant near Noorbagh, with an interim sanitary landfill at Achen Saidpora.

Instead, unscientific landfilling consumed wetland areas, creating severe environmental and health hazards, with odour extending to SKIMS. The original compostingbased waste management plan needs urgent revival to mitigate pollution and ensure sustainable urban sanitation.

Chrar-i-Sharif Development Project Following the devastating 1995

fire that razed the historic shrine and surrounding town, a dedicated

development project was initiated. With sustained efforts and ministerial support, a Rs 25 crore HUDCO loan was secured, and restoration works began. However, due to political transition, funding and momentum were lost.

The Chrar-i-Sharif shrine holds immense spiritual, cultural, and historical value, and the project must be revived and completed to honour the legacy of Hazrat Shaikh Noor-ud-Din (RA) and support the local economy.

Urban Renewal & Circular Road

Key internal roads of Srinagar, including the KZP road under the Circular Road Plan, remain incom-

plete or stalled without justification. These roads are crucial to decongesting the inner city and improving mobility. Immediate attention to resume work on these projects is warranted.

Parking Infrastructure

Unregulated roadside parking across Srinagar results in frequent traffic jams. There is an urgent need to develop designated parking spaces and multi-level facilities in commercial zones to ensure a smooth flow of traffic and ease of

Fixed Bus Stops with Bus Bays

In the absence of designated bus stops, passenger vehicles halt mid-road, obstructing traffic and increasing accident risk. The government must identify and build bus bays at fixed locations to streamline public transport and enhance commuter safety.

The projects and concerns highlighted above are feasible, impactful, and citizen-centric. Most were conceptualised with foresight but derailed due to administrative inertia or political shifts. The present administration has demonstrated resolve in executing large-scale reforms and development initiatives. It is urged to revisit and revive these proposals for sustainable urban planning, heritage preservation, and civic well-being.

n the hustle of wedding preparations, the fragrance of flowers fills our home. Laughter echoes through newly painted walls. Family and friends gather, clothes are being stitched, and invitations are being sent. But amidst all this joy, there is a silence only I can hear – a silence so loud it drowns the drums and songs.

Because my mother, Zainab Aziz, is not here.

On the 4th of May, I am getting married – a day she once dreamed of, longed for and prayed for. But the woman who waited for it the most won't be here to witness it.

She left us on a Friday, right after the sacred Jumuah prayer, on the 9th of December, 2022. She breathed her last in PGI Chandigarh - in my arms. In that one moment, life split in two: before and after. Since then, every joy has worn a shade of sorrow.

My mother was not just my world – she was its soul. A woman of such generosity that no beggar ever left our gate empty-handed. Some families came daily for milk, oil, or clothes – she never turned them away. She fed the hungry, clothed the poor, and treated every guest like royalty. She was the embodiment of warmth, sincerity, and silent sacrifice.

To her children, she was a fortress of love. She would often say, "One day, you will succeed.'

That one day is almost here – but her eyes won't see it.

She was so fond of my marriage, always praying for it, dreaming of the day her son would step into a new life. She longed to see us move into our newly built home – what she called her dream mansion. Today, we live in it, but it feels hollow without her warmth.



Recently, my only sister, Shazia Zainab, achieved what every daughter dreams of – a government job in the health sector. My mother prayed for it day and night. I still remember how her face lit up at the thought, her eyes glowing with dua. That prayer has been fulfilled but she isn't here to embrace my sister with pride.

We are trying our best to live by her values – to be honest, to be kind, to stay close to the Qur'an, to pray regularly, and to serve the poor. She always reminded us: "Never let pride touch your heart, and never let a needy hand return empty."

After she passed, I was lost - emotionally shattered. But then came a ray of mercy: my Murshid, Mr. Abdul Salam Dar – a man as pure as a flowing spring. He embraced me with compassion, consoled

my aching soul, and guided me back to the light of true Islam. His love and support became a shelter in the storm. My mother always wanted to meet him, and although that meeting never happened, I believe their souls are connected through purity.

There are nights I wake up yearning for her scent. There are days I walk into rooms expecting her to call my name. And every day, I feel the ache of not being able to hug her – to hear her soothing voice, just one more time. But this world has its limits. What I can't have here, I pray for in the hereafter.

Oh Lord of the universe – Ya Rabb, I have only one request:

Let me meet her in Jannah. Make me a noble soul whose deeds benefit her

Allow me to serve her in the gardens of eternity,

Just as she served us in this fleeting world.

As I take the most important step of my life, I carry a void inside me. While others will dance and celebrate, I will hold back my tears behind a smile. And in that moment, I will whisper to

Ammi, your son did it. But without you... it hurts.

ssemblies and Parliament are not about muscle power. They are meant to represent the will of the people, frame laws, and hold the government accountable. These institutions are platforms for open debate, discussion, and informed decision-making on issues that shape our collective future.

They uphold democratic governance by checking executive overreach, allocating public resources, and safeguarding the rights and interests of the people. The strength of these institutions lies not in noise or aggression, but in the calibre, vision, and knowledge of those who occupy

Yet, over the last three days, what the people have witnessed in the I&K Assembly is nothing short of a dangal. Physical assaults by legislators, verbal chaos, and disorderly conduct have taken center stage. It reflects a worrying trend where substance is being replaced with showmanship, and governance is becoming a stage for personal vendettas and ego battles. Such behavior not only weakens the legislative process but also diverts attention from the real issues facing the people of Jammu and Kashmir.

The region has its share of challenges: unemployment, infrastructural deficiencies, rising cost of living, an uncertain busi-

ness climate, and long-standing political grievances. The Assembly must function as a forum to find solutions to these problems, not to deepen divisions or distract from duties.

Scuffle In J&K Assembly Complex: AAP Protests Against PDP, BJP

JAMMU, Apr 10: AAP on Thursday held demonstrations against the PDP and the BJP over a scuffle involving its MLA Mehraj Malik with legislators of the saffron party in the assembly complex in Jammu.

Led by Malik and carrying placards against the BJP and the Peoples Democratic Party (PDP), AAP activists demanded action against those who perpetrated the scuffle. A scuffle broke out between BJP members and AAP MLA Malik on the Jammu and Kashmir Assembly premises on Wednesday after he allegedly made some objectionable remarks.

The lone AAP legislator was also involved in a heated exchange with PDP members led by Arif Amin, who were present outside the House, after they objected to his remarks against former chief minister Mufti Mohammed Sayeed, prompting the security personnel to intervene.

"I was raising issues concerning the people of Jammu and Kashmir. While the House



was not allowed to function, thereby failing to represent the wishes of the people, the chief minister, despite the House being in session, was in Srinagar with them (Union Home Minister Amit Shah and others)," Malik told reporters.

He vowed to represent the people and their aspirations, even if the House was disrupted. "I speak for all – Hindus, Muslims. If Prime Minister Narendra Modi can talk about Muslims, why can't I talk about Hindus?" Hitting out at the BJP, he questioned why the saffron party did not remove liquor shops near temples if they truly supported the causes of Hindus. "If I raise such issues, am I hurting Hindu sentiments? The BJP is playing the religious card to win elections." Malik also slammed Sayeed as "culpable" for bringing the BJP to power in Jammu and Kashmir.

"I stand by my statements on Mufti Mohammad Sayeed... They cannot scare

me... He has betrayed the Muslim community. It is because of Mufti Saveed that I am in this condition and the BJP is resorting to hooliganism. If my voice is being suppressed in the House and I am being attacked outside the House, it is because of him," the AAP lawmaker said.

On the other hand, BJP MLA Vikram Randhawa lashed out at Malik and demanded action, even calling for invoking the stringent Public Safety Act (PSA) against him. "He used derogatory words. He is always abusing Hindus. We will not tolerate this...," Randhawa told reporters.

Leader of Opposition Sunil Sharma said the AAP MLA had "lowered parliamentary standards by behaving like a ruffian". "I moved a breach of privilege against him in the House regarding his remarks on

Hindus but nothing was done," he said. "If you hurt the feelings of Hindus now, you will not only be taken to task in the Assembly but confronted on the streets, too. No one will tolerate this nonsense,' Sharma said. (AGENCIES)

Scientists have found that a toxic rare earth metal used in MRI scans can generate nanoparticles of the metal in human tissues.

Researchers from the University of New Mexico in the US, while studying the health risks posed by gadolinium, a toxic rare earth metal used in MRI scans, have found that oxalic acid, a molecule found in many foods, can generate nanoparticles of the metal in human tissues.

Training the immune system to target the most vulnerable sites on the toxin is expected to create more effective vaccines, and the more effective and longer-lasting a vaccine is, hopefully, the more people will take it, said Maynard.


