**NEW DELHI, APR 14:** Union Home Minister Amit Shah on Monday said that Prime Minister Narendra Modi's vision changed the entire landscape of the country's criminal justice system.

Shah, who was the chief guest at the All India Forensic Science Summit 2025 organized by the National Forensic Sciences University (NFSU) here, as per the news agency—said, "Under the leadership of PM Modi, we are striving to make the justice system peoplecentric and scientific. Efforts are also being made to ensure that those seeking justice get justice on time and also



have the satisfaction of getting justice. Through this, our aim is to create a safe, capable and competent India."

To strengthen the criminal justice system, the Government of India has brought three new criminal laws in the form of Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS) and Bharatiya Sakshya Adhiniyam (BSA), he added.

The conference on the theme of 'Role of Forensic Science in Effective Implementation of New Criminal Laws and Combating Terrorism' was attended by many dignitaries including Justice V Ramasubrama

### Kashmir's pilgrims left in limbo as Saudi Arabia cuts Hajj quota by 80%

CM Omar, Andrabi urge EAM to engage with Saudi authorities; Farooq appeals to PM for quota restoration

SRINAGAR, APR 14 (KNO): A sharp 80 per cent cut in India's private Hajj quota by Saudi Arabia has left many Kashmiris uncertain about their pilgrimage plans with the decision affecting over 52,000 Indian pilgrims, including hundreds from the valley. The move has sparked widespread concern among hopefuls, their families and political leaders alike.

A group of Kashmir applicants selected for Hajj 2025, speaking to the news agency— expressed



their uncertainty about their status, saying that while they were initially overjoyed with the con-

firmation, they are now in limbo and unsure if they will make it onto the final list. "We don't know if we'll make it or if we're even on the final list anymore. It's creating a lot of stress and confusion for us," said one of the applicants.

He said the situation has left many in a state of anxiety, unsure about their chances of participating in the pilgrimage.

Arifa Bano, a resident of north Kashmir, said, "I have waited years to perform Hajj. This sudden change is heartbreaking. We hope the government does something."

### J&K road accidents claim four lives, leave 30 injured in 24 hours

**SRINAGAR, APR 14**: At least four people lost their lives while over 30 persons were injured in multiple road accidents across Jammu and Kashmir in the past 24 hours, officials said. In Ramban, a pre-dawn accident on Monday near Banihal claimed the life of one person and left nine others injured. The accident, as per the news agency—, occurred when a Tata Mobile vehicle carrying members of two Bakarwal families from Rajouri's Teryath area overturned and crashed into a railway bridge wall. A baby girl among the passengers,

nian, Chairperson, National Human Rights Commission (NHRC), Attorney General R Venkataramani, Rajya Sabha MP and Chairman, Bar Council of India Manan Kumar Mishra, Union Home Secretary Govind Mohan and Vice Chancellor, NFSU Dr. J. M. Vyas.

Shah said, "Forensics is not a new idea in our country. Its detailed description is found in Charak Samhita, Sushruta Samhita and Kautilya's Arthashashtra. Acharya Kautilya has guided the world in detail on topics like toxicology, identification of poison, body language of suspects, and identification of accused on the basis of speech."

He said, "PM Modi's visionary leadership brought significant transformation to the country's criminal justice system. A system has been established where neither the accused nor the complainant is subjected to injustice. To ensure this balance, integrating forensic science into the criminal justice process is essential."

NOT POSSIBLE TO DELIVER TIMELY JUSTICE WITHOUT FORENSIC SCIENCE

"Without forensic science, it is not possible to deliver timely justice and increase the rate of conviction. The entire scenario of crime has changed today. Now criminals use different means of technology, information and communication, due to which crime has now become borderless," Shah said, as per KNO.

"Earlier, crime used to happen in a small part of a district, state or country, but now crime has become borderless. Modern crimes now transcend city, state, national, and even international boundaries," the Home Minister added.

He said, "Seven campuses of the National Forensic Sciences University have been established in different states of the country. Nine more campuses will be established in the next 6 months."

Apart from these, he said, the establishment of 10 more campuses is proposed. "There will be no state in the country where there is no campus of National Forensic Sciences University. We will work to make each campus the best unit in the world by giving it one subject. The students of the university will be helped in research and development so that they achieve heights in research and make the campus the best in the allotted subject. "

The Union Home Minister said that after its completion, every year 36000 diploma and degree holder youth will pass out from these campuses and strengthen our criminal justice system.

Shah said, "There is a need for 30,000 trained professionals to visit every crime scene where the punishment is more than seven years. Each year, around 36,000 students will graduate from the National Forensic Sciences University, many of whom will go on to work in private forensic laboratories as well. He further mentioned that the Ministry of Home Affairs (MHA) is working on an agreement between private and government Forensic Science Laboratories (FSLs), allowing certain samples received by government FSLs to also be analyzed by private labs."

Shah said that NFSU is advancing into several emerging fields, including drone forensics, smart city forensics, marine forensics, and corporate forensics.

He also highlighted the growing international presence of NFSU, stating that around 240 foreign students are currently enrolled, and that the university will continue to expand globally in the coming years.

GUJARAT FORENSIC SCIENCES UNIVER-

Referring to the importance of Gujarat Forensic Sciences University, Shahsaid, "When PM Modi was the Chief Minister of Gujarat and he himself was the Home Minister, the seed of Gujarat Forensic Sciences University, planted by PM Modi in 2009, has now grown into a banyan tree in the form of the National Forensic Sciences University — the first university of its kind in the world."

He said, "It is a matter of joy for him that when the National Forensic Sciences University was established on 1 October 2020, Narendra Modi was the Prime Minister and I was the Home Minister of the country."

Shah said that Forensic Science University is not only producing skilled professionals but is also paving the way for research across various fields. He noted that the university has become a trusted institution for forensic analysis in complex cases and has also evolved into a hub for equipping the country's forensic laboratories with modern technology.

He added that the university offers a wide range of programs, including degree, diploma, PhD, and research courses. Additionally, it has developed and adopted numerous indigenous technologies and has created toolkits to supply these innovations to police forces across the nation.

PAYSTRIBUTES TO DR BHIMRAO AMBED-KAR

Paying tribute to Bharat Ratna Babasaheb Dr Bhimrao Ambedkar on his birth anniversary, Shah said that Babasaheb worked to finalize the Constitution of India. "It was a Herculean task to finalize the Constitution after thousands of hours of intense discussion on every subject, but Babasaheb composed the Constitution by incorporating all aspects

keeping in mind the needs of the country and with the idea of maintaining the relevance of the Constitution for many years," he said.

The Union Home Minister said, "Our Constitution is not just a book. It has a system for the protection of the body, property and honor of every citizen and forensic science is now playing a very useful role in strengthening the criminal justice system associated with the protection of these three."

COUNTRY GOT RID OF COLONIAL ERA LAWS

Shah underlined that following the directive of PM Modi to get rid the country of colonial-era laws, work on finalizing new criminal laws was carried out between 2019 and 2024.

He noted that extensive discussions during this period revealed the extent to which the outdated laws were harming India's criminal justice system.

He emphasized that if laws are not updated in accordance with changing times, they become obsolete and irrelevant.

He added that the original intent of the

He said that J&K has again become a preeminent tourist destination and called for choosing the path of "value-based tourism" instead of chasing volumes.

The Chief Minister said the tourism is something that Jammu and Kashmiris famous for. "Long before we became famous for the troubles, we were famous for the beauty, and for the tourism. And this beauty is not something that is talked about in recent times," Omar said, as per KNO.

He illustrated his point by citing a famous couplet inscribed on a wall of the Red Fort that describes Kashmir as a "heaven on earth".

"These words were written centuries ago. From then to now, Jammu and Kashmir has attracted attention largely for good, but in recent years, somewhat for the bad as well," the Chief Minister said.

"But, I can safely say that we have turned the corner, and Jammu and Kashmir today has once again become a pre-eminent destination for tourism in the country, increasingly for overseas tourists as well," he said.

He said that when J&K was struggling with the aftereffects of violent attacks and terror, "for us, tourism was a visible sign of a move towards normalcy."

"Increase in the number of tourists added to its economic activity, and also gave us a sense that perhaps better days were ahead of us" Omar said, adding, "And, therefore, we chased volumes, we went out and tried to get as many tourists as possible to visit J&K, because the more the tourists, the more impact, and therefore it was a win-win for all of us."

Emphasising the importance of "value-based tourism", he said, "We have in mind nine new destinations that we hope to get funded through multilateral agency funding, which we hope will ease some of the pressure on Gulmarg, Pahalgam and Sonmarg in the Valley, and also open up areas of Jammu hitherto undiscovered for tourism"—

sures, has left nearly 52,000 Indian pilgrims uncertain about their sacred journey many of whom had already made payments.

Even the visa suspension has disrupted travel plans for hundreds of Indian pilgrims, especially from Kashmir. Many had prepared for the Umrah pilgrimage, only to face cancellations due to visa denials.

Asenior official at the Jammu and Kashmir Hajj Committee said that as of now, 550 pilgrims are scheduled to travel through private arrangements.

"It is essential that pilgrims confirm whether the HGO they are dealing with is officially listed and has been allotted a quota by the Ministry," he said.

For Hajj 2025, a total of 4,100 people from J&K submitted applications. As per official details, 3,601 were selected in the first draw conducted by the Haj Committee of India, while an additional 21 women were approved under the Mahram quota bringing the total number of confirmed pilgrims from J&K to

The move is part of a broader effort to manage crowds and logistical pressure during the pilgrimage.

Last year, J&K received a quota of 8,345 Hajj slots. The Hajj Committee received 8,147 applications and facilitated the pilgrimage of 7.008 individuals.

08 individuals. However, this year's quota reduction especially for private arrangements is expected to drastically lower the number of J&K pilgrims able to perform Hajj.

The sudden announcement has drawn criticism from several political leaders. Former J&K Chief Minister and National Conference president Dr Farooq Abdullah said, "I appeal to the Prime Minister to speak with the leaders of Saudi Arabia and urge them not to reduce our quota of Hajj pilgrims. There is also the question of jobs here."

Dr Farooq said he would urge Chief Minister Omar Abdullah to formally write to the Prime Minister to address the issue.

Chairperson of the J&K Waqf Board, Dr Darakhshan Andrabi said the Ministry of External Affairs has taken up talks on this matter with the Saudi authorities

CM Omar, through his office's post on X, said: "The reported cancellation of Hajj slots for over 52,000 Indian pilgrims, many of whom have already completed payments, is deeply concerning. I urge Hon'ble Minister of External Affairs @DrSJaishankar to engage with the Saudi authorities at the earliest."

People's Democratic Party (PDP) president Mehbooba Mufti echoed the concern, posting: "Disturbing news emerging from Saudi Arabia. Reports indicate that 80% of India's private Haj quota has been cut abruptly. This sudden decision is causing immense distress for pilgrims and tour operators across the country."—

Katra, where the Prime Minister is scheduled to flag off the first train to Kashmir on

Prime Minister Narendra is set to flag off the first train between Katra in Jammu and Srinagar in Kashmir. He will also inaugurate the Chenab bridge.

PM Modi had described the Chenab bridge as an "unparalleled" example of engineering. Moreover, the flagging off the commercial operation of the first train between Kashmir and Jammu will mark the beginning of full rail connectivity from the Valley to the rest of the country. To start with, the national transporter will operate one Vande Bharat train between Katra and Srinagar, which will enable travelers to cover the stretch in just over three hours. Currently, it takes around 6 to 7 hours.

The Northern Railway has been conducting the trial run of trains between Kashmir and Jammu for more than two months. At present, train services in Kashmir are limited to the Sangaldan-Baramulla section, while long-distance trains terminate at Katra.

The bridge over the Chenab river is 35 metres taller than the Eiffel Tower.

Officials said around 29,000 tonnes of steel has been used in the construction of the bridge. They added that construction of the bridge was challenging because the area falls in earthquake-prone region and so its design and construction were done in such a way that even if an eight-magnitude earthquake occurs it will not affect the bridge—

and people who have dedicated their lives to political and social matters, unanimously concluded that the Waqf Amendment Act is a serious infringement on the rights of the Muslim minority."

He further said that such measures threaten the democratic framework and constitutional values of the country. "This is what we highlighted there. Because of such actions, the democratic fabric and constitutional

structure of our country are being weakened," he said

Tarigami appealed to civil society, parliamentarians, legislators, writers, and the media to raise their voices. "Whether it is an attack on minorities, on democracy, on institutions, or on constitutional rights—one never knows what will be targeted next. Before it's too late, voices must be raised," he added.

He also said that in a recent assembly meeting, several honourable members demanded a debate on the issue. "It was appropriate for us to raise this question, as it deeply concerns the people of Jammu and Kashmir and the country at large. But unfortunately, no debate was allowed. And there should have been one. I said this in the assembly as well."

Referring to other pressing issues, Tarigami said, "As far as Jammu and Kashmir is concerned, the Party Congress also unanimously passed resolutions on the issues of casual labourers, daily wagers, need-based workers, Anganwadi workers, helpers, and ASHA workers. These workers, even today, are struggling to earn two meals a day. The central government has repeatedly assured that those working under daily wage and need-based schemes should be paid minimum wages, but the ground reality remains different."

In another resolution adopted by the party congress, CPI(M) asks Centre to restore full statehood to J&K. The unconstitutional abrogation of Articles 370 and 35A had dismembered and downgraded the State, with its bifurcation into Union Territories (UTs) creating a deep political void, intensifying the sense of uncertainty and alienation among the people.

It said that despite a slew of oppressive measures taken by the BJP-led Centre, people turned out in large numbers to vote in the Assembly polls held after a gap of seven years and delivered a verdict against the Union government. But the Centre continued to undermine the democratic verdict.

The resolution urged the government to restore full statehood to J&K, protect land and job rights, restore democratic civil and trade union rights, release political detainees and journalists and end indiscriminate arrests of the youth on baseless charges, he saID—

however, was unharmed, the officials said. The injured were taken to Sub-District Hospital (SDH) Banihal and later referred to Government Medical College (GMC) Anantnag for further treatment.

A minor tourist lost her life after being struck by an unknown vehicle in Pahalgam area of Anantnag district. According to an official, the accident occurred near the selfie-point in Pahalgam, where the vehicle hit and injured the young girl.

In Anantnag, a separate road accident took place in Sinthan Top area involving an Intrav (chota hathi) vehicle, resulting in injuries to eight people.

The injured were taken to PHC Larnoo, with some among them being referred to GMC Anantnag and SDH Kokernag. All the injured are stated to be stable, the officials said.

In Srinagar, two motorcyclists were critically injured in a collision near the All India Radio Kashmir flyover. They were quickly transported to SMHS Hospital by the Dial 112 police team.

A three-year-old boy was killed in Ganderbal after being hit by a vehicle in the Kullan Gund area. The boy, identified as Mohammad Hussain, was declared dead on arrival at SDH Kangan.

In Bandipora, a tractor plunged into a gorge in the Duban area of Onagam, resulting in one fatality and leaving another injured.

The deceased, Mohammad Yaseen from Malangam, was confirmed dead at the scene, while the injured, Bilal Ahmad was taken to a District Hospital for further treatment.

Police have registered cases and launched investigations into these incidents.

Meanwhile, a senior traffic police official advised drivers to exercise extreme caution, obey speed limits, and remain alert at all times

"It is crucial for all road users to exercise extra care to ensure their own safety and the safety of others. Prioritize life over reckless, high-speed driving," the officer said—

preventing such incidents.

Earlier, the Senior Superintendent of Police (SSP) Traffic Rural Kashmir, Ravinder Pal Singh at Kupwara had a few days back stated that despite the awareness drives, the initiative will only bear fruits if motorists truly understand and cooperate with the rules.

"We try our best to reach rural areas with a thrust to control accidents, fatalities, but this is only possible when people consider whatever we advise them," SSP Singh said.

He also pointed out that wrong-lane driving is a major contributor to road accidents and cautioned against teenagers driving without proper licenses.

The SSP, in the meanwhile, added that they will be strict with the school buses found to be overloaded. "They need to follow the guidelines of the Supreme Court. We will distribute stickers displaying the guidelines and traffic department contact numbers."

He further noted that installing CCTV cameras in school buses would become mandatory, adding that they are going to seize the vehicles that violate these parameters.

Also, a police spokesperson shared, women should feel safe and supported, whether they're commuting, shopping, or working. "We want to create an environment where no woman hesitates to speak up against any misconduct," they said.

Meanwhile, locals also appreciated the move, especially women who often feel vulnerable in crowded public spaces like markets, buses, and streets—particularly after dark.

Srinagar, Apr 14: Patients visiting the Bone and Joint Hospital in Srinagar have accused the hospital administration of favouritism and malpractice, alleging that MRI facilities at the government hospital are selectively used for influential individuals, while ordinary patients are frequently directed to a private diagnostic centre outside the hospital. Several patients and attendants expressed outrage, claiming that hospital authorities rarely conduct MRI tests on-site. Instead, they are allegedly being pressured to get the scans done at a nearby private centre, raising suspicions of a nexus between the hospital and the private facility."This is a public hospital, and yet MRI tests are hardly being done here. Whenever we ask about it, we are told the machine is busy or not functional. But we have seen VIPs and well-connected people getting immediate access," said a patient from north Kashmir. Another attendant, accompanying an injured labourer from Pulwama, said they were advised to go to the private diagnostic centre just minutes after registration. "It's a well-coordinated push. As soon as you mention MRI, they start hinting it will be quicker and better outside," he alleged. The complainants have urged the Health Minister of Jammu and Kashmir to intervene, demanding an inquiry into the alleged irregularities and immediate steps to ensure fair and accessible services at the hospi-

This is a tremendous mockery," Lone stated.Furthermore, Lone emphasized that a historic opportunity was missed to either pass a resolution or atleast conduct a meaningful discussion on the contentious Waqf Bill."It could have sent a powerful message from the only Muslim-majority province in the country but instead it appeared as though NC was fighting against itself merely to sabotage the discussion and to appease New Delhi," he remarked. When questioned about NC's plans to challenge the Waqf Bill in the Supreme Court, PC President noted that while courts will adjudicate according to legal principles, the emotional appeal that could have been conveyed through the Assembly has been squandered. "As a sole Muslim-majority province, our collective voice would have carried significant weight, but now even if thousands of individuals approach the court separately, the matter will be decided purely on legal grounds rather than reflecting the sentiments of the people.

## **Kashmir University Faces Major Staff Crunch with 570 Vacant Posts'**

SRINAGAR,: Nearly 20 per cent of the 2,859 sanctioned posts in the University of Kashmir were lying vacant as on February 2024, the varsity said in response to an application filed under Right to Information Act (RTI), highlighting significant staff shortage across departments.

The application filed by Jammubased RTI activist Raman Kumar Sharma in February this year revealed that majority of the vacancies are at the faculty level. This includes over 200 key posts of professors, associate professors and assistant professors, besides 110 junior assistants.

Against the sanctioned strength of 2,859 posts, 570 posts were vacant as on February 29, 2024, Central Public Information Officer of the University of Kashmir, Ghulam Mohammed Wani said in his response.

Wani, who is also Assistant Registrar at the university, said there are 56 sanctioned posts of professors but 47 are vacant, while 91 out of 120 associate professor posts are unoc-

Similarly, only 291 posts of assistant professors are filled, leaving 80 other posts vacant, he said, adding that against the sanctioned posts of seven directors, five remained vacant.

As many as 110 junior assistant



posts, against sanctioned strength of 180, are without staff, he said.

The RTI also revealed that the posts of dean of college development council, dean of students' welfare, academic coordinator, research fellow, editor-cum-lecturer, documentation officer, editor-cum-research assistant, additional controller of examination and assistant estates officer are also lying vacant.

The university also awaits the appointment of professor-cum-principal (nursing), two assistant professors (nursing), three tutors (nursing), two deputy directors and three assistant directors in physical education department, one deputy director and three assistant directors in directorate of internal quality assurance, nine assistant librarians and two placement officers.

The Institute of Music and Fine Arts of the university is also without a principal and out of seven senior instructors (IMFA), only three are posted in the department, the RTI

There are three vacancies of joint registrars, two deputy registrarscum-deputy controller examinations, seven assistant registrars-cum-assistant controller-examinations, two assistant programmers, one auditor, three coaches (physical education and sports), two computer operators, three Hindi typists and five junior engineers, Wani said.

### Need of the hour; fire safety audit of religious places in J&K

ast week a child lost his life while some others sustained injuries after fire broke out in a religious seminary at Tral in South Kashmir's Pulwama district. The incident sent shock waves among the people of the valley and they expressed concern over the unfortunate death of the young boy. Even though the fire tenders from different fire stations reached the place of incident within no time the intensity of fire was such that the young boy was charred to death instantly.

The people as a whole expressed concern over the lack of fire safety equipment at the seminary and said that if the proper security measures were in place the incident could have been avoided. It has been observed that the fire safety procedure is compromised at most places of religious importance across the Kashmir valley. As a result of this, the lives of hundreds of people who visit these places are at risk. The worst thing is that both the masses as well as the government are not paying attention to this issue.

The need of the hour is that a fire safety audit is carried out in all the masjids, temples, gurdwaras and churches across the union territory of Jammu & Kashmir. Once this exercise is carried out then the picture would be crystal clear and it would be known how many such religious places are without the necessary fire-fighting equipment. This should be followed by issuance of warning to the management of deficient religious places. A time frame needs to be set out for installation of fire safety equipment failing which stern action needs to be taken against the guilty.

Over the years there has been a mushroom growth of the religious seminaries in Jammu & Kashmir, especially the valley. There is no harm in imparting religious education to the boys and girls but at the same time the lives of the people are more important. The management of such institutions need to be made aware about the safety concerns and it should be impressed upon them to put in place the necessary fire safety equipment.

It is highly unfortunate that many people who carry out construction of shopping complexes and malls also compromise over the safety of the people who are expected to visit such places. Somehow the departments also take the things very lightly and they issue the no objection certificates (NOCs) to owners of such complexes and malls who blatantly flout the norms according to their own wish.

## The Alarming Rise of **Unemployment in India**

nemployment has emerged as one of the most pressing socioeconomic issues in India today. Despite several government initiatives aimed at improving the labor market, the unemployment rate in the country has been rising steadily, reaching a concerning 9.2% in June 2024, as per data from the Centre for Monitoring the Indian Economy (CMIE). This spike in joblessness is not only affecting urban populations but has also deeply infiltrated rural areas, with youth and educated individuals bearing the brunt.

India, with its vast and diverse demographic landscape, faces a complex challenge. While a large population is often viewed as a potential economic asset, it becomes a liability when job opportunities fail to keep pace. The growing gap between available jobs and the number of job seekers, particularly among the youth, is a clear indication of systemic inefficiencies and structural flaws in the labor market.

#### **A Youth Crisis**

Youth unemployment has become particularly severe, with highly educated individuals, including graduates, postgraduates, and even PhD holders, struggling to find suitable employment. This trend reflects not just a scarcity of jobs but also a serious mismatch between the education system and market demands.

India's education system, criticized for emphasizing theoretical learning over practical and vocational skills, has contributed to this issue. Many students graduate with degrees that do not translate into employable skills, leaving them illprepared for the job market. As a result, even prestigious academic qualifications are no longer a guarantee of employment.

In states and union territories such as Jammu and Kashmir, the problem is even more acute. Many highly qualified

youth remain unemployed, leading to rising frustration and concern over their future prospects. The region has witnessed a surge in the number of unemployed graduates, with limited government or private sector opportunities to absorb them.

#### Rural Realities and Gender Divide

The unemployment crisis is not confined to urban centers. Rural India has seen a sharp rise in joblessness, with the rate climbing from 6.3% in May 2024 to 9.3% in Iune 2024. Contributing factors include seasonal employment in agriculture, underemployment, and a lack of alternative job options.

Women, especially in rural areas, face additional barriers. The lack of proper educational infrastructure, poor functioning of government schools, and prevailing gender biases continue to limit opportunities for girls and women. Many females are either not allowed or not encouraged to pursue higher education or join the workforce, further deepening the unemployment problem.

#### **Root Causes of Unemployment**

Several key factors contribute to the rising unemployment rate in India:

Population Growth: A rap-

idly growing population creates immense pressure on the job market, leading to an excess supply of labor. Skill Mismatch: There is a

clear gap between the skills possessed by job seekers and the requirements of indus-Agrarian Distress: A large

section of the population is dependent on agriculture, which offers limited and inconsistent employment. Technology and Automa-

tion: With industries embracing automation and digitization, demand for manual labor has declined. Economic Slowdowns:

Events like the COVID-19 pandemic and global financial uncertainties have adversely impacted hiring across sec-

Educational Shortcomings: The current education system lacks emphasis on employability, practical training, and vocational courses.

#### **Economic Consequences**

The high unemployment rate has far-reaching economic and social implications. It directly affects consumer spending, as unemployed individuals have less disposable income. This slowdown in demand can hinder economic growth, reduce investor confidence, and trigger social unrest.

Furthermore, widespread unemployment can lead to mental health issues. increase crime rates, and cause a sense of hopelessness, particularly among the vouth. It also affects family structures and can lead to migration from rural to urban areas, creating further stress on cities and urban infra-

The Indian government has launched various initiatives to tackle unemployment, such as the Skill India Mission, Startup India, Make in India and Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA). While these initiatives have shown some success, experts argue that their implementation often falls short. Issues such as bureaucratic hurdles, corruption, and lack of awareness limit their reach and effectiveness. It is also crucial to invest in modernizing the education system by integrating vocational training, internships, and digital literacy. Creating industry-academia partnerships can help align the skills of graduates with real-world job requirements. In addition, promoting sectors like renewable energy, tourism, healthcare, and digital services can provide employment to a wide range of individuals, from skilled professionals to semi-skilled workers.

## Why India's First National Cooperative University Matters

The passage of the bill for India's first national cooperative university, Tribhuvan Sahkari University, in Parliament marks a historic milestone in the journey of the Indian cooperative movement. That this development comes during the 2025 International Year of Cooperatives only adds to its significance. As Union Minister for Cooperation Shri. Amit Shah noted, this university is poised to become a powerful vehicle in realizing the vision of "Sahkar Se Samriddhi" - "Prosperity Through Cooperation."

India is home to the largest cooperative movement in the world, comprising over

800,000 cooperatives and 287 million members. Deeply embedded in the daily lives of people-from roti, kapda, to makan (food, clothing, and shelter) – cooperatives are more than just economic institutions; they represent an expression of community-driven development, economic equity, and social justice. The establishment of the Ministry of Cooperation (MoC) in 2021 signaled a renewed national commitment to this sector, aimed at expanding its reach, improving its efficiency, and integrating it as a cornerstone of inclusive development.

Ministry of Cooperation has taken commendable steps: allocating 2,516 crore to computerize 67,390 Primary Agricultural Credit Societies (PACS), introducing model byelaws adopted in 32 states to enable over 25 business activities, creating 2 lakh new multipurpose cooperatives, supporting 1,100 Farmer Producer Organizations (FPOs), and transforming 44,000 PACS into Common Service Centers. Tax incentives, easier access to credit, and

decentralized storage solutions are enhancing cooperatives' operational capacities. The establishment of three new national federations for seeds, exports, and organic products further signal that cooperatives are being positioned as key agents of India's development. Yet, for all its scale and

reach, the cooperative sector's education and training infrastructure remains fragmented, under-developed, and unevenly distributed. The demand for qualified professionals-from managerial and administrative to technical and operational is far outpacing the available supply. Equally critical is the need to invest in the capacity-building of existing employees and board members, many of whom lack access to regular training or structured learning opportunities. Without standardized curricula, quality assurance, and institutional coherence, the sector cannot fully realize its potential or sustain its growth. With India's diverse cooperative landscape-spanning dairy, credit, housing, fisheries, textiles, and more-the university has the potential to act as a converging space for multidisciplinary expertise, linking academia, practitioners, and policymakers.

Globally, cooperative education has been foundational to the success of cooperative movements. As far back as the Rochdale Pioneers in 1844, the original rules of conduct included allocating a portion of profits to education. The fifth Cooperative Principle-Education, Training and Information-remains a core pillar of the movement, ensuring that members, leaders, and the broader community understand and uphold the cooperative model. It is this deep-rooted educational tradition that sustains cooperative governance, fosters innovation, and strengthens accountability.

In this context, Tribhuvan Sahkari University can be more than just an academic institution-it can become a national and global knowledge hub for cooperative development, a space where practice meets policy, and learning fuels leadership. At the ICA Global Cooperative Conference held in New Delhi, Prime Minister Shri. Narendra Modi called on India to lead the Global South in uniting cooperatives to build shared platforms, tackle common challenges, and collectively chart a path forward. This is a story of yesterday, today and tomorrow because yesterday these kids were born, today they are living somehow and tomorrow well no one knows!



### J&K Students Association Thanks EAM Jaishankar for Repatriation of Two Dozen Trafficked Kashmiri Youth Held Hostage in Myanmar

SRINAGAR, APRIL 14 The Jammu and Kashmir Students Association on Monday expressed its gratitude to the External Affairs Minister, Dr. S. Jaishankar, for his swift and timely intervention that led to the rescue and repatriation of two dozen Kashmiri youth, including Faizan Ahmad of Safakadal, Srinagar, who were trafficked and held captive in Myanmar under distressing conditions.

In an official statement, Nasir Khuehami, National Convenor of the Association, stated that these youth, hailing from economically weaker backgrounds, had been misled by fraudulent agents offering fake promises of jobs in Thailand. Upon reaching Bangkok, they were transported to Myanmar after a 15-hour bus journey and a forced river crossing. Once in Myanmar, they were held hostage in areas notorious for human trafficking, forced labor, cybercrime networks, and organized criminal syndicates.

He said that the traffickers demanded ransom money from the families of the victims. In the case of Faizan Ahmad, an



amount of 4.5 lakh was demanded with threats of dire consequences. "His family, already in financial distress, could not arrange the ransom. This was a common ordeal for many of the other victims," Khuehami added.

The Association had formally written to Dr. S. Jaishankar on March 10, seeking urgent intervention. "We are thankful that the Ministry responded the very next day, assuring us that the Indian Mission in Myanmar had already taken up the issue with the concerned authorities," he said.

Khuehami quoted the MEA's official communication dated March 11, which stated: "Requests for the rescue and repatriation of all Indian nationals, including Kashmiri youth Faizan Rasool, entrapped in Myawaddy, have been taken up with the concerned authorities in Myanmar. We are actively working on it."

Following this assurance, robust diplomatic efforts were undertaken by the Indian Missions in Myanmar and Thailand, leading to the successful rescue of around a dozen individuals in the initial phase. All the rescued youth were brought pack safely under full security arrangements and are currently undergoing counselling and debriefing.

"The timely intervention of Dr. S. Jaishankar and the dedicated efforts of the Indian Embassies have brought immense relief and hope to dozens of families who were plunged into despair. His leadership has once again reaffirmed that India stands with its citizens, even in the darkest corners of the world," Khuehami said. He emphasized that the rescue mission not only saved lives but also sent a strong message to international trafficking rackets—that the Indian state will not tolerate the exploitation of its citizens.

The Association expressed deep appreciation to the Ministry of External Affairs, the Indian Embassies in Myanmar and Thailand, and all officials involved in the rescue. "His empathy, resolve, and commitment have restored faith among families who were on the brink of losing hope," the statement said.

His leadership has reaffirmed that India does not forsake its citizens, no matter how far, complex, or dangerous the situation may be. The successful evacuation of these young men has not only saved lives but also delivered a clear warning to criminal syndicates and traffickers: the Indian state will pursue justice and protection for its people—without delay and without compromise.

His intervention, coupled with the tireless efforts of the Indian embassies, brought an end to this nightmarish saga. The families of these rescued youth-who had been living in agony and despairnow feel a sense of solace and relief, thanks to the government's compassionate and coordinated diplomacy. The tears in their eyes now reflect gratitude rather than grief.

## **Doodkul Villagers Protest Decades of Neglect, Demand Road and Basic Facilities**

Langate, Apr, 14: Residents of Doodkul village, located in the Mawar area of Langate in border district Kupwara, staged a strong protest on Sunday over the deplorable condition of roads and the lack of basic amenities in their area. The village, home to over 300 families, has reportedly been neglected for decades despite repeated appeals to authorities. Villagers said that although Doodkul has been inhabited for more than 70 years, the area continues to suffer from poor road connectivity. The 3-kilometer stretch linking the village to the main road is riddled with massive potholes, resembling mini ponds, making travel not only inconvenient but hazardous—particularly during medical emergencies or for school-going children who use the road daily.

"Every day, our children risk their lives just to reach school. In cases of medical emergencies, the condition of this road has turned fatal in the past," said one protester. The villagers also raised serious concerns over the nonimplementation of government schemes. "Jal Jeevan Mission (JJM) is a distant dream for us. We had to jointly purchase plastic pipes from the market for drinking water supply. What kind of development is this?" asked a resi-



dent.In a scathing attack on political representatives, the villagers accused elected officials—from Sarpanchs and DDC members to MPs—of ignoring their plight postelections. "We voted for them with the hope of change, but they vanished after winning. Even jailed MP Engineer Rashid's son, Abrar Rashid, is busy touring Pir Panjal, while his neighboring village Doodkul is suffering," another local complained.

 $They also \, named \, other \, leaders \, like \, Ir fan \, Pandithpori, Mir$ Junaid, and Shaikh Khursheed, accusing them of making lofty promises before elections and abandoning the village afterward. The villagers lamented that their elected DDC member, Khursheed Ahmad Dar, and BDC representatives have yet to conduct even a single review visit to the area. "We have been left at the mercy of God," a protester said. The aggrieved residents have appealed to the Deputy Commissioner Kupwara and the Lieutenant Governor's administration to intervene directly and ensure road connectivity, potable water, and implementation of welfare schemes. When contacted by Headlines  $Today, the \, Executive \, Engineer (Exn) of \, PMGSY \, stated \, that$ the road does not fall under their jurisdiction. However, the Executive Engineer of R&B Division Langate responded positively, saying, "If this road comes under our department, I assure a personal visit to the area within a few days to assess and address public grievances regarding road connectivity." The villagers now await action, hopeful that their voices will finally lead to meaningful development and long-overdue relief.

#### Mehul Choksi, wanted in PNB loan fraud case, arrested in Belgium: **Reports**

Fugitive Indian diamantaire Mehul Choksi, wanted in the PNB loan fraud case, has been arrested in Belgium on India's extradition request, according to reports.

The 65-year-old was detained on Saturday and is currently in a Belgian jail, news reports said, quoting sources in the CBI, which had put out a Red Corner Notice against him.

India has an extradition treaty with Belgium.

However, Choksi is expected to seek bail and an immediate release, citing health reasons, as he is suffering from cancer.

Choksi, along with his nephew Nirav Modi-who is in London awaiting extradition-is accused of defrauding Punjab National Bank (PNB) of Rs 13,850 crore.

The case, which shook the Indian banking sector in 2018, involved fraudulent Letters of Undertaking (LoUs) and Foreign Letters of Credit (FLCs), allegedly issued through collusion with bank officials.
