RAMBAN, APR 21: : All 50 pilgrims from Gujarat who were stranded in the landslide incident in Ramban in Jammu-Kashmir are safe, Gujarat Commissioner of Relief Alok Kumar Pandey said here on Monday. Three persons were killed and more than 100 people rescued after cloudburst-induced floods and landslides on Sunday caused massive damage to infrastructure, including roads and residential buildings, in Ramban district in the northern Union Territory. Upon learning that pilgrims from Gujarat were stranded due to the landslide incident, Chief Minister Bhupendra Patel promptly instructed authorities to coordinate with the J-K TURN ON.....PAGE 02

JAMMU, APR 21: While all private member's resolutions which couldn't be taken up due to repeated adjournments amidst pandemonium in the Legislative Assembly over Waqf Act have lapsed, all 33 private member's bills are intact and will be taken up whenever the House meets for the next time.

"All 33 private member's bills will remain valid. They will not lapse. The bills will be listed whenever the next Assembly session is held," Legislative Assembly Speaker Abdul Rahim Rather told the Excelsior.

However, he confirmed that all private member's resolutions which were listed in the House for two days have lapsed and will not be taken up again. A number of MLAs had tabled resolutions seeking restoration of Statehood to Jammu and Kashmir.

This has come as a big relief for the MLAs who spent lot of time in drafting the bills before submitting them to the

SRINAGAR, APR 21: Asia's largest Tulip Garden, situated on the foothills of Zabarwan range in Srinagar, has set a new record by welcoming over 8.14 lakh visitors during the 26-day-long Tulip Show 2025.

According to data accessed by the news agency— a total of 8,14,727 tourists visited the Indira Gandhi Memorial Tulip Garden from March 26 to April 20, 2025, surpassing all previous records.

The record-breaking footfall includes locals, national, and international tourists, who came to witness the mesmerizing bloom of over 1.7 million tulips of different

through rugged terrain to reach Kela Morh, where the cloudburst had triggered flash floods, leaving a trail of destruction.

The natural calamity has claimed the lives of three persons, while causing extensive damage to residential structures, vehicles, and critical road infrastructure. Ramban district, often referred to as the lifeline between the Kashmir Valley and Jammu, remained cut off for the second consecutive day due to debris and damage along the National Highway, J&K's primary transport

Interacting with local residents and officials from the district administration, the Chief Minister was briefed on the scale of the damage and the progress of ongoing rescue and relief operations. He expressed his heartfelt condolences to the families of the deceased and assured that the government stands shoulder to shoulder with the victims of this tragedy.

"The scale of destruction is deeply distressing. Our administration is on the ground, working tirelessly to ensure the safety, relief, and rehabilitation of every affected family," CM Omar Abdullah said.

We will leave no stone unturned in standing by our people during this difficult time,"

He further directed the concerned departments to expedite restoration work on the highway to resume vehicular movement at the earliest.

The district administration informed the Chief Minister that clearance operations are in full swing, with teams from the Public Works Department (PWD), Border Roads Organisation (BRO), disaster response units, police, volunteers, and the local population working round the clock to remove mudslides and boulders and restore normalcy in the affected area.

following a devastating landslide and assured that Centre is committed to helping those affected by the disaster.

The landslide has resulted in the tragic loss of three lives.

"A team of the BJP has arrived at Ramban to make an assessment report of what has happened on the ground. We will prepare a comprehensive report and, being in opposition, we will do whatever is possible to provide help from the state government and provide details to the central government," Sharma told reporters.

"BJP is very serious about this disaster. We assure that the central government will provide financial help to the people affected by the landslides," he added.

restore traffic movement on the highway. "We are working hard to clear the highway. If all goes well, we may allow one-way traffic within two to three days," officials said, adding that no passenger vehicles are currently stranded on the highway.

To speed up restoration work, NDRF, SDRF and local volunteers have been deployed for rescue operations. Heavy machinery, including JCBs and earthmovers from agencies like KRCL, CPPL, and DMR is working round-theclock to remove debris and repair the damaged road.

The Indian Army, CRPF, and the civil administration have launched a joint operation to assist stranded people, deliver essential services and support ongoing repair

Over a dozen vehicles have been damaged, some buried under the debris. The rescue operations are continuing across the district.

Dozens of bridegrooms were seen walking on foot along the Jammu-Srinagar Highway due to the road closure. One groom walked 10 km to reach his bride after a landslide hit Ramban and adjoining areas. He was heading to Srinagar from Sangaldan Railway Station.

"I didn't expect to travel on foot today, now I'm reaching by train. But it is reality,' he said.

Divisional Commissioner Jammu, Ramesh Kumar, said that while the rain has stopped, assessment of road conditions in Ramban is ongoing.

"We are examining areas where cracks have developed and evaluating the overall stability of the road. A detailed assessment is essential before commenting on its condition," he said.

He said that the district administration including the DC, SSP and teams from NHAI, SDRF, NDRF and other agencies, are actively engaged in restoration efforts.

"The weather has improved, assessments have begun, and restoration is in progress. The affected people have been identified and relocated to safer locations," he said.

Relief requirements are also being assessed, and all damaged areas are under review to ensure proper support. "The DC and SSP teams are working round-the-clock with full support from the UT government," Kumar said.

 $Regarding \, the \, reopening \, of \, the \, highway, \,$ he said, "It's too early to give a timeline. Once

the full extent of the damage is assessed and road stability confirmed, we can estimate when traffic will resume. Our teams are working to reopen it as soon as possible."

He said that the damage is extensive, with sections of the road having sunk, retaining walls collapsed, and heavy mud accumulation. These challenges will take time

However, alternative routes have been arranged. Light Motor Vehicles (LMVs) heading to Kashmir are being diverted via Mughal Road, while Sinthan Top is open for LMVs from 11:30 AM to 4:00 PM.

"Following the CM's instructions and guidance, the Gujarat State Emergency Operation Centre (SEOC) immediately contacted the relevant authorities in Jammu and Kashmir to ensure the safety and security of the Gujarat pilgrims. The bus carrying tourists from Gujarat is in a safe zone, away from the landslide, and all the travellers are safe," Pandey informed.

"The army personnel have provided food, water, and other essentials to the Gujarat travellers. Moreover, accommodation and meal arrangements have also been made for all the pilgrims at the Army camp," he added.

The travellers from Gujarat currently do not have any medical emergencies and the J-K administration is actively working to safely remove the travel bus trapped in the landslide, Pandey said.

Legislative Assembly for introduction.

"Drafting bill for a MLA is time-consuming exercise. For a Government bill, there are number of Government officers including the Law Department which drafts the bills but a legislator has to do this exercise on his own by consulting law books, taking opinion of legal experts etc while drafting the bill," some of the MLAs said and expressed satisfaction that the bills will remain intact and will be listed in the next session.

The private member's resolutions were listed in the Assembly on April 7 and 9 while the private member's bills were due to be taken up on April 8. However, entire business of three days couldn't be taken up in the House due to repeated adjournments amidst pandemonium over National Conference MLAs' adjournment motions seeking suspension of business to discuss Waqf bill passed by the Parliament.

No business was taken up in the Assembly from April 7 to 9 which were last three days of the budget session. The House was adjourned sine die on April 9 by the Speaker.

The Assembly has to meet once in six months. As the House was adjourned sine die on April 9, it has to be convened again before October 9. The session, most likely a brief one, could be held in Srinagar in September this year.

From appointment of first-ever Lokayukta in Jammu and Kashmir to implementation of Anti-Defection Law in District Development Councils (DDCs), imposition of prohibition, regularization of daily wagers and contractual staff, amendment in reservations, vesting ownership rights of Evacuee Property, block level recruitment and setting up of the J&K Legislative Forum for Monitoring and Protection of Human Rights, the legislators had submitted 33 private member's bills in the Assembly.

CPM MLA MY Tarigami had given the Jammu and Kashmir Lokayukta Bill through which he had demanded appointment of Lokayukta in the Union Territory.

Four legislators had sought ban on liquor in Jammu and Kashmir through separate private member's bills tabled by them in the

Legislature. They included NC veteran Ali Mohammad Sagar, a former Minister, Ahsan Pardesi (NC), Sheikh Khursheed Ahmad (Awami Ittehad

Party) and Mir Mohammad Fayaz (PDP). Khursheed, through a separate bill, had also sought ban on Online Gaming and Fan-

tasy League. Regularization of daily wagers and contractual workers figured through the private member's bills tabled by PDP's Waheed ur Rehman Para and NC's Saifullah Mir (former Law Minister) besides others.

BJP MLA Balwant Singh Mankotia though a bill titled Jammu and Kashmir Temples and Land Protection Bill had sought restoration of entire encroached land of religious places. u and Kashmir Excise (Amendment) Bill.

He enjoined upon the concerned department to expedite the work on the utility projects like water supply under AMRUT and sanitation under SBM (U). He made out that these projects once completed would improve the living standards of the residents substantially.

The Chief Secretary had a detailed review of progress made on the ongoing flagship

projects under the Smart Cities Mission, AMRUT 2.0, PMAY-Urban, PM eBus Sewa, DAY-NULM, SBM 2.0, CITIIS 2.0 and other major initiatives of the department.

About the Srinagar Smart City projects, CEO, SSCL, Owais Ahmad, informed that the works span infrastructure modernization, heritage restoration, mobility enhancement and public space improvement. He added that 161 projects worth budgeted cost of Rs 3634 crore have been taken in hand under Smart City Mission. Out of these, 11 works are being executed with a cost of Rs 203.47 crore. These included construction of Traditional Souq Market and Craft Centre at

Blocks, interpretation facility centre, cafe deck and viewing towers along Shalimar

Regarding Jammu Smart City Limited (JSCL), CEO, JSCL, Devansh Yadav, informed the meeting that a total of 127 projects were taken in hand at a budgeted cost of Rs 3581 crore. The ongoing 7 projects costing around Rs 529 crore included Tawi River Front Development, Oceanarium at Bag-e-Bahu, Complete Street Development from Canal Road to Talab Tilo and Waste 2 Wonder Park and others.

As part of the Tawi Riverfront Development Project (TRF), it was revealed that the interception and diversion of nallahs at both left and right banks has been completed.

It was further divulged that 100 ACeBuses each have been approved for both the cities under PM eBus Sewa (via Challenge Method). For the same, financial assistance from GoI to the tune of 100% for 'Behindthe-Meter' power infrastructure and 90% (up to 20 Cr) for depot infrastructure is being provided by MoHUA.

Moreover, the DPRs for Jammu Depot Infrastructure (JSCL) has been framed costing around Rs 16.72 crore and for 6.6 MW power substation a DPR worth Rs 8.51 crore has also been formulated. Similarly, for Srinagar Depot Infrastructure a DPR of Rs 14.50 crore has been formulated besides DPR worth Rs 5.78 crore for Power sector has been made through the concerned agencies. All the DPRs have been approved by the Central Steering Committee, the meeting was informed.

With respect to progress on housing projects under PMAY-U, MD, Housing Board, Shahbaz Mirza, informed the meeting that under BLC Vertical (2021–24) 27,439 houses have been completed with a fund utilization of Rs 496.15 crore including a central assistance of Rs 40 crore released in Feb–Mar 2025.

Regarding PMAY-U 2.0 expansion, a Memorandum of Agreement (MoA) with MOHUA stands signed to implement the scheme in all 78 municipal bodies of the UT. It was also given out that a baseline survey for identification of houseless individual/ families had also been initiated. To ensure that the benefit of PMAY reaches the section of people who don't have permanent house to live in, a digital app had been developed to survey the urban areas. Additionally, the Master trainers were imparted training in all the districts and committees structured for verification and selection of eligible beneficiaries.

Regarding the financial assistance under PMAY-Urban 2.0, it was said that Rs 2.25 lakh as Central Assistance and UT share of Rs 0.25 lakh under BLC and AHP vertical of the scheme would be given to the benefi-

 $Regarding \,progress\,on\,SBM\text{-}U2.0(Swachh$ Bharat Urban Mission), the meeting was apprised that a Material Recovery Facility for dry waste, compost/CBG plants for wet waste, facilities for C&D waste, bioremediation of legacy waste and STPs for Used Water Management for the two Municipal Corporations and 78 ULBs are under different stages of implementation. It was further added that all the 78 ULBs had been declared "Safaimitra Surakshit Sheher" by the GoI.

MD, NULM revealed that out of a total of Rs 61.77 crore received funds Rs 55.54 crore have been utilized, so far. She also gave out that a new mission Deendayal Jan AajeevikaYojana (Shehri) is under design to replace NULM with components like Livelihoods, Skilling, SHGs, Enterprise Promotion, Local Action for which the deliverables, timelines and institutional mechanism being finalized

the third straight day, causing extensive losses to the fruit growers and orchardists. For the losses, the government has already directed the district administrations in Kulgam and Shopian to assess the losses for the compensation.

It is worth mentioning here that the three-day wet spell led to the closure of many crucial roads including the Srinagar-Jammu National Highway, which has wit-

nessed massive damage and would likely take a few days to clear the debris and throw the road open for vehicular movement.

Furthermore, three people including two minor siblings have died in a landslide in Ramban area.

Meanwhile, in its advisory, the MeT has stated that all concerned are advised to plan accordingly and follow the administration and traffic advisories.

The farmers have been advised to resume the farm operations from tomorrow (April 22) onwards, it reads, adding that since due to the continuous rain during the past 3 days, the possibility of landslides, shooting stones and rock fall at vulnerable places can't be ruled out.

The advisory appealed people to stay inside and at safe places during thunder, lightning and gusty winds-

will also embark from Srinagar, he added. He said the vaccination drive is being conducted on April 21, 22, and 23. "Pilgrims from remote areas can arrive at the Haj House in Bemina one or two days in advance, and all arrangements for their stay have been made," Dr Qureshi said.

Regarding the flight schedule, he said that on April 9 and 14; two flights are scheduled per day, while on other days one flight will operate daily. The Hajj departures will begin from May 4, and return flights are scheduled between June 17 and June 28.

Meanwhile, only 3,624 pilgrims from Jammu and Kashmir are set to perform Hajj this year, a substantial decrease from 7,008 in 2024 and 35,000 in 2017.

This 70% drop over two years is attributed to rising costs, the discontinuation of government subsidies, and logistical challenges.

Notably, a significant factor contributing to the decline is the 80% cut in India's private Hajj quota by Saudi Arabia, affecting over 52,000 Indian pilgrims, including many from Jammu and Kashmir. This abrupt decision has left numerous pilgrims in uncertainty-

Conference President said, "We know about it. It is not a new thing. There are people among us who are part of it and we need to strongly crack down on these agents and punish them for pushing our youth to the brink."

He also called for concerted efforts to combat the drug menace. "There are people $who \, are \, involved \, in \, this \, and \, are \, selling \, drugs \,$ here. We must bring them down and give them the harshest punishment possible. They are jeopardising our future," Dr Farooq

Calling the recent cloudburst in Ramban a "National Disaster" Dr Farooq Abdullah said, "It's a major disaster; the whole village has come down. I am hopeful that the Government of India will take note of it and extend all possible support."

He stressed the urgent need for rehabilitation of the affected families. "The victims will have to be resettled as they can no longer live there. Their homes and livelihoods have been washed away. The situation demands swift intervention," he added.

"The cloudburst has not only caused loss of life and property but also severely impacted connectivity in the area," he said, adding, "The tragedy has also disrupted the traffic on Jammu-Srinagar National Highway. The highway has been affected again. Had the train service commenced people could have availed the facility. Unfortunately the Prime Minister couldn't inaugurate the train service due to the inclement weather."

Calling for strategic infrastructural development, Dr Farooq also emphasized the importance of an alternative all-weather route. "One national highway is not enough. A tunnel should be constructed on the Mughal Road to provide a reliable alternative. It will ensure uninterrupted access, especially during natural calamities," he said, as per KNO.

Dr Farooq also expressed confidence about statehood restoration. "We will get our powers and statehood back. It has been promised in the Parliament. It will definitely come."

Asked about differences in the National Conference, especially after comments by Srinagar MP Aga Syed Ruhullah Mehdi, he said, "It is an internal matter."

He, however, declined to comment on Congress leader Rahul Gandhi's remarks abroad regarding the Election Commission. "Please do not ask me questions about Rahul Gandhi. I have no comments on it."-

As per Sample Registration System (SRS) data from 2018–2020, Jammu & Kashmir's sex ratio at birth** has increased to 921 females per 1,000 males, up from 918 during 2017-19. These appeals pertained to corrections under Section 22 and inclusions under Section 23 of the Act.

"The lack of appeals following the publication of the electoral rolls is a testament to the transparency, inclusiveness and robustness of the SSR process. With active participation from political parties through their Booth Level Agents, we are confident that the electoral rolls published in January 2025 reflect a high level of accuracy and public trust," said a representative of the Chief Electoral Office (ECI).

Adequate stock of essential commodities, fuel available in Kashmir Valley: Div Com

Asks people not to panic; says efforts on for restoration of national highway

SRINAGAR, APRIL 21: Divisional Commissioner (Div Com) Kashmir, Vijay Kumar Bidhuri on Monday said that there is an adequate stock of essential commodities including LPG, Diesel & Petrol available across the Valley.

He stated that significant efforts are underway to repair and restore the National Highway to facilitate the movement of vehicles. Bidhuri maintained that restoration work is expected to be completed within four or five days while one way Light Motor Vehicles are allowed to ply on Mughal Road.

Div Com made these remarks while chairing a meeting of officers to evaluate the availability of essential supplies in the region and to assess damage incurred by orchardists.

Addressing the meeting, he underscored that there is enough fuel stock to last for over 12 days and urged citizens to refrain from causing unnecessary panic or queuing at petrol stations.

He said that the LPG stock is sufficiently available for 17 days, while the 10, 000



Kilolitres of petrol will suffice the requirement for 16 days and similarly 12500 Kiloliters of diesel are available in Valley. Meanwhile, to address profiteering by some traders, the Div Com instructed

Deputy Commissioners to constitute joint teams to conduct thorough market inspections, while Superintendents of Police were asked to deploy personnel at petrol stations to discourage queuing by people. Regarding damage to apple orchards from severe weather conditions, Bidhuri directed Deputy Commissioners to constitute joint teams to assess the extent of the damage caused by heavy rains, strong winds, and hailstorms, and to submit their findings promptly.

Spray orchards now to prevent fungal infections: Horticulture experts to growers

Srinagar, Apr 21: Horticulture experts have urged apple growers across Kashmir to act immediately and spray recommended fungicides if they missed the pre-rain spraying schedule, warning of an increased risk of scab and other fungal diseases. Dr Tariq Rasool, a plant pathologist at Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST), Srinagar, speaking to the news agency—Kashmir News Observer (KNO), said orchards sprayed before the rainfall are currently protected and do not require immediate attention. However, growers who failed to spray prior to the rains are at a higher risk of fungal infections.

"Scab is a common fungal disease that can significantly reduce fruit quality and yield. Spraying immediately after rainfall is essential for disease prevention," he said.

Ramban Tragedy: Mehbooba blames reckless environmental practices

Srinagar, Apr 21: Blaming reckless environmental practices as one of the reasons for the Ramban landslide, former Jammu and Kashmir Chief Minister Mehbooba Mufti on Monday said the disaster was not merely an act of nature but a consequence of unbridled human interference with the environment.

Addressing media persons, Mufti highlighted the growing environmental degradation in the region, citing 'unchecked' deforestation and 'unregulated' mountaincutting as key contributors to such tragedies.

"The way we cut down mountains and forests without hesitation, we think about development in a way that ends up causing destruction," Mufti said, as per the news agency—Kashmir News Observer (KNO), adding that such disasters are now direct fallout of environmental negligence. Urging the government to prioritise evacuation and relief, she said, "Many people have gone missing. Some have lost their lives, and others may still be trapped under debris."

Mufti said several vehicles were buried under the landslide, while road closures have left children, women and elderly passengers stranded in extremely difficult conditions.

She appealed to the administration to expedite rescue operations and ensure timely relief for those stuck in the area. Mufti also said she had directed her party's General Secretary to immediately visit the affected area and coordinate the necessary help on the ground—(KNO)

Ramban incident a stark reminder of damage to ecology & environment

Three persons including two children lost their lives while herds of cattle perished following cloud burst and landslides in the Ramban district during the intervening night of April 19 and 20. There is no denying the fact that the incident was a result of nature's fury and nobody can stop the same. At the same time it is an established fact that over the years the greedy nature of the people has caused innumerable damage to ecology and environment.

Over the years the mountains and the peaks along the Srinagar-Jammu national highway have bore the brunt of the man's greed. Due to excessive blasting the mountains and peaks have started to cave in and it is due to this reason that the same soil comes on the main highway due to which the highway gets closed. Since Jammu & Kashmir witnessed heavy rains over the past three or four days the damage to mountains and peaks have been unprecedented.

It was due to this reason that a huge stretch of highway caved in following which many vehicles were washed away. In addition scores of passenger vehicles and trucks carrying goods got trapped in the debris of the soil and rocks that came down due to the caving of mountains and peaks. Luckily the people boarding the passenger vehicles along with the drivers of these vehicles and also of the goods trucks managed to save their lives. Had this not happened then the figure of casualties would have been much higher.

Like other places the forest cover along the Srinagar-Jammu national highway has replenished over the years and trees have been felled in the name of development. Development for the sake of development is good but that should not be at the cost of causing damage to the ecology and environment. There are many foreign countries where the people at helm have maintained a fine balance between the environment and the development. It is quite unfortunate that in this part of the world development is taking place at the cost of the environment.

For the past so many years excessive blasting has taken place along the Srinagar-Jammu national highway so that the highway is widened. Due to the blasting the soil of the mountains and peaks has loosened and even if there is very less rainfall the mountains and peaks come down. This leads to frequent closure of the highway and at times the situation takes an ugly turn as was witnessed a couple of days back.

Article 142: A sword of complete justice or unbridled power

rticle 142 of the Indian Constitution grants the Supreme Court extraordinary powers to pass any decree or order necessary for doing complete justice in any matter pending before it. This provision allows the apex court to override existing laws or fill legal gaps to comprehensively resolve a dispute. It can be used to issue directions, enforce decrees, compel the production of documents, or even punish for contempt. A recent empirical study by IIM Ahmedabad reveals that between 1950 and 2023, the Court referenced Article 142 or the phrase "complete justice" in 1,579 cases, predominantly civil cases. Notably, the Court explicitly invoked its Article 142 powers in 791 cases.

This power has been invoked in a variety of significant cases throughout Indian history.

Landmark Cases:

Shah Bano Case (Mohd. Ahmed Khan v. Shah Bano Begum, 1985): The court used Article 142 to grant maintenance to a divorced Muslim woman under Section 125 of the Criminal Procedure Code, leading to a national debate on Muslim personal law and secularism.

Bhopal Gas Tragedy Cases (Union Carbide Corporation v. Union of India, 1991): The Supreme Court invoked Article 142 to direct Union Carbide to provide compensation to the victims of the Bhopal Gas Tragedy, even going beyond existing legal provisions to ensure a fair outcome.

Recognition of Irretrievable Breakdown of Marriage: While not explicitly a new law, the Supreme Court has increasingly used Article 142 to grant divorce based on the irretrievable breakdown of marriage, even when it's not a ground explicitly recognised under existing personal laws, to do complete justice to the parties involved.

In Shilpa Sailesh v Varun Sreenivasan (2023): The Supreme Court held that it can directly grant divorce on the ground of "irretrievable breakdown of marriage" under Article 142, even if the other spouse opposes it. This judgment paved the way for a no-fault divorce jurisprudence, despite the ground not existing under personal laws in India.

Chandigarh Mayoral Election Case (2024): The Supreme Court invoked Article 142 to overturn the results of the Chandigarh mayoral election due to evidence of tampering and declared the rightful

Dalit Youth Admission to IIT Dhanbad (2024): The Supreme Court used Article 142 to ensure the admission of a Dalit youth to IIT Dhanbad after he missed the fee deadline due to circumstances beyond his control, emphasising the need for complete justice even when procedural rules are involved.

Addressing Systemic Issues and Formulating Guidelines:

Vishaka Guidelines (Vishaka v. State of Rajasthan, 1997): In the absence of specific legislation, the Supreme Court used Article 142 to lay down comprehensive guidelines to protect women from sexual harassment at the workplace. These guidelines were considered law until Parliament enacted the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.

Cleaning of Taj Mahal (M.C. Mehta v. Union of India, various orders): The Court has continuously used Article 142 to issue directions to protect the Taj Mahal from pollution, including orders related to industrial emissions and vehicular traffic.

BCCI Reforms (Board of Control for Cricket in India case, 2016): The Supreme Court invoked Article 142 to implement significant reforms in the administration of the Board of Control for Cricket in India (BCCI) to ensure transparency and accountability in cricket governance.

Liquor Ban on Highways (2017): The Supreme Court, using its powers under Article 142, ordered a ban on the sale of liquor within a specified distance of national and state highways to reduce drink-driving and road accidents.

Intervening in Political **Constitutional Matters:**

In Prem Chand Garg 1962, the court had been called upon to examine whether the provision enabled it to pass rules that would restrict the scope of Article 32. A five-judge bench had answered in the negative. Speaking for the majority, Justice Gajendragadkar wrote that an order passed to secure complete justice "must not only be consistent with the fundamental rights guaranteed by the Constitution, but cannot even be inconsistent with the substantive provisions of the relevant

In Vinay Chandra Mishra (1995), a three-judge bench later held that the Prem Chand Garg. The precedent was no longer "good law". The bench clarified that Article 142, being a constitutional power, cannot be restricted or conditioned by statutory provisions.

S.R. Bommai v. Union of India (1994): While the main judgment dealt with Article 356 (President's rule), the invocation of Article 142 allowed the Supreme Court to order floor tests in state assemblies to determine the majority, contributing to the resolution of political crises.

Complete Justice": The phrase "complete justice" is interpreted broadly, allowing the Supreme Court flexibility to tailor its orders to the specific facts and circumstances of a case.

These above-mentioned cases demonstrate the diverse ways in which the Supreme Court has utilised Article 142 to address unique situations, protect fundamental rights, fill legal gaps, and ensure that the ends of justice are met. It remains

a powerful and often debated tool in the Indian judicial landscape

Limitations: While the powers under Article 142 are wide, the Supreme Court has also recognised certain limitations. For instance, it cannot pass orders that violate fundamental rights or substantive statutory provisions. The power is meant to supplement, not supplant, existing

This provision has been invoked in a recent direction by the Supreme Court concerning bills passed by the Tamil Nadu State Legislature and awaiting the Governor's assent.

Background of the Issue:

The Tamil Nadu government had approached the Supreme Court alleging that the Governor was unduly delaying assent to several bills passed by the State Assembly. Some of these bills had been pending for a significant period, leading to a situation where the legislative will of the state was being seemingly obstructed. The Governor had also reserved some of the bills for the consideration of the

Exercising its powers under Article 142, the Supreme Court delivered a significant judgment on April 8, 2025. The Court held that the Governor's action of indefinitely reserving 10 bills for the President's assent was unconstitutional. More significantly, to ensure "complete justice," the Supreme Court deemed these bills as having been passed into law from the date they were re-presented to the Governor by the Assembly. This is an unprecedented step where the Supreme Court directly gave effect to state laws without the Governor's or President's assent.

Furthermore, the Supreme Court laid down specific timelines for Governors to

*One month to act on bills if reserving for the President or withholding assent with the aid and advice of the Council of

*Three months if doing so without such

* One month if the bill is resent after reconsideration by the Assembly.

* The Court also specified a threemonth timeline for the President to decide on bills reserved by the Governor.

The Supreme Court clarified that a Governor is a nominal head bound by the advice of the elected Council of Ministers and does not have the authority to indefinitely delay or act as a parallel executive. The concept of "absolute veto" or "pocket veto" does not exist in the Indian constitutional scheme. Once a bill is re-passed by the Assembly without substantive changes, the Governor is constitutionally obligated to give assent. Reserving such a bill for the President is deemed impermissible.

Article 142 vis-à-vis the Direction to the President:

While the Supreme Court directly

deemed some bills as passed using Article 142, its direction concerning bills reserved for the President sets a timeline of three months for the President to make a decision. This implicitly directs the President to consider and decide on the pending Tamil Nadu bills within this timeframe.

In summary, the Supreme Court's invocation of Article 142 in the context of the Tamil Nadu bills has two key aspects related to the President:

* Directly enacting laws: By deeming the bills passed, the Supreme Court effectively bypassed the need for Presidential assent for those specific bills that were initially reserved by the Governor after being re-passed by the Assembly.

* Setting a timeline: The Court has directed the President to decide on bills reserved by the Governor within a period of three months, thereby introducing a time-bound element to the President's consideration of state legislation.

Judicial Overreach Debate: The Supreme Court's intervention, particularly the setting of a timeline for the President, has sparked some debate regarding the separation of powers. Some argue that it curtails the President's constitutional discretion. However, the court's rationale is rooted in ensuring the smooth functioning of the democratic process and preventing undue delays that could render the legislative will of a state ineffective. The court has also stated that if the President withholds assent after the Governor has reserved a bill, the State Government has the right to challenge this action in the Supreme Court. The frequent use of Article 142 sometimes sparks debates about judicial overreach, with concerns raised about the judiciary potentially encroaching upon the domains of the legislature and the executive.

The boundary between restraint and overreach could be blurry, and an assessment of which side the Court lands is often clouded by the analyser's own understanding of the social and political imperatives. But as long as there are intersections between law and public life, there will be a place for the Court's discretionary power under Article 142. And as long as the rule of law prevails, there will be calls to use it sparingly, at each time upholding the constitutional principles and respecting the separation of powers.

This situation arising in the Tamil Nadu bills case highlights the Supreme Court's role as the guardian of the Constitution and its willingness to use its extraordinary powers under Article 142 to ensure that constitutional processes are followed and that complete justice is done in the relationship between the states and the





Coaching Centre in Srinagar Exposed for 'Faking Student's Score' Allegedly to Attract Admissions QR Code Reveals Truth Behind Fabricated 99.84 Percentile Claim

Srinagar, Apr 21,: In a shocking revelation, a coaching centre in Srinagar has been caught red-handed for misleading the public by falsely claiming that one of its students secured an extraordinary 99.84 percentile in the JE (Joint Entrance) examination, whereas her actual percentile was only 73.2.

A Kashmir News Trust (KNT) investigation found that 'SKIE Classes,' the coaching centre in question, had circulated a tampered PDF version of the student's scorecard on social media through its affiliated network of Facebook influencers. The doctored score sheet, which showed a significantly inflated percentile, was aggressively pushed online, earning the centre widespread publicity. However, the scam unraveled when techsavvy users scanned the QR code embedded in the PDF, which revealed the student's authentic percentile of 73.2—well below the 94 percentile cut-off required for the JE qualification.Education experts have strongly condemned the fraudulent act, terming it a serious breach of trust. "This appears to be a calculated move aimed at luring fresh admissions, considering it's currently the peak

season for enrollments," an education sector

analyst told KNT. "Editing a government-



issued document is a serious offense. The student could not have done it alone-clearly, the centre orchestrated the entire thing."The student, whose identity is being withheld for privacy reasons, was reportedly presented to social media content creators under dubious circumstances-either by coercion or manipulation. These Facebook hawkers filmed and circulated videos celebrating her so-called 'historic achievement,' further fueling the deception.

Ironically, the centre described the fabricated percentile as a "historic moment," exploiting both the innocence of the student and the trust of the public. "A student who herself hasn't qualified was showcased as a topper," said the education expert, adding that such conduct highlights how low some

coaching institutes can stoop for profit. Observers also criticized certain media outlets for broadcasting the fake achievement without verification, allegedly in return for monetary favors. "This is not just a case of one student's score being faked—it's a glaring example of how educational ethics are being trampled for quick financial gains," said a parent who had considered enrolling their child at SKIE Classes. Authorities have been urged to take strict action against the coaching institute, not only for document tampering but also for misleading the public and exploiting the student. "Let this serve as a wake-up call-KNT

Kashmir Transporters Await Over Rs 200 Crore Payment for Shri Amarnath Yatra Duty, **Appeal to Authorities for Immediate Intervention**

Srinagar, Apr 21,: Transporters from Kashmir Valley who had deployed thousands of vehicles for security purposes during the 2024 Shri Amarnath Yatra have appealed to the authorities to clear their long-pending payments, claiming they are under severe financial distress.

According to the transporters, dues amounting to over Rs 200 crore remain unpaid despite assurances that payments would be cleared within 15 days of the Yatra's conclusion. "It has been more than eight months, and not a single rupee has been $released," one of the {\tt aggrieved} transporters$ said. The vehicles were provided through the Regional Transport Office (RTO) Kashmir for deployment during the pilgrimage and were also used during the Assembly election period. However, the transporters say they are now being forced to run from pillar to post to claim their rightful dues. "We procured our vehicles on loans and are unable to pay EMIs to banks. Our vehicles risk being seized, and we can't even afford school fees for our children," another transporter lamented.

With the 2025 Yatra set to begin in June, transporters said it is unjust that they may be asked to prepare for a fresh round of deployment when the previous year's dues are still unsettled. They have made a direct appeal to the Home Department to intervene and ensure the immediate release of their pending payments.

"This is not just about business. It's about our survival. We fulfilled our duties in good faith and now we are being left to suffer," they said. (CNS)

Israel conducts over 200 strikes in Gaza within days, kills Islamic Jihad member

JERUSALEM, APR 21 (UNI)

Israel's military said on Monday that it carried out more than 200 airstrikes across the Gaza Strip over the past three days, killing a member of the Islamic Jihad

The military said the strikes targeted militant infrastructure, militant cells, rocket launch and sniper positions, weapons depots and command centers.

It identified the killed fighter as Ahmad Mansour, who it said participated in the Hamas-led surprise attack on Israel on Oct. 7, 2023, and later directed rocket fire during the ongoing war.

In Rafah's Shabura and Tel al-Sultan neighborhoods, Israeli troops dismantled "terrorist infrastructure" and uncovered a cache of grenades, ammunition and other military gear.

Along the recently constructed Morag Corridor, which bisects Rafah from Khan Younis and the rest of Gaza, troops located weapons, destroyed Hamas infrastructure and killed several militants, the mili-

In northern Gaza, soldiers launched an airstrike on a building containing what was described as underground infrastructure and detected multiple militants. The army also reported dismantling Hamas sniper posts that had threatened its ground forces.

At least eight people were killed in Israeli strikes on Monday and dozens wounded, the Palestinian news agency WAFA reported.

Jharkhand encounter: Shah hails forces

"Today security forces achieved another significant success in the ongoing operation to uproot Naxalism. In an encounter at Lugu Hills in Bokaro, Jharkhand, 8 Maoists were neutralised, including a top-level naxal leader, Vivek, who carried a reward of Rs 1 crore, and two other notorious Naxalites".

"The operation is being continued. Applaud our security forces," Shah added.

Eight Maoists were killed in an encounter with police in Jharkhand's Bokaro district on Monday. The security forces recovered several sophisticated weapons after the encounter.

Six killed as car collides with tree in UP

Six persons were killed and two injured when a car collided with a tree in Nebua Naurangia area of Kushinagar district here in Uttar Pradesh, police sources said here on Monday.

Police sources said that the wedding procession of Vikas, a resident of West Tola of Narayanpur Charaghan under Ramkola police station, had gone to Devgaon of Nebua Naurangia.

"The incident took place late on Sunday night when one of the car in the wedding procession lost control and collided with a tree near Shukla Bhujauli on Khadda-Padrauna road," they said.

Police sources said that hearing the sound, people and police reached the spot and started a rescue operation. "The bodies and injured people trapped in the car were taken out by cutting it with the help of a gas cutter and hammer," they

Police sources said that three persons died on the spot. "The injured were taken to the district hospital in serious condition where three more died during treatment. Two injured have been referred to Medical College Gorakhpur," they said.

Superintendent of Police (SP) Santosh Kumar Mishra said that six people have died in the road accident. "Two sustained serious injuries and have been referred from the district hospital to Gorakhpur Medical College," he said.

He said that five of the deceased have been identified as car driver Om Prakash Madheshiya, Harendra Madheshiya, Ranjit Madheshiya, Mukesh and Bhim Yadav. "The injured include Raj Kishore and Bajrangi," he said.



Extreme heat may raise risk of schizophrenia, depression: Study

NEW DELHI

Rising temperatures may not only affect physical health, but could also increase the burden of mental and behavioural disorders (MBD) like schizophrenia and depression by almost 50 per cent by 2050, according to a new study.

The research led by the University of Adelaide highlights the urgent need to act now to protect mental health as the climate warms.

Published in the journal Nature Climate Change, the study shows that high temperatures contributed to an annual loss of 8,458 disability-adjusted life vears (DALYs), representing 1.8 per cent of the total MBD burden in Australia.

Cancer risk from CT scan radiation at par with alcohol and obesity: Study

Repeated exposure to unnecessary computed tomography (CT) scans raises the risk of cancers as with alcohol consumption and obesity, according to a new study.

The study, led by researchers from the University of California-San Francisco (UCSF), showed that CT scan radiation accounts for 5 per cent of all cancers annually.

Chronic pain may raise risk of depression by 4x: Study

NEW DELHI

People suffering from chronic pain -- or pain that lasts at least three months -- may be up to four times more likely to experience depression, according to a study.

Almost 30 per cent of people worldwide suffer from a chronic pain condition such as low back pain and migraines, and one in three of these patients also report co-existing pain conditions.

The study published in the journal Science Advances shows that having chronic pain in multiple parts of the body was linked to a greater risk pain at a single site.

"Pain isn't only physical," said Dustin Scheinost, Associate Professor of imaging at Yale School of Medicine (YSM).

However, for one in three people with epilepsy (around 20 million individuals worldwide), current antiseizure medications are ineffective.
