SRINAGAR, APR 24 The light rainfall lashed the parts of Kashmir on Thursday while the weatherman predicted the possibility of a brief spell of light rain and thundershowers for the next two days.

According to the news agency—, Jammu and Kashmir's deficit rainfall has reduced further after the recent heavy wet spell.

The data prepared by the local Meteorological department reveals that the present



deficit rainfall in I&K from March 01, 2025 to April 23, 2025 has reduced to 32 per cent with Srinagar, the summer capital of the region, recording an average rainfall.

Against the normal precipitation of 231 mm, Jammu

and Kashmir has recorded a rainfall of 156.2 mm in the last 54 days, the data revealed.

Besides Srinagar, the other stations including Bandipora, Baramulla, Ganderbal, Pulwama, Kupwara and Ramban have recorded an average rainfall during the period.

However, Anantnag, Budgam, Doda, Kishtwar, Kulgam, Poonch, Shopian and Udhampur have recorded deficit rainfall upto 59 per cent during the period while Jammu, Kathua, Rajouri, Reasi and

SRINAGAR, APR 24: Amidst the shadow of recent tragedy at Pahalgam, which claimed 26 lives and left several others injured, hope and resilience are still echoing at world's famous ski-resort—Gulmarg as tourists continue to find warmth, safety and solidarity.

Tourists, currently in Gulmarg while speaking with the news agency—, said that they feel secure and supported, while many urged fellow travellers not to give in to fear.

'Yes, the day of the incident was very frightening, but now there is nothing to worry about. Locals and security agencies are cooperating very well and we feel absolutely safe here," said Rupali, a tourist from Mumbai.

Echoing similar sentiments, Jagnesh Mishra, another visitor, appealed to the travellers not to cancel their bookings. He said the Kashmiri people are incredibly supportive—from drivers to hoteliers, everyone has been welcoming.

Separately, External Affair Minister S Jaishankar and Home Minister met President Droupadi Murmu and briefed her about the steps taken.

The envoys of the G20 nations and other nations were briefed at South Block.

Foreign Secretary Vikram Misri also told them about India's policy of "zero tolerance" against terrorism.

The briefing came as Prime Minister Narendra Modi earlier in the day warned of stern action against the terrorists responsible for the killing of tourists at Pahalgam, and said they would be identified, pursued and punished.

Speaking at a function in Bihar's Madhubani district, Prime Minister Modi said, "India will identify, track and punish every terrorist, their handlers and their backers. We (India) will pursue them to the ends of the earth. They will be punished beyond their imagina-

"It's high time to take action against terrorism," PM Modi said, and described the Pahalgam attack as an attack on the whole nation, and said the nation will give the perpetrators a befitting reply.

The meeting with the envoys comes as India announced the downgrading of ties with Pakistan, including suspension of the Indus Water Treaty of 1960, shutting down of the Attari land-transit post, expulsion of Pakistani military attaches and its decision not to issue any more visas to Pakistanis and those who are in India were told to leave by April 27.

Modi said, adding that those involved in the act, would be identified, tracked and punished. "No one would be spared", he warned.

"Those involved in the attack would be chased till end of the earth," he said.

At least 27 tourists from across the country and a local died in a dastardly attack by terrorists in the picturesque tourist destination of J&K's Pahalgam on April 22, drawing worldwide condemnation and anger in the country.

While addressing a public meeting in Bihar's Madhubani, the Prime Minister said the entire country was united and was deeply disturbed by the gruesome act of

The PM said people from different parts of India were in Pahalgam when they were attacked by terrorists. Those who lost their lives were from various states and spoke different languages, he said, adding the dead also included one person from Bihar.

The PM thanked all world leaders and people of their countries who stood with India in condemning the Pahalgam terror attack. Those injured in terror attack were being given the best medical treatment to ensure their early recovery, he added.

The public meeting addressed by the Prime Minister was his first after the Pahalgam terror attack.

A local shopkeeper expressed grief, saying, "We joined the protest to send a message that we, as Kashmiris, reject such bloodshed. Tourists are our guests, and we feel shattered by what happened in Pahalgam."

Similar scenes unfolded in other areas of the city. The Bharatiya Janata Party (BJP) held

a "Shradhanjali Sabha" to honour the victims, during which party leaders observed a moment of silence and lit candles in memory of those who lost their lives.

A local resident said, "We want to make it clear that the people of Kashmir have nothing to do with this inhuman act. The terrorists aim to disrupt our unity, but today, Kashmiris have shown the world that we stand for peace."

The Employees Joint Action Committee (EJAC) also staged a protest at Press Enclave, condemning the attack and appealing to the government to ensure the safety of Kashmiris living in other states, where they face harassment and threats following such incidents.

Employees from minority communities participated in the protests, demanding justice and security for everyone. One protester holding candles and banners said, "This is not just about Kashmir or tourists; it's about humanity. The attackers must be brought to iustice.'

Protesters chanted slogans such as "Kashmir se aayi ek awaaz – Hindu Muslim Bhai Bhai" (A voice from Kashmir - Hindus and Muslims are brothers) and "Tourist ka Qatle-Aam Band Karo" (Stop the massacre of tourists), echoing their condemnation and calls for peace.

Security forces were deployed in large numbers at both Lal Chowk and Press Enclave to ensure that the protests remained peace-

Pahalgam left a deep scar, it has also united Kashmiris and tourists alike in collective grief and resilience, even as the Valley, often painted with narratives of fear, continues to reveal its true colours of hospitality, unity and undeterred hope.

The atmosphere in Gulmarg is calm, with enhanced security presence and visible efforts by locals to make visitors feel comfortable. "We are overwhelmed with the love and safety we have felt here. Those who attacked wanted to disturb peace, but it won't work. People here are treating us like their own," said another tourist, moved by the solidarity shown by the locals.

Similarly, a tourist from Karnataka, who expressed grief over the attack but at the same time stood firm in his decision to continue the visit, saying that the attack at Pahalgam was painful. "We are sorry for the lives

"We hope the government works to ensure such incidents don't repeat, but we never felt like leaving the Valley out of fear. People here stood with us at every step," he said, adding that they have been to Kashmir with a dream because it's a paradise on earth.

Earlier, a wave of concern gripped Kashmir's tourism industry post-Pahalgam terror attack, leading to cancellations and fear among incoming tourists, however, the tourists here in valley reassure the world of their safety and locals extending their unwavering warmth-

warmth that Kashmir is known for.

Official data accessed by the news agency— Kashmir News Observer (KNO), revealed that over 15,000 tourists availed the Gondola ride in the past 48 hours including 7,299 on Wednesday and 7,616 on Thursday.

"10,398 tourists took the Gondola Phase-I ride while 4,517 went up through Phase-II," the data revealed.

Meanwhile, the tourists, while praising the region's safety, hospitality and the proactive support from both locals and authorities, said that the incident at Pahalgam was indeed unfortunate, but what they have seen on the ground is completely different from what some media reports suggest.

As a gesture of goodwill, tourists at the Gondola base station were served traditional Kashmiri Kahwa, which many described as touching and thoughtful.

Officials say these efforts are a reflection of the Valley's determination to uphold its legacy of hospitality, even in times of sorrow.

Anita, a tourist from Delhi said that they have been treated with warmth, served Kahwa, and made to feel safe and welcome. "This is the Kashmir we always heard about – kind, welcoming and beautiful. The locals and security personnel have been outstanding," she said. "We never felt any sense of fear

or threat," another tourist said. Managing Director of Jammu and Kashmir Cable Car Corporation, Syed Qamar Sajjad, acknowledged the spirit of the visiting tourists. "We are grateful they haven't lost faith. Time to say goodbye to Indus **Water Treaty**

Pollowing the April 22 (Tuesday) terror attack at Baisaran-Pahalgam that left 25 tourists and a local dead, the Government of India has decided to suspend the implementation of the Indus Water Treaty. The Indus Water Treaty was signed by governments of India and Pakistan way back in 1960. The Treaty gives control over the waters of rivers like Beas, Ravi and Sutlej to India while control over the waters of rivers like Indus, Chenab and Jhelum was given to Pakistan.

For the past six and half decades the treaty has seen some ups and downs but it is probably for the first time that New Delhi has decided to suspend the same. The Government of India has accused Pakistan of perpetrating the Baisaran-Pahalgam attack and New Delhi took many steps in retaliation including suspension of the Indus Water Treaty. Although the treaty was signed by New Delhi and Islamabad the biggest sufferer has been Jammu & Kashmir and its people.

Since Pakistan has control over water of rivers like Indus, Chenab and Jhelum the power generation has not been done up to the expected level for the past six and half decades. Due to this reason the people of Jammu & Kashmir especially, those living in Kashmir have been suffering on the energy front. For ages together the people at helm have been claiming that Jammu & Kashmir has a potential of generating 20,000 megawatts of electricity but no headway has been made in this regard.

One of the reasons responsible for such a thing is the implementation of the Indus Water Treaty. As the running water of rivers like Indus, Chenab and Jhelum could not be utilized by India the generation of power could not materialize with the people of Jammu & Kashmir being the ultimate sufferers. The successive governments of Jammu & Kashmir failed to project their case with regards to the Indus Water Treaty and made their people suffer for no fault of theirs.

Since the Government of India has decided to suspend the Indus Water Treaty the time has come to break the treaty once for all. Once the treaty is dumped in the dustbin the people of Jammu & Kashmir would heave a sigh of relief. Following this the power generation would receive a fillip in the union territory and the dream of generating 20,000 megawatts of electricity would become a reality. Once this is done people of Kashmir would face less power cuts in general more so during winter.

Dark side of climate research: How billions in green funds fail the planet

ince climate change is real and climate research is urgent, there is a darker reality that cannot be ignored. The climate crisis has turned into a big-money industry that focuses more on appearances than real results. Leaders across the world frequently declare climate emergencies. Trillions are being pledged every year for adaptation and mitigation. Projects are approved in international summits, glossy reports are released with theatrical flair, and consultants fly from one sustainability conference to another. But the grim metrics continue unabated – carbon emissions rise, ice caps melt, and heatwaves grow more frequent and deadly. The promises grow louder while the planet gets hotter.

What has emerged is not just inefficiency – it is profiteering under the pretext of planetary salvation. Climate change has been commodified, repackaged as a billion-dollar business opportunity. At the heart of this system is an unholy nexus of bureaucrats, researchers, and policy brokers who monetise the crisis rather than solve it. Research projects that claim to "build resilience" or "develop frameworks for green futures" are routinely funded, with little or no field validation. And in most cases. what exists are verbose documents, animated presentations, and a trail of unspent or misused money.

Consider the Green Climate Fund (GCF), launched to support vulnerable countries in confronting climate change. Despite its noble intention, several funded projects have shown no measurable results on the ground. For example, in Senegal, a multi-million-dollar project aimed at coastal resilience faced criticism from civil society organisations for failing to deliver basic safeguards or infrastructure improvements. In Peru, allegations emerged that a GCF-funded project was benefiting private interests, bypassing local stakeholders it claimed to support.

India, too, is no stranger to such systemic rot. The Compensatory Afforestation Fund (CAMPA), created to restore forests cleared for development, has repeatedly been misused. In several states, instead of planting trees or supporting forest communities, CAMPA funds were spent on administrative expenses like buying smartphones, laptops, and furniture. In Odisha, government auditors found that crores were spent on non-forestry purposes, raising serious questions about transparency and impact. The same pattern played out in Madhya Pradesh and Uttarakhand, where fund diversion became



routine, and actual afforestation was poorly monitored or non-existent.

Jammu & Kashmir, a region highly vulnerable to climate extremes, has witnessed similar failures. A performance audit by the Comptroller and Auditor General revealed that nearly 25% of funds meant for disaster risk reduction were siphoned off to projects with no link to mitigation ranging from construction of roads to unauthorised purchases. In several cases, documents listed climate training programs and awareness workshops that were either never conducted or grossly inflated in scope. The infamous Roshni land scam, although framed around economic upliftment, also touched the environment sector - land meant for forests and conservation was encroached and sold off to elites under the guise of "develop-

Beyond India, in Uganda, climate funds disbursed through NGOs were found to be embezzled using fake receipts and ghost employees. A forensic audit found no trace of several activities that had allegedly been completed. In the Philippines, the government's "Greening Program" claimed to plant over a billion trees. Later audits revealed that nearly 88% of those trees were either dead or never planted to begin with.

What is worse is how this industry shields itself. The climate expert class consultants, NGOs, international advisors – thrive in ambiguity. They use polished jargon like "resilience plans", "adaptability", "coping mechanisms", "mitigation measures",

"sustainability", and "partnerships" to sound important and avoid clear answers. Peer-reviewed publications and conferences validate each other in an endless echo chamber, while the actual beneficiaries - communities living through floods, droughts, and heat – see no change. Paper-based success replaces physical impact. No one verifies whether claimed interventions ever happened. If you ask too many questions, you are labelled anti-science.

The media, unfortunately, has often served as an amplifier for these empty claims. Press releases are printed uncritically. Sensational headlines about breakthrough innovations circulate widely, only to be forgotten when those breakthroughs vanish into bureaucratic black holes. Investigative journalism on climate spending is rare because access to documents is limited, and criticism is branded as obstructionist. Yet, silence is complicity.

This systemic failure is not just about climate - it reflects how institutions worldwide function today. Governments treat sustainability goals like PR campaigns. Politicians invoke net-zero pledges while approving new coal and oil extraction. Large-scale renewable projects often displace indigenous communities and forests in the name of clean energy. Global climate talks promise justice, while elite consultants benefit from travel, contracts, and visibility. It is hypocrisy draped in the language of sustainability.

Even the world's most prestigious

scientific body - the IPCC - has not been immune to criticism. Leading researchers have highlighted the misuse of emission scenarios like RCP 8.5 to justify extreme projections, fuelling panic, poor policy prioritisation, and misaligned funding. Instead of serving as a neutral advisory platform, climate science has become intertwined with political narrative

The truth is, we are facing two crises. One is the ecological emergency that threatens life on Earth. The other is an accountability crisis - an industrial-scale grift exploiting fear, urgency, and public trust. Until we distinguish real climate action from performative metrics, we will keep funding the same problems we claim to solve.

This is a wake-up call – not against science or policy – but against silence. Journalists must dig deeper. Policymakers must mandate audits and demand field verification. Scientists must be willing to challenge flawed data and resist institutional capture. And citizens must demand outcomes, not just narratives.

The climate fight must be real, not rhetorical. The planet does not need another summit. It needs the truth.

Because the environment deserves better than bureaucratic theatre. And journalism, if it must remain relevant, must investigate – not just echo.

The Decline Of Teacher's Diaries In J&K Schools

teacher's diary is a research document, a collection of lesson plans and resources designed to support teachers in implementing the principles of NEP 2020. It is not a PDF file but an on-the-spot, situation-based tool catering to CBE (Competency-Based Education) and student-centric learning.

A teacher's diary should document a teacher's learning journey, student-centric learning, and continuous professional development. A teacher's diary is a personal teaching scrapbook. A teacher's diary is a flexible, free-spirited space where we, as educators, can jot down our feelings too-what happened in the class, how an excellent student is maintaining progress, improving, how a poor student is improving, and so on.

A teacher's diary is not a structured planning tool but a composite one, covering almost everything in the classroom.

A few days ago, I observed a teacher friend of mine preparing a lesson plan in a hurry as he anticipated the visit of inspectors to my institute. What he did was ridiculous. He opened Google and started writing the answer to a question, presenting it as a lesson plan. The notebook where he wrote served as a teacher's diary. The inspectors checked the so-called diary, and my friend had a smile on his face, indicating as if he had succeeded in deceiving the officials.

A teacher's diary is a record of a teacher's daily activities, including lesson planning, classroom observations, students' progress, and reflection on teaching practices.

A teacher's diary is a tool used for planning, reflection, and tracking teaching activities.

As an academic monitor, I often get chances to observe the situation at the ground level. Our School Education Department is doing tremendous work, but we, as educators, do not come up to the expectations. The education policies regularly get destroyed due to our laziness at the ground level,



and it pains

Lately, my fellow educators in one of the reputed government schools in my vicinity asked me about a teacher's diary structure. When by chance, I turned over the leaves of the diaries they had prepared, I could find only questions and answers like a student's primary class notebook.

A teacher's diary is a personal assistant to an educator. It is a mirror, the reflection of which tells us how to decorate. A teacher's diary is like a spy cam for me, helping to have a very close look over classroom management. A teach-

er's diary is a tool for continuous improvement, reflection, and professional growth, ensuring teachers are equipped to implement the vision of the new education policy, NEP 2020. It creeps like a mouse but has a jaw like a lion.

It is the responsibility of resource persons at the zonal, district, and state levels to provide assistance to the educators in government schools of J&K to learn about this beautiful tool-the teacher's diary. But, unfortunately, most of the resource persons never visit schools and never provide on-thespot assistance to the teachers. In

the context of NEP 2020, they are supposed to be in the schools.

I was appointed as a general line teacher in 2007. I remember the teacher's diary prepared in those days. With the passage of time, we, as educators, trimmed the lesson plans and reduced them to almost nothing. The impact of the teacher's diary nowadays is like a king's falcon. The king trimmed the feathers of his most loved falcon, and the falcon couldn't fly.

Sometimes, a teacher starts jotting down many lesson plans in the diary-almost a couple of months' worth-in one hour when expecting inspection.

Here is a breakdown of what can be included in the teacher's diary aligned with NEP 2020:

Daily Plan:

- Note the date and specify the subject being taught.

- Outline what students are expected to learn (e.g., understanding the structure of a sen-

- Detail the specific activities and list the materials, books, or technology needed (e.g., picture cards, whiteboards, etc.).

- Follow this with an assessment-how you will gauge student understanding (e.g., a quick quiz).

- Record various assessments, including formative and summative, focusing on skills and competencies rather than just rote memo-

Student Observation:

(This part has almost been neglected by most educators.)

- Make brief notes on individual student behaviour-their progress, challenges, and strengths.

- Note the overall class engagement and any behavioural difficul-

- Identify areas where you need to improve. Be sincere. There is always room for improvement.

Parental Communication: - Record any parent interactions

and phone calls. - Share progress and any areas

of concern with parents. Lesson Review:

- Reflect on how the lesson went-what worked well and what could be improved.

The teacher's diary serves as a comprehensive record of the teacher's work. When maintained properly, the diary can be used for documentation and evaluation. A teacher's diary, as per NEP 2020, should align with:

- Holistic development: Ensuring lesson plans are engaging and relevant to each student's unique

- Continuous improvement: Allowing teachers to identify areas for growth.

Teacher's empowerment: Providing a platform for documentary work, sharing experiences, and engaging in professional development activities aligned with NEP

It is the responsibility of the resource persons at the zonal, district (DIET), and state levels (SCERT) to come out of their cosy rooms and help the teachers of government schools in J&K in these matters. They are meant for this. Provide special training to educators on a priority basis, exclusively meant for the "Teacher's Diary," as soon as possible.

Remembering My Grandmother 'Amma" - Syeda Sakina Gilani (1930-2009)

Then I reflect on the people who have shaped and influenced my early life, one person stands foremost in my heart and mind - Syeda Sakina Gilani, my late grandmother. Born in 1930 at 'Yarkand House', Malarata, Srinagar, she was the daughter of S. Syed Ahmad Gilani. He had left Srinagar to join his father, Syed Ghulam Mohammad Gilani, who was already settled in Yarkand (Central Asia) and successfully running a carpet business there. Besides being a leading businessman, Syed Ghulam Mohammad Gilani also held the position of political representative appointed by the British

imperial government in Yarkand. Sadly, my grandmother never saw her father in her lifetime, as he passed away in 1964 due to cardiac arrest in Murree (now Pakistan) and could not return to Srinagar. At a very young age, she was married to her cousin, Syed Abdul Rashid Gilani, the son of her elder maternal uncle, Maulana Syed Mohammad Yasin Shah Gilani in Khanqah Moulla, Srinagar.

Amma was a pass out of Punjab

University, Lahore, and belonged to the first generation of educated women in Kashmir. Despite having ample opportunities for employment, she chose to dedicate her life to her home and family, a decision she took with grace and conviction.

For me, writing articles is not just a hobby – it is a powerful medium to express my emotions and preserve cherished memories. My father, Syed Iftikhar Gilani (1950-2001), passed away suddenly due to cardiac arrest on 12th June, 2001, at the young age of 50. His passing left me and my two sisters, Yasmeen and Sabiyah, orphaned. However, our grandparents, Syed Abdul Rashid Gilani ('Abaji') and Sveda Sakina Gilani ('Amma'), never allowed us to feel the pain of that loss as orphans. They enveloped us and our grief-stricken mother, Shahida Chishti, in unconditional love and care - treating our mother not merely as a daughter-inlaw, but as a daughter.

They raised us in a disciplined, decent, and deeply religious environment, something for which I remain forever grateful. Amma was one of the most disciplined, educated, and Godfearing women I have ever known. The secret to her graceful and happy life lay in her unwavering honesty, truthfulness, and straightforwardness. This article is my humble tribute to her cherished memory.

Amma always maintained a positive and optimistic outlook, and her sincere commitment to helping others was a source of inspiration. She was a wonderful wife, a devoted mother, a loving grandmother, and above all, a kind and supportive mother-in-law. She constantly encouraged us to preserve her values with gratitude.

Her daily routine began before dawn with Tahajjud (pre-dawn prayers), followed by Fajr Namaz (dawn prayers). She would then devote herself to Zikr-o-Azkaar (remembrance of Allah), Tilawate-Qur'an (recitation of the Holy Qur'an), and reading of Aurad-e-Shareef, Kibrat Shareef, and Qaseedah Shareef. Even after these spiritual commitments, she never remained idle. She actively assisted my mother in household work, believing firmly that the teachings of the Holy Qur'an and the Hadith should not be confined to mere recitation but should be implemented practically in everyday life, fulfilling the true spirit of divine guidance.

When we were in our primary classes, she would personally teach us. Amma had a wonderful command over Urdu and spoke it with elegance. She instilled in us the values of hard work, honesty, self-discipline, and dedication, teaching us that success comes only through perseverance. She always encouraged us to stay focused and committed in our stud-

I still cherish fond memories of Amma's surprise visits to our study room – gentle reminders of her care and concern for our education. Those thoughtful gestures shaped our learning habits and commitment. Spiritually too, she left a lasting influence, often taking us to Dargah Shareef for Friday prayers. Through her, we developed deep reverence for the Auliya-e-Kiraam (saints of Islam) – a tradition we proudly continue by visiting various shrines even today.

Despite leading a simple life, Amma

found immense joy in her family, relatives, and neighbours. She taught us that true happiness lies in nurturing strong and loving bonds within one's family and community.

On 1st January 2009, at the age of 78, Amma passed away peacefully, leaving behind a legacy of wisdom, love, and discipline. Though she is no longer physically present, her memories, life lessons, and unwavering faith continue to guide me and my sisters, Yasmeen and Sabiyah.

The love of a grandmother is unique, and we consider ourselves blessed by Allah to have had such a caring, educated, and compassionate grandmother. She played an irreplaceable role in our childhood, and I fondly remember the warmth of her kitchen and the lovingly prepared dishes we shared.

Amma was not only our grandmother – she was our mentor, friend, and greatest inspiration. The deep and lasting bond we shared was rare and special, for she was truly an extraordinary woman with remarkable qualities.

I will always cherish her memory, holding a special place for her in my heart. This tribute to Amma, Syeda Sakina Gilani, would be incomplete without honoring her noble and pious soul. Her teachings and values will forever live on in our hearts and continue to shape our family's future.

May Allah grant her the highest place in Jannat-ul-Firdous. Aameen.

Srinagar, Apr 24: Following the decision of the Government of India (GoI) to downgrade diplomatic ties with Pakistan the Border Security Force (BSF) on Thursday said it has "scaled down" the retreat ceremony held at Attari, Hussainiwala and Sadki along the India-Pakistan border in Punjab in the wake of the Pahalgam terror attack.

In a statement to the news agency— Kashmir News Observer (KNO) a BSF spokesman said, "These steps reflect India's serious concern over crossborder hostilities. Peace and provo-

 $cation\,cannot\,coexist.\,As\,part\,of\,this$ calibrated decision the BSF is suspending the symbolic handshake of the Indian guard commander with the counterpart and the border gates will remain closed during the ceremony."

The spokesman said, "All other drills will continue and common people will be allowed to witness this daily flag-lowering ceremony."

Pertinently, twenty-six men, mostly tourists and including a Nepalese citizen, were shot dead by the terrorists at Baisaran meadow in Pahalgam earlier this week plunging the entire nation into mourning. In the aftermath of the attack India



has launched a diplomatic offensive against Pakistan and taken a number of counter-measures linking these attacks to the neighbouring country. The Cabinet Committee on Security (CCS), chaired by Prime Minister Narendra Modi on Wednesday decided to put the Indus Waters Treaty of 1960 in abeyance with immediate effect. The integrated checkpost at Attari was closed. Pakistani nationals who entered India through valid endorsements were asked to return through that route before May 1, 2025. Pakistani nationals will no longer be allowed to travel to India under the SAARC Visa Exemption Scheme (SVES). All previously issued

SVES visas are deemed cancelled. Pakistani nationals currently in India under SVES visas must leave the country within 48 hours.

The Defence, Military, Naval, and Air Advisors in the Pakistani High Commission in New Delhi have been declared persona non grata and have one week to leave India. India will also withdraw its corresponding Defence, Navy, and Air Advisors from its High Commission in Islamabad. These posts in both High Commissions stand annulled. The total strength of the High Commissions will be reduced from 55 to 30 by May 1–(KNO)






Scientists create novel method to identify healthy and cancerous cells

Researchers from Tokyo Metropolitan University in Japan on Saturday said they have found that the motion of unlabelled cells can be used to tell whether they are cancerous or healthy.

Paediatric thyroid cancer risk rises with early exposure to air, light pollution

NEW YORK

Early-life exposure to small particle air pollution and outdoor artificial light at night could increase the risk of paediatric thyroid cancer, a new study led by researchers at Yale University in the US has suggested.

The team found a "significant association" between exposure to ambient fine particulate matter air pollution (PM2.5) and outdoor artificial light at night (O-ALAN) and increased risk of papillary thyroid cancer in children and young adults up to 19 years old, according to the study published night is common, particuin Environmental Health Perspectives.

The exposures occurred during the perinatal stage of life, typically defined as the time from when pregnancy occurs up to a year after birth.

"These results are concerning, especially given
