JAMMU, APRIL 28: ,: Chief Minister Omar Abdullah today delivered an emotional and powerful address, expressing profound grief, condemning terrorism and calling for unity and resilience in wake of killing of 26 civilians in Pahalgam terror attack.

The Chief Minister was speaking during a special session of the Jammu and Kashmir Legislative Assembly convened after the tragic Pahalgam terrorist attack that claimed 26 innocent lives.

Beginning his speech, the Chief Minister reflected on the painful circumstances that brought the House together. "It is hard to believe that just a few days ago, we were engaged in vibrant debates in this very House - over the Budget and many other important matters. We had hoped that we would meet again in normal conditions. None of us could have imagined that we would be meeting in such tragic and painful circumstances," he said.

The Chief Minister expressed gratitude to the Lieutenant Governor for convening the special session and emphasized the significance of the Assembly to understand

## **Pahalgam Carnage Triggers Social Stigmatization** of Violence in Kashmir for the First Time: Sajad Lone

JAMMU, APRIL 28:, Peoples Conference chairman and MLA Handwara Sajad Gani Lone said the Pahalgam terror attack, which killed 25 tourists and a local, had sparked a historic awakening against violence in Kashmir, ending what he called the "social sanctity" that violence once held in the Valley.

"In the past 35 years, we have not witnessed an incident like the one that happened in Pahalgam. According to the news agency–Kashmir News Observer (KNO) correspondent, Lone stated in his speech, "Someone from outside came and martyred them on our land. They

were tourists who came to enjoy the beauty of Kashmir, who stayed in our hotels, and who travelled with our taxi drivers," Lone as per the KNO correspondent said while speaking during the special session of the Jammu and Kashmir Assembly here on Monday.

Calling it a watershed moment, Lone said that while Kashmir had witnessed bloodshed for decades, the aftermath of the Pahalgam attack was different. "It was not just a street, not a lane, not a city, not a village where people did not come out in anger and go against this violence. This has never happened in the last 78 years. This happened for the first time," he said.



He hailed the families of the victims for preventing an eruption of hatred.

"The fire that could have been lit, they [families of victims] put it out and created an atmosphere of love. In the whole of India, the face of that Kashmiri was seen - the Kashmiri who gave his life to save a tourist," Lone said, recalling accounts of locals carrying injured tourists on their shoulders for over an hour through jungles to get them medical help.

Expressing his deep gratitude, Lone added, "We should be thankful to their relatives. After such a big loss, they demonstrated humanity when others might have turned to anger."

pain of these 26 innocent lives lost, as much as this House does," he stated.

Reflecting on the personal losses among legislators themselves, the Chief Minister recalled the sacrifices of members like Shagun Parihar, Sakina Itoo and Sajad Lone, and the horrors of the October 1, 2001, Assembly attack. He asserted that perhaps no Assembly can understand this grief better than theirs.

On behalf of the House, the Chief Minister strongly condemned the terrorist attack and expressed solidarity with the victims' families. "This was not just an attack on people from one state – it was an attack on the very soul of India," he declared.

He highlighted that the victims hailed from across India, from Arunachal Pradesh to Gujarat, from Kerala to Jammu and Kashmir, symbolizing a national tragedy.

Omar Abdullah lamented that despite hopes that terrorism was a chapter of the past, the brutal attack marked the tragic return of terror involving death of so many civilians after 22 years. Remembering his own presence at the police control room to pay last respects, he spoke of the profound helplessness he felt facing the bereaved families. "What apology would ever suffice?" he asked.

The Chief Minister acknowledged that although security responsibilities no longer rested with the elected government, he, as Chief Minister and Minister of Tourism, bore responsibility for having invited the visitors and ensuring their safe return - a responsibility he felt he had failed to uphold.

Narrating the heart-wrenching words of a newly wed young woman who had lost her husband in the attack, the Chief Minister underscored the senselessness of the violence. "But who amongst us can ask for such violence? No one in this House or outside it, would ask for blood to be spilled ? No!" he stated emphatically.

Despite the deep wound inflicted by the attack, the Chief Minister identified a glimmer of hope: the spontaneous, widespread public condemnation of the attack across Jammu and Kashmir. From Kathua to Kupwara, ordinary citizens raised banners and placards reading "Not In My Name," distancing themselves from terrorism without any political prompting.

"This attack was not done for us — it was done against us," he stressed, adding that true and lasting peace would only be achieved when the people stand firmly with the forces of peace and governance.

He cited a significant moment of mourning at the Jamia Masjid in Srinagar, where a two-minute silence was observed after Friday prayers – an act that, he said, carried profound meaning for every Kashmiri.

The Chief Minister also narrated stirring examples of humanity shown by ordinary Kashmiris like a ponywala risking his life to save tourists, a humble fruit seller on Dal

the April 22 incident and lauded the people for "frustrating terror conspirators" who wished to divide the nation on communal lines.

"Though it took us 36 years to unite against terror, it also brought us on the same page with the nation. The conspiracy was also to divide us, but we made it clear that no conspiracy can divide us," he said.

"We should have full faith in our Prime Minister who is running a government which has a strong will and has demonstrated it time and again...

"We must be rest assured that that 26 lives snatched from us will be avenged. The person who had made India proud is not the one who can stay silent," the LoP said.

Sharma said the entire humanity has been shattered by this inhuman act and the whole country is in grief and shock.

He appreciated Chief Minister Omar Abdullah for his outreach in the aftermath of the attack and said the all-party meeting convened by him sent a strong message that "we are standing united in this hour of grief".

"A united voice in this difficult time is necessary to make these nefarious designs of terrorists unsuccessful," he said, adding no words can compensate for the loss of victim families but the House wants to convey to the nation that the people of Jammu and Kashmir are badly hurt by this incident and share their sympathies with all the victim families from across the country.

He said the 90 elected legislators have a responsibility to ensure that no evileye should harm the unity demonstrated by the people, irrespective of their religion.

Asking people to refrain from using language that can hit the morale of the security forces and the government, he said Pakistan fully understands that it can never win in a conventional war against India and is, therefore, plotting such conspiracies to disturb peace and incite polarisation. The PDP leader stressed that Kashmir was, for the first time in decades, mourning alongside the rest of India. "Whether it was Pulwama, the Mumbai attack, or Kargil – never during the 30 years of violence did Kashmiris and the rest of the country mourn together. But today, for the first time, Kashmir is mourning alongside the entire nation," Parra said.

Citing instances of solidarity across Kashmir, he said, "Whether you heard the voice of the Mirwaiz at the Jama Masjid - he supports this resolution; whether in Lal Chowk, where Mehbooba Mufti held the first protest - she supports this resolution. Omar Sahib [Abdullah] held an all-party meeting – the aim of that was to show that we stand with the nation."

Parra also acknowledged the remarks made by BJP leader and Leader of the Opposition Sunil Sharma. "Sunil Sharma Sahib said that the response of Kashmiris is being acknowledged across the country. Every nation faces trials. A nation's mettle is not tested in victory or joy. Every nation's testing times come during crises, and perhaps for this country, Pahalgam was a great test. Today, the entire country – India – was being tested, and the patience shown by Hindus across India needs to be acknowledged," Parra said.

He praised the restraint shown by communities across the country in the face of provocation. "The response of Kashmiri Muslims – they said, and because there were civilian casualties and the attack was not on armed forces but on ordinary bathing people - I would say, Sir, that perhaps a nation's real test is how it deals with a crisis. And during this crisis, the entire country behaved in a way that made us feel we were acting as a nation, trying to behave with patience so that those who carried out this attack – whose aim was to provoke riots, Hindu-Muslim tensions - could not succeed."

Parra reiterated his demand that those who lost their lives in the Pahalgam attack be recognized as martyrs and urged authorities to address the hardships faced by the local population. "I again request all honorable members that those who died in Pahalgam should be given the status of martyrs, and also, with regard to the hardships faced in Kashmir – as many people's homes were destroyed -- that should also be acknowledged that alienation increases due to such actions. When you talk about ending terrorism, you have killed terrorists for 30 years, but every time, every year, you still have to do it again. You kill a terrorist, you do not end terrorism. The only time when there is action against terrorism is this moment when people of Kashmir have rejected terrorism," Parra said–

"I have too much respect for the sanctity of these 26 lives to indulge in petty politics. I will not exploit their martyrdom to raise demands for statehood or any other political gain today," he declared.

He assured the Assembly that discussions around governance, rights, and aspirations would take place at an appropriate time, but today was a day solely for grief, solidarity and resolve.

Concluding his address, the Chief Minister called upon all Members to pass a unanimous resolution condemning the barbaric attack and expressing solidarity with the bereaved families.

The House later unanimously passed a resolution condemning the inhuman terror attack on tourists at Pahalgam.

Sheikh Khursheed, while paying homage to the victims, said that memorials for victims should be established in Pahalgam. He requested all the MLAs to contribute for this memorial out of their salaries.

Mehraj Malik also condemned the gruesome attack and said that we need to be united and not let just four persons disturb the social fabric of our country.

Tarigami also criticized some media houses for giving it a colour of Hindu-Muslim.

"We need to introspect from top to bottom to see the gap somewhere which led to the Pahalgam incident," he said.

Furthermore, the Kulgam legislator said that the real victims are people of Jammu and Kashmir, they should not be alienated. He added that the people need to be taken on board to fight against the terrorism and eliminate it.

He also said that though the session has been called, those who have the security apparatus in their hands should have been also called so that they could have been questioned over the incident.

Tarigami said that the security and safety of students from J&K presently studying outside stands the responsibility of every single individual. However, he said that "if we fail to do so, then the terrorists will succeed in their mission."

# Pahalgam Attack: Passenger traffic at Srinagr airport records sharp decline

Tour operators report mass booking cancellations; Authorities ramp up security at tourist hotspots

Srinagar, Apr 28 (: Passenger traffic at Srinagar International Airport has witnessed a steep decline following the recent terrorist attack in Pahalgam, Anantnag. According to data accessed by the news agency—Kashmir News Observer (KNO), the number of passengers travelling through Srinagar Airport fell noticeably over the past few days, beginning April 23, soon after the Pahalgam attack.

It says, on April 23, a total of 17,653 passengers travelled through the airport across 112 flights with 6,561 arrivals and 11,092 departures.

However, from the very next day, the numbers started dropping. On April 24, the airport handled 15,836 passengers on 118 flights including 4,456 arrivals and 11,380 departures.

The downward trend continued on April 25, with 14,041 passengers travelling on 100 scheduled flights, in addition to a few additional flights that carried minimal numbers—24 arrivals and 794 departures on four extra flights. Similarly, on April 26, Srinagar Airport witnessed 14,783



passengers travelling through 106 scheduled flights, with an additional three flights carrying 28 arriving and 351 departing passengers. Airport officials told KNO that while flight operations have remained largely unaffected in terms of the number of flights, the load factor (passenger occupancy) has fallen. "The fear triggered by the attack has led to a dip in tourist arrivals, affecting the overall air traffic," an official said. He said that the security situation continues to be monitored closely and that all flights are operating normally, but the immediate aftermath of the attack has definitely impacted air travel demand. Meanwhile, travel industry stakeholders, especially those associated with tourism, said they are worried about the declining footfall and its potential impact on Kashmir's tourism season.

"April to June is our prime season. Such incidents severely dent the confidence of tourists. The dip in air traffic is already reflecting this," said a travel operator in Srinagar, adding that most of the bookings have been cancelled.

Meanwhile, the authorities have assured enhanced security measures in and around tourist hotspots to ensure the safety of visitors.

Notably, the attack in Pahalgam claimed the lives of 26 people, mostly tourists and was widely condemned. Security has since been heightened across South Kashmir and other tourist areas—(KNO)

## Woman Dies After Setting Herself Ablaze Over Alleged Family Dispute in Hazratbal

Srinagar, Apr 28, : A woman lost her life after setting herself on fire following a family dispute in the Hazratbal area on the outskirts of Srinagar on Monday. According to officials, the woman, originally from Shalimar and married in Hazratbal, sustained critical burn injuries after dousing herself in kerosene. She was immediately shifted to JLNM Hospital Rainawari but succumbed to her injuries during treatment. Soon after the incident, SDPO Zakura, SHO Nigeen, and DO Hazratbal rushed to the scene to take stock of the situation.

A police official confirmed the woman's death, adding that she was a mother of two. Police have taken cognizance of the matter and further investigations are underway.

The petition has been moved by advocates from Jus Front Advocates & Solicitors, New Delhi, represented through arguing counsels Advocate J. M. The PIL raises grave concerns regarding the failure of state and central authorities to ensure adequate security for tourists in sensitive regions, despite prior intelligence warnings. The petition urges the Hon'ble Supreme Court to undertake a thorough investigation into these security failures and issue the following directions: Protection of Tourists-Recommend stringent security measures to safeguard tourists and hold authorities accountable for lapses.Compensation for Victims-Direct authorities to provide adequate compensation to victims' families and enforce existing Supreme Court judgments on yatra and tourist protection. Media Responsibility- Address concerns regarding certain press reports that may disrupt communal harmony, urging immediate judicial intervention to uphold unity and integrity. Student Safety-Establish safeguards for the students belonging to the UT of J&K who are studying outside the UT. Further, it seeks directions upon the Union Government to constitute a Special Investigation Team (SIT) to probe the attack and fix accountability in à time bound manner amongst other things.

# Wildlife Deptt Kashmir warns against sale/purchase/ possession of Scheduled birds Guilty to be handed-over imprisonment, fine punishments

SRINAGAR, APRIL 28: Wildlife Department Kashmir has warned against the sale, purchase, or possession of Scheduled birds, calling it a criminal offense under the Wild Life (Protection) Act, 1972. As per an official communication issued from the office of Wildlife Warden, Wetlands Division Kashmir, Srinagar it has been informed that any individual or bird vendor found engaging in such activities will be subject to legal action.

As per Section 51 of the Wild Life (Protection) Act, 1972, any person who contravenes the provisions of this Act shall be punishable with imprisonment for a term which may extend to seven years or with a fine up to Rs. 01 lakh, or both.

If the offense involves a bird specified in Schedule I, the punishment shall be not less than three years and may extend to seven years, along with a fine of at least Rs. 25000.

If the offense involves a bird specified in



Schedule II, the punishment shall extend up to three years, along with a fine of at least Rs. 25000.

It has come to the notice of Wildlife authorities that some of the Birds listed under Schedule I & Schedule II are being traded by the vendors or possessed for bird keeping which is strictly prohibited. Individuals who are currently in possession of any of the Scheduled birds are urged to surrender them voluntarily at the nearest wildlife facility to avoid legal consequences. The authorities will ensure proper rehabilitation and care of the surrendered species.

# What about this sort of terrorism?

In the aftermath of the Baisaran-Pahalgam terror attack that left 25 tourists and a civilian dead, all the stakeholders chipped in and did their best to facilitate the return of tourists to Srinagar and other places. People offered free food, free transport, free lodging and other logistical support to the tourists so as to give them confidence that the people of Kashmir are with them in the testing times of distress and trouble.

Since many tourists decided to cut short their Kashmir visit and return to native places one was expecting that the airlines would come to their rescue as well, but that was not to be. Instead of slashing the price of tickets for different destinations from Srinagar most of the private airlines operating their services resorted to unprecedented hikes in the same. # The Myth of conquest: Why Gaza will never be subdued by Israel

To conquer a place is to fundamentally subdue its population. This must be clearly differentiated from 'occupation', a specific legal term that governs the relationship between a foreign "occupying power" and the occupied nation under international law, particularly the Fourth Geneva Convention.

When Israeli forces were ultimately compelled to redeploy from the Gaza Strip in 2005, a direct consequence of the persistent resistance of the Palestinian population there, the United Nations resolutely insisted that the Gaza Strip remained an occupied territory under international law.

This position stood in stark contradiction to that of Israel, which conveniently produced its own legal texts that designated Gaza a 'hostile entity' - thus, not an occupied territory.

Let us try to understand what appears to be a confusing logic:

Israel proved incapable of sustaining its military occupation of Gaza, which began in June 1967. The paramount reason for Israel's eventual redeployment was the enduring Palestinian Resistance, which rendered it impossible for Israel to normalize its military occupation and, crucially, to make it profitable - unlike the illegal settlements of East Jerusalem and the West Bank.

Between 1967 and the early 1970s, when Israel began investing in building illegal settlement blocks in the Strip, the Israeli military under the command of Ariel Sharon relentlessly strove to suppress Palestinians. He employed extreme violence, mass destruction, and ethnic cleansing tactics to subdue the Strip.

Yet, at no juncture did he achieve his ultimate and comprehensive objectives of complete subjugation.

Subsequently, he invested in his infamous, but failed 'Five Fingers' plan. At the time the head of the Israeli army Southern Command which included Gaza - Sharon stubbornly believed that the only way to defeat the Gazans was by severing the contiguity of the Strip, thus hindering organized resistance.

In pursuing this aim, he sought to divide Gaza into so-called security zones where the main Israeli Jewish settlements would be built, fortified by massive military build up. This would be joined by Israeli military control of key routes and the blocking of most coastal access.

However, this plan never fully actualized, as creating these 'fingers' required that Palestinians on both sides of the 'security zones' would have to be pacified to some extent - a condition that reality on the ground



never delivered.

What did actualize was the building of isolated settlement blocks: the largest was in the southwest of the Gaza Strip, near the border with Egypt, known as the Gush Katif, followed by the northern settlements, and finally the central settlement of Netzarim.

Housing a few thousand settlers, and often requiring the presence of a far greater number of soldiers assigned to protect them, these socalled settlements were essentially fortified military towns. Due to the limited geography of Gaza (181 square miles or 365 square kilometers) and the stiff resistance, the settlements had limited space for expansion, thus remaining a costly colonial endeavor.

When the Israeli army emptied the last illegal settlement in Gaza in 2005, the soldiers snuck out of the Strip in the middle of the night. At their heels were thousands of Gazans who chased the soldiers until the last of them fled the dramatic scene.

That singular and powerful episode alone is more than sufficient to allow one to assert with unwavering certainty that Gaza was at no point truly conquered by Israel.

Though Israel withdrew its permanent military presence from the main population centers of the Strip, it continued to operate within socalled buffer zones, which were often significant incursions into Palestinian territory, far beyond the armistice line. It also imposed a hermetic siege against Gaza, which starkly explains why the majority of Gazans have never stepped a foot outside the Strip. Israel's control over airspace, territorial water, natural resources (mostly Mediterranean gas fields), and much more readily led the UN to its immediate conclusion: Gaza remains an occupied territory.

Unsurprisingly, Israel vehemently opposed this reality. Tel Aviv's true desire is absolute control over Gaza, coupled with the convenient and selfserving designation of the territory as perpetually hostile. This twisted logic would grant the Israeli military an endlessly exploitable pretext to initiate devastating wars against the already besieged and impoverished Strip whenever it deemed convenient.

This brutal and cynical practice is chillingly known within Israel's military lexicon as 'mowing the grass' - a dehumanizing euphemism for the periodic and deliberate degradation of the military capabilities of the Palestinian Resistance in an attempt to ensure that Gaza can never effectively challenge its Israeli jailors or break free from its open-air prison.

October 7, 2023, ended that myth, where Al-Aqsa Flood Operation challenged Israel's long-standing military doctrine. The so-called Gaza Envelope region, where the late Sharon's Southern Command is based, was entirely seized by the youth of Gaza, who organized under the harshest of economic and military circumstances, to, in a shocking turn of events, defeat Israel. While acknowledging the UN designation of Gaza as occupied territory, Palestinians understandably speak of and commemorate its 'liberation' in 2005. Their logic is clear: the Israeli military's redeployment to the border region was a direct consequence of their resistance.

Israel's current attempts to defeat the Palestinians in Gaza are failing for a fundamental reason rooted in history. When Israeli forces stealthily withdrew from the Strip two decades ago under the cover of night, Palestinian resistance fighters possessed rudimentary weaponry, closer to fireworks than effective military instruments. The landscape of resistance has fundamentally shifted since then.

This long-standing reality has been upended in recent months. All Israeli estimates suggest that tens of thousands of soldiers have been killed, wounded, or psychologically impaired since the start of the Gaza war. Since Israel failed to subdue the Gazans over the course of two relentless decades, it is not merely improbable, but an outright absurdity to expect that Israel will now succeed in subduing and conquering Gaza.

Israel itself is acutely aware of this inherent paradox, hence its immediate and brutal choice: the perpetration of a genocide, a horrific act intended to pave the way for the ethnic cleansing of the remaining survivors. The former has been executed with devastating efficiency, a stain on the conscience of a world that largely stood by in silence. The latter, however, remains an unachievable fantasy, predicated on the delusional notion that Gazans would willingly choose to abandon their ancestral homeland.

Gaza has never been conquered and never will be. Under the unyielding tenets of international law, it remains an occupied territory, regardless of any eventual withdrawal of Israeli forces to the border – a withdrawal that Netanyahu's destructive and futile war cannot indefinitely postpone. When this inevitable redeployment occurs, the relationship between Gaza and Israel will be irrevocably transformed, a powerful testament to the enduring resilience and indomitable spirit of the Palestinian people.

The place is 30 Kilometers away

The first sight that catches the attention is a mosque made of stones clearly indicating the locals are the ones who visit this place on regular basis. Millennia Civilization

Kashmir has been an integral part of India's civilizational history for millennia-home to great scholars, saints, and spiritual traditions. Misleading metaphors such as "Pakistan's jugular vein" or politicized terms like "Indian Illegally Occupied Jammu and Kashmir (IIOJK)" are rhetorical constructs lacking historical, legal, and ethical grounding. Geographically, controlling Kashmir would have given Pakistan military advantages.

**Identity Politics** Over decades, Pakistan built a national mythology around "Kashmir Banega Pakistan" ("Kashmir will become Pakistan") to fuel domestic nationalism.

**Global Diplomacy** 

Keeping Kashmir in dispute gave Pakistan leverage on the world stage especially the Muslim world. Pakistani claim isn't based on Kashmir's civilizational history, because if it were, they'd have to admit it's thoroughly Indian. Their claim is based on religious demographics and modern political ambitions, not on cultural or historical legitimacy.

Key Historical Moments Let's walk through (the author has literally walked through the valley and especially Pahalgam in the 1990s, the latest hot spot of Terror target of the innocent tourist Hindus) the key historical moments that show how Kashmir was naturally a part of India's civilizational and political fabric even before 1947:

Ancient Kashmir: Part of Indian Civilization

Kashmir is mentioned in ancient Hindu scriptures like the Mahabharata, the Puranas, and Buddhist texts.

The famous text Nilamata Purana describes Kashmir as the "Land of the Gods."

Medieval Kashmir: Flourishing with Indian Traditions

Kings like Lalitaditya Muktapida (8th century) ruled a powerful kingdom linked closely with the rest of India.

Even after the Islamic conquest in later centuries, Kashmir retained a distinct syncretic tradition (for example, Rishi-Sufi culture where Hindu and Muslim mystics respected each other deeply). Sikh and Dogra Rule (19th Centurv)

After the fall of the Mughal Empire, Kashmir came under Afghan rule (which was brutal and unpopular).

Then Sikhs under Maharaja Ranjit Singh took control in 1819, integrating Kashmir into the Sikh Empire – which was very much a part of greater Indian political life.

After Ranjit Singh's death, the British made a deal with Gulab Singh, a Dogra Rajput, through the Treaty of Amritsar (1846) - Kashmir officially became part of the princely state of Jammu and Kashmir under Dogra rule. General Zorawar Singh the Dogra General extended the territory into Tibet in December 1841 where he died fighting in the battle at Taklakot near Kailash Mansarovar.

The 1947 Moment: Accession to India

In 1947, British India was divided into India and Pakistan, and princely states were given the choice to join either.

The Maharaja of Kashmir, Hari Singh, wanted to stay independent initially. But when Pakistan sent tribal raiders (Pashtun militias backed by its army) into Kashmir in October 1947 to forcibly take it, Hari Singh formally signed the Instrument of Accession to India on October 26, 1947.

The Governor-General of India (Lord Mountbatten) accepted it, and Indian troops were airlifted to defend Kashmir.

The slogan 'Kashmir is Pakistan's Jugular Vein' was once used to forge a national identity in the wake of Pakistan's creation in 1947, during a time when the young nation was searching for a unifying theme a National Rallying Cry. Such expressions have so far served only to inflame tensions and obscure the region's true heritage. India's sovereignty over Jammu and Kashmir is both constitutional and civilizational. Pakistan needs to shift from rhetoric fake emotional slogans to respectful dialogue rooted in historical truth and mutual understanding and ditch the drama to face the real facts. Clinging to such slogans has not propelled the country forward. It is time for Pakistan to leave behind these outdated narratives and move ahead as a modern, forward-looking nation, built on principles of innovation, development, and global integration."

Kashmir therefore is rightly called "The Cradle of Indian Civilization" a Mother of Indian Spiritual, Intellectual, and linguistic traditions. It's not just geographically beautiful; it's also a jewel of Indian heritage.

SRINAGAR, APRIL 28: Jammu and Kashmir Lakes Conservation and Management Authority (LCMA) has initiated the process of demolishing all illegal structures constructed in the Rakhe-e-Arth resettlement colony.

Accordingly, an anti-encroachment drive was conducted today during which boundary walls and plinths of two structures, being constructed at Rakhe-e-Arth resettlement colony were demolished by the enforcement wing and engineers of the LCMA.

It is worth mentioning that the Rakhee-Arth resettlement colony has been established by the government for rehabilitation of Dal dwellers only. As on date



around 1806 plots have been allotted to such Dal dwellers, who had shifted from the lake and have been paid compensation for acquisition of their structures and land in the lake by the LCMA. However, it has been brought to the notice of LCMA that some notorious persons have illegally occupied some

plots on the basis of fake documents or have occupied the plots without having any authorisation from the LCMA. It has also been observed that some persons, who are actually residents of different districts of Kashmir are also residing in Rakhe-e-Arth resettlement colony, which as per LCMA needs immediate

attention.It is being clarified to all that the Rakhe-e-Arth resettlement colony has been established for Dal dwellers only and nobody other than Dal dwellers has any right to purchase the land there or use any means to stay in the colony. The LCMA warns all such individuals, who are befooling the general public and selling the plots on the basis of fake promises and fake documents, of dire consequences in future.

Meanwhile, anti encroachment drives shall continue, and all such plots and structures which have been raised on the basis of fake documents or without any valid authorisation will be raised to ground.

The LCMA has collected all the information and the process of cleaning has been set into motion.

## Lahaul-Spiti becomes India's first all-women administrative district AGENCIES

SHIMLA, APR 28 (UNI)

In a historic move, Lahaul-Spiti district of Himachal Pradesh, known for its challenging terrain and extreme weather, has become India's first allwomen administrative district.

This transformation comes with the recent posting of IAS officer Kiran Badana as Deputy Commissioner.

A firebrand officer, Badana's appointment marks a major milestone for the district where, interestingly, the female population outnumbers males due to very high male migration outside the district for livelihood.

This shift follows a series of strategic political and administrative decisions. # Scientists link fatty, sugary diets with impaired brain function

In a significant study, researchers have linked fatty and sugary diets to impaired cognitive function.

The team from University of Sydney looked at the relationship between high-fat, high-sugar (HFHS) diets, particularly those high in refined sugar and saturated fat, and firstperson spatial navigation.

Spatial navigation is the ability to learn and remember a path from one location to another, a process that can approximate the health of the brain's hippocampus, said International Journal of

Middle-aged Americans demonstrated some of the highest levels of loneliness in a new study released on Tuesday, which assessed tens of thousands of 50 to 90-year-olds across 29 countries.

The peer-reviewed research, published in Aging and Mental Health, shows loneliness generally increases with age -with only the US and the Netherlands representing places where middle-aged people feel more lonely than older generations.


## AI algorithm can help identify highrisk heart patients: Study



Myanmar will host Group D of the Qualifiers between August 6 to 10 in a centralised single roundrobin format.

A total of 33 teams were divided into eight groups (Group A with five teams and rest of the seven with four each).

The group winners and the three best runners-up, alongside hosts Thailand, will complete the cast of 12 teams for the 12th edition of the AFC U20 Women's Asian Cup, which will take place from April 1 to 18, 2026.

The top four teams in the final tournament will qualify for the FIFA U20 Women's World Cup 2026.

The AFC U20 Women's Asian Cup, an eight-team tournament until 2024, has been expanded to 12 teams from the 2026 edition onwards.

The seedings for the draw were based on a points system derived from the teams' final rankings across the previous three editions of the tournament. India were placed in Pot 2.
