Retired Sikh teacher donates land for Muslim graveyard access in Tral Muslims say 'no force can break' their centuries-old brotherhood with Sikhs

Tral, May 05: In a touching display of communal harmony, a retired Sikh teacher in south Kashmir's Pulwama district has donated land to create an access path for a Muslim graveyard. This act underscores the strong and lasting bonds between the Sikh and Muslim communities in the region.

Retired teacher Pushwinder Singh, a resident of Saimoh Tral, provided a strip of his land to ensure easy access to the graveyard, which has long been used by the local Muslim community for burials.

Speaking to the news agency—Singh said Kashmir is a land of saints and a prime example of communal harmony, a tradition he believes will continue. Singh said his



ancestors have lived in the area with strong inter-community relations, and while there might be occasional issues within their own religious groups, there have never been problems between different faiths, particularly in Tral.

"I provided land measuring 90x6 ft for the way of the graveyard so that Muslims

won't face any problems when they have to bury anyone," he said.

Singh said whenever a Muslim from the area passes away and is to be buried in the nearby graveyard, he and other Sikhs assist with arrangements like providing light, bricks and other necessities, and stay until all work is completed. "Everyone should take such steps to strengthen brotherhood, as 'humanity comes before religion'," he

Local Muslims said they have lived in harmony and brotherhood for centuries, a bond that no force can break.

Ghulam Hassan, a local, said Pushwinder Singh even exchanged land with another person to acquire the specific plot needed for the graveyard access.

With blood stripped clothes, the nomadic woman who fought against the four rapists was found unconscious. However, seeing her daughter, the goons escaped the spot.

FOR A WHILE, THE DAUGHTER OF the victim who had reached the spot was puzzled and wailed aloud to call the family to the incident spot in woods. "My sister called us after seeing our mother unconscious and in a pool of blood," the victim's family narrates the ordeal while speaking to the news agency-Kashmir News Observer (KNO).

Immediately, the nomadic lady was rushed to the nearby health facility for treatment, where she was declared brought dead.

Holding deep sighs and sobs, the daughter of the victim pleaded justice and demanded the culprits should meet the same fate. "We will only find peace when the rapists will be brought to justice. Our mother has left behind little kids. How can we live without our mother," said her daughter.

'Weren't they born from a mother. How can they assault and kill a mother of five. The culprits were Inhumans," she wailed. "We found an accused with blood on his pants due to which he was caught. Otherwise we would have no idea about the culprits."

"The culprits should be hanged till death," she, along with her family and relatives,

Narrating the moments before the incident the daughter of the victim said that her mother was serving tea to them. "Hardly we knew that our mother was serving the last tea to

In the meantime, the body was shifted to $Government\,Medical\,College\,(GMC)\,Srinagar$ for legal medico formalities and was handed over to the family for last rites this morning.

A 30-minute rehearsal for blackout was conducted in the entire Ferozpur Cantonment area on Sunday amid the heightened tensions between India and Pakistan following the Pahalgam terror attack.

The rehearsal was conducted on the guidelines of the Cantonment Board/Station Commander

"The blackout was from 9 pm to 9:30 pm. As per the orders of the senior officers, lights were fully switched off. If any vehicle was found with its light turned on, it was turned off...Police are fully alert. Deployment has been made at all intersections," said Gurjant Singh, SHO, Ferozepur Cantt Police Station.

The government has given the armed forces complete operational freedom to decide on the mode, targets, and timing of India's response in the wake of Pahalgam terror attack. The government has also announced a series of measures, including putting the Indus Water Treaty in abeyance, to send a strong message to Pakistan for its support of cross-border terrorism.

The government convened an all-party meeting after the terror attack and Opposition parties have expressed their full support for any action taken by the government against the perpetrators of the henious attack.

In the briefing to the Cabinet Committee on Security meeting held a day after the terror attack, the cross-border linkages of the terrorist attack were brought out. It was noted that this attack came in the wake of the successful holding of elections in Jammu and Kashmir and its steady progress towards economic growth and development.Jammu travel guide

Diplomatic ties were further scaled back with the mutual expulsion of defence staff, marking a significant shift in India's policy toward Pakistan.

Official sources familiar with the development informed the news agency-Kashmir News Observer (KNO) that the government has initiated reservoir flushing operations at the Baglihar and Salal dams on the Chenab River. These operations, previously conduct $ed\,with\,prior\,notice\,to\,Pakistan\,under\,treaty$ norms, were carried out without any communication this time, they said.

According to officials, the decision not to notify Pakistan stems from the suspension of the IWT mechanism following the Pahalgam attack that left 26 dead.

The sluice gates at Baglihar and Salal dams were opened initially to flush sediment and later closed, temporarily holding back a significant volume of water that would otherwise flow into Pakistan's Punjab province.

Officials estimate that the downstream water flow has been reduced by nearly 90

The National Hydroelectric Power Corporation (NHPC), which operates the dams, said the maintenance work was aimed at increasing reservoir capacity and improving power generation.

Baglihar, located in Ramban district, has a capacity of 900 megawatts, while Salal, in Reasi district, produces 690 megawatts. Both projects are classified as run-of-the-river schemes but require periodic sediment removal to maintain operational efficiency.

The current maintenance includes nearemptying reservoirs and operating adjustable spillway gates, temporarily disrupting natual river flow.

India has also indicated that similar flushing work will be carried out at the Kishanganga hydroelectric project on the Jhelum River.

The Kishanganga project has been at the centre of long-standing disputes between the two countries. India's recent actions signal a policy shift towards using its full entitlement of waters under the treaty without the usual bilateral engagement.

Beyond the immediate reservoir activities, India has expedited work on multiple hydroelectric projects in Jammu and Kashmir, including Pakal Dul, Kiru, Kwar and Ratle. These projects are expected to add over 3,000 megawatts of capacity by 2027-28.

The government described the current steps as part of a broader reassessment of India's approach to water-sharing with Pakistan, prioritising national interests and security concerns over treaty obligations-

Revival of Durbar Move a welcome move

The union territory government of Jammu & Kashmir headed by Omar Abdullah has fulfilled one of the promises made immediately after the 2024 assembly elections by reviving the bi-annual Durbar Move. As soon as the National Conference government assumed office in October 2024 it was promised that the Durbar Move would be revived in the union territory. The same could not be done last year due to the paucity of time.

The people of Jammu region especially, the traders had been demanding the revival of Durbar Move for a long time. The practice of Darbar Move that had been going on since 1873 was banished following the abrogation of Article 370 and Article 35A on August 5, 2019. The people at that time had said that since a lot of money is incurred on the shifting of offices from Jammu to Srinagar in the last week of April and from Srinagar to Jammu in the last week of October the practice needs to be stopped.

Although most of the people of Jammu region were unhappy with this decision, they could not come out in the open at that time due to some political compulsions. With the passage of time there was resentment among the people on this front and gradually the voices became louder. The National Conference had felt the pulse of people in this regard and the party leaders including the incumbent chief minister had promised revival of Durbar Move.

It is a well established fact that following the opening of Durbar Move offices in Jammu in the first week of November people in large numbers from Kashmir would visit the winter capital on account of one engagement or other. These people would put up in hotels, eat food in restaurants and go shopping for various things in the different markets of the Jammu region. As a result of this there was flow of money and the economy of the region was in a proper shape.

One can hope that the incumbent government lasts its full term and the people of Jammu get benefitted from the revival of Durbar Move. If that happens then the same is likely to bolster the chances of National Conference in the Jammu region in the next assembly elections. Even though the elections are more than four years away still then there are people who will give credit to the National Conference for this development.

ast week, I found myself in the heart of Vasant Kunj, New Delhi, in the company of two close friends, Gul Muhammad and Malik Rashid. 

Shehr-e-Khaas: Where Big Hearts Lived in Small Homes



There was a time, not too long ago, when life in Srinagar's Shehr-e-Khaas, the historic Downtown, moved with a gentle rhythm, simple, contented, and gracefully bound by a deep sense of togetherness. The narrow lanes, old wooden houses, bustling courtyards, and centuries-old mosques weren't merely structures of brick and stone, but living witnesses to a society where people's hearts were connected, where neighbours were part of one's own extended family. Though homes were modest and means limited, hearts were generous, and relationships sincere, built upon silent, unspoken understandings that only true communities possess.

In those days, society itself took responsibility for its people. Neighbours cared for one another, not to interfere, but because they genuinely felt for each other. It was natural for an elder to stop a boy or girl and ask where they were going, why they were out late, or how their parents were doing. No one took offence. These were questions asked from the heart, driven by concern and the desire to guide the younger generation along the right path.

One of the most beautiful aspects of that time was the way people shared not only their homes but their joys and sorrows. Whenever a special dish was prepared, Tehri, Halwa, Gaadi, Paachi, Houk Suen, or the winter delicacy Harisa, it was customary to share with the neighbouring homes. Not out of formality, but as a simple, affectionate gesture that said, "You are part of us." Festivals, weddings, and even small moments of happiness were celebrated together. No one hid



their happiness behind doors, and no one bore sorrow alone.

The soul of Shehr-e-Khaas, however, wasn't confined within the four walls of homes. It lived and breathed in the community's daily gathering spots, the waani pend, Kander Waan, hamams, and Naid Waan. These were the neighbourhood's open-air parliaments, where conversations flowed. People of every age and class, elders, youth, the poor, the rich, gathered there to exchange news, debate politics, and discuss matters of society. Family disputes, community issues, and even pressing social concerns were deliberated openly. Respected elders would offer advice, resolve conflicts, and take reformative steps where needed. These informal forums were once the nerve centres of Shehr-e-Khaas, hotbeds of wisdom and social unity. Alas, their voices have now fallen silent, and their presence faded from everyday life.

A vital strength of that era was the strong social checks and balances maintained by elders, relatives, neighbours, and respected family heads. These guardians of morality and harmony watched over society, not with harshness, but with quiet wisdom and a genuine sense of responsibility. Elders were a blessing and a boon, a moral compass that steered the young and reminded the old of their duties. Disputes and disagreements arose, as they do everywhere, but those conflicts were settled with grace and wisdom. Respected elders, relatives, and neighbours would gather, listen carefully to both sides, and deliver fair, sincere decisions aimed at restoring peace. Their words carried authority not because of any legal standing, but because they came from hearts filled with honesty and a genuine desire to maintain harmony.

Families took great care in preserving the dignity of their women. If any mistreatment happened within a household, it seldom remained unnoticed. The women of the neighbourhood, quick to sense unrest, would quietly intervene, counsel, and, if necessary, take collective steps to protect and resolve. Similarly, if a married daughter visited her parental home too frequently or stayed too long, discreet inquiries would be made, not to interfere, but to gently ensure that all was well. Such social checks kept families united, safeguarded relationships, and prevented matters from worsening in silence.

Children, too, were raised by the entire community. Respect for elders was an unspoken rule. If a child misbehaved in the street, any elder had the right to correct them, and no parent ever took offence. In fact, families appreciated this collective upbringing, knowing it shaped well-mannered, responsible individuals. Disrespecting elders wasn't just frowned upon, it was considered a moral failing, a stain upon one's family name, and an insult to the very values the community stood for.

Another beautiful aspect of Shehr-e-Khaas was its tender care for the poor and needy. If someone lost their job, fell ill, or faced a rough patch, the neighbourhood quietly arranged help. Meals would arrive at their doorstep, financial support discreetly extended, and every effort made to uphold the dignity of the person in distress. No one was left hungry, abandoned, or

Back then, people valued physical visits to their relatives, friends, and neighbours. Joys and sorrows were shared in person, hands held, shoulders offered. The warmth of presence was irreplaceable. In those days, even telephones were a rarity, and today's WhatsApp messages and hurried phone calls didn't exist. People believed in personal visits, arriving at your doorstep to share your joy, offer condolences, or simply sit beside you in silent companionship. Presence spoke louder than words, and every emotion was felt, not forwarded. Bonds were maintained through real visits, cups of Kehwa and Noon Chai, shared bread, and hours of heart-to-heart conversation. In this well-knotted society and family system, crime and moral decay were minimal.

The constructive and positive role of elders, be they neighbours, friends, or relatives, kept temptations and wrongdoings in check. Their wisdom, their ability to foresee problems, and gently guide or decisively intervene maintained the social fabric in ways laws alone never could.

When tragedy struck, a death, an illness, or financial hardship, the entire neighbourhood would rally together without waiting for a call. Neighbours arrived with help, kind words, and whatever was needed. From cooking meals for the grieving family to simply sitting beside them in silent solidarity, people stood by each other, providing strength and comfort when it mattered most.

This was Srinagar, with Shehre-Khaas as its soul, a place where simple lives were rich in values, family bonding, and relationships. But sadly, those precious bonds are breaking. Today, the same streets greetings, innocent laughter, and neighbourly concern now seem quiet and detached. People have withdrawn into their own busy lives, hesitant to engage or intervene. Joys are celebrated in isolation, tragedies go unnoticed, and families suffer in silence. Where wise elders once settled disputes with heartfelt counsel, legal complaints and cold courtrooms now take their place. The absence of social checks, the fading watchfulness of elders, and the neglect of family and neighbourhood heads have left a void that has made society colder and weaker. Respect for elders has faded, and the younger generation often grows up unaware of the warmth of a shared upbring-

We haven't merely lost customs, we've lost the very soul of our community. The traditions that once made Shehr-e-Khaas a shining example of kindness, unity, and moral strength now survive only in fading memories and the tearyeyed stories of those old enough to

As material comforts have multiplied, hearts have shrunk. Big homes now shelter lonely hearts, and streets that once celebrated life together echo only with the hurried, indifferent footsteps of strangers. The warmth, closeness, and silent moral guidance of Shehre-Khaas are quietly disappearing.

And with every bond that breaks, we lose not just a tradition or a custom, but a piece of our identity, our history, and our collective soul.

May the memories of those golden days remind us of what we have lost, and perhaps, one day, lead us back to a life where hearts are bigger than homes, where neighbours are family, and where the streets of Shehr-e-Khaas once again ring with greetings, laughter, and the gentle wisdom of its

Dr. K. Kasturirangan: A Visionary Architect of India's Space and Education Renaissance



'ndia Mourns the loss of Krishnaswamy ■Kasturirangan,an eminent space scientist and Education reformer,who passed away on April 25,2025 at the age of 84 at Bengaluru. His death marks the end of a remarkable era in India's Scientific and Educational advancement.

The former Chairman of the Indian Space Research Organisation, is celebrated not only for his pioneering contributions to India's space program but also for his visionary leadership in shaping the future of education in India. One of his most impactful contributions in recent years has been his chairmanship of the committee that drafted the National Education Policy (NEP) 2020, a landmark reform in India's education landscape.

Dr. Kasturirangan holds a Ph.D. in experimental high energy astronomy and is known for his instrumental role in developing India's



remote sensing and satellite capabilities. Under his leadership, India launched several major satellites, including INSAT, IRS, and the early stages of the Chandrayaan mission. His scientific achievements earned him numerous awards, including the Padma Shri, Padma Bhushan, and Padma Vib-

In 2017, the Government of India appointed Dr. Kasturirangan to head the committee tasked with drafting a new education policy for the country, replacing the decades-old National Policy on Education of 1986. 1.Early Childhood Care and Education (ECCE) as a foundation for lifelong learn-

2.A 5+3+3+4 curricular structure, replacing the traditional 10+2 system.

3.Introduction of mother tongue/local language as medium of instruction till Grade 5.

4. Integration of vocational

education and life skills. 5. Promotion of multidisciplinary education and flexibility in subject choices.

6.Establishment of the National Educational Technology Forum (NETF).

7. Emphasis on teacher training and accountability.

Dr. Kasturirangan's ability to blend scientific rigor with cultural sensitivity and policy acumen has resulted in an education framework that aspires to transform India into a knowledge superpower. 



The Union government, in its affidavit, defended the amendment as a necessary reform to curb misuse. It cited a 116 percent increase in waqf land after the 2013 amendment, alleging that "private and public lands were being arbitrarily claimed as waqf," infringing on citizens' and government's property rights.

Regarding the exclusion of "waqf by user," the Centre stated that the change does not curtail the right to dedicate property to God, but ensures dedications follow statutory procedures.

The Centre also rebutted objections over the inclusion of non-Muslim members in the Central and State Waqf Boards, arguing that their presence is minor and only aims to ensure diversity and transparency, not interference with religious rights.

Meanwhile, six BJP-Multiple petitions have ruled States, Haryana, Maharashtra, Madhya Pradesh, Rajasthan, Chhattisgarh, and Assam have also approached the Supreme Court in support of the amendment, contending that unregulated waqf claims have serious administrative and legal implications.

Israeli researchers have discovered that stress experienced by mothers during pregnancy affects the foetus's brain.

The discovery led by researchers from the Hebrew University of Jerusalem (HU) could pave the way for new treatments or interventions to support a baby's healthy development after birth, Xinhua news agency reported.

Chemicals in food containers, medical equipment behind spike in heart disease deaths: Lancet

NEW DELHI

Daily exposure to certain chemicals used in plastic items like food containers or medical equipment could be linked to an increase in deaths due to heart disease worldwide, according to a study published in the journal Lancet eBiomedicine on Tuesday.

Researchers at New York University Langone Health said that the chemicals, called phthalates, are in widespread use globally.

Phthalates found in cosmetics, detergents, solvents, plastic pipes, and bug repellants have for decades been linked with an increased risk of conditions ranging from fertility issues and cancer.

India & Australia extend dominance in annual rankings update

DUBAI, MAY 5 (UNI)

Australia remains at the top in Tests, India leads the two white-ball formats, while Sri Lanka emerge big winners as the yearly ICC rankings refresh brings big movements across formats.

The latest rankings rate all matches played since and those of the previous two years at 50 percent.

Championship holders recent months, including Australia have retained their top spot in the ICC Men's Test Team Rankings, though their lead five rating points, leapfrog-champions England, who 13 points after the annual gain of one point) and four points. update.
