NEW DELHI, MAY 6: In an apparent reference to the Indus Waters Treaty being put in abeyance, Prime Minister Narendra Modi on Tuesday said earlier even the water which rightfully belonged to India went outside the country but it will now flow for India's benefit and will be utilised for the country.

Addressing the ABP Network's 'India@2047' Summit, Modi asserted that for taking big decisions and achieving objectives, it is important to give primacy to national interest and believe in the country's capability.

The prime minister said that when people look at the country now, they can



proudly say "democracy can deliver", and stressed that the government was moving from GDP-centric approach to progress based on Gross Empowerment of People (GEP).

While speaking about the work done on the interlinking of rivers, Modi quipped that water is a topic of intense discussion in the media lately.

"Earlier, even the water which rightfully belonged to India was going outside the country. Now India's water will flow for the country's interest and will be useful for it," he said in an apparent reference to India putting Indus Water Treaty in abeyance as part of countermeasures against Pakistan after the Pahalgam ter-

Innocents must not suffer in Pahalgam attack probe: **Omar Abdullah**

SRINAGAR, MAY 6 (UNI) Jammu and Kashmir Chief Minister Omar Abdullah on Tuesday called for restraint, urging law enforcement agencies not to target innocent civilians while pursuing those responsible for the Pahalgam terror attack. Omar also acknowledged the prevailing atmosphere and the need for time in handling the situation.

"We cannot deny the situation, nor can we close our eyes to it," he told reporters in Srinagar.

The Chief Minister emphasized that in the hunt for the perpetrators of the April 22 Pahalgam attack, that left 25 tourists and a civilian dead, the innocents must not be made to suffer. "It should not appear that we are trying to catch all the people of Jammu and Kashmir just to nab a few," he remarked.Omar said they had conveyed their concerns over the security measures in some areas.

"We have made our point about being a little careful in this regard," he noted.

After the Pahalgam attack, security grid in Kashmir have stepped up crackdown against terror ecosystem. In last two weeks, nearly 2900 people have been detained for questioning or

J&K set for civil defence mock drill today

Emergency response system to be tested; sirens to sound at multiple locations

SRINAGAR, MAY 06: Jammu and Kashmir is all set to witness a civil defence mock drill on Wednesday.

According to the details available with the news agency—Kashmir News Observer (KNO) the directions to hold the nationwide exercises have been passed by the Ministry of Home Affairs.

An official said that the preparations for conducting mock drills in J&K have been finalized and tomorrow sirens will be activated at various locations in the union territory to test emergency response systems. "Public is requested to remain calm and not be alarmed," he added.

The official said that Union Home Sec-

retary Govind Mohan on Tuesday reviewed the civil defence preparedness across the country through a high-level video conference with Chief Secretaries and heads of civil defence of all states and union territo-

"The aim is to assess readiness in the event of a hostile attack, with a specific focus on improving coordination and training across all levels of administration," the official said, adding, "Over 270 'civil defence districts' across India, which include sensitive locations such as military installations health institutions, schools will be covered under the drill."

Sukhnag Nallah mining: J&K admin justifies activity for ring road amid eco-concerns

Government tells NGT it's exempt from clearance; petitioner alleges ecological damage

SRINAGAR, MAY 06: The Jammu and Kashmir administration has strongly defended its authorisation of riverbed mining in the ecologically sensitive Sukhnag Nallah, asserting that the activity is vital for the construction of the Semi-Ring Road and falls under emergency exemptions from environmental clearance.

The response, accessed by the news agency-Kashmir News Observer (KNO) has learnt, was filed before the National Green Tribunal (NGT). It comes amid a petition alleging illegal extraction and



ecological harm in the area. In a detailed affidavit submitted to the NGT's Principal Bench, the Union Territory administration and the District Min-

eral Officer (Budgam) argued that the mining was exclusively for government work of an "emergent nature", and therefore exempt from standard environmental approvals. The officials cited a 2020 notification from the Ministry of Environment, Forest and Climate Change (MoEF&CC), which exempts dredging and desilting for linear infrastructure projects—such as roads and disaster response-from requiring environmental clearance.

The case, *Raja Muzaffar Bhat vs. UT of Jammu & Kashmir & Ors.*, underscores the ongoing conflict between development

Residents of a village in Kulgam district found Magray's body on Sunday amid allegations that the deceased was taken away by security forces for questioning in the wake of the Pahalgam incident.

While Police have launched an investigation to ascertain the exact cause of the death, a drone footage, which surfaced hours after Magray's body was recovered, showed a youth jumping into the gushing Adbal stream and getting washed away.

Police claimed that Magray, who confessed to being an overground worker (OGW) for terrorists, tried to escape while leading security forces to a hideout in a forest area. (Agencies)

Responding to reports about the death of a youth from Kulgam—who was picked up by security forces and later found dead in a stream—Omar said such incidents should not happen.

"...The news of arrests and detentions is coming in from across the Valley," he said, pointing out that the people of Jammu and Kashmir had clearly voiced their anger over the attack.

"For the first time after such an incident, people came out and expressed their displeasure. They said clearly that they do not support this kind of violence," Omar added, underlining the collective rejection of militancy by the local population.

Pak Army violates ceasefire for 12th night Pakistan Army once again violated the ceasefire agreement along the Line of Control (LoC), continuing their pattern of unprovoked firing in several areas.

The latest incident occurred on the night of May 5-6, when Pakistani troops opened fire using small arms across the LoC in multiple sectors, including Kupwara, Baramulla, Poonch, Rajouri, Mendhar, Naushera, Sunderbani, and Akhnoor.

This marks the 12th consecutive night of ceasefire violations by Pakistan, further aggravating the already fraught situation between the two neighboring countries.

In response to the provocations, the Indian Army carried out a strong and calibrated retaliation, adhering to standard operating procedures to maintain security and safeguard personnel and infrastructure in the region.

These repeated violations of the ceasefire agreement, which was established in February 2021, have significantly undermined the credibility and effectiveness of the agreement. Truce violations instill fear

The relentless violations following the April 22, Pahalgam terror attack, have instilled widespread fear and panic among the people living in the frontier areas. "For 12 consecutive nights, 53 incidents of small-arms fire and mortar shelling have been reported in villages across Kupwara, Baramulla, Poonch, Rajouri, and Akhnoor," an official told KNO.

Residents, rattled by the constant sound of gunfire, are fleeing to safer areas or fortifying their homes and bunkers. "We live in constant fear. Every night, we hear the sound of shells landing near our homes," said Farooq Ahmad, a resident of Uri.

"I don't know how long we can stay like this. Our children are scared to even sleep,' added Shabir Ahmad from Poonch.

The escalating violence, coupled with the severed India-Pakistan diplomatic ties, have heightened anxieties about a potential military escalation. "We're caught in the middle. No one seems to care about the people who are suffering here," said Rukhsana Begum, a resident of Rajouri-(KNO)

genuine claims, and proactively reaching out to families, especially in case of the death of insured members, to ensure timely support.

To ensure the schemes reach the most deserving, the Chief Secretary directed for the inclusion of Self Help Group (SHG) members registered with JKRLM and their families under all applicable social security schemes. He also instructed for coverage of registered building and construction workers under Atal Pension Yojana, with the premium to be borne by the Building and Other Construction Workers Welfare Board here.

Dulloo also called for formulation of a focused strategy to enhance credit flow under the priority and MSME sectors, ensuring that all banks meet the targets assigned to them. He also enquired about the progress in rolling out the 'Gramin Credit Score' system for agricultural lending on the lines of the CIBIL score used for individual borrowers.

The Chief Secretary also reviewed ITenabled financial interventions such as the distribution of RuPay Debit Cards under PMJDY and Smart Cards for KCC beneficiaries. He assessed progress made in designing loan products to promote High-Density Plantation, rural homestays, and properties identified under the Svamitva Yojana.

Further, he sought an update on the Credit Grievance Redressal Portal, being developed for the convenience of all bank customers in the UT. He was informed that the portal is ready for launch and will soon be made operational to facilitate efficient resolution of customer grievances.

During the meeting, Principal Secretary. Finance, Santosh D. Vaidya, highlighted the noteworthy performance of J&K Bank, stating that it had achieved an 11% year-on-year growth in its business, significantly reduced its Non-Performing Assets (NPAs) to 3.37%, and brought down its cost-to-income ratio to 58% from the earlier 71%. He appreciated the bank administration for these achievements and termed the performance as satisfactory and commendable.

Managing Director, J&K Bank, Amitava Chatterjee, also shared important statistics on the implementation of social security schemes across the UT. As the lead bank and Convenor of UTLBC, he detailed the bank's efforts to popularize financial inclusion schemes and expand credit outreachto the priority sectors.

With respect to Pradhan Mantri Jeevan Iyoti Bima Yojana (PMJBY) offering life insurance for citizens aged 18–50 years an impressive number of 2.47 lakh new enrolments were done during the previous financial year with cumulative coverage reached 9.67 lakh and settlement of 668 claims with Rs. 13.34 Cr disbursed during the previous financial

Atal Pension Yojana (APY) targeting unorganized workers also registered an significant progress with 24,230 new account openings, cumulatively reaching 2.48 lakh accounts since inception.

As far as the priority sector lending is concerned under the Annual Credit Plan 2024–25, J&K's banks collectively achieved 92% of the credit disbursement target, totaling Rs. 36,575 Cr. J&K Bank emerged as the top contributor, surpassing targets at 139% for physical targets and 134% in credit volume. The Micro, Small, and Medium Enterprises (MSME) sector absorbed Rs. 22,688 Cr, accounting for 62% of priority sector lending. A total of 2.96 lakh accounts were supported with J&K Bank leading the table with Rs. 5,537 Cr disbursements in this sector.

The meeting was informed that the agriculture sector too received focused attention with Rs. 6,430 Cr disbursement out of a target of Rs. 11,056 Cr, achieving nearly 58% of the

According to the government's reply, a District Level Single Window Committee chaired by the Deputy Commissioner of Budgam approved the extraction of riverbed minerals (RBM) and clay by M/S NKC Projects Pvt. Ltd.—the contractor for the Semi-Ring Road-in November 2022, even before formal no-objection certificates (NOCs) were issued. Minutes from the meeting, submitted as Annexure-I, indicate that the chairperson's directives were treated as interim NOCs to fast-track the project.

Authorities said the extraction sites were identified by the Flood Spill Channel Division in Narbal to mitigate environmental impact. "The DMO Budgam acts tough against illegal mining," the affidavit noted, highlighting a series of seizures, fines, and FIRs filed against violators in the past year.

However, the administration's reliance on the 2020 MoEF&CC exemption is expected to face scrutiny. Critics argue that such provisions, meant for genuine emergencies, are being exploited to circumvent environmental norms for large-scale infrastructure development. The petitioner's counsel has previously claimed that the mining is causing "irreversible damage" to the Nallah's flow and aquatic life—an allegation the government's reply does not directly address-

and bunker management procedures. In Jammu and Kashmir, the Directorate of State Disaster Response Force (SDRF) and Civil Defence Kashmir has issued a public advisory notifying residents of the scheduled mock drill.

According to the advisory, the drill will begin at 4:00 PM on Wednesday, and sirens will be activated as part of the exercise.

It urged residents not to panic, and to cooperate fully with officials during the simulation. "This is a practice exercise to test our emergency response systems. Please remain calm and do not be alarmed," reads the official notice issued by the SDRF & Civil Defence Kashmir.

"To enhance the Civil Defence preparedness for emergencies, a Civil Defence Mock Drill will take place on Wednesday, May 7, 2025, at 4:00 PM. As part of the drill, sirens will be activated at various locations in Kashmir. This is a practice exercise to test our emergency response systems. We kindly request all members of the public to remain calm and not be alarmed. Your cooperation is essential in making this safety initiative a success," the Directorate of SDRF and Civil Defence Kashmir stated in an another public advisory.

Authorities across all states and the union territories have been instructed to ensure $active \, public \, participation. \, Students, hospital \,$ staff, government and private sector employees, railway and metro officials, and members of the police, paramilitary, and defence forces will be part of the exercise.

The MHA has said that the civil defence framework is an important component of national preparedness, especially given "new and complex threats."

It stated that such drills improve the passive defence strategy and help safeguard civilian lives and infrastructure.

Officials have also been directed to ensure communication systems are tested, bunkers are cleaned, made accessible and designated personnel are familiar with evacuation pro-

cedures. The government said that the civil defence drill is part of a broader initiative to improve grassroots-level readiness and empower local communities to respond effectively to emer-

Rail connectivity of Kashmir with rest of country continues to be a dream

pril 19, 2025 was considered to be a red letter day in the union territory of Jammu & Kashmir Aday in the union territory or Januara & Adams Prime Minister Narendra Modi was scheduled to flag off the Vande Bharat express from Katra. The Vande Bharat express will connect Katra with Srinagar and as such the decades old dream of rail connectivity of Kashmir with the rest of the country would be realized. This would have come as a relief for the people of the valley.

The residents of the valley have been at the receiving end as far as surface connectivity is concerned. As soon as the weather becomes inclement the Srinagar-Jammu national highway gets closed and there is no movement of vehicles on the highway. Since the Prime Minister's visit could not materialize, the dream of rail connectivity of Kashmir with the rest of the country continues to be a dream. The people are eagerly waiting for the day when this becomes

Since the meteorological department had forecast that the weather would be bad on April 19 the Prime Minister's visit had to be cancelled. As the Baisaran-Pahalgam massacre took place three days after the PM's scheduled visit there has been no talk of the flagging off of the Vande Bharat express. Therefore the people of Kashmir have kept their fingers crossed as far as inauguration of the Vande Bharat express is concerned. The delay in connecting Kashmir with the rest of India through trains has disappointed the people of the valley.

The talk about the inauguration of Vande Bharat express has been going for months now and delay in the same is bound to cause ripples among the public circles. Although some of the dates had been proposed for the start of the same, ultimately April 19 was set as the date for the inauguration. The people were eagerly waiting for the day but the inclement weather virtually acted as a damp squib thus dashing the hopes of valley residents.

As both India and Pakistan are at loggerheads after the Baisaran massacre the inauguration of Vande Bharat express may not happen earlier as expected. Once the situation becomes normal in Jammu & Kashmir then only the concerned authorities would take a call on the flagging off of the Vande Bharat express from Katra to Srinagar. As the Prime Minister is expected to inaugurate the train service the delay may be longer as expected and as such valley residents would have to wait a little longer.

The Celebration of Toppers: A **Double-Edged Sword**

Every year, the academic landscape lights up with newsfeeds celebrating toppers. Screens are flooded with pictures of smiling faces, scores flaunting 99% and above, and captions that scream #ProudParent, #HardWorkPaysOff, and #TopperDiaries. These posts do more than celebrate success-they set a benchmark

For many students, especially those who didn't meet their own expectations, this can be deeply unsettling. The overwhelming glorification of academic excellence creates a silent pressure cooker of comparison. "If she scored 98%, why did I only get 85%?" is not just a thoughtit's an internalized critique, made sharper with every scroll. While appreciating achievement is natural, the unintentional consequence is the creation of an elitist narrative-where anything less than 'topping' is treated as underperformance.

Social media has birthed a new kind of celebrity: the academic influencer. These are students who, after topping exams, are sponsored the **Ambassadors for Coaching Centres** like in Srinagar SKIE Coaching Center did. After knowing her results ,she just came again on Social media that she is in mental trauma. Al's many students create YouTube channels or Instagram pages to share their study hacks, productivity routines, and "how I got 99% in 12th" stories. Their intention may be noble, but the impact is complex.

This curated perfection can feel intimidating. Students begin to doubt their own methods and feel inferior even before their results are out. The idea of "success" becomes boxed into rigid templates-morning routines starting at 5 AM, study timetables split into color-coded blocks, and zero screen time for fun.

When a student's reality doesn't match this perfection, it often leads to guilt and a decline in self-worth. What social media fails to show is the silent majority-the students who worked hard but didn't get the highest marks, and still have bright futures ahead.

Trend-Driven Stress and Meme

Ironically, social media is also the place where students vent their stress. Every result season, meme pages explode with content about failing maths, overprotective parents, or "hiding from relatives." Laughter becomes a coping mechanism, a digital sigh of collective relief.

However, beneath the humor lies real anxiety. Students tag friends in posts about "marks ruining my life" or "becoming a monk after seeing my result," but not everyone is laughing on the inside. The joke is often a mask for pain. Moreover, viral trends such as "result reaction videos" or "how my parents reacted to my board marks" bring private emotions into the public eye. The line between genuine emotion and performative content is blurring, leaving students unsure of how to process their feelings authentically. This leads to what psychologists call "imposter syndrome"-the feeling of being a fraud despite genuine effort. Even high scorers may feel inadequate because someone else scored a fraction more or secured a spot in a better college.

What makes this worse is the "highlight reel" nature of social media. Students see only the successes, not the failures, sleepless nights, or moments of doubt. This creates a skewed perception of reality and can drive feelings of worthlessness and depression.

Parental Pressure and Social **Expectations Amplified**

In many households, especially in South Asian cultures, academic performance is still a major measure of worth. With social media in the mix, parental expectations are now public. A father sharing his son's 99% score on Facebook isn't just proud-it sends a message to his circle about his family's status.

For students who don't meet these unspoken standards, this visibility can feel suffocating. They not only feel they've let themselves down but also believe they've failed to uphold their family's online reputation. This pressure isn't always expressed directly-it's in the silence that follows a disappointing result, the absence of a social media post, or the constant comparison with a more "successful" cousin.

Digital Detox or Digital Dependence?

Ironically, while social media contributes to this stress, it also becomes a place for support. Students share their stories, form study groups, and follow mental health pages. But the key is moderation. Some students choose to go on a digital detox during result season to protect their mental peace. Others, however, find themselves trapped in a loop-refreshing feeds, waiting for updates, checking how others fared, and reading motivational quotes they don't truly believe. This unhealthy dependence can extend beyond results-affecting college admissions, career choices, and long-term confidence.

The Way Forward: Creating a Healthy Digital Culture

Now it will not just be watched-now action will be taken. Under the IT Act 2000 and Digital Media Ethics Code 2021, action will be taken against such social media platforms and 'influencers' who are engaged in spoiling the atmosphere by spreading content against the country.

Expression versus Destruction Freedom of thought in the coun-

try is protected by the Constitution. But should this freedom be so open that anyone can say anything, and when questions are raised, they can take the cover of 'democracy,' 'free speech,' and 'dissent'? Should anti-national content also be considered a part of expression?

When a youth says "there is no job," it is a legitimate pain. But when the same person writes on social media, "India should burn," "Hindustan is hell," or "The country has become fascist," then these are no longer opinions-they become a well-planned rumor, which is further fueled by political or foreign

Therefore, now it will not be decided which party the person posting the post supports; now it will be decided what impact the post has on the nation.

The growing web of 'payout jour-

Nowadays some 'freelancers' and 'influencers' are giving "gyaan" on every issue on social media. But behind these gyaanis, there is often a payout strategy hidden. Videos are made under a particular ideology-someone is accused, someone's image is tarnished, and in the end the climax is that "India is no longer

Those who defame India by taking 'payouts' on social media will no longer be spared. The government has taken a strict stand under the IT Act 2000 and Digital Media Ethics Code 2021. Now there will be neither silence nor exemption on anti-national content. Legal action will be taken against those who spread rumors and agendas in the name of freedom of expression. It will not be decided which party you support, but it will be seen whether your views are with the integrity of India or against it. Now think before posting country comes first, not popularity!

worth living in."

All this is part of the agenda marketing where India's image is tarnished internationally-especially on sensitive topics like human rights, anti-Muslim sentiment, and Dalit oppression. Also look at their timing: when there is a discussion on India in the UN or when foreign reports come out, on the same days these 'anti-India campaigns' intensify on social media.

Will treason be identified by the party?

Another funny point of the debate is that people try to decide whether an idea is anti-national or not based on whether the person posting it is a BJP supporter or a Congress critic. But should India's integrity be identified with a party? Will national interest also be seen through a political lens?

No. It is time to draw clear lines between country and party.

Nation comes first-not ideology, caste, religion, or party.

Any post that tries to destabilize India by making baseless allegations against its borders, its soldiers, its judicial system, or its democratic institutions is antinational. And now the government has made it clear that such content will be banned immediately.

IT Act and Digital Code: No More Exemptions

The IT Act 2000 and the Digital Media Ethics Code 2021 will no longer be limited to books. Those who believed that the online world is a 'no rules zone' will now have to face the ground reality.

Under these laws:

Notice to the platform for sharing anti-national content and instruction to remove the content Criminal case filed for spreading fake news.

It is mandatory to openly display paid promotions.

Actions like financial penalties and even bans on promoting anti-India 'trends'

Now the government is going to strictly implement these legal provisions.

This is a country, not a story pitch!

India is not a product that needs to be defamed to be sold in 'International Outlook.' This country is made of the faith, soul, and struggle of crores of people. If any person thinks that he can defame the country through a tweet or a reel, then he is making a big mis-

This "anti-national outsourcing" going on on social media will not continue anymore.

The pen is now responsible. Literature, journalism, media, and social space-all these are the backbone of democracy. But when these platforms become infected with foreign agendas or political hatred, then purifying them becomes a part of national secu-

Now the time has come that the pen should also be used responsibly.

Before every post, before every tweet, before every video, ask yourself, is this in favor of my country or against it?

If the answer isn't clear, don't

One more thing in closing-

This country is not afraid of debate. But it will not remain silent due to conspiracy.

Now that era is over when people used to gain 'popularity' by abusing the nation.

Now the answer will be givenstrict, legal, and immediate.

World Laughter Day: One-dimensional laughter in a one-dimensional world: a sociological reflection

ach year, the first Sunday of May is celebrated as World **⊿**Laughter Day−a tribute to the healing power of laughter, unity, and peace. Streets echo with cheerful gatherings, yoga sessions filled with giggles, and social media feeds glow with smiling emojis. At first glance, it's a wholesome celebration of joy. But from the lens of Herbert Marcuse, one of the sharpest critics of modern society, we might ask: Is this laughter liberating or limiting?

In his 1964 classic One-Dimensional Man, Marcuse argued that advanced industrial societiesboth capitalist and communisthad created individuals who are conformed, complacent, and controlled. These "one-dimensional" people lose the capacity for critical thinking, imagination, and authentic freedom. What seems like happiness is often a mask that conceals alienation and compliance.

Laughter as Repressive Desublimation

Marcuse introduced the concept of repressive desublimation, where people's instincts and desires are released, not to empower them, but to pacify them. In today's world, laughter too can be commodified-turned into entertainment, memes, and commercial therapy. We are encouraged to laugh, not to question; to smile,

World Laughter Day, then, can be seen as a ritual of emotional release in a system that exhausts us daily. It offers temporary relief, but without challenging the source of our stress-be it long working hours, consumerism, or social iso-

The One-Dimensional Culture of

In a truly liberated society, laughter would arise from freedom and genuine connection, not from marketed jokes or superficial distractions. But in our one-dimensional world, even laughter is standardised-packaged into sitcoms, stand-up routines, and apps promising instant mood boosts.

Marcuse feared a world where even dissent and humour were absorbed into the system. And perhaps that's where we are-where rebellion becomes a t-shirt slogan and resistance becomes a punch-

Towards a Two-Dimensional Joy This doesn't mean we must stop laughing. Instead, we must recover the depth of our emotions. Laughter should be a tool of healing, not sedation. It should accompany awareness, not replace it.

So, on this World Laughter Day, let us laugh-but let us also ask:

What are we laughing at, and what are we forgetting while we

Can our joy be a force of resistance rather than compliance?

Examples of Marcuse's Theory Applied to Laughter

Consumer Culture and Laughter Marcuse argued that in modern societies, consumerism becomes a primary way of fulfilling needs, even false ones. The push for continuous consumption dulls critical thinking and reduces people to mere cogs in the machine. This concept applies to laughter as well: Example:

- Laughing as a Product: Advertisements often use humour to sell products. While we laugh at a commercial, the joke itself is part of a strategy to make us associate happiness with consumption. On World Laughter Day, people may laugh in group sessions, but are they truly liberated, or are they merely laughing to distract themselves from the need for real social change and deeper connections?

The Illusion of Freedom in Media Marcuse warned that mass media plays a crucial role in shaping a one-dimensional society. It often turns rebellion, dissent, or alternative lifestyles into consumable entertainment, which then loses its potential to challenge



authority.

- Comedians and Political Satire: Stand-up comedians or late-night TV shows may criticise political leaders or social issues, yet their content is often designed to entertain rather than inspire change. Comedy can become a form of repressive desublimation, where jokes about power structures become so normalised that they no longer incite real resistance, but rather reinforce the existing order.

Workplace Humour and Alien-

Marcuse's analysis of labour in industrial society suggests that workers are alienated from the products of their labour, leading to an inner sense of emptiness. Laughter in this context often masks dissatisfaction and frustra-

Example:

- Corporate Humour: In the workplace, humour often circulates around trivial matters or internal jokes that serve to distract workers from the monotony and alienation of their labour. This

laughter can be seen as a way to mask deeper frustrations with oppressive work environments or a lack of personal fulfilment. On World Laughter Day, a corporate gathering might feature jokes and laughter, but does this laughter address the real issues employees face, like burnout or lack of creativity?

Technology and Laughter Marcuse critiqued the role of technology in modern societies, noting that it is used not to liberate but to control and manipulate people. Technology, including social media, can shape how we express emotions like laughter.

Example:

- Laughter on Social Media: Social media platforms encourage users to post funny content, often through memes or short videos. While it may seem like a celebration of joy, this laughter is often controlled and commodified. Algorithms determine what content is visible, shaping our understanding of what is funny. This is an example of Marcuse's point that technology

serves to reinforce the status quo

by dictating the types of joy we experience.

Political Correctness and Humour

Marcuse's work often emphasised the control of intellectual freedom. In contemporary debates around political correctness, humour becomes a battleground for questions of freedom of expression and social justice.

Example:

- Political Correctness and Jokes: Comedians today navigate the fine line between free expression and being "cancelled" for crossing boundaries. In a one-dimensional society, humour can be used to safeguard the dominant social order. By enforcing certain norms around what is acceptable to laugh at, society may stifle the potential of humour to challenge power

Mass Entertainment and the Pacification of Society

Marcuse argued that the mass media pacifies the population, offering distractions to prevent people from thinking critically about their conditions. Entertainment becomes a tool of repressive desublimation.

Example:

- Laughter in Reality TV: Reality television often presents "unscripted" moments of humour that may seem spontaneous but are carefully curated for entertainment value. These programs distract viewers from societal problems by providing them with a false sense of connection and enjoyment. On World Laughter Day, while people might enjoy shared laughter, do they recognise that these forms of entertainment keep them from engaging with deeper societal issues?

Laughter as a Form of Resistance While Marcuse's work critiques the one-dimensionality of society, it also suggests that authentic human expression can offer a path to liberation. In this sense, laughter that arises from true solidarity, critical thought, and resistance is empowering.

Example:

- Revolutionary Laughter: In social movements, laughter can be an act of defiance. Protesters use humour to mock oppressive regimes or challenge unjust systems. This form of laughter, rooted in critical awareness, contrasts sharply with the empty laughter promoted by consumer culture. On World Laughter Day, we could reflect on how laughter has historically been used to resist oppression (e.g., in political protests, satirical works, or underground movements).

Conclusion

Marcuse's analysis of modern society's one-dimensionality reveals the ways in which humour, laughter, and entertainment are often co-opted by systems of control. However, when laughter is authentic and comes from a place of true connection and awareness, it has the potential to be liberating. On World Laughter Day, we might ask ourselves: is our laughter freeing us, or is it simply another tool used to distract us from the deeper questions of our existence?

The Punjab Police exposed vulnerabilities in India's sought permission from the central government to deploy commandos, while the Crisis Management Group (CMG) in Delhi considered sending National Security Guard (NSG) operatives. However, delays in decision-making and concerns about passenger safety prevented any action. Frustrated by the lack of refueling, the hijackers stabbed two passengers, including 25-year-old Rupin Katyal, who was fatally wounded, and forced the plane to take off

without refueling. The aircraft landed in Lahore at 8:07 PM, where it was refueled after negotiations with Pakistani authorities. It then proceeded to Dubai, landing at Al Minhad Air Base at 1:32 AM on December 25. In Dubai, the hijackers released 27 passengers, primarily women and children, and offloaded Rupin Katyal's body. The United Arab Emirates denied India's operation, citing sovereignty concerns. The plane then departed for its final destination, landing at Kandahar Airport in Talibancontrolled Afghanistan at 8:33 AM on December 25. The Taliban surrounded the aircraft with armed militia, claiming it was to protect the passengers, though Indian officials viewed this as a move to prevent a military rescue



JAMMU, MAY 6: In line with the Chief Minister's directions regarding promotion of tourism infrastructure in Jammu province and periodical review by Atul Duloo, Chief Secretary, a joint team of officers from Tourism, Revenue, PWD and Forest Departments conducted on spot visit to assess the site's potential for development of an adventure Hub at Aithem near Surinsar lake in Jammu district. The team was led by Aijaz Qaiser, Ioint Director Tourism, Jammu.

ment norms. The adventure Hub will come up as a major attraction site



for the nature lovers, bird watchers, star gazers and adventure enthusi-

asts. The project will have state of the art facilities like eateries, public conveniences, Sunrise and Sunset points and Yoga platform. Pertinently, yhe department of tourism has already trained a batch of 23 paragliders in P1, P2, P3 levels in collaboration with NIMAS Training Institute. Seppa, Arunachal Pradesh.

Vikas Gupta, Director Tourism Jammu, has taken up the matter with the Atal Bihari Vajpayee Institute of Mountaineering and Allied Sports, Manali, for imparting advance courses in paragliding (P4 &SIB) to the same set of 23 paragliders so that they can be eligible for their certification as tandem pilots. To assess the

site from a technical perspective including wind speed, wind direction and the gradient of the take-off point, the trained paragliders took-off solo test flights for the first hand experience and assessment. VPN use banned, hate speech prohibited in Doda amid security concerns

Jammu, May 3: In the wake of the recent terror attack in Pahalgam, security agencies have intensified surveillance and imposed a clampdown on the use of Virtual Private Networks (VPNs) in Jammu's mountainous Doda district. The decision comes amid mounting concerns over the misuse of encrypted platforms by terror outfits and anti-national elements to communicate anonymously and evade detection. Authorities say the move is a preventive step to block covert online communication channels often exploited for planning and coordinating militant activities. VPNs, which allow users to bypass local network restrictions and mask their digital footprints,



have increasingly come under scrutiny in sensitive regions prone to terrorism. Doda, which had seen a significant decline in terrorism over the past decade, has recently witnessed a worrying resurgence of terror activity. Intelligence inputs suggest that a few terrorists suspected to have links to the gruesome Pahalgam attack are currently taking shelter in the rugged forested terrain of Doda.

According to sources, several suspects believed to be directly or indirectly involved $in the Pahalgam\, terror\, strike$ may have infiltrated into the region through existing routes connecting the Kishtwar district in Jammu province with south Kashmir. The mountainous geography and dense forest cover of these areas make them ideal hideouts for terrorists trying to escape counter-insurgency operations.

Security forces have stepped up combing operations in Doda and adjoining areas, including parts of Kishtwar, to track down possible hideouts. Surveillance has also been intensified along traditional infiltration routes, and communication networks are being closely monitored to prevent further security breaches.

Police arrests 02 drug peddlers in Awantipora; **Contraband substance** recovered

Pulwama residents demand widening, repair of **Newa-Rohmoo** road

Pulwama, May 06: The residents across several villages in South Kashmir's Pulwama district here have expressed growing frustration over the worsening condition of Newa-Rohmoo road—a crucial transport link that connects parts of Pulwama with Srinagar and Budgam. Speaking to the news agency—Kashmir News Observer (KNO), locals said that the Newa-Rohmoo road is a key artery that serves thousands of commuters daily, including students, patients, farmers and traders.

However, the residents said the road has been left in a state of neglect for years, with no proper macadamisation or structural upgrades undertaken to accommodate the growing traffic.

Qayoom Khan, a local social activist said



that one of the biggest challenges, residents point out, is the narrow width of the road, especially along critical stretches."Due to the absence of lane expansion, vehicles are frequently forced into risky manoeuvres, resulting in regular traffic congestion and minor accidents," he said.

"The road's current width is not fit for modern traffic needs," said Javid Ahmad, a resident of Newa. "During peak hours, it's a nightmare. A journey that should take 10 minutes stretches to over an hour. Emergency vehicles, school buses, and ambulances all get caught in the chaos." Local residents stated that they have raised the issue multiple times over the years with various government departments and public representatives, but their pleas have gone unheard. "From public hearings to written representations, we've tried everything. Unfortunately, nothing has moved on the ground," said Basit Ahmad, another concerned local. "Even the patchwork repairs done occasionally are substandard and don't last more than a few

Residents said the road's condition worsens during the rainy season, turning muddy and nearly impassable. Elderly villagers and school-going children face particular hardship in navigating the pothole-ridden stretch.

NR flags delay in tunnels' communication system of Srinagar rail project

NEW DELHI, May 6: The communication system inside the escape tunnels between two sections of Udhampur-Srinagar-Baramula Rail Link Project (USBRL) is incomplete and yet to be fine-tuned, the Northern Railway complained in a written communication to the Konkan Railway Communication Limited, its service provider.

The final Katra-Sangaldan section of the 272-km USBRL project was to be inaugurated by Prime Minister Narendra Modi on April 19 to connect Kashmir with the rest of the country. However, it was postponed due to bad weather predictions and the new date has not been announced

The work to instal and enable an integrated tunnel communication system in the USBRL project was awarded to Konkan Railway Communication Limited (KRCL) for train operational efficiency and safety.

However, according to the Northern Railway's letter, despite various written instructions as well as repeated verbal discussions, the KRCL has not completed crucial work essential for communication inside the tunnel.

According to the letter, the inspection by the Commissioner of Railway Safety (CRS) from Sangaldan to Reasi section was done on June 18 last year and Reasi to Katra on January 8 this year but tunnel VHF communication



works are still not completed at the site.

"From Sangaldan to Dugga and Katra-Reasi section, tunnel VHF (very high frequency) communication has not been activated in the escape tunnel till yet," the letter, addressed to the chairman and managing director of the KRCL, said, complaining that important communication components required for 'adits' (opening of tunnel) have not been supplied yet.

Besides the escape tunnels, the letter also highlighted challenges in seamless communication in the main tunnels and said, "In VHF Communication in Main Tunnels in Sangaldan-Dugga and Katra Reasi sections, compliant of noise, voice not clear, communication break, communication at one station only are also reported by user depart-

 $\hbox{``Also, all the 6 channels designed for VHF communication'}\\$ are to be fine-tuned. Hence OEM (Original Equipment Manufacturer) should be called to settle these issues so that continuous and clear VHF Communication should be made available," it added.

The letter has also flagged the delay in the supply and installation of Voice Recording Equipment (VRE) in all block sections from Katra to Sangaldan and said the installation of ROIP (Radio Over IP) in the new divisional control office, Jammu also has not started yet.

The Northern Railway maintained that in view of the incomplete works, the tunnel VHF system of these sections could not be offered to the Jammu Division.

"To avoid further delay, your immediate intervention in the matter is required for completion of balance works and complete commissioning of VHF works," the Northern Railway said.

It added, "Tunnel VHF Communication is a vital component of communication for train operation in Katra-Banihal

At present, train services are operational between Baramulla and Sangaldan via Qazigund and Banihal. (PTI)

Older adults are at significant risk of brain stroke due to prolonged exposure to air pollution, according to a study led by Chinese researchers.

The study showed that elderly males are disproportionately affected by ischemic stroke related to air pollution. Ischemic stroke is a condition resulting from reduced blood supply to specific areas of the brain due to blocked blood vessels. The primary contributor to this burden is PM2.5 from air pollution.

"Our analysis uncovered that AAC was a very strong contributor to fall risks and was actually more significant than other factors that are clinically identified as fall risk factors."

World number one Sinner accepted the ban in February after reaching a settlement with the World Anti-Doping Agency (Wada) over his two positive tests last year.

His ban expired at midnight on Sunday, meaning he is able to compete at his home tournament - the Italian Open - in Rome this week, the BBC reported.

"Of course when you go to court it can go both ways - nothing or a lot," the 23-year-old told a packed interview room at the Foro Italico.
