

BHUJ (GUJARAT), MAY 16: In a strong message to the international community, Defence Minister Rajnath Singh on Friday cautioned that Pakistan's close ties with terror outfits pose a grave danger to global peace, warning that it would be no surprise if nuclear weapons in the neighbouring country fall into the hands of terrorists.

Addressing the air warriors at the air force station at Bhuj, Singh, according to the news agency—accused the Pakistan establishment of actively supporting terrorism and rebuilding terror infrastructure destroyed by Indian forces during 'Operation Sindoor,' India's military retaliation to the April 22 terror attack in Pahalgam,



which left 26 civilians, mostly tourists dead."It has been proven beyond doubt that there is a strong nexus between Pakistan and terrorists. In such circumstances, if nuclear weapons fall into the hands of terrorists, no one should be surprised. It is not just a threat to India, but to the entire world," he said.

Pakistan and Pakistan-occupied Kashmir early on May 7 in response to the April 22 Pahalgam terror attack. Jammu and Kashmir tourism

India and Pakistan agreed on May 10 to stop military actions. India has, however, made it clear it has merely paused its operation and its future actions will be guided by Pakistan's conduct.

Modi had said Operation Sindoor was India's new policy against terrorism and the country's unwavering pledge for justice.

"It is the new normal. We have only kept in abeyance our operations against Pakistan and the future will depend on their behaviour," Modi had said in a 22-minute address.

Shah said the new multi agency centre (MAC) will synergise the efforts of all agencies and provide a seamless and integrated platform to deal with the complex and interconnected current national security challenges.

The new network will strengthen the country's efforts to deal with serious threats like terrorism, extremism, organised crime and cyber attacks, he said.

Shah lauded the new MAC network and expressed satisfaction at

the successful completion of hardware and software related tasks in record time.

He said it incorporates futuristic capabilities such as embedded artificial intelligence and money laundering techniques to harness the potential of the vast database with MAC and Geographical Information Services.

Shah laid the future roadmap by emphasising the need to integrate other significant databases housed with different central agencies in different silos, on this platform for leveraging the advanced data analytics made available with new MAC.

Executed at a cost of over Rs 500 crore, the new MAC network has undergone both qualitative and quantitative transformation.

The new MAC network spanning the length and breadth of the country, has weaved-in $country \hbox{'s} is land territories, in surgency affect$ ed areas and mountainous high altitude terrain ensuring last mile connectivity down to the level of district SP's in the remotest areas with a fast and stand-alone secure network, the release said. "The Indian Air Force not only dismantled the terror network within minutes but also struck deep into enemy territory without even crossing the border. Our aircrafts are capable of neutralising enemy targets from within Indian

airspace," he stated. He highlighted how "Operation Sindoor," named by PM Modi himself, sent a strong signal to the world about India's capabilities and determination to root out terrorism. "You entered their land and decimated their terror infrastructure. You have sent the message of a 'New India'—strong, decisive, and self-reliant—to the entire world," he said, commending IAF Chief and all personnel involved.

PAK'S TERROR FUNDING EXPOSED

The Defence Minister alleged that Pakistan is planning to divert a portion of the \$2.1 billion IMF aid it is set to receive, to rebuild terror infrastructure for groups like Lashkare-Taiba and Jaish-e-Mohammed.

He claimed that Islamabad has earmarked Rs 14 crore for Jaish chief Masood Azhar, a UN-designated terrorist and mastermind of deadly attacks such as the 2019 Pulwama and 2016 Uri strikes. "Pakistan will use the tax money collected from its citizens to fund Masood Azhar and rebuild terror infrastructure in places like Muridke and Bahawalpur. This is a clear case of indirect terror financing, and if the IMF's aid is used for this purpose, it becomes complicit. The funds contributed by nations like India to the IMF must not be misused to promote terrorism," Singhwarned.

Singh called upon the International Monetary Fund (IMF) to reconsider its one-billiondollar assistance to Islamabad and refrain from providing any support in future as well. INDIA HAS PUT PAK ON PROBATION

He also expressed deep concern that Pakistan had started reviving terror training camps and logistical hubs dismantled by Indian forces. "This rebuilding effort must be seen as a deliberate provocation. India has put Pakistan on probation—we are watching its every move. Any misadventure will invite a heavy price," he said firmly.

He asserted that the current ceasefire means that India has kept Pakistan on probation on the basis of its behavior. If the behavior improves, it is fine; but if there is any disturbance, harshest punishment will be given, he said.

Singh stated that India's war against terrorism is now a central element of the National Defence Doctrine, and the government is committed to wiping out proxy and hybrid

"This is not the old Bharat anymore. Under the leadership of PM Modi, India has drawn

a red line on terrorism. We do not tolerate, we retaliate. That is the New India," Singh

Khan, both 12 years old, were inseparable siblings. Their mother showered them with love and affection when they returned home. The twins excelled academically, consistently securing top positions in their class, and actively participated in sports, making their teachers proud.

Following an attack on terrorist institutions, tensions escalated between India and Pakistan. On May 7, India conducted air strikes targeting terrorist locations in Pakistan. General of Police (IGP), Kashmir, said.

The IGP was addressing a press conference with General Officer Commanding, Victor Force, Major General Dhananjay Joshi and CRPF Inspector General Mitesh Jain at the headquarters of the Victor Force here in south Kashmir's Pulwama district.

Birdi said due to the intensified focus of various security agencies and the coordination between them, two successful operations were conducted and six terrorists killed in the last three days. He termed the elimination of the ultras "significant achievements".

"These successful operations were possible because of the coordination and synergy among the security and intelligence agencies. We are duty-bound to end any terror activity in Kashmir and we are always ready to stop such acts," the IGP said.

The encounters took place in the Keller area of Shopian and Nadar area of Tral in Pulwama on Tuesday and Thursday, respecThree terrorists each were killed in the

two operations. Major Joshi said immediately after the Pahalgam terror attack, which claimed 26 lives, the security forces designated several areas as focus areas.

"We had intelligence inputs that terrorists had moved to the higher reaches after the melting of the snow. Keeping that in mind, our domination parties were continuously deployed in the higher reaches, mountainous areas and forests," he said.

The security agencies received an intelligence input about the presence of terrorists in the Keller area on the night of May 12, Major Joshi said.Jammu and Kashmir tourism

"So the domination party that was deployed there for some time relocated itself and in a focused way, closed in on the area. They challenged the terrorists who fired at them, leading to an encounter in which three terrorists were neutralised," he said.

About the Tralencounter, the GoC said the operation took place on a different terrain.

"We had inputs and cordoned off the village. The terrorists took positions in different houses and fired at us. Our challenge was the safe evacuation of the innocent civilians, including children. Then, systematically, searches were conducted one by one in the houses and three terrorists neutralised at separate places," he added.

Major Joshi asserted that the successful conduct of both operations shows that the security forces will find terrorists wherever they are and neutralise them.

Of the six slain terrorists, the most prominent was Shahid Kuttay, who was involved in major attacks, including one on a sarpanch in Shopian's Heerpora on May 18 last year and a firing incident at the Danish Resort on April 8 last year, in which two German tourists and a driver were injured, the officer said.

"Kuttay was also involved in fundraising and other activities," he added. The neutralisation of both the modules

has dealt a blow to terror outfits and will help stop their activities here, Major Joshi said.

Addressing the presser, the inspector general of the Central Reserve Police Force (CRPF) said the success of these operations could not have been possible without the support and cooperation of the local popula-

"It is not only difficult but impossible to wipe out terrorism without the support of people. The successful operations are a proof that the people here want an end to terror in Jammu and Kashmir," Jain said. Jammu dining guideJammu and Kashmir tourism

The air travel disruptions caused by the recent tensions between India and Pakistan have left at least 1,895 Haj pilgrims from lammu and Kashmir stranded, prompting the J&K Haj Committee to consider operating additional flights to clear the backlog.

Speaking to KNO, Executive Officer of the Haj Committee, Dr Shujhat Qureshi, said that efforts were underway to accommodate those who were unable to fly earlier due to the disruptions. "For additional flights, we are waiting for approval from HCoI. We are expecting a schedule in the next 2-3 days", Dr Qureshi said.

According to official data, a total of 1,895 pilgrims have been impacted by the weeklong disruption and are currently awaiting rebooking. The J&K Haj Committee is in active discussions with the concerned agencies to arrange special flights and clear the backlog at the earliest.

As per the data, of a total of 3622 pilgrims from J&K and 242 from Ladakh, 480 have left from Delhi,10 from Mumbai, 2 from Hyderabad and 1461 from Srinagar, with the rest of the numbers remaining pending. As per the officials, there were a few fresh cancellations as well.

The disruptions have triggered anxiety among intending pilgrims and their fami-

gation on the Jhelum river but also boost power generation during lean winter months.

However, Mehbooba Mufti lashed out at Omar, accusing him of making "irresponsible and provocative" statements at a time when Jammu and Kashmir has suffered the most from the recent hostilities between India and Pakistan.

"J&K Chief Minister Omar Abdullah's call to revive the Tulbul Navigation Project amid ongoing tensions between India & Pakistan is deeply unfortunate. At a time when both countries have just stepped back from the brink of a full-fledged war—with Jammu and Kashmir bearing the brunt through the loss of innocent lives, widespread destruction and immense suffering such statements are not only irresponsible but also dangerously provocative," she said on X. "Our people deserve peace as much as anyone else in the country. Weaponizing something as essential and life-giving as water is not only inhumane but also risks internationalizing what should remain a bilateral matter.'

Omar hit back, accusing Mehbooba of trying to appease elements across the border for political mileage.

"Actually, what is unfortunate is that with your blind lust to try to score cheap publicity points & please some people sitting across the border, you refuse to acknowledge that the IWT has been one of the biggest historic betrayals of the interests of the people of J&K," Omar said on X.

He defended his stand against the Indus

Mehbooba responded by invoking Omar's political lineage, reminding him that once Sheikh Abdullah advocated for accession to Pakistan.

Dry fruit, Kehwa, saffron sellers in Lethpora, Pampore say they face losses after Pahalgam attack Seek govt intervention to revive Kashmir's tourism sector

Srinagar, May 16: The recent terrorist attack in Pahalgam has dampened the tourism sector in the Kashmir Valley, leaving local traders and vendors in Lethpora and Pampore in south Kashmir's Pulwama district struggling to survive.

As reported by the news agency—Kashmir News Observer (KNO), small-scale traders who depend heavily on visiting tourists, especially those selling dry fruits, saffron and the renowned Kashmiri Kehwa, are now facing a severe decline in customers and income.

The once-bustling Srinagar-Jammu National Highway, where tourists traditionally stopped to enjoy a warm cup of kehwa or purchase local produce, is now eerily deserted. Peak season trading, which usually brings



lively activity and prosperity, has abruptly turned into a period of silence and mounting concern.

"We're barely making even one per cent of what we used to sell before the attack," lamented Manzoor Ahmad, a dry fruit stall owner in Lethpora. "There used to be dozens of tourist vehicles stopping here daily. People loved our kehwa and bought it in bulk. Now, hardly anyone slows down or stops.'

Shabir Lone, who runs a kehwa stall near Pampore, expressed similar worries. "The attack has not only instilled immediate fear but has also shattered tourist confidence. Even those who had already booked their travel plans are cancelling. Nobody feels safe coming here anymore," he said with a worried look.

The economic repercussions are compounded by the emotional toll on these people. For many vendors, this seasonal income is their primary livelihood. "We have children to feed, loans to repay, and no savings to fall back on," said Gulzar Ahmad, a saffron seller. "If this situation persists, we may be forced to shut down our stalls permanently."

Govt Likely to Resume RTC Bus Services from North, **South Kashmir to Srinagar's City Centre**

Srinagar, May 16: In a move that could significantly ease commuting woes for passengers from North and South Kashmir, the Jammu and Kashmir administration is planning to allow State Road Transport Corporation(SRTC) buses to operate up to Jahangir Chowk in Srinagar, officials said.Reliable sources said that a high-level meeting is expected to take place soon to finalize the modalities of this much-anticipated decision. PM Surya Ghar Scheme Stalls in J&K: Six Months On, No Transition from JAKEDA to KPDCL

Srinagar, May 16:The ambitious PM Surya Ghar Muft Bijli Yojana, launched by the Union Government to promote rooftop solar adoption, appears to have entered a state of stagnation in Jammu and Kashmir. Over six months have passed since the scheme's introduction, yet applicants who had previously registered on the JAKEDA (Jammu and Kashmir Energy Development Agency) portal continue to remain in limbo—awaiting a seamless transfer to the Kashmir Power Distribution Corporation Limited (KPDCL) portal.

Despite early promises of integration and expedited implementation, there has been little to no movement in streamlining the application process, leaving both customers and vendors frustrated.

Take immediate steps for regularization of **CIC operators in RDD**

Touple of days back the Department of Information came out with a press release regarding the appointment of clerical staff in the Rural Development Department. The press release while quoting the Secretary of the concerned department said that 122 people are being appointed as junior assistants. It was made out while 120 people have been cleared for appointment as junior assistants with the selection of two people kept withheld for technical reasons.

The appointment of 122 persons as junior assistants in the Rural Development Department is a welcome step and it will lead to better working of the department. At the same time the department should think about the people who are working on contract basis over the past couple of decades. These people have been waiting for the regularization for years now and as on date the same is still pending. Despite repeated assurances the hapless fellows continue to work on

Around 180 people have been working as community information centre (CIC) operators in the Rural Development Department for the past 20 years or so. Despite spending so much time in the department the services of these people have not been regularized and they continue to yearn for the same. These CIC operators have given their youth to the department and discharged their services with utmost dedication and professionalism. As on date these people are paid a meagre amount of Rs. 10,000 as monthly wages.

Given the continuous price rise in the market the amount is too small and the CIC operators are at the receiving end. In 2014 then state government headed by Omar Abdullah passed an order regarding regularization of CIC operators. As the assembly elections were round the corner at that time the cabinet order could not be implemented. It was expected that the PDP-BJP government that came into existence in 2015 would take the process and regularize services of the CIC operators, but the same did not happen.

Since Omar has yet again become the CM of Jammu & Kashmir the onus lies on him in fulfilling this promise of his made more than a decade back. Since he is aware about the problems of CIC operators immediate steps should be taken to regularize their services. Once the CIC operators become permanent employees their problems would be solved and they will be absolved of the tension. The sooner it is done better it will be for the people yearning for their regularization.

The recent escalation between India and Pakistan has once again underscored the fragile nature of peace in the subcontinent. While the ceasefire agreement brings a temporary halt to hostilities, the uncertainty surrounding its longevity remains. The echoes of conflict still linger, and the people-especially those living near borders-continue to bear the brunt of geopolitical ten-

Prime Minister Narendra Modi, in his address to the nation, reaffirmed India's commitment to counterterrorism, stating that "Operation Sindoor" has set a new standard in India's fight against terrorism. He emphasized that India will not tolerate nuclear blackmail and will respond decisively to any threats against its sovereignty.

The military leadership echoed similar sentiments, highlighting the precision strikes that eliminated over 100 terrorists in Pakistan and Pakistan-occupied Kashmir 'as stated.

However, amidst the strategic operations and diplomatic maneuvering, one undeniable truth remains-'war brings death and destruction, and no one truly emerges as a winner. The devastation caused by prolonged conflict far outweighs any perceived gains. While some voices advocate for a decisive military operation to reclaim Pakistanoccupied Kashmir (PoK), they overlook the grave reality that Pakistan is also a nuclear-armed nation. From the outset of the strikes, Pakistan openly declared that any threat to its sovereignty would be met with nuclear retali-

The ceasefire agreement, brokered under intense international pressure, including former U.S. President Donald Trump's warning to halt trade with both nations, reflects the necessity of diplomatic intervention. While some may view this as external interference, the reality is that economic stability and global partnerships play a crucial role in maintaining peace.

Yet, beyond the political and military calculations, the

most tragic consequence of this conflict has been the suffering of civilians. Border residents, caught in the crossfire, have faced unimaginable losses. Homes have been reduced to rubble, livelihoods shattered, and families displaced. In Jammu and Kashmir's border villages, residents have been forced to abandon their homes in the wake of relentless shelling. A young schoolgirl from Uri moved hearts when she tearfully expressed that her family had lost everything they owned-their house, their belongings-forced to flee with nothing but the clothes on their backs.

Despite the devastation, the plight of these civilians remains largely ignored in mainstream discourse. The focus remains on military strategies and political maneuvering, while the voices of those who have suffered the most are drowned out. "Is it not unfortunate? Do their lives not matter?

The reality is stark-both India and Pakistan became test grounds for war machinery, with defense manufacturers reaping profits while civilians paid the price. The financial resources expended in this brief period of conflict could have been used to uplift millions living below the poverty line. Instead, they fueled destruction, leaving behind scars that will take generations to heal.

Most critically, those who advocate for continued war must understand the catastrophic consequences of nuclear conflict. The nuclear weapons possessed by both India and Pakistan today are far more powerful than those used in Hiroshima and Nagasaki. If either country were to deploy nuclear weapons, it would likely use its most destructive arsenal to ensure the enemy is unable to retaliate. But in doing so, the user nation itself would suffer irreversible consequences.

A nuclear strike on Mumbai or Islamabad would not only obliterate millions instantly but would also trigger a "nuclear winter" plunging the entire subcontinent into darkness and famine. Crores of people would evaporate at the point of impact, while those who survive would curse themselves for not perishing. The land would be barren, economies would collapse, and civilization as we know it would cease to exist.

Former Army Chief General Naravane aptly warned that "war is not a Bollywood movie"-it is not scripted for dramatic victories but is a grim reality where destruction is absolute. Those who casually demand escalation must reflect on the irreversible

consequences of their words. India's history offers invalu-

able lessons in resilience and strategic patience. The philosophy of "Ahimsa", which led to the British colonial exit, remains a testament to the power of nonviolent resistance. The nation's strength lies not in reckless aggression but in measured responses and long-term stabil-

Now, more than ever, both nations must prioritize trustbuilding and peace efforts. Kashmiris deserve a rightful place in discussions shaping the future, and political divisions must be set aside in favor of national and humanitarian interests. True strength is demonstrated not just in power but in restraint, and wisdom lies in knowing when to exhibit force and when to seek reconciliation.

History of our civilization offers two guiding principles: "no matter how powerful one may be, true strength lies in restraint," and never underestimate the complexities of your adversary". As India and Pakistan stand at this delicate juncture, it is time for wisdom to prevail-not through division and hostility, but through dialogue, diplomacy, and respect for diverse voices.

Noise To The Volselers

t's deep and hard to describe the peace that fills your soul when you finally finish your university degree, especially when it's the end of a Master's journey. It's a special kind of freedom and joy that words can't fully capture. That's how I felt on the evening I finished. I had finally got freedom from the endless cycle of assignment deadlines, exams, and research work.

I felt like a heavy weight had been lifted off my shoulders, like a thick cloak I had been carrying and surviving for years. I felt light, almost like I could float, as I walked through the university gates one last time. I held onto that feeling of peace, thinking it was the start of something beautiful. But I didn't know that life was already waiting for me outside those gates with a harsh lesson I never saw coming.

If I had known what was ahead, maybe I would have stayed a little longer in the comfort of university life. Maybe I would have chosen the stress I knew over the unknown pain that was waiting for me.

Just beyond those gates that once welcomed me with dreams and hope, life was waiting like a trap, ready to teach me something no classroom ever could. The lesson came not from books or lectures, but from a moment so painful and clear that it split my life into two parts: before and after.

That one moment-just a heartbeat-left a deep mark on me. It became a memory I carry like broken glass under my skin. Sometimes it stays quiet. Other times, it hurts all over again. But it never really leaves.

What a cruel twist, to spend years studying how to understand the world, only to be completely unprepared for what life actually had in store. All those achievements and grades suddenly meant nothing in the face of real, unexpected pain. It was a lesson in loss-one no university could ever teach-and the certificate I truly earned was written in tears, not

The degree that now gathers dust on my shelf has my name on it, written in fancy letters. But my real graduation happened at those



gates, where I lost my innocence and gained a different kind of knowledge.

A painful wisdom that took up space in my heart, in places that once held hope for a future untouched by grief.

Sometimes, I wish I could forget what I have learned. I wish I could go back to that final evening of peace, when my biggest worry was a deadline and my biggest hope was freedom. But once you have crossed certain lines in life, there's no going back. You just carry your pain forward, letting it change you. And maybe, one day, that pain will shape you into someone who can hold both deep sorrow and, hopefully, a greater kindness than you ever knew before.

Since leaving the farewell function in the seminar hall of my university that final evening of the final semester, not a night has passed that I haven't thought of the elderly man sitting alone on the stone bench near a street vendor's fruit juice stall.

His trembling hands clutched

a faded photograph as he rocked gently forward and back, silent tears carving paths down his weathered face. The graduation cap in his lap belonged to someone who would never wear it. He and I both knew that ceremony would remain forever incomplete-a celebration permanently silenced.

That moment has never left me-a man older than my grandfather, bearing the unbearable weight of an absence, alone on a campus emptying for summer break. With no consoling words to ease his pain. With no one stopping to notice.

Like once during a class lecture, my professor, Poornima ma'am,

"This world has failed to see private griefs. This generation has failed to honour the silent sufferers among us. We have failed to acknowledge the invisible burdens. We have failed to witness the quiet devastation hiding in plain sight."

Remembering this thought made my chest constrict. I saw him. I caught his gaze for the briefest moment and witnessed the abyss of loss that lives on still, in what remains of his shattered heart. I paused as he pressed the graduation tassel between his fingers, a tangible remnant of dreams extinguished too soon.

I remember approaching him near the exit gate of my university, where he sat immobile as students streamed past with laughter and relief. I wish I had rehearsed what to say, but words abandoned me. All I could feel was my breath-it felt like an ache, a heavy burden that was making my lungs too heavy with each gasp.

"Are you alright, sir?" I finally managed. "Is there anything I can

He paused, looked at me with eyes that had cried oceans for a very long time, and asked,

"Son, what troubles your heart? Let me listen to your burdens."

And so I sat down beside him, under the environment and atmosphere and the sad shadows of that evening. The blisters on his hands were forcing me to cry every

moment. It felt like these hands had also endured a lot of suffering.

I told him I was afraid. That university was supposed to prepare me for life, but I was struggling to see my path forward. That my pursued education couldn't guarantee me purpose or peace. He nodded as I spoke, with a wisdom earned through suffering. He kept calling me "son," offering his perspective when words failed me.

"Don't fear tomorrow, young man," he said, his voice steadying

"My son would have been just like you-questioning, searching."

In that moment-and in the hour that followed-I was seen. By a stranger carrying a grief I could barely comprehend.

He told me about his son. His only son. A brilliant student who would have walked across the graduation stage tomorrow if he had not lost his battle with depression three months earlier. The father had come to campus to sit where his son once sat, to breathe the air his son once breathed, to collect the degree his son had earned but would never receive.

This winter, I have now decided that I will volunteer at the campus crisis centre instead of taking the internship I had planned. As I prepare for this work, I am reflecting on what it means to truly see people-to create space for their stories, to listen without the urgency to solve or fix. During these next months, I will honour his son's memory by being present for others who struggle in silence.

That evening changed me in ways I am still discovering. From that bench to the counselling centre, I learned that behind every face on campus-professors rushing to meetings, cafeteria workers serving with tired smiles, students projecting confidence-there are stories of triumph and devastation we rarely glimpse.

People often romanticise acts of compassion, calling them heroic, but every person who chooses to witness another's pain eventually comes to understand that it is we who are transformed. In these sacred exchanges, we learn what it means to have nothing and everything at the same time. We meet people who are, quite literally, surviving the unlivable situations of life. Who understands the fragility of life more than we could ever comprehend? It is their resilience, their continued breathing despite it all, that teaches us the meaning of courage.

From this time forward, I hope to listen more deeply. I hope to create more space for the untold stories that surround us daily. I will remember that behind every composed face might lie an ocean of grief-or joy. And perhaps the weight we carry becomes lighter

PM Modi's address after Op Sindoor: A nation's resolve against terror

n May 12, 2025, Prime Minister Narendra Modi addressed the nation following the successful execution of Operation Sindoor. This 22-minute speech was not just a recounting of military achievements but a declaration of India's unwavering stance against terrorism and its sponsors. The Prime Minister's address underscored India's commitment to safeguarding its citizens and sovereignty, sending a clear message to adversaries and allies alike. The Prime Minister began by acknowledging the collective grief and anger that swept the nation after the Pahalgam terror attack on April 22, 2025, which claimed 26 innocent lives. He emphasized that the entire country stood united in demanding a decisive response. We gave full freedom to the Indian forces to wipe out the terrorists, he stated, highlighting the government's resolve to act against those who threaten India's peace.

Operation Sindoor launched in the early hours of May 7, 2025, targeting nine terrorist camps in Pakistan and Pakistan-

occupied Kashmir. The Indian Air Force executed 24 precision strikes using Rafale jets armed with SCALP missiles and AASM Hammer bombs. The operation lasted approximately 23 minutes and was described as focused and non-escalatory, aiming to dismantle the infrastructure of groups like Lashkar-e-Taiba and Jaishe-Mohammed without causing civilian casualties. The choice of the name Operation Sindoor was deeply symbolic. In his address, PM Modi stated, The enemy has now realised the consequences of removing Sindoor from the foreheads of our women, referencing the cultural significance of Sindoor as a symbol of marital status and the pain inflicted on families by terrorism. His emotional tone resonated deeply across the country, especially with those who had lost loved ones. Beyond the military response, India undertook several diplomatic and strategic actions to isolate Pakistan. These included suspending the Indus Water Treaty, halting bilateral engagements, and sealing the Attari border. These measures aimed to convey that India would not tolerate any form of support for terrorism and would use all available means to protect its interests. PM Modi reinforced that India is now a proactive nation that will not wait for another tragedy to act.

A significant moment during the post-operation briefing was the presence of Colonel Sofiya Qureshi, a Muslim officer, Wing Commander Vyomika Singh, a Sikh pilot, and Foreign Secretary Vikram Misri, a Kashmiri Pandit. Their joint appearance symbolized India's unity in diversity and the collective resolve of its people to stand against terrorism, irrespective of religious or cultural backgrounds. That press briefing image will forever stay in our national memory, representing not just three officers, but the spirit of a billion Indians. Modi mentioned this unity in his speech as the real strength of Bharat. While the physical operation was underway, India faced a series of cyberattacks from state-backed hackers and hacktivist groups across several countries. These attacks targeted critical infrastructure, including defense, transportation, and financial sectors. Despite the intensity of these cyber threats, Indian cybersecurity agencies successfully mitigated the risks, ensuring the nation's digital infrastructure remained secure. The PM praised the agencies for their vigilance and assured the public that India's digital defenses are

PM Modi's address was not limited to recounting events but carried a warning too. He stated firmly that if Pakistan or any other nation sponsors terror again, the response will be even more decisive than Operation Sindoor. India has said no to terror, and the world has heard that loud and clear. In PM Modi's own words, Terror and Talks cannot go together. 

Researchers find molecule to kill sexually transmitted chlamydia



A team of international researchers has discovered a type of molecule that can kill chlamydia bacteria -- the world's most common bacterial sexually transmitted disease with 130 million cases a year -but spare bacteria that are important for health.

The team from Umea University, Sweden, and Michigan State University, US, identified more than 60 possible anti-chlamydia molecules.

India pharma market sees 7.8 pc revenue growth in April: Report

NEW DELHI

India's pharmaceutical market (IPM) continues its growth in April with 7.8 per cent year-on-year (yoy) in revenue, according to a report on Thurs-

The report, by rating agency India Ratings and Research (Ind-Ra), showed that the growth was driven by the price hikes taken by companies with volume growing 1.3 per cent yoy. Almost all major chronic therapies also showed positive value and volume growth.

"Ind-Ra expects IPM to grow to the tune of 7 per cent-8 per cent yoy during growth -- 2.8 per cent yoy April 2025 where value FY26, with sustained growth momentum in the chronic therapies, led by price increases and product launches," said Nishith Sanghvi, Director, Corporate Ratings, Ind-Ra.

UEFA accuses Infantino & stages **FIFA congress** walk-out

ASUNCION, MAY 16 (UNI)

UEFA accused Gianni Infantino of prioritising "private political interests" after FIFA's president turned up late for the world governing body's own congress in Paraguay.

Infantino has been on a diplomatic tour of the Middle East alongside United States President Donald Trump and arrived two hours and 17 minutes past the scheduled 10:30 start time (14:30 BST) for the FIFA event.

Infantino said his trip prior to the congress had been crucial as it allowed him "to represent football" in "important discussions" with "world leaders in politics and economy".

In protest at the 55-year-old Swiss-Italian's delayed arrival, UEFA president Aleksander Ceferin led a group of European delegates, joined by Football Association chair Debbie Hewitt, in staging a walk-out during a break at the event.

It meant there were clearly empty seats at the Conmebol Convention Center in Luque, on the outskirts of the Paraguayan capital of Asuncion, when the meeting resumed.

UEFA said in a statement the "lastminute changes" to the timings were "deeply regrettable" but "a point" had to be made, the BBC reported.
