E-ZERO FIR ; Smart Way to Nab Cyber Criminals With Unprecedented Pace : HM Amit Shah

NEW DELHI, MAY 19: The Indian Cybercrime Coordination Centre (I4C), which comes under the Ministry of Home Affairs, introduced the new e-Zero FIR initiative to nab cybercriminals with unprecedented speed, Union Home Minister Amit Shah said on Monday.

Launched as a pilot project for Delhi, the new system will automatically convert cyber financial crimes filed on the National Cybercrime Reporting Portal (NCRP) and helpline number 1930 to FIRs, initially above the threshold limit of Rs 10 lakh, he said.

The minister said the initiative will



soon be extended to the entire nation. "The MHA's Indian Cybercrime Coordination Centre (I4C) introduced

the new e-Zero FIR initiative to nab any criminal with unprecedented speed.

"Launched as a pilot project for Delhi, the new system will automatically convert cyber financial crimes filed at NCRP or 1930 to FIRs, initially above the threshold limit of ?10 lakh. The new system, which will drive investigations swiftly cracking down on cybercriminals, will soon be extended to the entire nation," Shah wrote on 'X'.

The home minister said the Modi government is bolstering the cybersecurity grid to build a cyber-secure Bharat.

Strong gusty winds claim girl's life, livestock losses, widespread damage across Kashmir

Houses, shops, masjids, shrines affected; 600 trees in Pulwama apple farm uprooted

Srinagar, May 19: A girl died while three others were wounded after a tree fell on a temporary tent in Kellar area of Shopian district following strong gusty winds late Sunday night, which caused huge damage to public properties.

The strong winds damaged the rooftops of several houses, shops, masjids as well as shrines across the valley. Extensive damage has been

reported to the apple farms in south Kashmir's Pulwama district.

As per the details obtained by the news agency, a tree fell on a temporary tent in the Kellar area of Shopian,

resulting in the on-spot death of a girl, Sobiya Riyaz, daughter of Muhammad Riyaz.

Three others, who sustained injuries in the incident, have been identified as Muhammad Riyaz, Rubeena and Saima Kousar. They belong to Rajouri and were presently putting up in a tent in Gadder forests.

This is expected to enhance scientific capabilities and eliminate redundancy.

For the Town Planning Organisation (TPO), the focus is on strengthening town planning functions to meet the growing demands of modern urban development. The restructur-

Mr Misri also told the Standing Committee on External Affairs that US had no role in the cessation of the conflict and Pakistan had reached out to India on May 10 afternoon after the precision strikes by Indian Defence forces on Pakistani military installations including the Nur Khan air base.

Mr Misri who gave a detailed briefing to the Standing Committee on Operation Sindoor, said there was no 'third-party mediation, sources said.

The Foreign Secretary said the government had made it very clear that neither Mr Trump nor his administration played any significant role. The plea for a ceasefire came from Pakistan and India agreed to listen and cease hostilities because targets set under Operation Sindoor had been met when nine terrorist camps including five in POK, were destroyed.

Plea for a ceasefire came from Islamabad, specifically from Pakistan's Director-General of Military Operations who reached out to his Indian counterpart, Mr Misri told the Committee.

He, however, declined comment if any Indian fighter jet had been shot down by Pak, citing national security constraints.

Investigations have revealed that Abdul Aziz carried out the grenade attack on instructions received from Nazir Ahmed, who is currently operating from Pakistan.

Nazir Ahmed had exfiltrated to Pakistan in 2001, where he joined the proscribed terror outfit Hizbul Mujahideen (HM) and later became associated with the Jammu Kashmir Gaznavi Force (JKGF), he said.

He added that towards the end of 2022, Nazir Ahmed re-established contact with Abdul Aziz, his relative, through encrypted messaging applications using Pakistan-based numbers. During this time, he radicalized and recruited Aziz into HM/JKGF, instructing him to carry out grenade attacks in District Poonch to further the terror outfit's agenda and ideology.

Nazir Ahmed not only indoctrinated and recruited Abdul Aziz but also supplied him with hand grenades and detailed instructions for the execution of the attack through encrypted communication channels, the spokesman said. He added that the investigation revealed a wider conspiracy by the Pakistan-sponsored Hizbul Mujahideen to destabilize the Union Territory of Jammu and Kashmir.

Pakistan," he added.

The morale of Pakistani troops is low following Operation Sindoor and the sub-sequent Indian response, he said.

"All intercepted communications point to the fact that the morale of Pakistani troops is down," he said, adding that Indian troops are maintaining high morale.

He stated that the proxy war waged by Pakistan has forced India to respond in a befitting manner.

"We will not tolerate such actions," the officer asserted.

Men and machines are in full operational readiness along the LoC, maintaining a high degree of vigilance over adversary movements south of the Pir Panjal range.

"We are on high alert round the clock, monitoring every movement along the border. We are fully prepared," said an officer commanding a unit deployed along the LoC. (Agencies)

Haryana police officer claimed on Sunday.

She was allegedly in touch with a Pakistani officer posted at the Pakistan High Commission in New Delhi during the fourday military conflict between India and Pakistan that followed the April 22 terror attack in Pahalgam, the officer said.

Hisar Superintendent of Police Shashank Kumar Sawan said Malhotra did not have any direct access to any information related to the military or defence operations which could be said at this stage that she could have shared.

But she was directly in touch with PIOs, he said addressing mediapersons in Hisar, Haryana.

"Certainly, they were developing her as an asset. She was in touch with other You-Tube influencers. They were also in touch with PIOs," the SP said.

"This is also (a kind of) warfare, in which they try to push their narrative by recruiting influencers," he said.

Hisar-based Malhotra (33), who runs a YouTube channel, 'Travel with JO', was arrested from New Aggarsain Extension on Friday, they said.

She has been booked under relevant sections of the Official Secrets Act and the Bharatiya Nyaya Sanhita, police said.

She was sent to a five-day police remand after being produced before the court on Saturday.

SP Sawan told reporters that Malhotra is being questioned by Haryana Police. "We are analysing her financial transactions, travel details, where she went and whom she met," he said, adding that the police are also in touch with the central agencies.

The officer said Malhotra was in touch with PIOs, and that she has visited Pakistan "multiple times" and China once.

Asked about any information on her movements during the Pahalgam terror attack and whether she was in contact with the Pakistani officer posted at the Pakistani High Commission during Operation Sindoor, the SP said during the (India-Pakistan) conflict, she was "in touch with the PIOs and the person who was declared persona non grata". "We will do a forensic analysis of her laptop and other electronic gadgets. It will then be clear what information she shared." he said. While she did not have any access to information on military operations, she was directly in touch with PIOs, he added. He added that multiple teams of financial experts were analysing her financial transactions and travel details. The officer said she has been to Pakistan on what appeared to be "a sponsored trip". In one of her videos, she was requesting a visa to visit China, he said. The SP said she went to Kashmir before the Pahalgam attack and visited Pakistan before that, and added that police are also trying to establish the "link" between these visits.

he said, adding that she has been on the radar of intelligence agencies for quite some time.

The SP refused to share details of any chat between Danish and Malhotra, saying it was a sensitive matter. "We are investigating the case from all angles," he added.

Malhotra, whose YouTube channel and Instagram account have 3.77 lakh subscribers and 1.33 lakh followers respectively, allegedly was in contact with the Pakistani staffer working at the Pakistan High Commission in Delhi.

In 2023, Malhotra came in contact with Ehsan-ur-Rahim alias Danish at the Pakistan High Commission where she went to seek a visa to visit the neighbouring nation, according to an FIR lodged at Civil Lines Police Station on May 16.

Malhotra, who visited Pakistan twice, had met Danish's acquaintance Ali Ahwan who arranged her stay there, the FIR read.

She met Danish several times at the Pakistan High Commission in Delhi and was found to be in touch with PIOs, it said. Ahwan arranged Jyoti's meeting with Pakistani security and intelligence officials. She was in contact with them through WhatsApp, Telegram and Snapchat, and passed on sensitive information, according to the FIR.

On May 13, India expelled the Pakistani official working at the High Commission for allegedly indulging in espionage. Later on Friday, Malhotra was arrested in Hisar.-(PTI)

The DoPT, as the cadre-controlling authority of IAS officers, compiles the Civil List annually using inputs from central records and state cadres. The 2025 edition reflects a total authorized cadre strength of 6,877 officers, with 5,577 officers in active service across 25 state cadres.

The launch event was attended by several senior dignitaries, including Director General of the Indian Institute of Public Administration(IIPA)Mr. S.N. Tripathi, Director and Chairperson of the Lal Bahadur Shastri National Academy of Administration (LBSNAA) Sriram Taranikanti, IAS, and Secretary, Department of Personnel and Training (DoPT), Rachna Shah, along with other senior officials.



Jammu Development Authority (JDA) has already received approval from its Board for its restructuring proposal, which has been forwarded to the Administrative Department for further consideration.

Srinagar Development Authority (SDA) shall see a detailed comparative restructuring of both gazetted and non-gazetted posts to enhance project execution capabilities and improve policy implementation across expanding urban areas.

The meeting was also told about the Urban Environmental Engineering Department (UEED) reorganisation which focuses on strengthening technical manpower and introducing reforms to improve scientific waste management, drainage, and sanitation systems.

"In our area of operation, we carried out seven of the nine precision strikes under Operation Sindoor, effectively destroying terror infrastructure," he added.

Pakistan"s retaliatory attacks targeted civilian and Army areas but caused no significant damage, he said.

"There was hardly any damage from their side. They targeted multiple locations using drones, missiles, and artillery, but our air defence systems responded meticulously and neutralized all threats," he said.

Under Operation Sindoor, India on early May 7 destroyed nine terror infrastructures in Pakistan and Pakistan-Occupied Kashmir (PoK) in retaliation to the April 22 Pahalgam terror attack. Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10. The two sides reached an understanding on cessation of hostilities on May 10 after four days of confrontations.

The Army official said Pakistan also attempted to attack a divisional headquarters and two brigade headquarters, but no damage was inflicted.

"In retaliation by our troops south of Pir Panjal, around 50 fatalities were inflicted on the adversary as we targeted their military formations," the official said.Jammu dining guide

Sawan said she was allegedly also in touch with other YouTube influencers. "They were also in touch with PIOs," he said.

Midnight Blaze Guts 20 Shops, 5 Houses in Sumbal; PDP Leader Announces Relief

Sumbal, May 19, : A devastating fire broke out at midnight in the main market of Sumbal in North Kashmir's Bandipora district, reducing at least 20 shops and five residential houses to ashes, officials said on Monday. According to fire department sources, the blaze is believed to have started from one of the commercial structures and quickly spread to nearby buildings, engulfing both resi dential and commercial properties in the vicinity. Fire tenders from Sumbal, Batwina, and Safapora fire stations, operating under the Ganderbal command, were rushed to the spot to control the inferno. With the help of police and local residents, the flames were eventually doused after several hours of intense firefighting. "There was chaos in the area as the fire spread rapidly during the night. It took several hours of coordinated efforts to bring the situation under control," said a local eyewitness. Fortunately, no loss of life was reported, but the material losses are estimated to be significant. Many shopkeepers, especially those without insurance, are now facing severe financial distress. Visiting the site of the incident, PDP leader and former MLC Yasir Reshi expressed solidarity with the victims and announced immediate relief of Rs 50,000 each for affected families and uninsured shopkeepers. He called for swift government intervention to assist those who have lost their livelihoods and homes.Reshi also criticized the poor preparedness of the fire services in the area and urged the government to upgrade the local fire station. "The fire station at Sumbal is illequipped. In the past, it had three fire tenders, but now only one remains. This needs immediate attention from the administration," he said.Locals echoed the demand, stressing the need for better emergency response infrastructure to prevent such incidents from escalating in the future.

SRINAGAR, MAY 19: Srinagar, May 19: In the face of a grave humanitarian crisis triggered by continuous shelling and cross-border hostilities, the Sub-Division Uri witnessed an extraordinary display of dedication, coordination, and public service. On 7th May 2025, a 24×7 Emergency Control Room was swiftly established at Government Higher Secondary School (GHSS) Uri, under the direct supervision of the Sub-Divisional Magistrate (SDM), Uri.The situation in Uri had rapidly escalated, with heavy shelling endangering civilian lives and disrupting normal life. DC Srinagar Inspects Bemina Grid Station, 93% Power Restored After Windstorm

Vanishing Fields: India's elderly farmers watch as farmland turns to factories

tith 15% of J&K's cultivable land lost in 12 years, a way of life-and food securityhangs in the balance. As elderly farmers in Kashmir and beyond sell their ancestral fields, a nation risks losing more than crops; it's losing centuries of wisdom, one bulldozed acre at a time. Once vibrant with the sounds of ploughs, rustling crops, and birdsong, the farmlands of India are today increasingly silent. Where golden wheat once swayed and buffaloes bathed in canal water, now stand steel warehouses, factories, and concrete industrial complexes. For many elderly farmers, this transformation is not a sign of development, but a painful reminder of a disappearing way of life.

Across India, land that was lovingly cultivated for generations is being sold off or acquired for industrial use. With it, not only is the agricultural output declining, but a cultural and ecological loss is also unfolding. Elderly farmers, once the backbone of India's food economy, now watch helplessly as their heritage turns into commercial zones.

Agriculture: The Declining Backbone

Agriculture has historically been the mainstay of Jammu and Kashmir's economy. Crops like rice, maize, wheat, saffron, and vegetables thrived across the Kashmir Valley and parts of Jammu. The region's apples, walnuts, and almonds were once symbols of its agrarian strength and cultural pride.

But over the past decade, agricultural land has been shrinking rapidly. According to government data, over 15% of cultivable land has been diverted for non-agricultural use in the last 12 years. This includes land allocated for industrial estates, government offices, brick kilns, road expansion, and private construction.

The trend is most noticeable on the outskirts of cities like Srinagar, Anantnag, Pulwama, Jammu, and Udhampur – where lush farmland is being flattened to accommodate commercial warehouses, cement plants and malls.

The loss of agricultural land may not be immediately visible amid the new buildings and roads, but its impact will be deeply felt in food supply, employment, culture, and ecology.

The Shift to Industry



boundaries deeper into rural areas. State governments, eager to attract investments and create jobs, often promote the development of industrial estates and special economic zones (SEZs) on agricultural land.

While these developments may create employment in the short term, they often come at the cost of selfsustaining local economies and food security.

According to a 2024 report by the National Agriculture Commission, India has lost over 12 million hectares of farmland to non-agricultural use in the past two decades – a significant portion of which came from smallholder farmers, many of them elderly.

Elderly Farmers: A Dying Breed Elderly farmers possess knowledge that has been passed down for generations – knowledge of soil health, natural pest control, crop timing, and water conservation. But with the decline of farming, this wisdom is being lost. Few young people are willing to inherit this profession, preferring urban jobs and lifestyles.

"There's no one to carry forward what we know," laments 75-year-old Kamalamma from Karnataka. "Our children say farming is hard work and gives nothing. But without food, what will their industries eat?" In many villages, ageing farmers now live alone on shrinking plots or survive on government pensions after selling their land. They feel abandoned, not just by their families, but by a country that once celebrated them as "annadatas" – providers of food.

Environmental and Food Security Concerns

The rapid conversion of farmland into industrial zones also poses serious environmental threats. Factories bring pollution, deplete groundwater, and often make surrounding areas unfit for cultivation. The disappearance of green cover also contributes to rising temperatures and climate imbalance.

Moreover, with fertile land disappearing, India's agricultural output is under strain. The country, which once boasted self-sufficiency in food, is now facing increasing reliance on imports for pulses, edible oils, and even some cereals.

Dr Arvind Rao, an agricultural economist, warns, "If we continue to trade agriculture for industry without balance, we are risking both food security and rural livelihoods. Elderly farmers know how to farm sustainably. Their knowledge is an asset we are discarding." A Cry for Balance Activists and rural development experts are urging governments to protect agricultural land through stricter zoning laws, offer better incentives for sustainable farming, and create programs that involve elderly farmers as mentors and guides.

In some states like Kerala and Himachal Pradesh, grassroots initiatives have started to reclaim abandoned land for organic farming, with elderly farmers leading the way. They're training young volunteers and reviving indigenous crops – but these efforts are still limited and need broader support.

Conclusion

The story of elderly farmers and their lost lands is not just about economics – it's about identity, sustainability, and respect for those who built the foundations of the nation's food systems.

Elderly farmers are not just watching their fields vanish – they're witnessing the erasure of an entire way of life. In the race for industrialisation, let us not forget the quiet wisdom in the fields we leave behind. Who is the beneficiary? Reservation: Generational Privilege or Real Justice?

he issue of reservation in India has always been a sensitive and controversial topic. It is considered an important tool for social justice, economic equality, and redressal of historical oppression. But as time passed, the concept of reservation seems to have deviated from its original objectives. Recently, the statement of Supreme Court judge Justice B.R. Gavai takes this debate in a new direction, in which he said that the decision to exclude affluent people from reservation should be taken by the Parliament. His statement raises many questions-is the real benefit of reservation reaching the class for which it was created? Does this system now demand reform and reconsideration?

The basic purpose of reservation

Reservation was introduced with the aim of eliminating the deep social inequalities prevalent in Indian society and bringing the deprived communities into the mainstream for centuries. It was a means by which social, educational, and economic backwardness could be removed and all sections of the society could get equal opportunities. Constitution maker Dr. Bhimrao Ambedkar presented reservation as a temporary measure so that Dalits, tribals, and backward classes could get justice and opportunities. His aim was to create a society where there is no place for caste discrimination and social oppression. It was not limited only to government jobs and education but was a bold step towards a holistic social reform.

The real face of the problem But, gradually, this system is

becoming a generational privilege for those families who have already been empowered. Justice Gavai's observation that when a person becomes an IAS or IPS, his children do not face the hardships of the same society points to an important truth. An officer's family is far removed from the real underprivileged due to higher education, a better lifestyle, and easy access to resources. This situation can be seen not only in government services but also in the private sector, higher education institutions, and other professional sectors. In such a situation, the question arises whether it is justified for these families to continue getting the benefit of reservation.

The necessity of economic support

The main objective of reservation was not only to eliminate caste discrimination but also to eliminate economic inequality. But today the basis of reservation is mostly based on caste identity, whereas in reality economic status should also be an important factor. Talking about excluding the afflu-

ent classes from reservation can be a necessary step in this direction so that the benefits can reach the people who are really in need. This approach will not only ensure a more equitable distribution of resources but will also promote a sense of real equality and justice in the society.

Social challenges of reservation The system of reservation often

falls prey to political gains and vote bank politics. This leaves the truly needy sections behind. In addition, a kind of class division has started emerging even within the reserved categories, where some families are continuously taking advantage of this facility, while others are still marginalized. This trend not only weakens the basic purpose of reservation but also increases social tension and a sense of injustice.

Responsibility of Parliament

Now the time has come for the Parliament to seriously consider this issue. It has to be decided whether the benefit of reservation should be limited to those families who are actually deprived and backward. This change will be in line with the basic spirit of social justice for which the system of reservation was created. This decision is important not only from a legal but also from a moral and social point of view. Also, it demands a system that can review the relevance of reservations from time to time.

Direction of solution

The benefit of reservation should be limited to one generation only.

Caste and economic backwardness should be properly assessed by including an economic basis. Children from affluent families should be kept out of the reservation so that its benefits reach the real needy. Reservation should be reviewed at a fixed period so that its real beneficiaries can be identified. Inclusive policies in education and employment should be promoted so that all sections can get equal opportunities. Transparent research and surveys should be conducted from time to time on the effectiveness of reservation so that the status of its real beneficiaries can be assessed. Education and skill development should be improved at the regional and rural level so that the real potential of the deprived sections can be enhanced. Reservation policy should be viewed from a long-term and impartial perspective by limiting political interference.

A new dawn

Reservation is a sensitive and complex subject, but its framework needs to change with time. Justice Gavai's statement points to an important debate that can shape the progress of our society and the new definition of justice. If we truly want to build an equitable society, we must reform and restructure the policy of reservation with time. This will not only respect the basic objectives of the Constitution but also be a necessary step towards a better and more just society.

Gaza's graveyard of Illusions: How Israel's narrative collides with military failure

Sraeli Prime Minister Benjamin Netanyahu is a skilled salesperson, though the product he peddles is deeply flawed. His current challenge is to convince himself, his people, the region, and the world that, despite significant setbacks, he is winning the strategic war against his adversaries.

Former Israeli national security officials, while employing different terminology, essentially convey the same conclusion. They describe Netanyahu as a "master tactician" but "not a master strategist," as reported by CNN. In an article detailing one of Netanyahu's grandiose, yet hollow, pronouncements of aspiring to control the Middle East, CNN's headline declared that "The Endgame is unclear as ever."

Netanyahu and his extremist allies are acting in defiance of reality. They either believe, or wish to believe, that the endgame is perfectly clear.

According to Finance Minister Bezalel Smotrich, Israel is operating under a grand military strategy, one that will culminate in "Syria being dismantled, Hezbollah being severely defeated, Iran being stripped of its nuclear threat, Gaza being cleansed of Hamas, and hundreds of thousands of Gazans being displaced to other countries."

Smotrich's extensive list, communicated at the end of April, concluded with Israel emerging "stronger and more prosperous." This wish list aligns closely with a similar list presented by Netanyahu last March.

However, Netanyahu, desperate for immediate political capital, chose to boast about purported achievements rather than future goals. He claimed to have already brought his enemies to their knees



and "destroyed the remnants of the Syrian army."

This latter claim refers to Israel's unilateral actions against Syria last December, a nation embroiled in internal strife and not actively engaged in war with Israel. In essence, Israel fabricated a major war front in the absence of actual conflict and declared itself the decisive victor.

Rarely do Israeli leaders publicly articulate their nation's true intentions with such stark language. They often frame war, colonial expansion, and even genocide using terminology palatable to Western mainstream media and public: Israeli aggressions are portrayed as self-defense, and the construction of illegal settlements as self-preservation.

However, the political discourse emanating from Israel lately strikes a different tone. One might argue that Israel, ostracized by much of the world and led by individuals facing criminal charges, no longer feels compelled to conceal its genuine aims. This is incorrect, however, as Israel is now more than ever desperate to provide any rationale, however feeble, to justify its extermination of the Palestinian people in Gaza.

Indeed, were Israel not concerned about accountability, it would not dedicate significant time and resources to defending itself in the world's highest legal and criminal courts, nor would it issue travel warnings to its soldiers or conceal their identities for fear of prosecution.

Israel's inflated political rhetoric and its pronouncements of imaginary achievements are a form of hype aimed at preserving its image as a powerful regional player capable of not only influencing political outcomes but fundamentally shaping the entire Middle East.

The irony of this hype is that Israel has been attempting, and failing at an unprecedented cost, to conquer Gaza, a devastated, tiny territory with a starving population still reeling from the impact of the ongoing Israeli genocide. Even venturing a few hundred meters into Rafah or Khan Yunis continues to result in deaths and injuries within the Israeli army, which is struggling to amass the necessary numbers for large-scale offensives within the Strip.

One must, however, distinguish between Israel's intentions and its failure to realize them. Indeed, dominating the Middle East has been the formula driving Israel's actions for decades. In fact, there is an official document that details Israel's regional ambitions: "A Clean Break: A New Strategy for Securing the Realm."

This document was prepared in 1996 by Richard Perle, a prominent neoconservative intellectual and a close associate of Netanyahu, for the so-called Study Group on a New Israeli Strategy Toward 2000. It aimed to guide Israel toward a more assertive policy that rejects the "comprehensive peace" notion, advocating for destabilizing the region and "rolling back" threats, specifically those emanating from Syria, Lebanon, Iraq, and Iran, among others.

The US invasion of Iraq in 2003 presented a golden opportunity for some of these goals to be achieved, though the ultimate outcome fell short of the overall objectives. Humiliated by the failures of his army and intelligence throughout the Gaza war, and facing immense pressure from a deeply discontented public, Netanyahu knows that his legacy, which he had hoped would be remembered as the greatest among all Israeli leaders, will instead be marred by controversy and disgrace.

Thus, Netanyahu is re-engaging in Perle's old strategy, though under entirely different circumstances. To "secure the realm" would imply that Israel is indeed in control, possesses incomparable military strength, and that its adversaries are willing to accept their diminished role in this Netanyahu-crafted Middle East.

But even a skilled salesman, or "great tactician," cannot market genocide as a victory, nor can a disreputable and dysfunctional army secure a strategic triumph.

Israel has clearly failed to secure any genuine or lasting victory, and the obvious solution is for Israel to be reined in and held accountable for its crimes in Gaza and throughout Palestine. The Middle East would then be poised for true stability, peace, and even prosperity, free from Israeli scheming and the relentless pursuit of more war fronts and illusory victories.

In a remote Budgam school, a limping educator with a magic bag becomes parent, nurse and cultural guardian to children who shout 'Me first!' for his affection

Got a chance to visit an elementary government school in a remote area of my district, Budgam, as an educator-cumacademic monitor. I met a gifted teacher spreading fragrance amid a bunch of doleful kids at a primary government school. I saw a teacher with a white beard, sitting with one leg stretched out among beautiful kids.

In excitement, I started asking questions to the kids based on FLN-that is my duty. They answered all the questions. The teacher, whom I initially considered a weak and ordinary educator, shouted in amusement, "It is we who taught them!"

Then suddenly, a blooming bud, perhaps from a pre-primary class, started shouting at the teacher in smattering Urdu: "Shar... Shar... Shar... shirt ka button gir gaya!" – "Sir, the button of my shirt fell off." It sounded so cute.

I carefully watched the situation. Instead of taunting the child, the teacher pulled out a thread and needle from his handy bag and stitched the button back on. I was happy to see the educator in focus with his armoury.

We started walking on the school lawn. The teacher was limping-perhaps suffering from gout, which he was, in fact, when I enquired. On the school lawn, I saw an innocent kid with dust on his face who had fallen down. The teacher rushed towards him, took him to the washroom, pulled off his clothes, and bathed him. He had soap in his handy bag.

I started realising that I had a great opportunity to learn a lot from this great teacher. Therefore, I stretched the discussion longer and decided to stay at this small government primary school located on a hill with lush greenery for the whole day.

There were almost 15 students in the pre-primary classes (nursery, LKG, etc.). Then came lunchtime. The bell rang: Than... Than...

I was curiously watching the scenario, intending to know what next from this great educator. Then came the 15 blooming buds, who sat and formed a beautiful half-moon on the green park. They were served with MDM.

This great educator folded the sleeves of his shirt and started mouth-feeding them one by one. The kids started shouting, "Me first, me first, me first..." It was ecstatic to watch. I was in a poetic frenzy.

They were very happy. How could these kids miss their parents in such a setting with this great educator? I asked myself.

After lunch, the kids started playing, and we began our lunch. All of a sudden, we heard a scream. I smiled and thought– what next?

The great educator left his lunch and ran towards the scream with his handbag. I too followed. A kid had a bruise near his left elbow, perhaps struck by the school fencing.

The educator opened the zip of his handbag and pulled out an antiseptic tube with pure love and affection, covering the bruises of the kid. I was very surprised to see all this. I, as an educator, got to learn so much.

The walls of the school were painted with beautiful colours and pictures depicting discipline, character, and moral behaviour. When I asked this legend about the source of the money used for painting the walls so beautifully, the reply shocked me: "From my salary. Getting 70K, I can afford to spend 10K."

I could see some kids aged 3 to 4 sitting

in his lap, trusting him more than their parents.

The corner of the lawn attracted me. I saw a tin shed of 6 by 8 feet. I was very eager to enter this tin shed. There were Kashmiri cultural items placed so beautifully. The teacher intended to help the kids learn about their Kashmiri culture, to link culture with education. "The articles placed here were collected by me from nearby villages," he replied.

The paintings of great personalities on the corridor walls were awesome. Each painting contained a brief life history of that personality.

I was intending to spend more time with this great personality to learn more, but the last bell of the school rang: Than... Than... Than...

The legend disappeared. I saw him at the school gate, hugging and kissing these little angels one by one, reciprocating love, wishing them well. It appeared as if the students did not want to leave him. He, too, was going to miss them.

The handy bag was still there, hanging from his arm, ready to come to the rescue of these angels. I was completely moved. I bid him goodbye. I learnt a lesson to follow.

This all reminded me of Khalil Gibran: "Your children are not your children.

They are the sons and daughters of

Life's longing for itself. You are the bows from which your children as living arrows are sent forth.

The Archer sees the mark upon the path of the infinite, and He bends you with His might that His arrows may go swift and far.

Let your bending in the Archer's hand be for gladness;

For even as He loves the arrow that flies, so He also loves the bow that is stable."

DDC, MD JJM review Jal Jeevan Mission implementation in Kulgam

KULGAM, MAY 19: District Development Commissioner (DDC) Kulgam, Athar Aamir Khan, along with Mission Director (MD), Jal Jeevan Mission (JJM), Khurshid Ahmad Shah, today jointly chaired a review meeting to assess the progress and implementation status of the Jal Jeevan Mission (JJM) in the district.

Chief Engineer PHE Kashmir, Superintendent Engineer PHE HYD Circle Anantnag/Kulgam, ACD, Technical Advisor Kashmir JJM- JK, Executive Engineers of PHE Division Kulgam/ Qazigund, PHE-Mechanical and other concerned officers were present in the meeting.

Both the officers were apprised about the present position of projects

through a powerpoint presentation. As per the figures, the district consists of 61,122 rural households out of which 53,871 households have been provided with Functional Household Tap Connections (FHTCs) till date. 143 civil schemes and 16 mechanical schemes are in the scope of execution under JJM out of which 108 and 7 respectively have been commissioned. 259 works have been executed comprising of one Dug well, 4 Bore wells, 18 Rapid Sand Filtration Plants (RSFPs), 131 Pipe Networks, 15 Slow Sand Filtration Plants (SSFPs) and 92 General Service Reservoirs' (GSRs).

District Development Commissionerand Mission Director JJM impressed upon all the officers of Jal Shakti Department to take responsibility of



the execution of works under JJM and work with utmost dedication

and sincerity, and provide FHTCs to the remaining 7251 households. They

stressed upon the officers to gear up the execution of works without further delay so that the remaining people of the district are facilitated with the piped drinking water.

District Development Commissioner&MD fixed timelines on execution of different works and directed the concerned officers to ensure completion of these works within the given timelines. They also took a detailed review of various other schemes sponsored under JKIDFC and NAB-ARD, besides reviewing the Mechanical schemes. The chair was also informed that 42 villages in the district have been certified as Har Ghar Jal (HGJ) villages. Locals and attendants have raised concerns about administrative delays, questioning why no interim arrangement has been made to ensure uninterrupted testing services. "This is not just a machine, it's a lifeline for patients, especially expectant mothers who need regular monitoring," said a local resident outside the hospital. [KNT]

A key agenda of the meeting was an indepth review of the Jal Jeevan Mission, the national flagship programme aimed at providing assured tap water supply to every rural household. The Vice Chairperson instructed concerned departments to mobilize resources, eliminate delays, and ensure last-mile delivery with urgency.

DC Reasi reviews readiness for Outreach Camps in 44 Tribal Villages

REASI, MAY 19: Deputy Commissioner(DC)ReasiNidhiMalikchaired a comprehensive review meeting today to assess preparedness for a district-wide outreach campaign covering all 44 tribal villages under the union government's flagship-Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) and Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DA-JGUA) programmes. The initiative, part of the ongoing Janjatiya Gaurav Varsh celebrations, aims to deliver individual entitlements and raise awareness among the tribal people about key government welfare schemes. As part of the Dharti Aaba Abhiyan campaign, Awareness and Benefit Saturation Camps will be organized from June 15 to June 30, 2025. These camps are designed to ensure saturation of welfare schemes at the grassroots level by facilitating doorstep delivery of essential services to tribal communities in the remote and underserved areas of District Reasi.

The DC also reviewed the groundtruthing status of all 44 tribal villages, conducted block-wise by Gram Sabhas through Block Development Officers (BDOs), based on 25 key indicators - including the availability of pucca houses, piped chlori-



nated water, electricity, schools, Primary Health Centres (PHCs), and Community Health Centres (CHCs), among others.

The ground-truthing exercise, conducted through Gram Sabhas, focused on identifying both fulfilled and pending gaps. The DC added that insights from this assessment will inform the preparation of Detailed Project Reports (DPRs) and enhance service delivery during the campaign.

During the meeting, DC Reasi emphasized that village-level and clusterlevel targeted service delivery camps

will focus on services such as Aadhaar enrollment, ration card issuance, Ayushman Bharat (PM-JAY) health coverage, caste certificate issuance, PM-KISAN registration, and Jan Dhan account facilitation, among others. The objective is to ensure that every eligible tribal individual and family receives the benefits of these schemes without delay or exclusion.

To ensure effective implementation, the DC directed all BDOs and line departments to conduct thorough awareness campaigns in each tribal village. These efforts will support the targeted delivery of entitlements and strengthen monitoring mechanisms. She also instructed district officers to ensure active participation of their

staff in upcoming block-level committee meetings and service delivery camps for better coordination and execution.

The campaign will involve active participation from Common Service Centres (CSCs), frontline workers, and departmental teams to ensure seamless service delivery. Emphasis will be placed on inter-departmental convergence and last-mile delivery, ensuring no eligible beneficiary is left behind.

SC: Equal pension for all retired HC judges, including additional judges

NEW DELHI, MAY 19 (UNI)

The Supreme Court has ruled that all retired high court judges are entitled to equal pension and retirement benefits, regardless of whether they served as permanent or additional judges.

A bench comprising Chief Justice of India (CJI) BR Gavai and Justice AG Masih held that making a distinction in post-retirement benefits among judges based on their mode of appointment violates Article 14 of the Constitution, which guarantees the right to equality.

The court stated, "Any discrimination among judges for terminal benefits after retirement is violative of Article 14. All high court judges, including those who retired as additional judges, are entitled to full pension."

It further clarified that no difference can be made based on whether a judge was promoted from the district judiciary or elevated from the bar.

The court also extended the benefit of parity to the families of additional judges, ruling that they too are entitled to the same family pension and post-retirement benefits as those granted to the families of permanent judges.

Key directions issued by the court include, retired chief justices of high courts shall receive a full pension amounting to Rs 15 lakhs per annum.

Retired high court judges, including those who served as additional judges, shall be paid Rs 13.6 lakh per annum as full pension.

All judges, irrespective of how they entered the judiciary by elevation from the bar or promotion from the subordinate judiciary are entitled to

Biden diagnosed with 'aggressive' prostate cancer

AGENCIES WASHINGTON, MAY 19 (UNI)

Former US President Joe Biden has been diagnosed with prostate cancer that has spread to his bones, an official said.

Biden, who left office in January, was diagnosed on Friday after he saw a doctor last week for urinary symptoms, a statement from his office said

The cancer is a more aggressive form of the disease, characterised by a Gleason score of 9 out of 10. This means his illness is classified as "high-grade" and the cancer cells could spread quickly, according to Cancer Research UK.

Biden and his family are said to be reviewing treatment options. His office added that the cancer was hormone-sensitive. meaning it could likely be managed.

"On Friday, he was diagnosed with prostate cancer, characterised by a Gleason score of 9 (Grade Group 5) with metastasis to the bone, BBC reported.

An international team of researchers found that a cholesterol-lowering drug may offer a more effective and convenient way to protect people at high risk of heart attack and stroke.

The study led by researchers at Monash University in Australia tested a once-daily oral medication called Obicetrapib and found it significantly lowered both LDL or bad cholesterol and cardiovascular disease.


