DAHOD, MAY 26 (UNI) Emphasising that cultural values demand action against injustice, Prime Minister Narendra Modi said on Monday said Operation Sindoor was not just a military action but a reflection of India's values and emotions.

Without mentioning Pakistan, the Prime Minister said the country born after Partition has focused on hostility towards India and causing harm, an official statement said.

"India, on the other hand, is committed to eradicating poverty, strengthening its economy, and achieving development", Modi said, while addressing a gathering in Dahod, Gujarat.

Questioning whether the nation could remain silent after the terrorist attack in Pahalgam, Jammu & Kashmir, Modi said terrorists had no idea of the consequences of their actions, recalling the brutal-



as 140 crore Indians were challenged by terrorism.

Modi declared that he fulfilled his responsibility as the nation's leader, giving full freedom to India's armed forces, who then executed an operation unseen in decades.

He highlighted that nine major terror hubs across the border were identified and destroyed in 22 minutes, and stated that Pakistan's military attempted retaliation but was decisively defeated by Indian forces. He reiterated his deep respect for the valour of India's armed forces, saluting their courage and dedication from the sacred land of Dahod.

The Prime Minister highlighted that a developed India can only be built when both its armed forces and economy are strong. Adding that the government is continuously working in this direction, ensuring national security and economic growth go hand in hand.

The Prime Minister laid foundation stone, inaugurated and dedicated to the nation multiple development projects worth over Rs 24,000 crore in Gujarat.

perpetrators would be tracked from wherever they are hiding.

"Pakistan forgot that 11 years ago, there was a Congress government, which has now changed. We responded to the Uri, Pulwana and Pahalgham strikes and struck terror bases," he said.

Referring to Operation Sindoor, Shah said that on May 7, nine terror camps were destroyed in 22 minutes, while India's air defence system ensured that Pakistan's missiles and drones did not touch the country's soil

On May 9, Pakistan's air defence system was destroyed by Indian armed forces, he said

"Modiji has declared that there would be retaliation if the blood of innocent Indian civilians is shed. If our women's sindoor is harmed, the response will be bloodier," he said, adding that Operation Sindoor proved the government's commitment to protecting India's borders.

Shah also reiterated that Naxalism would be wiped out from the country by March 31, 2026.

"When Operation Sindoor was underway, under Operation Black Forest by CRPF, Chhattisgarh police and BSF neutralised several Naxalites. Several Naxalites were also arrested and many surrendered," he said.

The Union Home Minister said Modi had ended the Indus Water Treaty, which was signed by former PM Jawaharlal Nehru, and also all trade with Pakistan. "Modi has said trade and terror cannot go together," he said.

Shah slammed the Uddhav Thackeray-led Shiv Sena (UBT), saying it had mocked the all-party delegations as "baraat" (wedding party).

While Foreign Secretary Vikram Mistry gave a presentation on Operation Sindoor to the MPs at the meeting, Jaishankar responded to queries later.

The sources said the Congress members asked the government why India was "hyphenated" with Pakistan by the US and also raised the issue of IMF aid to Pakistan and India's abstention at the meet.

where the potential lies and where gaps need to be filled. These short-term objectives will cumulatively guide us toward our longterm goal of Viksit Jammu & Kashmir by 2047,' he said. The meeting was attended in person by Chief Secretary Atal Dulloo, Additional Chief Secretary to the Chief Minister Dheeraj Gupta, Principal Secretary Finance Shailendra Kumar, Commissioner Secretaries of Industries & Commerce Vikramjit Singh, Secretary Planning, Development & Monitoring Department, Talat Parvez, administrative secretaries of other key departments including Social Welfare, Rural Development, Health & Medical Education, and Director Planning. Referring to Mission Yuva and the DGGI reports, the Chief Minister stressed the importance of using this data constructively. "These findings must improve our planning and programmes. I urge all line departments and district administrations to reorient their schemes in a manner that addresses the issues highlighted by both data sets," he said.

He said that the District Good Governance Index should not be perceived as a ranking of 'good versus bad' governance, but as a barometer of 'good to better' governance. "Districts that have shown strong performance must continue to lead by example, while those that lag must be supported to identify structural gaps and implement reforms. Any such systemic constraints should of India under the leadership of physicist Padma Shri Dr H C Verma to foster experimental science learning and ignite curiosity, creativity, and scientific temper among students.

Observing that the yatra will cover every district of India, Sinha asserted that it will unify diverse regions under a shared mission to revive the joy of learning science.

"When science is deeply woven into the fabric of society, it not only fosters innovation but can also significantly shape the direction of a nation by improving the quality of life for the entire society," the Lieutenant Governor said

Highlighting how under the leadership of Prime Minister Narendra Modi, India's approach towards 'Atmanirbharta' has fundamentally changed, Sinha stated, "Our scientists know that India cannot depend on others to defend her. Emphasising the need for bringing new scientific advancements to classrooms and laboratories, the Lieutenant Governor urged the teaching community and educational institutions to provide young researchers with a broader canvas and bigger goals for experimentation.

The Lieutenant Governor also called upon Indian scientists and engineers around the world to consider returning home, assuring that conditions are now favourable for pioneering inventions and that they can significantly contribute to India's scientific and economic leadership.

"The confluence of Science, Spirituality, and Sanskar has powered India's global standing. We are strategically investing in scientific and technological advancement to make India a leading global scientific power", he said

He further said that the scientists, innovators, and researchers are determined to reclaim ancient glory and build a developed India bv 2047.

Jat came under the scanner in the course of close monitoring of his social media activity by the CRPF, in coordination with the central agencies, during which he was found to have "acted in violation of established norms and protocols," according to a statement issued by the CRPF.

He was handed over to the NIA for further inquiry, it said.

"Concurrently, the individual has been dismissed from service with effect from 21.05.2025, under the relevant provisions of the Constitution of India read with the CRPF Rules," the statement said.

"Pakistan is famous for its cowardly acts and targeted our civilian areas after our armed forces carried out Operation Sindoor to destroy terror infrastructure on May 7 across the border in retaliation to the April 22 Pahalgam terror attack," Sharma told reporters at the party headquarters here.

"Fourteen of our civilians lost their lives in Poonch, two in Rajouri and one each in Uri (Baramulla district) and Jammu in the indiscriminate Pakistani shelling," he added flanked by other members of his team.

Sharma said that in addition, 1,500 to 2,000 structures - mostly residential houses - were damaged along with heavy loss to livestock and the agriculture yield in the border areas.

"Operation Sindoor was the reaction of our forces to the act of terror that left 26 persons, mostly tourists, dead. The precise and targeted action brought Pakistan on its knees, but the terror supporting country resorted to indiscriminate attacks on the residential areas on this side of the border," he added, reiterating the government's resolve that Operation Sindoor has only been suspended and any act of terror in future would be considered as an act of war. Sharma, who is also the general secretary of J&K BJP, said that his team visited all the shelling-hit areas, including Hiranagar. Suchetgarh, Arnia, R S Pura, Chamb, Planwala, Akhnoor, Rajouri, Nowshera, Poonch, Mendhar and Surankote in Jammu region and Uriin Baramulla and Tangdharin Kupwara district of north Kashmir. "The 10-day tour culminated the day before yesterday and was witness to heavy damage to structures on the ground besides the loss of lives and the livestock and injuries to many. Despite facing the brunt of Pakistan shelling and incurring losses, we found the border residents satisfied with the response of the Indian forces. They were happy that Pakistan was brought on its knees," he added. Assuring proper rehabilitation of the shelling victims, Sharma said the Home Ministry has already started the process of providing more underground individual and community bunkers to the border residents and the local administration has already started the process for which the border residents expressed their thanks to the government. Jammu dining guideJammu and Kashmir tourism The BJP leader said Prime Minister Narendra Modi and Union Home Minister Amit Shah have already announced one government job for the next of kin of those who lost their lives in Pakistani shelling. The file of each case has already been prepared and submitted to the General Administration Department for approval, he added. Sharma further said the Centre has also provided Rs six lakh to families of each deceased persons and adequate relief to those injured, while the Jammu and Kashmir government has also announced an ex-gratia relief of Rs 10 lakh to each of them. He said that the highest 690 structures were damaged in Pakistani shelling in Poonch followed by 524 in Uri area of Baramulla. "Some 1,500 to 2,000 structures – both residential and commercial – were damaged in the border areas. The J&K government can

only provide Rs 1.20 lakh under the SDRF norms, but we have recommended a special package in our report to help border residents to rebuild their lives. They will get the money through direct transfer benefits in their bank accounts," Sharma said.

"The BJP is committed to the welfare of the border residents and will ensure that they do not face any problem," he added. (Agencies)

Addressing members of the Consultative Committee on External Affairs here, the minister said the cessation of Operation Sindoor was done only after Pakistan DGMO asked for the halting of hostilities and there was no question of US mediation between the two, the sources said.

The Congress and Rahul Gandhi have been targeting Jaishankar, alleging that he had informed Pakistan beforehand about the Indian strikes at terror camps.

The sources said the minister told the MPs at the meeting that only the DGMOs of the countries spoke to each other and no other Indian official spoke with the Pakistani side.

He said the US was urging India to speak with Pakistan and it was told that terror and talks would not go together, he said.

Responding to several queries posed by MPs during the meeting about the halting of Operation Sindoor and the US "interference", the External Affairs Minister told MPs at the meeting that the DGMO had informed his Pakistani counterpart that if they would fire, India would fire back.

He said the targeted strikes at terror camps in Pakistan also hit the morale of Pakistani forces.

The sources said the minister sought the cooperation of all MPs in "exposing" Pakistan across the world. He said that is why the government has sent multi-party delegations of MPs to various countries to put across India's united message against terrorism to the world.

District also emerges as a key economic driver under District Domestic Product in J&K



The meeting assumes significance since it is being held at the world famous health resort of Gulmarg in North Kashmir. According to the meeting notice circulated by the General Administration Department (GAD) in addition to the cabinet ministers, top notch officers in both the civil and police administration are scheduled to attend the meeting.

As the agenda of the meeting has not been circulated by GAD it remains to be seen what would be discussed in the meeting. People are speculating about the agenda in their own way but no one is sure about the same. There are some who are assuming that the chief minister would seek assistance from both the police and civil administration in running smoothly the affairs of the government. Since the IAS and IPS officers come under the purview of Lieutenant Governor it remains to be seen whether these officers would attend the meeting.

Ever since the Omar Abdullah led government assumed office in October last year there have been many instances where the office of chief minister and office of LG have been at loggerheads. The same has resulted into administrative inefficiency with the public issues having been relegated to the backburner. India-Pakistan tensions rise after Pahalgam incident; U.S. voices concern

he Pahalgam terror attack on April 22, 2025, which resulted in the deaths of 26 civilians, has significantly intensified geopolitical tensions between India and Pakistan. The incident has led to a series of diplomatic, military, and economic responses, marking a notable shift in the bilateral relations of the two nuclear-armed neighbors. In the wake of the 2025 Pahalgam attack, which resulted in the deaths of 26 civilians, India and Pakistan have found themselves at the center of a complex web of international alliances and diplomatic maneuvers. The global response to this conflict reflects a tapestry of historical ties, strategic interests, and regional dynamics.

India's Response

1. Suspension of the Indus Waters Treaty (IWT): India suspended the IWT, a 1960

agreement governing the sharing of the Indus River system, citing Pakistan's alleged support for cross-border terrorism. This move allows India greater autonomy over the use of the Indus, Jhelum, and Chenab rivers, potentially impacting Pakistan's agriculture-dependent economy.

2. Diplomatic Measures:

India undertook several diplomatic

- actions, including: Closing the Attari-Wagah border crossing.
 - Revoking visas issued to Pakistani nationals under the SAARC Visa Exemption Scheme.
 - Expelling Pakistani military advisors from its High Commission in New Delhi and recalling its own from Islamabad.

Reducing the strength of dip-

lomatic missions in both countries to 30 personnel each.

3. Military and Cyber Operations:

India launched "Operation Sindhoor," targeting terrorist camps in Pakistan-administered territories. Concurrently, Indian cyber defense groups countered over 1.5 million cyberattacks from Pakistani and allied hacktivist groups, breaching several Pakistani government and institutional systems.

4. Civil Defense Preparedness:

India conducted "Operation Abhaya's," a nationwide civil defense drill across 244 districts, enhancing civilian readiness against potential threats. Activities included air-raid siren tests, blackout simulations, and evacuation drills

Pakistan's Reaction

Pakistan denied involvement in the Pahalgam attack, labeling India's suspension of the IWT as "water warfare" and an illegal move. Officials warned that any attempt to stop or divert water flow would be considered an

2. Airspace Closure:

In retaliation to India's military actions, Pakistan closed its airspace to Indian carriers, escalating to a total airspace closure, affecting regional air traffic.

3. International Appeal:

Pakistan sought an immediate session of the United Nations Security Council to address the escalating tensions and India's suspension of the IWT.

Geopolitical Implications the United States growing concern for India

India has expressed concern over perceived shifts in the U.S. stance, particularly its attempts to balance its relationships with both India and Pakistan during the 2025 conflict. Here's a nuanced breakdown of the situation: The U.S. expressed support for India's fight against terrorism while urging both nations to de-escalate tensions. President Trump emphasized the importance of India and Pakistan resolving issues bilaterally. U.S. Position in the 2025 India-Pakistan Conflict 1.

While the United States officially condemned the Pahalgam terror attack and expressed sympathy with India, President Donald Trump and other top officials repeatedly stressed:

- The importance of maintaining "good relations with both India and Pakistan."
- That the U.S. was "doing big deals with both countries," hinting at parallel economic and security partnerships.

This neutral tone has been interpreted by some in India as a lack of strong support during a moment of heightened crisis.

2. Strategic Interests in Pakistan

The U.S. has several reasons for hedging its bets:

- Counterterrorism logistics and intelligence in the region still involve Pakistan, especially regarding Afghanistan.
- Ongoing military-to-military cooperation under certain U.S. aid frameworks continues, albeit reduced.
- Geopolitical competition with China may push the U.S. to prevent Pakistan from falling entirely into Beijing's sphere.

3. U.S. Mediation Offer

There were indications from Washington that the U.S. was willing to mediate or facilitate dialogue between India and Pakistan – a position India has traditionally rejected, asserting that all disputes should be handled bilaterally. American diplomats urged India to exercise restraint, particularly after India launched Operation Sindhoor. This was perceived in some Indian circles as pressure to hold back, while not holding Pakistan equally accountable.

The 2025 conflict revealed that:

- India-U.S. ties are strong but not unconditional.
- The U.S. aims to maintain regional balance rather than take sides fully.
- India is increasingly turning toward multi-alignment, strengthening ties with France, Russia, and others, to avoid overdependence on the U.S.

The Pahalgam attack has not only strained India-Pakistan relations but also impacted regional dynamics:

Water Security: The suspension of the IWT raises con-

cerns about water security in Pakistan, which heavily relies on the Indus River system for agriculture.

- Regional Stability: The involvement of major powers like the U.S., China, and Russia underscores the potential for broader regional instability if tensions are not managed.
- Diplomatic Channels: The reduction in diplomatic engagements and increased military posturing highlight the need for renewed dialogue to prevent further escalation.

Pakistans concern and international isolation

1. International Isolation and **Diplomatic Setback**

- Diminishing Global Sympathy: After the Pahalgam attack, which India attributed to Pakistan-based terror groups, much of the global community leaned toward supporting India's right to defend itself, leaving Pakistan diplomatically cornered.
- UN Rejection: Pakistan appealed to the United Nations Security Council for intervention following India's suspension of the Indus Waters Treaty (IWT). However, the UN largely urged bilateral de-escalation, not condemning India, which was a major blow to Pakistan's narrative.
- Limited Backing: Apart from traditional allies like China, Turkey, and Malavsia, few countries openly supported Pakistan. Even Muslim-majority nations like UAE and Saudi Arabia took neutral positions, calling for peace rather than backing Pakistan outright.

The Pahalgam terror attack has significantly altered the geopolitical landscape between India and Pakistan. The series of retaliatory measures, diplomatic strains, and international reactions underscore the fragility of peace in the region. While both nations have taken steps to assert their positions, the path to de-escalation lies in constructive dialogue and mutual cooperation to address underlying issues and prevent further conflict.

India's Defence drive powers economic growth

The recent hostilities between India and Pakistan have once again highlighted a stark truth: warfare, regardless of its scale or region, exacts a significant economic cost. This has been the case historically, and it continues to hold true today. Waging war is no longer solely about manpower and traditional weaponry; it requires vast financial resources, technological infrastructure, and logistical agility. Modern warfare, as evidenced in the recent India-Pakistan tensions and the ongoing Ukraine-Russia conflict, is increasingly reliant on cutting-edge systems, cyber capabilities, unmanned vehicles, and precision weapons. The nature of war is evolving-and fast. It is now abundantly clear that a nation heavily dependent on foreign imports for its defence needs stands on precarious ground. The election of Donald Trump in the United States, and the policy shifts it brought, has underscored the geopolitical risks of import reliance in defence sectors, making it clear that self-reliance is no longer a choice, but a necessity.

Amidst this shifting global backdrop, India is waking up to the urgency of building a robust domestic defence manufacturing ecosystem. While the share of manufacturing in India's overall GDP has been declining, a significant exception has emerged in the form of defence manufacturing-a sector that is now showing a gradual, determined upward trajectory. This shift is not merely reactive, but strate-

gic. The dynamics of global alliances have also shifted: China's proactive support to Pakistan in supplying arms and military technology has created an additional layer of urgency for India to bolster its own indigenous defence capabilities.

In recent years, the Indian government has taken serious steps to build these capabilities. India's defence production reached an estimated INR 1.27 lakh crore in the financial year 2023-24, reflecting a staggering 174 per cent increase over the past decade. This growth is not confined to figures on paper but is materialising on the ground, as seen in the increasing deployment of indigenous systems during periods of heightened security threats. Under the overarching umbrella of the 'Atmanirbhar Bharat' (Self-Reliant India) initiative, India has been moving away from its historical dependence on imported defence systems and making significant strides in domestic innovation and production.

One of the cornerstones of India's new defence capability is the BrahMos missile, a result of a joint venture with Russia but now largely indigenised. Known for its speed and precision, the BrahMos has played a vital role in recent precision-strike operations, demonstrating both tactical superiority and technological maturity. The newly inaugurated production facility in Lucknow—part of the Uttar Pradesh Defence Industrial Corridor—is expected to manufacture 80–100 BrahMos missiles annually, alongside 100-150 units of its next-generation variants. This facility not only secures India's domestic supply but also positions the country to cater to international demand for high-performance defence equipment.

Equally significant is the Akash missile system, developed indigenously by the Defence Research and Development Organisation (DRDO) and containing over 96 per cent indigenous components. It is one of India's most advanced and locally produced air defence systems. During recent hostilities, the Akash system proved its effectiveness by accurately intercepting aerial threats at critical moments. More than 250 Indian companies have been involved in producing subsystems and components for the Akash project, making it a textbook case of industrial collaboration, supply chain development, and national security convergence. DRDO is also actively enhancing the system's capabilities and expanding its operational range, ensuring that future versions stay ahead of evolving threats.

Another notable development is the D4 anti-drone system, designed to address the rising threat of unmanned aerial vehicles (UAVs). Developed with inputs from DRDO labs across Bengaluru, Hyderabad, and Dehradun, the D4 system can detect, track, and neutralise drones using both soft-kill techniques like jamming and hardkill measures like lasers. It is a reflection of India's growing research and development prowess in dealing with new-age, asymmetric threats in modern warfare.

Yet, despite this progress, challenges remain. India is the fourth-largest spender on defence globally, after the United States, China, and Russia, and still imports around 40 per cent of its defence needs. Between 2020 and 2024, Russia accounted for 36 per cent of India's arms imports, followed by France at 33 per cent, Israel at 18 per cent, and others making up the rest. India's defence budget has increased substantially-from Rs 2.53 lakh crore in 2013-14 to a projected Rs 6.8 lakh crore in 2025-26. The 2024-25 budget alone allocated nearly Rs 1.7 lakh crore for defence procurement. Historically, defence manufacturing in India has been dominated by 16 Public Sector Enterprises (PSEs). However, the ecosystem is expanding. Today, it also includes around 430 licensed private companies and approximately 16,000 Micro, Small and Medium Enterprises (MSMEs) supplying goods and services. By the end of FY24, total defence production had reached Rs 1.27 lakh crore, with nearly Rs 90,000 crore already clocked before the most recent hostilities. This figure excludes the Rs 2.09 lakh crore worth of defence contracts awarded in the current fiscal year-92 per cent of which were granted to Indian companies, with public sector firms like Hindustan Aeronautics Limited (HAL) playing a major role.

The Defence Procurement Board has also approved purchases worth Rs 4.25 lakh crore, with nearly 90 per cent intended for domestic manufacturing. Significant portions of this future manufacturing will be anchored in the Uttar Pradesh and Tamil Nadu Defence Corridors. Private sector giants like the Tata Group have chosen Vadodara, Gujarat, as their manufacturing base, reflecting the growing geographical spread of India's defence industrial network.

However, this progress still represents only a fraction of the resources required to fully modernise India's Armed Forces. Much of the existing equipment remains outdated, often based on legacy Soviet designs, especially in critical areas like troop transport aircraft. The need for advanced early warning systems, cost-effective anti-drone measures, and efficient inventory management is pressing. For instance, the Indian Navy alone is responsible for maintaining a diverse inventory of nearly 400 different types of equipment, including a vast range of ammunition and spares.

In the last two decades, India has begun to allow greater participation from the private sector in defence manufacturing. The emphasis on indigenisation now includes more than 310 specific items in addition to the 2,500 items previously indigenised. The government has released a larger list of 36,000 items intended for future indigenisation, aiming to achieve full self-reliance in defence manufacturing by 2032. These initiatives are not only important for national security but also for their broader economic impact-stimulating industrial activity, generating employment, and fostering innovation.

Defence sector jobs, unlike those in more volatile industries like technology or consumer services, are largely insulated from economic cycles. This makes them attractive, especially for educated and skilled youth looking for stable employment. As seen in the United States, where the aerospace and defence sector contributes nearly 4 per cent to the GDP and supports about 2 lakh companies and 22 lakh jobs, this sector can be an engine of high-quality employment. In fact, defencerelated jobs in the US tend to pay about 50 per cent more than average national wages, due to the high level of skills and training required. Similarly, in the European Union, the defence sector employs over 10 lakh people and saw an 8 per cent increase in new jobs in the past year alone.

India has the potential to develop its own defence economy on a similar scale. However, building a sustainable militaryindustrial complex is a formidable task. It requires persistent investment in R&D, skilled manpower, and strategic vision. It is not enough for large private companies to invest in the hope of lucrative government contracts. Without a long-term, policydriven approach to technology development, collaboration, and quality assurance, these investments may not yield the desired results.

Another crucial consideration is India's position in the global defence supply chain. Foreign collaborations and joint ventures have the potential to accelerate India's technological advancements. The government's decision to allow 74 per cent foreign direct investment (FDI) in approved defence manufacturing units is a step in this direction. Russia's March 2025 offer to co-produce its advanced S-500 missile system in India may be a direct result of this liberalised policy. Such collaborations bring not only investment and technology but also open the door to exporting Indian-manufactured defence equipment to global markets.

However, even as India scales up its defence manufacturing, quality control remains a critical challenge. High-quality production standards are non-negotiable in defence, and any lapse can have dire consequences. There is an urgent need to empower oversight bodies responsible for guality control, ensuring they function with autonomy and integrity. Without this, increased spending and manufacturing volumes may not translate into operational effectiveness or global competitiveness.

Finally, while the economic benefits of a robust defence manufacturing sector are undeniable-especially when other sectors of the economy face headwinds-the government must ensure that the defence supply chain remains secure. A reliable regulatory framework is essential to prevent defence technologies or components from falling into the wrong hands. National security must remain the guiding principle as India moves forward on this transformative path.

In conclusion, India is at a critical juncture. The journey towards becoming a self-reliant defence powerhouse is well underway, but the road ahead is complex and fraught with challenges. With careful planning, sustained investment, and an unwavering focus on quality and security, India can build a resilient, world-class defence industrial base—one that not only secures the nation but also drives its economic future.

When joy arrives drenched in sorrow.

In the hustle of wedding preparations, the fragrance of flowers fills our home. Laughter echoes through newly painted walls. Family and friends gather, clothes are being stitched, and invitations are being sent. But amidst all this joy, there is a silence only I can hear – a silence so loud it drowns the drums and songs. Because my mother, Smt Nanti

Devi is not here. On the 4th and 5th of June 2004, I am getting married – a day she once dreamed of, longed for and prayed for. But the woman who waited for it

the most won't be here to witness it. She left us on a Friday18 January 1998 at 4-00am. She breathed her last at in my arms at Village Bhagota Distt and Teh Doda. In that one moment, life split in two: before and after. Since then, every joy has worn a shade of sorrow.

My mother was not just my world – she was its soul. A woman of such generosity that no beggar ever left our home empty-handed. Some families came daily for milk, oil, or clothes – she never turned them away. She fed the hungry, clothed the poor, provide water to thirsty people in forest area of Doli Mandi when she was grazing cattle and treated every guest like royalty. She was the embodiment of warmth, sincerity, and silent sacrifice.

To her children, she was a fortress of love. She would often say, "One day, you will succeed."

At that time, I am doing my M.Sc Environment Science from Jammu University.On eve of My Beloved Mother Prof Zahoor ul Din Head Of Department Urdu and than the Controller of Examination University of Jammu extended Date Sheet Environmental Sicence for one month.I never forget respected Professor, this big step till the last breath of my life I still remember that at one night ,I return back to Swami Vivekananda Boys Hostel in my Room Number 213 for collection of study material keeping my beloved mother alone in Jewal Hotel with my elder brother Mr Dev Raj.I daily asking myself why I do so .But then came a ray of mercy: my Father Sh Gouri Lal who is none more as my father left to Heavenly Abode on 26 November,2019 a man as pure as a flowing spring. He embraced me with compassion, consoled my aching soul, and guided me back to the light of true person. His love and support became a shelter in the storm. My mother always wanted to meet him, and although that meeting never happened, I believe their souls are connected through purity.

There are nights I wake up yearning for her scent. There are days I walk into rooms expecting her to call my name. And every day, I feel the ache of not being able to hug her – to hear her soothing voice, just one more time. But this world has its limits. What I can't have here, I pray for in the hereafter.

He also directed that all non started works under the District Capex should be reviewed thoroughly.Taking strong note of the lack of progress in certain sectors, the ADDC asked the Ground Water Division to furnish a written report explaining why a significant number of assigned works have not been initiated despite allocation of funds.

Indian Chamber of Commerce Jammu represents and submitted memorandum to Regional Director RBI Jammu Kashmir Ladakh in 66th Empowered Committee Meeting

Jammu, May 26, 2025: The Indian Chamber of Commerce (ICC) Jammu, under the leadership of its Chairman Rahul Sahai, submitted a detailed memorandum to Sh. Chander Shekhar Azad, Regional Director, Reserve Bank of India (RBI), Jammu Kashmir & Ladakh, during the 66th Empowered Committee Meeting. The memorandum highlighted the pressing economic and sectoral concerns faced by MSMEs in the Union Territory in light of the recent war-like situation.

The representation applauded the courage of the Armed Forces and the leadership of the Hon'ble Prime Minister of India for standing strong in difficult times. However, it emphasised that the ongoing uncertainty and threat of recurrence have deeply shaken the MSME sector and the broader business community across Jammu and Kashmir.

The fallout includes widespread damage to homes in border areas, business closures, grounding of flights and trains, exodus of labour, a collapse of the tourism industry, and an alarming decline in business activity and income. Additionally, concerns were raised over unsecured banks credit limits in case of "Act of War" situation , continued interest charges without proper economic activity, pending GST refunds in treasuries and government scheme payments (such as under Ayushman Bharat), and unsecured properties of insurance claims due to the "Act of War" clause.



In its memorandum, ICC Jammu proposed several critical interventions. These include directing IRDAI to extend war-risk insurance coverage for J&K properties, and ensuring banks refrain from blocking MSME accounts or classifying them as unsecured due to

current instability. The Chamber urged banks to develop new and simplified financial products such as loans against pending Ayushman Bharat dues, solar financing for MSMEs, and hassle-free loans against property in these difficult times. Regarding Treds Sahai suggested audit that why buyers are not registering on treds platforms of RXIL, M1 Exchange etc. Further, the Chamber called for liberal renewal of credit limits,

liberal renewal of credit limits, issuance of special stress loans, restoration of ATM withdrawal limits to pre-war levels, six-month interest reimbursements as provided during COVID, and regionspecific RBI relaxations in credit restructuring and working capital support and Cibil scores. Addressing the growing concern of cyber threats, ICC Jammu recommended immediate cyber audits of banking systems and creation of a dedicated Cyber Response Team by banks. Another significant concern raised was the safety of public deposits and bank lockers in war-prone situations. The Chamber sought clarifications and called for enhanced security measures such as relocating lockers to secure zones and basements.

Rahul Sahai, while submitting the memorandum, emphasised the urgent need for the RBI's leadership to safeguard MSMEs and restore economic confidence in the region. ICC Jammu reaffirmed its support for the Government of India and appealed for swift action to stabilise the economic environment of Jammu and Kashmir.


