Pahalgam Terror Strike Was Attack On India's Soul, Our Response Decisive: PM Modi

Terrorists tried to divide Indians, but we gave them a befitting reply

GANGTOK, MAY 29: Prime Minister Narendra Modi on Thursday said the Pahalgam terror strike last month was an attack on the soul and unity of India, and subsequent Operation Sindoor was a "decisive response" to terrorists.

He asserted that the country was united in its fight against terrorism, adding that India gave a befitting reply and destroyed terror infrastructure and several airbases in Pakistan.

Describing the Pahalgam attack as a "deliberate attempt" to create a rift in India on religious lines, Modi said, "We sent out a clear message that India is united despite the terror strike which erased sindoor of some of our sisters." At least 26 people, mostly tourists, died in the April 22 ter-

victims' faith left the entire country grieving and

Addressing the 50th anniversary of Sikkim's statehood function at Paljor Stadium here, Modi said the Himalayan state is the "pride of the nation" and its people believe in democracy.

The prime minister regretted that he could not attend the function at the statehood celebrations due to inclement weather, but assured that he would visit the state in future.

"Operation Sindoor against terrorists in the wake of the Pahalgam attack was a befitting reply to those who unleashed terror in India. What terrorists did in Pahalgam was an attack on humanity, and we are now united in the fight against terrorism," the PM said virtually from Bagdogra in West Bengal.

Centre Sanctions 581 CAPF Companies For Amarnath Yatra

NEW DELHI, MAY 29: N: The Centre has ordered deployment of a total 581 companies, comprising about 42,000 on-ground personnel, of the Central Armed Police Forces (CAPFs) for the annual Amarnath Yatra in Jammu and Kashmir, official sources said on Thursday.Jammu dining guideJammu and Kashmir real estate

While 424 companies are being sent to the Union Territory (UT), the rest, including about 80 companies that moved to the UT during Operation Sindoor, will be "relocated" to secure the yatra route, the pilgrims and other areas, including Srinagar, they said.

The Union home ministry, officials said, has directed that these forces move "immediately" and take position in Jammu and Kashmir by the second week

The Amarnath Yatra will begin on July 3 and end on August 9. The security deployment plan for the pilgrimage is being prepared keeping in mind the challenges emerging from the April 22 Pahalgam terrorist attack in which 26 persons, mostly tourists, were killed, they said.

JAMMU, MAY 29: Congress leader and Leader of Opposition (LoP) in the Lok Sabha, Rahul Gandhi, has written to Prime Minister $Narendra\,Modi, urging \,the\,immediate\,creation$ of a comprehensive rehabilitation package for residents of Poonch and other border areas in Jammu and Kashmir affected by recent cross-border shelling by Pakistani troops.

In his letter, dated May 29, accessed by the $news\,agency-Gandhi\,highlighted\,the\,severe$ impact of the shelling that took place between



May 7 and 10, following India's Operation

The unprovoked attacks resulted in 28 deaths, including 14 in Poonch district, injured over 70 people, and caused widespread destruction of homes, religious sites, and livelihoods. Thousands were forced to flee their villages near the Line of Control (LoC) and seek refuge in government relief camps.

During his visit to Poonch on May 24, Gandhi met with affected families, toured damaged sites, including Gurudwara Shri Guru Singh Sabha, Geeta Bhawan temple,

Centre notifies ESZ around Tral wildlife sanctuary Move to secure last remnants of endangered Hangul population

SRINAGAR, MAY 29: : The Union Ministry of Environment, Forest and Climate Change has notified an eco-sensitive zone (ESZ) around Tral Wildlife sanctuary. In a notification, a copy of which is in possession of news agency—Kashmir News Observer (KNO), the Union Ministry notified that an area to an extent of zero to 3.26 kilometers from the boundary of Tral Wildlife Sanctuary as its ESZ.

"The extent of the eco-sensitive zone around the Tral Wildlife Sanctuary ranges from 0 kilometer to 3.26 kilometer from its boundary,

encompassing an area of 127.10 square kilometers, which includes 26 villages," reads the notification.

Historically- parts of the protected area, namely Shikargah and Khangund, previously designated as Conservation Reserves-have the distinction of being among the oldest notified protected areas in the country. Their notification dates back to 1945, when they were governed by the game laws of the Maharajah of the erstwhile princely state of Jammu and Kashmir.In 2019, these conservation reserves, along with the adjoining areas comprising

Kashmir reports first COVID-19 cases in new wave: Two GDC students test positive

SRINAGAR, MAY 28: Kashmir has reported its first COVID-19 cases in the current wave, with two female MDS students from Government Dental College (GDC) Srinagar testing positive for the virus. Health officials, however, have assured the public that the current strain is behaving mildly and does not pose a serious threat.

The two students, both dentists and residents of Kerala, had recently returned to Srinagar after visiting their hometowns. Upon feeling unwell, they were advised to undergo testing at the Government Medical College (GMC) Srinagar, where they tested positive for COVID-19.

"They have been isolated as per the protocol," a health official said, adding that both are asymptomatic or experiencing only mild symptoms and do not require hospitalisation.

Professor (Dr) Sandeep Kour Bali, Principal of GDC Srinagar, told the news agency—that the students are isolated in the college hostel, with a separate washroom facility arranged for them. She said all staff and students at the college have already received both doses of

Shattered by shelling, border resident Daat Hussain loses home and hope in Rajouri's Dehri village

n the remote and oftenforgotten border village of Dehri in Manjakote, tragedy struck when the modest home of 60-year-old Daat Hussain, a daily wage labourer, was reduced to rubble in a recent bout of cross-border shelling. What was once a newly built dream home - filled with aspirations, memories, and a future planned with care now lies in ruins.

Daat, who sustained critical injuries during the attack, is currently recovering at a relative's

home. While his physical wounds are healing, the emotional scars run far deeper. "We had just begun to live with dignity," he murmured, his voice trembling as he looked over what used to be his family's only shelter.

The house, built just months ago with a loan of 5 lakh, had recently been furnished and painted, symbolizing the family's slow but steady progress. That fragile progress was obliterated in an instant. Everything – household items, new tiling, and electrical fittings – was destroyed in the blast.

Daat lives with his 55-year-old



wife and three daughters, each at | a critical juncture in life. His eldest daughter was married just two

months ago, a rare moment of celebration for the family. His second daughter, a bright college student in her final year, was scheduled to be married in just ten days. Instead of wedding bells, the family faced the deafening silence of grief and loss as the marriage had to be cancelled. The youngest daughter, a second-semester student at Government PG College, Rajouri, continues her studies under the growing shadow of insecurity.

'This was not just a house," said a family member, holding back tears. "It was a promise to our daughters — a symbol of security and stability. Now there's nothing left."The family has no alternative income, no property elsewhere, and no resources to rebuild. What's left is grief, broken dreams, and a desperate plea for help. Community members and local panchayat representatives have rallied around the family, urging the district administration to act swiftly.

There is a growing public sentiment that the government must step in immediately, not just with temporary relief, but with a comprehensive rehabilitation package. "This family has lost everything through no fault of their own. It's not just about bricks and cement

This will be the Home minister's third visit to Jammu and Kashmir since April 6 and first after the Indian armed forces struck terror infrastructure in Pakistan and Pakistanoccupied Kashmir (PoK) in the early hours of May 7 in retaliation to the Pahalgam terror attack that left 26 people, mostly tourists,

has been an essential component in the country's national security and it played a key role in India's effective action against terrorism during Operation Sindoor.

He said most of the people in PoJK feel a "deep connection" with India and only a few of them have been "misled".

"The situation of our brothers and sisters living in PoJK is similar to that of Shakti Singh, the younger brother of brave warrior Maharana Pratap." "Even after separation, the confidence and faith of the elder brother towards his younger brother remains intact," Singh said.

"India always talks about connecting hearts, and we believe that by walking on the path of love, unity and truth, the day is not far when our own part, PoJK, will return and say, I am India, I have returned," he said.

In a clear message to Pakistan, Singh also said the business of terrorism is not cost effective and it will come with a heavy price as Islamabad has realised now.

His comments came three days after Prime Minister Narendra Modi said it is for the youth of Pakistan to step forward and "free Pakistan from the disease of terrorism".

The defence minister described 'Make-in-India' as crucial for national security and prosperity, stating that the use of indigenous systems during Operation Sindoor has proved that India has the power to penetrate any armour of the enemy.

"We destroyed the terrorist hideouts and then the military bases. We could have done a lot more, but we presented a great example of coordination of power and restraint," he

In his remarks, Singh also highlighted India's domestic defence capabilities. India's defence export was less than Rs

1000 crore 10 years ago but it has now reached a record figure of Rs 23,500 crore, he said.

Today, it has been proven that Make-in-

India in defence is essential for both India's security and prosperity, he said.

Today, we are not just building fighter jets or missile systems and we are also preparing for new-age warfare technology, he said.

Singh also spoke about India's ambitious plan to build a fifth-generation stealth fighter jet – the advanced medium combat aircraft (AMCA).

The defence ministry this week cleared the "execution model" to design and produce

Singh emphasised that through the AMCA "execution model", the private sector will get an opportunity to participate in the project along with public sector companies for the first time.

"Under the AMCA project, the plan is to develop five prototypes, which will be followed by series production. It is a key milepost in the history of the Make-in-India programme," he said. (Agencies)

The initiative follows the first Civil Defence Exercise conducted on May 7, during which several critical gaps in emergency response systems were identified. In response, emergency powers were invoked, and support was arranged through the State Disaster Response Fund (SDRF).

The upcoming drill will simulate a range of high-stakes emergency scenarios to assess and enhance the preparedness of

Civil Defence and allied forces. These will include the silent recall of Civil Defence volunteers, supported by youth organizations such as NCC, NSS, NYKS, and Bharat Scouts & Guides, to assist in various civil defence measures. Simulations will also involve air raids by enemy aircraft. missiles, and drones, along with the activation of hotlines between the Air Force and Civil Defence control rooms and the use of

centrally operated air raid sirens. Complete blackout measures will be implemented in sensitive zones, excluding critical services, to test civilian response under wartime conditions.

A scenario involving a drone attack on a military station will also be enacted, requiring the evacuation of 20 civilian victims to a safer location.

Also, the drill will include mass casualty management exercises, with the mobilization of medical teams and the provision of 30 units of blood for the injured.

As part of the rear area security plan, the exercise will also simulate the deployment of Border Wing Home Guards in coordination with Indian Army units.

All participating districts have been directed to coordinate with local administration and relevant stakeholders to ensure full-scale implementation.

Even though some raids have been conducted on their clinics, surprisingly these medicos managed to flee.


These doctors have not erected boards at their clinics, instead they pass on the message to the patients visiting them at SKIMS Soura in the outpatient department. The medicos say that it is not possible for them to provide best treatment to the patients at the hospital and as such they would have to visit the clinic. They provide the contact details of the person managing their clinics to the patients or their attendants.


At the clinics the patients have to stand and there is no seating arrangement not to talk of other facilities. Since the patients have no option they are forced to visit the clinics of such doctors while braving the vagaries of weather. Ironically the people at helm know that such things are going on in the society but no action whatsoever has been against the doctors who have defamed the noble profession of medicine.

The time to draw a line has come and the administration should make it clear to the medicos to either take up a government job or work in a government hospital. In the recent past a disturbing development in the medical scenario has taken place and that is the poaching of doctors working at SKIMS, Soura. A leading corporate hospital managed to poach upon super specialists working in different departments at the only super speciality hospital of Kashmir.

This development has forced the patients to visit the concerned corporate hospital and receive the treatment there only. The mentioned corporate hospital charges a huge amount from the patients and they are left high and dry. The doctors working at this corporate hospital are given a target of roping in a particular number of patients and carrying out a particular number of surgeries on a given day or a week.

We couldn't see, they were still singing: Memories flying from the village balcony

hile we are living our lives in the prison of busyness behind the glittering roads, tall buildings and closed windows of the city, life is still breathing under the open sky in the balconies of villages far away. There, mornings still begin with the chirping of birds, afternoons are adorned with the tune of the cuckoo, and nights resonate with the hooting of owls. This article is a journey of those memories and experiences - of that world felt while sitting in the balcony of a village, which was once ours, but which we lost somewhere in the noise of the city.

When I recently came to the village, I was sitting in my balcony one evening. Suddenly a bird caught my attention. It looked familiar - brown and white, nimble and very playful As soon as I saw it, a voice came from some corner of my mind - "Dhaurraiya!" Yes, this is what we used to call it when we children used to visit our grandmother's house. When the whole family gathered in the village during summer vacations, all of us children would sit in the courtyard and chase these birds, feed them, and argue over their names. "This is not a sparrow, it is a Dhaurraiya," my cousin would say proudly.

Living in the city limits the ability to recognise birds. Crows, pigeons, parrots and sometimes sparrows these are all that we see. But here in the village, it is as if the pages of a forgotten book have opened up again. There is a tree in front of my balcony, on which mynas and bulbuls come early in the morning. Peacocks dance in the fields far away, and their chirp ing is like a part of some traditional music. A glimpse of the Neelkanth is also visible, and that blue colour refreshes the eyes.

The tit-tit of the sandpiper, the agility of the water hen, the cooing of the cuckoo and the running of the partridge - all these together create a lively world which we have never known properly in the cities.

In the silence of the night, when two owls come regularly to the village and sit on an old neem tree, a different feeling is felt. In the city, the word owl is associated with an insult or superstition, but here they are like teachers of the night - silent sentinels who maintain the balance of nature.

When I asked my grandmother if this bird was called Dhauraiya, she smiled and nodded, "Yes, daughter, it is the same. Now where do you see it in cities? You people don't live there that you will be able to see it."

This shook me to my core. Are these birds really going extinct, or have we become extinct from the places where life and nature breathe together?

This balcony in the village had become a window - not just to look outside, but to look inside. I started remembering grandmother's stories, those afternoons when we used to sit in the shade of a tree and watch the

birds' nests, those pea fields in which the partridges used to run, and those ponds where the water hens used to swim with their chicks.

Our generation has seen bird emojis on mobile screens, but not their true colours. We have heard bird calls on Google, but never seen the morning congregation of birds sitting under the open sky.

Coming to the village, I realised that in our hustle and bustle, we have left behind everything that used to make our soul smile. Birds are not just flying creatures, they are a part of our past. They are companions in our folk songs, stories, and emotions. "Kaaga sab tan khaiyo, choonchoon khaiyo maan" - from this couplet of Kabir to Mirabai's cuckoo and Tulsi's chatak, every bird has been an essential part of our culture.

I remember when I first came to the city, I used to think that the dazzling light of the city is the goal of life. But now I understand that light is necessary, but not every light is the sun. There are some lights that dazzle the eyes but make the mind dark.

While sitting in this balcony of the village, a small bird comes again and again, sits for a few moments, and then flies away. Looking at it, it feels as if it is adding wings to my memories. Every time it flies, an old memory floats away in the air.

The more we are getting away from nature, the more emptiness is increasing within us. From mental health to social distancing, a major reason for the problems of modern life is that we are getting disconnected from the land, trees, birds and our origins.

This article is a request - to myself, and to all of you. Go to villages, breathe in the open air, recognise the sounds of birds, teach children their names, and realise that life exists not only in human noise, but also in chirping.

The city gives us height, but the village gives us depth. The city is the race of development, the village is the lap of heritage.

And most importantly - these birds are not extinct. They are still singing, it's just that we have stopped listening. Let's start listening again. Not from our balcony, but from the window of our mind.

Lesson plan in Edu. -A wastage of time

odern education is about producing workers to perpetuate the secularised, capitalist system and not about producing thinkers. Thinkers change system and shift paradigms and so modern education is as careful as it can be avoided producing too many people who are capable of sustained critical thinkers.We all know that teachers spend a lot of time preparing lesson plans rather than focusing on how well they deliver those lessons. This is a complete wastage of time. This is one he'll of a statement. In our Distt.Doda a process of providing quality education to students is at its peak where DIET Doda issued 31 point programme to every school to be follow in letter and spirit .It is impressed upon all Teachers, Masters and Lecturer to prepare lesson plans for teaching students from primary to higher secondary level including other 30 points to be followed. I realise I have not written anything for this blog for quite some time .So I am really glad to write some thing about the teacher's pedagogic abilities .Without this it would be impossible to determine the extent of the teacher's teaching abilities. Every one know a great planner when one read their lesson plan, but one know a great teacher when one see them. While the lesson plan might reveal some interesting things about the decision taken by the teacher, I don't think it is necessary to determine the extent of the teacher's teaching abilities, because the only thing it does determine is the extent of teachers planning abilities. And is just one of many skills of effective English teachers .What I definitely object to though are the incredibly detailed lesson plans we are obliged to write for formal observations. Firstly they do not reflect how we plan on a day to day basis .Let's be honest any good teacher will prepare and plan for their classes in one way or the other .I will often visualise the different stages, interaction pattern, lesson aims and go over the various options. I could use in the class without writing too much down. The best decision come to me on the spot. They depend on students on their mood ,on what happens in the class, and on countless other unpredictable factors . Which brings me to my second objection .One can't plan for the unpredictable. And what happens in class is to a lesser or greater extent about the lesson, it's aims ,possible interaction patterns,predicting setbacks and devising solutions to them are all part and parcel of preparing for a successful lesson, I can't see how writing them down in their former of an ever more complex and detailed lesson plan will help one effectively

Teaching is not about managing the delivery of a lesson plan .Unfortunately though both teacher training courses as well as in house observations place great importance on thorough lesson planning.Because as we are told there is a direct correlation between a good lesson plan and a lesson success. Really ?When preparing for my last observation I spent several hours writing the plan and preparing materials. According to the feedback I received the lesson went well but I did not feel the hours of prepaid off.I didn't feel it was a particularly outstanding lesson.And I am pretty sure I would have taught a similarly effective lesson with 10% of the time put into planning .And would have been much less stressed about to stick to the lesson stages. So might have respond to students immediate queries and needs better too. So why are we told by trainers and observers to prepare a detailed lesson plans?Perhaps because they provide comfort to the novice and to certify the novice's ability. Perhaps be cause it is part of what most teachers to do. Perhaps because the observers or trainees actually believe that how the plan looks reflect in a way how the lesson is going to plan out.It shows that the trainee is diligent and had carefully thought about the lesson. This belief though is underpinned by the misconception that teachers can control what students learn.Lesson plan doesn't prepare the trainee for the daily teaching and planning routine. It is stressful time consuming and not environmental you friendly .Successful teaching is much more than a well written lesson plan.Our attitude to lesson plans is full of hypocrisy too. Treating TB beyond medicine

t the recently concluded World Health Assembly at Geneva, the announcement of India's trachomafree certification by the World Health Organization (WHO) is more than just a public health triumph; it's a profound testament to the power of a collective national will. This achievement, born from decades of proactive efforts in hygiene, cleanliness, and awareness, offers a compelling blueprint for how India is now tackling another ancient scourge, tuberculosis (TB). Indeed, the echoes of the trachoma victory resonate strongly in the nation's ambitious drive towards a TB-Mukt Bharat.

Just as a sustained focus on fundamental public health principles underpinned the fight against trachoma, the current war on TB is being waged with an equally comprehensive, and crucially, deeply ingrained Jan Bhagidari -people's participation-philosophy. This isn't merely a catchphrase; it's the very bedrock of the government's strategy. The recent 100-day TB elimination campaign provides a vivid illustration of this resolve. The sheer scale of the undertaking, with 12.97 crore people screened and over 7.19 lakh TB patients notified, is staggering.

Yet, what truly sets this effort apart is the parallel commitment to dismantling the social symptoms of TB. The organization of 13.46 crore "Ni-kshay Shivirs," or community screening and awareness camps, speaks volumes about a recognition that effective treatment extends beyond medicine to encompass the eradication of stigma, myths, and misinformation.

Jan Bhagidari, in the context of TB elimination, is a vibrant, multi-faceted phenomenon. It's an ecosystem that supports the tireless dedication of community health workers like ASHAs and Anganwadi workers, who are the most valuable point of contact in remote villages. They are the unsung heroes identifying presumptive cases, ensuring treatment adherence, and providing vital nutritional support. Building on this foundation, the mobilization of resources by local self-help groups, NGOs, and faithbased organizations further strengthens this community-led effort by establishing critical patient support networks.

Before these frontline warriors even step onto the field, however, the ground is already being prepared by India's dynamic media ecosystem. The catchy slogan for the 100day campaign, 'Jan Jan Ka Rakhe Dhyaan, TB-Mukt Bharat Abhiyaan', is not just a clever turn of phrase; it's a national clarion call, resounding across television, radio, and public spaces in myriad local languages. This comprehensive awareness generation has



been significantly bolstered by unwavering political will, with the highest echelons of government, including the Honourable Prime Minister, consistently championing India's progress. D&FCO issues Advisory for FBOs, Consumers on Artificial Fruit Ripening Recommends use of approved source of Ethylene Gas; Warns against applying banned calcium carbide

JAMMU, MAY 29: The Drug and Food Control Organisation(D&FCO) has advised the Food Business Operators (FBOs) dealing with storage, packaging, distribution and sale of Fruits & Vegetables to strictly adhere to the prescribed guidelines during and post artificial ripening treatment to ensure safe and compliant ripening practices, failing which penal action as warranted under FSS Act2006 shall be initiated.

The Organization has specially issued advisory for repining of Climacteric Fruits-Fruits which are harvested at full maturity and can be further ripened during transit or storage like Banana, Guava, Avocado, Mango, Apple, Pear, Apricot, Peach and Tomato etc

Artificial ripening is the process by which ripening is controlled to achieve desired characteristics intended for better consumer acceptance. Fruit trade involves

transporting fruits to distant places. It said that considering the issue of use of banned calcium carbide and non-availability of alternative ripening agent, Food Safety & Standards Authority of India (FSSAI) permitted the use of ethylene gas for ripening of fruits in India vide notification dated 23.08.2016, subject to adherence to the SoPs by the Food Business Operators

A detailed SoP for use of Ethylene gas for artificial ripening has been notified by FSSAI and available at the official website https://fssai.gov.in/cms/guidance-notes.

Artificial Ripening with Calcium Carbide, popularly known as 'Masala' has been strictly banned in terms of sub-regulation 2.3.5 of Food Safety & Standards (Prohibition and Restrictions on Sales) Regulation, 2011, due to its potential health hazards. Recommending the use of Ethylene Gas, D&FCO said that Ethylene is a hormone produced naturally within the fruits to $stimulate \, ripening \, process. \, Ethylene, being$ a natural hormone, does not pose any health hazard to consumers.

Ethylene gas, ethanol, ethephon, etc. can be used on fruits to trigger the ripening process in fruits, under controlled conditions of Humidity, Temperature and Expo-

However, any source of ethylene gas coming in direct contact with fruits is not per-

Further, only the approved source of Ethylene Gas is allowed to be procured and used, besides ensuring authenticity/purity of the sachets containing ethephon in powdered form and other components.

"Only those sachets must be used that are properly labelled mentioning details of manufacturer, composition, instructions for use etc. Use of Ethylene Gas for artificial ripening can be done upto the concentration of 100 ppm (100 μ l/L) only" the organization advised further.

Fruit should not occupy more than 75% of the volume of the chamber (as well as crate) during the treatment.

Gas leakage monitoring system should be installed in the commercial ripening cham-

Stacking of boxes should be done keeping minimum 4-6 inches space from the walls and between the adjacent crates.

Revised_10_02_2020.pdf Consumers also are advised to remain vigilant in the market and purchase fruits from known sellers/reputed stores/dealers who declare that fruits sold have not been ripened using harmful/banned chemicals and to wash fruits thoroughly with potable water before its use/consumption to ensure its safety and quality.



Age-related decline in the immune system can have a measurable impact on CAR-T cell therapy -- one of the most advanced forms of cancer immunotherapy, according to a study.

CAR-T therapy works by engineering a patient's T cells to recognise and destroy cancer cells.

The study led by Swiss researchers found that CAR-T cells from aged mice had poor mitochondrial function, lower "stemness," and reduced antitumour activity.

"By correcting age-related metabolic defects, we could improve outcomes for a large segment of cancer patients.'

power supply to our citizens especially during the harsh winter season."

This initiative aims to multiply breeder, foundation, and True Potato Seed (TPS) seeds, moving beyond the university's previous focus solely on breeder seeds to meet the growing demand of the valley.

In a landmark event today at Badugam, Tulail, a renowned potato growing area, 150 quintals of breeder seed were distributed among farmers through a participatory approach. This initial phase covers 7.5 hectares (150 Kanals) of land, in addition to over 75 percent of the cultivable area at the Mountain Agriculture Research & Extension Station (MAR&ES) and Krishi Vigyan Kendra (KVK) Gurez.
