



## Biggest Ever, Most Successful Anti-Terror Operation was Carried out in Shape of 'OPERATION SINDOOR': PM Modi

PM Further Reiterated that Proxy Wars Will Not be Tolerated Anymore'

Bhopal, May 31 (UNI) Prime Minister Narendra Modi on Saturday said proxy wars by terrorists will not work and bullets will be answered with cannon balls, adding that 'sindoor' has become a symbol of valour following India's response to the Pahalgalam terror attack.

He also described Operation Sindoor as the biggest and most successful anti-terror operation in the country's history. Speaking at the 'Lokmata Devi Ahilyabai Mahila Sashaktikaran Maha Sammelan' here on the occasion of the legendary queen's 300th birth anniversary, Modi said, "Through a decisive response, Bharat gave a message that proxy war by terrorists will not work. Bharat, a land of culture and values, sees sindoor as a symbol of women's power. Today, that same sindoor has become a symbol of our valour and resistance to terrorism." "If you fire bullets, then rest assured that they will be answered with cannon balls," Modi said.

"India is a country of culture and traditions, and sindoor is a symbol of women power in our tradition. Hanuman ji, who is immersed in Ram Bhakti, also sports sindoor. We offer sindoor in Shakti Puja. This sindoor has become a symbol of bravery," he said.

Earlier this month, Indian armed



forces carried out missile strikes on nine terror targets in Pakistan and Pakistan-Occupied Kashmir under Operation Sindoor. The operation was conducted two weeks after the massacre of 26 civilians in Kashmir's Pahalgalam.

## UN Glaciers' Meet: India Says Pakistan Violating Indus Water Treaty Through Terrorism

NEW DELHI, MAY 31: India has said that Pakistan should stop blaming it for the breach of the Indus Water Treaty, as the unrelenting cross-border terrorism from its soil is interfering with the treaty's implementation.

Addressing the plenary session of the first UN conference on glaciers in Tajikistan's Dushanbe on Friday, Minister of State for Environment Kirti Vardhan Singh said that Pakistan itself was violating the treaty through terrorism.

"We are appalled at the attempt by Pakistan to misuse the forum and to bring in unwarranted references to issues which do not fall within the purview of the forum. We strongly condemned such an attempt," he said. Singh said it is an undeniable fact that there have been fundamental changes in circumstances since the

## 'World No Tobacco Day'

J&K has 6th highest prevalence of tobacco use in India

Srinagar, May 31: On the occasion of World No Tobacco Day, worrying data has emerged that places Jammu and Kashmir among the top six states and union territories in India with the highest prevalence of tobacco use.

According to health officials, more than 20 per cent of the population in J&K is

engaged in some form of tobacco consumption.

An official informed the news agency that smoking tobacco in the region stands at a prevalence rate of 20.8%. This ranks J&K sixth in the country, following Manipur, Arunachal Pradesh, Tripura, Meghalaya, and Mizoram. However, the use of smokeless tobacco is significantly lower in the region at just 4.3%, making it the second-lowest in the

country after Himachal Pradesh.

According to the Global Adult Tobacco Survey (GATS 2) data, 35.2% of men and 5.1% of women in J&K smoke tobacco, with an overall adult prevalence of 20.8%. In terms of smokeless tobacco, 6.8% of men and 1.5% of women—4.3% of all adults—are current users. Altogether, 39.7% of men and

## Police arrests 02 in Facebook donation fraud in Srinagar

SRINAGAR MAY 31 (KNS): In a swift and decisive action, Srinagar Police busted an online fraud racket involving a fake medical donation appeal on social media platform (Facebook). On 30th May 2025, Police Station Nowhatta received a written complaint from Muneer Ahmad Misger son of Mohammad Sadiq Misger resident of Mughal Masjid, Nowhatta, stating therein that an unidentified journalist had uploaded a photograph of his sister on Facebook with a fabricated story to appeal for public donations for a surgery that never occurred. The act, carried out with malicious intent, amounted to cheating and exploitation.

Accordingly, a case vide FIR No. 21/2025 was registered under sections 318(2) and 319(2) of the Bharatiya Nyaya Sanhita (BNS) and investigation was initiated.

During the course of the investigation, the administrator of the Facebook page involved in the fraudulent post was identified as Mohammad Lone son of Ali Mohammad Lone, resident of Tujan, Pulwama and arrested. Another accused namely Amir Yousuf Khan son of Mohammad Yousuf Khan, resident of Bandipora, presently residing in Gulab Bagh, Zakoora, was

"This challenge has sounded the death knell for terrorists and their handlers. Operation Sindoor is the biggest and most successful operation in the history of India against terrorists. While the Pakistan army could not even imagine, our army destroyed the terrorist hideouts," he added.

Talking about the Nari Shakti Vandan Adhiniyam, also known as the Women's Reservation Bill, which aims to reserve one-third of the total seats in the Lok Sabha and state legislative assemblies, the PM said, "This time, 75 women have become members of Parliament. Our effort is to increase this number." This is the spirit behind the Nari Shakti Vandan Adhiniyam. Women reservation in Parliament and state assemblies had remained pending for a long time, but has been achieved now, he said.

"This means the BJP government is empowering our sisters and daughters at every level and in every field," he said.

He also said the world is witnessing the capability of India's daughters in the defence sector today.

"To achieve this, the government took many steps in the last decade. From school to the battlefield, the country today has unprecedented faith in the bravery of its daughters," he said.

Referring to Lieutenant Commanders Roopa A and Dilna K, who recently returned to India after circumnavigating the globe in a sailing boat, the PM said the two brave daughters of the Navy completed the 250-day voyage.

"Our government is working on the mantra of 'Nagrik Devo Bhava' (citizen is god), which was the philosophy of Ahilyabai Holkar," he added.

Rani Ahilyabai Holkar was born on May 31, 1725, at Chondi village in Maharashtra's Ahilyanagar. She ruled the Malwa region of central India from 1767 to 1795, as the queen of the Holkar dynasty in the Maratha Empire.

"When we talk of girls' marriageable age, some people in the country see secularism in danger. They think it is against our religion. But Devi Ahilyabai thought about the marriageable age of girls in those times," he said.

"She got married at an early age. She knew the way to girl's progress. In Malwa Sena, she created a special battalion of women. These people of the western world do not know. They curse us in the name of the rights of women and try to portray us in a bad light. Women were in our army even 250-300 years ago. At village level, she created safety groups for women," Modi noted.

"When the country was in shackles of slavery 250-300 years ago, it was not easy to do something so impactful that future generations would remember it. But Devi Ahilyabai did it. She never separated devotion to God from service to the people," he said.

She was a great guardian of India's heritage. When temples and pilgrimage sites were being attacked, she took the initiative to rebuild and preserve them, including Kashi Vishwanath, he added.

"I consider myself fortunate that the same Kashi has given me the opportunity to serve. When you visit Kashi today, you will find signs of Ahilyabai's work. She created a model of governance where the poor and deprived were given priority," he added.

Earlier, Modi released a commemorative stamp and Rs 300 coin to mark her birth

The region amidst the fresh wet spell has witnessed cold days with Srinagar recording a maximum temperature of 14.5 degree Celsius, which was 12.2 degree Celsius below than normal.

Qazigund, a gateway of Kashmir, recorded 13.0 degree Celsius, which was 12.6 degree Celsius below normal while Pahalgam recorded 8.2 degree Celsius and 14.8 degree Celsius below normal.

Kokernag, Kupwara and Gulmarg have recorded a maximum temperature of 12.0 degree Celsius, 12.8 degree Celsius and 6.8 degree Celsius respectively.

Jammu region has also recorded the cold day with winter capital recording a maximum temperature of 32.9 degree Celsius while Banihal and Batote recorded 14.6 degree Celsius and 18.1 degree Celsius respectively. Baderwah has recorded a maximum temperature of 18.4 degree Celsius while Katra recorded 28.6 degree Celsius.

Meanwhile, an independent Weather Forecaster, Faizan Arif Keng told KNO that the weather conditions would improve from tomorrow while short spells of showers can continue during the next three days.

"Temperature will remain near normal to below normal during the next three days," he added—

Indus Waters Treaty was signed, which requires a reassessment of the treaty's obligations.

These changes include technological advancements, demographic changes, climate change and the ongoing threat of cross-border terrorism, he said.

The minister said that the treaty's preamble states it was concluded in the spirit of goodwill and friendship, and that honouring the treaty in good faith is essential.

"However, the unrelenting cross border terrorism from Pakistan interferes with an ability to exploit the treaty as per its provisions."

"Pakistan, which itself is in violation of the treaty, should desist from putting the blame of the breach of the treaty on India," he said.

At the International Conference on Glaciers Preservation, Pakistan Prime Minister Shehbaz Sharif on Friday said his country would not allow India to cross the red line by holding the Indus Waters Treaty in abeyance and endangering millions of lives for narrow political gains.

"India's unilateral and illegal decision to hold in violation the Indus Waters Treaty, which governs the sharing of the Indus Basin's water, is deeply regrettable," Pakistani newspaper Dawn quoted Sharif as saying.

Following the April 22 terrorist attack in Pahalgam, Jammu and Kashmir, which killed 26 people, India announced the suspension of the treaty as part of several punitive measures against Pakistan. Fine dining reservations

He also asked the officials to ensure 100% saturation of flagship schemes like Ayushman Bharat. "Don't leave any beneficiary unregistered. Every citizen must experience the impact of the Modi Government's transformational schemes," he stated.

Highlighting recent strides in science-driven agriculture, Dr. Jitendra Singh showcased a series of transformative initiatives reshaping the agri-economy of the region.

"The Biotech Industrial Park in Kathua has been made operational and integrated with Biotech Kisan Clusters, serving as a hub for innovation and farmer-scientist collaboration. The Purple Revolution, marked by the successful cultivation of lavender in Baderwah in collaboration with IIM Jammu, has now spread to neighbouring states like Himachal Pradesh and Uttarakhand, enabling young agri-entrepreneurs to earn lakhs through sales in high-end perfume markets," he added.

Dr. Jitendra Singh also highlighted a breakthrough project by the Department of Atomic Energy and DBT to enhance shelf life and productivity of crops—enabling Kashmiri apples to now grow in Jammu alongside mangoes.

Touching upon the nation's historic and cultural identity, Dr Singh emphasized the importance of remembering and honoring key national milestones and movements. He recalled the Emergency of 1975 as a "Black Day", underscoring the need to observe its 50th anniversary on June 26 as a reminder of the value of democracy and civil liberties.

In anticipation of World Environment Day on June 5, he directed renewed enthusiasm for the 'Ek Ped Maa Ke Naam' campaign, encouraging citizens to participate with greater dedication and vigour.

Dr. Jitendra Singh also advocated for grand celebrations on International Yoga Day (June 21), particularly at major tourist destinations, to highlight India's global leadership in wellness and mindfulness.

Furthermore, he appreciated the Tiranga Yatra, linking it with the success of "Operation Sindoor," and called for its continued celebration as a symbol of national pride and collective self-esteem.

Dr. Jitendra Singh is also set to launch the two-day Lavender festival on 1st June at Baderwah. Under the Floriculture Mission in J&K, over 385 hectares have been brought under cultivation, directly benefiting more than 3,000 farmers, with breakthroughs such as genetically engineered roses that can bloom in desired colors and across seasons. The MoE said, "It was highlighted that enrolment in private schools is higher in comparison to government schools."

"Further, the UT was advised to prioritise the improvement of the Gross Enrolment Ratio (GER) and Net Enrolment Ratio (NER) at the Higher Secondary level in the coming years," reads the report.

Furthermore, the ministry has said that out of the total 18,785 government schools, only 3304 that amounts to 17.6 percent schools have solar panels installed. "Further, there are very few secondary or senior secondary schools without ICT and computer labs, smart classrooms and subject specific labs in the UT."

The MoE suggested that these gaps can be saturated this year only. Accordingly UT was advised to identify the gaps through UDISE+ and propose these schools in the current year Annual Work Plan and Budget (AWP&B) for the consideration by the board.

Earlier this week KNO reported that MoE in the report had said that in Jammu and Kashmir at least 65 government schools are having zero student enrolment and more than five thousand primary schools are with less than 30 enrolment and over 1500 schools are reeling under enrolment with only 15 students each.

MoE had said, "Out of the total 18,785 government schools in the UT, there are 65 schools including 62 primary and three upper primary schools are with zero enrolment."—(KNO)

6.2% of women—23.7% of all adults—either smoke or use smokeless tobacco.

The official said that in the past five years,

the government has implemented a slew of measures to curb tobacco consumption. "Thousands of challans have been issued and lakhs of rupees collected in fines from violators found smoking in public places," he said.

He added that many individuals in the Kashmir Valley have quit smoking over the years, supported by widespread counselling and pharmacotherapy sessions. Awareness drives are also being carried out across the region to inform the public of the serious health risks associated with tobacco use.

"If we are able to make people aware and conscious about the dangers of tobacco, there won't be a need for enforcement," he said, emphasising the importance of education over punishment.

In line with national guidelines under the Cigarettes and Other Tobacco Products Act (COTPA), 2003, enforcement drives are being conducted regularly. Officials have also been directed to make sure that educational institutions and tourist destinations remain tobacco-free zones.

J&K has also imposed a complete ban on the sale of loose cigarettes, beedis, and tobacco, aiming to limit accessibility and deter casual consumption.

Health experts warn that smokers and tobacco users are 2.5 times more likely to develop tuberculosis (TB), with tobacco use known to raise the risk of TB, cause recurrence, and impair treatment. Officials urged the public to quit tobacco now for a healthier future.

Globally, tobacco remains the leading cause of preventable deaths, claiming over seven million lives annually, with more than one million deaths occurring in India alone.

Kashmir has also witnessed a rising trend in tobacco-related illnesses, particularly lung cancer, which is now the second most common cancer in the region. Hospital data indicates that men are disproportionately affected, with a direct link between smoking duration, frequency, and the development of cancer.

Though the risk of cancer persists even after quitting, experts assure that the chances decrease significantly over time, making early cessation critical—(KNO)

## May's freak weather points towards environmental concerns in Kashmir

The month of May has witnessed freak weather across the Kashmir valley with the day temperature reaching 34.5 degrees Celsius and the same plummeting to 14.5 degrees Celsius on the last day of the month i.e., Saturday. Not only has the day temperature seen both the upward and downward trend during this month but some other disturbing weather patterns were also witnessed. These include gusty winds, hailstorm and continuous rainfall at a tremendous speed.

Environmentalists across the globe have over the years issued stern warnings about the changing weather patterns and Kashmir valley is no exception in this respect. Erratic weather has become the order of the day in the valley and the people are very much worried about the same. Over the past one week or so the Kashmir valley has been greeted with spells of rain, hailstorm and devastating winds. Before this the valley witnessed abnormal day temperature with a large section of people demanding early summer vacation for the schools.

The unprecedented heat wave led to a change in the school timings and as on date the children have to leave early in the morning for their schools. With the day temperature plummeting more than 12 degrees below the normal level on May 31 the woollens were out and people could be seen wearing sweaters, jackets as well as uppers. Due to the inclement weather conditions most of the people preferred to remain indoors and as such there was less movement of masses on the roads.

One can expect the temperatures both day as well as night to go down and it is not so worrisome. The cause of worry is the frequent spells of hailstorm across the length and breadth of the valley and also the high intensity winds that lead to devastation both on the human as well as material front. Few days back a woman lost her life after a tree fell on her in the Tral area. The high intensity winds have led to damages to properties of different forms.

Climate change is a global phenomenon and it has to be understood by one and all. The people more so the common masses and also those who are at the helm should take measures that will bring about stability. Since deforestation has taken place in an unprecedented manner it is important that trees are planted in a good number so that parity is restored and there is no more damage to the environment.

## Dominance of Chaupals in Haryana - Roots of democracy or chains of tradition?

In the socio-cultural life of Haryana, Chaupal has not been just a place to sit but a tradition, a power structure and an informal justice system. When the village elders sit under a peepal tree or on a paved platform and discuss, it is called "Chaupal" in common language. But this Chaupal is not limited to just conversations but has become an institution that decides the social direction. But today the question is whether this dominance is positive or is it becoming an obstacle in the way of a democratic and just society?

## Historical background: The role of Chaupals

When the Panchayats were not fully developed in Haryana, the importance of Chaupals was even greater. Any village matter - be it a land dispute, fixing a marriage relation or deciding to boycott someone - everything was done in the Chaupal. It was a symbol of local self-governance, which was based on the principle of collective dialogue. But as time changed, the institutions of democracy, Panchayat elections, police-administration and courts became stronger, the role of Chaupals should have also changed. But even today in Haryana, Chaupals remain the "informal court" of social decisions.

## Chaupal vs Constitution: A clash

The Constitution of India gives equal rights to every citizen - discrimination on the basis of caste, sex, religion or class is prohibited. However, decisions in the Chaupals are often based on caste hierarchy. For example: "A boy from this caste should not marry a girl from that caste." "He has married without the panchayat, so he will be boycotted." These decisions are against the basic spirit of the Constitution. Women and Dalits in particular rarely get a chance to speak in the Chaupal. In most cases, the Chaupals become a bastion of patriarchy and casteism.

## Social control or social exploitation?

Chaupals sometimes play the role of social control that acts before the law. For example, when a girl uses a mobile phone, the Chaupal pronounces - "ban mobile phones." Or "those who have married for love should be expelled from the village." Such decisions fall under the category of social exploitation. Even

today, incidents of honour killings are reported in Haryana, which have their roots in the decisions of the Chaupal. The basic reason for this dominance is that Chaupals are often monopolized by elderly men, where youth, women or socially marginalised people cannot raise their voice.

## Do Chaupals also have a positive role?

It would be wrong to say that Chaupals play only a negative role. In some areas, Chaupals are also a democratic form of resolving mutual disputes, maintaining social harmony, and taking collective decisions. Such as: water conservation, de-addiction campaign, or collective efforts to promote education. Making rules to prevent wasteful expenditure in marriages. But this role is constructive as long as it ensures everyone's participation and is in accordance with the Constitution.

## Political use and abuse

Chaupals have been used extensively in Haryana's politics. Leaders go to Chaupals to do public relations, but at the same time they also use them as a means of caste mobilization and social polarization. Concepts like "Choudhary ji's decision is more important than all" in Panchayat elections or Assembly elections harm the democratic process.

## Women and Chaupal: Entry prohibited?

Participation of women in Haryana's Chaupals is still very limited. Even though women have got reservation in Gram Panchayats, when the same woman Sarpanch goes to the Chaupal to present her views, she is silenced. This is a double standard - empowerment on paper and neglect on the ground.

Many social activists fighting for women's rights have faced direct opposition from the Chaupal culture. That is why the dominance of Chaupals is becoming an obstacle to women's participation.

## Thinking of the new generation and distance from the Chaupals

Today's young generation, influenced by the internet, social media and urban life, is distancing itself from the Chaupal culture. They find this system outdated and biased. The youth ask questions: "Whom should I love, how will an elder decide this?" "I will decide my career path, not the Chaupal." The democratic consciousness of this generation is challenging the dominance of the Chaupals. This is the direction of democracy, which needs to be strengthened in the villages.

## Can there be a new form of Chaupals?

The solution is not to completely reject the Chaupals, but there is a

need to redefine them. For example: Women, Dalits and youth should get equal rights to speak in the Chaupals. Decisions should be tested on the basis of rules and laws. Chaupals should be used in social campaigns, rural development and promotion of education. If Chaupals become an extension of democracy, then they can remain relevant even today.

## Chaupal: Tradition or symbol of patriarchy?

The basic concept of Chaupals has been mutual dialogue, consultation and dispute resolution. But now this place often seems to be a hub of social oppression and caste dominance instead of justice. In the villages of Haryana, most of the Chaupals are dominated by men only. Women can neither speak nor sit there. This inequality is not just gender based, it is also caste and economic class based. Ignoring the words of backward classes, Dalits and minorities has become a part of the old traditions of these Chaupals.

## The truth of the data:

Haryana tops the list of honour killing cases. Of the 25 cases registered in the country in 2021, 17 were from Haryana. Khap or Chaupal played a role in most of these cases. According to the report, 60% of rural disputes are first resolved in the Chaupal, 80% of the decisions of which do not involve women. A report by the Haryana State Women's Commission (2020) shows that 72% of rural women are deprived of their rights due to the conservative system of Chaupal.

## 'Balla village' of Karnal district, Nalwa village of Hisar district

In 2016, the Chaupal of Balla village in Karnal decided to expel a loving couple from the village citing 'same gotra'. The woman was estranged from her family and the boy was threatened with death. When the matter went to court, the court found it to be a violation of Article 21 (life and personal liberty) of the Constitution. But by then society had pronounced its 'punishment'. This case shows that even today Chaupals can ignore the law in the guise of their tradition. In 2019, a Dalit family faced social boycott in the Chaupal of Nalwa village in Hisar only because their daughter had married an upper caste youth. The Panchayat not only prevented the entire family from coming to the Chaupal, but also prohibited them from filling water from the village well and purchasing from ration shops.

## Positive example: Bibipur village, 'Dhosi village' of Bhiwani, Rewari district

But not every Chaupal is a symbol of fanaticism. Bibipur village in

Bhiwani changed the definition of Chaupal. The Sarpanch there, Sunil Jaglan, made the Chaupal a platform to raise the voice of women. The 'Selfie with Daughter' campaign started from here. A women's forum was set up in the Chaupal, where women also participate with equal rights. There was an open debate and decisions were taken on issues like de-addiction, child marriage, education and toilets. This Chaupal of Bibipur shows that when the society wants, tradition can be combined with modern values. According to the Haryana Panchayat Development Report (2021), Chaupals in 78% of the villages of the state are not operated under any legal framework, due to which they often take decisions outside the scope of the Constitution. Digital Chaupal was started for the first time in 2022 in the village Chaupal on the demand of the youth. In this, the problems of the village were linked to the block office through video conference and women also got equal participation. Its direct effect was that quick decisions and solutions were taken on issues like toilet construction, scholarship distribution and MNREGA wages in the village.

## Criticism of Chaupals in the media

"Khap panchayats in Haryana still control social behaviour, bypassing constitutional rights." "In a Rohtak village, a girl was punished for wearing jeans - the chaupal gave the verdict, women were expelled." While Haryana's chaupals are symbols of dialogue and community, they have also become an obstacle to democracy and equality. These chaupals now need to introspect. They should adapt tradition, but with inclusiveness, gender equality and constitutional values. The chaupal of Bibipur is an ideal, while the chaupal of Balla is a warning. It is now up to the villages of Haryana to choose which path they take - the path of democracy or the shadow of tradition?

## We need participation, not domination

The Chaupals of Haryana are the mirror of the society - but when the mirror itself becomes blurred, the image also gets spoiled. If the dominance of the Chaupals suppresses equality, justice and democratic values, then it is necessary to challenge it. But if it is made inclusive, sensitive and democratic, then it can become the strongest institution of rural India. We have to decide whether the Chaupals will remain a platform for dialogue or the throne of power? Till the time the Chaupals do not become the voice of everyone, their dominance will remain a threat to democracy.

# Turn intent into action for a child marriage free India by 2030

Last year on Akshaya Tritiya, something remarkable happened in Rajasthan. A day that had long been associated with a surge in child marriages passed without a single reported case in the state. That wasn't a coincidence. It was the result of strong judicial intervention, clear Government directives, and the grit of a network of NGOs that responded with urgency. The Rajasthan High Court, in response to a petition by the Just Rights for Children (JRC) network, ruled that village heads would be held accountable for any child marriage in their jurisdiction. The state administration acted swiftly, activating enforcement mechanisms at every level.

It was a moment that proved the power of coordinated action. That breakthrough was more than just a one-day victory it signalled what's possible when law, governance, and community align. But the challenge goes beyond Akshaya Tritiya, and the question is no longer whether this change is possible, but whether this change can be seen across all religions, faiths, and all auspicious occasions when child marriage sees a surge. The question is how to make it consistent, how to scale it nationally, and how to sustain the momentum so that India can truly become child marriage-free by 2030 – a goal the Government has already committed to achieving. India is not lacking in laws or intent.

The Prohibition of Child Marriage Act is clear. The Protection of Children from Sexual Offences Act is well drafted. The Government of India's recent nationwide campaign for a 'Bal Vivah Mukta Bharat' shows a new level of resolve. Networks like Just Rights for Children, who have long been working to end child marriage, have actively been supporting the cause, and the judiciary is taking firm steps. The over 250 NGOs of the network have been following a strategic roadmap outlined in Bhuvan Ribhu's best-seller, 'When Children Have Children: Tipping Point to End Child Marriage'. Notably, hearing the petition by Just Rights for Children's partner, SEVA, the Supreme Court passed a judge-



ment last year on Child Marriage, which is a roadmap for action to end Child Marriage.

The judgement emphasised a prevention-protection-prosecution strategy and community-driven approach; guidelines issued to various ministries for the complete elimination of child marriage; a multi-sectoral coordination, training and capacity building of the law enforcement officers needed to be there.

What we need now is to turn this intent into action at every level of society, especially at the last mile – in our panchayats, schools, and households. One of the most commendable recent steps has come once again from Rajasthan. In March 2025, the state Government issued an order that makes it mandatory to print the date of birth of both the bride and groom on every wedding invitation card. It may appear like a small bureaucratic detail, but it's a transformative move. With this step, age becomes public information – subject to scrutiny by relatives, neighbours, vendors, and authorities. It empowers communities to intervene early and gives law enforcement a tangible way to identify and prevent illegal child marriages. This is a smart, low-cost, high-impact innovation that should be replicated across all states. There's an irony we must acknowledge: poverty is often cited as the main reason

families marry off their children early. But India also runs some of the largest social welfare programmes in the world – from free education for girls to scholarships, health insurance, and livelihood support schemes. The disconnect isn't in the intention or the policy. It's in awareness and last-mile delivery. Far too often, families simply do not know about the schemes they are eligible for.

This is where panchayats and grassroots networks must play a stronger role. Panchayats are not just local governance bodies – they are the bridge between citizens and the state. When empowered and informed, they can help families access schemes, encourage education, and intervene when early marriages are being planned.

And as Rajasthan has shown, when panchayats are held accountable, they become effective watchdogs as well. Education is another key pillar. Without ensuring that every girl stays in school till the age of 18, we will not be able to end child marriage. The dropout rates after Class 8 remain high in many parts of the country, and this is precisely the age when girls become vulnerable. Investing in education – not just by building schools but also by ensuring safe transport, toilets, books, and digital tools – is an investment in a child marriage-free future. Several states, including Bihar, West Bengal, and Odisha, have introduced conditional cash transfers to encourage families to keep their daughters in school. These schemes have had measurable success. The central Government's Beti Bachao Beti Padhao campaign has also done important work in shifting public perception around the value of girls. These are efforts that must be strengthened and expanded.

At the same time, enforcement must remain strong. Child marriage is not a tradition – it is a punishable crime. And everyone who facilitates it, knowingly or unknowingly, must be made aware of the consequences. This includes priests, band players, transporters, and tent owners. Sev-

eral state Governments have rightly asked all such vendors to take pledges to refrain from supporting child marriages.

These are necessary steps – part of the broader cultural shift that's already underway. The positive shift in Rajasthan has also been supported by civil society groups such as the Just Rights for Children (JRC), which works across 416 districts with over 250 NGO partners. Their model combines legal intervention, awareness building, school outreach, and community mobilisation.

Posters in temples and mosques, awareness drives in schools, and legal aid in high-risk districts – these are the kinds of actions that make a real difference. And the Government has welcomed this support, recognising that the fight against child marriage needs every hand on deck. India has reached a turning point. The laws are already success stories to learn from. What we need now is scale.

Every village should have a working group on child marriage prevention. Every panchayat should have data on at-risk children. Every district should have a rapid response mechanism for suspected cases. This is not about doing more, it's about doing smart and doing together.

Let's stop thinking of child marriage as an issue we'll tackle eventually. Let's treat it as a national emergency – one that deserves the same focus we give to infrastructure, health, or digital access. Because at its core, child marriage is not just a violation of a child's rights – it is a threat to India's future.

We already have what we need: committed leadership, strong laws, innovative state initiatives, and an active civil society. If we now add stronger local governance, better delivery of welfare schemes, and consistent public awareness, we will reach the tipping point. India can become child marriage-free by 2030. That's not a dream – that's a deadline. And with the right push, we're closer than ever.

## Growth expected in domestic textile industry

After promoting tourism and technology, the Prime Minister has now resolved to take the Indian textile industry to new heights.

At an investors' conference held in Bhopal, the capital of Madhya Pradesh, he named Madhya Pradesh the 'Cotton Capital' in the textile industry sector. The reason for this is that 25 percent of the country's total organic cotton production comes from here. Indigenous sarees are produced on a large scale in areas like Chanderi, Maheshwari and Khajuraho. This industry has been running for centuries with the help of knowledge tradition and indigenous equipment. If technology-based modernization is done with adequate capital investment in it, not only will production increase, but a global market will also be available for these products.

A study of religious and historical texts, including the Rigveda, reveals that India has been a leader in cotton production, cloth making and dyeing since ancient times, hence, various ways of wearing and wrapping clothes have been prevalent here. The

Rigveda and other Sanskrit texts also provide a detailed description of clothes. These texts describe different types of attire. In India, there is diversity in clothing styles based on geography, climate, season, zodiac sign, caste and religion. Different attires were worn on occasions of celebrations, sports, dance and war. The tradition of cotton production and making clothes from it is more than five thousand years old in India.

The artisans used to spin cotton on a spinning wheel to make clothes. They were also skilled in the technique of dyeing the threads and cloth. It is clear that India has been an expert in making and wearing various types of clothes since ancient times. That is why it got the name of cotton textile industry. This industry holds an important place among the major textile industries in the world due to its wide value chain, availability of local raw materials and expertise in manufacturing art. On the one hand, small artisans are engaged in textile manufacturing. On the other hand, big entrepreneurs who make clothes with modern machines are also active. When the British set their eyes on this industry under the pretext of trade, they destroyed this traditional handicraft and started producing clothes with machines brought from Britain. In 1818, the first cotton textile industry was established in

Fort Gloucester near Kolkata. After this, the foundation of the Bombay Spinning Mill was laid in Mumbai in 1854. Today, 10 crore people are earning their livelihood through about 3400 textile industries in the country. Apart from this, large-scale cloth production is also done through handloom, handicrafts, small-scale electric looms and traditional methods.

These small and cottage industries provide employment to lakhs of people at the local level. The industry includes cotton, natural and man-made fibres, silk-based fabrics and woven fabrics. Textiles account for 4.5 per cent of India's total exports and contribute 15 per cent to export earnings. However, imports of foreign textiles have weakened this domestic industry. Exports have also declined. Countries like Bangladesh and Vietnam have overtaken India in textile exports. Madhya Pradesh has already been a leader in textile manufacturing. Large textile industries like JC Mills in Gwalior, Hukamchand Mills in Indore and Vinod Mills in Ujjain were active till the seventies. But strikes by employee organisations almost destroyed them.

Birla's textile industry is still present in Nagda. Apart from this, saris are being manufactured on a large scale using hand spinning wheels in Chanderi and Maheshwar. The original Chanderi saree has a GI

tag, which certifies its authenticity and quality. This protects the customers from fake sarees. Recently, Aryapratap Singh in Gwalior has started manufacturing clothes based on Vedic science. Nowadays, there is increasing interest in Vastu and astrology among the youth, keeping this in mind, the production of clothes with symbols of Vedic astrology, planets and constellations has been started.

Their price ranges from Rs 80,000 to Rs 4 lakh. Computer science engineer and CEO of God Company Arya Prakash Singh says that he designs clothes based on the date, place, time and palm lines of the customers. They are designed according to the effect of color, gemstone and metal on the zodiac sign. The branding and marketing of these clothes is being done through social media, website and Instagram. Arya Pratap got this inspiration from reading Ramayana and watching films and serials based on it. It is our ignorance that we consider Western countries as leaders in science and technology, while in reality India, especially Britain, was much ahead when Britain took over our textile industry.

At that time, our artisans were experts in making fine yarns of 2400 to 2500 counts. They could make a yarn 29 yards long in one grain weight. Even with today's most modern technology, only

yarns of 400 to 600 counts can be made. Yarns of 2400 to 2500 counts were made in Murshidabad. The British cut off the thumbs of the artisans to put an end to this art, after which the British textile industry was established in India. This technique was not recorded in books, but was ingrained in the minds of the artisans through knowledge-tradition and home training.

This rich tradition of Indian textile industry was affected by the oppression of the British. Evidence of their cruelty is found in their diaries. The cloth that was sent to Britain from Surat was forcibly made by the artisans. Heavy fines were imposed for not completing the work on time. The company paid the artisans so little that if they had sold the same goods to Dutch, Portuguese or Arab traders, they would have been able to sell them.

Then they would get a very high price. The artisans were forced to such an extent that they could not even leave this profession. Many restrictions were imposed on their freedom. Investing in this industry will not only revive it but will also provide employment to millions of people. This is an opportunity to revive the ancient prosperity of India.

the Tobacco Epidemic, its epidemiology, health and environmental consequences of Tobacco use and Tobacco Control Laws, with a special focus on this year's theme - "Unmasking the Appeal: Exposing Industry Tactics on Tobacco and Nicotine Products."

This year's campaign will focus on revealing the tactics that the tobacco and nicotine industries use to make their harmful products seem attractive. The industry consistently tries to find ways to make these products appealing, by adding flavours and other agents that change their smell, taste or appearance. These additives are designed to mask the harshness of tobacco, thereby increasing its palatability particularly among young people. Glamorized marketing, deceptive designs, addition of Coolants and additives strategically attracts a younger demographic, including through digital media channels. These tactics can contribute to early initiation of smoking or nicotine use with potential lifelong addiction and health consequences. By making these products more attractive, the industry not only boosts their immediate consumer base but also makes quitting harder, prolonging exposure to harmful substances.

## DC Poonch reviews progress of Mission Yuva implementation

# Commissioner's post in Food and Drug Administration lying vacant for 3 months in J&K: RTI activist

The position of commissioner in Food and Drug Administration (FDA) has been lying vacant since the retirement of Hashmat Ali Yauto in February, an RTI activist said on Saturday, questioning the delay in filling the vacancy. Jammu-based RTI activist Raman Kumar Sharma had filed two applications in April with the health and medical education department using Jammu and Kashmir government's RTI portal, asking who had been appointed to the post of commissioner after Yauto's retirement

and reason for the delay in appointing a new officer in his place. "The Health & Medical Education Department transferred the applications to the Food Safety Department and finally it was responded to on May 19, confirming that the post is still lying vacant and that the matter is with the General Administration Department (GAD)," Sharma told PTI on Saturday. He said no timeline or proposal was shared in the reply. Yauto, an IAS officer, retired as commissioner of the FDA on superannuation on February 28.

The FDA commissioner is responsible for enforcing food safety laws, licensing, inspections, and ensuring the availability of safe and standard quality food and medicines to the public. According to the amended J&K Reorganisation Act, the Lt Governor has been granted powers to transfer IAS officers while the postings of Jammu and Kashmir Administrative Service (JKAS) officers remain with the Chief Minister's Office (CMO). "It is shocking that almost three months have passed and the government has neither appointed a new officer nor assigned the charge

to anyone in an officiating capacity," Sharma said. He said the absence of the chief has raised serious concerns about the functioning and accountability of the department. In the past, Sharma said even the Jammu & Kashmir High Court had to intervene in the matter, underlining the importance of filling the post without delay due to its direct link with public health and safety. "This is a critical post. The government's delay is disappointing," he said, adding, "there is no transparency and the silence of the authorities is worrying." (PTI)

# MRI facility sanctioned for GMC Anantnag under CSR initiative, project worth Rs 19.70 crore to ease patient burden in South Kashmir

In a major healthcare boost for south Kashmir, Government Medical College (GMC) Anantnag is set to receive its first-ever Magnetic Resonance Imaging (MRI) facility, sanctioned under the Corporate Social Responsibility (CSR) initiative of the Power Grid Corporation of India Limited (POWERGRID). The development comes in response to sustained efforts by the Deputy Commissioner of Anantnag, Syed Fakhruddin Hamid, who had written to POWERGRID urging the installation of the MRI facility at GMC Anantnag. In response, the corporation approved the project and entered into a Memorandum of Understanding (MoU) with HLL Lifecare Limited for the supply and installation of a 1.5 Tesla MRI



machine. The total cost of the project has been pegged at Rs 19.70 crore, and the installation is expected to be completed by December 31, 2025. In an official letter, POWERGRID confirmed its commitment to funding the project and ensuring timely payments to all vendors involved, adding that HLL Lifecare will not bear any financial liability related to delays or claims. GMC Anantnag, operational since 2019, caters to hundreds of patients daily from across south Kashmir. In the absence

of an in-house MRI facility, many patients are routinely referred to tertiary hospitals in Srinagar or private diagnostic centers, often paying between Rs 5,000 to Rs 8,000 for an MRI scan. This not only adds to the financial burden of the patients but also puts pressure on Srinagar's already overstretched healthcare infrastructure. Sources said GMC had earlier submitted quotations worth Rs 18 crore through the Government e-Marketplace (GeM) for the MRI machine under the CSR proposal. While

the possibility of a 3.0 Tesla MRI was initially considered, the 1.5 Tesla model was finalized due to feasibility and cost-effectiveness. With the upcoming installation, the referral rate to Srinagar hospitals is expected to drop, offering timely diagnostic support to patients and significantly reducing travel-related hardship. The district administration has expressed gratitude to POWERGRID, particularly its Chairman and Managing Director R.K. Tyagi, and Superintendent Engineer South Kashmir, Er Altaf Khan, for their unwavering support in pushing the project forward. Health officials termed the development a "game-changer" for the region, calling it a long-overdue facility that will bridge a critical gap in public healthcare services in south Kashmir.

# Ovarian cancer on rise among young women in Kashmir: Top Oncologist



In an alarming development with regard to women cancer cases among young women are on the rise in Kashmir, a leading oncologist has said.



In a special conversation with Dr. Shamima Wani, Professor and Head of the Department of Oncology, GMC Srinagar, delved into the increasing trend of ovarian cancer in young women in Kashmir, its factors and available treatments. Ovarian Cancer On Rise Among Young Women In Kashmir:

Dr Shamima said that in ovarian cancer, small cysts start forming in one or both ovaries, which later turn cancerous. "But not every cyst can be cancer. Ovarian cancer is a cancer that arises from the uncontrolled division of ovarian cells which if left untreated, can also engulf the surrounding tissues. There are three types of ovarian cancer, including epithelial ovarian cancer, germ cell tumors and stromal cell tumors," she explained. Dr. Sham said that the number of ovarian cancer patients has been increasing in the Kashmir Valley in the last few years. Compared to breast cancer and other cancers, ovarian cancer is now seen more in women here, she said. "70 percent of patients admitted to the oncology department of GMC Srinagar are affected by this



cancer (ovarian cancer). Our data show that the number of ovarian cancer patients is increasing compared to breast cancer," warned the oncologist. Dr Shamima said that the cancer, which was traditionally seen among women above 50 years of age, is also found in women aged 30 to 40 years. She said that epithelial ovarian cancer was most common, which was earlier seen in elderly women, but now it is not limited to women of any particular age. Over the causal agents, Dr. Shamima Wani said that there are many reasons behind this including

late marriage, obesity, late or no childbearing, changes in diet and lifestyle and use of some hormonal drugs. "Apart from this, continuous formation of eggs in the ovaries can also cause ovarian cancer. The formation of eggs in the ovaries should stop for some time. The continuous formation of eggs in the ovaries has negative effects on the ovaries due to which the risk of cancer also increases". Regarding the causes of ovarian cancer in young or unmarried girls, Dr. Shamima said that these include changes in lifestyle and diet, especially

pesticides in vegetables and fruits. As for treatment, she said that 80 percent of ovarian cancer patients are reported at stage three, while 20 percent of patients at stage one and two. "In such a case, complete treatment is possible only in stage one and two. Treatment at stage three is not completely possible. However, even in this stage, 70 percent of patients can be cured, but there is no guarantee that the cancer will not return," she said. Along with breast cancer, the number of patients suffering from ovarian cancer is also increasing in Jammu and Kashmir, especially in the Kashmir Valley. Among them, the number of young women is not less, she said. According to experts, in the past few years, there has been an increase in gynecological cancers in Kashmir compared to other states and UTs of the country. Ovaries are an important part of the female reproductive system. The female reproductive system has two sets of ovaries on either side of the uterus. The ovaries contain ova or eggs which are released for each menstrual cycle. The ovaries are the reproductive glands of women which are dedicated to producing eggs and the female hormones estrogen and progesterone. SOURCE - KASHMIR NEWS TIMELINE

# Digestive health deeply connected to immunity, mental well-being: Doctors

Digestive health plays a critical role in maintaining overall well-being, according to doctors. They say digestive health has a close connection with the immune system, mental health and energy levels. Speaking to the news agency, the doctors said that a balanced diet, proper hydration and limiting processed foods are essential for preserving gut health and promoting a healthier lifestyle. Dr Tariq Ahmad, a gastroenterologist based in south Kashmir, said gut health goes beyond digestion and plays a pivotal role in immune function and emotional stability. "Over 70% of the immune system resides in the gut, making it a key player in defending the body against infections," he said. He elaborated, "The gut is home to trillions of microorganisms that are essential for digesting food, producing vitamins,



and protecting against pathogens. A disrupted gut microbiome can impair immunity, cause fatigue, and even affect mood and mental clarity." Dr Ruqaya Akhter, a psychiatrist, said there is a strong connection between the gut and the brain, often referred to as the "gut-brain axis". "Many neurotransmitters like serotonin, which influence mood and sleep, are produced in the gut. An unhealthy digestive system can contribute to anxiety, depression and cognitive issues," she said. Doctors recommend staying well-hydrated and avoiding ultra-processed foods high in sugars, preservatives, and artificial

additives. These substances can disturb the delicate balance of gut flora, leading to inflammation and sluggish digestion. "Artificial sweeteners, excessive fat intake, and lack of dietary fibre negatively impact gut bacteria. This can slow digestion and reduce nutrient absorption, directly affecting energy levels and vitality," they added. Incorporating more whole foods, fruits, vegetables and fermented items into the diet is encouraged to nourish beneficial gut bacteria, the health experts said, adding that regular physical activity and stress management are also vital components of digestive health.

Digestive health refers to the proper functioning of the gastrointestinal (GI) tract, which includes the stomach, intestines, and associated organs. A well-functioning digestive system ensures the body absorbs essential nutrients and eliminates waste efficiently. "Digestive health is not just about avoiding bloating or constipation," doctors said. "It is deeply connected to immunity, mental health, energy, and even skin health. The gut houses nearly 70% of the immune system and a vast community of microorganisms known as the gut microbiome, which influences everything from mood to metabolism." According to data from the Indian Council of Medical Research (ICMR), up to 30% of Indians suffer from some form of gastrointestinal disorder. While medications can help manage symptoms, prevention through healthy lifestyle and dietary habits remains key. KNO

# All medico-legal and post-mortem reports to be processed through MedLeaPR portal

The Health and Medical Education (H&ME) Department announced on Wednesday that all medico-legal reports and post-mortem reports will now be processed and issued through the MedLeaPR portal. According to an official order issued by the department—copy available with the news agency—Kashmir News Observer (KNO), Dr Arsalan Rashid has been appointed as the nodal officer for the Jammu division, while Dr Azia Manzoor has been designated as the nodal officer for the Kashmir division. "Medico-Legal Reports (MLRs) and Post-mortem Reports (PMRs) play a crucial role in criminal prosecutions. Currently, these reports are primarily handwritten by doctors, which

can lead to issues of illegibility and disputes over authenticity during court trials. To address this, a technical solution has been developed in the form of the MedLeaPR system, whereby such reports are issued via an online portal," the order states. Further, the order references Government Order No. 22-JK (HME) of 2025, dated January 10, 2025, which confirms that the Medico-Legal Manual prepared by an inter-departmental committee, including members from the Departments of Health, Law, and Home (Police, Prosecution, and Forensic), has been notified. The order states that, in addition to current modes, all reports will now be issued through the JK MedLeaPR Portal. "A dedicated portal has been created for this purpose, which, after security

clearance, has gone live at [https://medleapr.jk.gov.in](https://medleapr.jk.gov.in) ([https://medleapr.jk.gov.in](https://medleapr.jk.gov.in)). Medical practitioners responsible for submitting MLRs and PMRs are already registered on the portal. Additionally, 160 master trainers have been trained across various medical institutes and districts. Each institute and district has designated a MedLeaPR Nodal Officer, with Dr Azia Manzoor Bhat, Assistant Professor in the Department of Forensic Medicine and Toxicology at Government Medical College, Anantnag, appointed as the overall in-charge and single point of contact. This appointment is supported by Government Orders No. 390-JK(HME) of 2024, dated June 20, 2024, and No. 450-JK(HME) of 2024, dated July 8, 2024," the order adds. "It is now ordered that all Medico-Legal and Post-

mortem reports shall be processed and issued exclusively through the MedLeaPR portal hosted at the State Data Centre, J&K. In exceptional and urgent cases where technical issues prevent online reporting (reasons to be recorded in writing on the report), reports may be issued offline. However, such reports must be registered online on the portal retroactively as soon as possible." Both Nodal Officers will coordinate with relevant stakeholders, including doctors, to facilitate the seamless use of the platform. They will monitor and evaluate the progress within their divisions, address operational issues faced by doctors, support the trained master trainers, ensure all reports are entered online, and upload offline reports retrospectively.

## ISRO reflects a successful 2024

As the Indian Space Research Organisation (ISRO) is gearing up for mega launches including Chandrayaan-3, Gaganyaan and Indo-US Nissar Mission, besides sending country's first Astronaut to International Space Station (ISS) on board Axiom-4 mission, the Space Agency looked back with pride its achievements made in 2024.

In an update on its website, ISRO said there were five launches from the spaceport of Sriharikota that proved successful that included precise injection of eight Indian spacecrafts, one foreign satellite and six rocket bodies, including POEM-3 and 4. They included PSLV-C58/XPoSat, PSLV-C59/PROBA-3, PSLV-C60/SPADEX docking experimental mission, GSLV-F14/INSAT-3DS, and SSLV-D3/EOS-08 mission, all of them successfully injected the payloads in their designated orbits.

ISRO's GSAT-20 was launched by Falcon-9 Block 5 of SpaceX from



Cape Canaveral. TSAT-1A was also launched by Falcon-9.

"Consequently, a total of 8 Indian satellites, 1 foreign satellite, and 6 rocket bodies (including POEM-3 and POEM-4) were placed in their intended orbits", It said reflecting back on its achievements of 2024.

It said a total of 136 Indian spacecraft, including those from private operators/academic institutions, were launched in Earth-orbit till December 31, 2024.

As of that date, the number of operational satellites owned by the Indian government is 22 in LEO (Low Earth Orbit) and 31 in GEO (Geosynchronous Earth Orbit).

In addition, two Indian deep space missions, namely, Chandrayaan-2 Orbiter (CH2O) and Aditya-L1 at Sun-Earth Lagrange's point were also active.

The propulsion module of Chandrayaan-3 spacecraft continued to operate in a high Earth orbit (more than 1 lakh km away) after being relocated from its lunar orbit since November 2023.

ISRO Chairman Dr. V. Narayanan, releasing the Indian Space Situational Assessment Report (ISSAR) for 2024 compiled by ISRO System for Safe and Sustainable Space Operations Management (IS4OM), said the upper stage of PSLV-C3 underwent an accidental break

up in 2001 and generated 371 debris.

While most of these fragments have re-entered the atmosphere, 41 PSLV-C3 debris were still in orbit by the end of 2024.

On Atmospheric re-entry, it said among the intact Indian upper stages, 34 rocket bodies re-entered the Earth's atmosphere till 2024 end, and five of such re-entries took place in 2024.

All LVM3 rocket bodies have decayed, only the one from LVM3 M2 OneWeb India- mission remain in orbit.

Among GSLV rocket bodies, only GSLV-F12 and GSLV-F14 rocket bodies are in orbit.

A total of 31 Indian satellites have re-entered the atmosphere till the end of 2024.

In the year 2024 alone, 9 Indian satellites re-entered the atmosphere. Among them was Cartosat-2 which re-entered the atmosphere on February 14, 2024, the first-ever LEO satellite of ISRO to be de-orbited at end-of-life to reduce its post-mission orbital life from more than 30 to less than 4 years.

## MLA Abbas Ansari gets 2-year jail term in hate speech case

Abbas Ansari, MLA from Mau Sadar seat and son of former mafia Mukhtar Ansari, was sentenced to two years imprisonment along with a fine of Rs 11,000 by a special court here on Saturday in a hate speech case, a prosecution officer said here.

Prosecution officer Haredra Singh said that the MP-MLA court of Judge Dr Krishna Pratap Singh convicted Abbas Ansari and his associate, Mansoor Ansari, in the hate speech case. After being convicted, both people were taken into custody



by the police.

He said that Abbas Ansari was found guilty under various sections and sentenced to two years imprisonment and a fine of Rs 11000, added to the total amount of different sections.

"MLA Abbas Ansari's election agent and associ-

ate, Mansoor Ansari, was sentenced to 6 months imprisonment and a fine of Rs 1000," he said.

During the 2022 assembly elections, Abbas Ansari, contesting from the Mau Sadar assembly seat, was addressing an election meeting at Pahadpura ground in the

city area on the evening of March 3, 2022.

During the address, he said that the administrative officers of the district will be stopped after the elections and taught a lesson.

He said that no one will be transferred after the formation of the Samajwadi Party (SP) government. Everyone will be kept here, and accounts will be settled.

Taking cognizance of this matter, an FIR was registered at the city police station on the complaint of Sub-Inspector Gangaram Bind. Sadar MLA Abbas Ansari and others were accused in the case.

## Seven killed in Arunachal landslide

UNI ITANAGAR, MAY 31

Seven people died in a landslide on National Highway-13 between Bana and Seppa in Arunachal Pradesh's East Kameng district late Friday night amid heavy rains, leading to shock and major traffic disruption in the region.

Sources said a vehicle carrying seven people was swept away by a massive landslide on the Bana-Seppa stretch of NH-13 and plunged into a deep gorge. The vehicle was traveling towards Seppa when the rain-triggered landslide struck it.

Arunachal Pradesh Home Minister and local



MLA Mama Natung has expressed deep sorrow over the loss of lives in his Assembly constituency.

In a message, Natung extended his condolences to the bereaved families, stating: "It's very painful to hear about the tragic loss of seven lives in my

Assembly constituency. My heartfelt condolences to the bereaved families."

The Minister urged citizens to remain cautious during the monsoon season and avoid travel during nights, especially in landslide-prone areas. "I request everyone to

remain vigilant and avoid traveling at night during the monsoon season. My thoughts and prayers are with the affected families. Om Shanti Shanti," Natung added.

Authorities have launched rescue and clearance operations at the site, while local administration has urged citizens to exercise caution and restrict travel during extreme weather conditions.

Meanwhile, sources said that rescue teams have recovered all seven bodies, but their identities are yet to be established.

The northeastern state has been experiencing incessant rains since Thursday.

Motor Accident Claims Tribunal, Jammu also settled cases which included Rajiv Kumar vs United India Insurance Co in which an amount of Rs. 18,85,869/- was awarded in favour of the claimant after settlement. ## Manipur Governor visits flood-affected areas

Meanwhile, in an appeal by the state Information department, it was informed that many houses, offices and institutions have been inundated due to breaches in river-

banks. Similarly, landslides have been reported from many hill districts.

According to the weather forecast issued by the Indian Meteorological Department, Meteorological Centre, Imphal, heavy to very heavy rainfall is likely to continue at isolated places till June 1.

## Afghan gov issues 575,000 electronic national IDs to citizens in two months

The National Statistics and Information Authority (NSIA) of Afghanistan said nearly 575,000 national electronic identity cards (IDs) have been distributed to Afghan citizens over the past two months, local media Tolonews reported Saturday. According to the NSIA, the services provided included the issuance of 1,978 new paper ID cards and 509 replacement cards, the verification of 2,068 existing documents, and the correction of citizenship information of 3,088 people via the remote portal. In order to ensure timely and equitable services for citizens, electronic ID distribution centers have been extended to remote areas and districts, facilitating easier access to identification for residents.

# MI's legacy faces PBKS dream run in IPL Q2

The stakes couldn't be higher. The lights at Narendra Modi Stadium are ready to blaze, and the roar of over a lakh fans will rise as Punjab Kings and Mumbai Indians lock horns in Q2 encounter for a place in the IPL 2025 final.

But amid the drama and unpredictability that defines T20 cricket, one quiet, clinical force looms large - Jasprit Bumrah. The seasoned MI pacer, with 18 scalps at a stingy economy of 6.36, has been in menacing form and could well be the difference in Sunday night's Qualifier 2.

Mumbai are surging



into this clash on the back of a dominant 20-run win over Gujarat Titans in the Eliminator. With five titles to their name, they are no strangers to pressure - and this current unit, under the leadership of Hardik Pandya, looks locked in.

The batting lineup is humming. Rohit Sharma found rhythm at just the right time, scoring a com-

posed 81 off 50, while Jonny Bairstow, thrust into the spotlight as Will Jacks's replacement, wasted no time - hammering 47 off 22 balls and setting the tone early.

Suryakumar Yadav, meanwhile, continues to defy cricketing logic with 673 runs at a jaw-dropping strike rate of 167.83.

Tilak Varma, Hardik, and Naman Dhir add steel

to the middle order, while Deepak Chahar could come in as the Impact Player to make early inroads with the ball. Bumrah's deadly precision and the left-arm swing of Trent Boult give MI an edge with the new ball, but Mumbai will still be wary of their unsettled fourth bowling option, with Richard Gleeson underwhelming last game.

Punjab, on the other hand, are nursing fresh scars. Their 101 all-out collapse against RCB in Qualifier 1 was a brutal reality check after a consistent season. Now, they must dust themselves off and step into a ground where playoff inexperience and scoreboard pressure can swallow teams whole.

# Karun Nair's unbeaten 186 against Lions pushes India Test case

UNI LONDON, MAY 31

India batter Karun Nair pushed his case for a Test recall against England by scoring 186 not out for India A on day one of the first unofficial Test against England Lions.

The 33-year-old famously scored 303 not out against England in Chennai in 2016, only to be dropped three Tests later after six matches.

Nair, who has played county cricket for Northamptonshire since his last international, has been included in India's Test squad for the upcoming Test series and dominated a youthful bowling attack in Canterbury.

The right-hander was dropped on 89 and 134, but put on 181 with Sar-



faraz Khan and 177 unbroken with Dhruv Jurel on Friday.

Sarfraz, a surprise omission from India's Test squad, made 92 and Jurel, who was included, ended the day on 82 not out. Test opener Yashasvi Jaiswal was caught behind off 19-year-old Hampshire seamer Eddie Jack for 24.

The pick of the Lions bowlers was left-armers Josh Hull, who made his England debut in the third Test against Sri Lanka last year, the BBC reported.

He had India A skipper Abhimanyu Easwaran lbw for eight and Sarfraz caught down the leg side.

The four-day match continues on Saturday and

is followed by a second unofficial Test from June 6 in Northampton.

England all-rounder Chris Woakes and new India Test skipper Shubman Gill are in the respective squads for the second match as they prepare for the highly anticipated five-Test series which begins on June 20 at Headingley.

# Ecuador names Valencia, Plata in squad for World Cup qualifiers

UNI QUITO, MAY 31

Brazil-based forwards Enner Valencia and Gonzalo Plata have been included in Ecuador's squad for World Cup qualifiers against Brazil and Peru despite injury concerns, the Ecuadorian football federation said.

Internacional's Valencia has missed the Porto Alegre club's past six games due to a hamstring strain, while Flamengo's Plata has been sidelined since April with a knee injury.

"They are in a complicated situation but they are currently in the process of recovering," Ecuador manager Sebastian Beccacece told reporters on Friday.

The Argentine coach recalled Leonardo Campana and Angelo Preciado, who missed Ecuador's last double header of qualifiers in March with injuries.

As expected, the 28-man squad includes Brighton left-back Pervis Estupinan, Paris Saint-Germain center-back Willian Pacho and Bayer Leverkusen defender Piero Hincapie.

# WADA president vows to keep calling out U S anti-doping system flaws

UNI WARSAW, MAY 31

World Anti-Doping Agency (WADA) President Witold Banka vowed to continue speaking out forcefully about what he sees as serious flaws in the American anti-doping system, following his re-election to a third and final term as head of the global watchdog.

Banka, a former Polish sprinter and Minister of Sport and Tourism, along with China's former Winter Olympic champion Yang Yang, was re-elected during a virtual



Foundation Board meeting on Thursday.

The U.S. Anti-Doping Agency (USADA) later, in a social media post, called it the "ultimate 'bait and switch,' first promising governance reforms following the Russian

anti-doping scandal and then quietly changing the rules the second the world looked away."

On Friday, WADA's president responded to USADA's criticism. "I'm not particularly surprised that such words were said

in the USA." Banka told Polish outlet Sportowe Fakty.

"Representatives of this country actually tried to undermine my leadership in WADA and attempted to change the leader. The American government stopped its contribution to WADA, lost a representative on the board of our institution and ultimately also influence on the elections."

"I'll continue to speak boldly about the shortcomings of the American anti-doping system," he added.

# Liverpool announces Frimpong signing

UNI LONDON, MAY 31

Premier League champions Liverpool has announced the signing of Dutch international right back Jeremie Frimpong.

The 24-year-old joins from Bayer Leverkusen for 35 million euros (40 million U.S. dollars) just hours after Real Madrid announced the signing of Trent Alexander-Arnold from Liverpool, with Alexander-Arnold arriving in time for the FIFA Club World Cup at a cost of between 10 and 15 million euros.

Frimpong said on the Liverpool website on Friday that when he learned of

interest from the Premier League champions, he told his agent to "just get this done."

"Liverpool fans, I'm going to give my all, my energy, my work-rate and hopefully we can win together, we celebrate together, get everything together."

"I'm just excited to be here. Thank you guys for accepting me and I won't let you guys down and I'll give you the energy that you guys want," he added.

Frimpong began his career in the Manchester City youth system, before joining Celtic and then moving to Bayer Leverkusen.

# AIFF announces amendments to regulations on status & transfer of players

UNI NEW DELHI, MAY 31

The All India Football Federation (AIFF) has announced a set of amendments to its Regulations on the Status and Transfer of Players (RSTP), which will come into effect from June 1.

The reforms focus on enhancing player welfare, supporting women's football and youth football

more effectively, and improving regulatory transparency.

A standout feature of the updated regulations is the increased attention to the rights and well-being of female players. The AIFF has introduced provisions addressing menstrual health, allowing female players to take leave from training during the onset of their menstrual cycle.

Expanded clauses now also cover pregnancy, adoption, and family leave for both players and coaches, aiming to create a more inclusive environment for women in the sport.

The amendments also introduce structural reforms in player transfers and youth development.

New limitations on the number and duration of player loan deals have been set to ensure fairness.

# Top players advance as Zheng cruises into French Open last 16

UNI PARIS, MAY 31

Paris Olympic champion Zheng Qinwen of China advanced to the women's singles Round of 16 at the French Open for the second time, as top seeds continued to shine at Roland Garros.

The eighth seed spent under 90 minutes on Friday to beat 18-year-old Canadian qualifier Victoria Mboko 6-3, 6-4 in their first career meeting, marking her second appearance in the last 16 at Roland Garros after her breakthrough run in

2022. "I was born in China in a really hot place, which is called Wuhan. So I handled the hot weather quite well," Zheng said in her post-match interview.

"Last year, when I played the Olympic Games, it was hotter than this. So actually I like this condition, but I want to say thanks to all the crowd who suffered here under the sun today with me."

Zheng also praised her young opponent. "I want to say congrats to the opponent because I feel she played really well, and I think we pushed

each other to play our best tennis. And sometimes we had really good points. It was not an easy match."

Top seed Aryna Sabalenka of Belarus also continued her strong showing with a 6-2, 6-3 victory over Serbia's Olga Danilovic, advancing into the tournament's fourth round for the third consecutive year. Four-time winner Iga Swiatek of Poland overcame a spirited challenge from Romania's Jaqueline Cristian in straight sets, stretching her tournament's winning streak to 24 matches.

# Bopanna-Pavlese beat local favourites to enter third round

UNI PARIS, MAY 31

India's Rohan Bopanna and Czech partner Adam Pavlasek showcased resilience and tactical prowess to edge past France's Fabien Reboul and Sadio Doumbia 6-2, 7-6(5) in a gripping second-round men's doubles encounter at the French Open on Court 14.

The Indo-Czech duo dominated the opening set, leveraging their powerful serves and strategic net play to secure a 6-2 lead. Bopanna's experience and Pavlasek's agil-



ity were evident as they broke the French pair's serve twice, capitalising on early opportunities.

However, the Frenchmen, buoyed by the home crowd, mounted a formidable comeback in the second set. Doumbia and Reboul tightened their

service games and applied pressure on returns, leading to a closely contested set that culminated in a tiebreak.

Despite the momentum shift, Bopanna and Pavlasek maintained composure, clinching the tiebreak 7-5 and sealing the

match in straight sets. Statistically, the match was evenly poised. Bopanna and Pavlasek recorded 8 aces to the French duo's 5 and had a slightly higher first-serve win percentage at 72% compared to 68%.

Both teams converted three break points, but the Indo-Czech pair's ability to win crucial points, especially in the tiebreak, made the difference.

This victory marks a significant step for Bopanna and Pavlasek as they advance to the third round, continuing their quest for a maiden Grand Slam title together.

# India women's football team suffer narrow defeat against Uzbekistan

India suffered a 0-1 defeat at the hands of Uzbekistan at the Padukone-Draavid Centre for Sports Excellence, in the first of two FIFA International Friendlies here.

After a goalless first half, Diyorakhon Khabibullayeva (56') scored the only goal of the match to hand Uzbekistan the win on Friday night.

Keeping true to his words, India head coach Crispin Chettri introduced some fresh blood into the team, handing out three debuts against a strong Uzbekistan side. Attackers

Manisha Naik and Malavika debuted from the starting XI, while midfielder Priyadarshini came off the bench in the second half for her first cap.

An even start to the match saw India earn a few corners, while goalkeeper Panthoi Chanu did well to keep the Uzbekistan attackers at bay in the opening exchanges. Panthoi, who marched in as the Blue Tigresses' captain on Friday, did especially well to collect the ball from Nilufar Kudratova in the eighth minute, after the Uzbekistan forward was played through behind the India defence.

As the game wore on,



India began to gain more composure, building their own attacks in the Uzbek third. Soumya Guguloth, on the counter, threaded a pass through to Dangmei Grace, who had raced past the Uzbekistan back

line, and only had the goalkeeper to beat. However, Maftuna Jonimqulova rushed out of her line and snatched the ball from the India forward's feet.

A little after the half-hour mark, Diyorakhon

ran on to an aerial through ball, and had just Panthoi to beat. However, India centre-back Shilky Devi showed good presence of mind to contain the Uzbekistan forward with her physical presence,

allowing Panthoi time to snatch the ball.

With the score level, India coach Chettri brought striker Pyari Xaxa into the game instead of Manisha Naik, thus pushing Grace into midfield. The move seemed to have been working in the initial stages of the second half, as India began to enjoy long bouts of possession in the Uzbekistan half. However, it also left them more susceptible to a counter-attack, which resulted in the deciding goal.

Maftuna Shoyimova, who was freed down the left flank, sent in a pinpoint cross into the India box, as Diyorakhon tapped

it in from close range in the 56th minute, to give her side the lead.

Diyorakhon had a chance to double the lead on the hour mark when she tried to volley another cross, this time from the left, but the forward could not connect with the ball, as Panthoi plucked it out of the air.

India went searching for the equaliser with Pyari being the focal point. Phanjobam Nir-mala Devi sent in a looping cross from the right, which was headed goalwards by Pyari. However, the header lacked power and rolled wide with around 20 minutes to go.

# EID; MARKETS SAY IT ALL : FESTIVE LOOK MISSING FROM THE SCENE

**When Markets Weep and Wallets Run Dry and Poverty Dims the Spirit of Eid-ul-Adha, No Bakra, No New Clothes, The Bitter Truth of Eid-ul-Adha in Poor Households and a Deserted Look at Shrinking Festive Spirit: Writes NAWAAB IBN AHAD**



**W**hen Markets Weep and Wallets Run Dry and Poverty Dims the Spirit of Eid-ul-Adha, No Bakra, No New Clothes, The Bitter Truth of Eid-ul-Adha in Poor Households and a Deserted Look at Shrinking Festive Spirit.

In the quaint bosoms of Kashmir's villages, where time itself treads softly between walnut trees and cobbled paths, there is a fragrance not of perfumes, but of shared sorrows and quiet resilience. It is here—away from the roaring politics, beyond the glare of news channels—that humanity has quietly preserved its last breath. And yet, as this year's Eid-ul-Adha draws near, the fragrance of festivity is faint, the perfume of joy diluted by poverty's ever-expanding shadow.

not long past, when these very streets shimmered under lanterns, when young children pointed excitedly at colorful bangles, and bakers pulled golden loaves from their tandors with songs on their lips. Today, that warmth is missing. The echoes of joy are replaced by the low hum of worry. The sound of shopping bags rustling has been drowned out by the silence of despair. "When Markets Weep and Wallets Run Dry" is not just a poetic phrase—it is a lived reality this Eid. Whose evil gaze has cast this shadow, once the sanctuary of artisans and the beating heart of commerce? Whose unseen malice dried the springs of its wealth, the perennial flow of income. What unseen affliction has replaced its rhythm of resilience with the silence of survival? Today, the land thirsts—not only for rain, but for economic sustenance. Its pockets once jingled with the melodies of merriment and modest luxury; now they lie deflated, their fabric worn thin, like the seasonal streams that vanish under the heat of indifference.

Village shopkeepers, who once smiled with modest pride as customers gathered in pre-Eid rushes, now sit behind counters gazing into the distance—waiting, hoping, disillusioned. The shelves remain full, but the eyes are empty. The bags are unpacked, the hands unlifted, the pockets unstirred. Villagers who once exchanged Eid greetings along with coins and kindness now shuffle past each other with unspoken heaviness, unable to ask, unable to give. The goats that once paraded through the lanes as symbols of devotion are now scarcely seen. And when they are, they walk not through crowds of excited children, but down lonely paths, watched with tearful longing by many who can no longer afford the rites of sacrifice.

In the tranquil lanes of Kashmir's rustic villages, where morning mist clings gently to deodar leaves and sparrows chorus in symphony with silence, there exists a rhythm—a serene, old-fashioned harmony that modernity has not yet stolen. Here, humanity lives not in skyscrapers or bank accounts, but in the way a neighbor places firewood outside another's door on a wintry night or in the hand that shares a piece of bread with someone whose hearth has gone cold. These are the lands where traditions still breathe through the lattice of simplicity; where culture has not been sacrificed at the altar of consumerism, and where hearts remain softer than the riverbeds of the Lidder in spring.

In these valleys, the village folk continue to nourish the essence of togetherness, holding dear the age-old



customs of sharing grief and joy like grains of harvested rice, bundled and distributed with humility. Eid-ul-Adha, the festival of submission and sacrifice, often painted in hues of celebration and piety, now arrives as a paradox—a dual spectacle of jubilation and sorrow, of roasted lambs on some tables and empty plates on many others.

While the essence of Eid speaks of devotion, offering, and compassion, the scenes unfolding in the heart of Kashmir this year draw a picture steeped in melancholy. Markets that once danced with life—bustling with buyers, brimming with bright fabrics, perfumed with the aroma of spices and sweets—now stand hushed, lonely, and sunken. The bazaars of Valley, all seem to echo with the same dirge: poverty has sewn a veil over festivity. Once the land of abundant exchange, where even outsiders thrived in Kashmir's generous economic fabric, is now retreating inward, gasping for breath in a tightening noose of inflation, joblessness, and unseen sorrow.

Yet, even in this bleakness, a light survives—faint but warm—burning in the hearts of the village people. The committees at the village level, though modest in strength and means, continue to hold the lamp of social duty. These grassroots councils, often unsung and unnoticed, have become the unseen hands that carry food to widow's doors, whisper hope into orphaned hearts, and knock on doors not for votes, but for mutual concern. It is they who raise the cry when someone sleeps hungry, and it is they who remind us that while governance may rest in tall offices, grace lies in the act of remembering one's neighbour.

The teachings of Islam have long proclaimed the sacredness of neighborly compassion. The Prophet Muhammad said, "He is not a believer whose stomach is filled while the neighbor to his side goes hungry." This is no metaphor—it is a mission. Eid is not complete with feasting alone; it is crowned only when the poor-

est among us smile even once. True Qurbani lies not merely in the shedding of an animal's blood, but in the slitting of one's ego, in the sacrifice of selfishness, in the elevation of empathy.

This Eid, for some, is a celebration; for others, it is a wound—open, raw, and silently bleeding. The tears that fall from old eyes are not only for loved ones lost, but for dignity withering under the burden of inflation. These tears, like droplets of dew, glisten on the cheeks of the forgotten, becoming diamonds on the petals of their resilience.

We must awaken to our duties—not just as Muslims, but as human beings woven into a shared fabric of fate.

The wealthiest among us must not forget those whose shoes are torn, whose gas cylinders are empty, whose hearts are full of quiet longing. Charity is not a burden; it is a blessing. The Quran says, "And spend in the way of Allah from what We have provided you before death approaches one of you." Let us not be delayed by convenience. Let our generosity arrive before the despair deepens.

Eid-ul-Adha is not about how grand our feast is—it is about how wide our arms are open. The true spirit of the festival lies in sharing—not just meat, but warmth; not just new clothes, but the assurance of being seen and remembered. Let us not forget those who have lost their jobs, those who sleep in rented rooms with broken roofs, those whose children look at butcher shops with silent yearning. Kashmir needs us—not just its governments, but its people. Let us revive the role of our local committees, empower the youth to lead kindness drives, and ensure no one in our village sleeps in darkness while another house glows in festival lights. Let us knock on doors not with pride, but with concern; let us distribute not only meat, but messages of unity, of remembrance, of brotherhood. In this Eid, let our sacrifices be deeper than rituals. Let us shed not just the blood of animals, but the indifference we've grown accustomed to. Let our hearts expand to include the widow across the road, the shopkeeper who hasn't sold a shirt in weeks, the father who fears his children will wake up on Eid morning and ask: "Isn't today a day of joy?"

Yes, it is a day of joy—for those who make it so for others. In Kashmir, the land of fading chinars and buried laughter, we still have one wealth intact—our shared humanity. Let us cling to it.
