# **HISTORY IN MAKING: PM Modi's Likely Inauguration of First Train** to Kashmir A Dream Come True

JAMMU JUNE 02: PM Modi is likely to flag off Vande Bharat train to Srinagar this weekend during PM's first visit to J&K post Pahalgam terror attack. "Prime Minister, Narendra Modi, will visit Jammu in the first week of June and will inaugurate the first Vande Bharat train to Kashmir," Former State President senior BJP leader Ravinder Raina told a local daily Newspaper. Raina is also BJP National Executive Member.

Earlier, the inauguration of the muchawaited train was scheduled for 19 April, however, it was postponed due to incliment weather. Inauguration again got delayed due to Pahalgam terror attack which happened on 22 April followed by Operation 'SINDOOR According to Sources Prime Minister will flag off train from Katra to Baramulla and virtually from Baramulla to Katra. He will address a rally at Katra Stadium. Modi is likely to  $visit\,highest\,rail\,bridge\,in\,the\,world\,over$ river Chenab and first Cable Stayed bridge on the railway track in Reasi district before flagging off train services from Katra. As per the sources, initially the train will run from Katra to Baramulla. #### All mild, no cause for alarm, says officials

**SRINAGAR, JUN 02:** Jammu and Kashmir has reported nine new COVID-19 cases since November 2024, marking the first such cases in several months.

A senior health official informed the news agency-Kashmir News Observer (KNO) that there are currently nine active COVID-19 cases in the Union Territory. Of these, five are from Kashmir and four

The official said the situation remains under control and there is no immediate cause for concern. He urged residents to stay vigilant and follow safety precautions. "We are strictly adhering to the guidelines issued by the Ministry of Health and Family Welfare (MoHFW). **SRINAGAR, JUNE 2**: Chief Secretary, Atal Dulloo, today directed the officers to ensure completion of all projects being executed under AMRUT 2.0 and SBM 2.0 on top priority across the Union Territory.

While chairing a high-level meeting held in this regard, the Chief Secretary reviewed the progress on various flagship urban development schemes. He stressed that both AMRUT and SBM are "Pragati programmes," which are being



monitored seriously at the highest level.

He emphasized that project implementation must be expedited and processes like tendering, approval and on-ground execution should be carried out in a fast-track manner. To ensure proper monitoring, he instructed all the concerned departments to prepare monthwise work plans and submit progress reports every fort-

During the review of SBM 2.0, it was informed that significant achievements have been made in solid waste and used water management.

Under the Integrated Solid Waste Management initiative, the department has reached a major administrative milestone. Used water infrastructure is also being improved, with many schemes already under construction and others in advanced planning stages.

For C&D processing, 125 plant processing TPD has been allotted to SMC and 65 for JMC.

# Chief Secretary reviews progress on PM Gati Shakti implementation Stresses adoption of best practices from top performing districts for tangible results

SRINAGAR, JUNE 2: SRI-NAGAR, JUNE 02: Chief Secretary Jammu and Kashmir, Atul Dulloo, today chaired a high level meeting to review progress on PM Gati Shakti (PMGS), National Master Plan implementation at Civil Secretariat here.The meeting focused on assessing the progress, identifying challenges and enhancing the coordination among various departments and stakeholders under the PM Gati Shakti initiative.The Chief Secretary said that PM Gati Shakti aims to revolution is e the infrastructure development by breaking departmental silos and ensuring synchronised planning

among the multiple agencies.

He emphasised that the initiative aligns with the vision of 'One Nation, One Master Plan', aiming to reduce logistics costs, improve multi-modal connectivity and enable last-mile infrastructure access across the Union Territory.

The meeting was informed that 624 individual data layers have been integrated making J&K one of the top 3 performing states/UTs. It was added that 39 UT departments have been onboarded on the Gati Shakti portal. Besides, 50 strategic projects valued at over Rs. 3,000 crore have been deliberated through 16 TSU and NPG meetings. He directed the Industries and Revenue departments to



play a pivotal role in adding layers to the portal and ensure inclusion of layers from the social sectors.

The officers were directed to replicate best practices from top performing districts of

other states for more effective and tangible results.

The Chief Secretary was informed that over 100 capacity-building sessions have been conducted across the departments while 23 planning tools

and a robust Maker-Checker-Approver mechanism has been implemented. Besides, extensive mapping of over 23,000 schools, 26,000+ Anganwadi centers and all 6,000+ Fair Price Shops has been done on the portal.The Chief Secretary reiterated the importance of adopting an Area Development Approach to infrastructure planning. He said under this model, a defined region is targeted for integrated development in logistics, economic activity, tourism, social services and governance.

The PM Gati Shakti portal is being leveraged to enhance the operational efficiency for defence logistics while ensuring optimal utilisation of civilian infrastructure.

The meeting also highlighted the significant efforts in training nodal officers, establishing district-level GIS cells and integrating digital surveys and indigenous technologies for infrastructure planning and execution.

The Chief Secretary called for expediting mapping of remaining assets, besides adding layers. He emphasised on leveraging the PMGS portal for project planning and monitoring besides strengthening the inter-departmental coordination for timely clearances and coordination. The Chief Secretary lauded the progress made under the PM Gati Shakti initiative and emphasized its transformative potential in enhancing logistics, infrastructure and governance across Jammu and Kashmir. He assured continued support from the administration in further streamlining and accelerating implementation.

With emphasis given on legacy waste clearance, the meeting was informed that 1.33 MT of legacy waste was remediated since the last review meeting.

In terms of sanitation infrastructure, construction work for 375 toilet seats has been awarded. The Jammu Municipal Corporation is working on 100 seats while the Srinagar Municipal Corporation is constructing 95 seats and 97 urinals.

Additionally, the Directorate of Urban Local Bodies has floated tenders for another 275 toilet seats and 58 urinals. For Individual Household Latrines, 51 beneficiaries have been identified and construction is underway.

The Chief Secretary praised the joint efforts of executing agencies, consultants and the urban local bodies, and underlined the importance of timely completion and quality control. He said that these projects play a vital role in achieving sustainable urban development and protecting public health.

While reviewing AMRUT 2.0, he noted that the mission is aimed at making cities water secure and improving the overall quality of life He said that, out of the total 99 approved schemes, the majority of works are already under active execution, while the rest are in various stages of tendering or

Out of the 153 approved projects, 99 focus on improving water supply systems, 04 are related to sewerage and seepage management and 50 are aimed at water roadies rejuvenation. He said that the goal is to provide 100 percent of households in AMRUT towns with functional tap connections.

The meeting was informed that a large number of these projects have already been tendered and some are under execution, while

The ministers are likely to be given details of the "Operation Sindoor", which is also expected to figure in the ruling BJP's programmes starting next week to mark the first anniversary of the PM Modi led government in its third term.

"Besides speaking on Operation Sindoor, the Prime Minister may give an overall highlight of his governance thrust in the council meeting as the ministers prepare to communicate with people across the country during the anniversary events," said a source.

On May 7, strikes on nine terror sites in Pakistan and Pakistan-occupied Kashmir followed by its counterattack on the neighbouring country's military facilities, especially air bases, have sent a clear message to the neighbouring country that "terror won't be tolerated" anymore.

PM Modi in his recent speeches has affirmed that "Operation Sindoor" has marked India's "new normal" in punishing terror acts linked to Pakistan and vowed to go after terrorists and their sponsors with equal ferocity in case of any future terror incidents on the Indian soil.

There will be no direct train from Delhi or any other part to Kashmir at present. The passengers will have to de-board at Katra and change the train. Later, the same process will shift to Jammu.

Several trials of train from Katra to Baramulla including that of Vande Bharat have been successful. During Operation Sindoor, a train carrying Army personnel also operated on the track up to Srinagar.

Fresh security audit of the track was conducted after Pahalgam terror attack and all issues have been addressed with deployment of more police personnel and strengthening of infrastructure.

Out of the total 272-kilometere, Udhampur-Srinagar-Baramulla Rail Link (USBRL) project, 209- kilometre was commissioned in phases with the first phase of the 118-kilometre Qazigund-Baramulla section commissioned in October 2009, followed by 18-kilometre Banihal-Qazigund in June 2013, 25-kilometre Udhampur-Katra in July 2014 and 48.1-kilometre long Banihal-Sangaldan stretch in February, last year.

The work on the 46-kilometre Sangaldan-Reasi section was also completed in June last year, leaving a total of 17 kilometre stretch between Reasi and Katra which was also completed nearly three months back leading to start of different trials of trains including

The project involved a cost of Rs 41,000

On January 4, a successful trial run of an electric train was conducted on the Katra-Banihal section. The Railways have conducted series of trials over the past few months on various segments of the track, including the two major milestones of the Anji Khad and Chenab bridges.

Kashmir will get a new specially designed Vande Bharat Express Train. This new semihigh-speed train will connect Katra and Srinagar. The new semi-high-speed train connecting Katra and Srinagar will be the third such train in J&K.Jammu and Kashmir real estateFine dining reservations

Routine testing for severe acute respiratory infections (SARI) and influenza-like illnesses (ILI) continues across healthcare facilities in both divisions.

It is noteworthy that the last reported COVID-19 case in Jammu and Kashmir was in November 2024.

To ensure preparedness, the Ministry of Health recently held a high-level review meeting with key health agencies, including the National Centre for Disease Control (NCDC), Emergency Medical Relief (EMR) Division, Disaster Management Cell, Indian Council of Medical Research (ICMR), and representatives from central hospitals. The purpose was to assess readiness and strengthen surveillance and response systems in case

Health experts have advised the public to remain alert but not alarmed. They said the current strains typically cause mild illness or no symptoms at all. Facilities have been upgraded since the initial wave of COVID-19, and the region is equipped to handle any escalation.

"Most positive cases recover on their own, and only a few may require hospital visits, which can be managed through outpatient departments," they said, adding that there is

Authorities continue to monitor the situation closely and have urged residents to follow safety protocols, including testing, wearing masks in crowded places and maintaining vaccination schedules.

Hospitals across Jammu and Kashmir have maintained dedicated isolation wards and medical facilities as precautions. Public awareness campaigns have been intensified to inform citizens about COVID-19 symptoms and preventive measures.

The Integrated Disease Surveillance Programme(IDSP)under the NCDC has increased efforts in monitoring, contact tracing and prompt isolation, forming a key part of the ongoing containment strategy.

Officials confirmed that all current positive patients are stable with very mild symptoms. "There is no immediate cause for panic, but precautions must continue," they said—

It was informed that advance distribution of food grains for the month of June is underway and daily joint market inspections are being conducted to ensure quality control, price regulation, cleanliness and fumigation in public areas.

Further, arrangements for uninterrupted power and water supply, deployment of medical teams at major congregation points such as Hazratbal Shrine, installation of waterproof tents and pandals, fire and emergency services, crowd and traffic management and designation of parking zones, were reviewed comprehensively. The Minister directed all the Deputy Commissioners and Senior Superintendents of Police to personally monitor implementation of all necessary measures and ensure smooth, safe and peaceful celebration of Eid-ul-Azha. He stressed the need for seamless coordination among all the departments involved in public service delivery.

Javid Ahmad Dar emphasized that elabo $rate\,arrangements\,must\,\bar{b}e\,made\,with\,regard$ to water and electricity supply, medical facilities, sanitation, fire and emergency response and public safety. He also directed that market regulation and availability of essential commodities at government-notified prices must be strictly enforced through regular inspections.

The minister clarified that constructing a few rooms does not constitute a hospital unless proper staff and facilities are in place. "Our focus is on consolidation and upgrading existing facilities, which will be prioritised after ensuring their robustness," she added.

Addressing concerns about the shortage of doctors in peripheral hospitals, Itoo said all attached doctors have now been detached from their posts and instructed to return to their original places of posting. "This step is crucial to ensure that rural and underserved areas receive adequate healthcare services," she said. She warned that those who fail to report back will face necessary action as per the law. The minister highlighted the achievements of the Omar Abdullah-led government over the past seven months but stressed that much more work remains.

On the issue of a Trauma Hospital in Budgam, she said the demand, particularly in light of increasing road accidents and the lack of immediate specialised care, is being examined. "The demand for a Trauma Hospital in Budgam has been raised by MLA Beerwah and MLA Chadoora. It will be reviewed, and necessary steps will be taken accordingly," she assured.During her visit, the minister interacted with health officials and members of the public, assessing the current state of medical infrastructure and educational institutions. She directed officials to prioritise strengthening primary health centres and upgrading schools with adequate staff and modern facilities.

Reaffirming her government's commitment, Itoo said, "An equitable development and the welfare of the people remain central to our agenda."-

# Deputations call on Satish Sharma, discuss key issues

SRINAGAR, JUNE 2: In a series of engagements aimed at addressing the grassroots public concerns, several deputations today called on Minister for Food, Civil Supplies & Consumer Affairs and Transport, Satish Sharma.

The delegations raised a wide range of issues spanning public transportation, youth employment, sports infrastructure and local development demands.

During his meeting with General Manager (Operations) Jammu & Kashmir Road Transport Corporation (RTC), the Minister discussed availability and augmentation of bus services during the upcoming Eid festival. He stressed the importance of ensuring seamless travel arrangements to accommodate the increased passenger traffic, particularly on intra-district and inter-district routes during the festive period.

A delegation of para-athletes representing various districts of the Union Territory submitted a memorandum highlighting concerns regarding the welfare and recognition of sportspersons with disabilities. They emphasized the urgent need for upgraded infrastructure, improved training facilities and mainstreaming of para sports. The



athletes also called for greater government efforts to popularize para games and ensure equal opportunities in sporting events. A deputation from Kokernag led by Legislator, Zafar Ali Khatana, met the Minister and raised a host of constituency-specific issues. The delegation submitted a list of developmental demands including road connectivity, water supply, healthcare facilities and educational infrastructure. They sought intervention of the Minister for timely redressal.

A delegation from Bandipora district, led by Advocate Saheer Rather, appealed to the Minister for establishment of a Business Process Outsourcing (BPO) centre at Chatti

Baddi. The delegation underlined the pressing need for employment avenues for the educated youth of the area.

A group of aspirants for the Jammu and Kashmir Services Selection Board (JKSSB) Junior Engineer (JE) posts also met the Minister. They submitted a plea requesting for postponement of the scheduled JE examination, citing issues related to short notice, logistical challenges and the need for more preparation time. The aspirants expressed hope that their concerns would be addressed in the interest of fairness and transparency.

Another deputation from Manwan in district Kupwara requested for initiation of a dedicated bus service from Manwan to Kupwara. The residents stressed that the absence of direct public transportation has been a long-standing issue causing hardships, particularly for the students and patients

Several other groups from different regions called on the Minister to bring forth various developmental, civic and service delivery issues. These included matters related to road connectivity, ration distribution, IT infrastructure and youth engagement programs.

The Minister assured that the concerns raised by the deputations would be examined seriously and remedial action would be taken in a time-bound.

The inspection, carried out under the supervision of the Directorate of Food Control Organisation (DFCO), covered a wide range of areas including Safakadal, Sakedafar, Nawakadal, Rajouri Kadal, and Nowhatta. Officials said that during the course of inspections, multiple cakes and other bakery products were found to be past their expiry dates.

According to officials, the Food Business Operators (FBOs) voluntarily destroyed the expired items on the spot in the presence of food safety officers. The drive was part of the department's broader initiative to uphold hygiene standards and prevent the sale of substandard or unsafe food items, especially in light of increasing demand during festive and wedding seasons. "The inspection aimed to ensure strict compliance with food safety norms and safeguard public health," a food safety officer said, adding that FBOs have been repeatedly advised to maintain proper storage conditions and closely monitor shelf-life labels of products. # JKCCC Delegation Calls On Advisor To CM Nasir Aslam Wani, Highlights Long-Pending Issues Faced By Contractors

Srinagar, 02 Jun, 2025: A delegation of the Jammu and Kashmir Contractors Coordination Committee (JKCCC) led by Chairman Ghulam Jeelani Purza called on Advisor to the Chief Minister, Mr. Nasir Aslam Wani and submitted a detailed memorandum highlighting long-pending and critical issues faced by contractors across the Jammu & Kashmir.

Speaking after the meeting, Chairman Ghulam Jeelani Purza stated "Contractors belonging to the Kashmir division suffered huge losses during the devastating floods of September 2014. At that time, the priority was immediate restoration of public infrastructure and contractors stepped up to the challenge by working on a war footing. Unfortunately, despite the urgency and commitment, hundreds of contractors are still unpaid for that work, most of which was executed without demanding any documentation in



good faith." "Another major concern is the delay in clearance of bills. Although the government had committed to releasing payments within 48 hours of bill submission, that promise remains unfulfilled. Bills continue to be held up at treasuries without justification. This delay has caused significant distress to the

contractor community, who are struggling to complete their projects due to lack of timely funds."

"Non-availability of raw materials is severely impacting development work. The root of this issue lies with the Geological and Mining Department, which has repeatedly seized vehicles transporting essential raw materials, even when materials were being moved legally. This disrupts both the supply chain and on-site work, leading to unnecessary delays and financial losses."

"We strongly oppose the decision of merging 18 Ft Main City Roads—including those in downtown and uptown—into the Srinagar Municipal Corporation. SMC lacks the necessary infrastructure and funds to handle the additional responsibility. This move will only complicate things further. We urge the J&K government to reconsider this decision and allow the Roads & Buildings Department (R&B) to retain its jurisdiction over these roads. SMC should be limited to roads below 12 ft—restricted to interior lanes only."

To ensure comprehensive coverage under social security and credit schemes, DDC instructed banks to intensify efforts for saturation under Kisan Credit Card (KCC), PM Jan Dhan Yojana (PMJDY), PM Suraksha Bima Yojana (PMSBY), PM Jeevan Jyoti Bima Yojana (PMJJBY), Atal Pension Yojana (APY), MUDRA loans and Aadhaar

DDC further directed the Lead District Manager to conduct a seminar for all bankers to sensitize them about operational guidelines and objectives of government flagship schemes, ensuring smooth and timely loan disbursements.

In conclusion, DDC urged all line departments to organize special awareness camps across the district to inform the public about various financial and welfare schemes and ensure effective last-mile delivery of benefits.

# Make corporate, private hospitals accountable for their actions

ast week an unfortunate incident took place in a corporate hospital in Srinagar when a youth died due to some mysterious circumstances. The family members and relatives of the youth alleged that he died due to the negligence of the doctors of the hospital. These people raised a strong protest against the hospital administration and urged the government to take punitive action against the medicos and other staff responsible for the death of the youth.

Following the incident the government swung into action and ordered a probe in the incident that led to the death of the youth. The government also restrained some of the doctors as well as paramedical staff of the hospital from carrying out practice at some other hospital. The government directive seemed to be somewhat absurd since no orders for closure of the hospital were issued. Ideally the hospital should have been sealed and it should have been thrown open only when the doctors and the other staff were given a clean chit.

Keeping the hospital open means that the government has fixed the responsibility about the death of the youth on concerned doctors and para-medical staff at least for the time being. For the time being no action has been taken against the management of the hospital and this has perplexed the people in general more so those who lost their dear one. The hospital has been in the news for the wrong reasons on multiple occasions ever since it has started functioning in Srinagar.No action whatsoever has been taken against the hospital administration for the unfortunate deaths that took place ever since its functioning. Once action had been taken in a particular case then there were chances that the subsequent unfortunate deaths could have been avoided. Over the years it has been observed that the health &medical education department has not acted against most of the corporate and private hospitals whenever any complaint has been lodged against them.

The inaction from the people at helm has given enough reasons for the masses to believe that the department is hand in glove with the corporate and private hospitals operating in the Kashmir valley. Since the health of an individual is paramount it is imperative that the health and medical education department leaves behind the slackness and acts against the management of the hospital whenever a complaint is lodged against a particular hospital.

Daughters: Not an inheritance, but the truth of sentiment

or centuries, the Indian society has had the notion that only a son carries the lineage, only a son will carries the lineage, only a son will carry the bier, only a son will inherit the property. This thinking not only pushes daughters to a second class status, but also hurts human sensibilities. But time has repeatedly proved that lineage is not just a name, lineage is a sentiment that anyone can carry forward. There are so many daughters who serve their old parents, support them and fulfill their last wish.

Today, when joint families are breaking up, when sons are busy with their careers in big cities, daughters are staying with their parents and providing them mental, emotional and sometimes even financial support.

Why do tears have the same effect? When sorrow comes to a home, tears do not see any relationship, gender or class. A mother's love and a daughter's affection-both have the same language of pain. Death is such a reality that brings everyone under one umbrella. At that moment, neither a son is big nor a daughter is small. At that moment, there is only a human being-dedicated, emotional, broken.

In our society, the post-death rituals are the responsibility of the son. But is it right to impose emotional responsibility on only one gender? When the daughter also suffers the same pain, sheds the same tears, then why is she less entitled?

#### changing social equations

Today's India is going through a transitional period, where daughters are being educated, made self-reliant, but the change in mindset is still incomplete. There is the slogan of 'Beti Bachao, Beti Padhao', but are we able to give equal status to daughters in every right of life? Are they getting equal status in property, tradition and decisions? Not just education, daughters also need property rights, participation in family decisions and social respect. This change will not come only from laws, but from thoughts.

Stories of experiences: Daughters who changed society

From small villages of Rajasthan to big cities, thousands of daughters have become the support for their parents that society expected from sons. One example is Priyanka from Maharashtra, who performed the last rites of her father after his death. The village



opposed it, but she stood her ground. Today other girls of the village consider her as their role model.

Another story is of Seema from Uttar Pradesh, who left her job when her father fell ill and served him day and night for three years. Finally, when her father died, Seema performed all the rituals alone.

#### Is this love, this devotion not part of the legacy?

#### What does the law say?

After the amendment of the Indian Succession Act, 2005, daughters have got equal rights in property. But how many times has this right been accepted at the social level? Even though the courts give equality to daughters, the society has still not been able to fully assimilate this change mentally. Many times daughters are forced to voluntarily 'give up' their rights so that sons can continue to have a share. This is not 'sacrifice', but a well-planned social pressure.

Why are daughters considered weak? Being sensitive is not a weakness. We have considered tolerance as a weakness. Daughters are the peace of the house, the flow of affection and the first companion in sorrow. If sons have these qualities, then they are called 'sensible', then why are daughters

Daughters are often the emotional

backbone of a family. They endure struggles silently and still smile. Isn't that power?

There is a need to change the mindset of generations

A son is necessary—this thinking is a social illusion. The lineage continues only where there are sanskars, and sanskars are not in son or daughter, but in upbringing and relationship. Is the daughter who lights the funeral pyre of her father any less than the one who garlands the father's photo?

The new generation has to understand that the responsibilities of the family are not only the sons'. Daughters can also be the support of their parents in their old age, if the society gives them that opportunity and right.

#### Inheritance is not just land or name

Heritage is also that which is reflected in tears, which flows in emotions, which lives in values. Daughters are the heritage that carries forward not just the relationship of blood but also of love and service. Nowadays it has been seen in families that daughters also bear the burden of expenses of their parents, they do everything from

medicine to care during their illness. When a daughter sees her father on the bed, she does not just see a patient but the pillar of her life falling down. Her pain, her service is no less than that of any son.

Change is needed in media and popular culture

In our television serials and films. daughters are either shown as a burden or as goddesses of sacrifice. These are extremes. We need stories that present daughters as real, strong and natural. When the cultural reflection of society changes, the mindset also changes.

#### our responsibility

Society should not see daughters as just an option, but consider them as full, capable successors. Education, security and respect for daughters are not mere slogans, but the beginning of a deep social revolution. There should be education of equality in schools, participation of daughters in panchayats, and their decisions should be respected in homes – only then will this change be permanent.

While raising daughters, do not think that "tomorrow they will become strangers," rather think that "this is my strength today."

In today's era when the definitions of family, relations and values are changing, it is important to understand the role of daughters once again from a new perspective. They are not just a support, they are a strength. They are not just entitled to sympathy, they are entitled to inheritance.

Daughters are not just the guarantee of relationships, they are also the backbone of society. They have the same concern, the same affection, the same infinite love for their father in their eyes as any son has—in fact, sometimes even more than that. Bringing them from the margins to the center, considering them not just 'daughters' but 'heirs' will be true social progress.

Manipur, completely destroyed by flood for over three days, witnessed life threatening operations with limited resources as few boats of Assam rifles, Army, Arambai Tengol, State government agencies, Manipur Mountaineering and Trekking Association worked hard to safely evacuate thousands of people to safe place on Monday.

Combined teams of rescue workers, since Sunday, evacuated patients, doctors, and equipment from INIMS, braving heavy rainfall, strong water currents. # **Address Basic Needs of Children With Disabilities**

espite improvement in the health care system in the country, the situation of specially-abled children or children with disabilities remains deplorable, particularly in rural areas and among the lower socio-economic population. Specially-abled children in India are subject to multiple deprivations and limited opportunities in several dimensions of their lives. Some of these include, not being enrolled to schools, lower employment rates, limited awareness of entitlements and services available and lack of social welfare support.

Due to stigma associated with disabilities, families become victims of discrimination and human rights abuse. When poverty, physical neglect and social marginalization intersect, the impact on the disabled can be devastating. Specially abled children are kept hidden away at their home, denied basic rights of mobility, education and employment.

The community-based rehabilitation (CBR) is a dynamic program globally for supporting specially abled children to lead better quality of life and lead life with dignity, wherein their rights are respected and guarded within their own communities and it creates platform for addressing the discriminatory practices in the community.

Such discrimination in some cases starts from the family members and spreads right up to the policy makers and state authorities. As a result of such discrimination the Speciallyabled children face chronic ill health, socio-economic burden and destitution. Sometimes it is so difficult to define the marginalization — they are outside the margin or within the community meaning, locked in the rooms, institutionalized, families isolating themselves, enrolling in special schools, not admitting that they have children with disabilities (CWDs), in the hospitals, etc.

Social attitudes and stigma play an important role in limiting the opportunities of disabled people for full participation in social and eco-



nomic life, often even within their

Predominantly in the cases of mental or intellectual disability, the family members are reluctant to accept the disability or refer to it as a physical illness and treatable condition. The pseudo-stigma attached to such disabilities, makes them hide the fact of having a disabled or challenged member at home ultimately leading to social isolation and restrictive behaviors.

There is a fear that they would be victims of disgrace and indignity and thereby family members lose the status or acceptance they enjoy in the community. This denial becomes a hurdle for early identification and treatment. Such persons would be hidden somewhere and they expect, unrealistically, to overcome the situation without realizing the long term consequences of such self-imposed denial.It is preventing of CWDs participating in any social events. Even the family members of the disabled often tend to avoid such social gatherings in shame or fear that someone would ask about their family member with disability. Specially-abled children are not exposed to any social gathering nor does our community recognize the need for children participation. CWDs are not been given opportunities in the areas of educa-

these circumstances it is natural that the CWDs feel rejected or unwanted in the society. Due to differential gender-based role expectations, education is not considered a priority for disabled girls. Dropout rates for disabled girls are higher than for disabled boys. There is an over-representation of disabled boys in education, both in special and mainstream schools. Parents become more protective and restrictive, especially after a disabled girl reaches puberty. Travelling to school is a huge problem, since, besides transport difficulties, the danger of sexual abuse and violation looms large. Persons with disabilities comprise at least 4 to 8 percent of the Indian population. Children with disabilities in India are subject to multiple deprivations and limited opportunities in several dimensions of their lives. Their families and caregivers also go through lot of stress and challenges in having a person with disability at home which ultimately leads to grave discriminatory practices towards these children.

The case studies describes the various ugly forms of the discriminatory practices seen in the community towards Specially-abled children, same been categorized as denial of disability, physical restraints, social boycott, denial of property rights, decreased marital life prospects due to disabled member in family, implications on sexuality of people with disability, women with disability, discrepancies in state welfare programs, and problems in measuring disabilities.Worldwide it is accepted to use International Classification of Functioning (ICF), disability and health, known more commonly as ICF, as measurement for quantifying disability, classification of health and health-related domains. These domains are classified from body, individual and societal perspectives by means of two lists: A list of body functions and structure, and a list of domains of activity and participation. Since an individual's functioning and disability occurs in a context, the ICF also includes a list of environmental factors.

# 'ICC to change two-ball rule in ODIs to revive reverse swing'

Mumbai Jun 2:

The International Cricket Council (ICC) is reportedly set to enforce updated playing conditions in international cricket starting from June 2025. While the new rules in Test cricket will be enforced from June, it will only be from July onwards that the updated playing conditions will come into effect in all international white-ball matches.

Among several changes, the most significant is the reintroduction of using one ball per innings in ODIs, replacing the current system where two balls are used from both ends. While two balls will still be used in ODIs at the start of the innings till the 34th over, the teams will only be permitted to use only one, with the option of choosing one of the balls, starting from the 35th over.

The ICC has communicated the update of the playing conditions to all its members, according to Cricbuzz. "There will be two new balls for overs 1 to 34. After over 34 is completed and prior to the start of over 35, the fielding team will choose one of the two balls to be used for overs 35 to 50. The chosen ball will be used at both ends for the remainder of the match (unless it needs to be changed). In a match reduced to 25 overs or less per side before the first innings commences, each team shall have only one new ball for its Innings," conveyed the



ICC. "A replacement ball at any time during the innings will be one of similar conditions to the ball that needs to be replaced. Note that the ball not used for overs 35 to 50 in the match will be added to the replacement ball supply," said the ICC. Change in concussion substitution

The other major change is the concussion substitution rule. From now onwards, teams will be required to name five concussion substitutes before the start of a match — one wicketkeeper, one batter, one seam bowler, one spinner, and one allrounder. The already existing rules will apply to the World Test Championship (WTC) final between Australia and South Africa, which will take place at London's iconic Lord's starting from June 11. The new playing conditions will come into effect

from the next cycle of the WTC. There will also be changes and adjustments to the boundary line catches and DRS rules as well. Among several changes, the most significant is the reintroduction of using one ball per innings in ODIs, replacing the current system where two balls are used from both ends. "There will be two new balls for overs 1 to 34. After over 34 is completed and prior to the start of over 35, the fielding team will choose one of the two balls to be used for overs 35 to 50.
