# **Terrorism an Epidemic Destined to Perish: Rajnath Singh**

'Operation Sindoor' biggest action taken against terrorism in Indian history

**DEHRADUN, JUN 10**: Branding terrorism as an epidemic destined to perish, Defence Minister Rajnath Singh on Tuesday termed "Operation Sindoor" as the biggest action taken against terrorism in Indian history.

Addressing a dialogue on the topic 'National Security & Terrorism', here Singh, according to the news agency—Kashmir News Observer (KNO) said, "In the last 11 years, Prime Minister Narendra Modiled Government has transformed India's security apparatus by changing the attitude and the way of action towards every issue related to national security, and the world witnessed this shift during Operation Sindoor."

Pertinently, "Operation Sindoor" was launched against terrorists sitting in Pakistan in retaliation against the April 22 Pahalgam attack, which left 26 civilians, mostly tourists dead. On May 6, Indian



armed forces launched a massive counter offensive by targeting nine terrorist camps deep inside Pakistan and PoK, which was followed by skirmishes that continued till May 10. Hostilities ended after Pakistan DGMO called his Indian counterpart and asked for a ceasefire.

"It [Pakistan] is a country very steeped in its use of terrorism as an instrument of state policy. That is the whole issue," Jaishankar told Politico during a visit to Brussels.

of war last month were still in place, he said: "If you call the commitment to terrorism a source of tension, absolutely, it is."

Asked to clarify about reports of Indian fighter jets downed by Pakistan, Jaishankar didn't deny the destruction of Indian Air Force planes, but said the appropriate authorities would communicate on the matter when ready.

He stated that India's fighter planes and missiles had inflicted far more extensive damage on the Pakistani Air Force than vice versa, forcing Pakistan to sue for peace.

"As far I'm concerned, how effective the Rafale was or frankly, how effective other systems were — to me the proof of the pudding are the destroyed and disabled airfields on the Pakistani side," he said.

"The fighting stopped on the 10th for one reason and one reason only, which was that on the 10th morning we hit these eight Pakistani, the main eight Pakistani airfields, and disabled them."

"And don't take my word for it, these are images which are available in Google. You can look at those runways and those hangars which have taken the hit," Jaishankar added.

Jaishankar asserted that Pakistan was training "thousands" of terrorists "in the open" and "unleashing" them on India.

"We are not going to live with it. So our message to them is that if you continue to do the kind of barbaric acts which they did in April, then there is going to be retribution, and that retribution will be against the terrorist organisations and the terrorist leader-

"And we don't care where they are. If they are deep in Pakistan, we will go deep into Pakistan," he added.

### RAJNATH

Terming the Pahalgam incident was an attack on the social unity of the country, the Defence Minister said, "India took a big & strong action against terrorism and its perpetrators by destroying terror bases & related infrastructure in Pakistan & PoK."

He said, "The abrogation of Article 370 heralded an era of peace and progress in J&K. Our neighbors could not tolerate this, and executed the terror attack in Pahalgam. Despite Pakistan's best efforts, it has not been able to stop development in Kashmir. Udhampur-Srinagar-Baramulla railway link is a shining example of the Government's relentless pursuit of progress in J&K. Soon, PoK will join us and say 'I, too, am Bharat'," he added.

Singh asserted that while the Indian Armed Forces have given a befitting reply to terrorists, it is imperative to prevent terror incidents such as the one in Pahalgam in future.

He emphasised on the need to be alert not just at the level of governments, but also at the public level. He described terrorism as a distorted moral reasoning, the biggest curse on humanity, a major threat to peaceful coexistence & democracy, and an obstacle in the path of progress. The fight against terrorism is not just a question of security, it is a battle to protect the basic values of humanity, he added.

He stressed that the terrorism cannot be left to die a natural death as its existence will continue to challenge collective peace, development and prosperity. He underscored the urgent need for a permanent solution to terrorism.

TERRORISTS ARE NOT FIGHTERS WITH A CAUSE"Terrorists are not fighters with a cause. No religious, ideological or political reason can justify terrorism. No human objective can ever be achieved through bloodshed and violence. India and Pakistan attained independence at the same time, but today, India has been recognised as the Mother of Democracy, while Pakistan has emerged as the Father of Global Terrorism," he said, adding, "Pakistan has always given shelter to terrorists, trained them on its soil and helped them. It always tries to justify this menace. It is important that we eliminate these terrorists and their entire infrastructure."

Singh urged the international community to stop foreign funding to Pakistan, saying that a large part of this financial aid is spent on terrorism. "Funding Pakistan means funding the infrastructure of terrorism. Pakistan is a nursery of terrorism. It should not be nourished," he added.

EXPRESSES SHOCK OVER UNSC DECISION TO NAME PAK AS VICE-CHAIR OF COUNTER-TERRORISMThe Defence Minister expressed shock at the recent decision by the United Nations Security Council to name Pakistan as the Vice-Chair of the Counter-Terrorism Panel, especially when the panel was formed after the 9/11 terror attacks. "Pakistan had sheltered the mastermind of the 9/11 attacks. Its land has been used as a refuge for global terrorist organisations. There, terrorists like Hafiz Saeed and Masood Azhar roam around openly, and senior officers of Pakistan Army attend the funerals of terrorists. Now, the same country is expected to lead the global community against terrorism. This raises serious questions on the intentions and policies of the international system," he said.

Singh called upon the global community and organisations such as the United Nations

to think on issues like terrorism more seriously, stating that "Only when we are free from terrorism, will we be able to move towards the goal of global peace, progress and prosperity." He added that the common people of Pakistan are of the same view, but the rulers there have put the country on the path of destruction.

ADVISES PAK TO SEEK INDIA'S HELP TO **DEAL WITH TERRORISM** 

The Defence Minister advised Pakistan to seek India's help if it is unable to take action against terrorism on its soil. He stated that the Indian Armed Forces are capable of taking effective action against terrorism on either side of the border, which was witnessed by Pakistan itself during Operation Sindoor. Calling Pakistan stubborn, he termed it necessary for the whole world to put strategic, diplomatic and economic pressure on Islamabad to deal with terrorism emanating from

DEFENCE SECTOR HAS EMERGED AS ONE OF STRONGEST PILLARS OF AATMANIRBHAR

Highlighting the strategy adopted by the Government to deal with terrorism and strengthen national security, The Defence Minister said the defence sector has emerged as one of the strongest pillars of Aatmanirbhar Bharat, and the weapons/platforms used during Operation Sindoor were Made-in-India. "Today, India is not only protecting its borders, but is also creating a system which is making us strategically, economically and technically strong. Earlier, we were completely dependent on foreign defence equipment, but today India is rapidly becoming Aatmanirbhar in defence," he said.

He listed out the steps taken by the Government to strengthen the defence sector, including increasing the defence budget from Rs 2.53 lakh crore in Financial Year (FY) 2013-14 to Rs 6,22 lakh crore in FY 2024-25; reserving 75% of the budget for capital procurement from domestic companies and the issuance of a total of 10 Positive Indigenisation Lists, comprising over 5,500 items. "Today, Indian Armed Forces use state-of-the-art weapons, missiles, tanks and other systems/platforms manufactured within the country. Our indigenous missiles such as Agni, Prithvi & BrahMos stand ready to give a befitting reply to the enemy. We also have the strength to build aircraft carriers such as INS Vikrant," he

Singh underlined that the Government's persistent efforts are bearing fruit as the annual defence production, which was around Rs 40,000 crore in 2014, has crossed the record figure of Rs 1.30 lakh crore today, and defence exports, which were Rs 686 crore in 14, has skyrocketed to Rs 23,622 crore in FY 2024-25, adding that Made-in-India defence products are being exported to nearly 100 countries. "We have set a target of Rs 1.75 lakh crore defence production this year and Rs three lakh crore by 2029. Our defence exports should reach Rs 30,000 crore this year and Rs 50,000 crore by 2029," he said.

ASKS PEOPLE TO BECOME SOCIAL SOL-

**DIERS BY IDENTIFYING LIES** He highlighted the growing use of information warfare in the 21st century, urging the people to become social soldiers by identifying lies, stopping rumours, and spreading awareness in the society. "While data and information are the biggest power, it is also the biggest challenge. During Operation Sindoor, Pakistan conspired to break the morale of our soldiers and citizens through fake videos, manipulated news and posts. Even though military actions have been stopped, information warfare is still going on. If people share false news without thinking, they unknowingly become a weapon of the enemy. It is time that all citizens become social soldiers. The Government is working on cyber security at its level, but every citizen needs to be a 'first responder'," he said.

He also exhorted the media that, in today's times, 'being most correct' must be accorded priority than 'being ahead'. "Instead of being 'verified', being 'viral' has become the standard of journalism. There is a need to avoid this,"

Singh termed the media as a "watchdog" when the issue of national security is not only concerned with borders, but is now a challenge in cyber and social sectors. "Journalism is not just a profession but a national duty. It informs while keeping us alert and vigilant towards the security of the country. A free and healthy journalism is a stabilising force that makes the society alert, unites it and spreads consciousness," he said-

According to the news agency—, Jammu recorded the hottest day of the season 44.4°C, which is 5.6°C above normal, while Banihal recorded 33.6°C, which is 5.2°C above normal.

Similarly, Batote recorded 33.3°C, which is 5.5°C above normal. Bhaderwah's maximum temperature settled at 33.4°C, which was 3.6°C above normal, and Katra recorded at 40.6°C, which was 4.9°C above normal.

Moreover, Kashmir division also witnessed the above normal temperature on Tues day with Srinagar, the summer capital of Jammu and Kashmir, recording 33.5°C, which was

districts, the Chief Secretary emphasised the need for time-bound implementation. He directed the DISCOMs, JPDCL and KPD-CL, to ensure that the vendors complete installations in the shortest possible time.

Dulloo impressed upon the Deputy Commissioners to personally monitor the progress on rooftop solar projects in their respective districts and ensure timely completion, enabling the consumers to experience minimal delays. He also reviewed the status of applications and installations districtwise and sought a strategy from each DC to fast-track execution.

To maintain quality and efficiency, he instructed the senior officers of JPDCL and KPDCL to undertake field visits to inspect the ongoing installations. He stressed the importance of institutional leadership while encouraging the DISCOM employees to set an example by adopting rooftop solar systems themselves. The Chief Secretary also directed that Common Service Centre (CSC) operators be empanelled to facilitate the consumer registrations at the grassroots level, ensuring ease of access for the rural

and remote households. Reviewing the solarization of government buildings, another critical component of the PMSMBY, the Chief Secretary described it as a prestigious initiative that must be executed with utmost seriousness. He directed the Deputy Commissioners to verify the functionality of each installed rooftop system and submit building-wise status reports by June 30, after coordinating with the JAKEDA for the requisite data.

Speaking on the occasion, Principal Secretary, Finance, Santosh D. Vaidya, stressed the need to involve the local contractors in solarisation drive by registering them as vendors and incentivising their participation. He underlined that the scheme's momentum hinges on the proactive involvement of local players, both from a developmental and entrepreneurial standpoint besides ensuring its completion on time.

Principal Secretary, PDD, Rajesh Prasad, highlighted that consumer response to the scheme has been overwhelming in recent months, with a significant uptick in applications. He noted that the focus must now shift to enhance the vendor capacity and on-ground execution, for which the department is actively engaging empanelled vendors. Providing an update on the implementation status, MD JPDCL, Choudhary Yasin, reported that 6,121 Solar Rooftop Systems (SRTs) with a combined capacity of 22.51 MW have already been installed across the UT. So far, 12,206 consumers under JPDCL and 8,108 under IPDCL have selected their vendors, while 802 (JPDCL) and 690 (KPD-CL) consumers have completed payments

He added that the cumulative application load received stands at approximately 78.51 MW (JPDCL) and 103.35 MW (KPDCL), indicating the strong public interest and demand.

Similarly, MD, KPDCL, Mehmood Ahmad Shah, informed the meeting that aggressive Information, Education & Communication (IEC) campaigns have been launched to promote adoption. He highlighted the terrain-related challenges in the Valley, especially on steep tin rooftops and the need for vendors to scale up their material procurement and manpower to meet demand.

Providing a detailed overview of the government building solarization component, CEO, JAKEDA, PN Dhar, shared that a total of 70 MW capacity will be achieved through Capex mode and an additional 175 MW under RESCO mode, covering 22,494 government buildings in the UT.

Under Capex mode, 5,220 buildings (43.40 MW) have already been taken up, with work orders issued for 3,403 more buildings, expected to add another 34.39 MW into the power system of the UT. Under RESCO mode, 1,500 buildings (35 MW) will be completed by NHPC and and 8,000 buildings (175 MW) by JAKEDA itself, the meeting was informed.

The meeting reaffirmed the government's commitment to green energy and urged all stakeholders to make coordinated efforts to ensure the timely and highquality implementation of this transformative scheme without any fail.

"The real responsibility of protecting the vatris lies with you—the locals. More than the government forces, it is the people of Kashmir, especially from areas like Pahalgam, who must ensure their safety," Mehbooba

# Secretary RDD reviews draft 'J&K Rural Building Bye Laws, 2025' 'Framework will transform rural planning through structured regulation'

SRINAGAR, JUNE 10: Secretary, Rural Development Department (RDD) and Panchayati Raj, Mohammad Aijaz Asad, today chaired a crucial meeting to discuss the draft of the 'Jammu and Kashmir Building Permission (Rural Areas) Procedure, 2025', a first-of-its-kind framework designed to regulate the building activities across the rural areas governed by Halqa Panchayats.

The meeting was attended by Director RDD Kashmir, Shabir Hussain Bhat, Director RDD Jammu, Mumtaz Ali, Director Panchayati Raj Sham Lal, Director Finance, Umar Khan, Joint Direc-

tor Planning, Kamal Kumar Sharma, Superintending Engineer REW Kashmir, Aamir Ali, Superintending Engineer REW Jammu, Rajesh Kumar, Deputy Secretary, Tahir Ahmad Magray and others.

The Secretary emphasised that the new procedure has been anchored in a robust legal framework drawn from the J&K Panchayati Raj Act, 1989 and the Rules of 1996.

"Section 12 (2) (iv) of the Panchayati Raj Act empowers Halqa Panchayats to regulate the buildings, shops and entertainment houses while as Rules 155 and 156 require mandatory approvals for construction, reconstruction or alterations'

The Secretary said that this



framework brings a long-awaited legal and procedural clarity to the rural construction. "It ensures accountability and offers a citizenfriendly mechanism that truly empowers the grassroots," he added. The new procedure applies to all Halqa Panchayat areas across

Jammu and Kashmir, excluding areas under Municipal Corporation/ Council/ Committee, Tourism Development Authority or other empowered authorities. It will come into force upon official notification by the government. The framework covers all types of construction activities including new constructions, extensions, alterations, reconstructions, changes in building use and reconstruction due to fire, collapse or demolition.

The Secretary emphasised that citizen convenience should remain paramount while maintaining regulatory standards.

During the deliberations, the Secretary directed the officials to expedite work on the Online Building Permit System (OBPS) to ensure applications are processed digitally, transparently and efficiently. He stressed the importance of maintaining detailed records of all permissions granted besides creating a robust monitoring mechanism to track compliance.

Aijaz Asad said, once notified, all officials will adhere to the 30-day cycle for processing applications, 15 days for internal review, 10 days for decision-making and 5 days for communicating outcomes. "This framework is not merely regulatory, it is transformational. It restores people's trust, strengthens Panchayati Raj and brings a structured, rule-based approach to rural development,"

## Molvi Imran Reza Ansari Meets LG Manoj Sinha Over Muharram Arrangements

Srinagar, 10th June 2025: Today, President of the All Jammu & Kashmir Shia Association and General Secretary of J&K Peoples Conference, Molvi Imran Reza Ansari, met Hon'ble Lieutenant Governor Shri Manoj Sinha to discuss critical arrangements ahead of the upcoming Muharram observances. While last two year's decision to allow the 8th Muharram procession in Srinagar marked a shift in approach, the focus of the meeting remained firmly on ensuring practical preparedness, administrative coordination, and safe religious conduct across the Valley this year. A key demand placed during the meeting was the revival of the traditional 10th Muharram procession route from Abi Guzar to Zadibal, which holds historic and religious importance for the Shia community. Molvi Ansari strongly recommended the establishment of dedicated war rooms in each of the key districts Srinagar, Budgam, Bandipora, Pulwama, and Baramulla along with the appointment of a district-level coordinator to monitor and manage Muharram-related arrangements in real time. He also urged the release of special funds to respective Deputy Commissioners to enable timely execution of essential works without bureaucratic delay. Additional issues raised included the need for urgent road and wooden bridge repairs along procession routes especially Dal area, permission for short-term tendering to carry out last-minute infrastructural works, and resolution of a decade-old compensation case related to a dangerous structure at Alamgari Bazaar, He also brought attention to CAPD supply shortages particularly rice and sugar used for preparing Niyaz, as well as persistent water scarcity in Zadibal, Bagwanpora and Dal localities. A water tanker deployment blueprint was requested for all the three areas to avoid service breakdowns during peak days. Molvi Ansari also proposed that only small ambulances be deployed during processions to prevent crowd disruption, and called for advance placement of essential medicines and availability of doctors in all Shia dominated areas to ensure timely medical response, smart bus transport for mourners on key Muharram days,


participate in the forthcoming camps. 'These camps are aimed to fulfill the gaps in service delivery by identifying eligible beneficiaries and covering them on the

In such a scenario the children are not able to develop properly and they also remain inactive in sports as well as extra-curricular activities. This casts a negative impact on the overall personality of children and they are not able to compete at different levels.

It is imperative that the policy makers in the field of education ensure that the NEP is implemented in letter and spirit across the country. All the components of the policy including the weight of the school bags for the children of different age groups need to be put into practice. This would ensure that justice is meted out to the children and they are no more pushed to the hilt when it comes to receiving education.

n hearing the word adulteration, images of fake milk, peanuts mixed with stones, colour in tea leaves and dust in spices flash in the mind. But these images are not limited to the stomach. The biggest adulteration that is happening today is in our thinking, conscience and system. Along with every product sold in the market, our sensibilities, honesty and moralitv are also slowly getting polluted. And the funny thing is – we have accepted this adulteration as so common that now when the real thing comes in front of us, we start getting suspicious.

Finding stones in peanuts is no longer a surprise. Pebbles in lentils, colour in peas, powder in salt and wax in ghee – all these have now become permanent members of life. From shopkeepers to big brands, everyone is involved in the blind race for profits. Everyone wants more profit at less cost, and the easiest way to do this is adulteration. Adulteration in intention, cheating in profit, and sacrifice of customer's

From the streets of the village to the noise of the city, everywhere is the same sad story. The red chillies in the pickle shine, but in reality it is the colour used to dye clothes. The foam in the milk is not the freshness of the dairy but the magic of detergent. And the greenery seen on the vegetables is not the result of nature but of chemicals. What we eat is not poisoning our body but slowly poisoning our soul.

There was a time when milk, ghee or grains would come from someone's house and would be accepted blindly. Today, even the sweets brought by relatives need to be checked - lest they are adulterated. In the market, "purity" is now just a branding tool, it has nothing to do with reality. Writing "100% pure' does not make things pure, but the consumer's eyes are blindfolded to such an extent that he does not even

Lead content in children's toffees, lime in flour, synthetic colours in turmeric - these are not just health issues, these are signs of moral degradation of the society. And the sad thing is that not only shopkeepers or companies are responsible for this adulteration, but also our tolerant society which remains silent despite knowing everything. Which lives with the mentality of "it's okay",

and dies slowly. Adulteration is not limited to just food and drink. Adulteration of emotions, adulteration of selfishness in relationships, adulteration of pretense in prayers and the most dan-



gerous – adulteration of ideologies in politics. Earlier people lived and died for ideas, now ideas come in 'packages'. Nowadays both 'secular' and 'nationalist' can be sold in the same advertisement - just the advertisement should be right. Who is speaking the truth and who is lying this is now decided by the troll army, not logic and wisdom.

Sometimes it seems that adulteration has become our identity. Adulteration of promises in election manifestos, adulteration of news in newspapers, adulteration of facts on social media - a world of adulteration is surrounding us from every side. And when someone speaks the truth, he is either called 'anti-national' or having a 'paid' agenda. This is the real tragedy.

On the other hand, the hunger for profiteering is also not stopping. The businessman knows that if he adds 5% stones to peanuts, he will earn lakhs of rupees at the end of the year. Companies know that if they add a little powdered colour, customers will find it "fresh". And even after knowing all this, the consumer is helpless - because there are few options and the truth is expensive.

The government runs 'food inspection campaigns' from time to time. Some samples are tested, some licenses are cancelled. But the real question is - is there no adulteration in this system? Are these campaigns just a sham? After all, how do those powerful companies, whose products are proven to be adulterated. still continue to sell them so freely?

The writer who speaks on adulteration is also a part of the system which compromises many times. If a reporter wants to do a story against an adulterating businessman, his editor thinks of advertising. If a doctor raises his voice against fake medicines, the pharmaceutical companies blacklist him. And the common public? It has been cheated so many times that it no longer has the power to resist.

In this adulterated environment, there are some people who are working honestly. Those who do organic farming in their fields, those who make sweets without adulteration, those who do not mix water in milk. But their struggle is very difficult. Consumers abandon them calling them expensive, and the government entangles them in rules instead of supporting them. In such a situation, speaking the truth and selling correctly have both become a kind

of 'revolution'. To stop adulteration that has penetrated deep into the society, not just stringent laws but a cultural movement is needed. We have to teach children that truth is the biggest business. We have to be vigilant as consumers, ask questions, investigate, and most importantly - not compromise our conscience.

A time will come when the adulterator will be afraid to taste even the sweets made at his own home. When the society will reach such a moral level that the one selling lies will not be able to stand in the market. But that time will come only when we all understand our responsibility. Otherwise today there is a stone in the peanut, tomorrow it will be in the soul too.

Those who think that adulteration is just a consumer problem are thinking very narrowly. This crisis is a crisis of our nation's credibility. If we are selling fake products to our own citizens, then what will we give to the world? The talk of "Make in India" is hollow as long as 'Adulteration in India' prevails.

Ultimately this fight is not about the taste of food, but about the truth of life. Because today's adulterated food items not only spoil health, they make the entire society sick. A stone not only pierces the peanuts but also pierces relationships and trust. And if we do not wake up even now, then we will only hand over a plate of tasty poison to the next generation.

# Deal of Awards: Sentiments Being Sold in The Literary Market

iterature is the call of the soul. It is the fruit of the creator's sadhana-an expression of penance, sacrifice and compassion. But today, when we look around, we find that this sadhana is now being sold at the shop of "contribution amount" and "nomination fee". Awards are no longer an acknowledgement of sadhana, but an auction of money. In such a situation, it is natural to raise the question -will the value of literature really be decided by bank transactions now?

#### A market running in the name of literature

Nowadays, messages come on social media, WhatsApp and mail in the name of literary events – "Get nominated for just 1000, get prize for 2500." Some so-called organizations and individuals lure literature lovers by spreading a web of awards adorned with big words like 'national', 'international', 'glory', 'gem'. The truth is that not awards but honours are being auctioned. Most of the organizers of these events mislead people by resorting to similar websites, names of fake international organizations and social media promotion. They arrange a trophy, certificate and sometimes an online ceremony for a fixed fee, which is only a means of self-praise, not real recognition.

#### **Brokerage for donations or prizes?**

There is often a clever trick behind these events – it is given a moral cover by calling it "support amount" or "press release expenses". The award should be given to a seeker for his contribution, not by looking at his pocket. When a writer creates a work with his hard work, he pours a part of his time, life and sensitivity into it. And then some people come - give money, take the award - isn't this an insult to the soul of literature? Here literature has become a product and the writer a consumer. The terms of the award are not decided on their creative criteria, but on UPI payment and confirmation of screenshots.

## Merchants of language degradation

Through such events, not only is literature

being cheated, but a systematic degradation is being spread in the name of Hindi and other Indian languages. The honour which was once a symbol of national pride has now become a commodity that can be obtained by buying tickets. This is an attack on linguistic culture, which needs an organised boycott. Many fake international awards are being run within India under the guise of foreign names. These events have only one objective - to earn money under the guise of name and exploit literary seriousness.

#### ■ Let literature remain a pursuit, don't make it a deal

institution behind them, only have Facebook page or Google form — they are suspicious. If any "international" award is being organized only in small cities of India, then investigation is necessary. If there is no transparency of the founder or jury on the website, then it is a red flag.

#### ■ Literature did not sell, it survived

We are not saying that awards should not be given – rather awards should be an acknowledgement of the sadhana of ascetic writers, not a receipt for a UPI payment. If we want to save the dignity of language, we will have to get rid of such fake institutions. Literature is not a room of kajal where



A true writer does not write for awards, but for the society. He does not run after awards, awards run after his devotion. Today, there is a need to expose such deceit that is making literature just a "selfie event". People who give "guarantee of awards" are actually the killers of the soul of literature. Such awards not only reduce literary dignity, but also give a wrong inspiration to young writers - that marketing and payment of the work is more important than the creation. Make the society aware, boycott it. Now the time has come that we boycott such events, socially expose those who sell awards for money, expose their names in social media and magazines, spread awareness among true writers and readers, keep literature as an expression of the soul, do not let it be auctioned.

## ■ How to spot a fake rewards scam?

Be cautious if nomination fee or contribution is demanded before getting the award. Events which do not have any reputed anyone can come, apply kajal and go away. It is sadhana, it is service, it is a struggle. The artificial light that is being created in

the world of literature is actually a darkness - far from the soul, close to money. Only true writers and readers can together eradicate this darkness. If we want to keep the soul of literature alive, then it is important that we raise our voice against such fake awards. This will not only protect the reputation of writing, but will also teach the coming generations that not awards, but creativity and sensitivity are the real capital of literature.

We are entering an era of literature where the biodata of awards has become more important than the soul. What is needed is patience, discretion and analysis that strengthens the true creator from within. In such an environment, the silence of true writers will be a crime. Only if they reject these fake platforms, will it be possible to

restore values. This is not just a boycott, it is the beginning of a cultural renaissance - where the resonance of ideas will be important, not awards. This is the time to save the practice of literature. If we do not speak today, then perhaps tomorrow the language, with the help of which we are writing this article, will not survive.

**△** Literature today is not a sadhana, but is becoming a market for bargaining. Fake organizations are distributing 'national' and 'international' awards for ₹1000-₹2500. This is not only the murder of literature, but also of language. Honor is being sold in the name of "contribution amount", and the sadhana of true litterateurs is being neglected. Now the time has come—boycott these events, expose them, and save literature from market impurity. Awards should be the dignity of creation, not an award for digital payment! If any award can be bought with 'contribution amount', then it is not an award, but a market spectacle. Literature is the language of the soul, not a crowd of trophies. Not only Hindi, but the soul of literature is being injured by the imitation of fake events. Now the time has come to take literature out of the "selfie event" and bring it back to the platform of true sadhana.

# Fungus is not only an Enemy of Crops, it is also **Dangerous for Human life**



ccording to a science journal, fungus can be a dangerous weapon of agricultural terrorism. A Ifungus called fugerium graminiarum affects the growth of various grains. This also reduces yield. After infecting it is spread with fungus crop matures. Fugerium gramini Arum is known to survive and infect new plants in small grain plants stem and of the foliowing tissues, residues. It produces mycotoxins that are consumed by harmful. In the past, the American intelligence agency FBI arrested Yunking Jiang, a researcher Chinese research scientist at the University of Michigan who brought dangerous biological fungus Fujerium graminirum to the US. Well fungus produces a variety of diseases such as head blight, root rot  $and \, seadling \, blight. \, Most \, of its \, species \, are \, mridafungus.$ While fugerium graminiSerum fungus spreads head blight disease in wheat, paddy, maize, and barley. This mainly produces vomitoxin substance which contaminates grains. The toxic substance derived from it wastes billions of dollars of crop every year and reduces yield. Significantly, the FBI had sent back to China from Detroit airport after Golmol replied about the red plant substance that Chinese research scientist Gian's Bwifrand Liu received in his bag last year in July. According to Liu, her plan was to use this material for research at the Michigan University lab. He then pulled this dangerous fungus to the Michigan University lab by hiding it through his girlfriend Gian. Liu used to work in this lab earlier. She is currently working in Chinese University. The FBI director has said it as a serious case that China is doing infiltrating sex in U.S. institutions so as to neutralize the populace through the food security mechanism. Unauthorized imports of this strain lead to more aggressive or pesticide-resistant variants. Due to this control measures are less effective. This dangerous fungus is also found in India. As reported by the U.S. National Library of Medicine 2022, the wheat crop in North India saw symptoms of head blast several times. However every time he got control over it. Climate change is the key reason behind it being active here. It is considered as a L threat to wheat crop. The comprehensive disease- survey conducted in Himachal and Tamil Nadu in ICAR's 2021 had revealed about this fungus. This caused the problem of head blight or stand in wheat grain. Not only this, a survey conducted by Karnataka Krishi Vivi in the Rabi season  $between\,2021\,and\,2022\,saw\,the\,problem\,of\,head\,blite$ in Karnataka. Actually in the US the smuggling incident of fugerium graminiuram by Chinese scientist has questioned global agricultural security, warning has also given that soil, seeds and crops can also become weapons of terrorism. Fugerium gramini Serum fungus can also plant grains that can lead to the death of humans and cattle. Being extremely subtle, it does not easily fall into the grip and expands itself through air, soil, and seeds. Symptoms are such as cropped diseases at the beginning of it. In humans it is too late as long as it is discovered.

# Court Slams Delay in Appointment of Advocate General, Stays Takeover of Reasi Temple

Srinagar, June 10, KNT: The High Court of Jammu and Kashmir and Ladakh has expressed serious concern over the prolonged vacancy in the post of Advocate General for the Union Territories of I&K and Ladakh, observing that the absence of this statutory position has rendered a key legal provision ineffective.Justice Rahul Bharti, while hearing a petition filed by the Nav Durga Jhaleri Mata Trust, questioned how long the UTs could function without an Advocate General. The post has remained unfilled since October 2024 after former Advocate General DC Raina stepped down following the formation of the National Conference-led government. Reports suggest the delay stems from a standoff between the Lieutenant Governor's office and the new administration headed by Chief Minister Omar

Abdullah. The court emphasized that in the absence of an Advocate General, Section 92 of the Code of Civil Procedure, which enables civil suits for the better management of religious and charitable trusts, has become defunct. "The office of Advocate General is in vacancy... leaving a live provision a dead letter of law," Justice Bharti observed. The remarks came during proceedings in a case where the temple trust challenged the administration's decision to hand over management of the Nav Durga Jhaleri Mata Shrine in Reasi to the Shiv Khori Shrine Board. The government's move was made pending the enactment of a law to govern religious institutions in the Union Territory.

## **Road Woes Deepen Across** Kashmir, No Sign of **Macadamisation Work Yet**

Srinagar, June 10, KNT: With summer already underway, locals across the Kashmir Valley are expressing growing anger and frustration over the dismal condition of roads, as the government fails to kickstart the annual macadamisation and repair work traditionally carried out during this

From Kupwara to Anantnag and Bandipora to Pulwama, people in almost every district are complaining about potholed roads, dusty stretches, and broken pavements, with no machinery or road crews in sight.

"This is the season when we used to see blacktopping work in full swing. But this year, it's all silence. Not a single patch has been repaired," said Ghulam Nabi, a shopkeeper from Baramulla. "We have just four workable months left, and still, no action." In Budgam, commuters say the roads have become nearly undrivable, resembling craters more than highways. "We are not driving on roads anymore. These are ditches stitched together," a teacher told the news agency Kashmir News Trust. "Even ambulances struggle to pass through. Is this the development we were promised?'

Locals blame the administration for turning a blind eye to basic infrastructure needs. "It seems the authorities are in deep slumber. Every year they claim macadamisation will be done in time, and every year the promises vanish into thin air.' In Srinagar's outskirts and peripheral areas, the situation is equally grim. Roads that were damaged during the winter remain untouched, with no signs of tendering, labor, or machinery.

People have beendemanding immediate intervention from higher authorities and transparency regarding the delay in the annual road restoration process. [KNT]

These are government and World Bank figures," Joshi emphasised, adding that the Opposition cannot dispute these facts.

He said the creation of the post of Chief of Defence Staff (CDS) – pending for over three decades — was a symbol of decisive governance. "Coordination among the three defence services is now areality. Earlier governments only spoke of reform; we implemented it," Joshi remarked. He also pointed to major defence exports worth 25,000 crore including BrahMos missiles and INS Vikrant as examples of India's growing self-reliance.

## **ED attaches Rs 100 crore** worth properties in **MUDA scam**

The Enforcement Directorate (ED) on Tuesday provisionally attached 92 immovable properties valued at approximately

100 crore in connection with the Mysuru Urban Development Authority (MUDA) scam, a case linked to Karnataka Chief Minister Siddaramaiah and others.

The agency stated the attachment was carried out under the provisions of the Prevention of Money Laundering Act (PMLA), 2002. This is the second major seizure in the ongoing investigation, taking the total value of attached assets in the case to 400 crore, which includes 160 MUDA sites worth around 300 crore previously attached. According to the ED, the latest set of properties are held in the names of housing cooperative societies and individuals.

# Sole aim of terrorism is to spread fear and destabilise societies: Nityanand Rai

Union Minister of State for Home Affairs Nityanand Rai said on Tuesday that the sole aim of terrorism is to spread fear and destabilise societies across the world and therefore it must be decisively defeated.

Speaking at the 23rd NSG International Seminar here, he said that terrorism has become the most serious threat to global peace, development, and human rights.

"It is our experience that to completely defeat terrorism, we need more than just military action. Global cooperation is essential. Countries must come together, share intelligence, and expose the motives and mechanisms of terrorists to dismantle their networks effectively," Rai said.

Highlighting the cross-border nature of terrorism, the Minister noted that it is not confined to the geographical boundaries of any one nation. "The challenge is national, regional, and global. Anyone who does not oppose terrorism is also a party to it," he warned.

Rai further asserted that terrorism should be recognised as a universal threat, regardless of where it strikes -beit India, Israel, the United States,



"If the global community truly wishes to defeat terrorism, it must identify and confront all its manifestations without bias or exception," he added.

Reaffirming India's unwavering commitment to the global fight against terrorism, Rai said, "India, as a responsible democratic nation and is fully committed to cooperating in global anti-terrorism efforts whether under the framework of the United Nations, through bilateral engagements, or other international initiatives."

"India has always been a strong partner in the fight against terrorism and will continue to play this role with full determination," he added.

# NATO secy-gen urges 5% increase in defence to counter Russian threats

NATO secretary general has repeatedly called countries such as Russia, China, North Korea, and Iran, hostile countries, and alleged threats emanating from them, thus urging increased militarisation of the multilateral body.

"Wishful thinking will not keep us safe," Rutte said. "We cannot dream away the danger. Hope is not a

strategy. So, NATO has to become a stronger, fairer and more lethal alliance." As such, Rutte proposed a target of 3.5% of economic output on military spending and another 1.5% on "defence-related expenditure" such as roads, bridges, airfields and sea ports. He said he is confident the alliance will agree to the

# Mamata clarifies OBC policy in Assembly as BJP stages walkout

Kolkata, June 10

West Bengal Chief Minister Mamata Banerjee on Tuesday told the state Assembly that backwardness alone determines inclusion in the Other Backward Classes (OBC) category, dismissing allegations of a religious bias in the process.

She criticised a social media campaign spreading "misinformation", asserting that religion has no role in OBC classification. Banerjee informed the House that a government-appointed commission is currently surveying 50 new subsections for potential inclusion. So far, 49 groups have been added under OBC-A and 91 under OBC-B. She

explained that the OBC-A category com-

prises more disadvantaged communities, while relatively better-off groups fall under

The chief minister's remarks followed the tabling of the annual report of the West Bengal Commission for Backward Classes for 2024-25. She emphasised that all additions were based on thorough field studies and the commission's recommendations. Addressing the recent controversy, Banerjee said, a Calcutta High Court directive led to the removal of several communities from the OBC list, creating uncertainty for job seekers in the state. She stated that her government has appealed the verdict in the Supreme Court, where the matter remains



"The Calcutta High Court gave a directive regarding OBCs. Several OBCs were removed from the list. Job seekers in Bengal found themselves in trouble. We have appealed to

the Supreme Court against the verdict of the Calcutta High Court. That case is currently under jaudicial consideration," she said.

In response to the court ruling, the state cabinet on June 2 approved a revised OBC list. The Department of Backward Class Welfare presented an updated draft reducing the earlier list of 66 communities to 64 and adding 76 new ones to resolve legal

challenges. Meanwhile, BJP legislators, led by Leader of the Opposition Suvendu Adhikari, walked out of the Assembly, accusing the chief minister of making misleading claims. They protested outside the Assembly gate, asserting that Banerjee's statements were inaccurate and that the Speaker denied Adhikari the opportunity to respond – prompting their demonstration.

"Without any agenda and prior intimation to the House, the West Bengal chief minister Mamata Banerjee went to the House and gave a wrongful statement regarding the OBC reservation. This she did because the assembly polls are knocking the door and she is doing appeasement politics. She made a statement in favour of her votebank," leader of the opposition, Suvendu Adhikari said. "We raised our voices strongly infront of the Speaker and the chief minister but he refused to listen and adjourned the House within minutes. This is unethical, violation of judiciary and humiliation of the opposition," Adhikari added.

# Breast Cancer in Women: Advancements in Treatment

reast cancer originates in the cells of the breast, most commonly in: a. Milk ducts (ductal carcinoma) – most common type. b. Milk-producing lobules (lobular carcinoma), and c. Less commonly, in other tissues of the breast. It can invade nearby tissues and spread (metastasize) to other parts of the body through the lymphatic system or bloodstream. While the exact cause of breast cancer is not always known, several risk factors have been identified: a. Genetic and Hormonal: Family history of breast cancer. Inherited mutations (e.g., BRCA1 and BRCA2 genes). Early menstruation (before age 12) or late menopause and hormone replacement therapy (HRT) after menopause. b. Lifestyle and Environmental: Obesity. Alcohol consumption. Lack of physical activity. Radiation exposure (especially during adolescence), and smoking (linked more recently to breast cancer risk).

Reproductive History: First pregnancy after age 30.Not having children, and not breastfeeding.c. Symptoms: Breast cancer may not show symptoms in its early stages. As it progresses, common signs include:Lump in the breast or underarm (often painless). Change in breast size or shape. Dimpling or puckering of the skin (like an orange peel). Nipple changes – discharge (possibly bloody), inversion, or pain. Redness, swelling, or thickening of the breast skin, and persistent pain in the breast or nipple.

There are several helpful guide on diet and precautions for suffering patients with or recovering from breast cancer, during or after treatment like chemotherapy, radiation, or surgery. A nutritious diet can support your immune system, reduce inflammation, help manage treatment side effects, and improve recovery.Recommended Foods Include: a. Fruits & Vegetables (Colourful Variety). Rich in antioxidants, vitamins, and fiber, and broccoli, spinach, kale, carrots, tomatoes, blueberries, apples. b. Whole Grains: Brown rice, oats, whole wheat, barley – help regulate blood sugar and improve digestion. c. Healthy Proteins: Lean meats (chicken, turkey), eggs. Plant proteins: lentils, chickpeas, beans, tofu, nuts, and fish (especially omega-3 rich fish like salmon or sardines). d. Healthy Fats: Olive oil, flaxseeds, walnuts, avocados, and Omega-3 fatty acids help reduce inflammation.

Plenty of Water: Stay hydrated, especially during chemo/radiation. f. Foods to Limit or Avoid: Processed meats (sausages, bacon, etc.). Excess sugar and sugary drinks. Alcohol especially post-diagnosis, it's best to avoid. Fried and fatty foods, and high-sodium processed snacks. g. Precautions During Breast CancerInclude: a. Lifestyle: Avoid smoking completely.Limit alcohol or stop entirely. Maintain a healthy weight – obesity is linked with cancer recurrence.Gentle exercise (as advised by your doctor) helps energy, mood, and immunity.b. During Treatment: Eat small frequent meals if appetite is poor.Manage nausea with bland, easy-to-digest foods like toast, bananas, or rice, and take doctorapproved supplements only if needed - don't self-medicate. c. Emotional Health: Mental health support is just as important - consider joining a support group or talking with a therapist. Yoga, meditation, and breathing exercises can reduce anxiety and improve sleep.d. Medical Monitoring: Regular followups, mammograms, and blood tests as advised, and bevigilant about any new symptoms like unusual pain, fatigue, or swelling.

Advancements in the treatment A latest overview of the latest advancements in breast cancer treatment combining modern science, precision medicine, and supportive care include: a. Targeted Therapy: Targetedtherapies attack specific genes or proteins that help cancer grow, unlike che-



motherapy which affects all rapidly dividing cells.Key Types:HER2-targeted drugs (e.g.,Trastuzumab/Herceptin,Epratuzumab): For HER2-positive breast cancer.CDK4/6 inhibitors(e.g., Carbocyclic, Ribociclib): For hormone receptor-positive breast cancers. PI3K inhibitors: Target PI3K mutations in some breast cancers, and PARP inhibitors (e.g., Olaparib): For patients with BRCA1/ BRCA2 mutations. b. Immunotherapy: Immunotherapy helps the body's immune system fight cancer more effectively. Recently approved for triple-negative breast cancer (TNBC), and drugs like Atorolimumab and Pembrolizumab show promise when used with chemotherapy.c. Precision (Personalized) Medicine: Doctors now test tumors for genetic mutations and molecular features, then choose treatments based on the individual profile.Genomic assays like Oncotype DX and MammaPrint help predict risk and decide if chemo is needed, and custom drug combinations are now being designed based on the cancer's gene expression.d. Advanced Radiation Techniques: Intraoperative radiation therapy (IORT) - given during surgery, reduces exposure to healthy tissue, and Proton beam therapy – a more precise form of radiation, useful for complex or recurrent

Hormonal Therapy Improvements: For estrogen-receptor-positive (ER+) cancers: Aromatase inhibitors (Letrozole, Anastrozole). Selective estrogen receptor degraders (SERDs) - newer oral versions are being developed, and tailored duration of therapy (some need 5 years, others benefit from 10 years). f. Supportive Therapies & Quality of Life: Better anti-nausea meds, pain management, and fatigue care, and integrative treatments like acupuncture, yoga, and nutritional support being studied alongside standard treatment.g. Ongoing Clinical Trials: Many new treatments are in clinical trials, including:mRNA vaccines for preventingrecurrence.CRISPR gene-editing approaches, and new antibody-drug conjugates (ADCs) that deliver chemo directly into

#### Treatment status in India

Breast cancer remains a significant health challenge in India, characterized by rising incidence rates, late-stage diagnoses, and disparities in access to advanced treatments.a. Current Landscape: Incidence and Mortality: As of 2024, breast cancer accounts for approximately 1 in 4 cancer cases among Indian women, with an incidence rate of 27 per 100,000 women. Despite being treatable, late detection contributes to around 90,000 deaths annually. Age Shift: There is a concerning trend of younger women, particularly in their 30s and 40s, being diagnosed

with breast cancer, underscoring the need for early screening initiatives.

Advancements in Treatment:Targeted Therapies: The introduction of antibody-drug conjugates (ADCs), such as Trastuzumab deruxtecan, has revolutionized treatment for HER2-positive metastatic breast cancer patients in India. AstraZeneca launched this therapy in January 2024, offering new hope for improved outcomes. Immunotherapy: Emerging immunotherapies, including checkpoint inhibitors, are being integrated into treatment protocols, particularly for advanced cases, enhancing the body's immune response against cancer cells. c. Challenges: Economic Burden: The financial impact of breast cancer is substantial, with the economic burden projected to rise from \$8 billion in 2021 to nearly \$14 billion by 2030. This increase reflects both direct treatment costs and indirect expenses, such as productivity losses. Healthcare Disparities: Access to quality care varies significantly across regions.

For instance, 5-year survival rates range from 31% to 54% for diagnoses between 1990 and 2000, improving to 64.3% from 2008 to 2012. These figures highlight the disparities in healthcare infrastructure and the need for equitable treatment access. d. Government Initiatives:The Indian government has launched several programs aimed at cancer prevention and treatment, focusing on early detection and affordable care. Efforts include establishing screening camps and enhancing public awareness to reduce the cancer burden.

# India's Covid cases near 7K; 3 deaths in 24 hrs, including Jharkhand's first

UNITED NEWS OF INDIA New Delhi, June 10

India's active Covid-19 cases have risen to 6,815 with 324 fresh infections as on 8 am across the country since the previous day on Tuesday, according to the Union Health Ministry. Regarding fatalities, the total death toll from Covid-19 in India for the year 2025 stands at 68, with three new deaths reported on Tuesday during the period. This included one death from Jharkhand, a first from the state this year.

The Covid tally showed Karnataka has recorded the highest number of new cases, with 136, followed by Gujarat (129), Kerala (96), Madhya Pradesh (9), Haryana (8), Maharashtra (6), Odisha (5), Chhattisgarh (3), Jharkhand (2), and Andhra Pradesh, Telangana, and Manipur, each reporting 1 case, as per the latest bulletin reports. States such as Arunachal Pradesh, Chandigarh (UT), Jammu and Kashmir (UT), Mizoram, Uttarakhand, Uttar Pradesh, and Tripura did not report any

new cases in the past 24 hours. Additionally, since January 2025, 7,644 patients have been discharged, with 783 of them being discharged until June 10. However, Covid-19 data from West Bengal is still pending.

Among those died in the past 24 hours, were 90-year-old woman from Delhi who died from comorbidities, a 44-year-old



man in Jharkhand with multiple health conditions, and a 79-year-old man from Kerala who passed away due to complications from Covid-19. Maharashtra has recorded the highest number of deaths (18), followed by Kerala (16), Karnataka (9), and Delhi (8), among other states.

Underlying comorbidities were a significant factor almost all the fatalities, including heart and kidney diseases and respiratory conditions.

In terms of case numbers, Kerala has surpassed 2,000 active cases, while Gujarat has crossed the 1,000 mark. Health officials attribute the rise to highly transmissible Covid-19 variants, such as NB.1.81 and LF.7, which are affecting coastal regions. Kerala, with 2,053 active cases, has also seen a rise in cases due to the IN.1 variant, which, while not causing severe symptoms, has led to fatal complications in some cases.

## Mbappe's 50th goal helps France to clinch third place

Stuttgart, June 10

France clinched the bronze medal in the UEFA Nations League after defeating hosts Germany 2–0 in the thirdplace play-off here on Sunday, with Kylian Mbappé scoring his 50th international goal to headline a resilient

performance by Les Bleus. Amid a vibrant atmosphere at the Mercedes-Benz Arena, Julian Nagelsmann's Germany started aggressively, threatening early through Nick Woltemade and Niclas Fullkrug. However, France goalkeeper Mike Maignan produced a fine save in the 2nd minute, and Lucas Digne heroically cleared Fullkrug's effort off the line three minutes later. Florian Wirtz then rattled the post in the 37th minute as Die Mannschaft dominated

the opening stages. But the breakthrough came for France just before the break. In the 45th minute, Mbappé drifted inside from the left and curled a stunning strike beyond Marc-André ter Stegen, bring-



ing up his half-century of international goals. The Paris Saint-Germain forward is now just one goal behind Thierry Henry, France's second alltime leading scorer.

Germany's momentum faltered in

the second half, and France seized control. Marcus Thuram struck the woodwork on 59 minutes, and Mbappé forced Ter Stegen into a remarkable save with an acrobatic volley in the 79th minute.

Les Bleus finally sealed victory in the 84th minute when a defensive mix-up allowed Mbappé to race through. Rather than shoot, he unselfishly squared the ball for substitute Michael Olise, who tapped in his first international goal to settle the tie.

Coach Didier Deschamps praised the composure and maturity shown by his young squad, saying the result was "a performance full of promise" ahead of their World Cup qualifying campaign.

France will next face Ukraine on September 5 in Group D of the European qualifiers for the 2026 FIFA World Cup, while Germany take on Slovakia a day earlier in Group A.

Both nations will now turn their focus to the 2026 FIFA World Cup qualifiers as the European campaigns resume
