He also made a visit to the hospital at Baltal Base Camp, and inspected the healthcare facilities for the pilgrims and inaugurated a training ward for medical staff.

"Significant upgradation done to the overall Yatra arrangements. Shri Amarnath Ji Shrine Board, Administration, J&K Police, Security Forces, Service providers, all line departments and stakeholders have diligently implemented pilgrimcentric measures to ensure the pilgrimage is peaceful, safe, and hassle-free for devotees," the Lieutenant Governor said.

The Lieutenant Governor was accompanied by Shri K.N Rai, Member, Shri Amarnath Ji Shrine Board; Dr Mandeep K. The initiatives include Yatra Logo, Yatra Anthem, campaign website and MIS portal, Trinetra App, Pamphlet & Yatra Guidelines, Yatra Mascots and IEC toolkit aimed to promote sustainable practices, address sanitation issues, share verified information, and engage Yatris through feedback along the Baltal and Pahalgam axis, with the goal of achieving a Zero Landfill Yatra.

The campaign website www.shriamarnathjiyatra.com and an MIS portal will serve as the central hub for all information, updates, and resources, while the browser-based mobile application www.zerowasteyatra.app will provide real-time information and support to the Pilgrims.

Pamphlet & Yatra Guidelines, designed for Langar organizers, shopkeepers, and service providers along the Yatra route are focused on ensuring waste minimization, discourage singleuse plastics, and implement SBM-G norms.

Trinetra App will significantly enhance the pilgrim experience through sanitation facilities, safety alerts and making them aware of the values of cleanliness during their pilgrimage.

Ms. Anoo Malhotra, Director General, Rural Sanitation briefed the Lieutenant Governor on dedicated measures taken by the department to make the yatra more sustainable.

It was informed that the Department has installed a total of 5613 toilets / bathing units, on both the axis, of which 2920 are on the Pahalgam axis and 2693 are on the Baltal axis. Further, 7361 sanitation workers are deployed to ensure cleanliness of these sanitation units. The department has also established 15 Processing Facilities for Solid Waste Management on both the axis.

"As soon as any of the blacklisted persons walks into the frame, a hooter will go off at the surveillance centre manned by security forces so that steps to eliminate threat can be initiated in real time," said an official involved in the installation of the systems.

Additionally, the entire yatra routes passing through Kashmir valley have been declared as "no fly zones" as authorities have banned the use of any UAVs or drones in these areas from July 1 to August 10.

The annual pilgrimage to the holy cave shrine, believed to be the abode of Lord Shiva, in south Kashmir Himalayas starts on July 3 and will culminate on August 9 to coincide with Raksha Bandhan.

Lieutenant Governor Manoj Sinha has been visiting the base camps for the past week, reviewing the security and other arrangements for the pilgrims.

"I had a meeting with senior officers (of Shri Amarnath Shrine Board) and security agencies. After the meeting, I can say that the arrangements this year are much better. The coordination among the security agencies is good, and they are all alert," Sinha told reporters at Baltal base camp on Monday.

Although a significant number of pilgrims have registered for this year's pilgrimage even after the April 22 Pahalgam terror attack, the authorities are not taking any chance and have bolstered security with several other measures.

Furthermore, all vehicles plying on the routes and individual pilgrims will be tagged with radio frequency identification technology, which will help in monitoring their movement.

The entire route from Jammu to the holy cave has been brought under CCTV surveillance, and a three-tier security blanket has been thrown around all the base camps, officials said

A large number of police and paramilitary personnel have been deployed for static guard duty along the Jammu-Srinagar highway. The deployment of security personnel has also been carried out at some vulnerable spots on link roads connecting with the highway.

Random checking of vehicles is being done from dawn till late at night to ensure that no hostile element is able to breach the security arrangements, a senior police official said.

The Amarnath pilgrims have been the subject of several terrorist attacks in the past.

Thirty-two people, including two dozen Amarnath pilgrims, were killed in a terror attack at the Nunwan base camp in August 2000, while 13 people were killed in another strike in July 2001 when the ultras struck at the Sheshnag base camp of the Yatra.

In 2002, terror struck at Chandanwari base camp, and 11 pilgrims were killed.

Reflecting on the significance of the meet, the Chief Minister said that there was a time when such Buyer-Seller Meets were not needed. "Tourists from across the globe would come to Kashmir and naturally become buyers. Today, through initiatives like this, we are trying to revive that connection-to bring the buyers back and reestablish the relationship between creators and customers.'

He emphasized that the event is not a one-off showcase.

"Under the scheme, we are committed to organizing six regular Buyer-Seller Meets and six reverse meets. These will ensure sustained engagement and provide deeper market access for our artisans and entrepreneurs." he said.

Underscoring the importance of inclusivity, the Chief Minister urged the Industries Department to prioritise artisans and entrepreneurs who have not yet had the opportunity to participate in such platforms, particularly those with limited financial means. "They have the skill and the product, but lack exposure. If we bring them into the fold, we can address many challenges related to marketing and reach," he said.

He further stressed that the real benefits of such initiatives must directly reach the artisans themselves.

"We must ensure that no one else takes credit or benefit for the work done by our craftspeople. The recognition and rewards must go to the actual creators," CM Omar Abdullah said

Calling for innovation and adaptation, the Chief Minister said that artisans need to modernise-not just in design and product development, but in processes and infrastructure as well. "Consumer tastes are constantly evolving, and if we remain rigid, we risk falling behind. The government is ready to extend every possible support-be it raw material banks, colour banks, or design innovation centres—to help our artisans compete effectively in international markets," he said.

Appreciating the participation of buyers and dignitaries, he said: "Your presence here is deeply encouraging-not only for us in the government but also for the artisans, entrepreneurs, and all others participating in this event. It gives us confidence and reaffirms that the direction we have taken is the right one.'

Reflecting on the journey and continued challenges, he added that while the past few years seem to have passed in the blink of an eye, many of our issues remain unresolved. "Our artisans have magic in their hands, and I urge all visitors to witness it at the exhibition stalls."

He noted that many of the exhibits are the result of years of dedicated craftsmanship.

"One piece I saw today took over three years to complete. Some stalls reflect the rich heritage we have inherited, while others account by NRPC secretariat.

JDF for the past two to three months and have agreed to form a platform that will work for the interests of the people," said Lone.

He said that the alliance comprises individuals who have endured pain and suffering in Kashmir over the past three decades.

'There are two types of people in J&K: those who were beaten and jailed, and those who inflicted that suffering. The latter have ruled Kashmir for the past 30 years," he said.

Speaking at the occasion, Shamim Ahmad Thokar, president of the Justice and Development Front-a political party established by Jamaat-e-Islami-affiliated candidates-said. "We cannot succeed alone. To serve the people effectively, we must unite. Our party will join this alternative alliance."

Peoples Democratic Front president Hakim Muhammad Yasin added that the alliance would fight for the restoration of Kashmiris' dignity.

The new coalition has the potential to become the primary opposition to the ruling NC-led alliance, particularly given the traditional vote base of the Peoples Conference and the JDF backed by JeI, which was a major political force in the Valley until the 1987 elections.

Yasin's PDF holds significant influence in the Khansahib area of Central Kashmir's Budgam district. With the Kashmir-based opposition parties in disarray after a humiliating defeat in the 2024 Assembly elections, this alliance could pose a serious challenge to the ruling bloc in future elections.

In their agenda, the alliance has said that they will fight for restoration of Article 370, 35A. and statehood.

The conglomerate has also called for amnesty for political prisoners and detained vouth.

It has termed the reservation as a regional issue, saying that it is being used as a tool to disempower Kashmiris. (KNO)

issued to the news agency–Kashmir News Observer (KNO), accompanied by Special DGP Coordination SJM Geelani, IGP Security J&K Sujit Kumar, DIGP SKR and other senior officers conducted an extensive field visit of key areas in and around Pahalgam along the Yatra route.

DGP inspected the Base Yatra Camps at Nunwan and Chandanwari and conducted the security audit and reviewed deployments and arrangements at these camp locations, ensuring that all logistics, infrastructure, and personnel were in place to facilitate a smooth and secure pilgrimage.

Additionally, a detailed security review meeting was chaired by DGP at Pahalgam, which was attended by the Senior Officers of Police, Army, the Pahalgam route, especially in the wake of the terror attack. "It will be our tribute to those who died there - this will be our pledge against terrorism." she said.

Nirohotum Kumar from Assam said the terror attack cannot deter them from undertaking the pilgrimage. "What happened in Pahalgam was tragic, but it cannot scare us. We are going to Baba with full faith. This is our yearly commitment. No one can instill fear of death in us." He said people should come in large numbers. "This will also boost the morale of our soldiers," he said.

Bighirath Sharma of Surat, part of a 30-member group including 25 from Kashi, said, "Do you see any fear among the people here? At least 30,000 people are standing here today just to collect tokens - and this is only the first day." "Such a huge crowd from all over the country is proof that no one is scared. In fact, this is a strong reply to terrorists - that we will not be afraid, we will not back down," Sharma said.

A large number of pilgrims hoping to undertake the Yatra had to return disappointed from Saraswati Dham after failing to get tokens for on-thespot registration to travel in the first batch for darshan of the ice lingam of Lord Shiva.

Joginder Singh of Uttar Pradesh, who waited in line for four hours along with his group of eight, said. "We felt deeply hurt at not getting tokens today. We wanted to start our Yatra from day one and have Baba's darshan." He criticised the limited quota of 2,000 tokens fixed for the day. "We waited in line for four hours but still didn't receive a token. A large number of people came today, and only 2,000 tokens were issued." He said the government should issue tokens for the next day as well, so people don't have to wait in lines repeatedly.

Some of those who waited for hours only to be told that the daily quota had ended raised slogans and were involved in scuffles with the police personnel deployed there.

Surendra Singh from Punjab said that it was unfair that even after waiting for five hours, they didn't receive a token for registration.

"The government should issue quotas for the second and third day to those already standing in line so that people don't have to return," he said.

Three registration centres - Vaishnavi Dham, Panchayat Bhawan and Mahajan Hall – will start functioning in Jammu for offline registration from Tuesday. Only pilgrims having tokens issued by the Shri Amarnathji Shrine Board will be enterin Kulgam district left eight pilgrims dead. (Agencies)

It also informed that filling of vacant posts under promotion quota is in process.

Besides, the department in the meeting also stated that the placement proposals of eligible PG Masters, Teachers as in-charge lecturers in different disciplines are being finalized for submission to the authorities.

"Around 1600 vacant posts of lecturers shall be filled in OPG mode by July-15-2025 for major subjects and rest by July-31-2025," reads the documents

About the referral of Non-Gazetted posts to JKSSB, the department informed that the proposal for referral of 727 non-teaching staff and 43 posts of MTS to JKSSB has been submitted to the Finance Department for obtaining Financial Concurrence.

It also said that the vacant General Line Teacher posts stand frozen in light of SAC decision in 2018. (KNO)

NRPC raises.....

Northern Regional Power Committee NRPC) and 54th Technical Co-ordination Committee (TCC) of NRPC held on May 30 reveals that the issue of non-payment of liabilities by J&K, on account of these charges, was discussed threadbare.

According to the record note of the meeting, the committee expressed concern over non-payment, stating that it was affecting payment to receivable entities of the Northern region.

"It is to be noted that non-receipt of payment from J&K leads to non-payment to the receivable entities of Northern Region," reads minutes of the meeting, a copy of which is in possession of news agency–Kashmir News Observer (KNO).

The issue of non-payment of these liabilities was repeatedly raised by the Northern Regional Load Despatch Centre (NRLDC) with J&K. "In this regard, NRLDC has already sent various communications to J&K. This agenda was also raised in special meeting with J&K on 06 Feb 2025 but there is no update about the payment. J&K representative kindly update the status and share the firm commitment date of the payment," the document states.

NRLDC is operating and maintaining the 'Northern Region Pool Account" for deviation charges, reactive energy charges and congestion charges in accordance with provisions under various CERC Regulations. As per Regulations, the concerned utilities are required to pay the indicated amounts within 10 days of issue of weekly energy

The rigorous inspections were carried out along the National Highway in Kathua district-a crucial transit zone for Yatris en route to the holy shrine.

The inspection drive, led by the Legal Metrology unit in Kathua, was aimed to ensure fair trade practices and strict compliance with the Legal Metrology Act, 2009. During the

inspections, several traders were found violating various provisions of the Legal Metrology Act/rules and were accordingly booked by the area inspectors and penalties amounting 1.40 lakh were imposed. to

The department emphasized that traders must strictly use certified weighing instruments and cautioned against short-weight sales, particularly involving commodities like sweets, bakery items, snacks, beverages and pre-packaged food products which witness high consumer demand during the pilgrimage season and the department stressed the need for transparency.

In an official hand-out, the Department urged the consumers to remain vigilant and thoroughly inspect prepackaged products for key labelling

Srinagar, June 30, KNT: **Five prominent petitioners** in the Article 370 case have written an open letter to Chief Justice of India B R Gavai, urging him to constitute a bench to adjudicate the constitutional validity of Jammu and Kashmir's loss of statehood and to set a concrete deadline for its restoration. Jammu and Kashmir and to be specific Kashmir has been a land where Shivism flowed and rituals and traditions of Shivate philosophy thrived. So, there are many Shiv temples and natural shrines and caves found in the length and breadth of Jammu and Kashmir and Shree Budda Amarnath temple in Poonch is one of the famous temples which is frequented by a large number of devotees especially on the auspicious days which are dedicated to Lord Shiva. Buddha Amarnath, also known as Swami Budda Amarnath Ji Mandir, is an ancient Hindu temple dedicated to Lord Shiva, located in the Poonch district of Jammu and Kashmir. It is situated in village Rajpura, near Mandi ,and is known for its scenic and natural beauty and also for natural white stone Shivlinga and annual Raksha Bandhan Mela [Budda Amarnath ji Mela]. The, temple is considered older than the Amarnath cave shrine in Kashmir. The temple is nestled in the Pir Panchal, mountain range, about 25 Kms northeast of Poonch city. It is located on the banks of sacred river Pulsata and pilgrims often bathe in it before entering the temple. The shrine is important for Hindus, with the legend stating that Lord Shiva narrated the secret of immortality = Amar Katha to Goddess Parvati here. It believed that this cave shrine Kashmir and hence the name" Buddha Amarnath. "The main attraction is the natural shivling of white stone inside the temple. A major festival, the Buddha Amarnath mela is held during Raksha Bandhan attracting thousands of devotees. The temple is known for communal harmony it fosters, with members of all communities participating in the arrangements for the yatra. The temple has four doors meaning that the temple is open for the people of all faiths and backgrounds. Poonch is the nearest major city, located 20kms from the temple. Many devotees undertake the yatra on foot, following a route that passes through picturesque landscapes. In essence, ,Buddha Amarnath is a significant pilgrimage site for Hindus, known for its natural beauty, religious importance, and the communal harmony surrounding the annual yatra. This holy place [Buddha Amarnath] has a great religious and spiritual importance for Hindus. As per Hindu mythology, at this very place, the Lord Shiva had started narrating the Amar Katha to Mata Parvati ji which ended at Swami Amarnath cave located near Pahalgam Kashmir. This temple is considered older than the Sawami Amarnathji of Kashmir. That is why the shrine is known as Swami Buddha Amarnath. As per Hindu mythology, one must visit this sacred place before performing the yatra of Amarnath in Kashmir. A number of legends are famous in and around Poonch city regarding the eruption of this ancient temple As per one legend, Mahatma Pulsat-the grandfather of king Ravana of Shri Lanka mediated at this place for a pretty long time. He was a devotee of Lord Shiva. There are

temple is older than even the Amarnath

a number of references in Neel Mat Puran about Pulsat Rishi. As per these references, ,Pulsat was also an artist and sculptor. He carved a number of images of God. One of the references in Neel Mat Puran says, "By seeing the Goddess erected by Pulsat, one is free from all sins and gets highest knowledge and the temple erected by him gives one's merit of the gift of cows and also releases from the diseases." Since the Pulsat was a great Rishi, a sculptor and very popular among the inhabitants of this area ,therefore ,after his death the people converted this small temple into a shrine .Later on ,this shrine was named as Swami Buddha Amarnath. Even now a number of idols of ancient times are available in this area. It is possible that these idols may have been installed by Pulsat Rishi. Swami Buddha Amarnath Yatra is a centuries old yatra. .However, it was regularized during Dogra rule of Raja Moti Singh and Jagat Dev Singh in between 1852 to 1939.Swami Buddha Amarnath temple is situated in between the main belt of Pir Panchal range in Rajpura Mandi which is 23 kms on the North East of Poonch town. The sacred place is located on the confluence of two gushing streams namely Nallah Gagri and Pulsat Nadi. This place is surrounded by snow bound lofty mountains, thick belt of forests in the eastern side, lush green pastures and crystal, clear streams and nallahs. The climate of this attractive and charming spot is very pleasant and cool. At present Swami Buddha Amarnath temple is connected with a motorable road and it is 244 kms away from Jammu The original temple has been constructed with one big stone. There are four doors in the temple on northern, south-

ern. eastern and western side which indicates that the doors of this shrine are open for all four varnas. There is a natural Shivling of white stone - chakmak inside the temple. A number of ancient idols collected from nearby villages are also installed in the premises of the temple where there used to be four holy springs near the temple in past. At present, the water of three springs has been diverted to fourth one which is on the southern side of the temple. The water of these springs is considered as holy from the religious point of view. The pilgrims first take bath in this spring and then enter in the temple for darshan and prayers. The procession of Chari Mubarak starts from Dashnami Akara Poonch amid chanting of bhajans and religious slogans. A guard of honour from police contingent is also paid to Chari Mubarak at the gate of akhara. The Swami ji is carried in a palki by the devotees, along with sacred mace. Thousands of devotees and hundreds of Sadhus accompanying the procession which leads towards Swami Buddha Amarnath on foot. Dedicated to Lord Shiva, the Buddha Amarnath temple in Rajpura village in Mandi Tehsil $of Poonch \, district is one \, of the \, oldest \, shrines$ of Jammu region and has been attracting devotees in large numbers during Buddha Amarnath Yatra every year. May Lord Shiva shower his blessings upon the people of Jammu and Kashmir so that militancy is eliminated for ever and people of various faiths live in harmony and brotherhood. Thathastuo. We hope so and in near future peace and normalcy will prevail in J&K and people will live like brothers.

Carts, Cries, And Crackdowns: The Untold Side Of Urban Clean-Ups

In cities across India, a common scene has become a symbol of silent conflict – municipal teams clearing roadside areas, while handcart owners watch their goods being taken away, damaged, or destroyed. These anti-encroachment drives, meant to maintain public order, often end up causing emotional and economic devastation for thousands who earn their living through street trading. It is a complex issue. On one hand, city authorities are doing their job – trying to ensure roads remain decongested and public spaces are safe. On the other hand, handcart owners, many of whom are poor and marginalized, have no designated space or licenses, and rely on their carts to survive. This is not just a question of law - it is a question of humanity, of inclusion, and of how we treat our weakest citizens.

The Role of Municipal Corporations: Duty With Dignity

Municipal corporations are not villains in this story. They have a duty to maintain cleanliness, safety, and urban order. Encroachment on footpaths, traffic bottlenecks, and sanitation issues are real concerns. No city can function if every space is taken over informally.

But while their duty is justified, the method often isn't. Throwing away someone's livelihood is not regulation — it feels like punishment. Instead of abrupt removal or destruction, authorities can choose measured steps: A National Picture: Data and Reality

The National Policy on Urban Street Vendors estimates that over 10 million families rely on informal cart-based trade.

A study in Delhi found that 70% of roadside sellers were evicted without any notice or paperwork.

What Actually Happens During These Drives

Municipal drives are often conducted as part of routine efforts to maintain cleanliness and order in public spaces. Officers, along with sanitation staff or local police, reach areas where roadside carts operate. However, due to the sudden nature of these drives, many cart-pullers — some just beginning their day — may find themselves unprepared, highlighting the need for better coordination and communication on both sides.

Some plead, some beg, others simply watch helplessly. "Please don't take this — this is for my children," they cry. But often, the response is swift and harsh. Carts are pushed aside, baskets of fruits dumped, stalls loaded into trucks. There are no formal receipts, no fines issued, and no clear explanation given. This sudden force turns daily work into devastation in minutes.

This method, while effective in clearing spaces, leaves behind broken livelihoods — and more importantly, damaged trust between citizens and the institutions meant to serve them.

Hardships of the Handcart Owners

Most handcart owners are informal workers with no stable income, fixed space, or official identity. They push heavy carts over long distances, carry perishable goods, and sit under harsh weather conditions for 10–14 hours a day. Their investment is small — a few thousand rupees — but it's often all they have.

A fruit seller in Jammu said, "I don't block the road. I just stand in a corner to earn my daily bread. But one morning, they threw my bananas into the drain. I cried not because I lost money — I cried because I felt invisible."

Their stories are not uncommon — and neither are their struggles. Most of them have no access to formal vending zones, licensing systems, or legal awareness.

- Issue warningsImpose fines
- Seize goods temporarily
- Identify repeat offenders separately
- Provide vending alternatives where possible
- This way, order is maintained without cruelty.

Even some officials agree that a more balanced approach is needed. "We understand their pain," said a senior Jammu Municipal official. "But the city has to function. We are ready to cooperate if handcart owners come forward for registration and follow rules."

Urban planners too have voiced the need for more compassion. Prof. Neeraj Sharma, an expert on inclusive cities, says, "Street-level earners are part of urban India. Ignoring them or crushing them is not development — it's displacement. We need co-existence strategies, not confrontation."

Real Examples From Across India Jammu (January 2025)

Over 100 street vendors and shopkeepers staged a protest outside the residence of former CM Farooq Abdullah after the Jammu Municipal Corporation conducted a major anti-encroachment drive. The vendors alleged their goods were confiscated without warning and demanded an immediate halt to the operation.

Srinagar (January 28, 2022)

During a Srinagar Municipal Corporation (SMC) drive at Jahangir Chowk and Hari Singh High Street, several street vendors had their carts forcefully seized or vandalized. Multiple videos went viral showing vendors screaming:

"Look how they are snatching our livelihood, where will we go? I've a family to feed."

"I'm a father of four girls... please don't do this, where will I go?"

Nagpur, Maharashtra (May 2025)

The Sitabuldi hawking zone, used by around 1,000 vendors, was cleared in an anti-encroachment drive. Licensed hawkers were relocated to areas with poor footfall, with allegations that many returned after paying bribes Ranchi, Jharkhand (June 2025)

Over 100 vendors were evicted from major public roads. Though officials claimed prior warning, traders—including Ram Avadhesh and Rekha Mandal—argued they were given no viable alternatives.

Guwahati, Assam (June 2025)

Street vendors in Ganeshguri, Bhangagarh, and Jalukbari faced repeated evictions. Despite fines (up to ₹10,000) or confiscation, many returned within days pointing to the cyclical nature of these drives . stitution."

Yes, Cities Need Development — But It Must Be Inclusive

There's no question that urban areas must be organized. Public walkways must be free, traffic must move smoothly, and sanitation must be ensured. But in the process, we cannot erase people — especially those who rely on informal work for survival.

Development is not just about removing the poor – it's about including them with dignity. Simply throwing their belongings away doesn't eliminate the problem – it deepens inequality, and pushes them into debt, depression, and distrust.

If a cart is illegal or in the wrong place, seize it, fine it – but do not humiliate the person behind it. Create clear policies, provide designated vending spaces, and let people earn with self-respect.

Solutions That Serve All

We need a new approach that protects both public order and the right to livelihood:

- Establish vending zones with proper facilities
- Create transparent licensing systems
- Give prior written notices before action
- Train municipal staff in humane enforcement
- Provide low-cost stalls or carts on rent
- Set up grievance cells for street workers
- Let handcart owners be seen as part of the economy not a problem to be erased.

- Fast-track implementation of Town Vending Committees (TVCs)
- Launch mobile registration and ID drives for cart-based traders
- Include informal earners in Smart Cities Mission planning
- Partner with NGOs for rehabilitation and alternate site planning

A City That Cares is a City That Grows

Urban development is necessary. But it must be done with care, consultation, and compassion. We cannot build smart cities by breaking the backs of those who serve us through the most basic forms of trade.

Let us create spaces for them — not sweep them away. Let us impose rules — not cruelty. Let us regulate — not ruin. Because in the end, no city is truly developed if its poorest are left behind on the footpaths of silence.


With the emergence of new female writers, the way their body, age and smile are traded in the literary markets instead of their creativity is a deep and shameful truth. Stage, criticism, role, respect - everything becomes a trap. This editorial shows the mirror to the hypocritical system running in the name of women's writing, where the writer's 'presence' sells more than her pen. Now the time has come for the literary world to recognize this internal exploitation and muster the courage to change it.

As soon as a new writer enters the literary arena, a festive atmosphere is created. She has come with a pen – to give life to words, to share experiences and to give voice to feelings. But is the power of words alone enough to survive in this world?

No. In this market, one looks at one's face before one's writing. One asks about one's age before one's book. One's speech and smile are discussed before one's thoughts. And unfortunately, this is the point where the dark truth of the literary field emerges.

erative', and 'rude'.

This market of literature has become the graveyard of that intellectual freedom, which many women dream of when they take up their pens. New writers get silence, not a platform. They get doubts, not support. There is an attempt to find the intention behind every word of hers - "For whom did you write?", "On whose advice?", "With what intention?"

This is the same society which on one hand writes columns in newspapers on the 'Me Too' movement, and on the other hand is ready to call young female writers in isolation at literary conferences and give them "personal guidance".

This mindset has not only crushed new talents but has also shattered women's faith in literature. Those who were supposed to make the world of writing their home find the doors closed for them - if they do not 'compromise'.

History is witness to this - writers like Amrita Pritam, Mahadevi Varma, Mannu Bhandari, Mrinal Pandey, Vandana Raga not only used their pens but also wrote against the patriarchy that had made its home in the literary world. They watered this path with struggles and left a consciousness for the coming generations.

But the question still remains - why even today does a new female writer have to stay silent or fight to protect her dignity? Why does 'women's writing' still remain an 'easy target' for senior male writers?

Many times, attempts are made to mould the writing style of a female writer according to the male norms. "Write less aggressively, be more sensitive, romantic poems are appreciated more" - these are the advices of the 'gurus' who teach new names. But the truth is that this is not a demand for 'conformity', but 'persuasion'.

There is another aspect to this - when a female writer becomes successful. the credit for her success is given to her 'male mentor'. As if her talent was not her own, but was acquired through someone's 'contacts' and 'patronage'.

And when she denies these things - it is not her poems that are reviewed, but her character. This double standard has become the backbone of this market. Now there is a need to question this

system.

Now there is a need for every new writer to write in her poem, "I am not a rose that has bloomed just to decorate - I am that thorn that will tear apart your intentions."

Writers need to be each other's voice. More than sharing a stage, they need to share a space – where they listen to each other, support each other, and never leave anyone alone.

Publishers, editors, organisers - now there is a warning for you too. If you do not clean up your policies, these pens will write your name not with ink but with fire.

This market, which was once a market of ideas, has today become a bazaar - where 'female presence' is sold, not 'writing'.

Let us now take a closer look at where this waste originates and what it consists of. Biomedical waste doesn't just come from hospitals – it is generated across a wide range of healthcare settings, from large medical institutions to small clinics and even home-based care. Depending on the type of facility and the nature of medical procedures performed, the volume and kind of waste can vary greatly. In this article, we will explore the primary and secondary sources of biomedical waste and examine its key components, some of which pose serious health and environmental risks.

As mentioned, biomedical waste originates from a variety of healthcare settings, which can be broadly classified into two categories: primary and secondary sources. The primary sources include private and government general hospitals, maternity hospitals, clinics of general practitioners, medical colleges, veterinary colleges and hospitals, blood banks, pathology labs, animal houses affiliated with research labs (mostly located in pharmaceutical industries), etc. Blood donation camps, dental clinics, domestic healthcare practices, primary healthcare centers, educational institutions, industrial healthcare centres, AYUSH hospitals, etc., are considered secondary sources. The type and quantity of the waste depend on the sources of generation.

Composition of biomedical waste

Waste generated in healthcare centers is broadly divided into hazardous and infectious waste and non-infectious or general waste. Infectious waste is further categorised into the following four major categories:

Human anatomical and pathological waste: This accounts for only a small fraction, comprising about 10-15 per cent of the total waste generated in a hospital. However, this small fraction is of the biggest concern, as it poses a direct threat to the health and hygiene of human beings by transmitting viral, bacterial, fungal, or parasitic diseases. This type of waste includes internal organs such as appendices, tumours, glands, and tissues. It also includes any other organs removed during surgery, biopsy, or other medical procedures. Body parts like legs or hands that are partially or completely amputated are included. The placenta removed during childbirth is part of this waste. Aborted foetuses are also included.

Blood and other body fluids fall under this category. Animal carcasses and tissues from laboratories are part of this waste as well. Used dressings and cotton swabs soaked in blood or body fluids are included. Hospital gowns, aprons, and other similar materials also form part of this waste. In short, any material that has been

in experiments or testing in veterinary hospitals or colleges, or animal houses in pharma industries, also belong to this category.

Plastic waste: The use of plastic articles for treatment purposes has become very common in hospitals, not only in India but all over the world. Disposable plastic items used in hospitals are generally made from high-quality, sterilised plastics like polypropylene, high-density polyethylene (HDPE), and PVC, which are ideal for their strength, flexibility, durability, etc. These articles are also ideal for maintaining sterility. Thus offering crucial benefits like infection control and ease of use. However, they also contribute significantly to medical waste, accounting for about 25 per cent to 30 per cent of the total volume. These articles include syringes, IV sets, and tubing used for intravenous administration of medicines; gloves; catheters; endotracheal tubes; cannulas; dialysis sets; blood and urine bags, etc. Most of the syringes are either for intramuscular or hypodermic injections to inject medicine into the body.

Metal Sharps: Waste Sharps, including metals, needles, syringes with fixed needles, needles from needle tip cutters or burners, scalpels, blades, or any other contaminated sharp object that may cause punctures and cuts. This includes used, discarded, and contaminated metal sharps.

Glass: Broken or discarded and contaminated glass, including medicine vials and ampoules, except those contaminated with cytotoxic wastes.

Governance in J&K suffers under dual control: Karra Says Congress committed to statehood

Kupwara, Jun 30 (KNO): Jammu and Kashmir Pradesh Congress Committee (JKPCC) President Tariq Hameed Karra on Monday voiced serious concern over the prevailing administrative setup in Jammu and Kashmir, calling the dual control system 'deeply disturbing' for the entire governance.

Speaking at a workers' convention in north Kashmir's Kupwara district, Karra, as per the news agency-Kashmir News Observer (KNO), said that not only was the existing arrangement getting disturbed due to the dual control system, but it was also coming as a hindrance to the spirit of alliance.

"The way the LG administration is functioning, it seems unwilling to cede even a minimal share of authority or even the government, which may be trying to take beyond the due share of authority. The ultimate casualty is the common people of I&K." Karra said.

Responding to media buzz about a new political front being floated in Jammu and

Kashmir, Karra said that the Indian National Congress remains committed to the INDIA alliance, which includes the PDP and NC, and that he has no knowledge regarding any new political formation.

He further rejected the notion that coalition partners need to always appear together in public or contest elections jointly. "Congress and the National Conference fought the elections based on their manifestos. Every party is accountable to its own voters," he said.

Karra said the restoration of statehood to Jammu and Kashmir remains the central demand of the Congress. He slammed the Centre for not delivering on its repeated promises. "Since August 5, 2019, we have heard promise after promise, in Parliament, on stage, and during visits to the Valley, but not one of those assurances has materialised," he said.

He accused the government of shifting the goalposts, from delimitation to elections, while keeping the people in a state of uncertainty. "This is not just a political demand. Statehood is our constitutional right," he said.

NC exposes failure of LG Admin in utilisation of development funds: Rattan Lal Gupta

Jammu, June 30: Advocate Rattan Lal Gupta, Provincial President of Jammu and Kashmir National Conference, has raised serious concern over the failure of the LG administration in utilising funds meant for the development as well as the construction of underground bunkers in border areas, as revealed through a recent RTI. He shocked over utilization of only 53% of the central funds allocated over the past five years have been spent under the LG led administration, which is a matter of serious concern considering the grave threat to civilians during frequent crossborder shelling incidents.

In a press release issued here today, the senior NC leader said the negligence of the administration has once

again exposed its disconnect from ground realities. "Despite receiving generous financial support from the Centre, the LG-led dispensation has failed to implement even the most critical safety measures for border residents. This is not just a case of financial mismanagement but also of criminal neglect towards the lives of people living along the International Border and LoC," he said.

Taking a strong dig at the LG administration, Rattan Lal said that no real development has taken place in the last 10 years under the BJP regime in J&K as most of the funds under vital social welfare schemes have either lapsed or remained unutilised. "From rural development to youth welfare, from health to infrastructure - every sector has been ignored. The administration has mastered the art of

photo-ops and announcements. but the people on the ground continue to suffer," he added.

The Senior NC leader further pointed out that even after the formation of the popular government led by Omar Abdullah, the LG administration is acting as a parallel power centre and deliberately creating hurdles in the smooth functioning of the elected government. "This is unacceptable in a democratic setup. If the Centre claims to have restored normalcy, then it must also allow the elected representatives to function without any interference," he said.

Rattan Lal Gupta reiterated the urgent need for restoring full statehood to Jammu and Kashmir, asserting that statehood is a constitutional right of the people and must not be delayed any further.

PM Modi to attend 17th BRICS Summit in Rio De Janeiro as India to hold chair of BRICS next year

UNITED NEWS OF INDIA New Delhi, June 30

With India set to hold the chair of BRICS next year, Prime Minister Narendra Modi's upcoming visit to Rio De Janeiro, Brazil for the 17th BRICS Summit, holds even more significance.

The BRICS Summit is taking place on July 6 and 7. Prime Minister Modi will arrive in Brazil the July 5 evening, to attend the main programme, which is on July 6.

The theme of the Rio Summit is Strengthening Global South Cooperation for Inclusive and Sustainable Governance. The program on July 6 includes the first agenda item, the Reform of the Global Governance, where only the full BRICS members will participate. And thereafter, there is the second item on the agenda, the Peace and Security, in a working lunch format, where the leaders will discuss the agenda item. Leaders' statements will be issued later.

The BRICS has 10 full members and 12 partner countries, as well as eight invited countries at the Head of State, Government level, and seven heads of regional and multilateral bodies

Post-lunch, the third item on the agenda is the Strengthening Multilateralism, Economic Financial Affairs, and Artificial Intelligence. Later there will be an official reception



and all the leaders will be participating. On July 7, the fourth item of the agenda is environment, COP30, and Global Health. Brazil will also be hosting COP30 in November this year."As you know, the BRICS process is led by the Chair and they set the agenda, but the decisions are in a consensus-based format. We are hopeful that there will be four deliverables, although discussions are continuing still at the Sherpa and the Sous-Sherpa level.

"The leaders' declaration, the leaders' statement on glob-

al governance and artificial intelligence, the leaders' framework declaration on climate finance, and BRICS partnership for elimination of socially determined diseases," said Secretary ER Dammu Ravi, at a briefing today."There will also be in addition four reports that will be submitted to the leaders. One, the deliberations that happen during the National Security Advisors level, the Business Council meetings that would have happened before that, the Women's Business Alliance report, and the civil council report," he added.On the bilateral front, Prime Minister Modi during the state visit to Brasilia on July 8, is scheduled to hold bilateral talks with President Lula. He will be accorded a ceremonial welcome on arrival, followed by a restricted meeting and a delegation-level format talks, culminating with a lunch hosted by President Lula for Prime Minister Modi.Prime Minister has earlier visited Brazil on three occasions, the first in July 2014, followed by another visit in 2019 to attend the BRICS summit. and in November last year to attend the G20 summit in Rio de Janeiro."The state visit will provide an opportunity to review the entire gamut of our partnership, including trade and investments, oil and gas, renewable energy, mining and critical minerals, defense and security, agriculture and livestock, healthcare and traditional medicine.

"May the injured recover soon," he added.

An ex-gratia of Rs 2 lakh each from the Prime Minister's National Relief Fund (PMNRF) will be provided to the next of kin of those who died in the incident. Those injured will receive Rs 50,000, said the statement from the Government. Six people were killed and 20 others



injured, some of them critically, following an explosion in a chemical reactor at a factory in the Pashamylaram industrial area of Sangareddy district in Telangana thismorning. According to police, the explosion occurred at Sigachi Industries, triggering a massive fire that engulfed parts of the facility.

BJP alleges INDI Bloc promoting 'Namazwad', undermining constitutional values

The Bhartiya Janata Party (BJP) on Monday launched a sharp attack on the Opposition INDI Alliance, alleging that its parties like the RJD and Samajwadi party were attempting to promote what he termed as "Namazwad"—a religiously motivated deviation from constitutional principles-and accused them of undermining the legacy of BR Ambedkar. Addressing a press briefing, Senior BJP leader Sudhanshu Trivedi claimed that there is "no mention of the concept of Waqf in the Quran, attributing it to interpretations developed by clerics. He further said the Quran encourages voluntary giving, not institutional religious control, and warned that opposition parties are attempting to "con-



vert Samajwad (socialism) into Namazwad."

"If their government comeswhich is not going to happenthey will throw Baba Saheb Ambedkar's Constitution in the dustbin and implement Sharia law," the BJP Rajya Sabha MPP said.

"They are bowing before mullahs and maulavis to pursue hardline vote bank politics. Be it the Congress, the RJD, or the Samajwadi Party-they are all driven by a thirst for votes from fundamentalist sections," he

alleged.

Trivedi also revisited the Shah Bano case of 1985, accusing the Congress of having previously placed personal law above constitutional supremacy by enacting legislation that effectively overruled a Supreme Court judgment in favour of Muslim women's rights. He suggested that such precedents demonstrate the Congress's historical willingness to appease conservative religious sentiments at the expense of legal uniformity. Reinforcing his party's stance, Trivedi said the BJP remains committed to preserving the values enshrined in the Constitution, adding that voters must choose between "a government that respects Ambedkar's vision" and one that "seeks to impose religious law through the backdoor."

India, Bhutan hold **Development Cooperation** Talks, review progress in implementation of approved projects

India and Bhutan held their Development Cooperation Talks in New Delhi today, during which they reviewed the progress in implementation of the projects approved in previous rounds.

The Indian side conveyed that it will continue to work together with the Royal Government of Bhutan on its development agenda, in line with the shared vision of His Majesty the King of Bhutan and Prime Minister of India, and based on the priorities of the Royal Government and the people of Bhutan.

The Indian delegation was led by Secretary (West) Tanmaya Lal, and the Bhutanese delegation was led by Foreign Secretary of Bhutan Aum Pema Choden.

India and Bhutan share an exemplary partnership characterised by trust, goodwill, mutual understanding at all levels, and strong bonds of friendship and close people-to-people ties. The Development Cooperation Talks are an important bilateral mechanism to review the full spectrum of India-Bhutan development partnership, a statement said.

Government of India (GoI) has committed support of INR/Nu. 10,000 Crore (100 billion) for Bhutan's 13th Five Year Plan period (2024-2029) which would cover Project Tied Assistance (PTA) projects, High Impact Community Development Projects (HICDP), support for Economic Stimulus Programme (ESP) and budgetary support in the form of Programme Grant. During the Talks, the two sides discussed various components of the support and reviewed the progress in implementation of the projects approved in previous rounds.

A total of 61 Project Tied Assistance projects amounting to INR/Nu 4958 crores (49.58 billion) and 283 HICDPs amounting to INR/Nu417 crores (4.17 billion) covering a wide range of sectors are in various stages of implementation. Both sides agreed to make suitable revisions to the allocations for some of the PTA projects taking into account the evolving requirements.

Assam Chief Minister Himanta Biswa Sarma has said that the government will make the Aadhar issuance for adults stricter in a few days with the exception of the tea garden population.

The Chief Minister said this on his X handle today and added that the move is being done to ensure that no infiltrator can legally obtain the card and disturb India's harmony.

"Infiltrator Mukt Assam is our goal and we will NOT STOP till it is attained," Sarma said on his X handle.

"We are adopting a multipronged strategy to detect illegal immigrants--regulating Aadhar issuance via DCs is just



one step we are taking in this direction," Sarma said on his X handle.

"Almost all the adult population in Assam have already obtained an Aadhar card. Whoever gets birth, young people, kids etc. they will require Aadhar cards. But suddenly if a 50 year old male comes and asks for an Aadhar card, then it raises questions. Henceforth for adult people Aadhar will be issued only after the satisfaction of the District Commissioner. So far it was issued by the SDC office, now we are making it a little tougher. The issuance will be after specific satisfaction of the District Commissioner," said Sarma.

The Chief Minister however, said that the government is also making an exception for the tea garden population where almost 50000 adult people are yet to get Aadhar cards. The Chief Minister's statement came recently after the issue was discussed in the state cabinet last week.

2019 triple murder in Sandeshkhali

Amid the ongoing controversy surrounding the law college gang-rape case - in which students allegedly linked to the ruling Trinamool Congress are involved - the West Bengal government faced further embarrassment today as the Calcutta High Court ordered a CBI probe into the murder of three BJP workers in Sandeshkhali, North 24 Parganas district that happened six years ago. The murders, allegedly committed in 2019, had links to Shahjahan Sheikh, who has since been suspended from the Trinamool Congress.Justice Joy Sengupta of the High Court passed the order, directing the Central Bureau of Investigation to form a Special Investigation Team (SIT) to handle the case.On June 8, 2019, residents of Sandeshkhali – Pradeep Mondal, Debdas Mondal, and Sukanta Mondal – were allegedly murdered.

Iran could again begin enriching uranium within months: IAEA Chief Grossi

UNITED NEWS OF INDIA Vienna, June 30

Rafael Grossi, chief of the International Atomic Energy Agency (IAEA), said that while the US strikes have caused massive damage to the Iranian nuclear sites, they didn't fully destroy them, potentially enabling Tehran to proceed with enriching uranium in "just a matter of months". Grossi's statement directly contradicts the stance of US President Donald Trump, who had said that the Iranian nuclear project was pushed back by decades, while Israeli Prime Minister Benjamin Netanyahu said that the centrifuges at Fordo, Natanz, and Isfahan were severely damaged, pushing the program by several years, CBS News reported.

In an interview with the media agency's 'Face the



Nation with Margaret Brennan' programme, the IAEA chief, giving his stance on the varying assessments said "This hourglass approach in weapons of mass destruction is not a good idea.

'The capacities they have are there. They can have, you know, in a matter of months, I would

sav. a few cascades of centrifuges spinning and producing enriched uranium, or less than that. But as I said, frankly speaking, one cannot claim that everything has disappeared and there is nothing there."

Grossi added that while the watchdog group's investigations did not hint at a nuclear weapons program, the uranium enrichment was way beyond needed for civilian use. The situation was further made complicated by Tehran's refusal to answer some "very important questions."

Verifying Grossi's statement of severe damage on Iranian facilities, a US official told CNN "As Rafael Grossi said just days ago, the difference between Iran's nuclear program before and after Operation Midnight Hammer is 'night and day,' and a 'very serious level of damage' was done.



Dhoni's Application To Trademark 'Captain Cool' **Gets Accepted**

MUMBAI: MS Dhoni's application to trademark the phrase 'Captain Cool' - a moniker long associated with him because of his calm on-field demeanour - has been officially accepted and published by the Trademark Registry of India.

The trademark will be granted if no objection or opposition is raised by any third party within 120 days of its acceptance, which was on June 16, 2025. The trademark was filed under categories related to sports training, coaching, and the provision of sports training facilities and services.

Dhoni had filed the application in June 2023. He was informed at the time by the registry that another company, Prabha Skill Sports (OPC) Private Limited, had already registered the trademark 'Captain Cool'. In response, Dhoni filed a rectification petition for the cited mark, alleging that the company was attempting to exploit his brand and the popularity of the term.

In his application, Dhoni stated: "This is

a case of bad faith registration on the part of the company, aimed at deceiving the public and unlawfully enriching themselves by trading on the name of a well-known individual." Dhoni's application was accepted after at least four hearings.

Dhoni was last seen in action during IPL 2025, where he took over the Chennai Super Kings' captaincy midway through the season after Ruturaj Gaikwad suffered an injury. CSK endured a disappointing campaign, finishing at the bottom of the table for the first time in 16 seasons.

Earlier this month, Dhoni was inducted into the ICC Hall of Fame. "It is an honour to be named in the ICC Hall of Fame, which recognises the contributions of cricketers across generations and from all over the world," Dhoni said in a statement. "To have your name remembered alongside such all-time greats is a wonderful feeling. It is something that I will cherish forever."

Dhoni, who will turn 44 this July, has kept his options open with regard to returning for another IPL season.
