# Discrimination in Naib Tehsildar Exam: NDA Demands Equal Language Rights for Jammu Youth

**JAMMU, JULY 11:** Nations Development Association (NDA), Chief Functionary Sushil Singh Charak has made a strong representation to Hon'ble Chief Minister Janab Omar Abdullah, highlighting the issue of the mandatory Urdu language requirement in the Naib Tehsildar recruitment exam, which is causing distress among aspirants from the Jammu Division.

# Charak pointed out that the

majority of youth from Jammu do not study Urdu, rendering them ineligible under the current recruitment criteria. He criticized the policy as exclusionary and called for recruitment exams to be conducted in multiple regional languages to ensure broader participation. He cited The Jammu and KashmirOfficial Languages Act, 2020 (Act No.23 of 2020), passed by Parliament, which recognizes Urdu, Hindi, Dogri,



Kashmiri, and English as official languagesof the Union Territory. Restricting exams to Urdu alone, he stated, goes against the inclusive intent of the Act. Charak appealed to the Chief Minister to uphold the principles of fairness and inclusivity by revising the language criteria and eliminating regional bias in recruitment processes, thereby ensuring equal opportunity for all youth across Jammu and Kashmir.

He added that J&K has achieved 99% institutional deliveries in 2024-25 and Infant Mortality Rate (IMR) has significantly dropped from 16 to 14 as per SRS 2022 Bulletin, which is better than the national average of 26 per 1000 live births. As per HMIS data 2024-25, IMR has been recorded as 9.35 per 1000 live births, he reiterated. While giving the account of achievements, MDNHMBaseer-Ul-Haq Chaudhary informed that 86% of Ayushman Arogya Mandirs (AAMs) are operational in J&K. Additionally, he informed the meeting that the number of free drugs had been increased from 23 to 96 at SHC-AAMs and from 71 to 175 at PHC-AAMs during FY 2024-25. Free diagnostic services have also been expanded resulting in 242.75 lakh OPD evaluations at these health facilities from 2023 till date. Moreover, it was revealed that Rashtriya Bal Swasthya Karyakarm (RBSK) teams regularly conduct screenings in schools and Anganwadi Centres, with 91% of targeted beneficiaries (0-18 years) screened in 2024-25. In addition, 9.35 lakh patients have received tele-consultation services from FY 2023-24 to June 2025 and over 103,396 calls have been received by the Tele-MANAS unit established at IMHANS. It was revealed that 489 ambulances are operational under the 102-108 Ambulance Service. Also 10,164 (90%) ASHAs have qualified for NIOS certification, which is the highest in the country. Regarding the status of critical infrastructure raised under PM-ABHIM, the meeting was apprised that 10 Critical Care Blocks (CCBs) besides 20 Integrated Public Health Labs (IPHLs) and 287 Block Public Health Units (BPHUs) have been raised under this flagship programme. It was said that the projects to the tune of Rs 512.00 crore have been allotted to HSCC (India) Ltd for execution across the UT. More than 200 works have been awarded and 150 works have started in the last couple of months under this programme across the districts of the UT.

According to figures, today's pilgrims included 12,838 males, 4,343 females, 223 children, 141 sadhus, 8 sadhvis, and 2 transgender devotees. 455 security personnel also had darshan at the shrine.

With this, the total number of pilgrims who have paid obeisance since the beginning of the yatra on July 3 has reached 1,63,726.

Officials said that the pilgrimage continues under a multi-tier security grid, with roundthe-clock monitoring, medical support, and rescue teams in place to facilitate a safe and smooth yatra for the devotees.

In line with the government's commitment to equitable health access, Dulloo reiterated that no Primary Health Centre or Sub-Centre especially in remote and hilly areas should be left without doctors or requisite paramedical staff. He emphasized the need to fill vacant positions and deploy staff strategically to serve the underserved populations.

Taking stock of the critical care infrastructure being developed under PM-ABHIM, the Chief Secretary reviewed the status and timelines of various projects in the districts. He called for expedited completion of all ongoing works, urging the officials to meet deadlines without compromising on quality.

SRINAGAR, JULY 11 – In a major boost to expand the pool of trained human resource, Indian Institute of Carpet Technology (IICT), Srinagar, under the aegis of Handicrafts and Handloom Department, Kashmir, has master trained around 11,000 carpet weavers from different districts, under various skill development programmes.

The weavers have been trained on modified carpet looms which shall go a long way in penetrating niche markets for the famed hand-knotted carpets, which

"This face-to-face interaction and training shall go a long way in safeguarding the rare skill of weaving intricate hand-knotted carpets, which have a huge export market, both within

The exports of hand-knotted carpets from Kashmir have touched 838.70 crore in the last three financial years, despite challenges due to global conflicts which have affected markets in Middle East and other destinations.

In order to make the training programmes more attractive for trainees, IICT also provides monthly stipend as per Scheme Guidelines. "The stipend for these short-term training programmes of 4-6 months' duration with intake capacity of 20, ranges from 1000 to 3750 per month under various skill-based schemes

of Ministry of Textiles," he added.

The training programmes include Skill Upgradation and Capacity Building Training & Short-Term Training Programmes of the Ministry of Textiles and Skill Development Training Programme of Ministry of Social Justice and Empowerment.

The Director also stated that under the Guru-Shishya Hastshilp Programme, the services of National Awardees shall be availed to provide skill upgradation training to registered carpet weavers. "Under this 2-month training programme, each trainee shall be provided a stipend of 7500 per month," he stated.

We laugh at jokes while anxiety

claws at our chest. We attend family dinners while depression quietly devours our joy.

We excel in school or work while carrying the weight of past trauma.

And we do all of this because society told us that talking about what hurts inside is too much, too awkward, too "attention-seeking."And so, they go silent.

#### The Price of these Whispers:

But this silence comes at a cost, one that's often irreversible. Every time someone is told to "get over it,"

Every time someone is asked, "Why are you sad when you have everything?"

"You're just overthinking." "You're too sensitive." "Don't be dramatic."

This is why suicide rates continue to climb. This is why young people with

anxiety feel "crazy." This is why so many suffer silent-

ly, smiling by day and breaking by night.

#### Let the Whispers Become Voices

Healing begins with honesty. With the courage to say, "I'm struggling."

With the strength to listen to someone else's story without flinching.Because behind every whisper is a soul waiting to be heard.

And every soul deserves to be seen, held, and healed. It is time to unlearn what we were taught. Let us normalize going to therapy as easily as going to a doctor. Let us raise our children with emotional literacy, not shame. Every journey has a purpose; every road has a price — What comes for free can sometimes cost the

most. A few months ago, the Jammu and Kashmir government launched a much-talked-about free bus service for women — a move that many celebrated as progressive and empowering. For a region where mobility and safety for women have always been important issues, this step was seen as a milestone. However, like many well-intentioned welfare schemes, this one too deserves a closer look to understand its ground reality and long-term impact.

#### A Personal Experience

As a regular commuter who has mostly relied on government buses, I have always appreciated their relatively better service and comfort, even if the fare was slightly higher than that of local minibuses. After a tiring day at work, a guaranteed seat and a smoother ride make all the difference.

But since the introduction of the free bus service for women, this comfort has become rare. The buses are now packed beyond capacity. Finding a seat is next to impossible — and when a woman is seen standing, any man with a conscience feels morally compelled to vacate his seat.

What's more, many of the new users are employed women with decent salaries who previously used their own vehicles but now naturally prefer the free ride. As a result, the system is overloaded, leaving genuinely needy passengers – daily wage workers, students, the elderly – struggling for space and comfort. As a regular commuter who has mostly relied on government buses, I have always appreciated their relatively better service and comfort, even if the fare was slightly higher than that of local minibuses. After a tiring day at work, a guaranteed seat and a smoother ride make all the difference

While the aim was to support women who need financial relief, the reality is that the biggest beneficiaries are salaried employees and middle-class commuters who can easily afford the fare. Meanwhile, women in remote areas or those who depend on local shared transport have seen little to no benefit, because government buses do not cover every village or interior route.

#### More Pressure, Less Productivity

In many government offices and institutions, it's now common to see women employees arriving late more often. Overcrowded buses, unpredictable schedules, and over-reliance on the free service have made punctuality suffer. This unspoken cost – reduced productivity – is hardly ever discussed when we talk about the success of such welfare schemes.

#### Financial Burden on the Transport Department

Free travel does not mean free service. Operational costs — fuel, maintenance, staff salaries remain unchanged or even increase due to higher usage. The revenue loss has to be covered somehow — and it usually comes from taxpayers' money or by cutting funds from other areas in need. Over time, this can burden an already stretched transport department, leading to poorer services for everyone.

#### What Could Be Better?

Nobody questions the intention behind the scheme. Women's safety and mobility must be

strengthened. But we must also ask: Is this the most effective way? Instead of completely free rides, a subsidized fare could have ensured affordability without draining the department's finances. Or perhaps the same money could have been used to improve bus frequency, extend routes to remote areas, or invest in better infrastructure.

Some even argue that spending on uninterrupted power supply or subsidies for essential household items would benefit entire families, not just a segment of daily commuters.

#### Bottom line

Good governance is not just about launching popular schemes — it is about listening, observing, and course-correcting. Any welfare programme must evolve with honest feedback from the people it affects the most. Free bus travel might bring smiles today, but unchecked overcrowding, financial stress, and poor service tomorrow can wipe them out. Because in the end, everything comes at a cost — nothing is truly free. The price might not show up in the bus fare, but it surely appears elsewhere — in quality, efficiency, or sustainability.

The real measure of progress is not how much we can give away for free, but how wisely we spend public money so that relief reaches those who truly need it — without overburdening systems or compromising on quality. The same money could have improved bus frequency, extended routes to far-flung areas, or supported subsidies on electricity or household essentials — benefiting entire families, not just daily commuters.

In the end, a welfare state must strike a balance: thoughtful intentions must meet practical, sustainable execution. Only then can we call it real empowerment.

The comfort that comes for free often hides a heavier cost.

# Mayawati May Join Hands with Azam and Owaisi

As the 2027 Uttar Pradesh Assembly elections draw closer, political equations in the state are beginning to shift. Mayawati, who has long been the central figure of the Dalit vote bank, is now working on a strategy to attract Muslim votes. Meanwhile, discussions are gaining momentum about senior Samajwadi Party (SP) leader Azam Khan moving closer to the Bahujan Samaj Party (BSP). This development could pose a political challenge for SP chief Akhilesh Yadav, as his party relies heavily on Muslim and Yadav voters.

After witnessing BSP's poor performance in the 2024 Lok Sabha elections, Mayawati has altered her strategy. Her party, once the sole voice of Dalits, is now reduced to just one MLA. In this scenario, Mayawati is exploring old alliances to woo Muslim voters once again. Reports of Azam Khan, a senior SP leader and prominent Muslim face, leaning towards BSP are a strong indication in this direction. The growing distance of Azam and his son Abdullah Azam from the SP, along with their meetings with Chandrashekhar Azad's party (MP from Nagina), have become a topic of political discussion.

Azam Khan's tilt towards BSP could pose a multi-pronged threat to Akhilesh. The Muslim vote bank, which forms about 20% of the electorate, has been a significant strength for SP. However, losing a powerful leader like Azam could harm the



party, especially in western UP, where Muslim and Dalit voters play a decisive role. In areas like Rampur and Moradabad, Azam's influence remains strong. If he aligns with BSP, it could help Mayawati forge a Muslim-Dalit alliance.

In 2024, Akhilesh Yadav had challenged the BJP using his PDA (Backward, Dalit, Minority) formula. But the SP's defeat in the by-elections indicated that there could be a breach in the Muslim vote bank. Mayawati's renewed focus on Muslim voters and the potential support from Azam Khan could weaken this core base of the SP. Moreover, Mayawati's accusations that SP misleads Dalit and Muslim voters have further intensified political tensions.

On the other hand, Akhilesh is trying to counter this challenge by inducting Dalit and OBC leaders into the SP. However, if Azam Khan joins hands with BSP, Akhilesh will have to rethink his strategy. The 2027 election is set to script a new chapter in UP politics, where the strategies of Mayawati and Akhilesh are squarely pitted against each other.

Meanwhile, speculation is also rising about a possible alliance between BSP supremo Mayawati and AIMIM leader Asaduddin Owaisi. Both leaders aim to unite Dalit and Muslim votes to challenge the BJP and the SP-Congress alliance. While Mayawati has a strong base among Dalits, Owaisi holds significant sway in the Muslim community. Under a "PDM" (Backward, Dalit, Muslim) banner, this alliance could be especially effective in western UP and Bihar.

However, the road ahead won't be easy. In 2019, Mayawati had accused Owaisi of treating Muslim leadership as untouchable, while Owaisi had blamed her for promoting extremism. Yet, in the changing political landscape, both leaders seem to see an opportunity to come together. If this alliance materializes, it could cause a political earthquake in UP. It may split the secular vote, indirectly benefiting the BJP.

Questions are also raised on the role of the administration. As long as no incident takes place, everything is considered normal. But when a teacher is killed, memoranda are given, protests are held, and after some time everything is forgotten. This cycle is being repeated continuously.

Teachers are now pleading with the administration for their respect and safety. School directors are demanding strict action from the board officials. But will this problem be solved only by action? We have to go to the root and see how this violence takes birth in the minds of children.

Our schools should have mental counsellors, attention should be paid to the mental state of each student, families should be trained in communication with

children. Schools need to prepare students not only for exams but also for life.

Today there is a need for a "Dialogue Revival Campaign" that reaches every home. We have to rekindle the spirit of trust and coexistence among parents, teachers and students. If we do not listen to children, they will learn to speak through violence.

Teachers are now fighting for their rights and survival. This situation is shameful. A society that cannot respect its teachers can never prosper. If we still do not understand that this is not the murder of a teacher but of an entire generation, the day is not far when every school will become a battleground.

We have to understand that children are not wrong, they are just unheard. If they get love, understanding and proper direction, then the same child can change the world. But if he becomes a victim of neglect, rejection and violence, then the same child can also become the killer of a teacher.

The government should conduct regular mental health tests, dialogue sessions, and parent-teacher conferences in schools. Parents should listen to their children, not just command them. And society should see education as a process of creating sensitive, responsible citizens, not just a means to get a job.

This incident has come to wake us up from our slumber. This is not just a news item in a newspaper but a warning for the entire nation. If we do not wake up now, in the coming years we will find more weapons than books in our schools and more security personnel than teachers.

It is time that we take this warning seriously. We must revive dialogue, reinvent education, and teach our children to win with understanding, not violence. Only then will we be able to imagine a safe, sensitive and strong India.

**Trump threatens to impose 35%** tariff on goods from Canada

UNITED NEWS OF INDIA New Delhi 11 JUL 2025

US President Donald Trump announced today that his administration will impose a 35 per cent tariff on all Canadian goods starting next month.

Trump posted a letter sent to Canadian Prime Minister Mark Carney on his social media platform, Truth Social, outlining the upcoming tariffs.

This week, Trump has posted letters to 14 countries vowing to impose steep tariffs on their imports starting Aug. 1.

Arguing that Canada had not done enough to curb the flow of fentanyl into the United States, the President wrote, "If Canada works with me to stop the flow of Fentanyl, we will, perhaps, consider an adjustment to this letter." "These Tariffs may be modified, upward or downward, depending on our relationship with your country."

In the letter, Trump wrote, "As you will recall, the United States imposed tariffs on Canada to deal with our nation's Fentanyl crisis, which is caused, in part, by Canada's failure to stop the drugs from pouring into our country. Instead of working with the United States, Canada retaliated with its own



tariffs. Starting August 1, 2025, we will charge Canada a tariff of 35% on Canadian products sent into the United States, separate from all sectoral tariffs."

In the letter, Trump wrote, "I must mention that the flow of fentanyl is hardly the only challenge we have with Canada, which has many tariff, and nontariff, policies and trade barriers, which cause unsustainable trade deficits against the United

#### States. Canada charges extraordinary tariffs to our dairy farmers up to 400 per cent and that is even assuming our dairy farmers even have access to sell their products to the people of Canada. The trade deficit is a major threat to our economy and, indeed, our national security."

"Goods transshipped to evade this higher tariff will be subject to that higher tariff. As you are aware, there will be no tariff if Canada, or companies within your country, decide to build or manufacture product within the United States and, in fact, we will do everything possible to get approvals quickly, professionally, and routinely-In other words, in a matter of weeks," he added.

In the letter, Trump threatened to increase the tariff rate by the same amount if Canada decides to increase their tariffs on importing American products. He also targeted Canada's tariffs on US dairy exports and called the trade deficit a major threat to the US economy and national security. The US had previously imposed a 25 per cent tariff on Canadian goods, though Trump later exempted products covered under the 2020 trade agreement struck between the US, Canada and Mexico.

# PM to distribute over 51,000 appointment letters at Rozgar Mela tomday

# UAC delivers another batch of Su-34 fighters to Russian Defense Ministry

#### UNITED NEWS OF INDIA Moscow, July 11

The United Aircraft Corporation(UAC) has delivered the fifth batch of Su-34 fighterbombers to the Russian Ministry of Defense, the industrial umbrella corporation Rostec announced on Thursday.

"The United Aircraft Corporation (part of Rostec State Corporation) has delivered another batch of Su-34 fighter-bombers to the Russian Ministry of Defense. The aircraft have joined the Russian Aerospace Forces' tactical aviation fleet. The planes were made under the State Defense Procurement Order for this year," the statement said.

A military pilot, quoted by Rostec, said that



the Su-34's strength lies in its versatility, notably the range of munitions it can carry and the way it can execute combat missions.

The aircraft underwent a full cycle of factory testing during which they were checked under various operational modes, before flying to their home airfield. "One of UAC's most important tasks is supplying military products to meet the needs of the Russian Ministry of Defense. We maintain a high production rate for aviation equipment. This year, we plan a further increase in the combat aircraft output," UAC CEO Vadim Badekhi said.

The Su-34 fighterbomber uses unguided and guided airlaunched munitions to engage ground, surface and air targets, as well as infrastructure assets that are protected by air defenses and far from the home airfield. It can operate under enemy fire and electronic jamming, day and night, in all weather conditions and in any geography.

# EU unveils AI code of practice amid industry calls for regulatory delay

#### UNITED NEWS OF INDIA Brussels, July 11

The European Commission has released the final version of a voluntary code of practice for general-purpose artificial intelligence (GPAI), aimed at helping companies align with the European Union's AI Act.

The code offers guidance in three key areas: transparency, copyright, and safety and security. It applies to major GPAI models such as OpenAI's Chat-GPT, Google's Gemini, Meta's Llama, and X's Grok.

Under the AI Act, GPAI models are defined as systems capable of performing a broad range of tasks and being integrated into various downstream applications. These models, typically trained on large and diverse datasets, support services like language generation and multimodal content creation.

The code was drafted by a panel of 13 independent experts and reflects input from over

1,000 stakeholders, including AI developers, academics, civil society organizations, rightsholders and safety professionals, the Commission said while releasing the code yesterday. The code will need to be endorsed by European Union (EU) member states before GPAI providers can voluntarily sign it. Signatories would benefit from reduced administrative burdens and greater legal certainty, according to the Commission.

However, a recent letter signed by over 50 business leaders, including representatives from ASML, Airbus, Mercedes-Benz, and French AI startup Mistral, urged the EU to delay the implementation of GPAI-related rules by two years.

They warned that "unclear, overlapping, and increasingly complex" regulations risk undermining Europe's AI ambitions and could hamper the global competitiveness of European firms.

#### UNITED NEWS OF INDIA Kolkata, July 11

The Calcutta High Court today directed the Union Home Ministry to submit a detailed report on whether migrant workers from West Bengal had been sent to Bangladesh. The court also instructed Chief Secretary Manoj Pant to remain in contact with his counterpart in Delhi to gather information about the work-

The court has also directed the Centre to submit a detailed report on the entire matter before it comes up for the next hearing on Monday. The directive from the division bench of the Calcutta High Court was issued during a habeas corpus hearing concerning six migrant workers from Birbhum who had gone to Delhi for work. The petitioner alleged that some of them, including a family with an eight-year-old child, were sent to Bangladesh.

vidhan Bachao Samavesh' here, Gandhi, the leader of opposition in the Lok Sabha, said the INDIA bloc parties have decided to prevent the BJP from "hijacking" the Bihar assembly polls.

"Like Maharashtra, attempts are being made to hijack the elections in Bihar. The BJP is attacking our Constitution across the country," Gandhi



alleged.During an INDIA bloc meeting held on Thursday, it was decided to "prevent the BJP from hijacking the elections in Bihar" where assembly polls are due later this year, he claimed.He also accused the **Election Commission of India** (ECI) of "not doing its duty but working for the interest of the BJP".Gandhi also alleged, "The

BJP runs the government for five to sin capitalists. It does not work for the common people of the country." Stating that the 'Jal, Jangal, Jamin' (water, forest and land) belongs to the tribals and will remain for them, Gandhi claimed that Odisha's BJP government has "not implemented" the Panchayats (Extension to Scheduled Areas) Act, 1996. "Forest rights pattas are not provided to the tribals. The Congress has brought the PESA and Tribal Bill. We will enforce these laws and ensure the tribals get their land," Gandhi said. He alleged, "Odisha is being looted by the BJP government.

# **Objectionable social media posts against PM Modi, RSS: Cartoonist moves SC for anticipatory bail**

The Supreme Court on Friday agreed to hear the anticipatory bail plea of Indorebased cartoonist accused of uploading "objectionable" cartoons of Prime Minister Narendra Modi and RSS workers on social media.

A bench of Justices Sudhanshu Dhulia and Joymalya Bagchi agreed to hear on luly 14, the plea filed by Hemant Malviya challenging the Madhya Pradesh High Court order refusing to grant him relief after advocate Vrinda Grover sought urgent hearing in the matter.

The high court had observed that it was gross misuse of freedom of speech. Grover submitted the matter pertains to a cartoon which Malviya made in 2021

during Covid and the high court said no landmark cases like in Arnesh Kumar and Imran Pratapgarhi, which dealt with life and liberty, will be followed.

She submitted that the high court has condemned the cartoonist,

"The offence is under which BNS which entails a maximum of three years of punishment," Grover submitted.

Justice Dhulia ordered that the matter will be listed on July 14 before the appropriate bench.

On July 3, the high court refused to grant anticipatory bail to Malviya.

A FIR was registered against Malviya at Lasudiya police station of Indore in May on the complaint of local lawyer and Rashtriya Swayamsevak Sangh worker Vinay Joshi.

Malviya hurt the religious sentiments of

Hindus and disturbed communal harmony by uploading objectionable material on social media, the complaint alleged. The FIR mentioned various "objectionable" posts, including allegedly inappropriate comments on Lord Shiva as well as cartoons, videos, photographs and comments regarding Modi, RSS workers and others. "...on the face of it, the conduct of the applicant in depicting the RSS, which is a

Hindu organisation, along with the prime minister of this country in the aforesaid caricature, coupled with his endorsement of a rather demeaning remark, dragging unnecessarily the name of Lord Shiva in the comments tagged to it, is nothing but sheer misuse of freedom of speech and expression as enshrined under Art 19(1) (a) of the Constitution...," the high court said.

# **ACB Nabs PDD Lineman Red-Handed** While Taking Bribe in Baramulla

Srinagar July 11 (KNS): Jammu and Kashmir Anti Corruption Bureau (ACB) received a written complaint alleging therein that Manzoor Ahmad Bhat, Lineman-II (designated as Meter Reader Panzinara) in the Power Development Department (PDD), Sub Division Pattan Baramulla demanded a bribe of?5,000 from the complainant for processing fresh electricity connection to a newly residential house at Panzinara, Shalteng Srinagar.

Since the complainant didn't want to pay bribe, he approached ACB for taking legal action against the accused public servant under law. On receipt of the complaint, a discreet verification through designated officer was carried out. The verification report confirmed the allegations and accordingly, a case FIR No. 13/2025 under Section 7 of the Prevention of Corruption Act, 1988 (as amended) was registered in Police Station ACB Srinagar and investigation was initiated.

During the course of investigation a trap team was constituted. The team laid a successful trap and caught the accused public servant Manzoor Ahmad Bhat R/o Buran Pattan Baramulla, Lineman-II (designated as Meter Reader Panzinara) in Power Development Department (PDD) Sub Division Pattan Baramulla red-handed while demanding and accepting the bribe amount of ?5,000 from the complainant at Panzinara Shalteng Srinagar. The accused was arrested on spot by the ACB team after following the due procedure of law. The bribe money was also recovered from his possession in presence of independent witnesses associated with the trap team.

# MGNREGA Turned Mafia in Bandipora: Usman Majid Demands Impartial Vigilance Probe

Bandipora, July 11 (KNS): Former Minister and Ex MLA Bandipora Usman Majid has raised serious concerns over alarming irregularities in the implementation of the Mahatma Gandhi National Rural **Employment Guarantee Act** (MGNREGA) scheme in Bandipora district. Expressing strong anger and dismay, Majid has demanded an immediate and impartial probe by the Jammu and Kashmir Vigilance Department, calling the revelations not only shocking but a direct betrayal

of the trust reposed by the public and the central government.

"It is deeply astonishing that from labourers from outside Jammu and Kashmir are being engaged under MGNREGA in Bandipora, a scheme that was exclusively intended to benefit our unemployed local laborers," Majid said. He further alleged that MGNREGA cards are being used to siphon money into the accounts of relatives and close aides of GRS. He revealed that lowerlevel staff, particularly the GRS, are at the heart of this nexus, employing their own relatives, creating fake work

records, and diverting funds into their personal and family accounts. Some contractors are also hand-in-glove in this network, allowing large-scale misuse of public money with near-total impunity. "Machines are being used for work meant to be manual,

while payments are manipulated and misappropriated. What we are witnessing is not just negligence, this is a wellorchestrated scam. The system has been hijacked and turned into a mafia," he stated. Majid also pointed out that instead of entire communities benefitting from developmental work, the scheme has been manipulated to serve individual interests, particularly those with political links. He acknowledged that some honest and young officers are making efforts to curb the menace, but their actions are being undermined by a nexus

of corrupt elements. "The issue

has been blatantly politicised to protect the wrongdoers. There is a dire need to conduct a detailed audit of assets and properties of those linked to the implementation of MGN-REGA in the district," he asserted.

Calling the situation a betrayal of public trust and central government policy, Majid has urged the Lieutenant Governor's administration and Chief Minister Omar Abdullah to personally intervene. "Let us not allow a poverty-alleviation scheme to become a playground for corruption. The very soul of MGNREGA is being crushed.
