

LG addresses seminar on "J&K's March Towards Peace" at Gandhi Smriti, New Delhi





that more than once Prime Minister Modi has himself said, not once but more than once, also publicly in some of the public rallies, that the government of India is committed to provide statehood to Jammu and Kashmir and it will happen at the appropriate time." Singh said.

He was replying to a question on the letter written  $by Congress chief Kharge \, and \, Gandhi, as also \, demands$ made by Jammu and Kashmir Chief Minister Omar

Abdullah in this regard. "I think after what has been said by the Prime Minister of India, there is no need to add to what is being said by him," said Singh, a Union Minister of

State in the Prime Minister's Office. Asked whether efforts were underway for a legislation for the restoration of statehood to J-K in the upcoming Parliament Session starting Monday, the

minister said he was not privy to any such proposal. "No, I am not privy to that and I don't speak out of turn," Singh said.

Jammu and Kashmir was stripped of full statehood in 2019 when the government bifurcated the state into two Union Territories – Jammu and Kashmir, and Ladakh.

At the time of bifurcation, the Union government

had assured in Parliament as also in the Supreme Court that statehood to Jammu and Kashmir would be restored in due course. While assembly elections were held in Jammu and Kashmir last year and a government was formed

under National Conference leader Abdullah, the full statehood is vet to be restored. "When the prime minister says, I think we have every reason to trust what he says," said Singh, a three-term Lok Sabha member from Udhampur in

Jammu Division. Asked whether the government had a timeline in mind, the minister said he was not mandated to speak on this issue. "But I would satisfy myself by stopping short of saying or repeating only what the prime minister has said," Singh said. (Agencies)

"It is good that he (Shukla) returned safe and sound. Earlier, our astronauts had gone on a space mission with Russian teams, but this time he went there aboard the International Space Station.

"The government of India had a mission to send humans to the Moon on our own, and this is a step in that direction. I hope the time will come when the country's flag will be hoisted on the Moon," the chief minister told reporters on the sidelines of a function

Talking about the ongoing Amarnath Yatra, Abdullah expressed hope that the number of pilgrims would cross 3.5 lakh this year.

"There was a time when we were sceptical about anyone coming for the yatra this time due to the Pahalgam incident. So far, 2.50 lakh people have visited, and if this trend continues, the number will easily cross the 3.50 lakh as the yatra will continue till August 9... I hope the number will increase further," he said.

On the controversy surrounding his government's decision to make Urdu mandatory for the Naib Tehsildar recruitment examination, the chief minister defended the move, saying, "We do not have any wrong intention to keep anyone outside." "You have to keep in mind that our revenue records, even before independence, were in Urdu, so we will not deploy staffwho cannot read Urdu. What work will they do?"

The chief minister said earlier, IAS and JKAS officers with no knowledge of Urdu were given six months

to one year to acquire basic knowledge of the language. "So, it will be better if there is some policy to give the Revenue Department staff time so that they can achieve some sort of proficiency in Urdu otherwise, they cannot read the revenue records," he said. (Agen-

"The anti-terror operations are taking place continuously, and recently, we got a very big success in Dudu-Basantgarh, where a senior and top JeM commander, who was active in that area for the last four years, was killed. The operations are taking place and all the terrorists will be eliminated one by one," the police chief told reporters at the Akhnoor police station near here.

On June 26, JeM terrorist Haider, code-named Maulvi, from Pakistan, was killed in a gunfight while three of his associates managed to escape, taking advantage of inclement weather, challenging topography and dense forest in the Basantgarh area.

However, the DGP declined to give the exact number of terrorists active in the forest areas of the Jammu region and said "that number cannot be given in the public domain".

The DGP, along with Inspector General of CRPF Gopal Sharma; Inspector General of Police, Jammu Zone, Bhim Sen Tuti; and Deputy Inspector General of police, Jammu-Samba-Kathua range, Shiv Kumar, visited Akhnoor police station to felicitate the personnel for receiving the prestigious 'Award of Excellence' from the Ministry of Home Affairs in the annual ranking of police stations in J-K for 2024.

Handing over the award to the police station, the DGP hailed the officers and men posted at the police station for their rapport with the public and said the successful operation in the Akhnoor sector early this year was the result of timely input received from the

## MeT Issues.....

Advisory issued by MET Centre Srinagar reads. There is a possibility of intense showers at a few locations with isolated heavy to very heavy rainfall during July 16-17 and July 21-23. The advisory also warns of potential flash floods in vulnerable locations, as well as landslides, mudslides, and shooting stones in hilly

terrains and along major highways. Residents, especially those living in flood-prone and landslide-prone areas, have been advised to remain vigilant and avoid unnecessary travel. Authorities have been urged to stay on alert and take necessary precautionary measures to prevent disruption

and ensure public safety. Jammu and Kashmir has been experiencing rainfall over the past two days, bringing much-needed relief from the recent scorching heatwave.

Meanwhile, as per official data, various parts of Jammu and Kashmir received varying rainfall amounts over the past 24 hours. In the Kashmir Region, Pahalgam recorded 16.6 mm, followed by Kulgam (17.2 mm), Gulmarg (15.2 mm), and Awantipora (12.0 mm). Other notable figures include Tangmarg (12.2 mm), Kokernag (10.8 mm), Nowgam Handwara (10.8 mm), Qazigund (9.5 mm), Charar-i-Sharief (8.2 mm) and Sonamarg (8.5 mm).

Srinagar city received 4.3 mm, while its airport recorded 4.8 mm. Pulwama and Kupwara received 6.0 mm and 5.0 mm respectively. Light showers were also reported in Sopore (2.4 mm), Bandipora (1.0 mm), and Shopian (0.5 mm).

In the Jammu Region, Udhampur recorded the highest rainfall at 43.0 mm, followed by Katra (35.8 mm), Reasi (25.0 mm), and Rajouri (23.0 mm). Jammu city and its airport received 15.9 mm and 15.6 mm

respectively. Poonch registered 12.0 mm, while Banihal, Batote, and Ramban received between 3–5 mm of rainfall. Kathua recorded no rainfall during this period.

In the Ladakh region, Leh received 2.6 mm and Kargil 0.5 mm of rainfall in the last 24 hours.

Despite occasional weather challenges, the administration has ensured that all necessary arrangements are in place for the comfort and safety of the pilgrims.

Meanwhile, a fresh batch of 6,064 Amarnath Yatra pilgrims left from the Yatri Niwas, Bhagwati Nagar base camp in Jammu early Wednesday morning, officials said. The pilgrims, escorted by security forces, departed in a fleet of 234 vehicles, comprising both Light Motor Vehicles (LMVs) and Heavy Motor Vehicles (HMVs), under a multi-tier security arrangement.

According to officials, 3,593 pilgrims proceeded via the Pahalgam route, while 2,471 pilgrims took the Baltal route. So far, the pilgrimage has continued peacefully with robust participation despite intermittent downpours along the route.

Contrary to some false reports circulating on social media regarding the suspension of the Amarnath Yatra due to rains, the Divisional Commissioner Kashmir has clarified that the Yatra is ongoing without any interruption, and pilgrims are safely having darshan of Baba

"The Shri Amarnath Ji Yatra 2025 is proceeding smoothly, and pilgrims are taking darshan of Baba Barfani without any interruption," said the Divisional Commissioner Kashmir.

All media outlets are advised to verify facts from official sources before publishing or circulating any information regarding the Yatra, the statement said, adding that the public is requested to rely only on official updates for accurate and timely information.

Reaffirmingits unwavering commitment to the safety and well-being of pilgrims undertaking the sacred Amarnath Yatra, the Indian Army carried out a swift medical evacuation at Barari Marg on Monday night.

A defence spokesperson in a statement said that at around 8:00 PM, a 38-year-old pilgrim, Ajay Kumar from Ludhiana, began feeling unwell while descending the yatra route. "Acting promptly, the Medical Evacuation Team, led by the NCO Incharge stationed at Barari, responded immediately," he said.

The pilgrim was escorted to the nearest Medical Aid Post, where he received timely medical care and was kept under observation as per standard protocol, the Army said, adding that after being stabilised and showing improvement, Ajay Kumar reported feeling better and continued his descent without assistance, accompanied by his fellow pilgrims.

"This incident underscores the Indian Army's proactive humanitarian efforts in ensuring the health, safety, and morale of all yatris. Army medical teams remain on round-the-clock alert along the entire vatra route, committed to providing immediate assistance and facilitating a safe and smooth pilgrimage for all," the spokesperson said.

The annual Amarnath Yatra, which commenced earlier this month on July 3, is scheduled to conclude on August 9 this year. (KNO)

surveillance over the approaching troops, they said while citing it as a reason for the little success in past counter-terror operations.

The drones, in some instances, are believed to be carrying dry ration for the holed-up terrorists in the higher reaches of the Jammu region, the officials said.

The use of drones by terrorist groups to target vital installations in Jammu and Kashmir began on June 27, 2021, when two unmanned aerial vehicles (UAVs) struck buildings at the Jammuairport, marking a significant escalation in the conflict.

Post 2017, the use of drones initially for drug smuggling and later for arms dropping along the International Border in Punjab was viewed by the officials as the first step before shifting their use for direct attacks in Jammu and Kash-

The officials said the ISI is leveraging drone technology for precise real-time situational assessments ahead of infiltration attempts.

The officials also said that under the new strategy, the ISI has been using drones for monitoring the presence of the army along the Line of Control or the International Border, identifying vulnerabilities and analysing terrain to assist terrorists in crossing the LoC while minimising the risk of detection.

There were credible inputs that in third weekof May this year, ISI officials and top terrorists of the banned Lashkar-e-Taiba (LeT) and Jaishe-Mohammed outfits in Pakistan-occupied Jammu and Kashmir (PoJK) had a meeting during which focus was laid on increasing recruitment and the "importance of drone surveillance along the LoC to monitor conditionsprior to infiltration attempts, the officials said.

They said there were plans to replace active  $guides\,with\,local\,residents\,from\,PolK\,or\,Pakistan$ to manage infiltration routes more effectively.

The officials said that ISI was working on a detailed plan for the terror outfits that included relocating terror training camps and launching pads within PoK and constructing underground bunkers in preparation for potential armed conflict with India.

This move from ISI is believed to be a response to "Operation Sindoor," in which the Indian Air Force targeted and destroyed nine terror facilities in PoJK and Pakistan which included the headquarters of the banned Jaish-e-Mohammed and Lashkar-e-Taiba terror groups.

The rise of drone technology has opened a new and dangerous chapter in global terrorism, with UAVs now being used by terror groups for a variety of nefarious operations, including intelligence collection and the delivery of explo-

A report from the Association of the United States Army (AUSA), a nonprofit professional association dedicated to serving America's Army, said, "Once Pandora's box was open, bad actors adapted quickly and began using drones to plan and conduct attacks." (Agencies)

## Take proactive measures so as to avoid 2014 flood like situation

For the past few days most of the areas of Kashmir valley are witnessing intermittent rainfall and there is a forecast for more rainfall in days to come. Given this situation the people are somewhat worried since the ghost of 2014 flood is haunting most of them. There are people who feel that the light or moderate rainfall may lead to a flood like situation in some of the areas of the valley with the brunt being borne by those falling adjacent to the water bodies.

The cause of worry is that most of the water bodies in Kashmir have lost their carrying capacity over the years. In the aftermath of 2014 devastating flood the authorities carried out dredging in Jhelum and flood channels but the process was discontinued after some time. As on date a lot of silt has been deposited in the Jhelum and some other water bodies located across the Kashmir valley. The situation is also the same in the flood channels of Jhelum and the masses are somewhat

Over the years it has been observed that the people at helm tend to forget about the damages caused by different disasters both natural and man-made. Same happened with context to 2014 flood situation and the consequences of the same have somewhat been erased from memory especially by those who matter a lot. The discontinuation of the dredging process is one of the grave mistakes done by the administration and one fears that people might have to bear the consequences if God forbid flood hits Kashmir valley.

It is imperative that the irrigation and flood control department carries out dredging of different water bodies and flood channels across the valley during the upcoming autumn season. Once dredging is carried out in a serious manner it is quite natural that the carrying capacity of water bodies and flood channels is enhanced. This would ensure that the people would be relieved once there is rainfall in Kashmir valley and the fear of a flood would also diminish.

It would be in place to mention here that Lal Chowk the city centre of Srinagar got deluged due to flood in 2014. The development was unprecedented as it was for the first time in the history that the city centre got submerged due to flooding. The inundation of Lal Chowk and adjacent areas should have alerted the administration but more than a decade later there is not much difference and the people at helm seem to be in slumber.

## Even healthy brains decline with age. Here's what you can do

After about age 40, our brains begin to lose a step or two. Each year, our reaction time slows by a few thousandths of a second. We're also less able to recall items on a shopping list.

Those changes can be signs of a disease, like Alzheimer's. But usually, they're not.

'Both of those things, memory and processing speed, change with age in a normal group of people," says Matt Huentelman, a professor at TGen, the Translational Genomics Research Institute, in Phoenix. Huentelman should know. He helps run Mind-

Crowd, a free online cognitive test that has been taken by more than 700,000 adults. About a thousand of those people had test scores indicating that their brain was "exceptional," meaning they performed like a person 30 years younger on tests of memory and processing speed. Genetics played a role, of course. But Huent-

elman and a team of researchers have been focusing on other differences. A key protein called Reelin may help stave off Alzheimer's disease, according to a growing body of research.

"We want to study these exceptional performers because we think they can tell us what the rest of us should be doing," he says.

Early results suggest that sleep and maintaining cardiovascular health are a good start. Other measures include avoiding smoking, limiting alcohol and getting plenty of exercise.

Huentelman was one of several dozen researchers who met in Miami this summer to discuss healthy brain aging. The event was hosted by the McKnight Brain Research Foundation,



which funds studies on age-related cognitive decline and memory loss. To preserve cognitive function in later life, "we're going to have to understand [brain] aging at a mechanistic level," says Alice Luo Clayton, a neuroscientist who is the group's chief executive officer.

## SDH Kupwara Does Not Refer; It Responds

In a world where health headlines are dominated by mega hospitals, robotic surgeries, and cutting-edge technologies, it is easy to overlook the silent revolutions that take place in modest hospital wards tucked away in distant hills. But every now and then, a story emerges from the margins that reminds us what true public healthcare is about: skill, commitment, and the will to care where it's

needed most. Recently, a quiet milestone was achieved at Sub-District Hospital (SDH) Kupwara, nestled in the border district of North Kashmir. A 55-year-old man, suffering for over a month with unrelenting fever and abdominal pain, was diagnosed with a pyogenic liver abscess; a condition that, if not treated on time, can turn fatal. Imaging studies, including ultrasonography and a contrastenhanced CT scan, confirmed abscesses in segments VI and VII of the liver.

Under normal circumstances, this case would have followed a familiar script: an ambulance ride, a hurried referral to Srinagar, and anxious waiting for a procedure in an overloaded tertiary care centre. But this time, Kupwara chose to heal its own.

With clinical clarity and courage, the Surgical team at SDH Kupwara's opted to perform a pigtail catheter drainage of the abscess under ultrasound guidance; a procedure typically seen in more advanced centres. Six hundred millilitres of pus was successfully drained, bringing quick relief to the patient. No complications followed. The recovery began not in a faraway city, but right



here, in Kupwara.

The procedure was led by Dr Gulzar Ahmad Bhat, Consultant Surgeon, and Dr Wasif Bashir, Consultant Radiologist, with support from Dr Anil (PG in Surgery), Mr Tariq Ahmad (OT Technician), Mr Tanveer, and a dedicated nursing team. The patient responded remarkably well: his fever subsided, his discomfort eased, and he began walking the path to recovery under the watchful care of his own community doctors.

This may seem like a small medical event, but it carries with it a larger message; that SDH Kupwara can rise above the reputation of being a mere referral centre. When provided with skilled manpower, basic infra-

structure, and, most importantly, institutional trust, such hospitals can manage critical cases with dignity and success.

The implications are far-reaching. In a remote district like Kupwara, where geography and socioeconomic challenges already burden access to care, every procedure performed locally saves not just lives, but livelihoods. It saves patients from travel costs, emotional distress, and long absences from home. It strengthens the very idea of community-based, decentralised healthcare.

For young medical professionals posted in far-off places, this is also a moment of affirmation. It proves that their work matters; not only in statistics or performance sheets, but in human stories of recovery and hope. And for health administrators, this should be a cue: strengthening district hospitals isn't charity; it is smart policy.

SDH Kupwara's modest operating room did more than drain an abscess. It restored confidence; in local care, in homegrown skill, and in the idea that healing need not always come from far away. Sometimes, it happens quietly, humbly, in a room where a team decides to stay, to act, and to heal.

Let us celebrate this moment not just as a first for Kupwara, but as a symbol of what is possible in every remote corner of Jammu and Kashmir; when competence is given a chance, and care is allowed to flow freely, even at the periphery.

## Study of 1.2 Million Children Finds No Risk From Common Vaccine Additive

A massive, 24-year-long study of more than 1.2 million children provides reassurance to parents around the world. The research has found no compelling evidence that childhood vaccines lead to autism, asthma, or dozens of other chronic disorders. Researchers in Denmark examined the safety of a specific vaccine in gredient – aluminum salts – which, despite frequent debunking, remains a common talking point among vaccine skeptics. Clinical trials have tested their safety extensively, and they've been used in non-live vaccines for more than 70 years to boost the immune system's response to lower doses of medicine.

Though the salts contain aluminumions, their chemical properties are quite different to those of pure aluminum. "It's really important for parents to understand that we are not injecting metal into children," epidemiologist and senior author Anders Hviid from Statens

Serum Institute in Denmark told NBC News. "Our study addresses many of these concerns and provides clear and robust evidence for the safety of childhood vaccines."

From 1997 through 2020, Hviid and colleagues tracked the health outcomes of more than 1.2 million Danish children using a nationwide registry containing details on childhood vaccinations, diagnoses, and potential biases. Some of the children were born at a time when fewer vaccines with aluminum salts were recommended. Others grew up when more were recommended.

Ultimately, a kid's exposure to vaccine-related aluminum salts before age 2 was not significantly related to any of 50 chronic disorders, including 36 autoimmune, 9 allergic, and 5 neurodevelopmental conditions. The lack of dose-dependent relationship between aluminum salts and a child's ongoing health strongly suggests the ingredient is safe for use. Early childhood vaccination with aluminumadsorbed vaccines in Denmark from 1997 through 2020. (Andersson et al., Annals of Internal Medicine, 2025) Edward Belongia, a retired epidemiologist who studied vaccine safety for decades and who was not involved in the current research, told Stat News that this is "the largest and most definitive observational study on the safety of vaccinerelated aluminum exposure in children" he knows of.

## "SHRAMIK WARTA" launched to enhance grievances redressal for workers

IAMMU, IULY 16: In a significant step towards promoting transparent governance and effective grievances redressal in the labour sector, the Labour Commissioner Jammu and Kashmir S. Charandeep Singh today launched a new initiative titled "Shramik Warta".

The innovative programme is designed to establish direct communication channels with workers and labourers across the Union Territory through virtual platforms. The core objective of Shramik Warta is to ensure prompt and time-bound resolution of genuine labour-related grievances, while fostering accountability and responsiveness within the Labour Depart-

During the inaugural session held today, the Labour Commissioner interacted virtually with all 20 Assistant Labour Commissioners (ALCs) of the UT and personally heard the grievances of around 45 complainants from various districts. The Labour Commissioner, J&K attentively listened to each grievance and issued on-the-spot directions to the concerned officers for early redressal.

The issues raised by the complainants primarily revolved around payment of wages, gratuity, compensation, shop registration and issuance of labour cards. Several complainants expressed satisfaction with the swift action



taken by the Labour Department, appreciating the initiative as a much-needed platform for direct resolution and communication.

One of the complainant, Mr. Prince Sharma of Siot, Rajouri, of

M/S AM Agencies (CFA & Distributors for Procter & Gamble India Pvt. Ltd. and Gillette India Ltd.) employed as a Comber with a monthly salary of ₹15,115/-, brought out his grievance regarding non-payment of salary and dues TA, and retention incentives. He filed a complaint on 19.06.2025 under the Payment of Wages Act, 1936. The Labour Department acted promptly, issuing notices

to the employer the same day. A hearing was held on 02.07.2025 before the Labour Court, Rajouri, following which the employer was directed to pay ₹75,979/-. The amount was transferred to the worker on the same day, resolving the grievance within 15 days through timely departmental intervention. Similar other issues were also resolved during the WARTA.

Reinforcing the department's commitment, S. Charandeep Singh directed the district-level officers to organize awareness camps across the UT. These camps aim to sensitize the labour force about their rights, entitlements, and welfare schemes available under various labour laws and

He further reiterated that Shramik Warta is not just a grievance redressal mechanism but a step toward streamlining departmental processes, fostering transparency, and enhancing collaboration between field functionaries and the labour force. He announced that every Wednesday at 10:30 am to 11:30 am will be designated as the day for direct interaction between workers and the concerned authority, ensuring consistency and accessibility for all stakeholders.

The launch of Shramik Warta marks a progressive shift in labour administration in Jammu and Kashmir, ensuring that the voices of workers are heard and their rights are protected in a proactive and systematic manner.

al centre of the National School of Drama(NSD)in Jammu. Despite previous efforts, including course module structuring and identification of local collaborators, the proposal has not materialized on the ground. Thakur emphasized that such a centre is vital for nurturing talent and institutionalising theatre education in the region.

He also highlighted the absence of regional centres of the three premier national cultural institutions, namely Sangeet Natak Akademi, Sahitya Akademi, and Lalit Kala Aka-

demi, in Jammu & Kashmir. While each of these national bodies has dedicated centres in the North East, J&K continues to remain overlooked. Thakur strongly advocated for the establishment of one regional centre each of these academies in Jammu & Kashmir to ensure equitable access and representation.

Expressing grave concern over the disappearance of numerous traditional art forms in the region, Thakur called for a defined cultural policy focused on the preservation and promotion of endangered art forms. He noted that many national schemes aimed at directly funding cultural organisations have failed to reach Iammu & Kashmir due to its geographic and administrative disconnect from the national mainstream.

**SRINAGAR, JULY 16**: Anant National University signed a Memorandum of Understanding(MoU) with Tulkul Arts and Media Collective, Kashmir, to study, document and preserve the musical instruments of Sufiana Mausiqi, a classical musical tradition central to Kashmir's cultural landscape. The collaboration aims to build a design archive of these rare instruments, many of which are only being crafted by a handful of artisans, map their cultural, social and historical contexts and explore possibilities for contemporary use, preservation

and revival. The MoU was formally announced in Srinagar, in the presence of reputed dignitaries, including MLA Dr Bashir Ahmad Veeri and MLA Sajad Shaheen, Principal Secretary Department of Culture BM Sharma IFS Hervinder Kaur, Secretary Jammu and Kashmir Academy of Art, Culture and Languages, Dr Raja Muzaffar, social activist, Nisar Naseem, Cultural Activist, Dr Sukamal Deb, Lead, Anant Centre for Documentation and Development of Crafts (ACDC), Anant National University, Prof Parth Shah, Assistant Professor, School of Design and Manager, Makerspace, Ravice Rashid, artist-in-residence, Anant National University, among oth-

The MoU will facilitate a two-way knowledge exchange. Traditional craftsmen and practitioners from Kashmir will visit Anant to teach design students the process of crafting these unique and endangered instruments, along with the cultural and musical heritage associated with them. Anant students will,inturn,get firsthand exposure to the making techniques, traditional compositions and the rich history of SufianaMausiqi, deepening their understanding of India's richindigenous design traditions from Kashmir.

Anant, through ACDC, will support documentation, preservation and potentially the revival of this art form through design innovation, archiving and research. ACDC documents, supports, nurtures and disseminates knowledge of crafts and traditional systems and seeks to revive the languishing crafts of India by promoting and



preserving traditional crafts, modernising ancient practices, teaching Mind-to-Market (M-M) approach, organising upskilling programmes and

Speaking on the collaboration, Dr Sanjeev Vidyarthi, Provost, Anant National University, said, "Preserving a traditional art form is not just about archiving artefacts, it is about taking forward centuries old legacy by introducing it to the young minds of today who will shape our tomorrow. Our students actively engage with local communities to understand real-world challenges and co-create practical, sustainable solutions. ## **DC Kulgam Reviews AMRUT 2.0** for 100% Urban Tap Water

KULGAM, JULY 16: The Deputy Commissioner(DC)Kulgam,AtharAamirKhan (IAS), today chaired a comprehensive review meeting to assess the progress of works being carried out under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 in the district. During the meeting, officers from the

Ial Shakti Department gave a detailed PowerPoint presentation, briefing the DC on the status of various water supply and infrastructure development projects approved under AMRUT 2.0. It was informed that in the four towns

of Devsar, Kulgam, Frisal, and Yaripora, the total treated water requirement is 3.28 MGD (Million Gallons per Day), while the current availability stands at 1.489 MGD. The shortfall of 1.80 MGD is to be addressed through interventions under AMRUT 2.0.

Officials further informed the chair that four water supply schemes have been approved under the mission, all of which have been allotted for execution at an estimated cost cost of Rs.14.62 crore.

The identified water sources for these schemes include Nallah Veshow, Nallah Sonman, and Shankarpaul Spring.

The DC instructed all implementing agencies to ensure regular monitoring,



maintain transparency in execution, and fast-track the completion of AMRUT 2.0 projects for the benefit of the district's urban population.

The DC stated that the primary aim of AMRUT 2.0 is to provide universal access to functional household tap connections in all urban areas of the district.

He added that the ongoing interventions under the scheme would significantly enhance urban water infrastructure and improve service delivery to the residents.

The meeting was attended by Joint Director Planning, Malik Suheel, Superintending Engineer Hydraulic Circle Anantnag-Kulgam, Nawaz

## **DCDRC Bla delivers** judgment in favour of flood-affected shopkeeper

BARAMULLA, JULY 15: In a landmark decision, the District Consumer Disputes Redressal Commission (DCDRC) Baramulla/Bandipora has ruled in favour of a local shopkeeper, Syed Ibrahim Rizvi, in a case related to the non-settlement of an insurance claim following the devastating floods of September 2014.

The complainant, a resident of Malmoh Pattan, had insured the stock of his shop through a policy issued by Bajaj Allianz General Insurance Company, facilitated by J&K Grameen Bank Khore Sherabad. After the floods submerged his shop for over 15 days,  $causing \ complete \ damage \ to \ the \ insured \ stock, the$ complainant approached the bank and submitted a written request to process his claim.

However, despite the bank forwarding the claim to the insurance company, no further action was taken by the insurer, leading the complainant to file a case before the Consumer Commission.

After a thorough examination of evidence, witness testimonies, and legal submissions, the Commission held that there was a clear deficiency in service and unfair trade practice on the part of the insurance company and the bank. The Commission emphasized that once the bank forwards the claim, it constitutes valid and effective intimation to the insurer, regardless of whether the insurer acknowledges receipt.

In its final order, the Commission directed Bajaj Allianz General Insurance Company and J&K Grameen Bank to register the claim and pay an amount of Rs.3,00,000 along with 7% interest from the date of the order till its realization. Additionally, they have been directed to pay Rs.1,00,000 for causing mental agony and indulging in unfair trade practice, and Rs.20,000 towards litigation expenses.

The order, issued on July 15, 2025, was pronounced by Commission President Peerzada Qousar Hussain and Member Nyla Yaseen. The parties have been given a deadline of four weeks to comply with the

The training sessions will continue tomorrow for the remaining BLOs to ensure complete coverage and proper understanding of the revised guidelines. During the SIR, BLOs will undertake House-to-House Enumeration and provide Enumeration Forms to all existing electors. These forms can also be downloaded by electors. BLOs will collect one copy of the filled form and acknowledge receipt on another copy to be retained

The District Election Officer emphasized the need for BLOs to provide maximum facilitation to vulnerable groups, including senior citizens, persons with disabilities (PwDs), and economically weaker sections, to safeguard their electoral rights.

The training sessions are designed to equip BLOs with the necessary technical know-how and procedural clarity for efficient implementation of the SIR.






