CBK raids 7 locations in twin districts

SRINAGAR, JUL 17: The Economic Offences Wing of Crime Branch Kashmir on Thursday said to have conducted searches at multiple locations in Srinagar and Budgam districts and registered an FIR against seven individuals in a land fraud case.

They said that among the accused persons, one is a former Tehsildar, who is 'allegedly involved in a land fraud case' related to cheating, corruption and tampering with revenue records. In a press conference held today at Crime Branch headquarters in Srinagar, Senior Super-

intendent of Police (SSP) Crime Branch Abdul Wahid Shah said that the agency has booked the accused in connection with fraudulent land deals in Balhama area.

While faculty members have been deployed to maintain emergency services, the absence of resident doctors has led to delays and disruptions.

Notably, it has been already reported on July 16, that water levels were expected to increase as rainfall accumulation from upper catchments would reflect with a delay.

In the earlier report, it was noted that the water level at Sangam was 3.85 ft, Munshi Bagh at 5.94 ft, and Asham at 3.84 ft. The tributaries also showed low levels, including Vishow Nallah at 2.73 m and Wullar Lake at 1574.94 m.

Moreover, officials had earlier said there was no flood threat and water levels were being regularly monitored. It was also highlighted that the impact of rainfall in upper catchments would likely show a day later.

Meanwhile, Faizan Arif Keng, an Independent Weather Forecaster said the rain has helped ease the region's water shortages. "The recent rains have raised the water level of the Jhelum, which will go a long way in addressing water scarcity. Streams and tributaries have also swelled, ensuring enough water for irrigation," said Faizan.

Earlier, the Meteorological Centre Srinagar has forecast more rainfall in the coming days,

of land in Gooripora Rawalpora. "After the accused took back the original sale deeds for 'record updation,' they returned them with forged khasra numbers," he said, adding that later, part of the land was forcibly occupied by another individual claiming it had been sold to him.

The SSP added that during the preliminary investigation, Crime Branch Kashmir found that the sale deeds had been tampered with to reflect incorrect survey numbers.

He added the then Tehsildar and Patwari of Balhama had allegedly facilitated these changes to confer illegal ownership to one of the accused, Riyaz Ahmad Bhat. "The accused named in FIR No. 14/2025 registered at Police Station Crime Branch Kashmir include: Nusrat Aziz, the then Tehsildar Balhama; Ashiq Ali, the then Patwari Balhama; Riyaz Ahmad Bhat, resident of Nowgam Srinagar; Mohammad Shafi Lone alias Shafi Cheeni, resident of Peerbagh; Shamima Akhter, wife of Shafi Lone; Shahnawaz Ahmad Rather, resident of Padshahi Bagh; and Shabir Ahmad Wani, resident of Bagander Lasjan," said the SSP.

He added the case has been registered under sections 167, 120-B RPC read with Section 5(2) of the Prevention of Corruption Act. SSP Shah also said that searches were underway at seven locations in both Srinagar and Budgam following search warrants issued by the competent court.

He further added that Tehsildar Nusrat Aziz is already facing trial in another case (FIR No. 08/2021) for similar charges including forgery, cheating and corruption.

"This indicates that the individuals involved may be part of an organized network deceiving innocent land buyers in Srinagar and adjoining areas," the SSP said. Meanwhile, authorities said more arrests and legal action could follow as investigations progress. (KNO)

The protest stems from demands for justice and enhanced security measures for healthcare professionals after the assault, which occurred following the death of a patient on July 16.

The strike was triggered by an altercation at GMC Jammu on July 16, after the death of 60-year-old patient Rajinder Kumar, who succumbed to respiratory arrest due to a severe brain haemorrhage.

The patient's family accused the hospital staff of negligence, leading to a violent confrontation where a female resident doctor was allegedly kicked and assaulted by a relative of the deceased.

In response, junior doctors launched a flash strike, demanding immediate arrest of perpetrators and improved security protocols to protect medical professionals.

As of July 17, the RDA announced the complete closure of emergency and OPD services, citing the lack of action in connection with the assault.

"Modi^{'s} actions sent a strong message globally. Through them, Modi conveyed a powerful message to the world that India's citizens, armed forces, and borders should not be messed with. Anyone who dares to do so has to face consequences," he said.

Modi, he added, has turned the vision of a prosperous, secure and developed India into reality.

Under Modi's leadership, the country has become fourth largest economy in the world and 22 crore people were lifted above the poverty line, the Union minister told the gathering.

Praising Chief Minister Bhajanlal Sharma, he said the BJP government in Rajasthan had done remarkable work in a short period of time.

"Rajasthan was suffering due to paper leaks. By forming an SIT, the Bhajanlal government has sent a strong message to the paper leak mafia," he said.

Under Sharma's leadership, Rajasthan signed MoUs worth Rs 35 lakh crore during an investment summit and work has already commenced on MoUs worth Rs 3 lakh crore, Shah said.

The BJP government in the state decreased VAT on petrol and diesel and several other initiatives were taken, he went on to say. He also praised the state government for effectively implementing schemes and programmes of the central government.

Shah lauded the contributions made by the cooperative sector in the country's development over the last century and said that the next 100 years are the years of cooperatives.

"With the vision of reaching every corner of the nation, Modi established a Ministry of Cooperation at the central level. Today, cooperatives play an active role in 98 per cent of rural areas," he said.

Highlighting the sector's contribution to the economy, he said the ministry launched 61 initiatives in the last four years to strengthen the sector.

"The creation of two lakh new PACS (primary agricultural credit societies) has already started with 40,000 PACS already set up. We have completed the computerization of PACS and all states have accepted the new model bylaws for PACS," he said.

He also spoke of Rajasthan's agricultural contributions.

The minister said the government has initiated research on camel breed preservation and medicinal qualities of camel milk.

"This will ensure the long-term survival of camels in the coming years," he said.

Chief Minister Sharma also highlighted the works and achievements of his government.

The move has garnered support from doctors across India, with posts on X reflecting nationwide solidarity with the GMC Jammu doctors' call for justice.

Dr. Ashutosh Gupta, Principal and Dean of GMC Jammu, addressed the media, condemning the violence and outlining measures to manage the crisis.

"In a gruesome incident on July 16, attendants of a terminally ill patient resorted to physical and verbal violence against our doctors on emergency duty. The patient had been referred back from PGI Chandigarh with a poor prognosis, clearly mentioned in the discharge summary. Despite being advised to seek basic care at a local hospital, the family brought the patient to GMC, where he received the best possible treatment. CCTV footage shows the family members kicking and beating the lady doctor. Such attacks are unacceptable."

Dr. Gupta emphasized that emergency services would continue to be supported by faculty members and consultants to mitigate disruptions. He directed all Clinical and Para clinical Heads to ensure adequate staffing in the emergency department until normalcy is restored.

The Jammu and Kashmir Medical Students' Association also issued a statement on X: "We strongly condemn this incident at GMC Jammu where a doctor was assaulted. Doctors are humans too, any grievance must be addressed through proper channels, not violence. We urge the Government to ensure strict action and provide immediate protection to healthcare workers across J&K."

Meanwhile, the family of the deceased patient, Rajinder Kumar accused the hospital staff of negligence, which they claim led to the patient's death.

The family's allegations of negligence sparked the altercation, escalating into physical violence against the female doctor. No arrests have been reported as of the latest updates, fuelling the doctors' decision to intensify the strike. Moreover, the RDA at GMC Jammu has demanded the immediate arrest of the individuals involved in the assault, enhanced security measures in hospitals, and stronger legal protections for medical professionals.

The doctors have vowed to continue the strike until their demands are met, with the possibility of further escalation if no action is taken. (KNO)

It is a testament to the divine wisdom of Allah that He would not bring punishment upon His servants without first offering them guidance and clarity. The sacred text beautifully illustrates this principle, reminding us of Allah's compassionate nature and His desire for all to find their way before facing judgment.

And We do not punish (a people) until We have sent a messenger (to them).[1]

Most scholars agree that Allah Almighty does not punish a people in this world until He sends a messenger to that people. This is a testament to the fairness of Allah's judgment. Some scholars say that if the prophets and messengers had not been sent, there would have been no concept of punishment on the Day of Judgment, since reason also requires that until a person receives the invitation (i.e. the commands of the Lord of Glory), he should remain free from

being punished. [2] Imam Azam Abu Hanifah (RA) (80-150/699-767) emphasises that the existence and oneness of Allah are so selfevident that they can be regarded as fundamental truths, leaving no room for doubt or uncertainty. Allah Almighty affirms: "Their messengers said: 'Is there any doubt about (the existence of) Allah, the Originator of the heavens and the earth?"[3] Consequently, there is no valid reason to deny Allah or to engage in polytheism, even for those who have not received the message of the Prophet. Even individuals with limited understanding can recognise that a building cannot exist without an architect, just as writing cannot occur without a scribe. Therefore, how can we rationalise the entire system, from the earth to the heavens, functioning without a Creator?

According to Imam Shafa'i (RA)(150-205/767-820), this verse suggests that individuals who die before receiving a prophetic mission or have not been called to prophethood are excused by Allah and will not face punishment, even if they pass away in a state of polytheism. This is because comprehending divine laws is impossible without shari'ah, as

It would not be an exaggeration to give the title of Pole of Guidance or, the cradle of the great men of religion (Qutb al-Irshad) to this city of Hyderabad(Note: Shaykh Ahmed Sirhindi (RA) (971-1033/1564-1624) had bestowed this title on the city of Lahore during his time). Innumerable saints lived a life of anonymity and adopted such means of livelihood that the public could not reach their actual status, instead of raising the voice of My father was a king., These enlightened, broad-minded Sufis always preferred to utilise their abilities. In every era, the people of Allah, by the will of Allah, sometimes remain visible and sometimes hidden, due to which the public generally comes to know about their status after the passing of these blessed individuals. The seekers of truth should always be in search of truth and, as much as possible, should be busy trying to benefit from the beneficial company of these great men of religion.

Among the numerous great saints and scholars, the perfect embodiment of shari'ah and the path of truth and knowledge is Abul Irfan Hazrat Shah Syed Ahmad Arif Hussaini al-Qadiri al-Multani, affectionately known as Mian Qibla (RA). He is regarded as the heir to the sciences of the Noble Prophet and the repository of growth and guidance, known for being a source of obedience and worship, the centre of wisdom, and the epitome of asceticism. This remarkable individual firmly embraced the principle of or Tell me about me even if it were a verse."[8] He bestowed his intellectual and spiritual blessings upon his three brothers: the esteemed Shaukh Hazrat Shah Syed Peer Hussaini al-Qadiri al-Multani, also known as Sahiban Pasha (RA) (born on 8th Zil Hijjah 1310 AH, which corresponds to 23rd June 1893 CE), the respected Shaykh Hazrat Shah Syed Ismail Hussaini al-Qadiri al-Multani, known as Ismail Pasha (RA), and the venerable Shaykh Hazrat Shah Syed Abdul Qadir Hussaini al-Qadiri al-Multani (RA).

he possessed a profound command of Arabic vocabulary, making the composition of Arabic Hamdiya and Naatiya poems his primary hobby from a young age. He excelled in calligraphy and deeply appreciated physical exercise, contributing to his vibrant energy, good health, and cheerful demeanour. His manners were straightforward, and his commitment to shari'ah was a defining trait; he considered accepting offerings from devotees inappropriate. He conducted the annual Urs ceremony of his grandfather, i.e., Hazrat Shah Syed Peer Hussaini al-Qadiri al-Multani Muhaqqiq (RA), with remarkable devotion and respect. Despite facing financial constraints, he actively engaged in agriculture and gardening in Imampura Sharif. Whenever he learned of someone in distress, his response exemplified genuine compassion, in line with the teachings of the Quran.[9] Those afflicted with evil can receive complete and swift healing through his supplications.

When it becomes challenging to vocalise the voice of truth, when the foundations of Islam begin to be questioned, and when the teachings of the Noble Prophet (PBUH) are distorted, the Almighty Allah grants His devoted servants an inner strength manifested in the form of miracles that transcends human understanding. This manifestation of strength is helpful and effective inguiding misguided humanity towards progress and enlightenment.

Sakeena Itoo reviews performance, functioning of **J&K Medical Supplies Corporation Limited**

Asks for zero stock-outs of life-saving drugs, injections in health facilities across UT

SRINAGAR, JULY 17: Minister for Health and Medical Education, Social Welfare and Education, Sakeena Itoo, today directed the J&K Medical Supplies Corporation Limited (JKMSCL) to ensure zero stock-outs of lifesaving drugs and injections, particularly in emergency and trauma care units of all district hospitals across Jammu and Kashmir.

The Minister passed on these directions while conducting a comprehensive review of functioning and performance of the J&K Medical Supplies Corporation Limited (JKMSCL) in a meeting held at Civil Secretariat here today.

The meeting was attended by Secretary Health and Medical Education, Dr. Syed Abid Rasheed Shah; CEO State Health Agency, Ananth Dwivedi; MD JKMSCL, Kapil Mishra; Director Health Services Kashmir/Jammu, Director Family Welfare and Immunization, Director Finance, Health and Medical Education department, Principals of various GMCs and other senior officers, either in person or through video conferencing.

Addressing the officers, the Minister underlined the pivotal role of JKMSCL in ensuring seamless procurement and distribution of essential medicines, surgical equipments and other necessary medical supplies to the government health institutions across Jammu and Kashmir.

While having detailed appraisal of the corporation's procurement processes, inventory management systems, logistics networks and district-wise supply status, the Minister stressed on the urgent need to plug any gaps in real-time supply of critical and life saving medicines.

She directed the JKMSCL to ensure zero stock-outs of life-saving drugs and injections, particularly for cancer patients as well as cardiac patients in all district hospitals of J&K. "Health and well-being of the people is nonnegotiable. We must ensure that no hospital, regardless of its location, faces a shortage of essential or emergency medicines", asserted the Minister.

Highlighting that a robust, transparent and responsive supply chain is the backbone of any public healthcare system, she instructed the JKM-SCL management to adopt techenabled inventory tracking systems, ensure real-time coordination with GMC Principals, Chief Medical Officers (CMOs) and conduct monthly audits to monitor availability of essential healthcare supplies and utilization of stock.

She directed both the Directors of health department to give advance requisition for healthcare equipment and accessories to the JKMSCL in order



to avoid any delay in healthcare service delivery to people. "The effectiveness of our health system is closely tied to the efficiency of medical supply chains, any delay or lapse directly affects patient care", the Minister stated.

Calling for maintaining quality standards, especially in procurement of antibiotics, cardiovascular and other critical drugs, Sakeena Itoo emphasized upon the management of JKMSCL to maintain stringent qualitv control benchmarks for procurement process for enhanced transparency and competitiveness. She also

asked them to avoid any kind of delay in procurement process as these equipments and medical supplies are very critical for improving the healthcare facilities across Jammu and Kashmir

icines at all health institutions at their own level. She further stressed on the need to build greater synergy between the Corporation and various healthcare institutions, especially in remote

While reviewing the procurement

of high-end equipments like Tesla MRI machine. Cardia Cath Lab. 128 Slice CT Scan machine, 3D 4K visualization tower for Kidney transplant, microsurgery and open surgery, CT Simulator, Microarray system and other related equipment, the Minister directed both the management of JKMSCL and health department to check sites in advance at required health facilities where they are being set up so as to avoid any last minute delay.

During the meeting, a detailed presentation was given by the MD JKMSCL, highlighting key achievements, procurement timelines, vendor performance metrics and other issues of the corporation.

Meanwhile, the Minister also reviewed the saturation of Ayushman Bharat-PMJAY/SEHAT scheme across Jammu and Kashmir.

During the meeting, the Minister emphasized on the critical role of universal health coverage, underlining the need to ensure equitable and timely access to healthcare services for every household in the region, especially in remote and underserved areas. "The objective of Ayushman Bharat and SEHAT is inclusivity and access. We must ensure that no family is denied their right to quality healthcare because of procedural bottlenecks or geographic barriers", she said.

The Minister reiterated Government's commitment to accessible. equitable and efficient healthcare for all. She directed the concerned authorities to intensify door-to-door awareness campaigns, simplify enrolment procedures and ensure that vulnerable sections like nomadic populations, elderly citizens and persons with disabilities is not left out of the health safety net.

During the meeting, the CEO State Health Agency gave a detailed presentation on number of golden cards issued, beneficiaries enrolled and the quantum of claims settled under the scheme.

Sleeping under mosquito nets and installing mesh screens on doors and windows create a physical barrier, protecting you from mosquito bites, especially during the night when many disease-carrying mosquitoes are most active.

3. Apply mosquito repellents

Use topical creams, sprays, or patches containing DEET, picaridin, or eucalyptus oil on exposed skin. These repellents keep mosquitoes at bay and reduce the chances of being bitten, especially when outdoors.

SC seeks Bar Council of India Chairman's assistance on compliance with enrolment fee cap ruling

New Delhi, July 17: The Supreme Court today sought the assistance of Bar Council of India (BCI) Chairman and Senior Advocate Manan Kumar Mishra to ascertain whether State Bar Councils are complying with its 2024 ruling prohibiting enrolment fees beyond the statutory cap under the Advocates Act, 1961.

A Bench comprising Justice J.B. Pardiwala and Justice R. Mahadevan was hearing a contempt petition filed by

that several State Bar Councils continue to demand exorbitant enrolment fees from young lawyers in violation of the top court's judgment in Gaurav Kumar v Union of India.

While the Court refrained from issuing notice on the contempt plea at this stage, it directed BCI Chairman Manan Kumar Mishra to appear and assist the Court.

"We are not inclined to issue notice, however, we would like to know from the Bar Council of India whether

KLJA Kiran Babu, who alleged the directions issued in the main judgment are being complied with in letter and spirit or not," the Bench recorded.

In its July 30, 2024, ruling, the Supreme Court had held that State Bar Councils are bound by Section 24(1)(f) of the Advocates Act, which caps enrolment fees at Rs 750 for general category candidates and Rs 125 for Scheduled Caste/Scheduled Tribe candidates.

The Court had also declared that additional charges collected by Bar Councils, often rupees, violated the constitu-



running into thousands of tional rights of law graduates. The ruling, however, was

made applicable prospectively, with no refund required for past excess collections.

The petitioner alleged that despite the clear directions, many State Bar Councils continue to flout the fee cap, burdening fresh law graduates.

When questioned by the Bench on his locus to file the contempt plea, Babu responded that any person could move the Court for breach of its orders.

Choosing not to examine that issue at this stage, the Court deferred it, instead seeking a compliance update from the BCI.

Notably, the BCI has also moved an application before the Supreme Court in the Gaurav Kumar case seeking enhancement of the enrolment fee to Rs 25,000, which is still pending consideration.

The present contempt proceedings will be taken up next on August 4, with the BCI Chairman expected to clarify the compliance status of State Bar Councils with the Supreme Court's 2024 judgment. UNI SNG RN

UK secret plan to repatriate 33k Afghan nationals receives massive criticism from socio-political groups

LONDON/KABUL, JULY 17: An information leak has brought to light a secret new plan by the UK to repatriate over 33,000 Afghan nationals currently residing in the country.

While much of the proposal's mechanisms is undisclosed, it has been subject to a massive controversy in the country triggered by both social groups and the

political opposition, reports Tolo News.

According to British media, the plans include relocating those Afghans who cooperated with the Royal Army in Afghanistan, putting them under grave risk of near-certain retaliation by the Taliban administration.

The plan was initiated following the accidental leak of personal details of approximately 19,000 Afghan applicants in February 2022. The leak, which included names and contact information

of those who had applied for the 'Afghan Relocation and Assistance Programme' (ARAP), pressured the UK government into action.

So far, about 4,500 people have been relocated to the UK, and the 'Afghanistan's Response Route' programme for further relocations continues. The programme has so far cost around £400 million (\$536 million) and is expected to increase to £850 million (\$1.1 billion).

The action, which resulted from an organisational error by the UK Ministry of Defence in sending sensitive information via unauthorised email, has sparked widespread criticism.

Opposition groups in the UK have condemned the plan, criticising its lack of transparency and the high financial costs which will have to be borne by the taxpay-



ers, particularly when the country is witnessing a steep economic decline, high inflation, and a cost of living crisis.

There is further criticism levelled at the administration for the leak of sensitive information, with people questioning the government's accountability, and its handling of data deemed sensitive. UNI ANV SSP

DC Srinagar Reviews Khankah, Aali Masjid Restoration

Ensure Timely, Quality Restoration with Heritage Aesthetics

SRINAGAR, JULY 17: Deputy Commissioner (DC) Srinagar, Akshay Labroo conducted an on-site inspection of the ongoing restoration/ renovation works on the Khanqah-e-Naqshband Sahib (RA) at Khawaja Bazar and historic Aali Masjid at Eidgah being executed under the Preservation of Heritage Scheme of the Government to preserve the rich cultural and architectural heritage in the district.

At Khanqah-e-Naqshband Sahib (RA) at Khawaja Bazar Nowhatta in Shahr-e-Khaas area of the district, DC took on spot review of the Rs 3.37 crore project for renovation, restoration and development



of Khanqah on heritage pattern.

On the occasion, DC said that the project is of significant heritage importance, aiming to preserve and restore historical architectural aesthetics of centuries old Khankah-e-Naqshband Sahib (RA), a spiritual and architectural landmark in the Shahre-Khaas area of Srinagar district.

The DC was given a detailed appraisal of the works taken up as per approved DPR for restoration, revival, preservation and maintenance of heritage architecture of the 600 years old historic Khankahi Naqashband Sahib (RA). He was informed that the project includes structural conservation, retaining the original exterior appearance of wooden architecture & ornamentation, restoration of wooden elements on the exterior façade, installation of khatamband ceiling with papier mache work in the central hall.

Similarly, DC visited the historical Aali Masjid in the Eidgah area and took on the site review of the Rs 3.28 crore project being executed for its preservation and conservation on heritage pattern.

While taking stock of the ongoing works under the heritage conservation project, DC stressed that conservation efforts must retain original aesthetic & heritage.

It was informed that the project include works of water proofing solution to prevent the water seepage in the floor, waterproofing painting on the rooftop, khatamband on the outer open area of the Masjid with paper machie, aslar stone work on the outer side of the plinth and other works. He directed the concerned executing agency to accelerate the pace of work on the prestigious project with quality and strictly adhere to the set timelines. During the visit, DC was accompanied by Chief Planning Officer, Fayaz Ahmad Dar, Executive Engineers of R&B. SMC, PHE, PDD, Tehsildar, Khanvar, Tehsildar Eidgah, Officers of Archives & Archeology and other concerned departments.

Rs. 7 lakh penalty imposed on erring Food Business **Operators in Anantnag**

ANANTNAG, JULY 17: In a significant move to uphold food safety standards and safeguard the health of consumers, Additional Deputy Commissioner (ADC) Anantnag, Sandeep Singh Bali, who is also the Adjudicating Officer, Food Safety Anantnag, has imposed cumulative penalties amounting to Rs.7 lakhs on various Food Business Operators (FBOs) found guilty of violating multiple provisions of the Food Safety and Standards Act, 2006.

First spotted by Jaydev Unadkat and brought in as a net bowler in Rajkot, Fuletra was fast-tracked into the Vijay Hazare Trophy squad during the 2024-25 season, and debuted against Karnataka. He was later part of Sunrisers Hyderabad as a net bowler at IPL 2025.

More recently, he picked up 10 wickets in nine matches for Anmol Kings Halar in the Saurashtra Pro T20 League, where he earned the Emerging Player award. From being on the fringes of the state set-up just over a year ago, Fuletra has already broken into Saurashtra's Under-23 squad. A call-up to the senior team across formats appears to be a matter of when, not if.
