Hands over appointment letters to 158 NoKs of terror victims

SRINAGAR, AUG 05: Terming August 5 as the date of insaaf (justice) for Jammu and Kashmir, Lieutenant Governor Manoj Sinha on Tuesday said exactly six years ago, Prime Minister Narendra Modi took a bold and historic decision by abrogating Article 370, giving birth to Naya Jammu and Kashmir.

Speaking at a ceremony organized to handover the appointment letters to 158 Next of Kins (NoKs) of Kashmiri Civilians killed by Pakistan-backed ter-



rorists, LG Sinha, according to the news agency—KashmirNewsObserver(KNO) said, "I pay tributes to all the martyrs who became victims of Pak-sponsored terrorism. For over three decades, the terrorist nation spilled the blood of innocent Kashmiris. The pain endured by the terror victim families can't be translated into words," LG Sinha said.

Becoming emotional while narrating stories of families who lost loved ones to terror, LG Sinha assured them that their wait for justice was over.



He said that the government has launched a dedicated portal to document and support terror victim families. "We are rehabilitating the families on a war footing. The family of a slain SPO had to face social boycott, his widow and daughters struggled alone. I assure them - justice and jobs will

'We are duty-bound to stand by the martyrs' families. While we can't fill the void left by their loss, we can ensure they live a dignified life" he said.

LG Sinha said, "Over the past six years, the common people of Jammu and Kashmir have come to understand how separatism and terrorism were deliberately nurtured in the region. Thousands of innocent civilians lost their lives to terror. Those who operated and sustained the terror ecosystem within J&K are just as responsible as Pakistan for the bloodshed and suffering."

"For decades, the destiny of this region remained in the hands of those who thrived on fear and violence. But after August 5, 2019, that changed — the power to shape your future was returned to you."

LG SINHA SHARES TRAGIC ACCOUNTS The Lieutenant Governor shared the tragic account of Abdul Majid Mir's family, whose lives were shattered on June 29, 2004. On that day, Abdul Majid, from Sheikhpura, Baramulla, was kidnapped and brutally murdered by terrorists.

"Abdul Majid's family lost their sole breadwinner and received Rs 1 lakh as an ex-gratia payment under the Security Related Expenditure (SRE) scheme. Despite Abdul Majid Mir's martyrdom, his family struggled to live a life of dignity. Today, by providing a government job to his son, Mudasir Majid, the administration has fulfilled its long-overdue responsibility.

After three decades of hardship, justice has finally been delivered to Suhail Majeed and his family. Today, Suhail, a resident of Anantnag, received an appointment letter for the government job. His father, Abdul Majeed Wani, was shot dead by Pakistanbacked terrorists on August 30, 1994. Justice has been finally delivered to the family after

On February 24, 2000, SPO Manzoor Ahmad Rather, a resident of Warpora, Baramulla, was killed by Pakistan-backed terrorists. For 25 years, his family received no compensation. Today his son Khurshid Ahmad Rather has received an appointment letter. Traumatic period for the family is finally over.

For Parvez Ahmad Dar, the path to justice was painful. On July 6, 1996, terrorists killed his father, Ghulam Qadir Dar. On July 30, 2004, his brother, Aijaz Ahmad Dar, was also killed by terrorists. 29 years after his father's death, Parvez's nightmare is over," the Lieutenant Governor said.

He observed that the void in the lives of terror victims' families cannot be filled with financial assistance or jobs, but it will be ensured that these families can live with

"We will do everything possible for the rehabilitation of terror victims. It is my promise to the NoKs of terror victim families that perpetrators of heinous crime will receive exemplary punishment. We will also ensure the harshest possible punishment to terror sympathisers," he said, adding, "I assure the family members of civilian martyrs that I will not rest until every family that has been a victim of the terrorists' atrocities gets justice. I want to tell the loved ones of martyrs that the dreams of your father or your mother will now be fulfilled," he said.

"Many families lived under constant threat and intimidation for over thirty years. Today, that fear has begun to fade. They now see a ray of hope. I know each one of you had been waiting for this Naya Jammu and Kashmir — and it has become a reality."

IN NAYA J&K TERRORISTS ARE NOT

GIVEN GOVERNMENT JOBS The Lieutenant Governor while addressing those questioning the changes in J&K said, "To those who ask what's new, I say this is Naya J&K where terrorists are not given government jobs, but the families of martyrs are honored and empowered. Here, tears are not shed for terrorists, but the tears of common Kashmiris are wiped with compassion."

"In Naya J&K, children hold pens instead of stones, Pakistan no longer dictates shutdown calendars - the government issues event calendars, youth take out Tiranga rallies in Pulwama, schools and colleges remain open year-round, separatists are no longer glorified - common Kashmiris are."

He said, "On 5 August 2019, a new Jammu Kashmir was born. A new Jammu Kashmir that had dreams of a golden future in its eyes. A new Jammu Kashmir, which treated all its citizens as equal and removed discrimination that was prevalent for seven

The Lieutenant Governor called upon every section of the society to rise against terrorism. "Under the leadership of Prime Minister Modi, India has drawn a new redline against terrorism and equal punishment will be given to terrorists and their sponsors. India has made it clear that if terror is state policy, it will be met with a visible and forceful response.

Recalling recent counter-terrorism operations, LG Sinha highlighted the resolve of the security forces. "Our armed forces recently avenged the Pahalgam terror attack by neutralizing the three terrorists involved. Earlier in May, nine terror camps were destroyed deep inside Pakistan and PoK. PM Modi has made it clear that any act of terror against Indian citizens will be considered an act of war, and those responsible will pay a heavy price," he said.

He said, "Peace is a prerequisite for progress. There is no place for terrorism in a civilized society. Many generations of J&K have suffered the brunt of terrorism perpetrated by the neighbouring country. Every person has to take a pledge that they will not allow this to happen again."

The Lieutenant Governor also commended the Administrative and Police officials for addressing the issues and grievances of terror victim families with utmost sensitivity and sincerity.

felt that someone heard our cries," she said while speaking to the news agency-Kashmir News Observer (KNO).

Soliha said her father was killed in a terrorist attack more than a decade ago. Since then, her mother, a single parent, bore the burden of raising her daughter while knocking on every door for justice.

"My mother would hold my hand with one and the documents in the other," she said. The girl spoke of fighting every battle-legal, emotional and financial on her own. "Today, I saw relief on her face for the first time," she added.

At the official event in Srinagar, where Lieutenant Governor Manoj Sinha handed over appointment letters to families of terror victims, Soliha said she felt over-

whelmed with gratitude. "This appointment letter is not just a paper; it is a reward for my mother's struggle and a recognition of my father's sacrifice," she said.

Soliha said she wants to focus on her studies now. "My father's dream was for me to become something in life. With this support, I can think of a future. I feel light, as if a heavy weight has been lifted from our shoulders," she added.

Moreover, Soliha expressed deep gratitude to the LG Manoj Sinha administration: "We are very happy and thankful to LG Sahab. He didn't just announce something, but he gave us justice but something we have waited for all these years."

Observer (KNO), with moist eyes. As she sat among dozens of families of terror victims during an official event in Srinagar, LG Sinha assured that justice will prevail. For Samena, those words felt like a long-awaited answer to years of unanswered prayers.

"Nobody ever came to ask how we survived all these years. But today, LG sahab stood before us and promised that justice would no longer be delayed. When he said appointments will be fulfilled, we cried. We truly cried," she said.

Over the years, Samena says her family struggled – financially, emotionally and mentally. "We were not just grieving; we were abandoned," she recalled. But this year's event, which marked six years since the abrogation of Article 370, brought something her family had never experienced before: dignity and closure.

"People used to ask us why we still talk about something that happened so long ago. But pain doesn't expire. For the first time, our pain was acknowledged. LG Sinha made

us feel like we matter," she said. She added, "LG Manoj Sinha has given us more than a job, he has restored our dignity, our faith and our place in this land."

and the document in circulation is fabricated and misleading. They further stated that the State Election Commission is the only competent authority to notify the schedule for Panchayat elections and no such timeline has been officially announced

"The general public is advised not to fall prey to such misinformation. Circulating fake government orders is a punishable offence under the Information Technology Act and relevant sections of the Indian Penal Code," a senior official from the Rural Development Department said.

The department has urged the citizens to rely only on official government channels and verified communication for any updates regarding elections or other administrative matters. Strict action is being initiated against those responsible for creating and sharing the forged document.

Malik was admitted in the hospital on May 11, 2025 with complicated urinary tract infection and subsequently developed refractory septic shock secondary to urinary tract infection, hospital acquired pneumonia and multi-organ dysfunction.

"Despite all appropriate and aggressive medical interventions including multiple antibiotics and two CytoSorb sessions, including ventilator support and critical care management, his condition continued to deteriorate. He also developed disseminated intravascular coagulation (DIC) and acute kidney injury on chronic kidney disease needing multiple hemodialysis sessions," the RML said.

Prime Minister Narendra Modi has condoled the demise of Malik. "Saddened by the passing away of Shri Satyapal Malik Ji. My thoughts are with his family and supporters in this hour of grief. Om Shanti,"the PM said in a post on X.

Lok Sabha Speaker Om Birla also expressed grief over the death. "The passing of Shri Satya Pal Malik Ji, former Governor and member of the 9th Lok Sabha, is extremely sorrowful. I pray to God to grant peace to the departed soul and strength to the grieving family and supporters," Birla said in a post on X.

Malik became MLA from Baghapat assembly seat of Uttar Pradesh in 1974. He was elected to Rajya Sabha in 1980 and 1986 respectively on Lok Dal and Congress tickets.

In 1989 Malik won Lok Sabha polls and also served as Union Minister of state for Tourism and Parliamentary Affairs for a brief period

In 2004 Malik joined BJP. In October 2017, he was appointed as Governor of Bihar. A year later, in August 2018, he

was shifted to J&K as Governor. In November 2018, Malik dissolved J&K Assembly after rival claims were made for forming a government in the then state.

Malik cited reports of "horse trading" and "impossibility of forming a stable government by the coming together of political parties with opposing political ideologies"."The best course of action is to dissolve the assembly so as to provide stability and security to the state and hold elections at an appropriate time so that a government with a clear mandate is duly formed," Malik had said.

As Governor of J&K, Malik conducted Panchayat and Municipal polls in 2018. Malik was Governor of J&K when Union Government abrogated Article 370 and bifurcated J&K into two Union Territories.

Two months after scrapping of J&K's special status, Malik was shifted to Goa. After his run-ins with the state government there, Malik was shifted to Meghalaya where he served as Governor till October 03, 2022.

BJP vice president Rekha Mahajan, speaking at the event, highlighted the transformative impact of the abrogation, calling it the beginning of a "new era of peace, progress, and prosperity" for the region. (KINS)

be conducted regularly to evaluate real-time impact at the grassroots level.

The meeting included a detailed review of flagship schemes such as Self Help Group (Umeed), Prime Minister's Employment Generation Programme (PMEGP), J&K Rural Employment Generation Programme (JKREGP) and Mission Youth initiatives like Mumkin, Tejaswini and Spurring Entrepreneurship.

The Chief Secretary noted the issue of overlapping mandates among schemes like JKREGP and Mission Youth. He called for greater coordination and data standardization for effective monitoring.

The meeting expressed concern over the high Non-Performing Asset (NPA) ratios in non-bank-supported schemes, particularly those being run by the J&K SC, ST & BC Development Corporation and JKWDC, with some NPAs reported as high as 45%. The need for tighter credit discipline and recovery mechanisms was emphasized.

The key suggestions put forward during the meeting included development of a single digital interface for the beneficiaries to access and apply for all self-employment schemes. Introduction of a common application form that can auto-suggest suitable schemes based on applicant data, was another

suggestion deliberated in the meeting. The Chief Secretary urged all the departments to work in synergy, optimize resource allocation and bring about a transparent, inclusive and result-driven self-employment ecosystem across J&K.

Revitalize checking system to stop entry of adulterated food stuff to Kashmir

Few days back the Food Safety Department seized a huge shipment of rotten meat from an industrial estate in the outskirts of the Srinagar city. The department seized 1200 kilograms of rotten meat from the premises of an industrial unit in the industrial estate at Zakura. The officials of the department had said that the consignment of rotten meat was meant to be supplied to the different hotels located across the Srinagar city.

Initially it was made out that the rotten meat was meant to be supplied to a leading hotel of Srinagar, but later on the situation changed and it was made public that the meat was meant for multiple hotels and not one hotel. Since the consignment was huge and it consisted of 12 quintals of rotten meat one fails to understand how such a huge quantity reached Srinagar and then the Zakura area. This is a serious issue and needs answers from the people at helm.

The system of checks and balances seems to have gone awry in Kashmir and it is due to this reason that unchecked food stuff and other items enter the valley. In the past anything that was meant to enter the Kashmir valley was checked at Lakhanpur and Qazigund check posts. It seems the check posts have been wound up or the officials working there have been directed to let everything get in without any check whatsoever.

Since multiple government departments are entrusted with the responsibility of ensuring the safety and hygiene of the food stuff it is important that these departments work in unison so that no harm is caused to the common masses. Since it is the motto of all the government departments to provide relief to the people, all the practical and possible steps need to be taken in this regard. This would ensure that no food business operator takes the people for a ride and only hygienic food stuff is provided to the people of Srinagar and other districts of Kashmir.

As on date packaging food items manufactured by different companies have flooded the markets in Kashmir and there seems to be no quality check of the same. There are some food packets where there is no mention of the manufacturing and expiry dates and as such the health of the people is compromised. Proper packaging and labelling of the food packets should be ensured and any lacunae in this regard should not be tolerated.



Down The Memory Lane: A Rendezvous With Teacher of Teachers; Dr G Q Alaqaband

Entering the Govt. Medical College Srinagar main gate behind the wheel of his aqua coloured Fiat car, Prof. G.Q. Allaqband was a familiar sight at GMC Srinagar.

He would step out dressed in his signature small-check half-sleeve shirt, a crisp white coat invariably worn over it, glistening white beard neatly trimmed, spectacles perched gracefully, and brown, polished laceup shoes that reflected the same quiet discipline he carried into his clinical rounds.

His confident gait and calm authority needed no introduction.

As he made his way to Ward 3, Govt. SMHS hospital Srinagar, Kashmir the usual crowd of attendants with their steel tiffins would instinctively step aside.

The gatekeeper, busy as always with managing entry and exit, would suddenly get super alert, to let him pass without delay.

Prof. Allaqabband didn't need to announce his arrival—his presence spoke for itself.

One memory of him remains

I was a third-year MBBS student, still in the early stages of developing a clinical eye. I had been assignedmore accurately, compelled—to present a case.

The patient was an elderly man with left-sided weakness. I had taken the history, though truthfully, history-taking felt tedious and mechanical at the time—something to "get through" rather than learn from.

The patient was admitted to Ward 3. I don't remember the exact bed

Nevertheless I remember he was on the right-side wing of the male section, a few beds away from the

I remember the tension in the air as students gathered in a circle and Prof. Allagaband took his seat on a wooden stool nearby

After hearing the brief history, he rose and examined the patient him-

What followed was an elegant demonstration of bedside clinical medicine-eliciting reflexes, identifying subtle neurological signs, correlating findings with precision.

Each step was explained with clarity. We weren't just watching a physical examination—we were witnessing clinical mastery.

Then he took the case file, and instead of jumping to the conclusion, he began from the first page—the



patient's name, age, and date of admission. He explained how each entry in the record had its importance, and stressed how documentation was not a formality but a clinical tool. He advised us on how to write well, record carefully, and approach each case with discipline and detail.

And then came the questions: Adrenaline leached out of my adrenal glands

My heart started racing! "What made you ask that?" "What does that sign indicate?" "What else should you have considered?"

He guided our thinking without belittling our gaps.

He also checked our instruments our stethoscopes, reflex hammers, torches-emphasizing that clinical readiness started with simple tools. Preparedness, he taught us, was a form of respect—toward the patient, the profession, and oneself.

The session lasted over an hour, yet no one looked away. It wasn't just a clinical class—it was an experience. He transformed what I once considered mundane-like history-takinginto something essential, rich, and intellectually rewarding.

Prof. Allaqaband didn't teach with flair. He taught with depth. He showed us how to observe, how to question, how to think-and most of all, how

Long live the professor who reminded us that the foundations of medicine lie not just in books, but in careful listening, thoughtful examination, and meticulous recording.

The teacher of teachers Prof. G.Q. Allaqaband, Also we must read and listen to his hardships, the challenges he faced, how he rose through perseverance, how he qualified both MRCP London & Edinburgh in the first attempt and FRCP finally.

Cycle of professional limbo

In the classrooms of Jammu and Kashmir's higher education institutions, thousands of educated, experienced, and committed contractual teachers continue to serve under conditions of extreme uncertainty. These teachers, many of whom hold PhDs and have cleared competitive national eligibility tests, are engaged year after year on short-term contracts. Their appointments are often renewed semester-wise or annually, keeping them in a cycle of professional limbo. Despite playing a vital role in delivering college education across the Union Territory, their contributions remain undervalued by the system they loyally serve.

Over the years, these teachers have filled the vacuum created by unfilled permanent posts, shouldering equal academic responsibilities with fewer rights and significantly lower pay. Their work is indispensable, but their status is temporary. They are not entitled to regular salary structures, social security benefits, or long-term academic planning privileges. Their engagement is subject to arbitrary renewals, with no clarity on their future or recognition for past service.

Adding to the sense of betrayal are the broken promises made by political figures and administrative heads. Political leaders have, in various public forums, assured regularization and fair treatment of these teachers. However, no policy initiative has materialized to address their longstanding issues. These empty promises have only intensified the frustration and despair within the teaching community. What is being witnessed is not merely administrative apathy but a systemic disregard for academic labour.

The Indian Constitution, though not providing an explicit guarantee of employment, offers a moral and legal framework that these teachers believe is being violated. Article 14 ensures equality before the law and prohibits discrimination. Yet, contractual teachers doing the same work as their permanent colleagues continue to be treated unequally. Article 16 talks about equality of opportunity in matters of public employment, which these educators are denied, despite years of service and experience. Furthermore, the Directive Principles of State Policy — particularly Articles 39 and 41 — call upon the state to ensure the right to work and adequate means of livelihood. The continued exploitation of qualified teachers on temporary

contracts clearly undermines these constitutional

The negative effects of this prolonged career instability are wide-ranging and deeply damaging. Economically, these teachers live under constant stress. Their salaries, often much lower than those of permanent teachers, are not only meagre but frequently delayed. Many contractual educators go unpaid for months at a time, forcing them to borrow money, cut down on basic needs, or seek part-time work just to survive. Without any provision for provident fund, pension, health insurance, or even maternity leave, they face total financial insecurity. Their status as temporary employees also disqualifies them from availing bank loans, home mortgages, or education loans for their children. Even planning for future life events such as marriage, home ownership, or old age becomes impossible under such economic instability.

The psychological burden is no less serious. Constant fear of contract termination, year-to-year unpredictability, and lack of institutional respect lead to high levels of stress, anxiety, and depression. These teachers work with full sincerity and commitment, yet their position in the institution remains unacknowledged. This feeling of being undervalued erodes their self-confidence and leads to emotional burnout. The lack of a stable identity within the academic community also creates a sense of alienation and helplessness.

On a professional front, career instability prevents growth and innovation. Temporary teachers often shy away from investing in research, curriculum

planning, or long-term academic projects because they are unsure of whether they will be retained for the next academic session. Opportunities for research grants, academic conferences, or publications are often denied to them due to their nonpermanent status. The years they spend teaching are often not counted when applying for permanent posts, thereby penalizing their commitment. This leads to stagnation, where their qualifications and experience are effectively wasted.

The instability also has serious social repercussions. Many teachers are unable to start families or provide stability to their children due to their precarious incomes. Strained family dynamics, disrupted social lives, and feelings of inferiority in peer circles are all common. The community begins to see them as "failed professionals," despite their qualifications, simply because they do not have a permanent government job — a benchmark for social respectability in many parts of India.

Moreover, the consequences are not limited to the teachers alone. The larger education system also suffers. A teacher who does not know whether they will have a job next semester cannot be expected to fully engage with students or commit to long-term academic goals. Students lose the opportunity to learn from consistent mentors. Institutional planning, academic continuity, and the overall educational experience deteriorate when teachers are frequently rotated or replaced. The $result is a diluted \ quality \ of \ education - an \ outcome$ that ultimately harms the students and the reputation of the institutions involved.

The situation calls for an urgent and compassionate policy response. Jammu and Kashmir must not lag behind other Indian states that have formulated regularization policies for long-serving contractual staff. It is imperative to implement a clear, transparent, and fair framework that recognizes the experience and qualifications of contractual teachers. This should include regular monthly salaries in accordance with UGC norms, access to social security and medical benefits, and consideration for regularization after a fixed number of years of service. Contracts should be renewed on time, and delays in salary disbursement must be eliminated.

Education is the cornerstone of societal development, and teachers are its foundation. When the teachers themselves are unstable, insecure, and underappreciated, the entire educational structure is weakened. The contractual college teachers of Jammu and Kashmir are not seeking charity — they are demanding justice, dignity, and recognition. Their voices must be heard, not just for their own welfare but for the future of the students they teach and the society they serve.

IS THE INDIA BLOC A MAGNET FOR ROHINGYAS AND INFILTRATORS?

It has often been said that the true test of a political formation lies not in the slogans it chants, but in the silence it maintains. The INDIA bloc—a loose confederation of regional 'leaders' with a rapidly fading Congress party-has, once again, chosen to speak in panicked tones where silence might have served it better. The controversy surrounding SIR (Special Intensive Revision) has offered more than just a bureaucratic or procedural flashpoint. It has become a moral mirror, and one in which the INDIA bloc finds itself unable to look without wincing.

At its core, SIR is a measure to protect the most sacred aspect of Indian democracy-the integrity of the voter roll. It seeks not to target communities but to identify those who have entered the republic through extra-constitutional means and subsequently altered the balance of both demography and democracy.

The INDIA bloc claims to be the guardian of democracy, secularism, and constitutional morality. But scratch the surface, and a disturbing pattern emerges -a pattern that reveals not democratic idealism, but demographic opportunism. The fierce opposition to the Election Commission's SIR exercise exposes the bloc's most uncomfortable truth: it sees illegal migrants and infiltrators not as threats to national security, but as assets to its electoral arithmetic.

At the forefront of this resistance stand three familiar faces—Mamata Banerjee, Tejashwi Yadav, and Rahul Gandhi. All three leaders have launched scathing attacks on the SIR, labelling it a "conspiracy", a "targeted operation", and an "anti-minority witch hunt". But the real question is, what are they trying to hide? For them, the voter is no longer a citizen, but a statistic, one to be preserved not for their rights, but for their reliability in the voting booth. Mamata Banerjee's hyperventilation against the SIR is telling. Here is a Chief Minister who once brazenly claimed that "one crore people in Bengal are already illegal migrants"—only



to now call voter list verification an "ethnic cleansing exercise".Her paranoia is not unfounded. Bengal's border districts-Malda, Murshidabad, North 24 Parganas—are ground zero for unchecked migration. Over the years, her government has looked the other way as entire villages have been settled by illegal Bangladeshi entrants and Rohingyas, who are then given ration cards, Aadhaar IDs, and ultimately voter cards. SIR threatens to dismantle this vote bank empire. Lashing out at Mamata Banerjee in a meeting, Prime Minister Narendra Modi asserted a stern message. He stated, "In West Bengal, Trinamool, of its self-interest is putting Bengali identity at stake. Infiltration has increased, with a forged documents eco-system developed by the TMC. Bengal and the country's safety and

In Bihar, Tejashwi Yadav's resistance to SIR reeks of desperation. With Lalu Prasad's brand of caste calculus running out of steam, the RJD has been silently banking on demographic shifts in Seemanchal and border belts to tip the scales. And SIR now threatens to pull

 $Rahul\,Gandhi, as\,always, speaks\,of\,"protecting\,the$ soul of India". But this soul-searching has no space for national security, demographic stability, or voter legitimacy. The Congress' silence on illegal migration is not just strategic — it's suicidal. From Assam to Delhi, Congress governments in the past have either enabled or ignored infiltration. Now, stripped of its traditional base, the party sees the illegal vote as a survival strategy.

This is not the first time India has grappled with illegal immigration. From the days of Shyama Prasad Mookerjee, who warned against unchecked infiltration, to the Assam Accord, which tried in vain to draw a constitutional line, the Republic has always known

that citizenship cannot be based on convenience.But the INDIA bloc, true to its nature, has chosen to peddle old rhetoric: that SIR is an attack on minorities, that it is a communal ploy, that it seeks to divide. This is not conviction—it is camouflage.

The real fear is that SIR will unveil how deeply the electoral base in several eastern constituencies has been distorted by undocumented and politically nurtured settlements. That it will expose how entire Assembly segments were engineered not by democratic mobilisation, but by demographic manipulation.

There is a deeper philosophical question here—one that the INDIA bloc seems incapable of answering. What does citizenship mean in a post-Partition, plural republic like India?

If everyone who enters becomes indistinguishable from the citizen, if the sanctity of borders can be dissolved with political intent, and if voting rights can be quietly handed out in exchange for electoral returns, then we must ask: what remains of the nation?

The INDIA bloc's refusal to support SIR is not rooted in ideology. It is rooted in the absence of one. Their politics thrives not on the strength of an idea, but on the preservation of ambiguity, illegality, and vote bank arithmetic.In a democracy that values transparency, legitimacy, and the rule of law, SIR is not just a policy tool—it is an act of national introspection. It calls upon the state to ask: Who belongs? And perhaps more importantly, who doesn't?

That the INDIA bloc has chosen to oppose this is neither surprising nor new. It merely confirms what the public has long suspected —that this alliance has no vision for India, only a strategy to retain fragments

In that sense, SIR has done more than trigger a political storm. It has exposed the intellectual, political and ethical bankruptcy of a coalition long past its expiry date. And in doing so, it may have offered the Republic a chance — however fraught — to reclaim its original promise and infiltrators? If the SIR is allowed to succeed, it won't just clean up electoral rolls. It will clean up the political rot that feeds on ghost votes and silent demographics. And that's exactly why the INDIA bloc is terrified, because when the illegal vote dies, their politics dies with it.

India, Philippines hold joint Naval exercises in South China Sea while Philippines President is in India

NEW DELHI, AUG 5: India and the Philippines staged joint naval exercises in South-China Sea or 'West Philippine Sea' (as Philippines calls it) coinciding with the five-day State visit of Philippines President Ferdinand Marcos Jr to India while both countries signed a Strategic Partnership agreement to strengthen cooperation in Defence, security, maritime, health and several other sectors.

West Philippine Sea (WPS) is the designation by the Philippines government to parts of the South China Sea that are included in the country's exclusive economic zone. The term "West Philippine

Sea" has been in use by the international community since 1961. It was used to refer to the western portion of the Philippine Sea which is East of the Philippine

Philippines Army Chief Gen. Romeo Brawner said the joint naval exercises which began on Sunday were successful.

Asked if Chinese forces carried out any action in response, Gen Brawner said they did not experience any untoward incident. The Manila Times, a Philippines daily, said two Chinese Navy Warships were spotted shadowing Philippine and Indian ships in the West Philippine Sea.

He described the exercises as



a "show of unity" between India and the Philippines.

In Beijing Chinese Foreign

Ministry spokesman Guo Jiakun said disputes over territory and maritime rights and interests should be settled through negotiations and consultation by countries directly concerned and no third party is in any position to interfere in that.

The spokesman was asked about China's reaction on the India-Philippines joint exercises in the South China Sea. Three Indian Navy ships INS Mysore, INS Kiltan and INS Shakti participated in the joint exercises.

During the ongoing State visit of the Philippines President to India, both India and the Philippines signed a Strategic Partnership Agreement and agreed to strengthen cooperation in Defence, maritime and security areas among others. UNI RB 1940

Norway-Denmark-Sweden unveil joint military package for Ukraine

OSLO, AUG 5: Norway, Sweden and Denmark have unveiled a joint military support package for Ukraine, aimed at securing urgently needed US-made defence equipment through an initiative coordinated by the North Atlantic Treaty Organisation (NATO), the Norwegian government announced today.

The three Nordic countries will jointly finance one of the first aid



packages under the new US initiative known as the Prioritised Ukraine

Requirements List (PURL), which is designed to expedite the delivery of critical military supplies to Ukraine.

Under the plan, Ukraine will receive American-made air defence systems, including additional missiles for the Patriot system.

and the administration to expedite the relief and rescue operations, and to deploy additional NDRF teams if needed," he added.

Meanwhile, Rahul Gandhi said, "The news of severe devastation caused by a cloudburst in Dharali, Uttarakhand, leading to the death of several people and many others going missing, is extremely tragic and concerning".

Extending condolences, Rahul said, "I extend my deepest condolences to the affected families and hope for the swift recovery of the missing individuals". Emphasising the urgency of the situation, he appealed to Congress leaders and workers to support the administration in relief efforts and assist those affected in every possible way.

US federal court redirects border agents to stop deportations, overriding President Trump's asylum ban

WASHINGTON, AUG 5: In an upset to US President Donald Trump's anti-immigration stance, a federal court has redirected American border troops to stop their deportation of migrants, ruling that presidential order could not be used to cut off humanitarian support for potential asylum seekers, two Department of Homeland Security officials told CBS News.

Asylum and migration have been one of the cornerstones of the second Trump administration, with border agents allowed full hand to deport illegal migrants without valid permits. The move did indeed manage to curb immigration by a massive degree, particularly from the US-Mexico border, which recorded the lowest



level of migration so far.

The scale of deportations by the Trump administration has been unprecedented, with border agents not allowing any asylum seekers to enter in a bid to undo the damage caused by the alien 'invasion' under the previous Biden administration, where immigration was noted to be at its highest.

On Friday, a federal appeals

court lifted its pause on a lower judge's ruling that found Trump's decree to be in violation of US asylum laws. While the appellate court narrowed the lower court's order, saying that the POTUS' proclamation could be used to pause access to the asylum system, it also ruled the US government could not disregard other laws that bar officials from deporting migrants to places where they could be tortured or persecuted. Officials at Customs and Border Protection were instructed this weekend to halt deportations, thus effectively cancelling Trump's proclamation and to process migrants under the US immigration law, which affords foreigners on American soil the right to request humanitarian refuge, the two anonymous DHS officials said. While the court order could potentially reopen Washington's asylum system, it is unlikely to affect the status of those found crossing the southern border illegally. These people will likely remain detained while officials vet their claims.

The Trump administration has largely stopped the practice of releasing migrants onto American soil while they await their court dates, limiting releases to cases stances. The Justice Department could also try to get Friday's court order suspended by the Supreme Court, in a bid to revive the POTUS' asylum ban. In a statement to CBS News late Monday, CBP said Friday's court order affirmed "the President's authority to deny asylum to aliens participating in an invasion into the United States." CBP said the Trump administration is "committed to ensuring that aliens illegally entering the United States face consequences for their criminal actions." "This includes prosecution to the fullest extent of the law and rapid removal from the United States," the agency added.

Iranian crude oil to China declines significantly due to increased sanctions by US

BEIJING/TEHRAN, AUG 5: In a strong hit to Iran's economy, Chinese for crude oil purchases from the Middle East nation have fallen considerably, dipping to less than a third of what it was in July,

reports Iran International. Purchases fell to about 1.2 million barrels per day, nearly 30% lower than in June and slightly below the year-ago level, the drop following a sharp uptick witnessed in June when the demand exceeded to over 1.7 million barrels.

The rise in Chinese oil purchases was attributed to the Iran-Israel war, with experts noting that merchants bought Iranian crude in 'rush' fearing Tehran's supply fall owing to the war, un the backdrop of growing uncertainties back in June. The slowdown in shipments comes as the United States has stepped up enforcement of sanctions targeting Iran's oil trade. The US Treasury said last week it imposed measures against a fourth Chinese oil terminal allegedly handling sanctioned Iranian crude. The announcement followed broader sanctions on more than 50 individuals, entities, and vessels tied to what the US Treasury described as a "shipping empire" connected to Hossein Shamkhani, son of a

senior adviser to Iran's Supreme Leader. Iran's export capacity is constrained by aging oil fields, rising domestic demand, and low investment, leading to a greater fall in its rich oil industry.

For Iran, which is already undergoing crippling sanctions, and a sociopolitical-economic damage in the wake of the massive Israeli attacks, the news does not bode well, as China remains the largest buyer of Iranian crude oil, with Tehran selling its oil to Beijing at massive discounts. UNI ANV SSP

DFCO cancels sale licenses of 8 pharmacies, suspends operations of 75 retail sale establishments

SRINAGAR, AUG 5: In a significant move to ensure the public safety and curb the misuse of pharmaceutical drugs, the government of Jammu & Kashmir has launched a special enforcement drive across Jammu and Kashmir, targeting the pharmacies and drug outlets for compliance with legal and regulatory

During the drive, the officers of Drug & Food Control Organization (DFCO) carried out surprise inspections at various locations across the districts of Jammu & Kashmir. The objective of the initiative is to identify the pharmacies operating in violation of the Drugs and Cosmetics Act, 1940 and to strengthen the mechanisms preventing the unauthorized sale of psychotropic substances and prescription

Pertinently, the inspection teams cancelled the Drugs Sale Licenses of eight pharmacies for nonmaintenance of sale records of habit forming drugs and not adopting the computerized system of billing for maintenance of sales records. These included M/s Aatir Enterprises Ganjiwara Anantnag, M/s Al-Mehdi Medicate, M/s Shehjar Pharmacy Budgam, M/s Medicity Pharmacy, Chadoora,, M/s New Bhat Medicate Chadoora, M/s Dar Medicate Qazipora, Chadoora, Budgam, M/S Pharma Plus Medicare Near Zara Diagnostic Lab Kheora Rajouri and M/s Happy Saini Medical Hall, Haria Chak, Marheen.

Besides, the operations of seventy five retail sale establishments were disallowed on the spot under section 22 (d) of Drugs & Cosmetics Act, 1940 on spot for non maintenance of sale records, impersonation and improper storage conditions. These included 9 each in Jammu, Rajouri and Anantnag; 6 each in Kupwara and Budgam districts; 5 each in Udhampur and Kulgam; 4 in Pulwama, 3 each in Kathua, Samba, Ramban, Doda, Baramulla and Shopian districts; 2 in Poonch district, 1 each in Kathua, Ramban, Reasi, Kishtwar, Srinagar and Ganderbal.

Likewise, the statutory drug samples of more than 500 formulations of various categories were lifted randomly for determination of strength and purity. These samples were referred to the Drug Testing Laboratories located within J&K for framing of legal opinion to ascertain their quality parameters.

Besides, stocks of drugs worth Rs 8,40,348, found to be contravening the provisions of the D&C Act, have also been confiscated from the supply chain by the Regulatory Officers of the organization under section 23 of the Drugs & Cosmetics Act.

Lotika Khajuria, State Drugs Controller, J&K has once again impressed upon the trade fraternity to follow the conditions of licenses in letter and spirit.

LONDON: Former England captain Michael Vaughan has strongly endorsed Harry Brook as the ideal successor to Ben Stokes in the Test format, citing the 25-year-old's leadership qualities, temperament, and recent matchwinning form. Brook's explosive 111 off 98 balls in the ongoing Test not only pulled England back $into\,contention\,but\,also\,reaffirmed$ Vaughan's belief that the Yorkshire batter is destined for a bigger role

"Harry Brook, to me, looks a leader. He looks a born leader," Vaughan said while speaking on the Test Match Special podcast. "When you watch him on the field, there's a certain presence. He doesn't just bat with authority - he carries himself like someone who could run the

Brook's recent appointment as England's white-ball captain and his successful series win against the West Indies have added weight to Vaughan's argument. Though the West Indies were far from their best, Brook's calm decision-making and confident handling of the squad marked a promising start to his leadership journey.
In contrast, Vaughan cast

some doubts over current vicecaptain Ollie Pope's suitability for the top job. While acknowledging Pope's tactical awareness and value as a deputy, he questioned whether the 27-year-old had the assertive leadership qualities needed to take charge

"Ollie Pope is a fantastic deputy. He's intelligent, sharp, and probably one of the best people to have alongside a captain. But that doesn't always translate into

being the main leader. I've seen it before - Marcus Trescothick was my perfect vice-captain, but no one saw him as a captain-in-

Pope is currently captaining England for the fifth time, having stepped in for Stokes previously due to injury. Though he's regarded as a core part of the team's future, Vaughan believes leadership demands a different mindset — one that Brook seems to have

"We shouldn't just think about hierarchy. It's not about who's next in line, it's about who leads best under pressure, who players respond to, and who sets the tone. Brook ticks those boxes for me," Vaughan said.

He also emphasized that modern cricket requires bold, instinctive leaders — captains who are willing to take risks, much like Stokes himself. "You need someone who isn't afraid to back their gut, to make a call even if it's unpopular. Brook has shown he has that kind of edge — both as a batter and as a leader."

Vaughan's comments come at a crucial juncture as England face a transition phase in leadership, with Stokes battling recurring injuries and workload concerns. While the England and Wales Cricket Board (ECB) has yet to make any announcements regarding long-term captaincy plans, Brook's name is now firmly in the mix, thanks to Vaughan's strong endorsement.

As England eyes a fresh leadership blueprint in the post-Stokes era, Brook's poise under pressure, coupled with his already-growing reputation as a match-winner, may just give him the edge over others in the leadership race.

Tauson Stuns Swiatek to Reach Montreal **Quarters**

MONTREAL: Clara Tauson of Denmark upset second-seeded Wimbledon champion Iga Swiatek of Poland 7-6 (1), 6-3 on Sunday night to reach the National Bank Open quarterfinals.

The 6-foot Tauson, seeded 16th in the hard-court event that ends Thursday, avenged a loss to Swiatek at Wimbledon to set up a match Tuesday with sixthseeded Australian Open winner Madison Keys of the United States.

"I think, obviously, getting a win against her after losing to her in Wimbledon a couple of weeks ago is, obviously, nice, because I was not feeling great in that match, and I felt like I was playing some good tennis in Wimbledon," Tauson said. "So I felt like if I could keep that going, I thought I had a shot."

Tauson won her lone tour title in New Zealand in January, beating fellow Montreal quarterfinalist



Naomi Osaka of Japan in the final.

Keys outlasted 11th-seeded Karolina Muchova of Czechia 4-6, 6-3, 7-5 in the windy afternoon session. "Clara's a fantastic ball-striker," Keys said about the quarterfinal match. "She's got a big serve. She's got a lot of power on both sides. She covers the court quite well on top of everything, so I feel like she's one of those matches where you kind of have to temper

a little bit and not go for things too quickly.' Osaka also advanced in the afternoon, routing Anastasija Sevastova of Latvia 6-1, 6-0 in 49 minutes - the second-fastest victory of her career. Osaka had

a 42-minute victory in a 2016 event in Brazil. Osaka reached the final eight of a WTA 1000 or Grand Slam event for the first time in 19 months. On Tuesday, she will face 10th-seeded Elina Svitolina of Ukraine, a 6-4, 6-1 winner over fifth-seed Amanda Anisimova of the United States.

On Monday night in the quarterfinals, 18-year-old Canadian Victoria Mboko will face Jessica Bouzas Maneiro of Spain, and Marta Kostyuk of Ukraine will meet ninth-seeded Elena Rybakina of Kazakhstan.
