

# **Drawing Protests From Opposition, The Draft Laws Referred To JPC**

After HM Amit Shah Introduced Bill for Removal of PM, CM, Ministers Who Face Arrest On Criminal Charges

NEW DELHI, AUG 20: Union Minister Amit Shah on Wednesday introduced three Bills in Lok Sabha for the removal of Prime Minister, Chief Ministers and Ministers arrested on serious criminal charges for 30 days, drawing fierce protests from the Opposition as the draft laws were referred to a Joint Committee of Par-

Amid repeated disruptions, Shah introduced the three Bills as a resolution was passed by a voice vote to

refer the measures to a Joint Committee of Parliament comprising 21 members from Lok Sabha and 10 from

Rajya Sabha. The Committee has been mandated to submit its report to the House by the last day of the first week of the next session. The next session (Winter session) of the Parliament is likely to be convened in the third week of November.

As soon as the Bills were tabled, the Opposition members began protesting and trooped into the well, raising slogans. Some even tore copies of the Bills in front of Shah.

Opposition MPs, including AIMIM's Asaduddin Owaisi and Congress' Manish Tewari and K C Venugopal, spoke against the introduction, terming the proposed law against the Constitution and federalism, while Shah rejected criticism that the Bills were brought in haste.

The Home Minister also said that the Bills will be sent to the Joint Committee of Parliament where members of both Houses, including those from the Opposition, would get an opportunity to give their suggestions.



When Venugopal raised the issue of Shah's arrest while he was the Gujarat home minister and asked about his claim of morality in politics, the senior BJP leader countered, saying he had resigned on moral grounds before his arrest and joined the Government only after being discharged by the court.

"We cannot be so shameless that we continue to occupy constitutional positions while facing serious charges," Shah said.

Amid continuous noisy protests, the House was adjourned till 5 pm as Speaker Om Birla repeatedly asked the Opposition members to take their seats and maintain the dignity of the

Earlier in the day, as the protests escalated, there was a brief jostling between Opposition and ruling party MPs with BJP members, including Union Ministers Ravneet Singh Bittu and Kiren Rijiju, stepping in to shield Shah.

Three House marshals formed a protective ring around Shah. Even after the House was adjourned,

## Day 07: Rescue ops continues in Chasoti village

**SRINAGAR, AUG 21:** Rescue operations in Jammu and Kashmir's Kishtwar district entered seventh consecutive day on Wednesday, following the devastating cloudburst that triggered flash floods in Chasoti village on August 14, officials said on Wednesday.

The officials said that four specially trained sniffer dogs from the National Disaster Response Force (NDRF), along with eight handlers from Punjab, have been deployed to assist in the search for missing persons.

The dogs, trained to detect human remains, have already helped in locating four bodies and continue to be used extensively across debris-laden zones, they said.

The disaster has so far resulted in 65 deaths, with over 70 individuals still reported missing. The officials said bodies are still being recovered from various locations near the site of the cloudburst. Search operations are ongoing across multiple sectors, with teams using heavy machinery and manual methods to locate the missing.

Locals have been moved to nearby villages where temporary relief camps have been established to provide food, shelter, and medical aid.

The cloudburst struck near Chasoti village, which is located on the route of the annual Machail Mata Yatra, a major pilgrimage that draws thousands of devotees to the Chandi Mata temple in the remote Paddar Valley. The pilgrimage, which began on July 25 and is scheduled to continue until September 5, was halted due to the disaster.

SRINAGAR, AUG 20: Chief Minister Omar Abdullah today chaired a highlevel meeting to review the progress of financial inclusion schemes, social security coverage, district capex and progress of Constituency Development Fund (CDF) works programme. Chief Minister also reviewed the GST collection - tax and non-tax revenue for the current financial

The meeting was attended by the Advisor to the Chief Minister Nasir Aslam Wani, Additional Chief Secretary to the CM Dheeraj Gupta, all Administrative Secretaries, Deputy Commissioners of all districts, and other concerned, both in person and through virtual mode.



Principal Secretary Finance, Santosh D. Vaidya, gave a detailed presentation on the financial and social inclusion schemes, revenue generation trends and district-wise progress under capex and CDF works.

The Chief Minister noted tardy pace in uploading & tendering of works and issued directions to all departments and districts to focus on revenue realization & social inclusion schemes and monitor progress on a monthly basis rather than leaving corrective measures to the last quarter of the financial year.

"Departments must not wait for February and March to chase revenue targets. Each department will receive specific communication from the Finance Department flagging their areas of concern and giving a six-month revenue target breakdown. They should start working on improving revenue realization today, with a clear monthly plan," the Chief Minister stressed.

## CS, ICRISAT Discuss 'Climate Smart Agriculture'

SRINAGAR, AUG 20: Chief Secretary, Atal Dulloo, today held detailed deliberations with a delegation from the International Crops Research Institute for Semi-Arid Tropics (ICRISAT), Hyderabad, to advance the agenda of Climate Smart Agriculture in the Union Territory of Jammu and Kashmir.

The delegation, led by Dr. Stanford Blade, Deputy Director General, ICRISAT, also included Senior Scientists, Dr. Manzoor Dar and Dr. Demaris Odeny, while Professor Haroon Naik, Director Research, SKUAST-Kashmir, was present during the meeting.

The discussions primarily revolved around the establishment of Himalayan Centre of Excellence for Dryland Agriculture at SKUAST-K, envisioned as a landmark initiative to position J&K as a leader in climateresilient and sustainable agriculture.

The proposed Centre will serve as a hub for research, innovation and technology dissemination suited to the unique agro-ecological conditions of the Himalayan region. Its focus areas will include development of climate-resilient crop varieties, strengthening decentralized seed systems, promoting regenerative and dryland farming practices and advancing soil and water conservation besides enhancing farmer-centric value chains across the UT.

A key part of the deliberations highlighted the critical importance of fodder security for J&K. With a large proportion of farming households dependent on livestock particularly in hilly and rainfed areas.

The Chief Secretary was apprised of the urgent need to strengthen fodder development programs. He was informed that ensuring year-round availability of quality fodder would improve livestock

## 6200 food samples fail safety tests in J&K over 5 years

SRINAGAR, AUG 20: Jammu & Kashmir has reported alarming levels of food adulteration in the past five years, with more than 6,200 food samples failing safety standards out of 41,717 tested, according to data presented in Parliament.

The figures show that nearly 15 per cent of food items analyzed between 2020 and 2025 were found unfit for consumption.

## **J&K** receives normal rainfall in last 81 days

MeT predicts rains at isolated places till Aug 26

SRINAGAR, AUG 20: Amid the cloudbursts, flash floods, and heavy rainfall, Jammu & Kashmir has recorded normal precipitation in the last 81 days. As against the normal rainfall of 398.9 mm, the region has received 397.8 mm during this period.

The data prepared by the Meteorological Department (MeT) reveals that the region has recorded only a 5 per cent deficit in rainfall from June 1, 2025, to August 20, 2025.

Srinagar, the summer capital of Jammu and Kashmir, along with eight stations, including Baramulla, Doda, Ganderbal, Jammu, Kathua, Poonch, and Ramban, has recorded normal precipitation in the last 81 days, the data reveals.

Six other stations, including Anantnag, Budgam, Bandipora, Kulgam, Kupwara, and Pulwama, saw deficit rainfall ranging between 20% and 59%, it added.

Kishtwar district, despite witnessing massive flash floods triggered by a cloudburst, has recorded a large deficit in rainfall. Against the normal precipitation of 309.1 mm, the station has recorded only 91.8 mm. The Shopian station has also recorded a large deficit in rainfall of 70 per cent.

Reasi, Samba, and Udhampur stations have recorded excess rainfall ranging between 20% and 59% during the period, the data reveals.

## 65% of J&K's landslide areas classified as low risk, 12% high risk: Survey

**SRINAGAR, AUG 20:** Around 65% of Jammu and Kashmir's landslide-prone areas are classified as low risk, 23% fall under moderate risk, and 12% are identified as high-risk zones, according to the latest landslide susceptibility mapping by the Geological Survey of India.

The Government of India, according to the news agency-Kashmir News Observer (KNO), has made significant progress in mapping landslide-prone areas across the country, including Jammu & Kashmir (J&K), as part of its efforts to

manage natural disasters more effectively. The Geological Survey of India (GSI), the nodal agency for landslide studies, has completed comprehensive landslide susceptibility mapping for the entire landslide-prone hilly and mountainous regions, including Jammu &

According to the Ministry of Earth Sciences, the landslide susceptibility maps classify areas into low, moderate, and high-risk zones based on the likelihood of landslide initiation. In Jammu & Kashmir, about 65% of the landslide-prone area falls under the low-risk category, 23% under moderate risk, and 12% under high-risk zones.

This detailed mapping, created on a 1:50,000 scale, covers about 4.3 lakh square kilometers

## Railway Board Approves First Cargo Train Service From Delhi To Budgam In Kashmir Valley

**NEW DELHI, AUG 20:** The Railway Board has approved a cargo train between Delhi and Budgam in the Kashmir valley to benefit the local population and the business class.

A circular dated August 20 said the Railway Board examined the proposal of the Northern Railway Zone under which the Jammu Division falls, and decided to accord approval for a Joint Parcel Product-Rapid Cargo (JPP-RCS)  $train\,service\,on\,the\,Badgam-Adarsh$ Nagar(Delhi)-Badgam route on daily basis.

"The train service shall operate with

eight VPs (parcel vans) and one SLR (seating-cum-luggage rake). It will have an intermediate loading/unloading facility as Baribrahman (BBMN)," the circu-

It added that the service will initially run on pilot basis for one year from the date of operation.

"Northern Railway shall coordinate with the state police in matters connected to the security of running this train. Security of the parcels shall be ensured at both the originating and terminating ends. Scanning of the parcels shall be ensured in consultation with the state police," the Railway Board said.

## Assure speedy relief, restoration of services

KATHUA, AUG 20: Divisional Commissioner Jammu Ramesh Kumar and Inspector General of Police Jammu, B.S. Tuti today conducted an extensive tour of cloudburst and flash flood-induced landslide hit areas of Kathua district to assess the situation and review the ongoing relief and restoration measures.

At the relief camp established at SIDCO Ghati, the Div Com met the affected families of Jode area where five persons lost their lives in the recent calamity. He interacted with the displaced families, expressed deep concern over the loss of lives and extended condolences. He assured the victims of every possible support from the government and informed that immediate financial assistance under State Disaster Response Fund (SDRF) has already been provided by the District Administration. He directed Deputy Commissioner Kathua to ensure speedy restoration of road connectivity in the affected areas.

The Div Com also visited Dilwan village, which wit-



nessed significant damage to road infrastructure and habitations due to flashfloods. He directed the concerned Executive Engineers of PWD, PHE and PDD to work in close coordination for restoration of essential services in the shortest possible time to mitigate the hardships of the affected families.

Later, the Div Com visited Government Medical College, Kathua, where he met the injured persons of Jakhole and Janglote who were admitted for treatment. He enquired about their health and medical care being provided. He directed the GMC authorities and district administration to ensure best possible treatment and proper care of the injured and their families. Deputy Commissioner Kathua, Rajesh Sharma, apprised the Div Com that adequate medical facilities and all necessary assistance are being extended to the victims.

The three Bills are the Government of Union Territories (Amendment) Bill 2025; the Constitution (One Hundred And Thirtieth Amendment) Bill 2025; and the Jammu and Kashmir Reorganisation (Amendment) Bill

The Bills have proposed that if the Prime Minister, Union Ministers or Chief Ministers, are arrested and detained in custody for 30 consecutive days for offences that attract a jail term of at least five years, they will lose their job on the 31st day.

Opposing the Bills at the introduction stage, Owaisi said the Constitution is being amended to "destabilise governments".

Tewari echoed similar views, saying an individual is "innocent till proven guilty".

"This Bill is against the jurisprudence of criminal justice and distorts Parliamentary democracy. The Bill opens door for political misuse and throws all constitutional safeguards to the winds," he said.

RSP MP NK Premchandran alleged that the Bills are being introduced in "undue haste".

"These Bills are not being introduced as per the procedures of the House. What is the undue haste in bringing such important Bills that they have not even been circulated to the members," he said.

According to the Bill, there is no provision under the Government of Union Territories Act, 1963 (20 of 1963) for the removal of the Chief Minister or a Minister arrested and detained in custody on account of serious criminal charges.

Hence, there is a need to amend section 45 of the Government of Union Territories Act, 1963, to provide a legal framework for the removal of a Chief Minister or a Minister in such cases. (PTI)

The responsibility lies with each department to ensure timely progress," he emphasized.

During the meeting, it was noted that while social security schemes have shown impressive growth in recent years—with PMJDY account holders crossing 23 lakh, PMSBY enrollments touching 23.8 lakh account holders, and PMJJBY covering nearlv 9.83 lakh individuals.

Similarly, in respect of welfare schemes administered by Building & Other Construction Workers Board, the meeting was informed that 166.90 crore was disbursed to 2.5 lakh beneficiaries in 2024-25, yet active worker registration remains low, requiring expansion

The Chief Minister underlined the need to strengthen monitoring of both expenditure and revenue flows, ensure 100% uploading of works on BEAMS, and expedite accord of administrative approvals, tendering and execution of district capex works. He also called for intensified awareness campaigns to improve access to social security schemes and faster settlement of claims.

The Chief Minister reiterated his govern-

ment's commitment to social security, inclusive growth and fiscal discipline, while urging all departments and Deputy Commissioners to work in close coordination with the Finance Department to achieve the set targets.

Meanwhile, Director Meteorological Department (MeT), Dr Mukhtar Ahmad, said that generally hot and humid weather is expected, with a brief spell of rain and thunderstorms at a few places over the next two days, with isolated heavy rain over Jammu division, especially in Reasi, Udhampur, Rajouri, Kathua, and Samba, during late night

From August 23-26, he said, light to moderate rain and thunderstorms are expected at many places, with heavy rain at a few places in Jammu, including Jammu, Reasi, Udhampur, Samba, Kathua, and Rajouri, and in Anantnag and Kulgam districts of Kashmir, with moderate or intense showers over Poonch, Ramban, Doda, and Kishtwar.

He added that from August 27-30, hot and humid weather with a brief spell of rain and thunder is expected at a few places.

Moreover, in its advisory, the MeT has said that there is a possibility of intense, heavy rain and thunder at a few places in Jammu division and Kashmir division during August

As per the news agency—Kashmir News Observer (KNO), in 2020-21, 4,094 samples were tested, of which 871 were declared non-conforming, leading to 573 penalties.

In 2021-22, testing expanded to 8,109 samples, with 1,735 failing standards. That year also saw the highest enforcement, with 1,931 penalties imposed.

In 2022-23, authorities tested 13,502 samples—the highest in the period—but 1,195 failed to meet safety norms. A total of 1,592 penalties were issued. The following year (2023-24), 9,057 samples were tested, 750 were adulterated, and 1,612 penalties were imposed, including some pending cases from

previous years. In the current year (2024-25), 6,955 samples were tested, with 651 found unsafe, leading to 1,239 penalties.

Overall, Jammu and Kashmir recorded 6,202 non-conforming samples and more than 6,900 penalties between 2020 and 2025.

The Food Safety and Standards Authority of India (FSSAI) has been urging states and Union Territories, including J&K, to strengthen enforcement mechanisms and fill vacant posts of food safety officers.

The Health Ministry informed the Rajya Sabha that whenever samples are found nonconforming to provisions of the Food Safety and Standards Act, legal action and penalties are initiated against defaulters—(KNO)

across 19 states and union territories.

The GSI continuously updates its landslide database, which includes over 33,900 fieldvalidated landslides, supported by remote sensing and field data.

The maps and inventory are publicly accessible through the National Geoscience Data Repository and Bhukosh portals, helping authorities and stakeholders in disaster preparedness and land-use planning.

For more detailed local assessments, the GSI is also working on meso-scale mapping at scales of 1:10,000 and 1:5,000. In Jammu & Kashmir, this will enable more precise risk evaluations and guide safer infrastructure development. By 2028, 200 critical sectors across the country, including those in J&K, are targeted for completion of this highresolution mapping.

The government is actively enhancing landslide forecasting capabilities to respond to the increasing frequency of natural calamities. The Regional Landslide Forecasting System (RLFS), developed by GSI in collaboration with the Indian Meteorological Department and other agencies, provides early warnings based on rainfall and weather

This system supports disaster management authorities to take timely preventive actions in vulnerable regions.

Jammu & Kashmir, with its mountainous terrain and susceptibility to natural hazards, benefits from such forecasting efforts. While specific operational forecasts for J&K districts are currently under development, the government is committed to expanding these services across all high-risk zones.

The Committee also reviewed the implementation of Amnesty Scheme, RDSS, IPDS, PMDP and other ongoing projects.

 $The {\it Chair person}\, emphasized$ the need for result-oriented initiatives to address the power cuts and curtailment, prompt repair and replacement of damaged transformers, restoration of defunct street lights besides eradication of power theft.

She stressed the importance of ensuring scheduled power supply to consumers, particularly during peak hours.

The Committee called for effective resource mobilization for power generation, better manpower management and timely disposal of ex-gratia relief to the families of daily wagers/casual labourers who lost their lives in the line of duty.

The Chairperson directed for taking up the vacancies in the department with the recruitment agencies for early selection. She also asked for ensuring rationalization of staff for the convenience of the public.

The Committee further stressed on expediting fund utilization under RDSS and other

# 38th NCORD meeting held at Budgam

144 Kanals wild cannabis destroyed, 38 FIRs registered

BUDGAM, AUG 20: The 38th District-Level NCORD (Narco Coordination) meeting was held today in Budgam, under the chairmanship by Deputy Commissioner (DC), Dr. Bilal Mohi-Ud-Din Bhat to review ongoing measures against drug abuse and finalize fresh strategies for a drug-free Budgam. At the outset, DC took a detailed review of the action taken on previous NCORD decisions. It was informed that wild cannabis on 144 kanals of land has been destroyed in different parts of the district, besides 38

FIRs have also been registered against culprits involved in illicit cultivation, and also 57 arrests have taken place.

DC reiterated that drug abuse is a grave social problem, demanding deterrence, enforcement, treatment, and awareness as a multi-pronged strategy.

He directed for immediate execution of the District Drug De-Addiction Centre to strengthen treatment and rehabilitation facilities. DC directed BDOs, EOs, Agriculture, and Excise departments to clear all main roads from cannabis and poppy cultivation, particularly from Budgam to Chadoora, Magam, Beerwah, and Khag, and along Humhama to Budgam route.

He stressed that 100% CCTV and Computerized Billing Systems (CBS) be ensured in drug stores across the district, besides ensure continued monitoring of pharmacies with CCTV/CBS integration. It was informed that Budgam has 630 retail and 225 wholesale chemist outlets, all under strict monitoring.

Dr Bilal noted that 108 calls have been received on the Tele-MANAS mental health helpline, reflecting its growing role in community support.

SDMs were directed to convene meetings with religious scholars and stakeholders at subdivisional levels, encouraging sermons against drug abuse and formation of Nasha-Mukt Panchayats.

DC directed Rural Development Department to hold Gram Sabhas dedicated to drug abuse awareness. DSWO was directed to organize mega IEC drives across district for mass awareness.

CMO Budgam was directed to ensure 24x7 availability of medical facilities at the Addiction Treatment Facility (ATF) Centre in District Hospital Budgam.

DC underscored the importance of cooperation, coordination, and collaboration among departments and communities to eradicate the drug menace. He said that zero-tolerance against drug peddling will continue with strict punitive action against culprits while equal focus will be given to rehabilitation, awareness, and mental health support.

He urged all stakeholders, departments, institutions, civil society, and community leaders to work with collective resolve to break the drug supply chain and promote healthy, drug-free lifestyles.

The DC directed the REW Department to complete all SOS works by September 10, stressing that  $strict adherence \, to \, the \, set \, dead lines$ for estimation, tendering, and allotment will be mandatory. He asked the Executive Engineer REW to share real-time updates with BDOs to facilitate effective monitoring, while also instructing BDOs



to take personal responsibility for supervising field-level execution in mission mode.

Similarly, the DC laid down timelines for the 81 developmental works approved under the Constituency Development Fund (CDF), reiterating that 100% physical and financial targets must be achieved within the stipulated

Highlighting the geographical challenges of Ramban, the DC

"The present working season must be fully utilized. With the onset of winter, construction becomes extremely difficult in snow-bound areas. Any delay at this stage will directly hamper public welfare and development delivery."

The officers from Health, Education, Youth Services & Sports, Urban Local Bodies, and other departments also presented the current status of works under their sectors. The DC directed them to remove bottlenecks, ensure transparency, and resolve inter-departmental issues on priority. He also instructed SDMs and Tehsildars to extend complete cooperation to executing agencies and promptly address local-level hurdles, particularly in land clearance and commu-

nity coordination. The Deputy Commissioner further emphasized the importance of public accountability, instruct-

ing officers to make progress visible on the ground so that people gain confidence in the administration's commitment to inclusive growth. He said the district administration will regularly review progress and strict action will be taken against any officer or contractor found responsible for unnecessary delays.

The meeting concluded with a strong message from the Deputy Commissioner:

"Development is not just about numbers and budgets-it is about reaching every household with real benefits. The time has come to move beyond files and show visible results on the ground."

The renewed push is expected to bring greater momentum, efficiency, and accountability to Ramban's developmental landscape, ensuring that both urban and rural populations benefit from the ambitious District Capex Bud-

# **Advisor to CM meets KCCI delegation**

SRINAGAR. AUG 20: Advisor to the Chief Minister, Nasir Aslam Wani, chaired a high-level meeting to discuss the issues raised by  $the \, Kashmir \, Chamber \, of \, Commerce$ & Industry (KCCI), in Civil Secretariat, here today.

The meeting was attended by Additional Chief Secretary to the Chief Minister, Dheeraj Gupta, Commissioner Secretary, Industries & Commerce, S. Vikramjit Singh, Director, Handicrafts & Handloom, Kashmir, Mussrat Islam and President, KCCI, Javed Tenga, amongst others.

During the meeting, President KCCI raised the issue concerning handicrafts and handloom sector, particularly in light of the recent Notices issued by the Department of Handicrafts and Handloom to the Kashmir Handicrafts showrooms regarding sale of machine-made products along with handcrafted items. He also raised the issue of expediting testing and certification of GI room was blacklisted for selling



products at PTQCC lab at Baghe-Ali Mardan Khan.

The Advisor was briefed by the Department about the background of the Notices issued, in light of the formal complaint lodged by tourists for being sold machinemade imitations in the garb of Kashmir Handicrafts. He was informed that in one serious case of unfair trade practice, one show-

a counterfeit product and pasting a fake GI label on it, with the sole intention to dupe the buyer.

Reiterating the Government's resolve to secure the interests of talented artisans and weavers of Kashmir, Nasir Aslam directed the department to submit a comprehensive proposal for safeguarding the interests of the artisans as well as the business stakeholders associated with the crafts trade. He

further advised the KCCI delegation to initiate formal discussions with the Department of Handicrafts & Handloom, Kashmir, and to submit a comprehensive proposal at the earliest for consideration of the Government to allow the sale of machine-made products, provided they are properly labeled and segregated as a distinct product category. This would ensure transparency and prevent buyers from being misled into purchasing misbranded goods.

The KCCI delegation was also urged to sensitize all dealers about the importance of protecting and promoting authentic Kashmiri handicrafts. The Government, it was emphasized, will take strict action against mislabeling, misbranding, and deceptive alterations of products that are intended to pass off as genuine Kashmiri handicraft items.

Commissioner Secretary Industries & Commerce briefed the Advisor about the steps taken by the Department to upgrade the testing labs, in particular PTQCC, which has acquired new digital microscope and is in the process of procuring more high-end machines like SEM and additional HR Digital Microscope to further enhance the rate of testing of GI registered products.

The KCCI delegation also apprised the Advisor to the Chief Minister of the adverse impact on genuine hotels and restaurateurs caused by the sale of sub-standard meat by unscrupulous elements. They urged the Government to identify the suppliers of such harmful meat along with their entire supply chain.

In response, the Advisor assured the delegation that the Government is taking all necessary measures to curb the supply and sale of unsafe food. He emphasized that public confidence can only be restored when those engaged in the trade proactively educate consumers about food safety and the hygienic practices being followed, as public health remains a matter of par-

## MD-JJM Reviews Implementation of Jal Jeevan Mission in Tangmarg Subdivision, Inspects WSSs

BARAMULLA, AUG 20: Continuing the government's efforts to provide safe and adequate drinking water to every household, Mission Director (MD), Jal Jeevan Mission (JJM), J&K, Khurshid Ahmad Shah, today reviewed the implementation of JJM in Tangmarg subdivision and carried out an extensive tour to inspect various Water Supply Schemes (WSSs).

He was accompanied by Superintending Engineer (Hydraulics) Baramulla/Bandipora, Faisal Abdullah; Executive Engineer FBI Division Tangmarg; and other sub-divisional officials.

Progress Review & Achievements During the review meeting, it was informed that:

Out of 23 Water Supply Schemes, 16 have been completed, while work on the remaining is in progress.

Of the 38 allotted works pertaining to the civil component, 27 have been completed, while the rest are at different stages of execution.

These works include Bore Wells, Rapid Sand Filtration Plants (RSFPs), Over Head Tanks (OHTs), Pipe Networks, Slow Sand Filtration Plants (SSFPs), General Service Reservoirs (GSRs), and Pump Rooms.

Officials apprised the Mission Director that out of 19,098 total households in the Tangmarg subdivision, ner so that no household is left un-18,664 households have already been



provided with Functional Household Tap Connections (FHTCs), leaving only a small number of households yet to be covered.

Mission Director's Directions

While taking stock of the progress, Shah emphasized the importance of timely completion of all ongoing works so that the goal of 'Har Ghar Jal' certification can be achieved in Tangmarg at the earliest. He directed the officers to give a renewed push for covering the remaining households and ensuring universal access to potable water.

He also stressed the need to ensure sustainability of water sources, proper operation and maintenance of schemes, and adherence to technical and quality standards.

"The Jal Jeevan Mission is not just about infrastructure creation—it is about ensuring reliable, safe, and sustainable drinking water access to every household. The pace of work must be accelerated, and all bottlenecks resolved in a time-bound mancovered," the Mission Director as-

The Mission Director also conducted on-site inspections of several WSSs to assess the quality of construction, functionality of filtration plants, and efficiency of pumping stations. He interacted with locals, PRI members,  $and field \, staff, taking \, direct \, feedback$ regarding water supply, challenges faced, and the impact of JJM schemes in their villages.

 $Locals\,appreciated\,the\,government's$ initiative, noting that access to clean and regular drinking water has significantly improved their living conditions. Some also flagged issues related to water pressure and coverage in far-flung hamlets, which the Mission Director assured would be addressed promptly.

To resolve the matter, SSCL constructed new shops for the affected shopkeepers, thereby freeing the encroached space and enabling the bridge development works to progress smooth-

Bridge Development at Advanced Stage

Officials informed that the Amira Kadal Bridge development project is now at an advanced stage of completion. Once finished, it will improve traffic movement, pedestrian access, and connectivity to the Gonikhan Market, further enhancing its commercial viability.

SSCL's Commitment to Quality Development

In its statement, SSCL reiterated its commitment to ensuring timely, sustainable, and highquality infrastructure development across Srinagar, while also

safeguarding the interests of local stakeholders.

"The Smart City projects are not merely about beautification, but about creating long-term functional infrastructure that balances modern urban needs with the livelihoods of traders and shopkeepers. It came out that the elder sister hit her younger sister on her head many times with a hard object.

The incident sent shock waves among the people and most of them were at loss as to how come an elder sister murdered her younger sister. In most of the cases the elder sister is referred to as no less than a mother of her younger siblings and she showers her immense love on the younger ones. In the Ganderbal case the elder sister turned out to be a beast since she killed her younger sister who was just 14 years old.

## An Autobiographical Note



**Ghani Ghayoor** 

I was born in the remote village of Gursai in Tehsil Mendhar, District Poonch, cradled amidst the lofty peaks of the Pir Panjal range. My childhood, though simple and steeped in hardship, is etched in memories of meadows, cattle, and mountain pastures. My father, a hardworking farmer, and my mother, Attra, struggled with limited resources to raise a large family. Together they toiled in the small maize fields and modest grasslands with livestock, so that we children could survive—if not thrive.

Every summer, we moved our cattle-buffaloes, oxen, and horsesto the higher reaches of Pir Panjal. Their milk gave us curd, paneer, and butter, which we sold in Surankote and Mendhar markets to Khatri merchants. Twice a year, in Baisakh and Manghar, my parents went to these merchants to purchase cloth and other essentials. These rhythms of rural life, harsh yet dignified, shaped my earliest world.

My schooling began in a local mobile school in Gursai. I passed the eighth class there and in 1978 joined the High School in Surankote, twelve kilometers away. The daily journey was no small ordeal. For four years, from class nine to twelve, I walked across steep mountain slopes, cutting the distance in half, yet still covering twelve kilometers both ways. Hunger, fatigue, and poverty were constant companions. Often, with only a morsel of food in the morning and evening, I endured empty days. But the fire of learning within me kept me

In 1981, I passed my twelfth examination with distinction. That year became the turning point of my life. I secured admission to the Regional Engineering College (REC) Srinagar, supported by an educational loan and a scholarship from the Social Welfare Department. It was not just

an admission—it was my entry into a new life. I felt as though I had broken the walls of poverty and stepped into the open horizon of opportunity.

In 1988, after completing my professional education, I entered service in the Public Works Department (PWD). My employment allowed me to support my family and begin to heal the wounds of poverty—though the scars, as I often feel, remain visible even today.

During my early years in service, I became an avid reader. Philosophy, history, prose, poetry-I devoured them all. At first, this vast reading left me confused, but soon I discovered a compass: the world of Urdu and Persian poetry. Sheikh Sa'di's works, and above all, Rumi's Mathnavi, became my guiding light. Rumi's verses gave me solace amidst the fog of sectarian strife, opening before me a vision of spiritual freedom, humanity, and divine love.

By the year 2000, I myself began to compose poetry and prose in Urdu. My first book, Sulagta Sehra, appeared in 2006, marking my formal entry into the literary world. This was followed by Der Tak, a collection of ghazals, and Haqiqat-e-Neem Shab (fiction, 2016). My literary voiceshaped by my lived experiences, nurtured by Rumi, and sharpened by the lessons of hardship-grew deeper with each work.

Over time, I extended my work beyond poetry and fiction to criticism, translation, and evaluation. I contributed not only to Urdu but also to Gojri literature, striving to enrich the cultural heritage of my Pir Panjal homeland. After serving long years as an Executive Engineer in the PWD, I retired in 2022. Since then, I have devoted myself wholly to reading and writing.

From the meadows of Pir Panjal to the shelves of literary circles, my journey has been one of endurance, transformation, and devotion to letters. My writings carry the wounds of deprivation and the fragrance of awakening. I have given voice to the richness of Gojri while also contributing to Urdu literary criticism and poetic expression.

My aspirations remain as steadfast as the mountain peaks of Pir Panjal. I accept challenges with courage and strive to rise above them. My spirit leaps toward the stars, eager to grasp them. Upon my desk, manuscripts continue to awaken-God alone knows how many more worlds they

# Husband's deliberate incompetence in housework: A crisis of changing relationships

Modern marriage will only survive through partnership and equality

Marriage is not just about living together, it is a partnership of equals. Household chores are just as important as jobs or businesses. Willful incompetence ruins relationships. Equal division of responsibilities is the foundation of a happy family. Modern marriage will only survive if there is both partnership and

While the modern lifestyle has opened up new opportunities in relationships, it has also posed many new challenges. Education, employment and technology have made women more independent and self-reliant than ever before. Today's woman is actively moving outside the confines of the home and taking on jobs, businesses and administrative responsibilities. But the irony is that her position within the threshold of the home has not changed as much as it should have. In most families, the responsibility for household chores still lies almost entirely with women.

A new and alarming form of this problem has emerged - the husband deliberately shows incompetence in household chores. This is called armed incompetence in Western society, which simply means that the husband deliberately disrupts household chores in order to show that he is incapable of doing these tasks. As a result, the wife has to do everything again and gradually the entire burden of the house falls on her shoulders.

Imagine the wife asking him to cook vegetables in the kitchen. The husband will add so much salt that the food will not be edible. Or while washing

clothes, he will put colored and white clothes together so that they will get dirty. If he is given the responsibility of getting his child to do his homework, he sits half-heartedly and confuses the child more. In such cases, he later says bluntly - "Look, I can't do this, you do this." Such repeated incidents force the wife to take care of everything herself.

This tendency is not just a form of laziness, but a gender bias hidden in the psyche. For centuries, society has created the perception that domestic work is the responsibility of women and men are limited to only external responsibilities. But in today's times, when women are also fulfilling equal responsibilities outside, this argument is neither valid nor acceptable.

This situation became more evident during the Corona pandemic and lockdown. When offices  $became \, confined \, to \, homes, children \, started \, staying$ at home all the time and help from outside stopped coming, it was observed in millions of families that the workload on women increased manifold. They were in online meetings all day and also had to take the responsibility of cooking three times a day, teaching children, cleaning and taking care of the elderly. Husbands avoided these responsibilities as much as possible and the excuse was that they were not that skilled in household chores. This situation created tension in many relationships and the incidence of divorce and separation increased in many

Women are no longer silently compromising with the situation as they used to. Being educated and self-reliant, they are demanding equality. For them, marriage is no longer just a matter of following tradition, but a partnership. This partnership means that both partners share the responsibilities of the home. When the husband shows deliberate incompetence, it directly affects the wife's self-esteem and mental health. Sometimes this situation leads to depression, anxiety and fatigue.

This tendency also damages relationships from

a psychological perspective. A relationship is strong only when there is a sense of equality and trust in it. If one party repeatedly runs away from responsibility and the other party does everything under compulsion, then gradually resentment, bitterness and distance grow. The wife feels that her hard work is not being appreciated and the husband feels that he has run away for his own convenience. This imbalance cannot last long.

Research on this topic has also been conducted internationally. Several sociological studies in the US, Canada and Europe have found that unequal division of household chores is a major cause of divorce. The same trend is being observed in India too. Against the backdrop of changing urban life, dual employment and smaller families, women are becoming more vocal and openly demanding equality.

This problem will not be solved by law or social pressure alone, but it is possible only through mutual communication and understanding between husband and wife. Men have to understand that household chores are not just ordinary chores, but they keep the foundation of the family strong. If cooking, children's education or house cleaning are not done on time and properly, the atmosphere in the house deteriorates and tension increases. Therefore, it is not right to take them lightly or impose them only on women.

Similarly, women should also remember that they should not take on every responsibility without being told. Sometimes women remain silent thinking that "if he won't do it, then I will have to do it." Gradually this pattern becomes permanent and the husband becomes accustomed to avoiding responsibility. Therefore, it is important that the habit of sharing work is developed between the two from the very beginning.

# Abdul Ahad Azad: An Unsung Patriotic and Revolutionary Poet

Born as Abdul Ahad Dar in 1903, Abdul Ahad Azad was one of the well-known poets of his era. He is often referred to as the John Keats of Kashmir, as both Azad and Keats wrote modernist poetry and both died very young. In the beginning, Azad's education remained confined to the holy Quran and a couple of Persian books, but when his elder brother opened a private school, Azad also learned Urdu and Persian. He became a self-learner in his teens.

In 1918, when Azad was 16, he was appointed as an Arabic teacher in a government primary school in a nearby village called Zuhama where he spent 13 years on a monthly salary of thirteen rupees. In 1931, he was transferred to a middle school in Tral as a punitive measure for his alleged involvement in antigovernment activities. Although his house was searched, nothing incriminating was found there. It is said that during this period, the death of his only son dwindled Azad's faith, and he started leaning toward socialism. In 1934, he was posted once again at the Zuhama school, where he spent ten years, up to 1944. After that, for one year, he was transferred to Branwar school, Budgam. In 1945, he was transferred to Surasiyar, and until he died in 1948, he spent his time there.

Azad's sojourn enabled him to study a lot. Especially, he learned the Urdu language and its literature. During this period, Azad also learned mathematics, geography, history, and other subjects. He no longer remained confined to teaching Islamiyat or Arabic but took classes of other subjects also. In 1925, Azad took the munshi-aalim examination which he passed with distinction. He wanted to move to another step known as munshi-fazil also, but he fell ill with pneumonia and couldn't appear in the examination. Pneumonia and other ailments kept Azad infirm almost throughout his life. Azad's health deteriorated in 1948 at Surasiyar where he suffered from fever and gastritis. He was treated by local Unani practitioners and at the Ratan Rani Hospital in Srinagar where he was diagnosed with appendicitis, for which he should have been operated earlier but wasn't. When things deteriorated further, he was shifted to the biggest Government hospital, where doctors operated upon him, but the poison from appendicitis had infected his body so much that he couldn't survive. On 4 April 1948, Azad passed away at the age of 45.

Initially, Azad wrote ghazals, but later on, he tried his hand at other forms of poetry as well. He changed his nom de plume from Janbaaz to Azad in 1935. In 1935, he met Mahjoor, and both became friends. Their friendship con $tinued\,till\,Azad's\,death, though\,Mahjoor$ had distanced himself from Azad because of his communist ideology. Azad would send his ghazals to Mahjoor for review and corrections. He also got engaged in writing Mahjoor's biography, which eventually became a part of his unparalleled prose work, A History of Kashmiri Language and Poetry (1959). Azad felt the need to study Kashmiri poetry in detail. He became a real researcher. Facing enormous odds, he was able to collect enough material for his pioneering work on the history of Kashmiri literature. This work has been acclaimed as equivalent to Browne's Literary His $tory of Persia (Edward \, Granville \, Browne$ (1862-1926)) and Shibli's Sher-ul-Ajam. Unfortunately, the book couldn't see the light of day during his lifetime. It was posthumously published as Kashmiri Language and Poetry in three volumes by the J&K Academy of Art and Culture.

Azad was very shy and simple, which kept him away from pomp and show, thereby adversely affecting the chances of publishing his poetry in his lifetime. Although he had written many revolutionary poems, he couldn't make them known to people or was scared to publish them. However, his meeting with

Pandit Prem Nath Bazaz (the then editor of a popular newspaper, Hamdard) in 1942 made Azad known to the people. Azad started contributing to the paper, resulting in a lifelong friendship between him and Bazaz. The duo would often meet and discuss various issues together. Azad and Bazaz were both actively involved in the political matters of Kash-

Kashmiri poetry had considerably changed at the beginning of the twentieth century from mysticism to a description of Nature and as a tool for awakening the people of Kashmir against cruel autocracy. In this regard, Mahjoor and Azad unequivocally became the harbingers of the renaissance in Kashmiri poetry. Azad was greatly influenced by Mahjoor, but unlike Mahjoor, he couldn't earn any fame during his life-

Azad was greatly influenced by Marxism and became a staunch advocate of socialism. He joined a group of poets who openly advocated communism. On the pattern of the Progressive Writers Front headed by Munshi Prem Chand in India, they established a Front in Kashmir which was banned by the second Prime Minister of Jammu and Kashmir, Bakhshi Ghulam Mohammad, in 1953. However, Azad continued to write poetry, especially on social issues and the plight of common Kashmiris-labourers, workers and the poor.

Azad was a revolutionary by nature and wanted action against exploiters like landlords, factory owners and the rich. He criticized the political leaders also for the mess in society and instigated the youth to come forward and save their country from the corrupt leaders and officers.

In the beginning, Azad wrote lyrics, but later in his life, he became a rebel and a standard bearer of social revolution and freedom. He was greatly influenced by the Russian Revolution. He repeatedly asks the youth and the poor to shake off their timidity and stand up against oppression and suppression. He says:

> Why has the fire of self-respect extinguished in you O, fellow countrymen, wake up from slumber

Later on, in the same poem, he urges his countrymen to fight bravely. He says:

Submerged you lay in the mud of fear Like an earthworm you are in slumber Come out like a dragon wavering O, fellow countrymen, wake up from slumber.

In, one of his poems, he tells them: Following those ahead, you lamb Look ahead and see for yourself You might land in a ditch for a meadow

Play with the sword of truth.


In his poems 'The Russian Revolution' and 'Marxism', he says that this Revolution gave power to the powerless and the downtrodden. He found socialism a better alternative and a good system to change the lives of people. Azad praises

#### His faith a mirror to Nature Refined gold, Spring of springs.

Azad hails Marxism for its peoplefriendliness and for taking them away from poverty and helplessness. He even praises it for talking of faith in faithlessness: "kufra saet karaan roshan deenuk charaag" (Enkindles the candle of faith with faithlessness). Azad likens the Capitalists with Nimrod (the king of Babylon) who considered himself more powerful than God. Azad advised people to unite so that they could overcome their sufferings. Like his comrades in the Progressive Movement in Kashmir, Azad's slogan, too, was:

#### Rise to shape your life You become your own guide.

Azad was a true socialist, humane at heart, and a real patriot who wanted people to rise above all sectarian considerations and divides. He wanted to foster communal harmony and love for



their country. He sang:

Different is my tale, music and instruments are different Different is my tavern, goblets and glass are different Intoxication is mine, mine is the wine bearer and heart The music is my own, heart is mine, so is the santoor

In his poem, 'The Question', he sings: The water that reared Ghani, Sarfi and Kalhan Should that water be poisonous for us?

In at least six poems, Azad speaks about the beauty of his country and why everybody should work towards building it as a beautiful place to live in. These six poems are: 'soan vatan', 'tarana-evatan', 'myon vatan', 'sawaal', 'vatan daaro' and 'haa vatan daaro ho'.

In, 'soan vatan' (Our Country), Azad talks about the boundless beauty of his country and considers it as a heaven. He sings: This bright environment, clear fragrant air Life to hearts, cure to life Ailments are cured, hearts get

comfort This our country, a beautiful coun-Different flowers smile in

their beds

Many a pond is restless Dancing in love for King Inder As if fairies from beneath the ground fill the goblets

The damsels are getting goblets filled Watching from a distance the intoxicated narcissuses How can the bulbul hide their songs

I can't say clearly, saying openly is vice This heaven is in sight; that heaven invisible This heaven we see, that we have overheard

Azad talks about the beauty of his country, clean air and environment, flora and fauna, and how these lifecomforting objects of Nature make the country nunda boan (the most beautiful).

The poem entitled 'My Country' (myon vatan) is almost the replica of 'Our Country'. However, here he is more direct in his love for his country. He sings:

How beautiful is my country, on seeing it I get the strength My life and heart be sacrificed in its ways

We love it, Bulbuls and Doves hover around it With goblets in our hands, this flower garden is blessed

Towards, the end of the poem, Azad

Who you have to be afraid of; labour begets good fruit Enough is love for your country, the heart said, blessed be. Azad, you don't have money, you are loyal to the country That's why ready the countrymen are, blessed are your words.

In 'Country's Song' (tarana-e-vatan), Azad sends the message of brotherhood, unity, and equality, he sings:

Together we will say country, my country Sing the country's song.

In the last two stanzas of the poem, Azad makes people understand why he is singing the song for his country. He

All have one God All will have one voice Never shall we ask for ourselves Separately or individually.

Addressing directly his people, Azad exhorts them:

O Brave, move on Always quest for O, young brave people Have hope and yearning!

In 'Sawal' (A Question), Azad laments the pathetic condition of his country. He

> Aliens feel for us; the world is aghast How could this jackal victimize the lions?

In 'vatan daaro' and 'haa vatan daaro ho', Azad tells his countrymen to make their country great and beautiful. He tells them not to bow before anybody but to rise and shape their life. In 'vatan daaro', Azad says:

Neither you heard nor you saw What did you get after the great labour? I would say but I can't Listen carefully; find meaning

In 'ha vatan daaro ho', Azad advises his countrymen not to be scared but fight out bravely. He begins the poem

Why has the fire of self-respect extinguished in you? O, fellow countryman wake up You're crushed in the mud of fear Like the earthworm you are lying

down O, Python, come out wavering O, fellow countrymen wake up

In 'Shama' (The Candle) Azad, talks of unity, communal harmony, brotherhood and equality. He says:

My religion is unity; my faith equality This is my clear lesson for all To me K'abaa and the temple are

Be attentive and listen to my tale

Azad felt deeply for the people of Kashmir who were living under oppression and suppression by not only the rulers but also landlords, factory owners and the rich. In "shikwah-e-kashmir" (Kashmir's Complaint), he considers the political, social and economic evils responsible for the plight of the people. His solutions to these evils are courage, love for one's country, constant struggle and a scientific approach to life. Therefore, he sings in 'myon vatan' thus:

Sow the seeds of love; fill it with love and passion Among the love, the blessed love is patriotism.

He was optimistic about the future of his country and the young generation. Even if his generation did not heed him, he knew the future generations would. He says:

The world would remember Azad My love, I would remind you of this sometime



Azad was very shy and simple, which kept him away from pomp and show, thereby adversely affecting the chances of **publishing** his poetry in his lifetime. Although he had written many revolutionary poems, he couldn't make them known to people or was scared to publish them. Azad was a great revolutionary and patriotic poet par excellence of the era who unfortunately couldn't get his due recognition during his lifetime. He loved Kashmiris, Kashmir and its beauty which got trampled under the feet of exploiting landlords and the rich. He lamented and cried out, but there were no comforters for him. It is sad that a poet of his stature should have remained unknown in his lifetime, though his elder contemporary and friend Mahjoor became a household name during his lifetime and after his death. Like Mahjoor, Azad wrote in simple language avoiding unnecessary words and metaphors to instill in the young generation a spirit of courage and a sense of devotion to their country. about much in any of the writings on Azad and his poetry.

# **CLASSIFICATION OF PSYCHIATRIC DISORDERS**

Lot of misconceptions are there in our society regarding mental health disorders. We all cannot become Psychiatrists or Psychologists but at least we should know about basic concepts in mental health disorders. In psychiatry and psychology there are lot of classifications of psychiatric disorders but I am deliberately giving a classification that all sections of society can understand.

#### Psychiatry has given a simple classification of psychiatric disorders 1: NEUROTIC

When contact of individual with reality is not broken like Anxiety, OCD, PTSD, Conversion disorders. Phobias, Panic disorders, Eating disorders.

#### 2; PSYCHOTIC


When contact of individual with reality is broken like Schizophrenia, Schizotypal disorder.

Lot of literature is available on depression, anxiety, PTSD, but today let's simplify psychotic disorders usually present only in 2 to 3% of general population. Schizophrenia is a common disorder found in Kashmir.

#### **Major Symptoms: DELUSIONS**

They are fixed false beliefs far beyond credibility that may be bizarre [for exam-

ple 'my right eye is a computer that controls the world or nonbizarre (detectives of my city are after me] and these remain unmodified despite clear evidence to the contrary. Patients believe that they were born to spread a particular religion or cult; they also wrongly think other persons can hear silent thoughts of patient. Some patients believe that their wife/husband is not faith-



ful without any sort of evidence or believe family members or neighbours' want to poison them.

#### **HALLUCINATIONS:**

Even if Patients family and patient are in single room, patients usually complain of hearing strange voices or seeing strange things when others do not hear or seee it. Most common are auditory [voices] which patient perceives as coming from outside the patients head. Many times in cases of untreated patients these voices ask the patient to walk on water and many die of accidental suicides. In visual hallucinations patients can see angels, fairies, or ghosts.

#### Other Symptoms Include; **Loosening Of Associations:**

Patients ideas are disconnected, they jump from topic to unconnected topic, speech is incoherent.

#### Over Inclusiveness:

Patients continually may disrupt the flow of their thoughts by including irrelevant information.

Neologisms: Patients coin new words which may have symbolic meaning for them.

**Blocking:** Speech is halted [often in midsentence] and then picked up a moments or minutes later, usually at another place. These patients

#### have short attention span. **Echolalia:**

Patients repeat words or phrases in musical or singing fashion without an apparent effort to communicate.

To be considered schizophrenic it is of utmost importance to visit psychiatrist near you, only he can diagnose the disorder, also the following criteria is important.

1: Have at least 6 months of sufficiently deteriorated occupational, interpersonal and self-supportive functioning, have been actively psychotic in a characteristic fashion during at least part of that period and must not be able to account for the symptoms by the presence of a schizoaffective or major mood disorder, autism or an organic condition.

rganic condition.

It's very important to mention here ontrary to popular belief such patients study are NOT VIOLENT towards doctors, athough due to lack of insight some of nem will not visit any doctor or counselor rating that they are healthy and do not seed to visit any health care provider.

It's pertinent to say use of cannabis and enetic factors play significant role in development of Schizophrenia.

Treatment

1: Medical Treatment.

Do not stop or start treatment without octor's advice contrary to popular belief such patients usually are NOT VIOLENT towards doctors, although due to lack of insight some of them will not visit any doctor or counselor stating that they are healthy and do not need to visit any health care provider.

# PET HAIR CARE **DURING MONSOON**

Consider providing boiled drinking water to your pet to ensure they stay away from any waterborne diseases, especially during summer.

Keep antifungal powder, tick and flea repellents handy to ensure that your pet is free of

#### **Grooming routine**

Regularly brush the fur of your pet. This helps dislodge loose fur, prevents matting and enhances air circulation, improving their coat.

Keep their fur trimmed, especially during monsoon. This will protect the fur from dampness and matting.

Use specially formulated antifungal shampoos. It will help prevent fungal infections.

Dirt and muck from the ground easily get stuck in the paws; therefore, I suggest regularly cleaning them with antiseptic after every walk to ensure their hygiene. Additionally, you can invest in good-quality pet boots to protect their paws during monsoons.

#### Regularly clean their ears








# NDA VP candidate poised to win Sep 9 election, going by numbers game

**NEW DELHI. AUG 20:** The National Democratic Alliance (NDA) seems poised to win the Vice President's election scheduled for September 9, in view of the majority of its Members in both Lok Sabha and Rajya Sabha.

The Electoral College consists of all Members of Parliament from both Houses of Parliament totalling 782, excluding six vacancies. A candidate needs at least 392 votes to win.


Looking at the strength in both Houses, the NDA has 293 MPs in Lok Sabha and 130 in Rajya Sabha. This gives the NDA a solid 422 votes, way above the majority mark, making the NDA candidate C P Radhakrishnan hot favourite.

Going by the numbers game, INDI Alliance's Sudershan Reddy appears to have little chance.

INDI Alliance has 249 MPs in Lok Sabha and 106 in Rajya Sabha. This totals 355 votes. Although not a small number, it, however, falls short of the required 392.

Even if the INDIA Block sways smaller parties like the YSR Congress or BJD, the numbers gap

The NDA, therefore, is ahead even before the election, even if there are some abstentions or



there is any cross-voting which is highly unlikely.

Election to the Vice President's office must be held within 60 days

of the resignation by the earlier Vice President, in this case Jagdeep Dhankhar, and before September 19. Voting is done through

secret ballot. Last date for filing nomination is tomorrow.

The NDA candidate filed his nomination today. He was accompanied by Prime Minister Narendra Modi, Home Minister Amit Shah, Defence Minister Rajnath Singh, Health Minister and BJP President JP Nadda and Transport Minister Nitin Gadkari. Four sets of papers were filed as part of the nomination process.

INDI Alliance candidate B Sudershan Reddy, a former judge of the Supreme Court, arrived here vesterday evening and was received at the airport by Opposition MPs. He will file his nomination tomorrow. UNI RB 1726

## **CBI** arrests NHAI project director in Telangana while accepting bribe

NEW DELHI AUG 20: The Central Bureau of Investigation (CBI) has arrested two persons, including a Project Director of the National Highways Authority of India (NHAI), from Warangal, Telangana, for allegedly demanding and accepting a bribe of Rs 60,000 to permit a man run his restaurant along the Highway.

The CBI laid a trap and caught both the accused red-handed while demanding and accepting undue advantage. Searches were conducted at three places belonging to the accused.

## US willing to provide air support to Ukraine to aid in reaching peace deal with Russia

WASHINGTON, AUG 20: While ruling out any US boots on the ground in Ukraine, President Donald Trump nonetheless did express willingness to provide the country with air support if it helps in Moscow and Kyiv reaching an agreement for settlement, reports The Guardian.

security guarantees to help end the war at an extraordinary White House summit. Affirming Washington's full involvement in Europe's security, Trump had ruled out Ukraine's admission into NATO, calling it 'unrealistic'.

"When it comes to security, (Europeans) are willing to put people on the ground. We're willing to help them with things, especially, probably ... by air," Trump said in an interview on Fox News on

Russia has repeatedly warned that it will not allow Ukraine to ever join the NATO, and said that one of the preconditions for peace was Kyiv abandoning these aspirations, along with its demilitarisation and denazification.

The Kremlin's advance is currently ongoing, as Russian forces have captured further territories in Donetsk and Dnepropetrovsk, while also having  $targeted\,Ukraine's\,energy\,infrastructure\,on\,Monday.$ UNI

# IDF puts additional 60,000 reserves on alert for operation to fully take over Gaza City

TEL AVIV. AUG 20: The Israeli Defence Forces have put over 60,000 reserve troops on alert for the total capture of Gaza City. This comes in the wake of Israel's plan to fully occupy the Gaza Strip to remove the Hamas forces in the area. The military is set to launch its offensive against Hamas today in Gaza City, announced Israeli Defence Minister Israel Katz.

According to The Times Of Israel, the reserves would not be rolled out at once but rather in waves. The majority — around 40,000-50,000 — would be ordered to show up for duty on September 2. Another wave would take place in November-December, and a third wave in February-March 2026, the IDF

This move markedly increases the number of reserves being called for action, as the IDF already has thousands of reserves currently serving.

Additionally, the military is also extending reserve duty for some 20,000 reservists who were currently on duty by another

30-40 days. This would bring the total number of reservists at a given time during the offensive

to around 130,000. These reserves include three brigades and several more battalions, and many combat support soldiers, including in intelligence and logistics.

Not all reserves are going to deployed to Gaza City, but rather will fill in for the active ground troops deployed in various areas currently.

In all, five IDF divisions, made up of tens of thousands of troops, were set to participate in the military's planned offensive against Hamas in Gaza City, according to the army.

The forces included 12 brigade-level teams, each of which has infantry, armoured, artillery, and combat engineering forces, along with combat support.

In addition, the Gaza Division's northern and southern brigades

– normally tasked with the border – are set to participate in the offensive, bringing the total number of brigades to 14.

As per the IDF, the preparation phases for its offensive have already begun, with an ongoing offensive on the outskirts of Gaza City. The Nahal Infantry Brigade and 7th Armoured Brigade have been operating in the Zeitoun neighbourhood, and the Givati Infantry Brigade began a new offensive in the Kafr Jabalia area, north of the city.

In addition, the IDF said efforts to set up humanitarian infrastructure in the Strip's south for an estimated one million Palestinian civilians who are set to be displaced from Gaza City have started, including allowing tents and shelter equipment into the Strip in recent days.

The military said more aid distribution sites and at least two more field hospitals are set to be established. The European Hospital in Khan Younis, which was closed after the IDF raided a Hamas tunnel running underneath it, was also slated to resume operations. UNI ANV SSP

## Ten-point Consensus arrived at India-China SR talks on Border Question

NEW DELHI, AUG 20: India and China arrived a 10-point consensus including on border management mechanisms at diplomatic and military levels, trans-border rivers cooperation and sharing of hydrological information during emergency situations at the 24th Round of Talks Between the Special Representatives (SRs) of the two countries on the Boundary Question.

Releasing the details of the 10-point Consensus today the Chinese Foreign Ministry said the two countries agreed to give full play to the role of the China-India Expert Level Mechanism on Transborder Rivers and keep communication on the renewal of relevant

The Chinese side agreed to share hydrological information during emergency situations based on humanitarian considerations.

It was also agreed to re-open the three traditional border trading markets--Renqinggang-Changgu, Pulan-Gunji and Jiuba-Namgya.

The 24th Round of Talks on the Border Question was co-chaired by National Security Advisor (NSA) Ajit Doval and China's Foreign Minister Wang Yi here yesterday. The 25th Round of SR Talks will be held in China in 2026.

"Under the strategic guidance of the leaders of the two countries and in a positive and constructive spirit, the two sides had a candid and in-depth exchange of views on the China-India boundary question, and reached ten points of consensus," the Chinese Foreign

Ministry said. The two sides reiterated the



importance of maintaining peace and tranquility in the border areas, emphasized handling the issue properly through friendly consultations, to promote overall development of the China-India bilateral relationship.

They agreed on the need to take a political perspective of the overall bilateral relationship while seeking a fair, reasonable and mutually acceptable framework for settlement of the boundary question in accordance with the

Agreement on Political Parameters and Guiding Principles for Settlement of the China-India Boundary Question signed in 2005.

It was also agreed to set up an Expert Group, under the Working Mechanism for Consultation and Coordination on the China-India border affairs (WMCC) framework, to explore Early Harvest of boundary delimitation on appropriate Sectors.

A Working Group, under the WMCC framework, would be set up to advance effective border management to maintain peace and tranquility in border areas.

Both sides agreed to create General-Level Mechanisms in the Eastern and Middle Sectors, in addition to the existing General-Level Mechanism in the Western Sector, and hold the next round of General-Level Mechanism meeting in the Western Sector at an

early date.

They agreed to use the border management mechanisms at diplomatic and military levels to carry forward the process of border management, and discuss deescalation, beginning with the principles and modalities thereof.

The two sides also exchanged views on trans-border rivers cooperation and agreed to give full play to the role of the China-India Expert Level Mechanism on Trans-border Rivers and keep communication on the renewal of relevant MoUs.



# **Shubman Gill returns** to India's T201 squad as vice-captain for **Asia Cup**

**NEW DELHI:** The 15-member squad, picked by the selection committee on Tuesday, will be led by Suryakumar Yadav, and includes Abhishek Sharma and Sanju Samson as the two other opening candidates. With Gill as vice-captain, however, he is the frontrunner for one of the slots at the top of the order.

"We obviously see some leadership qualities in him, and his form in England was what we were hoping for. [He] exceeded all our expectations, which is a great sign when there's so much pressure as captain," chairman of selectors Ajit Agarkar said in Mumbai.

The middle and lower-order batting options are Suryakumar, Tilak Varma, Rinku Singh and Jitesh Sharma, who could be the first-choice wicketkeeper if India decide to open with Gill and Abhishek. There are also three allrounders in Axar, Hardik Pandya and Shivam Dube. The specialist bowling options are Jasprit Bumrah, Arshdeep Singh, Kuldeep Yadav, Varun Chakravarthy and Harshit Rana, who provides some extra batting depth too.

There was no place for Yashasvi Jaiswal, who was instead among the five reserve players, along with Prasidh Krishna, Washington Sundar,

Riyan Parag and Dhruv Jurel. Shreyas Iyer, who scored 604 runs at a strike rate of 175 in IPL 2025 and led Punjab Kings to the final, also did not find a place in the 15.

"With regard to Yashasvi, it's just unfortunate again," Agarkar said. "There's Abhishek Sharma: what he's done over the last year or so plus he can bowl a little bit - he gives us that option if required. One of these guys was going to miss out. Yashasvi just has to wait for his chance.

"With regard to Shreyas, who can he replace? No fault of his, nor is it ours. At the moment, you can just pick 15. So he will have to wait

Gill was vice-captain in the previous T20I series he had played - in Sri Lanka in July 2024 - but he had not been picked in any of the subsequent series as India prioritised his appearances in the Test and ODI formats. Axar was then appointed vice-captain for the home T20Is against England in January. Gill's return to the T20I format comes on the back of his contributions to India's Champions Trophy triumph earlier this year and his recordbreaking run as batter in the five-Test series in England, where he led India to a 2-2 draw in the Anderson-Tendulkar Trophy. He also scored 650

runs for Gujarat Titans in IPL 2025 at a strike rate of 155.87.

"Last time when he [Gill] played T20 for India, post T20 World Cup when we went to Sri Lanka - not Zimbabwe - when I was leading, he was the vice-captain," Suryakumar said after the selection meeting in Mumbai. "So that's where we started a new cycle. After that, he got busy with all the Test series, and he didn't get an opportunity to play T20s because he was busy playing Test cricket and Champions Trophy. So he's there in the squad, and we're happy to have him."

The Asia Cup is India's first T20I assignment since the bilateral series against England at home in January. India are in Group A, along with Pakistan, Oman and UAE. Their first game is against UAE in Dubai on September 10, after which they play Pakistan in Dubai on September 14, and Oman in Abu Dhabi on September 19.

"This is the first big tournament we are playing since the [2024] T20 World Cup," Suryakumar said. "We have played three-four bilateral series. It's a good tournament to test ourselves. After this, there are a lot of T20s - close to 20-22 T20s in total - before we play our first game in the [2026] World Cup, so I think the journey starts from the Asia Cup."
