

Soldiers kill terrorists because of their deeds: Rajnath

JODHPUR, AUG 25: Defence Minister Rajnath Singh on Monday asserted that Indian forces gave a "befitting reply" to Pakistan during Operation Sindoor and "our soldiers did not kill terrorists based on their religion, but because of their deeds".

Addressing an event Here, Singh also lauded the people of border areas for supporting the administration and the armed forces during the military operation to avenge the Pahalgam terror attack.

The Defence Minister said that after the incident, he called the service chiefs and asked if they were ready for the operation. "The chiefs of all three armed forces

unanimously replied, 'We are ready for any operation.' This is India. The prime minister gave the necessary directives," he said. "The target that was decided was hit

precisely, just as planned. During Operation Sindoor, our forces received full support from all border regions. India is a country that not only considers people within its

borders as members but also regards people across the world as part of its family, spreading the message of Vasudhaiva Kutumbakam."

"India does not discriminate based on caste or religion. However, terrorists killed people after identifying their religion. Our soldiers did not kill the terrorists based on religion but because of their deeds," he said.

Under Operation Sindoor in May, precision strikes were carried out on multiple targets in Pakistan and Pakistan-occupied Kashmir linked to terror groups. The operation aimed at destroying terror infrastructure and neutralising key operatives following the April 22 Pahalgam attack.

Kashmir Wetlands Record 1.3M Birds, 65% Rise in 6 Years

SRINAGAR, AUG 25: Kashmir's wetlands have turned into a bustling haven for migratory birds this season, witnessing an unprecedented surge with 13.43 lakh birds representing 67 species flocking to the Valley. Over the past six years, the water bird population in these wetlands has shown a major upward trend of up to 65 per cent.

According to the census document accessed by the news agency-Kashmir News Observer (KNO), a total of 1,343,506 birds belonging to 67 species were recorded across 26 wetlands. Hokersar contributed 29.97% of the total bird count,

SC declines urgent hearing, lists matter on Oct 10

NEW DELHI, AUG 25: The Supreme Court on Monday declined to grant an urgent hearing on the petition concerning the restoration of statehood to Jammu and Kashmir, reiterating that the matter is already scheduled for October 10 this year.

The plea for early listing was made by the counsel for petitioners, who sought urgent hearing of a contempt petition linked to the abrogation of Article 370. "Statehood was to be granted to Jammu and Kashmir, and I am seeking early listing of the matter," the counsel submitted before the bench led by Chief Justice BR Gavai.

SRINAGAR, AUG 25: As the people await violators to be held accountable and face public scrutiny for selling rotten meat and other food products the much-awaited list is set to be made public within the next few days.

The Food and Drug Administration (FDA) has intensified raids in Jammu and Kashmir, seizing 12,000 kg of meat, 21 quintals of synthetic cheese, and 440 quintals of Rasgulla ahead of the festival season.

Smita Sethi, Commissioner, Food & Drugs Administration, J&K, speaking to the news agency—Kashmir News Observer (KNO), said inspections are ongoing. "Yesterday, a big raid was

SRINAGAR, AUG 25: Minister for Health & Medical Education, School Education, Higher Education and Social Welfare, Sakeena Itoo today chaired a first-of-itskind stakeholders' meeting on the burning issue of drug deaddiction across Jammu and Kashmir.

The meeting, held at Sher-i-Kashmir Convention Centre (SKICC), was attended by Commissioner Secretary Social Welfare Department, Secretary

Health & Medical Education, DIG Police Crime Branch, Director School Education Jammu/Kashmir, Director Health Services Kashmir, Director Colleges, Principals of degree colleges, Chief Education Officers, Zonal Education Officers, school heads, representatives of NGOs, doctors, experts, civil society members and other stakeholders, both in person and through virtual mode.

During the meeting, participants voiced serious concern over the rampant rise of drug abuse among children and youth in J&K.

They flagged the easy availability of narcotics and psychotropic substances, particularly around schools, colleges and other vulnerable areas. Suggestions were made to introduce training modules in curricula, establish structural mechanisms, and conduct scientific awareness campaigns. Several substance users undergoing rehabilitation also shared their personal stories, narrating how they got trapped in addiction and the challenges of recovery.

Reaffirming his government's commitment to inclusive development, the Chief Minister said that while it is easy to deliver schemes to those who already enjoy resources, education and good health, the true test of governance lies in reaching the poor, the vulnerable, and those in far-flung rural areas.

"Social welfare schemes are neither favours nor acts of generosity. They are the rightful due

of citizens who face greater hardships than others. Any government that ignores them or focuses only on privileged sections fails in its duty," Omar Abdullah said.

The Chief Minister emphasized that from the beginning of his tenure, his cabinet—particularly Minister for Social Welfare Sakina Itoo—worked with sincerity to prioritize the weaker and disadvantaged sections. "We knew we could not change everything overnight. But as the saying goes, drop by drop becomes an ocean. Our effort has always been to start where the need is greatest," he added.

Chief Minister Omar Abdullah underlined the government's paradigm shift from charitydriven welfare to a rights-based approach, ensuring that benefits reach those who need them the most. He said that social protection measures are not favours, but the rightful entitlements of citizens facing socio-economic challenges.

The Chief Minister highlighted several flagship initiatives of his government, including enhanced marriage assistance for girls belonging to Economically Weaker Sections (EWS), an increase in pensions for over 10 lakh beneficiaries, and the provision of free public transport facilities for women to promote mobility and safety.

He also spelled out about the upgradation of 500 Anganwadi Centres into Saksham Centres and Bal Vidyalayas, designed to provide integrated child development, education, and nutrition services. In addition, new facilities such as Shakti Sadans and Vatsalva Sadans established to extend institutional care and protection to women and children in need.

Omar Abdullah also called for greater corporate participation in welfare efforts. Referring to schemes like distribution of scooters and assistive devices, he admitted that financial limitations sometimes delay benefits but stressed that Corporate Social Responsibility (CSR) funds from big businesses could complement government efforts.

Another major challenge, he said, was the lack of awareness about government schemes in remote areas. "It would be unfair if people in one district enjoy a scheme while those in another remain deprived. The government belongs to all districts and all communities of J&K. Welfare benefits must reach every corner of the state," the CM asserted.

He highlighted the success stories of education loans and scholarships that have enabled many students to pursue higher education, with some even becoming doctors. "This is what we must strive for—using schemes to improve the daily lives of ordinary people. That, I believe, is the highest responsibility of any government," Omar Abdullah remarked.

The Chief Minister in augurated an exhibition showcasing social welfare initiatives and schemes, and felicitated achievers who have made remarkable contributions in their fields. He also sanctioned loans in favour of women and disadvantaged groups, besides handing over prosthetic aids and scooties to Persons with Disabilities (PwDs), reaffirming the government's commitment to inclusive empowerment.

He distributed keys of motorized cycles, sanction letters, and appreciation plaques to beneficiaries and achievers.

sensitive government information, and minimise the risks of data breaches, malware infections, and unauthorised access.

"In exceptional cases where operational needs justify their use, controlled whitelisting may be permitted for up to 2-3 pen drives per department upon formal requests routed through the respective administrative head to the state informatics officer (SIO), National Informatics

"After approval, the pen drive must be phys-

ically submitted to the respective NIC cell for reconfiguration, authorisation, and ownership registration prior to use," the order said.

As a secure alternative, it said the departments are strongly encouraged to adopt GovDrive - a Cloud-based, multi-tenant platform offering every government official 50 GB of secure storage with centralised access and synchronisation across devices, it said.

The order also said that all sensitive technical information, including ICT architecture diagrams, system configurations, vulnerability assessments, IP addressing schemes and strategic technology plans, must be classified as confidential and handled exclusively through approved secure channels in accordance with the Information Security Best Practices by the Ministry of Home Affairs, CERT-In directives, and department data classification policies.

"Failure to adhere to these instructions shall be viewed seriously and may invite disciplinary action under relevant rules governing official conduct, IT usage and administrative responsibility," the order said.

It also said the directions have issued with the approval of the competent authority and shall come into fore with immediate effect.

"All the departments are advised to accord top priority to the implementation of these guidelines in the interest of secure and safe egovernance," it said. (Agencies)

followed by Shallabugh (29.44%) and other wetlands (40.59%). Eurasian Teal (Anas crecca) with 292,039 individuals (22.17% of total bird count) was the most abundant species, followed by Mallard (Anas platyrhynchos) with 226,023 individuals (17.16%) and Northern Shoveler (Spatula clypeata) with 209,715 individuals

The seven bird species—Mallard (Anas platyrhynchos), Eurasian Teal (Anas crecca), Northern Pintail (Anas acuta), Eurasian Coot (Fulica atra), Northern Shoveler (Spatula clypeata), Gadwall (Mareca strepera), and Eurasian Wigeon (Mareca penelope)—constituted 91.08% of the total birds counted during the AWC 2025.

An in-depth assessment and analysis of waterbird count data from the Asian Waterbird Census (AWC) over the period 2019–2025 demonstrates notable trends in population dynamics of major wintering species in the wetlands of Kashmir. Among these, the Eurasian Teal (Anas crecca) consistently recorded the highest abundance, reaching 336,053 individuals in 2022 and 292,039 in 2025, suggesting a stable preference for the region's shallow, vegetated wetlands.

These trends can be meaningfully correlated with the implementation of wetland management interventions, particularly the construction of bunds and habitat restoration for water retention. Bund creation has been instrumental in maintaining stable water levels during critical wintering months, directly enhancing the foraging and roosting conditions for dabbling ducks such as the Mallard (Anas platyrhynchos), Northern Shoveler (Spatula clypeata), and Gadwall (Mareca strepera), which all showed relatively high and stable counts in recent years. The Northern Shoveler population, for instance, increased dramatically from 53,868 in 2019 to 209,715 in 2025, a change that aligns with improved water retention capacity and

reduced human disturbance in managed zones. Over the span of the last six years, from 2020 to 2025, the water bird population in the wetlands of Kashmir has shown a remarkable upward trend, rising from 813,043 individuals in 2020 to 1,343,506 in 2025, marking a significant 65.28% increase over the period. This increase of over half a million birds demonstrates the success of sustained conservation efforts and wetland management strategies implemented by the Department of Wildlife Protec-

tion, Jammu and Kashmir. One of the most impactful measures contributing to this growth has been the creation of bunds and the installation of regulatory gates in major wetland Ramsar sites such as Hokersar, Hygam, and Shallabugh, which improved water retention capacity and helped maintain stable water levels throughout the migratory and breeding seasons. Desilting efforts, particularly intensified after 2020, rejuvenated open water areas and improved the depth and quality of aquatic habitats, directly correlating with the spike in bird numbers in 2021 and

Habitat restoration activities, including the removal of invasive weeds and promotion of native aquatic vegetation, contributed to increased habitat heterogeneity, attracting a more diverse array of water birds. Peripheral channels were restored and regularly maintained, reducing habitat fragmentation and supporting both core and buffer zones of the wetland. Solid waste management initiatives significantly reduced pollution and human disturbance, improving the overall health of the ecosystem.

Another key intervention was continuous water quality monitoring, which allowed timely action to address issues such as eutrophication and pH imbalances. Equally important were anti-poaching measures, including intensified patrolling and community compliance programs, which minimised threats during peak migratory influx and protected critical roosting areas.

The upward census trend over the past six years is not merely a reflection of migratory patterns but a direct outcome of holistic, sciencebased wetland management—(KNO)

request, pointing out that the court is required to sit as a constitutional bench of presidential reference in the matter and therefore it cannot be taken up before October 10. "The matter is already listed on October 10," the CJI said, making it clear that no urgent hearing will be entertained before the scheduled date.

Earlier, on August 14, the apex court had sought the Centre's reply within eight weeks on the statehood petition and stressed that the ground situation in Jammu and Kashmir must be taken into account before any decision on restoration of statehood. At that time, the Chief Justice had remarked, 'You cannot ignore what happened in Pahalgam," in reference to the militant attack that claimed 26 lives.

The petitioners argue that the government had committed to restoring statehood after the abrogation of Article 370 in 2019 and subsequent reorganization of the erstwhile state into two Union Territories. The issue has since remained a matter of legal and political contention.

The Supreme Court's decision today means that the hearing will go ahead as per schedule in October, keeping the question of statehood for Jammu and Kashmir pending for now. (KNT)

Omar said that statehood has been his government's top priority since taking charge. "In our first cabinet meeting, we passed a resolution on statehood and I personally gave it to the Prime Minister. But for ten months, nothing has moved forward,"

He added that earlier elections in J&K were held only because the Supreme Court set a deadline. "I hope this time too, the SC fixes a timeline so that our statehood is restored quickly," CM said.

On PDP chief Mehbooba Mufti's protest seeking transfer of prisoners, Omar Abdullah said such matters are decided in Delhi, not Srinagar.

"We too raised this issue with Home Minister Amit Shah. If PDP wants to protest here for show, let them, but the real decision lies in Delhi." he said.

CM also said NC's signature campaign for statehood is going on and will be submitted to the Centre and the Supreme Court once completed. (KINS)

carried out in Jammu. Today, around 100 kg of synthetic cheese was seized, bringing the total seized products to 12,000 kg of meat, 21 quintals of cheese, and 440 quintals of Rasgulla," she said.

She added that the Rasgulla's were expired, torn, kept in cold storage in tins without packaging or labeling, and likely to flood markets. "They had no proper storage solution, so we destroyed them, Sethi said.

On the meat supply chain and its movement to the Valley, she said it appears to

be 'smuggled'. "Yesterday's cheese seizure came through railways after a tip-off from Railway Police. Rotten and expired oil in 78 tins was also recovered," she said.

Commissioner Sethi added that the seized meat lacked proper storage conditions. "The owners have not disclosed the source. Some consignments have names associated, and we are trying to establish links, especially regarding the cheese," she

She confirmed that investigations are progressing, and a "list of violators, including license details, will be published within a few days."

Regarding food testing, Sethi said 12 reports have been received – four unsafe. four standard, and four in bad condition and unfit for consumption. "Unsafe samples contained only synthetic colors; no major harmful elements, viral or cancercausing agents, were found," she clarified.

The Commissioner assured that strict enforcement will continue to safeguard consumers across Jammu and Kashmir, with drives ongoing throughout the Union Territory. Notably, J&K FDA earlier ordered strict compliance with FSSAI rules for the sale of frozen meat and chicken products.

"Violators face fines up to Rs 10 lakh, seizure of stock, license cancellation, and even six years' imprisonment under the Food Safety Act," said an official—(KNO)

Minister Sakeena stressed on the need for shift from token awareness to meaningful action. "Awareness programmes must go beyond speeches. If we are able to save even one child through such initiatives, it will be a significant contribution to society," she asserted.

The Minister announced that the installation of CCTV cameras in and around schools and colleges would be made mandatory to monitor activities and prevent illicit drug circulation. She also called for the formation of community-based monitoring committees comprising parents, civil society members, and religious leaders, facilitated by the Education Depart-

These committees, she directed, should submit monthly reports to the Directors of School Education and Higher Education on their activities and impact.

The Minister further underlined the importance of regular health and behavioural screenings in colleges and schools for early detection and timely counselling of vulnerable students. "If we collectively implement surveillance, monitoring, community involvement, and screening, I am confident that we can make meaningful progress in addressing the drug menace," she affirmed.

The Minister assured that the government would extend full support to institutions, civil society and NGOs working in the field of de-addiction, and urged all stakeholders to work in close coordination to protect the future of the youth of Jammu and Kashmir.

Delivers address at All India Speakers' Conference in New Delhi, calls for strengthening Democratic values

Director Libraries Stresses Infrastructure Upgradation, Digitization of Libraries

SRINAGAR, AUG 25: The 4th meeting of the J&K Union Territory Level Library Advisory-cum-Purchase Committee (UTLLACPC) was today convened at the SPS Library, Srinagar, where the focus remained on infrastructure upgradation, digitization, and expansion of public library services to meet the growing demand of readers across Jammu and Kashmir.

Chairing the meeting, Director Libraries & Research, Mrs. Rubina Kousar, said that the Department is laying renewed emphasis on improving the physical and digital infrastructure of libraries to keep pace with the increasing footfall. She noted with satisfaction that J&K is witnessing a revival of reading culture, especially among youth who are frequenting libraries for academic and competitive exam preparation.

"It is heartening to see that our Public Libraries are once again buzzing with activity. However, the surge in footfall has placed immense pressure on existing infrastructure, and there is an urgent need to enhance facilities to match the aspirations of today's readers," she remarked

in her opening address. The two-day meeting will deliberate on critical issues concerning library reforms as well as finalize the selection of books for purchase for the financial year 2025-26.

Mrs. Rubina highlighted the support extended by the J&K Government and the Raja Rammohun Roy Library Foundation (RRRLF) towards library development. She expressed special gratitude to Prof. A. P. Singh, Director General RRRLF, for his sustained guidance and personal intervention in strengthening J&K's library infrastruc-

The Director underlined gaps that still exist in the system, pointing out that many libraries continue to lack basic facilities such as proper furniture, drinking water, toilets, IT infrastructure, and dedicated amenities for specially-abled readers. In this regard, she announced that in the first phase, all Central and District Libraries will be equipped with ramps, specialized furniture, and audiovisual reading aids for Divyangjan under RRRLF's match-

MLA Nizamuddin Bhat Visits Hailstorm-Hit Bandipora Villages, Calls for Immediate Relief

BANDIPORA, AUG 25: A severe hailstorm that lashed parts of north Kashmir's Bandipora district on Saturday evening caused extensive damage to standing crops, apple orchards, and vegetable fields, leaving hundreds of farming families in distress. Vil $lages including \, Dardpora \, and \, Shamthan$ were among the worst hit, with farmers reporting heavy losses to their seasonal produce.

In response, MLA Bandipora, Nizamuddin Bhat, on Sunday visited the affected villages to take stock of the situation on ground. He was accompanied by officials from the Agriculture and Horticulture Departments, as well as field officers who conducted spot inspections of damaged orchards and farmland to assess the scale of destruc-

During his interaction with farmers and orchardists, Bhat expressed deep concern over the losses and called for immediate relief and compensation. "The damage is widespread, and the livelihoods of hundreds of families are at stake. The administration must



act swiftly to conduct a comprehensive damage assessment and ensure timely support reaches the affected," he stated.

He assured the residents that he would personally take up the matter with higher authorities, pressing for special relief packages and compensation to mitigate the financial stress on farmers.

Farmers, meanwhile, narrated their ordeal, saying the hailstorm destroyed nearly 70-80% of apple produce in some areas, along with paddy fields, maize, and vegetable crops. Many expressed fear of mounting financial strain and debt burden if assistance is delayed. "We depend entirely on the apple harvest to sustain our families for the year. This calamity has left us devastated," said one orchardist in Dardpora.

The MLA also stressed the importance of crop insurance schemes and preventive measures, urging the government to explore long-term strategies to protect farmers from recurring climate-related calamities. He suggested that the Horticulture Department provide technical guidance and subsidized inputs to help farmers rejuvenate damaged orchards.

The visiting officers assured farmers that the administration would soon initiate a detailed survey of affected villages, after which relief under the State Disaster Response Fund (SDRF) and other government schemes would be extended.

The visit concluded with the MLA reiterating his solidarity with the farming community and his commitment to ensure that no affected family is left unattended in this hour of crisis.

SDM Gool Reviews Progress of PWD & PMGSY Roads, Stresses Timely Completion & Safety Measures

RAMBAN, AUG 25: SUB-Divisional Magistrate (SDM) Gool, Imtiaz, today convened a comprehensive review meeting to take stock of ongoing developmental works being executed under the Public Works Department (PWD) and Pradhan Mantri Gram Sadak Yojana (PMGSY) in Sub-Division Gool.

Balwant Thakur Engages with Roman Actors at Bath, England

Restore Trust Through Transparency

The cancellation of written examination by the Jammu and Kashmir Services Selection Board (JKSSB) following allegations of a paper leak has once again cast a long shadow over the recruitment process in the region. While the decision itself may be a necessary corrective measure, it also exposes deeper and systemic flaws that need urgent attention.

For thousands of aspirants, the government jobs represent not just employment but a pathway to stability and dignity in a region that has long grappled with political and economic uncertainties. Each recruitment exam carries with it the hopes and sacrifices of young men and women, many of whom prepare under challenging circumstances. Allegations of irregularities such as paper leaks, therefore, do more than taint an exam; they erode public confidence in institutions and damage the morale of the youth.

This is not the first time the JKSSB has come under scrutiny. Past controversies around recruitment processes and result delays have already created a trust deficit. The latest incident, unless handled with complete transparency and accountability, risks deepening public cynicism.

The Board must now go beyond mere cancellation. A thorough, time-bound and independent investigation should be launched to identify those responsible, whether insiders, external actors or a nexus of both. Accountability must not stop at scapegoats; structural reforms are essential to prevent recurrence.

Moreover, the aspirants deserve clear communication about the next steps. When will the fresh exam be held? What additional safeguards will be in place? How will fairness be ensured this time? Vague assurances will no longer suffice: the credibility of the process demands clear timelines and concrete action.

This episode should also serve as a wake-up call to overhaul the recruitment ecosystem in J&K. Digitization of question paper delivery, biometric attendance, and strict third-party monitoring are no longer optional—they are essential. If the administration is serious about empowering the youth and promoting meritocracy, then cleansing recruitment processes must be a top priority. Restoring faith in the JKSSB is not just about one exam. It's about reaffirming the integrity of the entire system.


Nishat Ansari - The Doyen of Urdu and Kashmiri Literature

In the galaxy of eminent litterateurs, authors, poets and writers, Nishat Ansari stands as a towering and respectable name whose literary brilliance continues to inspire gen-

Born on 23 December 1930 (though official records mention 23 December 1928), his actual name was Gh. Mustafa Ansari, while his pen name remained Nishat. After matriculation, he was appointed to the Cooperative Department, but due to lack of interest he resigned and later joined the Education Department as a teacher. For 23 years, he served across the Valley in different capacities, remembered by his students for teaching them with the care of a father. In recognition of his dedication, the Government of Jammu and Kashmir conferred upon him the Best



A multidimensional personality, Nishat Ansari never shied away from a literary challenge. Author of more than two dozen books, he was at once a poet, critic, researcher, translator and essayist. Five of his poetry collections were published during his lifetime, among them Gulnar, Nawan, Ablag, Aokus Boukus and Souz. His collection Gulnar won him the Best Book Award (1981) from the J&K Academy of Art, Culture and Languages.

For the Sahitya Akademi, New Delhi, he authored research monographs on Prof. Mohiuddin Hajini and Gh. Nabi Dilsoz, besides translating the revered saint Sheikh Noor-ud-Din Noorani's (RA) poetic Shruks into Urdu under the title Salsabeel. He also translated works of Dr. Zakir Hussain and Jigar Muradabadi into Kashmiri, published by the Sahitya Akademi. Posthumously, the Akademi awarded him for his translation of Dr. Zakir Hussain's book.

Over the years, Nishat Ansari remained deeply associated with prestigious institutions including All India Radio Srinagar, Sahitya Akademi New Delhi, J&K Academy of Art, Culture and Languages, Doordarshan Kendra Srinagar, Board of School Education, University of Kashmir and

Beyond an individual, Nishat Ansari was an institution in himself. He was the founder of Dayira Adab Delina Baramulla, and a basic member, Vice-President and long-serving General Secretary of Adbi Markaz Kamraz – the Valley's largest literary organisation. For 30 years, his role in maintaining records, organising events, and compiling conference reports was widely admired.

He also penned nearly 300 researchbased and critical essays published in reputed journals across Kashmir, India, and Pakistan. His autobiography, spanning more than 300 pages, will soon reach readers eager to explore the life of this literary giant.

On 25 May 2000, Nishat Ansari - a distinguished poet, critic and scholar of Urdu and Kashmiri literature – breathed his last. May his soul rest in eternal peace, and may Almighty Allah grant him the highest ranks in Jannah.

Contractual Hands, Broken Trust, and the Betrayal of Dogri Language

The recent recruitment controversy at Prasar Bharati's Regional News Unit, Jammu, has thrown open a window to the disturbing realities of favoritism, mismanagement, and erosion of institutional credibility. What should have been a transparent process to promote regional languages like Dogri and Gojri has instead exposed how fragile and compromised our systems become when temporary authority collides with permanent responsibility.

The recruitment of Editorial Executives and Newsreader-cum-Translators in Dogri was supposed to strengthen local broadcasting and give a platform to deserving youth. Instead, the episode is remembered for irregularities, procedural violations, and blatant internal manipulation. In the name of opportunity for regional talent, the process became a showcase of how personal networks and contractual influence can override fairness and legality.

The central charge lies in the role of contractual employees who were allowed to run critical aspects of recruitment without having any statutory power. In a national broadcaster where accountability is paramount, the sight of temporary employees conducting voice tests and even sitting in the chair of senior officials is not only irregular but deeply shocking. The presence of Jagmohan Sharma, who insiders say often acted in place of Assistant Director Gulshan Raina, raises sharp questions. Can a person with no permanent status in the organization be allowed to carry out functions reserved for senior officers? The answer lies in law and governance, and both seem to have been ignored.

Equally startling is the involvement of Vijay Bajaj, another contractual worker, who allegedly played an active role in conducting the recruitment tests. Voice tests are one of the most crucial elements in the selection of newsreaders and translators, but instead of being handled by authorized officers, they were reportedly managed by contractual hands. This is not a small procedural lapse. It is a direct assault on the sanctity of recruitment and on the trust of candidates who came forward with the hope of a fair assessment.

Adding insult to injury, the name of Professor Veena Gupta, a highly respected scholar of Dogri and former head of the Dogri Department at the University of Jammu, was misused as a supposed consultant for setting the examination paper. Professor Gupta herself clarified that she had no role in the process. This was not just a casual clerical mistake. It was a deliberate act to cloak a compromised selection with the veneer of scholarly endorsement. By misusing the name of an eminent academic, the organizers crossed the boundary from irregularity into deliberate deception.

 $But the \, consequences \, of \, these \, irregularities \, have$ become most visible on air. Even those who were finally selected are seen fumbling when they present their bulletins. Pronunciations falter, sentences break midway, and the flow of news collapses into hesitation. Listeners who tune in for clarity and confidence are instead greeted by confusion and stammering. When merit is sidelined and selections are made on the basis of dosti-yaari, favoritism, or other informal networks, the result is bound to be incompetence. Broadcasting is not a hobby; it requires training, fluency, and the ability to carry the trust of an entire audience. Sadly, this trust is being shattered every time an undeserving candidate takes the microphone.

This situation raises a haunting question: was the entire exercise meant to find the best voices for the job, or was it only meant to accommodate a chosen few? If personal friendships and hidden alliances decide who becomes a newsreader, then what future is left for hundreds of youth who prepare tirelessly, study for exams, and refine their skills in the hope of a fair chance?

The allegations do not end here. Insiders revealed that during the recruitment process, two highly qualified individuals who had once been associated with Akashvani were sidelined entirely. Their exclusion speaks volumes about the intentions behind the exercise. If merit and experience are deliberately ignored while questionable candidates are promoted, then the process cannot be described as anything but manipulation. The names repeatedly emerging in this manipulation are Jagmohan Sharma and Vijay Bajaj, who seem to have built an outsized influence within the unit.

The damage caused by such practices is not limited to a few failed candidates. It undermines the very spirit of public broadcasting. Akashvani is supposed to represent the voice of the people, provide a fair opportunity to regional language practitioners, and protect cultural diversity. When favoritism replaces merit, when procedural violations replace transparency, the entire credibility of the institution collapses.

The larger question is how such practices have been allowed to thrive. Yaseen and other cultural activists argue that there is a structural failure within the system. Contractual employees, instead of being limited to their defined roles, are often empowered to act like permanent officers. Government employees drawing hefty salaries are given casual duties in addition to their official assignments, thereby blocking opportunities for unemployed youth. The outcome is an atmosphere where insiders protect each other and outsiders, however qualified, are kept away.

This is not an isolated case. Reports suggest that similar irregularities are happening in other language sections, including Gojri. Appointments and selections are being influenced by informal networks rather than by transparent procedures. In effect, a public institution funded by taxpayers is being run like a private fiefdom, with a handful of people deciding who gets opportu-

nities and who remains excluded. The controversy has also highlighted the larger debate on governance. India is at a juncture where the government often speaks of transparency, accountability, and meritocracy. Prime Minister Narendra Modi's vision of good governance emphasizes fairness and opportunity. But when a national broadcaster, operating under Prasar Bharati, permits

such irregularities, it creates a sharp contradiction between vision and reality. The credibility of not just the organization but also of the broader system

comes under question. The incident also reflects how deeply entrenched favoritism has become in our institutional culture. Instead of nurturing new talent, organizations are often content to recycle the same names, empower the same insiders, and protect the same networks. For languages like Dogri and Gojri, which already struggle for visibility, such practices are doubly damaging. They deprive genuine practitioners of opportunities while pushing forward those who may not even have the required qualifications or experience.

What should have been a platform for promoting regional culture has thus been turned into a stage for personal gain. The misuse of authority by contractual employees is not just a breach of rules, it is $a \, be tray al \, of the \, trust \, of young \, aspirants \, who \, prepare$ and compete in good faith. Every instance of unfair selection sends a message to talented youth that merit does not matter, that transparency is an illusion, and that institutions are in the grip of those who treat them like personal estates.

The outrage is growing. Cultural and linguistic circles in Jammu are demanding a thorough inquiry into the recruitment scandal. Yaseen himself has announced plans to file fresh RTI applications to obtain documentation of not just this recruitment but also other recent selections, including for the post of Copy Editor in the news section of Akashvani Jammu. The demand is simple: show the procedures followed, show the qualifications of those selected, and explain on what grounds the decisions were made. If transparency exists, there should be no hesitation in making these details public.

The worry, however, is that silence will prevail. Institutions often prefer to protect themselves by denying information rather than by acknowledging faults. But silence cannot erase the truth. The more Prasar Bharati delays action, the deeper the damage will be to its credibility. The more irregularities are swept under the carpet, the harder it will be to restore

This episode is also a cautionary tale about the broader state of public institutions in India. When authority becomes concentrated in the hands of a few individuals who operate without checks and balances, institutions begin to decay from within. Instead of being engines of opportunity and fairness, they turn into tools for personal networks and vested interests. The story of Akashvani Jammu's Dogri recruitment is not just about one examination. It is about the future of public broadcasting and the future of regional languages in India.

Dogri and Gojri are not just academic subjects. They are living languages that carry the culture, history, and identity of millions of people. For years, activists, scholars, and cultural workers have fought to ensure that these languages receive institutional support and visibility. When recruitment processes meant to support these languages are corrupted, it is not just an administrative failure. It is an assault on cultural preservation itself.

Blasting and cloudbursts are two separate phenomena that can both lead to significant geological disasters in mountainous regions. Blasting, a humaninduced activity for construction, can destabilize slopes and trigger landslides. Cloudbursts are natural weather events $involving intense\,rainfall\,that\,cause\,flash$ floods and mudslides by saturating the already unstable terrain. In mountainous areas, blasting can exacerbate the dangers posed by cloudbursts by increasing the overall risk of landslides and debris

No, human-caused "unprecedented development" does not directly cause cloud bursts, which are natural, localized, and intense rainfall events. However, human activities like unregulated construction and deforestation in vulnerable areas amplify the destructive impact of cloud bursts and flash floods by destabilizing terrain and increasing risks.

Additionally, climate change, a significant human impact, increases atmospheric moisture and destabilizes weather patterns, leading to more intense and frequent thunderstorms, which are the primary cause of cloud

What is the phenomenon of 'cloudbursts'? Cloudbursts happen when strong updrafts in thunderstorms trap large amounts of water in high-altitude clouds, which then suddenly fall as heavy, localized rain when the updrafts weaken. These events are often intensified by topography, where mountain ranges force warm, moist air to rise (orographic lifting), leading to intense cloud formation and a sudden release of water. Climate change is increasing the frequency and intensity of cloudbursts because warmer air can hold more moisture, fueling extreme downpours.

Conditions for a Cloudburst: Cumulonimbus Clouds: The process begins with large, tall cumulonimbus clouds that can hold significanth moisture.

Rapid Updrafts: Warm, moist air rises rapidly, forming clouds and holding water droplets suspended within them due to strong updrafts.

Trapped Water: The upward currents are so strong that they prevent the water

droplets from falling, accumulating a large amount of rain in the cloud.

Weakening Updrafts: When the updrafts weaken or the cloud becomes too saturated, this collected waterfalls rapidly in a sudden, intense downpour.

Contributing Factors: Orographic Lifting: In mountainous regions, air is forced to rise over the terrain, enhancing cloud development and leading to increased precipitation.

High Humidity: Large amounts of moisture in the atmosphere are necessary for the formation of the heavy clouds involved in a cloudburst.

Temperature Differences: Significant temperature differences between different atmospheric layers can lead to instability and rapid convection, fueling the intense rainfall.

Climate Change: A warmer atmosphere holds more water, which can be released in extreme rainfall events, increasing both the frequency and intensity of cloudbursts.

How Forest Degradation Worsens Cloudbursts: Increased Soil Erosion and Landslides: The dense root systems of trees bind the soil, preventing erosion and acting as a natural barrier against debris flow. Loss of these trees leaves the soil exposed and unstable, causing rapid erosion and increasing the risk of landslides and debris flows during heavy

Reduced Water Absorption: Forests play a crucial role in regulating water flow. Trees absorb rainfall and facilitate its percolation into the soil, reducing surface runoff. Without this natural capacity, rainwater rushes down slopes, overwhelming natural drainage systems and exacerbating flash floods.

Magnified Disaster Severity: Had the forests in regions like Uttarkashi retained their historical tree cover, the impact of the recent disaster would have been significantly less severe, according to experts. The absence of trees means that water and debris flow down the mountainsides with greater force and volume, magnifying the destruction.

Combined Impact with Climate Change: Forest degradation, alongside climate change, human population growth, and unsustainable development, are key factors contributing to the increased frequency and intensity of cloudbursts and their devastating con-

In summary, forest degradation acts as a multiplier for the destructive effects of a cloudburst by removing natural defenses against heavy rainfall and causing rapid water runoff.

First Cloud Burst in J&K: There isn't a record of the "first ever" cloud burst in Jammu & Kashmir, as the region has experienced historical flooding, but a significant, devastating cloudburst event occurred in the Kishtwar district on August 14, 2025, killing 65 civilians and leaving 33 missing. This was followed by another cloudburst in Kathua district, which also caused casualties. The Kishtwar event was a major tragedy, severely impacting the Machail Mata temple yatra and causing widespread damage.

There isn't a record of the first-ever cloudburst in the world, as it's a natural phenomenon that predates human record-keeping. However, historical records and scientific studies document many severe cloudbursts throughout history and in various locations, including incidents in Panama in 1911, India in 1908 and 2005, and Guadeloupe in 1970, which highlight the event's destructive potential and long existence.

Historical Examples of Cloudbursts: 1911 (Panama): A rainfall of 63 mm (2.47 inches) in just three minutes was

recorded in Porto Bello, Panama. 1970 (India): A cloudburst in the



Alaknanda river catchment area led to a significant rise in the river level.

2005 (Mumbai): The city experienced a massive cloudburst that brought approximately 950 mm (37 inches) of rainfall in a single day.

Before modern meteorological science and recording equipment, events like cloudbursts would not have been documented in detail, making it impossible to pinpoint the first occurrence. Current records often focus on the impact and damages caused by cloudbursts, rather than their first instance.

When disaster strikes, the impact of the disaster can either increase dramatically or decrease dramatically, depending on your response to the disas-

Heavy rains in Jammu:

Heavy Rain in Jammu: Jammu is facing a crisis after experiencing extreme, continuous rainfall that caused flash floods, submerged low-lying areas, and triggered landslides. The city recorded its second-highest single-day rainfall in August in nearly a century, with floodwaters inundating homes and commercial establishments. Significant infrastructure damage includes submerged and damaged houses, washed-away vehicles, and a bridge on the Jammu-Pathankot NH. Rescue efforts are underway, with teams evacuating trapped students from a hostel. Authorities have issued alerts, closed schools, and advised residents to stay clear of rivers and floodprone areas as moderate to heavy rainfall is expected to continue.

Flooding: Heavy rainfall led to flash floods and waterlogging in several areas, including Janipur, Roop Nagar, and Talab Tilloo, forcing residents to evacuate.

Infrastructure Damage: Roads have caved in, a vital bridge on the Jammu-Pathankot highway has been damaged, and boundary walls of houses have col-

lapsed. Landslides: Landslides blocked roads, including the Jammu-Nagrota and Samba-Mansar-Udhampur roads.

Inundated Areas: Low-lying areas, several houses, and the ground floor of the Indian Institute of Integrative Medicine (IIIM) hostel complex were sub-

Rescue and Response: Evacuations: State Disaster Response Force (SDRF) and police rescued over 45 students trapped in the IIIM hostel using boats.

Disaster Alerts: Disaster response teams and police are on alert, with flood alerts issued for rivers like the Ujh and Basantar nullah.

Infrastructure Monitoring: Authorities are monitoring the situation closely, with relief and rescue teams on

Current Situation and Outlook: Weather Forecast: Moderate to intense rainfall is expected to continue in the region for the next few days, with the possibility of more cloudbursts, flash floods, and landslides.

Public Advisories: Authorities have advised residents to stay away from rivers, streams, and landslide-prone zones and to stay vigilant.

Kishtwar Cloudburst: Army Commander Lauds Forces For Relief Works! Northern Army Commander Lieutenant General Pratik Sharma has complimented troops for the disaster relief efforts undertaken by them during the Chisoti cloudburst.

Lt Gen Pratik Sharma, Army Commander Northern Command, visited hinterland formations and units at Rajouri and Kishtwar to compliment troops for their resilient action, as also swift and successful execution of HADR efforts during Chishoti cloudburst,

A cloudburst struck Chisoti, the last motorable village en route to the Machail Mata temple, on August 14, leaving 65 people dead and 33 missing.

The Army inducted over 300 troops with machines for the search, rescue and relief operation in Chisoti.

Army engineers built a Bailey bridge over the Chisoti nullah, restoring muchneeded connectivity to the village and the Machail Mata shrine. The Army has also inducted a couple of all-terrain vehicles as part of efforts to intensify the rescue and relief operation.

The flash floods triggered by the cloudburst left a trail of destruction, flattening a makeshift market and a langar site for the annual Machail Mata yatra, damaging 16 houses and government buildings, three temples, four water mills, a 30-metre-long bridge, besides over a dozen vehicles.

PM Modi Very Concerned, Monitoring Situation In Cloudburst-Hit Kishtwar: Rajnath!

Defence Minister Rajnath Singh reviewed the situation following a recent cloudburst in Jammu and Kashmir's Kishtwar and said Prime Minister Narendra Modi is very concerned over the tragic incident and is personally monitoring the relief and rehabilitation mea-

Singh also visited the survivors undergoing treatment at the Government Medical College hospital Jammu and lauded the doctors for saving precious

The defence minister said his plan to visit the cloudburst-hit area could not materialise due to inclement weather and a fresh landslide on the road enroute.

A large-scale search operation is underway for 32 people reported missing by their families after the tragedy.

Lauding the doctors for taking good care of those admitted to the hospital after the incident, the defence minister said the injured people are recuperating satisfactorily.

At Raj Bhavan, he reviewed the situation in the affected village via videoconferencing and said it is heartening to note that the Union Territory administration, Army, NDRF, SDRF and police have done excellent work during the

7 killed as cloudbursts hit two villages in J&K's Kathua:

Jammu Kathua Cloudburst: The district administration is closely watching the situation and has requested people to stay away from water bodies for their safety. On the other hand, the Indian Railways has regulated the operations of several trains following the cloudburst.

This was following torrential rain that had already led to local streams overflowing, cloudbursts hit Jodh Ghati village in Rajbagh and Bagra village of Janglote — both in Kathua.

According to local residents, after the cloudbursts, floodwater came down to the plains of Rajbagh and Kathua towns, submerging roads, lanes and bylanes. Several houses were also flooded, causing damage to buildings, belongings, and vehicles. Even the Raj Bagh police station saw knee-deep water

The Dyalachak–Billawar and Lakhanpur-Basohli roads were closed for vehicular traffic after they got damaged due to landslides at various places, the Kathua Police Control Room said.

Rail traffic between Kathua and Jammu was also disrupted after railway authorities halted Jammu-bound trains either at Jalandhar or Pathankote in view of flood waters flowing over the railway tracks in the Kathua area. Later, rail traffic was restored, but the trains were running late by three to four hours, officials said.

Meanwhile, Army columns and teams of J&K Police moved in and launched rescue operations. Deputy Inspector General of Police for Jammu, Samba, and Kathua range was himself camping at Rajbagh, supervising the rescue operations, officials said.

A New Dawn in Diabetes Treatment

Diabetes is one of the fastest-growing health problem which is posing biggest challenge for the humanity. A very large percentage of the world's population is suffering from this chronic disease which could lead to heart disease, kidney failure, blindness and nerve damage if it is not properly managed medically. The Current treatments consisting of insulin injections and oral medicines only helps in controlling blood sugar but they do not cure the disease completely. Today scientists and medical researchers across the globe are exploring a revolutionary approach which is known by the name stem cell therapy. This medical miracle which could one day allow the body to naturally produce its own insulin again.

How Stem Cell Therapy Works?

Stem cells are the body's master cells which are capable of transforming into many different types of specialized cells. In the case of diabetes:


For Type 1 diabetes (where the immune system destroys insulin-producing cells), stem cells can be converted into new insulin-producing B-cells. These cells are then transplanted into the body to restore insulin pro-

For Type 2 diabetes (where the body resists insulin and later loses insulinproducing capacity), stem cell therapy helps by repairing damaged B-cells and reducing inflammation making the body more sensitive to insulin.

Some therapies use encapsulated stem cells, placed inside protective capsules that allow insulin to pass through but block immune attack. Others therapies are using the patient's own cells, reprogrammed into insulin-producing cells to reduce the risk of rejection.

Costs And Availability

In the present era the stem cell therapy is available only through experimental trials at advanced medical centers in the USA, Europe, China and India. The estimated cost is very very high and the expenses of the therapeutic depends



on the hospital and method used. Since it is still under clinical study most health insurance policies do not cover it.

Success Rates So Far

In Type 1 diabetes, early trials and experimentation have shown that 20–40% of patients can reduce or temporarily stop insulin use after receiving stem cell-derived B-cells. However, longterm success remains under medical research and investigation.

In Type 2 diabetes, about 50–70% of patients in trials have reported better blood sugar control, lower HbA1c levels and reduced need for medication.

While these results are promising for the detailed medical and scientific research but complete cure remains rare

Risks And Challenges

No therapy is without risks. Stem cell treatment may cause:

1. Immune rejection of transplanted cells could also be a problematic area for concern particularly in Type 1 diabetes.

2. The risk of tumor formation if stem

cells are not fully matured before use could be the biggest challenge for

the medical fraternity. 3. Infections or complications could occur during the transplantation procedure and this could spoil the dream run of achieving freedom from diabe-

4. Ethical concerns could be raised in some countries of the world espe-

cially regarding embryonic stem cells. 5. High costs of using the therapy could pose a hurdle and which could limit the access of the therapy for ordinary patients.

Pros And Cons Of Stem Cell Thera-

1. The Stem Cell Therapy offers a potential long-term solution and the positive of the therapy is that it is not just symptom management.

2. The silver lining of using the therapy is that it may reduce or even eliminate insulin injections in some

Rana lays foundation stones for Flood Protection **Works, Water Supply Scheme in Uri**

Holds Public interaction at Boniyar and Uri



URI, AUG 25: In a major push to flood mitigation and infrastructure development in North Kashmir's Uri region, the Minister for Jal Shakti, Forest, Ecology, Environment and Tribal Affairs, Javed Ahmed Rana, today laid the foundation stones for Erosion and Flood Protection Works at Boniyar and a comprehensive Water Supply Scheme (WSS) under AMRUT 2.0 in Uri town.

The Erosion and Flood Protection project, with an outlay of 18.57 crore, is being implemented under the Comprehensive Flood Management Programme

The initiative aims to safeguard vulnerable stretches of the River Jhelum from RD 180 km to 225 km, where the riverbanks are most prone to erosion and flooding.

The project includes the construction of RCC retaining walls and crate protection works, and is expected to be completed within eight months, benefiting dozens of villages by protecting lives, property, and agricultural

Speaking at the foundation laying ceremony of Erosion and Flood Protection works, Minister Rana stated, "these projects re-



flect Omar Abdullah government's commitment to proactive flood management and environmental protection. They not only address immediate threats but also enhance the long-term resilience and ecological stability of the

region." Laying the foundation of the WSS Uri project, the Minister described it as a transformative step towards achieving 100% potable water coverage in Uri town.

The scheme, costing 6.71 crore, includes the construction of a 0.55 MGD Rapid Sand Filtration Plant (RSFP) at Uri, a 0.25 MGD RSFP at Lagama, a new water reservoir, and augmentation of the

existing distribution network. The system is designed to provide a reliable supply of 135 litres per capita per day, meeting both current and future needs.

He added that the projects will significantly improve public health, infrastructure and service delivery, especially in remote and underserved areas.

The events were attended by MLA Uri, Dr. Sajad Shafi, Chief Engineer PHE Kashmir, Er. Taj Choudhary, along with senior officials from the Jal Shakti Depart-

Later, the Minister held public interaction programmes at Peernia Playground in Boniyar and Officers' Club Uri, where he met

with a large number of residents and representatives from various villages and hamlets.

During the interactive sessions, locals raised pressing issues such as damaged road infrastructure, water supply challenges and the need for improved educational

The Minister gave a patient and sympathetic hearing, assuring the public that their concerns will be addressed on priority.

"The Omar Abdullah-led government is deeply committed to responsive and accountable governance. Development must reach every doorstep, and grievances must be resolved swiftly," he said.

He further emphasized the importance of timely implementation of projects under flagship programs and centrally sponsored schemes, urging officers to conduct regular field visits and reviews, especially in far-flung areas, to monitor the effectiveness of public welfare services.

7-Day Training Programme on **Scientific Beekeeping Concludes** at Kisan Kendra Jammu

JAMMU, AUG 25: The Department of Agriculture Production & Farmers Welfare Jammu, under its Apiculture Development Scheme, successfully concluded a Seven-Day Divisional Level Training Programme on Scientific Beekeeping integrated with the Oil Seed Mission (NMEO-OS). The training, which commenced on August 18, 2025, was held under the National Beekeeping and Honey Mission (NBHM) and aimed at empowering farmers with modern apiculture techniques to boost income and enhance pollination efficiency.

The valedictory session, held today at Kisan Kendra, Talab Tillo, was presided over by Director Agriculture Jammu, Anil Gupta as Chief Guest. The event was attended by senior officers including Joint Director Inputs, Dr. Ashwani Kumar; Assistant Entomologist, Rajesh Verma; Agriculture Economist, Tilak Raj Sharma; Agronomist (VIS) Vikas Padha; Agriculture Information Officer (FTC) Guldev Raj; and District Agriculture Officer, Neeraj Rajwal.

A group of 25 prospective beekeepers from Oil Seed Cluster Bhalwal successfully completed the training, which combined classroom lectures, field demonstrations, and exposure visits.

Comprehensive Training Modules

Scientists from SKUAST-Jammu and departmental experts covered critical aspects of scientific beekeeping, including:

- Apiary Management handling bee colonies, seasonal management, pest and disease control.
- Pollination Services significance of bees in enhancing oilseed and horticultural crop produc-
- Value Addition processing, testing, and marketing of honey and allied products like wax, propolis, and royal jelly.
- Entrepreneurship Opportunities business models for honey-based enterprises and role of FPOs.

The participants also visited the Apiculture Demonstration-cum-Training Centre, Chimney Chak, Jammu, where they received hands-on training in hive operations and colony management. Additionally, a field visit to the Honey Processing and Testing Laboratory at SKUAST-J familiarized them with quality control, value addition, and certification standards for honey and bee products.

Empowering Farmers through Beekeeping

Addressing the gathering, Director Agriculture Anil Gupta highlighted the vast potential of apiculture in enhancing farmers' income, crop diversification, and sustainable agriculture. He urged farmers to adopt scientific techniques and leverage departmental schemes that support modern beekeeping as a profitable allied enterprise.

Joint Director Inputs, Dr. Ashwani Kumar, stressed that apiculture not only generates income but also plays a vital role in pollination management, food security, and ecological balance. He motivated farmers to scale up beekeeping practices with the help of institutional support, training, and market

Recognition & Support to Farmers

At the conclusion of the programme, the department distributed Certificates of Participation, Beekeeping Tool Kits, and Bee Flora Saplings among the trainees. These saplings will help farmers develop local nectar sources, ensuring the sustainability of their beekeeping ventures.

Future Roadmap

Officials shared that such training programmes would be regularly organized across Jammu Division to promote apiculture as a commercially viable, technology-driven, and environmentally sustainable activity. Farmers were also encouraged to form clusters and cooperatives to collectively market honey and related products, thereby enhancing competitiveness in both domestic and international markets.

The meeting also explored opportunities for convergence of HADP with other flagship programmes, such as PM-Kisan, National Beekeeping and Honey Mission, and Rashtriya Krishi Vikas Yojana, to maximize resource utilization and avoid duplication

of efforts. Looking ahead, the DDC called for preparation of a district-level roadmap that integrates HADP outcomes with broader agricultural development, employment generation, and rural economy strengthening goals.











Ganguly **Appointed Pretoria Capitals Head Coach**

BENGALURU: Sourav Ganguly is going to be the new head coach of Pretoria Capitals for the fourth season of SA20, starting on December 26. He replaces Jonathan Trott in the role, having already acted as the director of cricket for JSW Sports - the parent company of Pretoria Capitals - since last year.

Pretoria Capitals have had an uneven time in the tournament so far: they finished the first season at the top of the table in the group stage, before losing to Sunrisers Eastern Cape in the final. In the two seasons since then - in 2023-24 and 2024-25 - they have faced more middling results, finishing in fifth position both times and failing to qualify for the playoffs.

Pretoria Capitals will be hoping that their luck turns around with Ganguly's appointment. This will be the former India captain's first time as a head coach. For four years, between 2015 and 2019, he was the president of the Cricket Association of Bengal. He joined Delhi Capitals as a mentor for the 2019 sea-

Australian quick Lance Morris out for 12 months with back injury

MACKAY: Fast bowler Lance Morris was Sunday ruled out for 12 months due to back surgery, denying him the chance to be part of Australia's squad for the Ashes series later this year.

The 27-year-old, who has been in and around the Australian set-up for several years, was originally named to feature in the current one-day series against South Africa. But he pulled out at the last minute after experiencing lower back pain in the lead up, with further investigation revealing a lumbar bone stress injury.

Morris said he had decided to have surgery. "I feel this is the most



logical way to realise my full potential and return to my very best cricket for the Perth Scorchers, Western Australia and Australia long into the future," he said in a statement.

"I also take great confidence in others who have undergone similar procedures and returned to their best. I plan to work hard through my recovery and return when the time is right."

Cricket Australia said he would likely be sidelined for 12 months, ending his hopes of an Ashes debut. Morris was seen as a potential fifth pace option for the campaign against England as back-up to Pat Cummins, Mitchell Marsh, Josh Hazlewood and Scott Boland.
