

11 Dead In Reasi, Ramban Cloudburst, Landslide

Over 100 die in 15 days in Jammu region • Union MoS, LG Sinha assure help • CM Omar directs for safeguarding lives

REASI/RAMBAN, AUG 30: Tragedy struck Jammu region once again within just four days, as 11 people lost their lives on Saturday in separate incidents of land $slides\, and\, a\, cloud burst\, in\, the\, twin\, districts$ of Reasi and Ramban, pushing the death toll to over 100 in just 15 days."

According to the details available with the news agency—Kashmir News Observer (KNO), the back-to-back incidents of landslides and flash floods triggered by the cloudbursts in Kishtwar, Kathua, Katra, Reasi and Ramban have so far claimed the lives of almost 100 people in the past 15 days while several others are still missing and rescue operation is still

As many as 64 people died in Kishtwar incident while Katra landslide claimed the lives of 35 people three days ago.

Today's twin incidents were the fifth major incidents in Jammu region in the last fortnight triggered by the heavy

Notably, J&K is presently witnessing intermittent rains for the last over one week, which also led to the flood-like situation across both the regions as the

water level in all the major rivers and streams crossed the alert mark.

In yet another incident, a family of seven died after a landslide, triggered by heavy rainfall, struck a residential house in Bhadder village of Mahore tehsil in

Officials said the incident occurred early this morning when a massive landslide hit the house, located on a steep slope, burying the structure under debris.

The house was occupied by multiple family members at the time of the inci-

"Seven people were trapped under the debris. Rescue teams, including personnel from the police, SDRF and local administration were dispatched immediately and all the bodies were recovered," an official told KNO.

Post-flood health alert: Experts urge caution with water, food safety in J&K

Food items exposed to flood water pose risk of water-borne diseases, say doctors

SRINAGAR, AUG 30: In the aftermath of recent floods that struck several areas of Jammu and Kashmir, health experts have urged people to exercise extreme caution while using

food and water supplies. They said contaminated sources pose a grave risk of water-borne diseases such as diarrhoea, cholera, dysentery, typhoid, and hepatitis A and E.

Speaking to the news agency— Kashmir News Observer (KNO), offi-

cials said the foremost priority should be access to safe water. They stressed that only clean water should be used for drinking, cooking, and brushing

Sealed and packaged bottled water from a reliable source is the safest

option, they added.

Chief Medical Officer (CMO) Anantnag, Dr Khalid Parvez said that in the absence of bottled water, residents should boil water for at least 10 minutes before use, and chlorine Turn on Page 2



J&K WILL GET BACK ITS STATEHOOD SOON: ATHAWALE

SRINAGAR, AUG 30: Union Minister of State (MoS) Ramdas Athawale on Saturday said Jammu and Kashmir will get back its statehood soon.

Although the Union minister did not give a time-frame, he said, "I believe it will happen soon."

Talking to reporters, Athawale said, "I think J-K should get back its statehood as soon as possible, and there is a demand for that

He said that when the Assembly elections took place in J-K last year, more than 60 per cent voting was recorded - which was more than many other states in the country.

"I thank the people of J-K for that, for not succumbing to fear. When (Union Home Minister) Amit Shah abrogated Article 370, he stated that J-K will soon get its statehood back and I think the Government of India can take

that decision soon in the future," he said.

When asked how much more time it can take for that, the Union minister said, "I cannot tell you when, but I believe it will happen

soon." Responding to a question about the recent floods in the Jammu region, Athawale said the Centre would do everything possible to help and support J-K.

DGP reviews flood-hit areas in Kathua

KATHUA, AUG 30: Director General of Police (DGP) Nalin Prabhat visited forward locations along the Kathua border to take stock of the security situation and assess the impact of recent floods. He was accompanied by DIG JKS Range, Shiv Kumar Sharma and SSP Kathua, Shobhit Saxena.

appealed to residents living in hilly and landslideprone areas to remain alert and avoid staying in vulnerable structures during periods of heavy rain.

An official said in another incident four people died after a cloudburst struck Rajgarh tehsil of Ramban district, while one person remains missing and according to the officials, the rescue operation was launched immediately to trace the missing person.

He said the rescue teams have recovered four bodies from the affected area and efforts are ongoing to trace the remaining missing person.

"The cloudburst triggered flash floods, damaging property and affecting normal life in the region. One person is still unaccounted for," the official said. LG ANGUISHED OVER LOSS OF LIVES

Lieutenant Governor Manoj Sinha expressed anguish over the loss of lives caused by recent landslides and cloudburst incidents in Reasi and Ramban districts, which left 11 people dead and one missing.

In a post on X, as per the news agency—Kashmir News Observer (KNO), the LG said that he has been in touch with senior officials to assess the situation and assured that all possible assistance is being provided to those affected.

UNION MOS SPEAKS TO DC RAMBAN

Meanwhile, Union Minister Dr. Jitendra Singh, in a post on X, said he had spoken to Deputy Commissioner Ramban, Mohammad Aiyaz Khan, regarding

"A cloudburst in the Rajgarh area has resulted in the unfortunate loss of four lives. One person is still missing, and search operations are underway. Fortunately, there are no injuries reported. Rescue efforts are in progress, and all possible assistance is being provided. I am in constant touch with the district administration," he said.

CM OMAR ASKS TO REMAIN VIGILANT, SAFE-**GUARD LIVES**

Moreover, Chief Minister Omar Abdullah also expressed condolences over the incident. In a post on X, his office stated: "The Chief Minister has expressed deep anguish over the loss of lives due to the landslide in Rajgarh, Ramban. He has directed the administration to carry out immediate rescue and relief opera-

According to the post by the Office of Chief Minister, J&K, "Chief Minister expressed deep sorrow over the tragic landslide in Reasi's Bhadder village that claimed the lives of seven family members.'

Taking note of the continuous heavy rains, he appealed to people to remain alert, avoid vulnerable areas, and strictly adhere to safety advisories. He has directed the district administration and disaster management authorities to remain on the ground, ensure round-the-clock monitoring, carry out timely evacuation of residents from risk-prone zones, and provide immediate relief and all possible assistance to the affected families.

He instructed the concerned departments to remain vigilant, coordinate closely, and take every precautionary measure to safeguard lives during the ongoing inclement weather.

WEATHER FORECAST

In the meantime, the weatherman has issued yellow and orange warnings for the next three days, saying that there is a forecast of light to moderate rain till September 02.

Dr Mukhtar Ahmad, Director Meteorological department (MeT), told KNO that one or two spells of light to moderate rain is expected at scattered to fairly widespread places with possibility of heavy to very heavy rain over Jammu, Kathua & Samba and moderate to heavy rain and thundershower and intense showers at Udhampur, Reasi, Rajouri, Ramban, Doda & Kishtwar till September 02.

He said during the period, a few places of South Kashmir and central Kashmir may also experience light rain with brief intense showers with thunder

From September 03 to September 08, he said that generally hot & humid weather is expected with brief spell of rain and thundershower at a few places.

ADVISORY ISSUED The MeT in its advisory has stated that there is a possibility of heavy to very heavy rain, thundershower and intense showers at few places of Jammu division during 30th late night to 2nd September.

"There is a possibility of cloudbursts, flash floods, landslides, mudslides, shooting stones etc at few vulnerable places," it reads and advised people to stay away from water bodies, Nallas, river embankments, loose structures etc.

All concerned are advised to stay alert & updated,

The Chief Minister directed authorities to ensure swift restoration of road connectivity, smooth traffic movement and uninterrupted supply of essentials, particularly to the Kashmir Valley and remote areas of Jammu division. He emphasized the need for close inter-departmental coordination and timely updates

to respond promptly to public needs. Chief Secretary Atal Dulloo briefed the meeting about the condition of NH-44, describing its restoration as the top priority since it is the lifeline connecting Kashmir with the rest of the country. He stressed the importance of facilitating movement of perishable commodities like fruit from the Valley and highlighted the grim situation in areas such as Kishtwar and Udhampur, which are facing outages of power, drinking water, road connectivity and mobile networks.

He further underlined the need for temporary restoration of highways such as Dhar-Mahanpur, Ramban-Gool, and Reasi-Mahore to reconnect

affected districts. The Chief Minister enquired about the stock position of ration, fuel and medicines in cut-off places like Bani, Kishtwar, Reasi and Udhampur. He directed officers to replenish supplies through alternate routes including via Anantnag for Kishtwar and through Bhaderwah for Bani — until full restoration of roads

is achieved.

Divisional Commissioner Jammu informed the meeting about the ongoing restoration works on NH-44, resumption of supplies into the Valley, and special trains being run to facilitate passengers and tourists. He assured that there is no shortage of ration, fuel or other essentials in Jammu and efforts are being made to keep cut-off areas adequately stocked.

Similarly, Divisional Commissioner Kashmir informed that the Valley has sufficient supplies of fuel and ration.

The Chief Minister also directed that all roads under BRO, NHAI, NHIDCL and other agencies that remain disconnected be monitored closely, with status reports shared with his office twice daily — morning and

tablets or household-grade unscented liquid bleach can be used for disinfection by following recommended instructions.

"If water appears muddy or turbid, it should first be filtered through a clean cloth before boiling or treating," he said, adding that to avoid recontamination, safe water should be stored in clean, covered

Dr Khalid added that hands or unclean objects should never be dipped into stored drinking water; instead, use a ladle or small vessel and drinking water must always be kept separate from water used for washing or cleaning.

Experts warn that food items exposed to floodwater are unsafe and must be discarded immedi-

They said that fruits and vegetables should be thoroughly washed with safe water before consumption, and people must wash their hands with soap and safe water before preparing or eating food, while utensils should be cleaned with safe water before use.

Open wells and surface water sources are at high risk of contamination after floods and submerged wells should not be used until they are properly cleaned, disinfected, and tested, according to health experts.

People have been advised to depend on alternative safe water sources until proper clearance is given. Doctors have urged people to remain vigilant for symptoms of water-borne diseases, and warning signs include diarrhoea, vomiting, fever, or jaundice.

"Anyone showing these symptoms should be taken to medical care immediately. For those suffering from diarrhoea, ORS (Oral Rehydration Solution) should be given promptly to prevent dehydration and clean, safe water saves lives. Following these precautions can prevent the spread of deadly diseases after floods," doctors said.

Medical experts have called for strictly adhering to these health and hygiene guidelines, saying this will help avoid a secondary crisis of preventable diseases—(KNO)

agency-Kashmir News Observer (KNO) said, "The administration is continuously working to restore connectivity in the affected areas. Teams have been mobilized across Doda to assess damage and repair essential infrastructure."

"Efforts are ongoing around the clock, and we are pleased to report that nearly 80 percent of services, including road access, electricity, and communication networks, have already been restored. The government remains committed to ensuring full restoration and providing relief to all impacted families," he added.

According to reports received by KNO the worst-Iffected areas in Gandoh Doda include Kaharah, Charawa, Kharangal, and several other localities.

Pertinently, a cloudburst struck Tanta Wanipora earlier this week, claiming several lives. Among the deceased were Noor Mohammad and Mohammad Ighal from Wanipora.

In a separate incident, Rubina Begum, wife of Imtiaz Ahmad, was swept away by powerful floodwaters. Several other residents have sustained injuries at various locations throughout the region.

Residents informed KNO that a youth sports stadium, constructed by the Department of Rural Development in 2022-23, suffered severe damage. "The stadium's walls, built close to the Neeru tributary of the Chenab River, were swept away by strong floodwaters. Once the region's largest and only sports facility, hosting a variety of local competitions, the stadium now lies in ruins," residents said.

In Kaharah Charawa, a tourism building and several homes collapsed and were completely destroyed. In Wanipora, ten residential houses remained under constant threat due to unstable conditions. The bridge at Thathri, already in a weakened state, and its accompanying roadside culverts were

Locals reported that torrential rains and flash floods have devastated water channels, footbridges, wooden temporary structures, standing crops, and orchards, further deepening the crisis.

Meanwhile, in Bhaderwah, lightning strikes hit three different locations last evening, sending terrifying and loud sounds across the area and creating an atmosphere of fear and panic.

The sudden onset of floodwaters following these strikes led to inundation of several homes. The power supply was also cut off until Saturday afternoon,

strengthened early warning systems, advanced forecasting models, sustainable land management, regulated construction, and community preparedness.

The government, researchers and other experts say structural engineering for hill construction and public awareness campaigns are needed to ensure a timely response to sudden rainfall events

This August, more than 25 cloudbursts and nine landslides have been recorded in Jammu and Kashmir, resulting in 150 deaths, over 300 injuries, and many missing persons.

The study, 'Assessment and Review of Hydrometeorological Aspects for Cloudburst and Flash Flood Events in the Third Pole Region (Indian Himalaya)', examines the growing vulnerability of Himalayan states, including Jammu and Kashmir, to extreme

weather events. The region's fragile mountains, steep slopes, and variable climate make it prone to cloudbursts, flash floods, and rainfall-induced landslides. Past events, such as the 2010 Leh cloudburst and 2014 Udhampur floods, caused significant fatalities and property damage. The study identifies several contributing factors. Climate change increases atmospheric moisture and rainfall intensity, while the interaction of monsoon currents with western disturbances triggers sudden downpours. Orographic lifting due to high mountains amplifies rainfall, and unplanned construction, deforestation, and land-use changes destabilise slopes. Limited meteorological data and sparse weather stations further restrict prediction and early warning

To reduce risks, the study notes that advanced forecasting models such as WRF (Weather Research and Forecasting model) and HYSPLIT (Hybrid Single-Particle Lagrangian Integrated Trajectory model) are used to predict and analyse cloudbursts in the region. The WRF model simulates weather patterns at high resolution, helping forecast rainfall, cloud formation,

winds, and temperature over specific areas. HYSPLIT tracks the movement of air parcels and moisture, showing how winds carry moisture toward the Himalayas, which can trigger sudden heavy rainfall. Together, these models provide meteorologists with detailed information on where and how intense a cloudburst might be, supporting early warning and disaster preparedness.

It also calls for sustainable land management, regulated urban growth, and integration of scientific research into policy. Without these measures, Jammu and Kashmir could see an increasing frequency and intensity of cloudbursts and related disasters in the future.

"The active monsoon, moisture carried by easterly winds, and interaction with western disturbances trigger cloudbursts," said Dr Mukhtar Ahmad, Director of the Meteorological Department (MeT).

He said that rising temperatures and increased moisture flow towards the Himalayas increase the likelihood of such events. The MeT forecasts heavy rainfall and potential cloudbursts in Jammu, Reasi, Udhampur, and the Chenab Valley until September 3.

Meteorologist Sonam Lotus said the Western Himalayas, including Jammu and Kashmir, Ladakh, Himachal Pradesh, and Uttarakhand, are prone to flash floods and landslides during the southwest monsoon, which lasts from mid-June to mid-September.

He added that early warning systems are critical but cannot fully prevent loss, and public awareness remains central to minimising casualties Independent weather forecaster Faizan Arif

said that India has early-warning systems for heavy rainfall and flash floods, but there is no precise 'cloudburst alarm' for individual vil-The India Meteorological Department's Dop-

pler radars, satellite nowcasts, and the South Asia Flash Flood Guidance System can identify dangerous cells 30-180 minutes in advance and issue district- or block-level alerts.

On minimising damage, Arif said that while a cloud burst cannot be prevented, its impact can

"Measures include mapping high-risk gullies above settlements, building and maintaining overflow channels and debris barriers, installing dense networks of rain gauges and river sensors linked to automatic sirens, enforcing no-build zones on fans and streambeds, and conducting drills for five-minute evacuations to higher ground, particularly at night and along pilgrim routes. In areas with extreme risk, relocation may be necessary," he said.

These steps, Arif said, can help reduce casualties during sudden rainfall events. (KNO)

stranded, raising fears of massive losses to Kashmir's horticulture sector.

Speaking to reporters, SSP Traffic NHW Raia Adil, as per the news agency—Kashmir News Observer (KNO), said restoration works were underway at multiple spots affected by landslides in the Udhampur–Ramban stretch. "We are on it to ensure traffic flows smoothly. However, commuters must wait for clearance from the control room before planning their travel," he advised.

Deputy Commissioner Udhampur, Saloni Rai, who reviewed the situation at Bali Nallah, said heavy rains had delayed repair work at several locations. "The restoration works resumed after a brief disruption. From this evening, vehicular movement of essential heavy motor vehicles shall be allowed," she said.

Despite the limited relief, fruit growers remain alarmed. Chairman of the Kashmir Valley Fruit Growers cum Dealers Union, Bashir Ahmad Basheer, said over 700-800 trucks carrying Bagogosha pears, Galamast and Red Ghala apples are still stranded. "Fruit mandis are packed with consignments losing shelf life. Orchards are full of harvested fruit that cannot be dispatched. Unless fruit trucks are allowed priority passage, growers will suffer irreparable damage," he

warned. At Sopore Fruit Mandi, considered Asia's second largest, President Fayaz Ahmad Malik said trade has come to a near standstill. "From over 100 trucks daily, we are down to barely 20. Perishable items like Bagogosha cannot survive these delays. The horticulture sector is staring at losses of crores if the highway is not fully restored soon," he said.

"Growers have been asked to halt dispatches", he added. The highway has remained closed for four straight days due to heavy rains and landslides in the Udhampur-Ramban sector. J&K Judicial Academy organizes one-day training programme on **Cyber Laws at Srinagar**

SRINAGAR, AUG 30: Under the patronage of Justice Arun Palli, Chief Justice of the High Court of Jammu & Kashmir and Ladakh (Patron-in-Chief, J&K Judicial Academy), and under the guidance of the Chairperson and Members of the Governing Committee, the Jammu & Kashmir Judicial Academy organized a one-day training programme on "Cyber Laws & Appreciation and Handling of Digital Evidence" for the Judicial Officers of Kashmir Province and the Union Territory of Ladakh.

The inaugural proceedings were conducted by Sonia Gupta, Director Judicial Academy, who emphasized that the programme aimed to equip Judicial Officers with updated knowledge and practical insights on the emerging and evolving domain of cyber laws and the effective handling of digital evidence in Judicial proceedings.

The technical sessions were led by Dr. Nisheeth Dixit, an eminent cyber expert from Delhi, who highlighted the growing importance of Judicial awareness in the digital era, where cybercrime and electronic evidence increasingly shape litigation. He elaborated on recent developments in case law influencing judicial interpretation of digital evidence and discussed the legal framework governing cyber offenses. Dr. Dixit explained procedures for authentication, preservation, and admissibility of electronic records and addressed the challenges faced in handling and evaluating digital evidence.

A key highlight of the session was the discussion on landmark case laws, including Sanjaysinh Ramrao Chavan vs. Dattatray Gulabrao Phalke [MANU/ SC/0040/2015], where the Supreme Court ruled on the admissibility of recorded conversations. It was emphasized that without analyzing the original voice recording, translated transcriptions lack authenticity and cannot be relied upon. Dr. Dixit stressed that source and authenticity are the two crucial factors determining the evidentiary value of electronic re-

The programme featured interactive discussions, $case\, analyses, and\, practical\, demonstrations, enabling$ participants to gain hands-on exposure to the complexities of digital forensics and evidence appreciation. Real-world experiences and best practices for preserving, analyzing, and presenting digital evidence in court were shared, ensuring that the sessions were not only theoretical but also practically enriching. Participants engaged enthusiastically and expressed their satisfaction with the programme's comprehensive and insightful approach.

The event concluded with a vote of thanks delivered by Sonia Gupta, who extended her gratitude to Dr. Nisheeth Dixit for sharing his expertise and to the Judicial Officers for their active participation.

J&K Judicial Academy organizes one-day training programme on **Cyber Laws at Srinagar**

SRINAGAR, AUG 30: Under the patronage of Justice Arun Palli, Chief Justice of the High Court of Jammu & Kashmir and Ladakh (Patron-in-Chief, J&K Judicial Academy), and under the guidance of the Chairperson and Members of the Governing Committee, the Jammu & Kashmir Judicial Academy organized a one-day training programme on "Cyber Laws & Appreciation and Handling of Digital Evidence" for the Judicial Officers of Kashmir Province and the Union Territory of Ladakh.

The inaugural proceedings were conducted by Sonia Gupta, Director Judicial Academy, who emphasized that the programme aimed to equip Judicial Officers with updated knowledge and practical insights on the emerging and evolving domain of cyber laws and the effective handling of digital evidence in Judicial proceedings.

The technical sessions were led by Dr. Nisheeth Dixit, an eminent cyber expert from Delhi, who highlighted the growing importance of Judicial awareness in the digital era, where cybercrime and electronic evidence increasingly shape litigation. He elaborated on recent developments in case law influencing judicial interpretation of digital evidence and discussed the legal framework governing cyber offenses. Dr. Dixit explained procedures for authentication, preservation, and admissibility of electronic records and addressed the challenges faced in handling and evaluating digital evidence.

A key highlight of the session was the discussion on landmark case laws, including Sanjaysinh Ramrao Chavan vs. Dattatray Gulabrao Phalke [MANU/ SC/0040/2015], where the Supreme Court ruled on the admissibility of recorded conversations. It was emphasized that without analyzing the original voice recording, translated transcriptions lack authenticity and cannot be relied upon. Dr. Dixit stressed that source and authenticity are the two crucial factors determin-

ing the evidentiary value of electronic records. The programme featured interactive discussions, case analyses, and practical demonstrations, enabling participants to gain hands-on exposure to the complexities of digital forensics and evidence appreciation.

In a major relief for people SMC starts sterilization process

In a major relief for the residents of Srinagar city the Srinagar Municipal Corporation has embarked upon a mission to sterilize the dogs roaming in the different areas of the city. The drive has already started and over the next one and a half years it is expected that the sterilization process would be completed. This would mean that the people would heave a sigh of relief from the fear of dogs.

According to the figures dished out by the officials of Srinagar Municipal Corporation 14,000 dogs have been sterilized so far. The Corporation has set a target of sterilizing 21,000 dogs in the next one and half years. The residents of the Srinagar city are hoping that this time around the sterilization process would be taken to its logical conclusion so that the desired results are achieved and that too within the specified period of time.

The process of sterilization was started some years back but the same was discontinued for the reasons best known to the people at helm especially those managing the affairs at Srinagar Municipal Corporation. Just a handful of dogs were sterilized at that time and since then the problem has assumed daunting proportions with no solution in sight. Since then the number of stray dogs has increased in Srinagar and other parts of Kashmir valley. Day in and day out there are reports of dog attacks in the valley.

It is imperative that the authorities managing the affairs of different municipal committees and councils of the valley also take up the sterilization process so that a difference is made in this respect. People living in districts other than Srinagar district are also facing the dog problem and they too need to be given respite from the problem. Once the sterilization is started and then completed it would ensure that people across the valley are free from this glaring civic issue.

Like other parts of the country the animal lovers are also present in appreciable number in Kashmir valley. These people should not have any problem with the sterilization of dogs across the valley since no harm is caused to the animals. As such the onus lies on the executing agency to take up the project and finish the same in stipulated time. The process needs to be taken up seriously and there should not be any laxity in this regard, only then the desired results would be met.

The Silent Cry of Mountains: Struggling with Crowds and Pollution

India's identity lies in its geographical diversity and cultural richness. From the heights of the Himalayas to the Aravali and Vindhya ranges, the mountainous regions of our country have always been centres of natural beauty, religious faith, and cultural heritage. That is why millions of people are drawn to these places every year. Some tourists come seeking peace and beauty, while others come as pilgrims in search of faith and spiritual satisfaction. But in recent years, the growing pressure of crowds at these sites has deeply disturbed the balance of nature. This uncontrolled flow of tourism and pilgrimage is now emerging not only as a spiritual or cultural phenomenon but also as an environmental crisis.

The Himalayas and other mountainous areas are known for their fragile geological structure. The rocks and soil here are far more sensitive than those in the plains. When millions of people arrive at once, not only does the human footprint increase, but large-scale construction is also required to provide arrangements for their accommodation, food, and travel. It has often been observed that landslides increase with the rise in crowd levels. In recent times, several accidents and tragedies have occurred at popular mountain routes due to overcrowding. It is as if nature $itself is warning \, us \, that \, it \, cannot \, be ar \,$ more weight than its limits allow.

To manage the pressure of crowds, hotels, restaurants, shops, and parking areas are built. Such constructions are often carried out by cutting into the natural slopes of mountains. To widen roads, thousands of trees are felled. As a result, the structural strength of mountains weakens, and in the rainy season, even a small



disturbance can turn into a major landslide. In the name of tourist convenience, continuous deforestation is taking place. This not only destroys biodiversity but also disrupts the lives of local people. The shrinking forests are destroying the natural habitat of wild animals, forcing them to enter human settlements.

The biggest impact of crowds comes in the form of pollution. Millions of people bring bottled water, packaged food, and other plastic materials to these sites. In mountainous areas, plastic does not decompose but instead accumulates in streams and rivers, polluting them. Rivers once considered pristine and sacred are now under so much pressure that their waters are becoming polluted. Pilgrims bathe in them, immerse offerings, and also throw garbage into them. The number of vehicles has increased so much that even small hill towns now experience massive traffic jams. Smoke from diesel vehicles

not only worsens air pollution but also affects snow and glaciers.

The religious significance of mountain sites makes them even more vulnerable. Every year, millions of devotees arrive at different shrines in these regions. While this symbolizes faith, when the pilgrimage turns into an uncontrolled crowd, it puts immense pressure on nature. These journeys are increasingly being seen as business opportunities, leading to the mushrooming of hotels, lodges, and markets. Though local people benefit to some extent, unplanned and imbalanced development ultimately causes harm.

The pressure of crowds affects not only the environment but also the local society and culture. The heavy inflow of tourists puts pressure on resources like water, electricity, and fuel. Often, local residents themselves have to face water shortages. Commercialization and external influences start changing traditional culture. For example, instead of local

handicrafts or cuisine, plastic products and fast food begin to dominate. Many people now perceive pilgrimages merely as tourist activities. This diminishes the sanctity of religious sites.

The solution to these problems requires joint responsibility from the government, local administration, and common citizens. Each site's capacity should determine the limit of visitors per day or year. Just as registration has been made mandatory for certain pilgrimages, similar steps should be taken elsewhere too. New hotels or parking lots should only be built if they meet environmental standards. Local architecture and traditional materials should be encouraged. Every construction project must include compulsory tree plantation, with the local community made an active partner in this

Single-use plastic must be strictly banned in mountainous regions. Instead, biodegradable and reusable materials should be promoted. Pilgrims and tourists must be made aware that travel is not merely for sightseeing or rituals, but also an opportunity to connect with nature. Campaigns like "Clean Travel, Safe Travel" should be run consistently. Real change will only be possible when local people actively participate, both as protectors of the environment and as stakeholders in tourism management.

Why road accidents are being ignored?

India's public discourse is often dominated by crises that erupt suddenly - terror strikes, natural disasters, and political upheavals. But one of the gravest national emergencies unfolds quietly on our roads every single day. Road accidents remain one of the leading causes of death in India, claiming more lives annually than some of the most visible public health crises. As per the reports of the Ministry of Road Transport and Highways (MoRTH), there were 1.55 lakh deaths and more than 4.4 lakh injuries in 2022. In 2023, the number of deaths increased to 1.68 lakh — a 9.5% increase, the highest ever recorded. That means 460 people lost their lives daily, a toll equivalent to the crash of a full passenger aircraft every day. Yet unlike such a catastrophe, road fatalities seldom provoke public outrage or political urgency. The World Health Organisation has repeatedly pointed out India's paradox: the country has only 1% of the world's vehicles but accounts for nearly 11% of global road accident deaths. The scale of the crisis is undeniable, yet it is treated as an inevitable by-product of mobility and modernisation rather than a systemic failure that demands urgent correction. The dispersed nature of the tragedy is the reason for the neglected priority of road safety. Unlike terror attacks or pandemics, road crashes appear as isolated incidents — a bus overturning in Rajasthan, a motorbike accident in Kerala, a pile-up on the Delhi expressway. Each is reported briefly, but collectively they form a public health crisis of staggering proportions. There are numerous causes that are well known: overspeeding, drink and drive, poor and improper road infrastructure and design, inadequate pedestrian facilities, weak enforcement of laws, and inconsistent driver training. The Motor Vehicles (Amendment) Act of 2019, which introduced stricter penalties and provisions, was hailed as a



 $turning\,point.\,But\,the\,implementation\,of\,provisions$ has been uneven. People don't fear laws due to political backing, unethical and corrupt links with officers, bribery and negligence. Many states diluted its provisions under political pressure, reflecting the uneasy balance between public safety and public sentiment. Citizens demand safer roads, yet often resist fines and penalties that could enforce discipline.If we pay heed towards the international comparisons which further highlight India's complacency. Sweden's "Vision Zero" policy treats every road death as preventable, reshaping its road design, management and enforcement strategies. The United States, with far higher vehicle density, reports proportionally fewer fatalities due to rigorous safety standards and enforcement. In India, however, accidents are still seen as individual misfortunes, not as symptoms of systemic gaps. We are also prey to the economic costs, which are severe. According to the World Bank report, road accidents and crashes cost India 3–5% of its GDP annually. Beyond economic losses, the human consequences are profound: the death of a breadwinner can push families into poverty, disrupt children's education, and perpetuate cycles of deprivation. Road safety, therefore, is not simply a transport issue; it is a development, civic sense, ethics and etiquette challenge.What is required is not token initiatives such

as "Road Safety Week", but sustained, long-term reforms. Enforcement must be impartial and consistent. Infrastructure should prioritise human life over speed and volume. Civic sense must be developed as a part of compulsory practice in schools, workplaces, and communities, in homes and on roads, insociety and outside society, embedding awareness into everyday behaviour. Road safety needs to become part of our cultural and institutional fabric, not an afterthought. The ethical dimension cannot be ignored. If 1.7 lakh people were to die in a terror attack within a year, Parliament would be in continuous session and policy would shift dramatically overnight. However, when the same number die quietly on the roads, the country moves on as if nothing has happened. This inconsistency reflects a collective failure of conscience. Indeed, roads are more than the lifeline of the country; they are a mirror and reflect the values of society in the country. To accept the routine loss of thousands of lives as normal is to lower the value of human life itself. Road safety must be seen not as an administrative responsibility but as a national priority, integral to public health, economic growth, and social justice. Until then, the nation's highways will continue to carry not only vehicles but also an unacknowledged toll of human tragedy.

A Tiger in a triangle! It is not that we have a short time to live, but that we waste a lot of it! You live as if you were destined to live forever, no thought of your frailty ever enters your head, of how much time has already gone by you take no heed! This is the theme that runs in the 26th Infantry Division Indian

Putting things off is the biggest waste of life: it snatches away each day as it comes, and denies us the present by promising the future... The whole future lies in uncertainty: live immediately.....It did lie in uncertainty when the bridge at Baghwati Nagar was smoked off when Tawi waters

Honestly speaking the administration was left clueless as to what to do next!

But one option was available and that was the Division of where Tigers live!

In a remarkable display of engineering prowess and operational efficiency, the Engineers of the Tiger Division, Indian Army, successfully constructed a 110-feet Bailey bridge over the Tawi River in less than 12 hours, restoring vital connectivity in the region.

But this Division has a remarkable his-

The 26th Indian Division fought primarily in the Burma Campaign during World War II, including the Third Arakan Offensive, leading to the unopposed capture of Akyab Island and the Battle of Ramree Island. The division also participated in Operation Dracula, which involved amphibious landings near Rangoon in April-May 1945, leading to the capture of the city. After the war, elements of the 26th Indian Division were involved in operations in the Dutch East Indies.

Here's a breakdown of their key engage-

Burma Campaign (World War II): Third Arakan Offensive: In late 1944, the division engaged in amphibious operations during this offensive.

Capture of Akyab Island: A significant objective of the Third Arakan Offensive. which the 26th Division achieved. Battle of Ramree Island: The division took part in amphibious operations to capture Ramree Island.

Operation Dracula: In April and May 1945, the division executed Operation Dracula, involving amphibious landings south of Rangoon to capture the city. Post-War Operations:

After the capture of Rangoon, the 26th Division was transferred to the 34th Corps and saw service in the Dutch East Indies.

Historical Context: The Indian Army during World War II was involved in campaigns across various continents, with the majority fighting against the Japanese in Asia.

The 26th Indian Infantry Division was a notable formation within the larger Indian Army that served with distinction in these campaigns.

The division was disbanded. In 1948, the 26 Infantry Division (Tiger Division) was re-raised by Lieutenant Colonel Kalyan Singh, and it has since been a key formation of the Indian Army, serving in operations like Operation Vijay (Kargil War), and is currently based in Jammu.

 $The \, division \, was \, \bar{formed} \, in \, March \, 1942$ in India, initially as the "Calcutta" Division, before being retitled the Indian 26th Divi-

Its badge featured a Royal Bengal tiger stepping through a blue triangle (representing the Ganges delta), on a black background, earning it the "Tiger Head" nickname.

The division is presently headquartered in Jammu, as evidenced by recent news of the Army paying tribute to the first Indian GOC of the Jammu division, Lt. Gen. Ajit Singh, who commanded it.

Battle Honors: The division has earned the Battle Honour title "Kargil" for its distinguished service during Operation Vijay, the Kargil War.

A story:

The division was nicknamed the "Tiger Head" Division, referencing its distinctive badge and its deep connection to the land it formed in.

For much of 1942, the division was heavily engaged in internal security, and not regarded as battle-worthy due to lack of training and transport. It formed part of the Indian XV Corps, but late in 1942, it was taken over directly by the

For the First Arakan offensive, all the division's brigades were detached one by one and committed to the offensive under the 14th Indian Infantry Division. In March, the offensive stalled and the HQ of 26th Division relieved that of the 14th Division, taking over the Arakan front too late to prevent a minor disaster. After this the British fell back almost to their starting

point on the Indian frontier. Once reorganised, the division was in reserve for the first part of the Second Arakan Offensive, once again under XV Corps. When a Japanese counter-attack at Ngakyedauk cut off the forward troops, 26th Division was deployed to relieve them. It fought down the coastal plain to reopen the roads by which the 5th Indian Division was supplied.

After the battle ended with the repulse of the Japanese attackers, the division took over the 5th Division's front and took part in the capture of two vital railway tunnels. After this, the Arakan offensive wound down to spare troops and resources for the battles in Manipur. The division was withdrawn during the monsoon rains to recuperate.

After the Japanese surrender, the division, under the command of Henry Chambers, reinforced other troops in Java and Sumatra, where the end of the war brought widespread disorder. The division was formally disbanded in India on 31 August 1945, but most of its units were stationed in Sumatra at Padang and Medan until November 1946, when they embarked at the port of Belawan to be disbanded in

India. The Badge of this unit was: A Yellow & Black Royal Bengal Tiger stepping out of a Blue Triangle set on a Black Triangular background, the Triangle was taken from the Greek letter Delta, for it was in the Honli Delta that the Division was raised from H.Q. Presidency & Assam District Troops, in April 1942, because of it's Badge it was known as the Tigers Head Division.

I always hit a harder all-time low! Selfaware, do I really run this show? Yeah, Feel safe when I'm in my mind, A backdoor and the lock shut tight! I wish I could drown out the sound! 'Cause these days it's been pretty damn loud! All my friends say they've been feeling the same! Something has to change! And we believe in the same! 26 Div believes in the same....Mk diary!

The crux of the story which we got: The recent heavy rains triggered floods across Jammu, Samba, Kathua, Pathankot and Gurdaspur, causing widespread damage to infrastructure and impacting our people. Responding with urgency, the Indian Army immediately launched largescale rescue and relief operations in close coordination with the civil administration.

Since 26 August, Indian Army soldiers of Rising Star Corps have braved floodwaters and adverse weather, deploying multiple rescue columns supported by Army & Air Force helicopters. The Army proactively employed the required number of columns along with requisite equipment and rescued nearly 1,000 stranded personnel including children, students, and paramilitary personnel, while also restoring critical communication links to Jammu and Srinagar by swiftly laying alternative OFC lines. Alongside rescue, essential medical aid, food, and relief material were provided to affected families.

The floods also severely damaged the

eastern portion of Tawi Bridge No. 4, a lifeline for movement in Jammu. With repair likely to take time, the Engineers of Tiger Division laid a 110-feet Bailey bridge under challenging conditions, overcoming washed-out approaches and limited workspace. The bridge has been completed in less than 12 hours, enabling vehicular movement.

The Indian Army's efforts have been in close coordination with civil administration & all agencies. We thank all of them for their support. Additional Army resources remain on standby to tackle any emerging challenges

Bailey's Bridge:

A Bailey bridge is a type of portable, pre-fabricated, truss bridge. It was developed in 1940-1941 by the British for military use during the Second World War and saw extensive use by British, Canadian and American military engineering

A Bailey bridge has the advantages of requiring no special tools or heavy equipment to assemble. The wood and steel bridge elements were small and light enough to be carried in trucks and lifted into place by hand, without the use of a

These bridges were strong enough to carry tanks. Bailey bridges continue to be used extensively in civil engineering construction projects and to provide temporary crossings for pedestrian and vehicle traffic.

Donald Bailey was a civil servant in the British War Office who tinkered with model bridges as a hobby. He had proposed an early prototype for a Bailey bridge before the war in 1936but the idea was not acted upon.

Bailey drew an original proposal for the bridge on the back of an envelope in 1940. On 14 February 1941, the Ministry of Supply requested that Bailey have a full-scale prototype completed by 1 May.

Work on the bridge was completed with particular support from Ralph Freeman.

The design was tested at the Experimental Bridging Establishment (EBE), in Christchurch, Dorset,] with several parts from Braithwaite & Co., beginning in December 1940 and ending in 1941.

The first prototype was tested in 1941. For early tests, the bridge was laid across a field, about 2 feet (0.61 m) above the ground, and several Mark V tanks were filled with pig iron and stacked upon

The prototype of this was used to span Mother Siller's Channel, which cuts through the nearby Stanpit Marshes, an area of marshland at the confluence of the River Avon and the River Stour.

It remains there as a functioning bridge. Full production began in July 1941. Thousands of workers and over 650 firms, including Littlewoods, were engaged in making the bridge, with production eventually rising to 25,000 bridge panels a

The first Bailey bridges were in military service by December 1941

Bridges in the other formats were built, temporarily, to cross the Avon and Stour in the meadows nearby. After successful development and testing, the bridge was taken into service by the Corps of Royal Engineers and first used in North Africa in

The history of the bridge in Indian context: The history of the Bailey bridge in India began with its adoption by the Indian armed forces from British legacy after World War II, used notably in the 1971 war with Pakistan. After its first civilian use in Kerala in 1996, the modular, prefabricated design became invaluable for connecting remote areas, aiding in border security, and serving as crucial infrastructure during disaster relief efforts, such as the 2021 Uttarakhand flash floods.

Origins and Adoption World War II Legacy: The Indian armed forces adopted the design from the British, utilizing it during the 1971 war with Pakistan to cross obstacles.

Civilian and Disaster Relief Use First Civilian Bridge: The first Bailey bridge constructed for civilian use in India was built on the Pamba River in Kerala in 1996.

Disaster Response: The modular and quick-assembly nature of the bridge makes it ideal for disaster relief operations. The Indian Army recently built a 190-foot bridge in Wayanad, Kerala, after landslides, and Bailey bridges were also used after the 2021 Uttarakhand flash floods.

Strategic and Infrastructural Importance: Connecting Remote Areas: Bailey bridges are extensively used to connect remote and challenging terrains, especially in the Himalayan and border regions.

Border Security: They facilitate the movement of troops and supplies in strategically important border areas along the India-China border.

Tourism: By providing access to remote scenic locations, Bailey bridges also contribute to tourism development.

making spaces that were historically closed to them. It is not charity; it is a matter of justice, compensation and democratic inclu-



The Science of Tooth Brushing

Brushing removes the plaque which is a sticky biofilm containing bacteria that gets accumulated on the teeth. Moreover the prolonged plaque buildup in teeth could leads to gingivitis and periodontal disease. Hence the medical and health experts have recommended brushing at least twice

Brushing in the Morning:

Pros 1. Removes Morning Breath: During the duration of individuals sleep saliva production decreases which results in creation of a dry environment that allows odor-causing bacteria to thrive. The Morning brushing refreshes the mouth and eliminates unpleasant breath.

2. Protective Shield for the Day: Fluoride toothpaste strengthens enamel and provides teeth a layer of protection against acids from the breakfast and daytime snacks.

3. Boosts Confidence: A clean, fresh mouth in the morning enhances social interactions and self-confidence.

4. Stimulates Saliva Flow: Brushing in the morning stimulates saliva secretion which is the mouth's natural defense against bacterial overgrowth.

1. Timing with Breakfast: Brushing immediately after eating acidic foods (like citrus or coffee) can damage enamel softened by acids. Experts suggest brushing before the breakfast or waiting at least 30 minutes after the early day

2. Does Not Protect Overnight: The Morning brushing cannot remove bacteria accumulated during the sleep duration of the previous night, allowing prolonged exposure of teeth to harmful acids.

Burshing Before Bedtime:

1. Removes Day-Long Plaque and Food Debris: Night brushing ensures that the bacteria and the food particles accumulated during the day are removed before the long sleeping period.

2. Prevents Nighttime Acid Attack: Since the saliva production is reduced at night hence the bacteria can easily multiply and produce acids. Brushing before going to bed lowers this risk significantly

3. Stronger Cavity Prevention: Dental studies suggests that brushing before bed is the most critical session of the day for preventing tooth decay.

4. Protects Against Gum Disease: Consistent nighttime brushing reduces the risk of gingivitis and periodontal disease caused by long-term plaque

Cons 1. Often Neglected Due to Fatigue: Many individuals skip nighttime brushing due to tiredness making it less consistent

compared to morning brushing. 2. No Refreshment for Morning: Brushing only at night does not prevent bad breath or oral discomfort upon waking early in the morning.

3. Less Immediate Social Benefit: While brushing before going to bed is medically important but bedtime brushing lacks the instant confidence-boosting effect of morning brushing.

Scientific Consensus: Which is Better?

The Dentists across the world have universally agreed that brushing at night is more important than brushing in the morning because it prevents prolonged bacterial activity during sleep. However, brushing in the morning is equally beneficial for freshness, confidence and enamel protection during the day.

Thus, the best practice is to brush twice daily—once in the morning and once before bedtime. If a person must choose only one, scientific evidence strongly favors nighttime brushing for long-term oral health.

The debate between morning and bedtime brushing highlights two complementary benefits: morning brushing ensures freshness and daytime protection while the bedtime brushing provides essential defense against overnight bacterial growth. The Medical and dental science experts recommend brushing at least twice daily, but if one has to prioritize, night time brushing is most critical for dental health. Maintaining this habit along with flossing and regular dental check-ups, is the surest path to a healthy smile and overall well-being.

DC Bandipora reviews progress of key developmental projects of R&B deptt

BANDIPORA, AUG30: Deputy Commissioner (DC) Bandipora, Indu Kanwal Chib, on Saturday chaired a comprehensive review meeting to assess the progress of ongoing developmental works being executed by the Roads & Buildings (R&B) department in the district. The meeting focused on developmental projects across education, health, roads and other key infrastructure sectors.

Superintending Engineer R&BBandipora, Arooj Alaaqband, along with Executive and Junior Engineers from Bandipora, Sumbal and Gurez divisions, presented detailed updates on various works, highlighting progress achieved and measures being taken to address challenges affecting timely execution.

Executive Engineer Bandipora, informed that the division maintains approximately 370 km of roads. He reported completion of 11 macadamization schemes under Cities & Towns

(C&T) at a cost of Rs.3.8 crore, while 8 pothole repair schemes worth Rs. 1.35 crore are currently in progress. Additionally, 15 km of macadamization work has been completed under NAB-ARD. Key projects highlighted include the Fruit and Vegetable Market at Potushay, Goat Dairy Farm at Arin, and the Non-Motorable Walkway around Wular Lake from Banyari Bridge to Naaz Nallah, funded by WUCMA.

Executive Engineer Gurez, stated that under NABARD, 6 km of road has been completed out of a target of 12.90 km, while CRIF and C&T projects achieved3kmand3.30kmcompletion, respectively. Under SAMAGRA, 5 out of 12 works have been completed, with remaining projects underway. He furtherinformed that Rs. 356.27 lakh have been allocated under District Capex this year for priority projects in education, health and R&B sectors.

It was also informed that R&B Division Sumbal maintains approximately 545 km of roads, with several ongoing schemes aimed at improving road and bridge infrastructure. Under NABARD and District Capex, 11 linkroad upgradation schemes, including macadamization of about 110 km in Hajin block, are currently underway, while under C&T, 10 macadamization schemes covering 15.85 km have been completed.

Significant infrastructure projects are also progressing, including the construction of transit accommodation in Hajin with 30 G+3 building blocks providing 480 dwellings for Pandit migrants, of which 24 blocks have been completed. Other key projects include Hajin Degree College, a footbridge at Tundpora Hakbara, and the Fruit & Vegetable Market at Naidkhai.

During the meeting, DC directed the Superintending Engineer to personally monitor the execution of works and conduct detailed reviews with Assistant Engineers (AEs) and Junior Engineers (JEs) working in the field. She instructed the Executive Engineer Gurez to ensure timely tendering.

30: Prime Minister Narendra Modi today travelled by bullet train from Tokyo to Sendai with his Japanese counterpart, Shigeru Ishiba, where he will tour key industrial facilities, including a semiconductor plant and a bullet train coach manufacturing site.

The two leaders shared pictures of their train ride on social media.

"With Prime Minister Modi to Sendai. Continuing from last night, I'm accompanying him from inside the car," the Japanese Prime Minister wrote on

Upon their arrival, the two leaders met Indian loco pilots undergoing training at the East Japan Railway Company. They also observed the new ALFA-X train and were briefed about the bullet train by the Chairman of East Japan Railway Company, also known as 'JR East', the train

PM Modi, who is on a twoday official visit to Japan for the 15th India-Japan Annual Summit, is visiting Sendai to tour key industrial facilities, including a semiconductor plant and a bullet train coach manufacturing site.

The two prime ministers also announced the India-Japan Economic Security Initiative, aimed at boosting bilateral cooperation in the field of economic security. This includes securing and strengthening



supply chains for critical goods and sectors and accelerating collaboration in critical and emerging technologies, with particular focus on telecom-

munications, pharmaceuticals, critical minerals, semiconductors, and clean energy.

Japan is focused on reducing its dependence on imports and

creating a more resilient semiconductor supply chain.

The facility near Sendai, in Miyagi Prefecture, is a new semiconductor wafer fabrica-

tion plant being developed by Taiwan's Powerchip Semiconductor Manufacturing Corporation (PSMC). It is being built in partnership with SBI Holdings and Japanese stakeholders under the joint venture Japan Semiconductor Manufacturing Company (JSMC).

Located at the Second Northern Sendai Central Industrial Park in Ohira Village, the plant represents one of Japan's biggest initiatives to revive its chipmaking industry.

The plant will manufacture 12-inch semiconductor wafers, starting with 40-nanometre technology and later expanding to 28 nm and 55 nm nodes.

The prime ministers also reaffirmed the importance of the Mumbai-Ahmedabad HighSpeed Rail as a flagship project between India and Japan. They agreed to work towards the commencement of operations at the earliest and to cooperate on introducing the latest Japanese Shinkansen technology in

The Indian side appreciated Japan's offer to introduce, in the early 2030s, the E10 series of the Shinkansen, which runs on the Japanese signalling system. To this end, both sides agreed to immediately begin work necessary for the early installation of signalling systems, including the Japanese system-as well as for the introduction of the General Inspection Train (GIT) and one set of E5 series Shinkansen rolling stock. Appeals Court invalidates Trump's global tariffs

WASHINGTON/ NEW DELHI, AUG 30: A federal Appeals court has rejected former President Trump's claim that emergency powers under the International Emergency Economic Powers Act (IEEPA) justify the imposition of sweeping global tariffsdelivering a significant blow to his efforts to reshape international trade policy.

In V.O.S. Selections Inc. v. Trump, the US Court of Appeals for the Federal Circuit ruled that IEEPA does not authorise President Trump to impose the specific Liberation Day tariffs, affirming the lower court's decision that the tariffs are "invalid as contrary to law."

The court said, "The Government appeals a decision of the Court of International Trade setting aside five Executive Orders that imposed tariffs of unlimited duration on nearly all goods from nearly every country in the world, holding that the tariffs were not authorised by the International Emergency Economic Powers Act (IEEPA), 50 U.S.C. § 1701 et seq. Because we agree that IEEPA's grant of presidential authority to "regulate" imports does not authorise the tariffs imposed by the Executive Orders,



we affirm," the order said.

In a 7-4 decision, the US Court of Appeals for the Federal Circuit affirmed a lower court's ruling that the tariffs were not authorised by the statute Trump cited to justify them.

The International Emergency Economic Powers Act (IEEPA) authorises the president to issue certain economic sanctions to counter an "unusual and extraordinary threat" in an emergency, but it does not permit the president's sweeping moves, the court ruled.

"Because we agree that IEEPA's grant of presidential authority to 'regulate' imports does not authorise the tariffs imposed by the Executive Orders, we affirm," the majority wrote.

The ruling does not take effect immediately, as the court withheld the mandate for its decision until Oct. 14, so the administration can appeal to the Supreme Court.

However, the judges discerned "no clear congressional authorisation" for levies of the "magnitude" of those that Trump imposed, they said.

"Reading the phrase 'regulate ... importation' to include imposing these tariffs is 'a wafer-thin reed on which to rest such sweeping power'," the major-

US President Donald Trump reaffirmed that all tariffs imposed on countries would remain in effect and, if removed, would be "disastrous to the coun-

His comments came shortly after a US court ruled that many of Trump's tariffs, which have upended global trade, were illegal. UNI

SC to hear pleas on Bihar electoral roll revision on Sept 1

NEW DELHI, AUG 28: The Supreme Court today agreed to hear on September 1 a batch of petitions concerning the Bihar Special Intensive Revision of Electoral Rolls, specifically applications seeking an extension of the deadline for filing claims and objections.

A Bench comprising Justice Surya Kant and Justice Joymalya Bagchi ordered the matter to be listed on Monday following an urgent mentioning by Advocate Prashant Bhushan.

He submitted that the Rashtriya Janata Dal (RJD) and several other political parties had approached the Court seeking an extension of the September 1 deadline for filing claims and objections to the draft voters' list.

When the Bench asked why the petitioners could not approach the Election Commission of India (ECI), Bhushan responded that such representations had already been made.

On August 22, the Court had directed the ECI to permit exclud-



ed voters to apply for inclusion through online mode by submitting their Aadhaar details.

At that hearing, the Court had also posted the matter for September 8 while orally assuring parties that their request for extension of the deadline could be considered subsequently.

Earlier, the Court had directed the ECI to publish the names of approximately 65 lakh persons excluded from the draft electoral roll, both on its website and at booth-level offices, along with reasons for their exclusion. UNI

Ex-Ukrainian National Security Council head Parubiy wanted in Russia since 2023

MOSCOW. AUG 30: Former Secretary of Ukraine's National Security and Defense Council, Andriy Parubiy, who was shot dead in Lvov (also known as Lviv) on Saturday, had been listed as a wanted criminal by the Russian Interior Ministry since 2023, police records show.

Earlier in the day, Ukrainian police reported the killing of "a well-known public and political figure born in 1971" in Lvov. Ukrainian President Volodymyr Zelenskyy confirmed Parubiy's death. A Ukrainian newspaper, Strana.ua, reported that he was shot dead in the street by a man posing as a courier.

According to Russian police data. Parubiy has been wanted by the Interior Ministry since November 2023. The Russian Investigative Committee charged Parubiy in absentia for atrocities committed in Donbas in 2014, which left 1,200 people dead or injured.



In April, a member of the Ukrainian Stop Grave resistance group told Sputnik that an investigation into a deadly fire at the Trade Unions House in Odesa, which killed 48 people and

injured more than 250 others on May 2, 2014, was obstructed by a group of journalists established by then-National Security and Defense Council chief Parubiy. UNI

Officials blame special envoy Steve Witkoff for Alaska summit failure due to his 'inexperience'

WASHINGTON, AUG 30: Washington's attempt to broker progress in the Ukraine conflict is being overshadowed by growing concerns over the role of Steve Witkoff, President Donald Trump's personal confidant turned special envoy for peace missions, with sources attributing the failure of the Anchorage summit to his "inexperience".

Witkoff, a real estate developer with no formal diplomatic background, has met Russian President Vladimir Putin five times in six months and was instrumental in arranging Trump's surprise Anchorage summit with the Russian leader, reports Politico.

Yet U.S., Ukrainian and European officials say his access has not translated into tangible results, with promised follow-ups between Putin and Ukrainian President Volodymyr Zelensky stalling.

Several officials familiar with the internal talks say Witkoff has complicated the process by refusing to rely on seasoned diplomats or consult regional experts, often framing negotiations as if they were property disputes.

"His inexperience shines through," one person involved told Politico, while another described him as "a rogue actor" whose lack of coordination leaves allies uncertain of what has been promised.

The August 15 Anchorage meeting itself was noted for its lack of preparation. Unlike traditional summits, it was arranged with little groundwork by foreign ministers or working-level staff, leaving few concrete outcomes beyond a high-profile photo opportunity.

Witkoff's office, thinly staffed and short on Russia expertise, has further fuelled doubts. U.S. officials say he rarely engages with intelligence briefings or emails, while foreign interlocutors complain he misrepresents or misunderstands Moscow's messages.

After one Moscow visit, he returned claiming Russia had agreed to territorial concessions in eastern Ukraine — an interpretation rejected by Kyiv and European partners.

Russian officials value Witkoff's closeness to Trump but reportedly share concerns about his ability to convey Putin's positions accurately. "There's what Russia says, and what Russia means," one person familiar with the talks noted.

Despite criticism, the administration defends him. A senior U.S. official pointed to the "historic" Trump-Putin summit and subsequent White House meetings with European leaders as evidence of progress. Some allies, including the UK's National Security Adviser Jonathan Powell, argue Witkoff's unconventional approach has opened doors that others could not.

Witkoff himself insists he is focused on "bringing two sides together" and narrowing issues to enable compro-

He is now working to arrange lower-level technical talks between Russian and Ukrainian officials, a shift towards a more traditional diplomatic track.

But scepticism remains deep. Ukraine and its European partners see no meaningful concessions from Moscow and warn against legitimising Russian control of occupied territories. To them, Witkoff's efforts risk advancing a Russian narrative rather than ending the war.

The envoy, once credited with securing the release of an American detainee from Russia, is now under pressure to prove that his unique access to Putin can yield more than symbolic meetings.

For now, his high-profile role underscores both Trump's reliance on personal envoys and the uncertainty surrounding Washington's Ukraine strategy. UNI

Sri Lanka pledges incentives to boost exports, valueadded products

COLOMBO, AUG. 30: Sri Lankan President Anura Kumara Dissanayake has stated that incentives will be introduced to encourage export diversification and the development of value-added products, the President's Media Division said Saturday.

The president said the government should support industries rather than hinder them, and stressed the importance of consulting with relevant sectors during the regulation drafting process while allowing sufficient time for implementation.

Dissanayake made these remarks on Friday at the Presidential Secretariat during the 2026 prebudget discussion with private sector representatives from the agriculture, food and beverage sectors, according to the department.

The meeting focused on providing facilities for farmers, exports, tax concessions, recycling, and



the legal framework affecting the sector.

Extensive discussion was also held on ensuring a continuous supply of quality agricultural and food products to consumers, as well as the challenges faced by businesses, with participants sharing their views and proposals.

The president pointed to the lack of a systematic approach for distributing products to consumers, emphasizing the need for stronger cooperation between the government and the private sector to

address these challenges. Dissanayake further explained that the government is focusing on securing full private sector support to expand markets for agricultural produce, dairy, and livestock. While value addition is the responsibility of entrepreneurs, he said the government intends to introduce a new framework to facilitate the process. UNI

Ashwin Eyes Player-Cum-Coach Path In Overseas Leagues

NEW DELHI: Having announced his retirement from all forms of international cricket and the Indian Premier League (IPL), R Ashwin has emerged as a free bird, ready to chart new paths. With his vast experience in international and franchise cricket, it now seems almost certain that he will expand horizons and explore opportunities in overseas leagues. Word is, he is open to try out a dual role - testing the waters as a coach-cum-

Ashwin still has plenty left to offer and is far from done. At 38, he is hardly past it; after all, MS Dhoni is six years older and still going strong. Ashwin now appears to be re-calibrating his career with a threeto-four-year horizon in mind, exploring opportunities beyond the familiar. On his radar are at least three overseas franchise leagues - with Major League Cricket (MLC) in the US a certainty, The Hundred in England a strong possibility, and either the ILT20 in the UAE or the SA20 in South Africa likely to complete

SA20 may not be possible this year since all the franchises - all of them are IPL owners - seem to have locked in their signings. As reported earlier by Cricbuzz, the SA20 auction register is also done. In fact, the SA20 auction ahead of season 4 is less than two weeks away - on September 9. A direct signing, outside of the auction and outside of salary cap, is a possibility but the wild card signings

The ILT20 is a potential target this year. Five of the six franchises are owned by Indians and all of them should be too happy to roll out the red carpet to Ashwin if there is a possibility. The ILT20 auction is on September 30 and there too the teams are allowed one signing outside of the salary cap and

It should be seen how it pans out but it is understood that officials from all the leagues are believed to have reached out to him, including from the Big Bash League in Australia, after he announced IPL retirement on Wednesday (August 27). A playercum-coach role seems a natural fit for him, given his skills and cricketing acumen. Throughout his career, he has been regarded as one of the game's most cerebral cricketers.

Post-retirement, Ashwin appears to have no dearth of options. Commentary could be one prospect, while his cricketing brain also makes him a potential candidate in administration too - it is even believed that some of the out-of-the-box suggestions to the last IPL retention rules came from his inputs to the BCCI. For now, though, his focus remains firmly on extending his playing career for the years

Contacted, Ashwin did not spell out his plans and merely said, "I really want to enjoy my last couple of years hopefully without any judgements from anyone. I wanna live life on my terms."

NEW YORK: Naomi Osaka is back in the third round of the U.S. Open for the first time since 2021, the year after she won her second championship at Flushing Meadows.

She's playing rather well at the moment, too, under the guidance of a new coach. Just don't expect Osaka to weigh in on whether she feels as if she is ready to make another deep run at the place.

"Honestly, I don't really know. I don't make it my business to know anymore. I kind of just leave it up in the air," the 23rdseeded Osaka said after eliminating Hailey Baptiste 6-3, 6-1 in the second round in just 70 minutes Thursday. "For me, I realize that I've done everything that I could. I've trained really hard. I practiced really hard. If it happens, it happens."

Osaka's four Grand Slam trophies all arrived on hard courts: two at the U.S. Open, two at the Australian Open. Since her 2020 title in New York, her trips there have gone this way: losses in the third round in 2021, first round in 2022, second round last year.



The surface tends to favor the big serves and powerful, first-strike tennis Osaka is $best\,known\,for, and\,something\,she\,displayed$ against Baptiste, of course, although she also demonstrated a willingness to vary speeds and spins.

The other talent Osaka is using to great effect so far this week is returning that gets an opponent on the defensive. Osaka already has won 11 of the 18 return games she's played so far, including during a 6-3, 6-4 win over Greet Minnen in the first round.

When East Zone captain Riyan Parag won the toss and bowled first against North Zone, he would have expected his pace spearheads to cause early damage. Instead, it was a little known left-arm spinner from Jharkhand, Manishi, who cut through the top order to give his team the upper hand at the BCCI's Centre of Excellence on the outskirts of Bengaluru.

By the time Manishi came on to bowl the 15th over, the North Zone openers Ankit Kumar and Shubham Khajuria, had put on 49 runs in 84 balls. But that solid start was about to unravel.

Manishi's first ball was loopy and full from around the wicket. Ankit tried to sweep but did not

account for the drift into him and was lbw. A few overs later, Khajuria went back to a skiddy length ball, played all around it and was lbw too. And after a 67-run stand between Yash Dhull and Ayush Badoni, Manishi came back and dismissed Dhull minutes before lunch, beating him in the flight to pick up a third lbw. "Initially, our thinking was that it is a green wicket, so I was asked to be more of a supportive bowler, you know, when the fast bowler needs rest, I can come and bowl four to five overs," Manishi told ESPNcricinfo after play on day one. "But when I got the wicket on the very first ball, I could attack a little more. "I noticed that my quicker deliveries were coming on to the bat nicely.
