

Flood Threat Looms as Jammu Rivers Rise

JAMMU/SRINAGAR, SEP 02: In a week, the water bodies across Jammu have once again swelled, crossing the alarm mark at multiple places, prompting authorities to issue an advisory urging people to stay away from vul-nerable spots. However, a teenage boy lost his life after being struck by lightning in Kokernag area of south Kashmir's Anantnag district.

According to details obtained by the news agency—Kashmir News Observer (KNO), the Jammu region has witnessed extreme weather conditions since August 14, 2025, leading to the loss of over 100 lives, including 65 in the Kishtwar cloudburst incident and 35 in landslides along the Shri Mata Vaishno Devi (SMVD) route.

One more life was lost in a natural calamity in Anantnag district today. A 16-year-old boy lost his life after being struck by lightning in Kokernag. Officials informed that Dilawar

CS Reviews Post-Flood Restoration Measures In Jammu

Stresses On Urgent Action On HM's Directions

JAMMU, SEPT 2: In the aftermath of the visit of the Union Home Minister, Amit Shah to Jammu yesterday to personally assess the extent of damage caused by the recent flash floods, Chief Secretary, Atal Dulloo, today chaired a high-level meeting with Administrative Secretaries and Divisional Administration to review the swift and time-bound implementation of the directives issued by the visiting Minister.

At the outset, the Chief Secretary underscored the urgent need for seamless interdepartmental coordination to bring immediate relief to the affected people and ensure



early restoration of essential services. including power supply and potable water, in the shortest possible timeframe.

Placing particular emphasis on connectivity, he directed that all efforts be undertaken on a war-footing to restore damaged road links at the earliest, as road connectivity forms the backbone for other relief, rehabilitation, and restoration measures.

He instructed the respective Divisional and District administrations to prepare a comprehensive action plan for the restoration of damaged infrastructure across the flood-affected areas, ensuring strict adherence to timelines.

Post-Heavy Rainfall, PDD Restores Supply Swiftly In Jammu

JAMMU, SEP 02: The Power Development Department (PDD) has issued a handout providing an overview of the power restoration works undertaken following the incessant rainfall and flash floods that caused severe damage to power infrastructure in the Jammu region on August 25 and 26. What made the restoration efforts truly exceptional was the strong teamwork and synergy between the Department and various state and central agencies such as NHPC, PGCIL, NHAI, and Police.

The PDD closely coordinated with these agen-

cies, which provided timely assistance and logistical support wherever needed to ensure the swift and uninterrupted execution of restoration work across all affected districts.

As a result, the Department successfully restored electricity supply across the Jammu region within a record time, despite the scale of destruction being so widespread that no district was spared from the damage. The torrential rains, coupled with overflowing River Tawi, local nallahs, and landslides, caused unprecedented damage particularly to the transmission and distribution infrastructure.

Flood Threat.....

Ahmad Bhokad (16), son of Mohammad Sardar Bhokad, a resident of Soin Wangam, Kokernag, was hit by lightning at Nawkhan near Margan Top, resulting in his on-the-spot death.

Meanwhile, as moderate to heavy rainfall was witnessed in the Jammu region from late Monday evening, water bodies in Udhampur, Kathua, Samba, and other places saw an unprecedented rise, leading to flood threats in the Jammu region again. The water level in Kashmir's water bodies was flowing well below the flood alert mark at the time the report was last filed.

The details indicate that the water level crossed the flood alert mark today, with the State Disaster Response Force (SDRF) issuing an urgent advisory, advising residents to stay away from the banks of the River Tawi and other swollen rivers in the Jammu region.

Heavy rainfall over the past 24 hours has triggered a critical flood situation across Jammu, with the River Tawi, Ujh, Basanter, Chenab, and Ravi rivers breaching alert and danger levels, prompting heightened vigilance from authorities.

Udhampur recorded the highest precipitation till this morning, with the figures revealing a total of 60.4 mm of rainfall at the station. Rajouri recorded a rainfall of 56.4 mm till this morning.

Batote station witnessed a rainfall of 55.1 mm since morning till evening, while 17.6 mm rainfall was recorded at the station till this morning.

Bhaderwah saw a rainfall of 42.6 mm since morning, while Katra recorded 32.7 mm till 5:30 PM. The data reveals that Jammu recorded a precipitation of 11.4 mm since morning and 17.8 mm till this morning.

In Srinagar, the summer capital of the region, the highest rainfall of 15.4 mm was recorded since this morning, followed by 13.2 mm in Kokernag.

During the fresh wet spell, Jammu city's River Tawi experienced a rapid rise in water levels, approaching the danger mark.

The SDRF reported that the Tawi has crossed the flood alert level, raising concerns about potential inundation in low-lying areas.

The District Magistrate of Jammu has reiterated warnings for residents to avoid the riverbanks, saying there is an imminent risk of flooding. A recent post on X by the District Magistrate said, "Citizens of Jammu are requested to stay away from Tawi River banks. The water levels may reach the danger mark within a short period of time."

The Tawi's rising levels follow a similar trend observed in Udhampur, where the river had previously crossed the evacuation level of 24.975 ft on August 26, 2025, surpassing both danger and evacuation thresholds. Authorities warn that continued rainfall could push the Tawi in Jammu city past the danger mark in the coming hours, potentially leading to evacuations in vulnerable

Kathua's Ujh River at Panjtirthi has also crossed the flood alert level, with a recorded discharge of 59,750 cusecs, surpassing the alert threshold of 48,000 cusecs. While it remains below the danger level of 88,000 cusecs, officials are closely monitoring the situation due to the steady upward trend.

Similarly, the Ravi River in Kathua has breached its flood alert level, with the water level recorded at 524.97 meters above mean sea level (MSL), exceeding the alert level of 523 meters.

The danger level for the Ravi stands at 527.91 meters, and authorities have warned that further increases could lead to severe flooding in villages such as Bagthali, Massos Pur, Keerian Gandial, Barni, Dhanna, Dhanore, Karyali, and adjoining

The SDRF, alongside local disaster management teams, have been placed on high alert across Jammu, Kathua, and Samba districts.

Meanwhile, the weatherman here has predicted heavy rainfall until tomorrow, saying that generally cloudy weather is expected with one or two spells of light to moderate rain and thunder at many places during the daytime, with the possibility of heavy to very heavy rain over Kathua, Jammu, Udhampur, and Reasi, along with moderate to heavy rainfall over Doda, Samba, Rajouri, Poonch, Ramban, Kishtwar, Anantnag, and Kulgam, mainly towards late tonight and early tomorrow, continuing till late afternoon.

Director Meteorological Department (MeT), Dr Mukhtar Ahmad, said that from September 4 to 7, a brief spell of rain and thunder is expected at a few places. From September 8 to 11, a spell of moderate rain is expected over a few districts of Jammu division during the night of September 8 and the 9th, with improvement thereafter until the 11th evening.

The fresh weather forecast has raised fears of flash floods and further inundation. Residents in flood-prone and low-lying areas are urged to remain indoors, avoid riverbanks, and keep emergency supplies ready.

In its advisory, the MeT has stated that there is a possibility of heavy to very heavy rain in a few districts, as well as the possibility of cloudbursts. flash floods, landslides, mudslides, and shooting stones at many vulnerable places.

It said that a rise in water levels in rivers is expected and urged people to stay away from water bodies, nallas, river embankments, and loose structures. Besides, the public has been advised to stay alert and updated.

Moreover, the Indian Army and other disaster response teams are actively engaged in rescue and evacuation operations, particularly in areas affect-

ed by overflowing rivers. It is worth mentioning here that the government has closed all educational institutions and non-essential offices in Jammu to ensure public

Railway services have also been disrupted, with 18 trains cancelled due to soil erosion and

While reviewing the security preparedness ahead of the Eid Milad-un-Nabi celebrations in the Valley, Birdi asked police to ensure compre-

hensive arrangements for the upcoming festival. The meeting was attended by all range deputy inspectors general (DIGs) and senior superintendents of police (SSPs) of Kashmir Zone.

The discussions focused on facilitating smooth and secure congregations and processions across he Kashmir Valley to mark the auspicious occa-

During the meeting, the IGP, Kashmir held detailed deliberations with senior officers regardng security preparedness across the Valley.

Birdi emphasised the need to maintain a heightened vigil and ensure foolproof arrangements, particularly at major shrines, mosques, and other religious places where large congregations are expected.

Special focus was laid on the Dargah Hazratbal shrine and other prominent religious places where night-long prayers and large gatherings are anticipated, the spokesman said.

The IGP directed officers to enhance surveillance at sensitive locations, maintain effective area domination through intensified patrolling, and ensure efficient crowd management to prevent any untoward incidents.

ground, the Minister directed them to maintain round-the-clock monitoring of the river water level and ensure a swift communication mechanism between field staff and control rooms. He asked for the immediate dissemination of alerts to the public in vulnerable areas so that people can be safely evacuated at the earliest in case of

any exigency. The Minister further stressed upon ensuring adequate stock of ration, drinking water, medicines and other essentials at relief centres. He directed the Civil Supplies department to make advance provisions so that no family faces hardship in the event of displacement.

Expressing satisfaction over the arrangements already made, Satish Sharma said the government has put in place a robust mechanism for flood preparedness, but constant vigilance and coordinated response are critical in dealing with such natural challenges. He appealed to the general public to remain calm yet cautious and to cooperate fully with the administration by following advisories and safety guidelines.

In a humanitarian gesture, the Minister announced that he will be donating his two months' salary to the Chief Minister's Relief Fund, reaffirming commitment towards supporting relief and rehabilitation efforts. He said that such contributions, though modest, can go a long way in extending timely help to families affected by natural

"The safety and welfare of the people is our topmost priority. The government is fully geared up to respond to any situation and all possible assistance will be extended to safeguard lives and property. We stand shoulder to shoulder with our people in this hour of need", the Minister maintained. The Minister assured that the administration will remain on high alert until the situation normalizes and reiterated that proactive steps will be taken to mitigate risks and minimize damage.

crippling mobility and cutting off villages," the Jammu-based White Knight Corps unit of the Army said in a post on X.

It said the engineer troops of the Army are currently carrying out mobilisation of bridging stores and building a Bailey bridge over Doda's Jangalwar Nallah, aiming to restore partial connectivity at the earliest.

"Despite challenges of weather and terrain, the bridge construction has commenced in full swing with engineers in close coordination with civil administration. Area protection by troops of White Knight Corps and traffic control by J&K Police are ensuring smooth progress of restoration efforts,' the Army said.

In a 12-hour operation on August 29, Army engineers erected a 110-foot Bailey bridge, connecting the flood-hit Tawi bridge, to restore vehicular traffic on the vital link in Jammu city.

The Ramban district administration has also roped in the Army to erect a temporary Bailey bridge at Batti. A bridge at Batti was recently washed away by flash floods in the Chenab, affecting connectivity to Gool sub-division, parts of Ramban tehsil and several strategic national

Army engineers visited the site to ensure early restoration of the vital connectivity link to Gool sub-division

More than 130 people, mostly pilgrims, were killed and over 120 injured, while 33 remained untraced following cloudbursts, landslides and flash floods in Kishtwar, Kathua, Reasi and Ramban districts since August 14.

He added that BJP representatives have consistently taken up the public's concerns with the government and coordinated with officials of the concerned departments to ensure prompt relief

 $However, Sharma\, strongly\, criticized\, the\, NC\text{-led}$ J&K government for its lack of seriousness and inadequate response, terming their efforts as mere 'lip service" and "eyewash.'

He said that the government demonstrated a perfect example of step-motherly treatment with the Jammu region in this tragedy. He said that despite having control over essential departments like electricity and water supply, the government failed to act on a war footing.

In contrast, Sharma praised the Union Government and the LG administration for their prompt and committed response as was evident in timely rescue operations in Mata Vaishno Devi route tragedy. He recalled that Defence Minister Rajnath Singh visited the region recently, and now, Union Home Minister Amit Shah ji, accompanied by senior officers of the Army, Police, CAPFs, and civil administration personally reviewed the ground situation. The Union Home Minister also met affected families, local MLAs, and BJP leaders to chalk out a comprehensive relief strategy.

Outlining the immediate measures, Sharma informed that the Union Home Minister directed the MLAs and senior leaders to interact with affected families on September 4–6, organize medical camps on September 9, and conduct cleanliness drives on September 10-11. He further added that rehabilitation of nearly 200 families affected by the cloudburst in Margee village of Warwan has been requested.

In a significant announcement, Sharma revealed that all 28 BJP MLAs have contributed Rs 1 crore each, amounting to Rs 28 crore, for relief efforts. Additionally, BJP MPs have also pledged Rs 2.5 crore each, taking the total to Rs 35.5 crore.

The Union Government has already released Rs 209 crore to the UT Disaster Response Fund (UT-DRF) and constituted a high-level committee to submit a report within two days, following which a relief package will be finalized and released within shortest possible time. The Union Home Minister has also asked the CMs of other states to contribute economically to recover from this

tragedy, said Sunil Sharma. Sharma further said that the Army, CAPF, and others will promote the people of health on a mission basis. He stressed that the Union government has made it absolutely clear that every possible maximal help will be provided to the

people. He also shared that a request has been made to allow the farmers to sell the accumulated aggregates on their fields on their own. The free ration to all the affected people is requested, which will be conveyed to FCI by the Union Home Minister. He added that all the union ministers of departments related to flood affected fields, will visit and organize meetings with the J&K government. Sharma reiterated that the NC government in J&K has miserably failed the people in their hour of crisis, while the BJP, Union Government, and LG administration remain fully committed to ensuring maximum relief and rehabilitation.

No fresh traffic.....

"Our priority is the safety of travelers. With heavy rainfall, we cannot risk allowing traffic movement at this stage," a senior traffic police officer said.

The officer further advised commuters not to travel on the route without confirming the latest status. "We urge people to avoid unnecessary travel and check official updates before starting their journey. The situation is being closely monitored, and decisions will be taken keeping public safety in mind," the officer added.

However, the officer clarified that traffic was moving smoothly on the Mughal Road as per the advisory issued.

The 250-km Jammu-Srinagar National Highway is the only all-weather road linking Kashmir Valley with the rest of the country, and frequent closures due to rains and landslides disrupt essen-

tial supplies. Meanwhile, the Meteorological Department

has predicted more spells of rain in the coming days, keeping officials and restoration teams on high alert. (KINS)

Rescue teams, disaster management units, and key departments have been asked to remain deployed in vulnerable areas.

Over the past few weeks, incessant rains have battered several districts of Jammu and Kashmir, triggering flood-like situations in low-lying areas especially of the Jammu division.

Several deaths, damage to property, and disruptions in road connectivity have also been reported, while assessments of losses are still underway.

Authorities have reassured the public that all possible measures are being taken to minimize damage and ensure safety, with both the LG administration and the elected government jointly monitoring the evolving situation. (KINS)

trek from Katra to the holy shrine claimed over 30 lives and left 20 others iniured.

In the aftermath of the tragedy, Jammu and Kashmir Lieutenant Governor Manoj Sinha ordered the constitution of a highlevel three-member committee to investigate the causes of the landslide and recommend preventive measures.

Officials said that the resumption of the yatra will depend on weather conditions.

Meanwhile, devotees across the country who had planned their pilgrimage have been advised to wait for further announcements from the Shrine Board. (KINS)

Highlighting the importance of public health, the Chief Secretary directed that all water sources be tested for contamination prior to supply, so as to prevent any outbreak of water-borne diseases.

He further instructed the Health Department to organize health camps in all affected villages, with medical teams conducting vital health checks and ensuring the availability of essential medicines to the local population.

In addition, he called for a detailed safety audit of all public infrastructure in the floodhit regions, particularly educational and health institutions, bridges, and government offices, to ensure structural stability and safeguarding of human lives.

Stressing that these measures hold the highest priority, the Chief Secretary made it clear that the directives emanate directly from the Union Home Minister and must, therefore, be implemented with the utmost urgency and seriousness.

The Chief Secretary further reiterated the government's commitment to not only providing immediate relief and rehabilitation to affected families but working towards longterm resilience through better infrastructure planning, disaster preparedness, and preventive measures to mitigate the impact of such calamities in the future.

Post-Heavy.....

Several transmission towers collapsed, foundations were submerged, and receiving stations were inundated with water. According to reports, with most feeders down, the power load in the region plummeted to just 299 MW on August 26, compared to the normal demand of around 1,050 MW.

Despite the daunting challenges posed by inclement weather, the restoration teams of PDD swung into action immediately, workinground-the-clock under extremely adverse conditions. By isolating faulty network elements and sourcing power through alternate arrangements wherever possible, the department managed to restore the load to 725 (70% of normal load) MW by 7 PM on August 27 and further to 960 MW (92% of normal load) by the evening of August 28. The restoration drive was carried out through close coordination among all J&K power corporations-JKPDC, JKPTCL, and JPDCL under the supervision of Principal Secretary, PDD, Sh. H.

Rajesh Prasad. Lieutenant Governor Manoj Sinha, Chief Minister Omar Abdullah and Chief Secretary, Atal Dulloo closely monitored the progress of the restoration works and remained consistently updated on the situation. Their intervention played a crucial role in arranging necessary resources from various agencies including central PSUs which significantly contributed to quick and effective restoration of the system.

The transmission lines damaged by the torrential rains traverse extremely challenging terrain, including hilly slopes, river crossings, and remote areas with poor road connectivity. On the first day of rainfall, many transmission tower structures along the 132 kV line at the River Tawi crossing collapsed one after another in a cascading manner. Additionally, towers on key transmission lines—such as the one feeding power to Kishtwar district and the 132 kV Hiranagar-Battal-Manwal Transmission Line supplying power to Batal and adjoining areas, including electric traction systems also collapsed. Likewise, 220 kV Barn-Kishanpur transmission line also suffered extensive damage, affecting power supply to Districts of Rajouri, Poonch, Reasi and Jammu. The towers on $these \, lines \, were \, situated \, on \, difficult\mbox{-to-access}$ hilly slopes, complicating restoration efforts and causing widespread blackouts and a panic-like situation for the department.

To overcome the formidable challenges, the MD JKPTCL, Rahilla Wani and her team deployed special measures and innovative solutions to restore power swiftly. For instance, the collapsed tower on the Hiranagar-Battal Manwal line was replaced using the Emergency Restoration System (ERS)—a modular-type special tower structure designed for quick deployment with the support of PGCIL. Unlike conventional towers, which can take months to erect, the ERS enables restoration within 24 hours. However, despite the tower collapse, power supply to most of the affected areas was restored immediately through alternative receiving stations by the JPDCL teams working in tandem, preventing a prolonged outage.

High-strength cranes and specialized equipment were used to string conductors on the towers of damaged 220 kV Barn-Kishanpur transmission line near Nagrota. The damaged tower on the Kishtwar line was also restored in record time despite its location in the tough hilly terrain of Doda district. In areas where roads had been damaged or washed away, materials had to be offloaded and carried head load over steep hills. Despite harsh weather conditions and limited connectivity, restoration teams demonstrated remarkable dedication working round the clock under the close supervision of senior officers to ensure timely completion of the

Executive Directors of PGCIL, Tarun Bajaj, and NHPC, Ram Swaroop, extended full technical and logistical support, playing a crucial role in accomplishing the mammoth task of power restoration under these extremely challenging circumstances.

The situation was even more alarming in the distribution sector, where out of 1,349 feeders, only 364 were functional by the evening of August 26. Nearly 19,000 distribution transformers, out of a total of 49,000 in the region, were affected, in addition to hundreds of damaged poles and conductors—making it one of the worst outages ever

The immediate action taken by the Managing Director JPDCL Sh. G. P Singh and his team was to restore power supply to essential installations, including Defence Installations, Jal Shakti, AIIMS & GMC Jammu, and other major hospitals in the city. These critical installations were given top priority, and electricity was successfully restored to most of them on the very first day of the rainfall. Restoration work continued day and night. Through continuous monitoring, swift deployment of manpower and machinery, and the use of short-term measures and innovative approach, full restoration was achieved well ahead of the anticipated time-

The heavy rainfall also impacted power generation severely. Amid heavy downpour; flooding of Power Houses, damage to access roads, and excessive silt load had forced shutdown of all hydroelectric projects of JKSPDC in Jammu Division. Amidst these challenges, the 900MW Baglihar Hydroelectric Project was restored to generation within 60 hours of shutdown. Operations were halted on 26th August due to dangerously high silt levels in the Chenab River. Through round-the-clock efforts involving road clearance, dewatering, cleaning of the powerhouse, testing of critical components, and continu $ous\,silt\,monitoring, MD\,JKSPDC\,Rahul\,Yadav$ and his team successfully brought the first unit online by 28thAugust evening, and all units were synchronized by 29th August to secure energy supply for the region.

Beside this close coordination was maintained with upstream and downstream projects, the Divisional and District Administration for regular discharge date to mitigate flood impacts and alert generation.

While temporary restoration has been completed by the department, permanent restoration of damaged infrastructure, including towers, poles, and substation equipment, would require considerable time, even several months. Accordingly, the department has already conducted a parallel assessment to determine the requirements and plan for permanent power restoration, which would be conducted in due course as and when the weather conditions normalize.

The extraordinary efforts of the PDD $work force, coupled \,with \,timely \,support \,from$ central agencies, turned what seemed an impossible task into a success story for Jammu region.

Budgam Residents Anguished Over Lack of Clean Drinking Water, Demand Action

BUDGAM, SEP 2: In several areas of Budgam district, people are up in arms against the non-availability of clean drinking water. Residents said that due to continuous rainfall over the past several days, the tap water being supplied has turned muddy and unfit for consumption, posing a serious risk of waterborne diseases.

In particular, people from different villages of Khan Sahib area complained that although multiple filtration plants and storage reservoirs were constructed under the Jal Jeevan Mission (JJM), most of them remain non-functional. Locals alleged that despite paying a monthly fee for water



supply, they are forced to consume contaminated water. "The government had promised that every household would receive clean drinking water through taps under Jal Jeevan Mission, but the reality on the ground is completely different," said one of the residents.

People further added that several projects under JJM in the area are still incomplete, leaving households dependent on unsafe water sources. Expressing anger, they said that the Jal Shakti Department has failed to ensure safe drinking water despite repeated complaints.

Locals appealed to Deputy Commissioner Budgam and Jal Shakti Minister Javed Ahmad Dar to intervene at the earliest and resolve the issue before it leads to a public health

Rana reviews restoration efforts in Poonch

Stresses efficient execution and coordinated response

JAMMU, SEP 02: In the aftermath of the recent floods that caused significant disruption across Poonch district, Minister for Jal Shakti, Forest, Ecology & Environment, and Tribal Affairs, Javed Ahmed Rana, today conducted a detailed virtual review of the relief and restoration efforts underway.

During the meeting, the Minister emphasized the urgent need for efficient planning and execution of restoration measures. He directed all concerned departments to ensure that restoration work is carried out without delay and that departmental heads personally oversee on-ground operations to accelerate progress.

He underlined that the focus must remain on quick resumption of essential services, including water supply, power, road connectivity and the distribution of food grains and other critical commodities, particularly in remote and vulnerable areas.

The Minister called for a comprehensive and inclusive rehabilitation strategy for affected families, along with the implementation of long-term preventive measures to mitigate the impact of future disasters.

He urged officials to ensure

that compensation and relief support are delivered swiftly and fairly, with special attention to

populations. Highlighting the need for safety in educational institutions, Rana stressed the importance of conducting thorough structural audits of schools in flood-hit areas.

He directed the concerned departments to identify vulnerable school buildings, carry out urgent repair works and ensure that learning institutions are safe for students and staff.

As part of the damage assessment, the Deputy Commissioner Poonch, Ashok Kumar Sharmabriefed the Minister on the overall impact of the floods on infrastructure.

He informed that 18 schools in the district sustained damage. primarily involving boundary walls, and that four schools require immediate restoration to ensure operational safety. These schools have been prioritized for repair to ensure the timely resumption of academic activities.

Regarding road infrastructure, the Minister was informed that of the 71 roads damaged in Mendhar subdivision, 65 have already been restored to motorable condition, with the remainder under active repair.

In Surankote Sub-Division, 10 roads were reported damaged, with restoration work underway on a priority basis. It was further shared that a majority of roads under the PMGSY scheme have also been restored. Recognizing the extent of damage to housing and protection works in rural areas, Rana instructed that repair and rebuilding be taken up by the Rural Development Department, as a special case, to expedite relief and recovery in the most impacted

villages.

Recognising the healthcare response to the floods, Deputy Commissioner informed that medical camps will be organized in flood-affected and other vulnerable areas over the next two to three days. To further strengthen medical outreach, the Minister proposed the deployment of Mobile Medical Units (MMUs) on a 10-day rotational basis in Mendhar, Surankote and Haveli, ensuring that people in remote or inaccessible regions have timely access to essential health services.

The Minister placed particular emphasis on the restoration of power supply, noting that interruptions in electricity directly affect water availability, as many water supply systems are electrically operated.

It was reported that out of 162 water supply schemes affected by the floods, a majority have been partially restored, with full restoration in progress.

He further emphasized the critical importance of inter-departmental coordination to ensure a unified and effective disaster response. He called on all departments to work seamlessly and adopt a mission-driven approach to rebuilding and service restoration.

The Minister also stressed the need for maintaining adequate buffer stocks of food and essential supplies, particularly in cut-off areas, to avoid shortages during future emergencies.

In addition, Rana called for the scientific mapping of vulnerable zones and high-risk habitations, stating that such datadriven approaches are essential to guide future mitigation strategies, minimize disaster risk and enable timely and targeted interventions.

The Minister reiterated the Omar Abdullah Government's unwavering commitment to the people of Poonch, stating that all efforts will be directed towards rebuilding stronger, safer and more resilient communities.

Natural Disasters in J&K:

A True Picture and a Wake-up Call

Natural calamities have been part of human existence since the beginning of time, but in the last few decades their frequency and intensity have increased to alarming levels. The fragile Himalayan region of Jammu and Kashmir has always been prone to landslides, flash floods, cloudbursts, and torrential rains, yet the devastation seen in recent times has shaken the very foundation of human resilience in the area. Across districts such as Kishtwar, Kathua, Reasi, Ramban, Rajouri, Poonch, Udhampur and Samba, people have witnessed tragedies that words can hardly capture. From the pilgrimage town of Katra near Mata Vaishno Devi shrine to the remote villages of Mahore, Banihal, and Bhadarwah, the landscape is scarred with grief. The cries of families who lost their loved ones echo through the valleys like a haunting reminder of how fragile human life is before nature's fury. These cries, accompanied by tears that fall like drops of blood, leave us questioning where to turn, whom to save first, and how to recover from such irreparable loss. The devastation is not only physical but emotional, cutting deeply into the very spirit of society.

Everywhere across Jammu and Kashmir there are stories of tragedy. Private properties have been reduced to rubble, school and college buildings have collapsed under the weight of heavy rains, and mountain slopes have slid into rivers and valleys, burying whatever stood in their path. This is not limited to human settlements. Even the nests of birds have been destroyed, animals have perished in large numbers, and forests have suffered irreparable damage. Lightning has struck down trees, floods have swept away fertile fields, and rain has lashed relentlessly. The destruction of natural habitats, the displacement of wildlife, and the loss of biodiversity all indicate a deeper crisis that extends beyond human suffering. For ordinary people, the loss of homes,

roads, and bridges is not just a material setback but a blow to their social and emotional fabric. These structures are lifelines in a mountainous region where connectivity is already fragile, and their collapse means isolation, hunger, and despair.

The magnitude of destruction is so vast that recovery seems almost impossible. The scenes unfolding in Jammu and Kashmir resemble the aftermath of a silent apocalypse. Compensation and relief may help to some extent, but no amount of money can bring back the dead or erase the trauma etched in the hearts of survivors. Families who lost their breadwinners, children who lost their parents, farmers who lost their fields-all face an uncertain future. What has been destroyed in a matter of hours will take decades to rebuild,

if it can ever truly be rebuilt. Yet, amidst this gloom, a faint silver lining can be seen in the courage and unity of those engaged in relief operations. The Army, Police, Civil Administration, National Disaster Response Force (NDRF), State Disaster Response Force (SDRF), and countless NGOs have joined hands in this struggle. Risking their own lives, they have reached villages cut off by landslides, rescued stranded families, distributed rations and drinking water, and worked tirelessly to restore connectivity. Their courage deserves not only appreciation but deep respect. They are the living proof that humanity, when united, can stand strong even in the face of nature's most brutal blows. While the monetary losses are beyond recovery, these relief measures give people a sense of hope. In the darkest of times, hope itself is a form of sur-

Another tragic dimension to this crisis is the collapse of essential services. Over the past few weeks, electricity and water supply have been disrupted in many parts of Jammu and Kashmir. Entire villages have been left without power for days, sometimes weeks. Water supply, already scarce in some regions, has been completely cut off, forcing families to walk long distances for drinking water. Life without electricity and water is not just an inconvenience; it is a slow erosion of survival itself. At such a critical time, providing rations, restoring electricity, and ensuring clean drinking water are not administrative tasks but

moral obligations. This is a call for collective action. If the government, local administration, and common citizens come together, what seems impossible can indeed be made possible. Disasters demand that communities rise in solidarity, helping $one \, another \, shoulder \, the \, burdens \, of \,$ survival. The people of Jammu and Kashmir must embrace this call, for unity and cooperation are the only true answers to such challenges.

The district administrations have tried to address the crisis, but the scale of damage is overwhelming. The floods and storms have not only taken lives but also destroyed fruit orchards and crops, which form the backbone of the region's economy. Farmers, who depend entirely on their fields for livelihood, now stand devastated, watching the labor of years vanish in a single night of floods. For them, timely compensation is not charity but survival itself. It is imperative that the government ensures compensation does not remain confined to paperwork, political speeches, or newspaper headlines. Too often, the most needy are left out, while the influential manage to secure relief. This cycle of injustice must end. The way forward lies in setting up locallevel committees in every Panchayat, involving revenue officials like Patwaris, community leaders, and district officers. Together, they must assess damages on the ground and ensure fair distribution of aid. This will guarantee that those who have actually suffered receive the relief they deserve. At the same time, the public must cooperate with officials, providing truthful information and supporting them in identifying victims. This is not a time for corruption or exploitation. It is a test of humanity, and failing it would be a crime against those already suffering.

The disaster has also exposed another pressing issue: the lack of educational infrastructure in rural areas. In many regions, children are forced to travel thirty to fifty kilometers to attend higher secondary schools or colleges. During disasters, when roads are blocked or destroyed, this becomes impossible, depriving students of their right to education. The government must treat this as an urgent lesson and establish more higher secondary schools and colleges in rural belts. This step will not only reduce pressure on urban institutions but also give underprivileged children in remote areas a fair chance at education. For many poor families, sending children to faraway towns is financially impossible, and disasters make it physically dangerous as well. Education within reach would provide these children an opportunity to break free from the cycle of poverty and vulnerability.

The central government has announced some aid for the affected areas, but the relief provided so far is far from sufficient. What has been given is not even close to the scale of destruction witnessed. The people of Jammu and Kashmir need and deserve far greater assistance. The central government must recognize the gravity of the situation and provide substantial financial and infrastructural aid to the Union Territory. This is not merely about rebuilding roads or houses; it is about healing wounds, restoring dignity, and giving hope to those who have lost everything. Only through significant and timely support can the injured be treated, the homeless be sheltered, and the livelihoods of farmers be restored. This is the spirit of the Indian Constitution, which promises equality, justice, and support to every citizen in times of need.

The natural disasters that have struck Jammu and Kashmir are not just isolated events but warnings for humanity. They remind us of the fragile balance between man and nature, and of our responsibility to protect and respect the environment. They also highlight the urgent need for stronger infrastructure, better preparedness, and greater cooperation between government, civil society, and ordinary citizens. Above all, they teach us that in the face of devastation, unity and compassion are our greatest strengths. The path ahead is not easy, but with collective will, honesty, and determination, Jammu and Kashmir can recover. The people have suffered immensely, but they also carry within them resilience and courage. It is time for all of us, whether in administration, institutions, or as common citizens, to come together and rebuild not just homes and roads, but also the spirit of hope. Only then can we truly honor the lives lost and ensure that the future is safer for generations to come.

Why are schools open even in dangerous weather?

"The question of children's safety versus formality: Amidst dilapidated school buildings, administration's insensitivity and flood-filth, not studies but saving lives is the first priority - why politics of orders even in a disaster?" Calling children and teachers to school in the event of rain and flood is playing with their lives. Dilapidated buildings, dirt, waterlogging and traffic obstructions have already created dangerous conditions. In such a situation, it is more important to focus on the safety of children than on studies. Education is meaningful only when children learn in a safe environment. The government should rise above formalities in times of crisis and immediately declare a holiday, so that possible accidents can be avoided.

The rainy season is considered a time of adventure and play for children, but when this season becomes $the \ cause of floods, dirt and \ life-risk, then \ the \ question$ arises that how sensitive is our system towards the safety of children and teachers. The decision of not closing schools despite the high alert declared for floods in 18 districts of Haryana recently puts a serious ques-

tion mark on this sensitivity. The dilapidated condition of school buildings is not hidden from anyone. In many places, there are cracks in the walls, water drips from the roofs and the floors get wet, inviting accidents. In buildings where studying is difficult on normal days, how can the safety of children and staff be ensured during continuous rains? Many government and rural schools are anyway in a

The problem of cleanliness is also serious. Dirt, waterlogging and open drains make school premises unhealthy and dangerous. During rainy days, the risk

ruinous condition due to lack of repair and maintenance.

of mosquitoes and infectious diseases increases. In such a situation, calling children to school is only playing with their lives. Not only this, the transport system gets badly affected due to floods and waterlogging. Children and teachers face great difficulties in reaching school. In many areas, the roads are filled with kneedeep water, somewhere bridges are broken and somewhere rivers are in spate. The daily movement of children in such conditions is only an example of the

administration's insensitivity. The most surprising thing is that the government and the higher authorities do not give orders to close the schools even after knowing it. This decision seems more like a formality than a compulsion - as if by just giving the order, the responsibility has been fulfilled. The question arises that can any formality be more important than the safety of the children? If an accident happens, will this silence and negligence of the administration be forgiven? It is not new to put a temporary halt on the education system in times of disaster and crisis across the world. During the Corona period, schools remained closed for months and education was carried forward through alternative means. When the safety of children was considered paramount during the pandemic, then why is the same sensitivity not shown in the

event of floods and natural disasters? Here it can be argued that schools cannot be closed so that there is no loss of education. But is the importanceof education greater than the lives of children and teachers? Education is meaningful only when students and teachers are safe. The decision to conduct studies under wet and crumbling roofs, in water-filled courtyards and in the fear of disease will not be called education, but compulsion and negligence. Actually, the real problem is both our policy and intention. The officials who should take immediate decisions after looking at the local conditions, just keep waiting for orders from the top. And the policy makers sitting at the top usually take decisions on the basis of paper reports and files. The result is that there is a big gap between the ground situation and the government orders.

Today, there is a need for the education department and the disaster management department to formulate a clear policy. It should specify under which circum-

stances schools will be automatically considered closed. For example, when a high alert for floods is issued in a district, when life becomes chaotic due to continuous rain, or when the safety of buildings is doubtful. This will enable lower level officials to take timely decisions and children can be saved from risks.

Along with this, emphasis should also be laid on regular repair and maintenance of school buildings. Leaking roofs and falling walls every monsoon expose the reality of our education system. If we cannot provide safe buildings for children, then the talk of the right to education proves to be hollow.

It is important to pay attention to another aspect. When governments talk of 'smart classes', 'digital education' and 'new education policy', why not resort to online or alternative education in times of disaster? Children's education can be continued without compromising their safety. But unfortunately, instead of such far-sighted steps, only the formality of issuing orders is carried out.

Children are the future of the country—we hear this sentence again and again. But when it comes to securing this future, our system fails the most. Keeping schools open in conditions like rain and floods is like putting the lives of both children and teachers at risk. This is not just insensitivity, but the height of negligence.

Now the time has come for governments to go beyond formalities and actually prioritise the safety of children. Schools should be closed immediately and reopened only when the situation becomes normal. The real purpose of education will be fulfilled only when children study and learn in a safe environment. If even this minimum safety cannot be ensured, then serious questions arise on the education system.

Sensitive governance is one that ensures the safety of its citizens—especially children—in times of crisis. If we fail in this basic responsibility, then all claims of development, education and progress will remain mere empty slogans.

In a world of chaos, books offer hope, healing, and a path back to humanity



The Silent Thief of Time and Productivity

Procrastination is a universal human behavior which is often described as the intentional delay of tasks despite knowing about the potential negative consequences. The word procrastination is derived from the Latin word procrastinare that means — "to put off until tomorrow"-this tendency is not merely laziness, but a complex interaction of psychology, neurology and social influences. In the recent decades, medical and psychological sciences have begun to recognize procrastination not just as a habit but as a form of self-regulation $failure\,with\,significant\,consequences\,for$ health, productivity and well-being.

The Science of Procrastination

From a neurological perspective procrastination arises from a conflict that arises between the two brain regions: the limbic system, which seeks immediate pleasure after completion of the task and it also avoids discomfort afterethe $missed\, dead lines\, and\, the\, prefrontal\, cortex$ is responsible for rational planning and creation of the long-term goals. When the limbic system dominates individuals postpone tasks that seem effortful or unpleas-

ant in favor of short-term gratification. Psychologically procrastination is linked to traits such as perfectionism, fear of failure, low self-esteem and difficulty managing time.


Researchers have classified it into two broad types:

- 1. Active procrastination where individuals deliberately delay the task but eventually complete them under immense pressure.
- 2. Passive procrastination where tasks are repeatedly delayed without successful completion, often leading to stress and missed deadlines.

Medical and Psychological Con-

Chronic procrastination has been associated with increased stress levels, anxiety attacks and depression. Studies across the globe has showed that it could negatively impacts the sleep patterns, increases susceptibility to lifestyle diseases due to poor self-care and contributes to reduced academic and workplace performance. Physiologically, the stress caused by constant delay elevates cortisol levels which can weaken immunity and affect cardiovascular health.

Pros of Procrastination



Surprisingly, procrastination is not entirely negative.

1. Creative incubation:

Some individuals generate better ideas when they delay in completion of the assigned tasks as their subconscious mind continues processing the task.

2. Pressure-driven productivity:

Certain people have the natural tendency to work more efficiently under deadlines and under such pressure situations they could produce high-quality output in shorter time spans.

3. Prioritization tool:

By delaying less urgent tasks individuals may inadvertently focus on what truly matters and requires immediate attention.

Cons of Procrastination

However, the disadvantages generally outweigh the benefits of procras-

1. Decreased efficiency:

Constant delays in essential tasks could lead to rushed, lower-quality work which could be rejected by the society.

2. Mental health burden:

Guilt, stress and anxiety starts accumulating after the missed deadlines for the essential tasks resulting in creation of a cycle of avoidance.

3. Lost opportunities:

Chronic procrastinators may miss deadlines for education, career or personal growth.

4. Physical health risks:

Neglecting exercise, medical checkups or healthy routines due to delay can have long-term and fatal consequences.

Social and Psychological Changes

To counter the issue of the procras-

tination, both individual and societal shifts are essential: 1. Psychological Interventions:

Cognitive-behavioral therapy (CBT) can help individuals reframe from negative thinking and in reducing the habit of avoiding essential tasks. Mindfulness practices such as meditation can help in improving the ability to focus and reduce the impulsive drive for instant gratification.Time-management training could encourage an individual about the positives of realistic planning and gradual progress.

2. Social Adjustments:

Educational reforms should include special training in self-discipline, task planning and emotional resilience. Workplace policies can reduce procrastination by promoting supportive environments, flexible deadlines and reward systems. Digital well-being tools such as app blockers and focus reminders can help manage distractions in a technology-driven age.

Procrastination is more than a casual habit of delaying tasks rather it is a scientifically recognized challenge with psychological, medical and social consequences. While it occasionally fuels creativity, its long-term effects can erode health, success and self-confidence. Addressing procrastination requires a combination of personal discipline, therapeutic intervention and societal support. In a world that is defined by productivity and efficiency of the individuals, understanding and countering procrastination is essential for individual well-being and collective progress of the society.

National Nutrition Week:

A Call to Embrace Millets for a Healthier India

As India marks National Nutrition Week from September 1st to 7th, under the theme "Eat Right for a Better Life," I find myself reflecting on a critical paradox. While our nation has made great strides in food production, we are still battling an unseen crisis of malnutrition. The Global Hunger Index (GHI) 2024 classifying our hunger situation as "serious." This data shows me that our problem isn't just a lack of calories; it's a deficiency of essential nutrients. In my work as a food scientist, I've come to believe that the key to creating a truly healthy and sustainable food system lies in returning to our agricultural roots: the humble millet.

In my view, the decline of millets from our national diet was a critical turning point. Following the Green Revolution, our agricultural focus shifted dramatically to high-yield, water-intensive crops like rice and wheat. This move, while successful in achieving food selfsufficiency, led to a dangerous lack of variety in our diets. We abandoned the rich diversity of our native grains for a narrow range of starches. My research confirms what our elders always knew: millets are a nutritional powerhouse. They are packed with protein, dietary fibre, and essential minerals such as iron, calcium, and zinc, which are crucial for combating common deficiencies like anaemia and bone density issues. Their low glycemic index makes them a valuable food for managing diabetes, and their naturally gluten-free nature makes them suitable for an increasing number of people with dietary sensitivities.

Beyond their health benefits, millets also offer a compelling environmental and agricultural solution. They are rightly called "climate-smart crops" because they are remarkably resilient. Compared to rice, which demands thousands of litres of water per kilogram, millets require significantly less, making them ideal for dry regions and a smart way to manage our water resources. Furthermore, their deep root systems help prevent soil erosion and improve soil health, reducing the need for chemical fertilizers and pesticides. By bringing millets back, we are not just addressing a nutritional crisis; we are also building a more resilient and sustainable farming landscape that can adapt to the unpredictable effects of climate change.

Despite this clear potential, millets face significant hurdles. From a scientific and practical perspective, I see that farmers lack assured market prices and struggle with the high effort required for post-harvest processing. The tough outer hull of millets demands specific machinery, which is often expensive and hard for small-scale farmers to get. On



the consumer side, there's a persistent lack of awareness, particularly in urban areas, and the higher cost of processed millet products compared to staple grains like rice and wheat presents a barrier to adoption.

To truly make millets a part of our national diet, we must look to science for a new approach. My own work and that of my team have shown that millets can be transformed from a simple grain into high-value functional foods. For instance, we use advanced analytical tools to perform bioactive profiling of millets, identifying specific anti-inflammatory or anti-cancer compounds. This allows us to move beyond a general health food and create specialized nutritional products. I have personally been involved in developing healthy snacks that blend millets with other traditional foods, such as my work in creating nutri-bars from millet and makhana (foxnut). We've also explored updating traditional methods, for example, by creating probioticfortified fermented millet drinks. This kind of innovation, which creates convenient, scientifically-backed, and appealing products, is essential for winning over the modern consumer.

Beyond the lab, these innovations must be supported by a comprehensive plan. We must continue to push for the integration of millets into public welfare schemes, as this creates a strong, stable demand. At the same time, we need to invest in making processing technology more widely available and helping companies bring new products to market. It is my firm belief that with the right combination of scientific innovation, smart policy, and a new appreciation for our agricultural heritage, we can build a food system that is both healthy for our people and strong for our planet.

This National Nutrition Week, let millets be more than just a passing trend. Let them be a powerful symbol of our shared effort to build a healthier, more prosperous India for generations to come.

JMC launches intensive cleanliness, relief operations post heavy rains

IAMMU, SEP 2: Jammu city has witnessed unprecedented damage due to the recent spell of heavy rains, leaving several parts of the city waterlogged and the residents distressed.

The incessant downpour has particularly affected low-lying areas, where water mixed with heavy silt and debris entered homes, causing severe inconvenience and damage to property.

In the emerging situation, the JammuMunicipalCorporation(JMC) has immediately swunginto action, deploying teams headed by nodal of ficers including Transport of ficersand sanitation officers with prime focus on flood hit areas by pressing additional machinery into service to address the crisis.

To increase the manpower for restoration works, as many as 200 extra Nallah labours were hired on emergency basis for muck cleaning and sanitation works.

Massive cleanliness drives are being undertaken at a war footing to clear the accumulated mud and debris from the affected areas.



Along with the mobilization of available machinery, extra machinery was hired to combat this

Prominent among the worst-hit localities are Peer Ko, Gorakh Nagar, Rajendra Nagar and Gujjar Nagar, where operations are on roundthe-clock to restore normal living conditions. Some of the areas of Gujjar Nagar, Rajinder Nagar, Sangrampur were cleared and work on other areas is in progress on fast track basis.

The overflow of the Tawi River has further aggravated the situation, inundating its adjoining areas and leading to substantial damage to infrastructure and residential premises. To counter this, Dr. Devansh Yadav Commissioner, Jammu Municipal Corporation has issued strict instructions to all departments to expedite the cleaning process, restore essential services and provide immediate

relief to the residents. He is per-

sonally visiting the spots and

monitoring the ground level situ-

Large mounds of mud and debris are being removed with the help of heavy earth-moving machinery, including JCBs, while field teams continue to manually clear clogged lanes and drains. Special focus is being laid on the restoration of water supply, with water being distributed through tankers on a ward-to-ward, communitybased system to ensure uninterrupted access to drinking water for the citizens.

In addition to sanitation and water restoration, the continuous rains have also disrupted electricity supply in several pockets of the city. The JMC is working in coordination with the concerned departments to expedite the repair and restoration work to minimize inconvenience to the public.

Given the risk of waterborne and vector-borne diseases in the aftermath of such flooding, Dr. Devansh Yadav has appealed to residents to cooperate with the ongoing operations, maintain cleanliness in their surroundings and avoid consumption of untreated or contaminated water. Awareness measures are also being intensified to prevent any outbreak of diseases such as dengue, malaria and cholera.

The Jammu Municipal Corporation reassures all residents that every possible step is being taken to bring the city back to normalcy at the earliest. Continuous monitoring of the situation is being carried out and emergency response teams are on high alert to address any emerging needs.

India's emerging as global leader of sustainability: Piyush Goyal

NEW DELHI, SEPT 2: Commerce and Industry Minister Piyush Goyal today said India has emerged as one of the best-performing G20 nations in meeting sustainability commitments, with renewable energy capacity surging and global partnerships expanding.

Speaking at CII's 20th Global Sustainability Summit in the Capital, Goyal credited Prime Minister Narendra Modi's leadership with putting sustainability at the heart of India's growth journey. "Without Prime Minister Modi's decisive role, COP21 may not have been a success. He brought the Global South together to make sustainability a shared responsibility," he remarked.

Highlighting India's achievements, Goyal said the country had already installed 50 percent renewable energy capacity, well ahead of schedule, and was on course to achieve 500 GW by 2030.

"India now offers round-theclock renewable power at globally unmatched rates, around Rs4.60-Rs5.00 per kWh," he said, adding that transparent bidding had cut solar tariffs drastically over the last decade.

The Minister said India's economic strength and resilience were rooted in sustainability, innovation, and inclusivity. He pointed to the success of the UJALA scheme and urged startups to innovate in areas such as energy efficiency, water harvesting, and waste management. Trump calls Chicago 'murder capital of the world'

WASHINGTON, SEPT 2: US President Donald Trump said on Tuesday that Chicago is the world's most criminal city in terms of murders.

"CHICAGO IS THE MURDER CAPITAL OF THE WORLD!" Trump wrote on Truth Social.

He added in another post that at least 54 people were shot in Chicago over the weekend, and eight people were killed, which is "similar" to the last two weekends.

"Chicago is the worst and most dangerous city in the World, by far. [Illinois Governor JB] Pritzker needs help badly, he just doesn't know it yet. I will solve the crime problem fast, just like I did in DC. Chicago will be safe again, and soon," Trump said.

Earlier in the day, White House Press Secretary Karoline Leavitt said that Trump would deliver an "exciting" statement related to the Pentagon on Tuesday.

On Monday, CNN reported that Chicago was expecting a significant surge in federal agents roaming its streets as the Trump administration is reportedly set to launch an immigration crackdown in the upcoming days.

The planned crackdown would be carried out by US Immigration and Customs Enforcement agents, Border Patrol officers, and potentially members of the National Guard, the report said, citing sources with knowledge on the matter. The deployment could happen by Friday and might include armored vehicles, the report added. (UNI)

In 'Reverse Trap', CBI apprehends two for attempting to bribe GST officer with Rs 22 Lakh

NEW DELHI, SEP 2: The Central Bureau of Investigation (CBI) today said they had arrested two people for offering and paying a bribe of Rs 22 lakh to a Superintendent of the GST Intelligence Directorate.

A senior CBI official said the accused were identified as Ram Sevak Singh and Sachin Kumar Gupta.

'The case began when the GST Superintendent, who was conducting a probe into alleged tax evasion by several online companies, was approached by the accused. They allegedly offered him the bribe in exchange for favours in the ongoing investigation," said the official.

"Demonstrating exemplary integrity, the officer immediately rejected the illicit offer and reported the matter to the CBI. The CBI devised a meticulous "reverse trap" operationa strategy where the complainant official acts as the bait to catch the bribe-givers red-handed," said the



official

The official further said the plan was successfully executed, leading to the apprehension of Singh and Gupta as they were handing over the bribe amount of Rs 22 lakh to the

Following the arrests, the CBI initiated extensive searches at multiple locations linked to the accused in Delhi and other cities. These raids are aimed at gathering further evidence related to the bribery attempt and the larger tax evasion case that prompted it.

This operation highlights a growing trend of using reverse traps to target corruption at its source—the bribe-givers. It also serves as a strong warning that attempts to subvert the law by bribing public servants will be met with strict legal action.

The CBI has commended the GST officer's conduct, stating that such acts of probity are crucial in the nation's fight against corruption. UNI

Products covered under a QCO must bear the Bureau of Indian Standards (BIS) Standard Mark, which is obtained by obtaining a BIS license or certificate of conformity (CoC).

"This follows a similar adjustment for QCOs notified by other ministries, such as textiles, where the period was also extended to 18 months. This measure extends essential support and flexibility to exporters dealing with chemicals and petrochemicals across India. The move is poised to simplify trade processes and elevate the global market edge of Indian goods," said the statement.

California court declares "illegal" Trump's deployment of military personnel in LA

WASHINGTON, SEP 2: Amidst his legal battles in the US federal courts, President Donald Trump suffered yet another legal defeat with a court in California ruling against his deployment of the National Guard and MarineCorps in Los Angeles, calling it a violation of federal law, reports CBS News.

The presidential move - part of the Trump administration's sweeping crackdownonillegalimmigration-has been heavily criticised, and met with fierce opposition, with a case filed by protesters against the decision.

In a 52-page ruling, District Judge Charles Brever found the Trump administration's move to be violative of the country's Posse Comitatus Act, a 1878 law that prohibits the use of the military for domestic law enforcement.

Breyer blocked the Trump administration from deploying or using the National Guard currently deployed in California, and any military troops in the state, for civilian law enforcement.



"The evidence at trial established that defendants systematically used armed soldiers (whose identity was often obscured by protective armour) and military vehicles to set up protective perimeters and traffic blockades, engage in crowd control, and otherwise

demonstrate a military presence in and around Los Angeles," Breyer wrote. "In short, defendants violated the

Posse Comitatus Act." The verdict greatly restricts the

president's ability to use federal ser-

vices for carrying out searches, deten-

tions, deportations, crowd control, and other actions which come under the ambit of police operations. Breyer's ruling came after he held a three-day trial in the case brought by California Governor Gavin Newsom in Iune, who sued Trump post his


announcement that he would be deploying the California National Guard to quell protests against his anti-immigration practices in Los Angeles. As of now, President Trump has deployed military personnel in cities such as Oakland, Baltimore, San Franciso, New York, Oregon, and Chicago,

while having placed Washington DC's law enforcement under direct federal control, for battling rampant crime which he attributes to the high level of immigrants. UNI

Rashid, Ashraf Shine as Afghanistan Secure First **Tri-Series Points vs UAE**

Sharjah: Afghanistan survived a brief scare from Muhammad Waseem to ultimately secure a comfortable 38-run victory, their first of the competition, on Monday. As so often, it was Rashid Khan who led the way for them, his 3 for 21 derailing the UAE at a critical juncture midway through their innings just when they looked to have made a fist of chasing 189. He also became the highest wicket-taker in men's T20Is in the process.

That target was set thanks to half-centuries from Ibrahim Zadran and Sediqullah Atal, whose 84-run partnership put their side on course after the early loss of Rahmanullah Gurbaz. UAE turned in a better bowling performance than they did against Pakistan, with their seam bowlers keeping Afghanistan quiet for the most part through the powerplay and then in phases during the middle overs, but paid the price for losing their discipline at the death. A priceless cameo from Karim Janat in the penultimate over meant 22 runs were added, and helped Afghanistan finish above par.

UAE rely so often on Waseem for a realistic shot, and that's exactly what he provided as he flew out of the blocks. They suffered none of the early difficulties Afghanistan had at the start as they stayed ahead of the asking rate thanks largely to their captain. But it always had the feel of a solo effort, and when he was dismissed, no one could replicate that scoring rate, and Afghanistan had enough on the scoreboard, and with the ball, to make the win look cushier than itoncelooked. The pressure was squarely on Afghanistan at the start, having lost the toss and beginning the day at the bottom of the table. That pressure was

 $compounded\,after\,Junaid\,Siddique\,and\,Muhammad$ Rohid got through three tight overs that allowed just 16, before Rohid drew an edge from a struggling Gurbaz to send him on his way. Atal and Ibrahim saw through a further couple of overs with the first five overs of the powerplay decisively going the home side's way. But UAE introduced seam bowler Saghir Khan for the final over of the powerplay, and the pair $saw\,an\,opportunity.\,A\,slot\,ball\,first\,up\,was\,whipped$ over midwicket, and Saghir's lengths didn't improve as the over went on. Afghanistan plundered 18 from it, and it set the partnership on its way.

Atal picked his moments through the remainder of the partnership, finding a four or a six just about every over, with Ibrahim cashing in when Dhruv Parashar sent down an errant over. It wasn't until the Afghanistan 100 was brought up that UAE finally broke the partnership, but with eight overs to go, Afghanistan had the platform they needed to launch. And launch they did. Throughout much of the innings, UAE had held on to Afghanistan's coattails, making sure they never pulled too far ahead. That faded in the final four overs, though, as the wheels came off for the hosts and Afghanistan's lower-middle order plundered 49 off the following three overs.

Azmatullah Omarzai - whose cameo was pivotal to his side's acceleration - triggered the gear change with a six over the on side, with Ibrahim matching him later in the over. Omarzai would go after Saghir too, but it was Janat's takedown of Rohid - who had given away just 12 in his first three and taken two wickets - that took the game out of the UAE's hands.






