

er (KNO) that following a "specific intelligence input" about the presence of terrorists, a joint team of Police, Army's 9 Rashtriya Rifles, and the Central Reserve Police Force (CRPF) launched a cordon-and-search operation in Guddar area this morning. J&K RECEIVES EXCESS RAINFALL OF 41% IN 3 MONTHS

MeT predicts briefs spells of rains till Sept 12

SRINAGAR, SEP 08: Amid frequent flood threats Jammu and Kashmir has received an excess rainfall of 41 per cent from June to September this year.

According to the Meteorological department (MeT) data, accessed by the news agency-Kashmir News

Observer (KNO), five stations in Jammu region have recorded the large excess rainfall from June 01, 2025 to September 03, 2025. The stations include Udhampur, Samba, Rajouri, Ramban and Doda. (Areas where rainfall exceeds 60% above the normal are categorized as experiencing 'Large Excess Rainfall'.)

SRINAGAR, SEP 08: Chief Secretary, Atal Dulloo today held a detailed meeting with the Inter-Ministerial Central Team (IMCT) that arrived in the Union Territory to assess the damages caused by the recent floods. The deluge affected several districts, damaging homes, infrastructure, standing crops and horticultural produce.

While no casualties were reported in the Kashmir Valley, the mountainous districts were deeply affected by flash floods, leading to the loss of human lives and extensive damage to public assets. The agriculture and horticulture sectors have also suffered

Extending his heartiest congratulation to the Vice Chancellor, faculty members, non-teaching staff and students on University's foundation day celebration, the Lieutenant Governor urged to set new and challenging goals and pursue them with a renewed sense of zeal and enthusiasm.

"Today's occasion is also an opportunity for self-analysis, self-exploration, and self-introspection. I am proud of the exceptional accomplishments of our universities in the recently released NIRF-2025 Rankings. The Kashmir Zone Police wrote on X: "Based on specific intelligence, an encounter has started in the Guddar forest of Kulgam. SOG of J&K Police, Army and CRPF are on the job. Further details to follow."

Meanwhile, Chinar Corps said that two terrorists were killed in the encounter while a Junior Commissioned Officer sustained injuries. Security forces are working to ascertain the identities of the slain terrorists as the operation continues.

"Vigilant troops observed suspicious movement and upon being challenged, terrorists opened fire, prompting a fierce exchange of gunfire. During the encounter, two terrorists were eliminated while a JCO was injured," it said on X.

Later in the evening Army wrote on X: "Chinar Corps honours the supreme sacrifice of the bravehearts, Sub Perbhat Gaur and L/ Nk Narender Sindhu, in line of duty for the Nation. Their courage and dedication will

forever inspire us. Indian Army expresses deepest condolences and stands in solidarity with the bereaved families. Operation

machinery, workforce mobilization and allied works, the Chief Minister stressed that strict adherence to timelines is critical for commissioning this prestigious project. He directed the executing agency to expedite all pending works and ensure their completion within fixed deadlines.

Omar Abdullah emphasized that AIIMS Awantipora must be commissioned as a single integrated unit, with both OPD and IPD services made operational simultaneously for the benefit of the general public.

To facilitate this, he instructed the executing agency to fortnightly review status of the progress of works.

The Chief Minister also called upon the executing agency to mobilize additional manpower and machinery to accelerate the pace of work. He reviewed in detail the physical and financial progress of the project, including the construction of the main hospital building, priority building works, approach road, water supply, final master plan, routes to emergency department and other allied facilities.

He further impressed upon them the need to ensure proper stabilization of the surrounding areas, especially in view of the recent heavy rainfall and the institution's location on hilly terrain.

Earlier, Executive Director AIIMS, Dr. Mohanty, briefed the meeting on the progress achieved so far, informing that MBBS courses are scheduled to commence in July 2026, while OPD and allied services are expected to become functional early next year, with the institution fully operational by the end of the same year.

Later, the Chief Minister inspected the site, the premises and perused master plan of the institution.

The Chief Minister emphasized that the marathon must go beyond being a sporting event to become a holistic cultural and tourism experience.

He directed officials to tie up with hotels, restaurants, and local businesses to provide special packages for participants and visitors, allowing them to explore Kashmir's hospital-

ity, cuisine and heritage during their stay. He also suggested introducing 10 km and 5 km runs for local participants in addition to the full and half marathons, thereby expanding community engagement and encouraging youth participation.

Stressing the importance of sustainability, he called for efforts to secure a title sponsor for the mega event to ensure financial viability and greater brand visibility.

Taking into account the Delhi Marathon and Diwali festivities, Omar Abdullah instructed that the Kashmir Marathon-2025 be scheduled on November 2 (Sunday), 2025, instead of the earlier proposed 19 October

The second edition will feature Full Marathon (42.19 km), Half Marathon (21.09 km), and a 10 km Run, covering iconic locations of Srinagar including Poloview, Rajbagh, Lal Chowk, TRC, Nishat Garden, and SKICC, offering participants the breathtaking autumn backdrops of Kashmir.

The event will be supported by a professional event management agency, responsible for logistics, branding, athlete facilities,

and post-event management. The marathon will also be featuring a Marathon Expo and a Gala Cultural evening, aimed at engaging athletes, tourists, and locals, while showcasing Kashmiri art,

culture, and traditions. Importantly, the event is being aligned with eco-friendly practices. The marathon will encourage youth involvement through school-level activities and fun runs, while NGOs and local volunteers will be engaged as "eco-volunteers" for route clean-ups and

sustainability initiatives. On the occasion, the Chief Minister launched the promotional video of Kashmir Marathon-2025 and was presented with his participation certificate from last year's edition, in which he himself successfully completed the half marathon.

Reiterating his government's commitment, Omar Abdullah said the Kashmir Marathon will be positioned as a world-class sporting spectacle that celebrates the Valley's scenic beauty, promotes tourism, and fosters a spirit of health, wellness, and community togetherness.

its tributaries in March 2022. The Union Ministry recommended the project for inclusion under the Flood Management Project (FMP) component of the Flood Management Project & Border Areas Programme (FMPBAP) for the period 2021–26, with 90 percent central funding and 10 percent Union Territory funding.

After Union Government's approval, the administrative council gave its go-ahead to the project in July 2022.

Two key components—resectioning of the Flood Spill Channel (FSC) and its linked components, and widening of the Outfall Channel (OFC)—were conceived as part of the project, with a combined financial implication of up to Rs 1280 crore.

However, the Irrigation and Flood Control Department Kashmir did not initiate work due to differences in findings between two studies conducted by the Pune-based Central Water & Power Research Station (CWPRS) and EPTISA, a multinational engineering company specializing in engineering, consultancy, information technology, and institutional development.

Given divergences, the matter was referred to the CWC, which nominated the Member (River Management) as the nodal officer to recommend a way forward.

After holding 11 meetings with various stakeholders, the CWC forwarded its recommendations to the J&K government on December 23, 2024.

Officials told KNO that the alterations recommended by the CWC would have an additional financial implication of Rs 300 crore. "We need to get approval for additional funding before executing work on these two components," an official said.

He added that around 20 bridges crossing the Flood Spill Channel (FSC) may have their foundations exposed due to excavation up to 2 meters deep. "Extra cost will be required to strengthen their foundations," he said.

When contacted, Minister for PHE, Irrigation and Flood Control, Javed Rana said they are examining the project.

MLA Doda Mehraj.....

Assembly elections, had initially supported Omar Abdullah during government

The government later informed the Legislative Assembly Speaker about the detention of Malik.

According to intimation by District Magistrate Doda, Harvinder Singh, a copy of which lies with the news agency—Kashmir News Observer (KNO), Malik, who represents Doda-52 constituency, has been booked under the provisions of the J&K Public Safety

The communication states that the action was taken on grounds of his activities being prejudicial to the maintenance of public

"After examining relevant materials, reports, and circumstances, authorities concluded that the continuance of such activities posed a 'grave threat' to peace, public order and tranquillity in the district," it

The government said preventive detention under the PSA was found necessary "in the interest of maintaining public order and safeguarding law and order in the region".

The arrest has drawn criticism from political leaders across the region.

Chief Minister Omar Abdullah voiced his opposition through social media, calling the detention unjustified. "There is no justification for detaining Mehraj Malik under PSA. He's not a threat to public safety, and using this discredited law against an elected representative is wrong. If the unelected government can use its powers against an elected representative like this, how can the people of J&K continue to have faith in democracy?" he wrote.

Reacting to the arrest, Arvind Kejriwal, National Convenor and Chief of the Aam Aadmi Party (AAP), said, "Is it a serious offense to request a hospital for one's constituency that an elected MLA is imprisoned? Mehraj Malik is a committed leader of the AAP. He will continue to represent the people and fight for their rights. Jail, threats, or conspiracies will not deter any dedicated member of AAP."

People's Conference President and Handwara MLA Sajad Lone condemned the move, saying it undermines democratic processes. "We strongly condemn the use of the PSA against MLA Mehraj Malik. This is a soulless democracy," Lone said, adding that such actions reduce the people's mandate to a symbolic exercise.

He added that the will of the people remains subservient when elected representatives are denied the right to express their views, warning that such measures damage the credibility of democratic institutions in the region.

PDP leader and MLA Waheed Parra also denounced the arrest, describing the use of PSA as a tool to silence political voices. "Draconian laws are being weaponised to crush dissent. Such authoritarian measures are no way to resolve political differences in a democracy," Parra said.

"Invoking the Public Safety Act (PSA) against MLA Mehraj Malik is unjustifiable. If an elected representative has erred, he must be questioned and dealt with under due

process of law. That is how accountability works in a democracy," Srinagar MP, Aga Syed Ruhullah Mehdi said.

The PSA, he said, intended for exceptional cases of grave security threats, has been repeatedly misused in Jammu & Kashmir to detain individuals on vague and arbitrary grounds. "It has effectively become a tool to silence voices. Such misuse erodes public trust in institutions and reduces a legal safeguard into an instrument of suppression. We strongly condemn the use of abusive language by Mehraj Malik, but this is not justice; it is repression," he added.

NC legislator Salman Ali Sagar said Malik's arrest under the PSA sets "a dangerous precedent" in Jammu and Kashmir. Terming the move as an attempt to "stifle democracy" and "silence dissent", he added, "Free speech and political voices must be protected, not suppressed.

Senior Awami Ittehad Party (AIP) leader and MLA from Langate, Sheikh Khursheed, also condemned the detention of fellow MLA.

Addressing a press conference, Khursheed urged the Lieutenant Governor to review the decision immediately and appealed to the Chief Minister to convene an all-party meeting to formulate a collective response.

"This decision is not just against Mehraj Malik, but against all the people of Doda who elected him through democratic means," Khursheed said, demanding immediate revocation of the order.

The legislator said that any objectionable remarks or actions attributed to Malik should have been dealt with through judicial or parliamentary channels, not through draconian laws.

The MLA also raised serious questions over what he termed as 'discriminatory use' of the PSA in Jammu and Kashmir. "Is this law meant only for the people of J&K? Is there any other region in India where such action is taken against elected representatives?" he asked—(KNO)

J&K receives.....

The large excess rainfall came at a time when the region experienced back-to-back years of deficit rainfall.

Pertinently, Jammu and Kashmir experienced its driest year in five decades in 2024, witnessing a significant deficit of 29%. In 2023, J&K recorded 7% deficit, in 2022 16% deficit, 2021 saw 28% deficit and 2020 experienced 20%

The data reveals that Srinagar & Jammu, summer and winter capitals of Jammu and Kashmir, are among the five stations where excess rainfall has been recorded during the period. The other three stations include Anantnag, Pulwama and Reasi. (Areas where rainfall exceeds 20% to 59% above the normal are categorized as experiencing 'Excess Rainfall'.)

Seven stations including Budgam, Ganderbal, Bandipora, Baramulla, Kulgam, Kathua and Poonch recorded a normal precipitation in this season, the data reveals. However, it shows that the two stations including Kishtwar, Kupwara and Shopian have recorded a deficit rainfall of 33 per cent, 20 per cent and 57 per cent respectively.

Meanwhile, the weatherman has predicted more spells of rain and thunder till September 12th.

Director MeT, Dr Mukhtar Ahmad told KNO that generally cloudy weather was expected today with one or two spells of light rain and thunder at many places of J&K with possibility of brief moderate showers over isolated districts of Jammu division.

From tomorrow, he said that generally hot & humid conditions are expected with brief spells of rain and thunder at a few places till September 12th evening.

He also said that a fresh spell of light to moderate rain and thundershower is expected at many places of J&K towards early morning and morning hours on September 13–(KNO)

and existing nano-enterprises for their upgradation.

He directed departments to ensure that Detailed Project Reports (DPRs) are meticulously prepared to minimize the risk of business failure and stressed the need for continuous capacity building of applicants. He also emphasized hiring skilled manpower for the Project Management Unit (PMU) to ensure professional execution of the mission.

Principal Secretary, Finance, Santosh D. Vaidya, in his remarks, underlined that the programme's success hinges on three pillars including that of skilling of youth, financial support through banks, and strong market linkages. He stressed leveraging existing institutional mechanisms to ensure the goals remain practical and achievable.

Director, IIM Jammu, highlighted the need for a year-long activity calendar for capacity building of stakeholders, with timely listing of training topics and resource persons from reputed institutions.

Presenting the progress report, Secretary, Labour & Employment, Kumar Rajeev Ranjan, informed that Mission YUVA has so far received 42,334 applications including 36,951 for nano enterprises, 1,557 for new MSMEs, and 210 from existing MSMEs.

He further added that the mission has also recorded 90,611 registrations on the YUVA portal, of which 20,304 applications have been verified by Single Business Development Units (SBDUs) and 15,438 approved by District Level Implementation Committees (DLICs).

At the banking level, 15,771 applications involving projects worth Rs 1,071.43 Cr have been submitted. Of these, 4,190 applications have been sanctioned and 2,087 projects disbursed, reflecting strong momentum in youth-led entrepreneurship.

The average project cost, supported under the scheme, was said to stand at Rs 6.3 lakh, with banks sanctioning projects worth Rs 264.47 Cr, disbursing Rs 133.46 Cr, and subsidies worth Rs 23.18 Cr claimed so far.

Director, Employment, Shahzad Alam, further highlighted the strong digital engagement of the mission, with the YUVA mobile app crossing 50,000 downloads and the portal recording over 9 lakh visitors, positioning it as one of the most transparent and accessible platforms for youth empowerment in the UT.

Later, the Chief Secretary reviewed the live YUVA Dashboard, assessing district-wise performance on applications, credit flow, DPR generation, and youth skilling activities across blocks and municipal areas. He also reviewed the status of DLIC clearances, pendencies at banks, and the impact of Udyam Jagriti

heavy losses, with vast stretches of paddy fields and apple orchards bearing the brunt.

During the meeting, the Chief Secretary made a strong pitch for immediate central assistance to restore vital infrastructure such as power supply lines, water supply schemes, schools, roads, bridges and other public utilities. He underscored the need of a comprehensive safety audit of critical public infrastructure, particularly schools, healthcare facilities, bridges and roads, to ensure their resilience for their utility for continuous public use.

The Chief Secretary also sought special relief for farmers whose crops or agricultural lands were damaged due to the floods. He proposed that the Central Government bear the farmers' share of premium too under the Pradhan Mantri Fasal Bima Yojana (PMFBY) so that the affected growers can avail insurance cover for their crop losses.

Highlighting the issue of connectivity, he pressed for immediate directives to central road agencies to undertake swift restoration of damaged roads and support new connectivity projects in flood-hit districts that remain cut off.

The Chief Secretary later took note of the restoration measures taken in Jammu division. He took detailed appraisal first from Divisional Commissioner Jammu and then enquired from each Deputy Commissioner about the status of essential amenities there along with relief and rehabilitation measures initiated to bring respite to the locals in terms of connectivity, power, water and

other public infrastructure. The IMCT has already visited several worst-affected areas of Jammu region, which has borne the maximum brunt of the recent floods and landslides. Over the past month, inclement weather has left J&K reeling, with around 150 people losing their lives and key roads, including the Srinagar-Jammu National Highway, frequently blocked, thereby affecting the movement of traffic on these roads here.

DC Srinagar reviews progress in testing, tracking & treatment

SRINAGAR, SEP 08: In order to review the progress towards Tuberculosis-Free Srinagar under the TB Mukt Bharat Abhiyan in the district and assess the measures taken to achieve the goal of a TB Free status, a meeting of District TB Control Society was held under the chairmanship of Deputy Commissioner (DC) Srinagar Akshay Labroo (Chairman District TB Control Society) here on Monday at meeting Hall of the DC Office Complex.

At the outset, DC took a Medical Zone/Block wise appraisal of key performance indicators including, TB notification rates, early detection and treatment adherence, implementation of Ni-Kshay Mitra initiative aimed to provide additional patient support to improve treatment outcomes of TB patients.

During the meeting, DC was given a detailed overview about the availability and utilisation of diagnostic equipment, screening



mechanisms and treatment facilities in all Medical Zones and Blocks of the district.

On the occasion, Labroo laid emphasis on coordinated efforts, community engagement and optimal utilisation of resources to achieve the objectives of the TB Free Srinagar under TB Mukt Bharat Abhiyan. He called for intensified screening drives, particularly targeting vulnerable sections of the population to curb the spread of TB.

DC pressed for optimised resource utilization to deliver timely diagnosis and ensure effective treatment regimens to the

TB patients. He stressed the importance of home visits by ASHA workers to extend 'athome' support to patients and enhance recovery rates.

He said though the efforts of the administration are yielding significant results, the District TB Society has to further intensify efforts under the TB Mukt Bharat Abhiyan and work collectively towards achieving a TB-Free Srinagar in alignment with national health goals.

DC assured all required support from the District Administration to District TB Control Society to further strengthen its functioning and improve testing measures to achieve required screening.

IGP Traffic Holds Key Meeting with Kashmir Valley Fruit Growers Union on Highway Blockade

SRINAGAR, SEP 8: Inspector General of Police (Traffic), Mr. M. Suleman Choudhary (IPS) held a crucial meeting today with the management of the Kashmir Valley Fruit Growers cum Dealers Union, headed by Chairman Mr. Bashir Ahmad Basheer, to address the ongoing crisis caused by the continuous closure of the Srinagar-Jammu National Highway (NH-44) due to inclement weather conditions.

During the meeting, Chairman Bashir Ahmad Basheer apprised the IGPTraffic of the severe distress faced by fruit growers as hundreds of fruitladen trucks remain stranded at various locations along NH-44 for several days. This, he said, has resulted in major damage to fresh fruit consignments, particularly early-season varieties such as Babugosha, Galamast, and Red Galla.

He further highlighted that despite advisories issued to fruit growers to delay harvesting, apple crops are naturally falling from trees, causing additional damage. As a result, the estimated losses to the horticulture sector are expected to exceed ₹500–700 crore, with the figure rising daily as the highway remains blocked.

Mr. Basheer appreciated the government's step of allowing six-tyre trucks to ply via the Mughal Road, but emphasized that this arrange-



ment is not sufficient for the transportation of large fruit consignments. He clarified that high-volume fruit transportation is traditionally carried out using 10, 12, and 14-tyre trucks, which are currently not suitable for the Mughal Road due to its infrastructure limitations and terrain conditions.

In response, IGP Traffic Mr. M. Suleman Choudhary informed the delegation that Mughal Road is not feasible for larger vehicles in its present condition. He acknowledged the gravity of the situation and assured the Union that the Traffic Department is making every possible effort to restore NH-44 at the earliest. He also confirmed that telephonic discussions with SSP Traffic (National Highway) have been held to expedite efforts.

Highlighting the economic strain, Mr. Basheer noted that freight charges have surged nearly 300% above normal rates, adding a heavier financial burden on growers already facing crop losses.

At the conclusion of the meeting, the Union delegation expressed satisfaction upon being informed that, if weather conditions improve, there is a strong possibility of NH-44 reopening within a day. The IGP assured that once reopened, priority will be given to stranded fruit-laden trucks to ensure timely delivery to markets across the country.

The meeting concluded on a positive and hopeful note, with both sides committed to mitigating the crisis and supporting the horticulture committee.

The Jammu & Kashmir MSME Health Clinic will serve as a dedicated institutional mechanism to identify early signs of stress in MSMEs and provide tailored solutions through financial and non-financial interventions. A Project Management Unit (PMU), to be hosted at IIM Jammu, will comprise experts in branding, marketing, finance, technology and strategy, supported by young professionals and data analysts.

The primary objective of establishing the Jammu & Kashmir MSME Health Clinic (JKMHC)

under the RAMP Programme is to create a proactive mechanism for the early identification and prevention of stress in Micro and Small Enterprises (MSMEs). This initiative aims to provide both financial and non-financial support to MSMEs that exhibit signs of stress and are on the verge of slipping into sickness. It is designed as a preventive measure to address the developmental needs of MSMEs, focusing on diagnostic and clinical support exclusively for enterprises showing early signs of stress.

The program has been structured to run over a two-year duration from FY 2024-25 to FY 2026-27, with a total outlay of

30.64 crore. It will cover nearly 959 identified MSMEs across Jammu & Kashmir and will be implemented in three distinct phases. Phase I will focus on diagnostic studies and identification of vulnerable enterprises, Phase II will implement financial and non-financial interventions and Phase III will establish longterm monitoring and sustainability frameworks.

Financial interventions under the program will include working capital loans, technology upgradation subsidies, warehouse receipt financing and export promotion grants, while nonfinancial interventions will emphasize capacity building, skill training, quality certification and strategic mentoring.

The signing of this MoU marks a significant step in strengthening the MSME ecosystem in Jammu & Kashmir. By combining academic expertise, government support, and trade promotion mechanisms, the initiative seeks to create a scalable and sustainable model over a clearly defined twoyear duration with a total outlay of 30.64 crore, transforming distressed enterprises into resilient contributors to the regional and national economy.

With IIM Jammu as the knowledge partner and host of the Project Management Unit, the initiative draws upon the Institute's strengths in research, innovation, and executive training. He emphasized that construction, vehicular, biomass burning etc. emissions contribute significantly to air pollution and climate change, leading to rising temperatures, extreme weather events and ecosystem degradation.

The Speakers further highlighted that Air pollution is contamination of the both indoor and outdoor environment and it can be due to any chemical, physical or biological agent that modifies the natural characteristics of the atmosphere. Household combustion devices, motor vehicles, industrial facilities and forest fires are common sources of air pollution. Pollutants of major public health concern include particulate matter, carbon monoxide, ozone, nitrogen dioxide and sulfur dioxide. Outdoor and indoor air pollution cause respiratory and other diseases and are important sources of morbidity and mortality. The event concluded with a vote of thanks by Dr Kirti PO underlined the need for collaborative efforts to reduce air pollution, build climate resilience and ensure sustainable development.

KATHUA, SEP 8: To provide timely succor to calamity-affected households, the District Administration Kathua today organised a relief distribution camp at Manhas Mohalla Ghatti which was presided over by Deputy Commissioner Rajesh Sharma.

Families that suffered losses due to incessant rains and flash floods were provided relief material comprising dry ration, blankets, mattresses and tents to ease their immediate dif-

ficulties. Interacting with locals, the Deputy Commissioner said the administration is afoot to reach out to all affected families, even in the remotest corners of the district to provide immediate relief and support for rehabilitation under SDRF norms.

The DC disclosed that out of approximately 1200 partially or fully damaged houses reported across the district due to incessant rains and landslides. The administration has already extended financial assistance to over 500 families under SDRF, while the process is on to clear remaining



He further informed that machinery has been pressed into service to retrieve remains from damaged properties, enabling affected households to begin restoration where possible. He said such relief camps are being organised at subdivision levels, while parallel efforts are underway to restore road, power and drinking water connectivity disrupted by rains and floods.

The Deputy Commissioner reiterated that early restoration of essential services, timely disbursement of relief assistance and addressing public grievances remain top priorities of the administration.

ADC Kathua Vishavjeet Singh and other revenue officials were present during the camp and also interacted with the affected families to take stock of their concerns.

Take all precautions before reopening of schools in Jammu division

As the authorities have decided to reopen the educational institutions in the Jammu division from Wednesday, September 10 it is important that all the safety parameters are followed in the same. The people at helm should ensure that no risk whatsoever is involved in the reopening of educational institutions and the safety of the students as well as teachers is not compromised in this process.

It would be in place to mention here that the educational institutions in the Jammu division had to be closed following prolonged spell of rainfall that led to flooding and inundation of many areas. Precious lives were lost and huge damages were caused to the properties spread across the Jammu division. Given the fact that there has been continuous rainfall in the Jammu division it is important that a proper check of the school buildings and related infrastructure is done.

Once a proper check is carried out and the infrastructure is found fit then only a school should be reopened. The condition of the private school buildings is better when compared to the government school buildings. Day in and day out there are reports that the condition of scores of school buildings is dilapidated and the same needs to be improved. There are many schools in both the Kashmir and Jammu divisions which don't have doors and windows and there are many others which do not have proper seating arrangements.

The children in these schools are forced to sit on jute matting which too is worn out in most of the cases. Since the government school buildings are prone to weather vagaries it is imperative that no compromise whatsoever is made with respect to safety and security of the children, teachers and the other staff. This would ensure that the children receive their education in a proper manner and the other activities are also carried out in a systematic manner. Once the mind of a child is diverted then it is quite possible that the education of the child would be affected.

At the same time it is also important that the educational institutions are free from water logging or stagnant water. The presence of water logging or stagnant water is a breeding ground for mosquitoes and as such one cannot rule out the outbreak of water borne diseases. All the precautions need to be taken in this regard so that the children don't fall prey to the water borne diseases.





Disaster Strikes, We React: The Flaw in Our Management System

India is a country blessed with incredible natural diversity. The towering Himalayas, vast plains, fertile soil, networks of rivers, and long coastlines provide us with immense natural wealth. But along with this diversity comes the recurring devastation of natural disasters. Sometimes cloudbursts strike, sometimes sudden floods swallow entire villages. At times the earth trembles, while elsewhere mountains crack apart. Modern science and technology have given us the ability to forecast weather, to estimate rainfall and its intensity in advance—yet, every time, our preparedness proves incomplete. This has become our greatest weakness.

The irony of disaster management in India is that we become active only after disaster has struck. Preparations for relief camps, strengthening of roads and bridges, cleaning of drains, and stocking essential medicines—all of this looks impressive on paper, but the ground reality is very different. Administration and concerned agencies often wait until the crisis is upon them. This is why thousands of people lose their homes each year, and properties worth crores of rupees are destroyed. At times, the negligence and apathy of government machinery proves to be even more dangerous than the disaster itself.

In particular, landslides have now become common in mountainous regions. What was once considered an unusual occurrence is now a recurring phenomenon during the monsoon. The reasons are not only natural, but man-made as well. Rampant deforestation has weakened the soil. Illegal construction on mountain



slopes, carried out without regard for geographical capacity, has destabilized the land. Expert reports constantly warn that the limit for construction on these slopes has already been exceeded. Governments too issue guidelines from time to time. Yet, in reality, large builders and hotel projects easily get approvals. Local administration and corruption only worsen the situation. The result is that even moderate rainfall during monsoon turns deadly, and entire villages or towns are wiped out by landslides.

A large part of India falls in earthquake-prone zones. Uttarakhand, Himachal Pradesh, Jammu & Kashmir, the northeastern states, and even the national capital Delhi lie within this danger zone. Every few years, a major earthquake reminds us how vulnerable we are. After every earthquake, discussions on earthquake-resistant construction gain momentum. Suggestions for safer buildings, recommendations of construction standards, and government directives come forward. But once conditions normalize, everything is forgotten. Builders and ordinary citizens are made aware of earthquake-resistant norms, yet there is never strict monitoring to ensure compliance. That is why the next time the earth shakes,

we are forced to bear heavy losses all

 $The \, situation \, is \, no \, different \, when \,$ it comes to floods and cyclones. Every year, our coastal regions face cyclones. The meteorological department often provides accurate forecasts, but the question is—do local administrations and communities prepare accordingly? In many cases, warnings are taken lightly. Relief material, safe shelters, and deployment of rescue teams are not arranged on time. As a result, thousands of people lose both lives and livelihoods. The same negligence is evident during floods. River embankments collapse, drains are not cleaned in time, water disposal systems remain incomplete, and cities struggle with waterlogging.

Disaster management must not be confined to post-disaster relief and rescue operations. It must be integrated into our development policies and daily lives. For example, if urban planning is approached with disaster-resilience in mind, the extent of damage can be greatly reduced. Strict enforcement of earthquakeresistant construction standards, regular cleaning of rivers and drains, prevention of illegal constructions, and promotion of afforestation can all significantly strengthen our preparedness.

Social awareness is another major need of disaster management. Citizens must be made to realize that $disaster \, preparedness \, is \, not \, only \, the \,$ responsibility of the government, but also of every individual. Schools and colleges should provide special training on disaster management, mock drills should be organized, and people should be taught how to protect themselves and their families in times of crisis. If preparedness at the citizenlevel is strong, the burden on the administration will be reduced, and loss of life and property will also

India has institutions such as the National Disaster Management Authority (NDMA). These organizations have comprehensive plans and policies for disaster management. But their impact is visible only when implemented effectively at the local level. Often, these plans look excellent on paper, but their execution is extremely weak. Corruption, negligence, and shortage of resources dilute them. What is needed is a stronger monitoring mechanism and clear accountability.

It is not in our hands to completely prevent natural disasters. But the extent of their impact depends entirely on our preparedness. If we remain careless, we will continue to suffer the loss of lives and property every year. But if we prepare seriously, adopt scientific recommendations, incorporate environmental balance into construction and development, and build public awareness-we can significantly minimize the impact of

Today, the need of the hour is to stop treating disaster management as a formality undertaken only after calamities strike. It must be integrated into our policies, our planning, and our personal responsibility. Unless wetake preparedness seriously, floods, earthquakes, and landslides will continue to shake us year after year. This remains our greatest weakness-and we must overcome it.

The Vision from the Ground Up

The National Education Policy (NEP) 2020 gives us the perfect blueprint for this. It's not just another document; it's a living guide that encourages us to break free from old ways of thinking. The policy's push for a well-rounded, hands-on education, one that mixes different subjects and puts technology at the center, is exactly what we need. We're asked to do more than just produce graduates; we're asked to create people who can solve problems, think critically, and contribute to their communities.

This is where our work gets truly personal. We've embraced programs like Unnat Bharat Abhiyan (UBA), which isn't just about adopting villages; it's about building a connection. It's about our students and faculty spending time in rural communities, understanding their daily struggles, and helping them find solutions. Imagine our students from the computer science department helping villagers set up a basic internet hub, or our education majors creating simple, visual tutorials in local languages on a tablet. This isn't just a project; it's a partnership. In this, our youth volunteers from the National Cadet Corps (NCC) and National Service Scheme (NSS) can play a particularly important role. Their existing framework of community service and discipline makes them ideal for leading on-ground digital literacy campaigns, acting as the first point of contact and support for village residents.

The Real Barriers and Our Next Steps

The work isn't easy. I've seen firsthand the obstacles we face. The biggest one is simply a lack of infrastructure. You can't teach digital literacy without electricity or a reliable internet signal. Then there's the people part of the problem. Many of our educators themselves need to be comfortable with new technology before they can teach others. And we can't forget the relevance issue: if the digital tools we offer don't solve a real-life problem for people, they won't be used. A study at Dibrugarh University even showed that even our postgraduate students struggle with some digital skills, which tells us we have work to do right at home before we go out into the community.

To start, we must team up with private service

providers and local governments. They have the resources and expertise to help us build community Wi-Fi spots and set up digital labs in villages. A combined effort is much stronger than a solo one. Within our own walls, every professor and student, no matter their field, should receive ongoing training in digital skills. We need to create a universitywide culture where digital literacy is a core part of everything we do, not just a separate subject. We should also invest in creating digital content in local dialects and languages. Think simple video tutorials for farmers on using a mobile app to check market prices or for women's self-help groups to manage their finances. It's about meeting people where they are. To incentivize this, we could launch a special "Digital Impact Fund" to support studentled projects aimed at solving digital literacy challenges, turning our students into entrepreneurs and innovators who are rewarded for practical solutions that directly help our communities.

The journey ahead is about more than just technology. It's about building a more inclusive society where everyone has a chance to succeed. The principles of NEP 2020 and the spirit of initiatives like UBA show us the way. By committing ourselves to these goals, we can transform our universities from academic centers into true engines of national development. It is a big task, but with a clear vision and collective effort, we can make sure that our nation's story in the digital age is one of universal access and shared opportunity.

of harmony and resilience. Managed by a Kuki-Meitei couple, Don-jalal Haokip and Rebati Devi, the orphanage stands as a poignant reminder of the unity and coexistence that once defined Manipur before the ethnic strife erupted in May 2023.

The foundation provides a safe haven for 19 children (14 Boys and 5 Girls) from diverse communities, including Kuki, Meitei, Naga, and Nepali backgrounds.

In a profound display of solidarity, all 19 children from the Ema Foundation are being sponsored by the Assam Rifles and are receiving their education at the Assam Rifles Public School in Keithalmanbi. Also, over a period of time, the foundation has received administrative support from various interested donors.

Your children are not your children. They are sons and daughters of Life's longing for itself. They come through you but not from you. And though they are with you yet they belong not to you... you may give them your love but not your thoughts.... A parent's love is a constant, enduring gift to their children, who ultimately belong to themselves and the future.....Some forget and some parents love the art...... New Keithelmanbi is a location within the Kangpokpi District of Manipur, India. It is notable for having a Police Station (NKM-PS) responsible for policing the area, including areas like Kotzim village and the surrounding villages of the Kom community.



IMCT assesses impact of flood across Shopian district

Also review relief, rehabilitation measures

SHOPIAN SEPTEMBER 08: The Inter-Ministerial Central Team (IMCT) deputed by the Union Government today held a review meeting to assess the damages caused by recent floods and incessant rainfall across district Shopian as well as relief and rehabilitation measures carried out by district administration.

Deputy Commissioner, Shopian, Shishir Gupta, presented a detailed assessment of damages suffered in Shopian district before the IMCT members which included senior officers from NDMA, Ministry of Rural Development, Ministry of Jal Shakti, MoRTH, Agriculture & Farmers Welfare, Ministry of Power and Finance.

During the meeting, DC Shopian gave a detailed PowerPoint presentation covering the disaster



preparedness framework. He informed the team that Shopian, spread over seven tehsils, although comparatively less vulnerable to floods than other districts, has suffered damages to public infrastructure including Roads, Bridges, Water Supply Schemes, Power assets and standing crops and

houses of lower riparian villages in Zainapora sub division.

DC Shopian also briefed on immediate restoration of services which were disrupted during floods and relief and rescue measures carried out in the district.

DC Shopian informed the IMCT that in Shopian district, 2 out of 6 major 33 KV lines, 16 feeders, 13 transformers and 19 electric poles were affected and have been restored; 55 out of 92 drinking water supply schemes were impacted and all have been restored, 25 roads were damaged of which 24 stand restored and 1 is under restoration besides PMGSY road length of about 860 metres was damaged.

 $The\,DC\,also\,apprised\,the\,IMCT$ that Mughal Road at KM 24 witnessed severe damage due to sliding and efforts are on to keep it open 24*7.

It was further informed that 28 villages in low lying areas covering 4284 hectares with a population of 17,200 were impacted, 4 villages namely Hydergund, Zainapora, Melahura/Wandina and Reshipora were directly hit, 21 shelter sheds were established, 129 families evacuated and 644

persons rescued.

The DC also briefed that 11 residential houses have been damaged while crop and orchard losses are being assessed.

The DC informed the team that Shopian administration has already initiated both short-term restoration measures and long-term resilience planning. He added that protective and restoration works like crate bunds, embankments and flood protection measures have been initiated at Hydergund, Zainapora, Safanagri and other vulnerable spots.

Addressing the officers, the IMCT directed for department-wise damage details be compiled for submission to GOI and assured that recommendations will be included in their report to enable immediate relief as well as longterm resilience planning for Shop-

DC directed officers to visit their assigned villages, engage with community members, gather accurate data, and submit baseline survey findings within a stipulated timeline. He also urged them to ensure that vulnerable sections, including women, elderly residents, and youth, are actively involved in identifying challenges and shaping development priorities.

The meeting was attended by Programme Officer ICDS, Yaar Ali Khan; SDM Lolab, SDM Karnah; CPO, DIO, BDOs, Executing Engineers, and other concerned officers. Technical departments were advised to coordinate with line departments for timely implementation of infrastructure projects, while social welfare teams were tasked with mobilizing commu-

nity participation. The DC further instructed that periodic review meetings be scheduled to monitor progress, address field-level challenges, and ensure transparency in execution.

Former EU foreign policy chief states Europe almost a US vassal

BRUSSELS. SEP 8: Former EU foreign policy chief Josep Borrell on Monday stated that Europe could no longer be considered an independent actor, as its increasing appearement of every US demand and weak leadership is pushing it closer towards becoming a vassal for Washington.

Borrell warned that the US undertheTrumpadministration can never be considered an ally.

Referring to the frictions in the bloc, he wrote in a column for Politico, "Our union appears dangerously fragmented and weak, stuck in a hostile internal and external environment.

"Home to just 5% of the global population and a widening economic gap with other major powers, Europe isn't just facing up to a world of continental empires but is at real risk of becoming America's vassal."

He cited Europe's agreement towards increasing its defence budget by 5% of its GDP due to US pressure at a time when its economy is in dire straits. He said euroep was becoming a "junior partner" to the US, in global conflicts all the way from its handling of the Russia-Ukraine war, to the conflicts in Gaza, and Nagorno-Karabakh.

Borrell asserted that "EU's involvement in conflicts abroad has become largely irrelevant, either due to its lack of credible international standing or unity."

Further attacking the European Commission's current leadership on domestic policies, he opined that the bloc under "President Ursula von der Leyen's second term has been coun-



terintuitively marked by the undoing of the Green Deal — the flagship project of her first term — as if climate change isn't getting worse. "The Commission has also proposed an underwhelming Multiannual Financial Framework with no real

increase, thus sacrificing cohesion policy to new priorities in defence products and research." He further remarked that the

bloc-beitthe EU councilor Commission - is becoming heavily divided as the leadership lacks any form of long-term political vision, leadership and unity, with "Trump sympathisers and nostalgic Atlanticists" content in flatteringtheUSandentertaining all its whims, "in the hopes of damage control, in turn fostering our political, strategic and even economic dependency on Washington—and it's hardly working."

Declaring that the US under Trump can never be an ally of Europe, the former VP of the Commission argued that all contracts signed under his tenure is only being binding to the other party. In this context, he referred to the EU's silent acceptance of US demands to increase its defence spending and buy greater stocks of US weapons, while Trump did not pledge to strengthen European security.

"His America constitutes a huge geopolitical, economic and cultural shock to Europe," stating that becoming "a U.S. protectorate isn't inevitable - especially given increasingly indignant public opinion over the series of concessions and humiliations we're witnessing."

To counter this, Borell urged a "reinvigoration of a pro-European majority in the bloc's three institutions — particularly the European Parliament," as well as ending the "vetocracy" being used by countries like Hungary to block Ukraine's EU membership and hindering Europe's ability in helping Ukraine.

"If no action is taken, and we wait for the next crisis to improvise on hard decisions, Europe as a political project risks dying," he concluded. UNI

Trump-Putin can prevent WW-III by working together, says top Kremlin official

MOSCOW, SEP 8: US and Russia can prevent a third World War by working together, said Kirill Dmitriev, Russia's presidential aide on international economic affairs, stating that President Donald Trump and President Vladmir Putin are working on ending Kremlin's war with Ukraine.

Taking to X, the envoy posted an old picture from the 1945 Yalta Conference featuring Stalin, Roosevelt, and Churchill, and underneath it – another picture of Trump and Putin.

He captioned the post: "Stalin, Roosevelt, and Churchill won WWII. Putin and Trump will prevent

The historic conference in Crimea between the



Allied leaders was noted to have laid the foundation for post-war construction of Europe and the establishment of a new world order.

It resulted in the creation of the UN, called for complete demilitarisation of Nazi Germany, and its division into four spheres of influence – US, Soviet,

Putin and Trump have held several phone conversations and met face-to-face in Alaska in mid-August to discuss a settlement for Ukraine.

While no agreement was reached in the Alaska summit, the two sides praised the engagement as highly productive, with a noteworthy change taking place in Washington's earlier stance of calling for a permanent settlement rather than just a ceasefire.

Following the talks, Trump said that Ukraine cannot hope to join NATO or reclaim Crimea, calling those prospects unrealistic.

Despite a diplomatic breakthrough in communications, the US has sent mixed signals, as it has also warned of secondary tariffs on Russia -- which currently has a duty 90% -- taking it to 100%, if the Kremlin does not reach an agreement with Kyiv soon. UNI

Nepal's 'Gen Z agitation' spirals out of control, protesters breach Parliament premises; 6 dead

KATHMANDU, SEP 8: In a major development, Nepal's 'GenZ' protesters - agitating against corruption, social media censorship, and negligence breached the Parliament's Gate 2, hurling stones, and setting fire to certain parts of the structure. The Kathmandu administration has imposed curfew in parts of the capital, amid reports that six people have died in violent clashes with the police.

The mass agitation occurred in wake of the government's controversial ban on several social media platforms such as Facebook, Instagram and YouTube, alleging that they had failed to register with the Ministry of Communication and Information

The youth-led protests, which began peacefully in the morning with patriotic songs and anticorruption slogans, have now turned into one of the most serious challenges to state authority in recent years, reports Nepal News.

The strong anti-administration protests – particularly the breaching of Parliament premises - point towards a nationwide unrest in the country, as parallel demonstrations in a similar light have also spread to Pokhara, Butwal, Dang, Nepalgunj, and other major cities.

According to reports, four demonstrators died at the Trauma Center and one at Civil Hospital in New Baneshwor after suffering critical injuries from rubber bullets. Another protester suc-



cumbed at Kathmandu Medical College in Sinamangal, bringing the total fatalities to six, Nepal Online Khabar said.

Dozens more were injured, though the exact number is yet to be confirmed. Hospitals con-

tinue to receive casualties from across the city.

The protests escalated after police used force to disperse crowds, deploying tear gas, rubber bullets, and water cannons. Despite a curfew imposed from

12:30 pm across several areas of Kathmandu, the demonstrations have not subsided.

New Baneshwor and surrounding areas remain tense as angry protesters continue to defy the curfew, clashing with security forces.

Security forces remain on high alert across the country as analysts warn that the movement reflects a generational shift in Nepal's political landscape.

Post the clash with authorities, Gen Z Nepal movement organisers urged participants via Facebook to leave the area immediately and safely.

The post read: "Many self-interested groups are attempting to provoke the crowd. Our day has already been a success. Everyone should return home safely." UNI

ED conducts raid over alleged fake gold loan fraud

NEW DELHI, SEP 8: The

Enforcement Directorate (ED) today said that it recently conducted search operations at multiple locations in Goa in connection with a Prevention of Money Laundering Act (PMLA) case. The case relates to an alleged bank fraud involving the sanctioning of gold loans against fake gold ornaments, which resulted in a loss of Rs. 2.63 crore to UCO Bank.

The action was initiated by its Panaji Zonal Office. A senior ED official said that the searches were conducted at the residential and business premises of Gundu Kelvekar and Hemant Raikar.

under the PMLA based on an FIR registered by the Economic Offence Cell, North Goa.

The ED initiated an investigation

The FIR alleges that Gundu Kelvekar, in a criminal conspiracy with Hemant Raikar, the empanelled gold valuer for UCO Bank, fraudulently obtained multiple gold loans from the Verna, Fatorda, and Margaon branches of the bank.

The loans were acquired by pledging fake yellow metal ornaments, which Hemant Raikar

knowingly certified as genuine gold. The ED investigation revealed that between 2019 and 2023, Gundu Kelvekar, assisted by his wife Mayuri Gundu Kelvekar, systematically obtained these loans in their names and in the names of their associates.

The investigation established a clear money trail where the loan amounts, once disbursed to the associates' accounts, were immediately transferred to the savings bank account of Gundu Kelvekar.

A significant portion of these funds was withdrawn in cash, with Gundu Kelvekar withdrawing Rs. 79.65 lakh and his wife withdrawing Rs. 48.75 lakh. Part of the funds were further layered through transfers to various entities, including bullion dealers, to project the Proceeds of Crime (POC) as untainted.

During the search operations at the residence of Gundu Kelvekar, assorted yellow metal ornaments weighing 4.5 kg were found. An authorised valuer confirmed these items were not gold but white metal with yellow plating. The PMLA investigations revealed that the gold loans procured fraudulently were not only from UCO Bank but also from other public sector banks and even a cooperative bank.

Therefore, the POC, presently estimated at Rs. 2.63 crore, is expected to increase significantly. The seized evidence is being scrutinised to unearth the complete trail of the POC.

Further investigation into the matter is on. UNI

AAP legislator demands compensation for Delhi farmers

NEW DELHI, SEP 08: Sanjeev Jha, the Aam Aadmi Party's Chief Whip in the Delhi Assembly, has written to Chief Minister Rekha Gupta seeking compensation for Delhi's farmers saying their crops were destroyed by recent flooding from the Yamuna River.

In the letter, Jha, who is the MLA from Burari, stated that rising water levels have caused severe waterlogging, submerging crops in low-lying areas of his constituency. He described the situation as a "serious livelihood crisis" for numerous farming families, noting that the destruction of their crops has resulted in a significant loss of income after months of

Jha urged the Chief Minister to deploy special survey teams to quickly assess the extent of the crop damage. He pointed out that in previous instances of similar natural calamities, the government had provided timely compensation and relief to affected farmers, and he expects the same response this time.

ED FILES CHARGESHEET IN UDUPI COOPERATIVE SOCIETY SCAM

NEW DELHI, SEP 8: The Enforcement Directorate (ED) today filed a chargesheet against Kamalakshi VividodheshaSahakaraSanghaNiyamitha, B.V. Laxminarayana, Asha Rao and Radhika in connection with a Prevention of Money Laundering Act (PMLA) case related to a cooperative society scam. The chargesheet was filed before the Additional District and Sessions Judge in Mangalore.

The ED initiated its investigation

based on multiple FIRs registered by the Udupi CEN Crime Police Station, Karnataka, under various sections of the Indian Penal Code (IPC) against B. Laxminarayana, Rao, Radhika and others. The ED investigation revealed that Laxminarayana(president of the cooperative society), with the aid of Rao (manager of the cooperative society) and Radhika (wife of Laxminarayana and director of the society), had mobilized funds from depositors to the tune of Rs 32,73,98,448.

They operated under the names

Kamalakshi Vividodhesha Sahakara Sangha Niyamitha, Udupi, and Ganapathi Investments, promising high interest rates of up to 15 per cent per annum. They subsequently cheated the depositors by defaulting on the promised interest and capital repayments. The ED investigation further revealed that the funds mobilized from the depositors were utilized by Laxminarayana to purchase immovable properties in his name and in the name of Radhika. These properties have been subjected to attachment. UNI

India's Nets speak, But Not Of Samson

DUBAI: If India's first practice session at the ICC Academy in Dubai was about finding their bearings, the second was about intent. There was a sharper edge to the drills, a clearer order to who batted where and, in the process, a few quiet hints about how the team management is beginning to imagine its playing XI. None of its poke more clearlythanthesilence around Sanju Samson. After his warm-up sprints and a token hit in the outfield, he settled on a red icebox and remained perched there for most of the evening, watching as Shubman Gill, Jitesh Sharma and Rinku Singh batted in the three centre-wicket nets. The irony was hard to miss. Of Samson waiting while Gill, India's returning vice-captain, for whom he had stood in during those months of breakthrough runs and centuries through late 2024 and early 2025, took his turn. Of Samson waiting while Jitesh, the squad's other wicketkeeper, and Rinku, the other designated finisher, sweated it out.

For the first couple of hours, the nets belonged to only six names: Gill, Abhishek Sharma, Suryakumar Yadav, Tilak Varma, Jitesh and Rinku.

Gill and Abhishek, teammates since their U-12 days, moved almost as a pair. The evening even began with Abhishek inspecting and playfully swinging Gill's bat, one that had already carried him to milestones, including his first international hundred in Zimbabwe, Later, the two slipped seamlessly into catching drills under fielding coach T. Dilip. From there, Gill and Abhishek headed to the farthest of the three nets, facing the new ball from Arshdeep Singh and Jasprit Bumrah. The bowling group was soon joined by Hardik Pandya and, notably, Shivam Dube, who ran in hard. In the adjoining net, Rinku was first in, tackling the spin trio of Kuldeep Yadav, Varun Chakaravarthy and Axar Patel. Tilak and Suryakumar followed, both logging extended time against spin, including a skiddy, round-arm legspinner. Tilak was

the last to finish, effectively closing a session Rinkuhadbegunhoursearlier. Meanwhile, Varun Chakaravarthy bowled one of the night's longest spells, then worked with Diliponhishigh catching. The coach's advice seemed to be pointed: crouch and move in only once the ball has left the bat. Dilip's presence was everywhere but his extended time with Rinku and Kuldeep stood out, Samson, though, remained peripheral. No fielding drills were lined up for him and his batting window was narrow. He got a hit out alongside allrounders Hardik, Dube and Axar, sharing a net with Hardik before moving quietly to the spin nets. When Samson was inthemiddle, Gautam Gambhirwas deep in conversation with Suryakumar, and they were later joined by Gill. They could have been discussing anything, but given how the night unfolded, it was unlikelytobeaboutSamson.Practicesessions don't name XIs, but they do whisper hints; and for Samson, the verdict seemed to arrive before his turn did.

BCCI's finances hit new highs; INR 14,627 crore added since 2019

NEW DELHI: Death and taxes are not the only certainties in life after all - the ever-swelling riches and coffers of the Board of Control for Cricket in India (BCCI), it seems, are just as guaranteed. As per a report, circulated among the state associations, the Board had a bank balance of INR 20,686 crore as of 12 months back.

Inevitably that must have gone up exponentially over the last one year, the financial assessment of which will be revealed at the AGM on September 28, even as it has emerged that the BCCI continues to pay income tax in thousands of crores.

A relevant part of the statement of accounts, submitted at the 2024 AGM, reads, "Honorary Secretary apprised the members that since 2019, the cash and bank balance of BCCI has increased from INR 6,059 crore which was before disbursing any amount to the state cricket associations to INR 20,686 crore which is after disbursing all amounts owed to the state cricket associations.

Therefore, since 2019, BCCI has added INR 14,627 crore in the last five

years. This is an increase of INR 4,193 crore since the last financial year. Further, since 2019, the general fund too has increased from INR 3,906 crore to INR 7,988 crore which is an increase of INR 4,082 crore."

The report also seems to bust the myth that the BCCI does not pay income tax. It set aside over INR 3000 crore towards taxes while continuing its appeal in various tribunals. "The BCCI has provisioned INR 3,150 crore towards income tax obligations for FY 2023-24. While BCCI is on the right track before the courts and tribunals, it has still made provisions towards paying any obligations that may arise towards tax," the report reveals.

The revenue would have been much more for the board but the gross media rights income from BCCI's international fixtures was reduced to INR 813.14 crore as compared to INR 2,524.80 crore of the previous year. "This decrease is the result of a reduced number of international home matches/ series played during the year as compared to the previous year. During the year, ICC CWC 2023 (ODI World Cup) was hosted by BCCI during the month

of Oct-Nov 2023," says the report. Some other key points of the Audited Statement of Accounts of 2023-

Income from Tours: The gross receipts from Men's Senior International Tours and events have decreased to INR 361.22 crore compared to INR 642.78 crore of the previous year.

Investment Income: The BCCI earned an interest income on bank

deposits of INR 986.45 crore as compared to INR 533.05 crore of the previous year. BCCI has managed to get the highest ROI available in the market with minimal risk from the major Nationalized/Private banks under the guidance and support of Mr. (Jay) Shah.

Surplus: The surplus of income over expenditure was INR 1,623.08 crore as against INR 1,167.99 crore in the previous year. This increase is mainly due to increase in IPL 2023 surplus & distributions received from ICC.

Funds: BCCI has allocated INR 1,200 crore towards infrastructure development fund, INR 350 crore towards platinum jubilee benevolent fund and INR 500 crore towards infrastructure for cricket development funds. These allocations supplement the long-term vision of BCCI towards growth of cricket and supporting its former play-

"Substantial provisions have been made towards distribution of amounts to state cricket associations. The total for 2023-24 stands at INR 1,990.18 crore with projected allocation of INR 2,013.97 crore for 24-25," it read.
